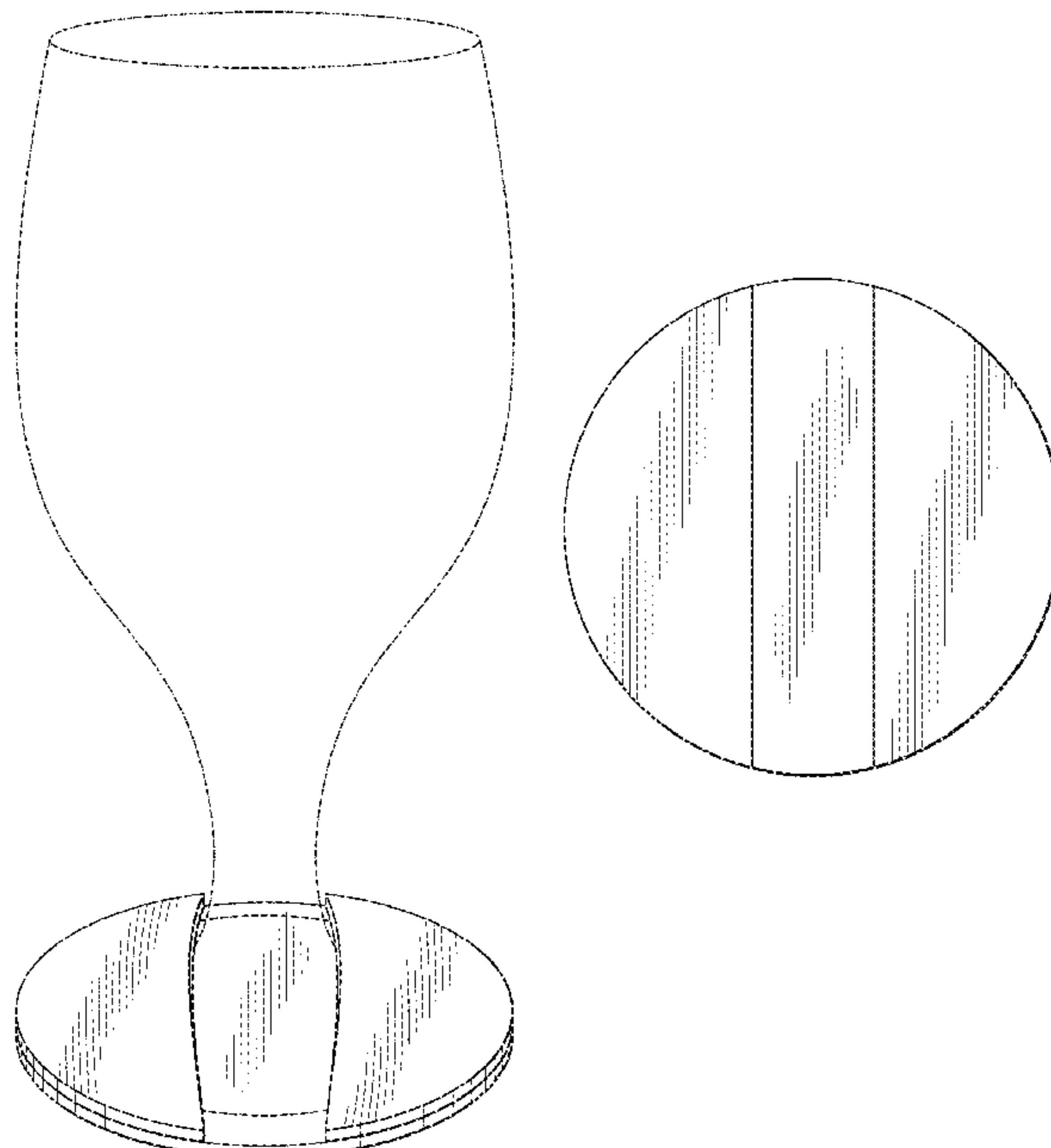
(57) **CLAIM**

The ornamental design for a stemmed glass cover, as shown and described.

DESCRIPTION

FIG. 1 is a top, front perspective view of the stemmed glass cover;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is right side view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.
The broken lines in FIG. 1 of the stemmed glass cover is for the purpose of illustrating environment, and forms no part of the claimed design.

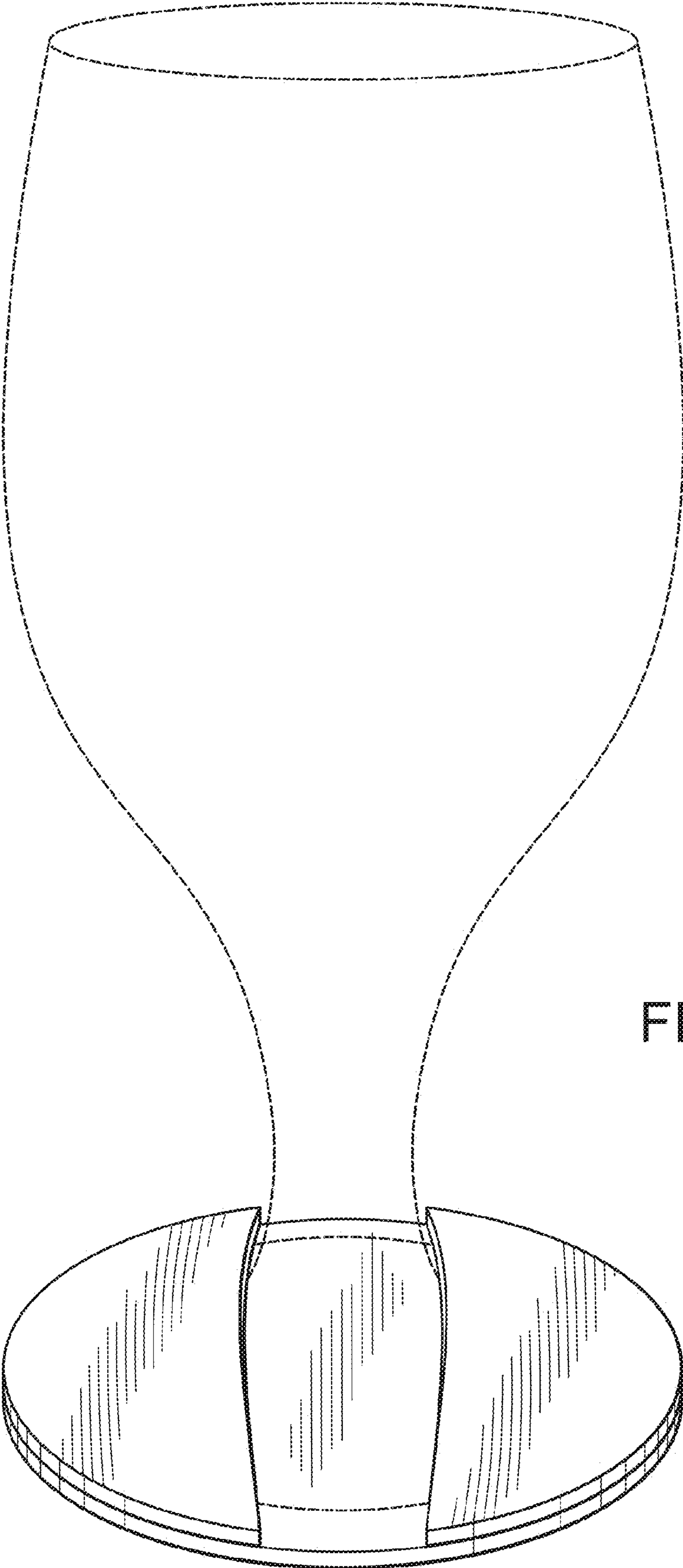

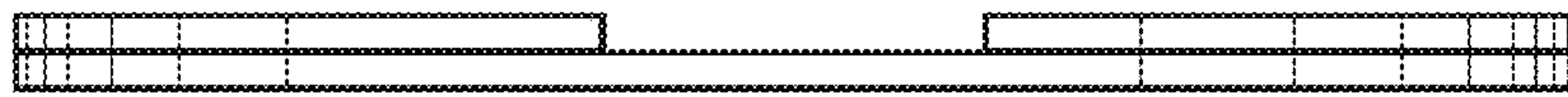

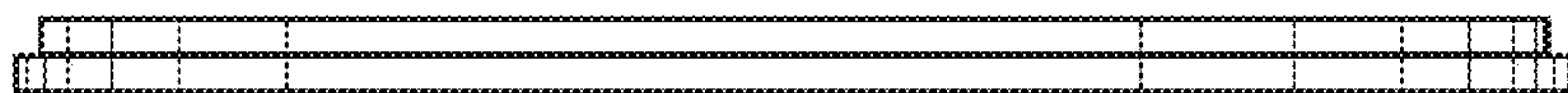

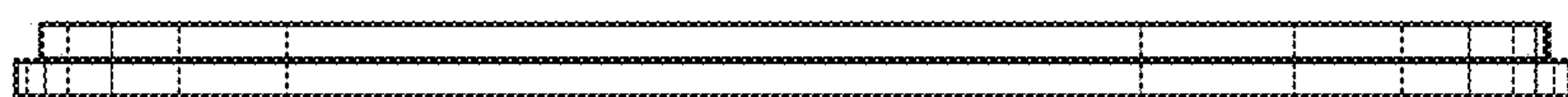

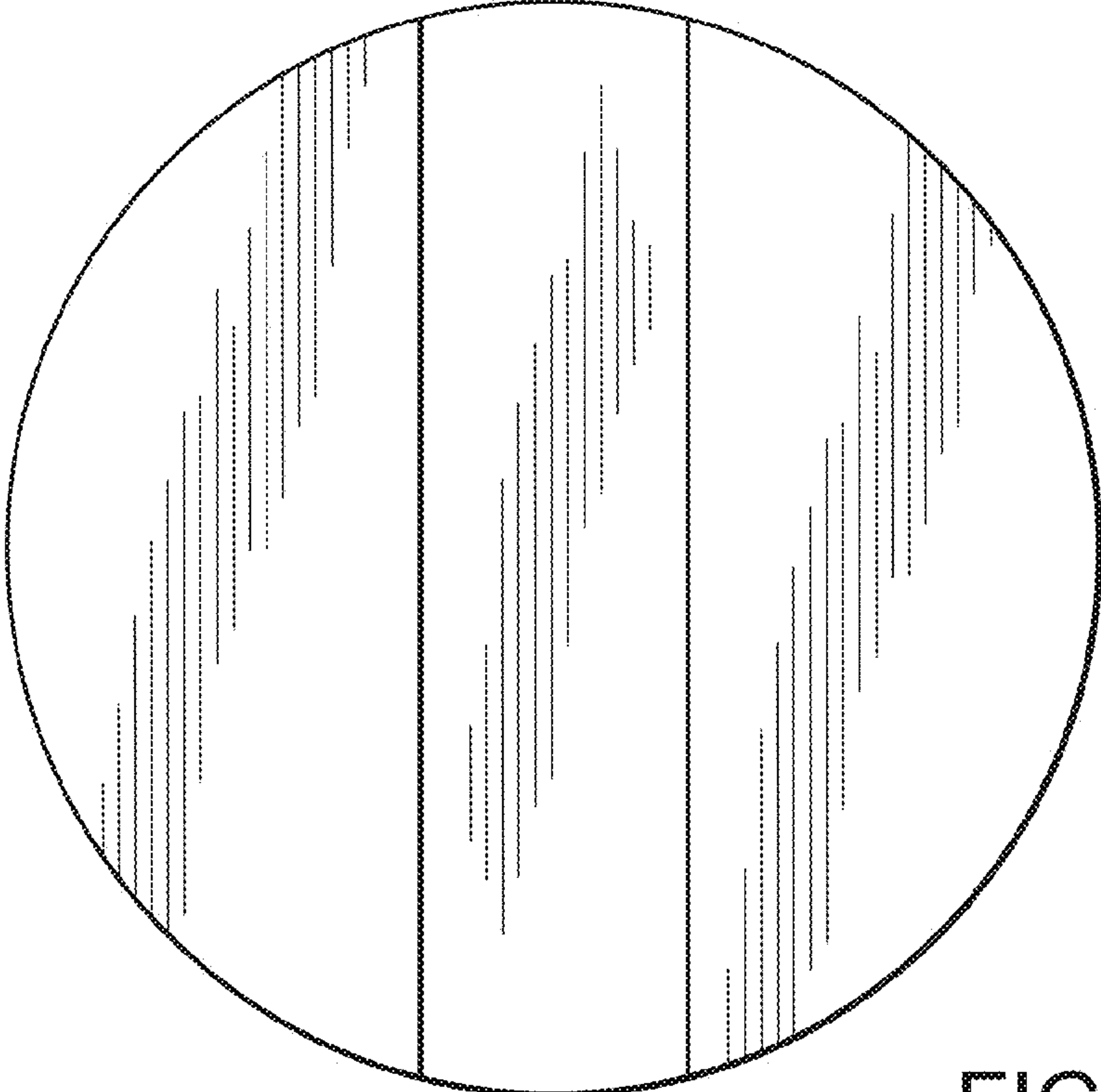

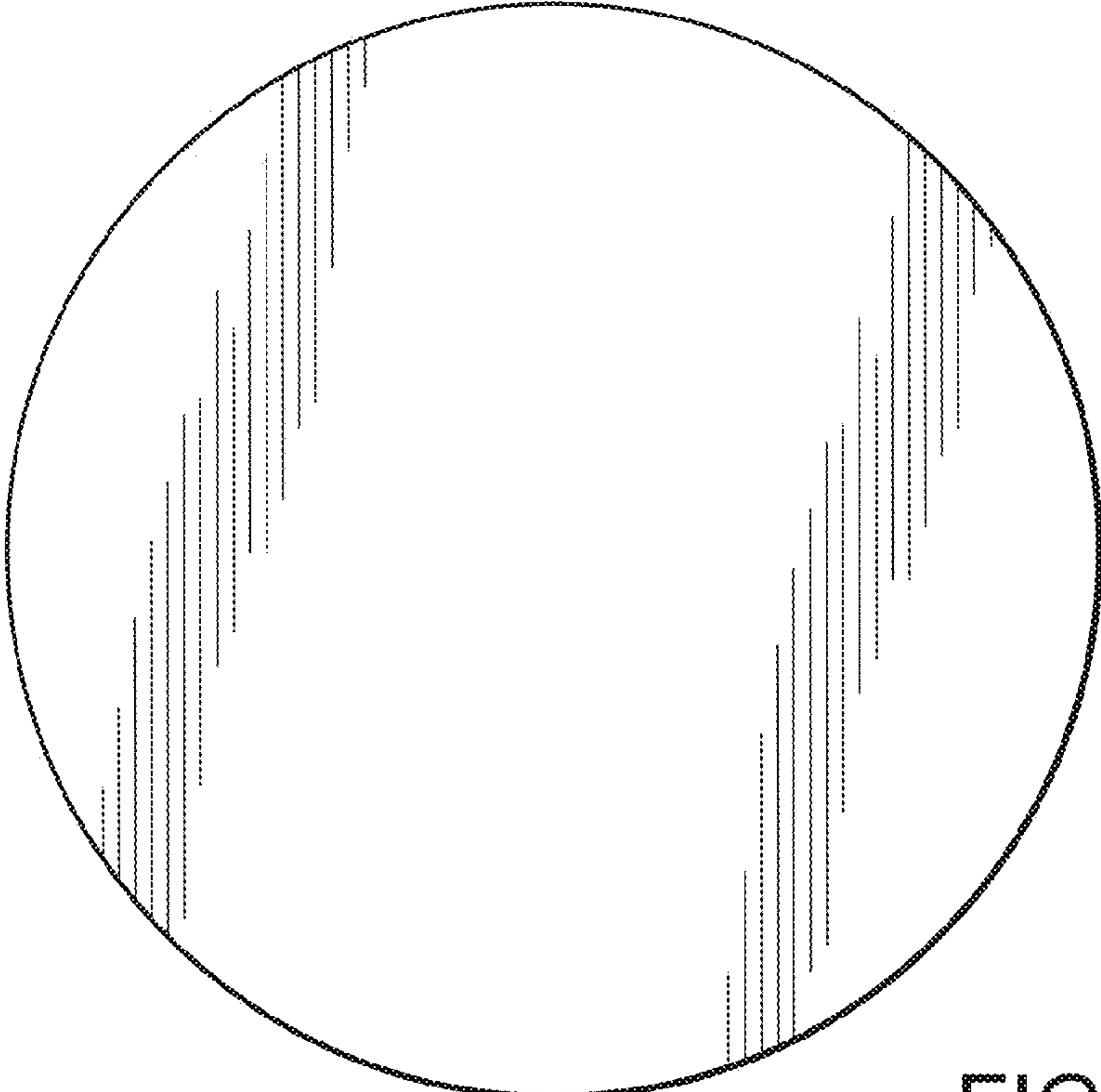
