(57) **CLAIM**

The ornamental design for a wrench body, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a wrench body showing my new design, whereby the broken lines form no part of the claimed design;

FIG. 2 is a top view of the same, whereby the broken lines form no part of the claimed design;

FIG. 3 is a bottom view of the same;

FIG. 4 is a left side view of the same, whereby the broken lines form no part of the claimed design;

FIG. 5 is a right side view of the same, whereby the broken lines form no part of the claimed design;

FIG. 6 is a front view of the same, whereby the broken lines form no part of the claimed design;

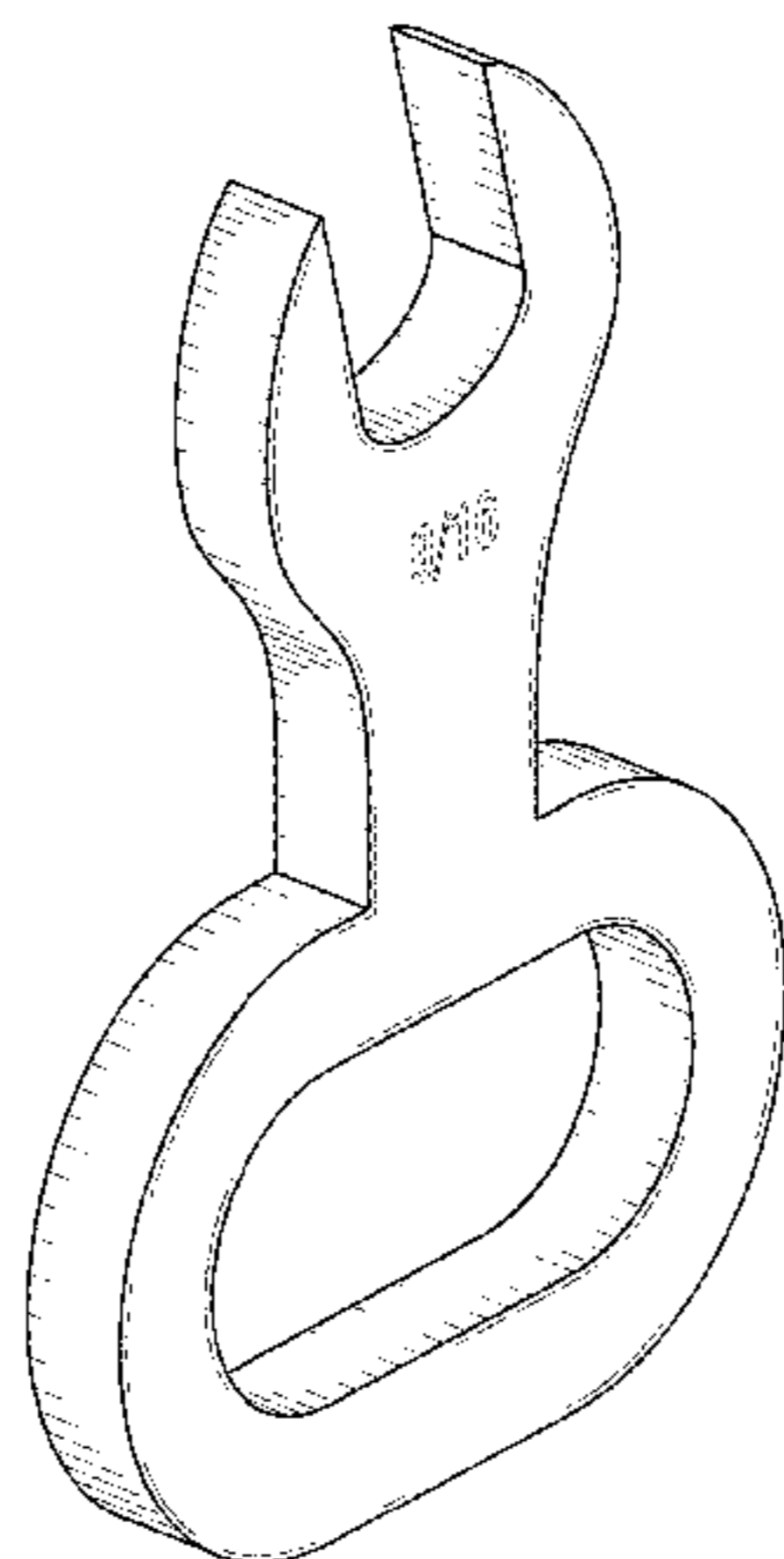
FIG. 7 is a rear view of the same, whereby the broken lines form no part of the claimed design;

FIG. 8 is a perspective view of the same, whereby the broken lines form no part of the claimed design, and whereby the broken lines of the human hand are shown for environmental purposes only and form no part of the claimed design;

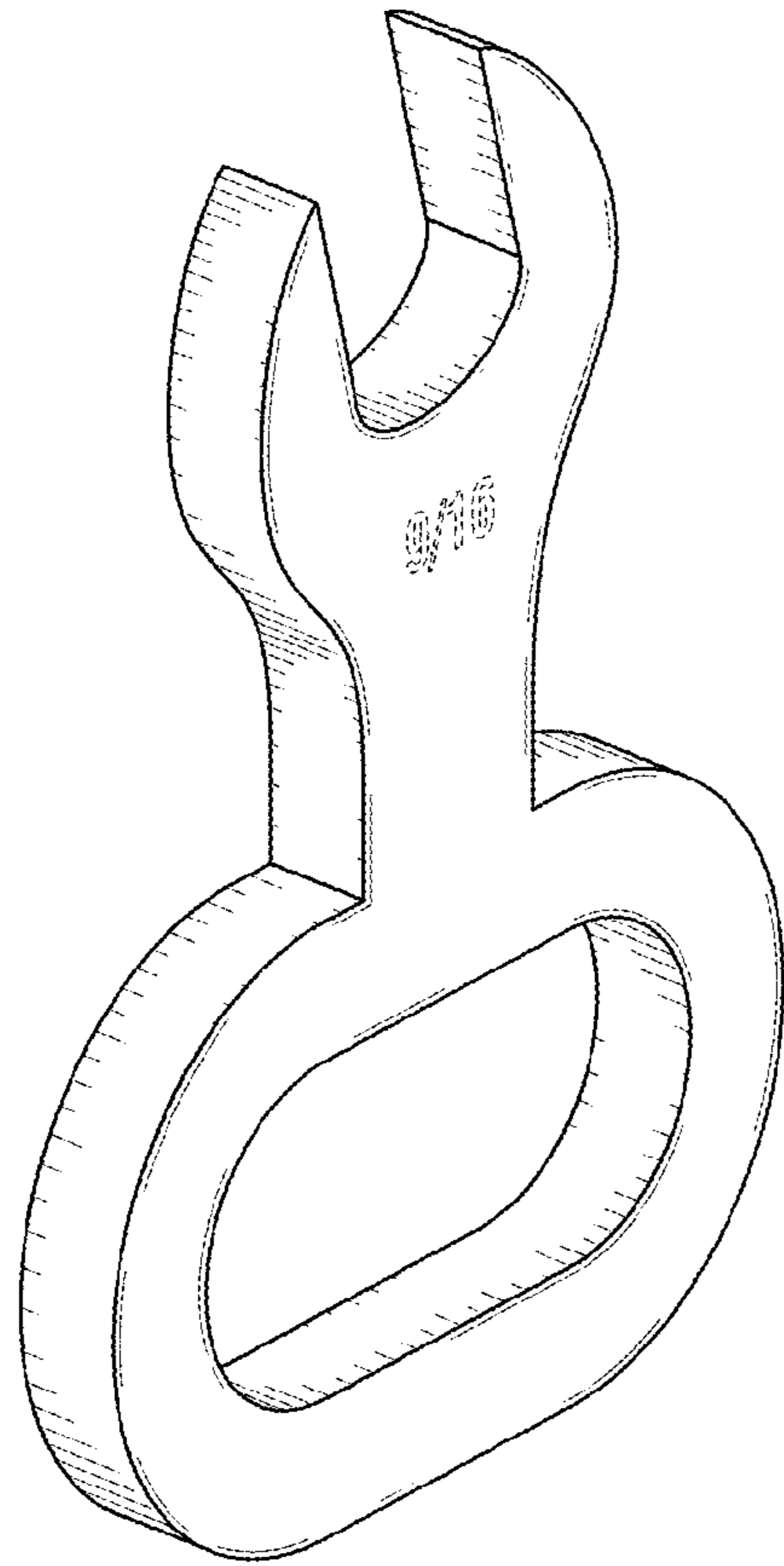

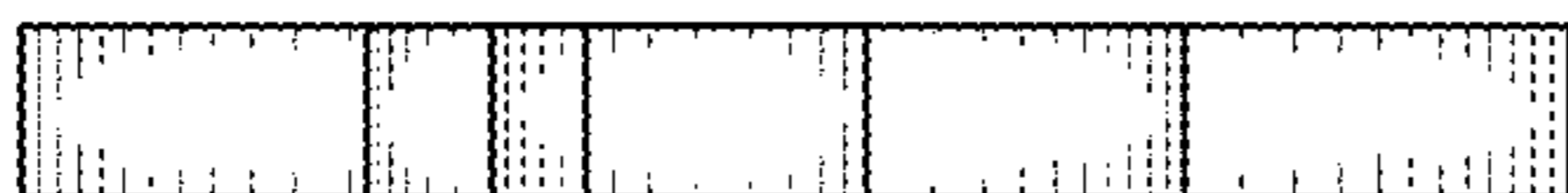

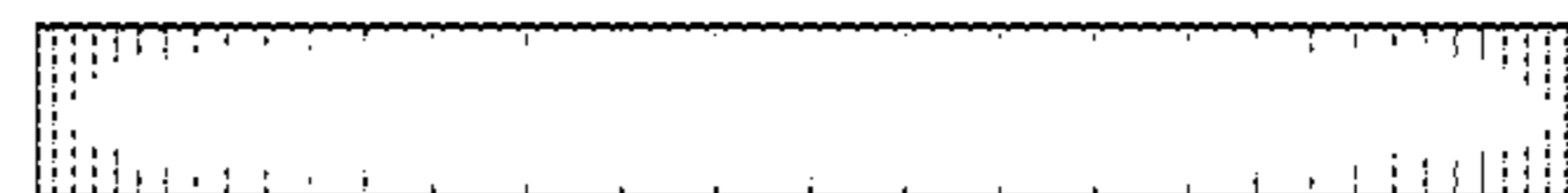

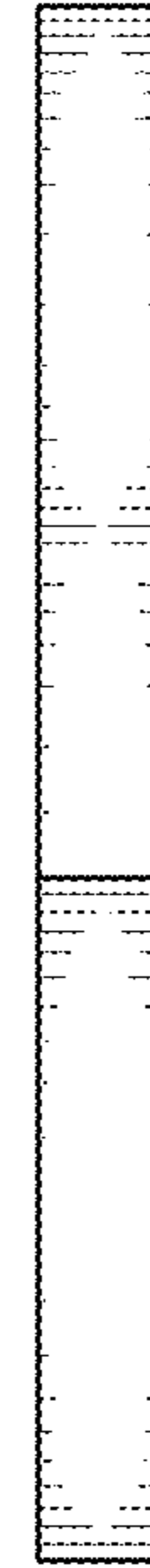

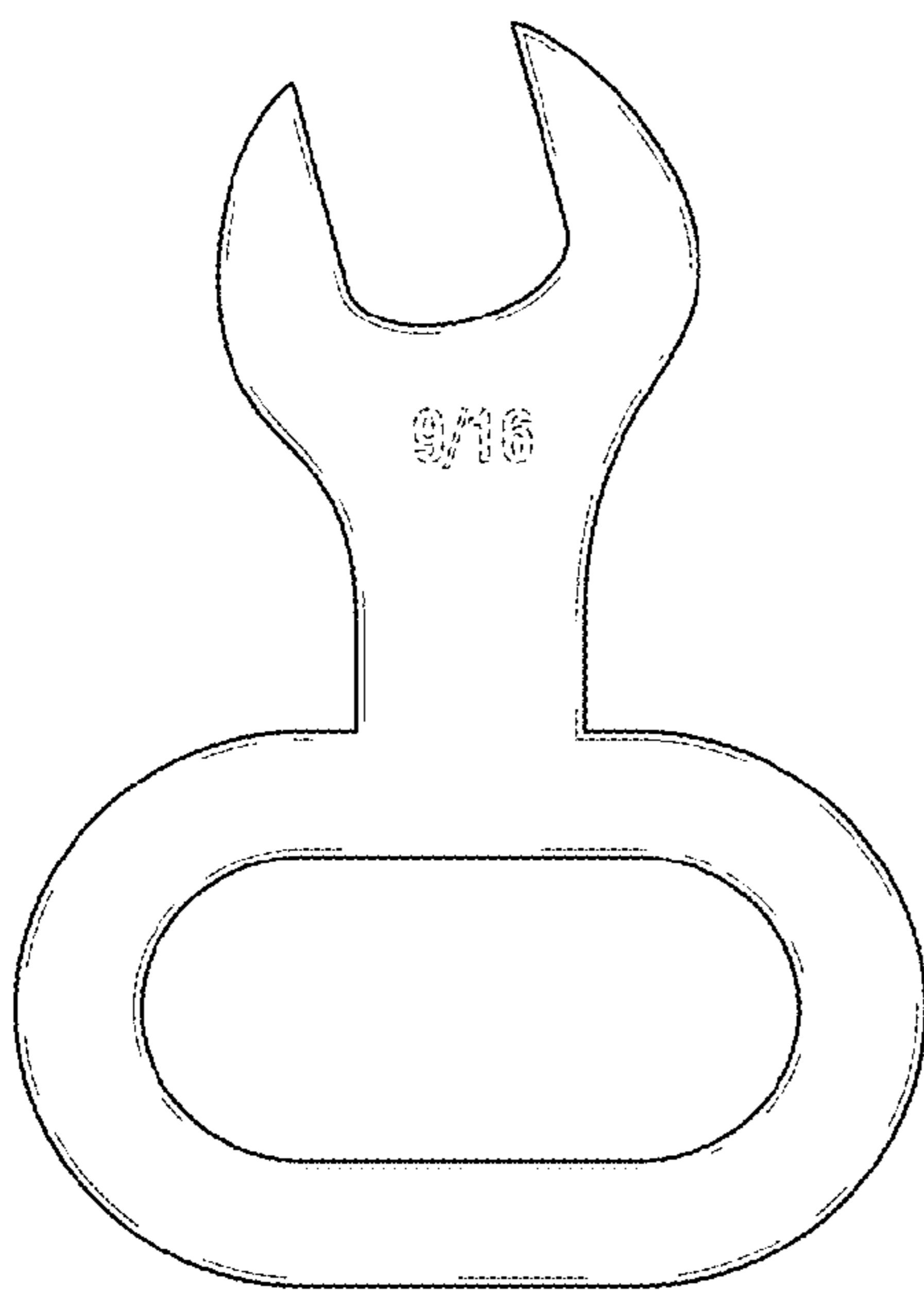

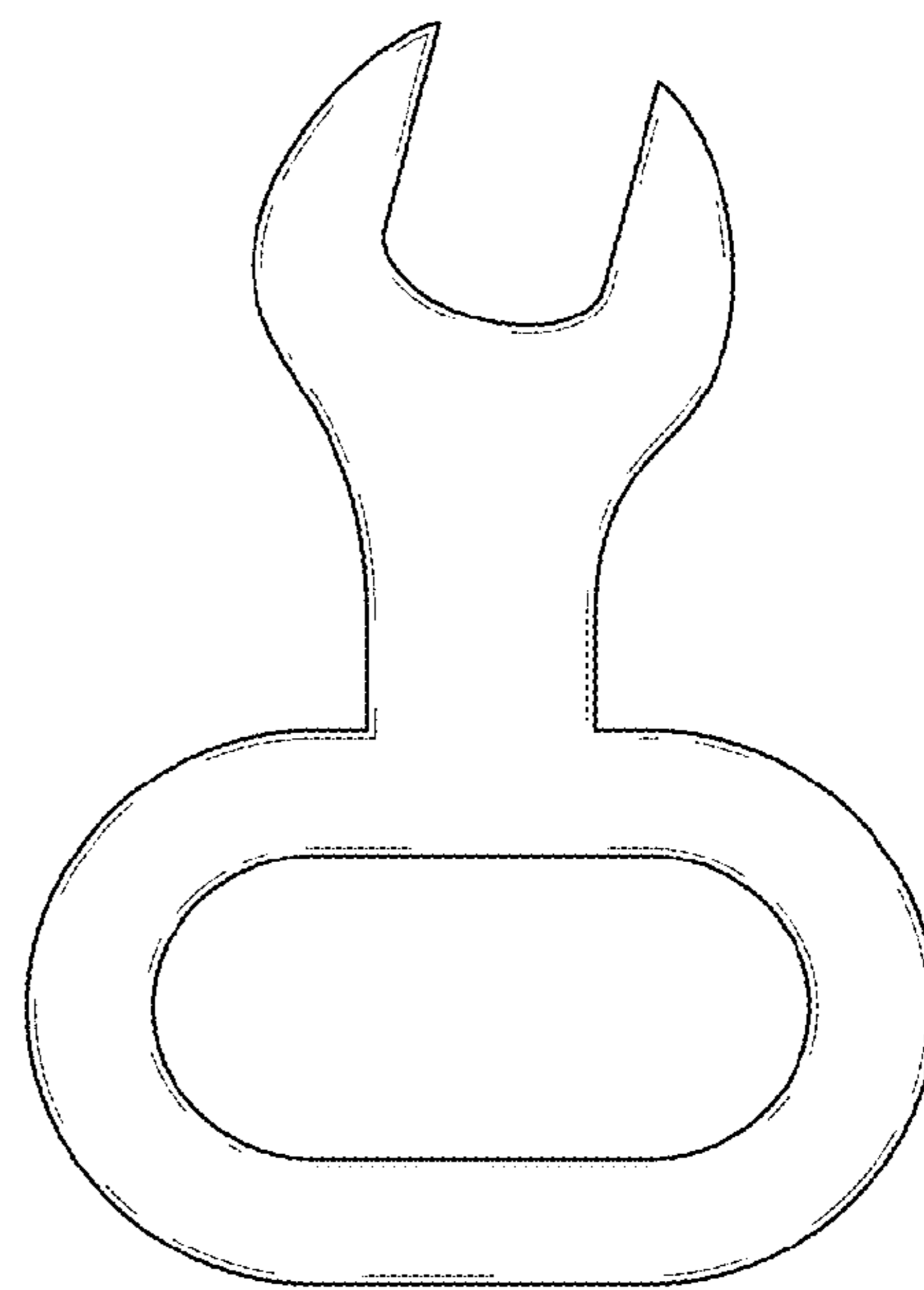

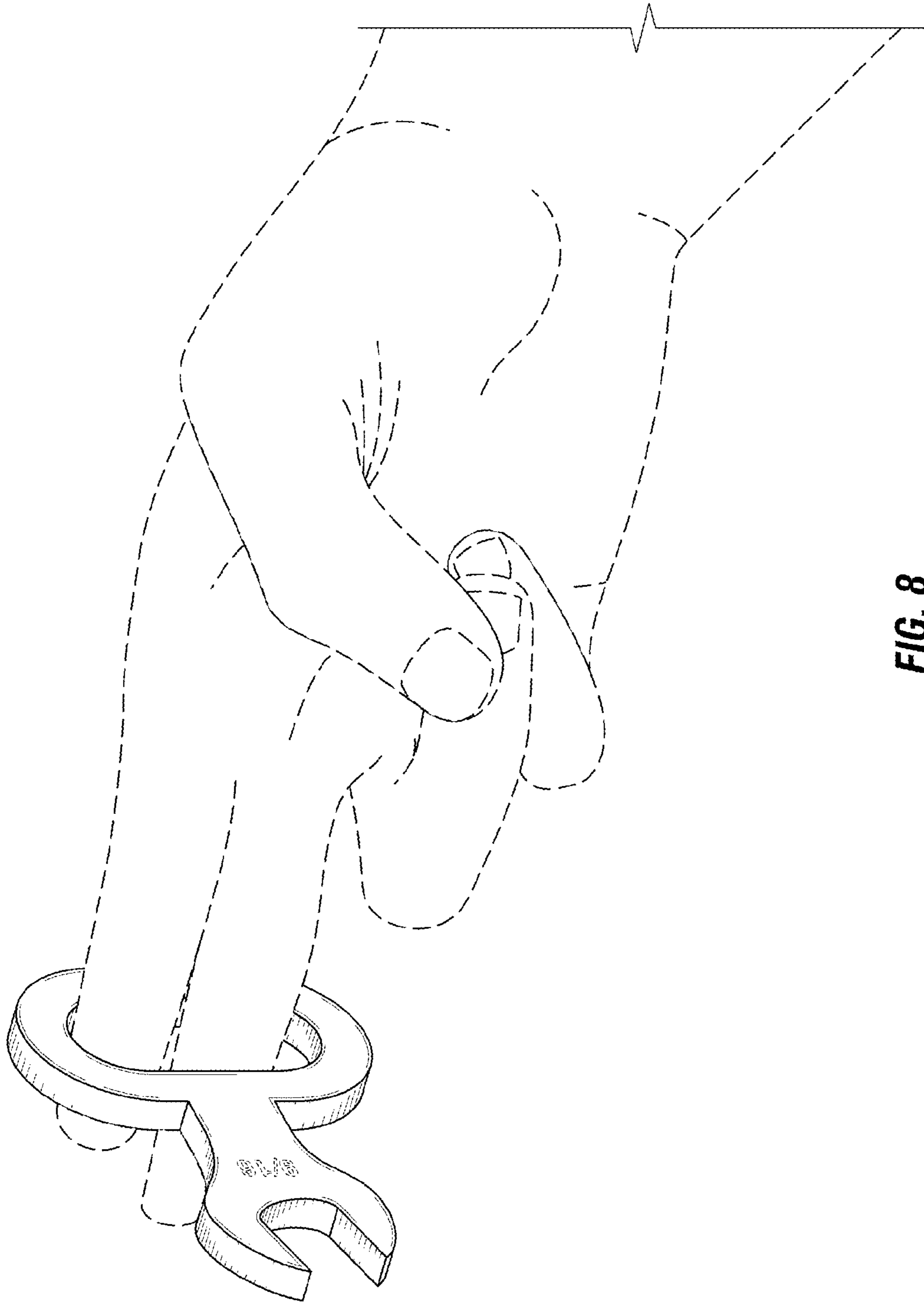

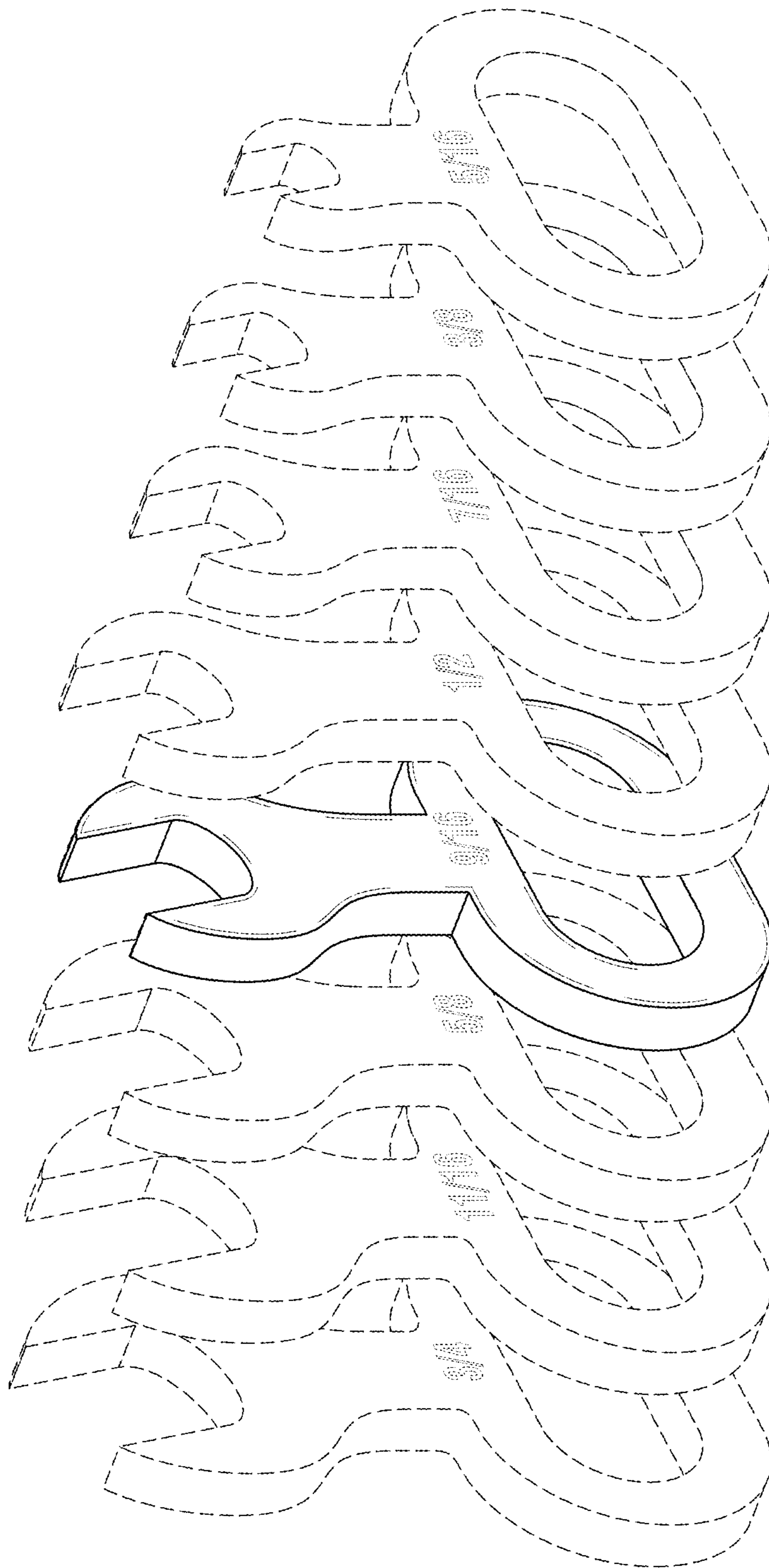

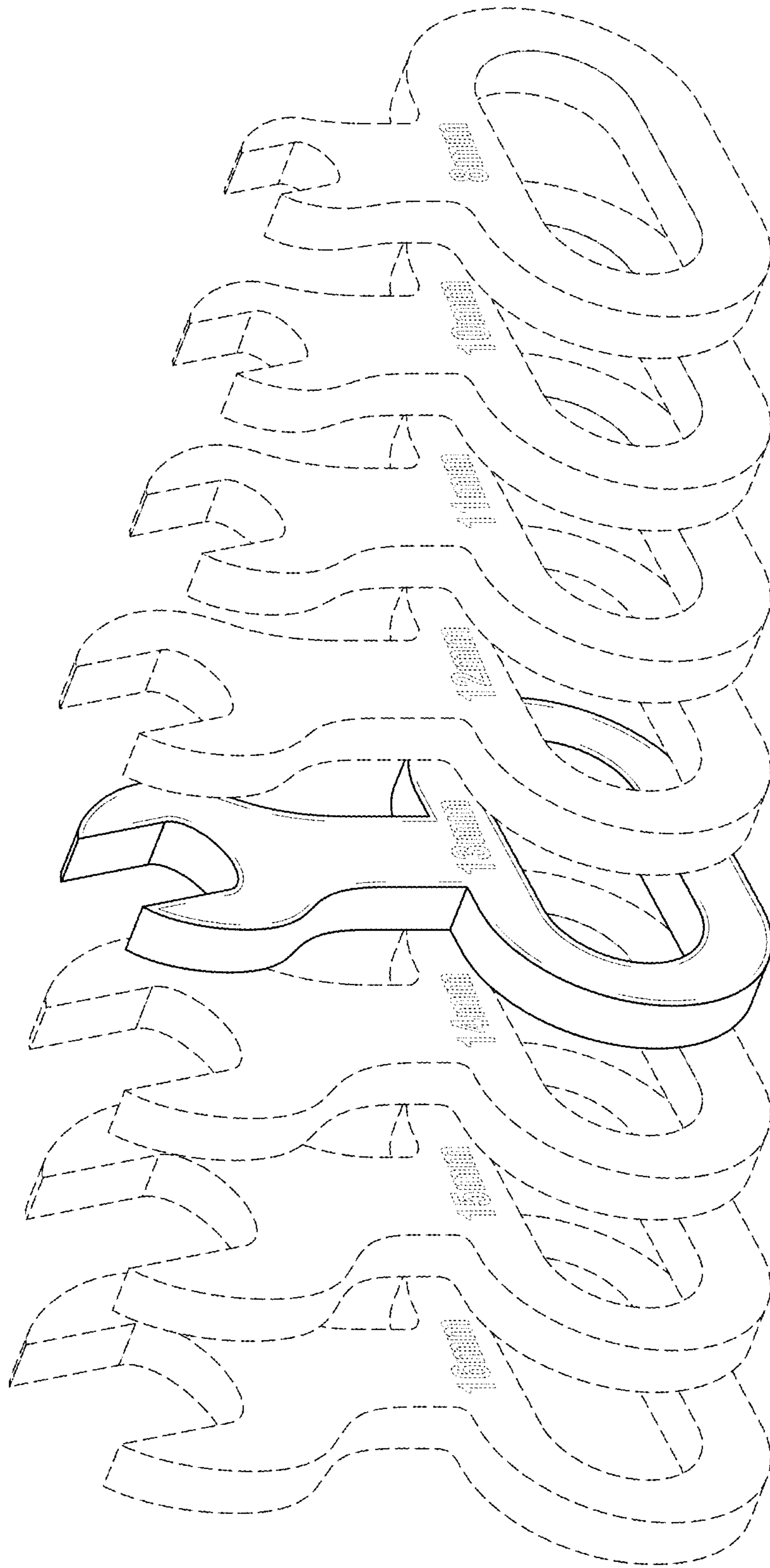
