FIG. 5 is a front side elevation view thereof;

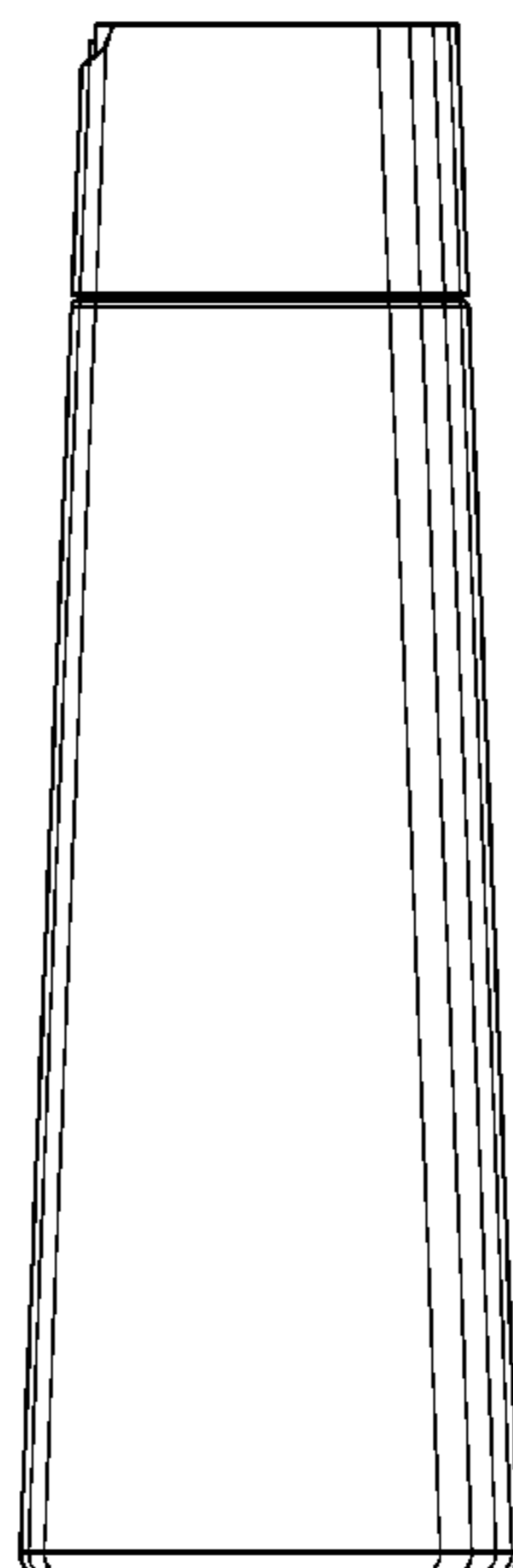
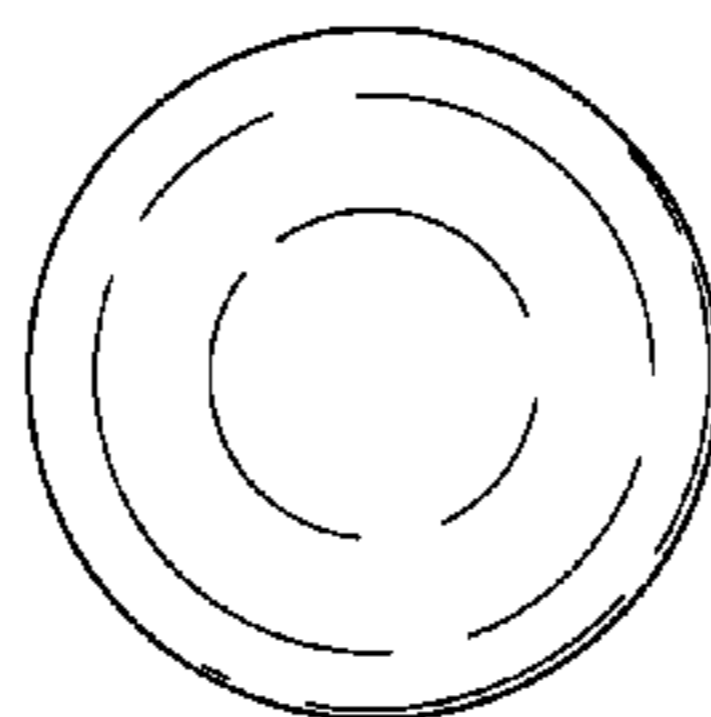
FIG. 6 is a left side elevation view thereof;

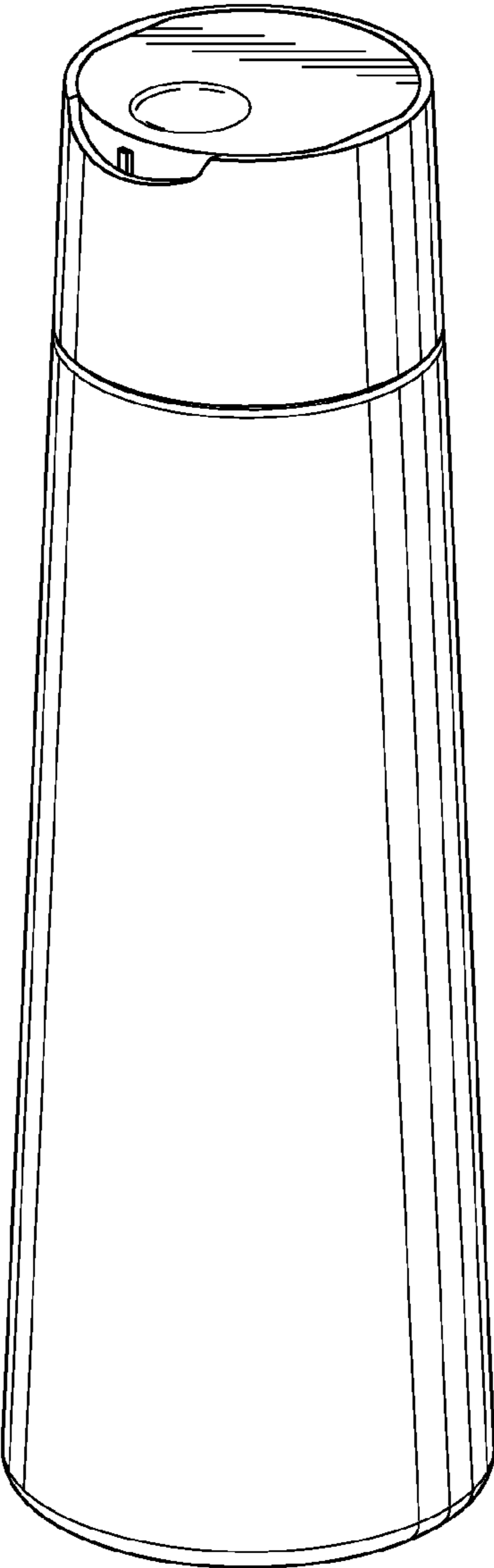
FIG. 7 is a right side elevation view thereof; and,

FIG. 8 is a bottom perspective view thereof.

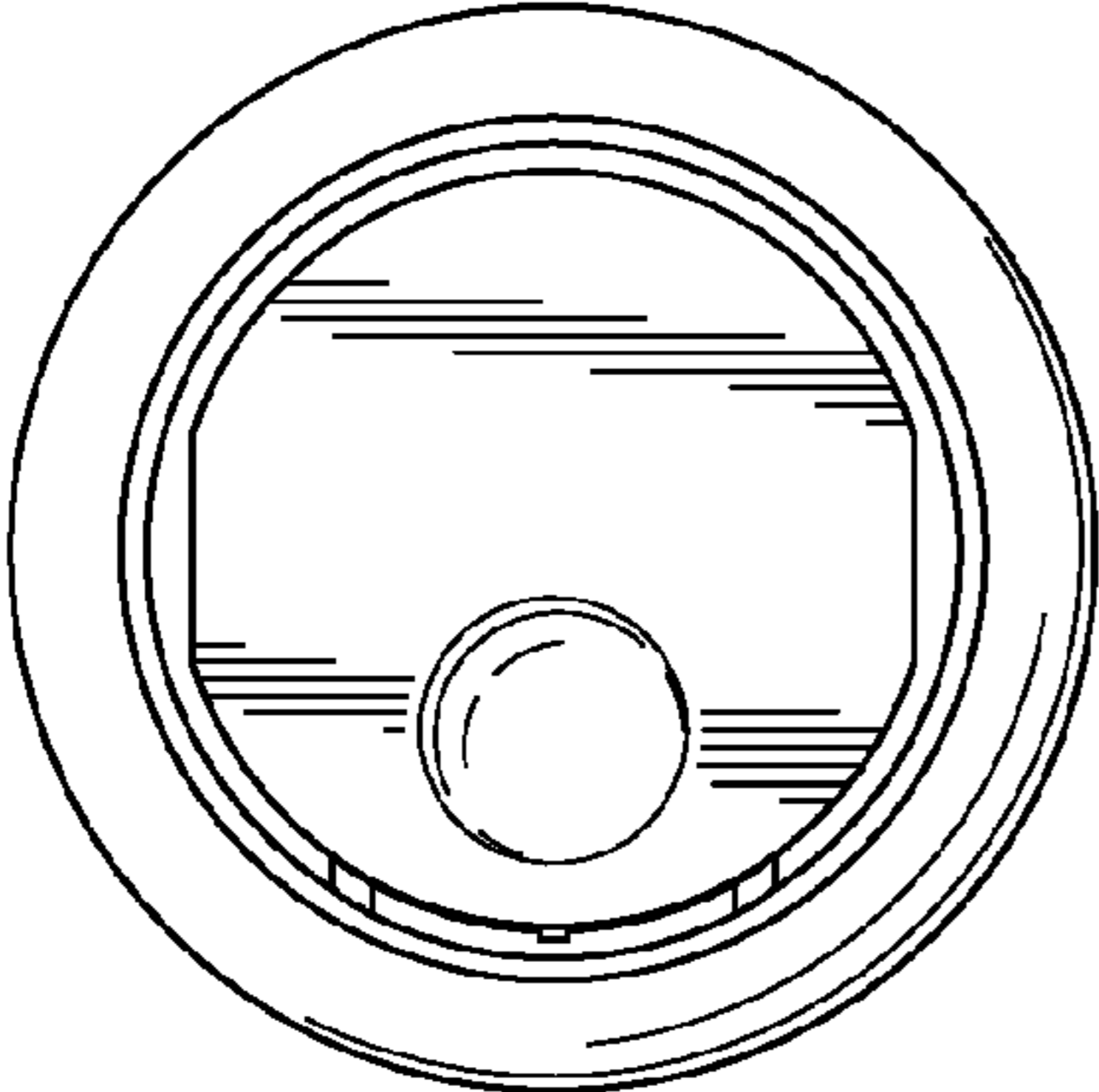

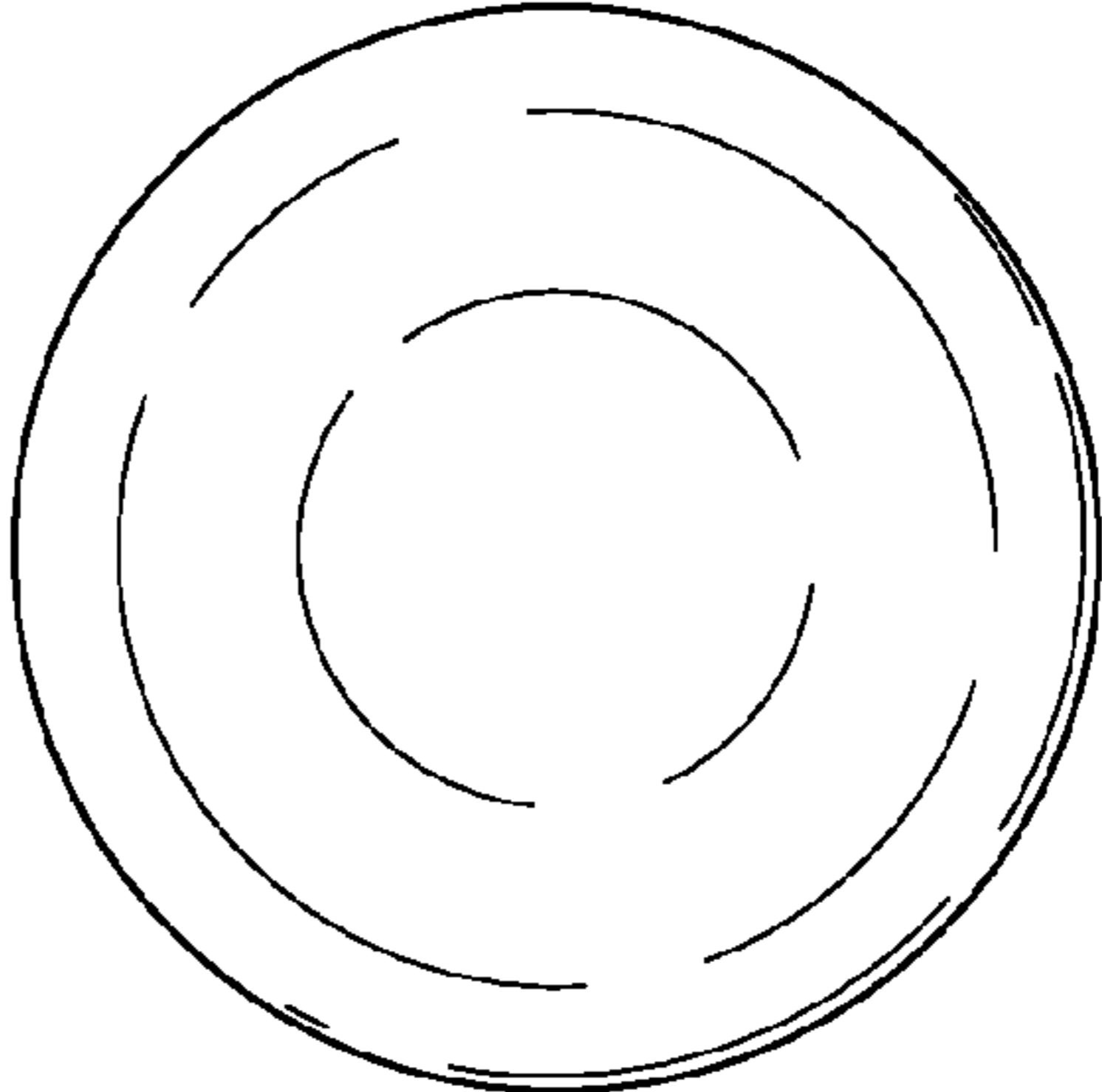




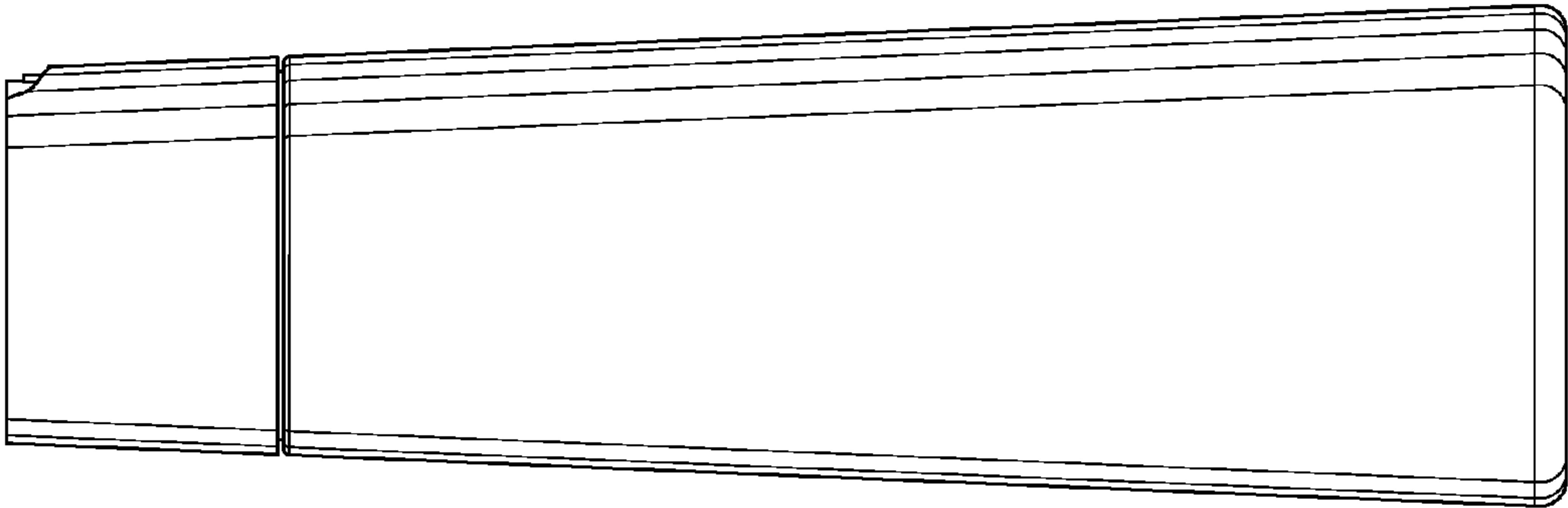

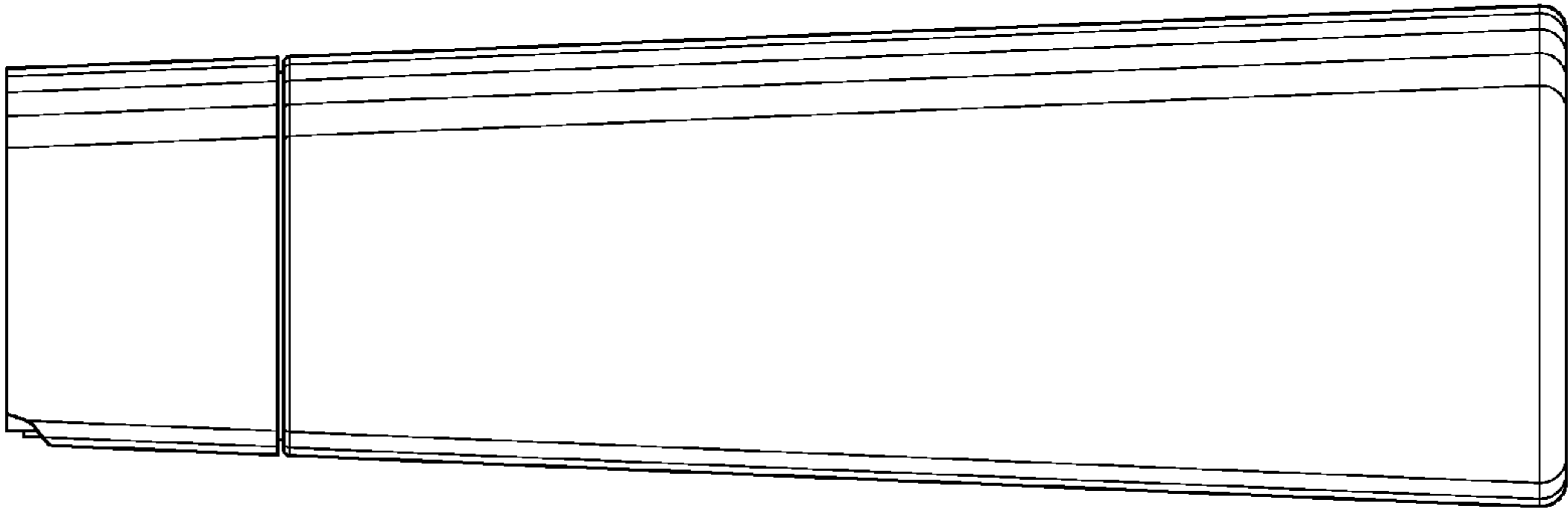

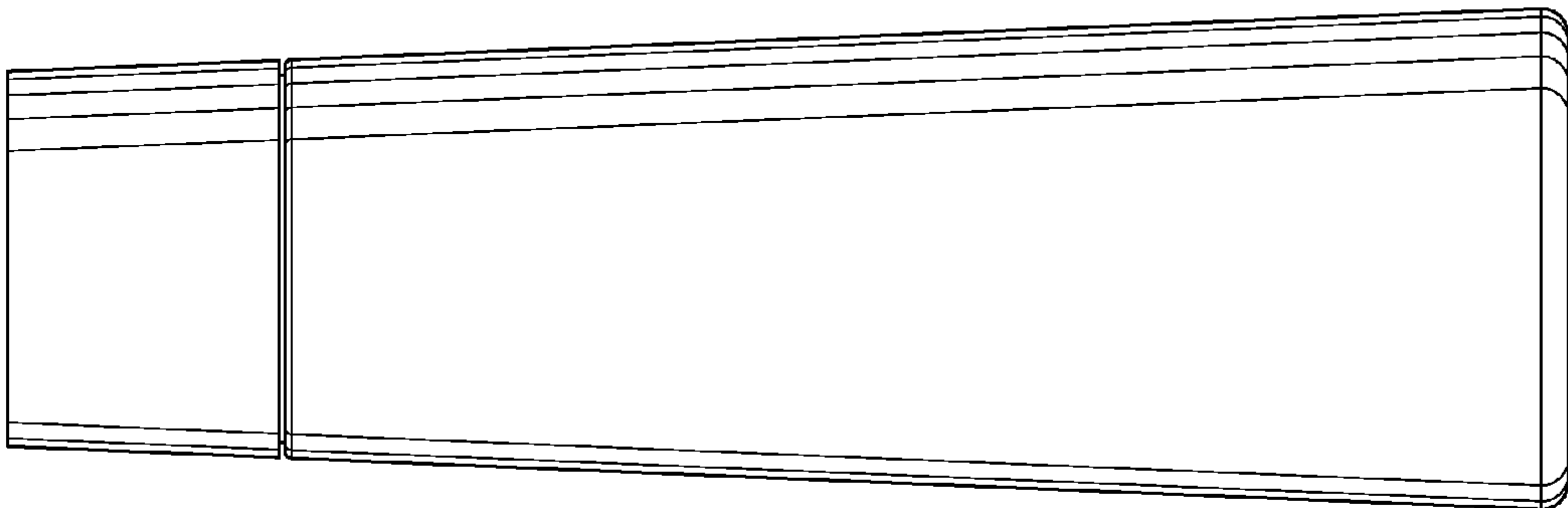

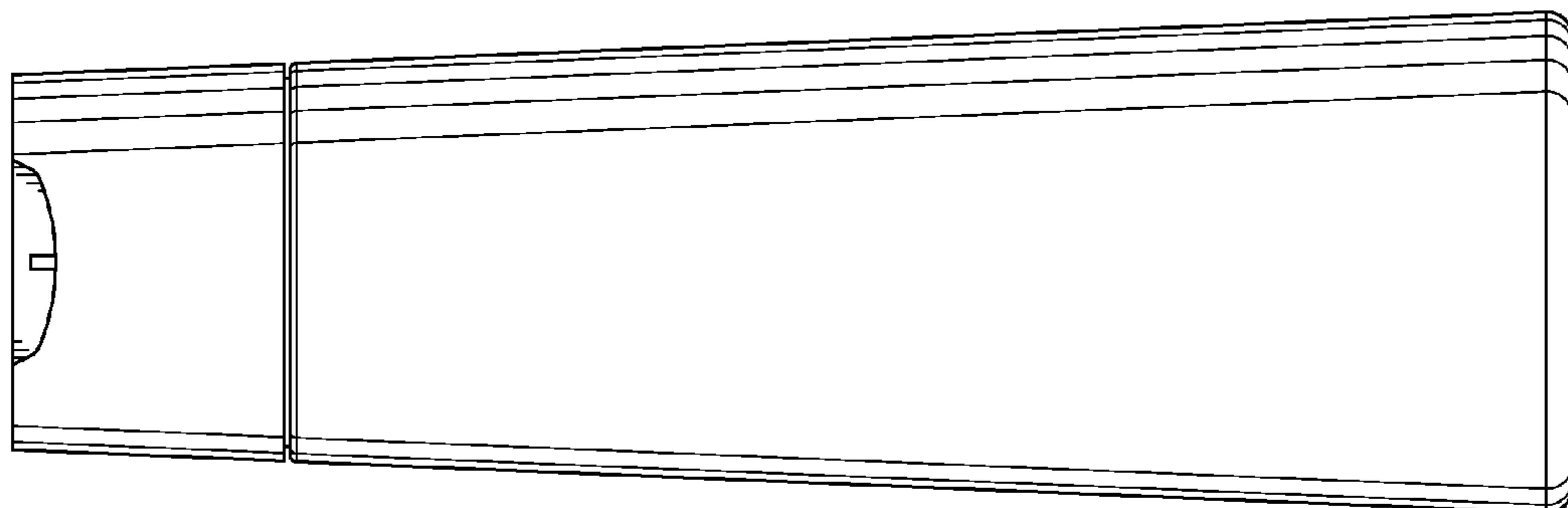

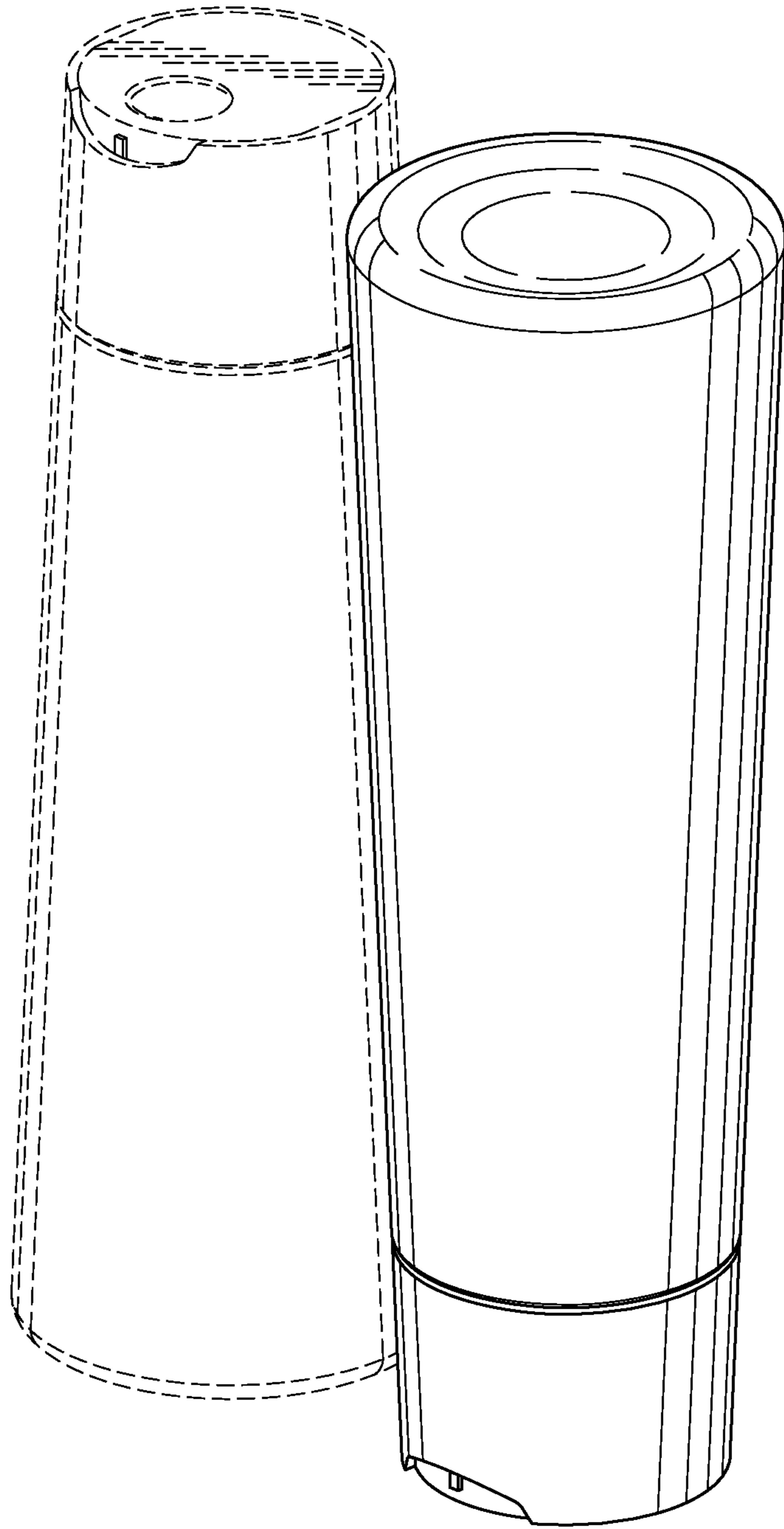
