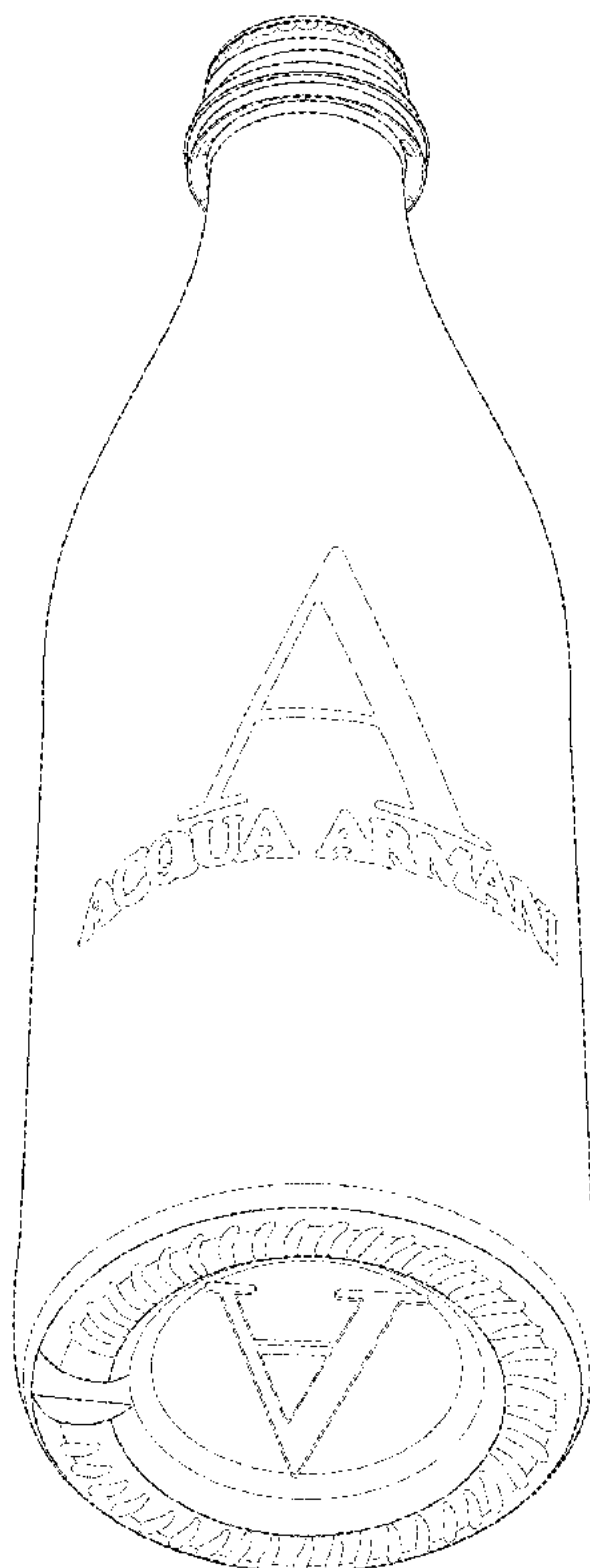
(57) **CLAIM**

The ornamental design for a combined bottle and cap, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a combined bottle and cap showing my new design;
FIG. 2 is a bottom perspective view of the combined bottle and cap of FIG. 1;
FIG. 3 is a front elevation view of the combined bottle and cap of FIG. 1;
FIG. 4 is a right side elevation view of the combined bottle and cap of FIG. 1;
FIG. 5 is a left side elevation view of the combined bottle and cap of FIG. 1;
FIG. 6 is a top plan view of the combined bottle and cap of FIG. 1; and,
FIG. 7 is a bottom plan view of the combined bottle and cap of FIG. 1.

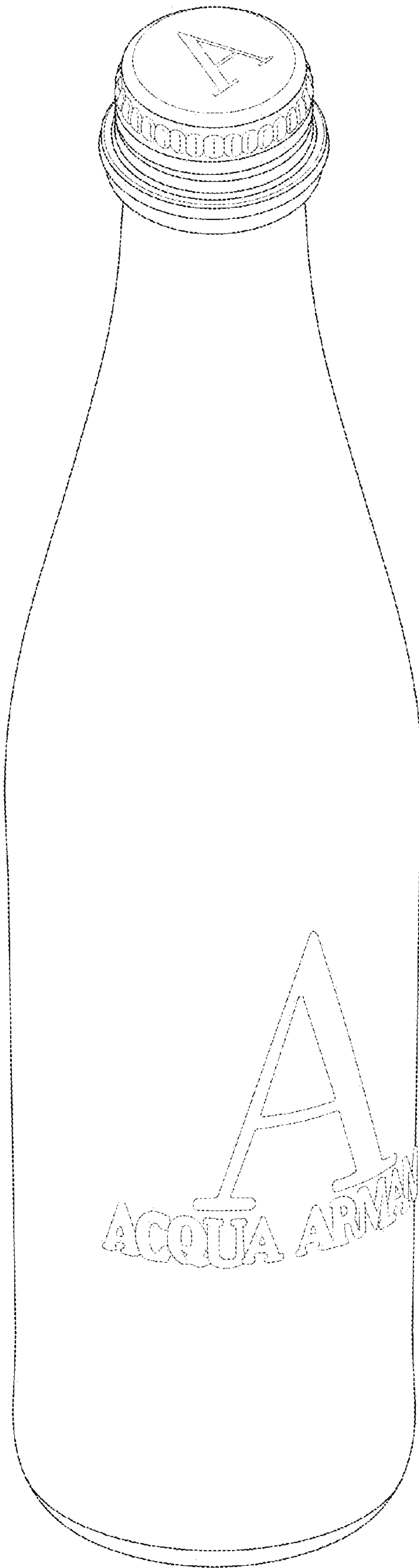

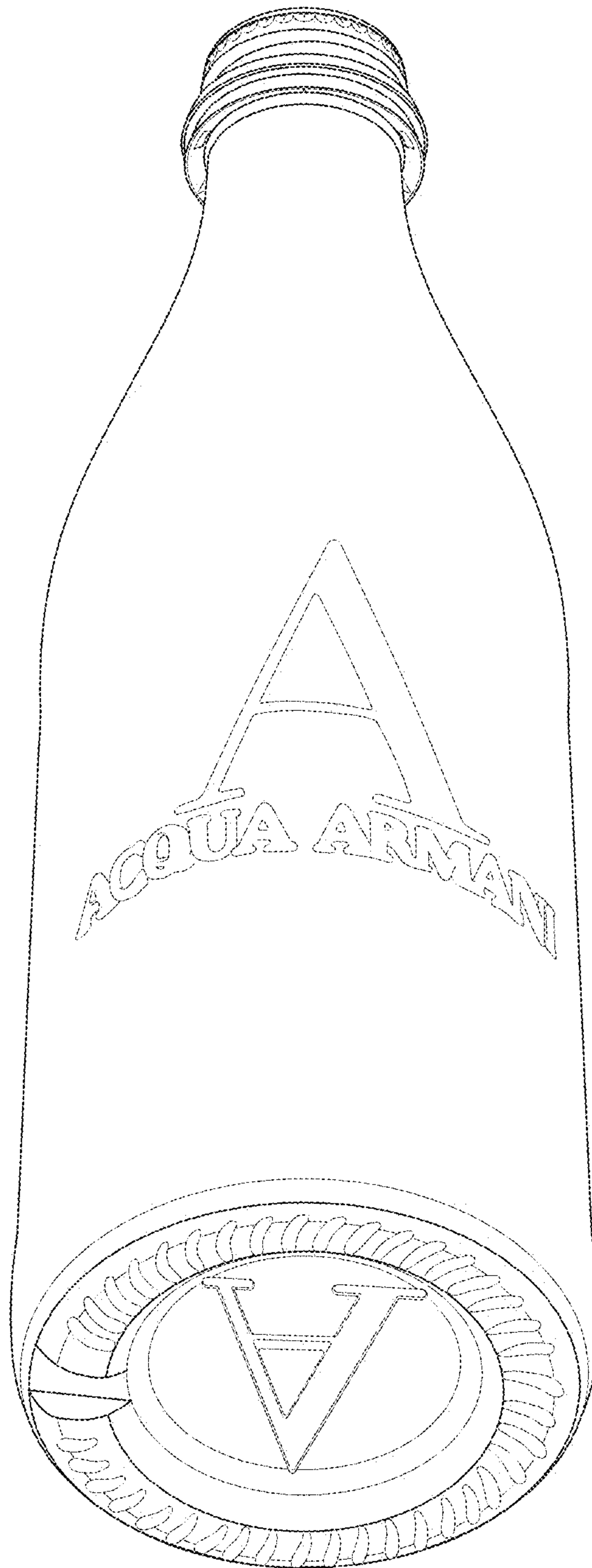

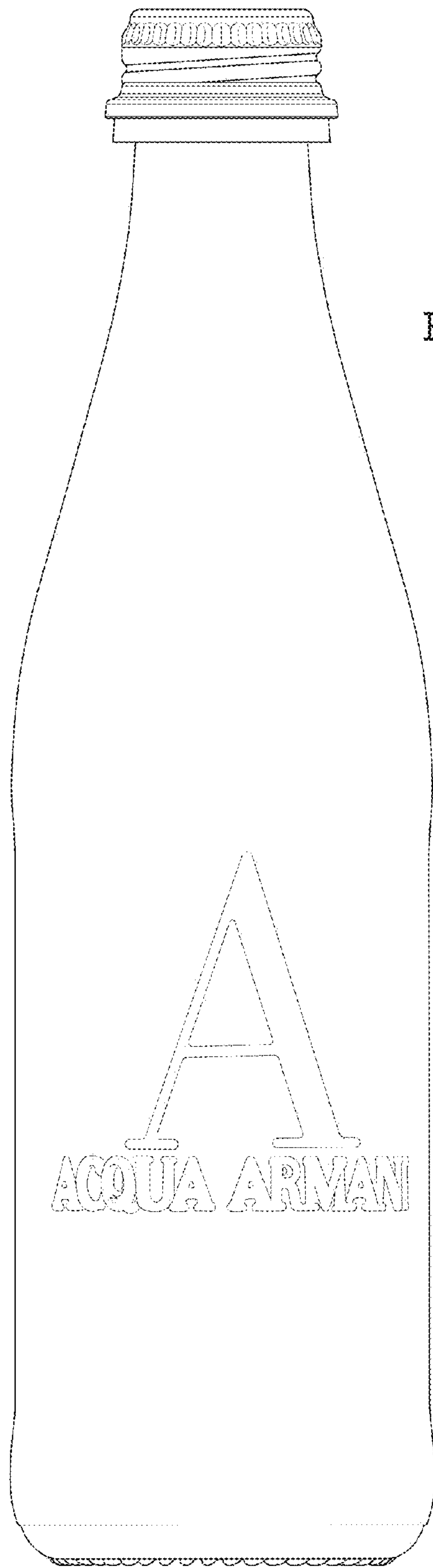

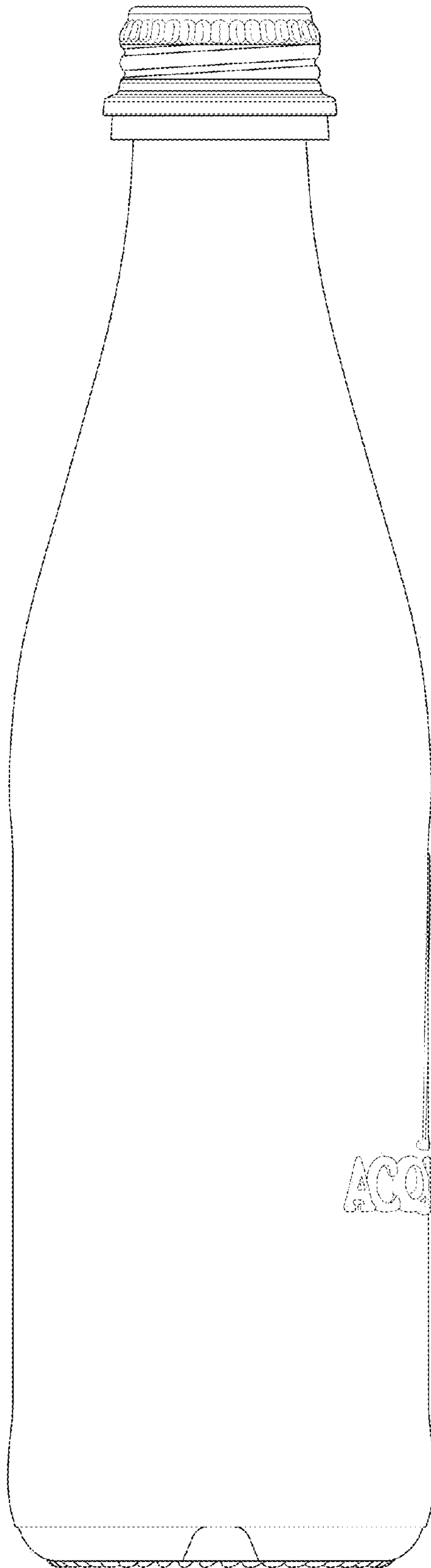

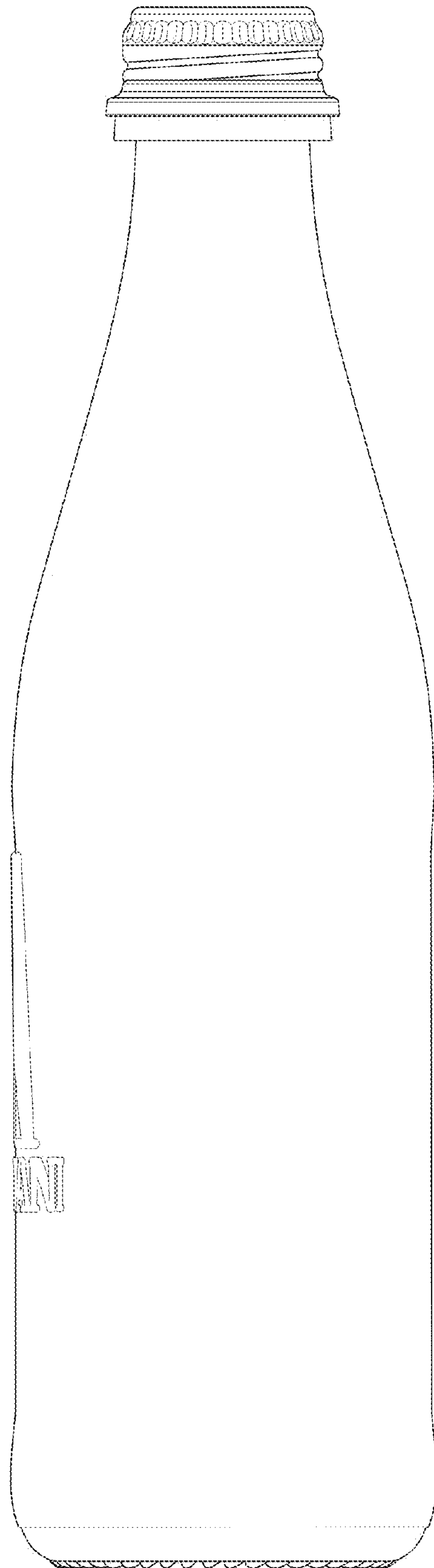

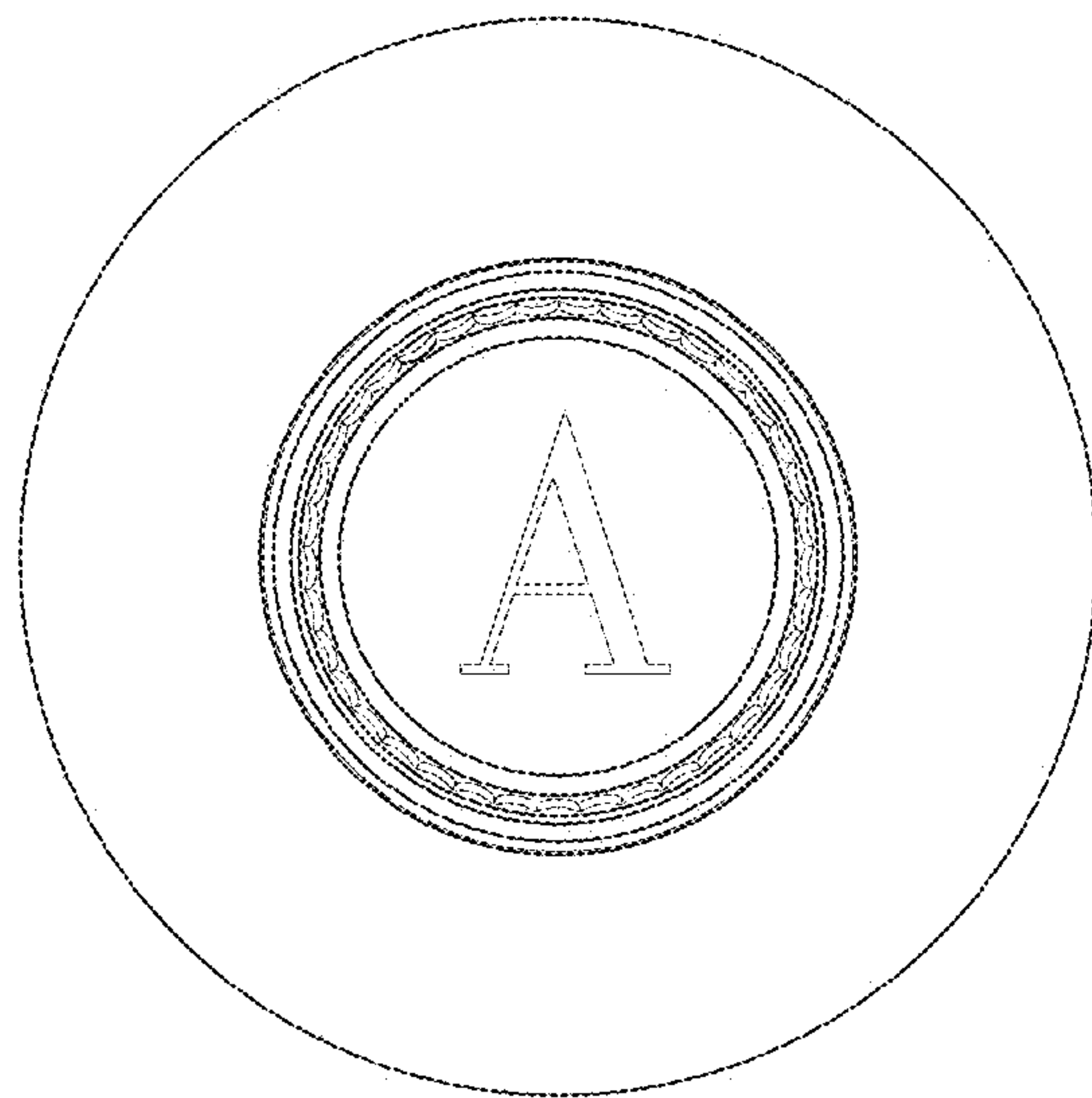

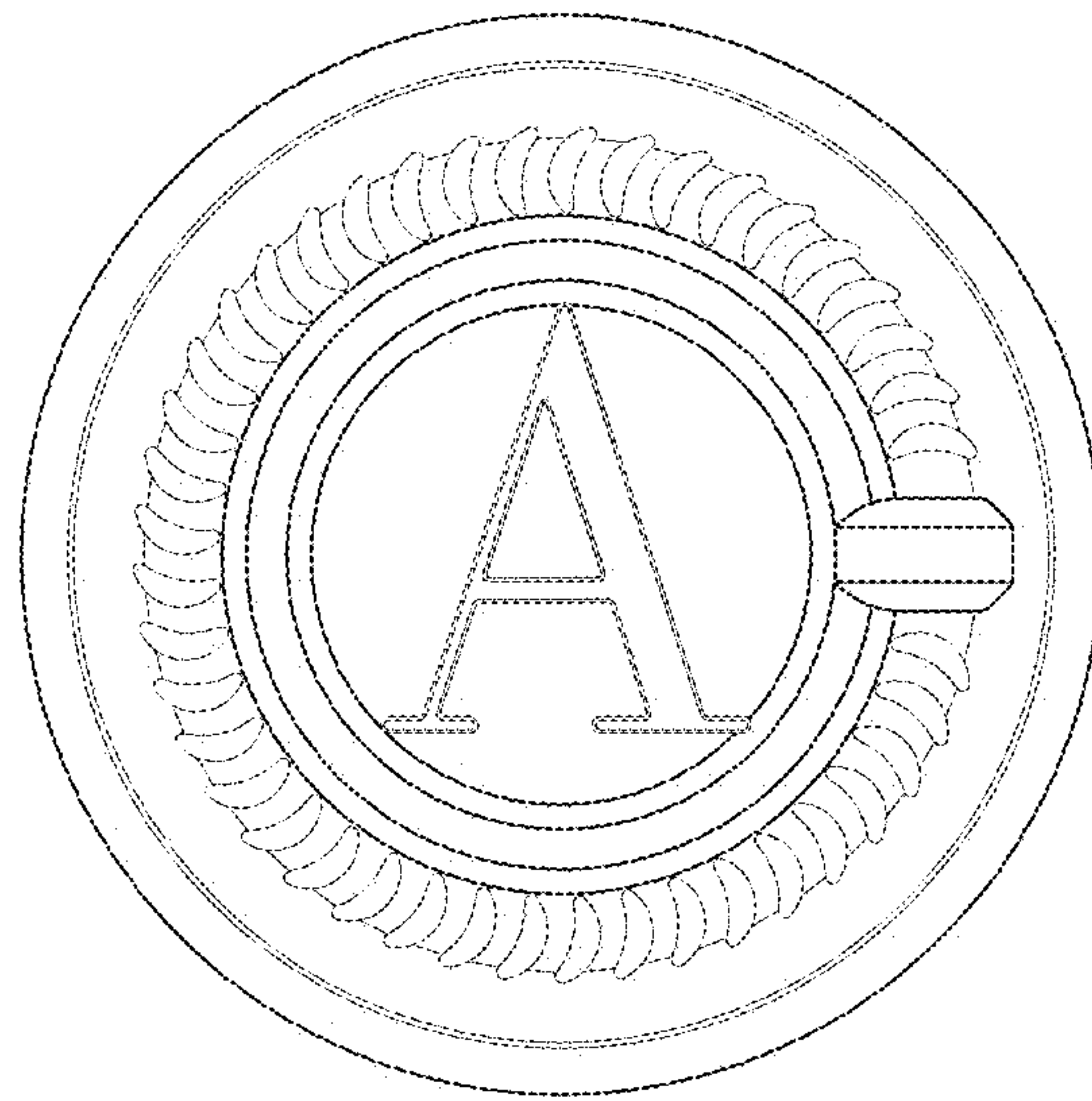
