(57) **CLAIM**

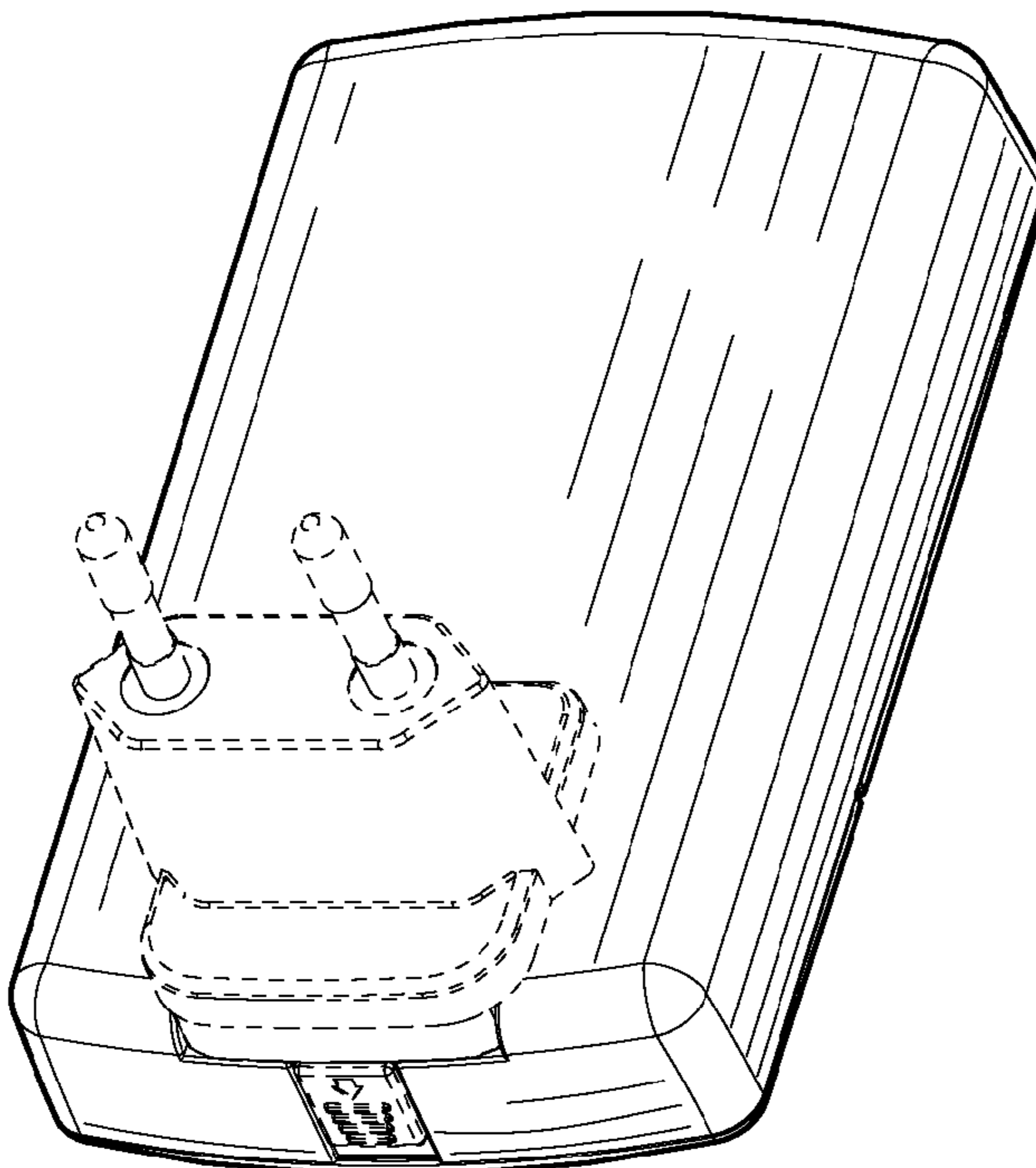
The ornamental design for a charger, as shown and described.

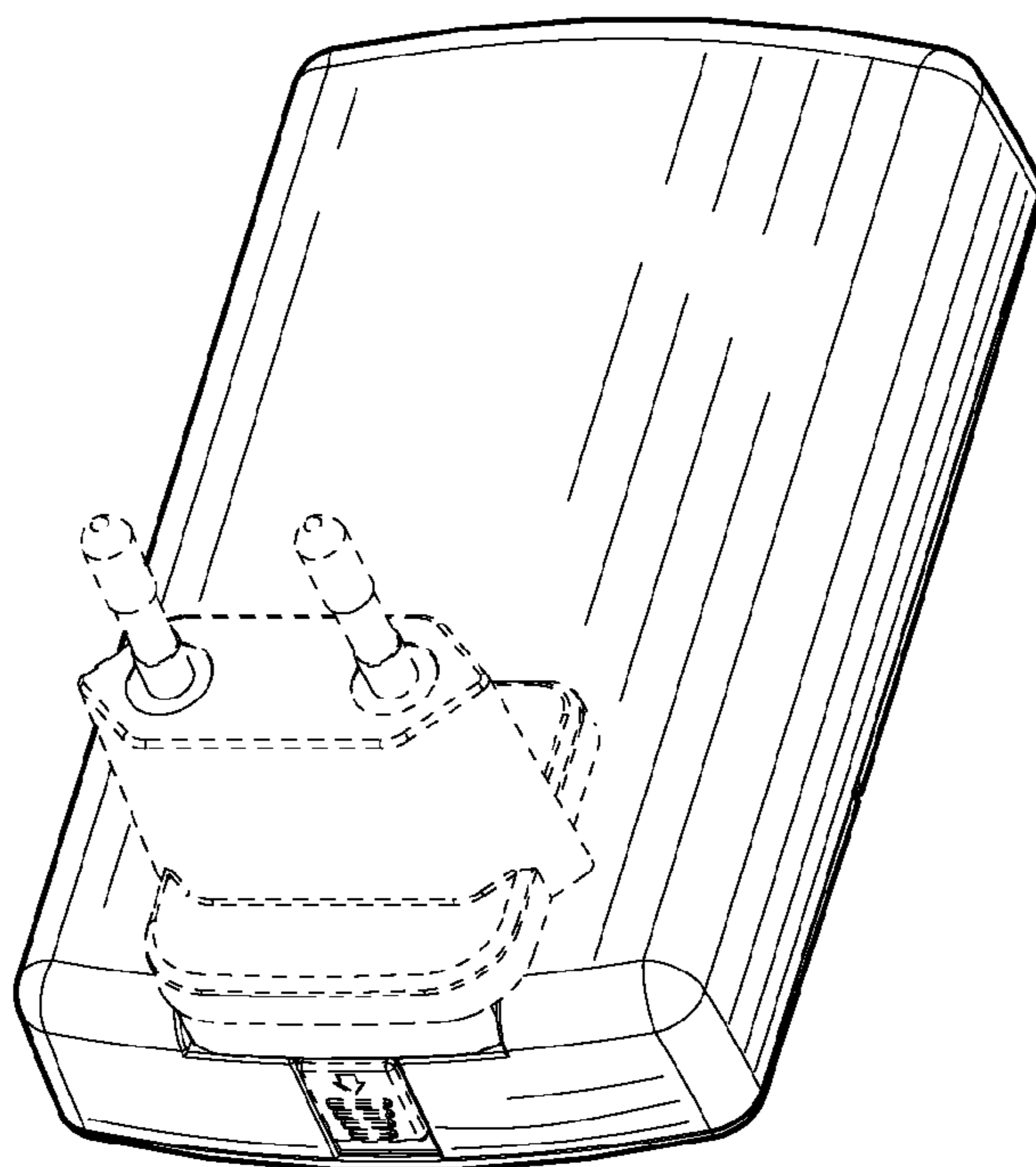

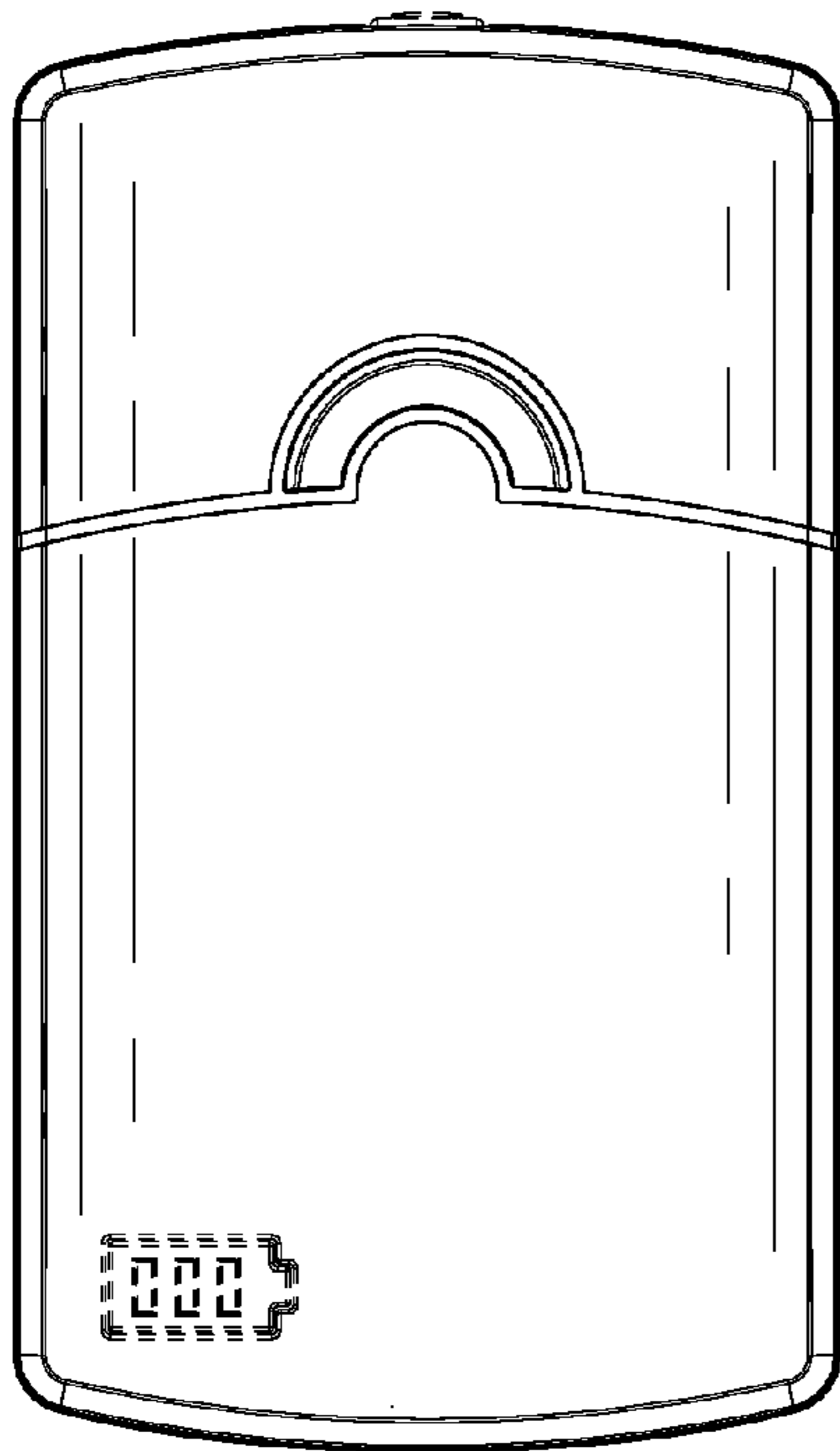

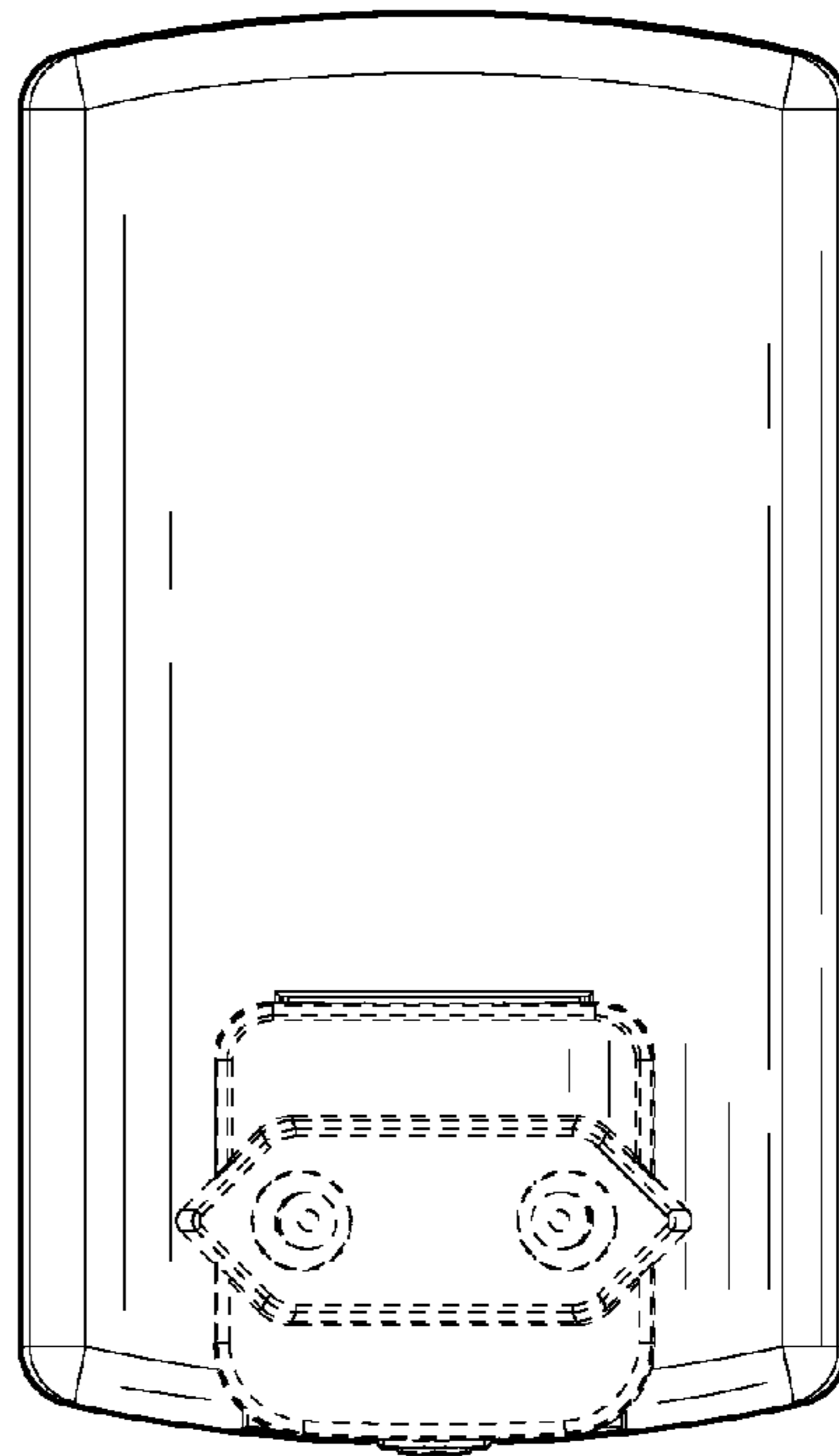

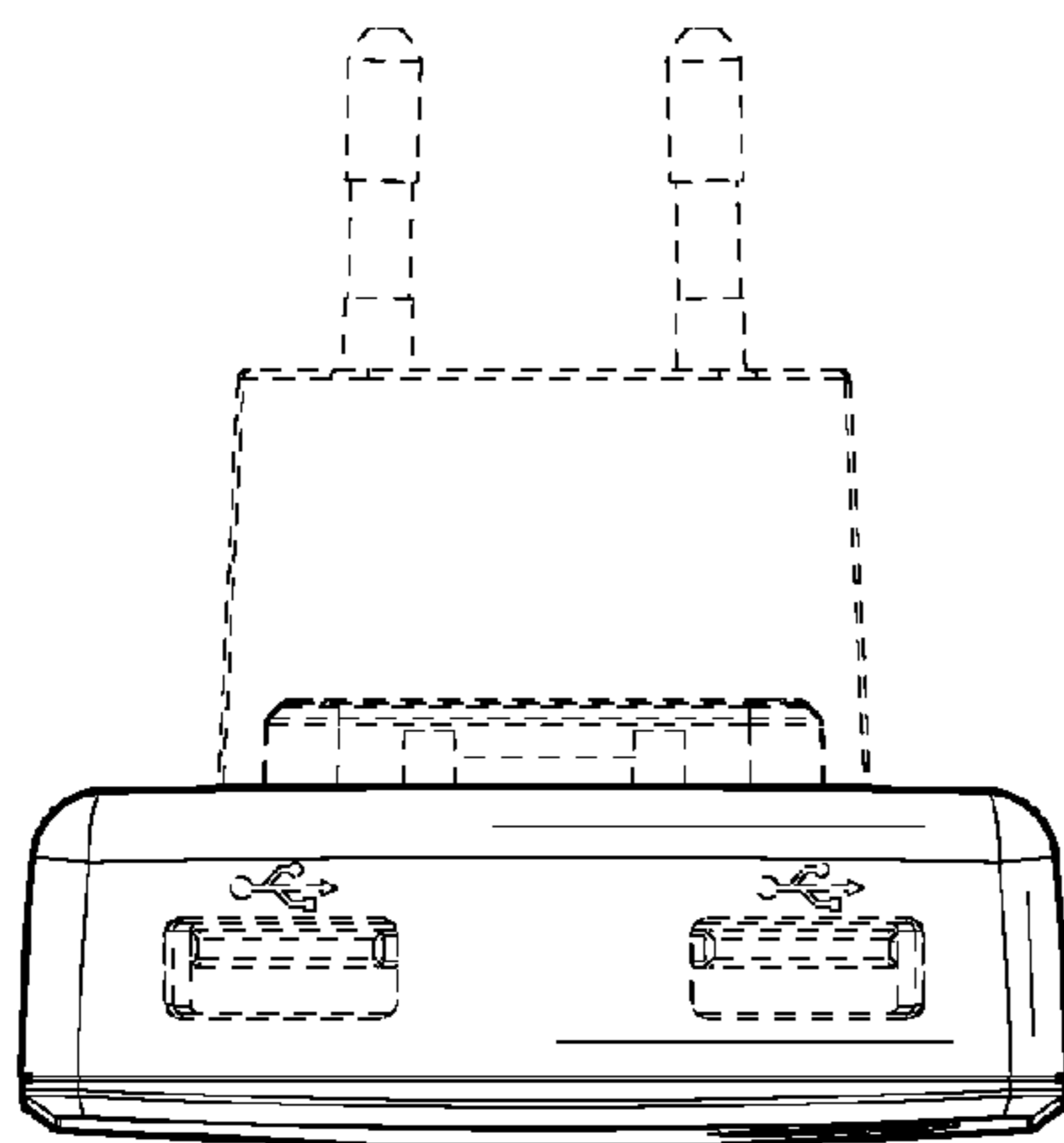

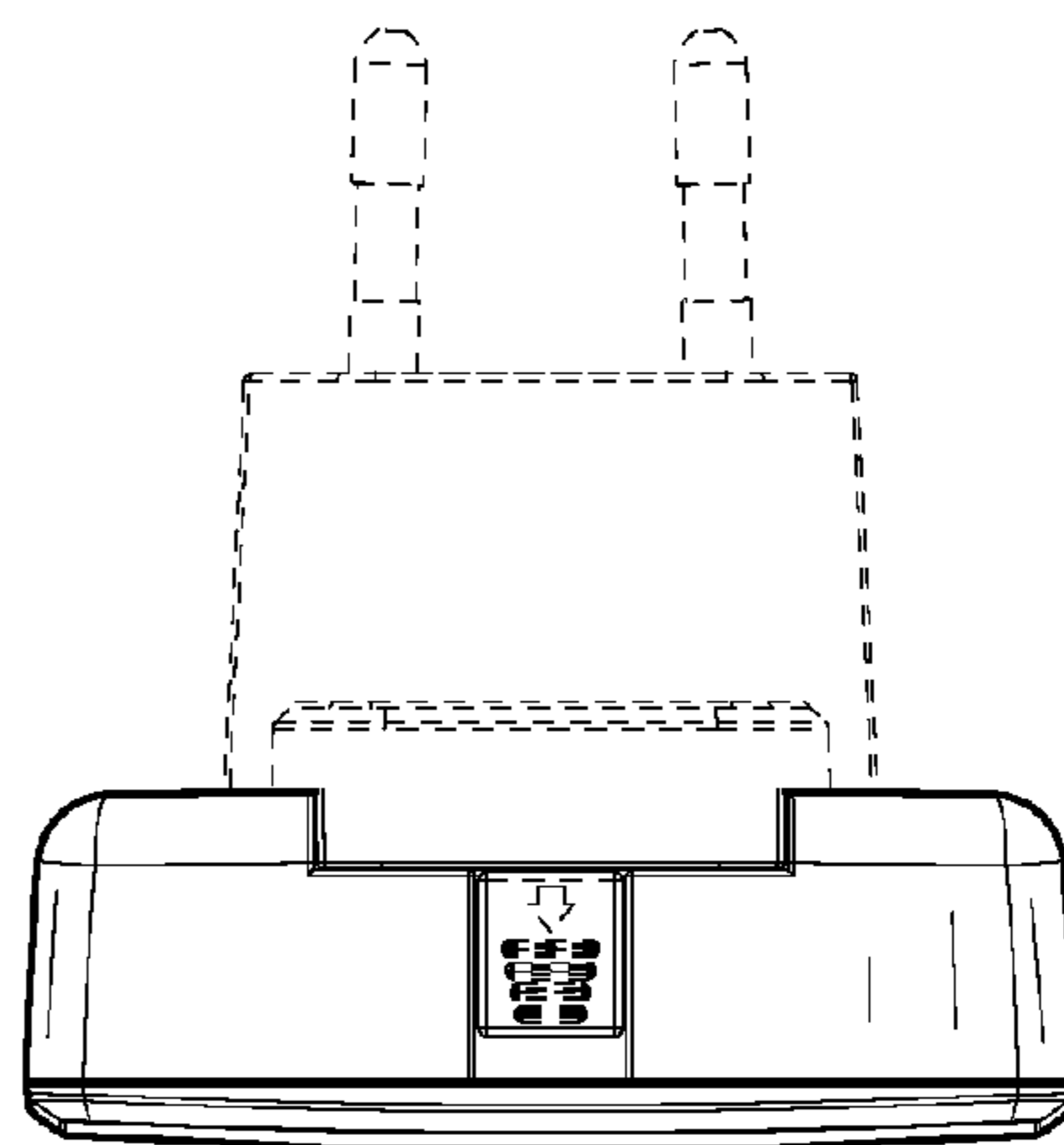

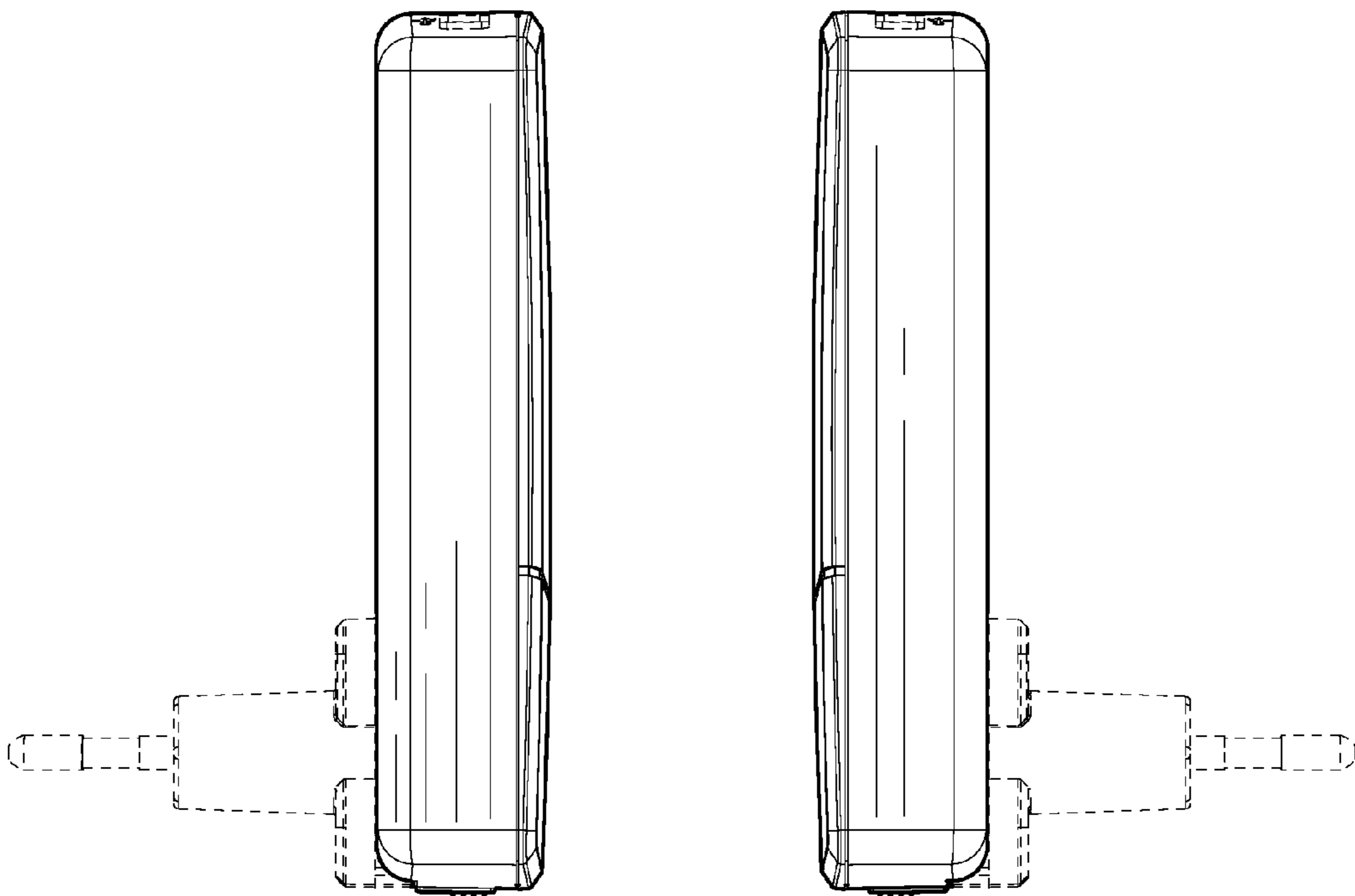
