(57) **CLAIM**

We claim the ornamental design for a remote control keypad, as shown and described.

FIG. 18 is a bottom view thereof.

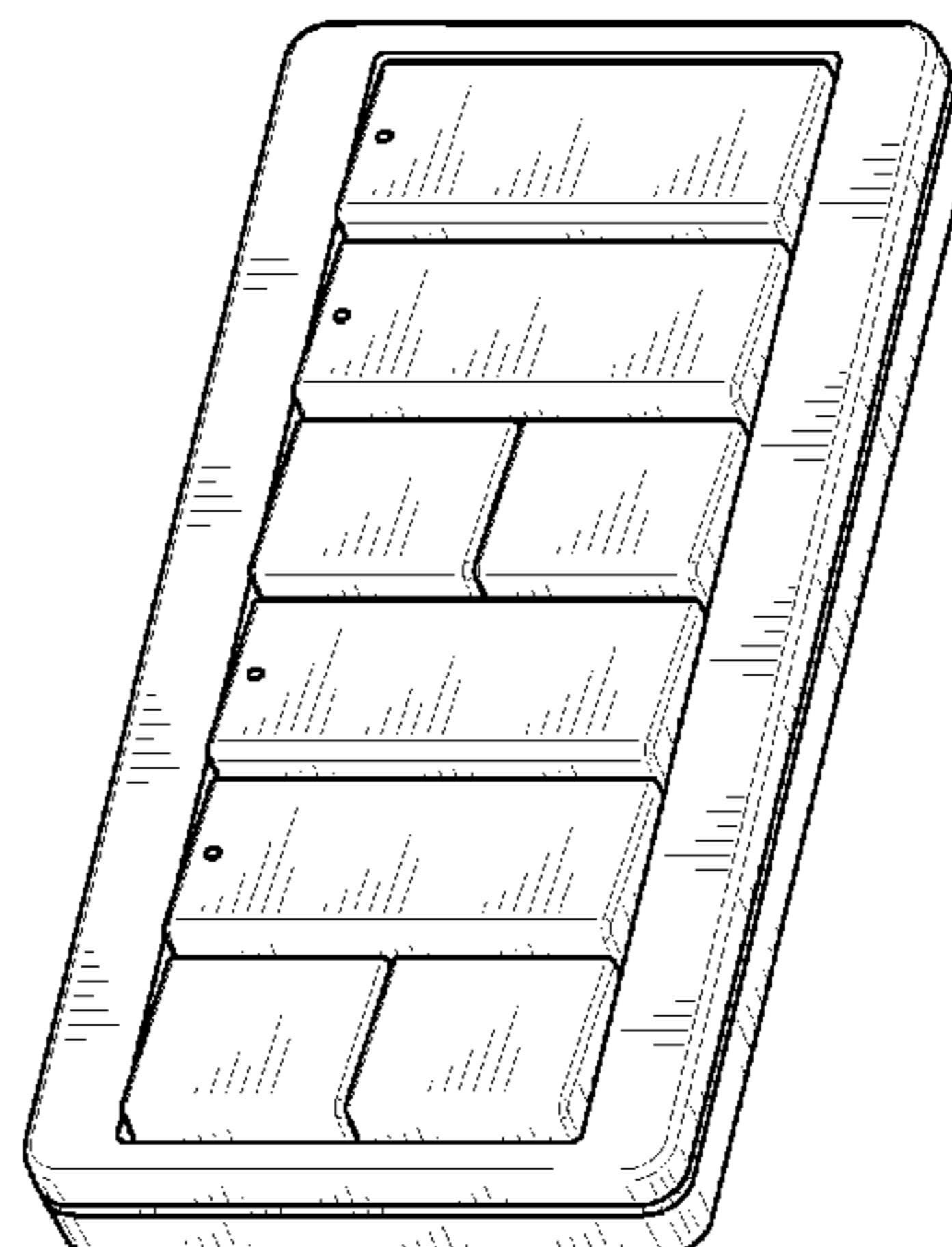
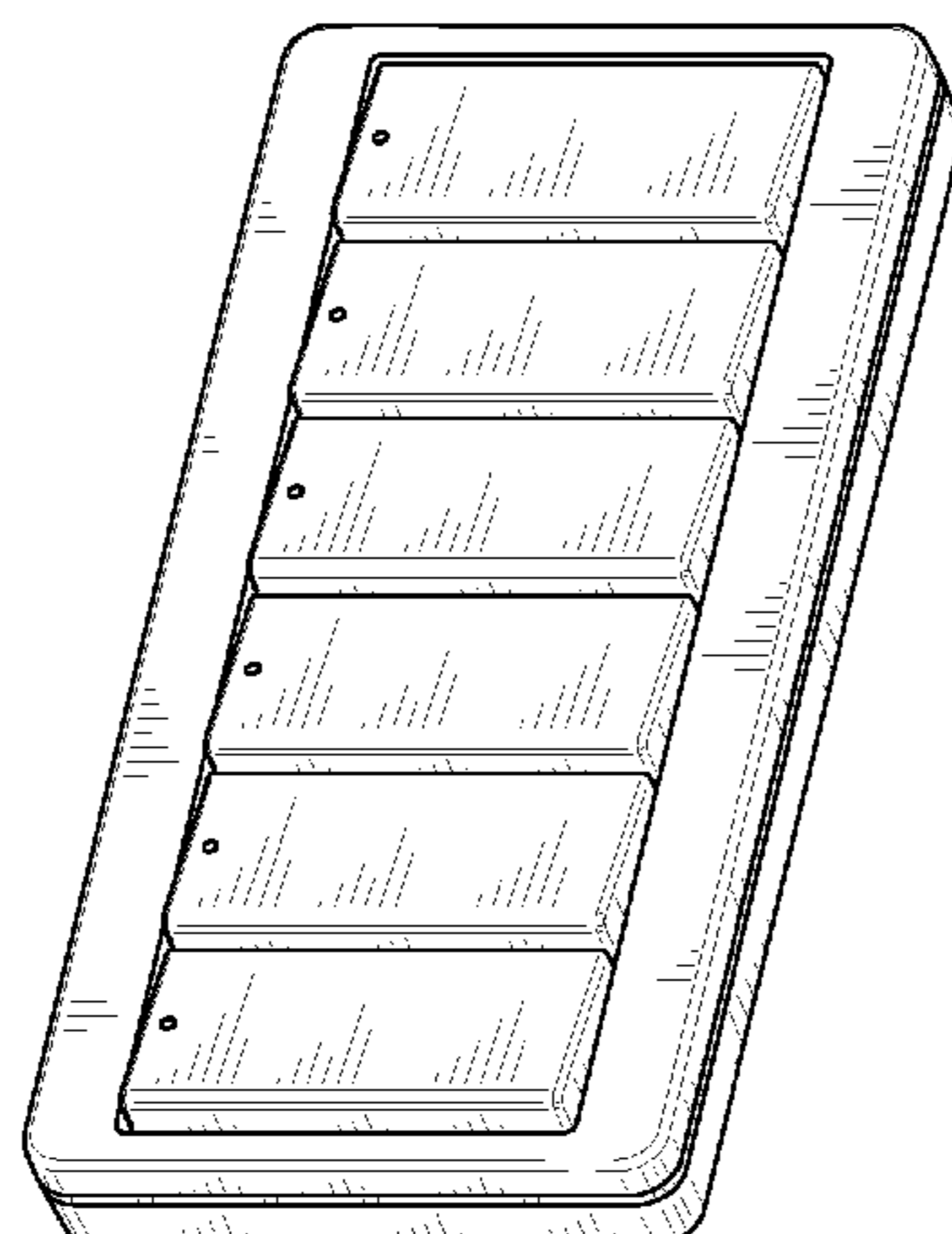


FIG. 19 is a perspective view of a remote control keypad according to a fourth embodiment of our new design.

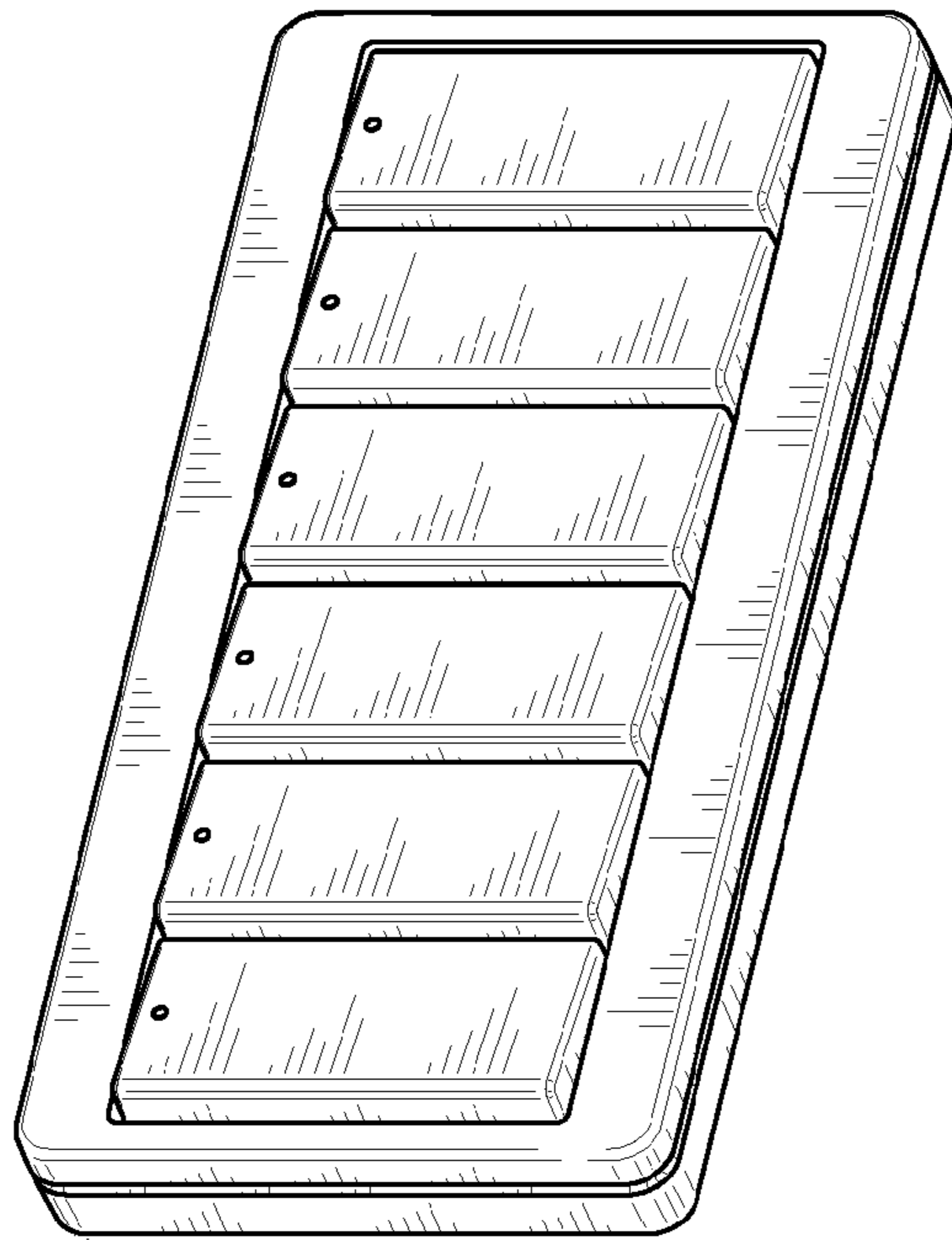

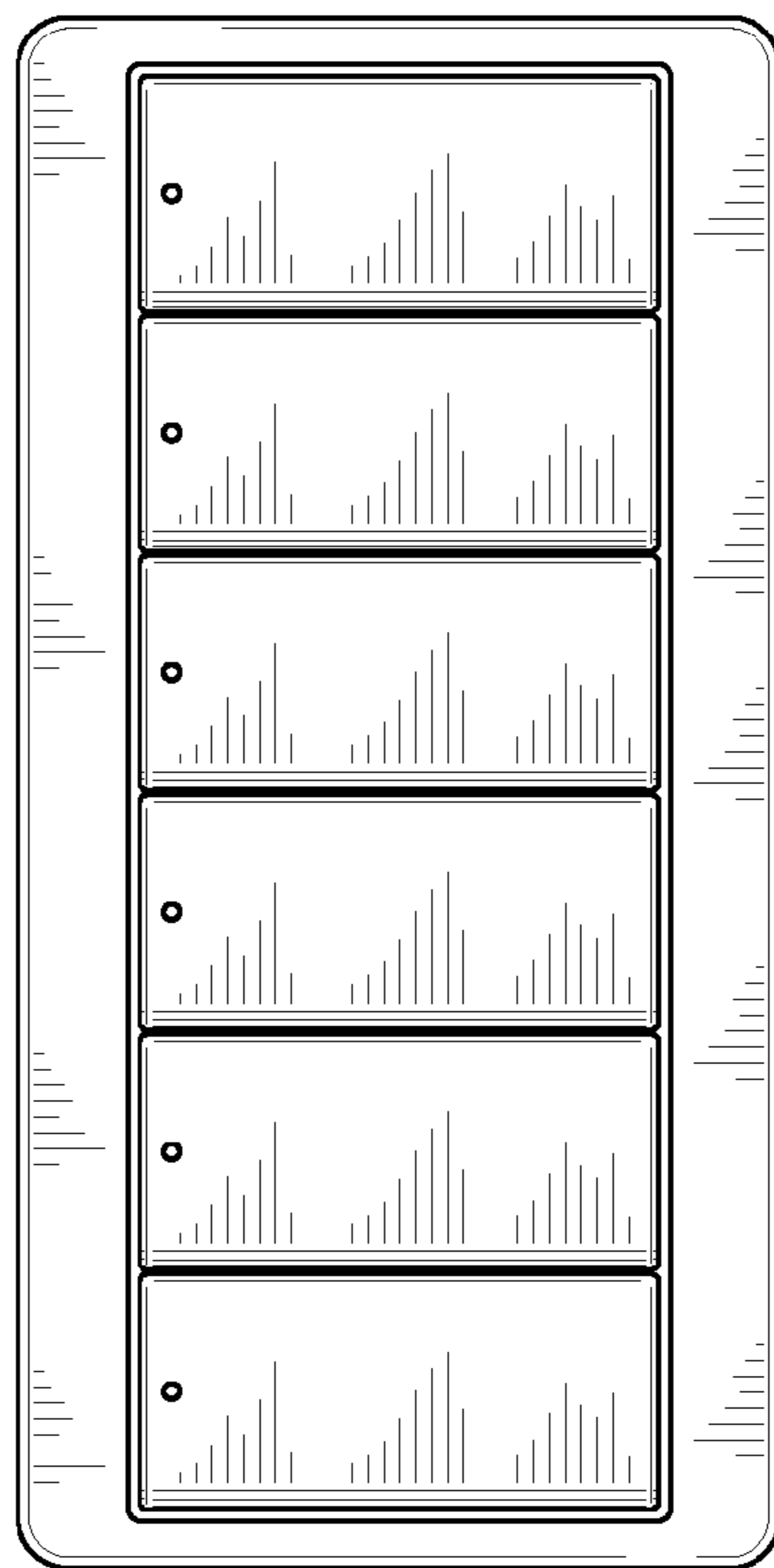

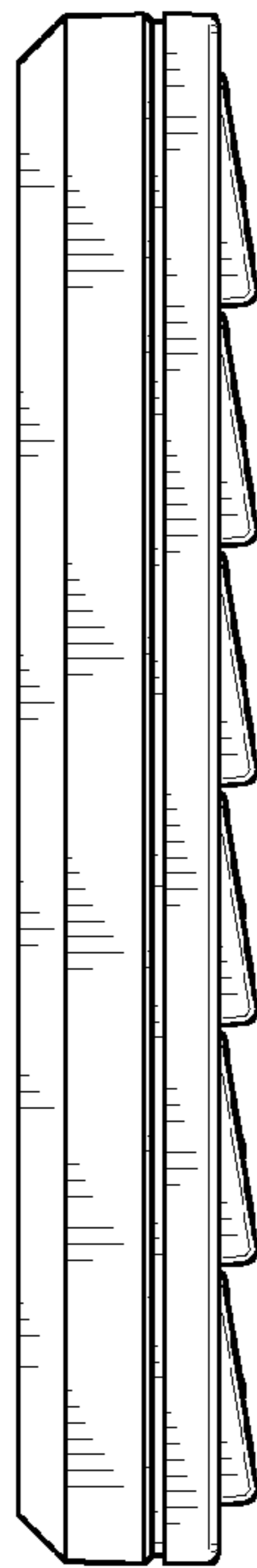

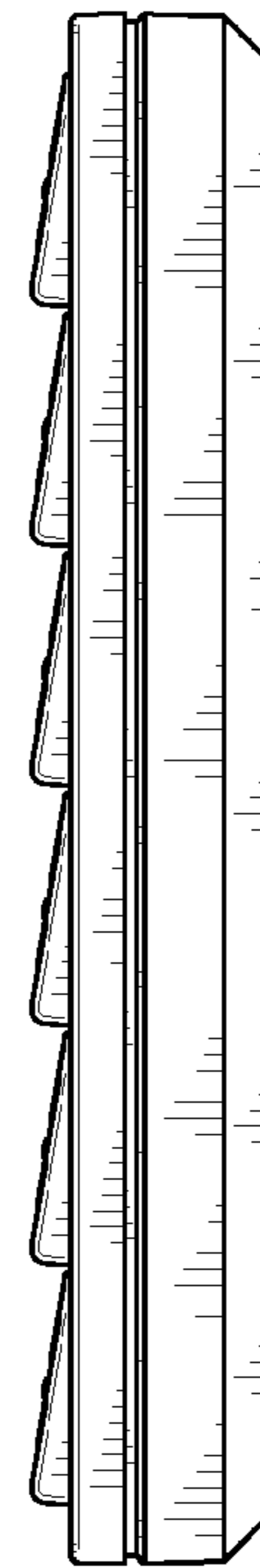

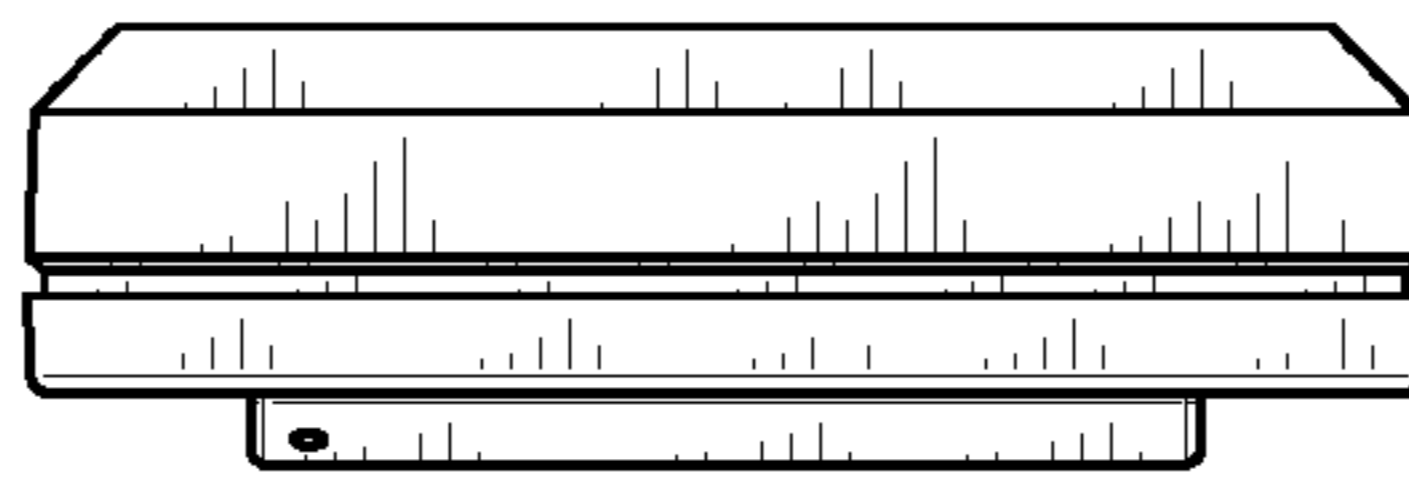

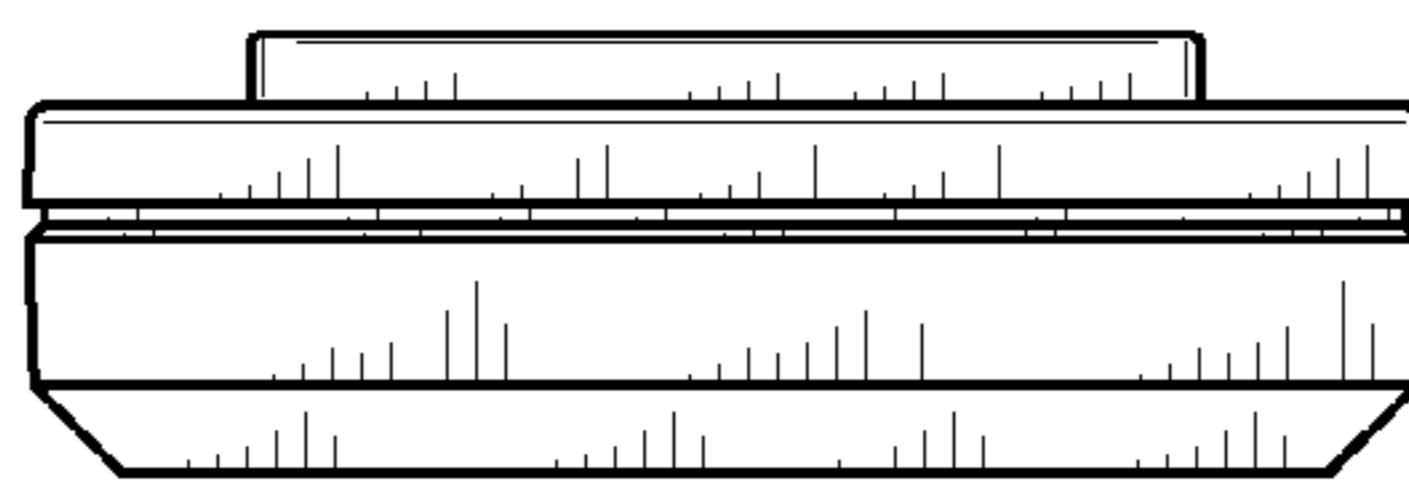

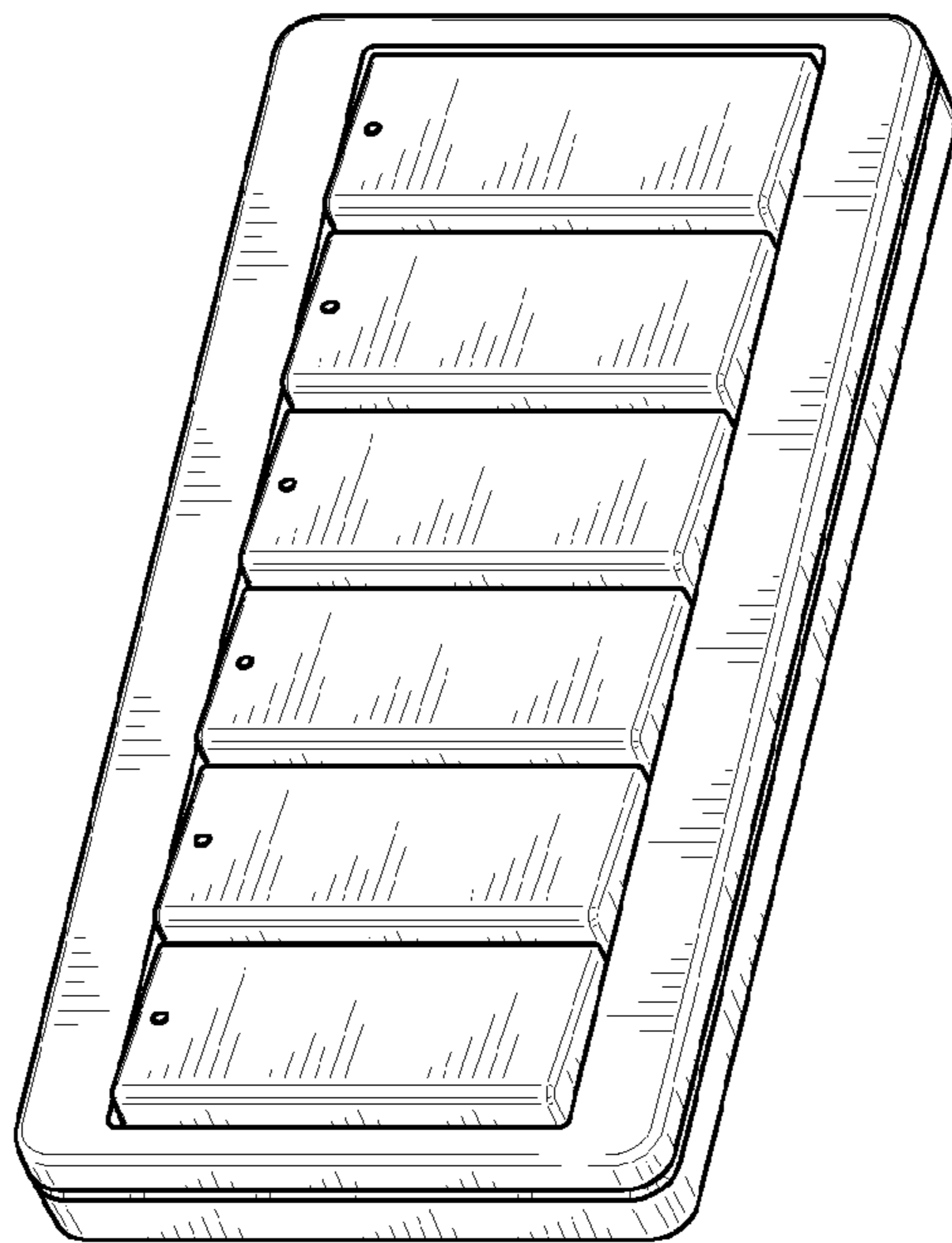

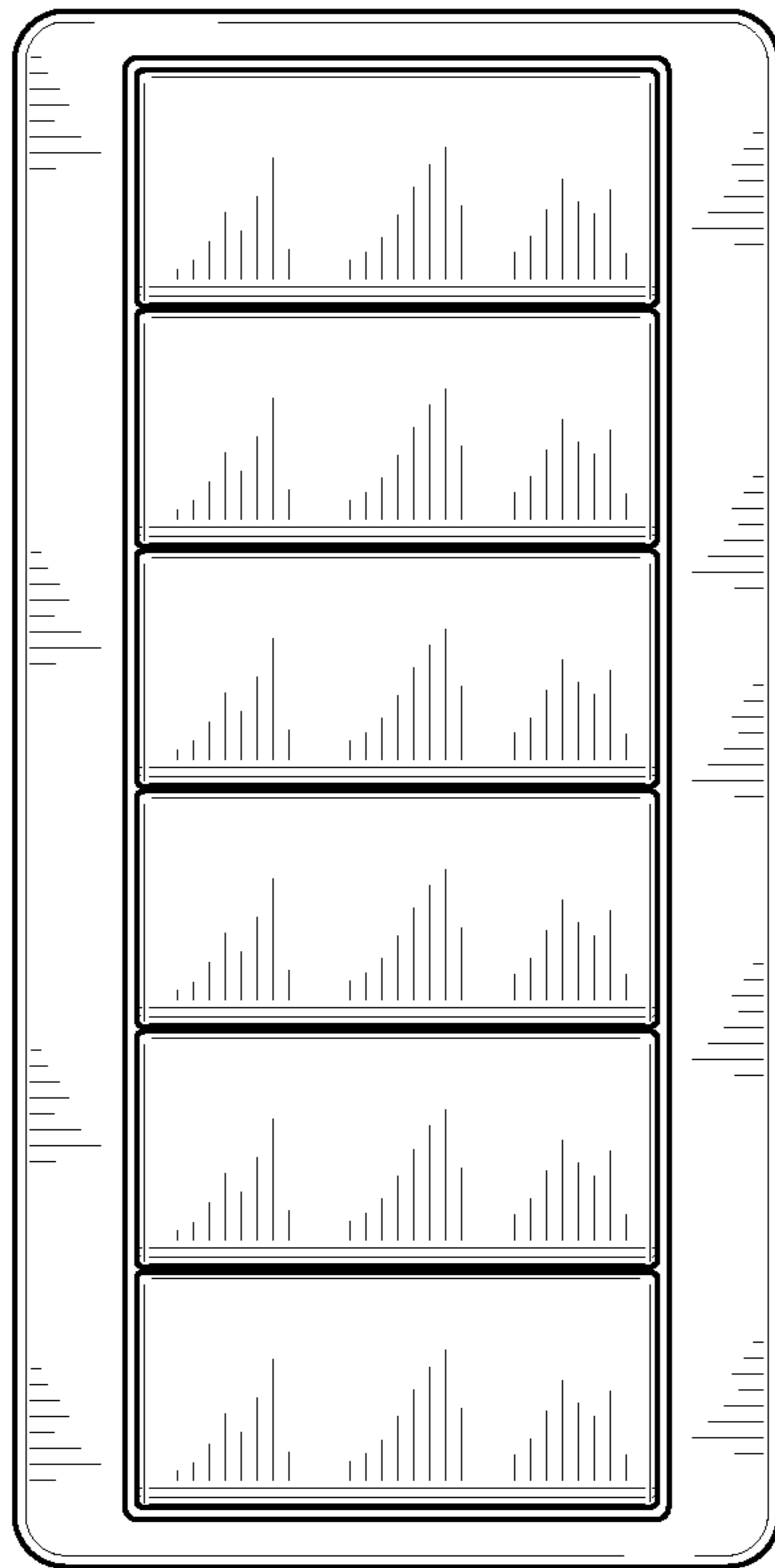

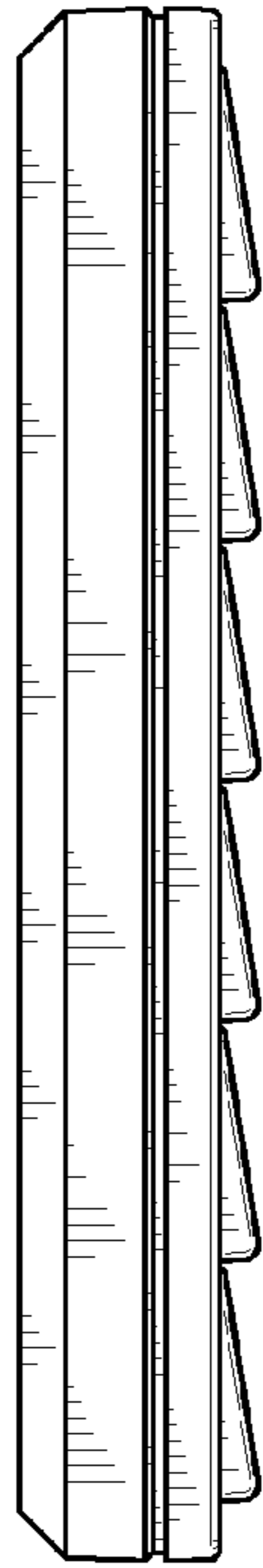

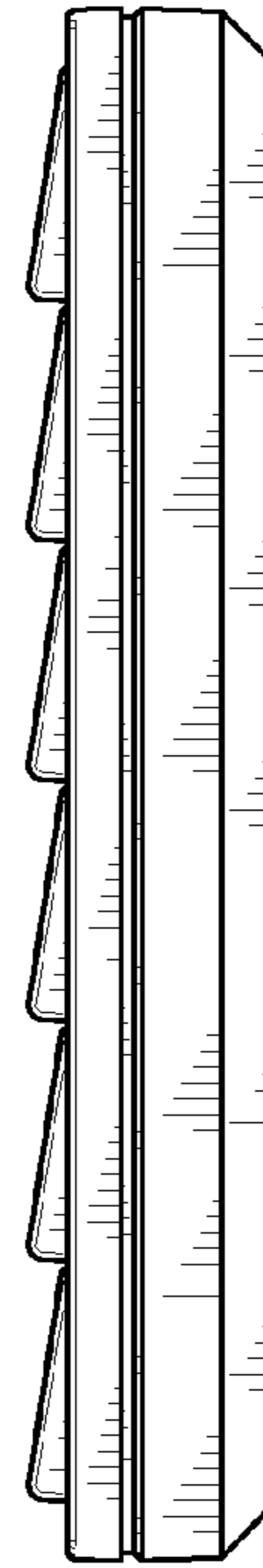

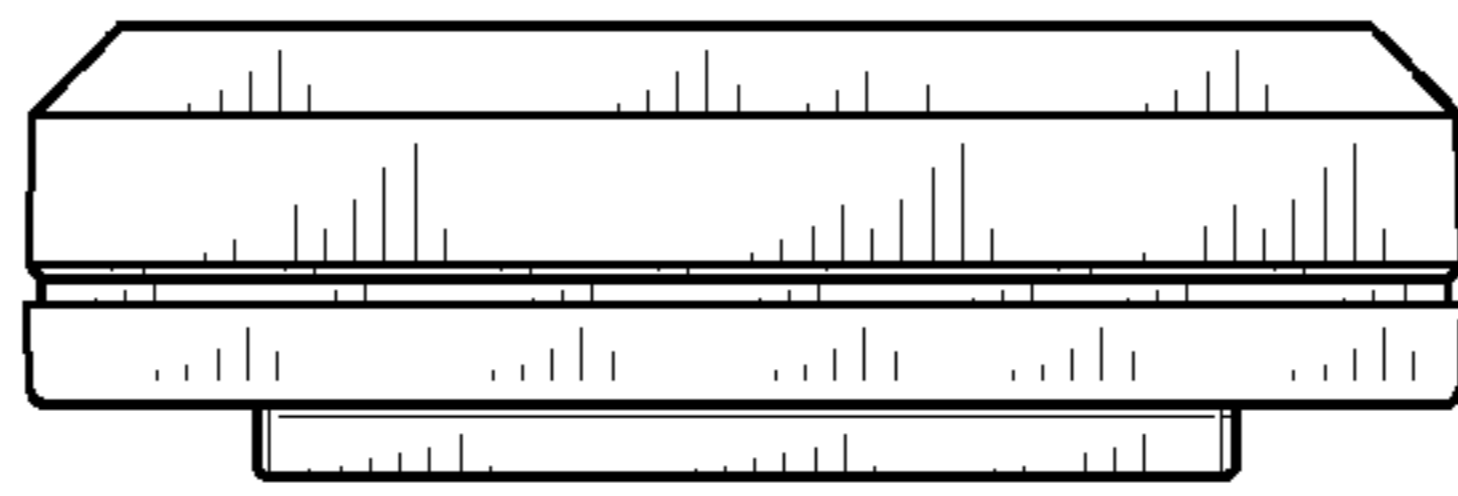

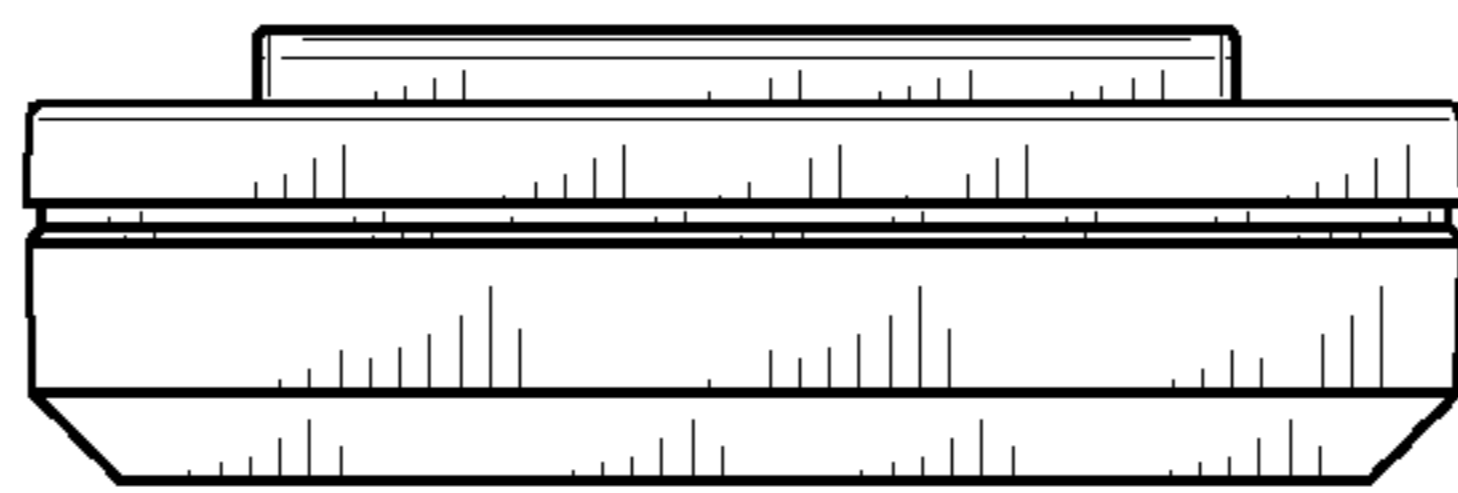

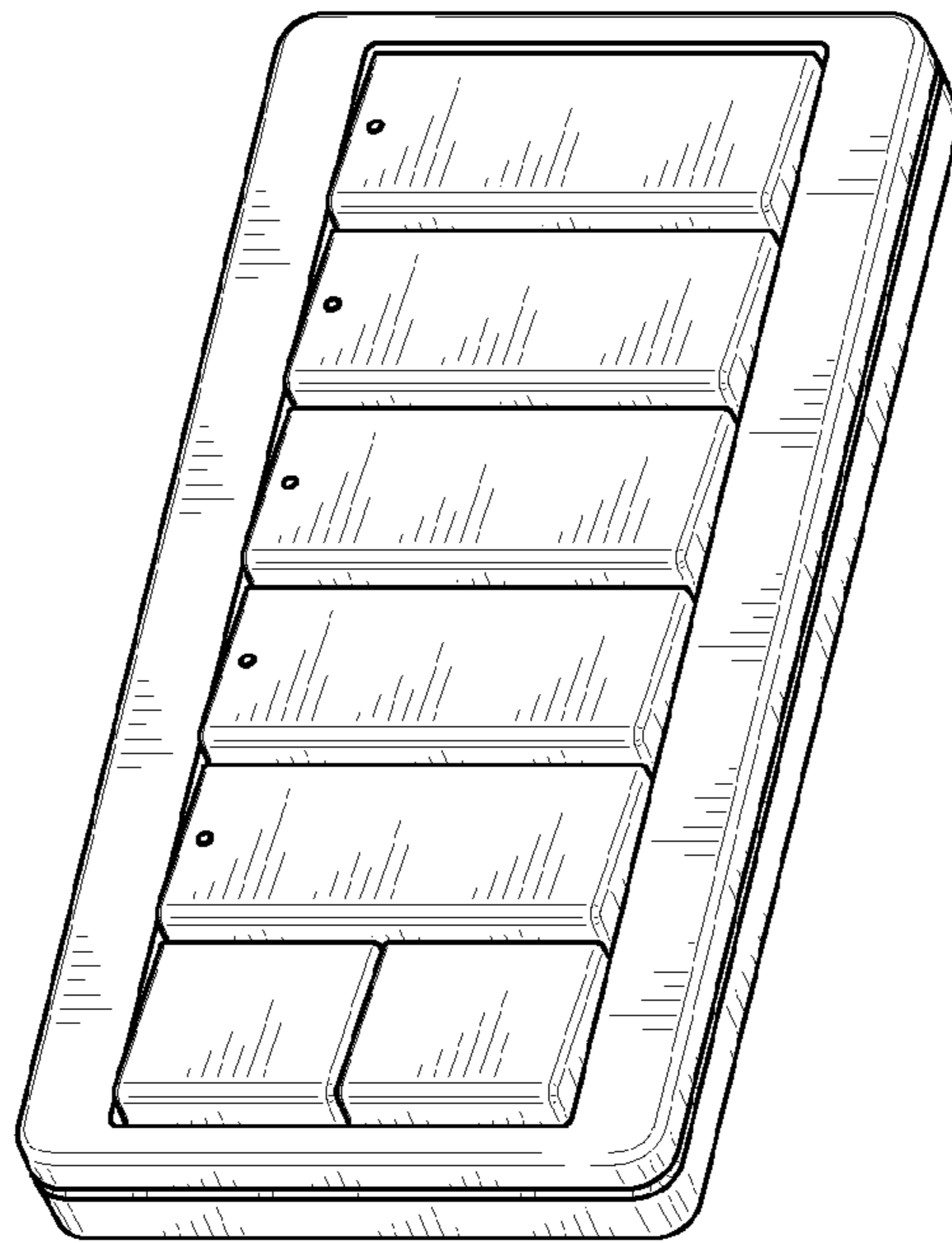

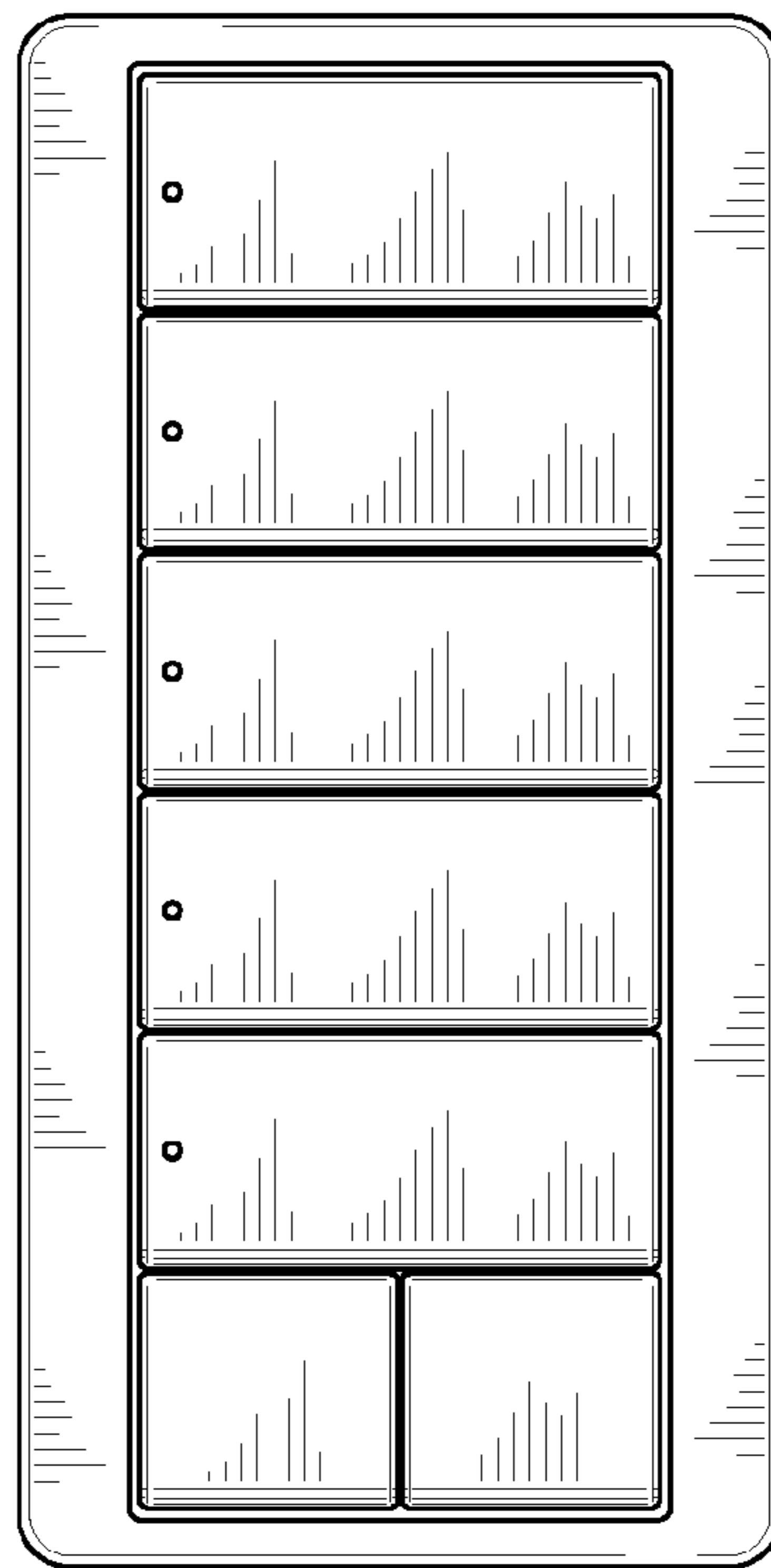

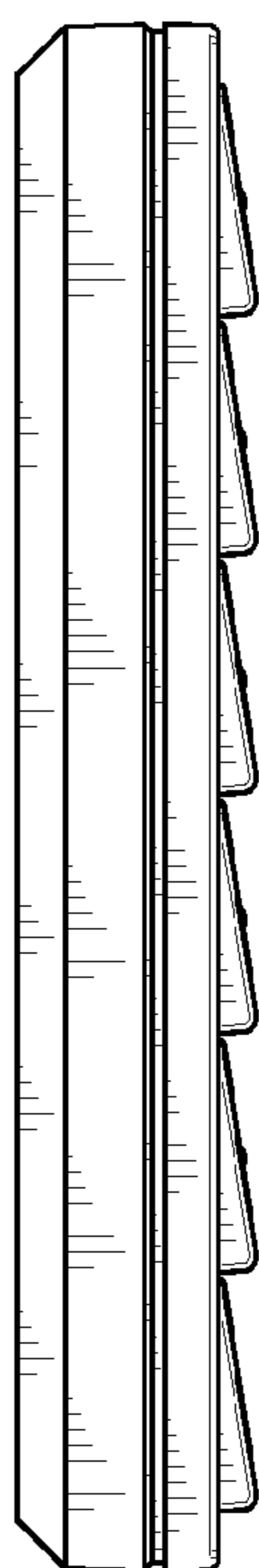

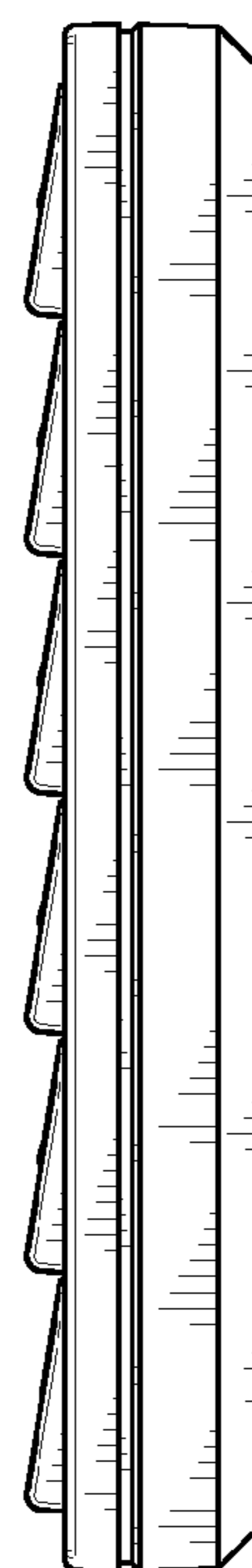

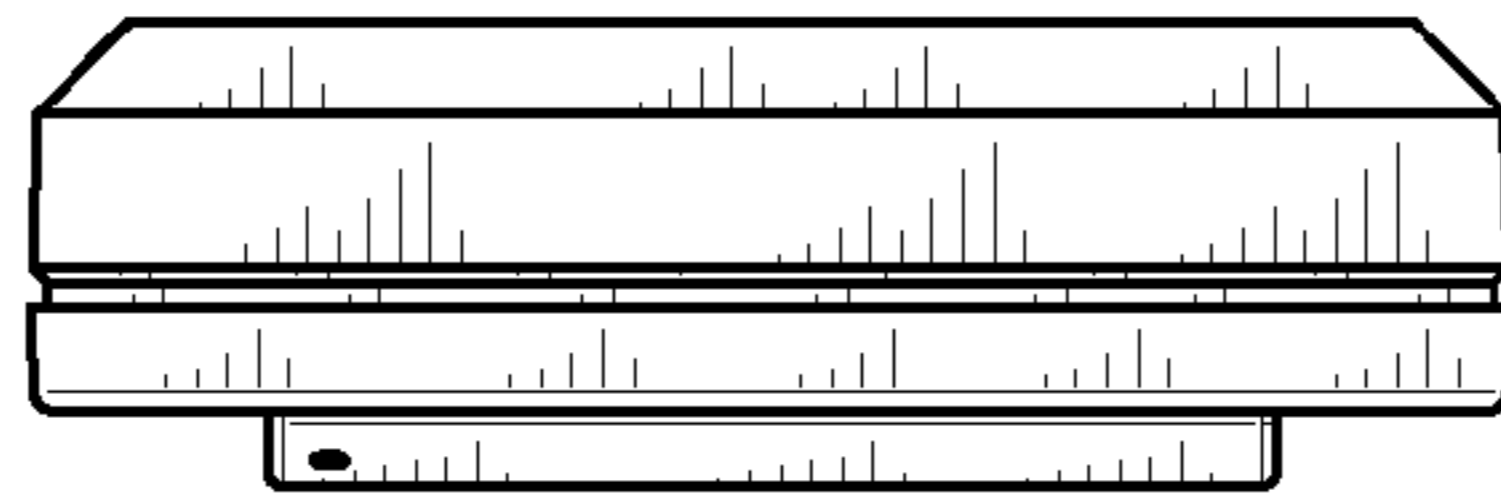

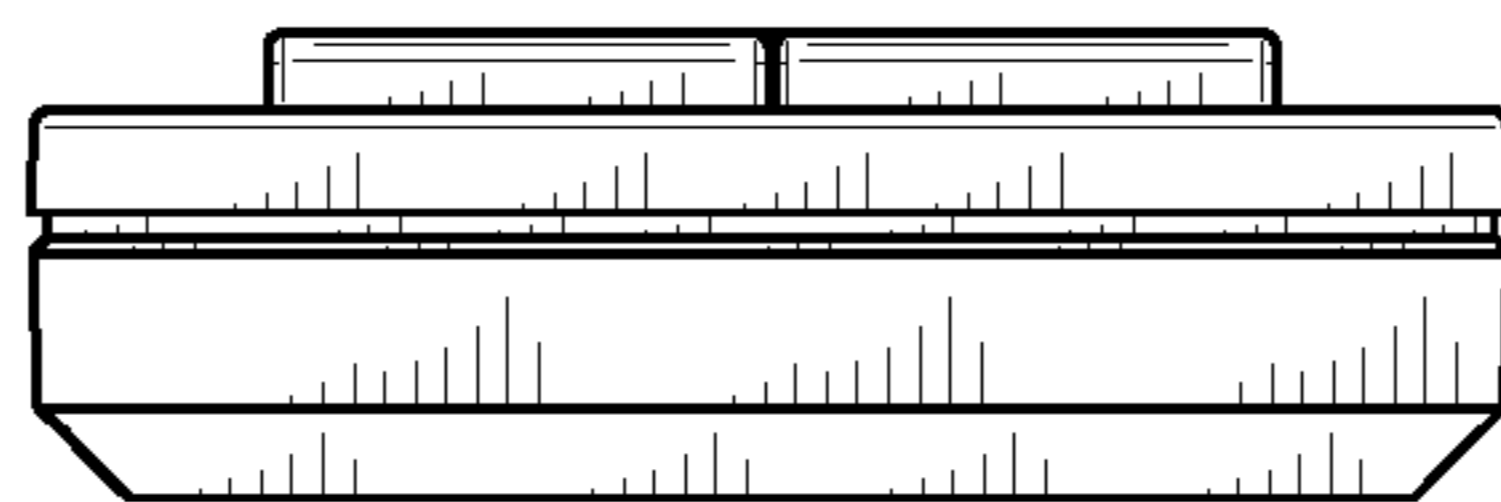

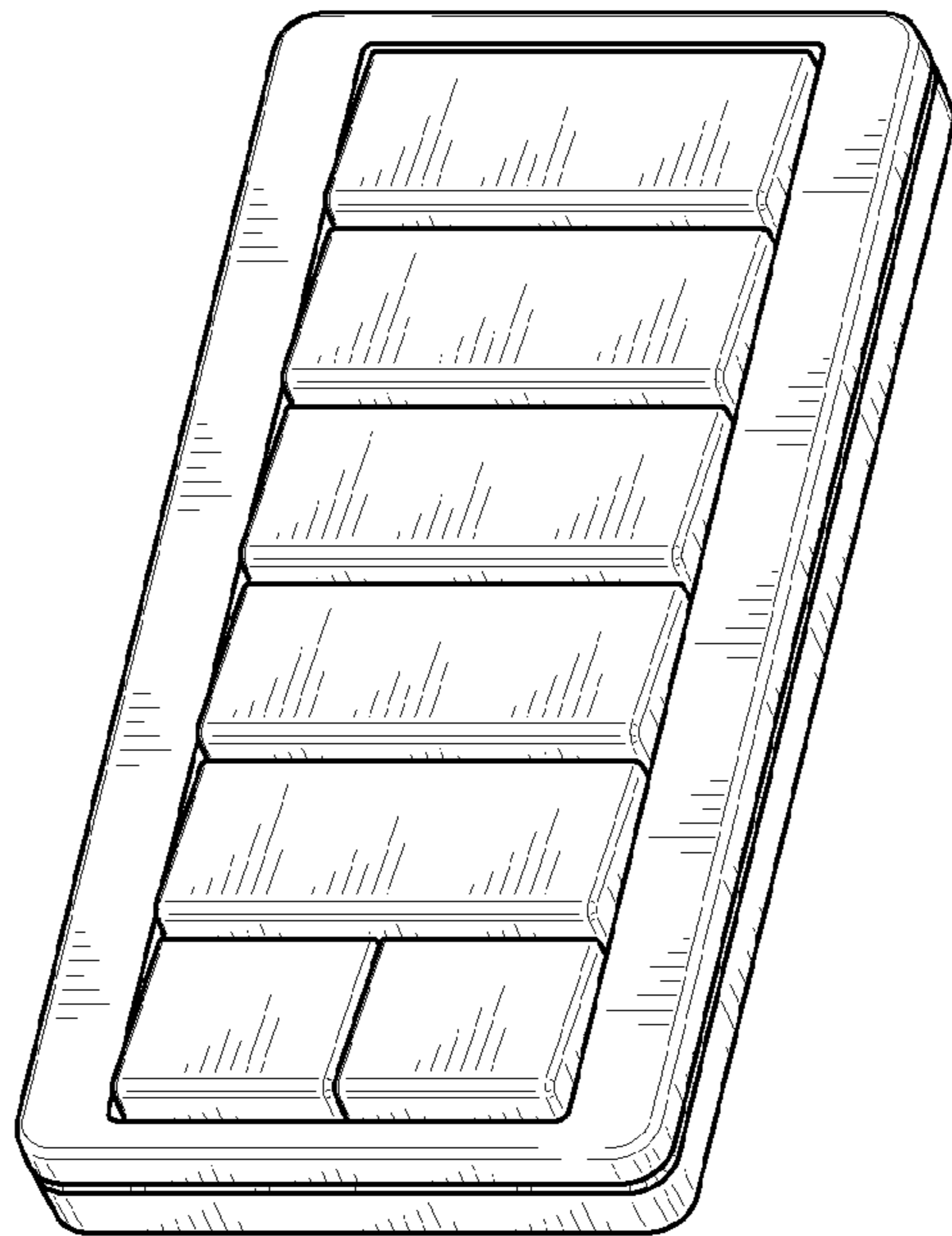

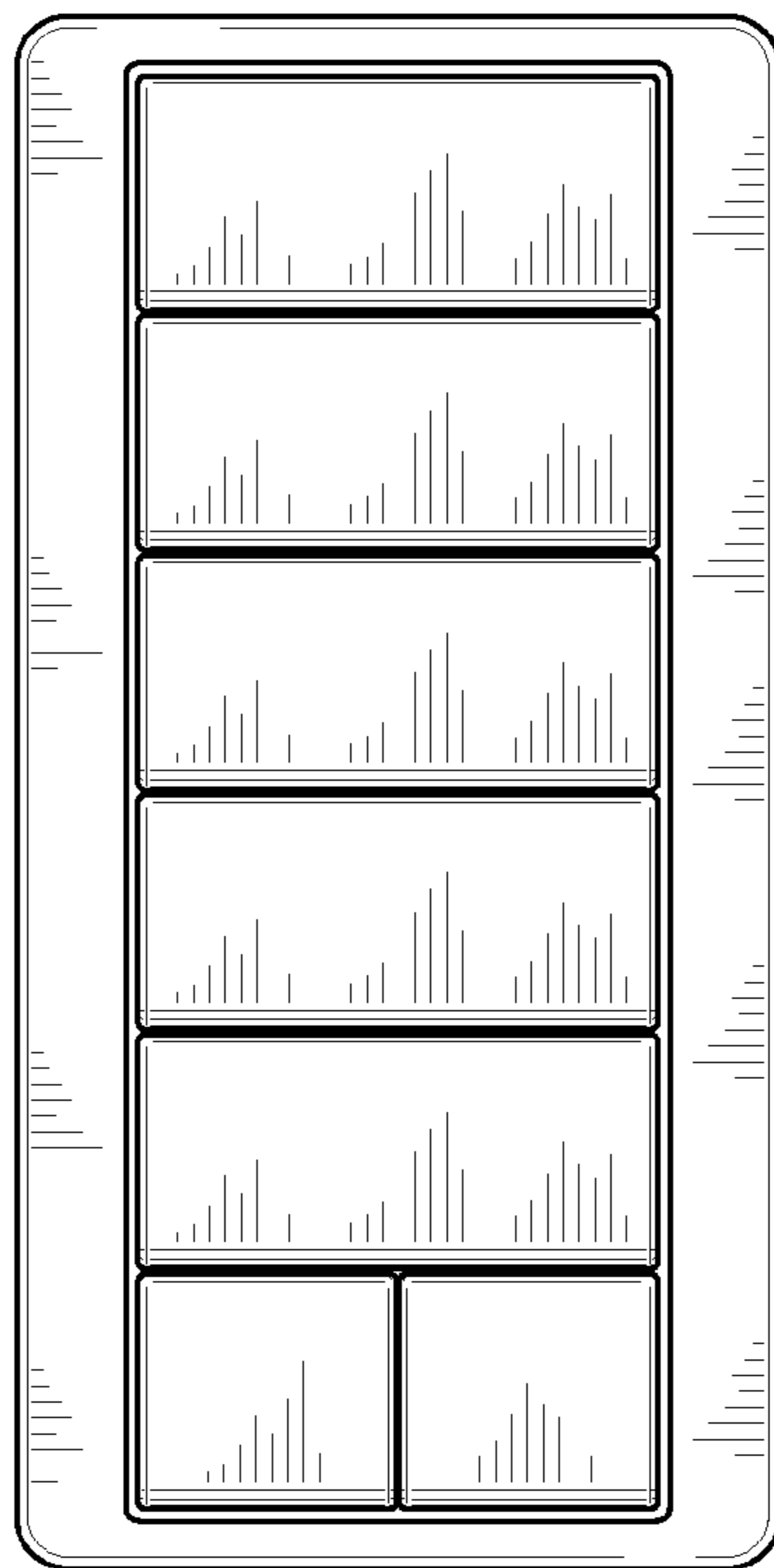

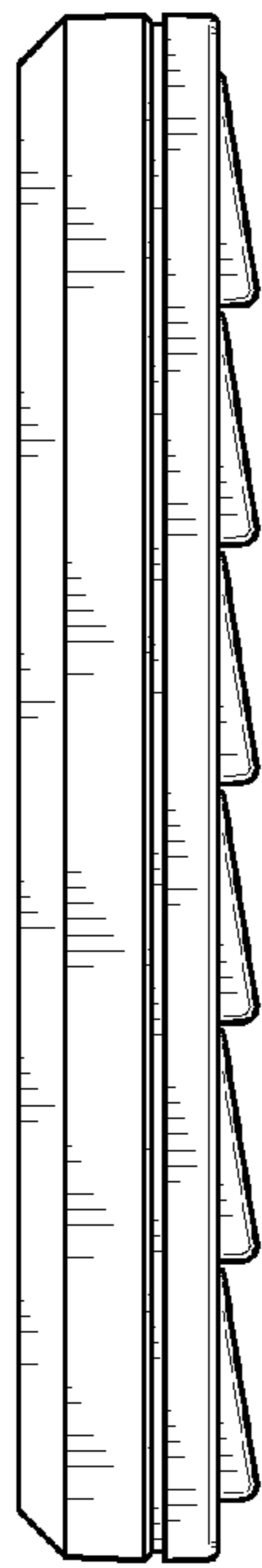

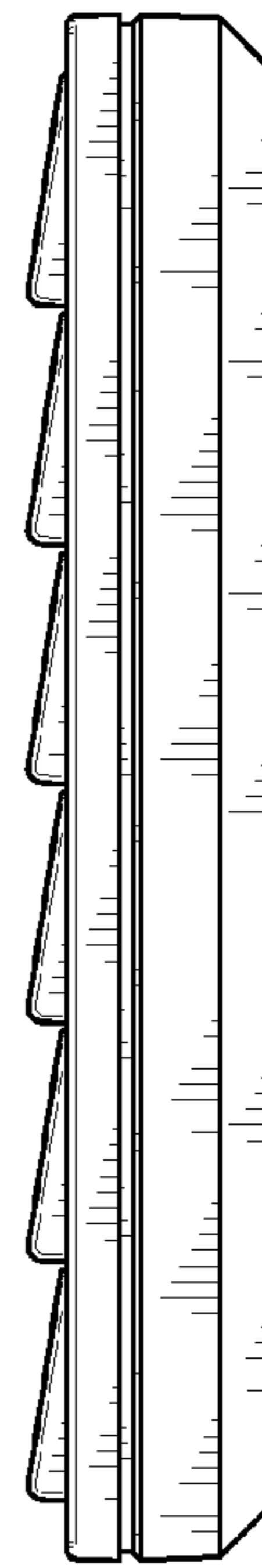

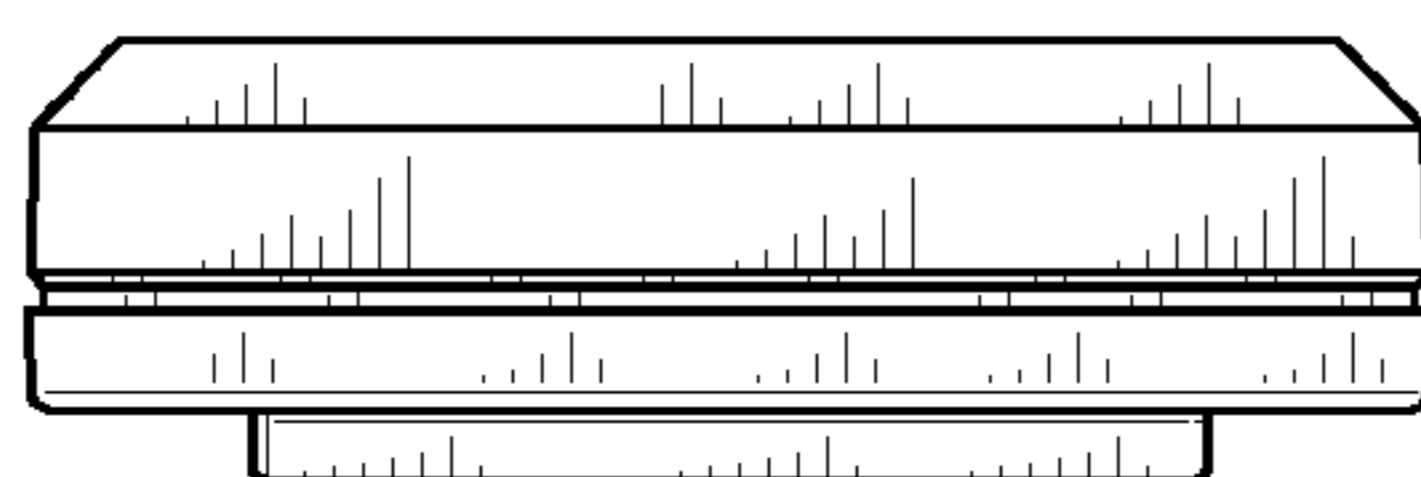

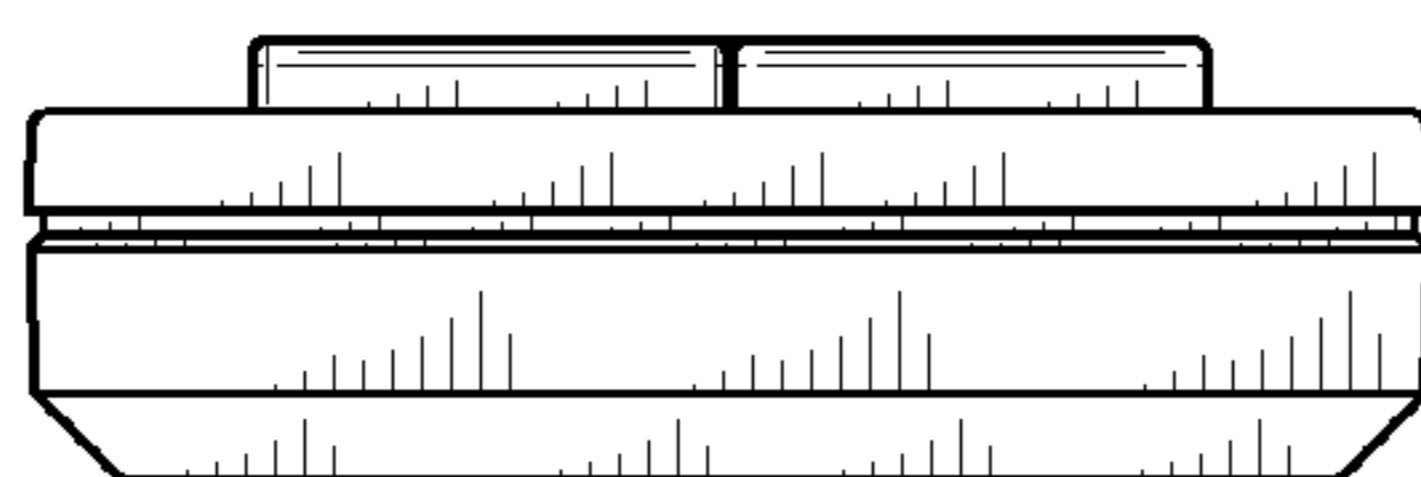

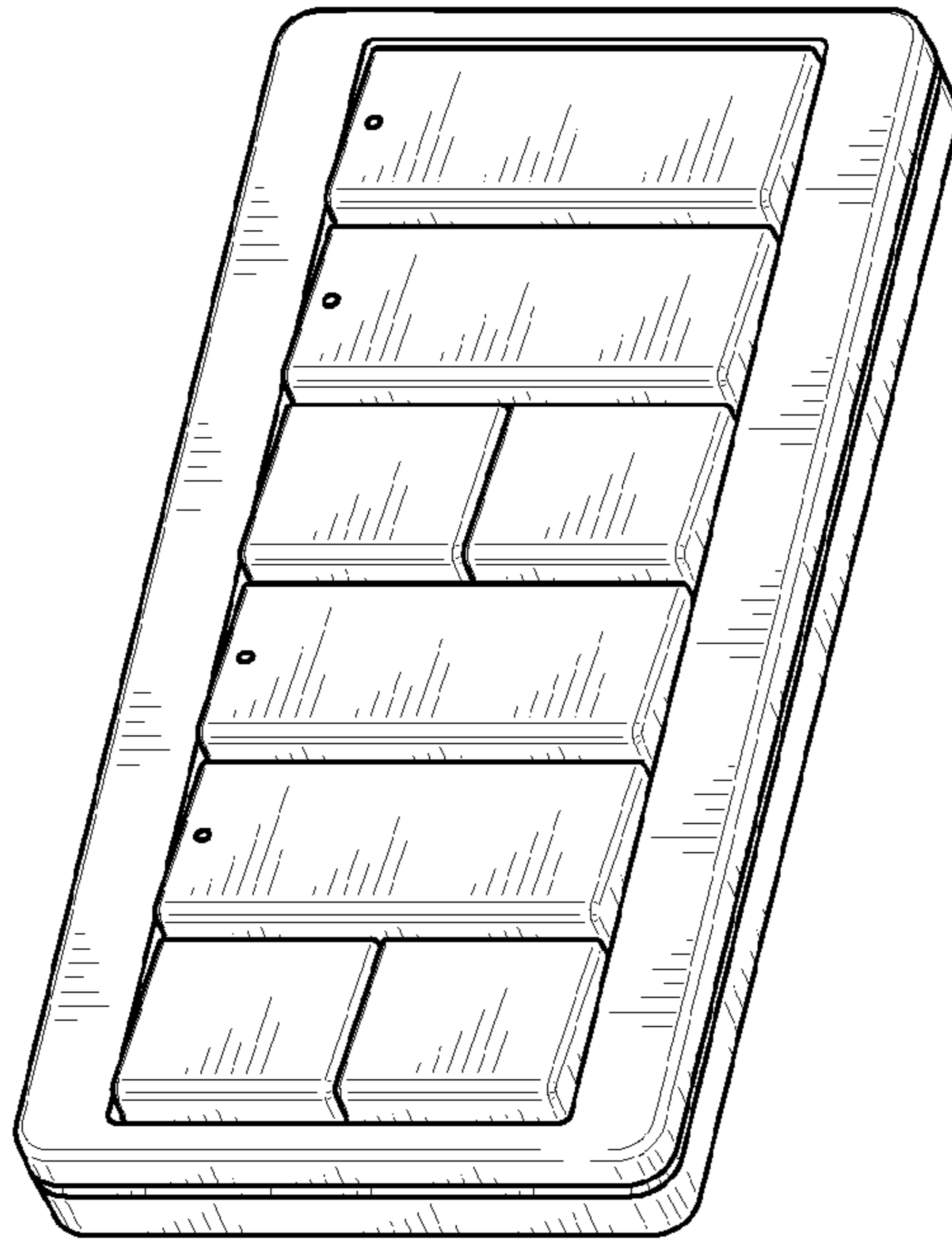

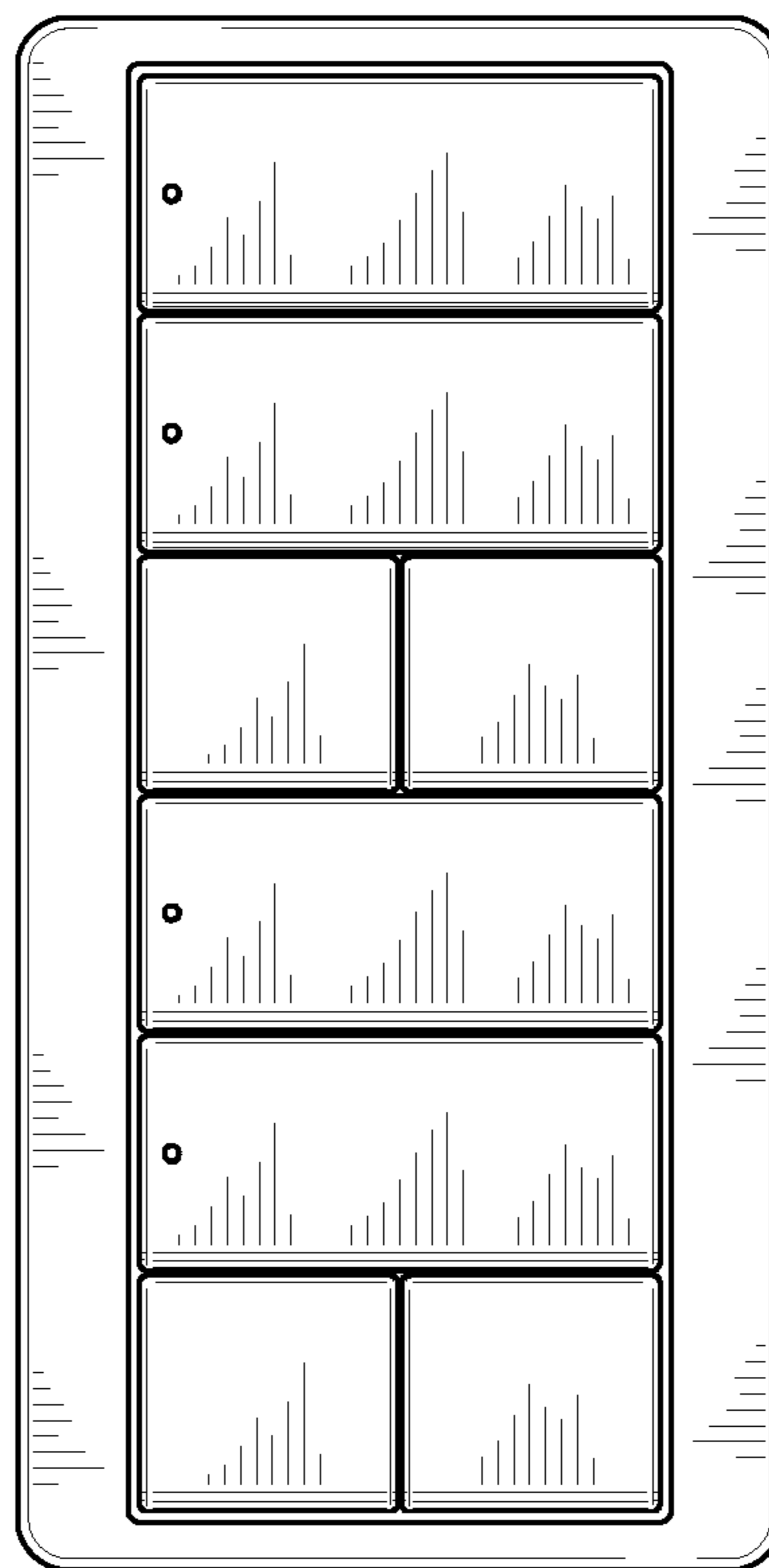

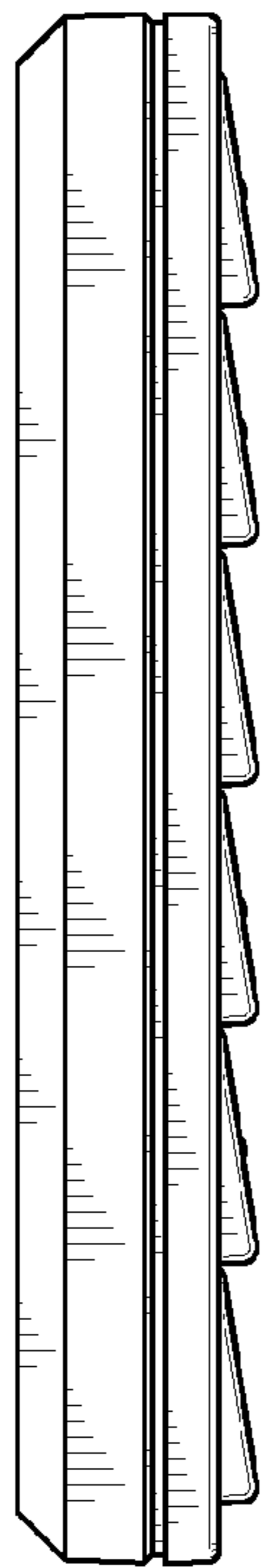

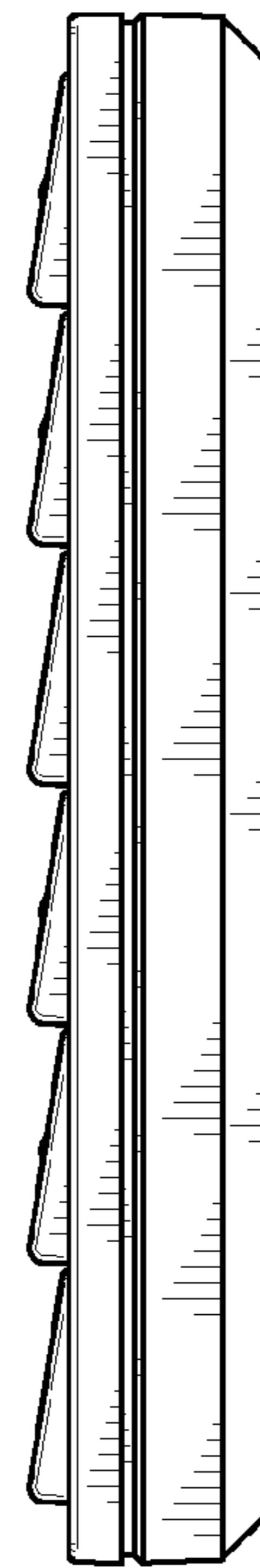

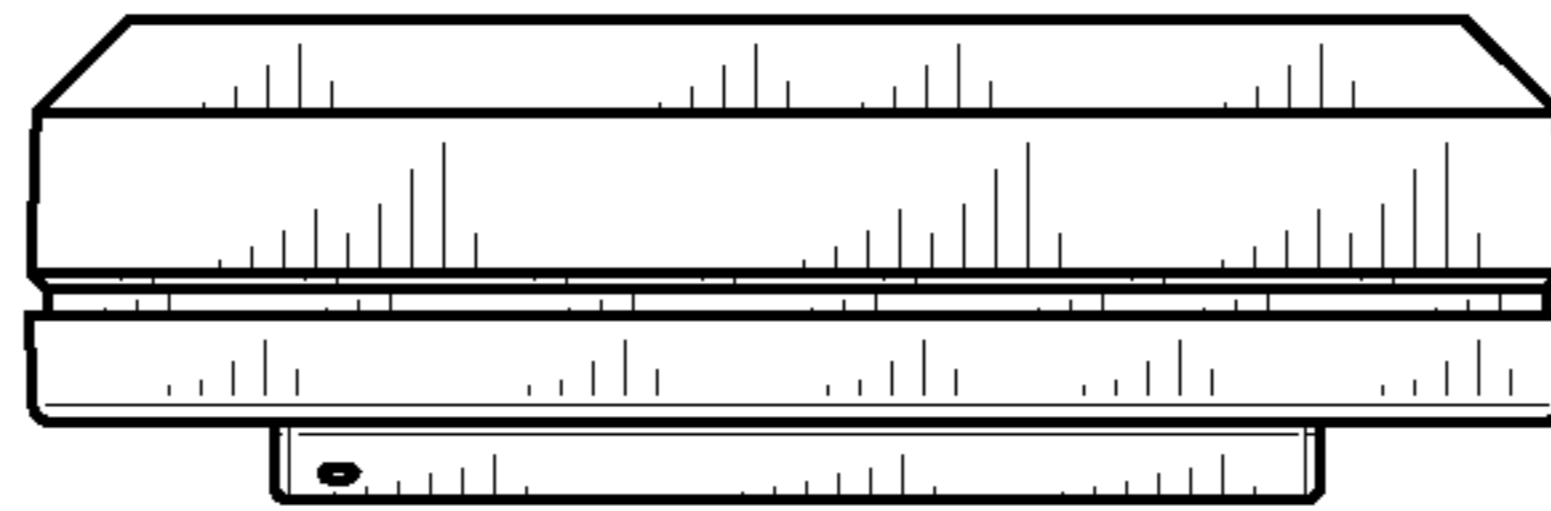

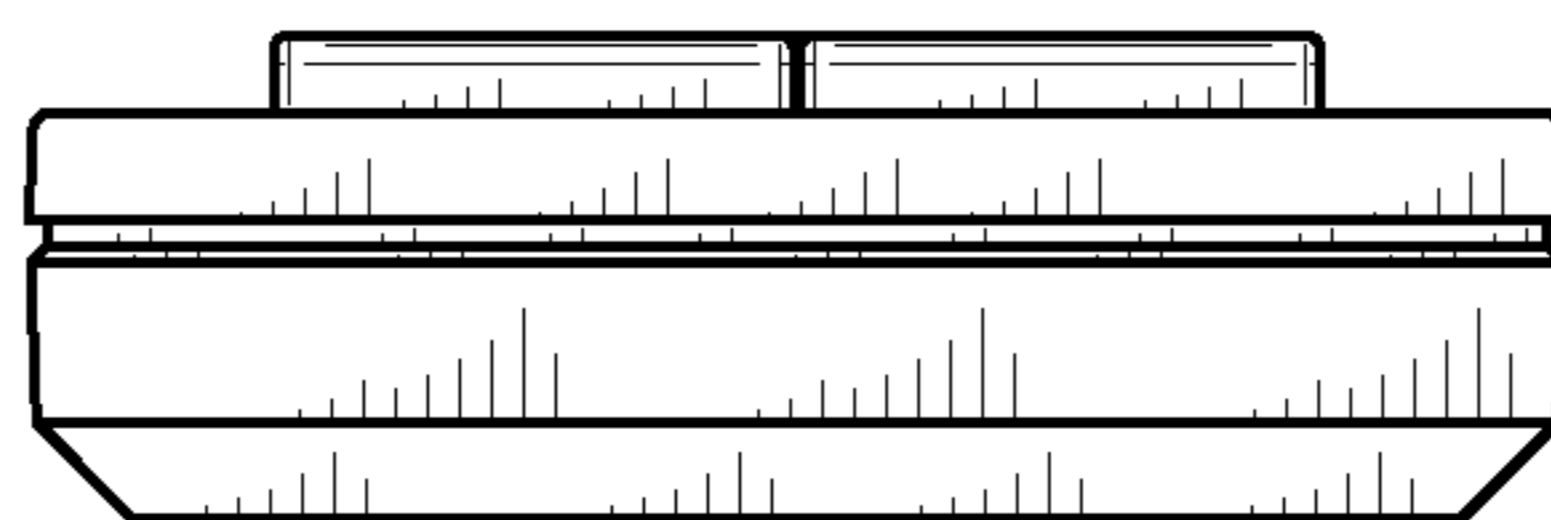

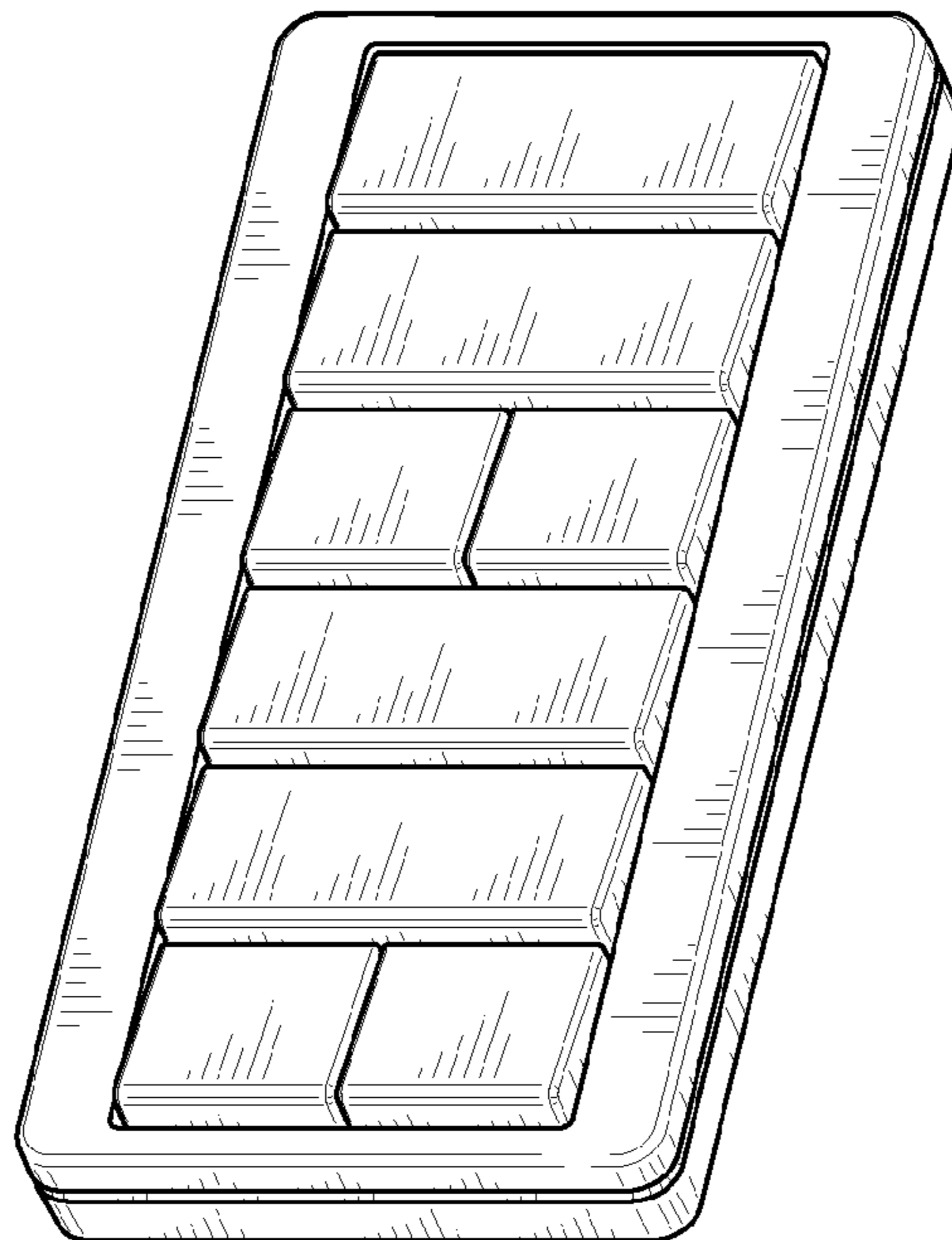

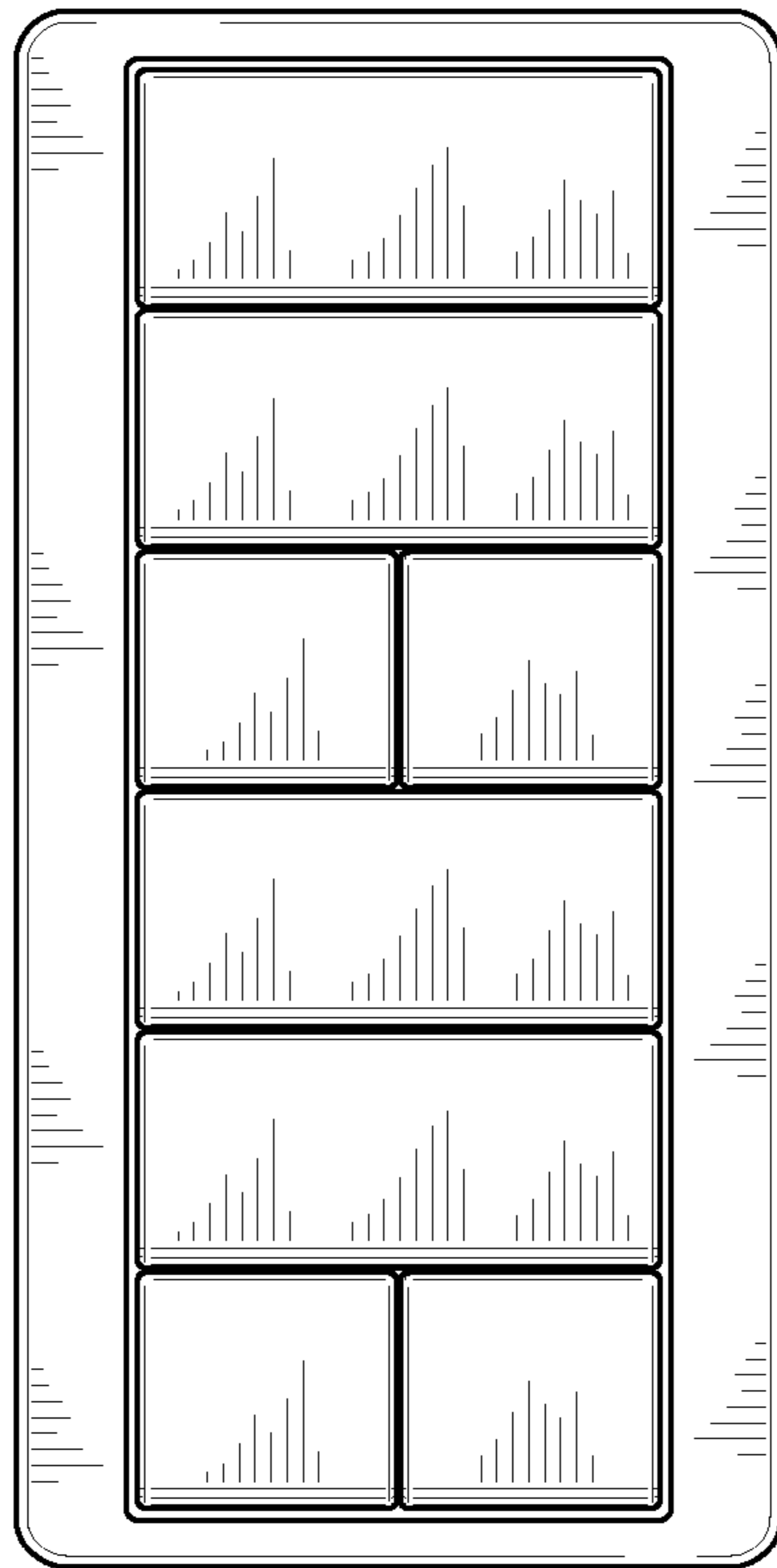

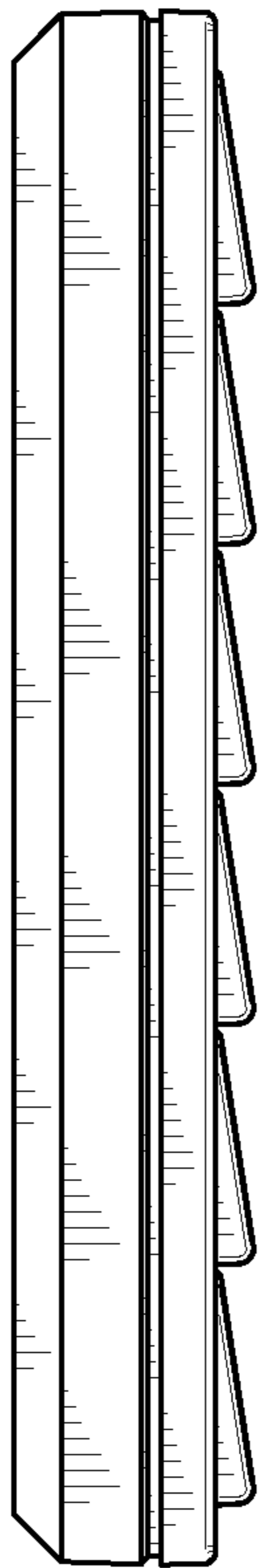

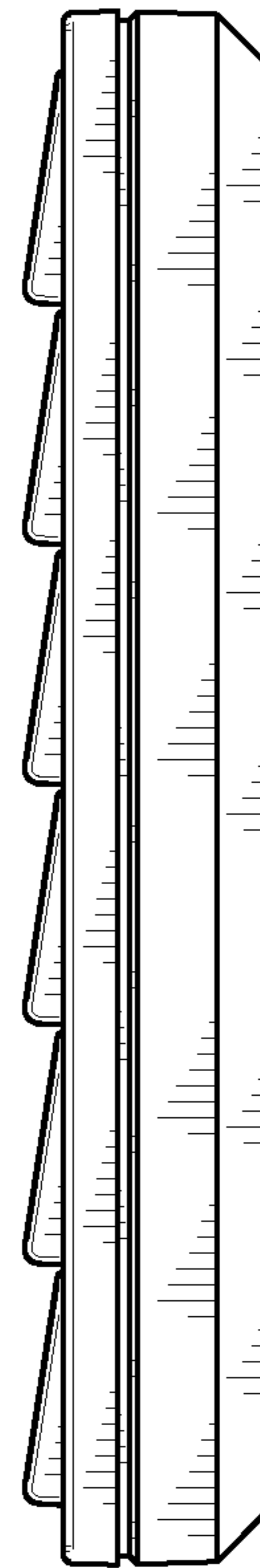

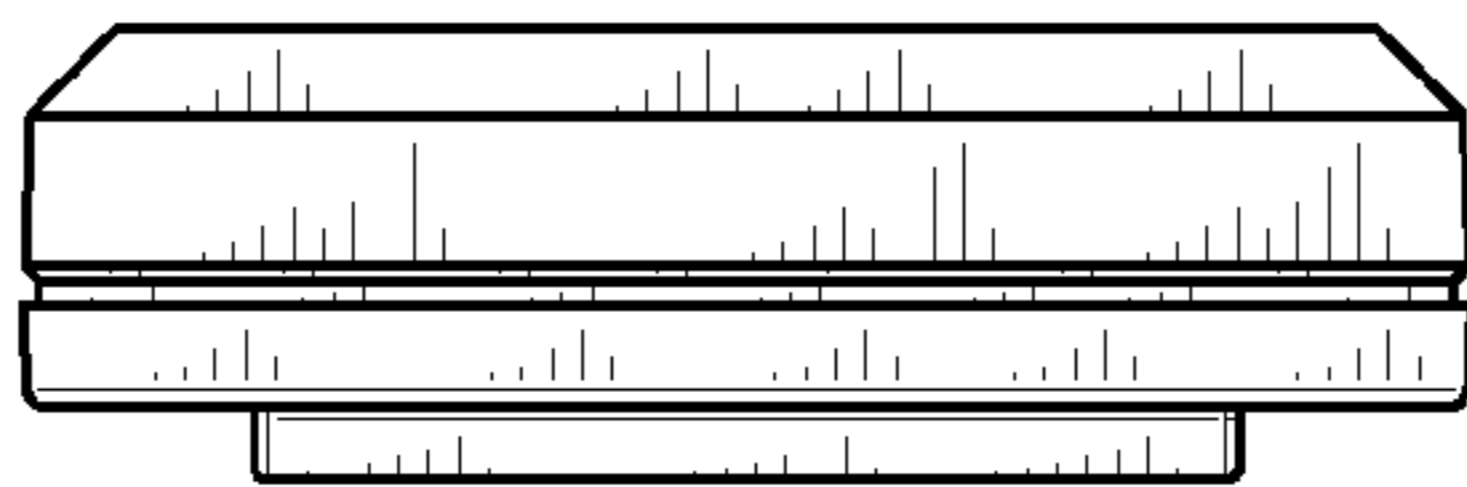

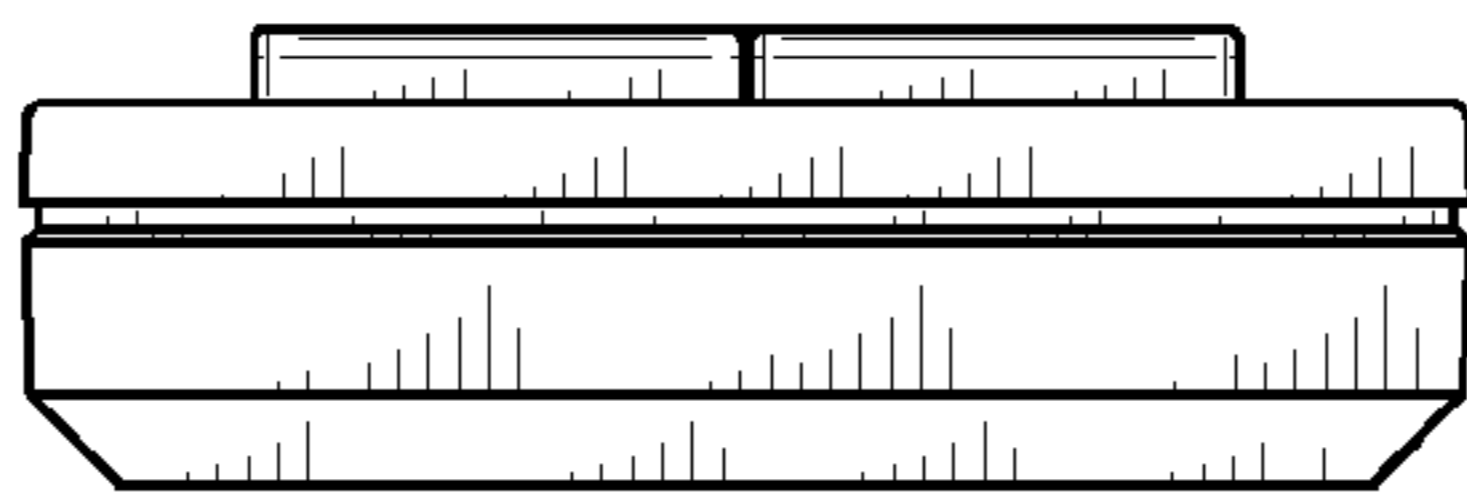

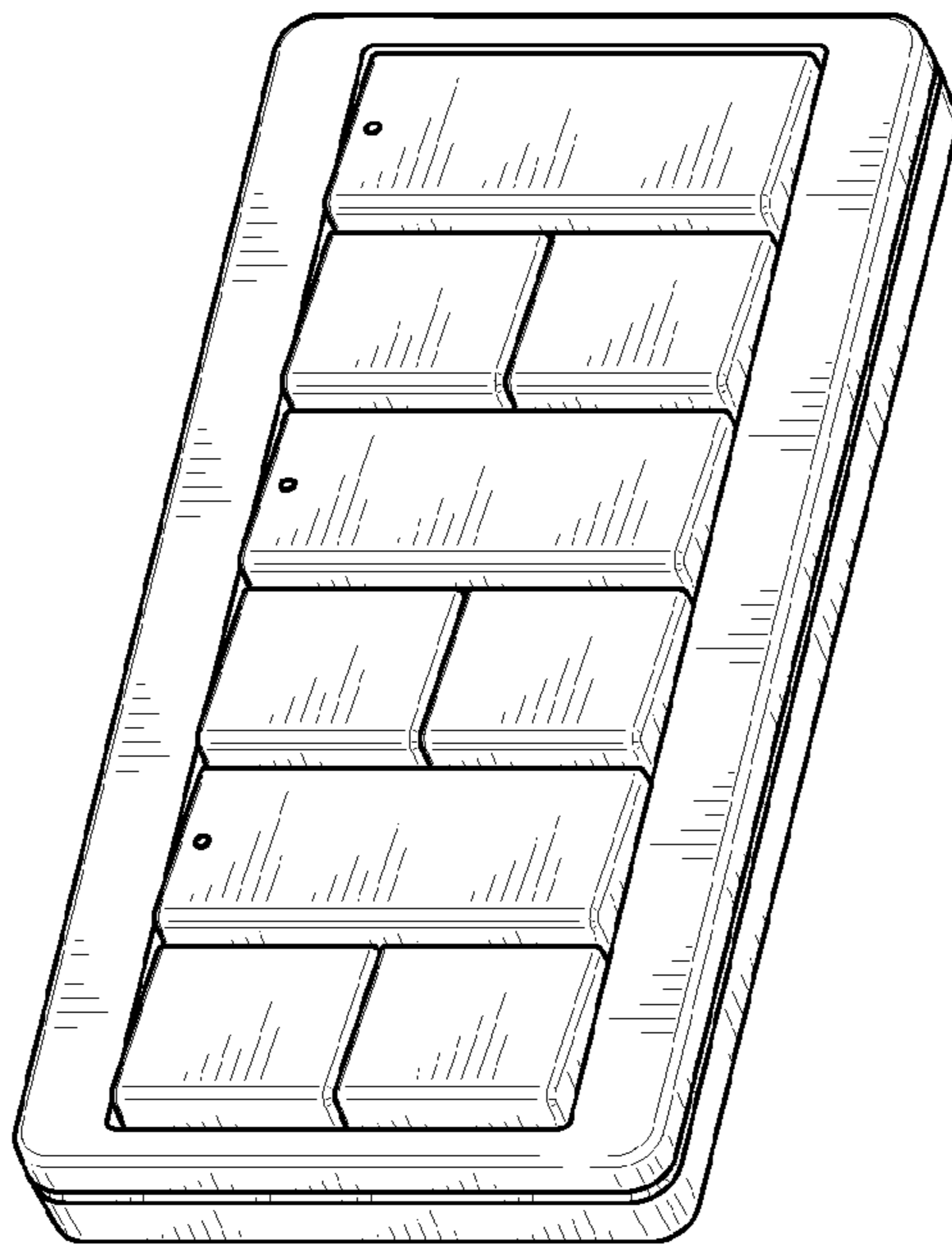

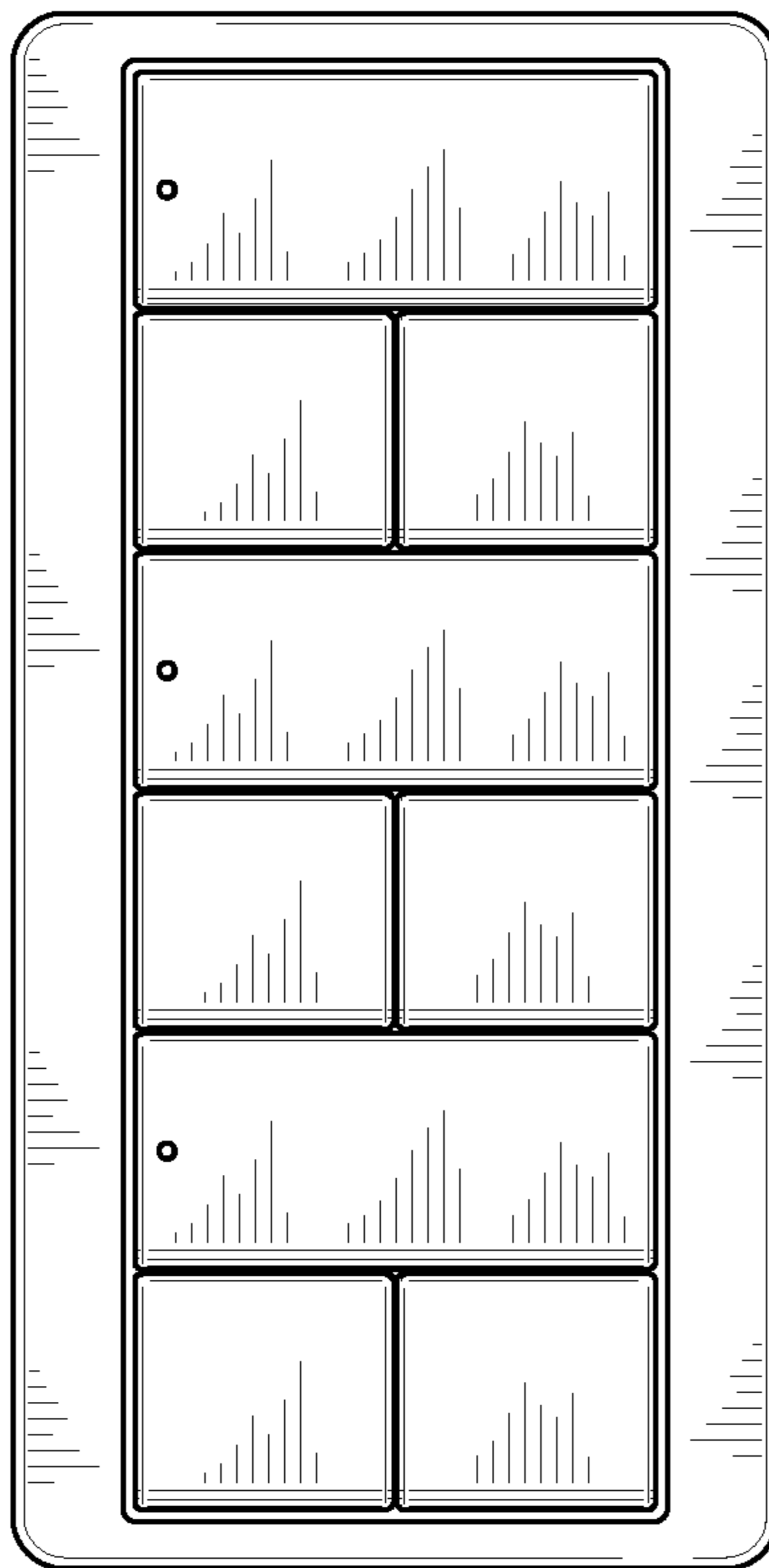

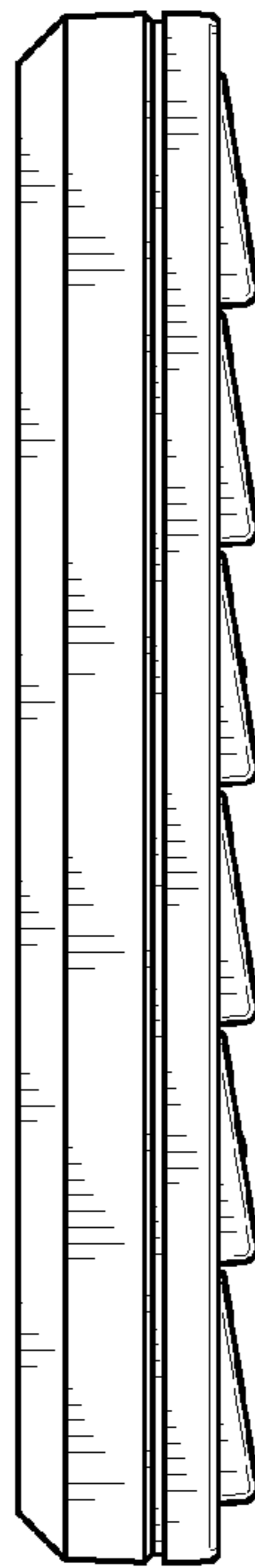

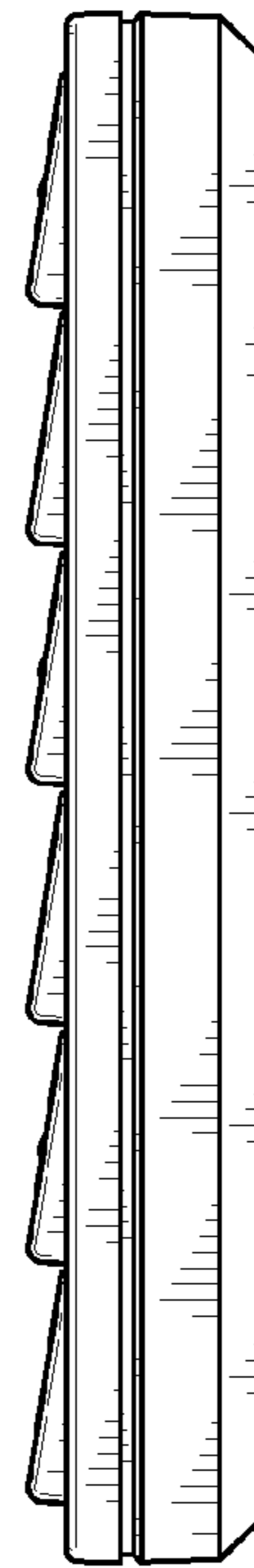

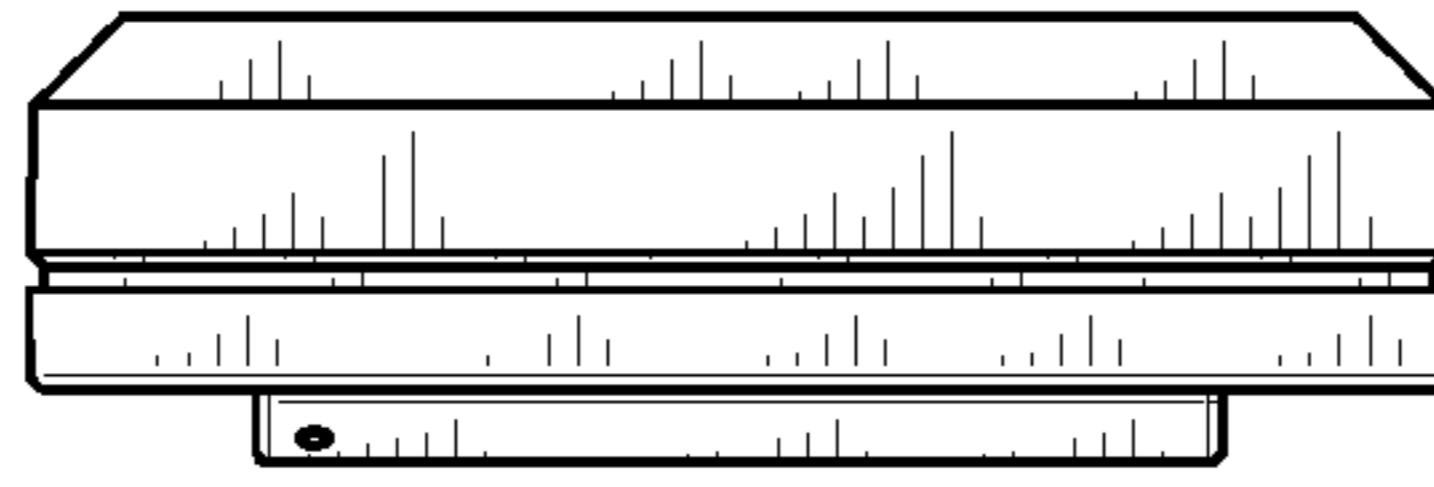

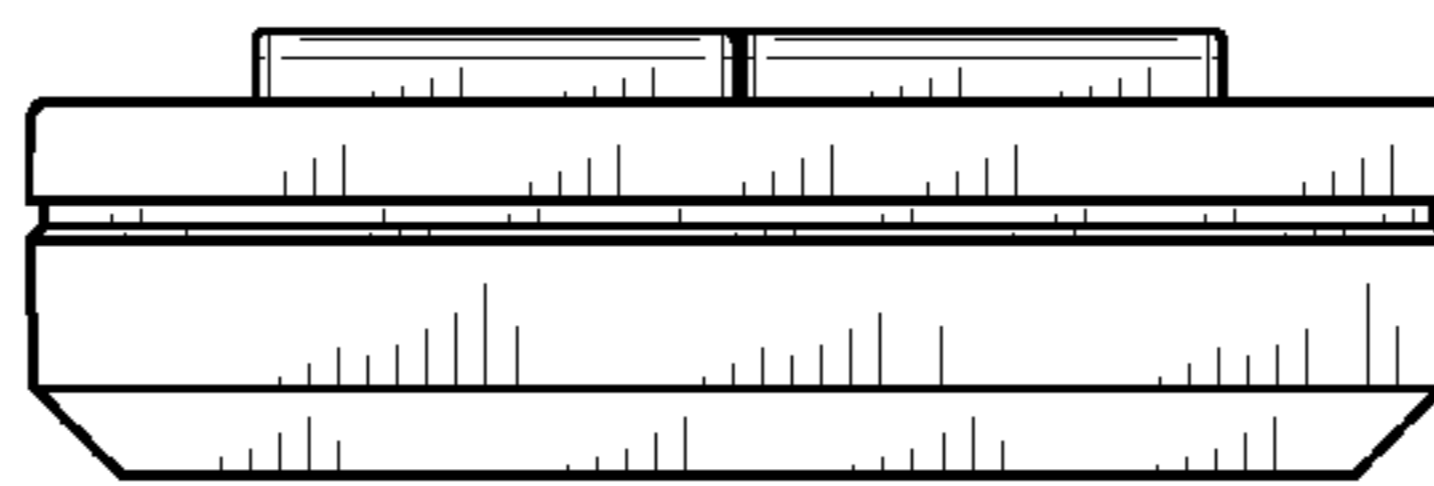

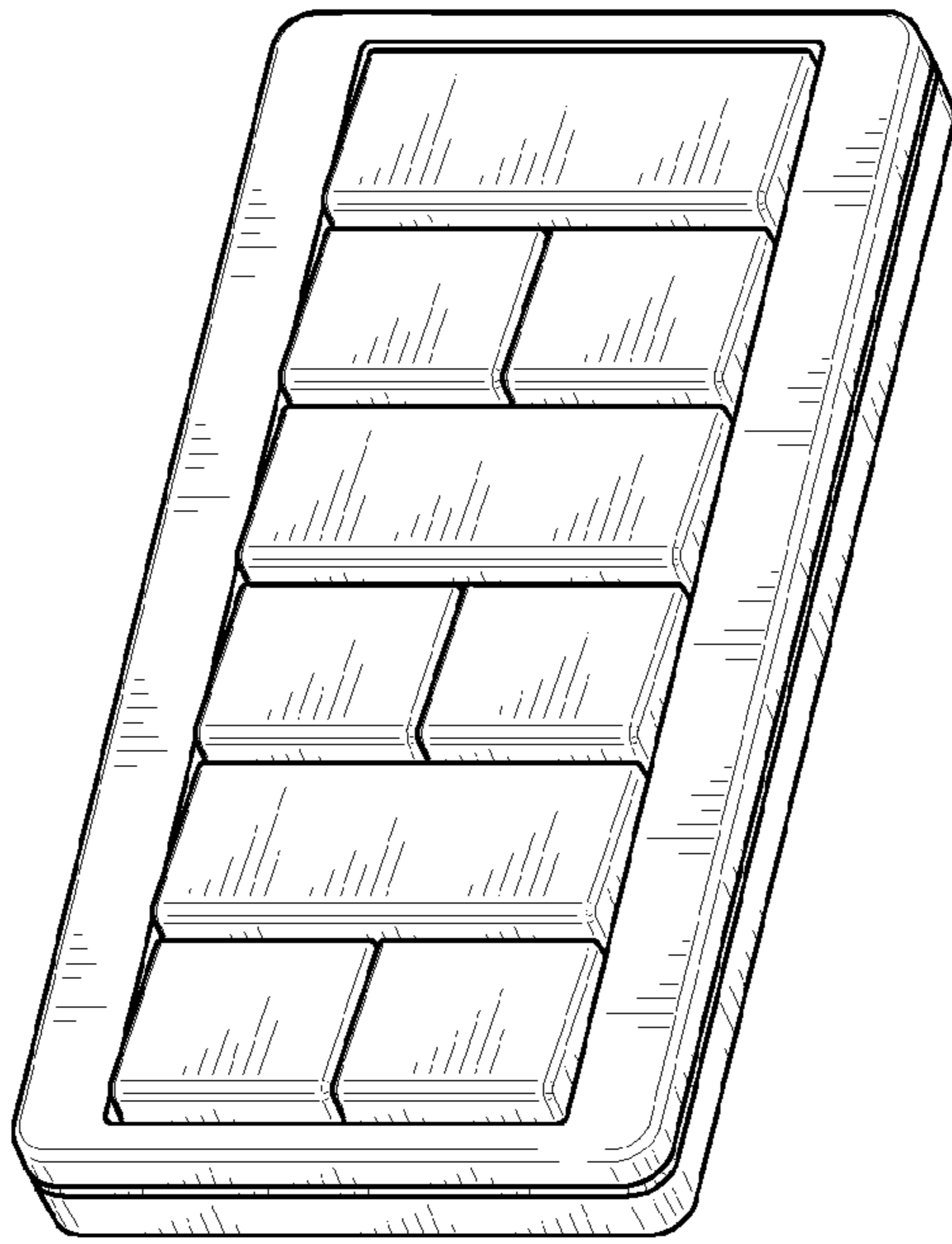

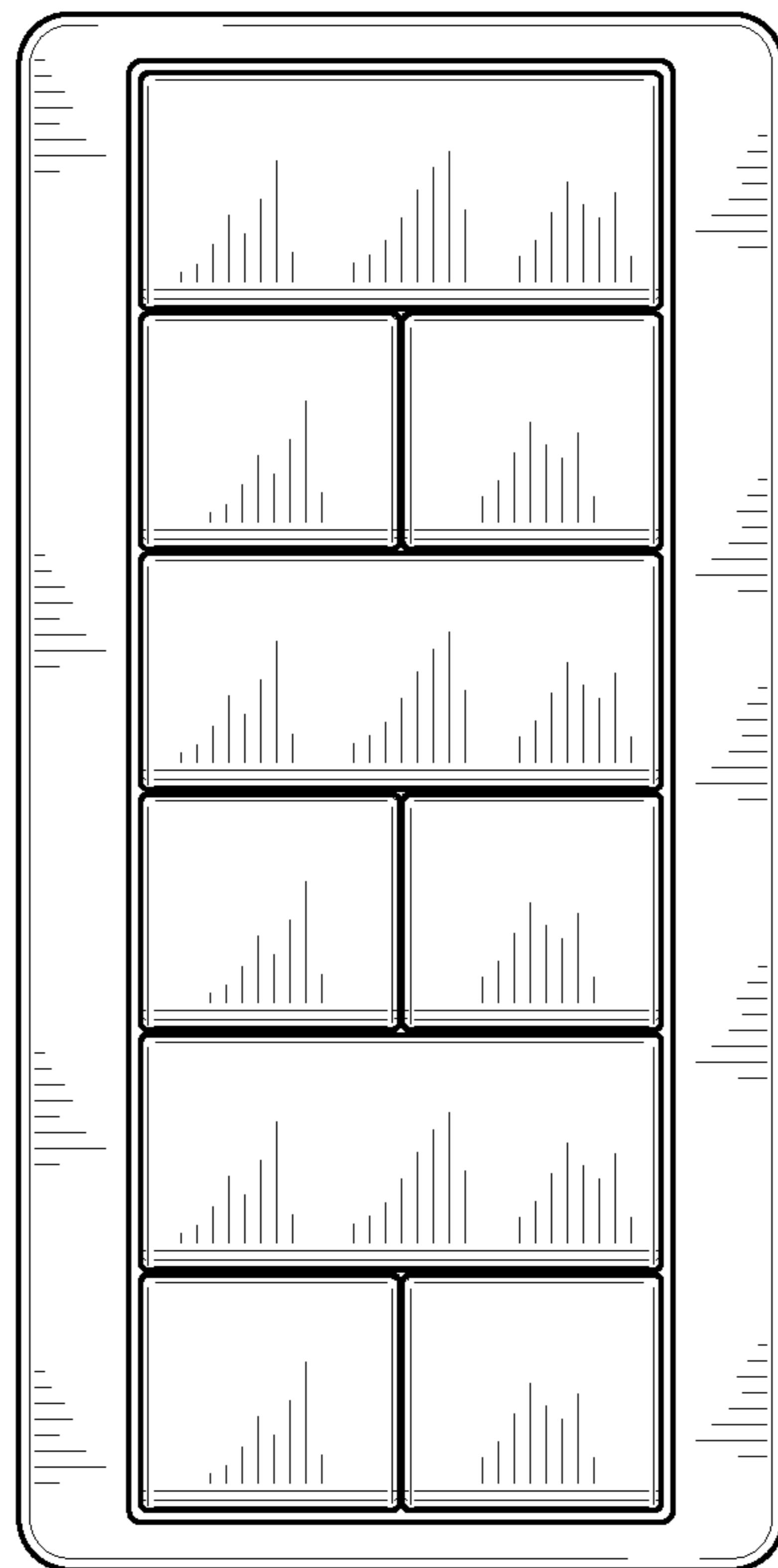

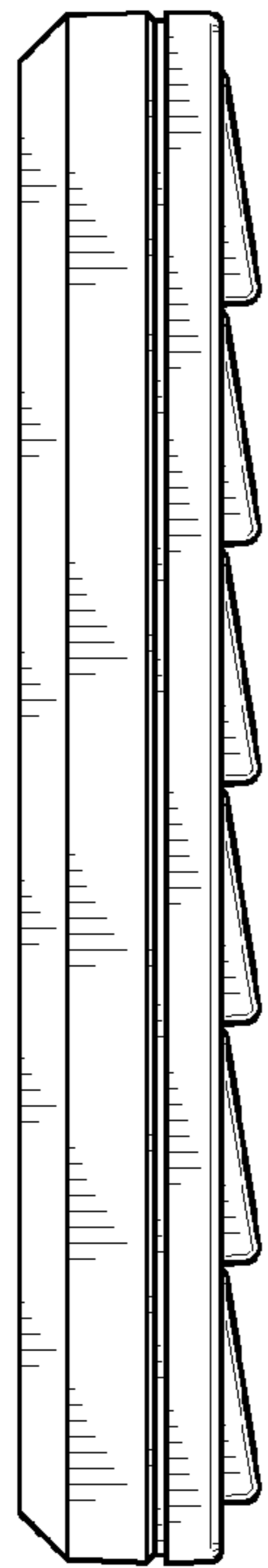

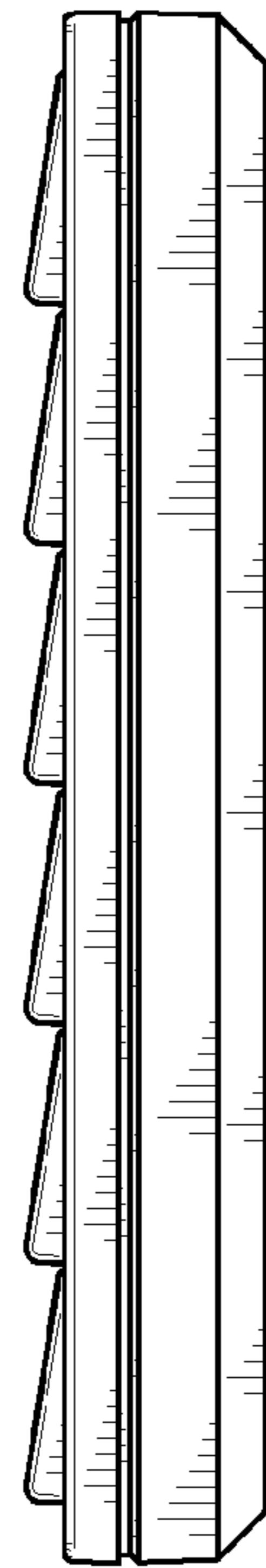

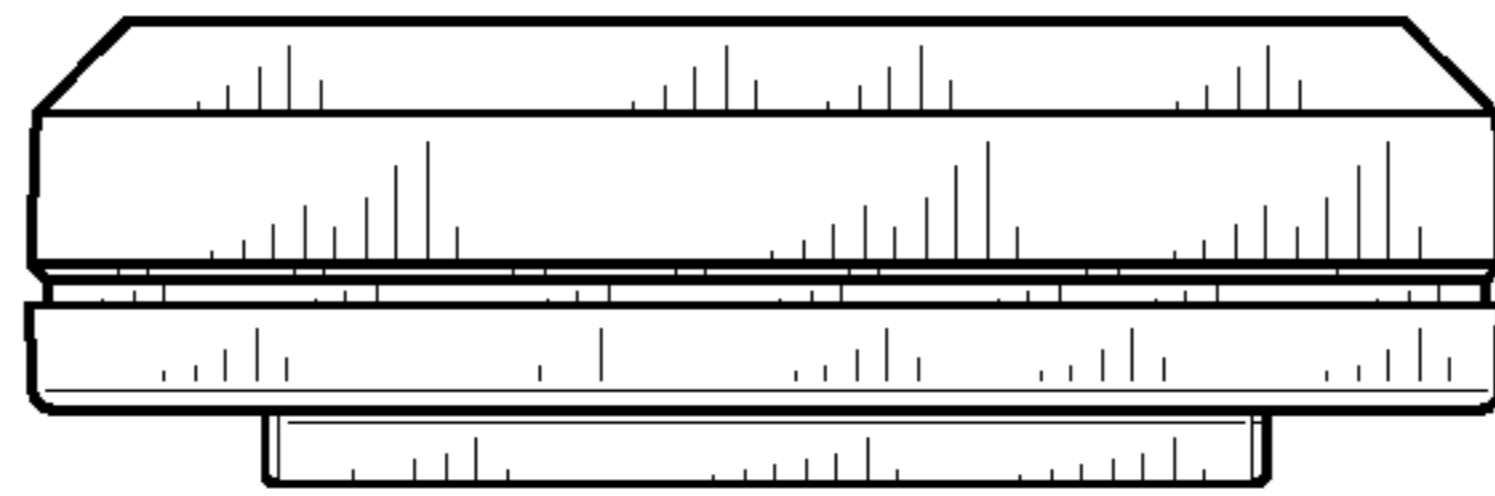

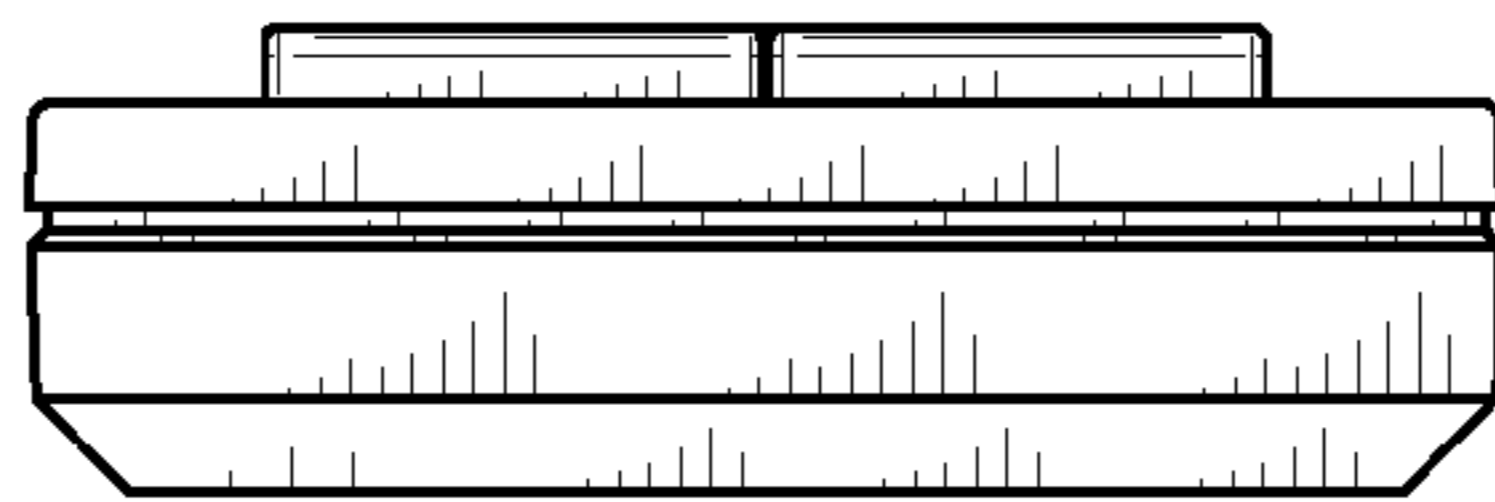
