The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

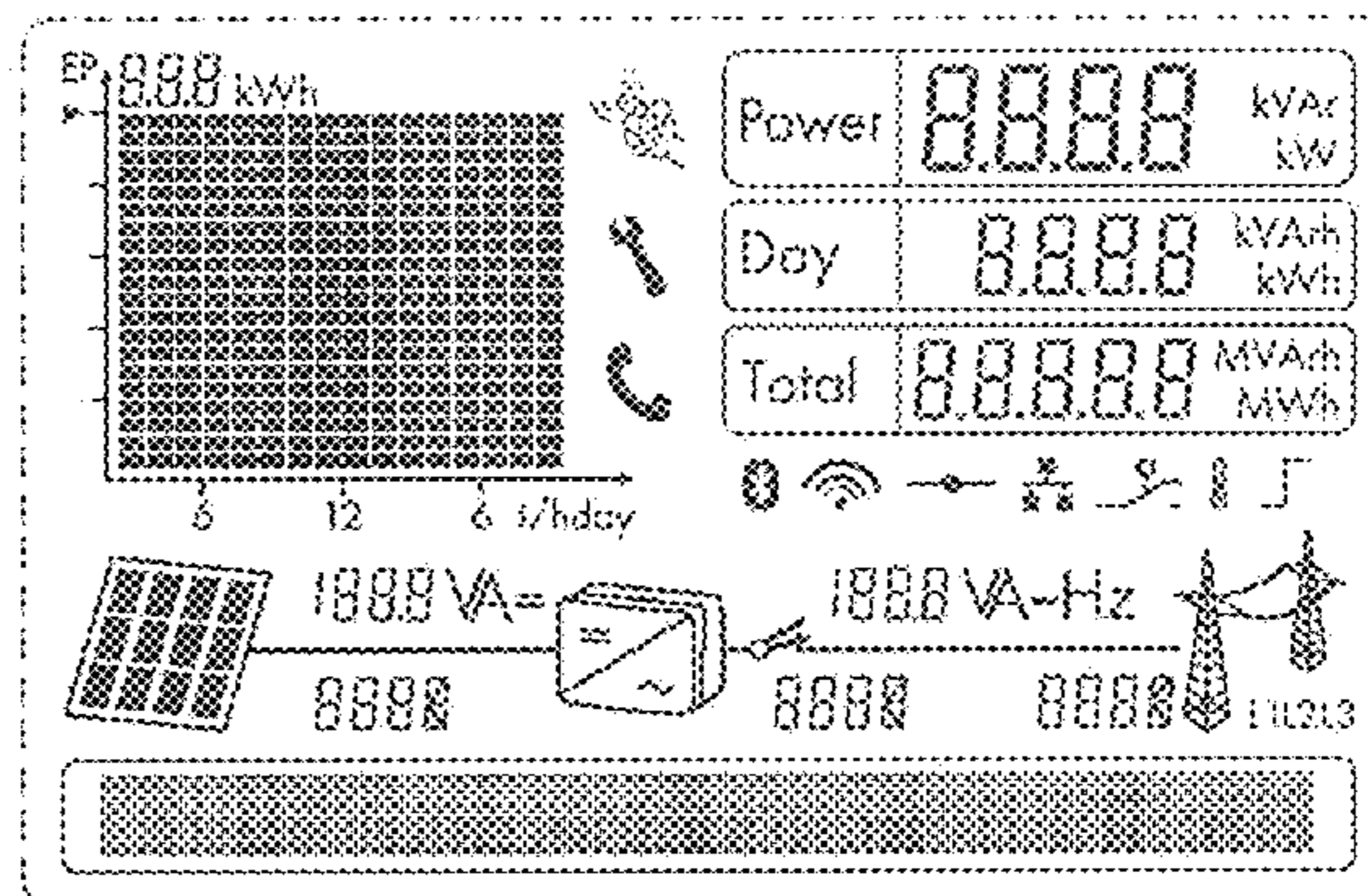
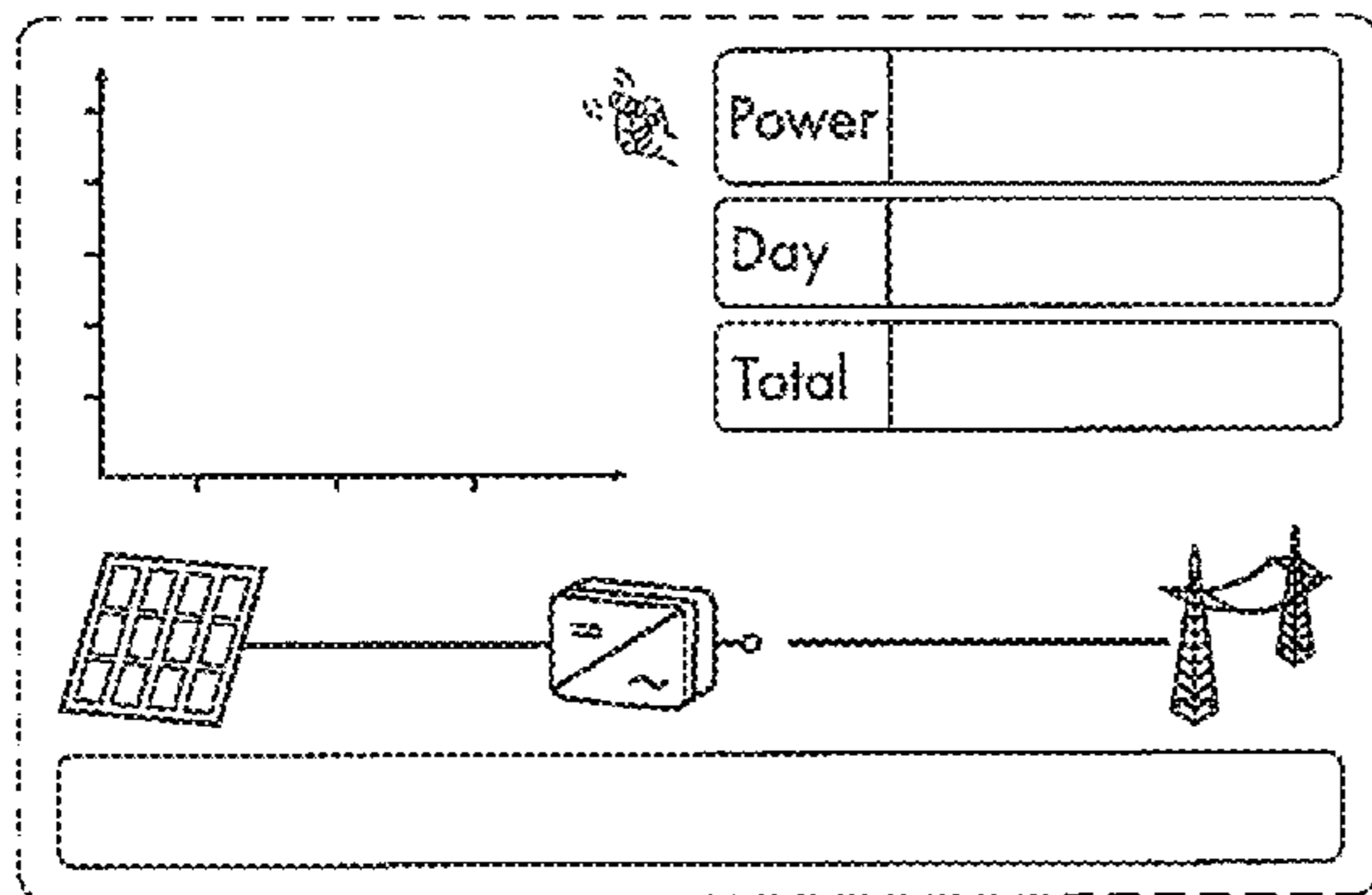
DESCRIPTION

FIG. 1 is a front view of a display screen or portion thereof with graphical user interface in accordance with a preferred embodiment of my new design, wherein the display is in an unenergized state; and,

FIG. 2 is a front view thereof, wherein the display is in an energized state.

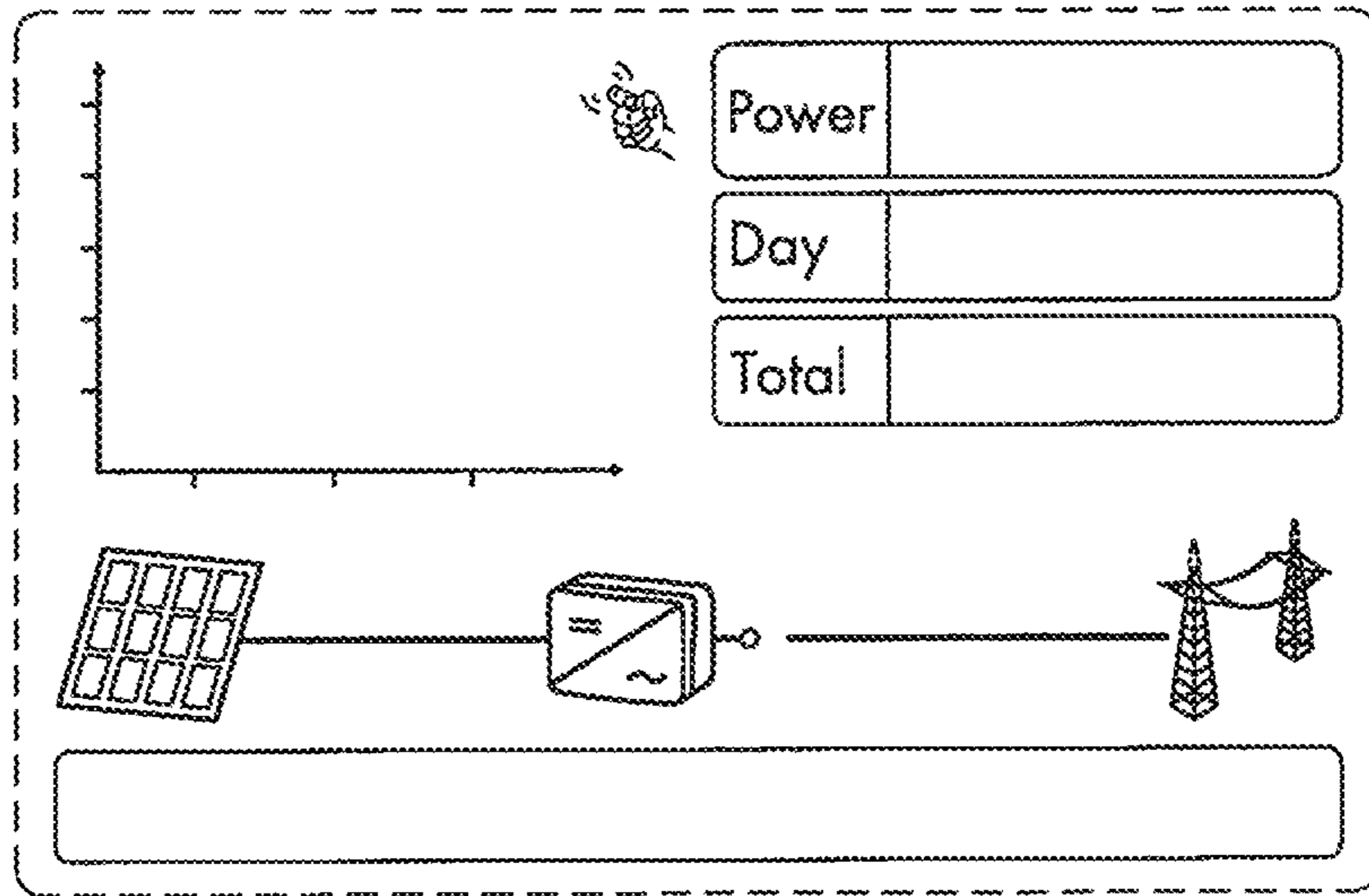

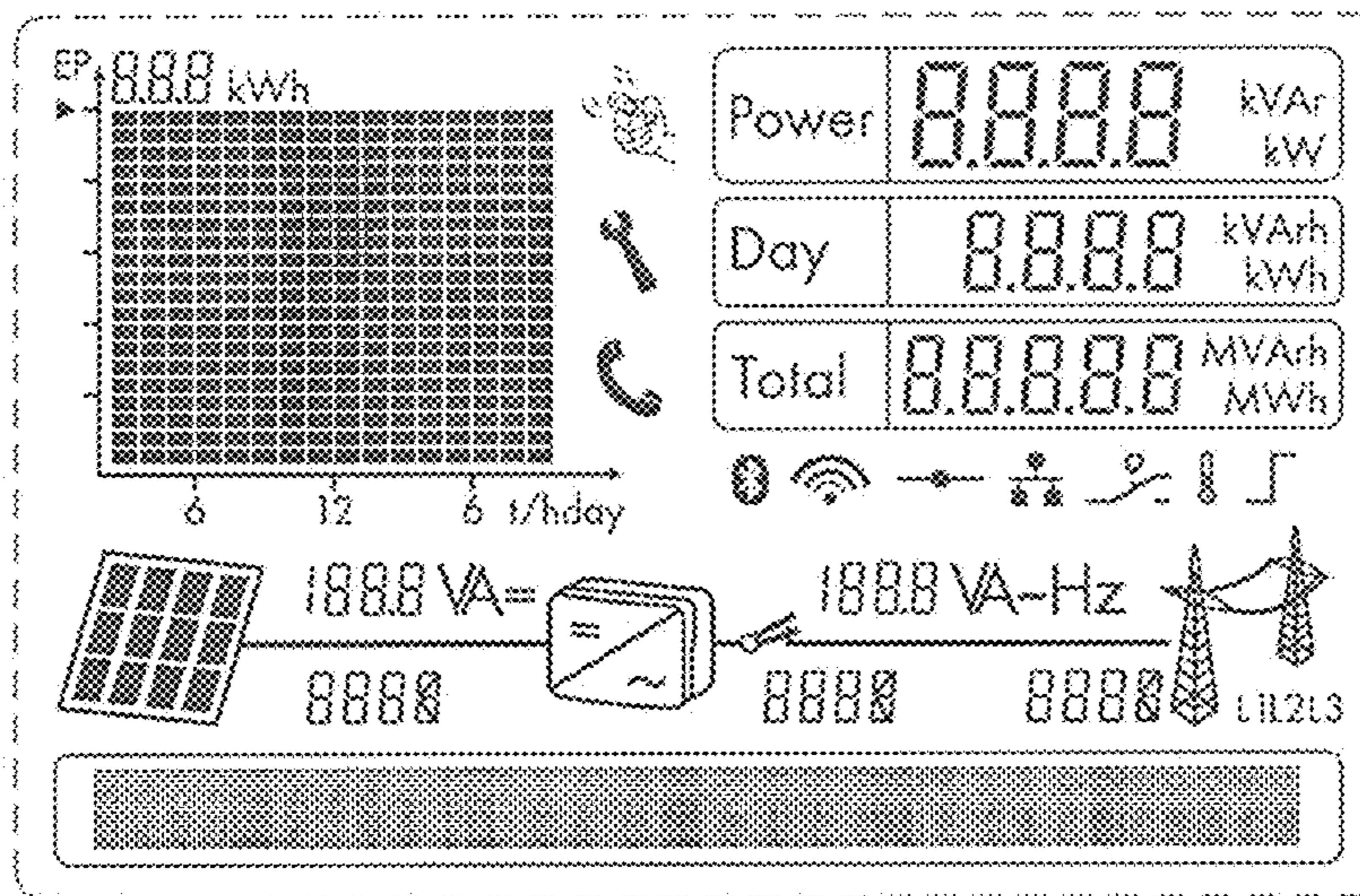
