The ornamental design for a display screen with icon, as shown and described.

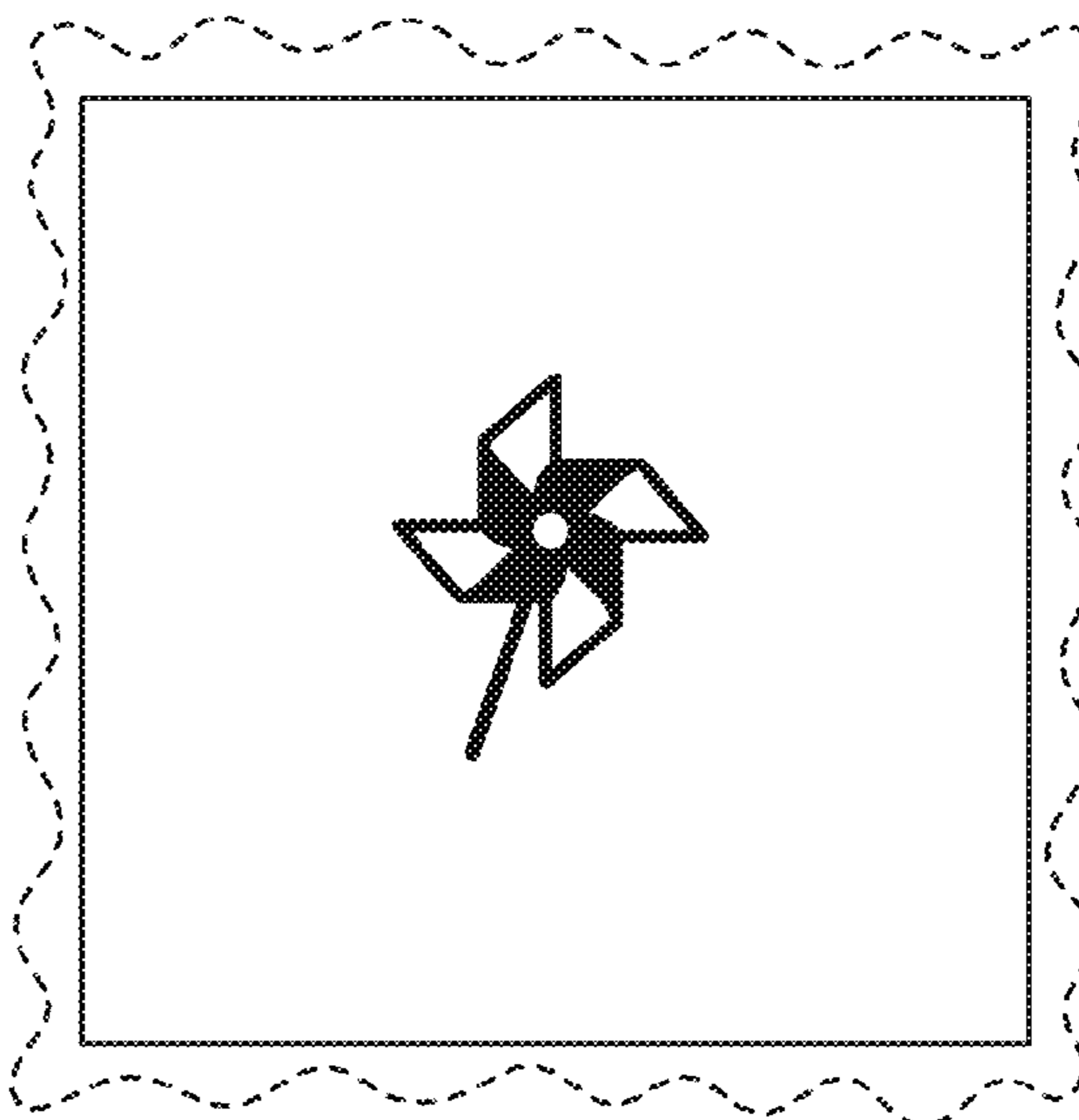
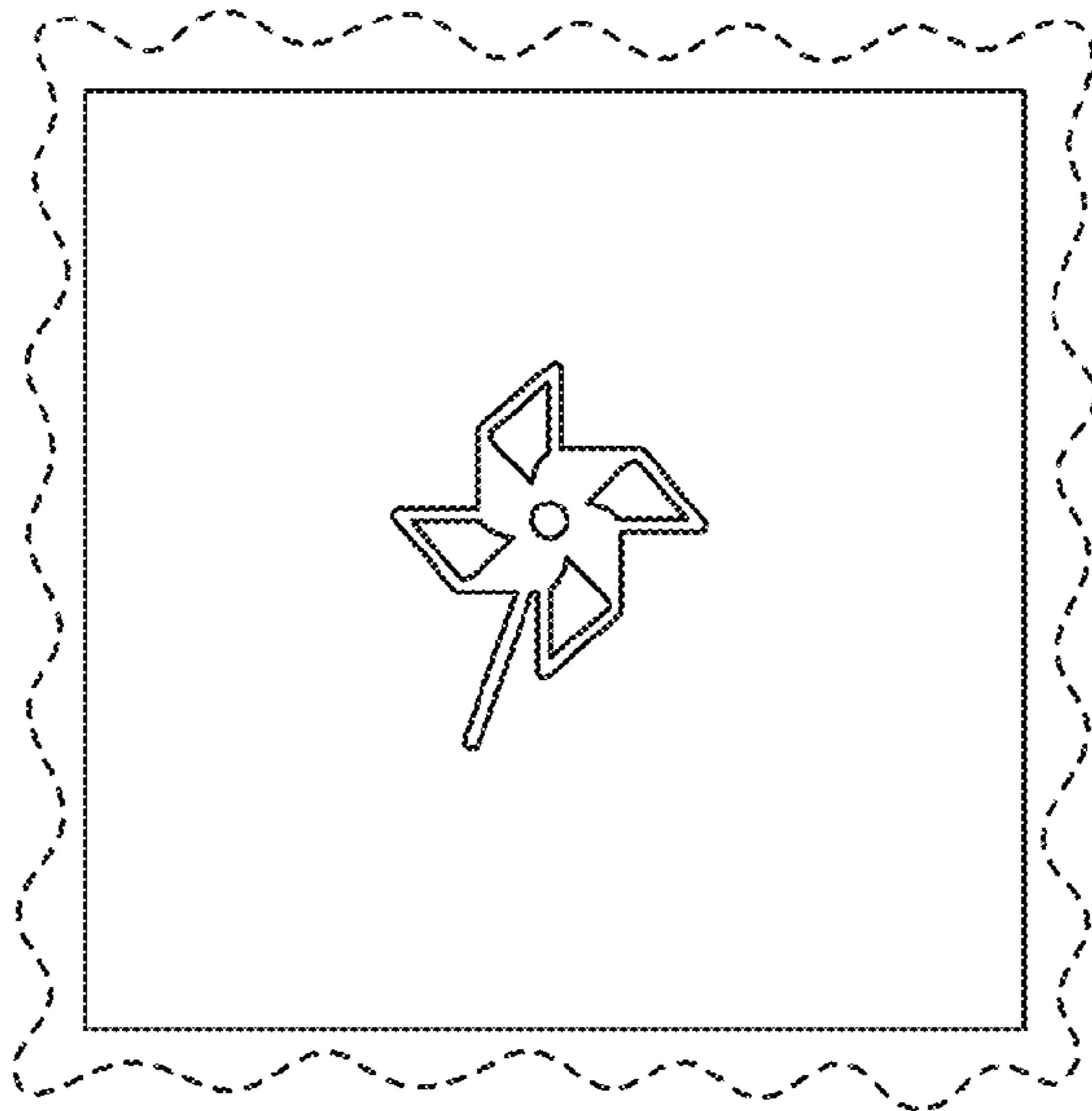
DESCRIPTION

FIG. 1 is a front view of a first embodiment of a display screen with icon showing the new design.
 FIG. 2 is a front view of a display screen with icon showing an alternative embodiment of the new design;
 FIG. 3 is a front view of the display screen with icon of FIG. 1 shown on a device; and,
 FIG. 4 is a front view of the display screen with icon of FIG. 2 shown on a device.

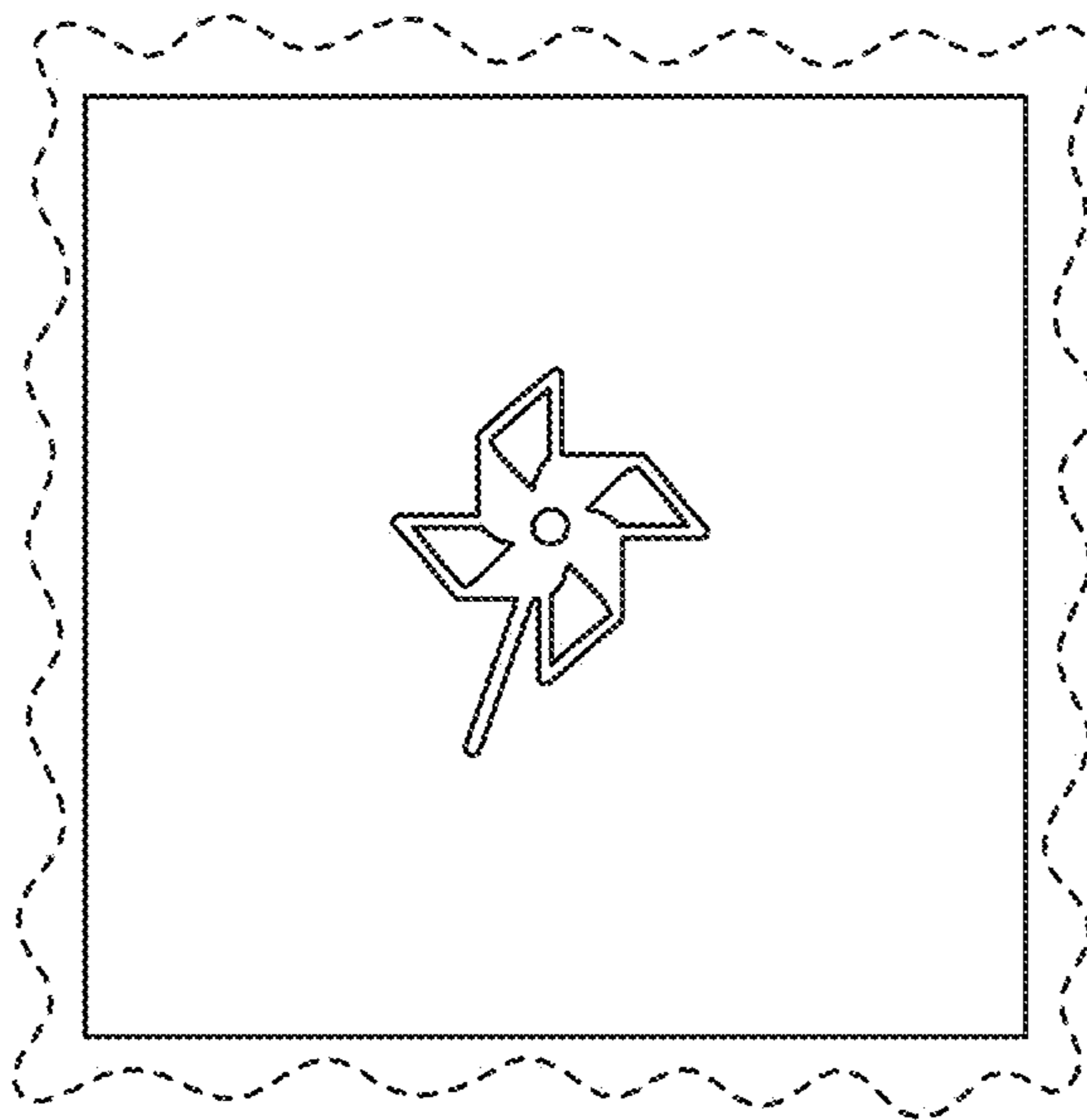

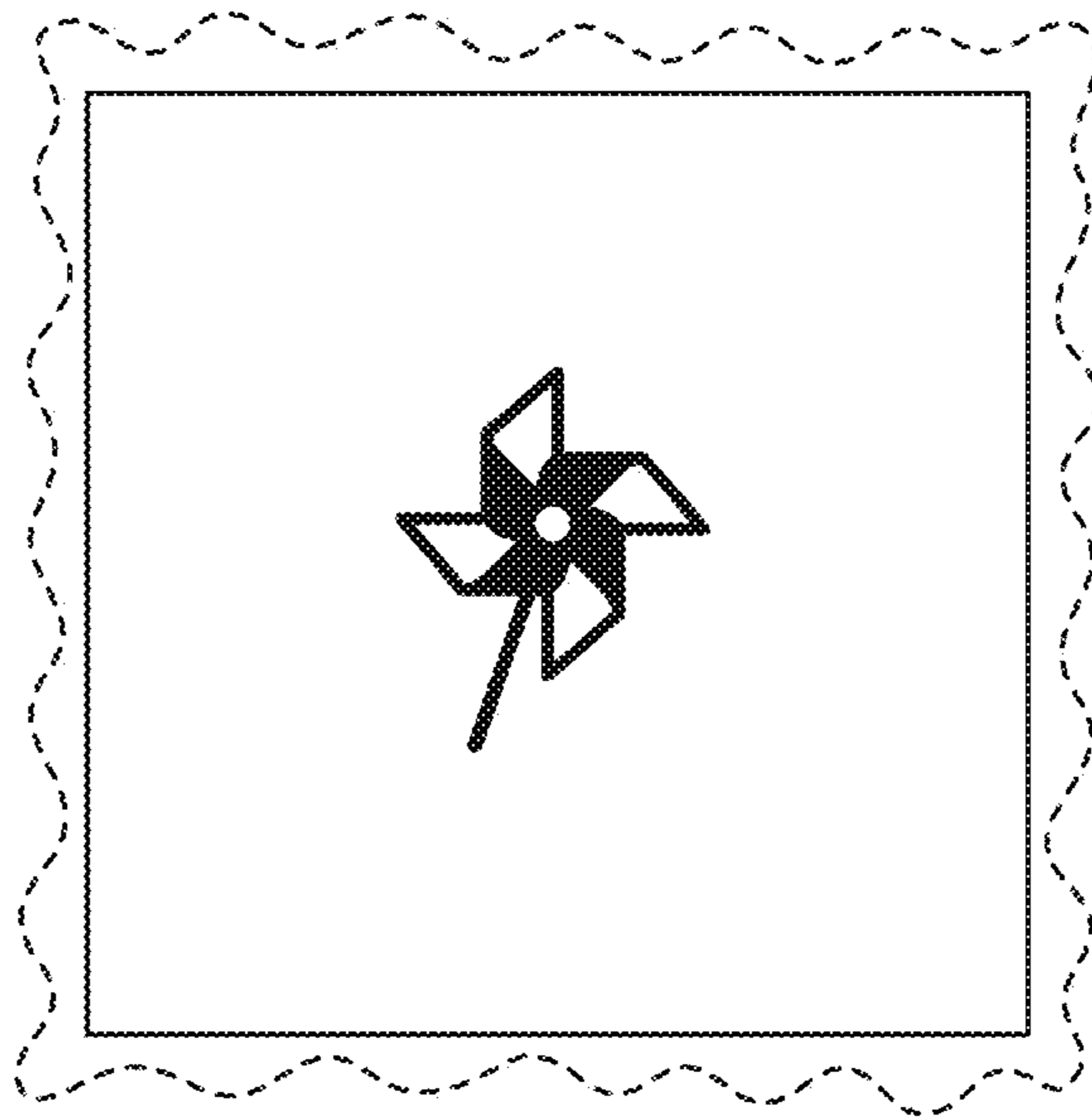

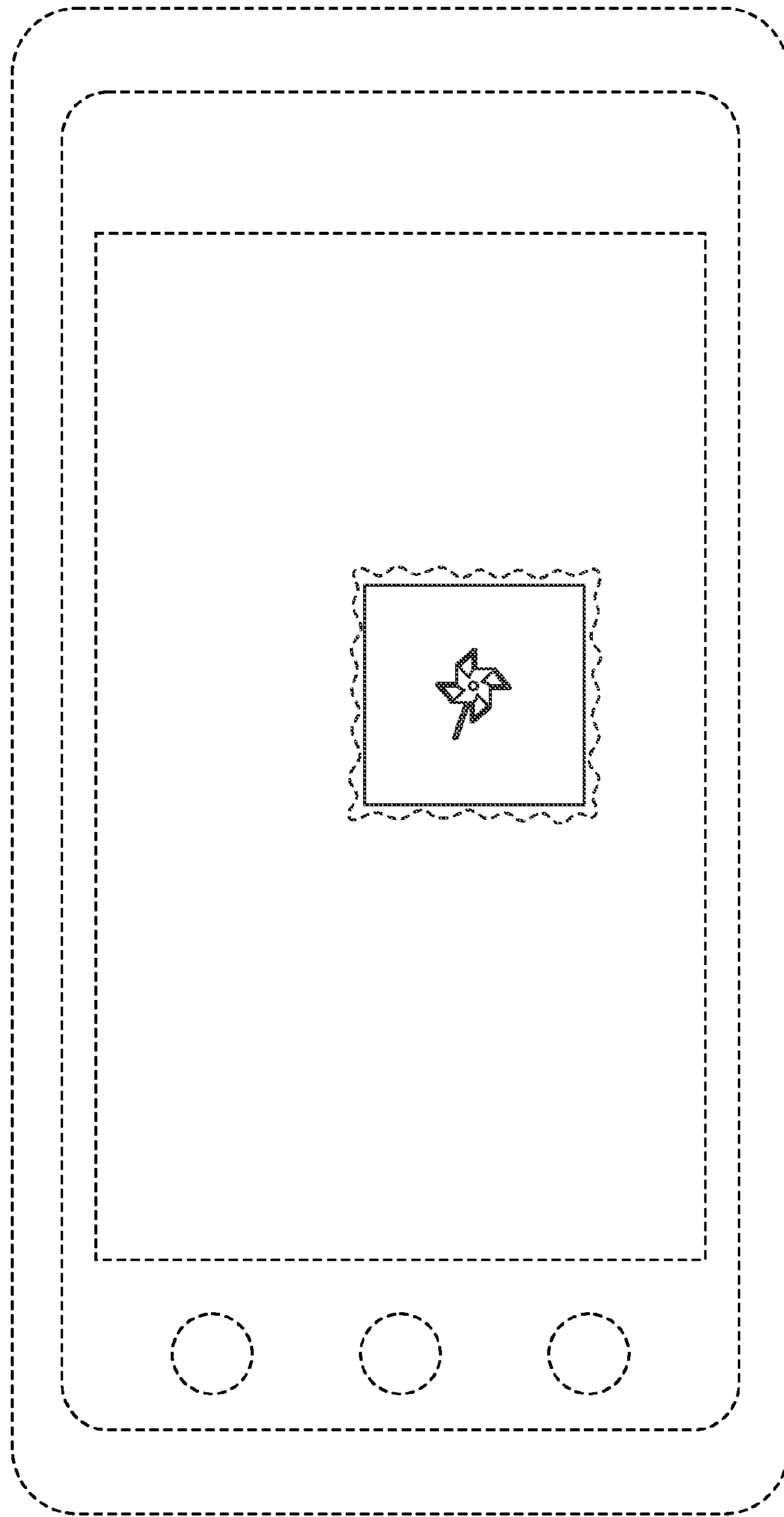

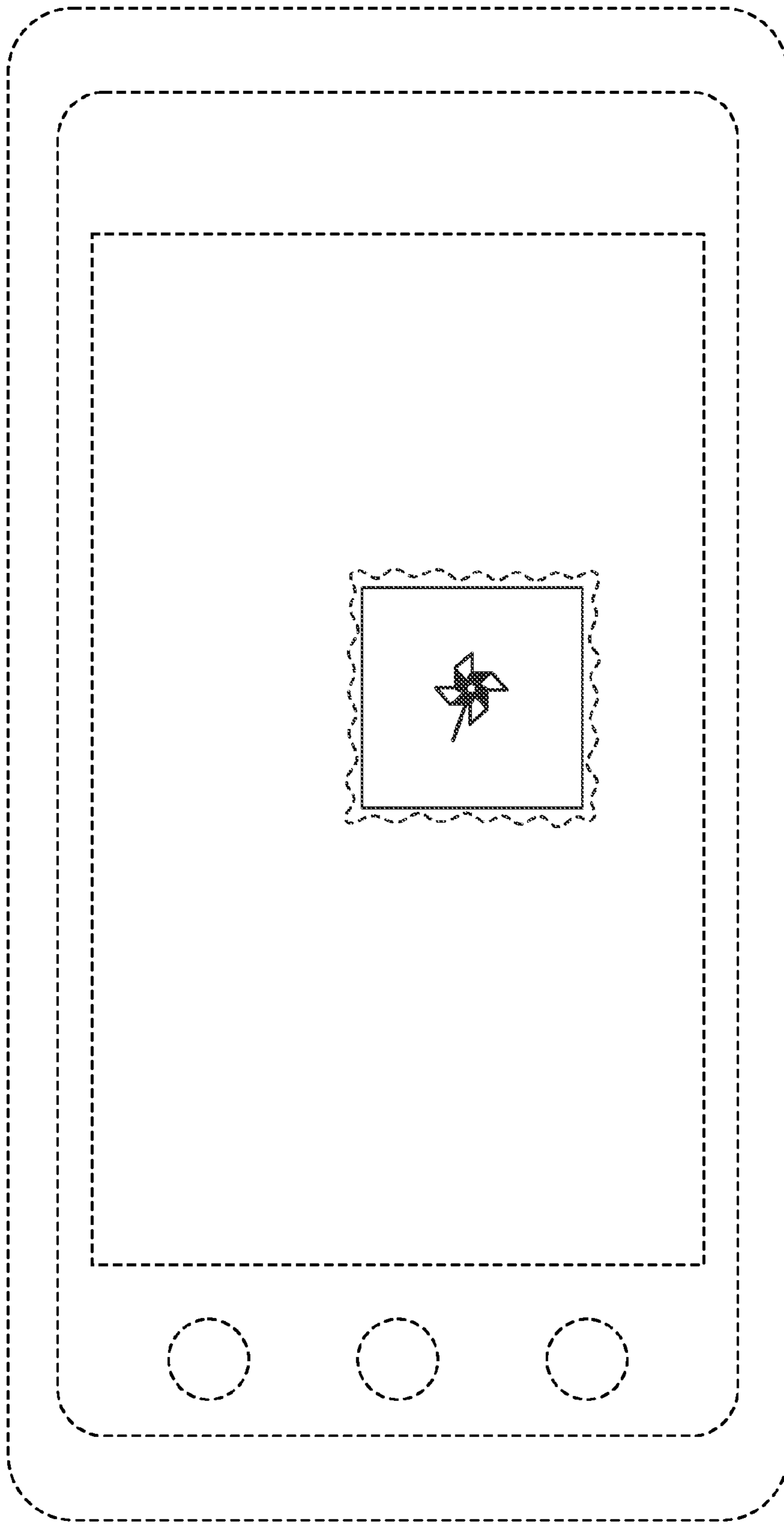
