(57) **CLAIM**

The ornamental design for a reinforced equipment pad, as shown and described.

**DESCRIPTION**

FIG. 32 is a bottom plan view of an alternative embodiment of the reinforced equipment pad shown in FIGS. 25-31;







FIG. 33 is a front perspective view of a reinforced equipment pad according to an alternative embodiment;












































































