(57) **CLAIM**

We claim the ornamental design for a shower hose filter assembly, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front isometric view of a shower hose filter assembly.

FIG. 2 is a front elevation view of the shower hose filter assembly of FIG. 1.

FIG. 3 is a rear elevation view of the shower hose filter assembly of FIG. 1.

FIG. 4 is a right side elevation view of the shower hose filter assembly of FIG. 1.

FIG. 5 is a left side elevation view of the shower hose filter assembly of FIG. 1.

FIG. 6 is a top plan view of the shower hose filter assembly of FIG. 1.

FIG. 7 is a bottom plan view of the shower hose filter assembly of FIG. 1.

FIG. 8 is an exploded front isometric view of the shower hose filter assembly of FIG. 1.

FIG. 9 is an exploded front elevation view of the shower hose filter assembly of FIG. 1.

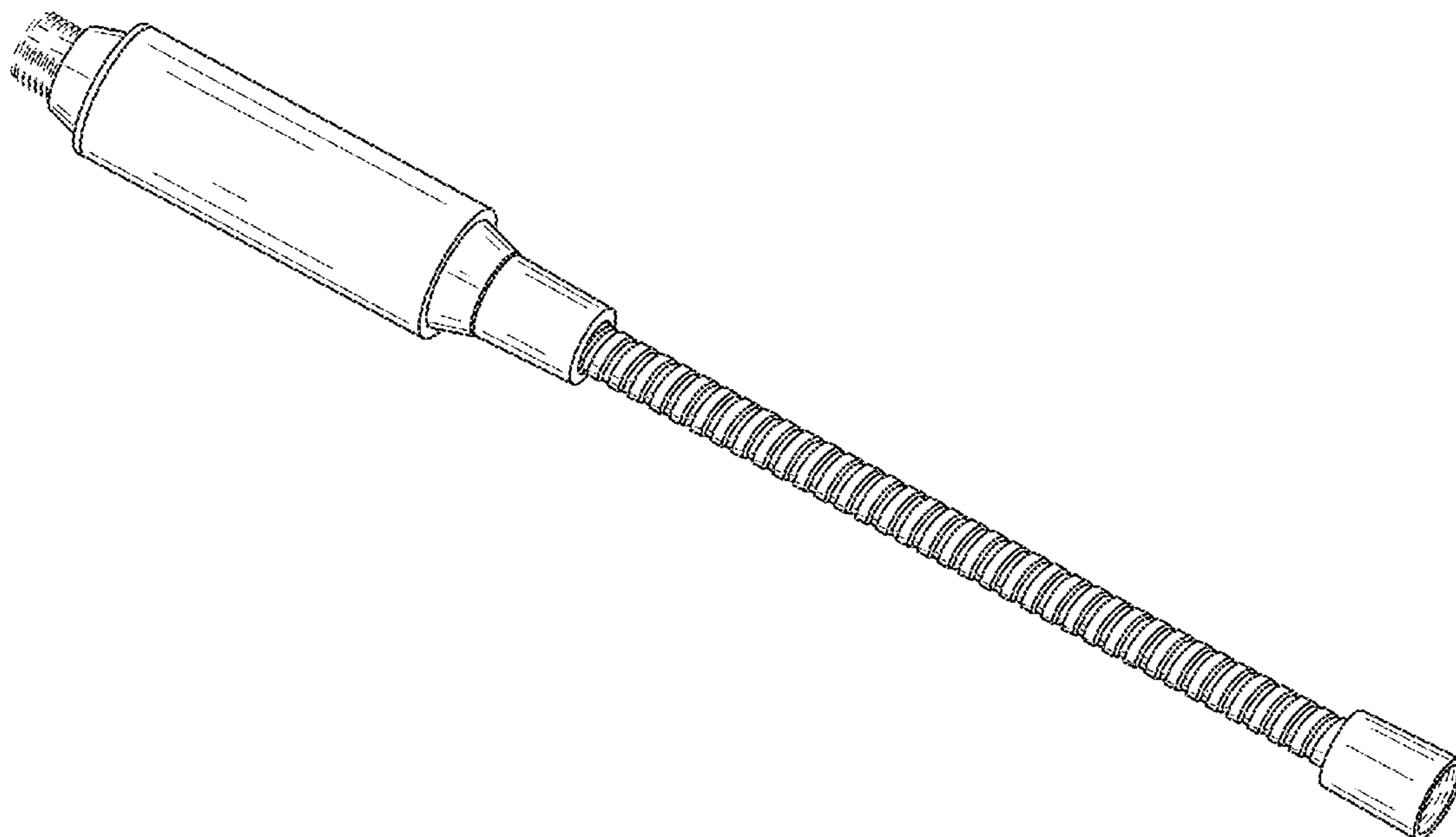
FIG. 10 is an exploded rear elevation view of the shower hose filter assembly of FIG. 1.

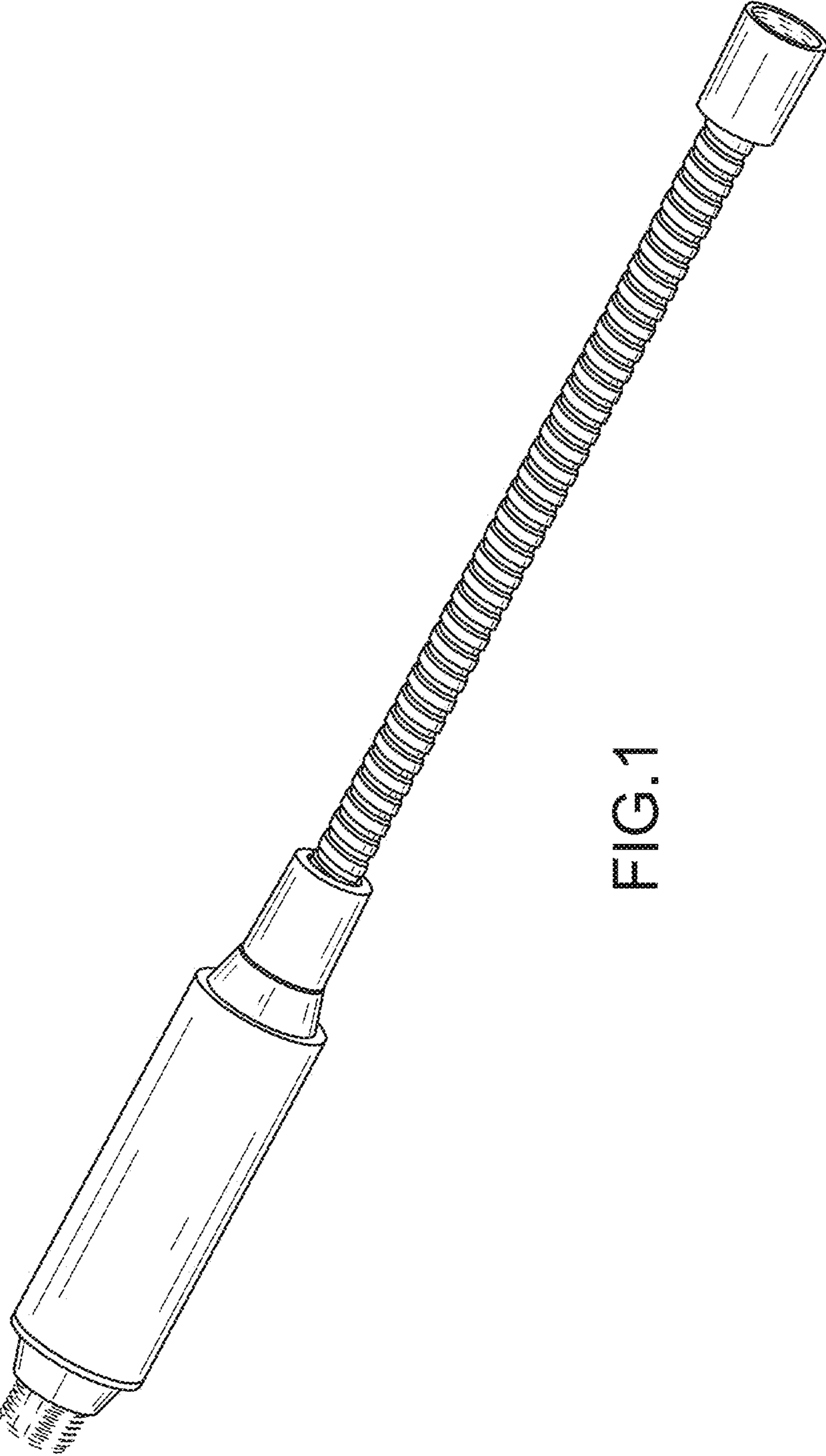

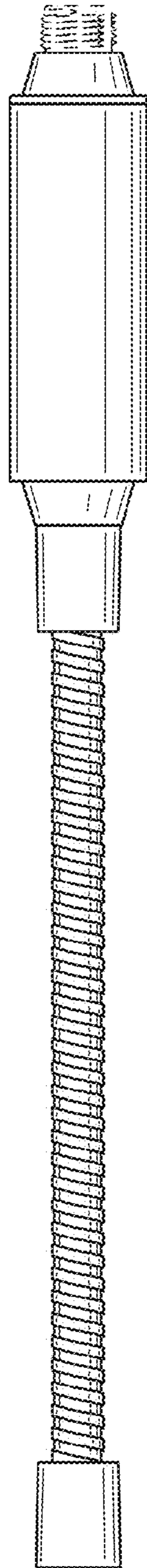

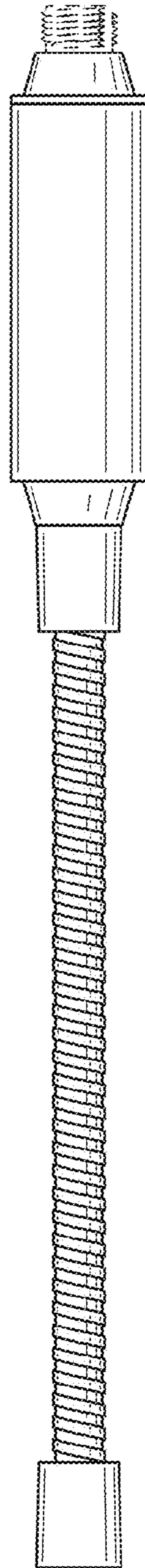

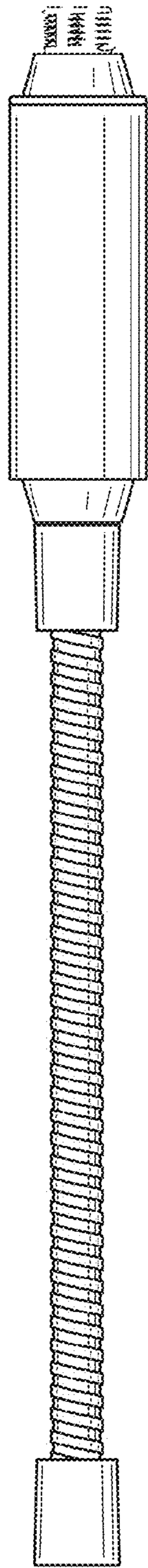

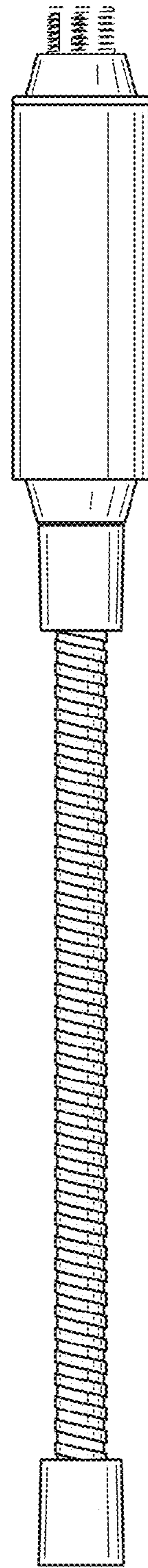

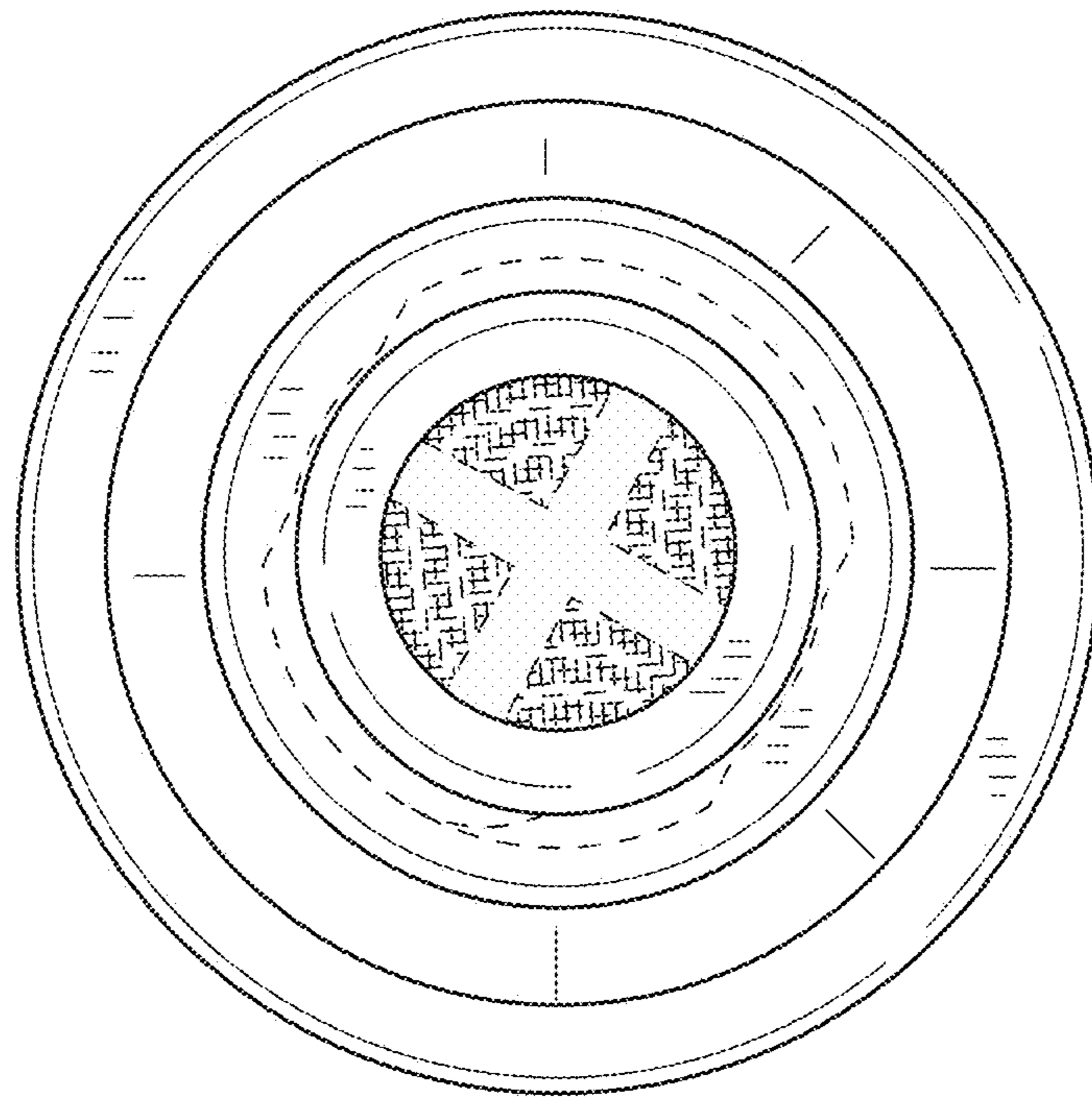

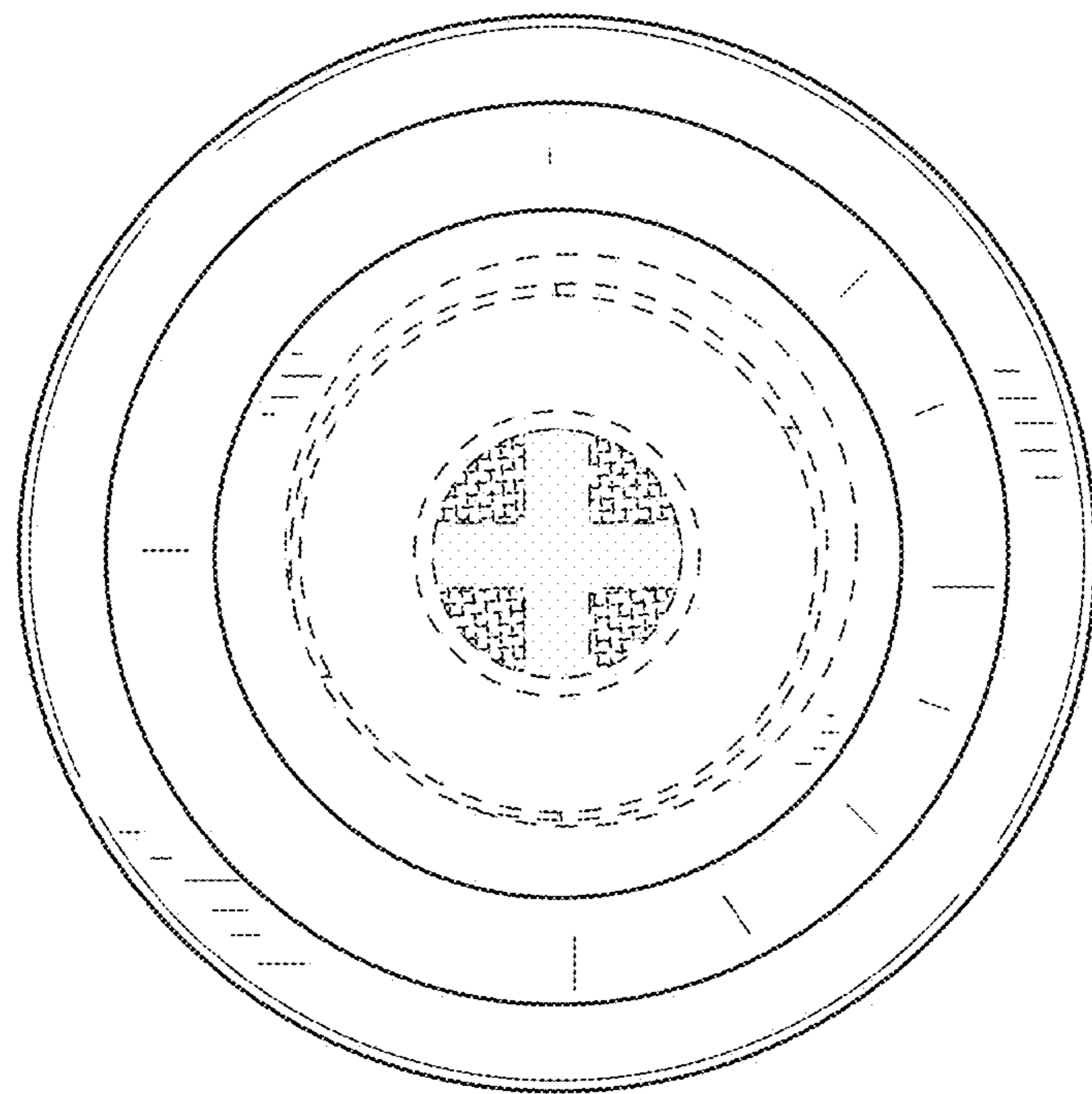

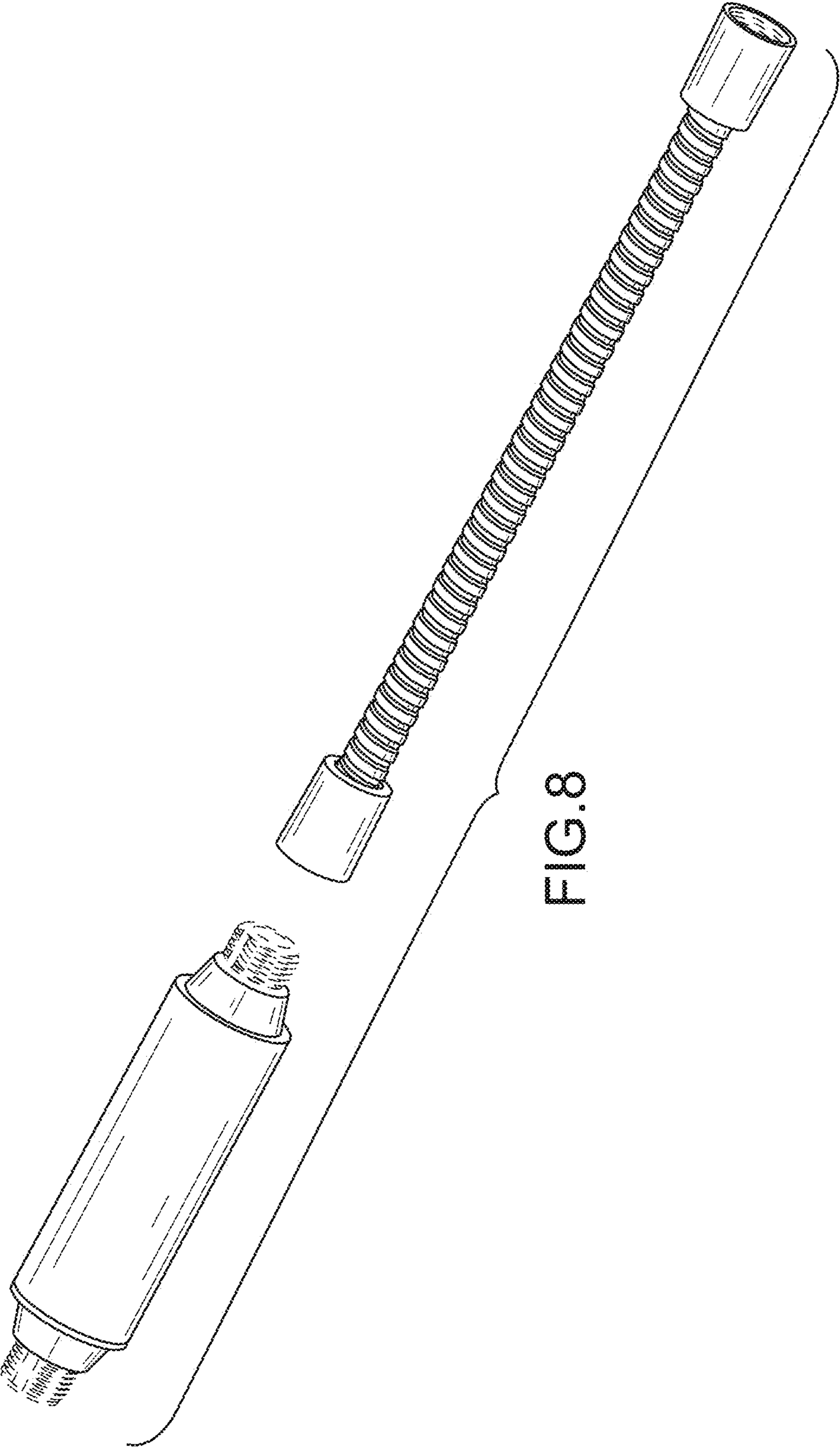

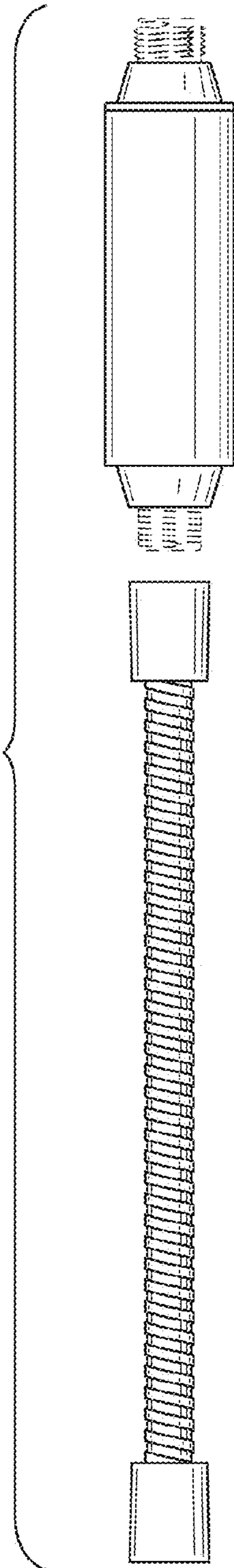
