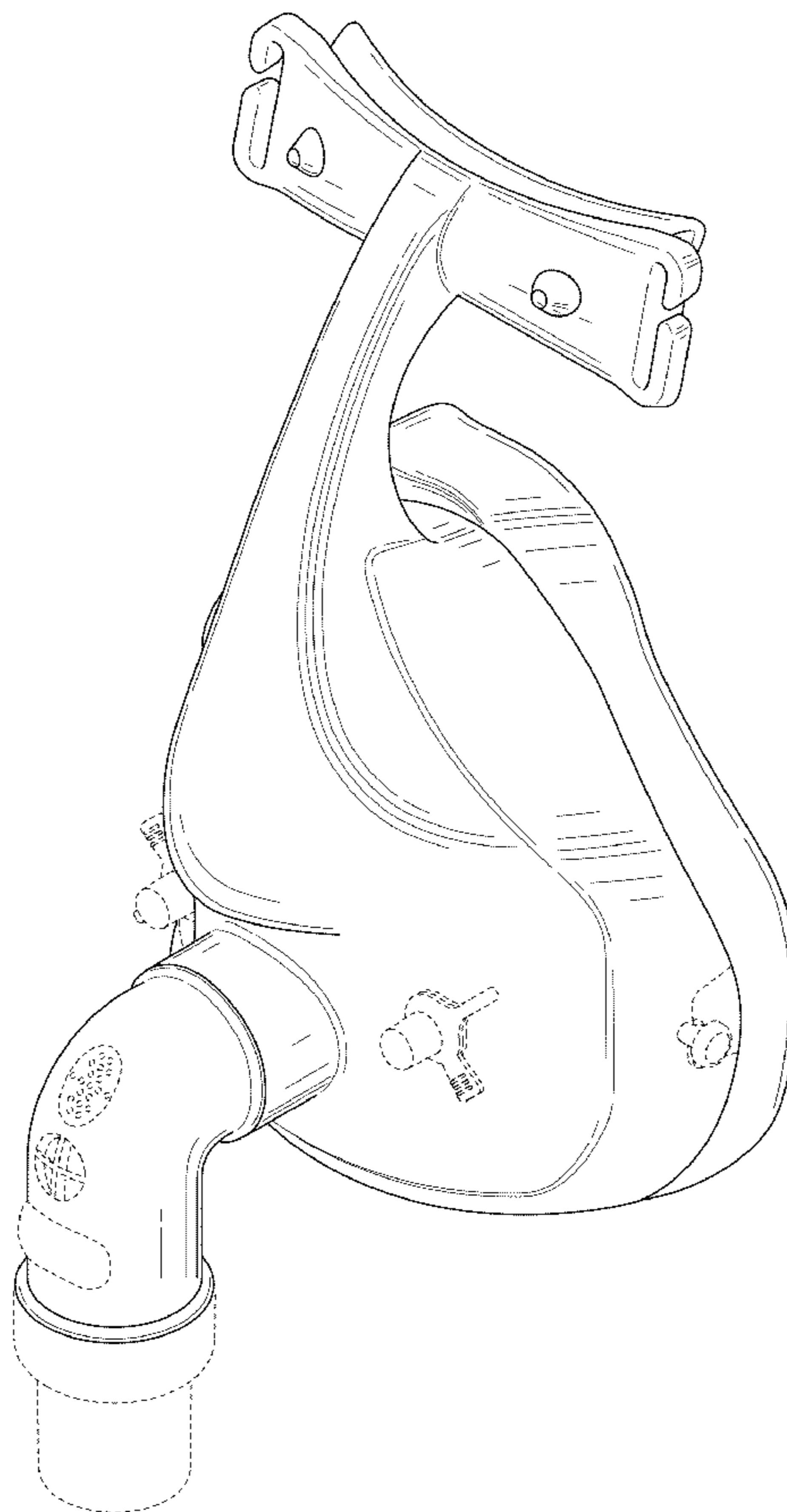
(57) **CLAIM**

We claim the ornamental design for a respiratory face mask, as shown and described above.

DESCRIPTION

FIG. 1 is a left perspective view of the respiratory face mask; FIG. 2 is a rear perspective view of the respiratory face mask; FIG. 3 is a front view of the respiratory face mask; FIG. 4 is a rear view of the respiratory face mask; FIG. 5 is a right side view of the respiratory face mask; FIG. 6 is a top view of the respiratory face mask; and, FIG. 7 is a bottom view of the respiratory face mask. The broken lines showing in the attached drawings are for illustrative purposes only and form no part of the claimed design.

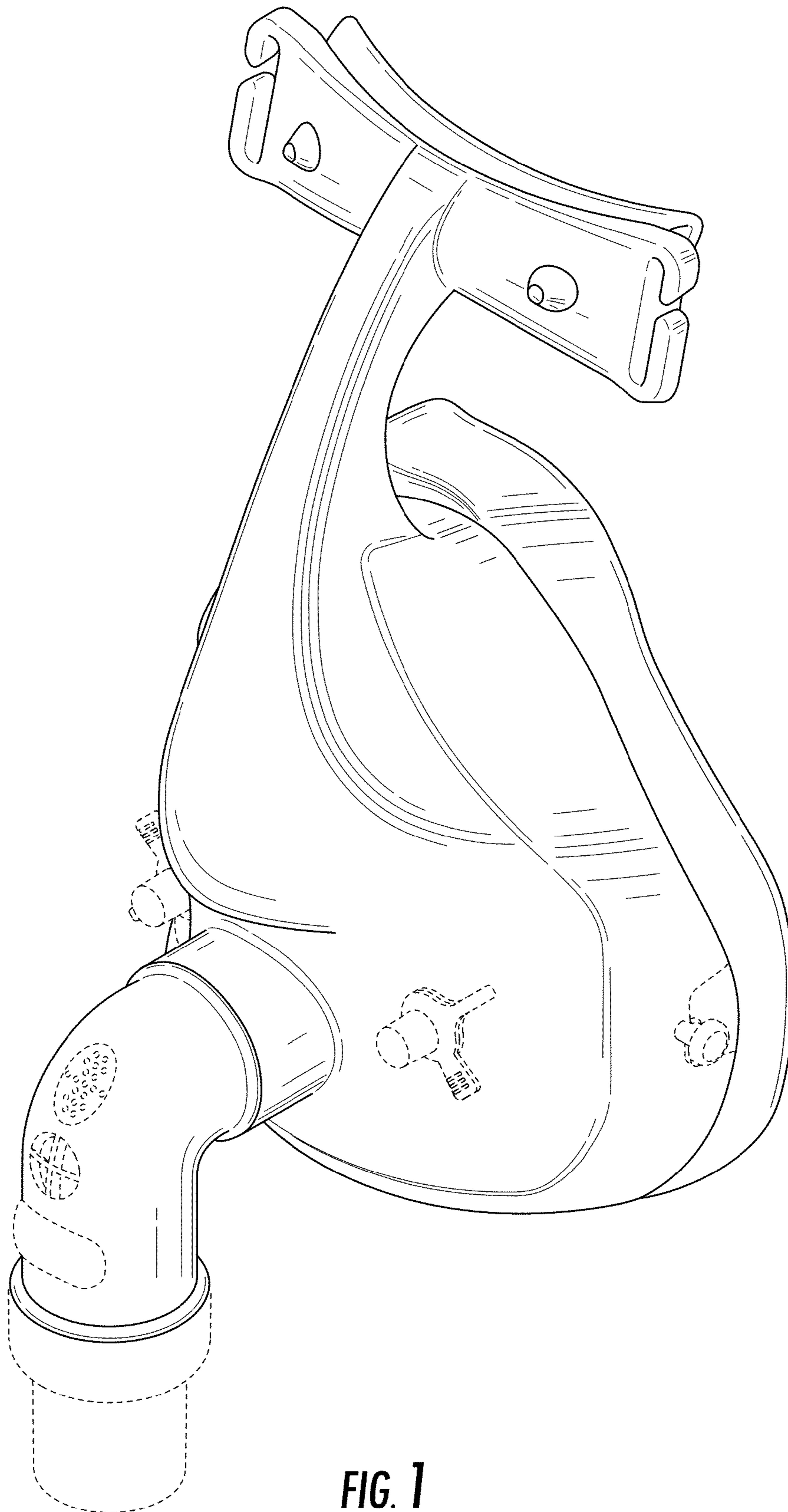

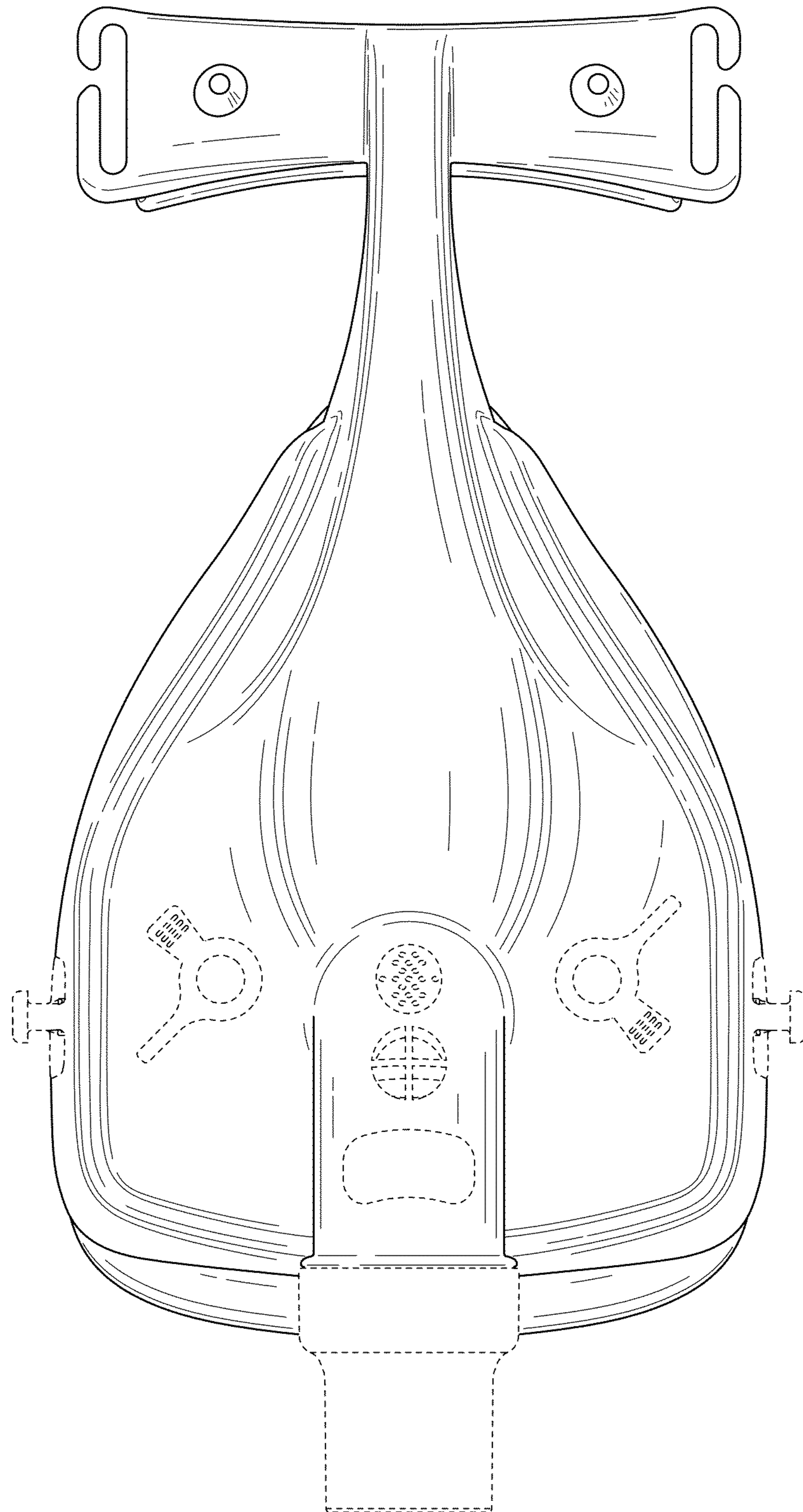

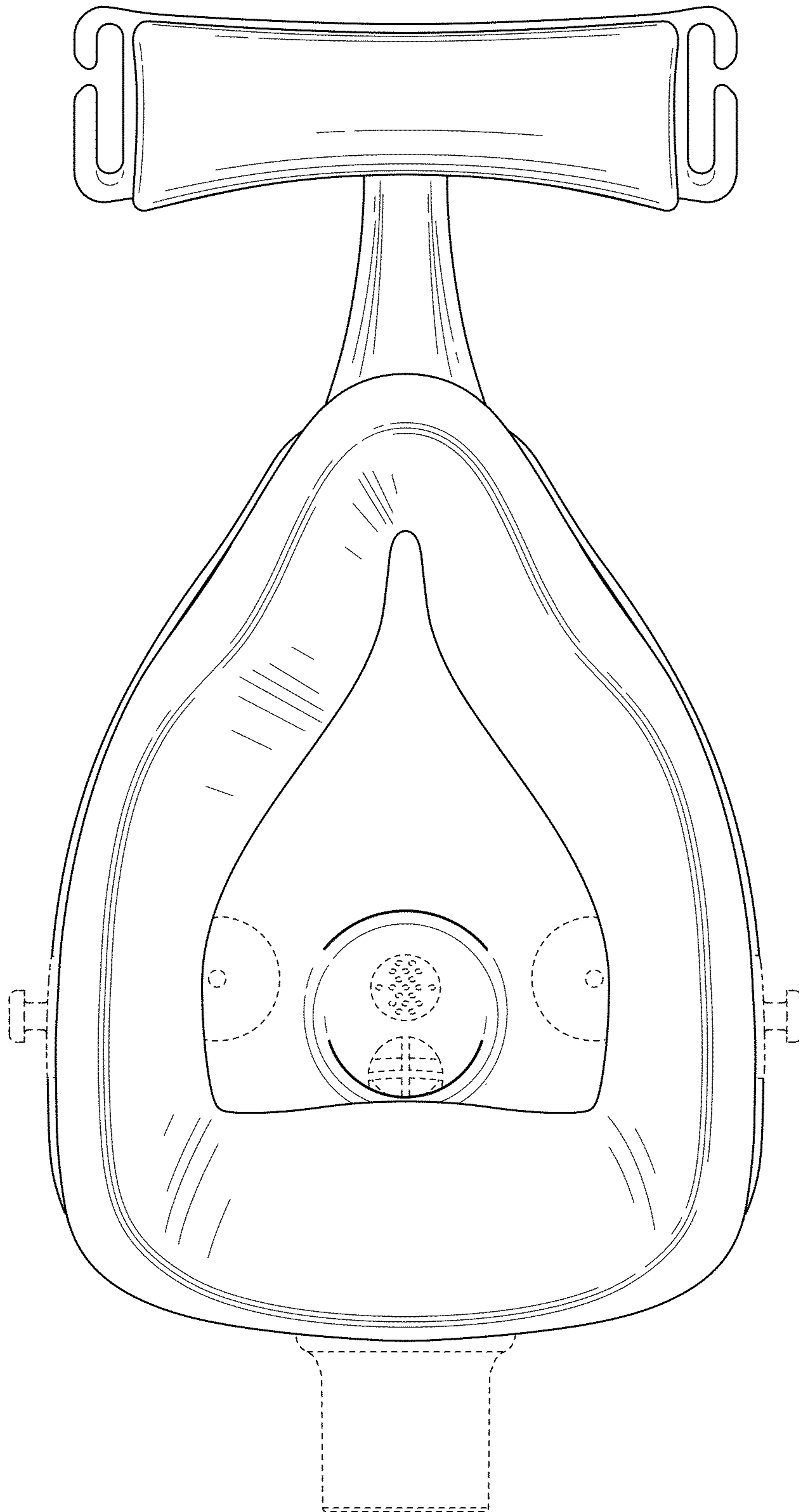

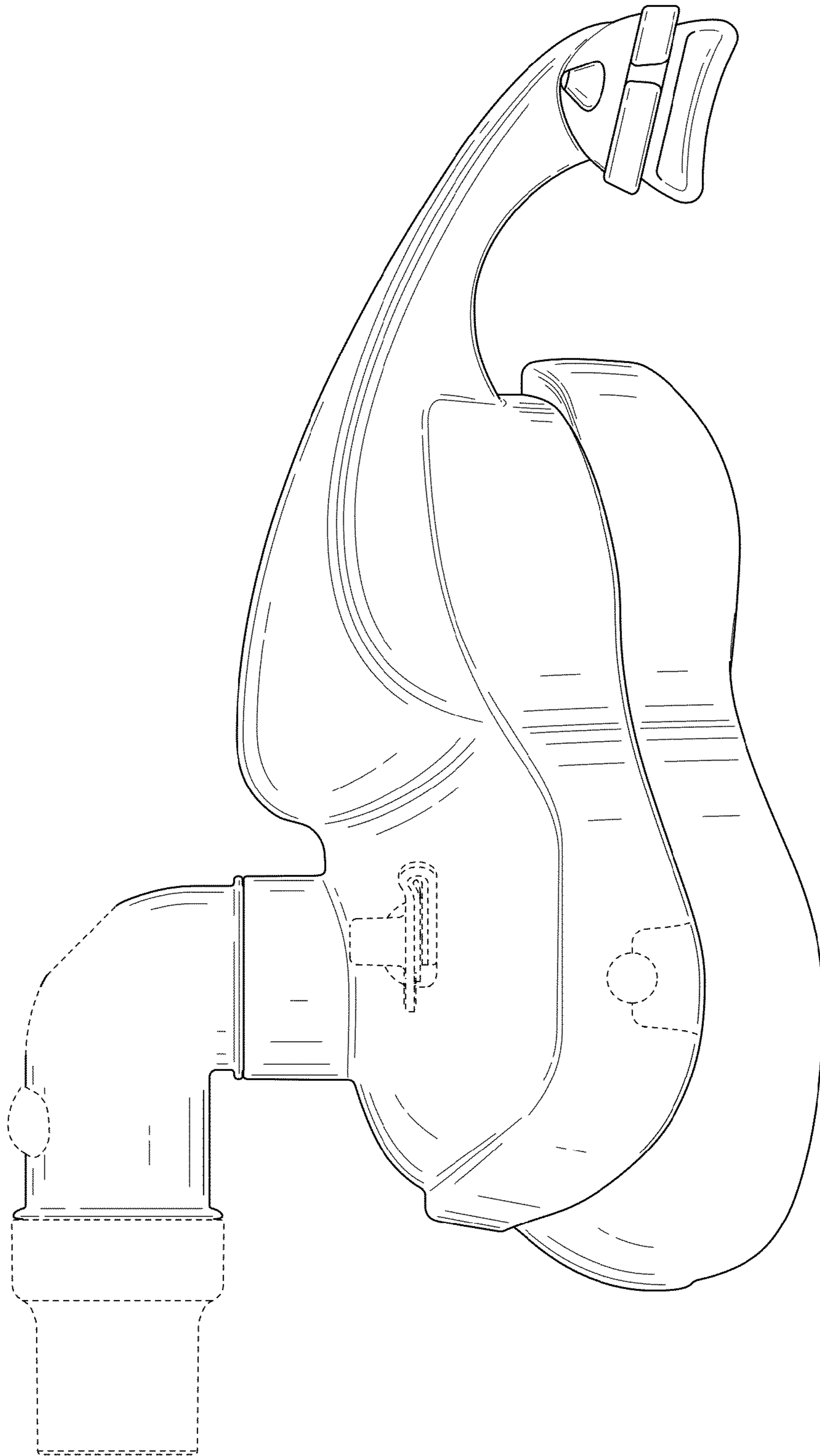

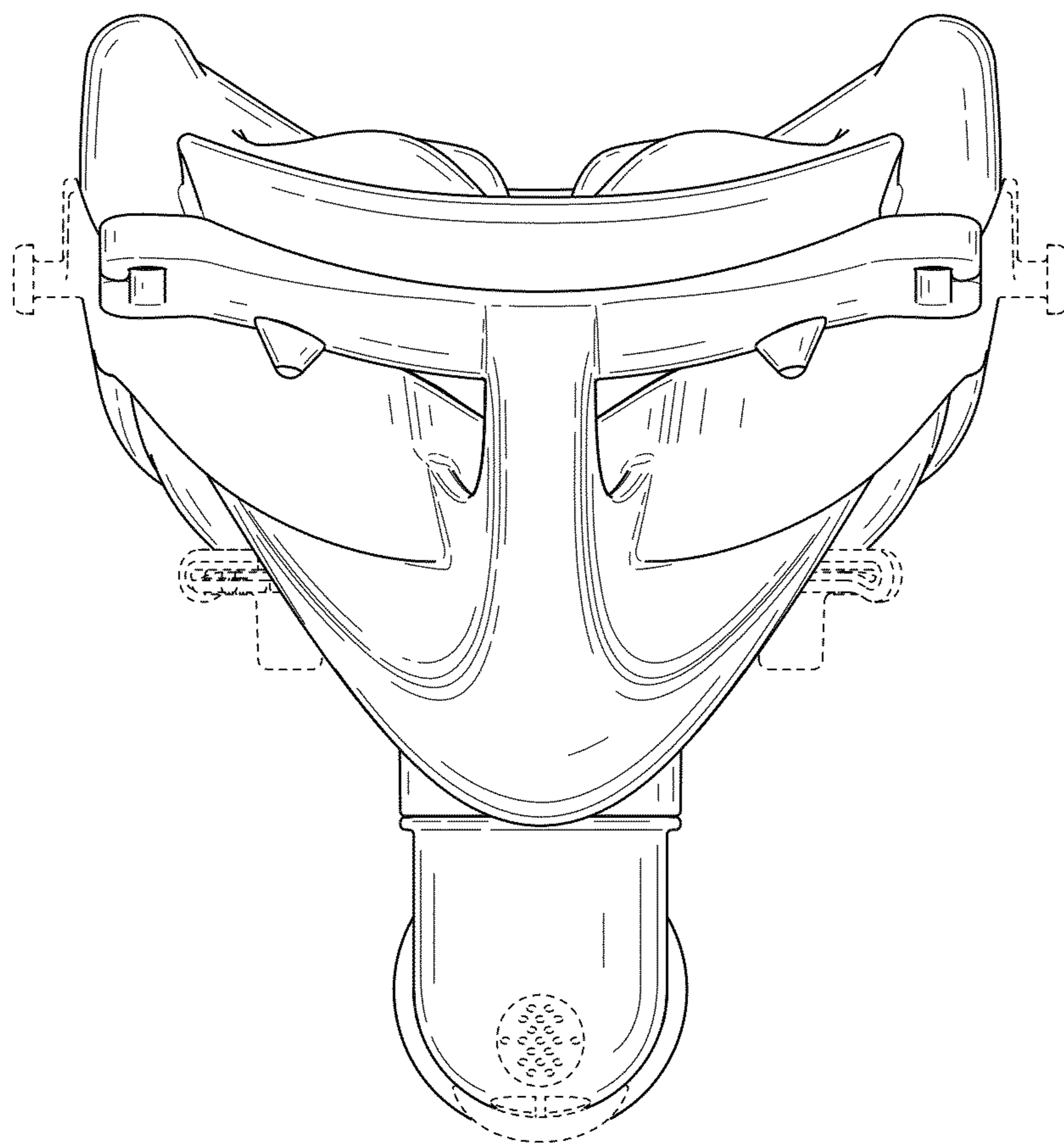

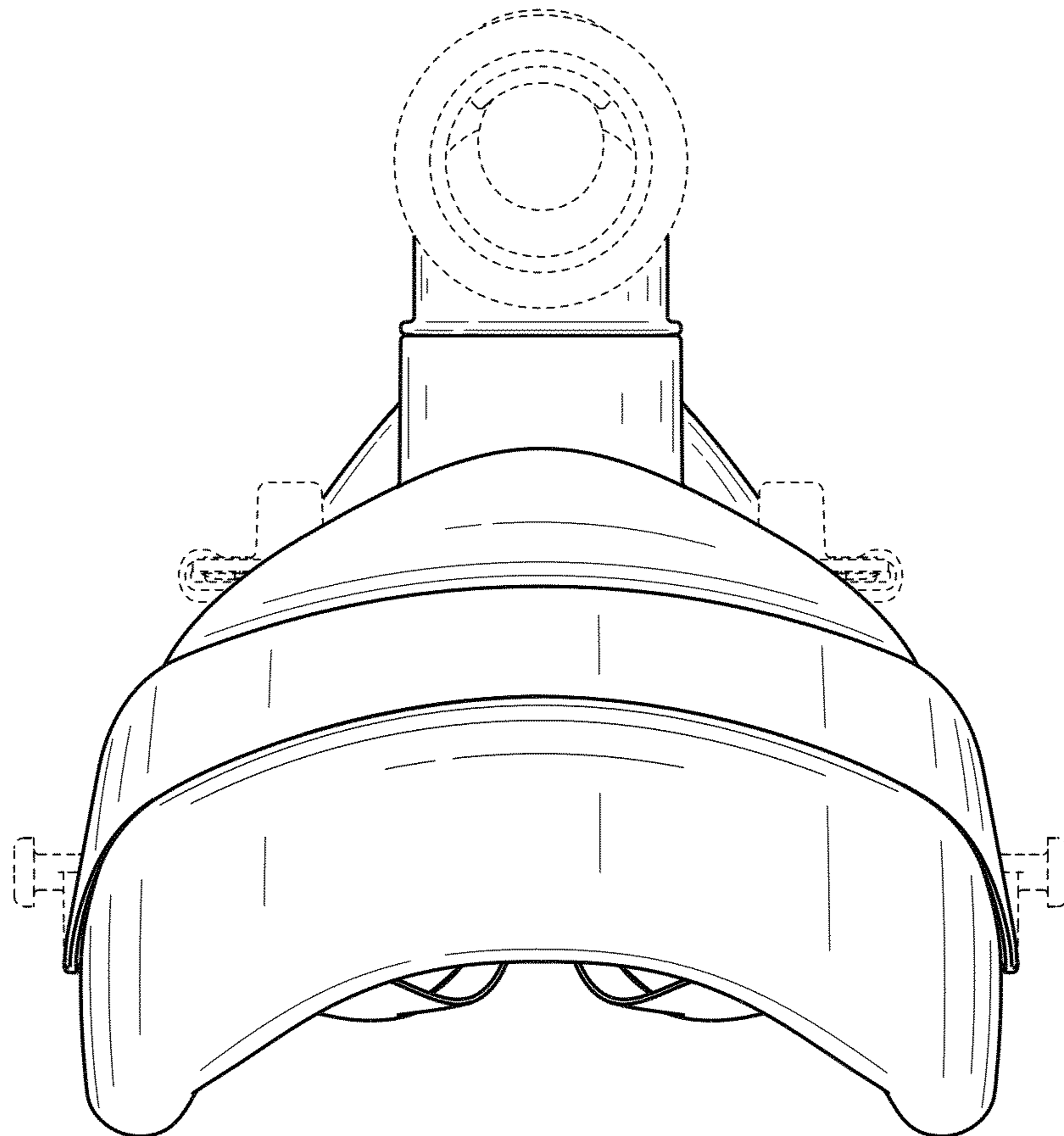
