(57) **CLAIM**

The ornamental design for a massage appliance, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of the massage appliance according to the invention;  
FIG. 2 is a left side elevation view of the massage appliance of FIG. 1, with the right side being a mirror image thereof;  
FIG. 3 is a front elevation view of the massage appliance of FIG. 1;  
FIG. 4 is a rear elevation view of the massage appliance of FIG. 1;  
FIG. 5 is a top plan view of the massage appliance of FIG. 1;  
FIG. 6 is a bottom perspective view of the massage appliance of FIG. 1; and,  
FIG. 7 is a bottom plan view of the massage appliance of FIG. 1.

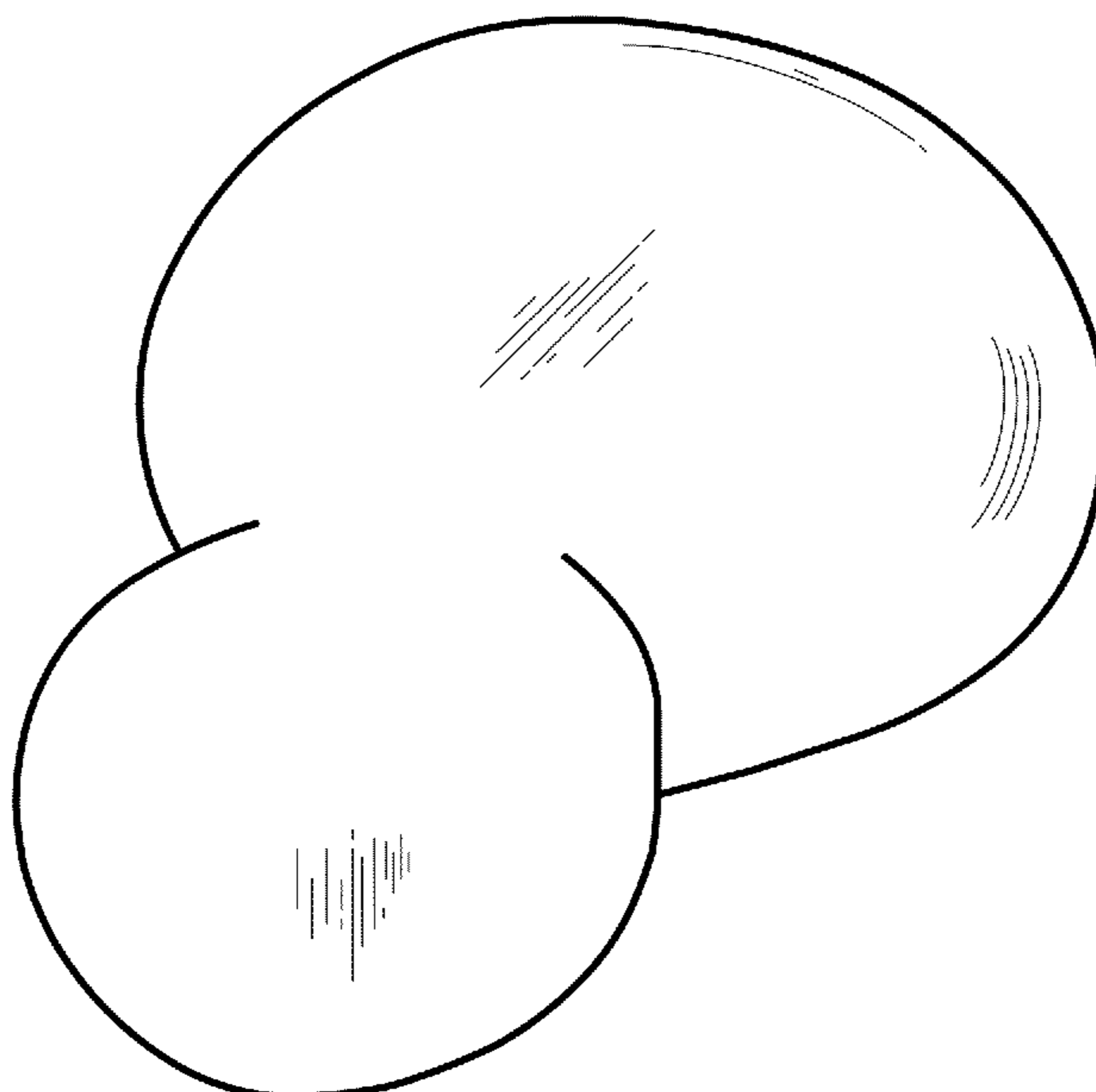

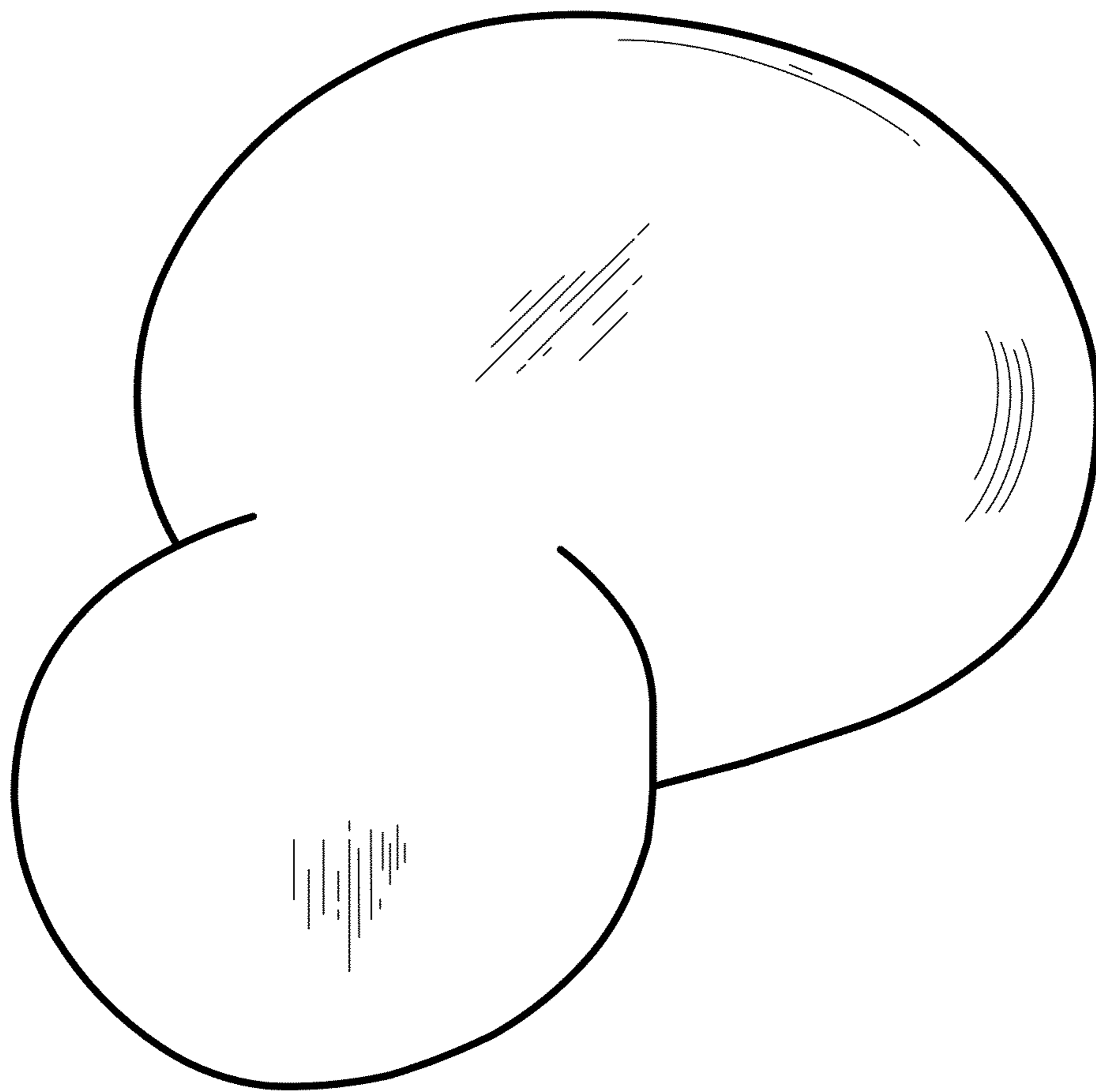

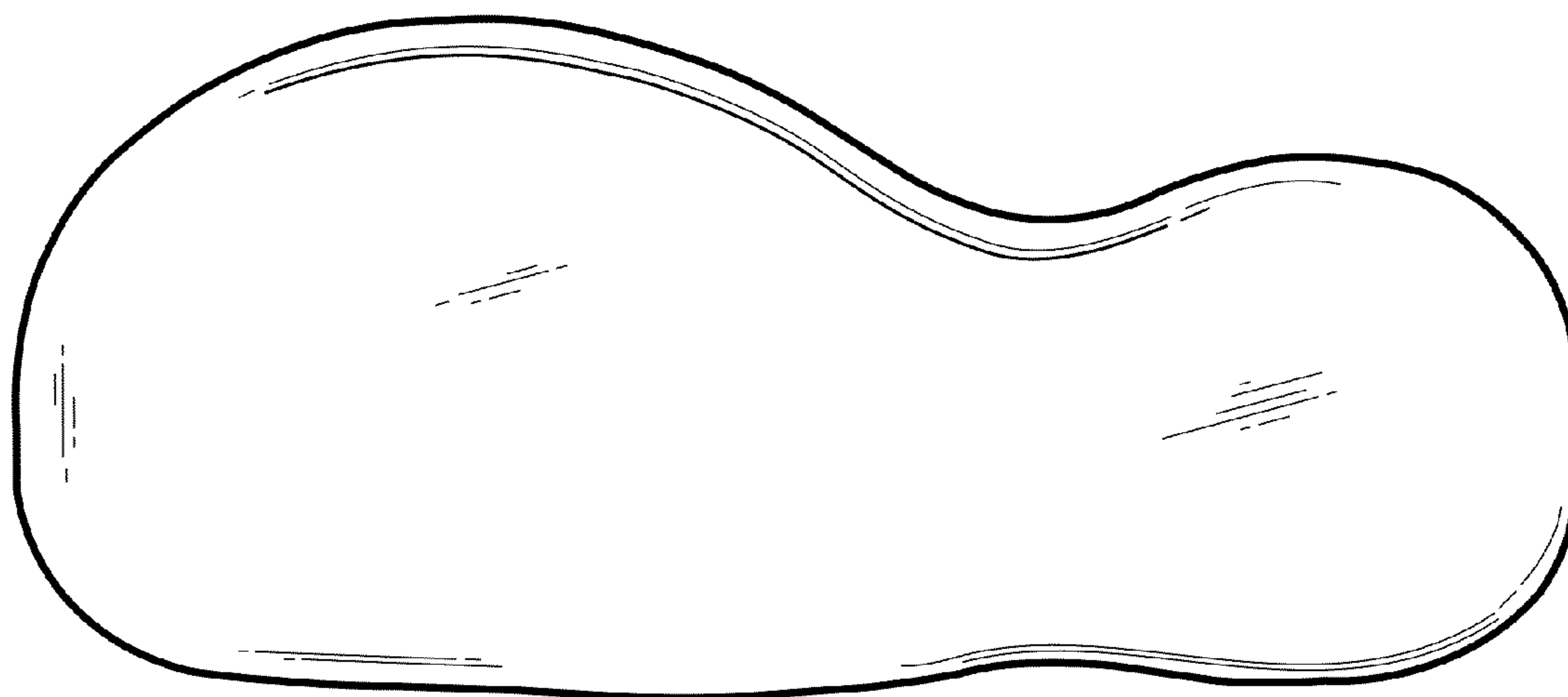

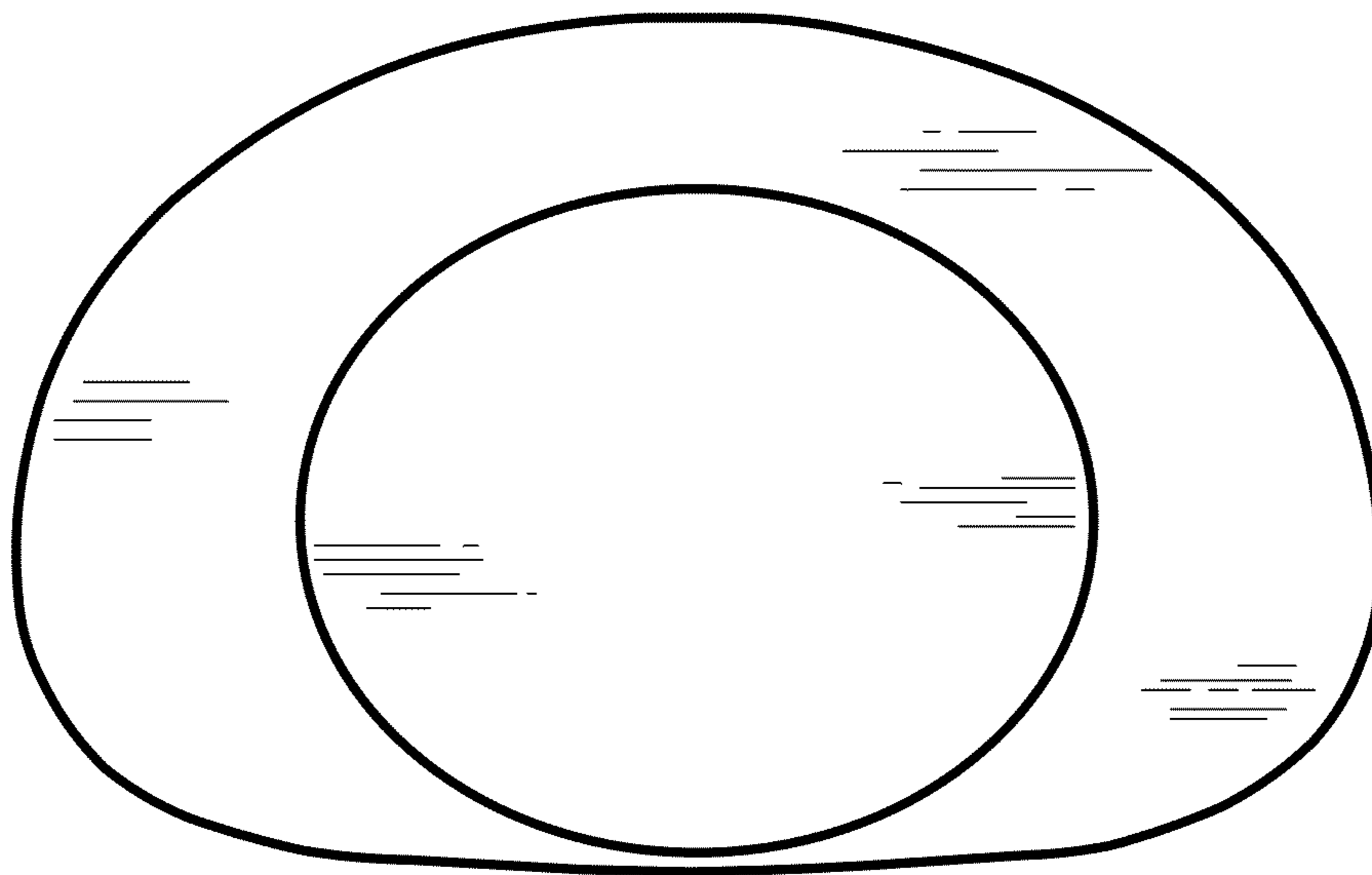

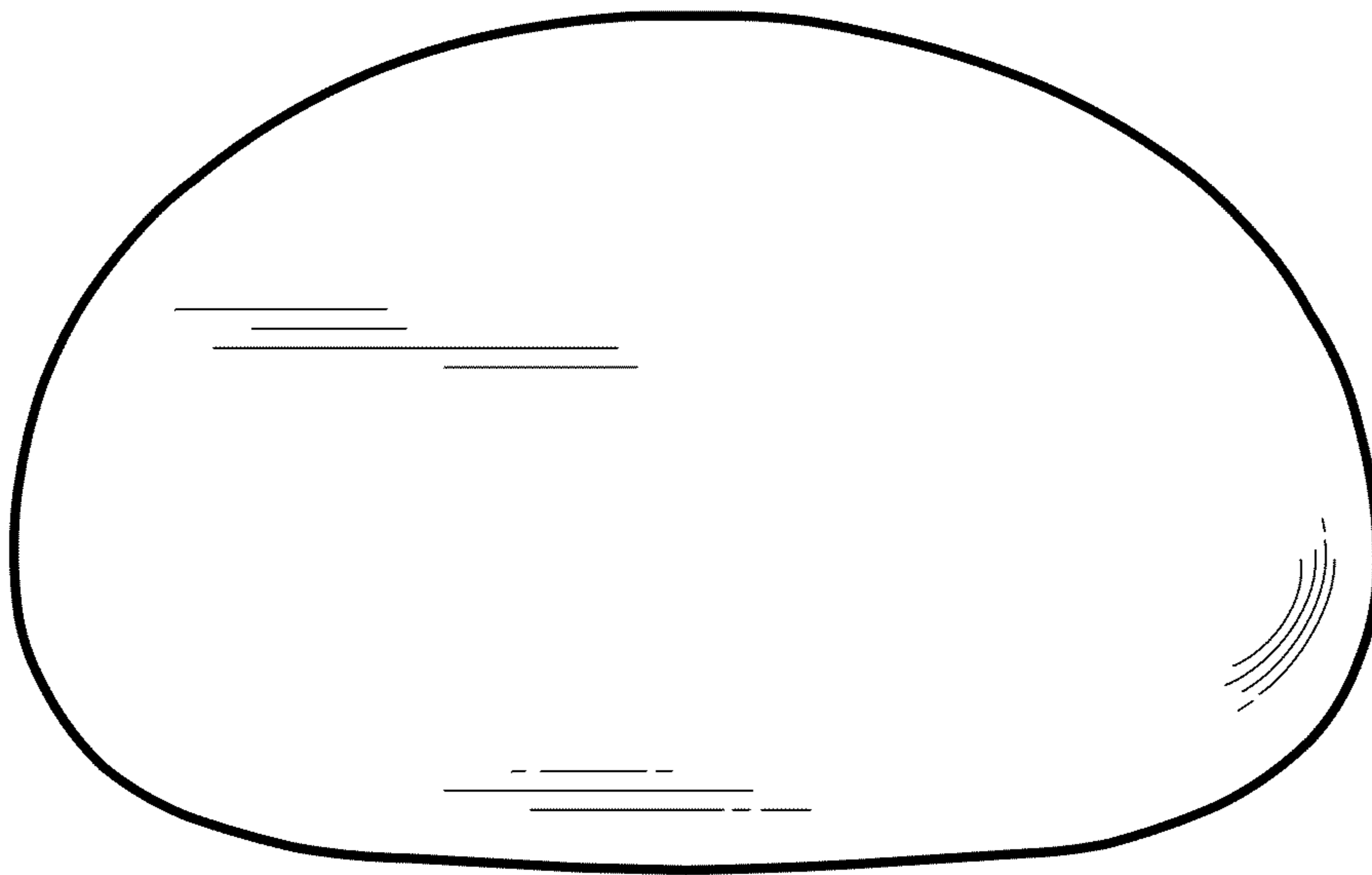

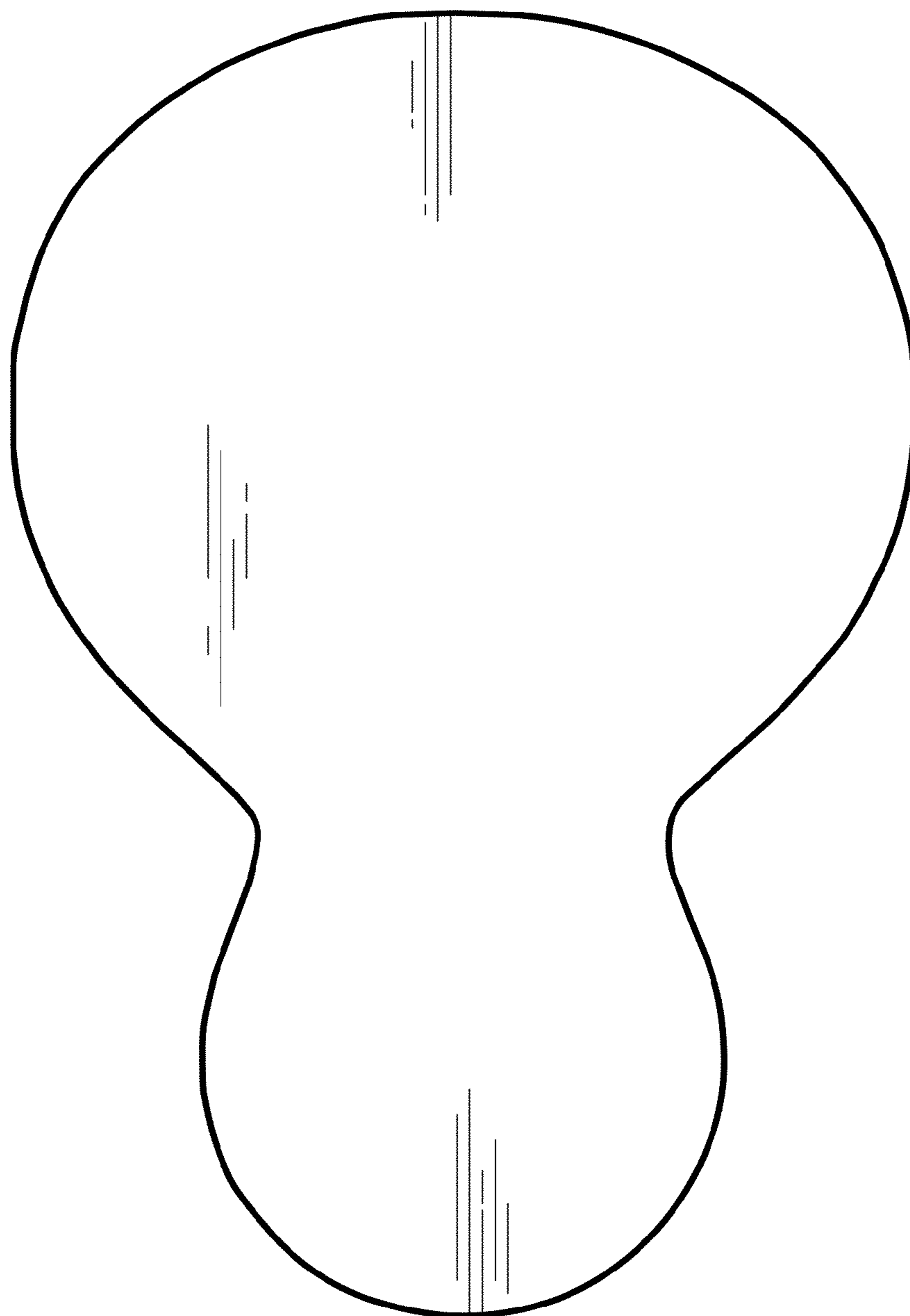

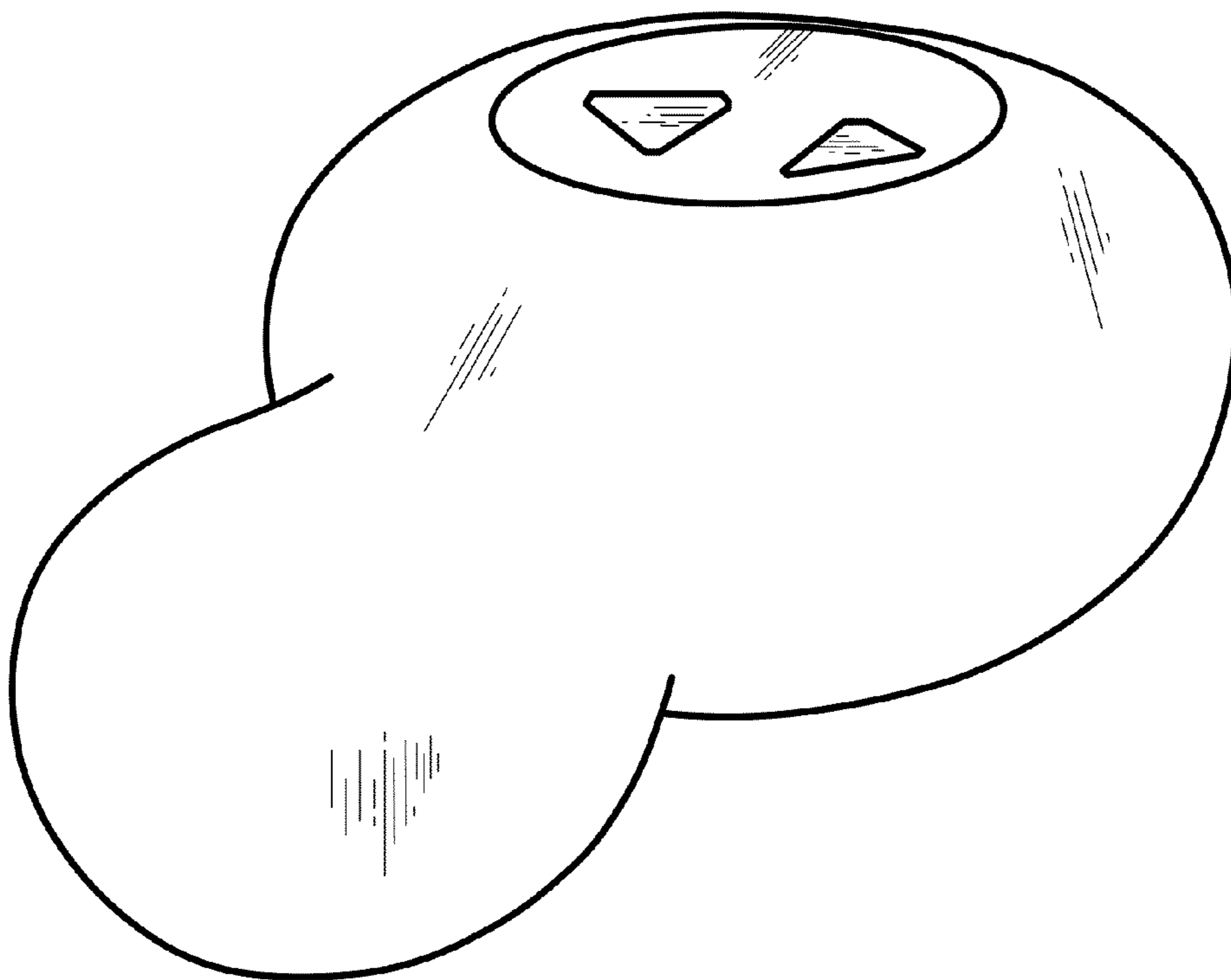
