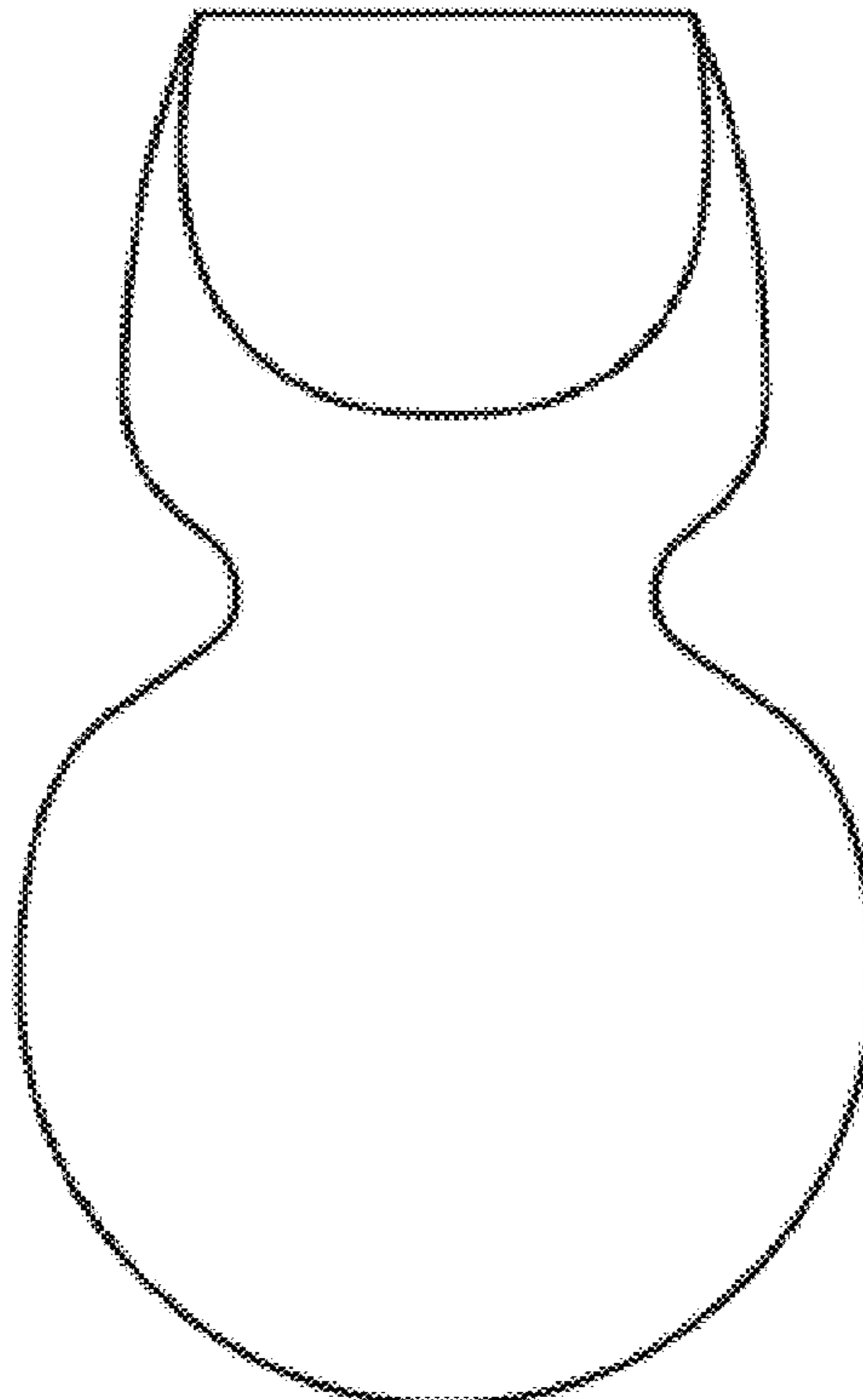

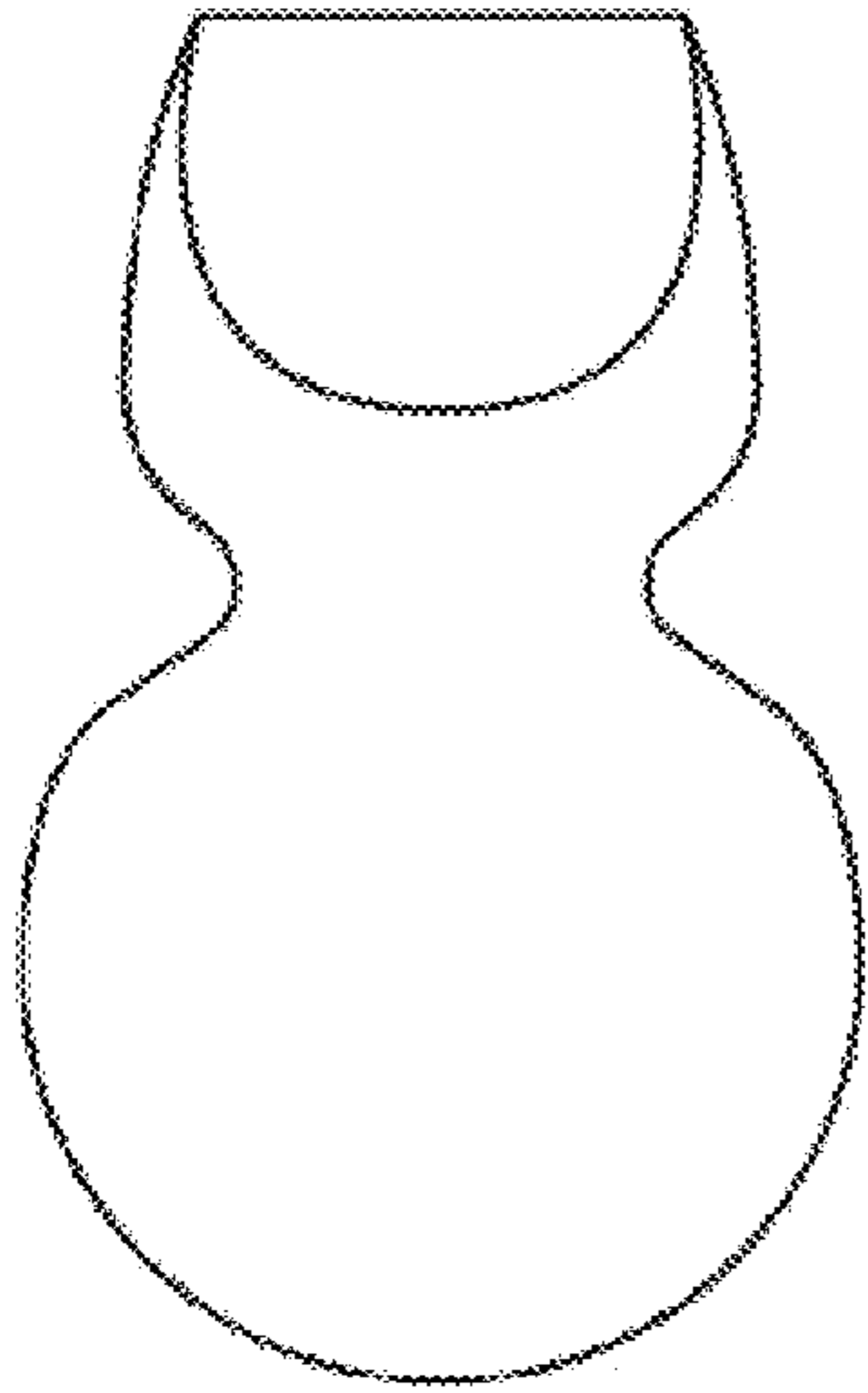
An ornamental design for a cosmetics sponge, as shown and described.

**DESCRIPTION**

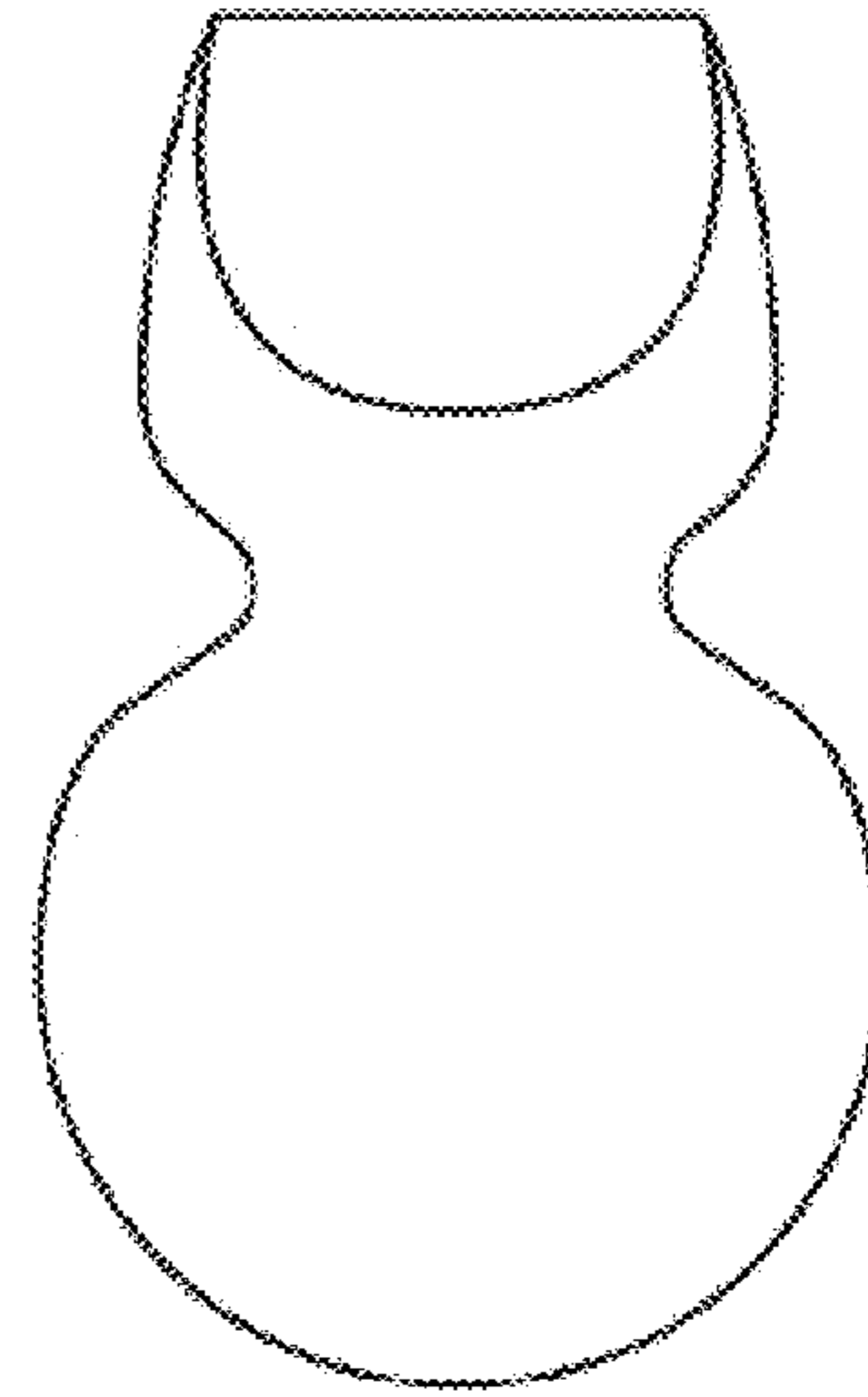

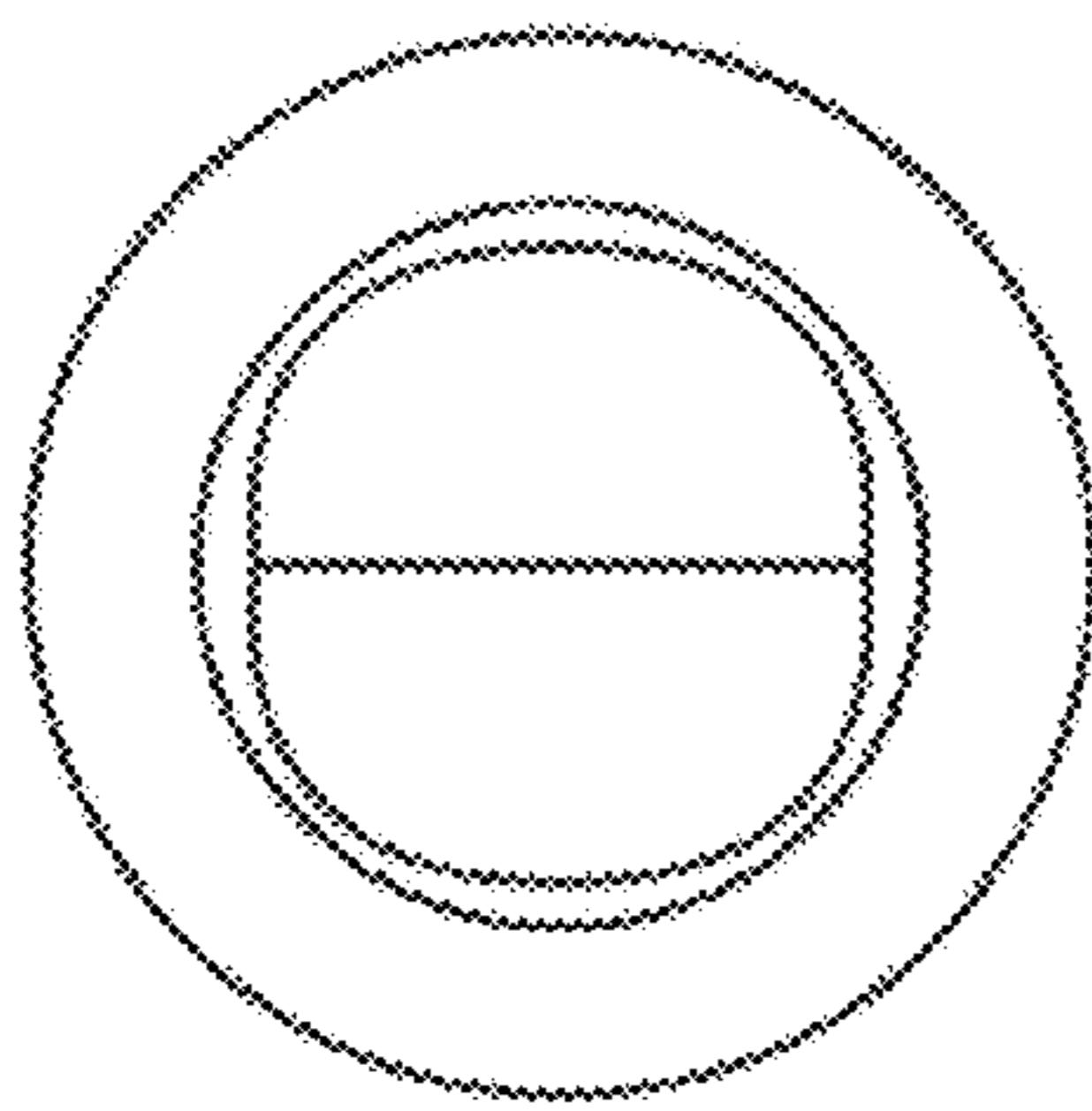




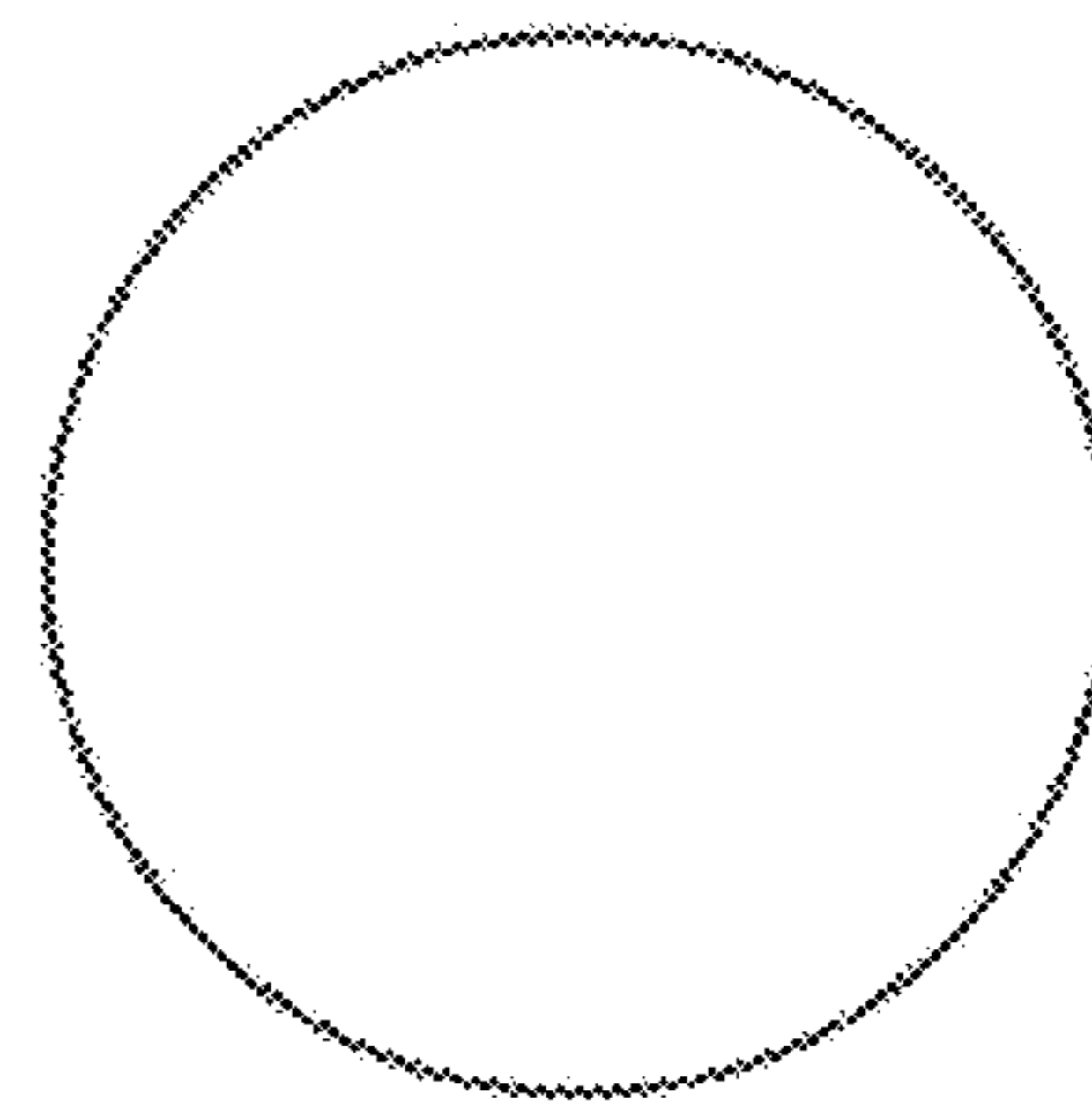

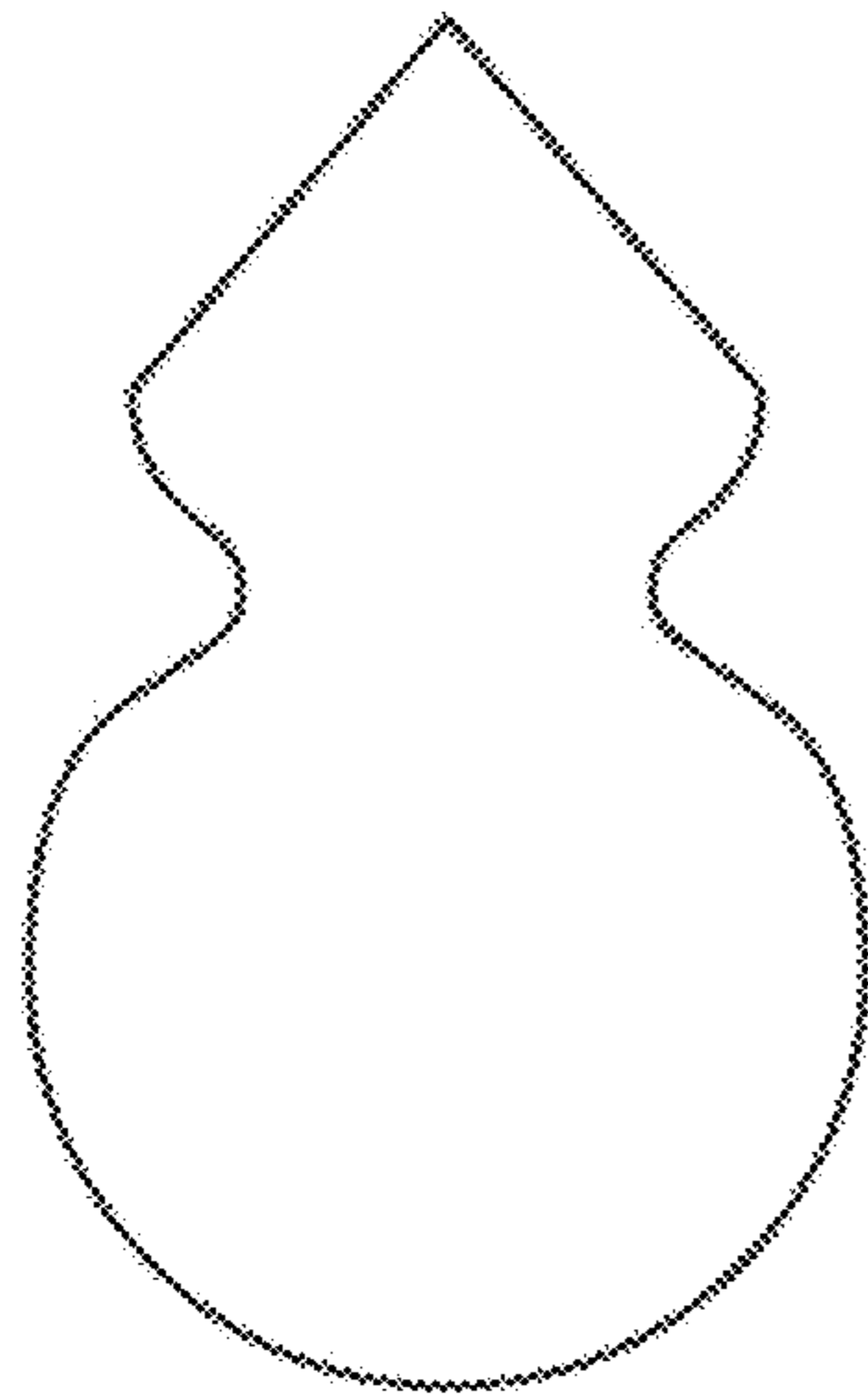

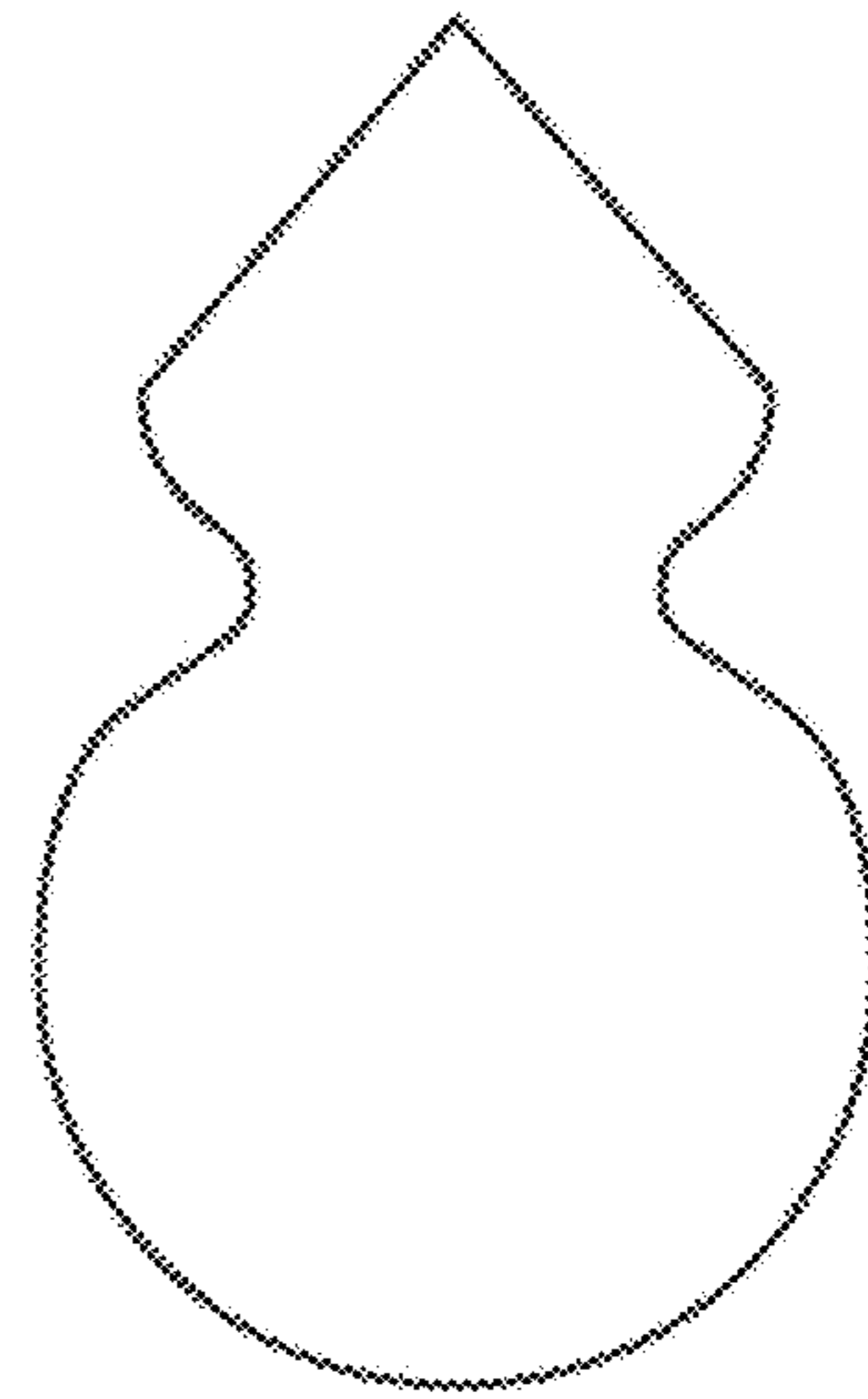
