(57) **CLAIM**

The ornamental design for a soap bar, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a soap bar according to the present invention illustrating the top, front, and right sides of the soap bar. The left side of the soap bar is a mirror image of the right side as illustrated. The front of the soap bar is also a mirror image of the rear as illustrated.

FIG. 2 is a top plan view of the soap bar of FIG. 1.

FIG. 3 is a bottom plan view of the soap bar of FIG. 1.

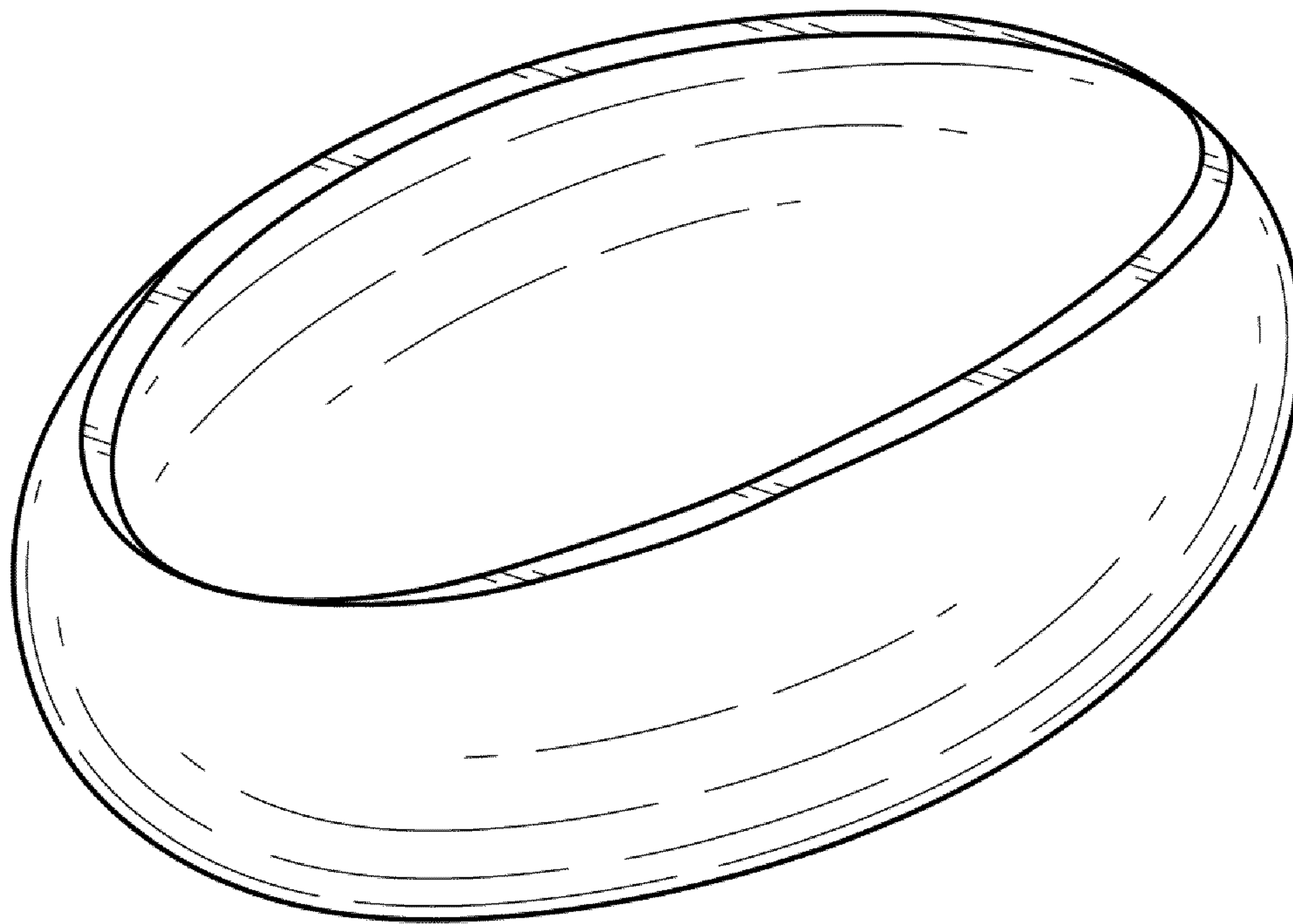
FIG. 4 is a left side elevation view of the soap bar of FIG. 1.

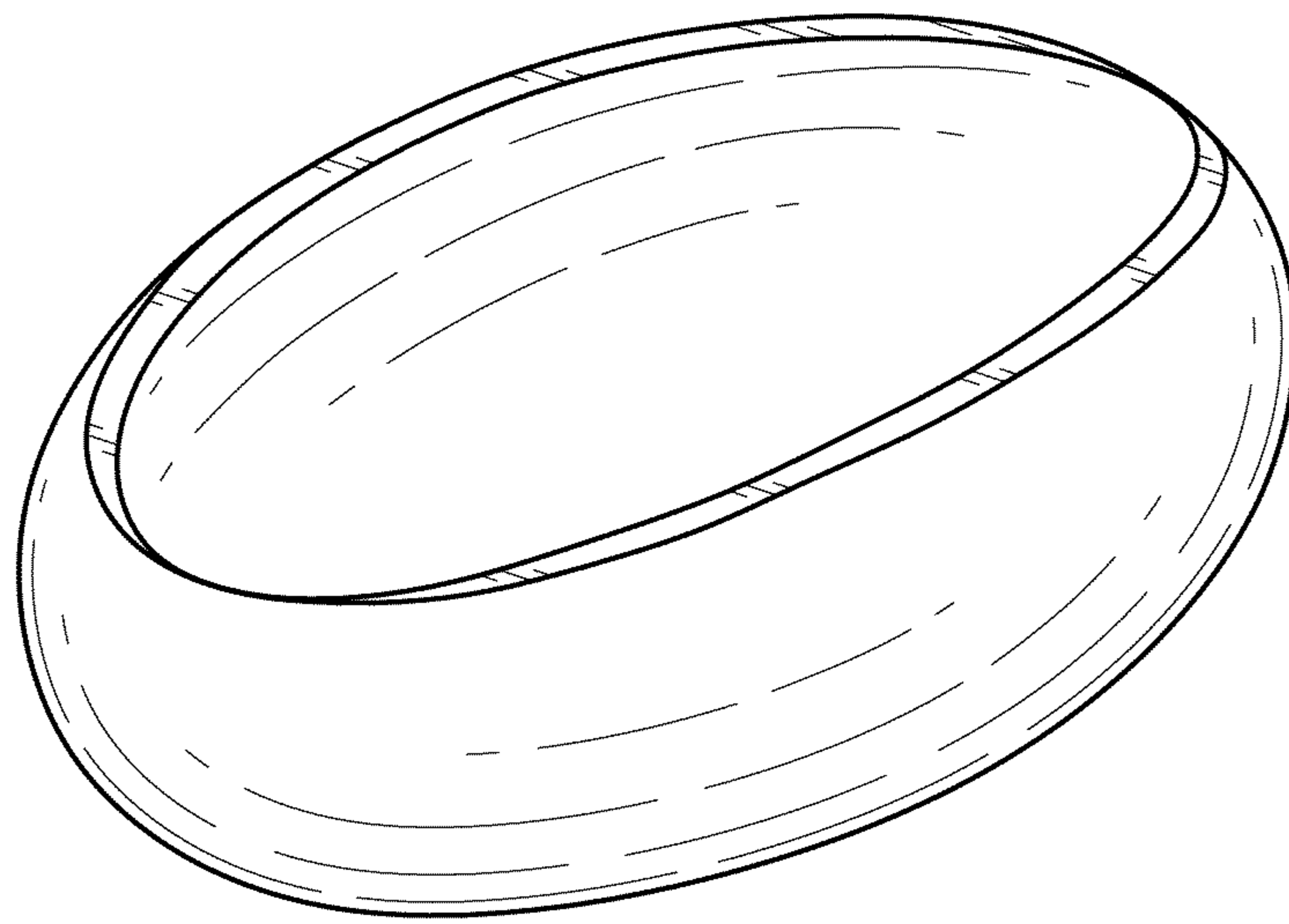

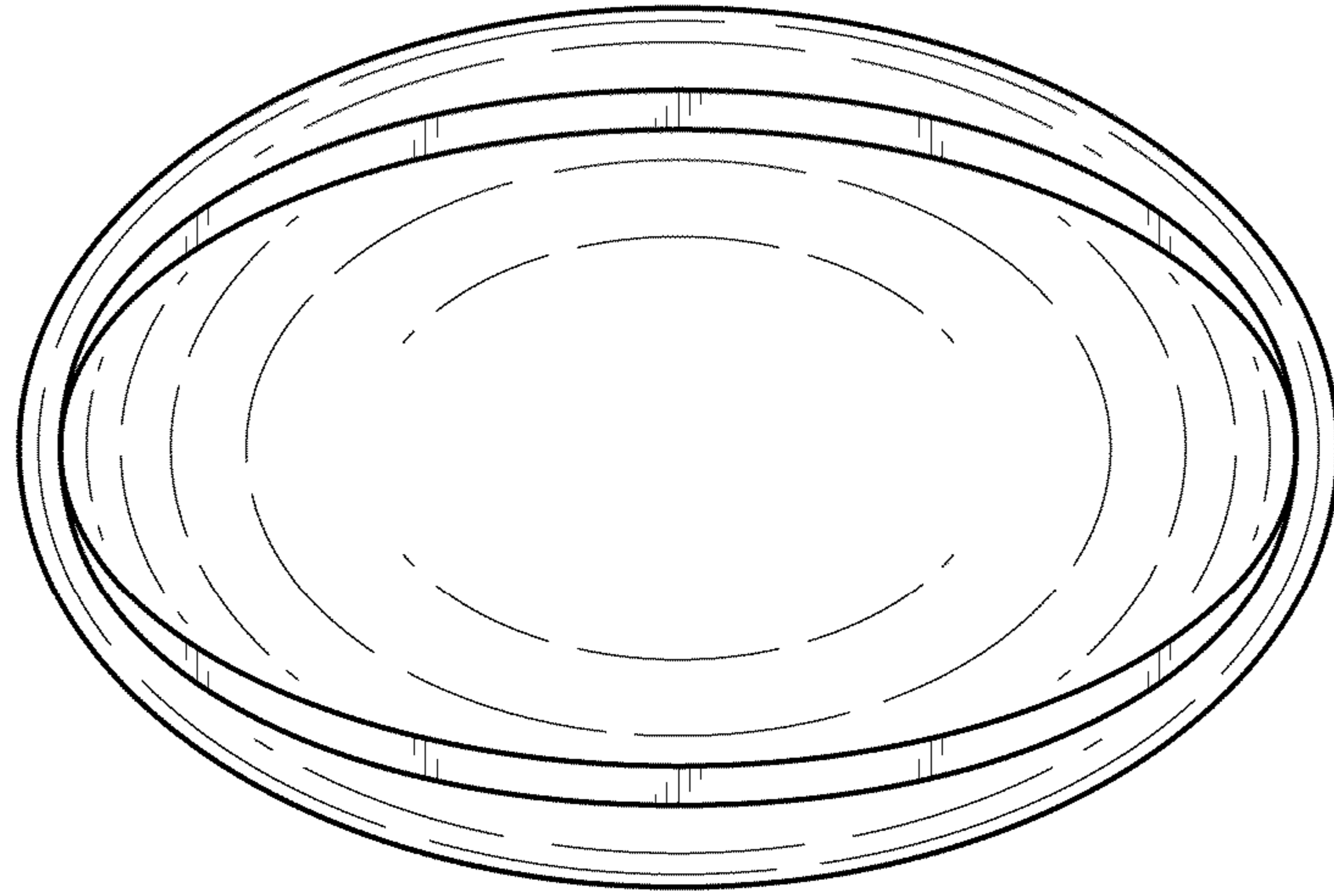

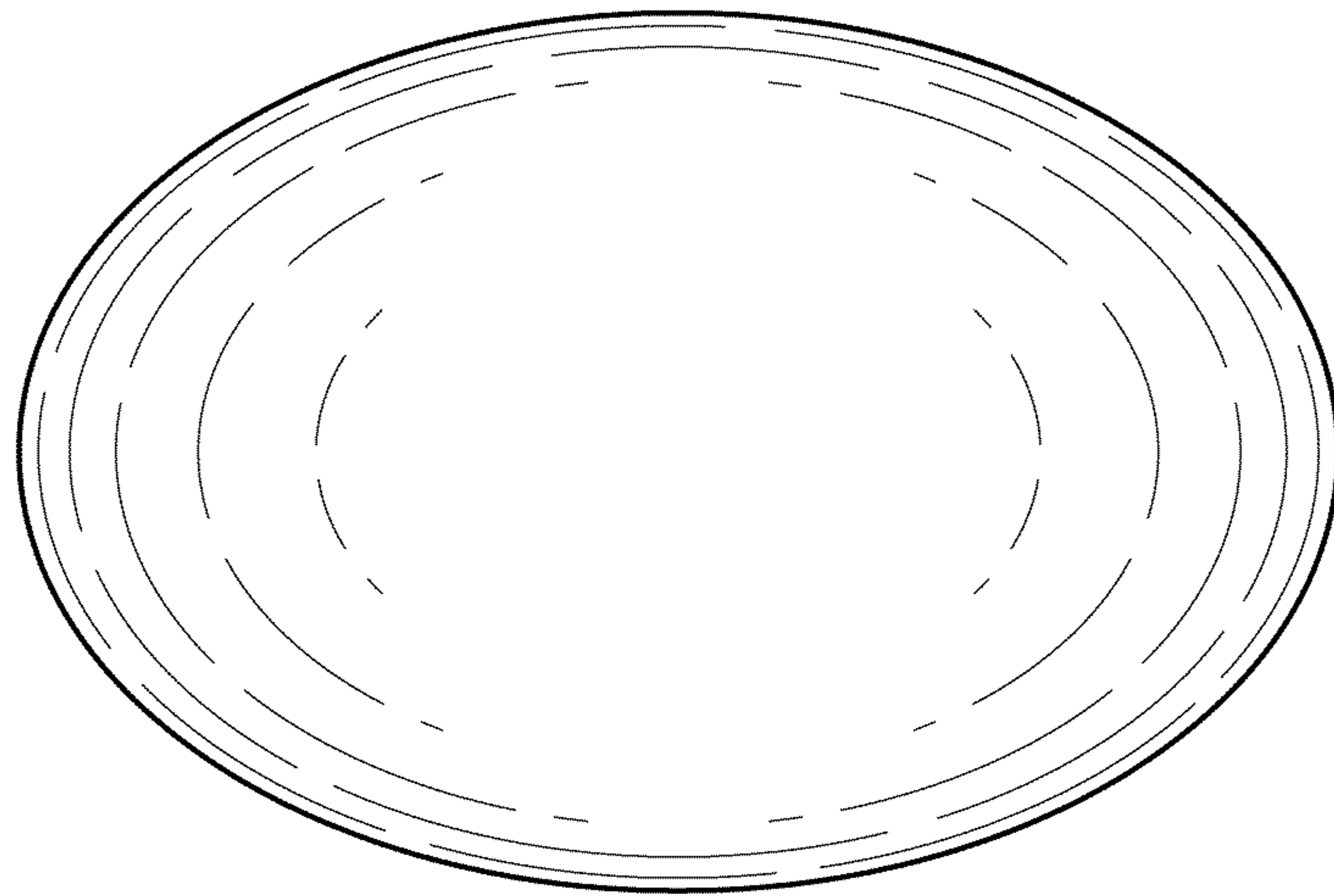

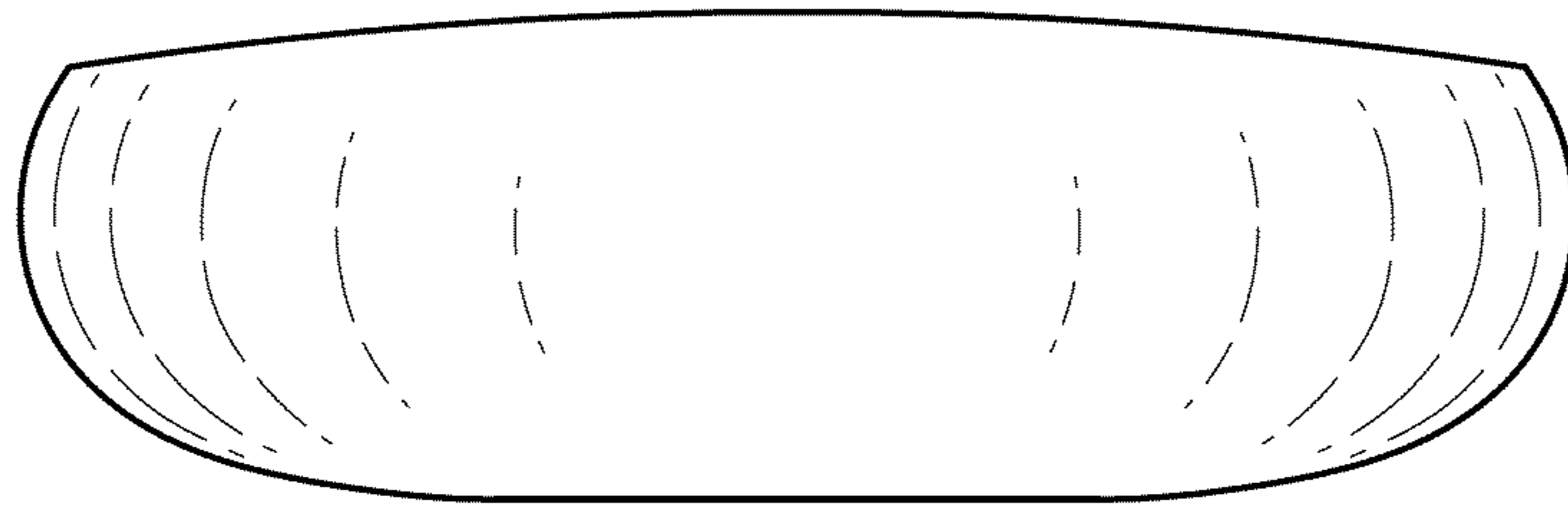

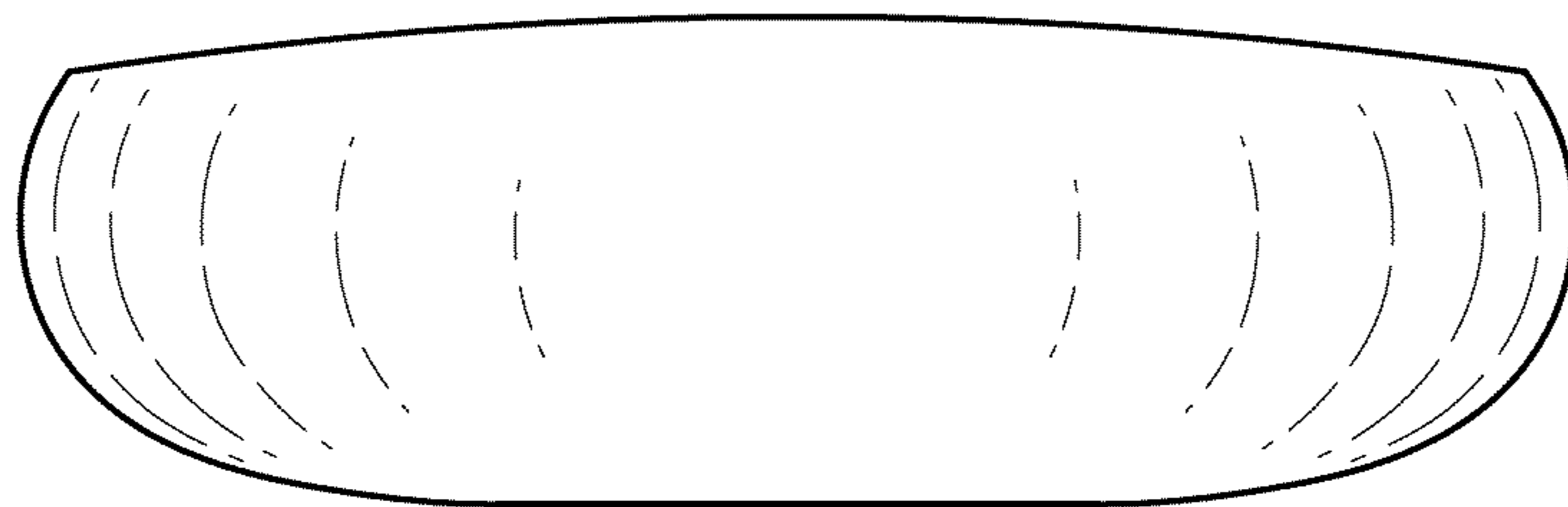

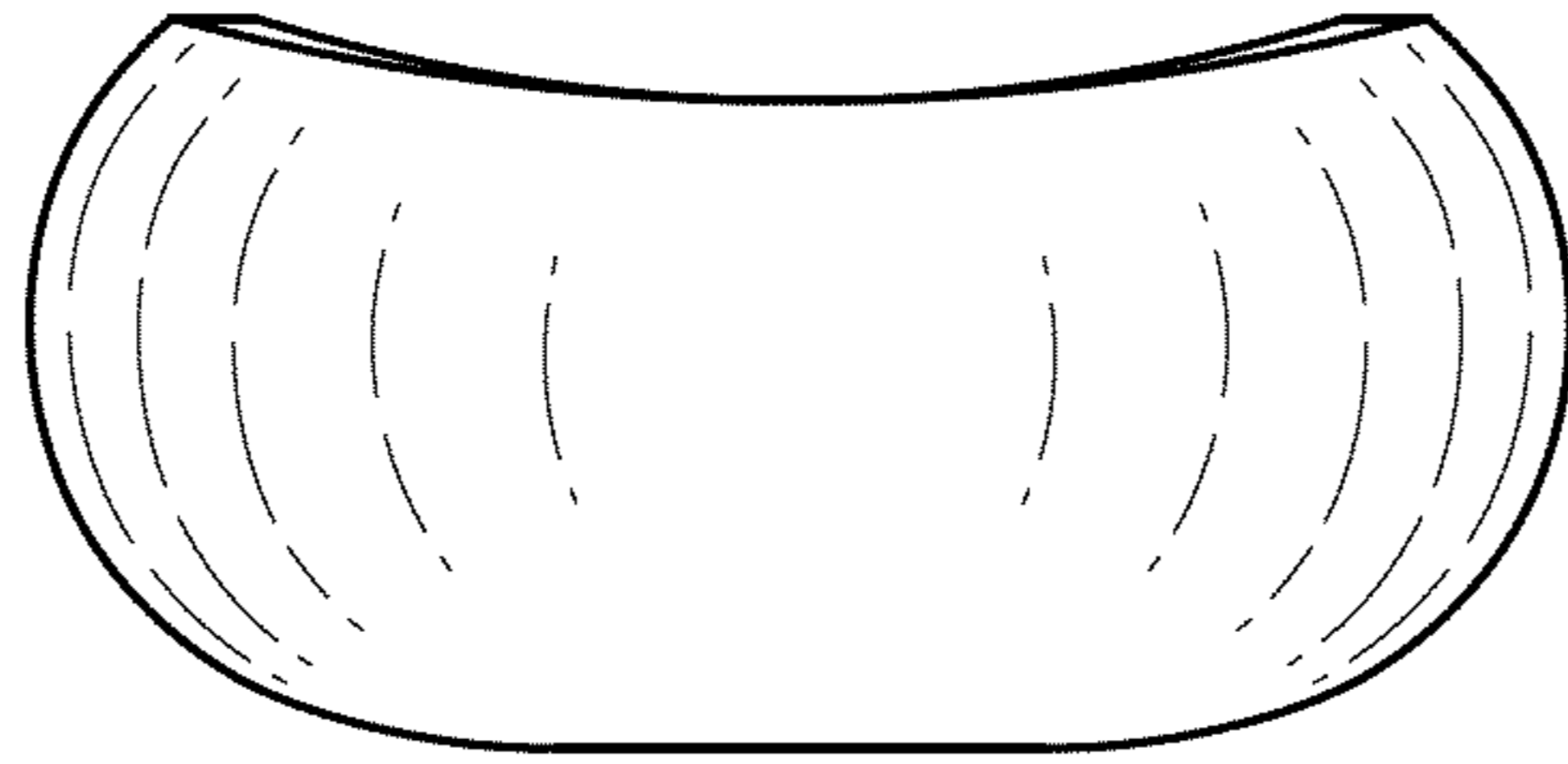

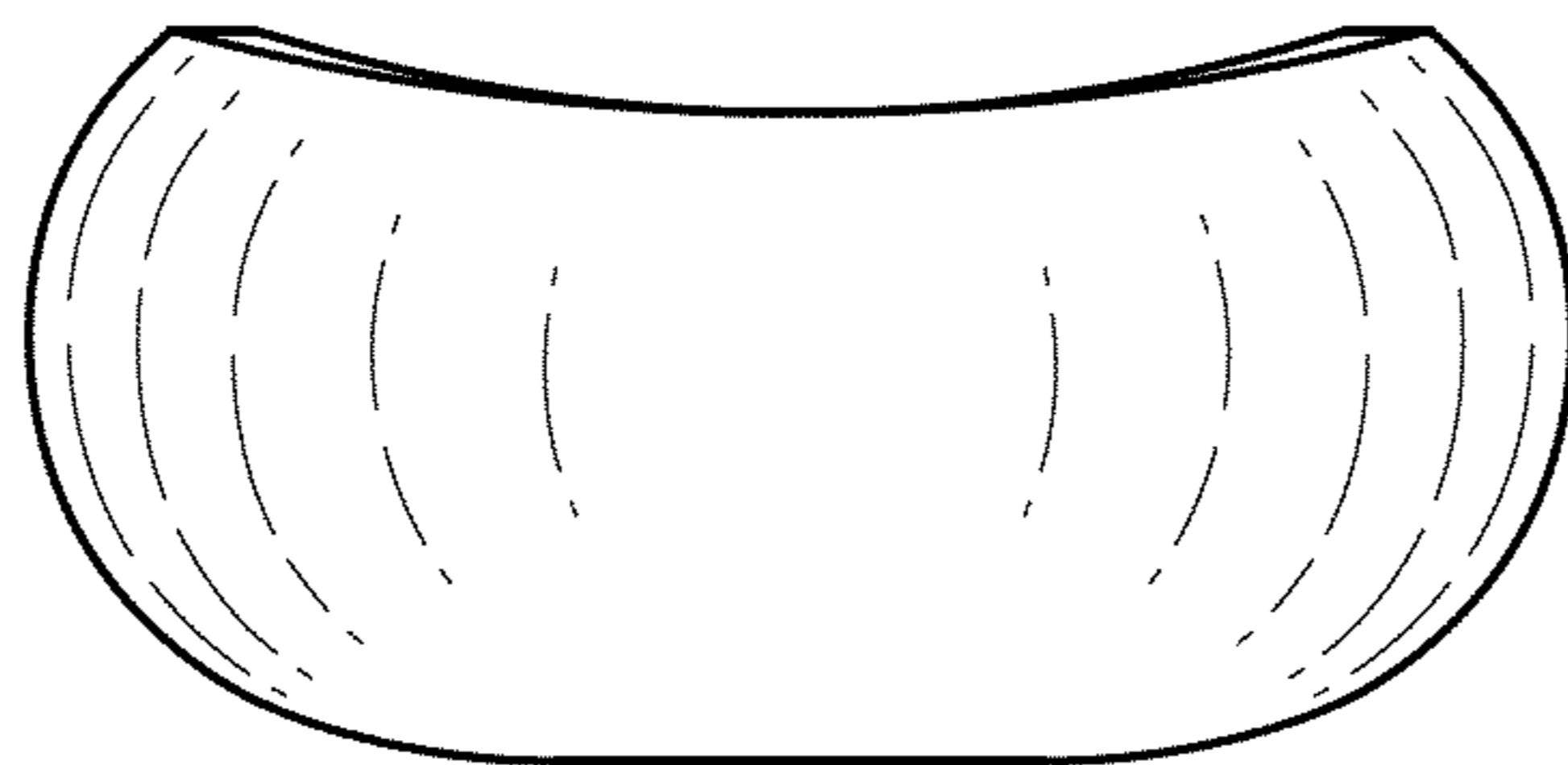
