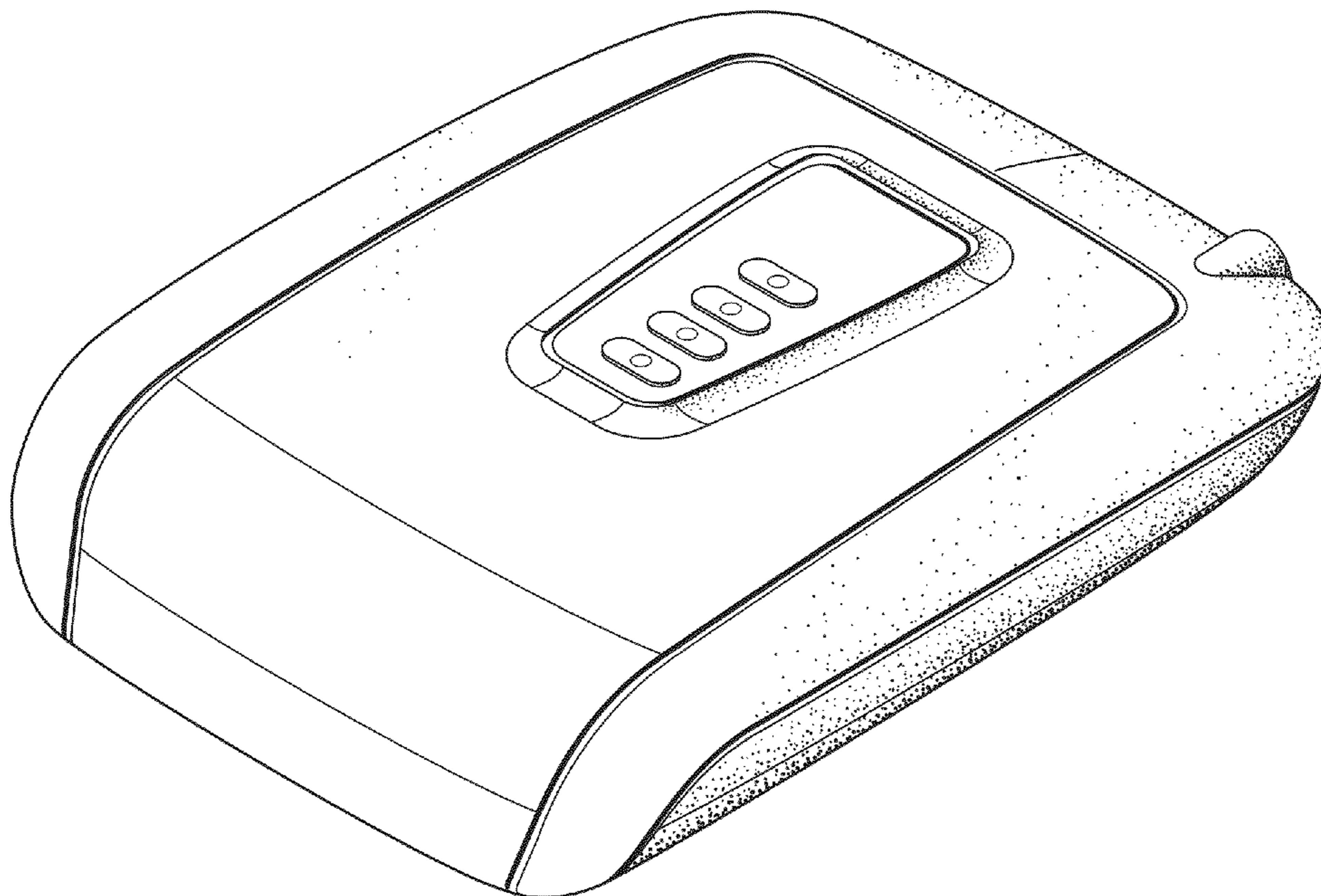
FIG. 8 is a first side elevation view of the base for handheld nail treatment device shown in FIGS. 1 and 2; and,

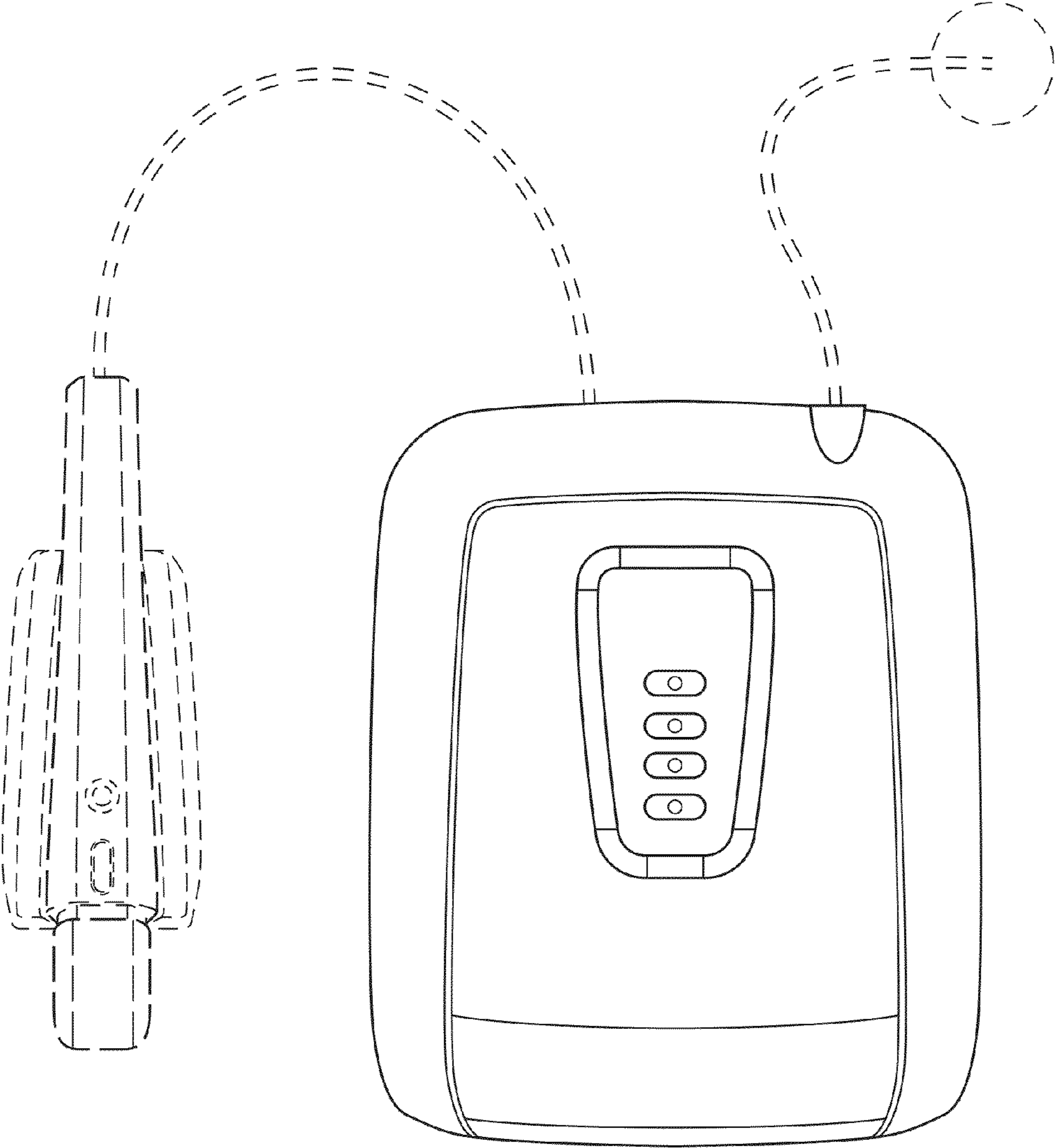

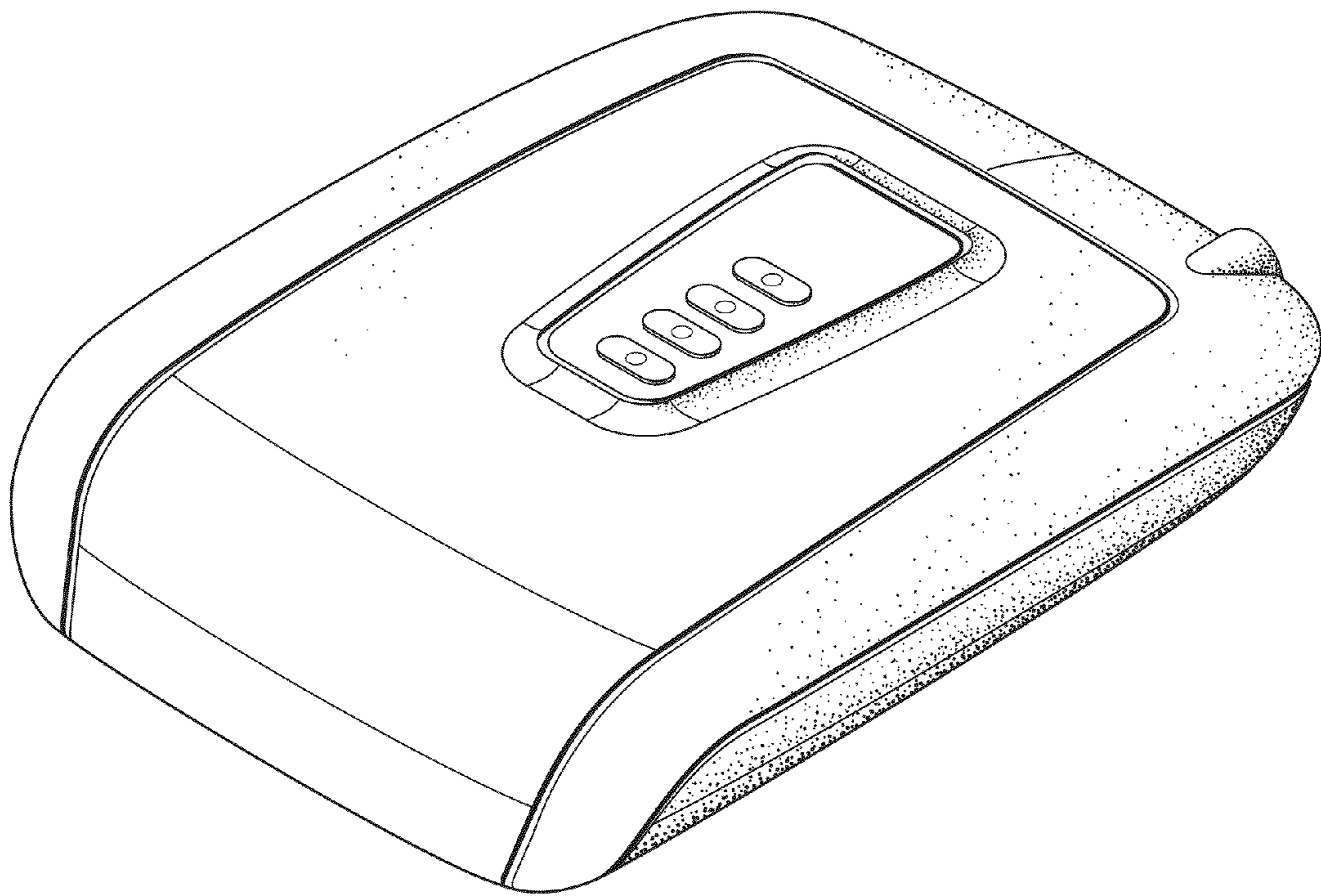

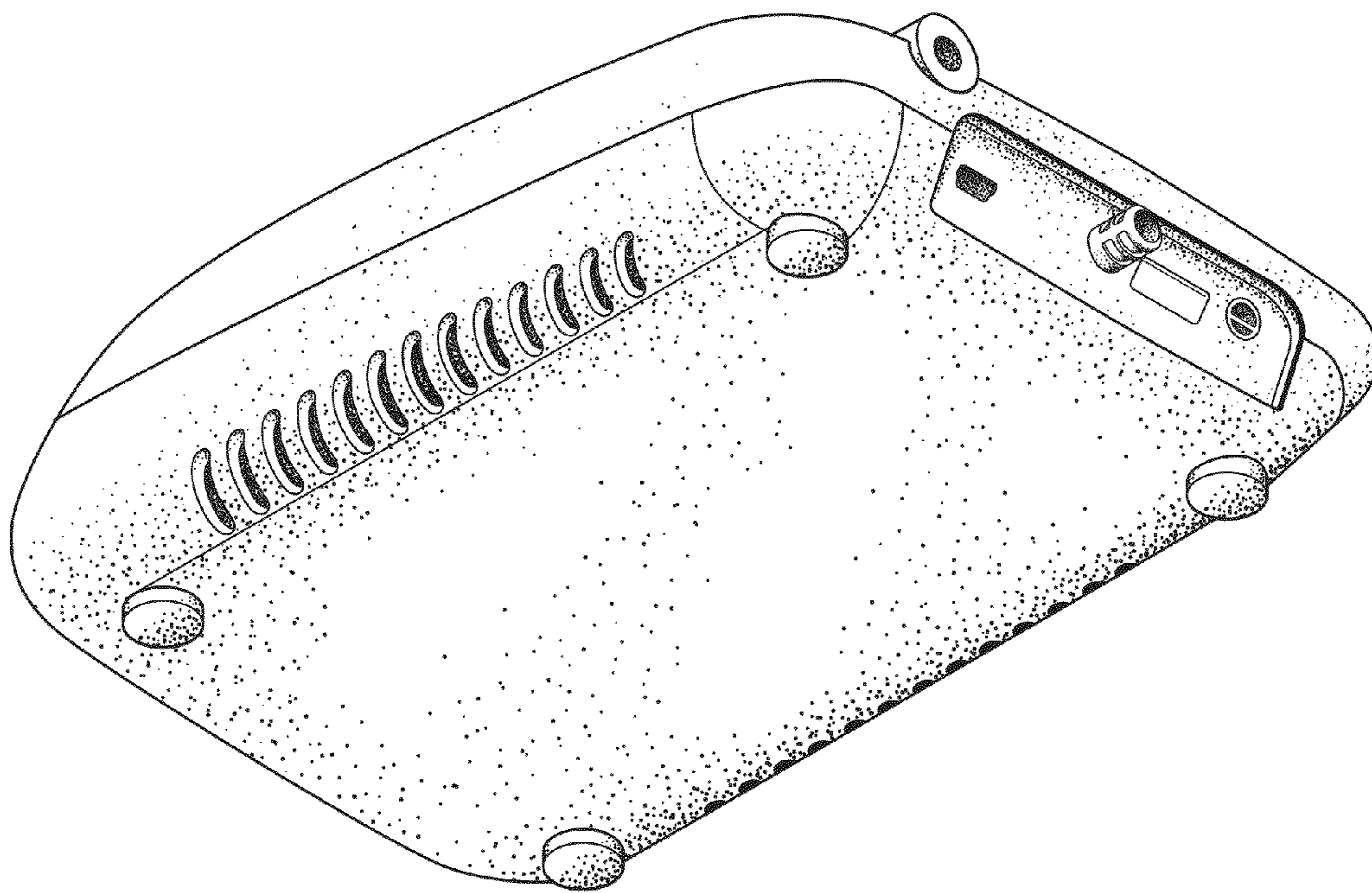

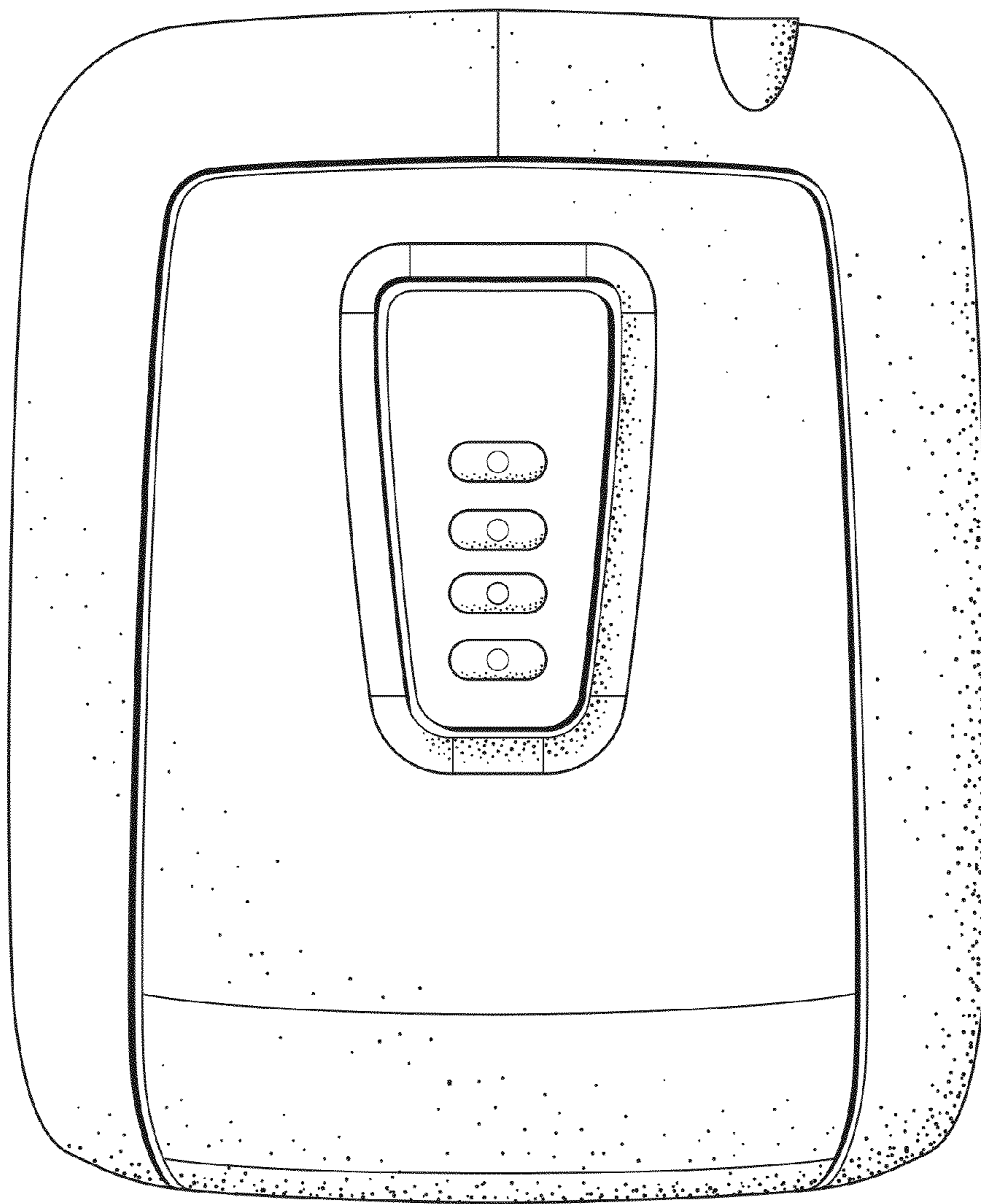

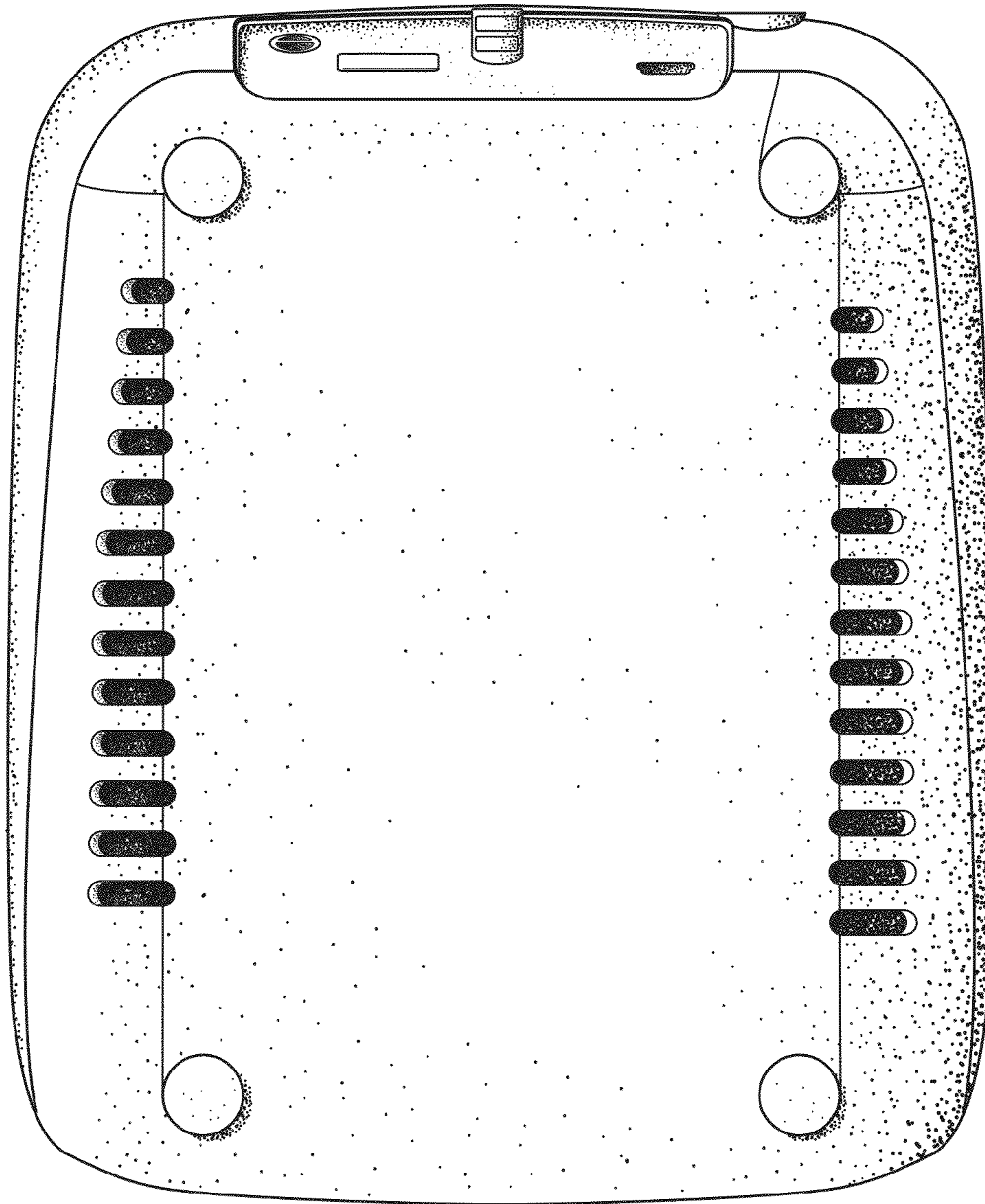

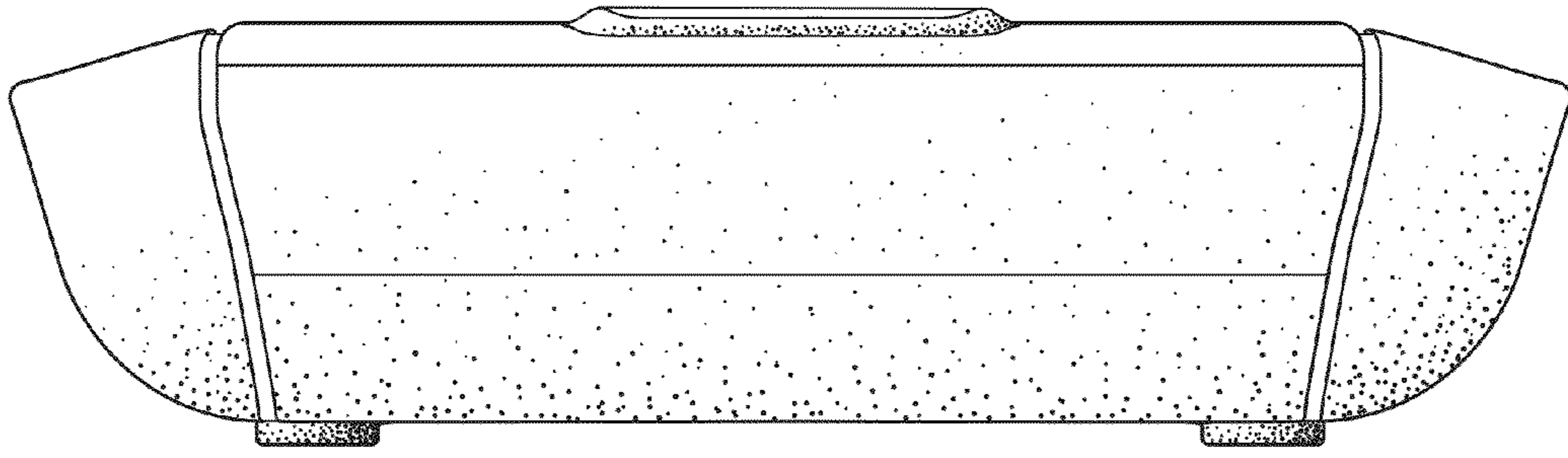

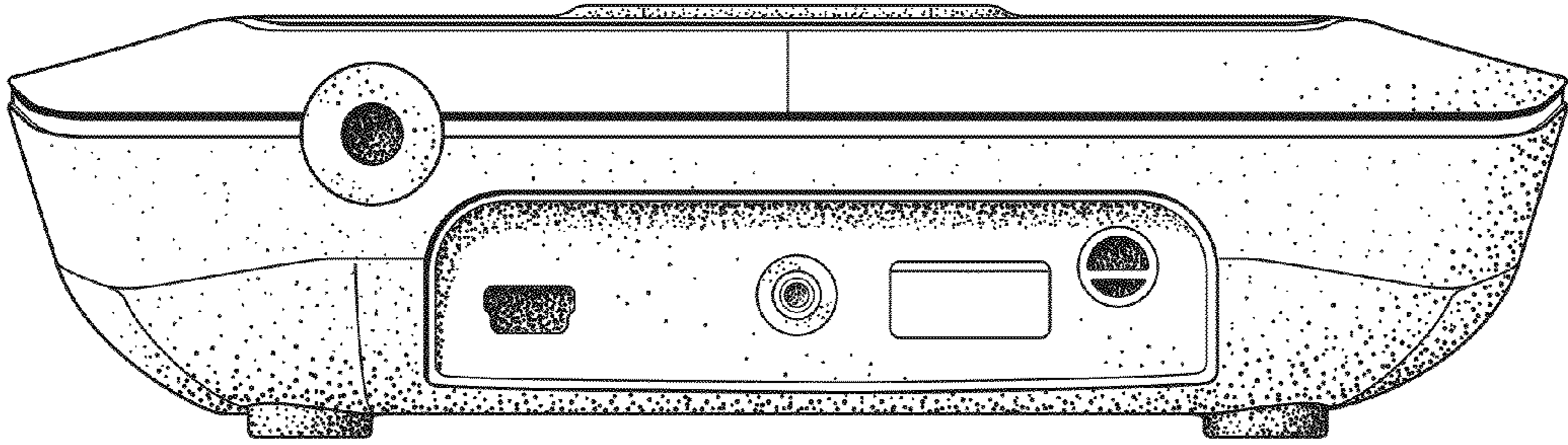

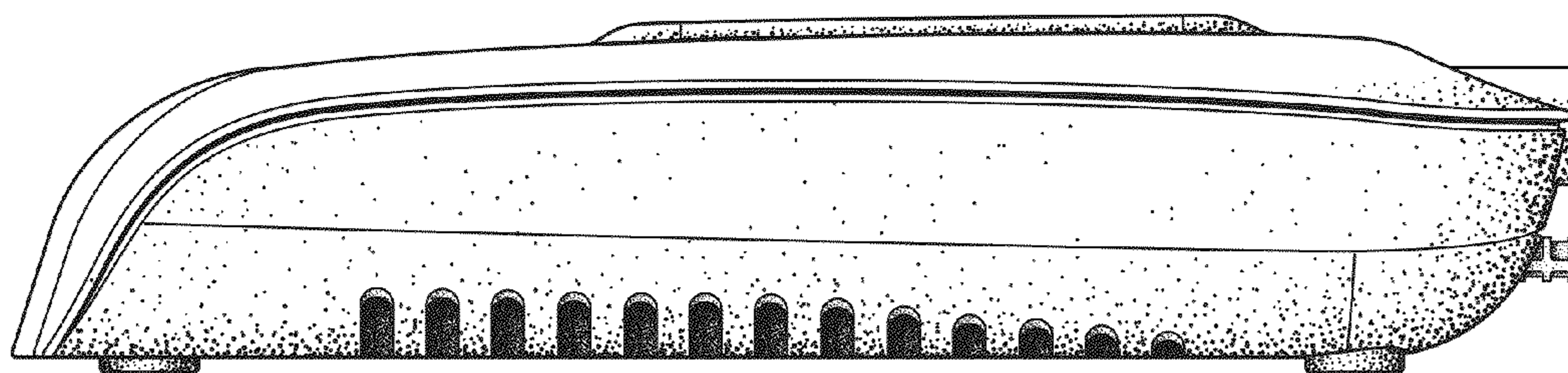

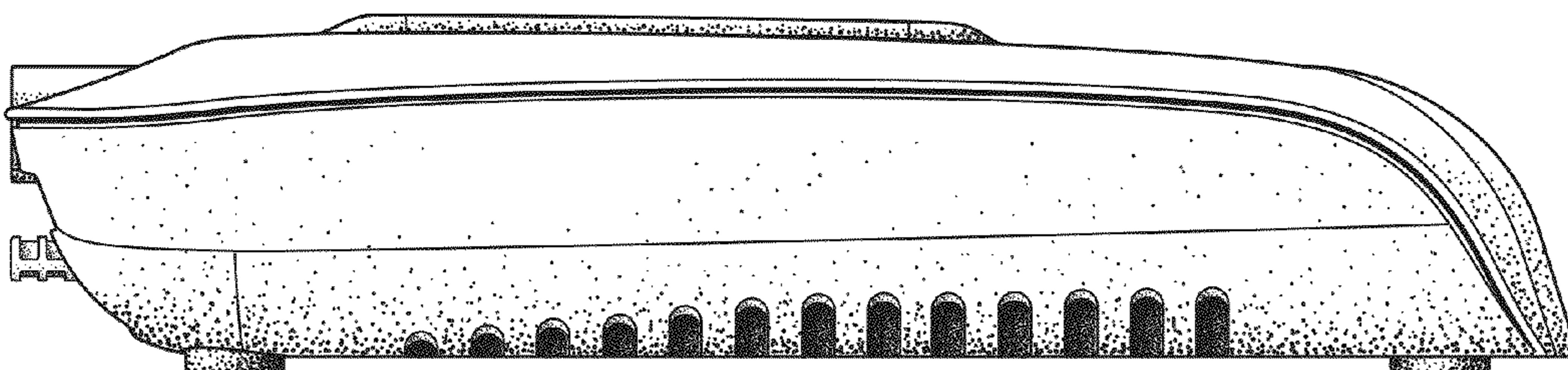
