The ornamental design for a furnishing, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a furnishing;

FIG. 2 is a front view thereof, the rear being identical;

FIG. 3 is a side view thereof, the opposing side being identical; and

FIG. 4 is a top view thereof.

FIG. 5 is a perspective view of a second embodiment of a furnishing;

FIG. 6 is a front view thereof, the rear view being identical;

FIG. 7 is a side view thereof, the opposing side being identical; and,

FIG. 8 is a top view thereof.

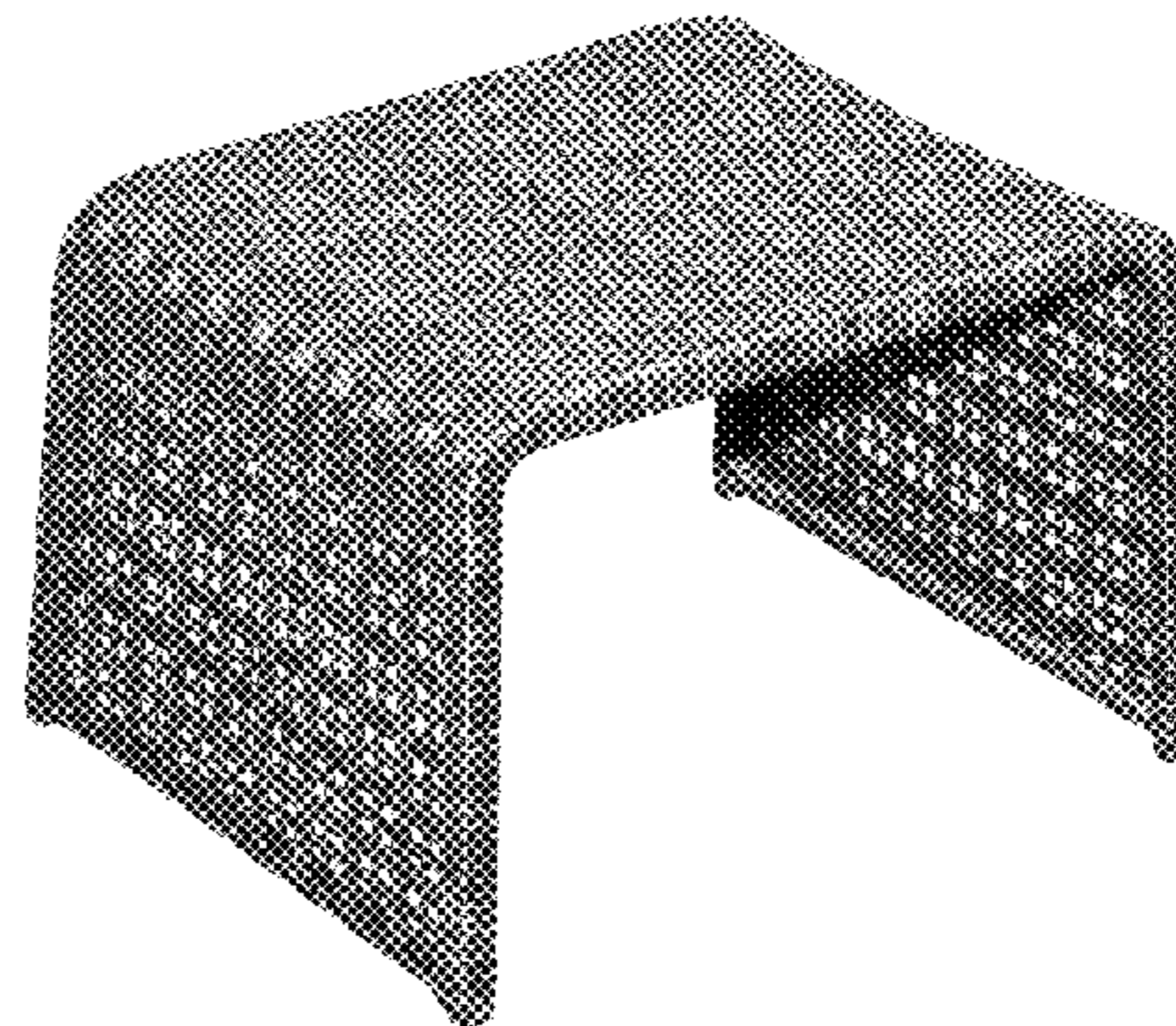
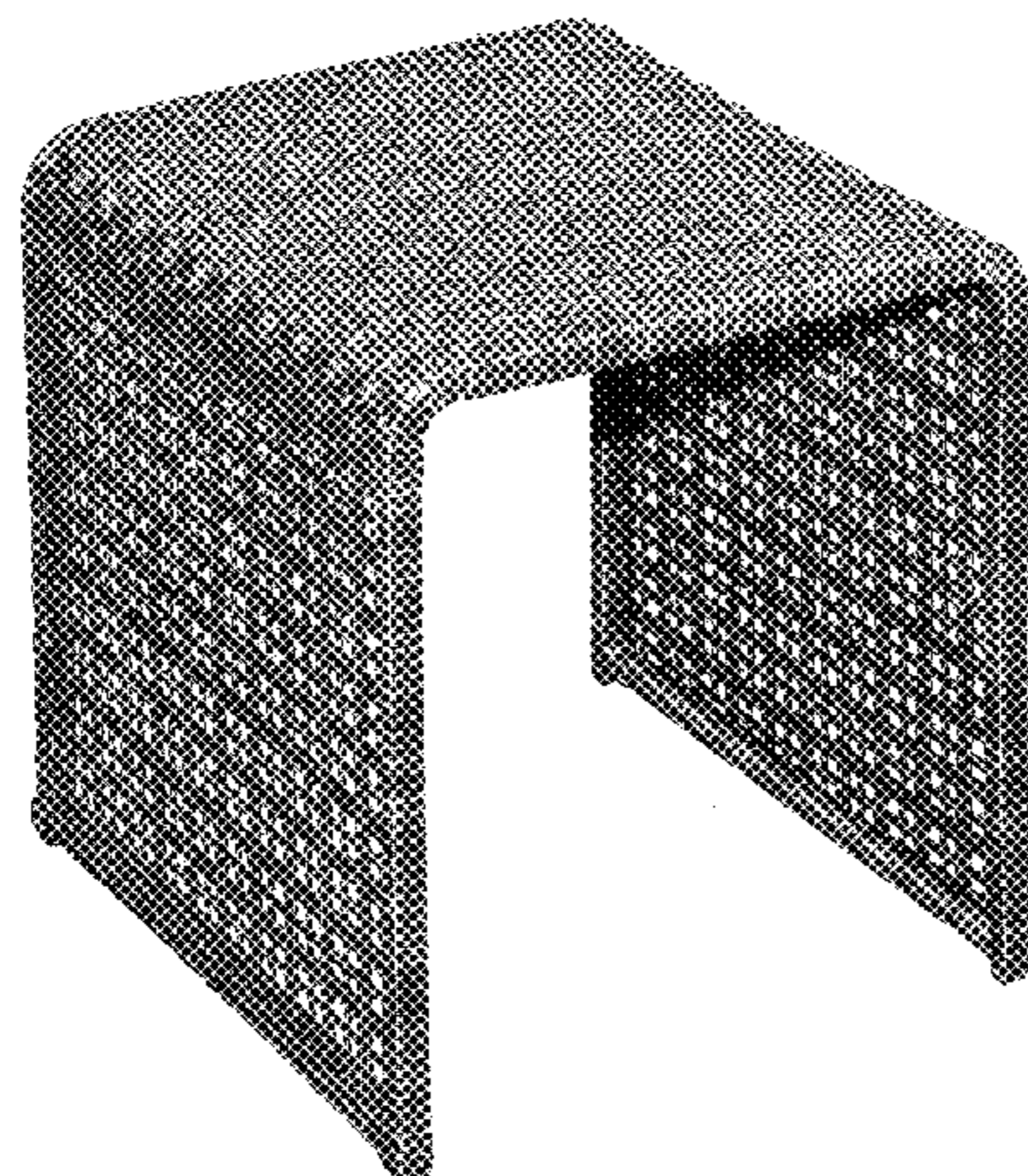

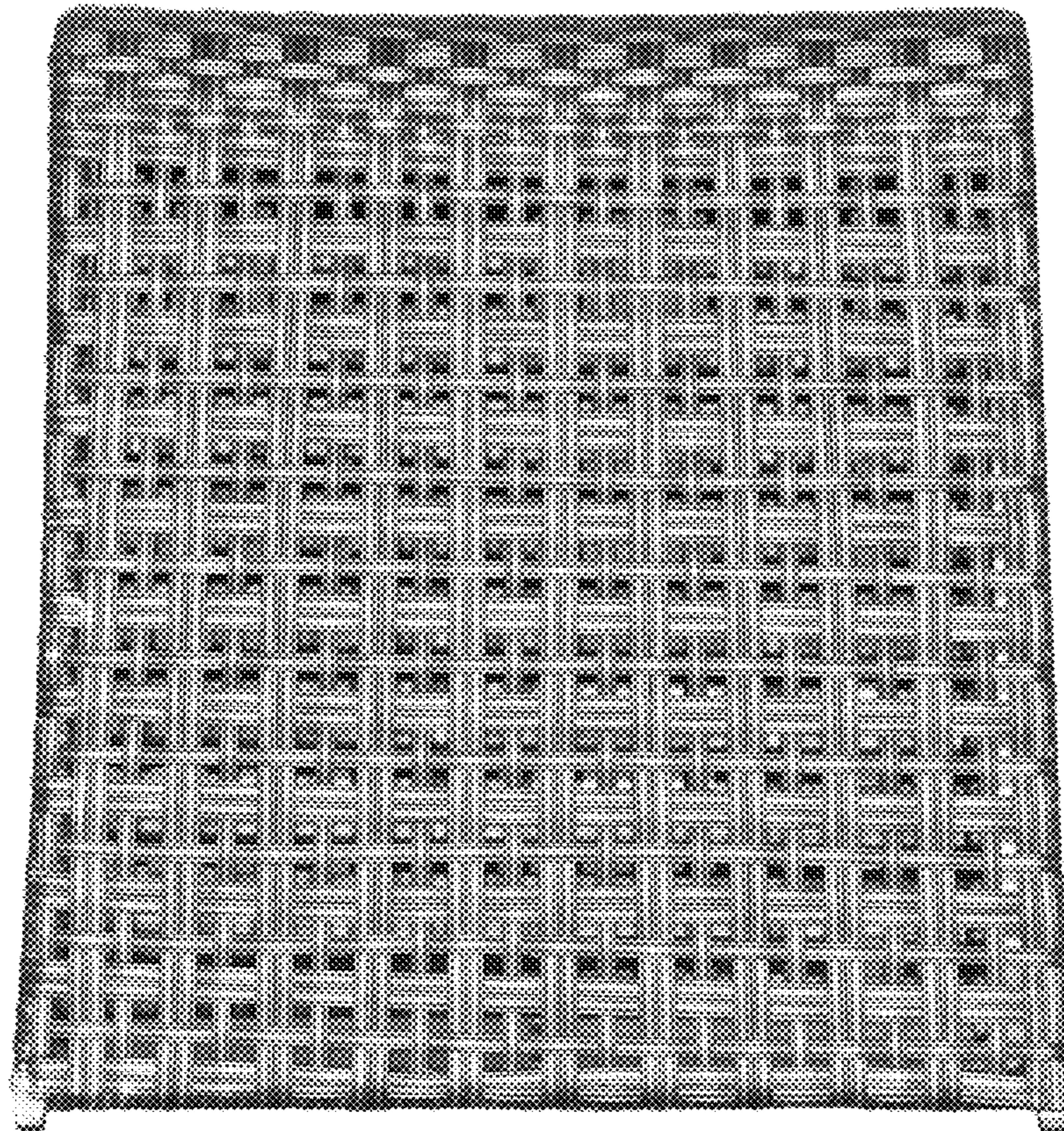

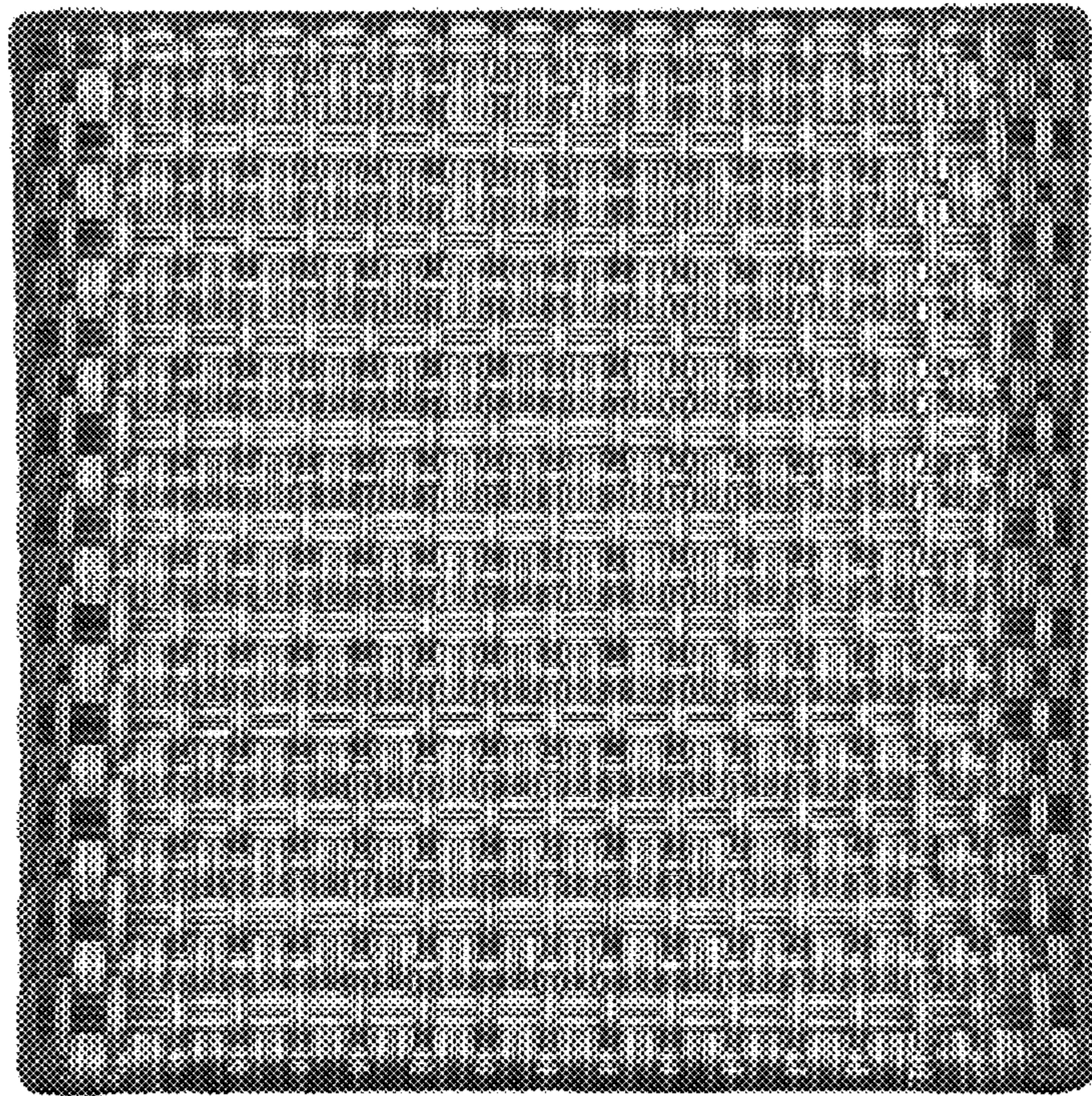

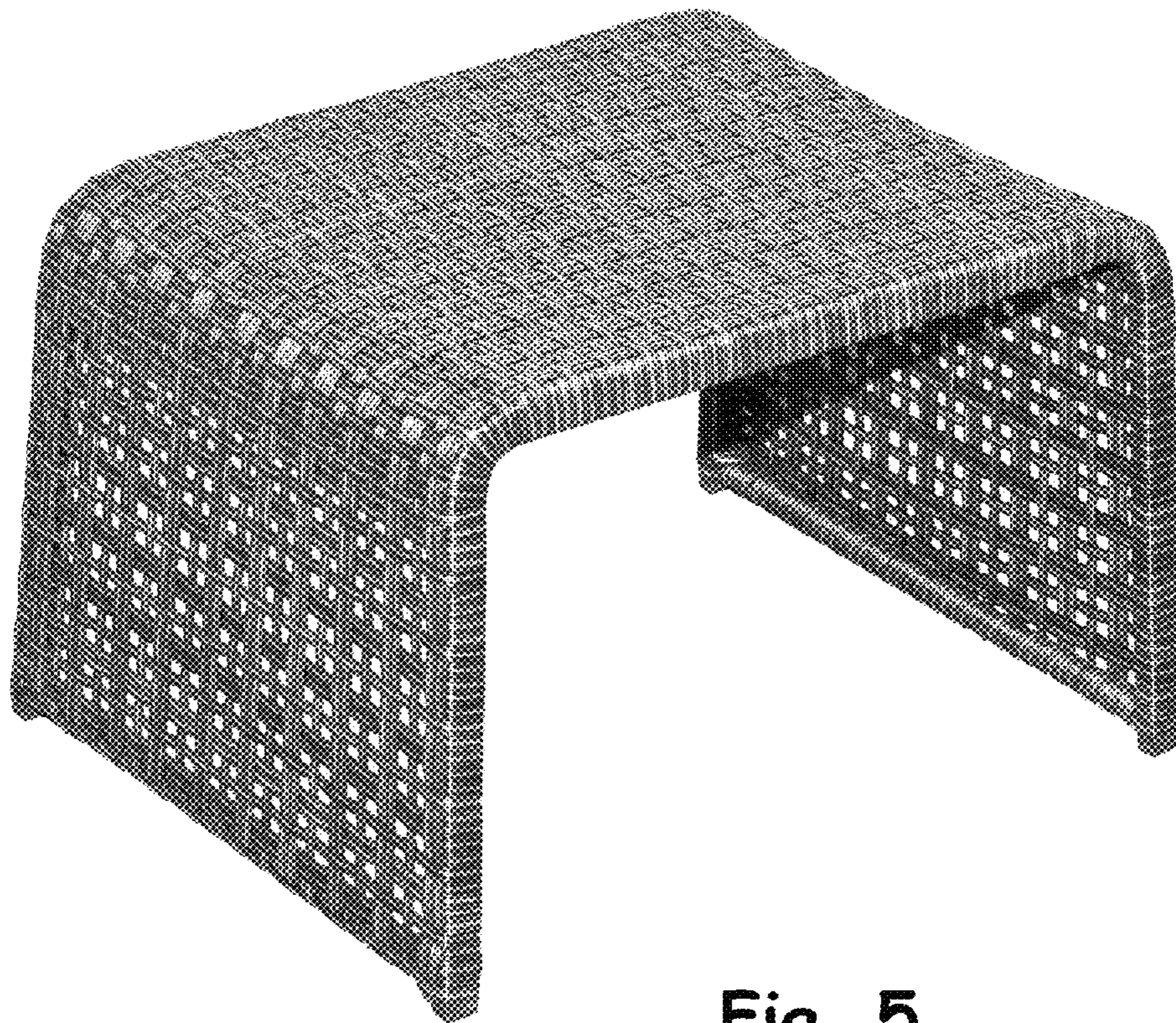

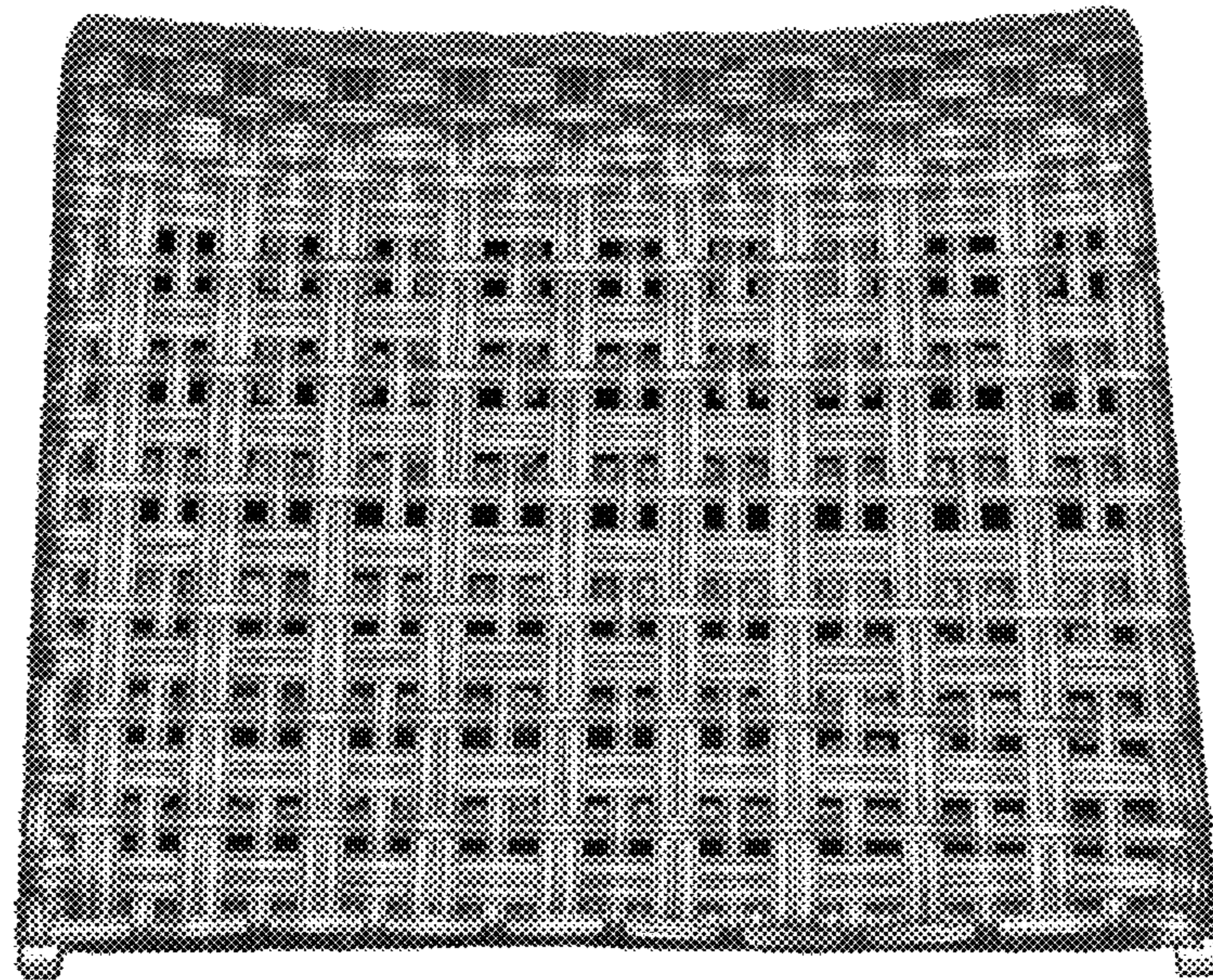

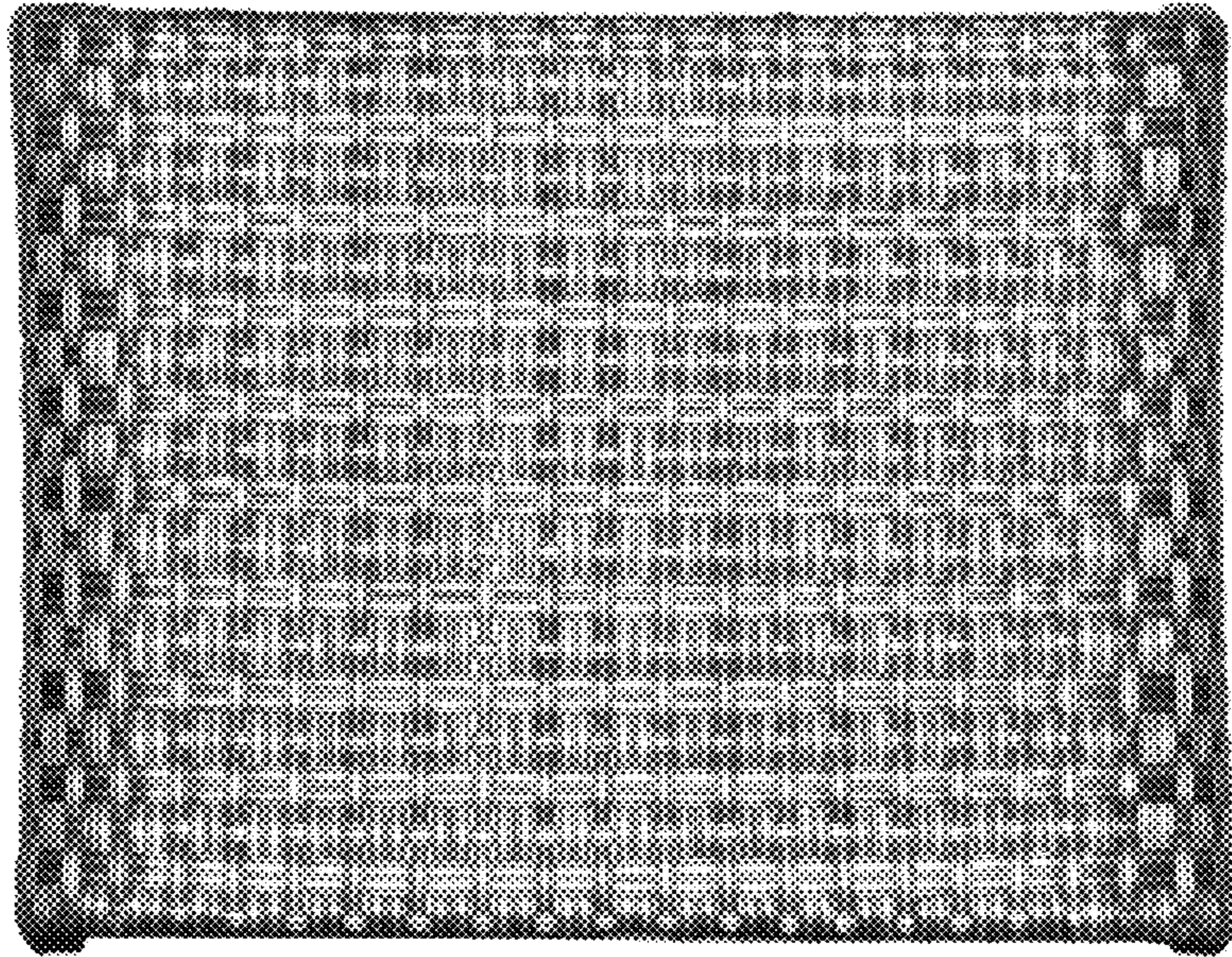
