(57) **CLAIM**

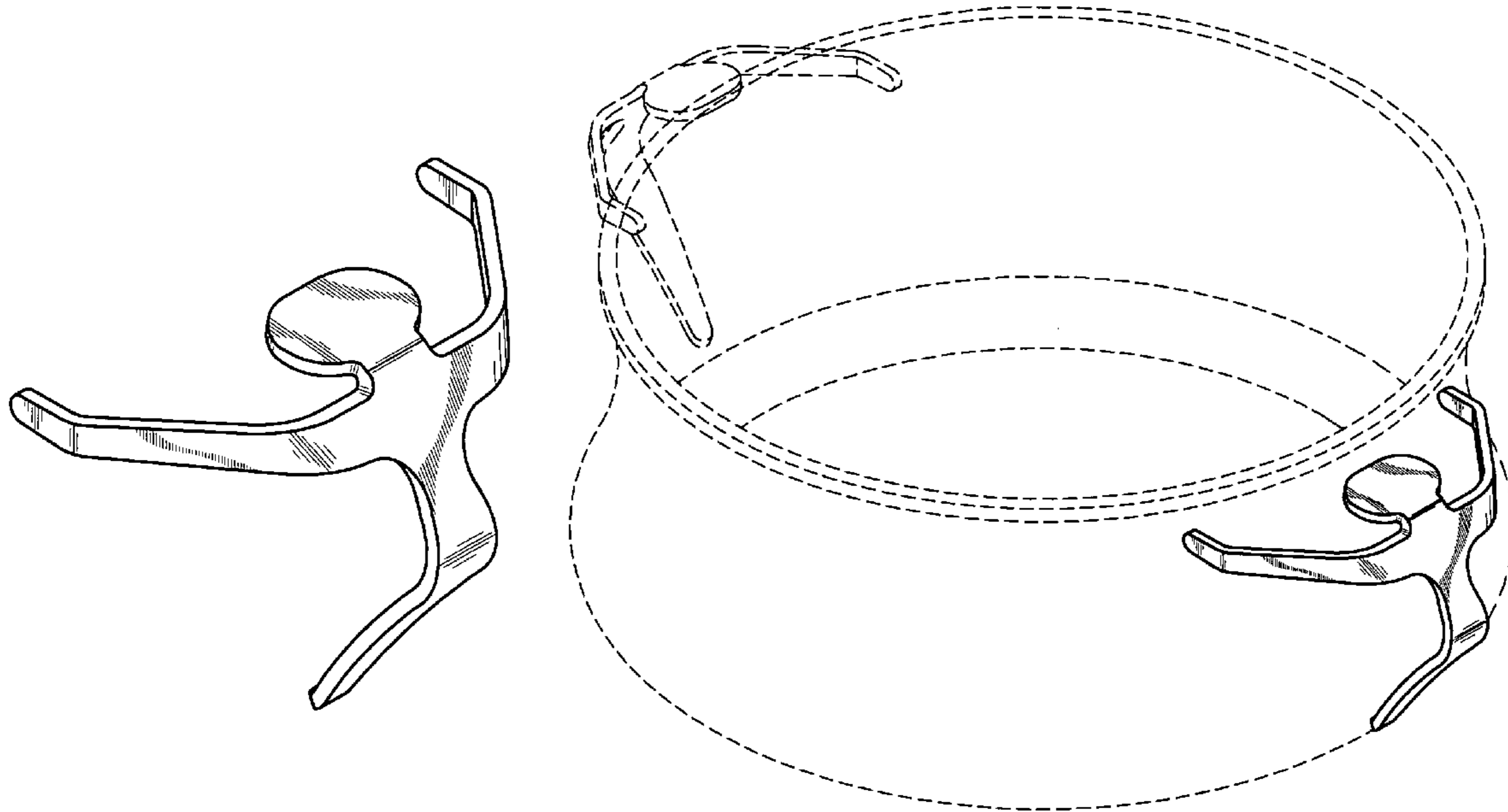
The ornamental design for a cookware handle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a cookware handle showing my design;

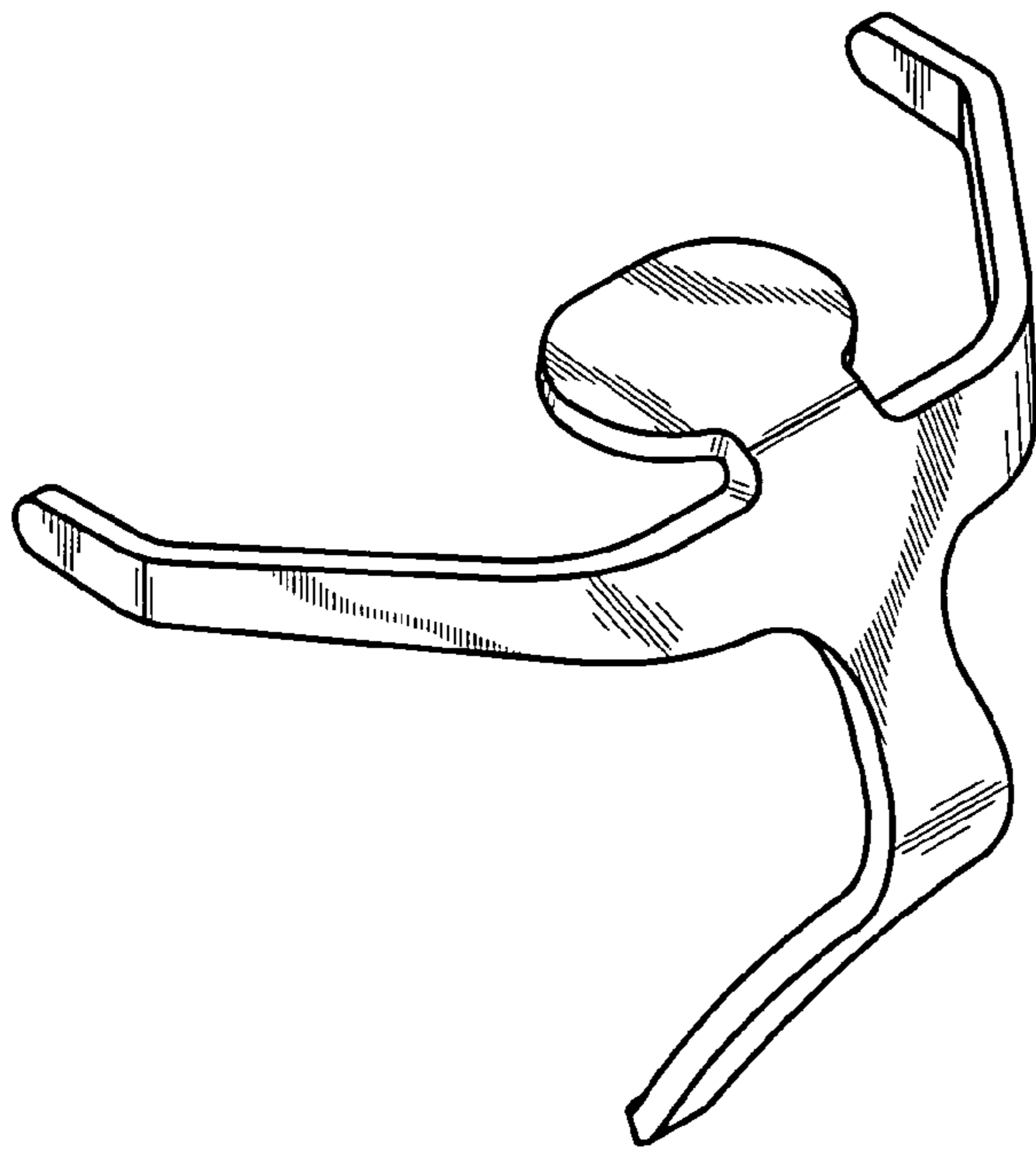

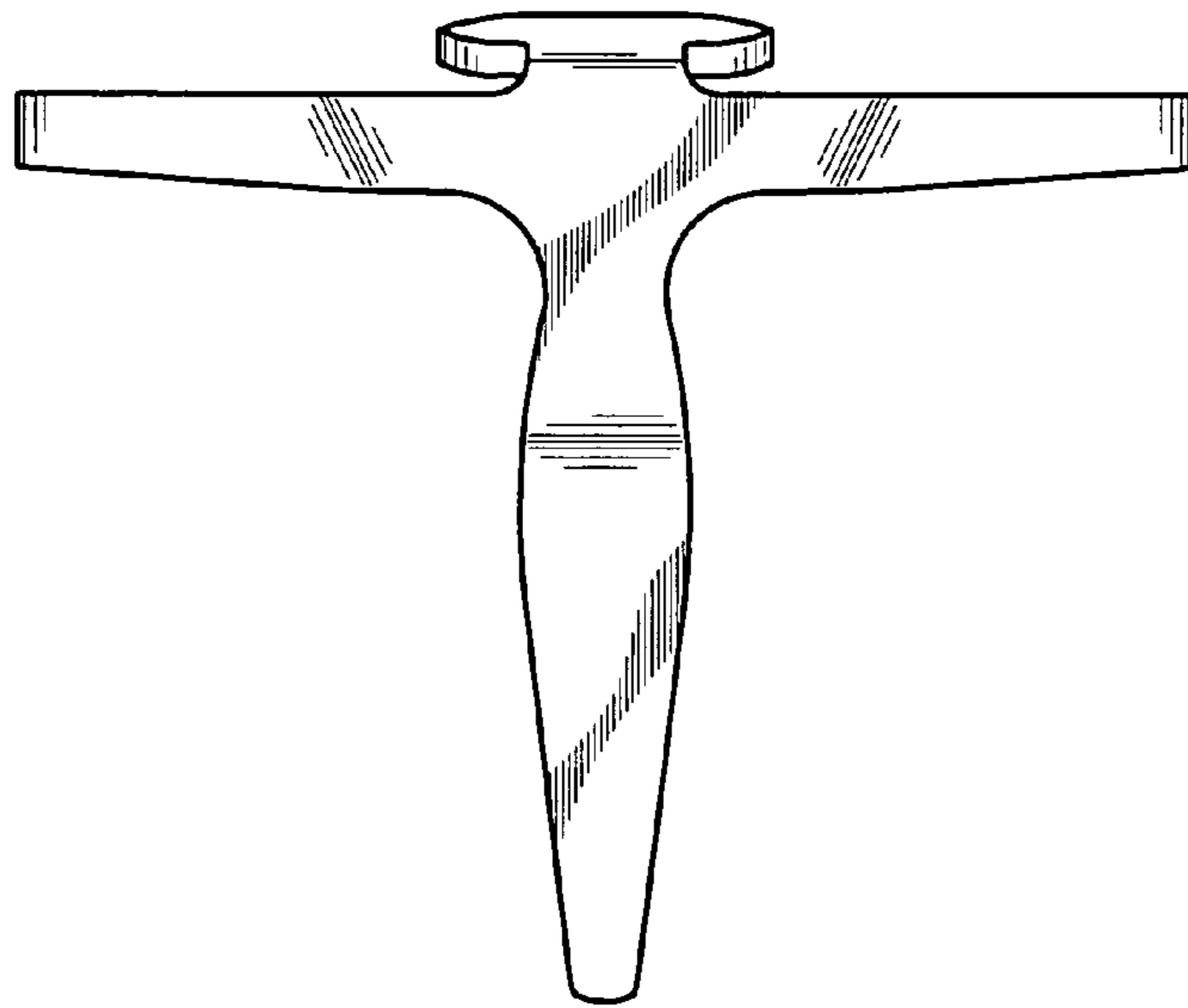

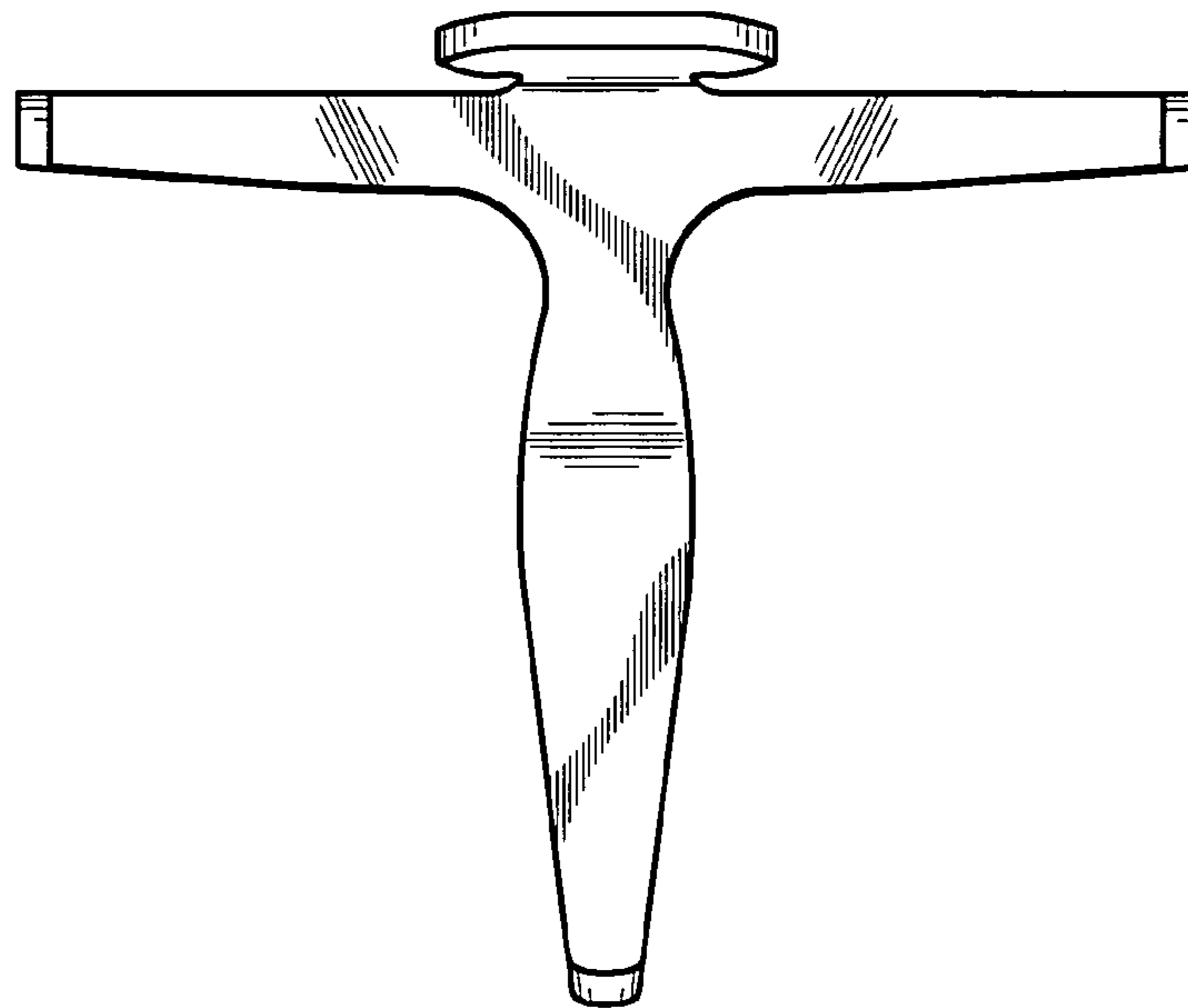

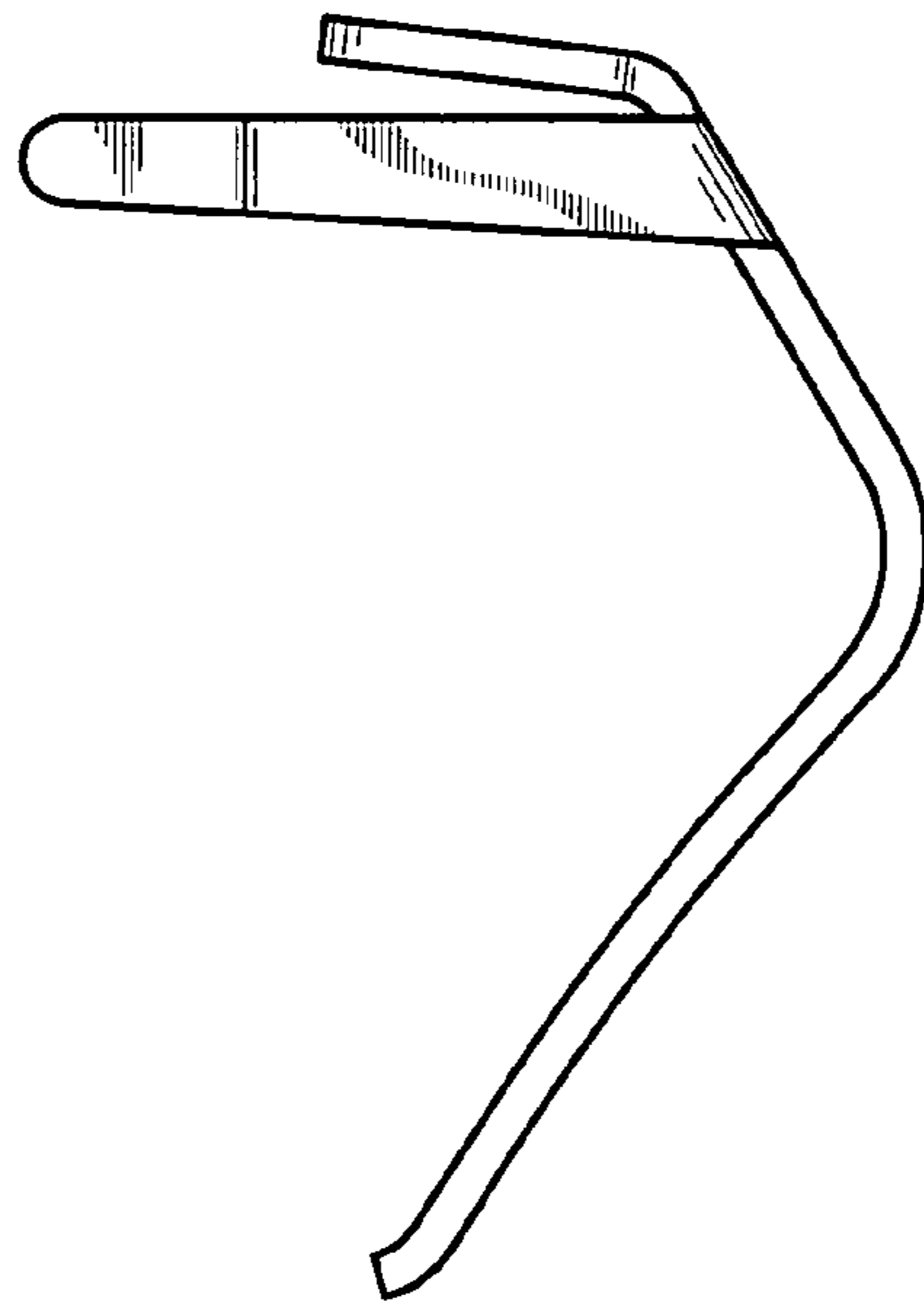

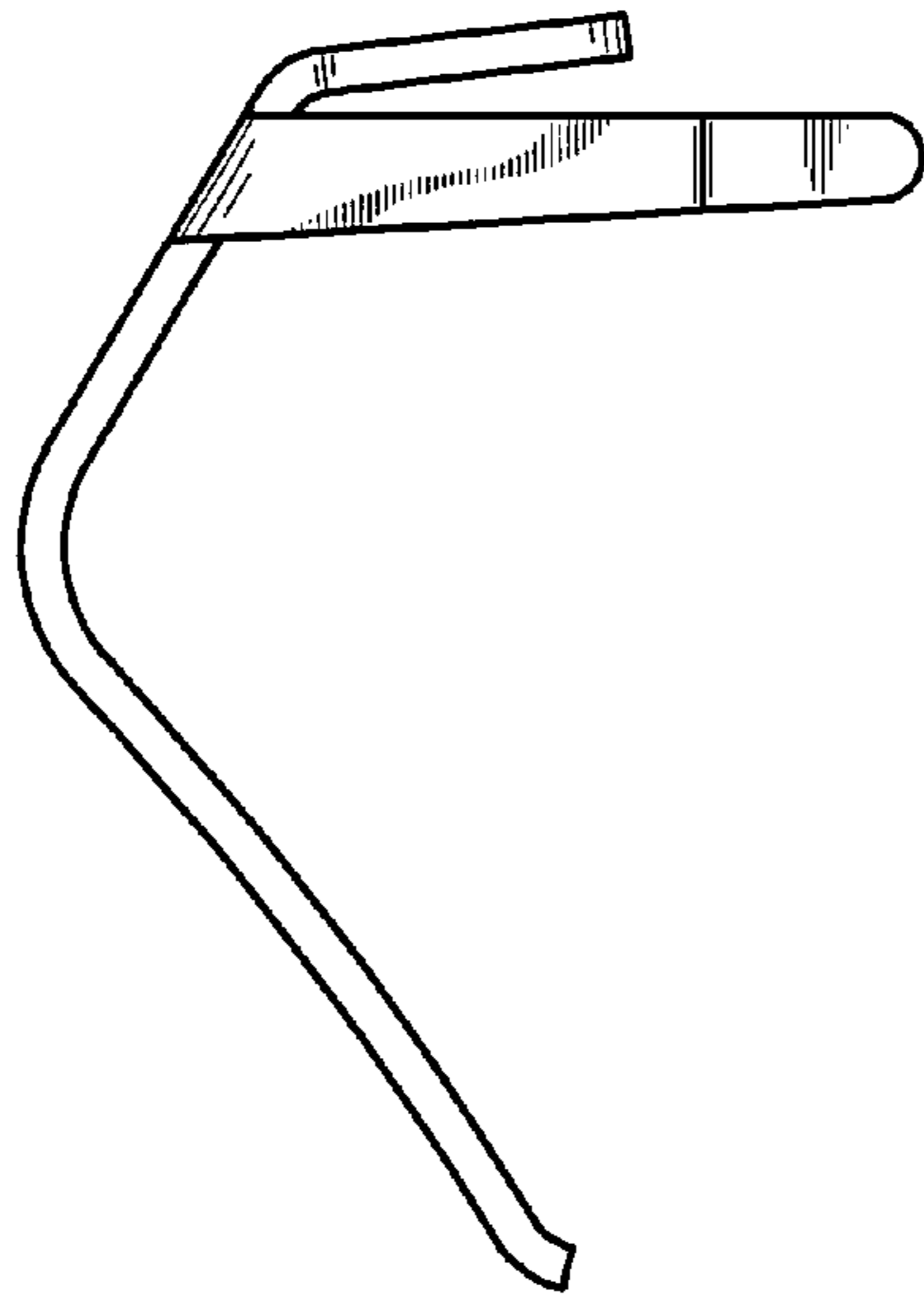

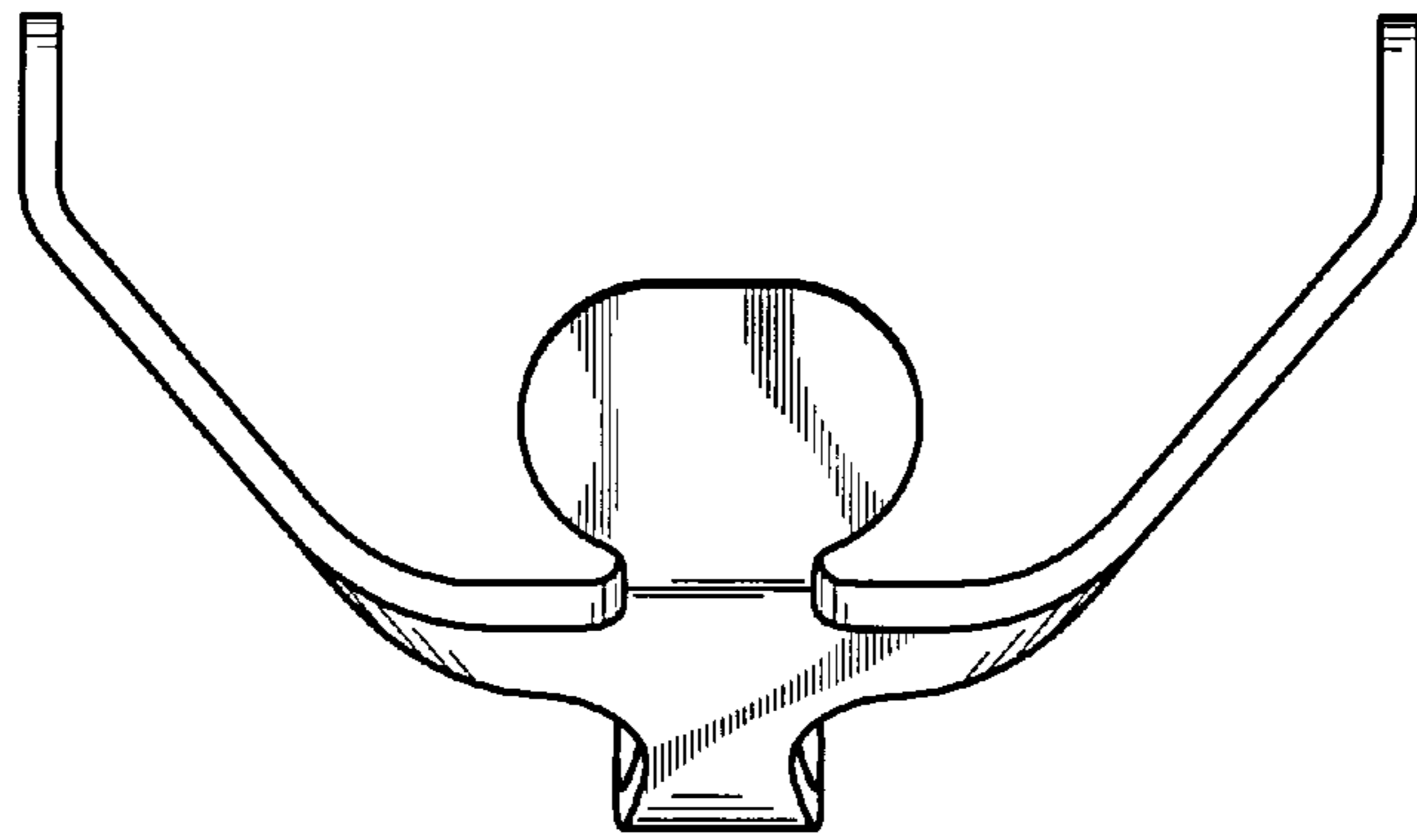

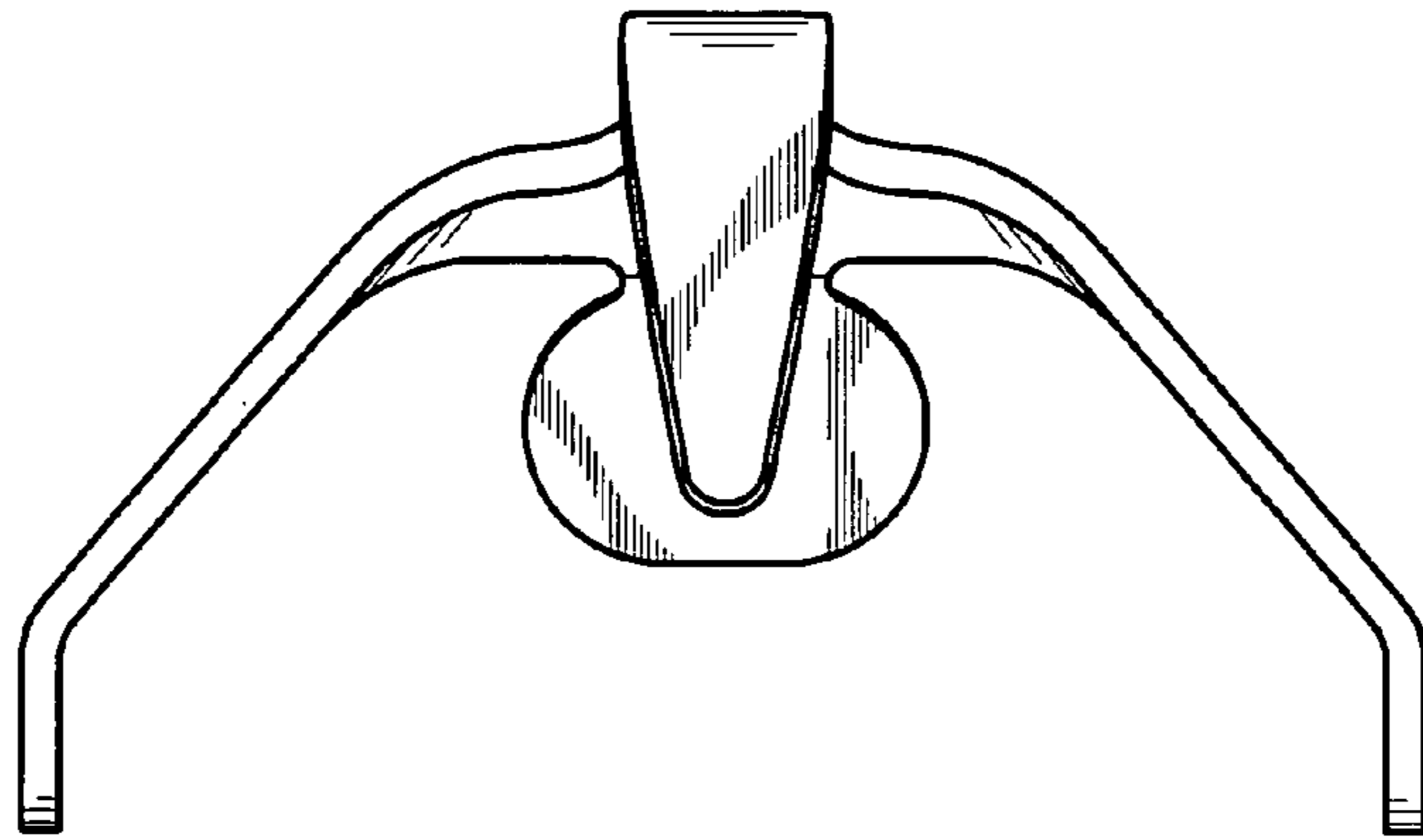

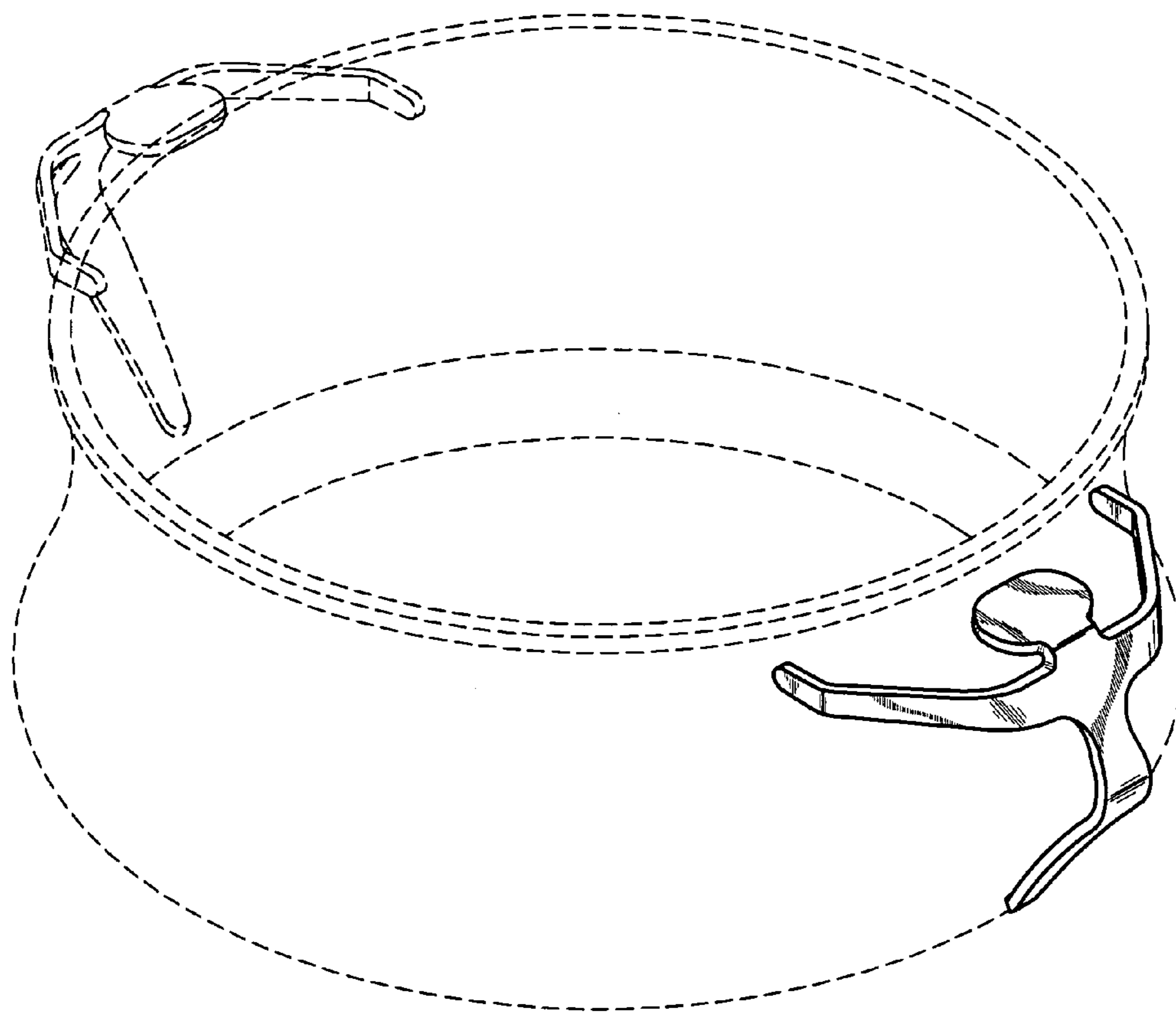
