(57) **CLAIM**

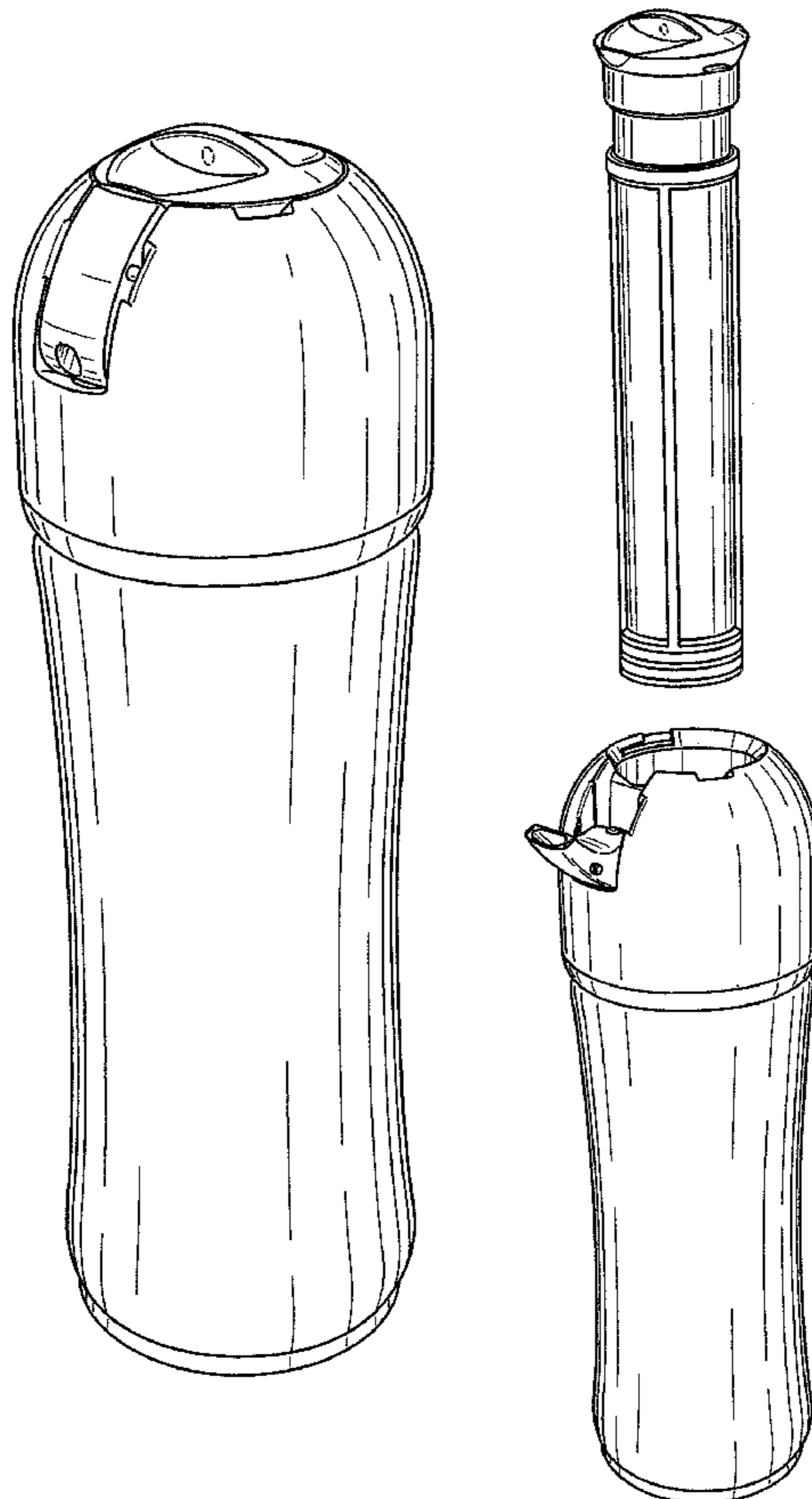
The ornamental design for a water bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view of a water bottle; FIG. 2 is a front view of the water bottle of FIG. 1; FIG. 3 is a rear view of the water bottle of FIG. 1; FIG. 4 is a left view of the water bottle of FIG. 1; FIG. 5 is a right view of the water bottle of FIG. 1; FIG. 6 is a top view of the water bottle of FIG. 1; FIG. 7 is a bottom view of the water bottle of FIG. 1; and, FIG. 8 is a front right perspective view of the water bottle of FIG. 1, shown at a reduced scale in an open configuration of use.

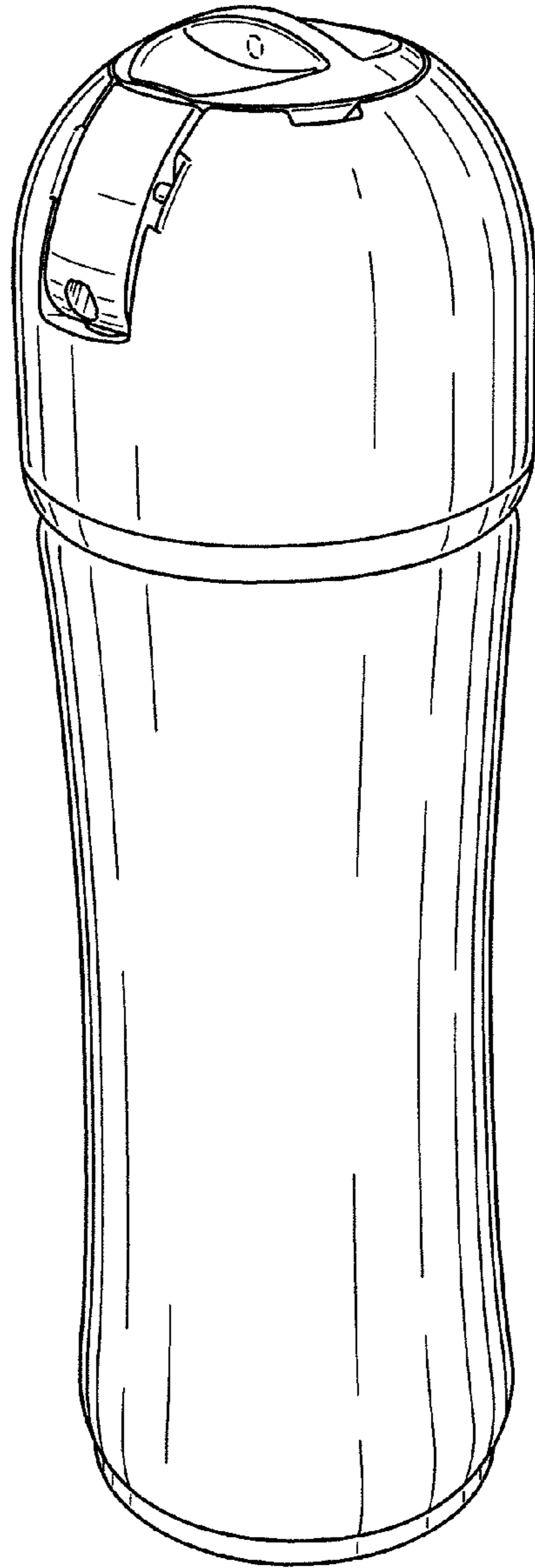

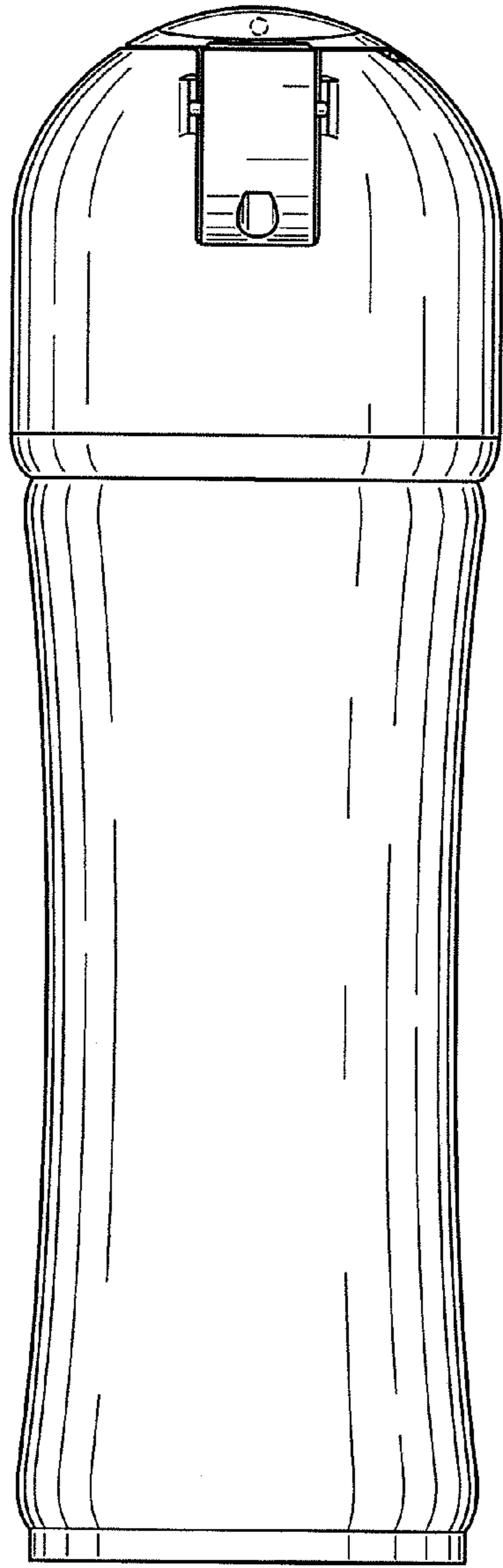

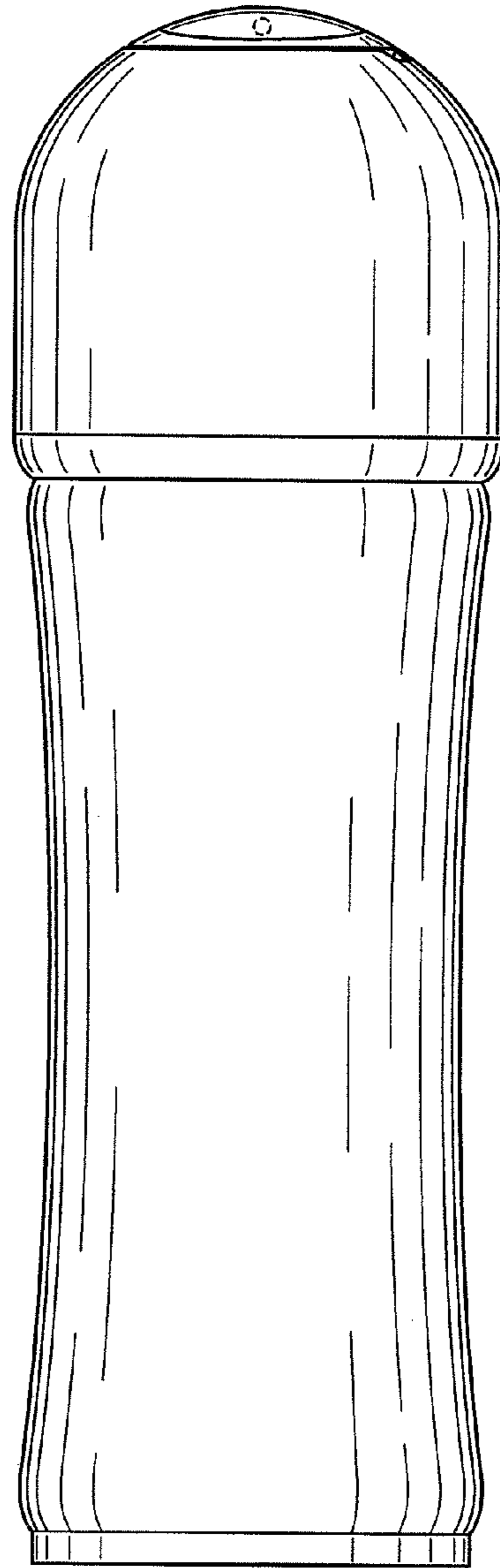

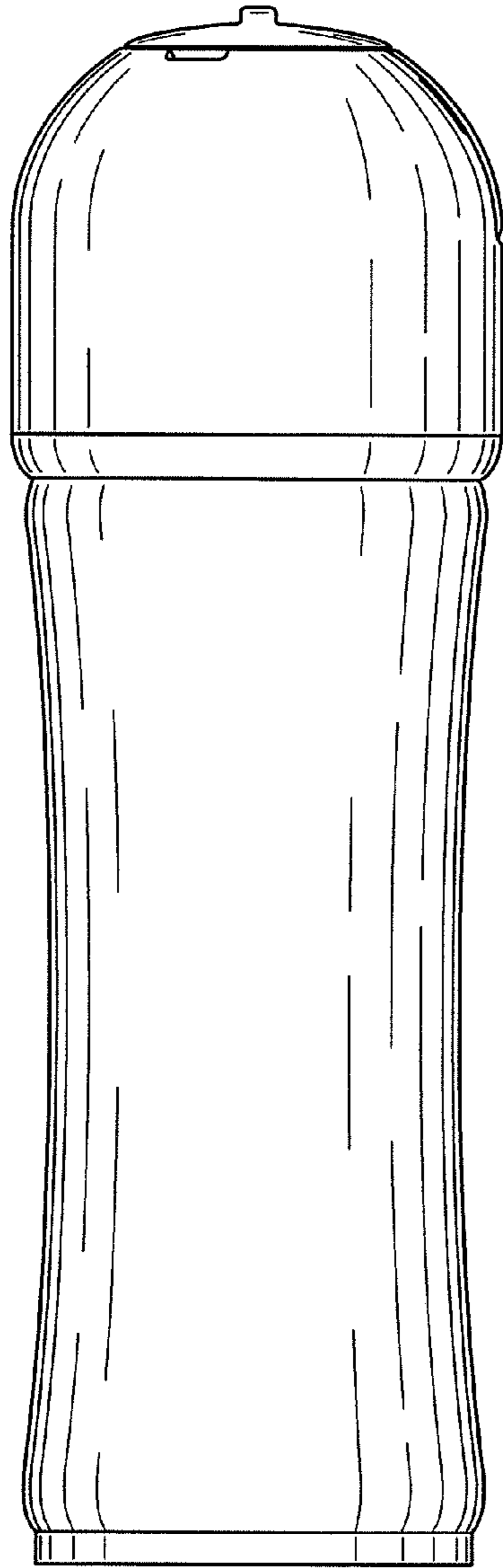

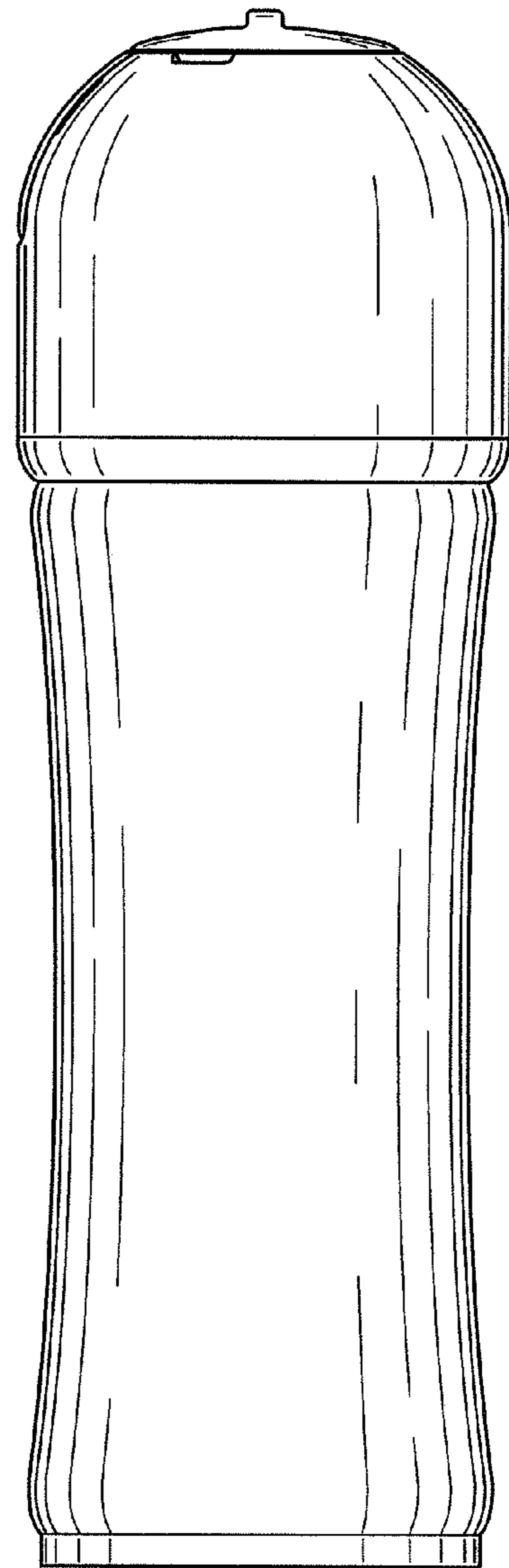

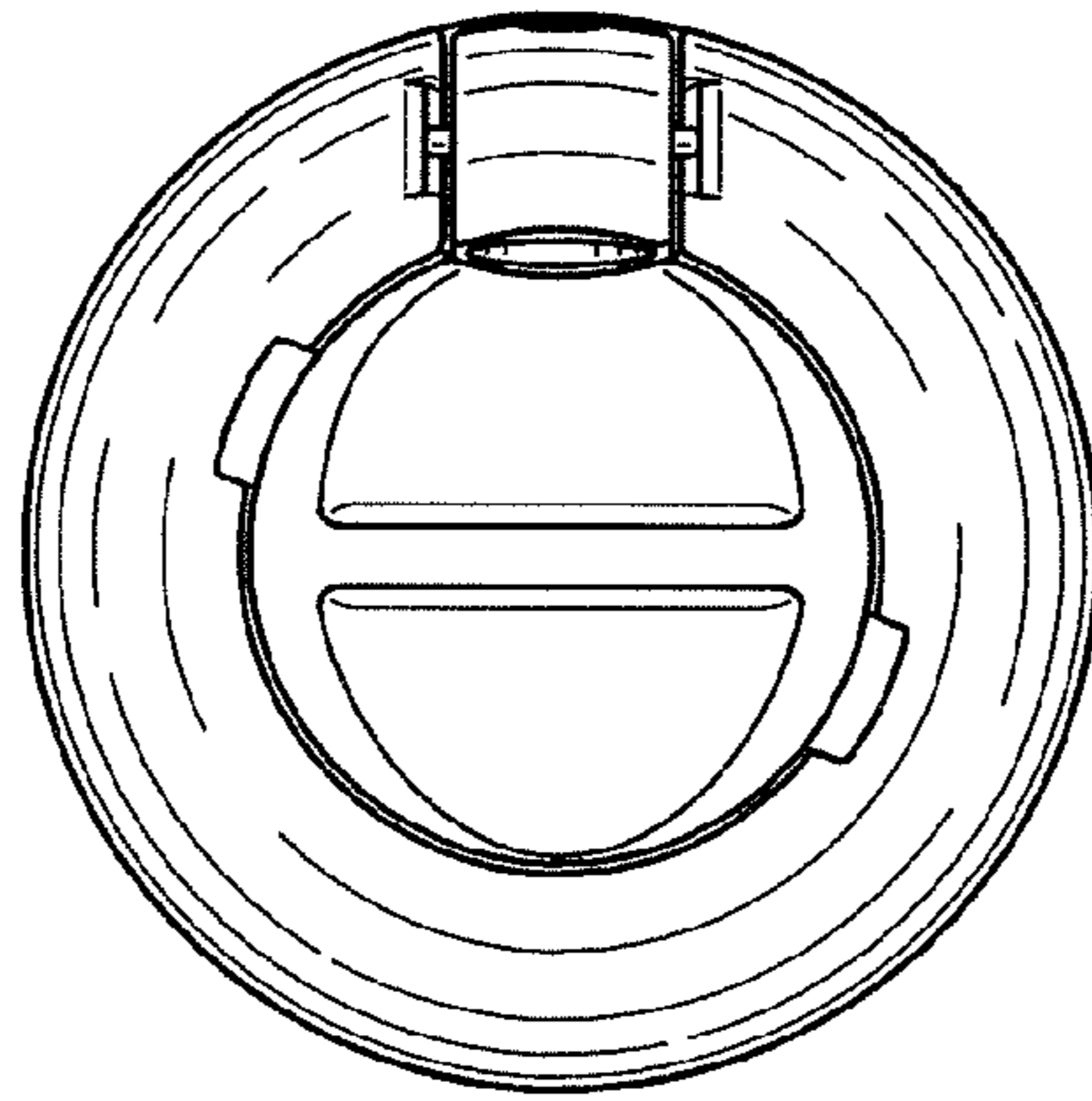

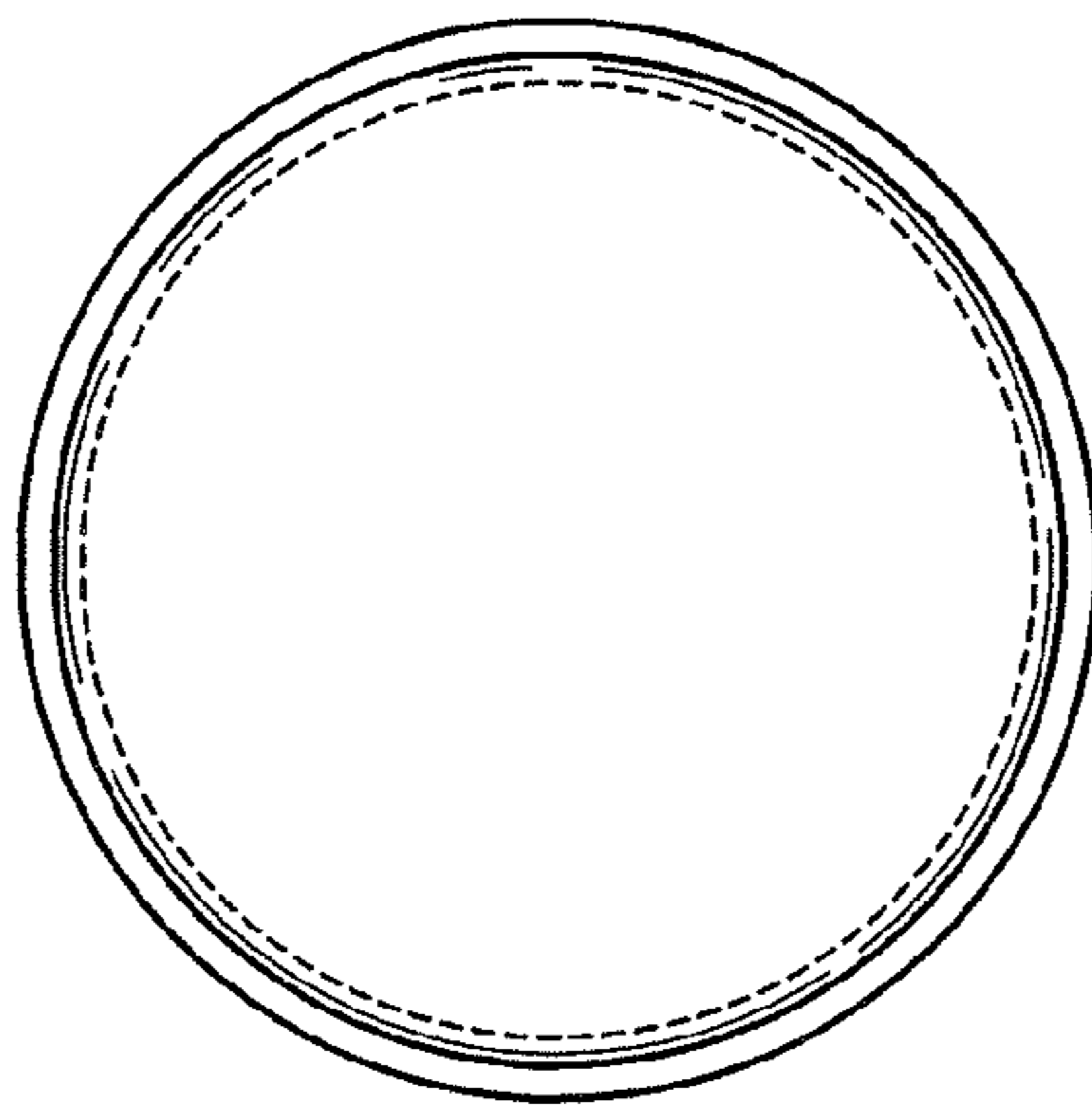

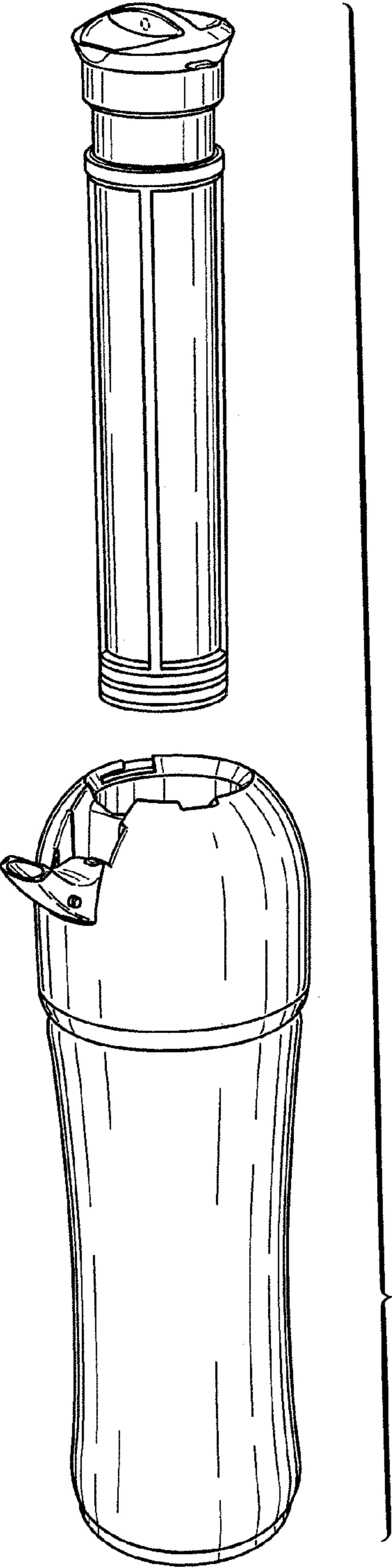
