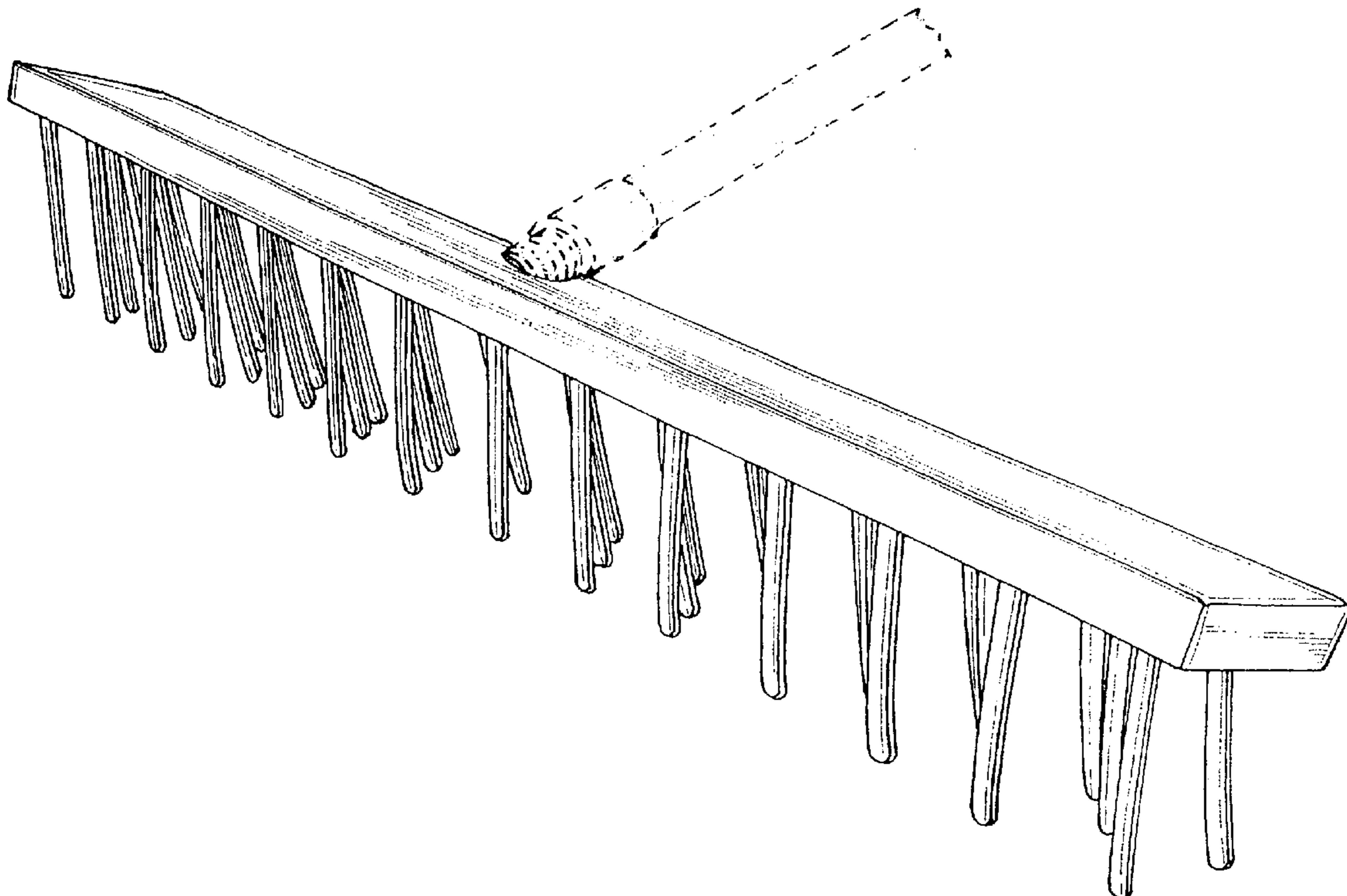
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view illustrating a rake;  
FIG. 2 is a left side view illustrating the rake of FIG. 1;

FIG. 4 is a front view illustrating the rake of FIG. 1;

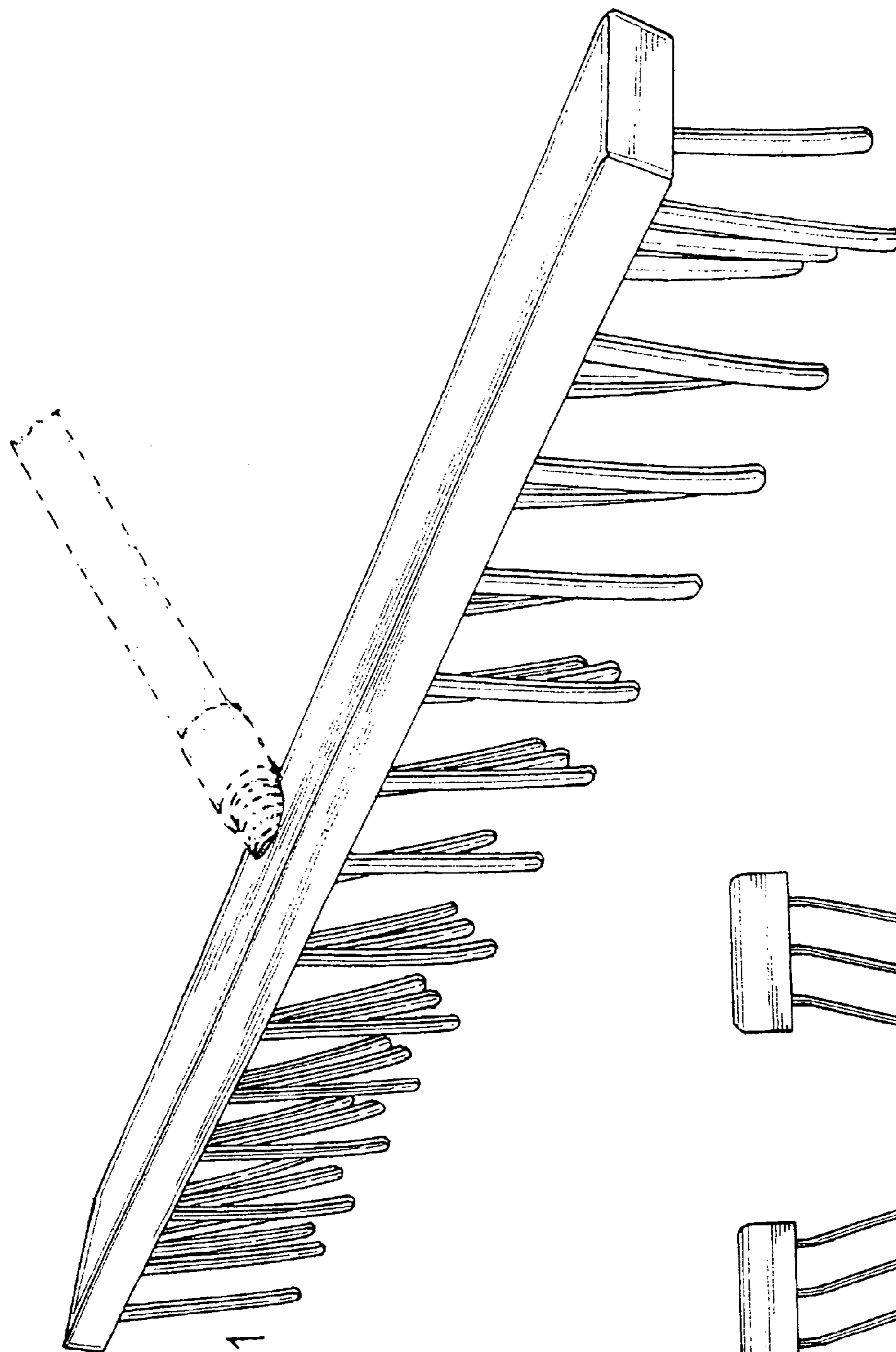

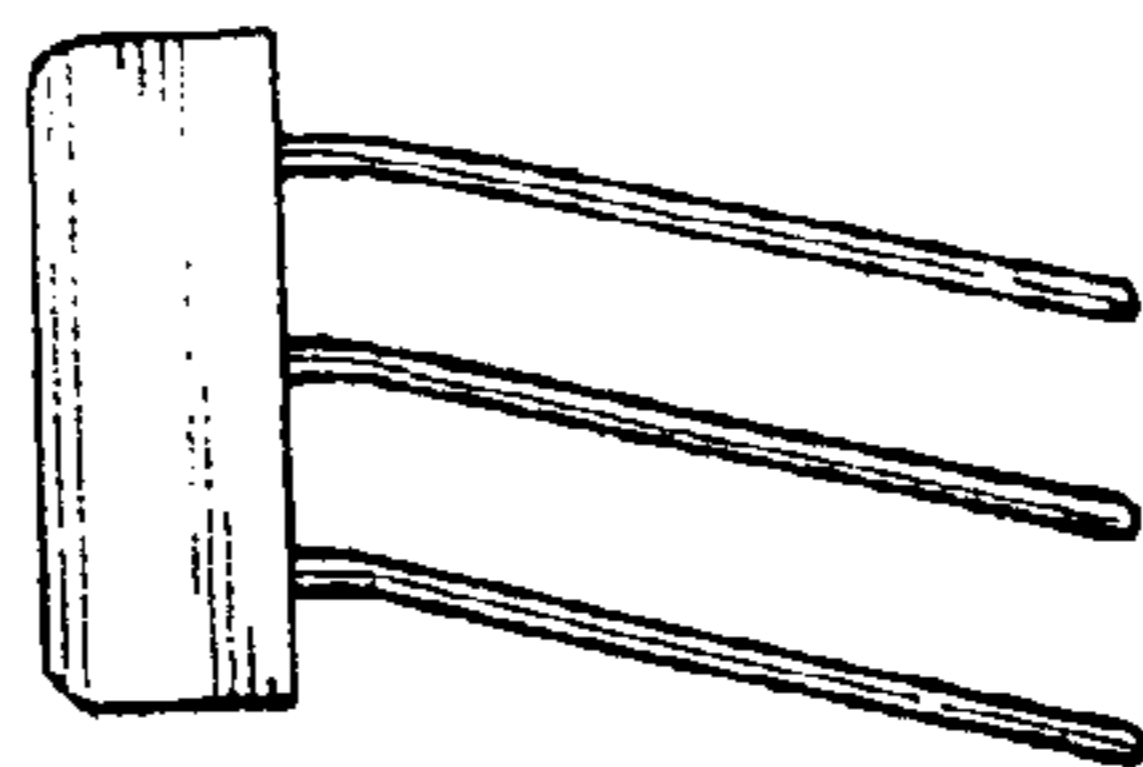

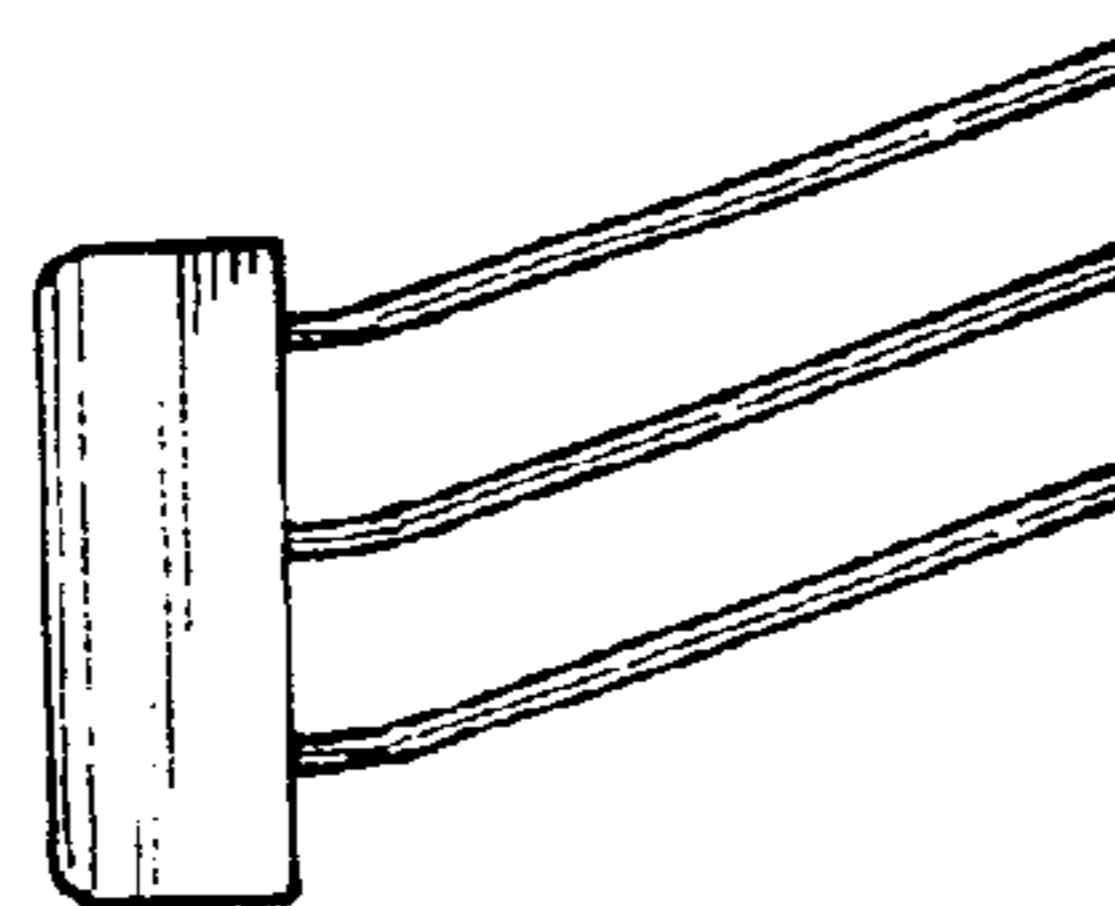

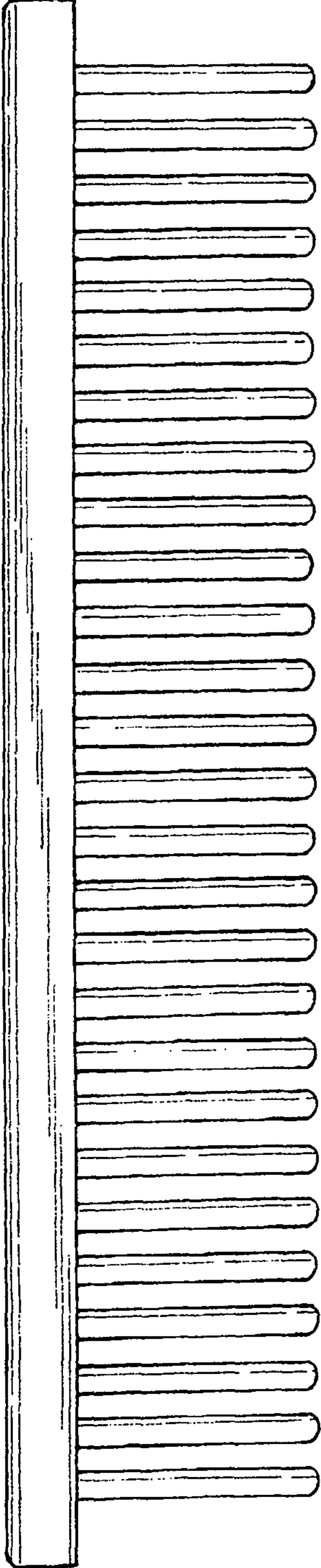

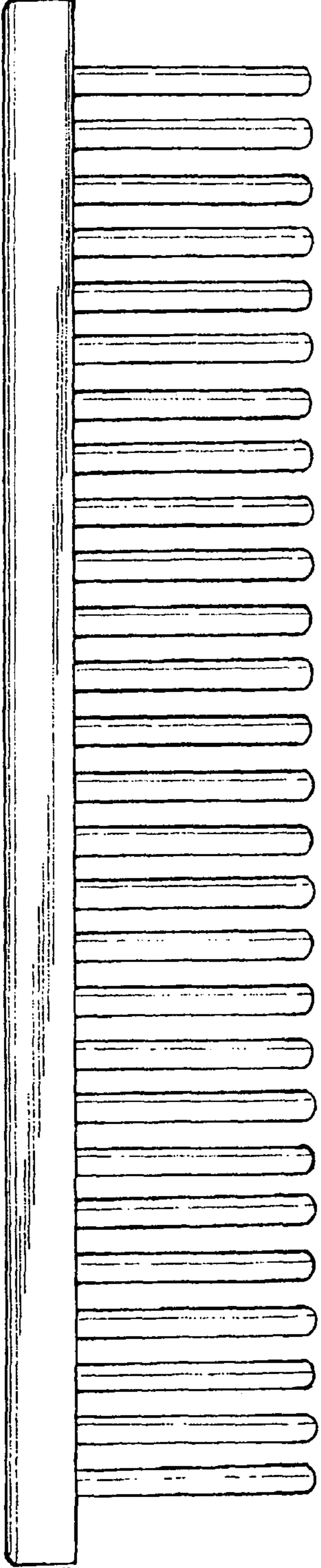

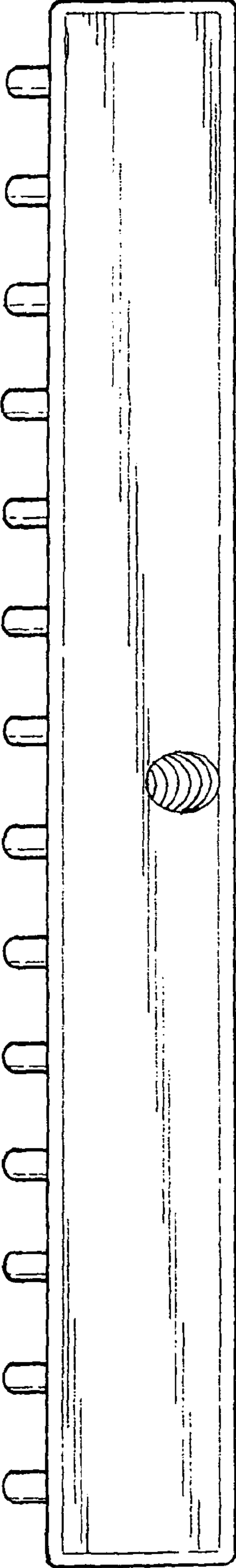

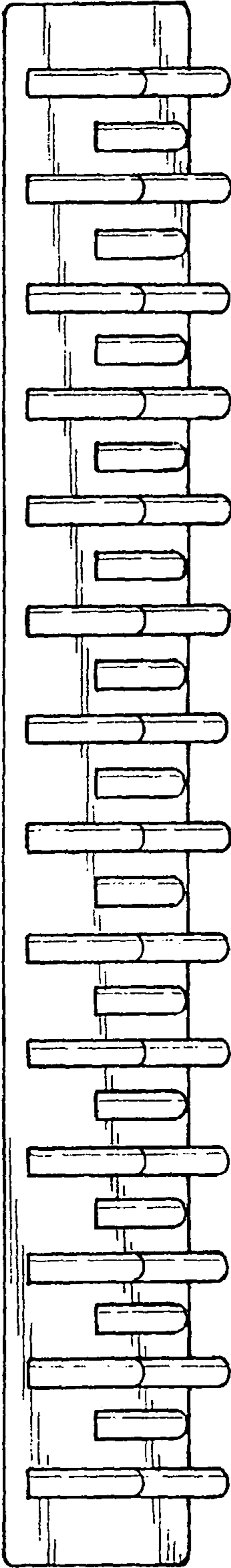
