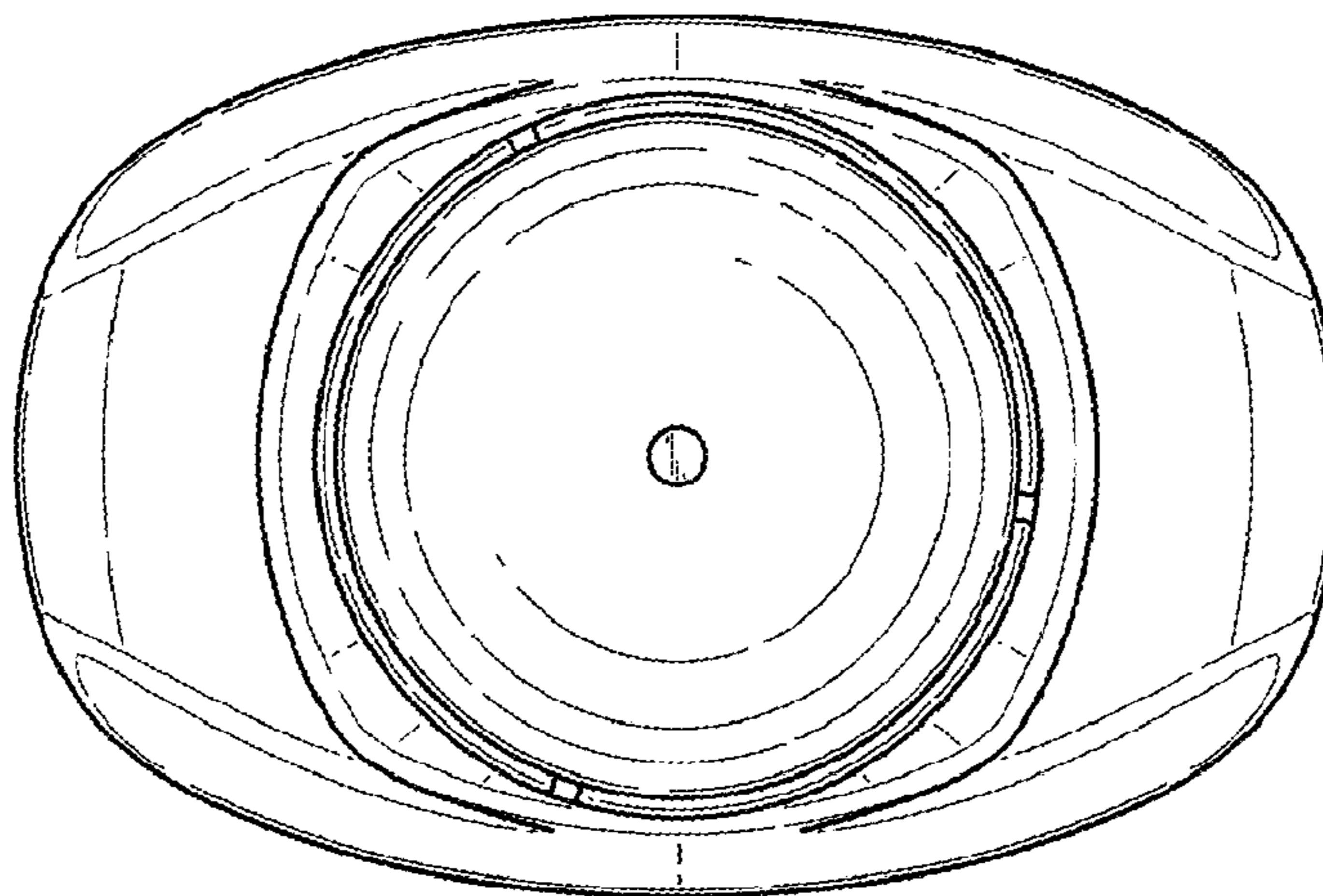
(57) **CLAIM**

The ornamental design for a bottle with cap, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and left side perspective view of a bottle with cap embodying the new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a back elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof; and,
FIG. 6 is a top plan view thereof.

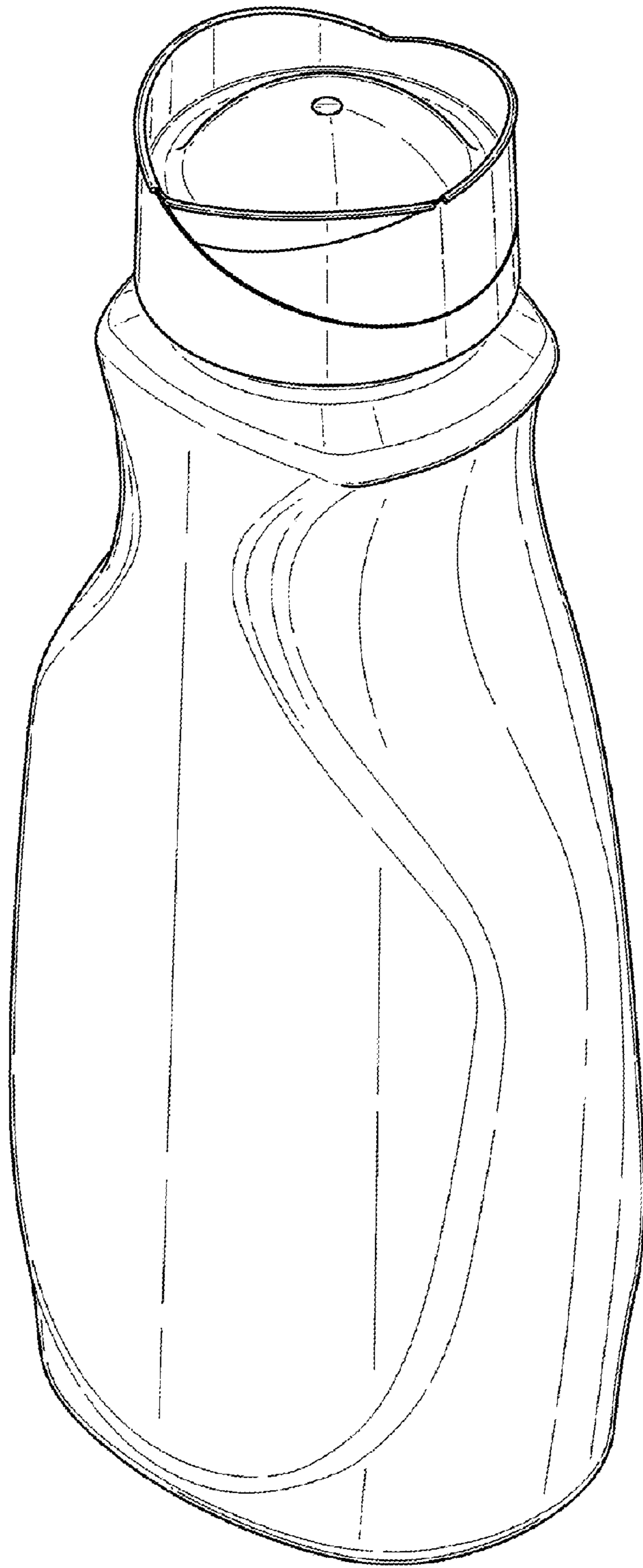

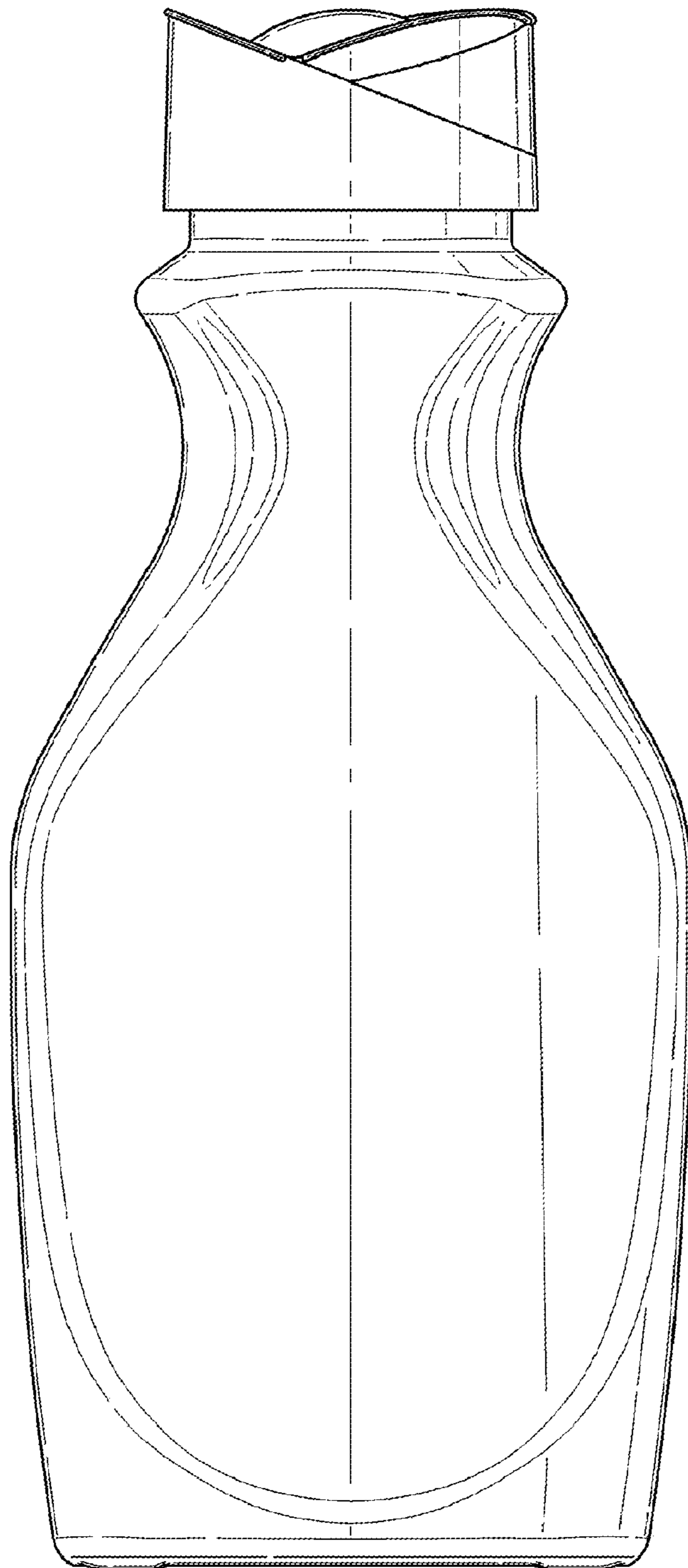

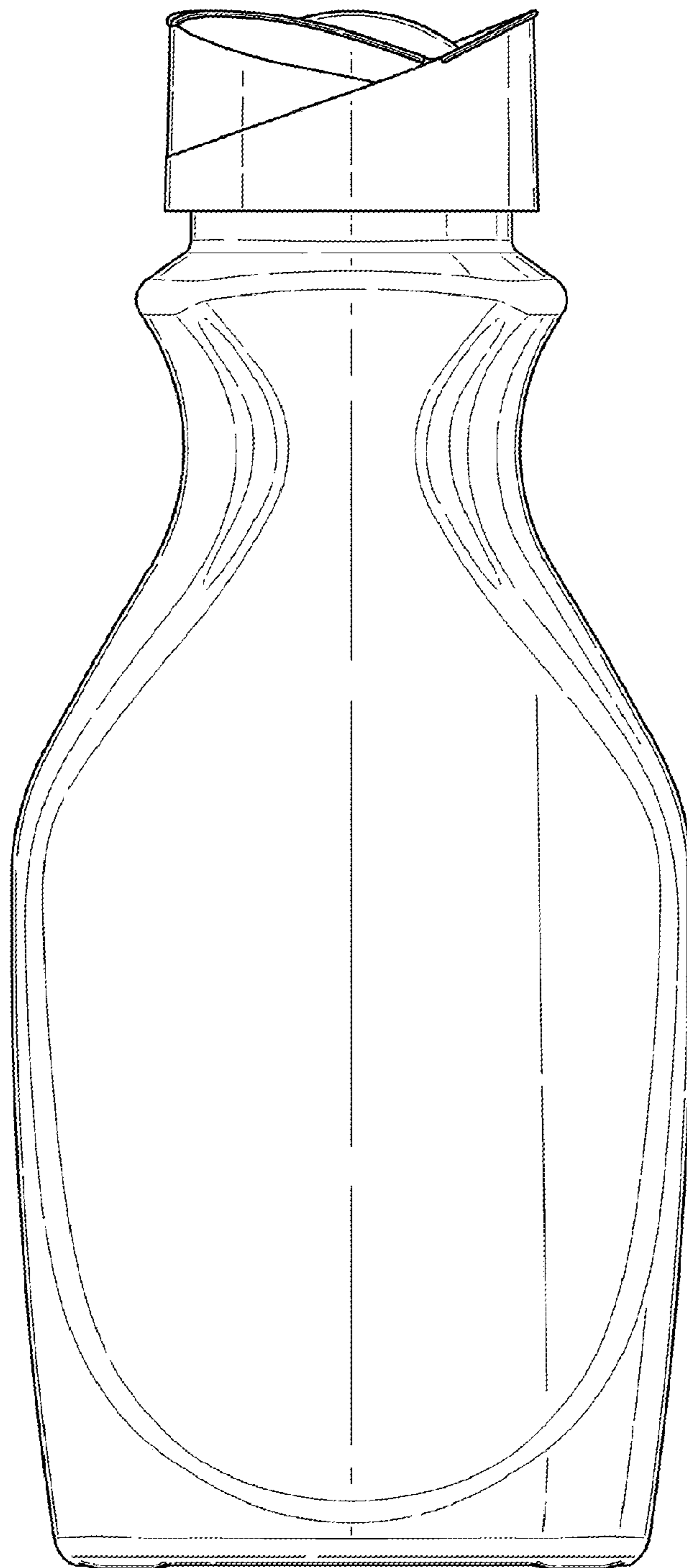

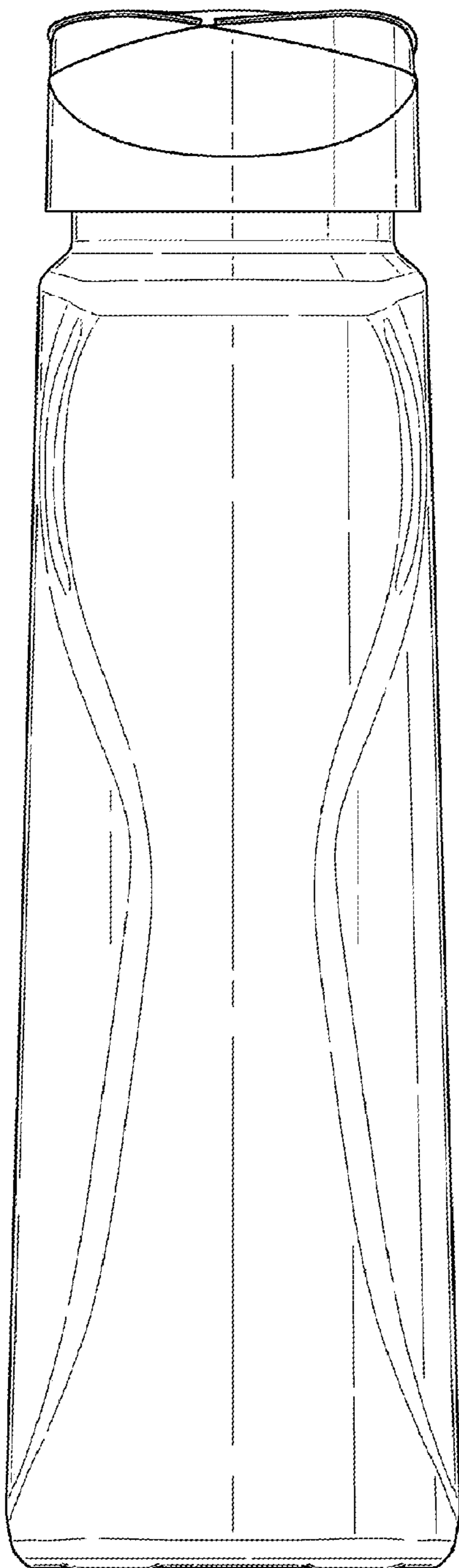

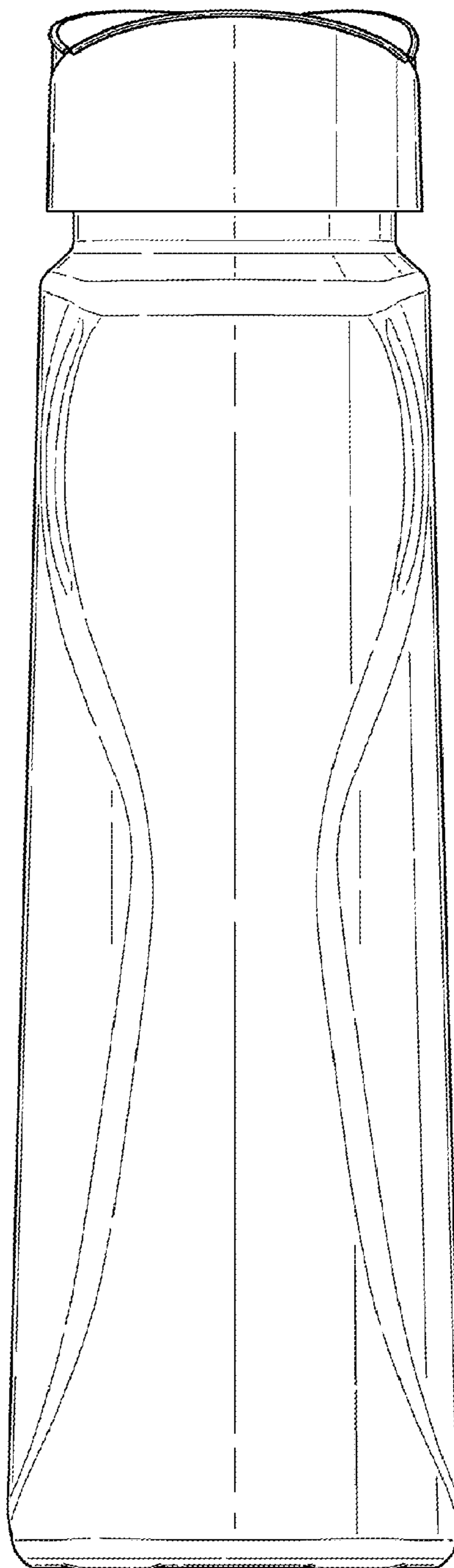

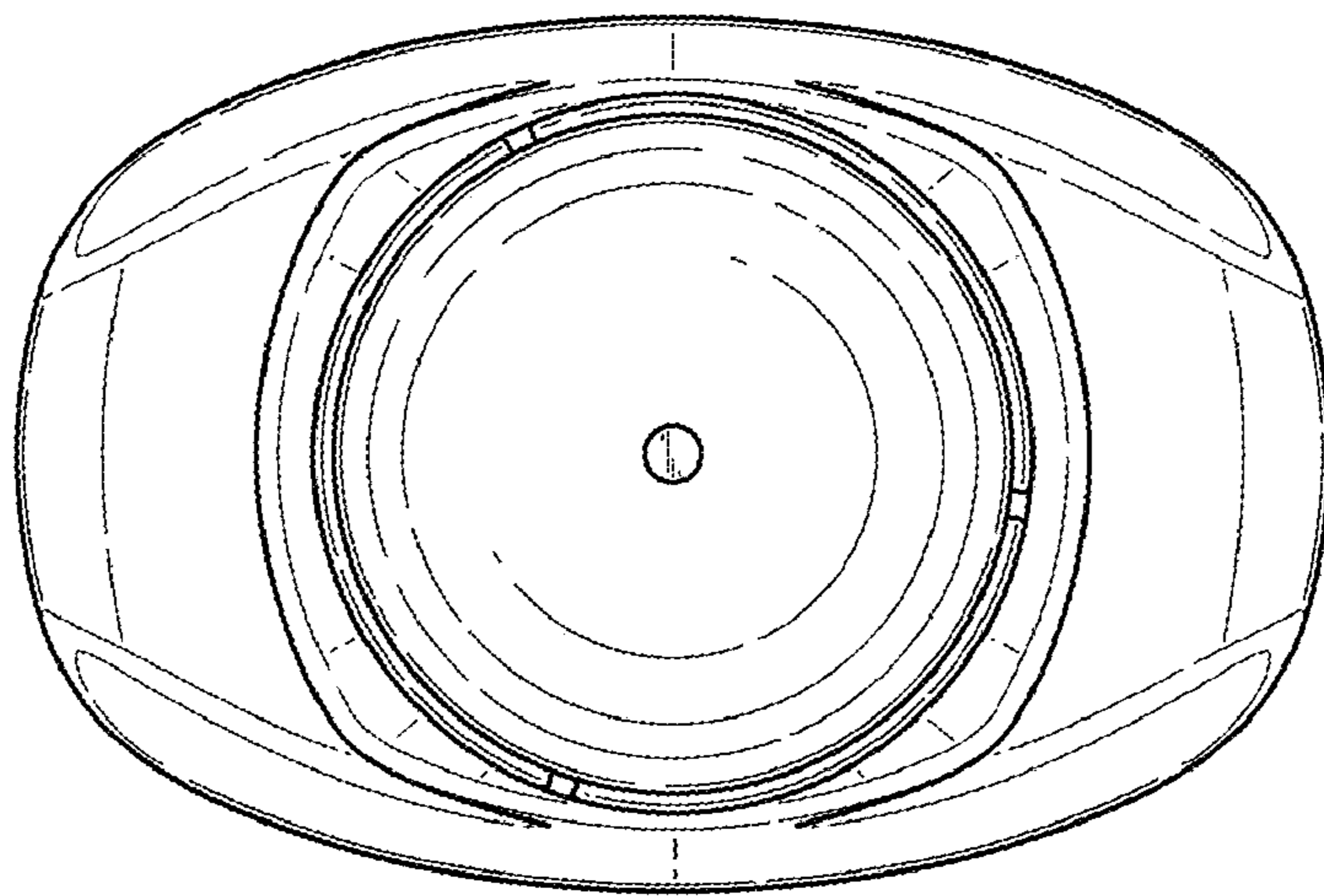
