(57) **CLAIM**

The ornamental design for a dip gauge, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a dip gauge in accordance with the design;

FIG. 4 is a right view of the dip gauge of FIG. 1;

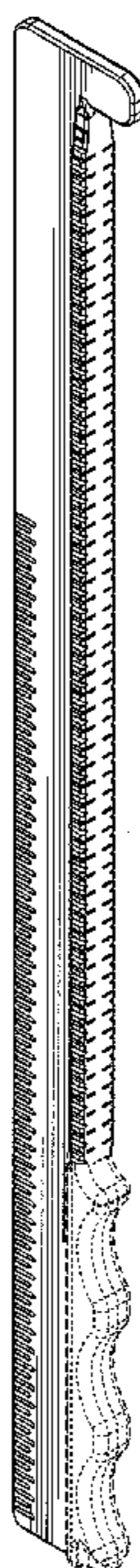
FIG. 5 is a left view of the dip gauge of FIG. 1;

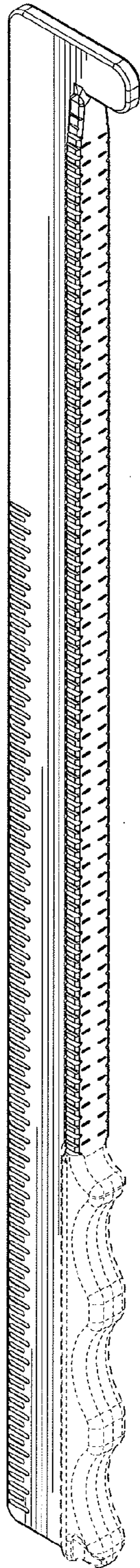

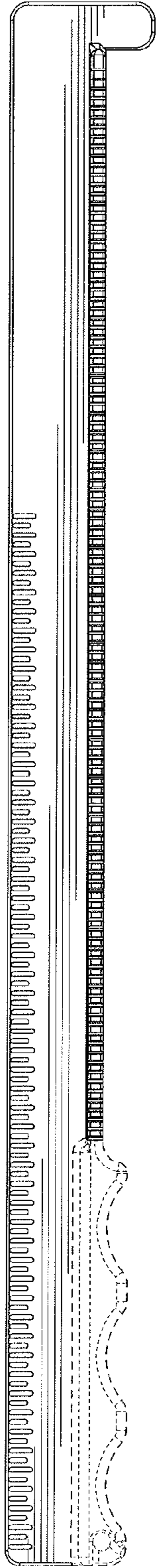

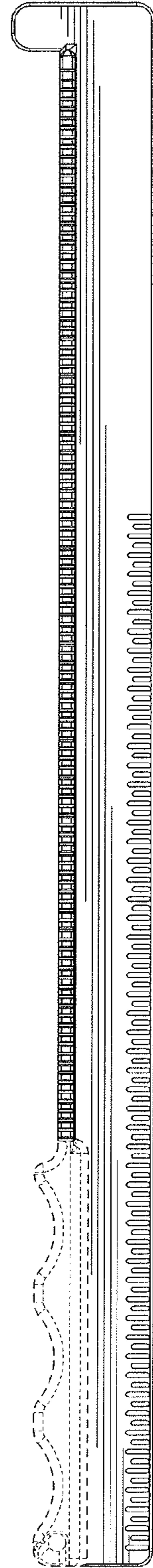

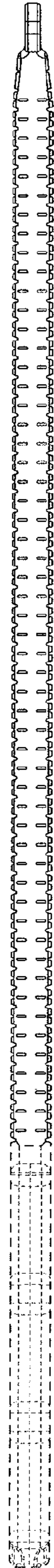

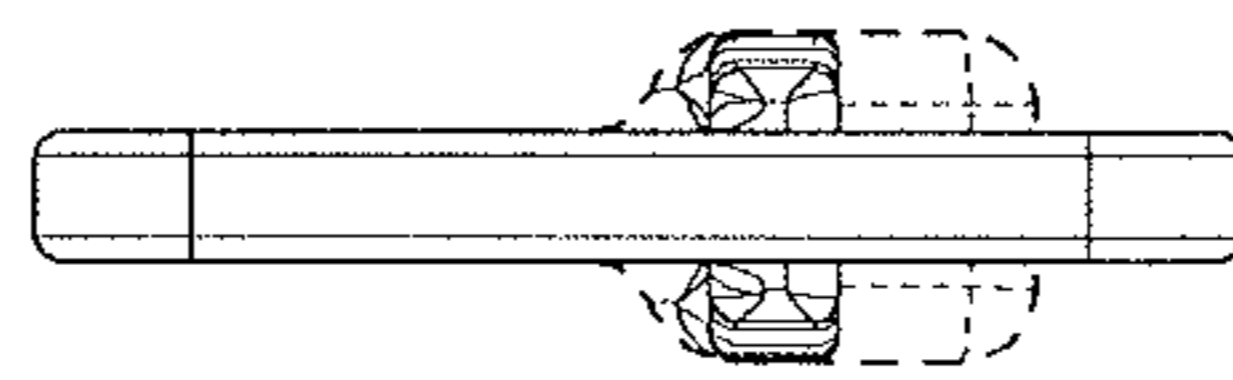

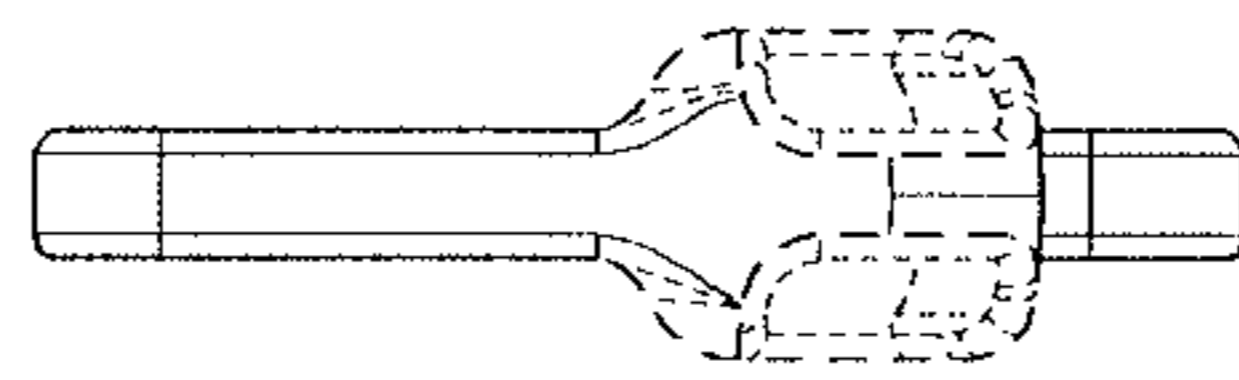
