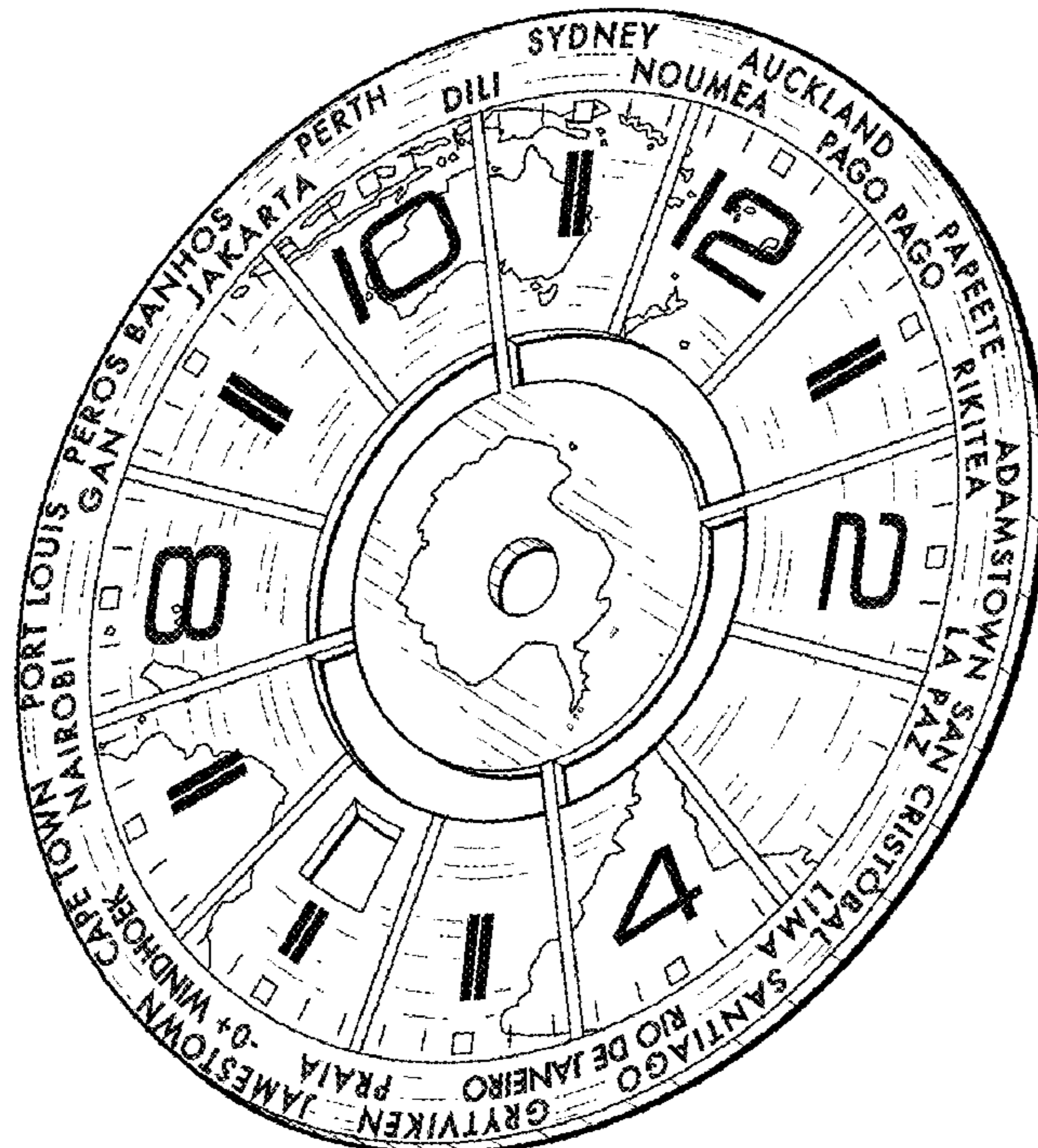
(57) **CLAIM**

The ornamental design for a watch dial, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of the watch dial of the present invention. FIG. 2 is a bottom view of the watch dial of FIG. 1. FIG. 3 is a right side view of the watch dial of FIG. 1. FIG. 4 is a left view of the watch dial of FIG. 1. FIG. 5 is a front view of the watch dial of FIG. 1. FIG. 6 is a rear view of the watch dial of FIG. 1; and, FIG. 7 is a top, right-side perspective view of the watch dial of FIG. 1.

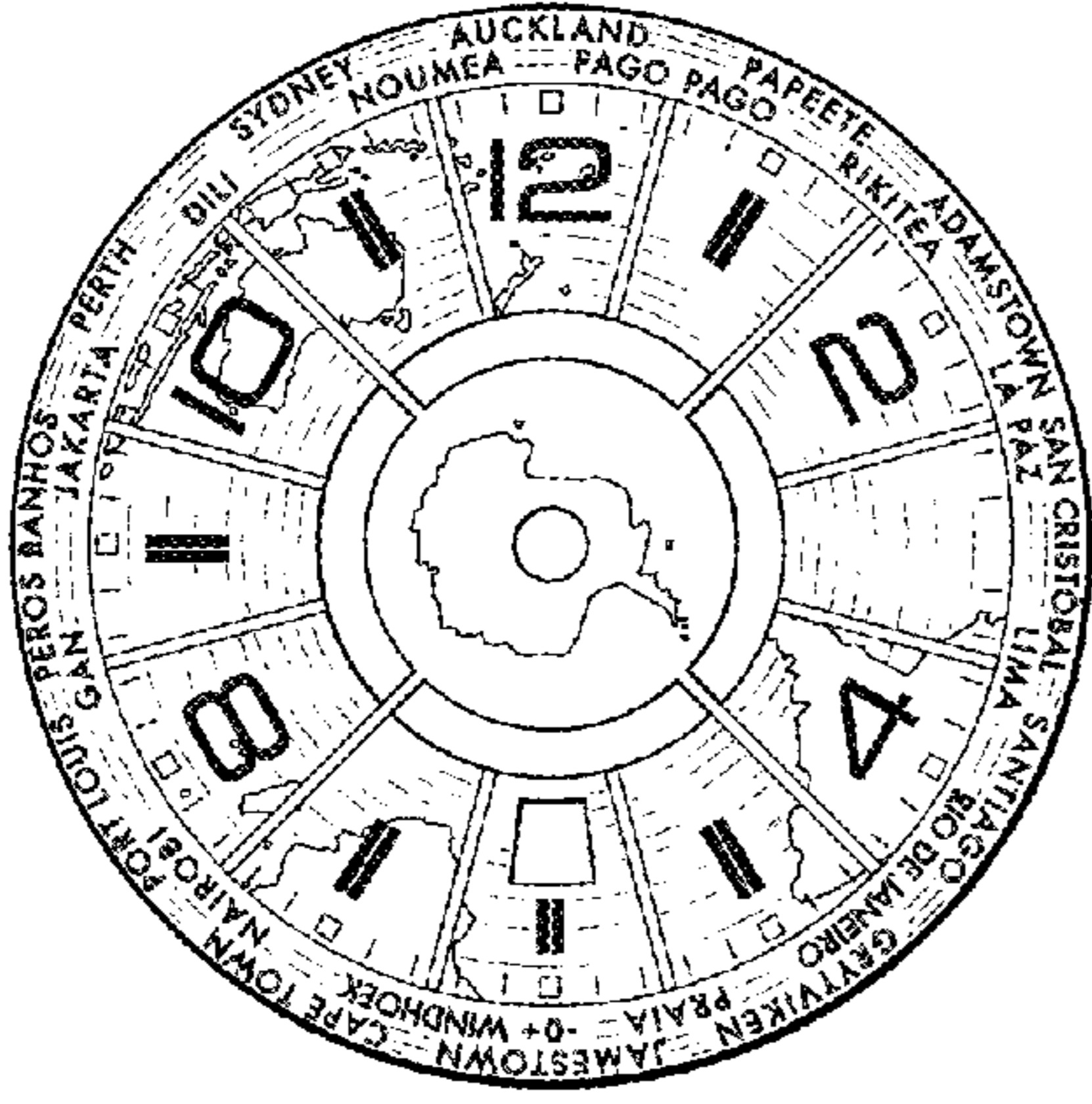

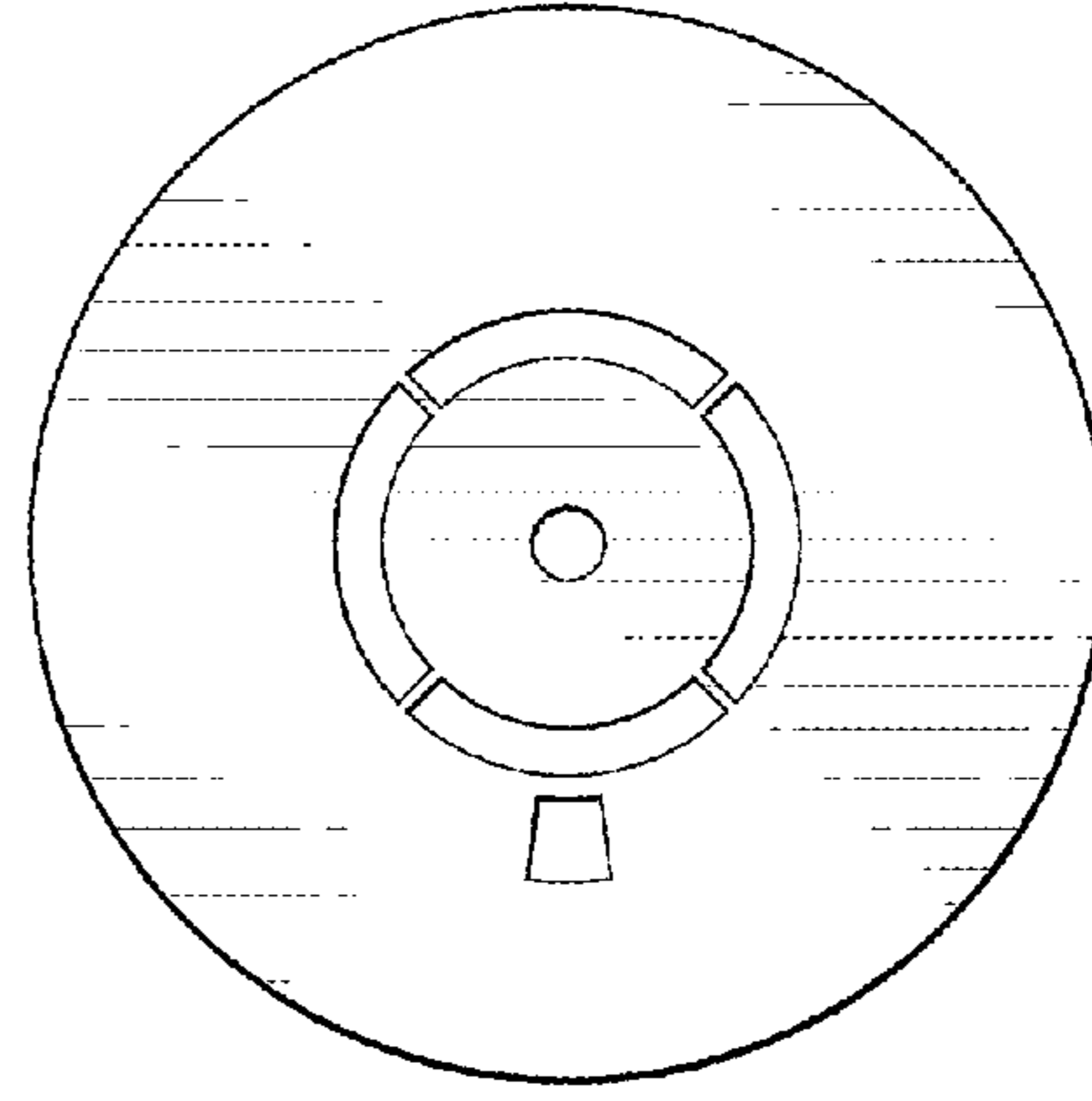

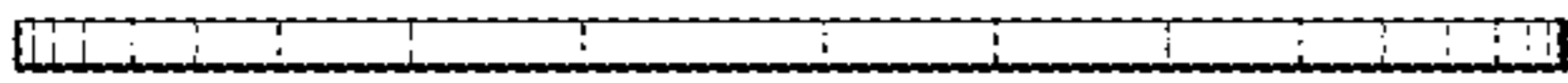

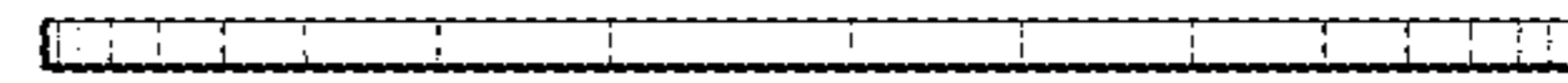

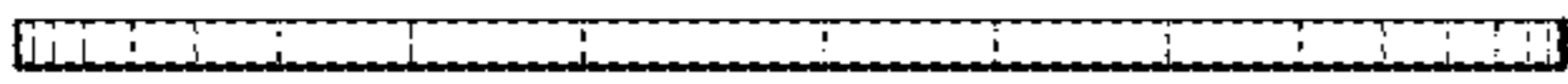

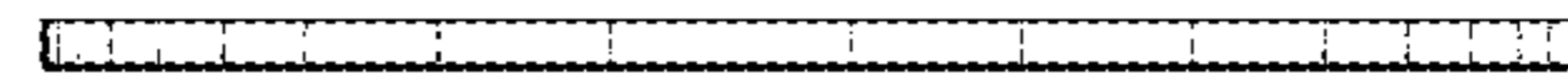

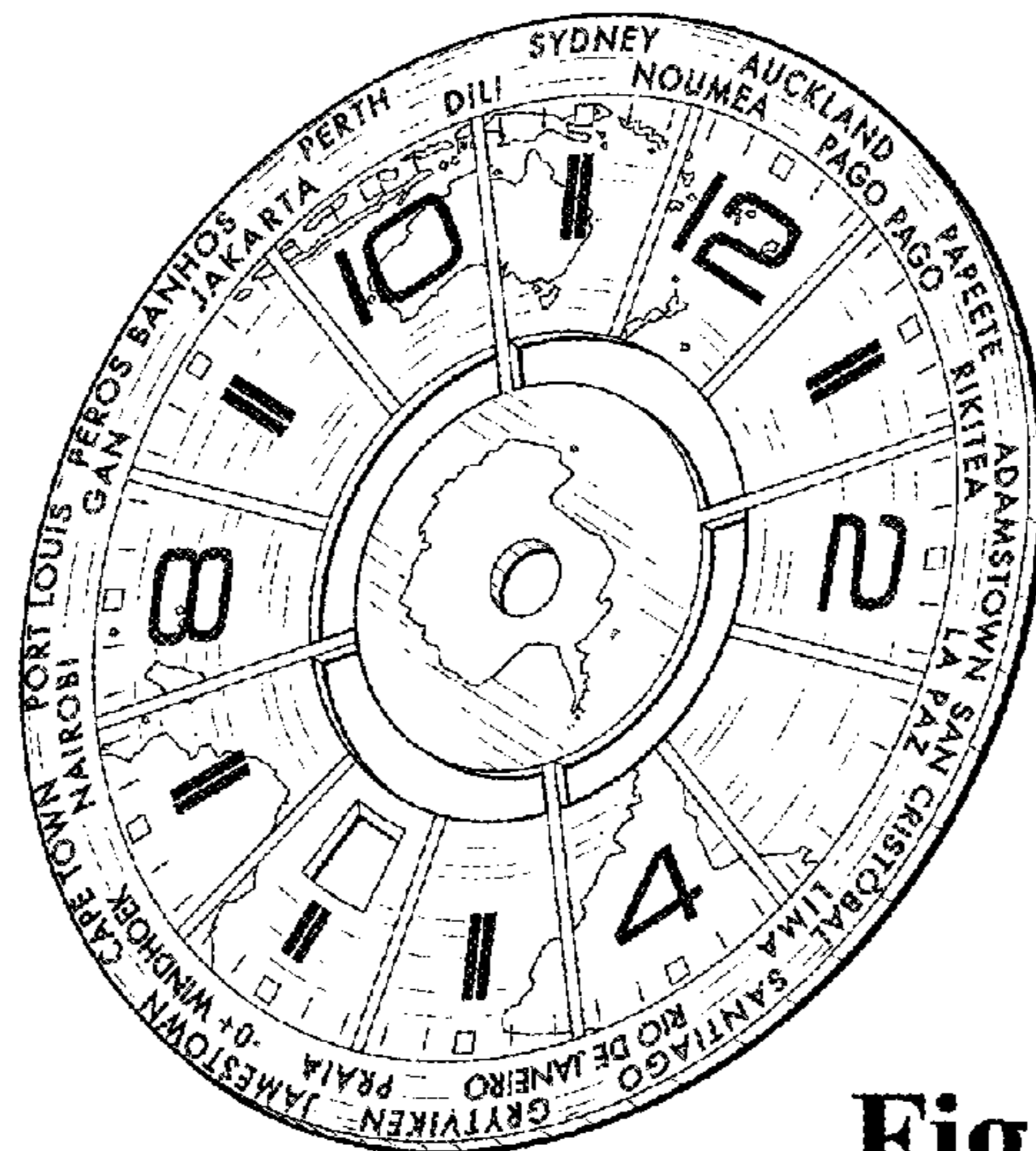
