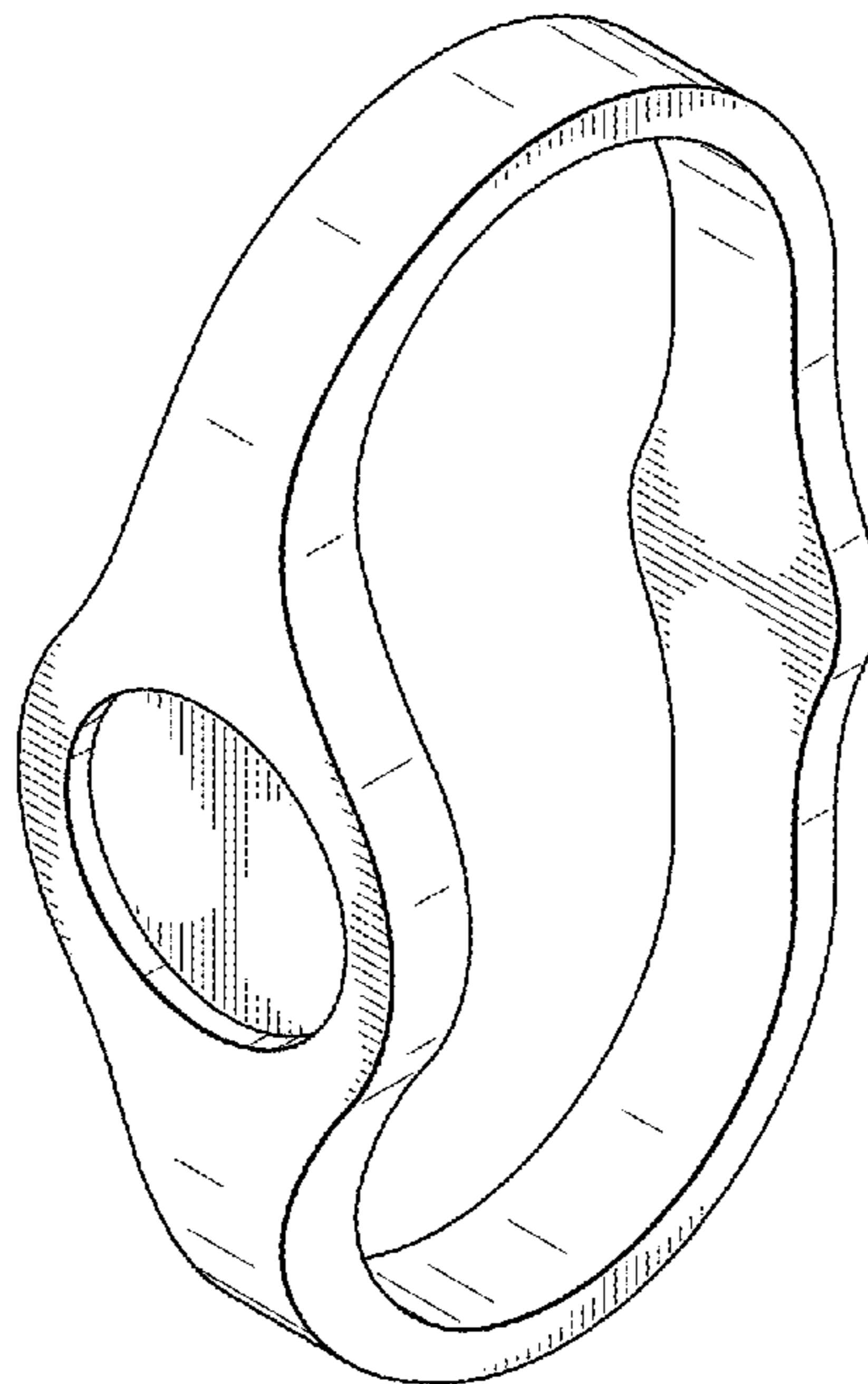
(57) **CLAIM**

The ornamental design for a bracelet with removable chip, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a bracelet with removable chip embodying my design;  
 FIG. 2 is a front view of the bracelet with removable chip;  
 FIG. 3 is a rear view of the bracelet with removable chip;  
 FIG. 4 is a right side view of the bracelet with removable chip;  
 FIG. 5 is a left side view of the bracelet with removable chip;  
 FIG. 6 is a top view of the bracelet with removable chip; and,  
 FIG. 7 is a bottom view of the bracelet with removable chip.

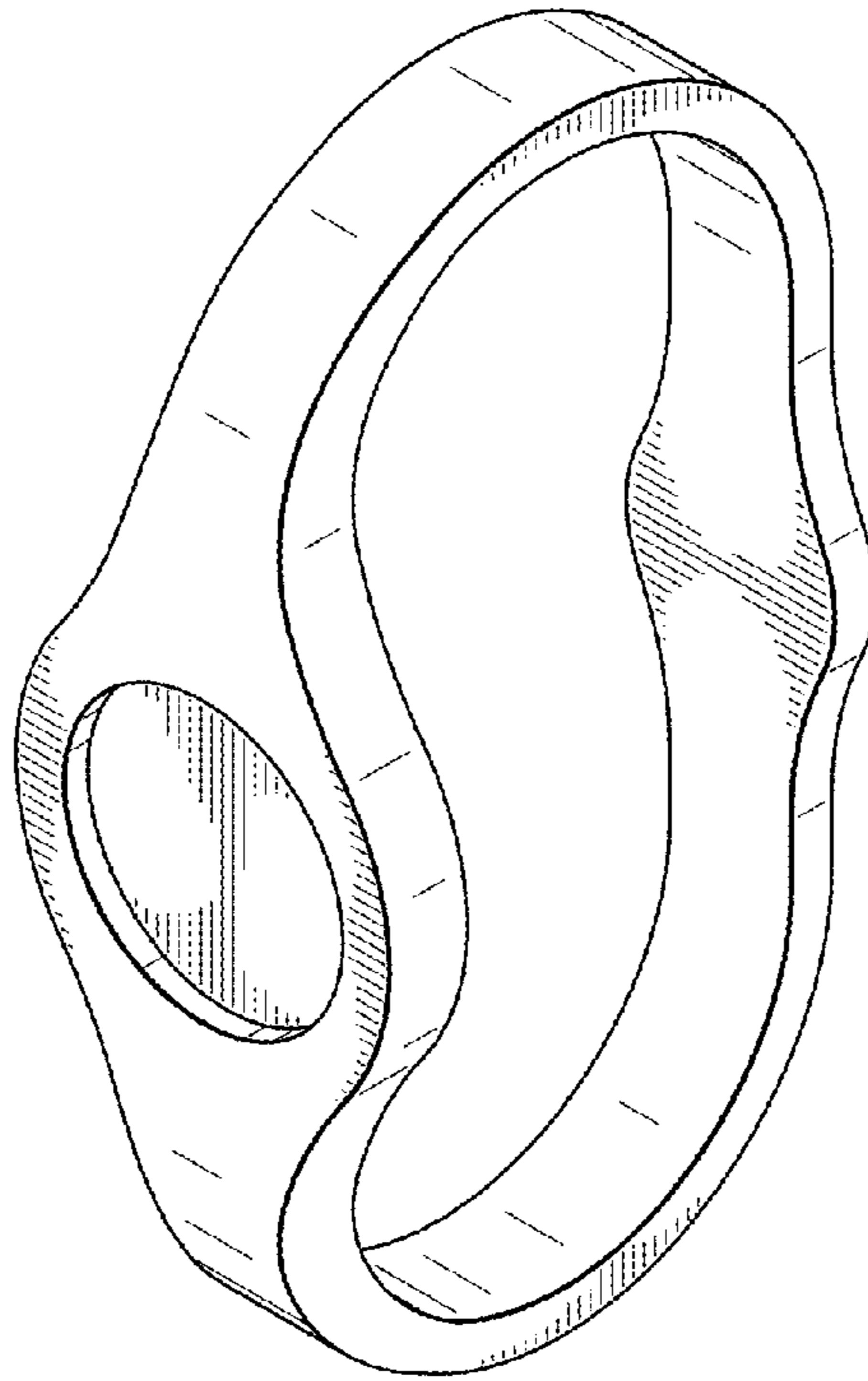

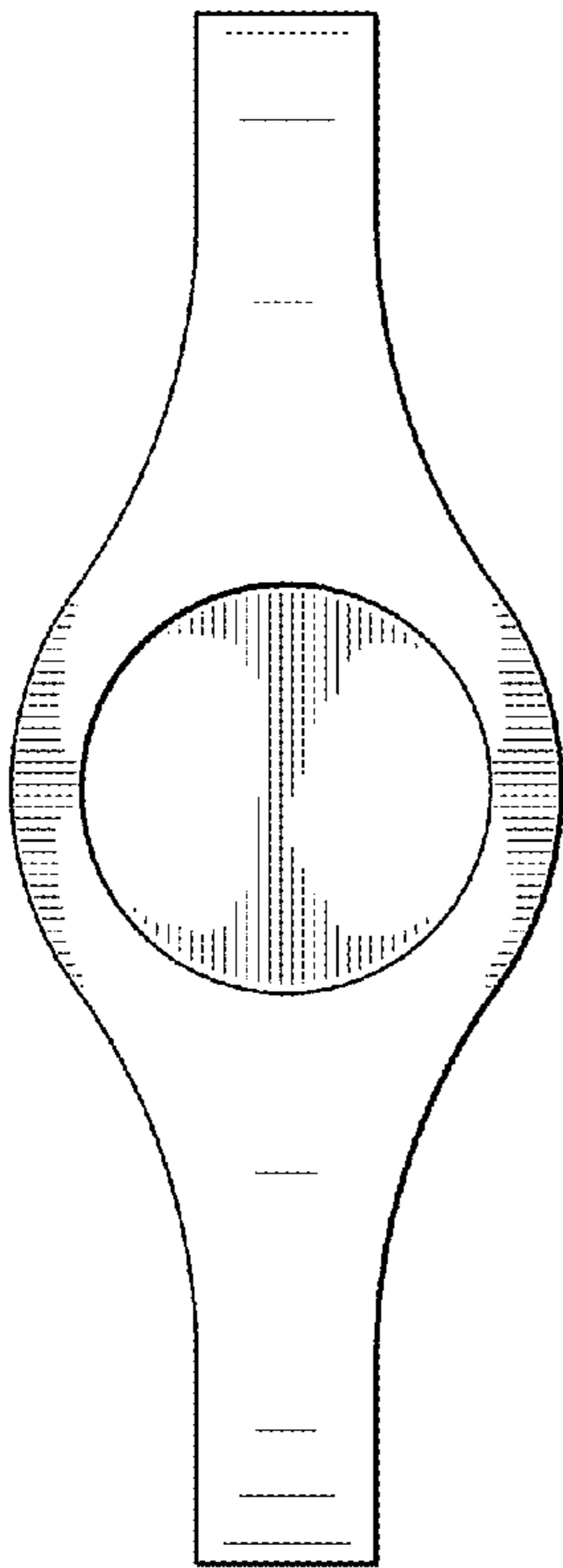

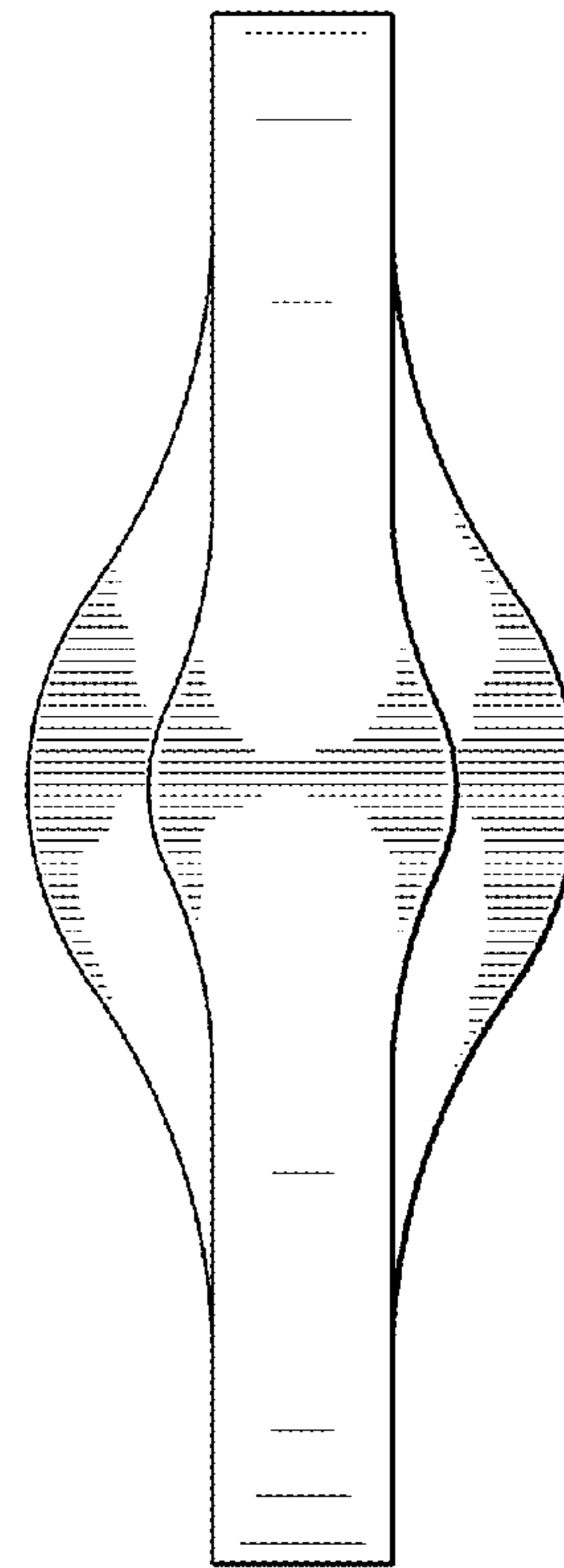

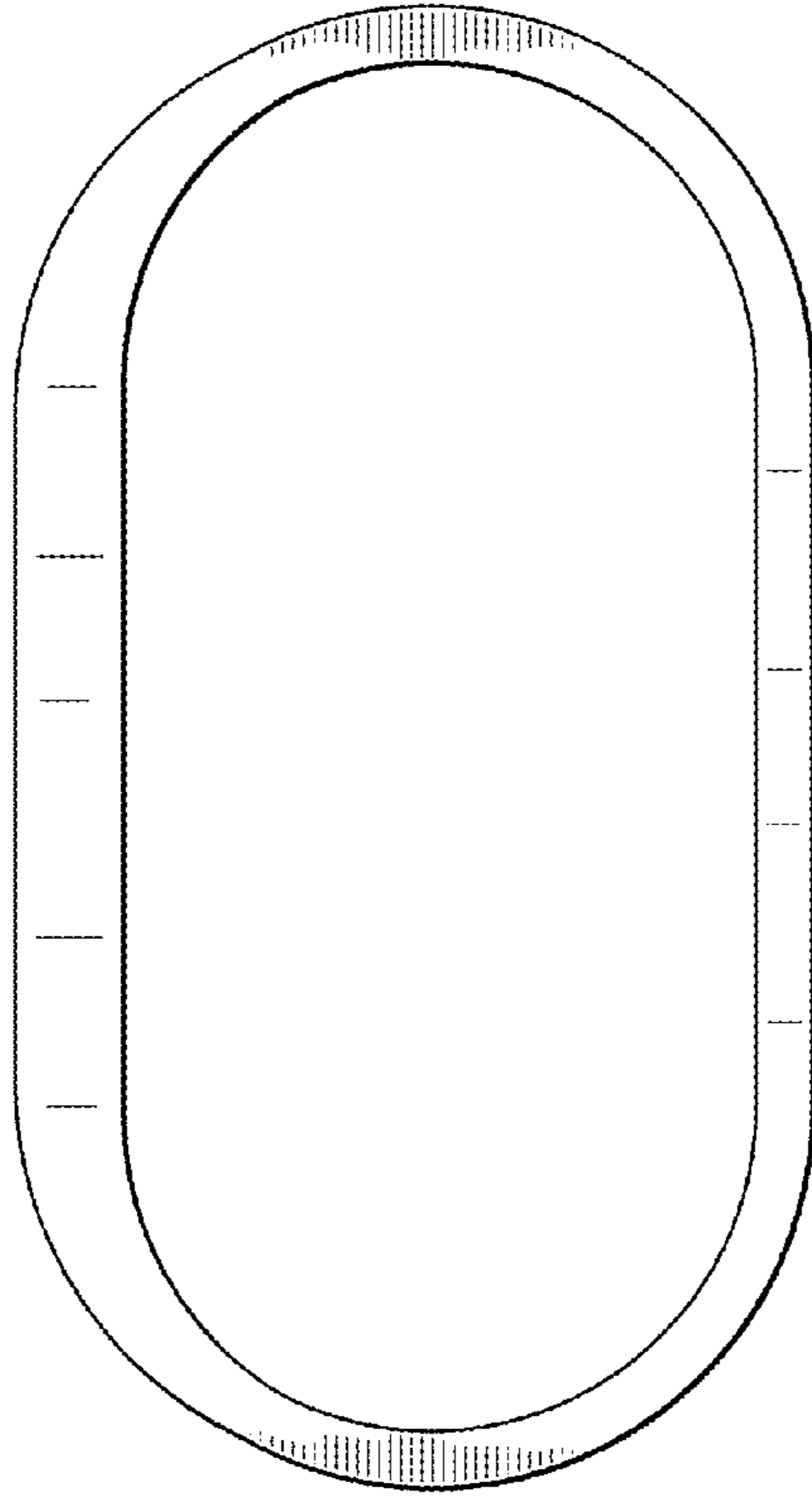

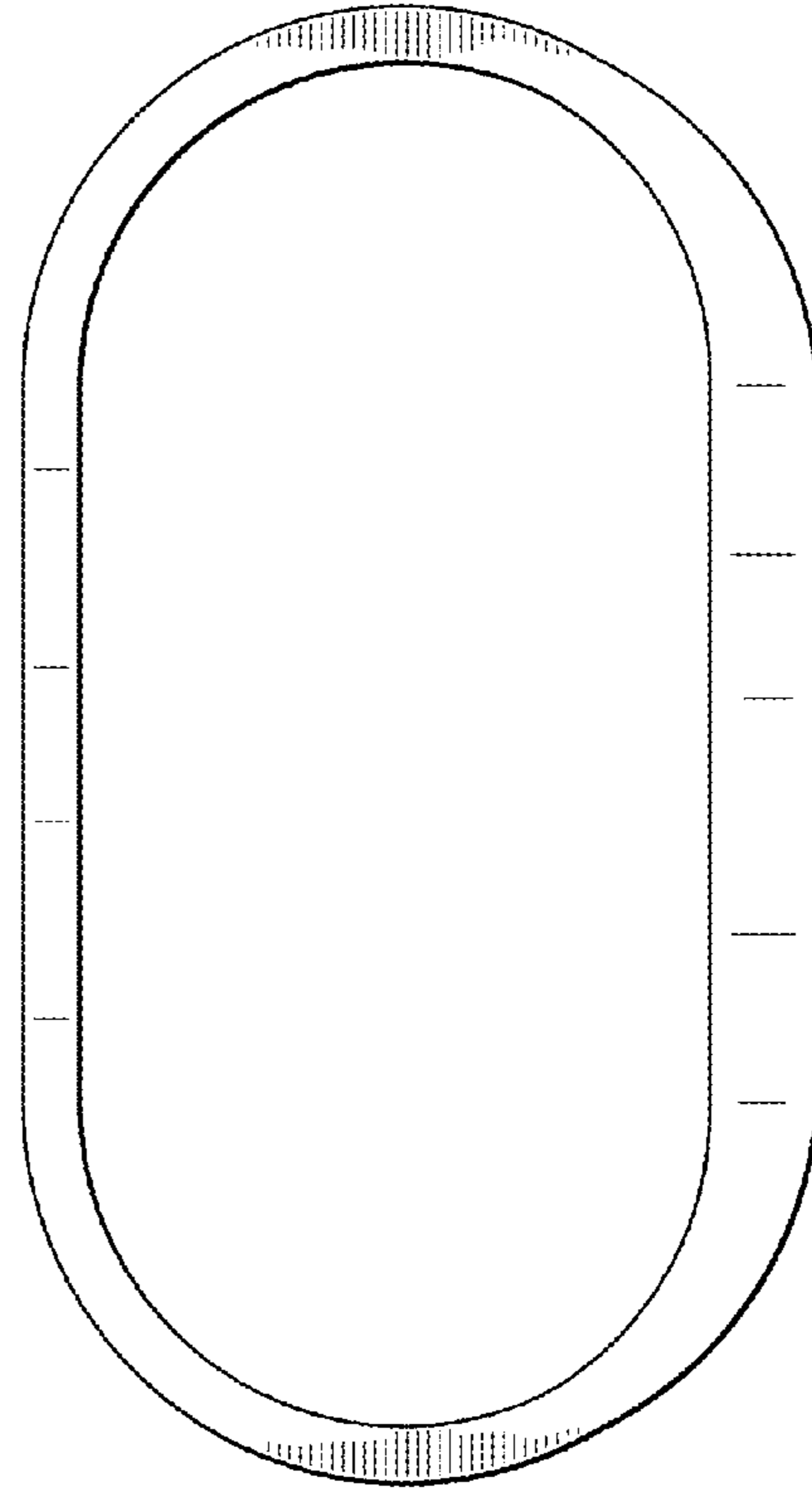

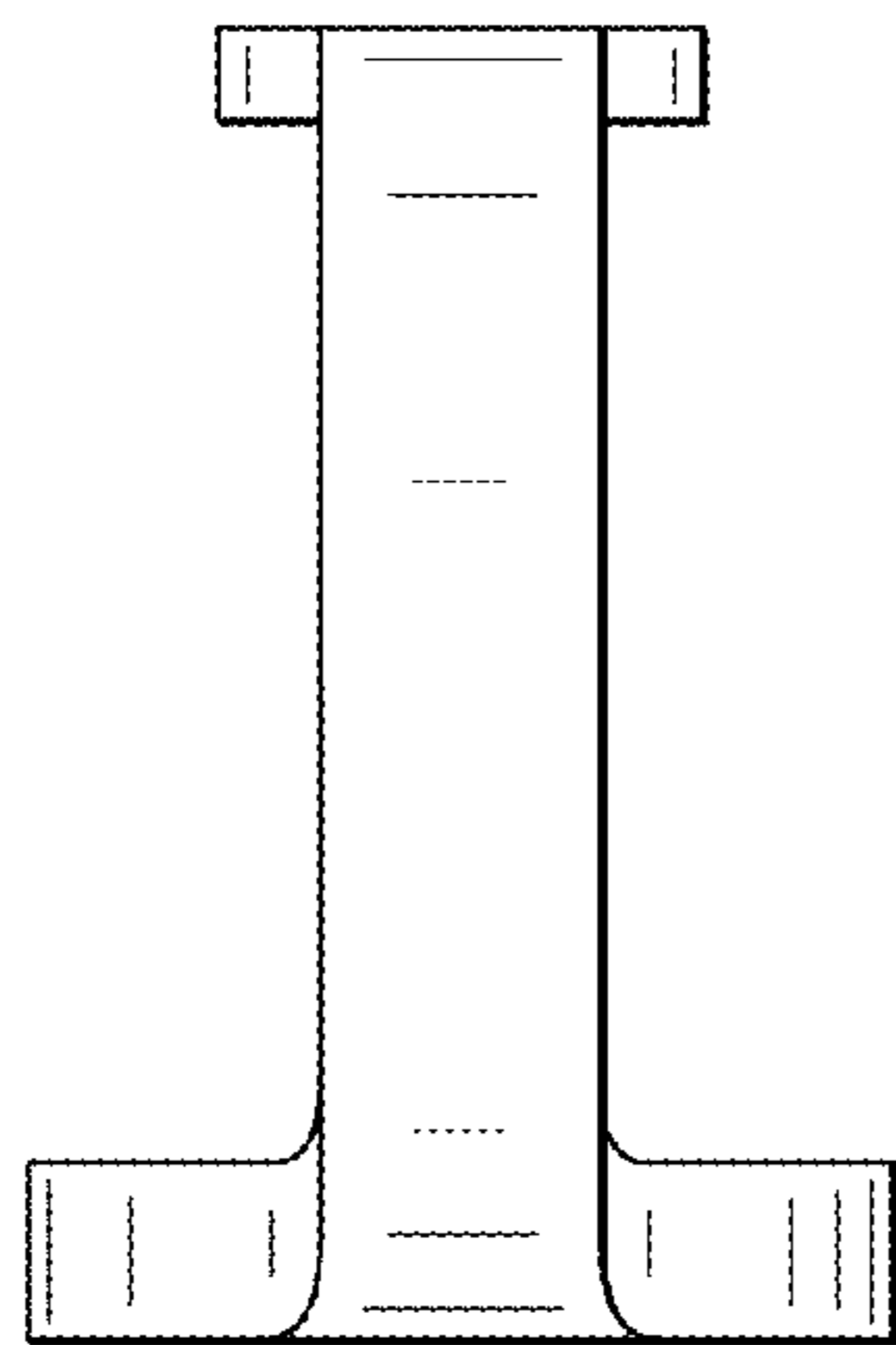

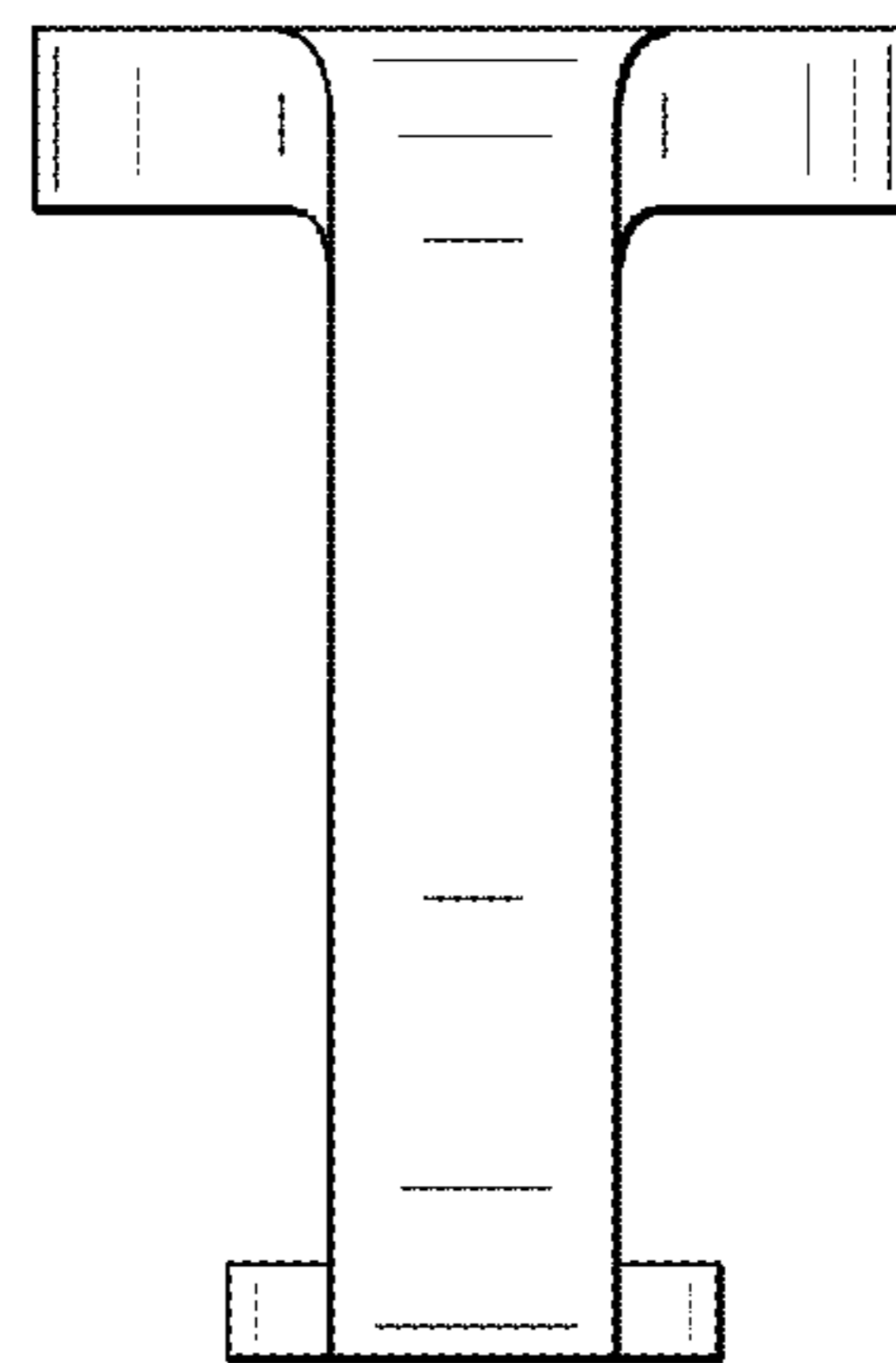
