**DESCRIPTION**

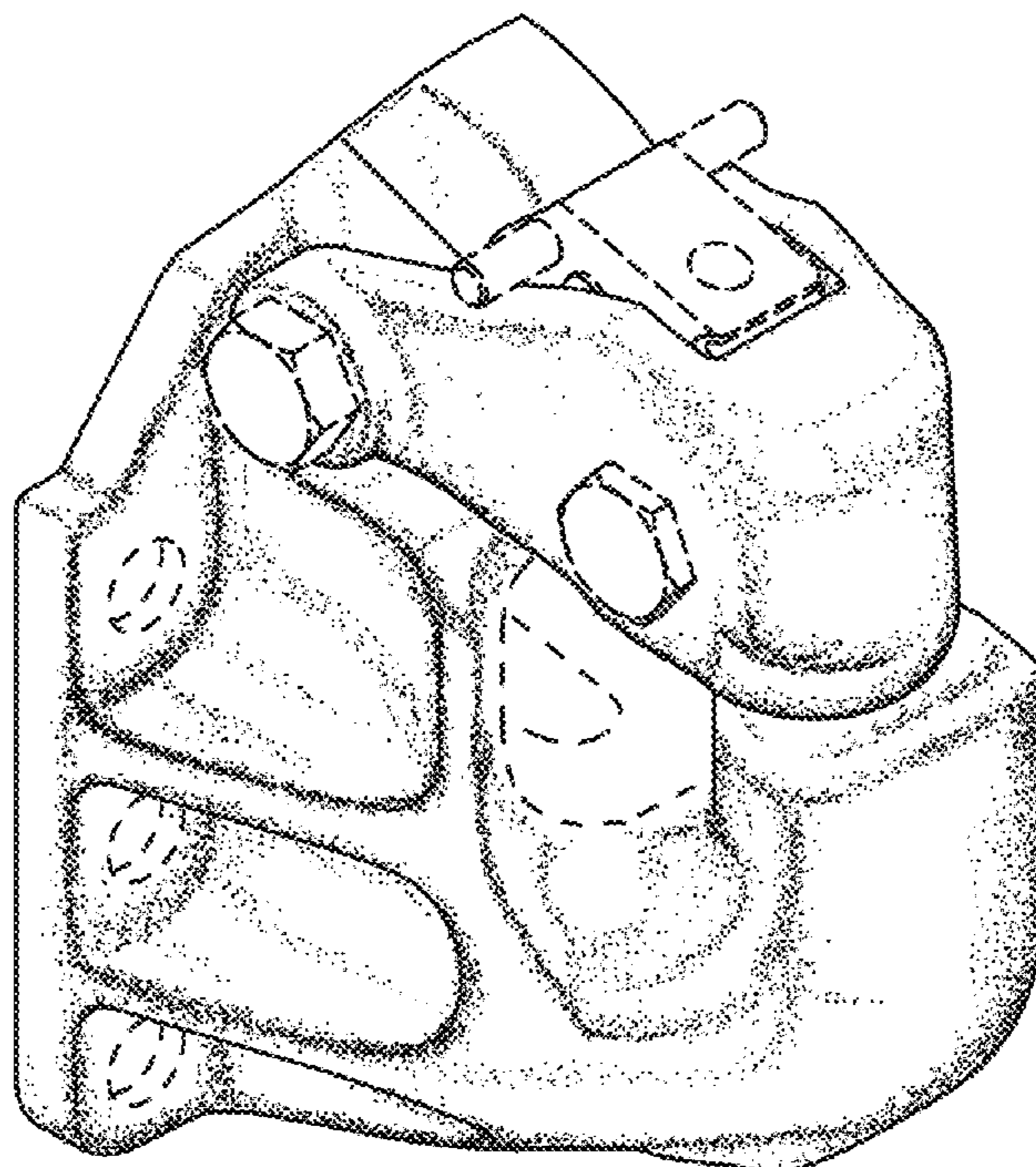
FIG. 1 is a perspective view of a pintle hook assembly;

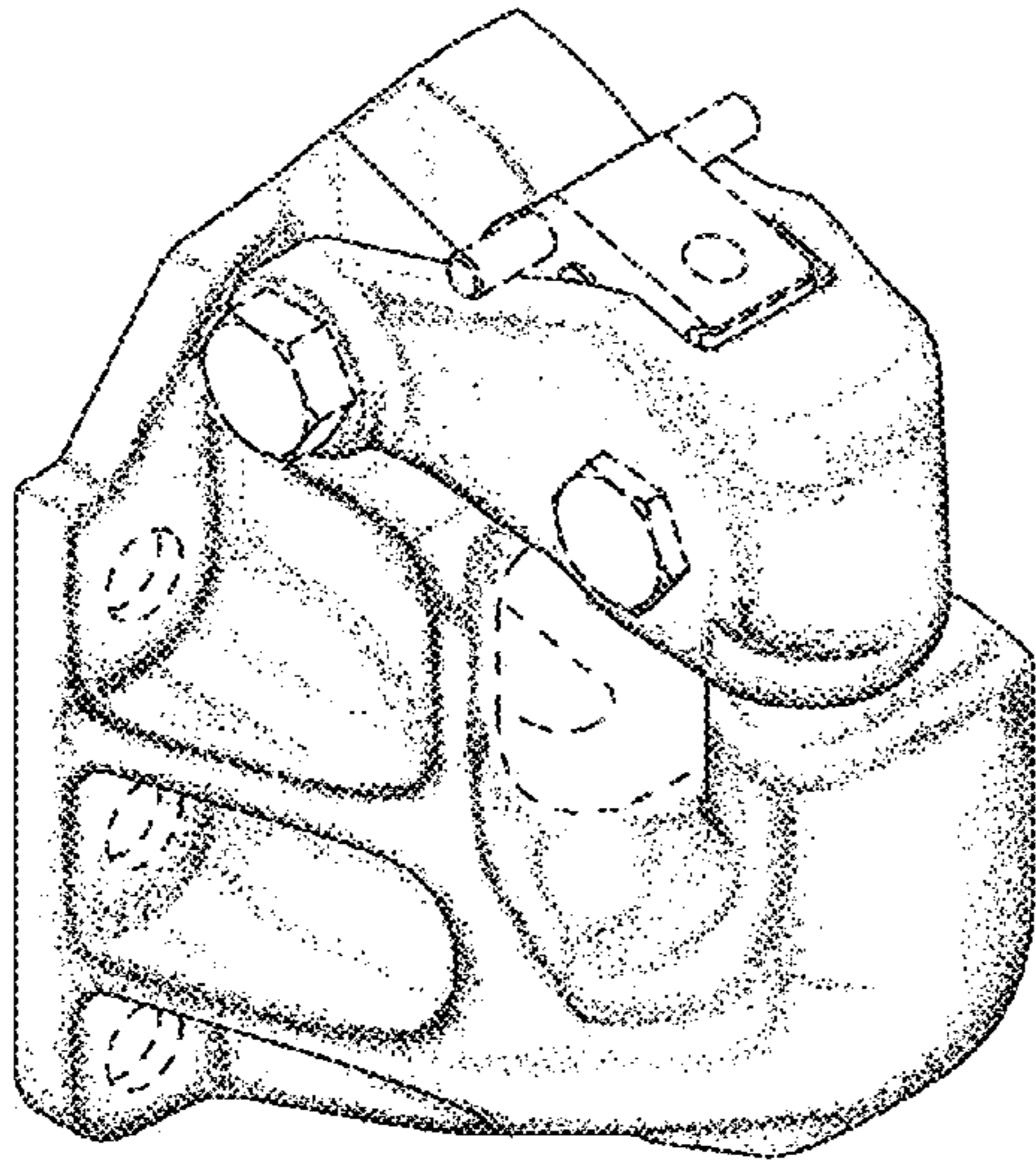

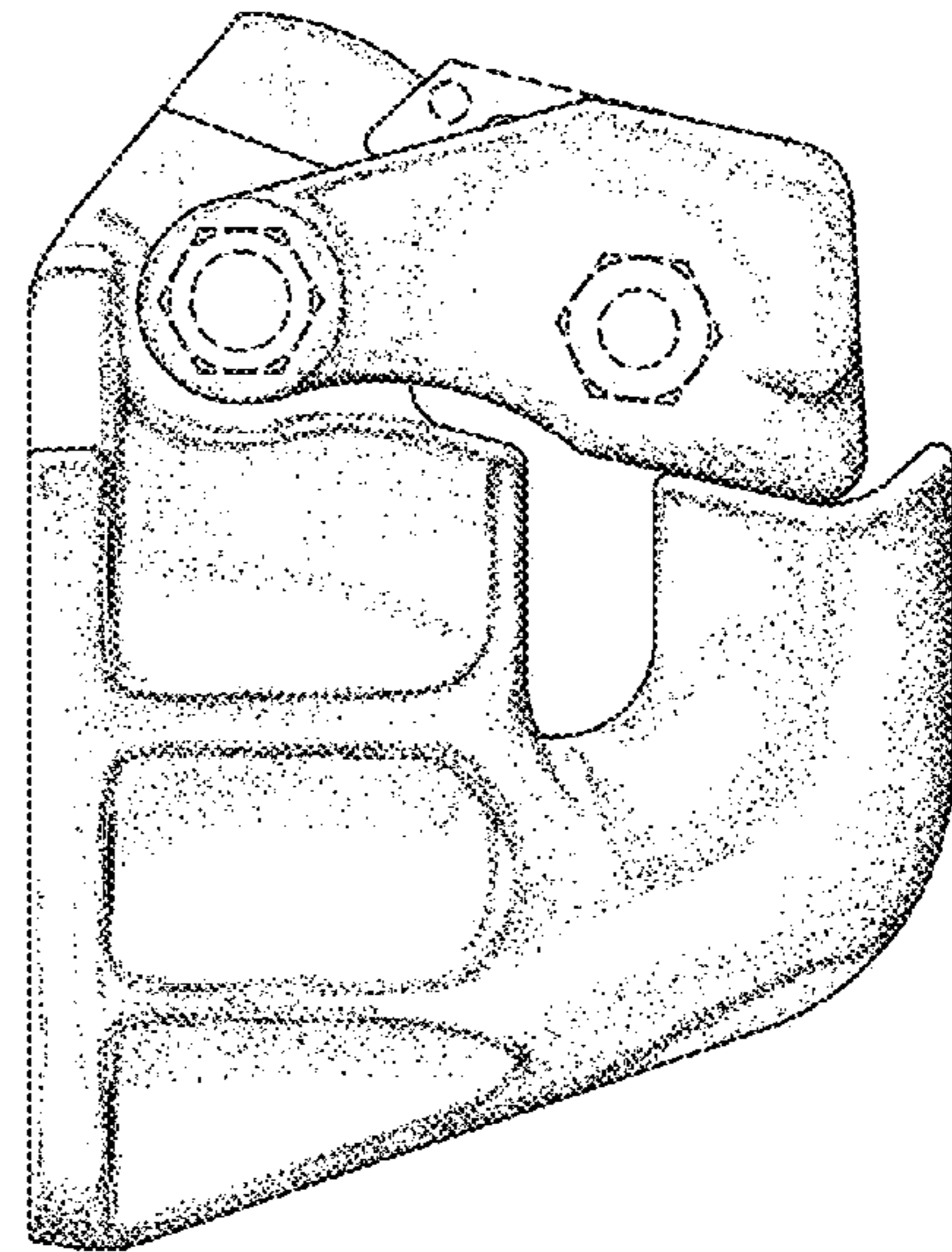

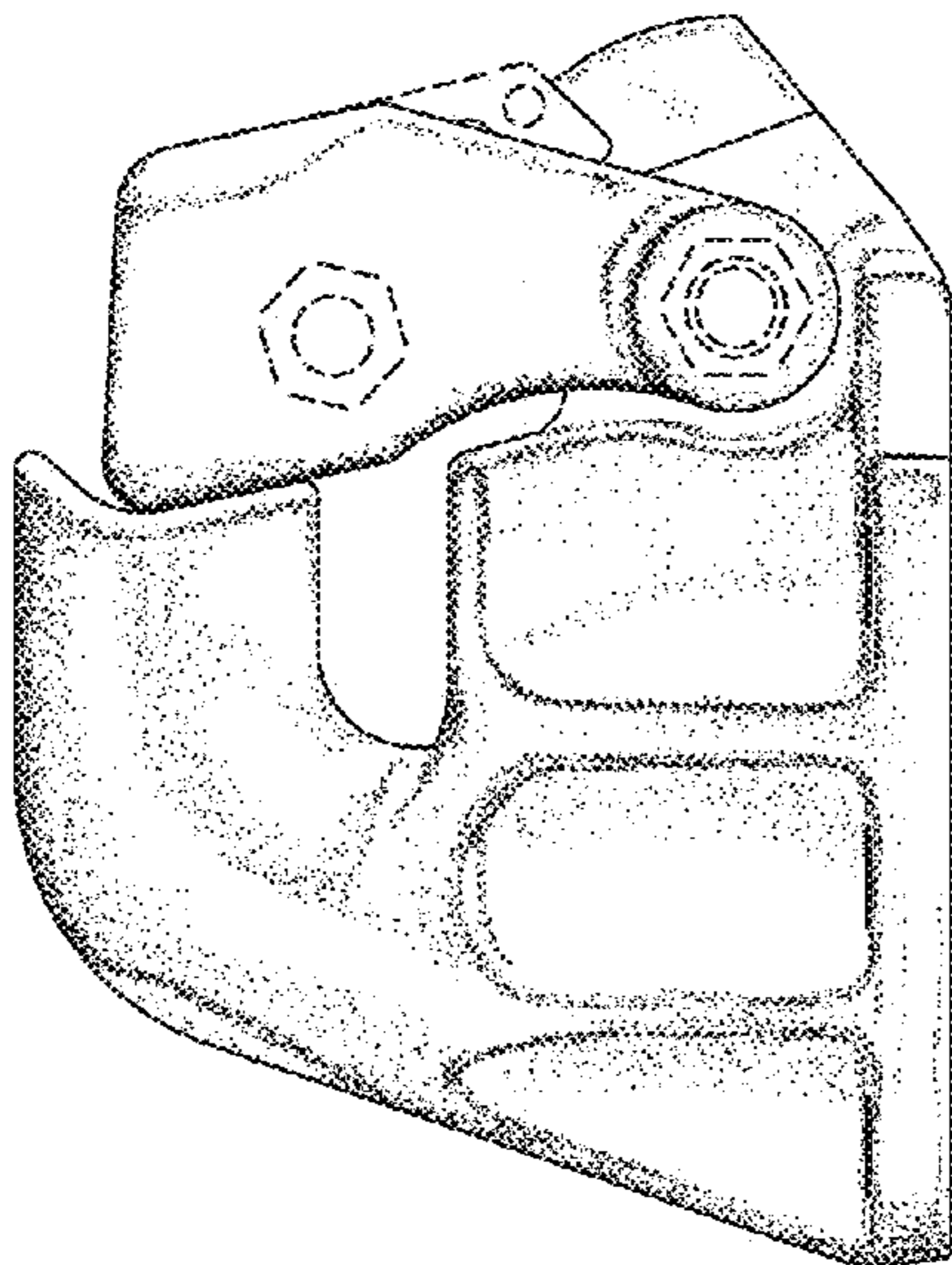

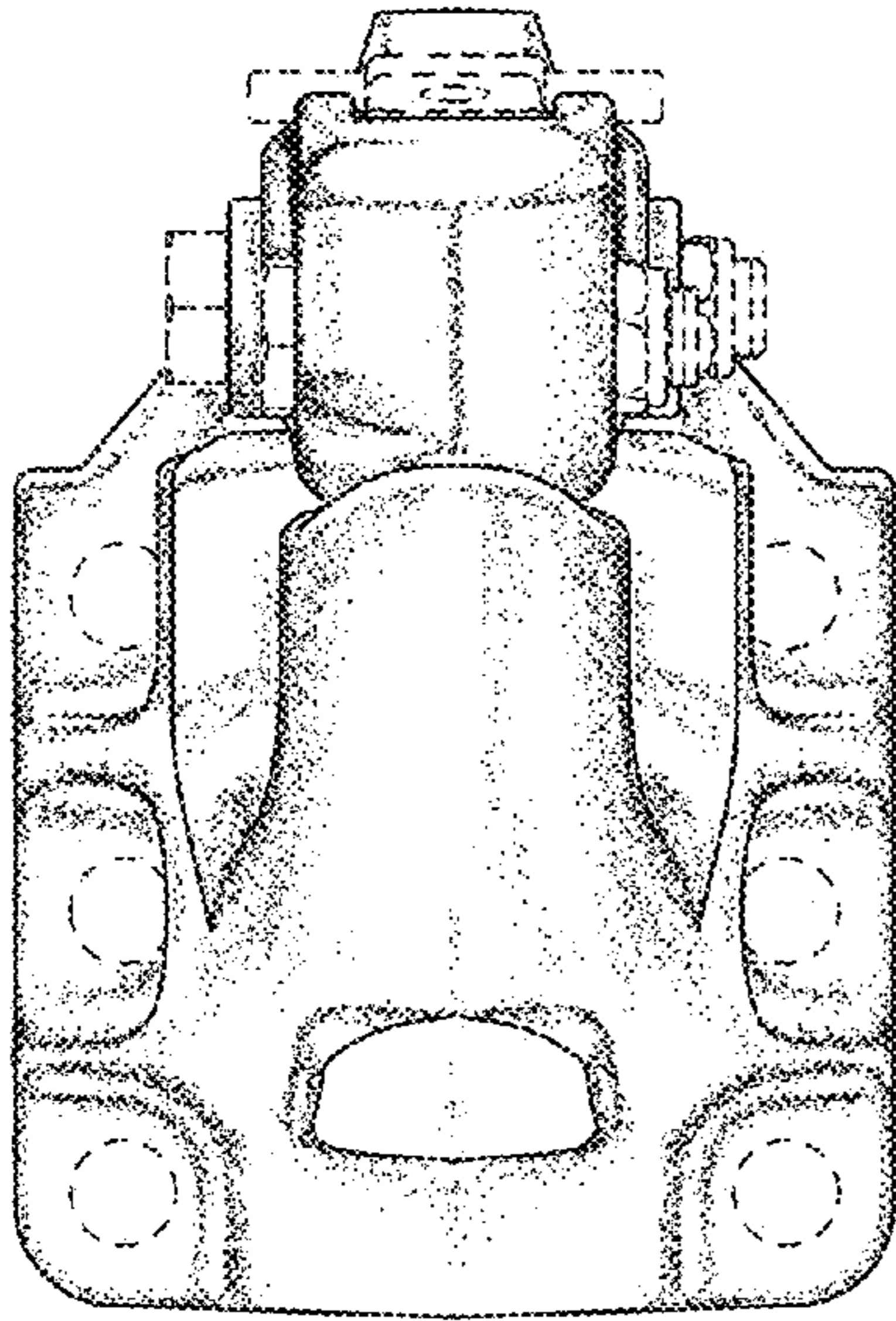

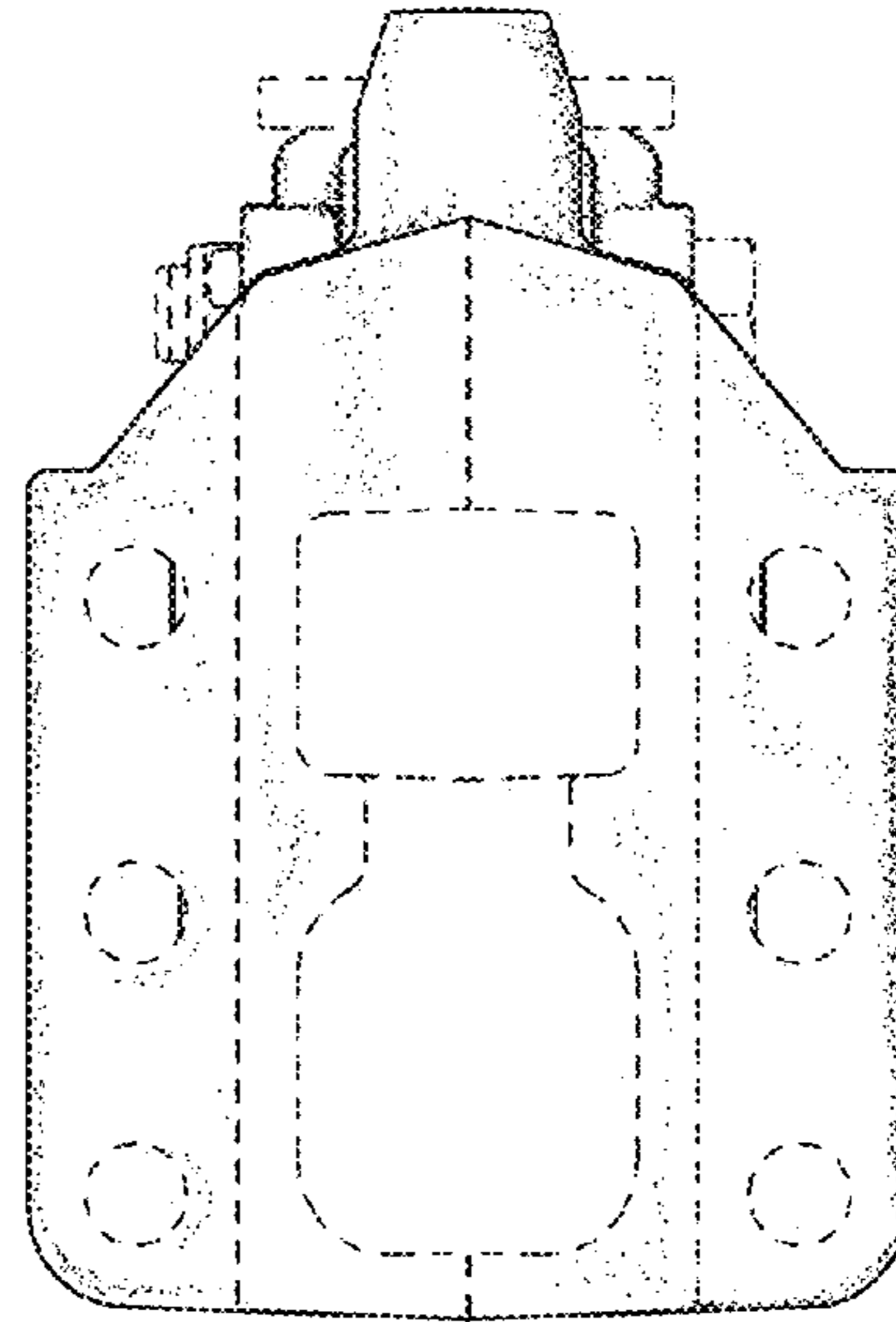

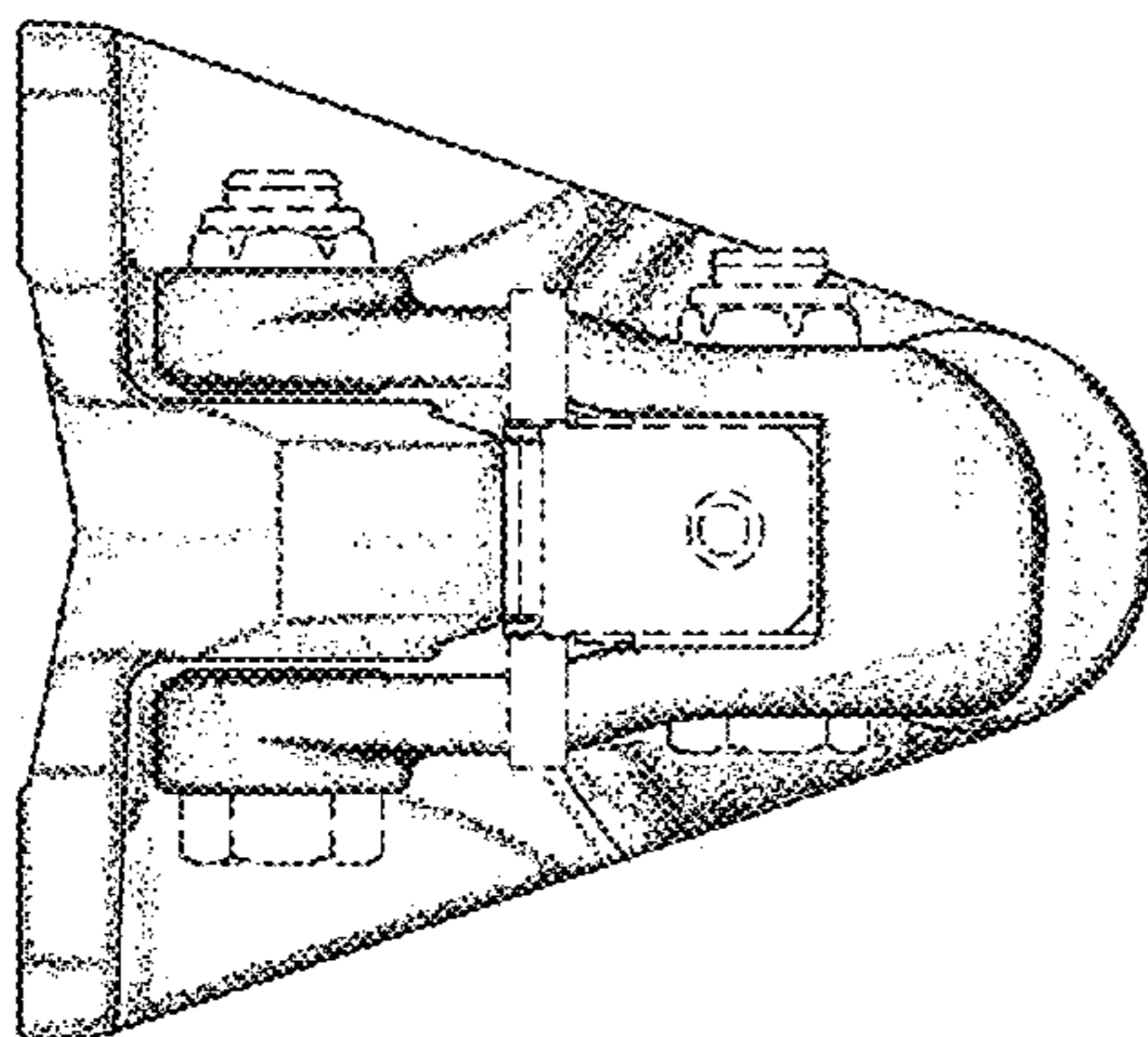

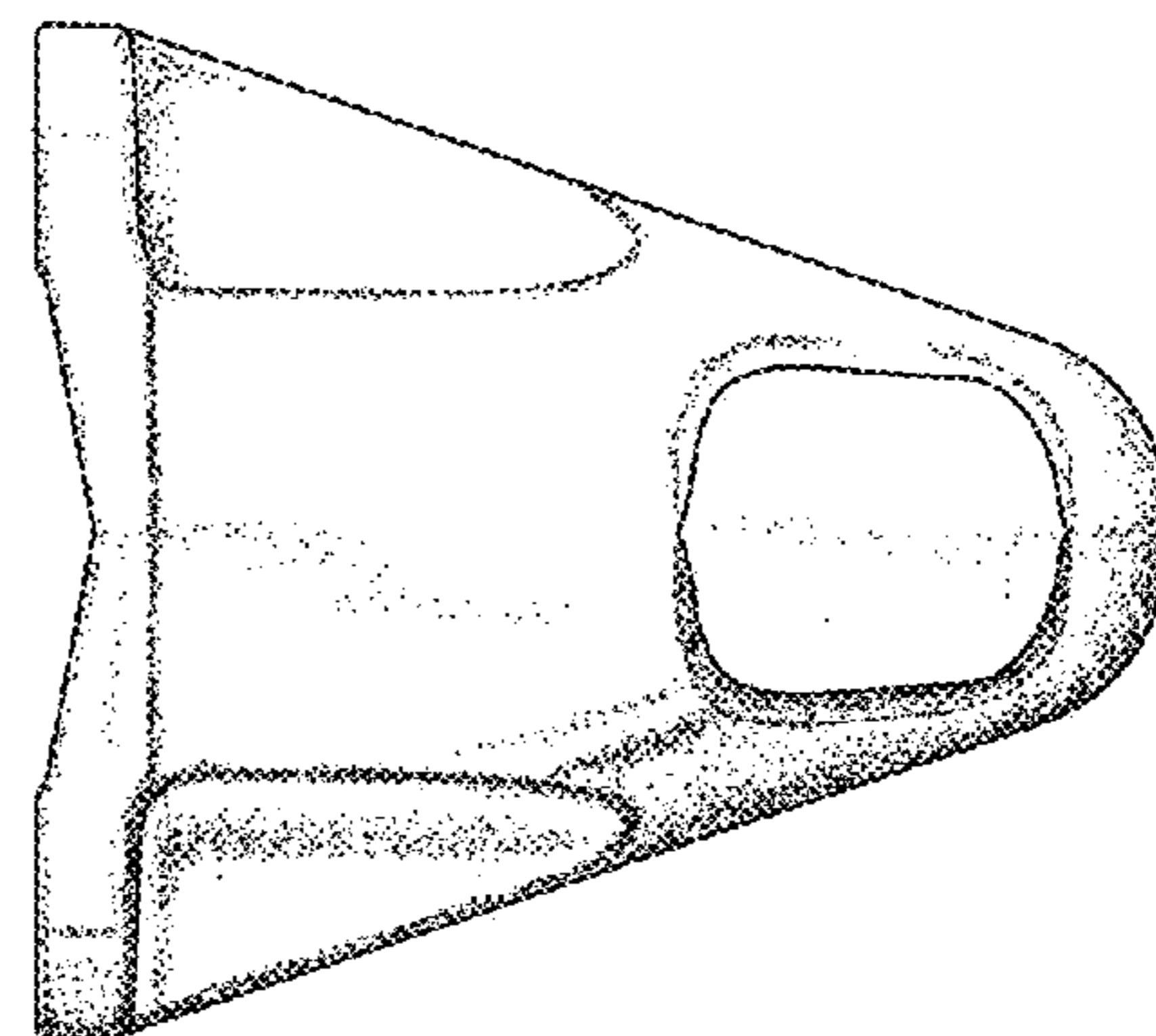
