The ornamental design for a charger unit for an electric skin brush, as shown and described.

FIG. 5 is an elevational view of the one side of the skin brush charger.

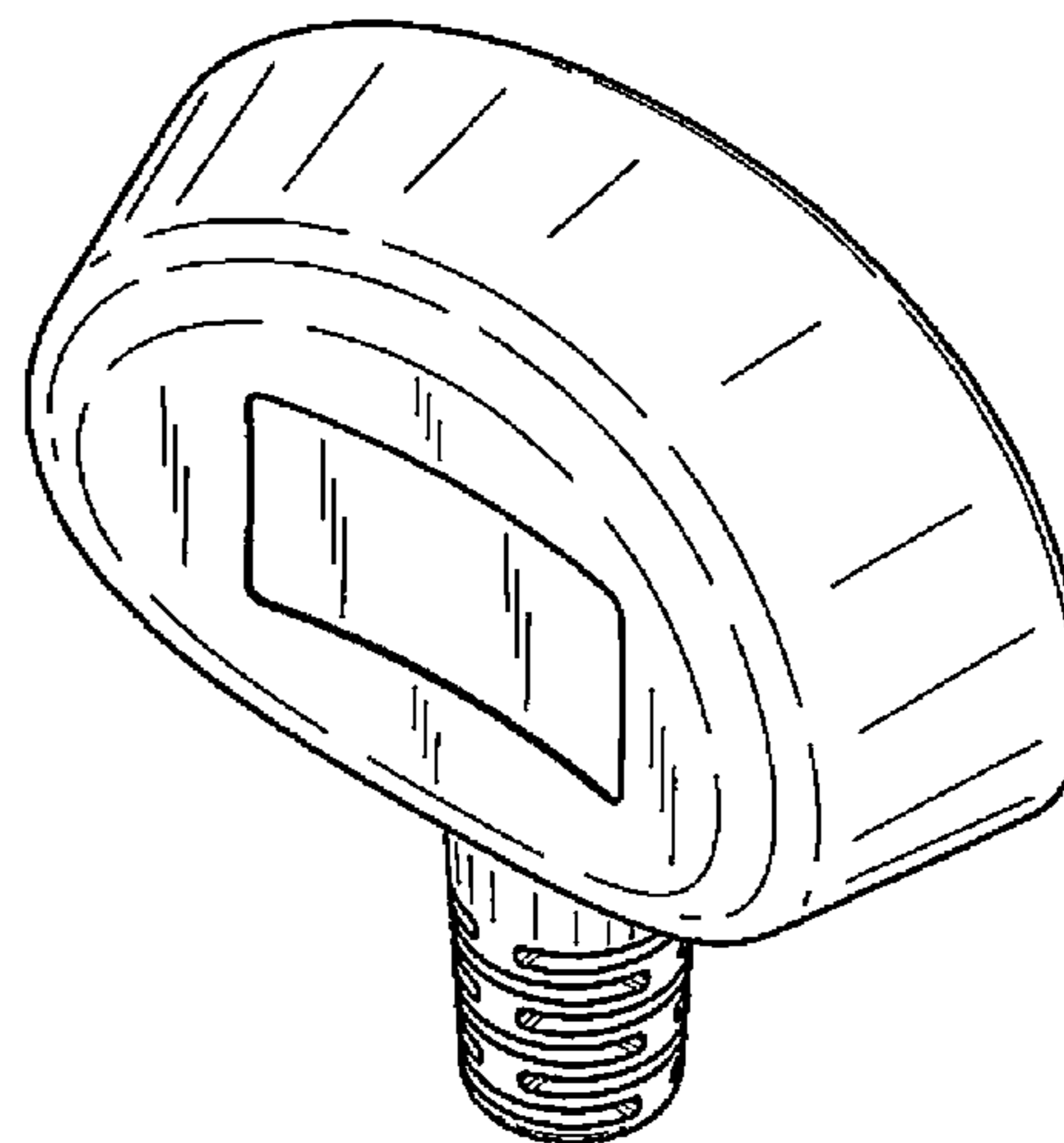
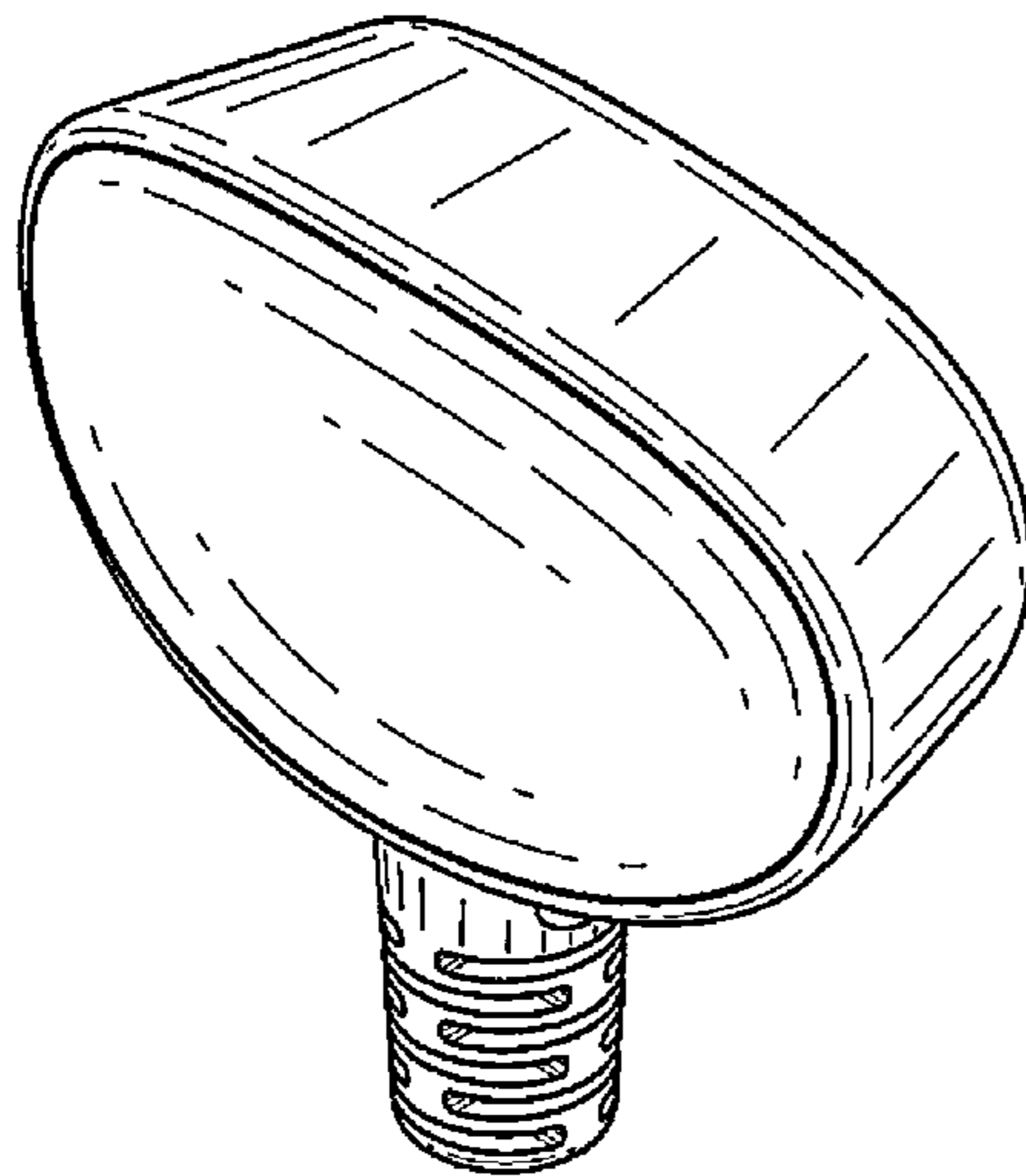
FIG. 6 is an elevational view of an opposing side of the skin brush charger.

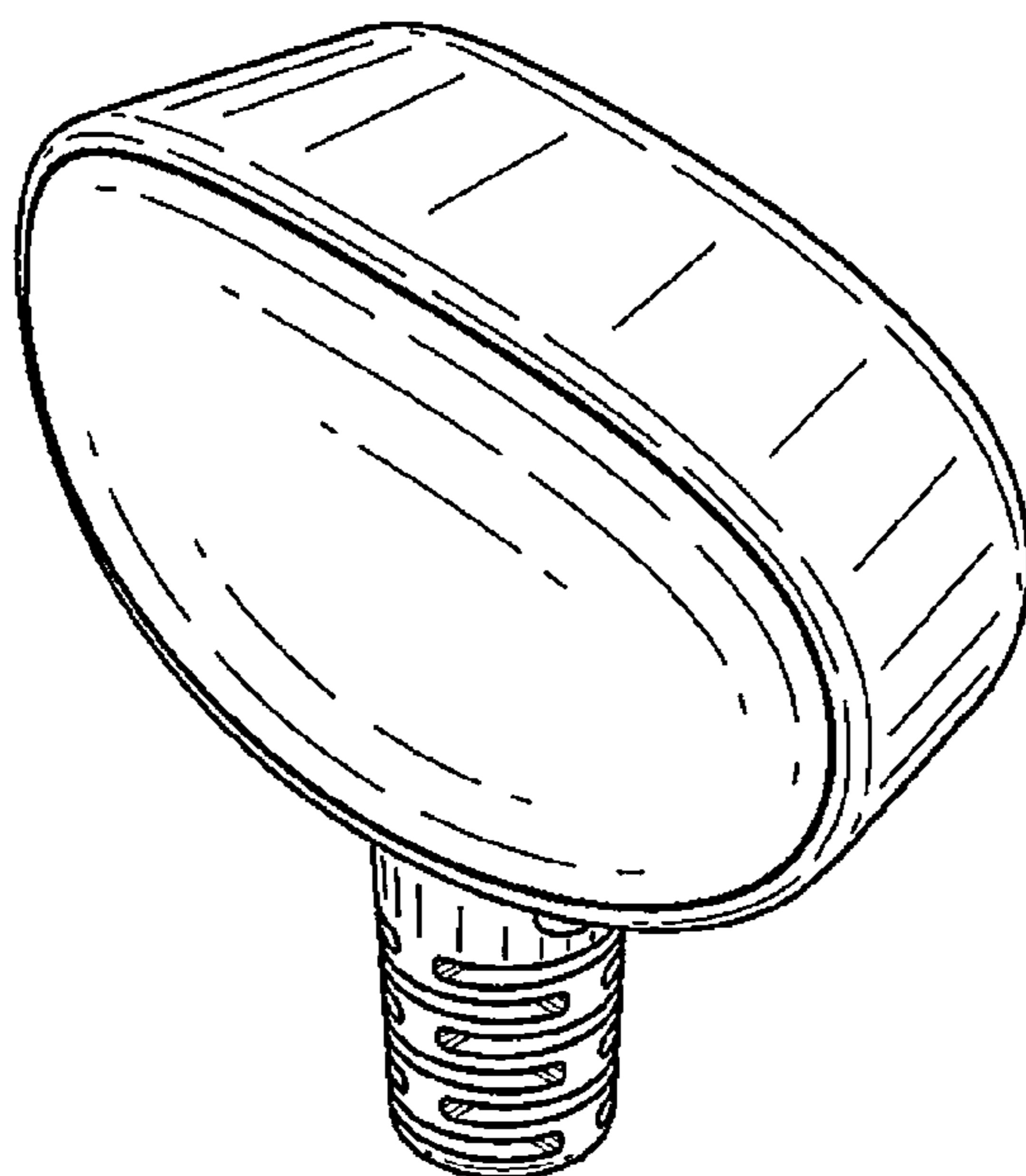

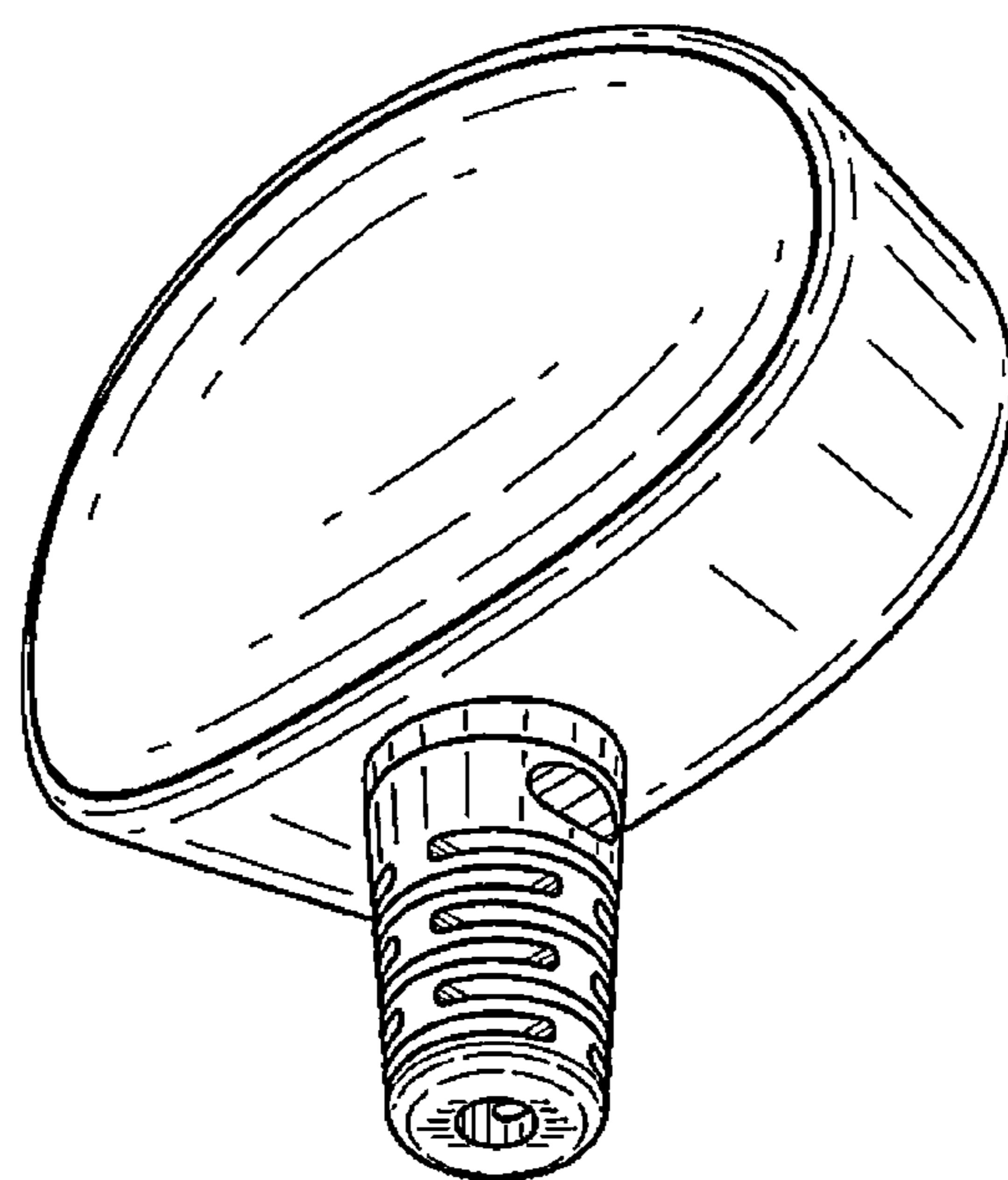

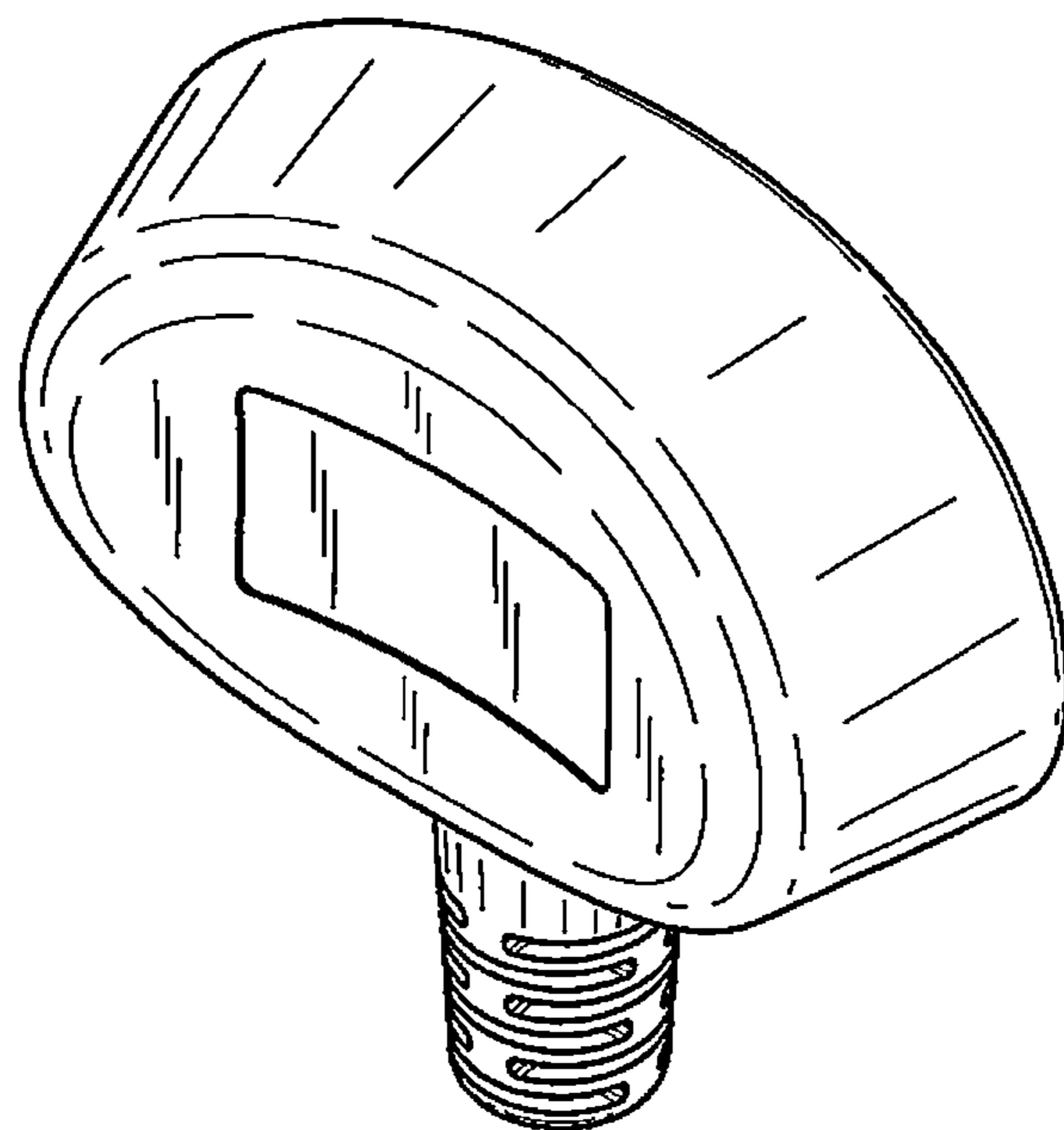

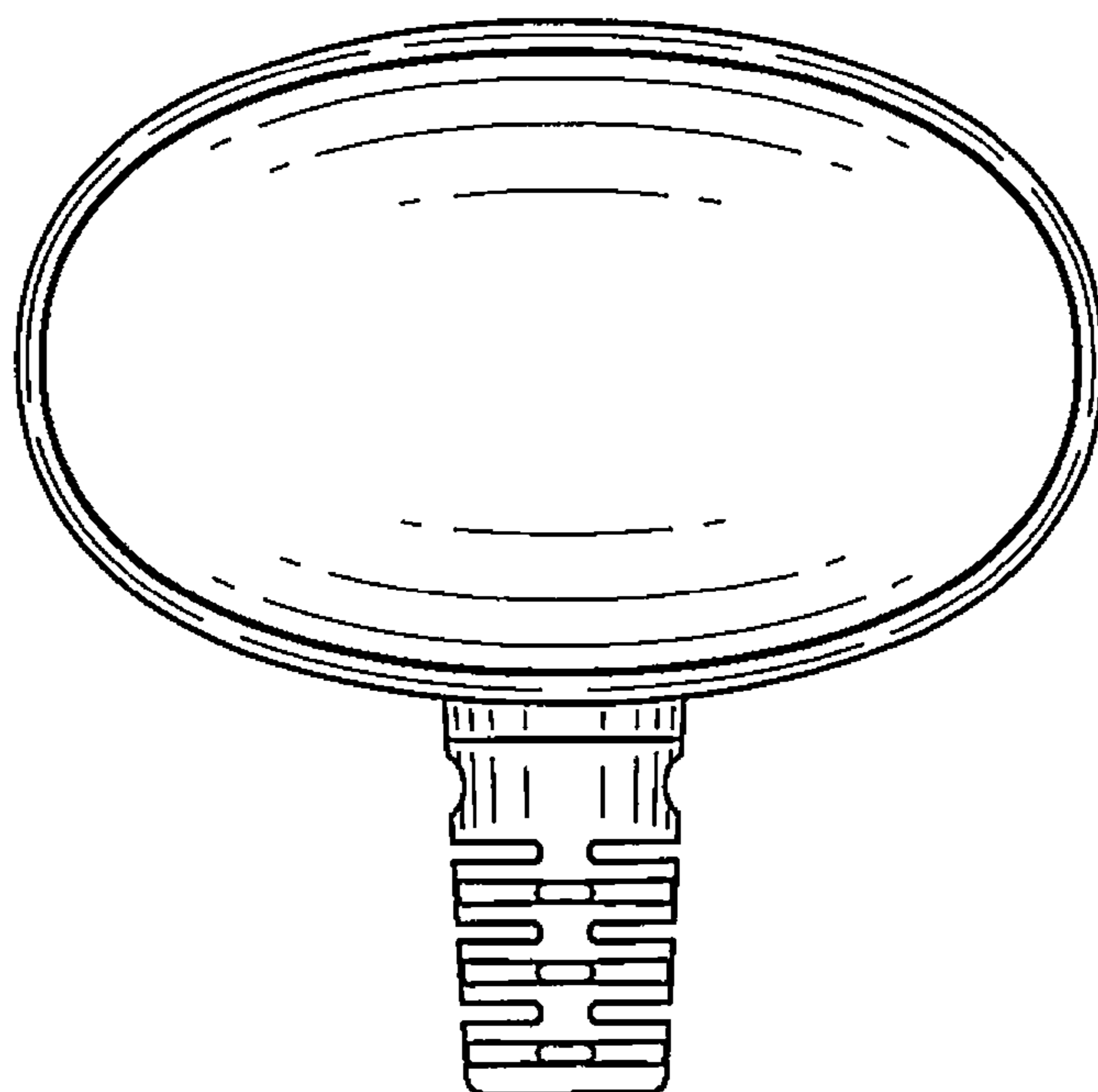

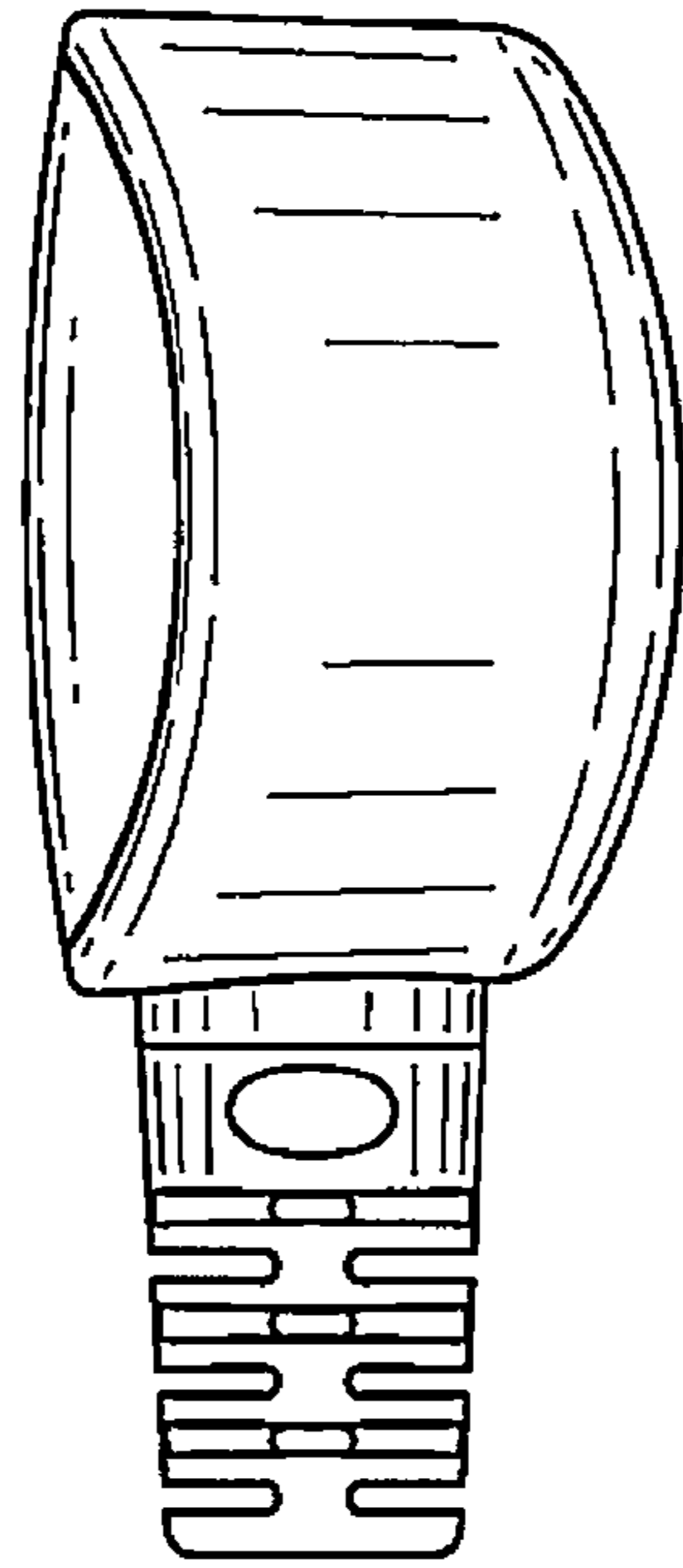

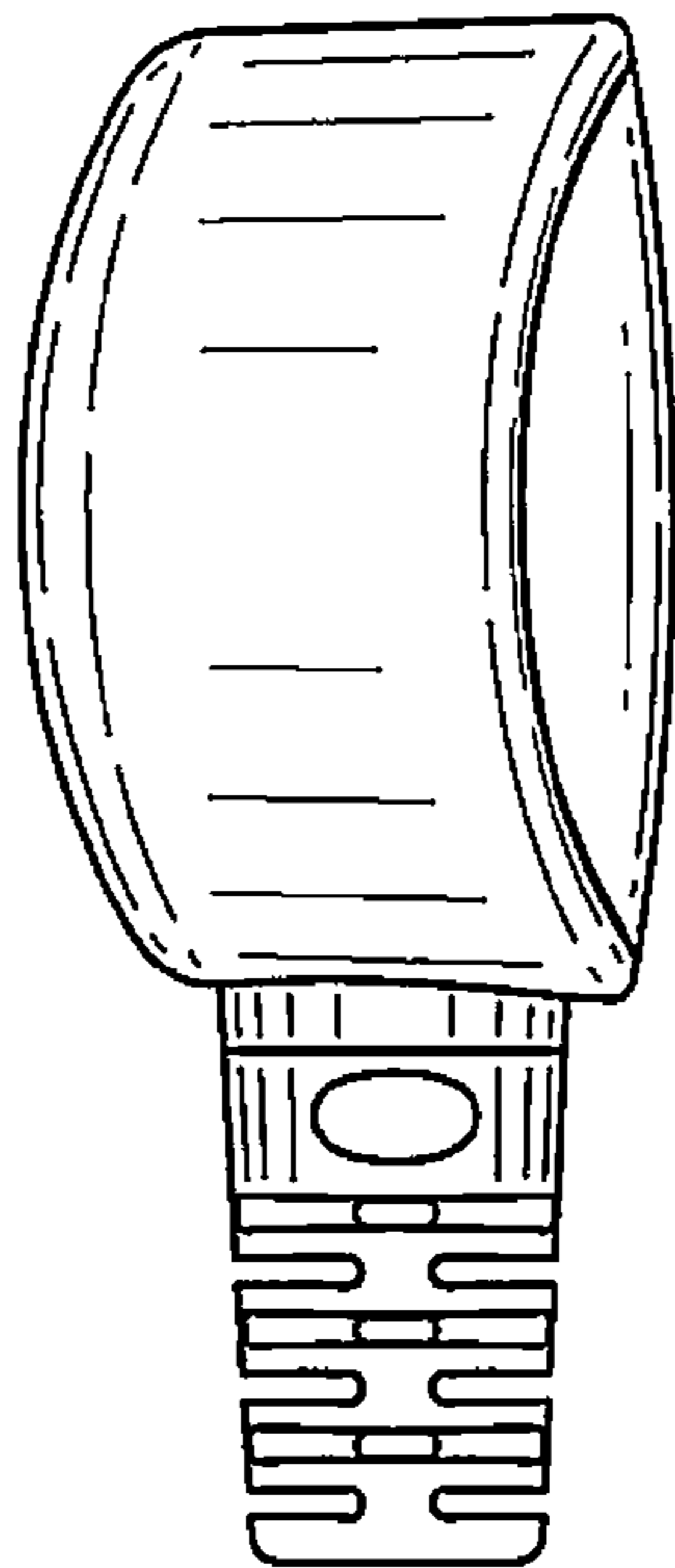

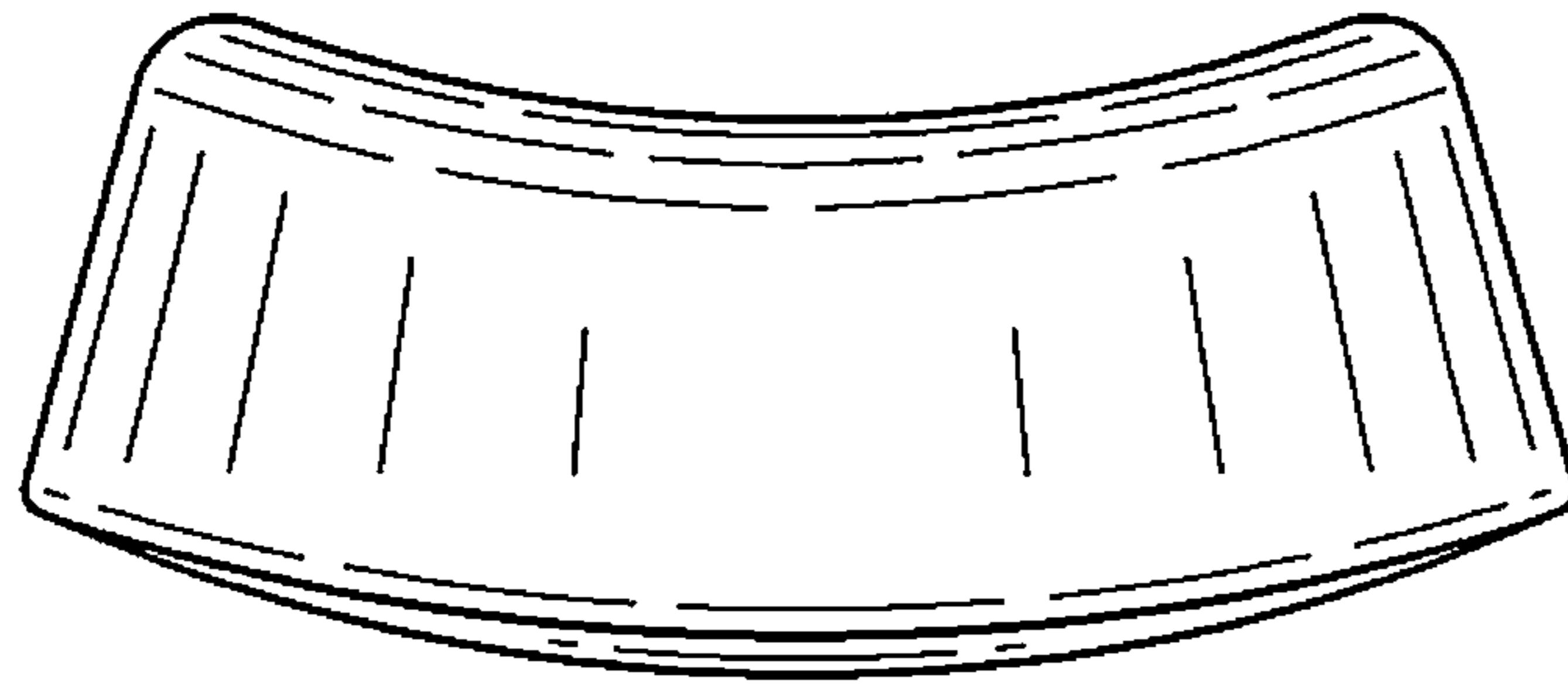

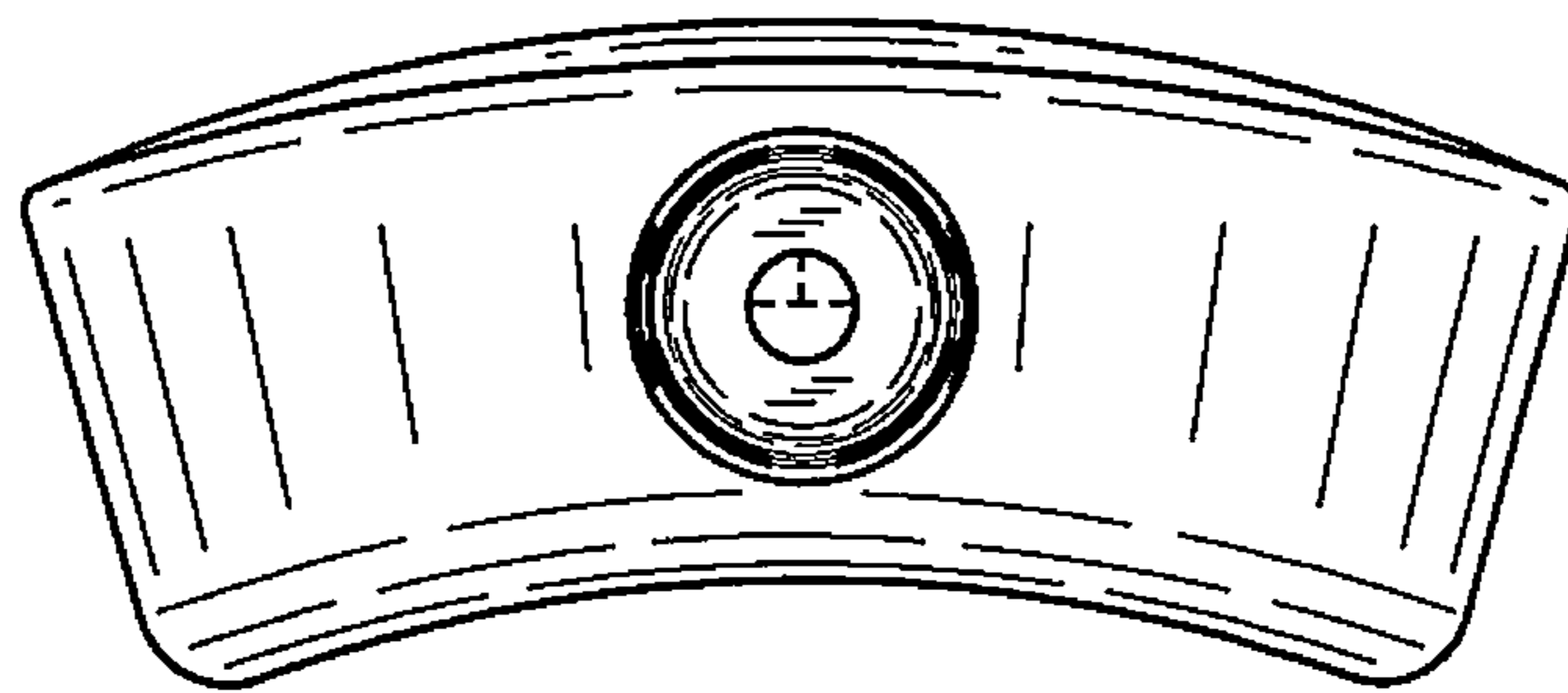
