(57) **CLAIM**

The ornamental design for a metal transaction card, as shown and described.

FIG. 1 depicts a front elevation view of embodiment of a metal transaction card, the metal transaction card having a carbon fiber inlay as shown.

FIG. 17 depicts a top plan view of the metal transaction card of FIG. 13, the bottom plan view being the mirror image thereof.

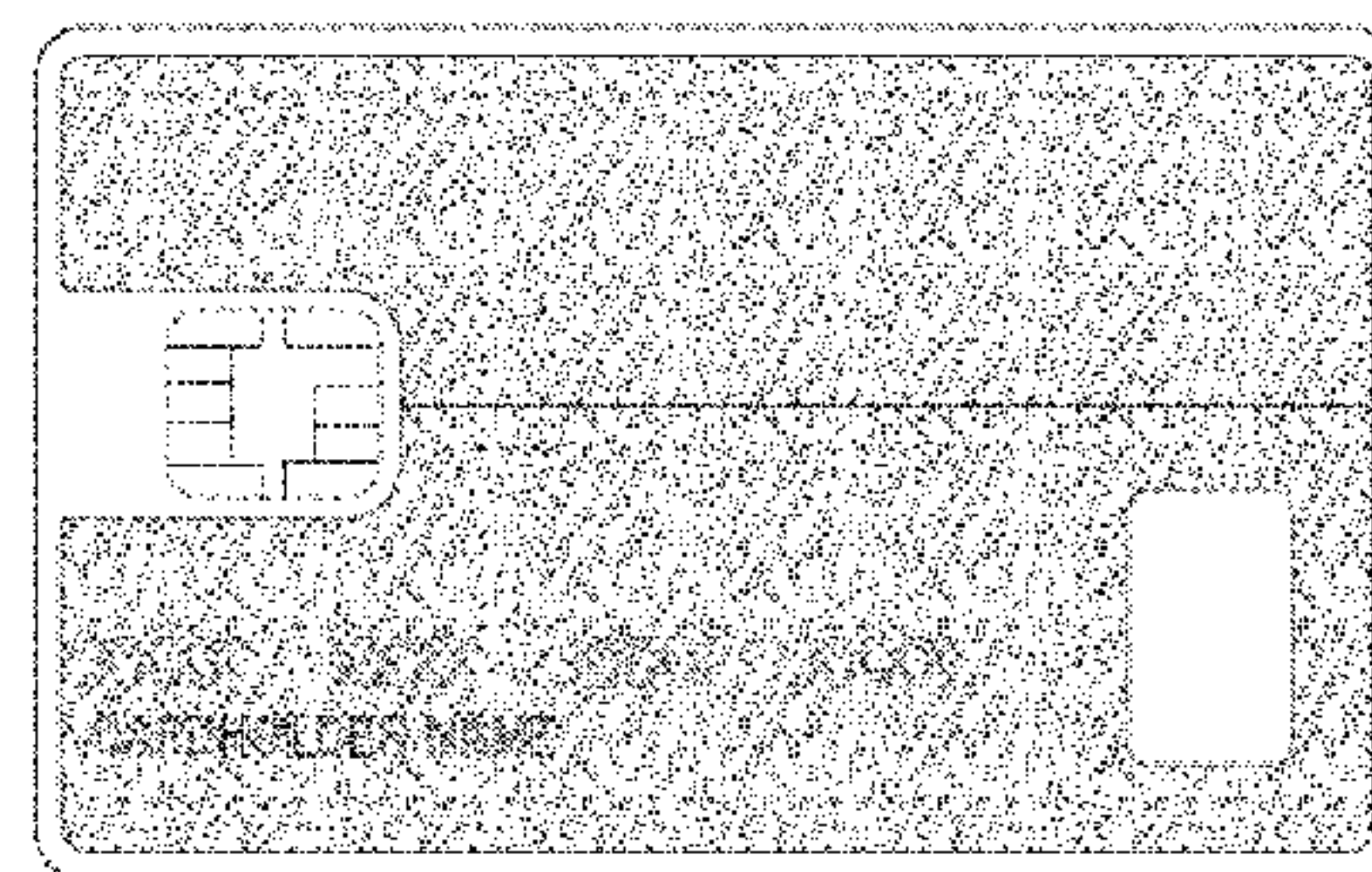
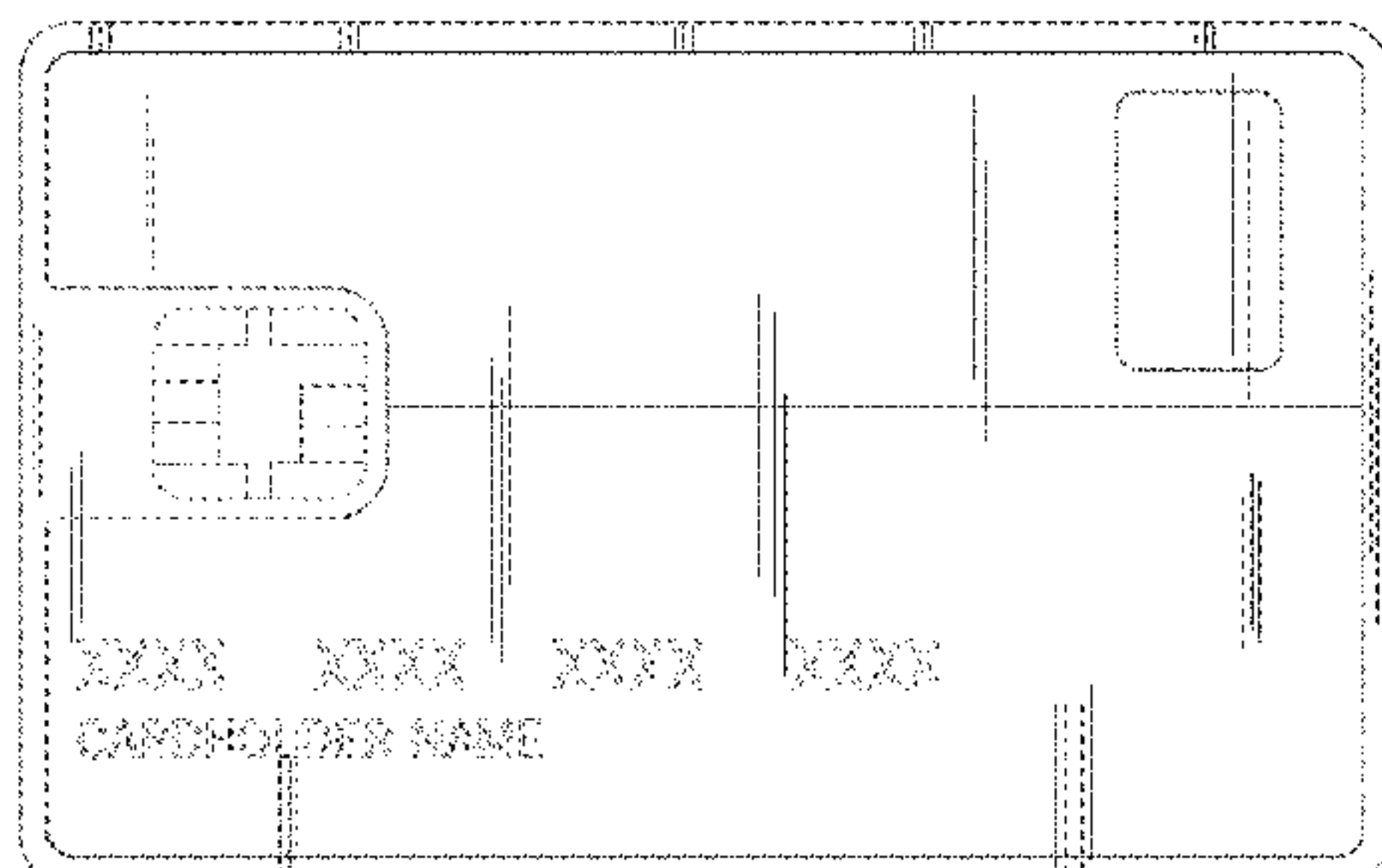


FIG. 71 depicts a top plan view of the metal transaction card of FIG. 67, the bottom plan view being the mirror image thereof.

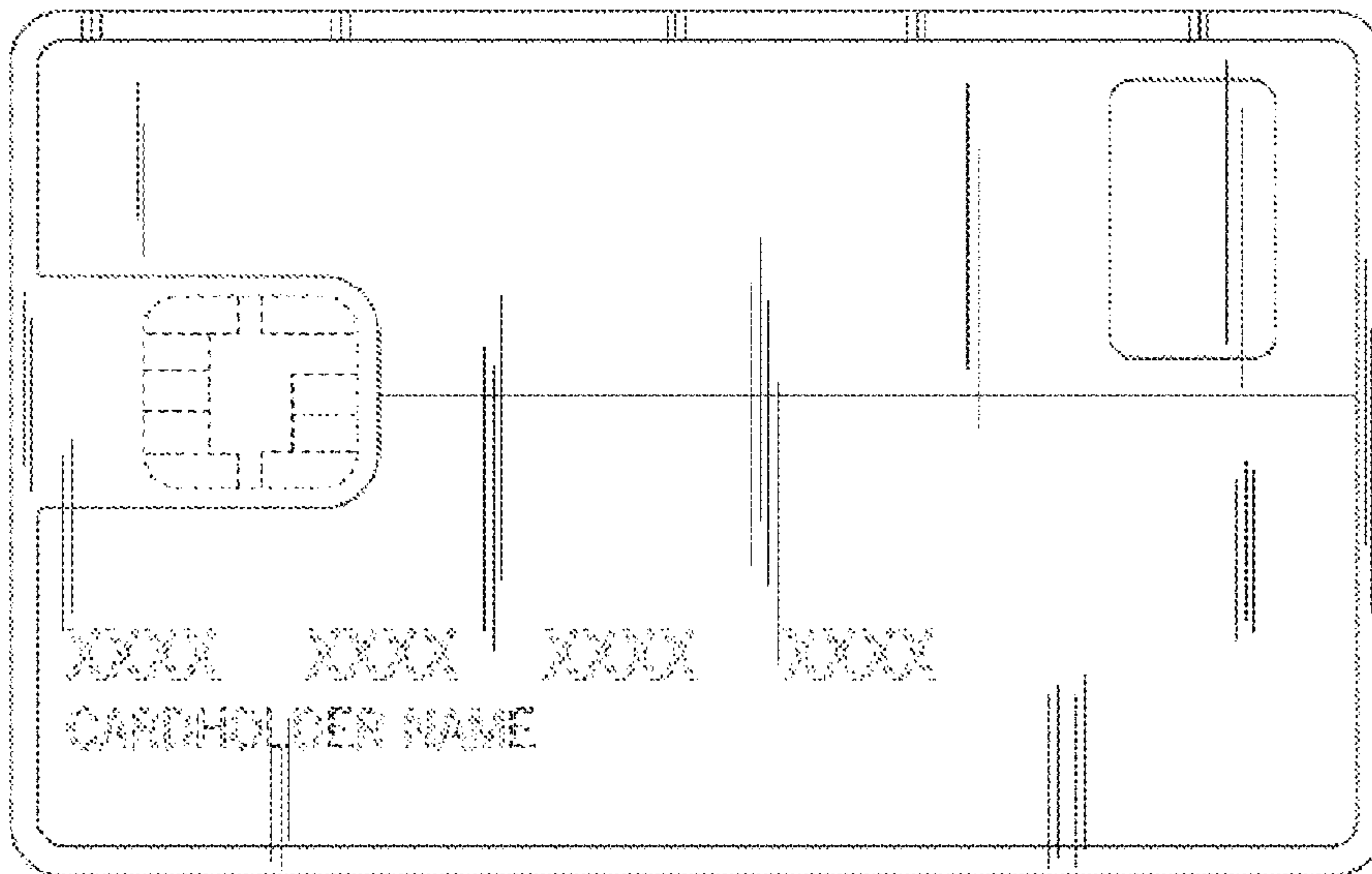

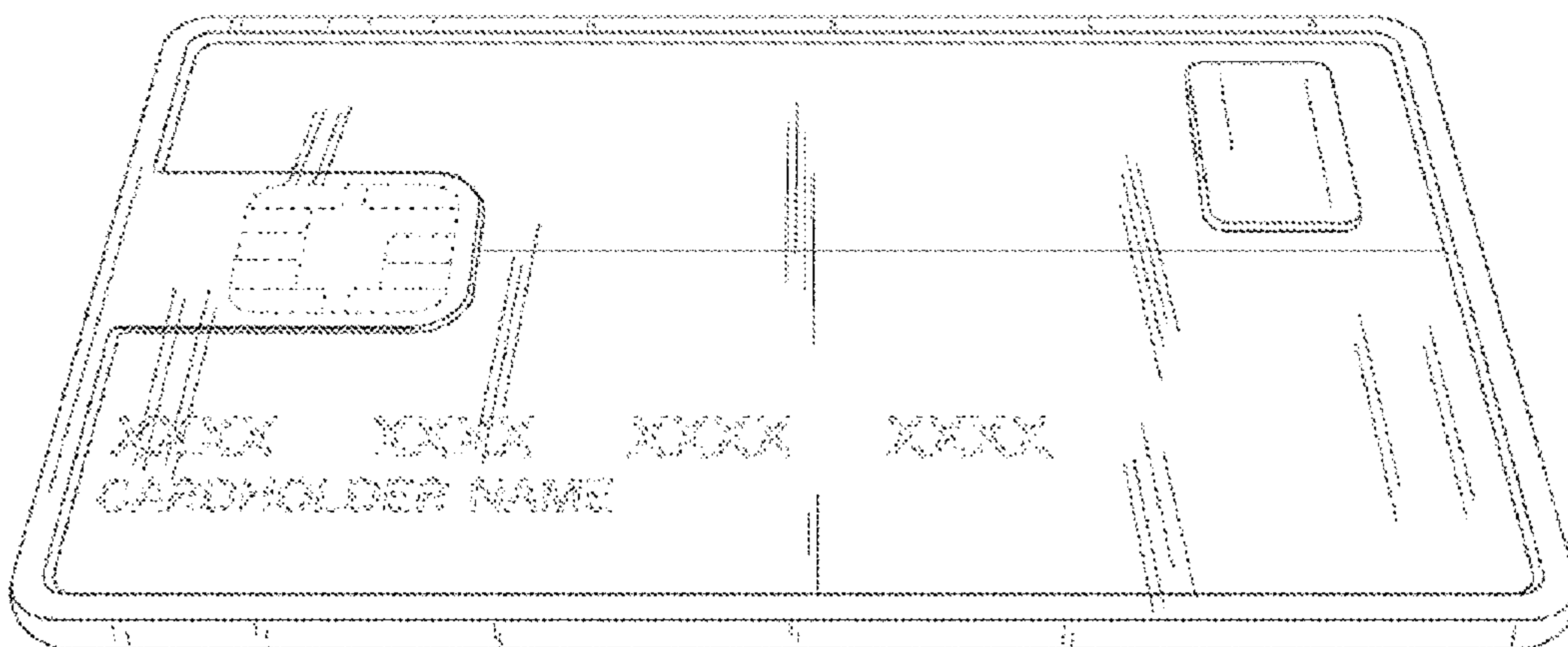

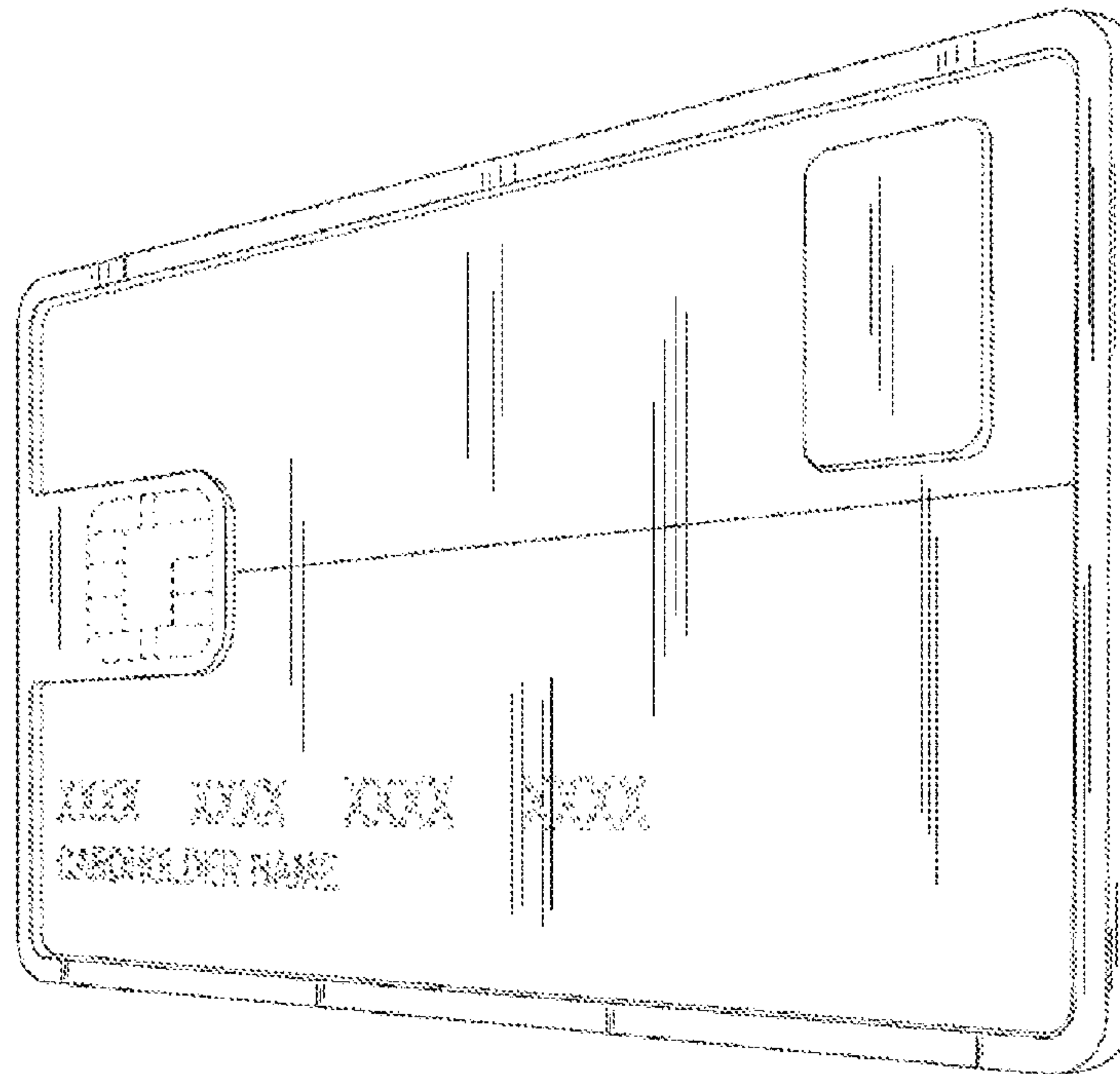

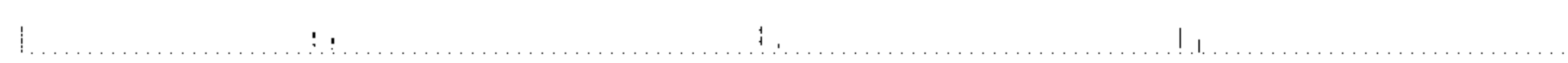

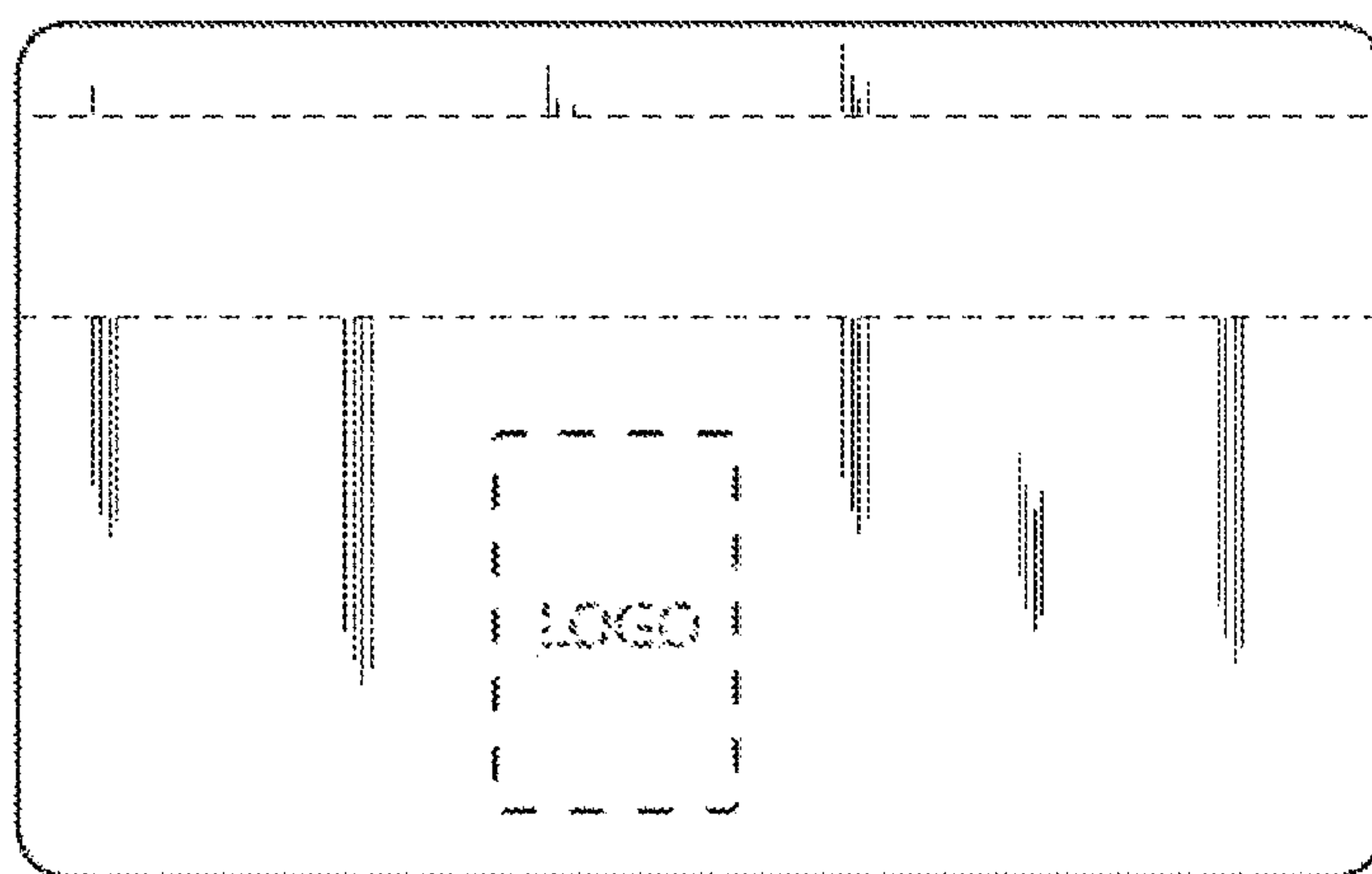

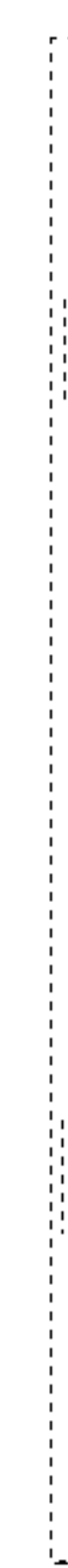

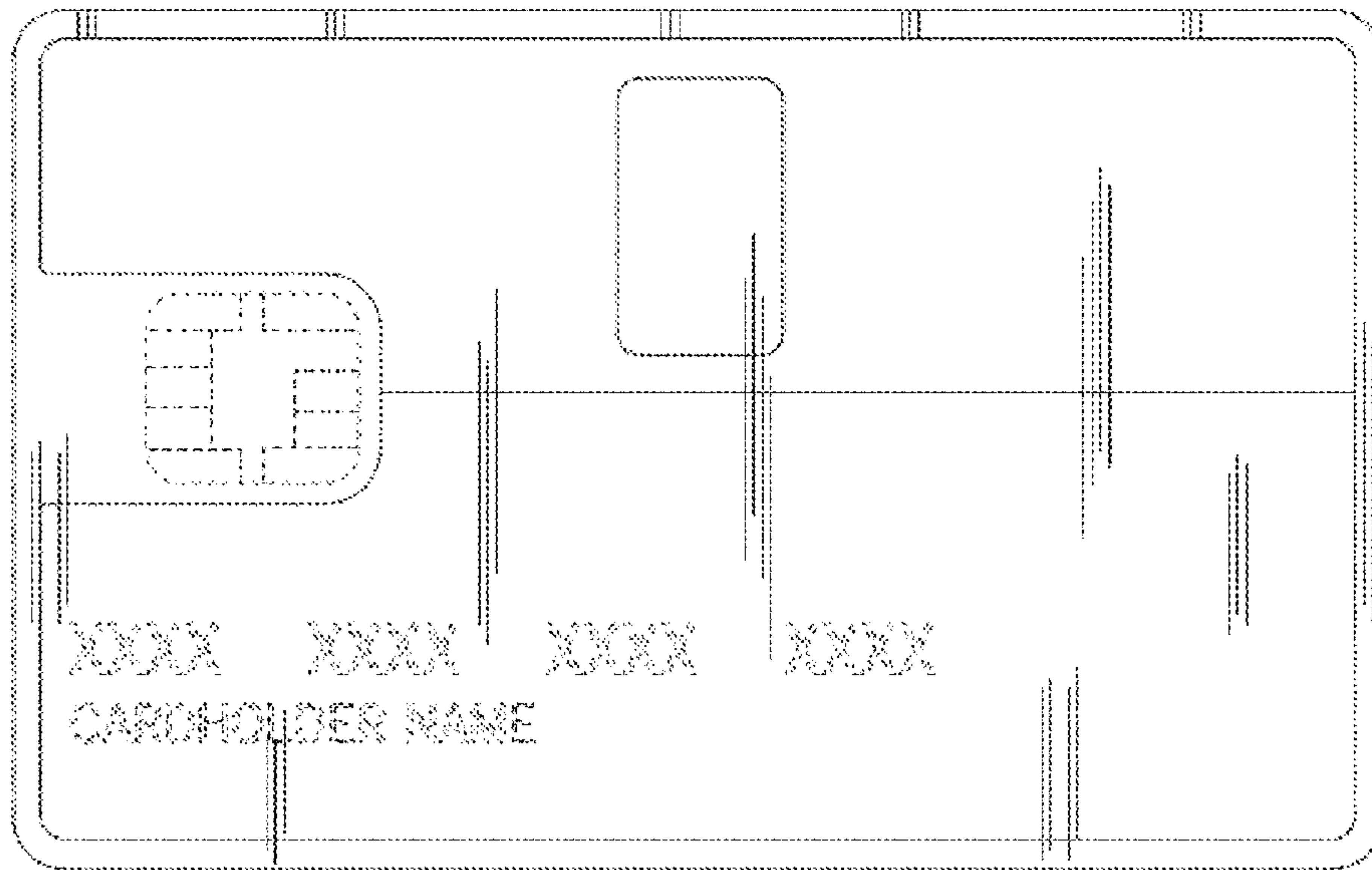

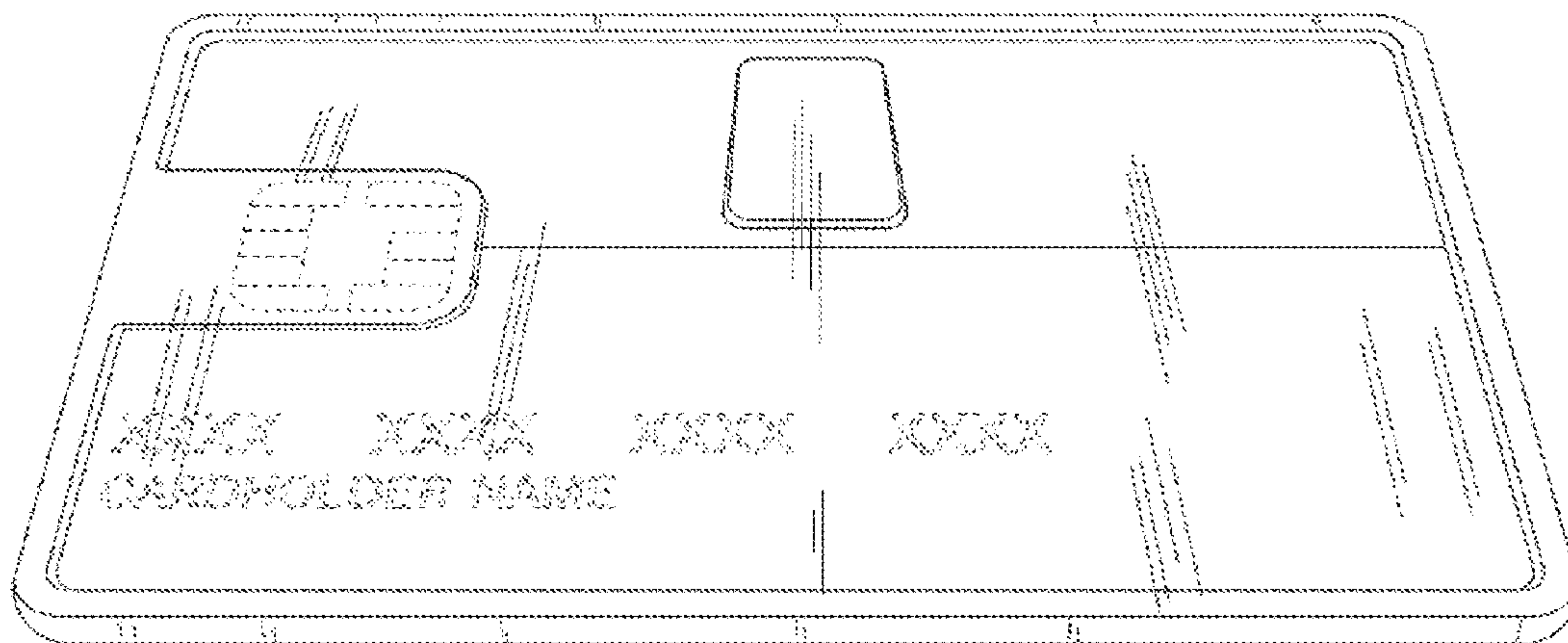

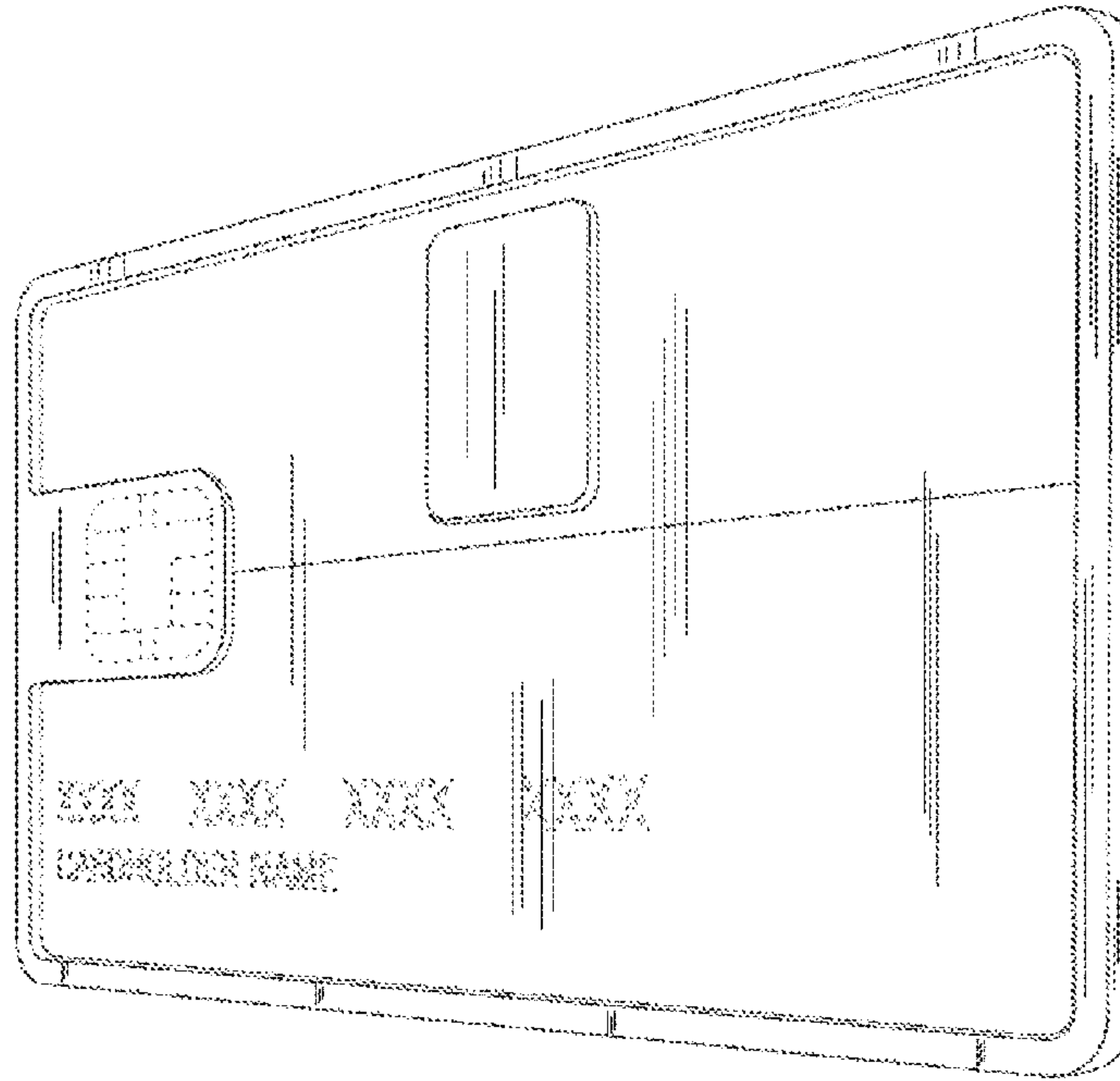

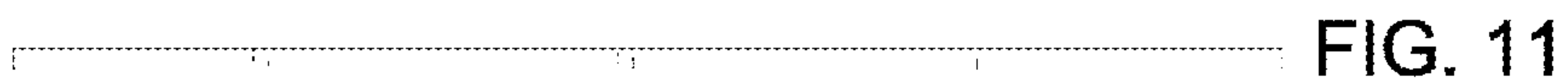

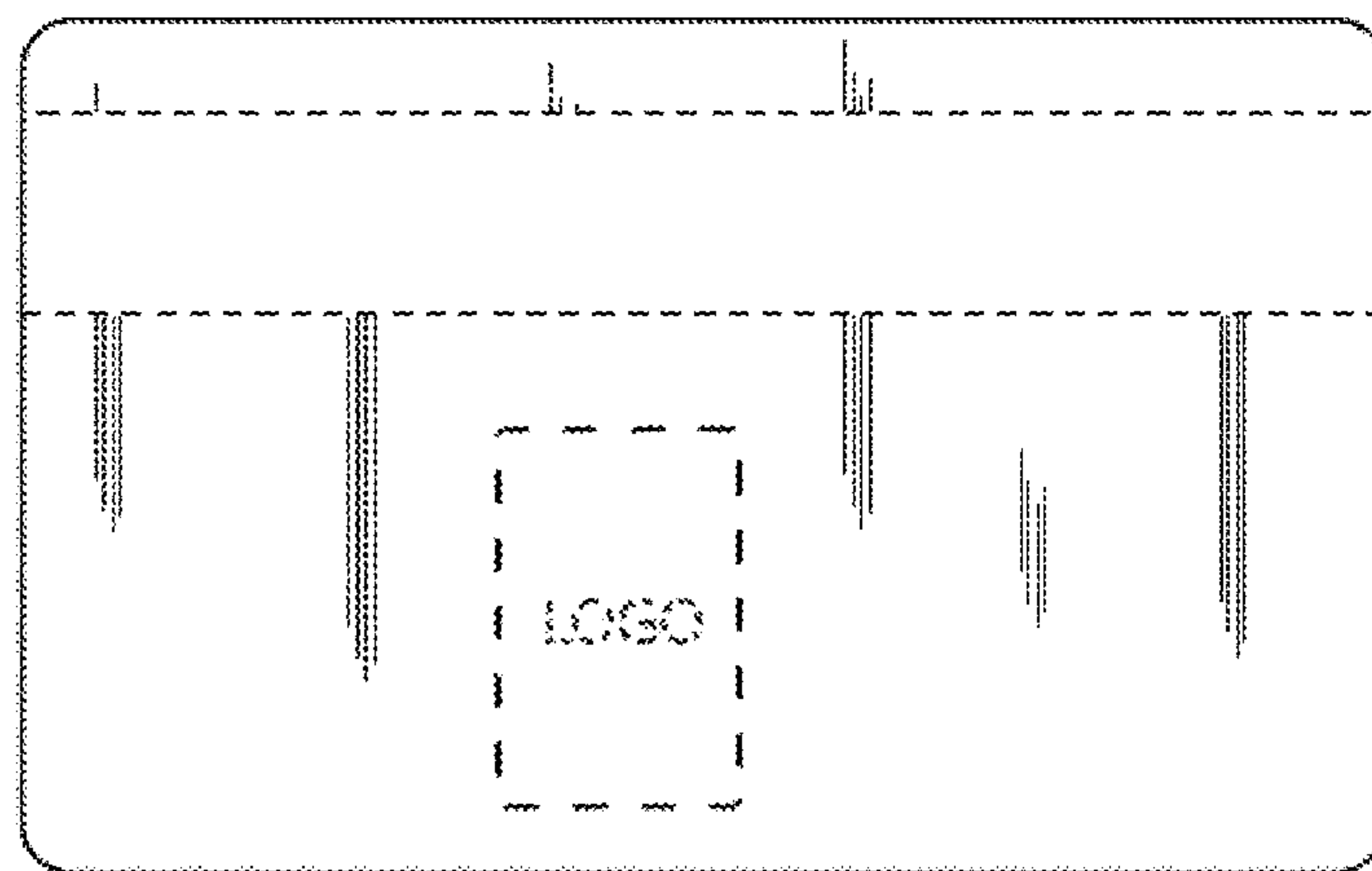

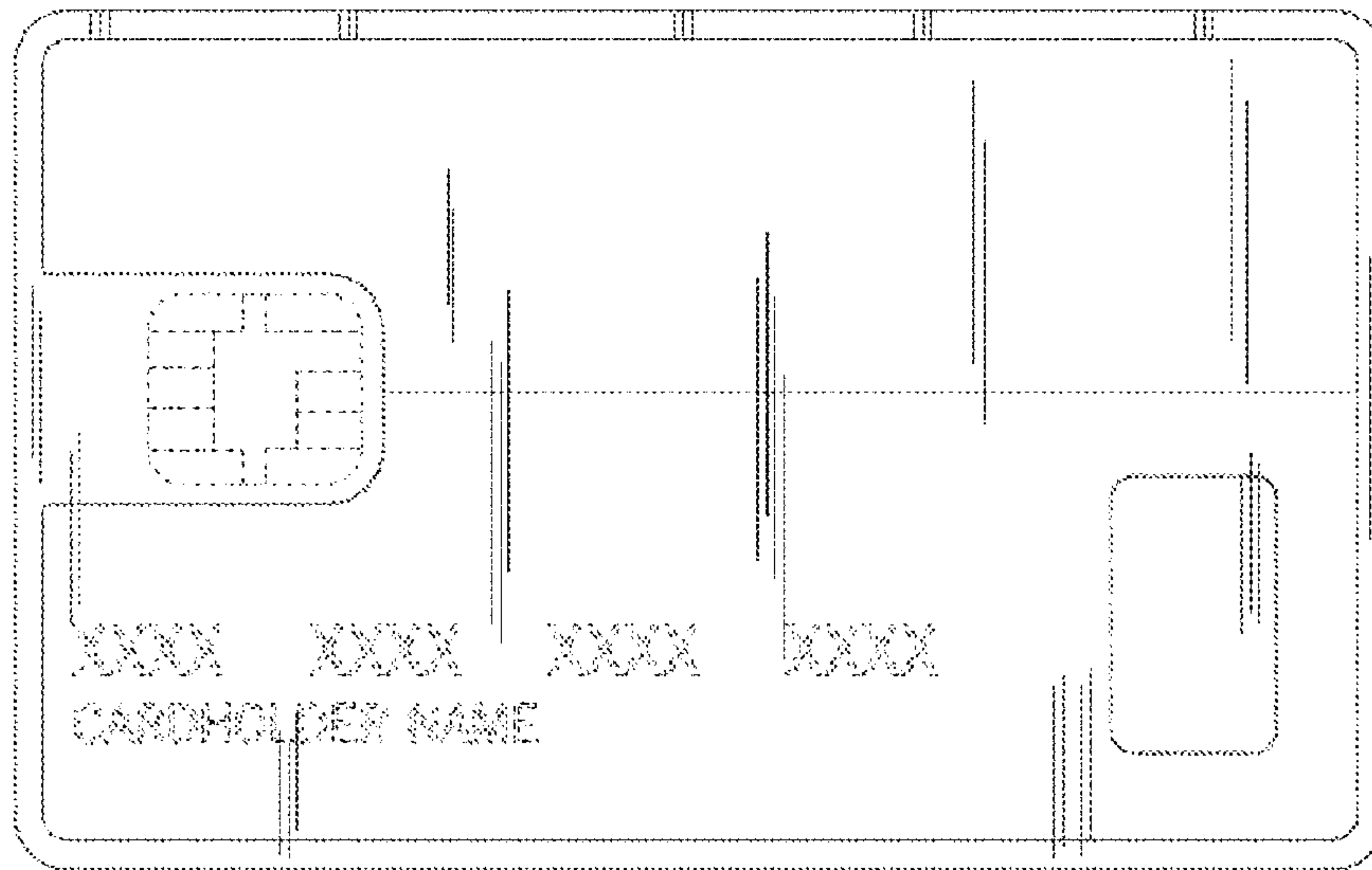

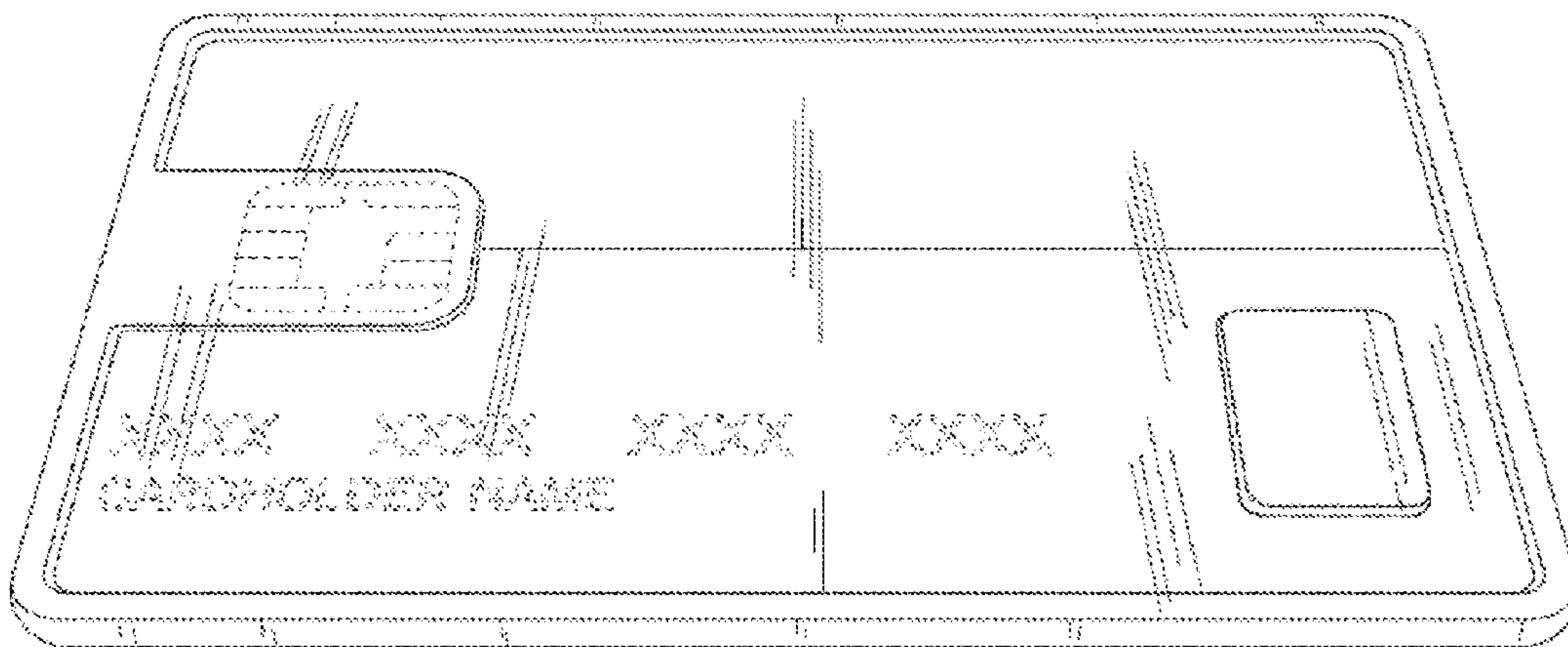

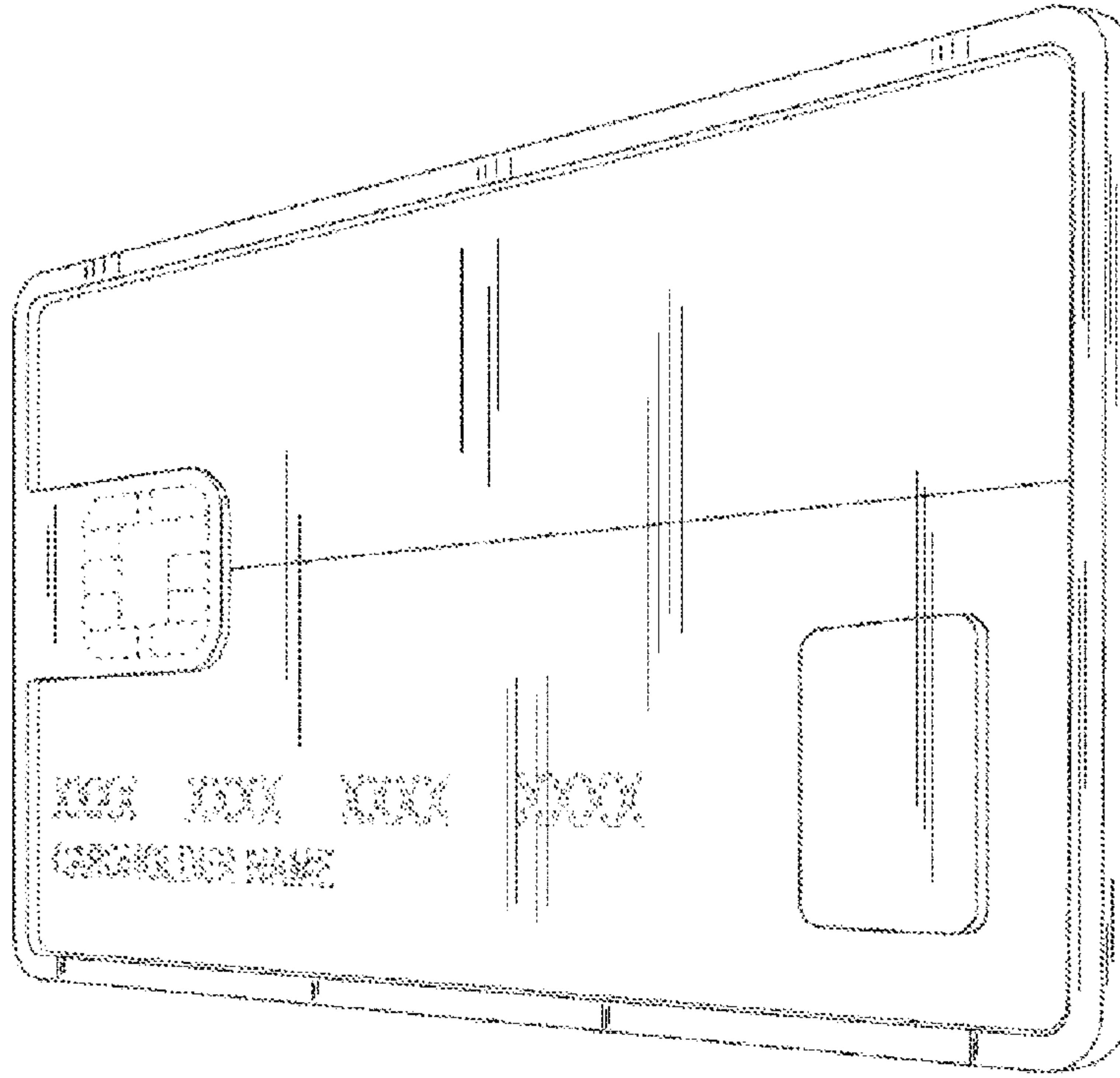

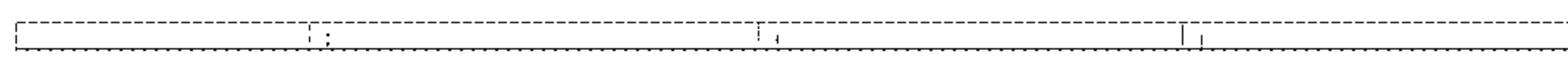

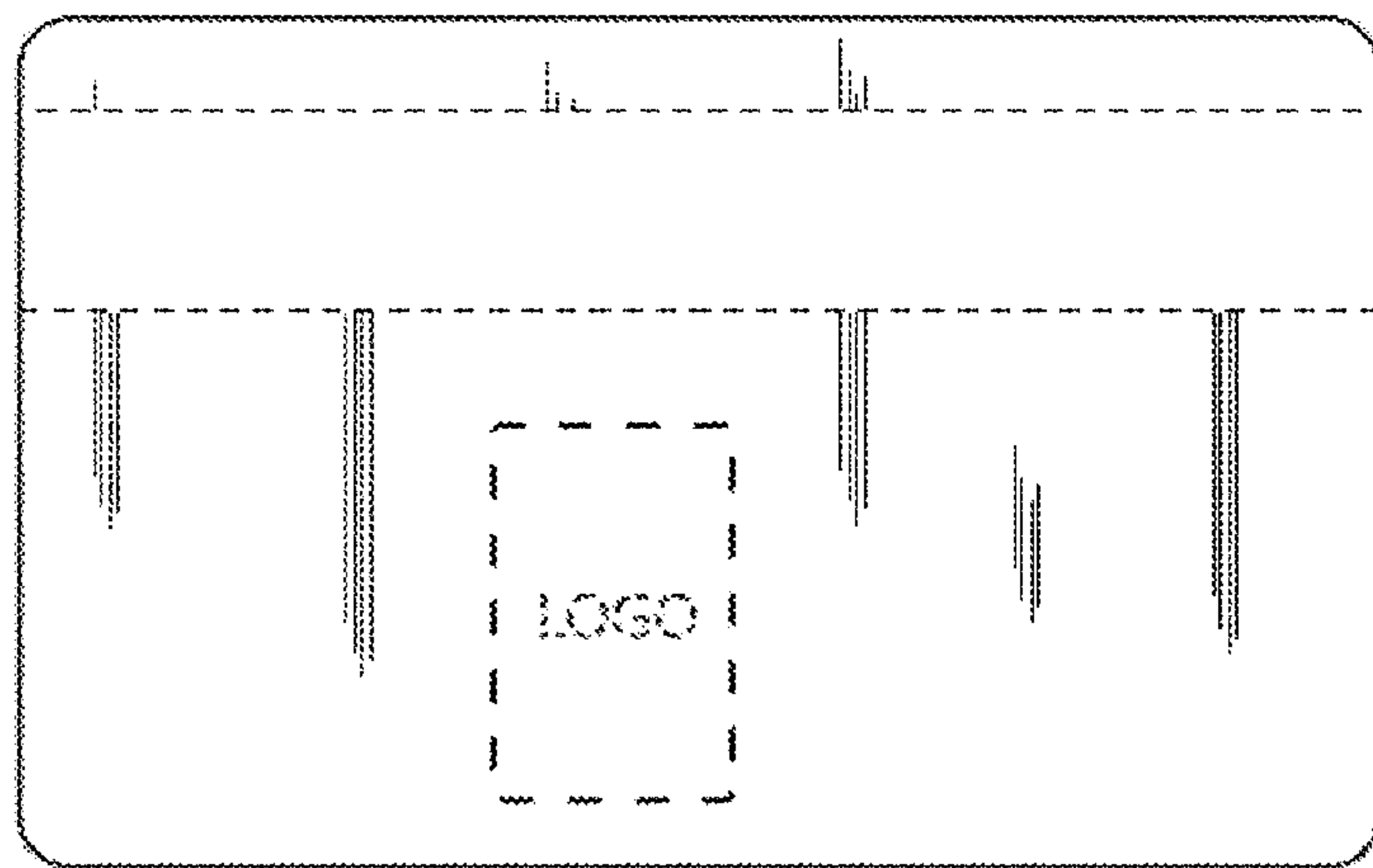

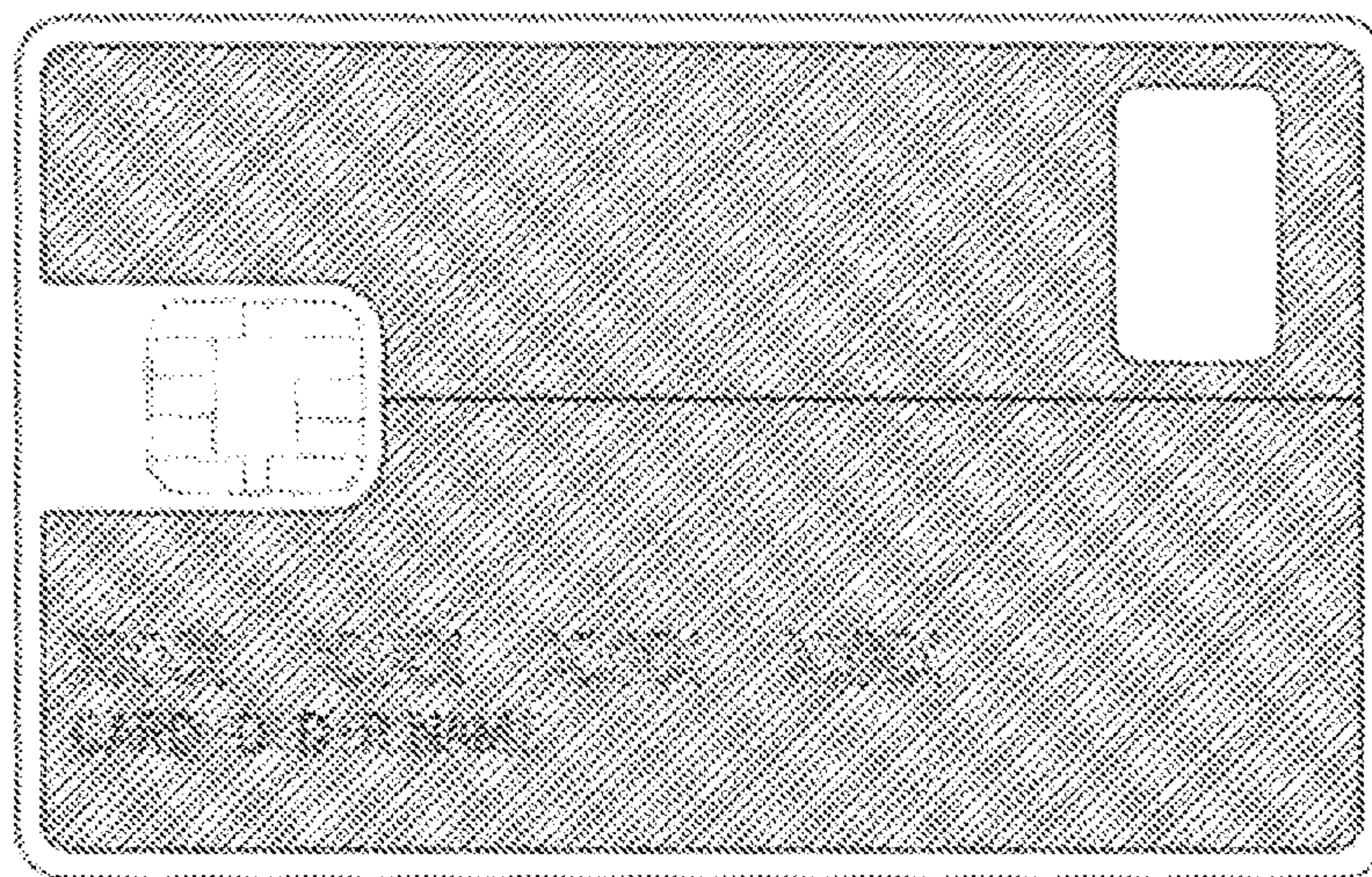

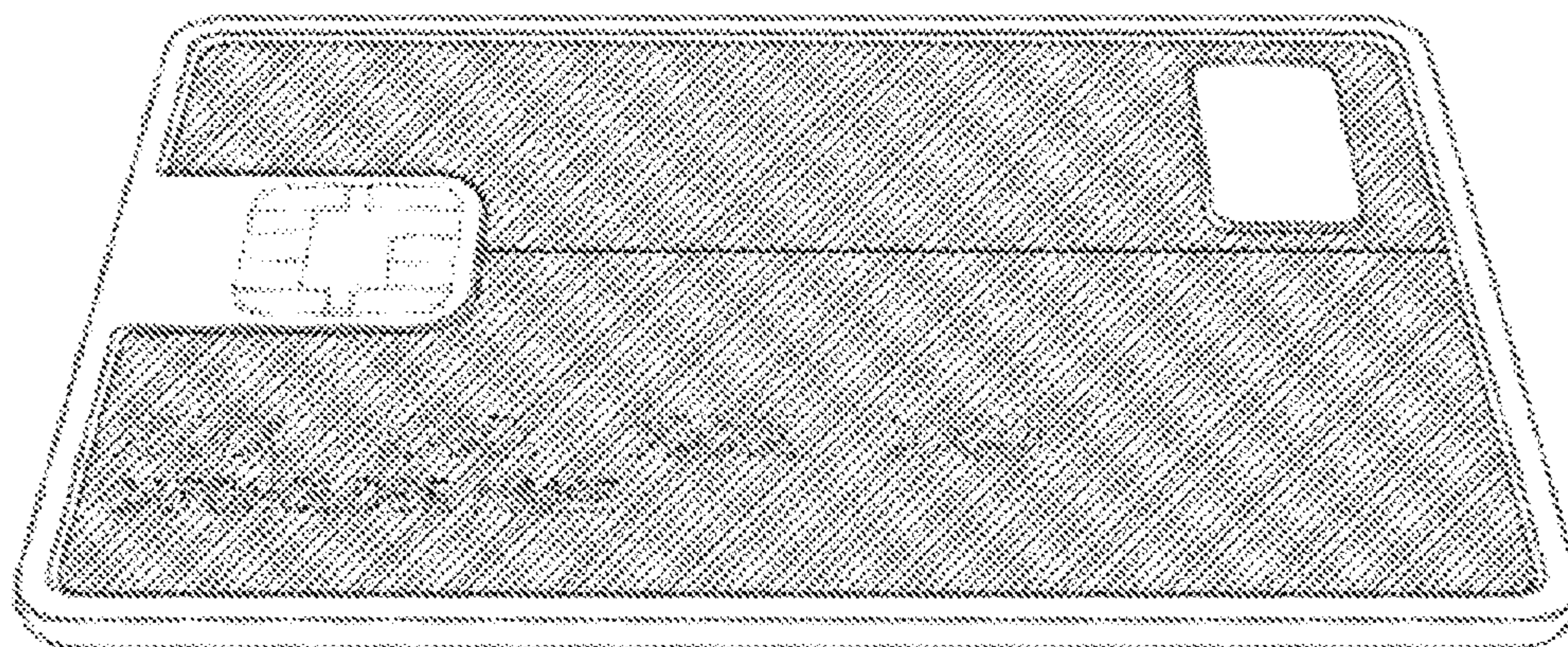

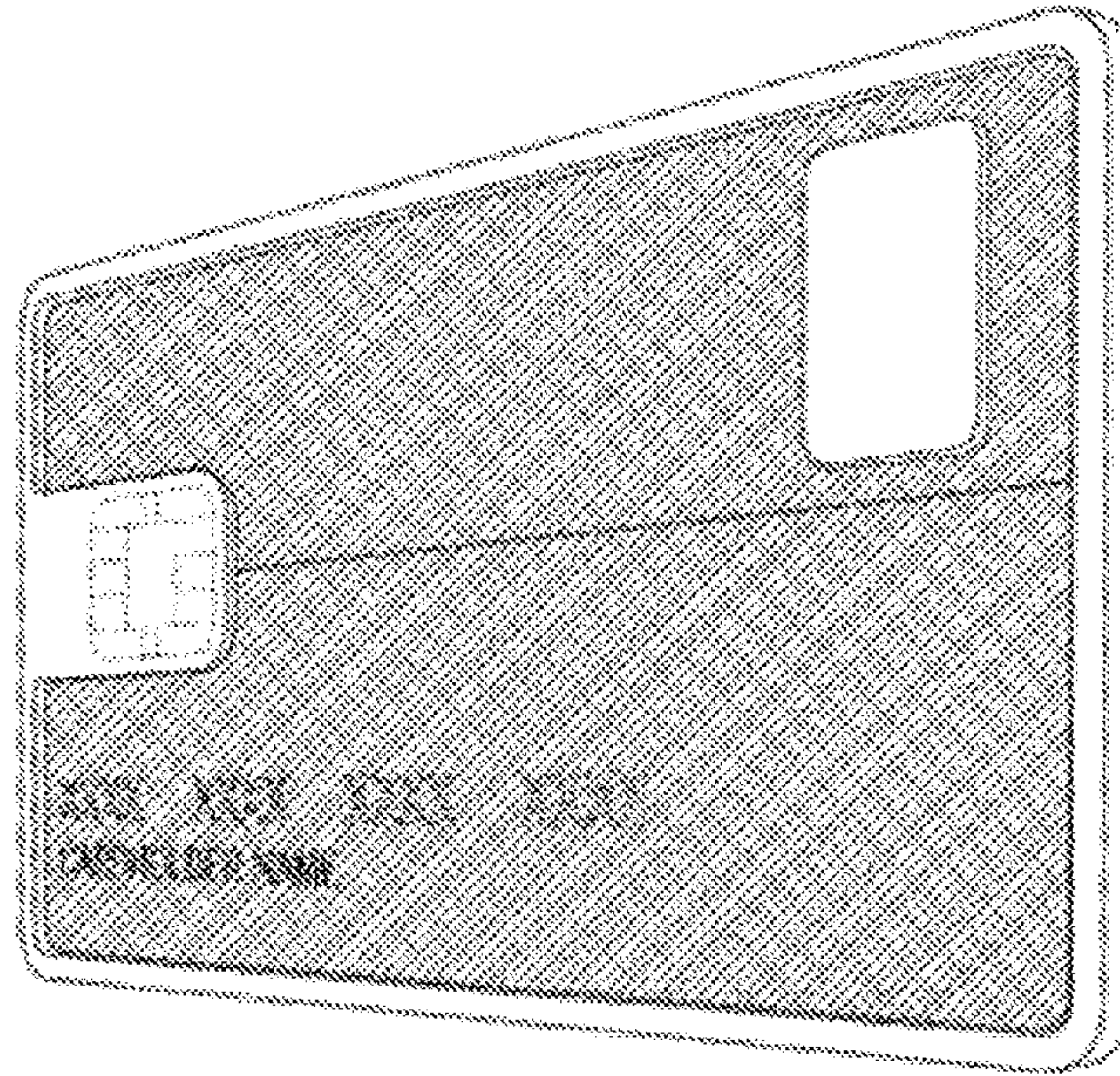

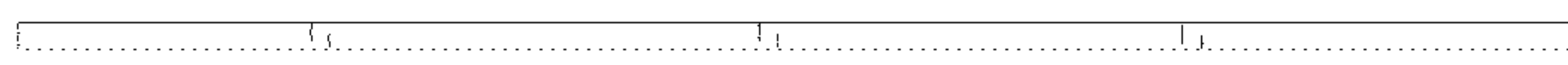

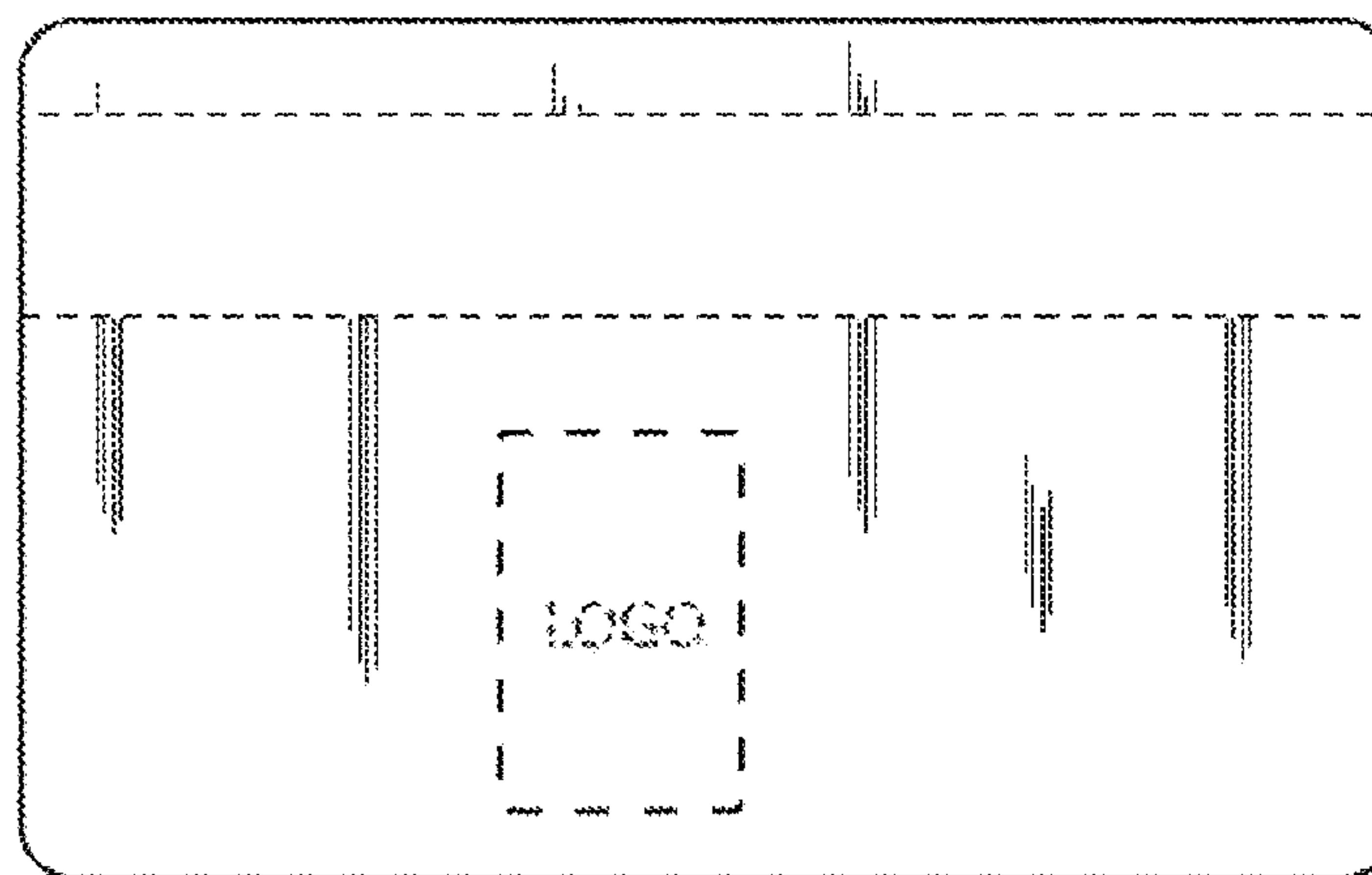

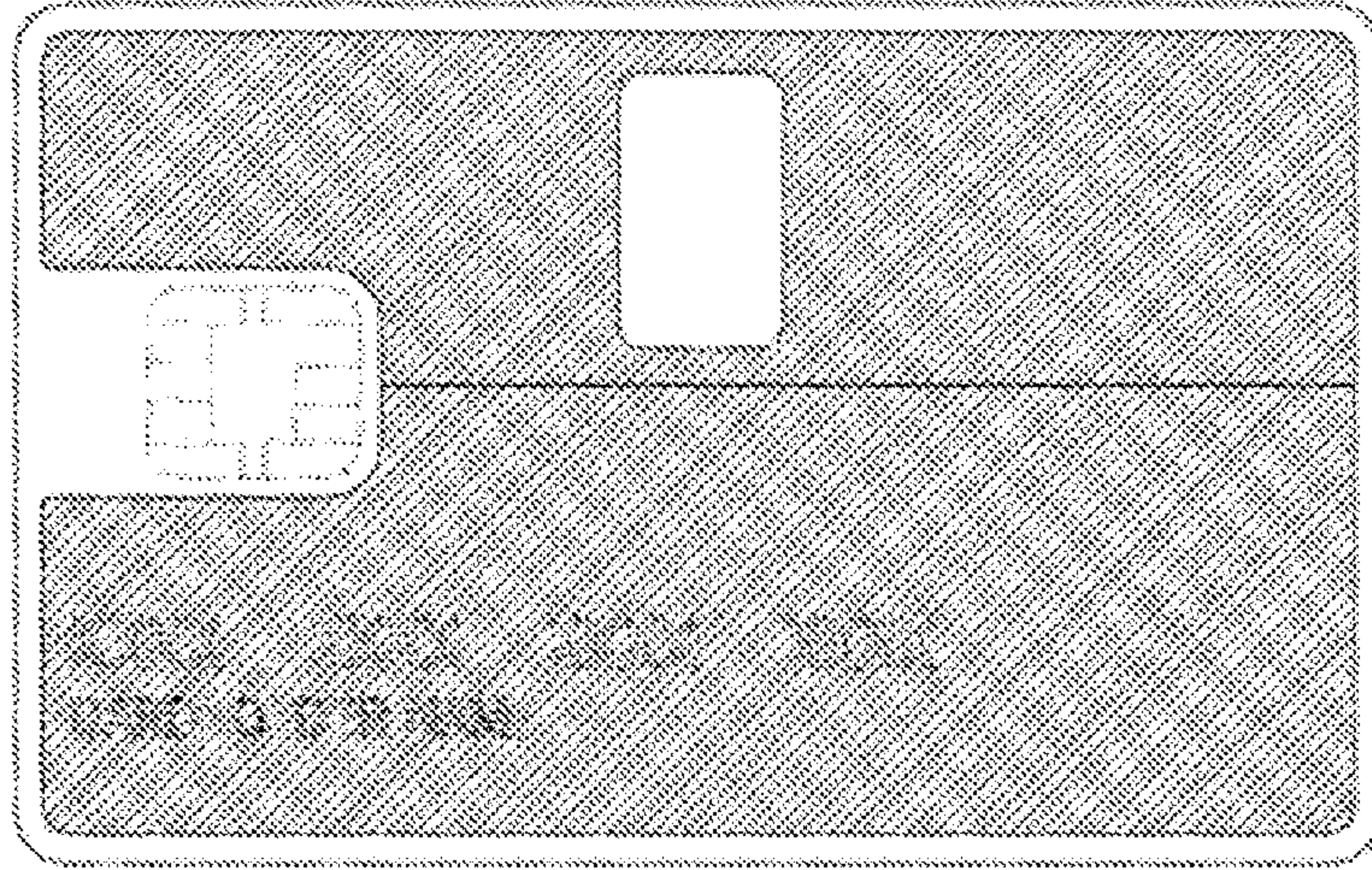

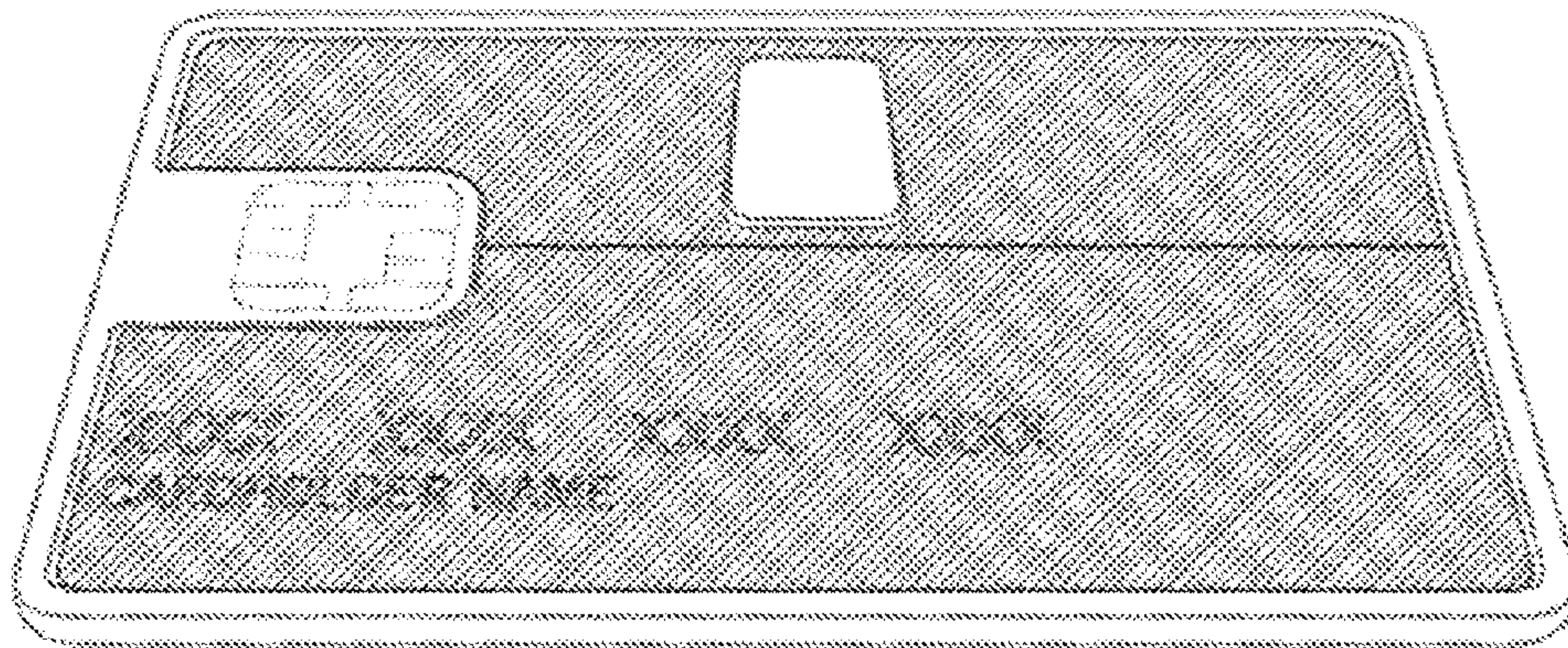

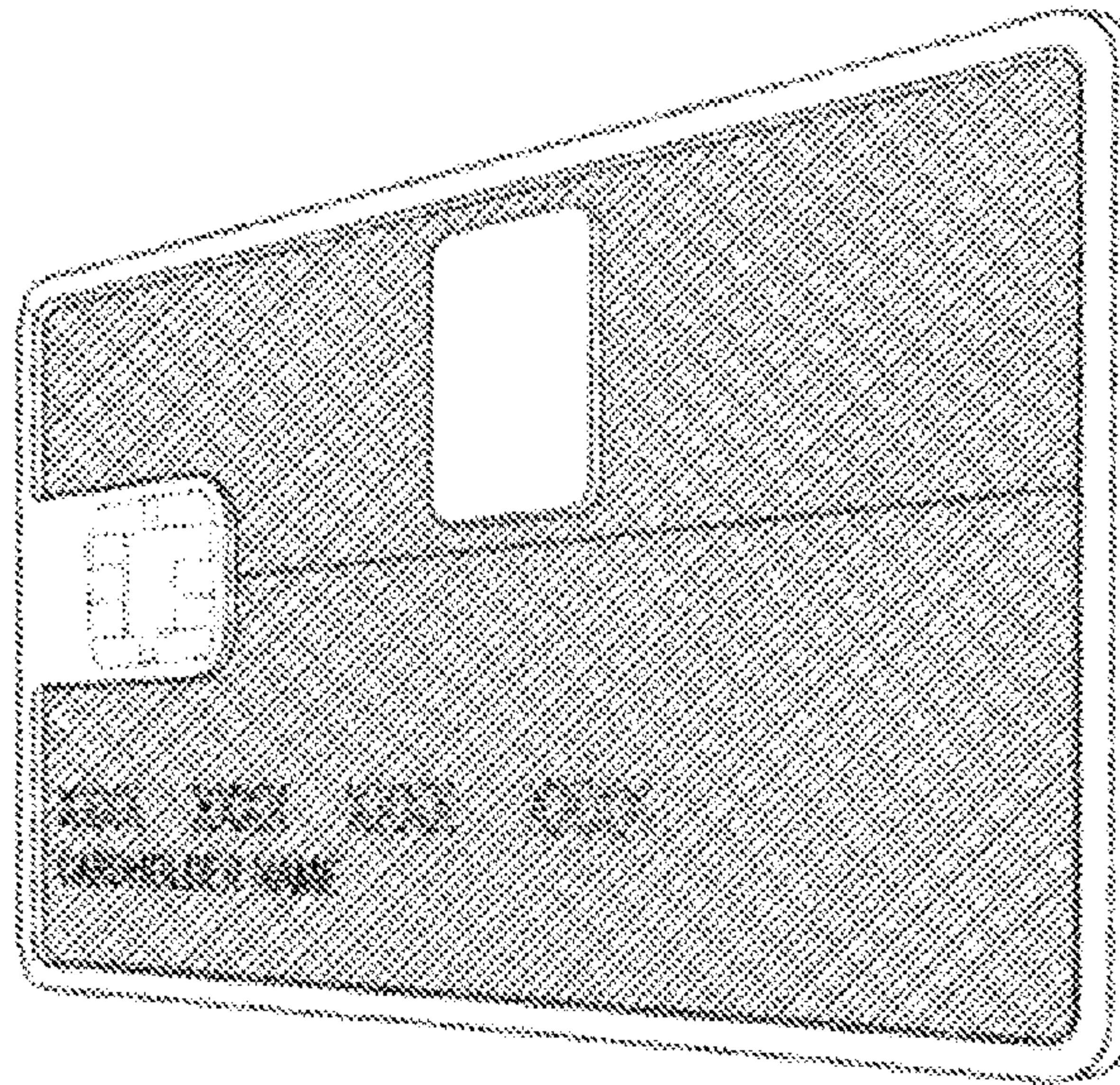

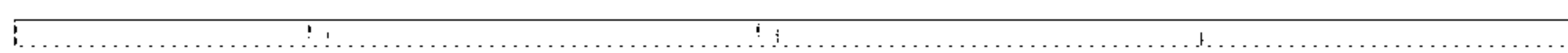

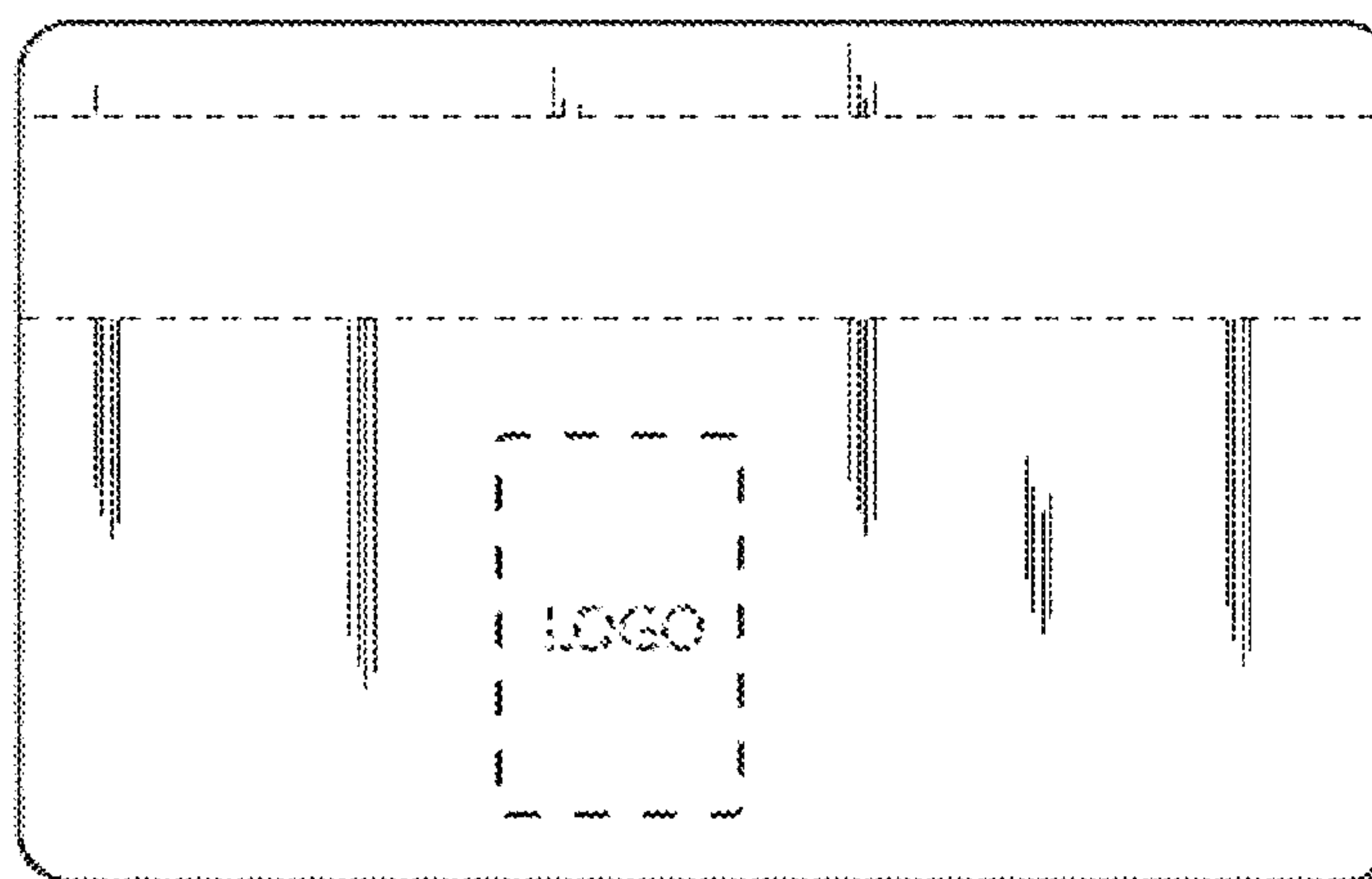

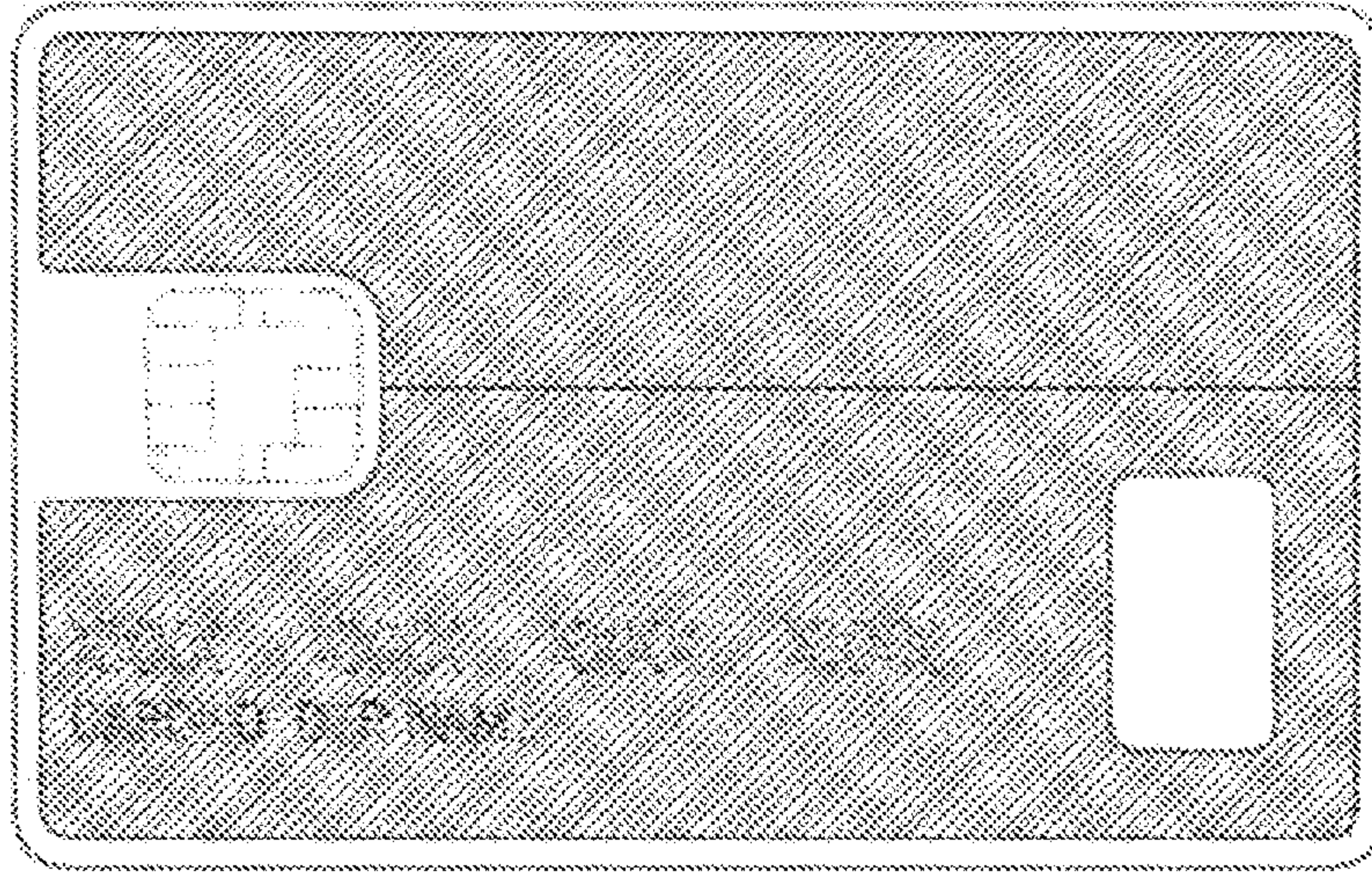

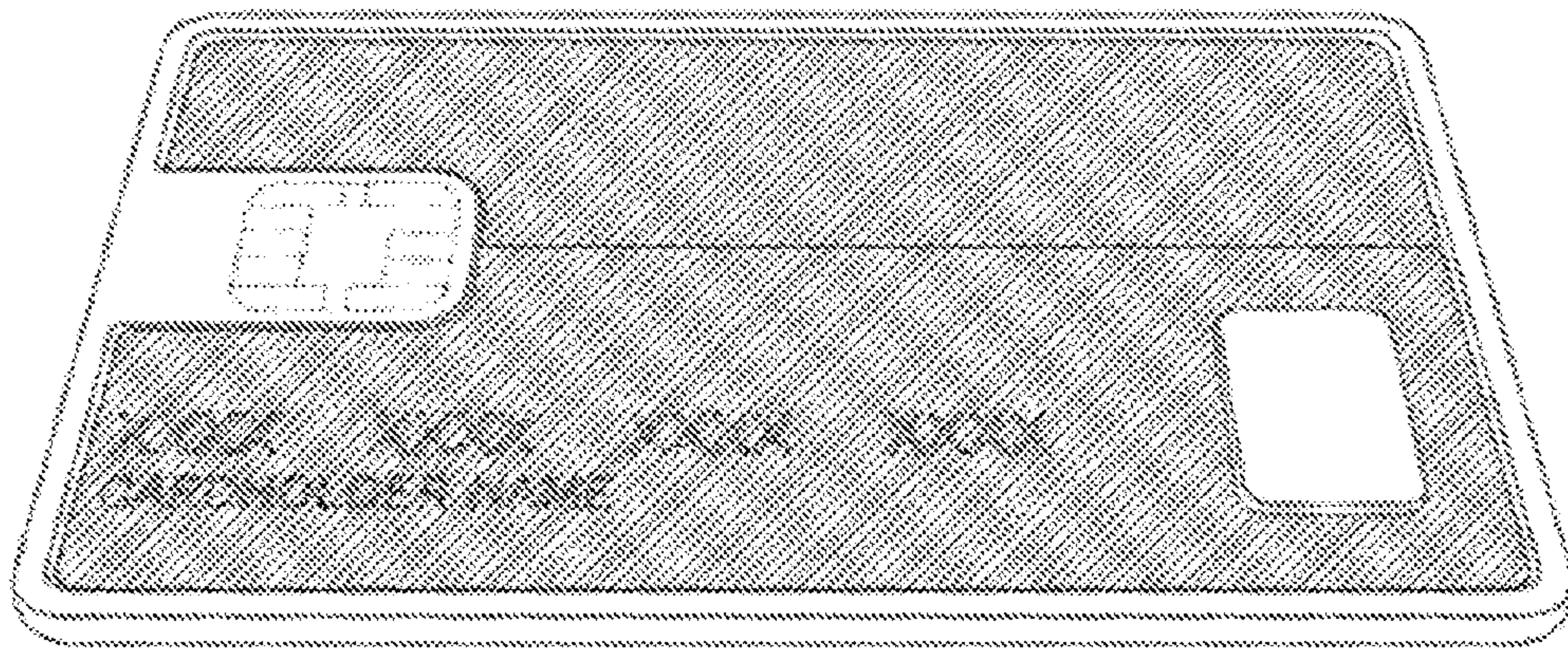

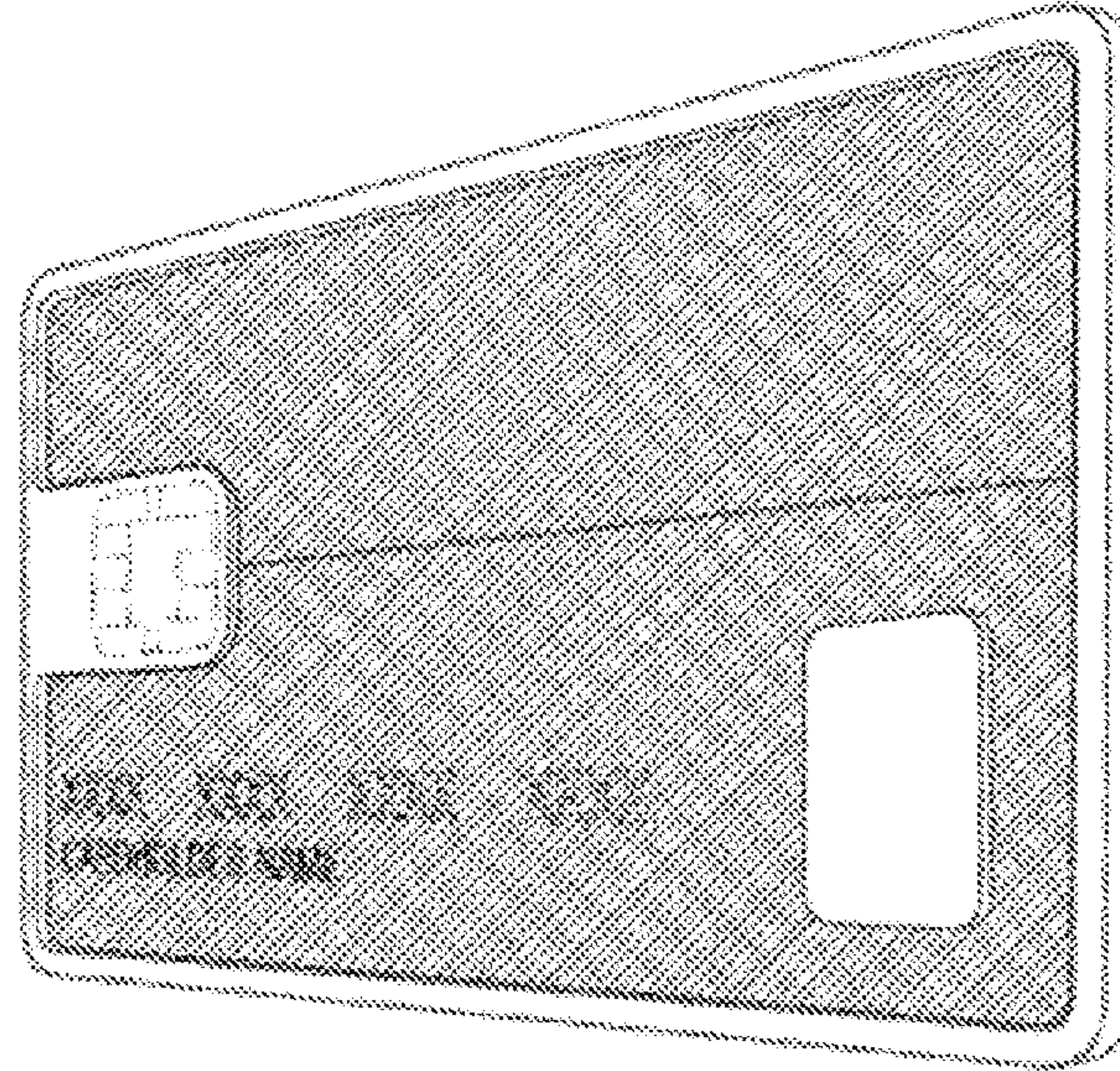

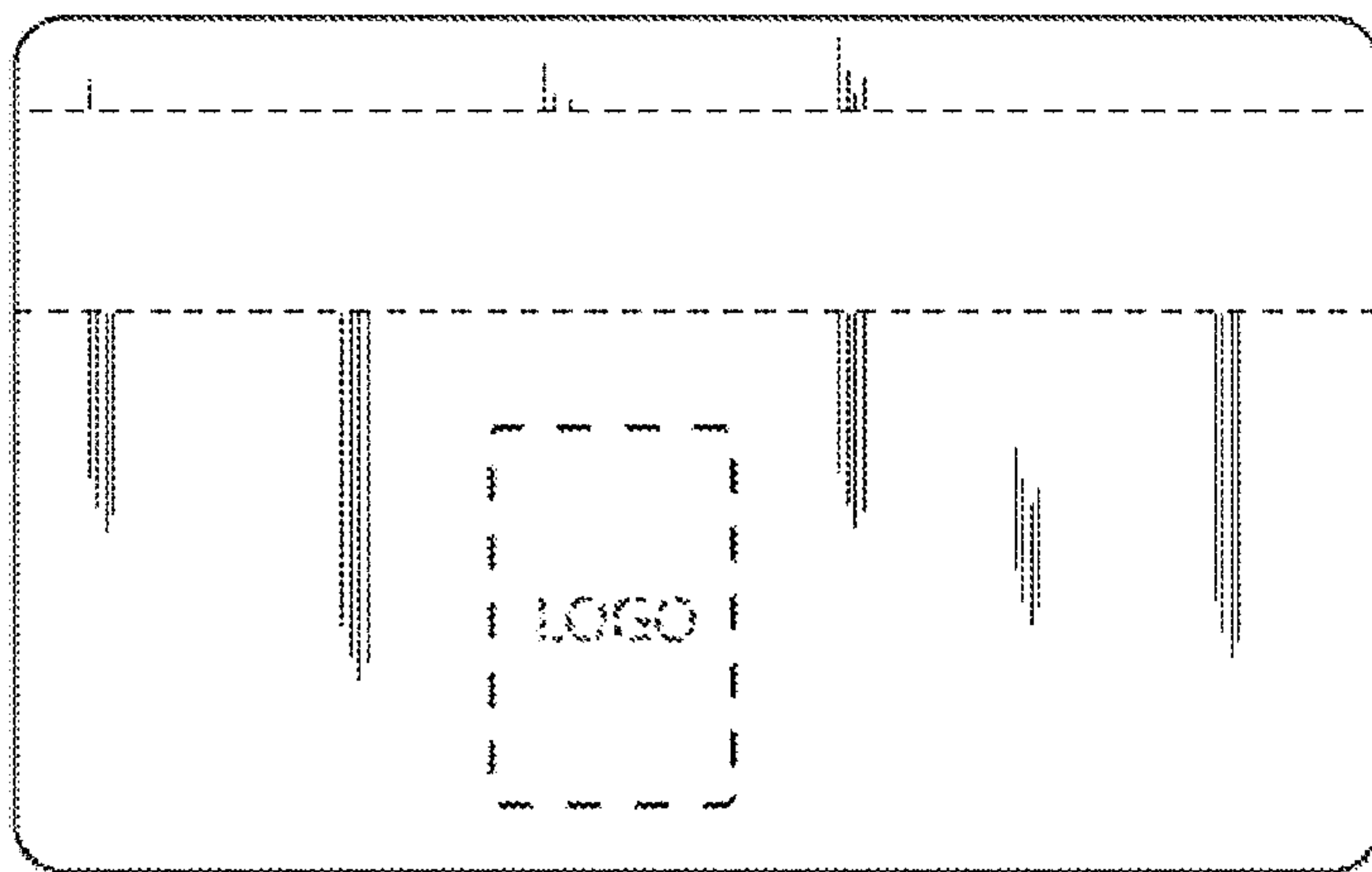

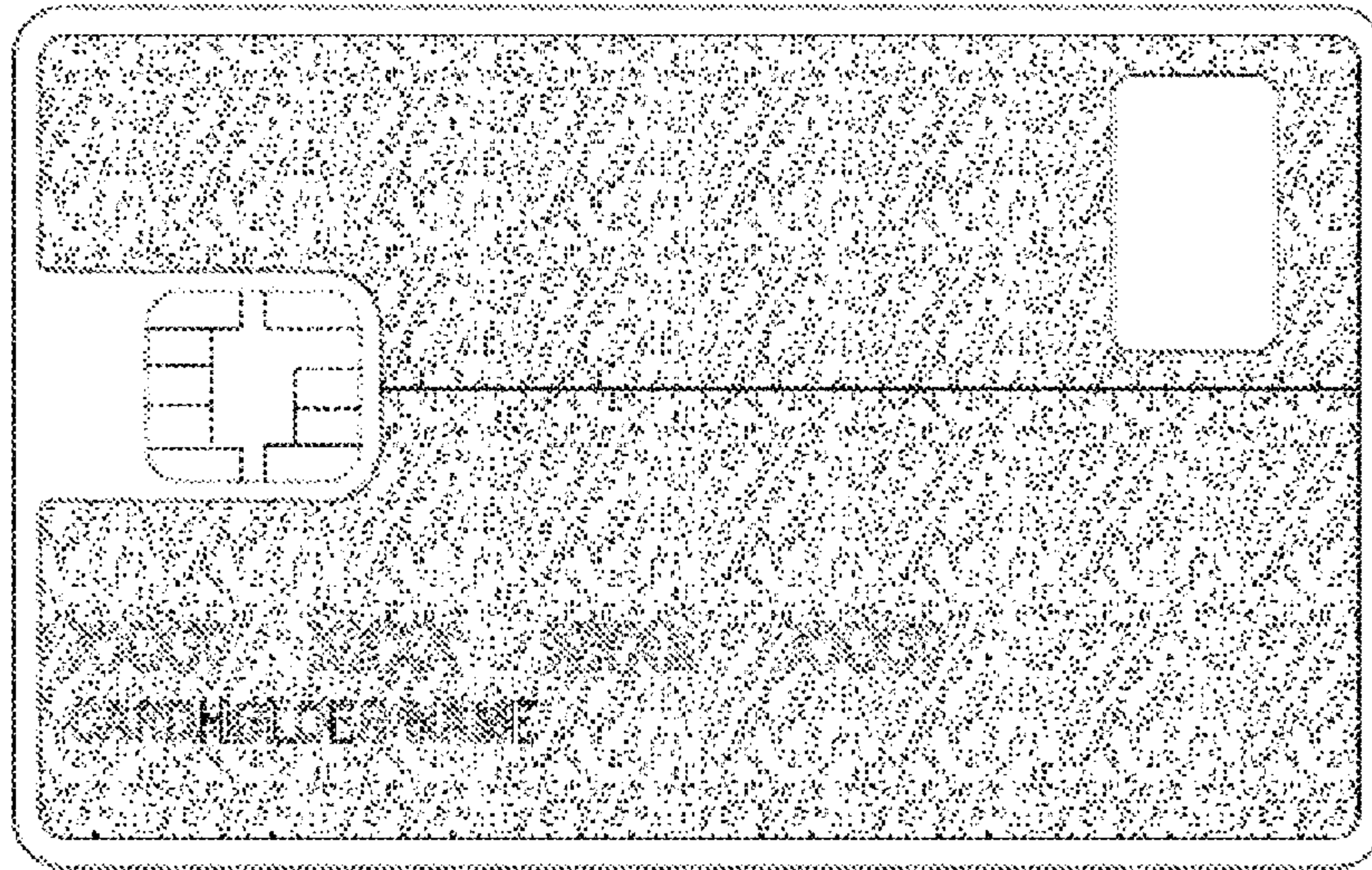

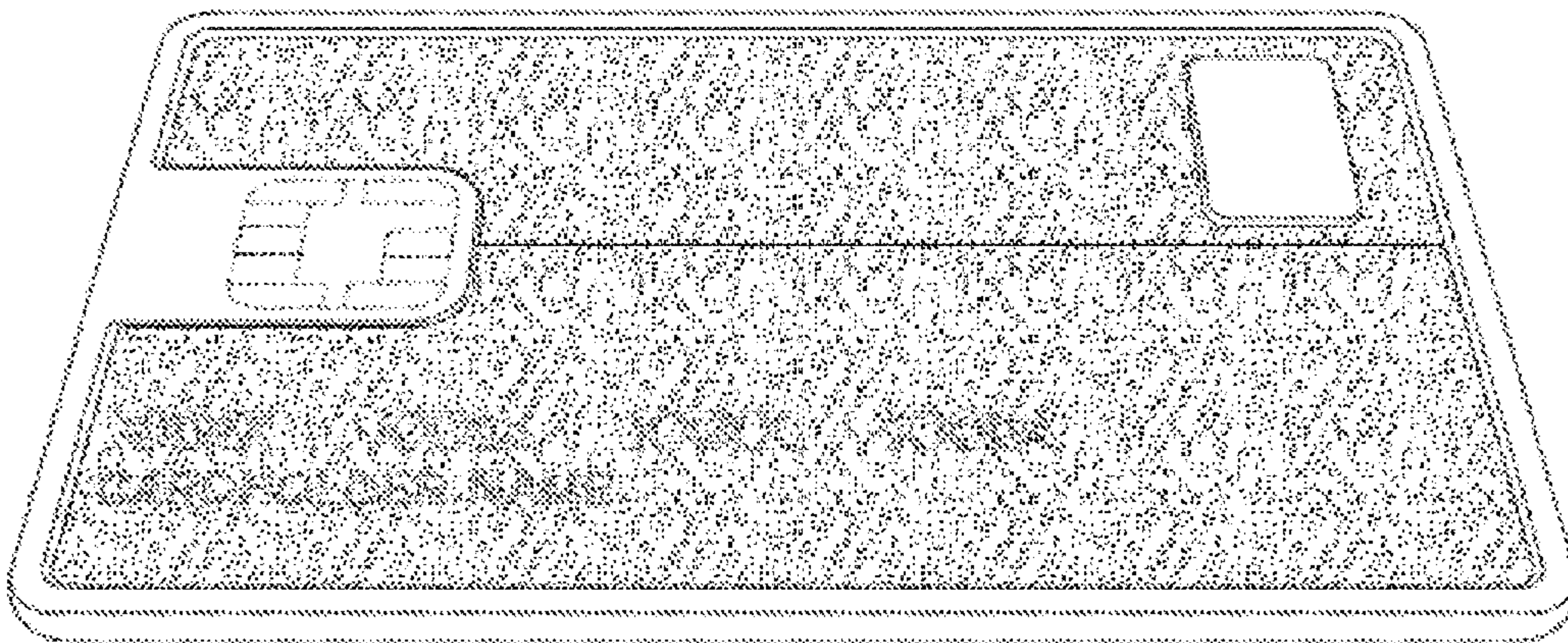

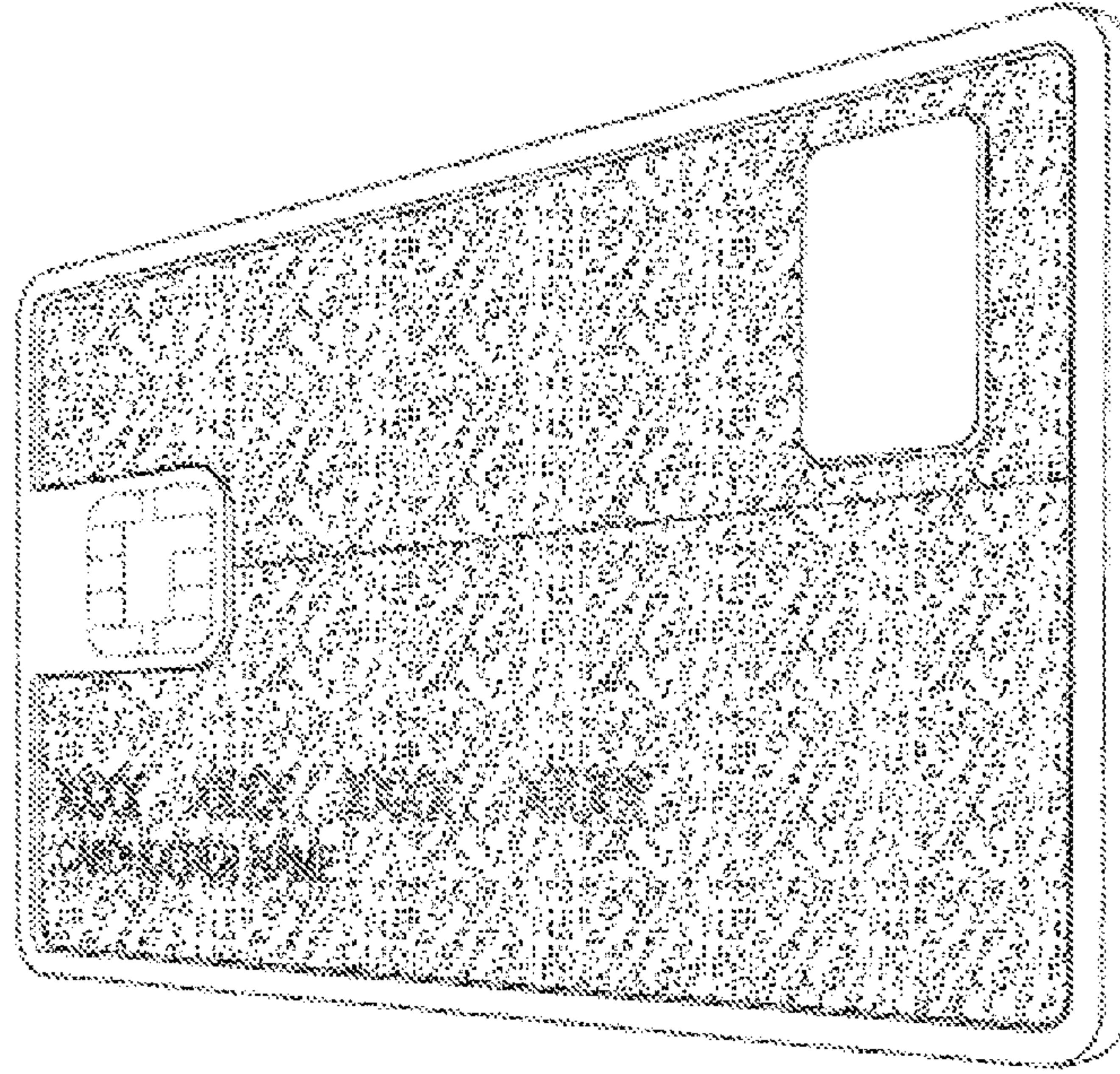

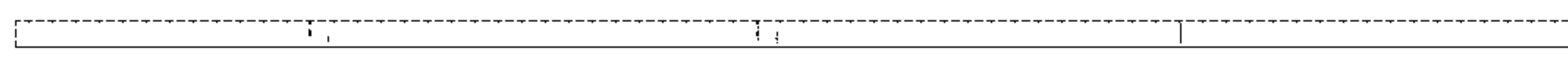

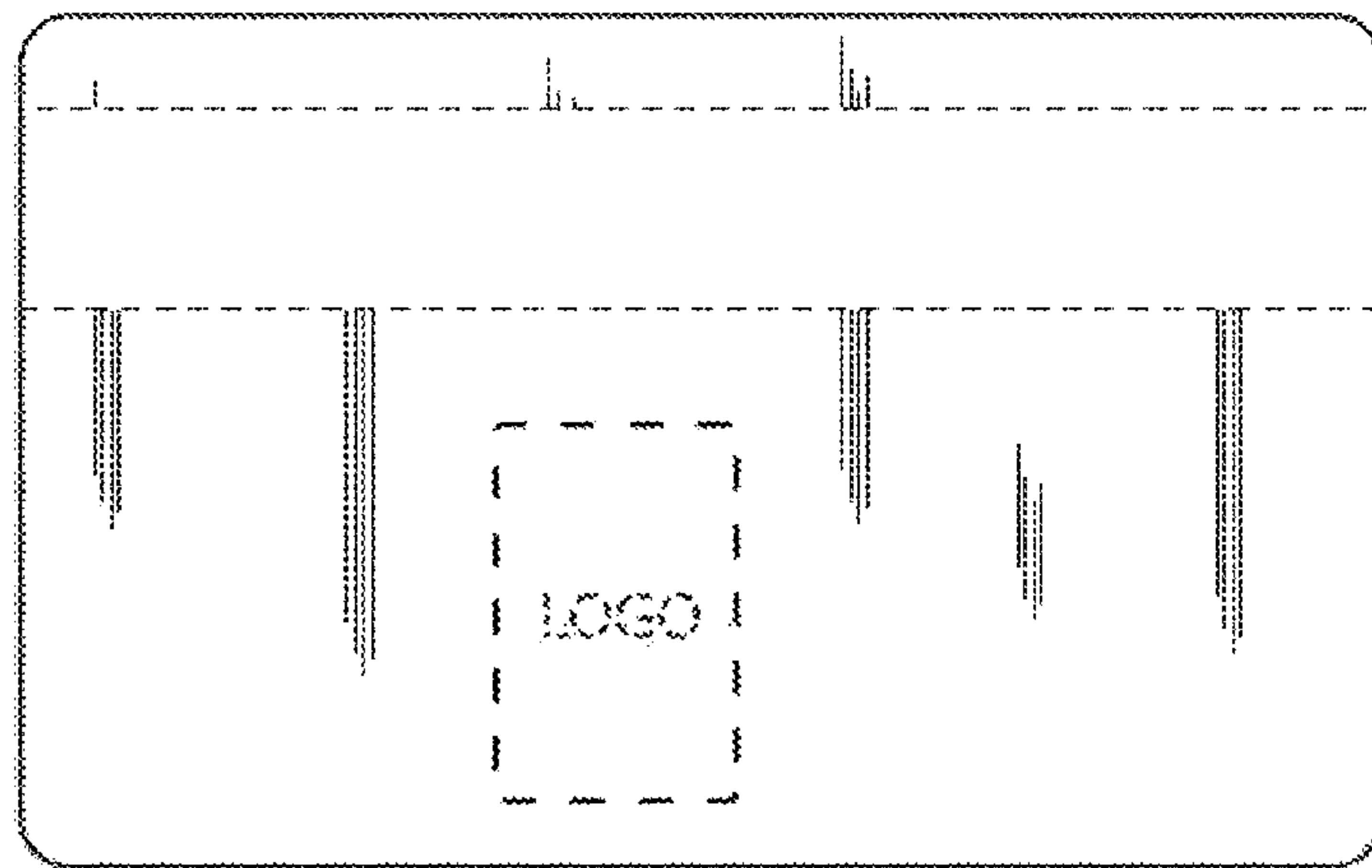

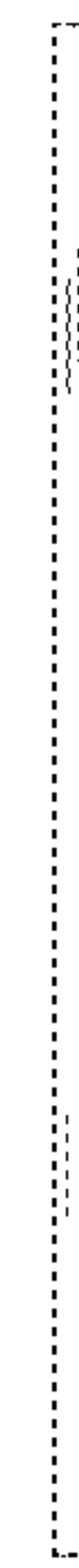

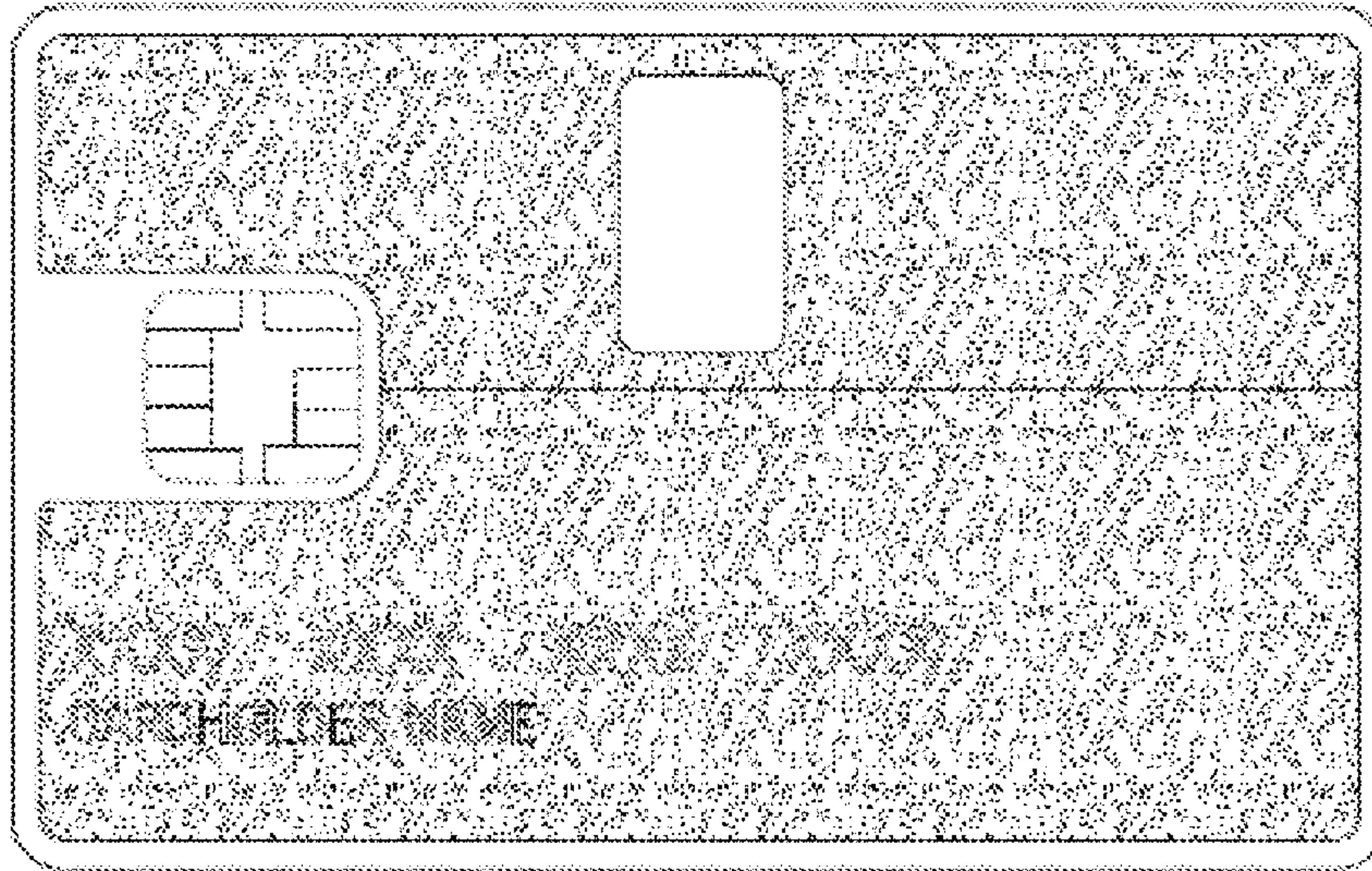

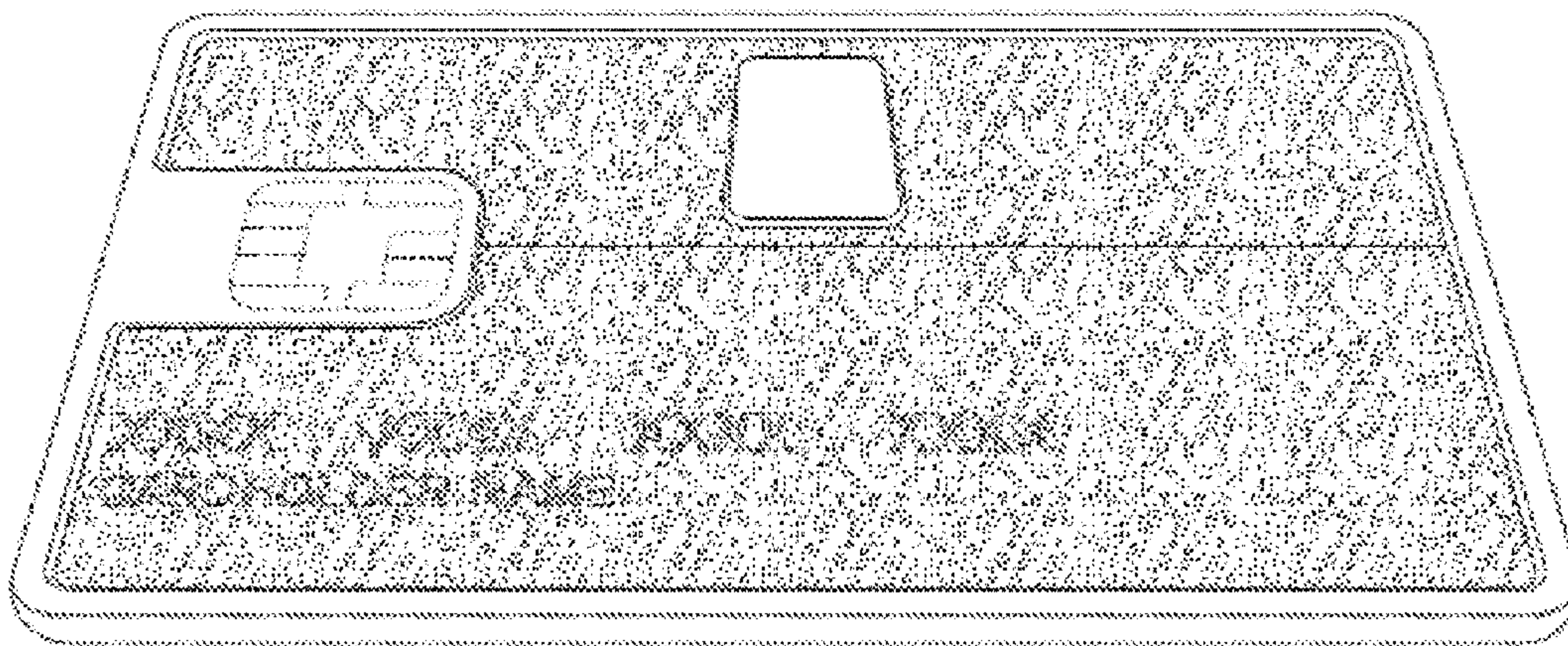

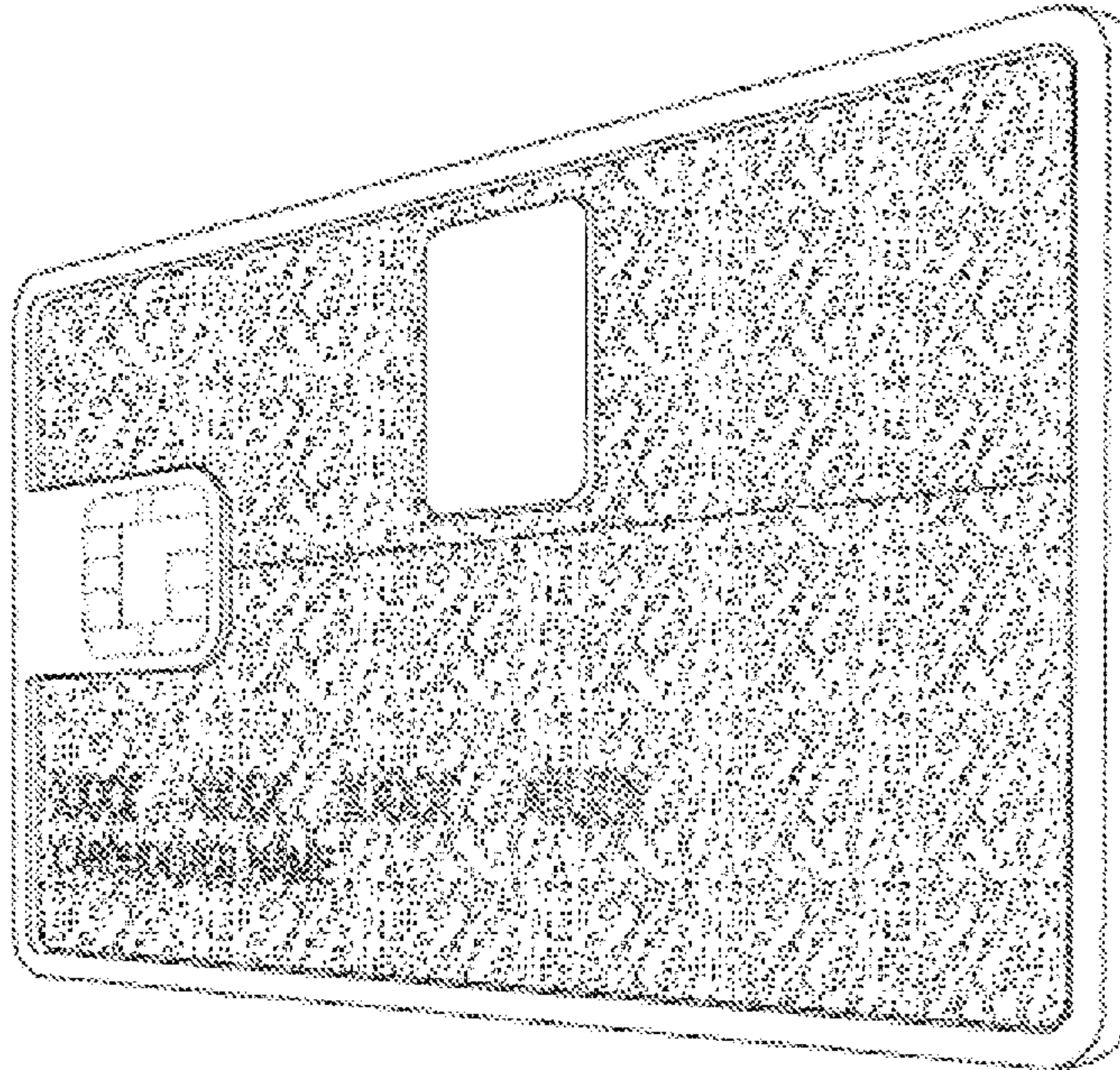

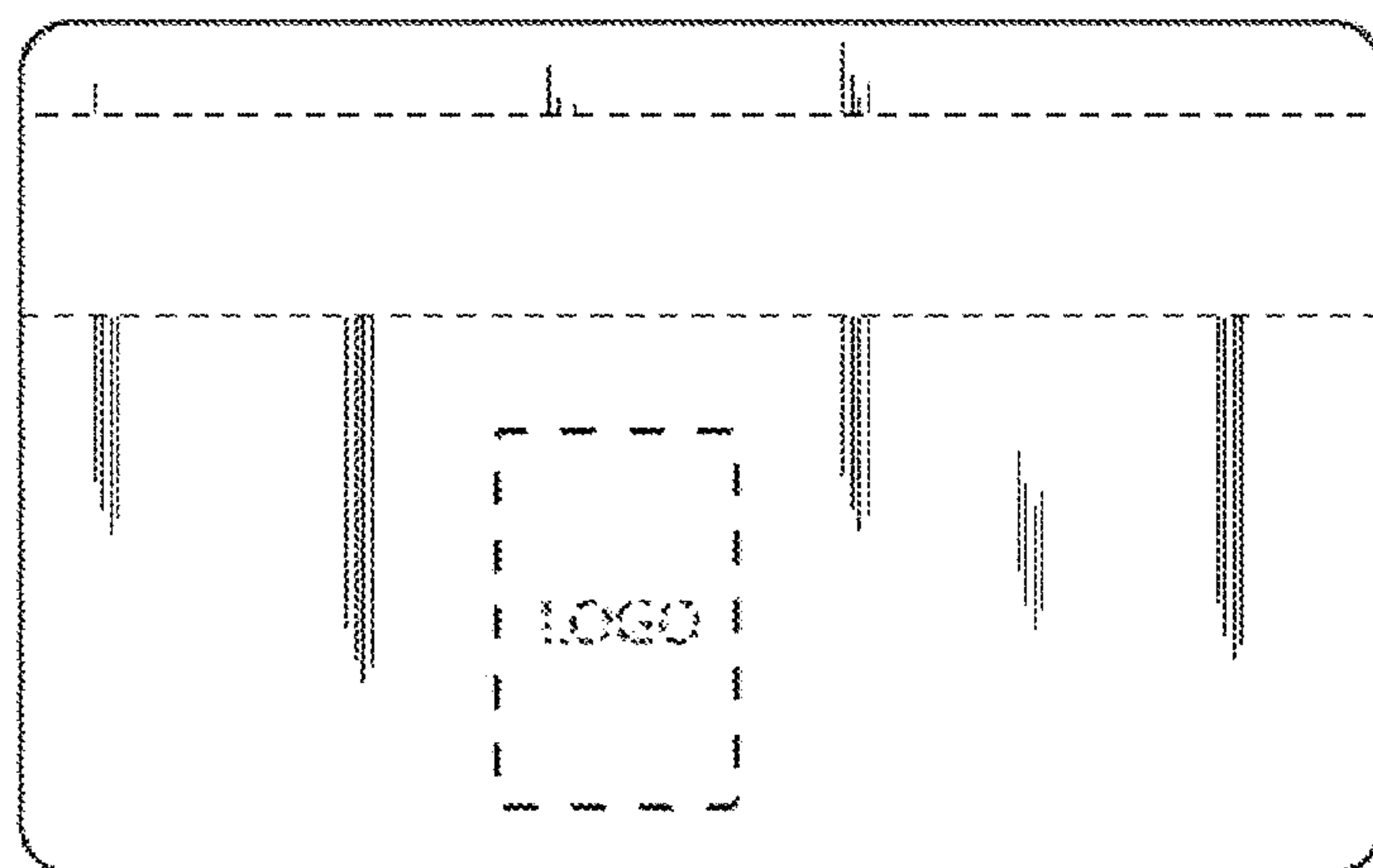

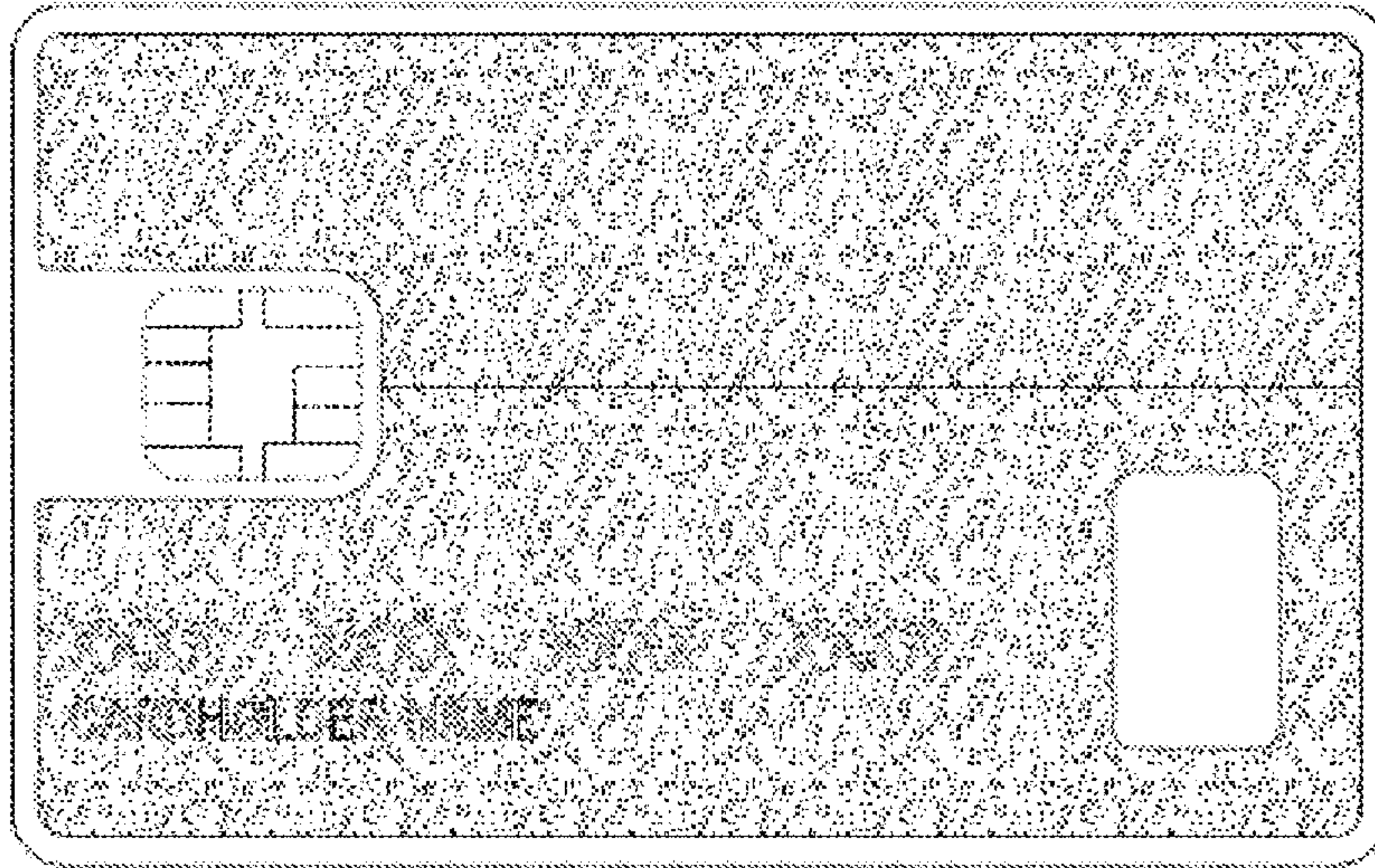

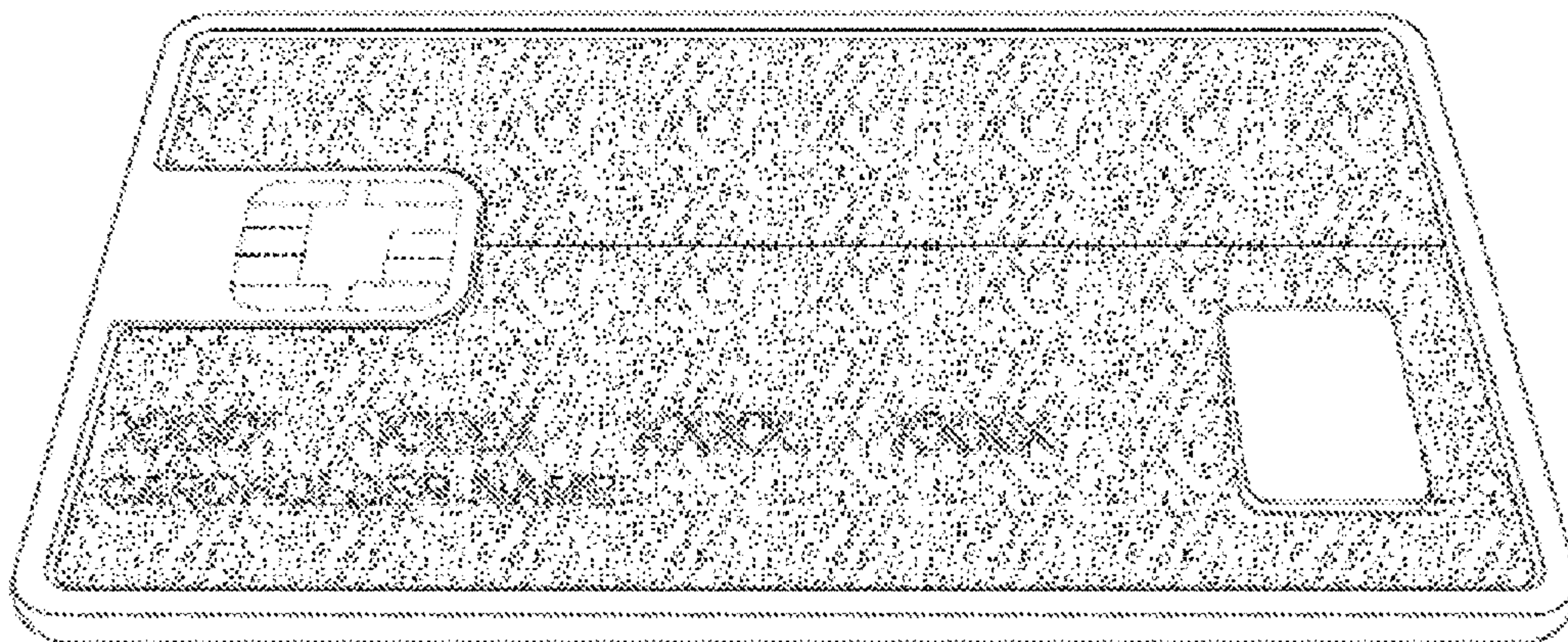

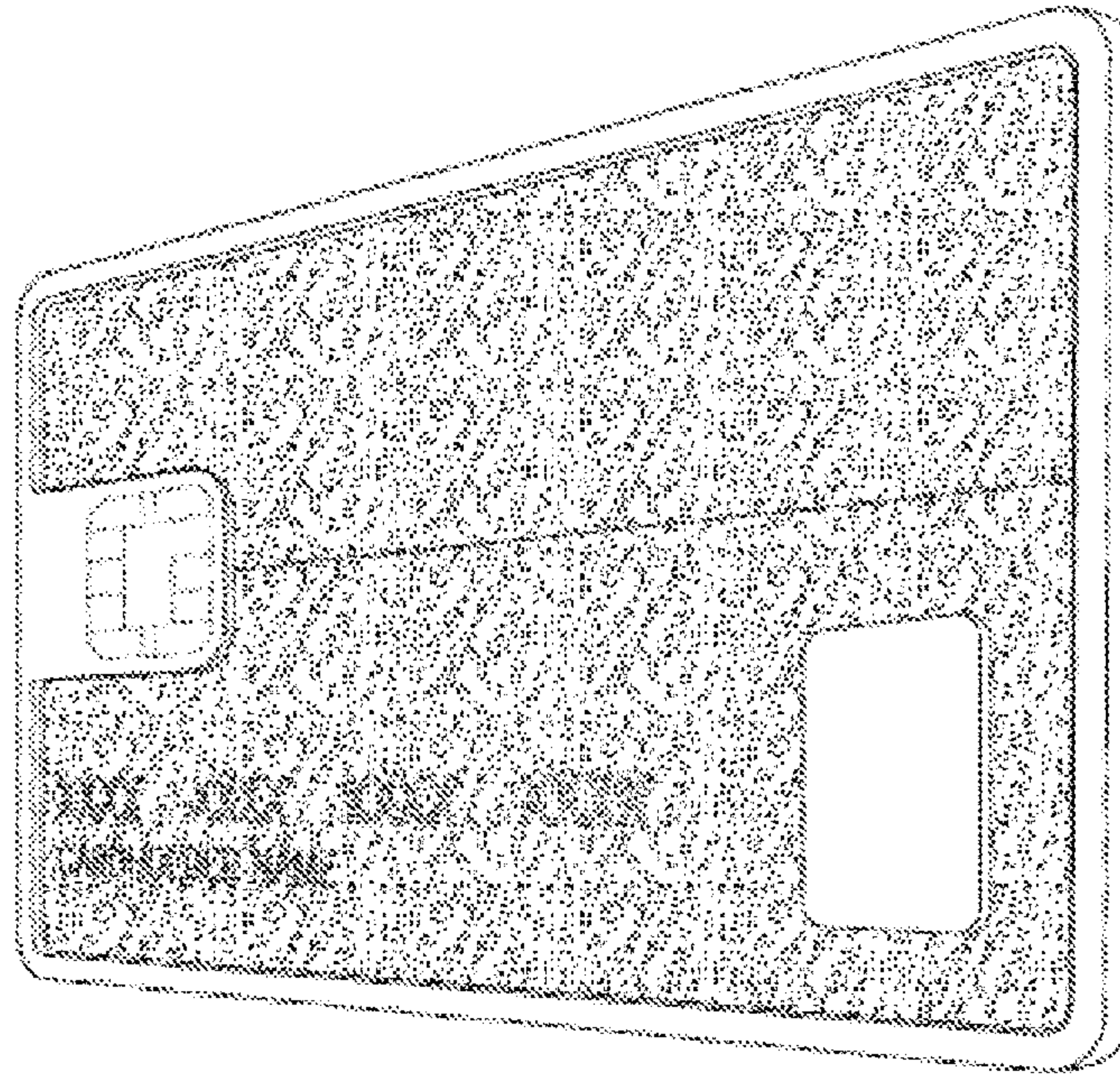

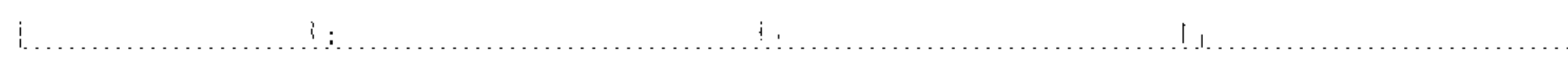

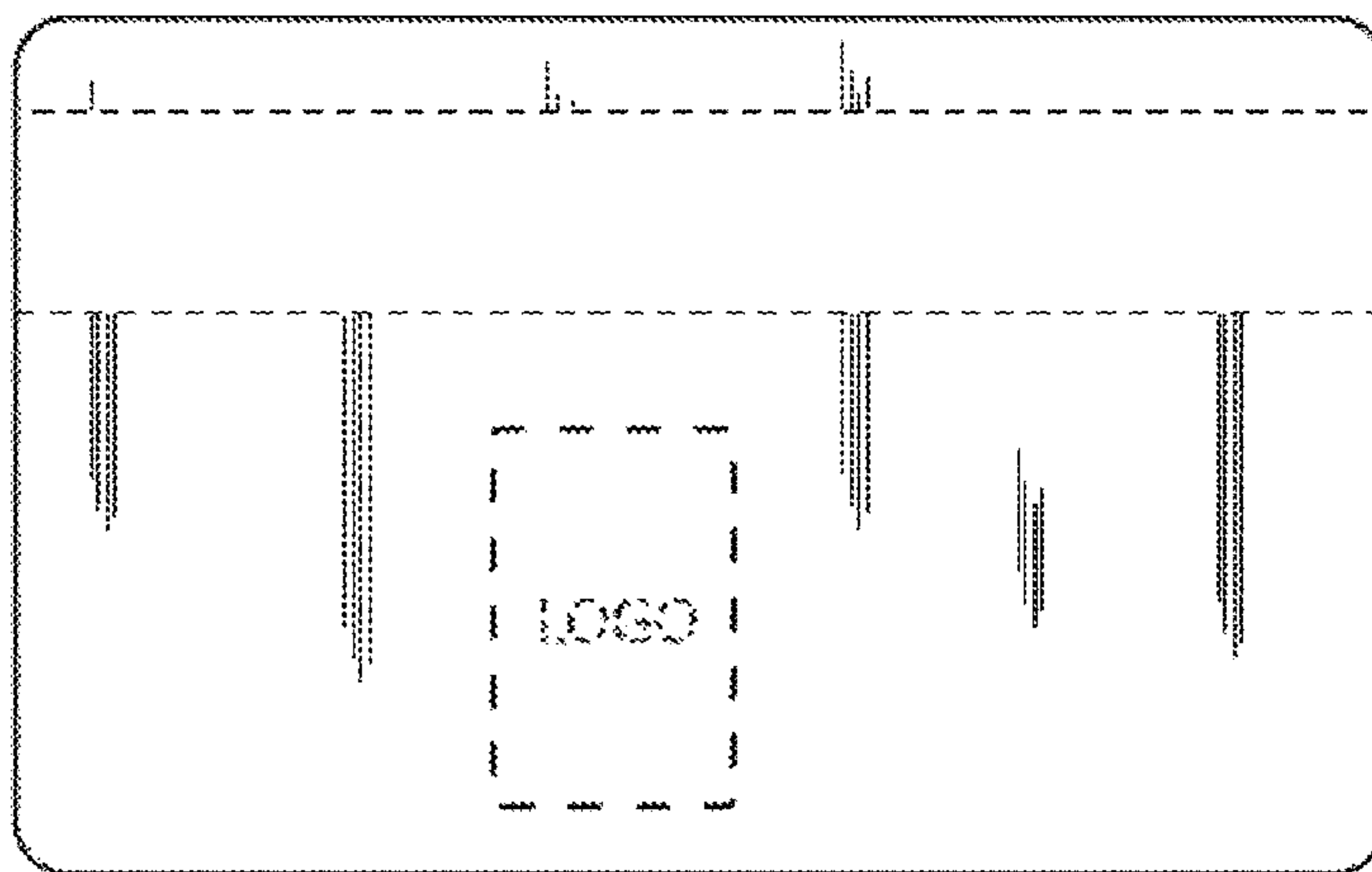

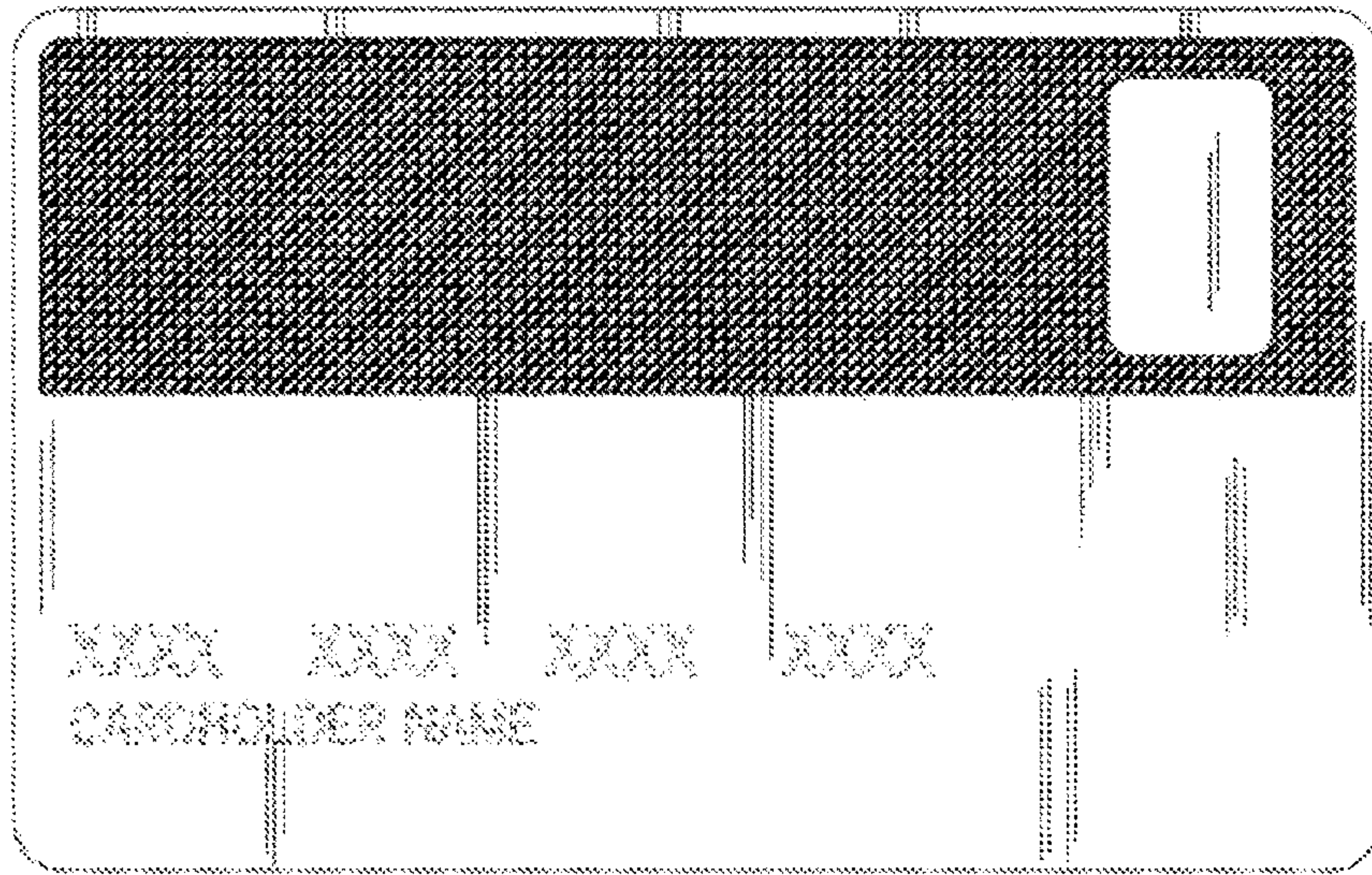

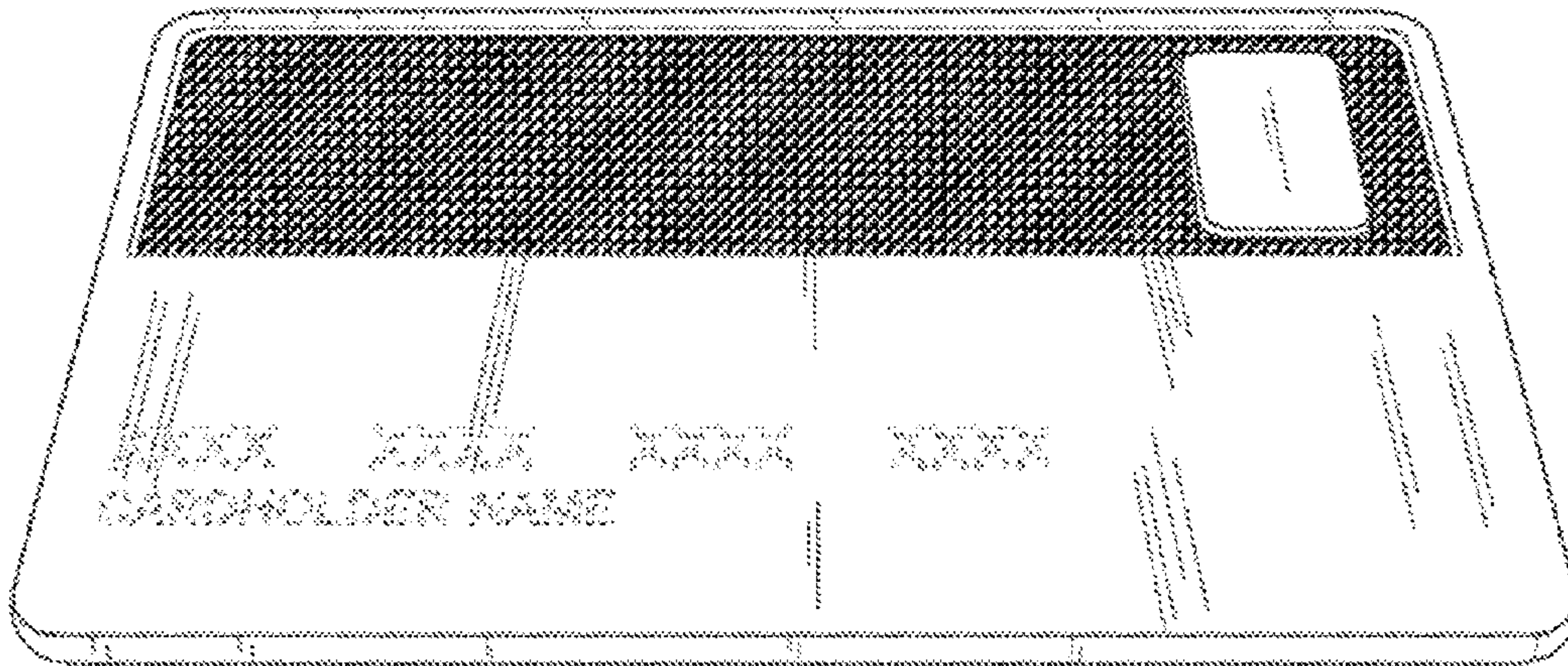

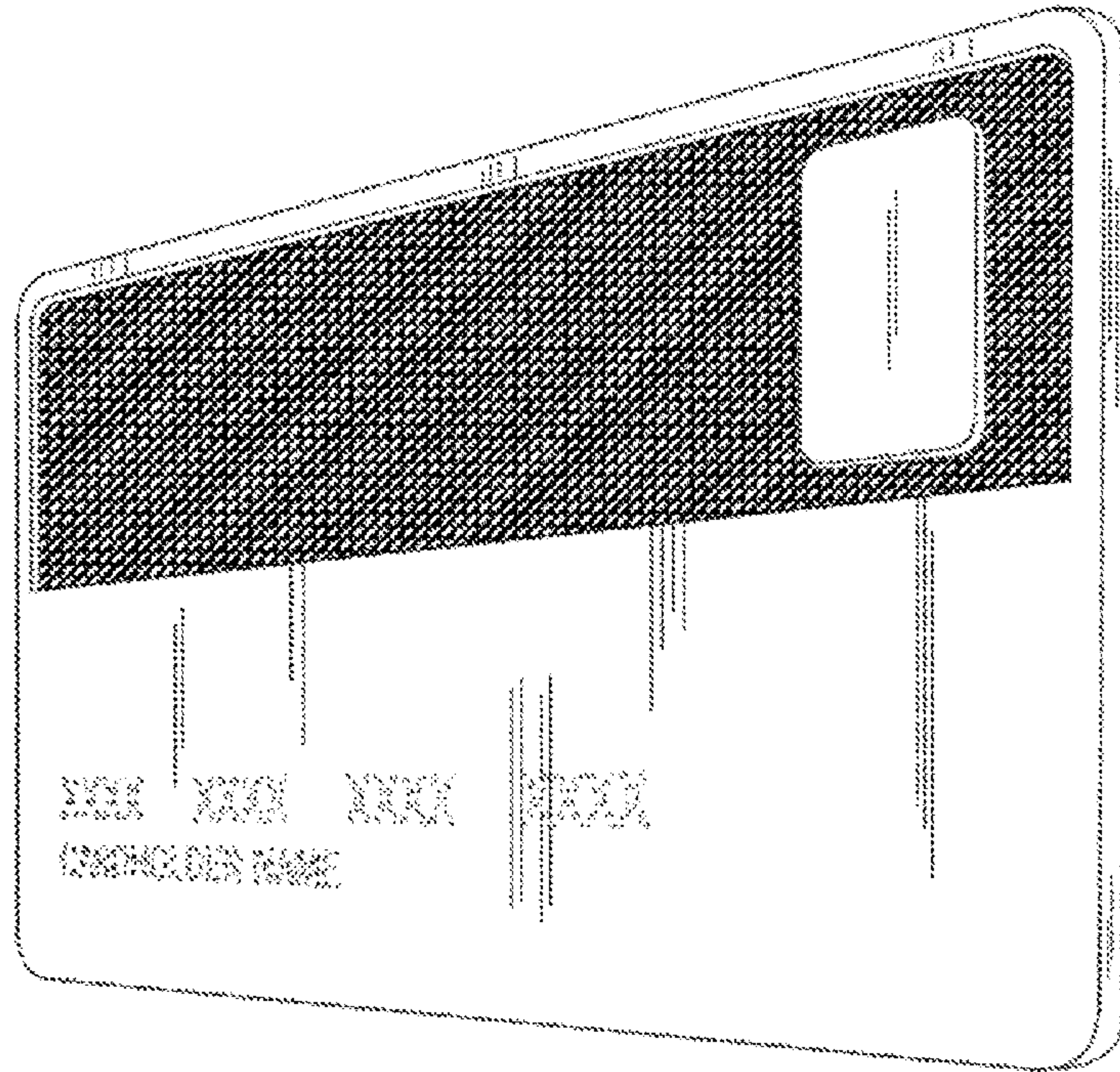

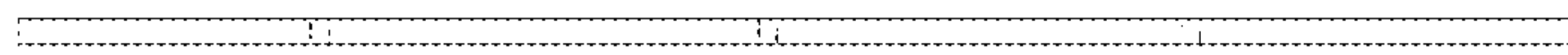

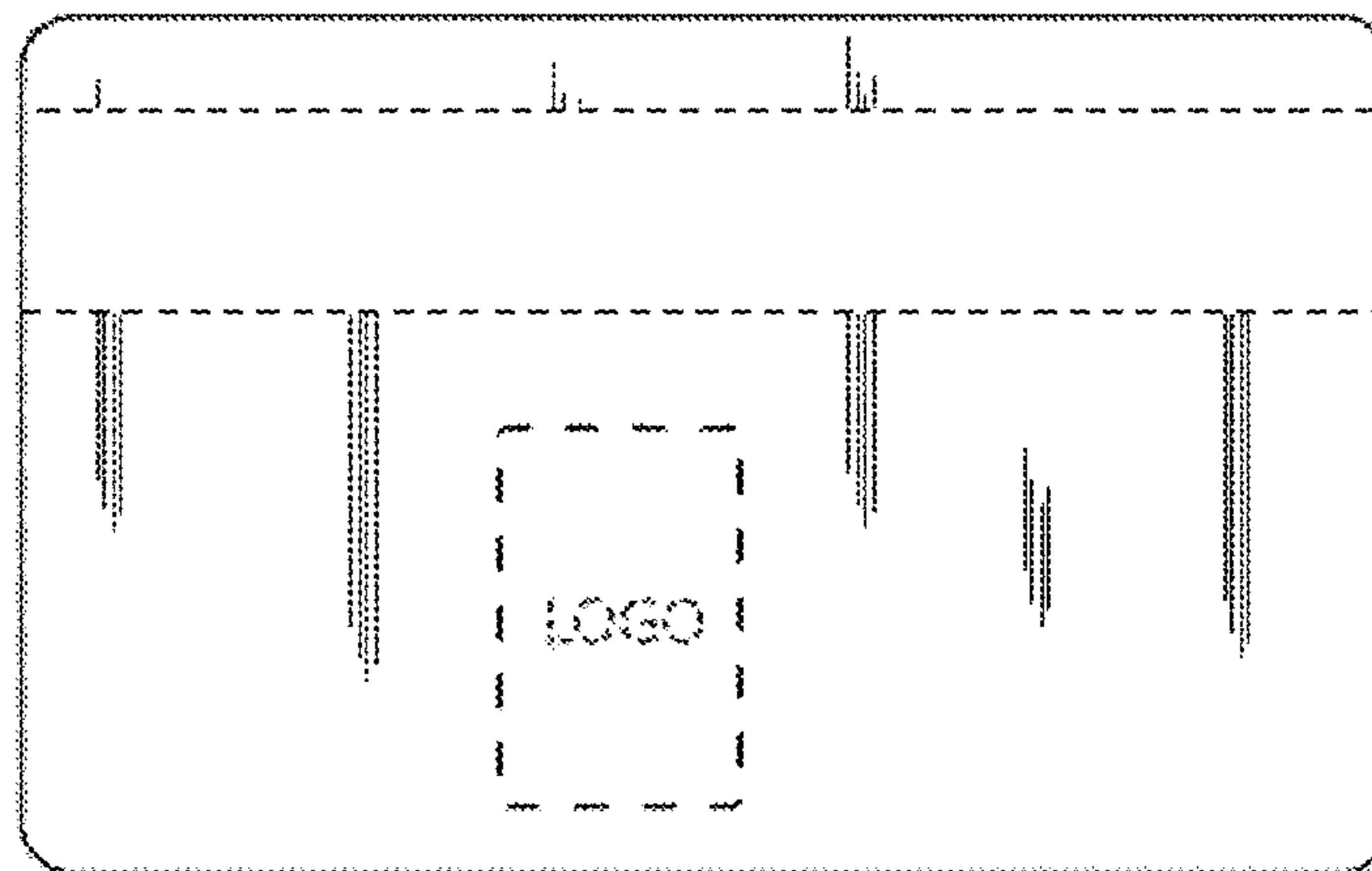

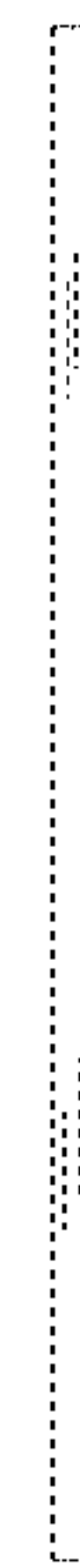

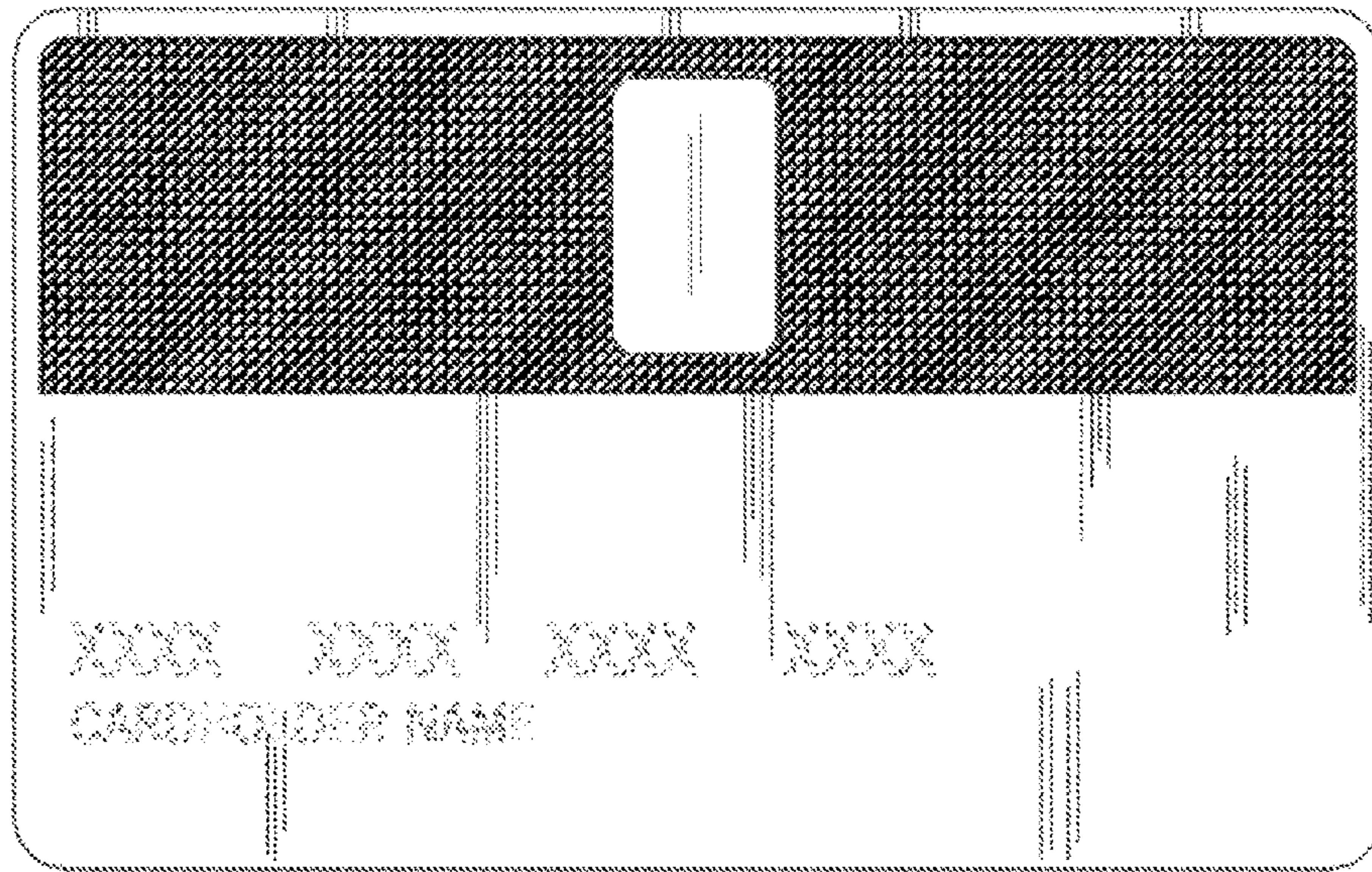

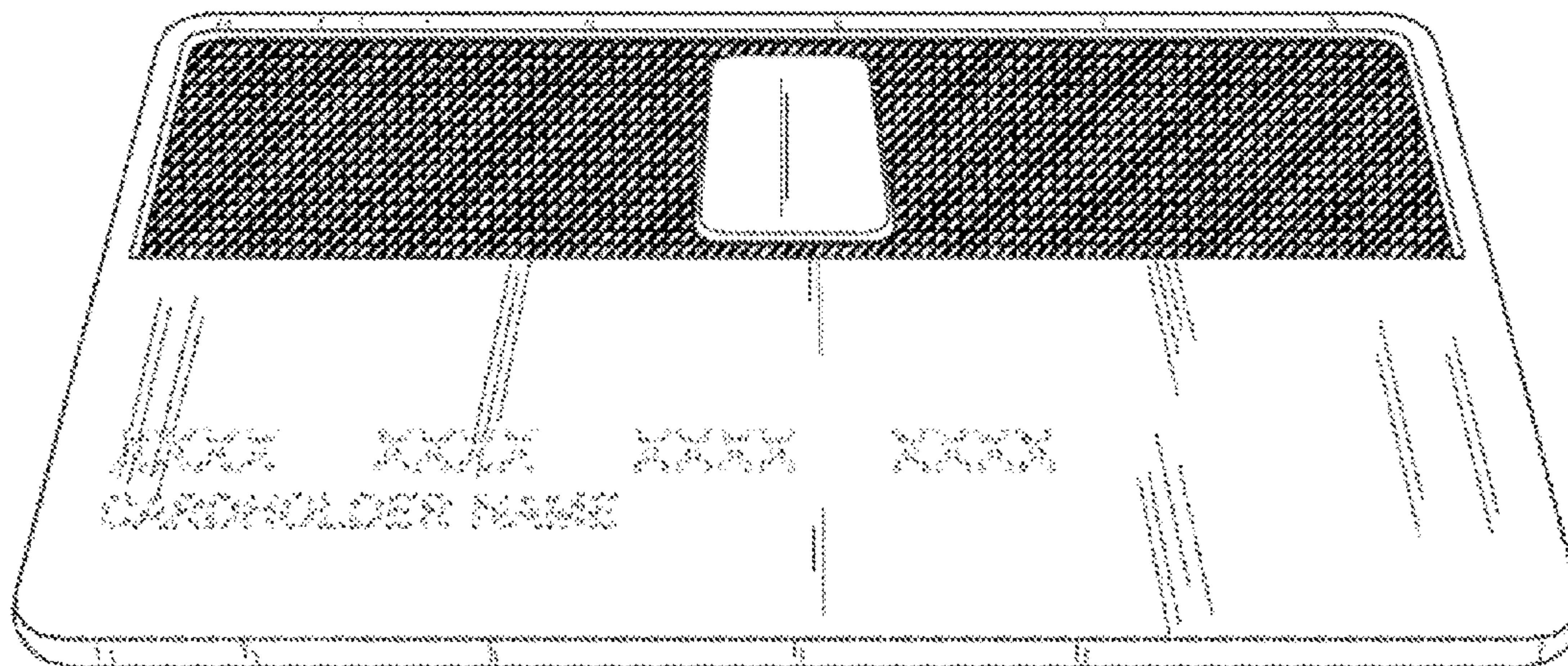

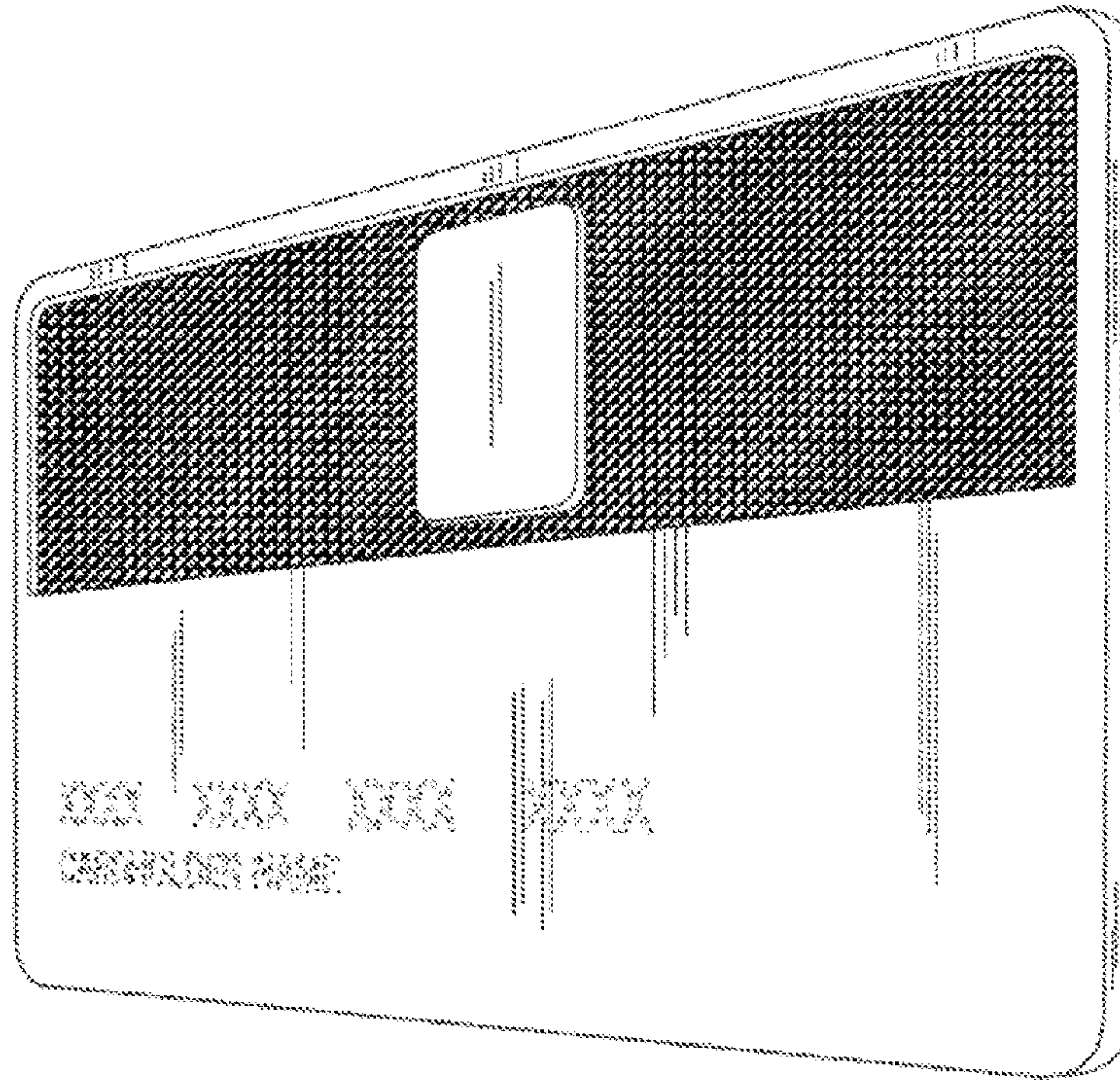

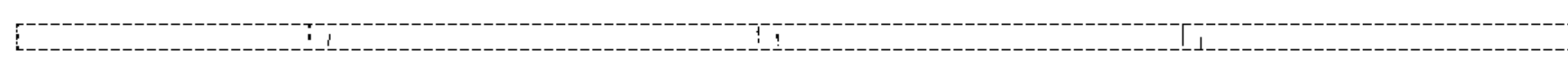

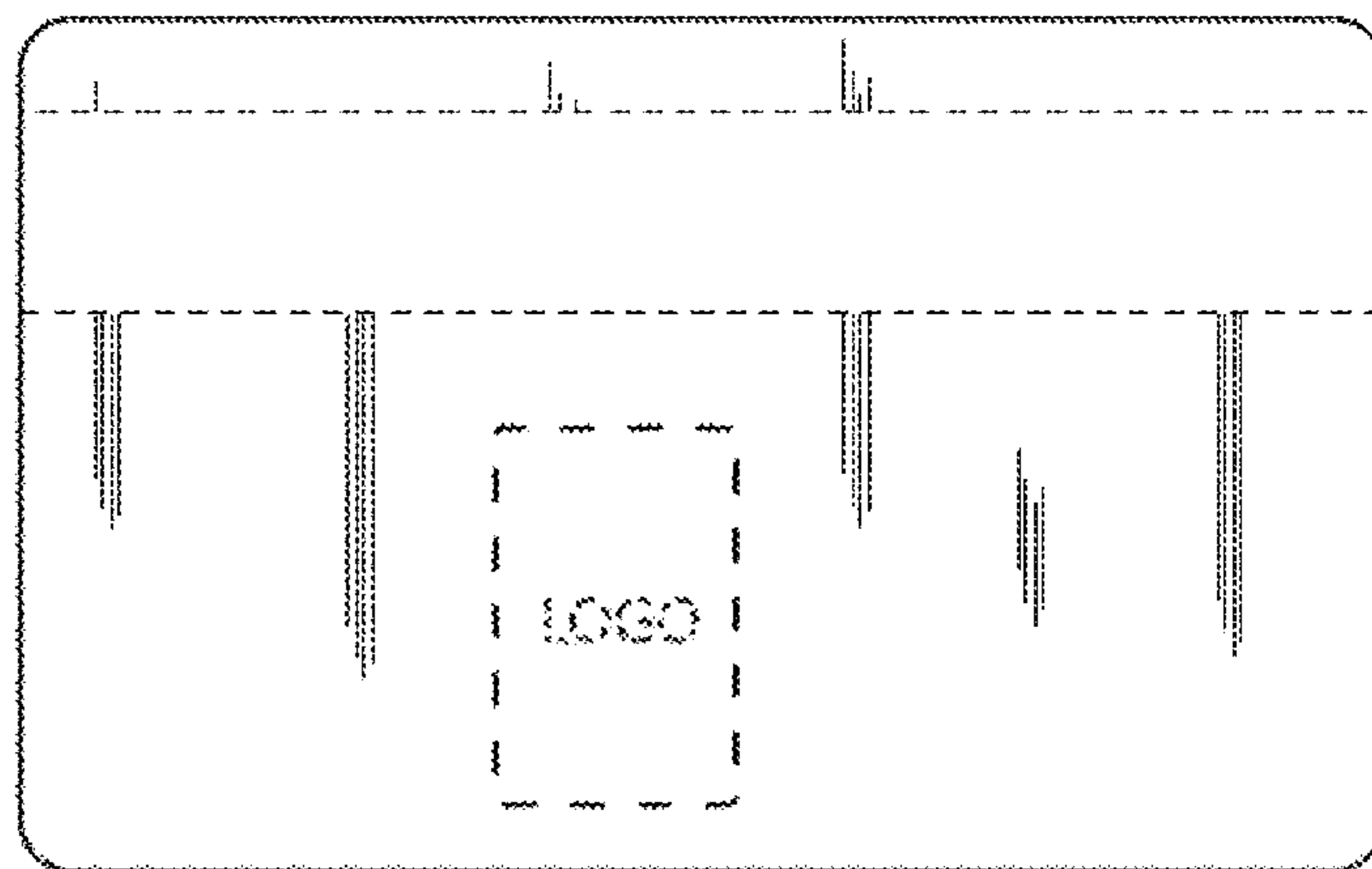

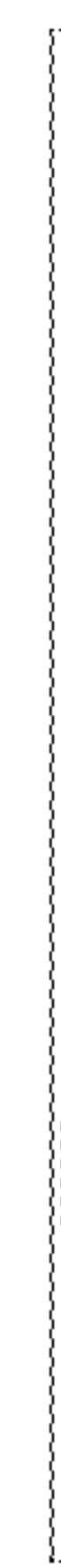

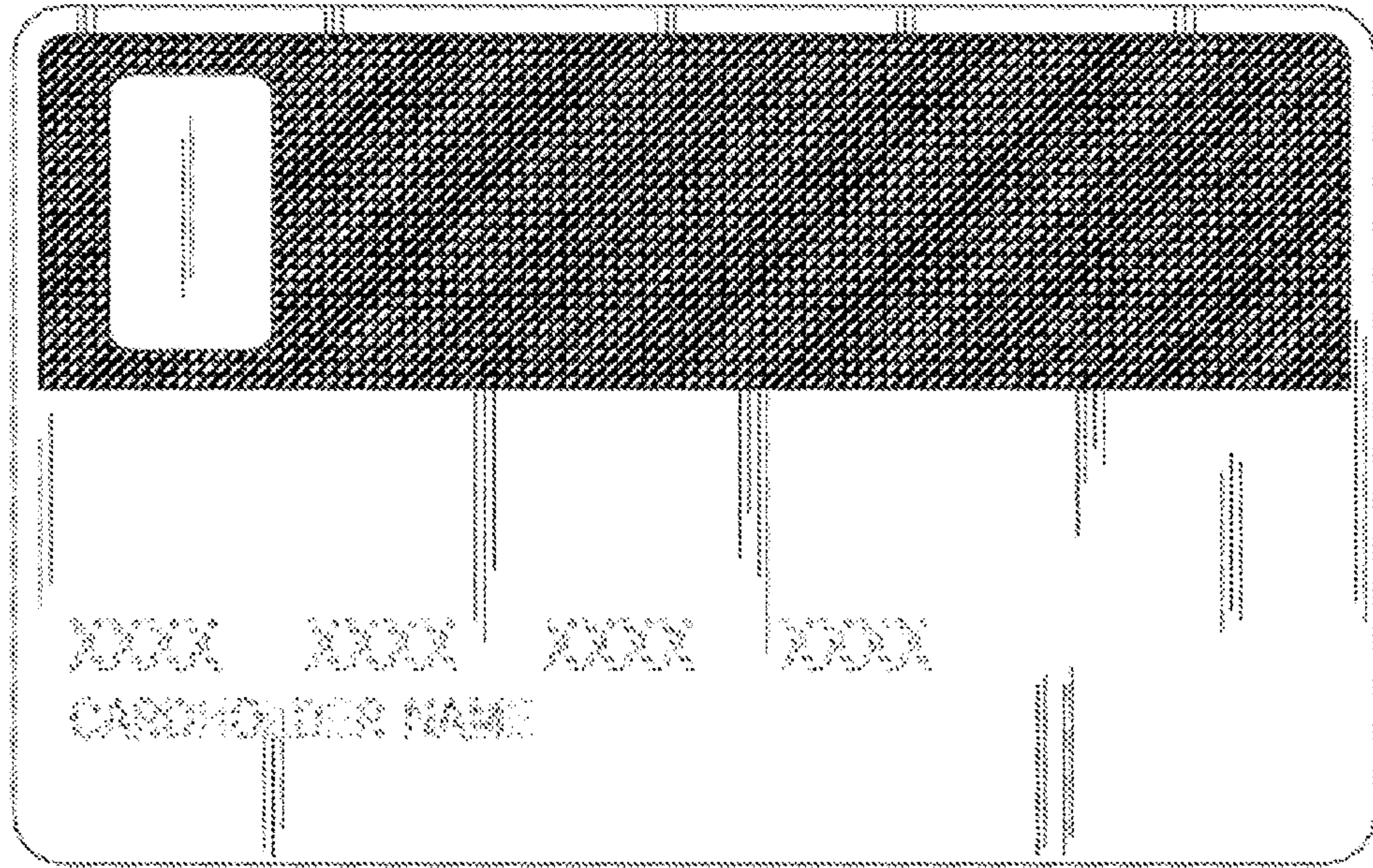

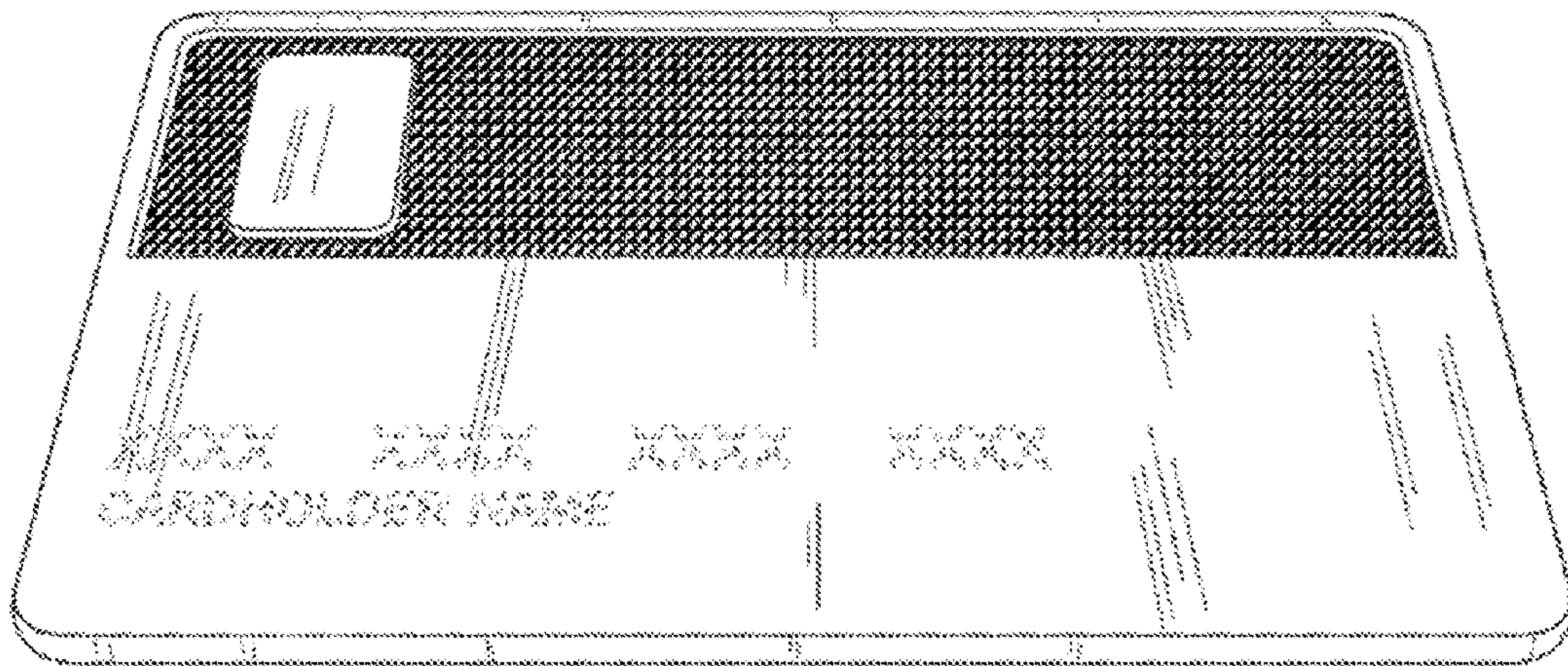

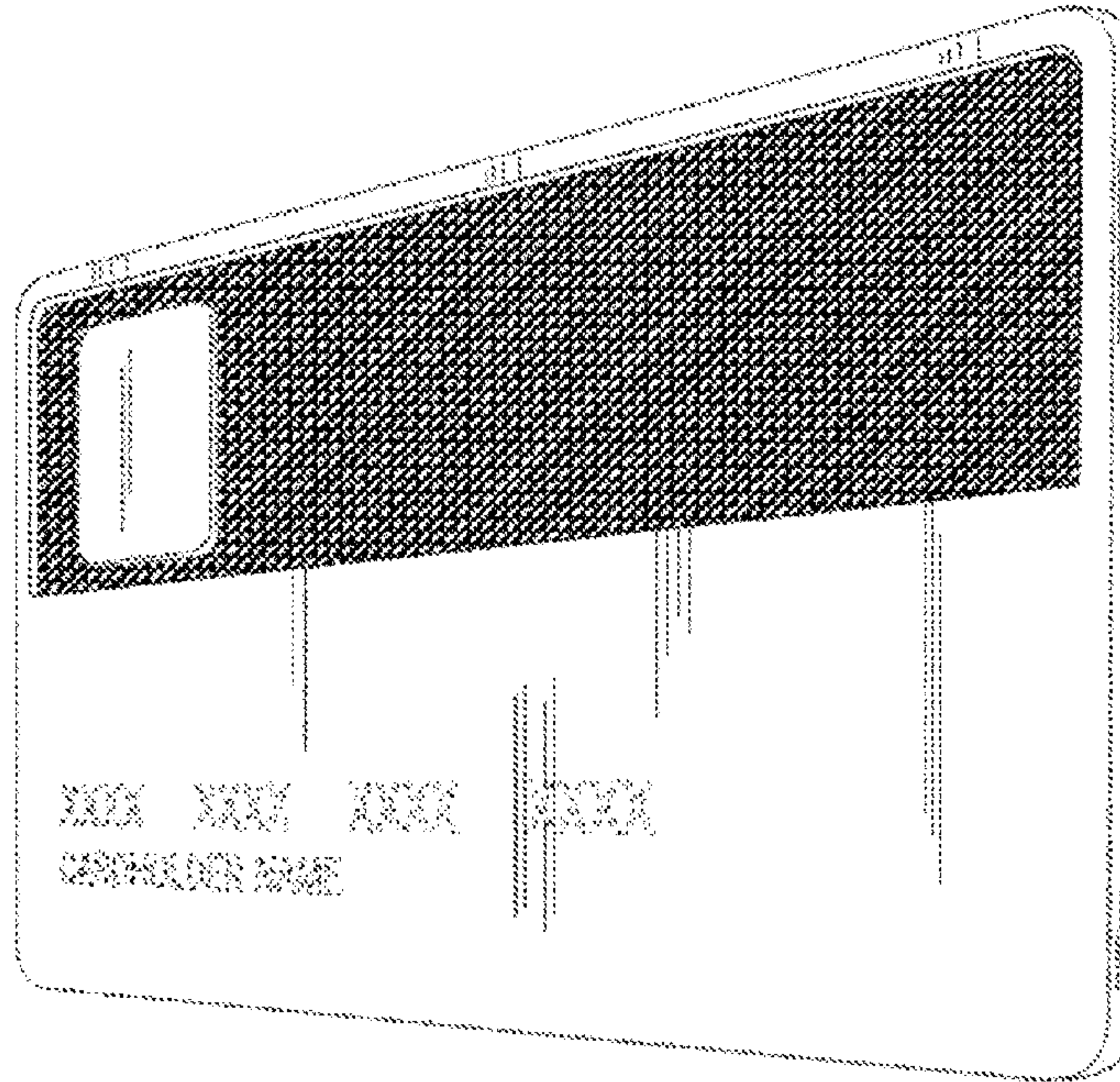

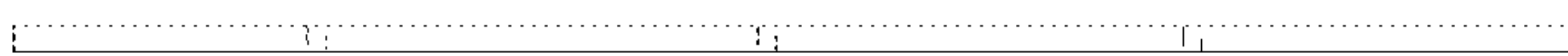

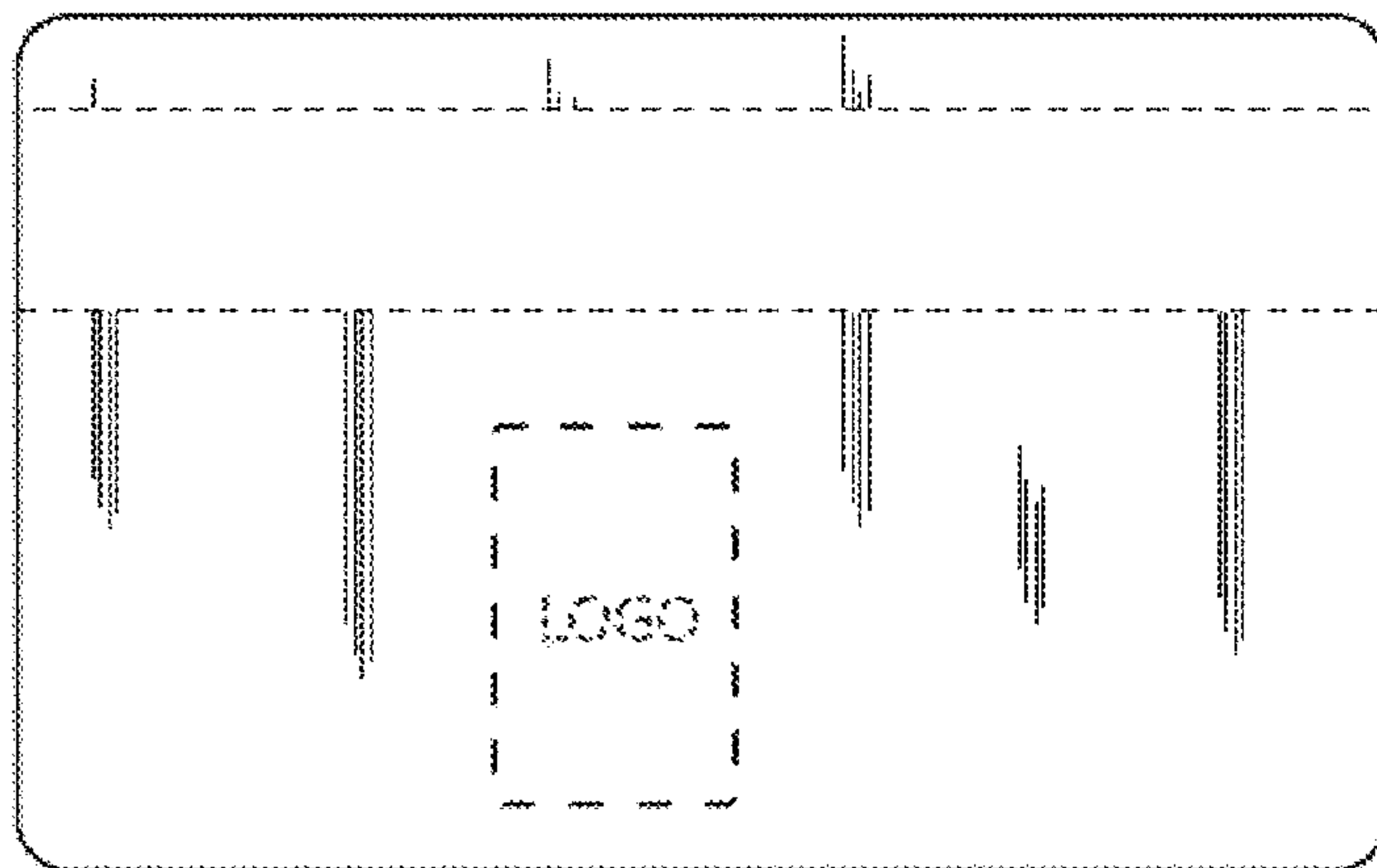

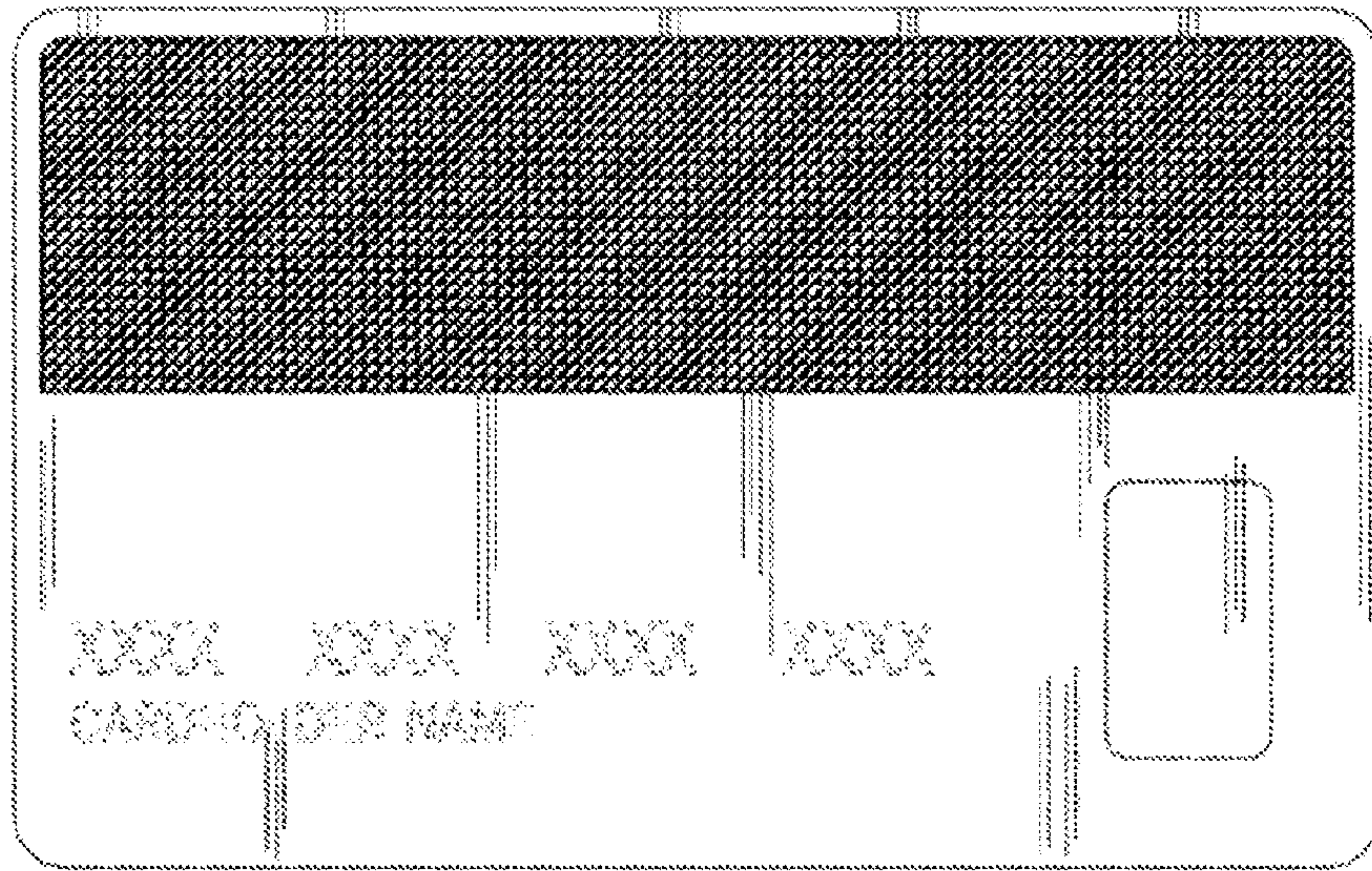

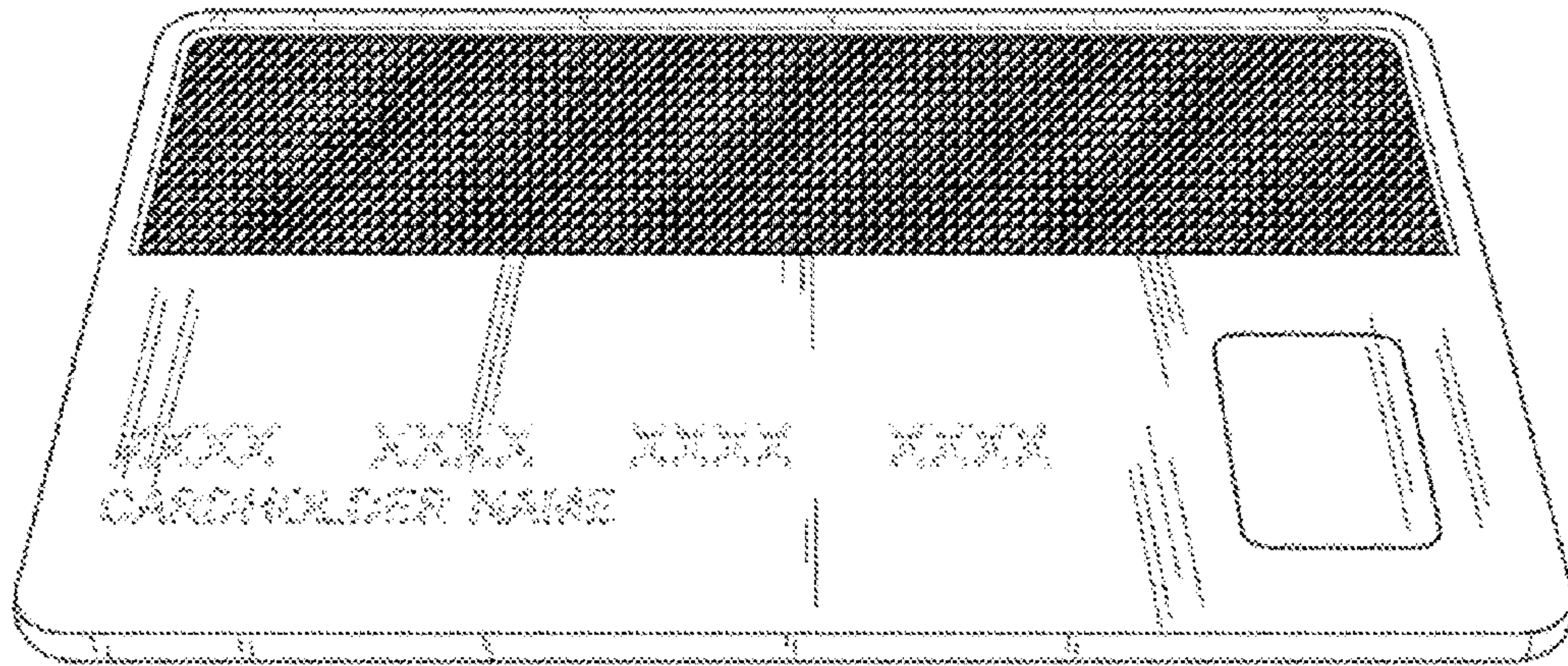

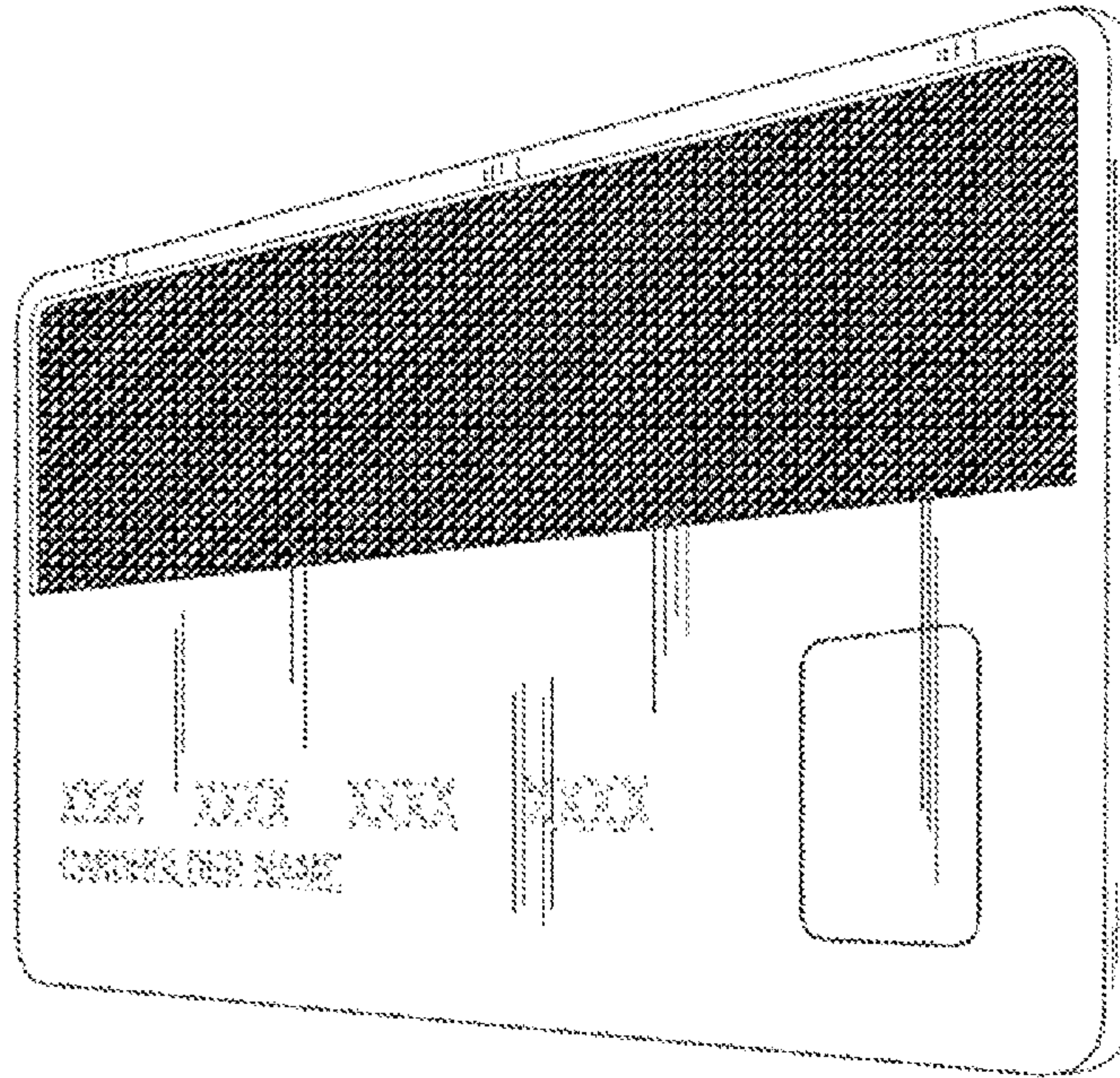

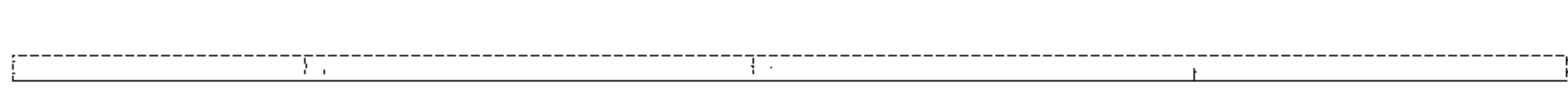

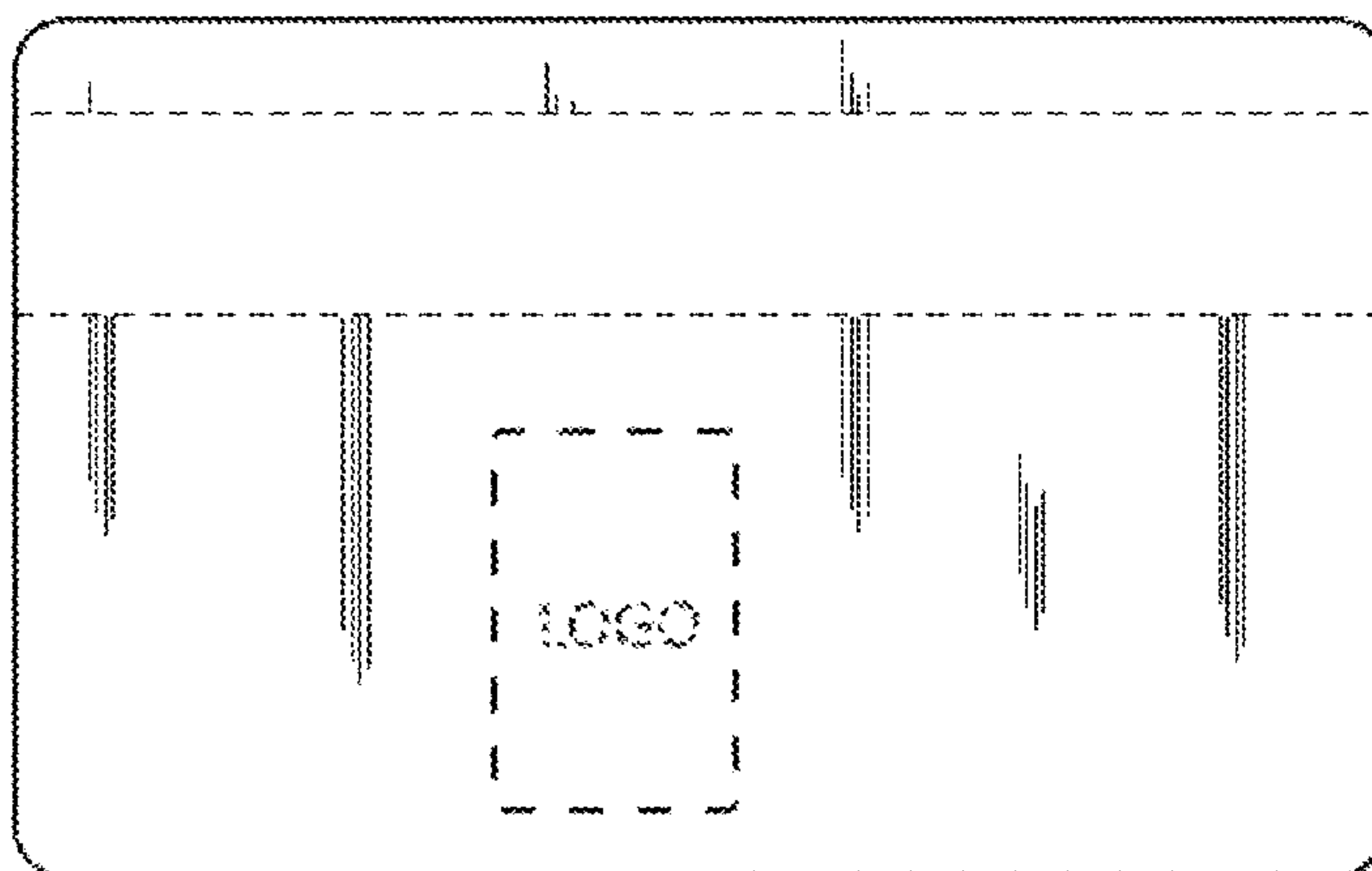

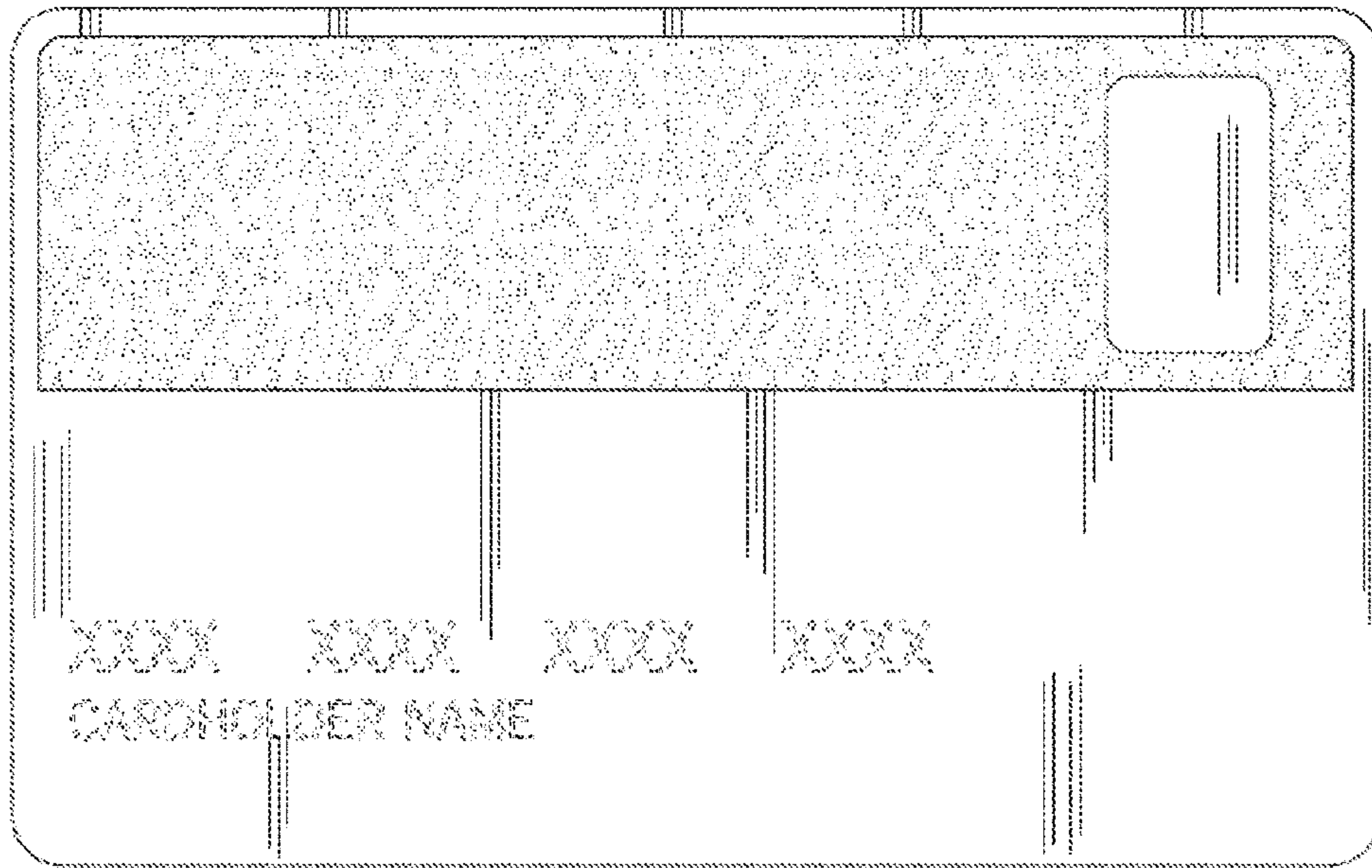

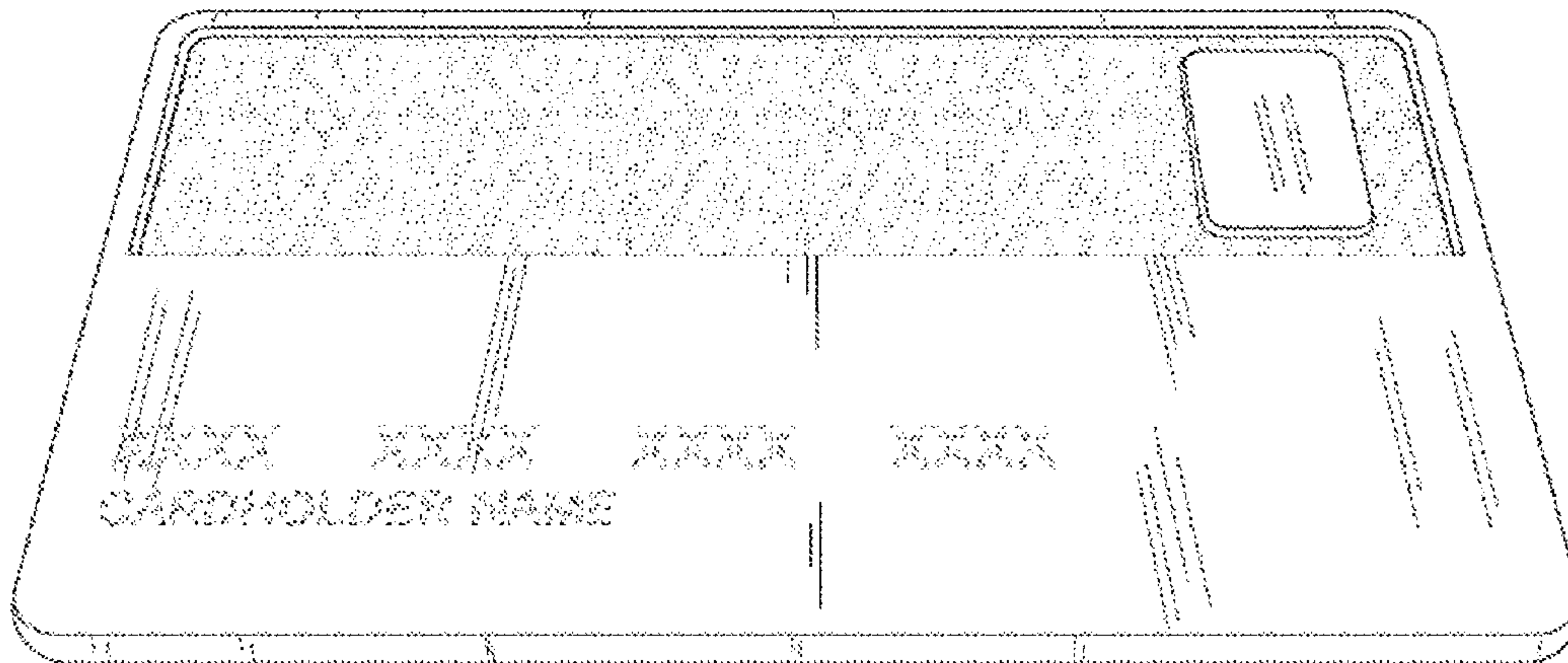

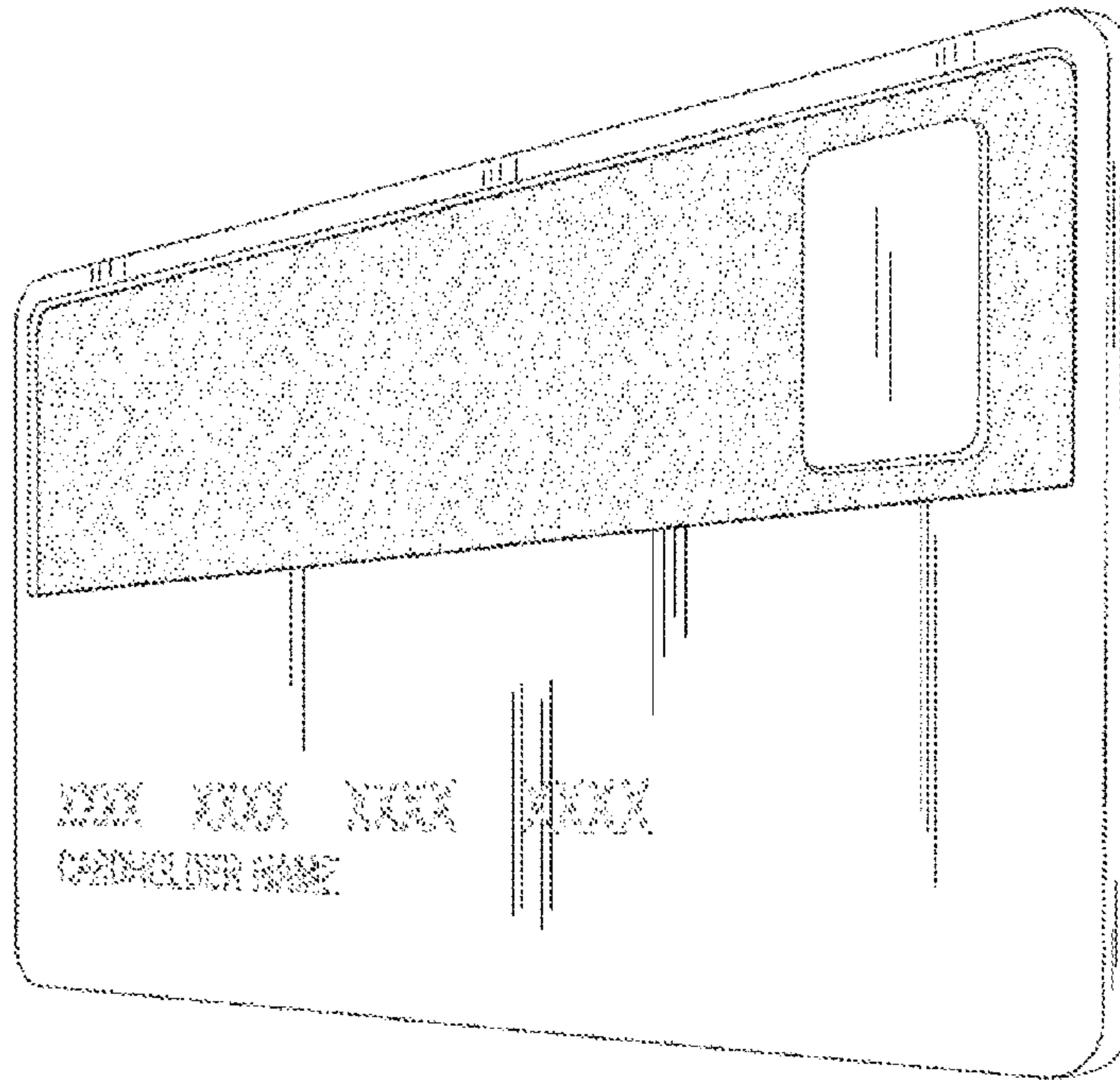

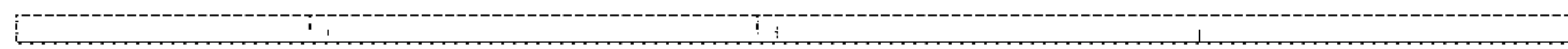

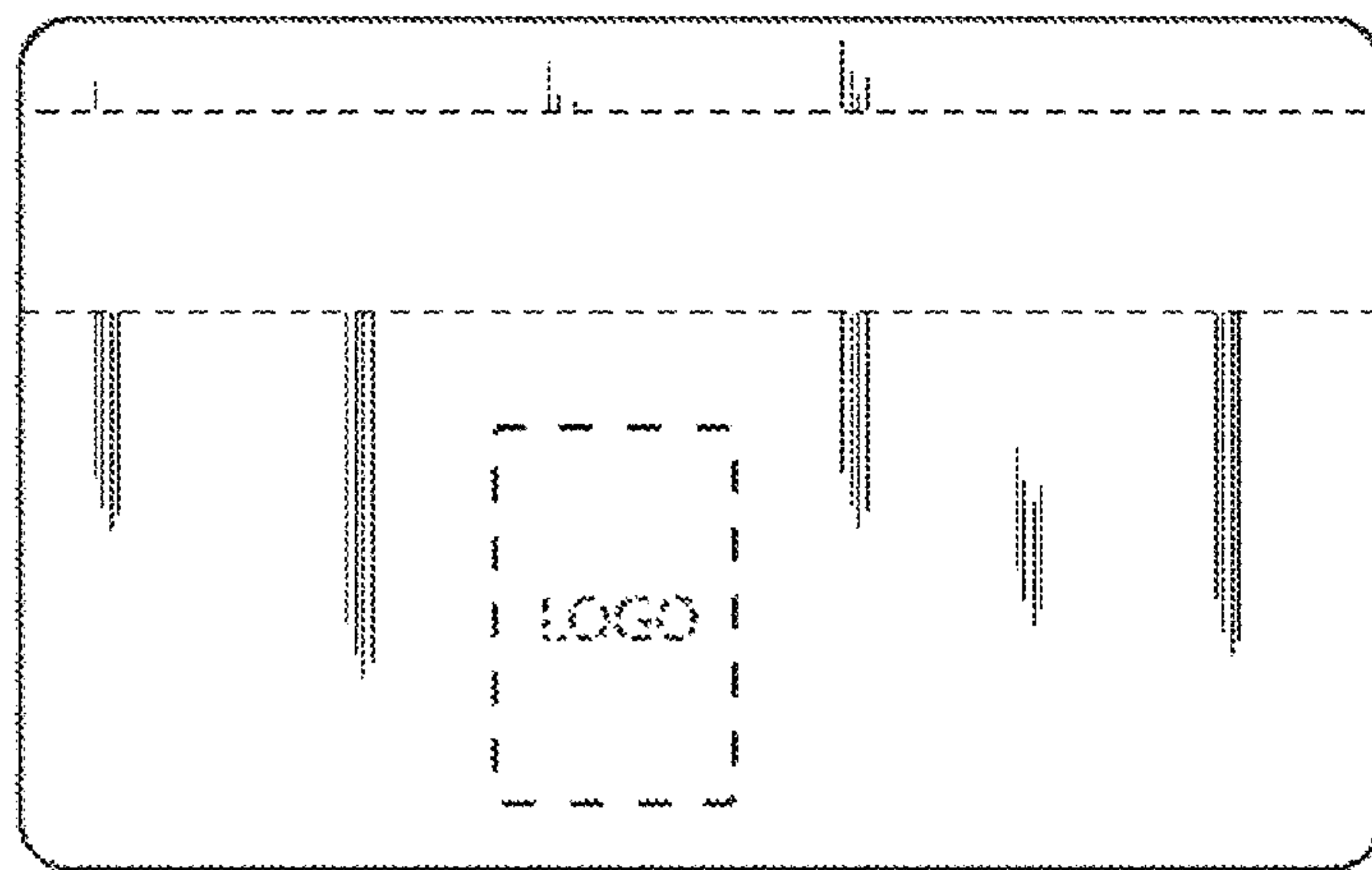

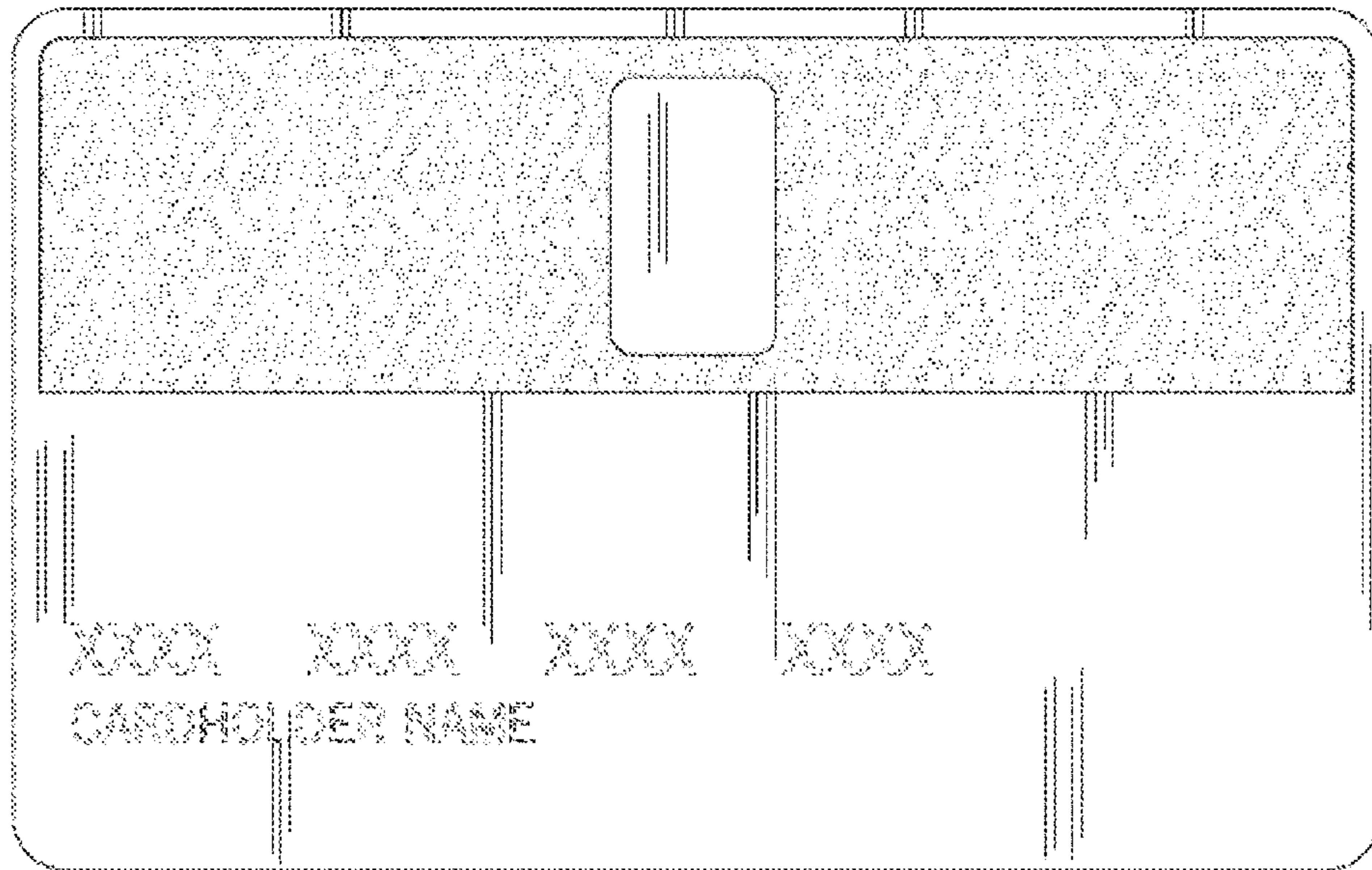

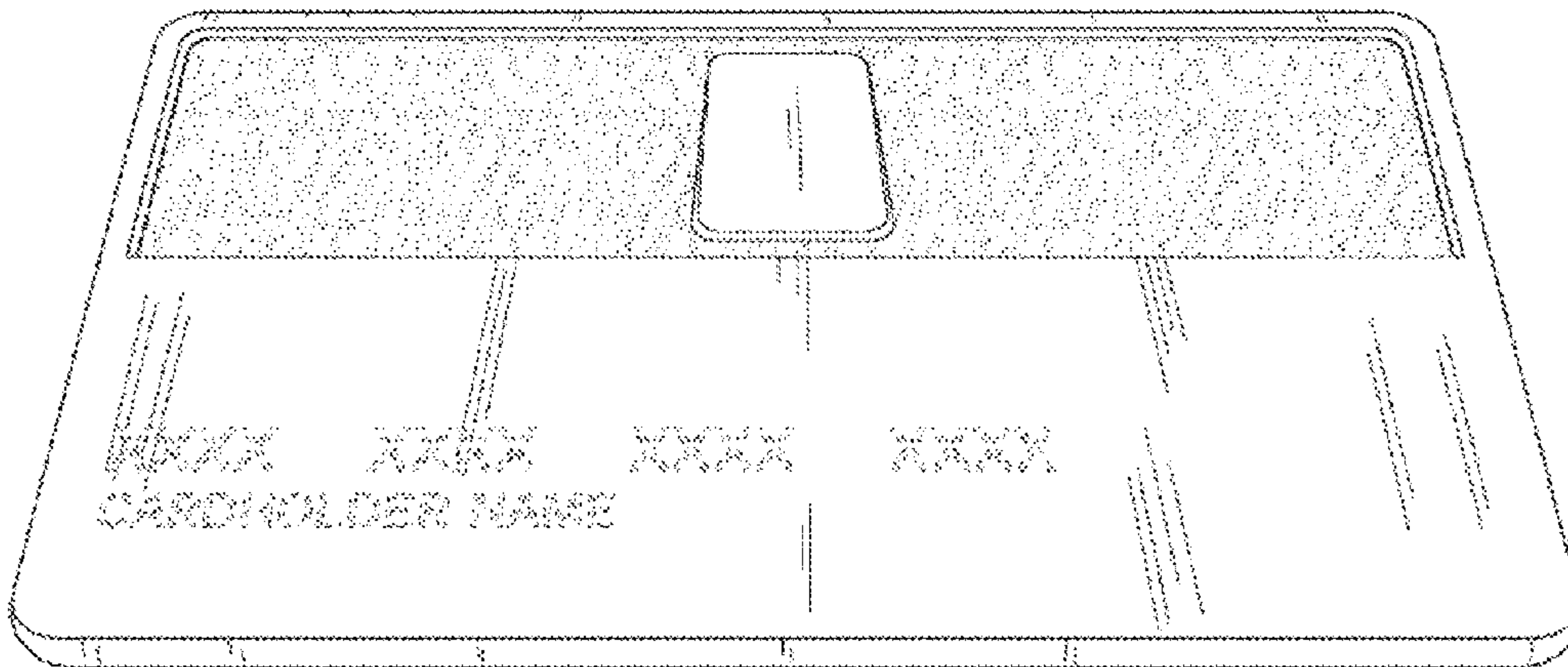

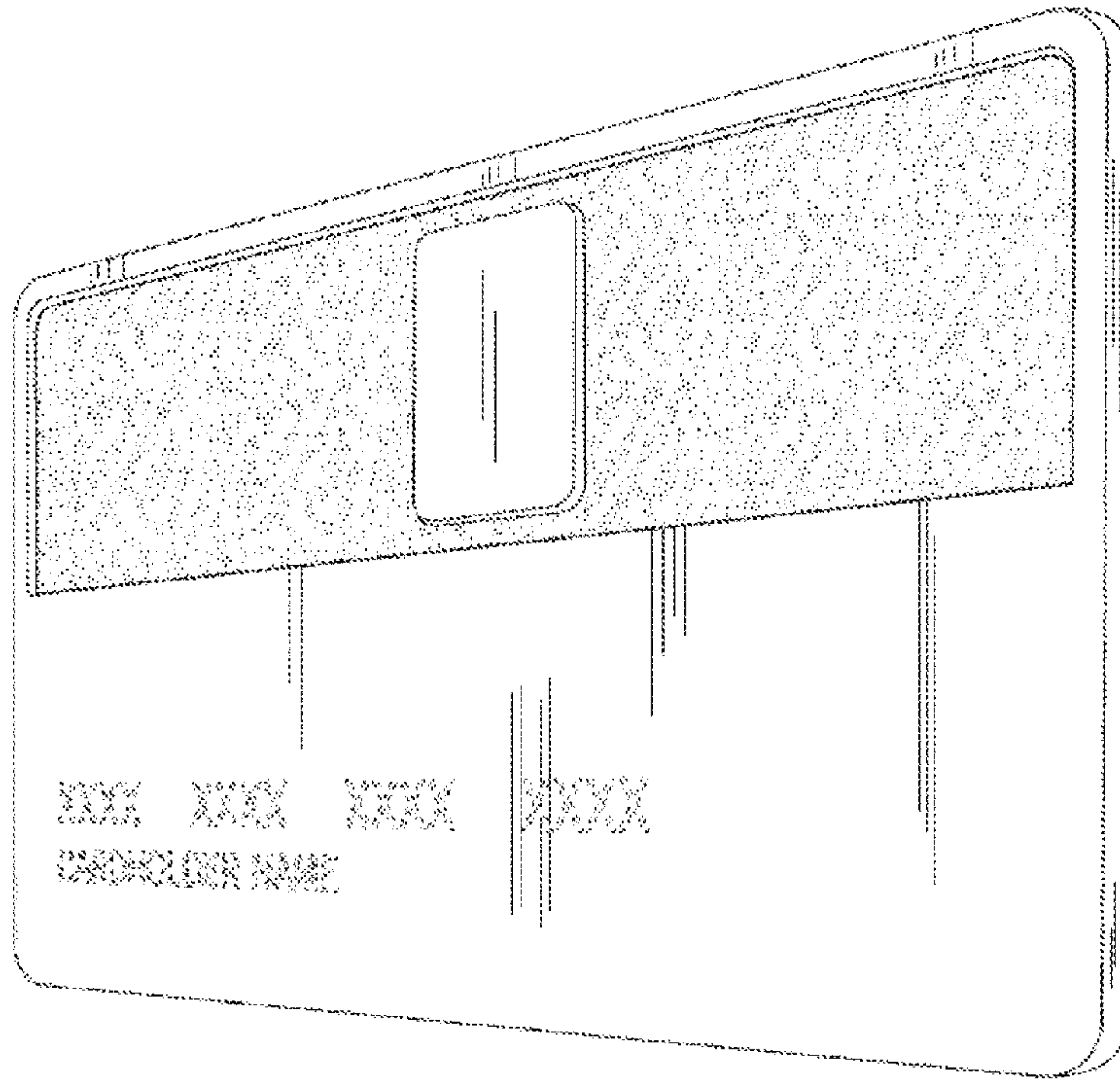

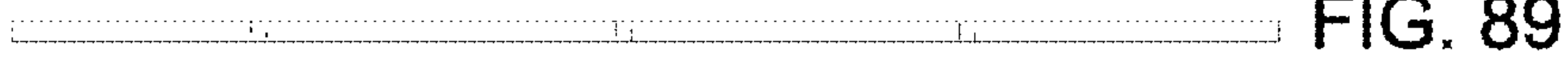

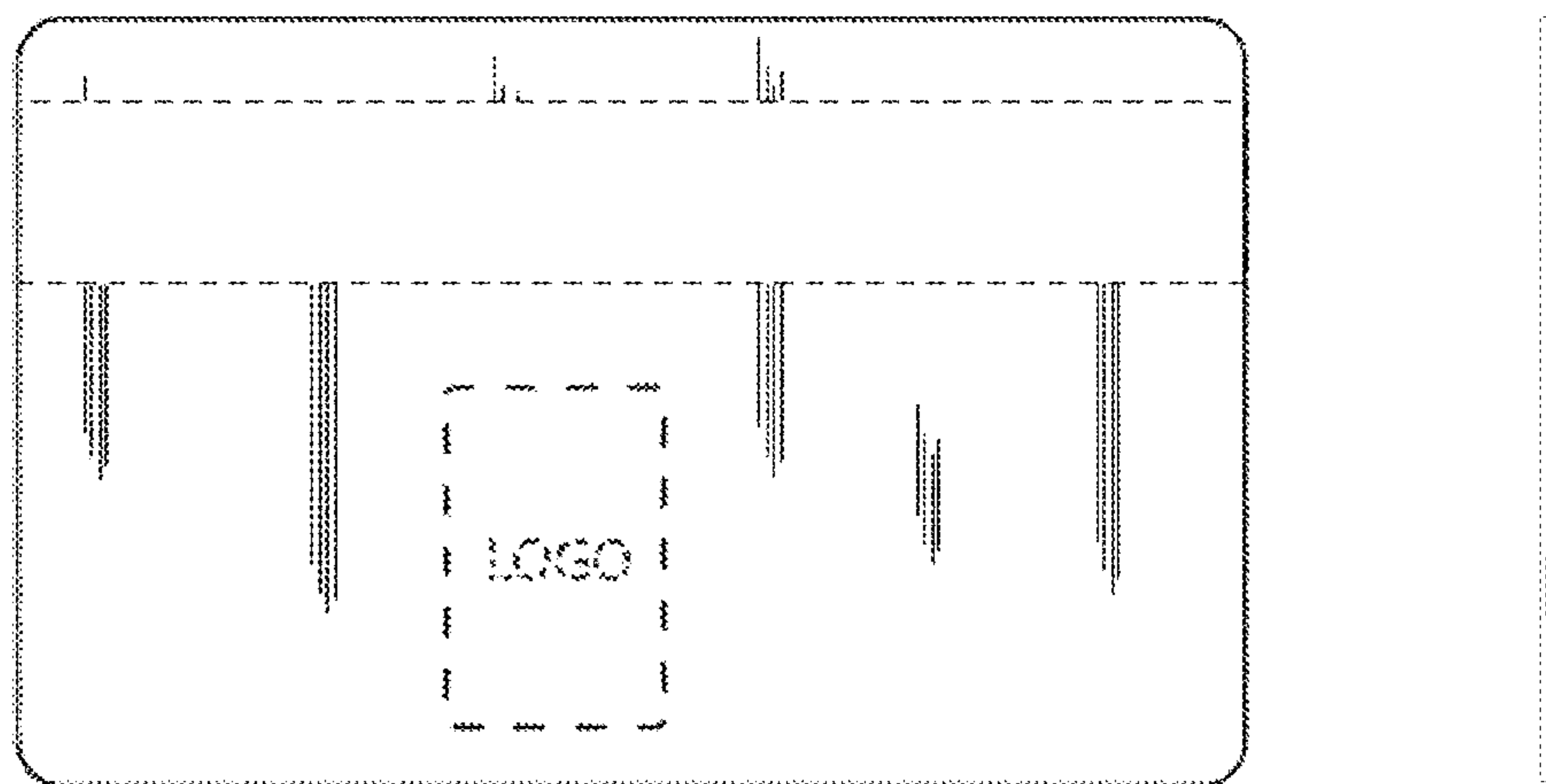

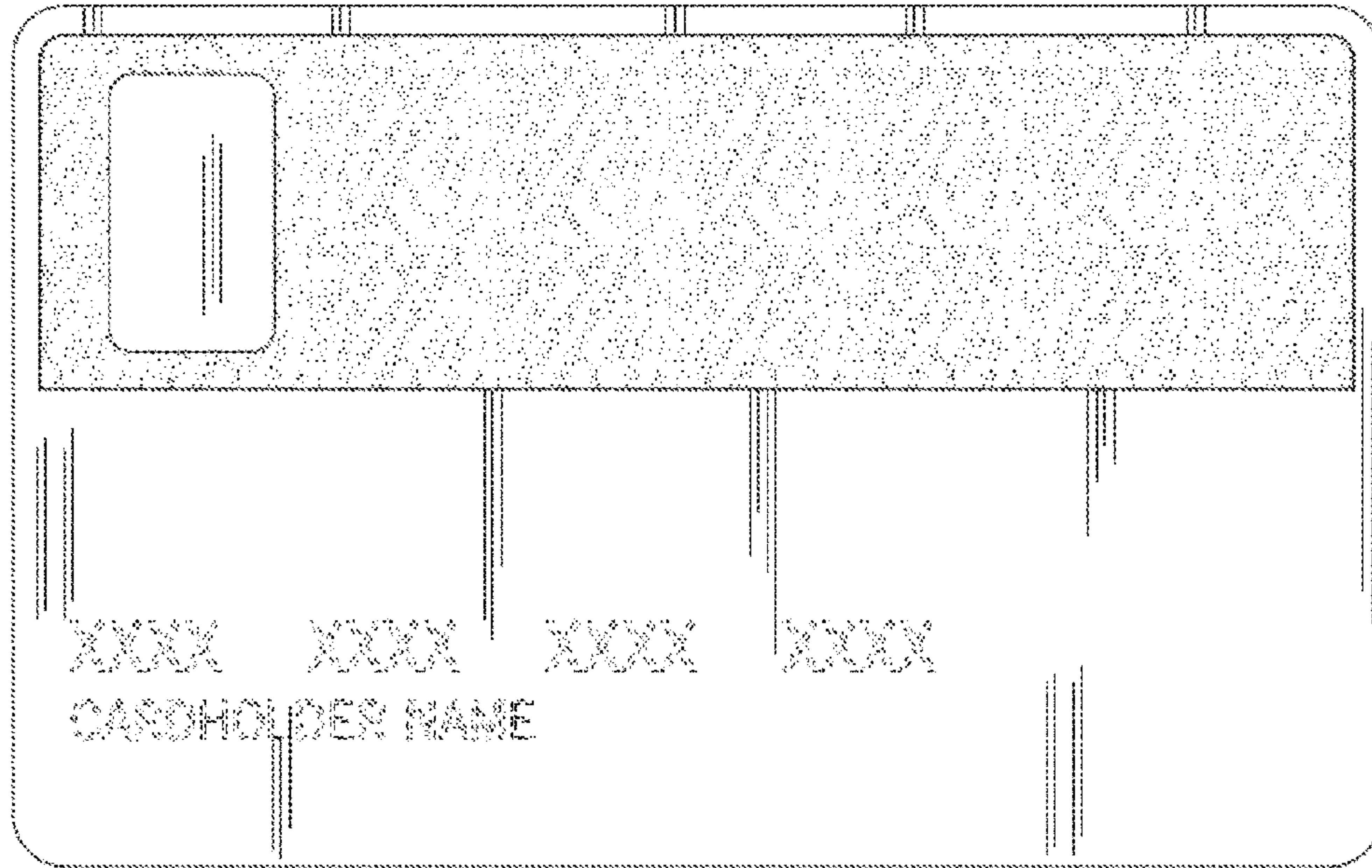

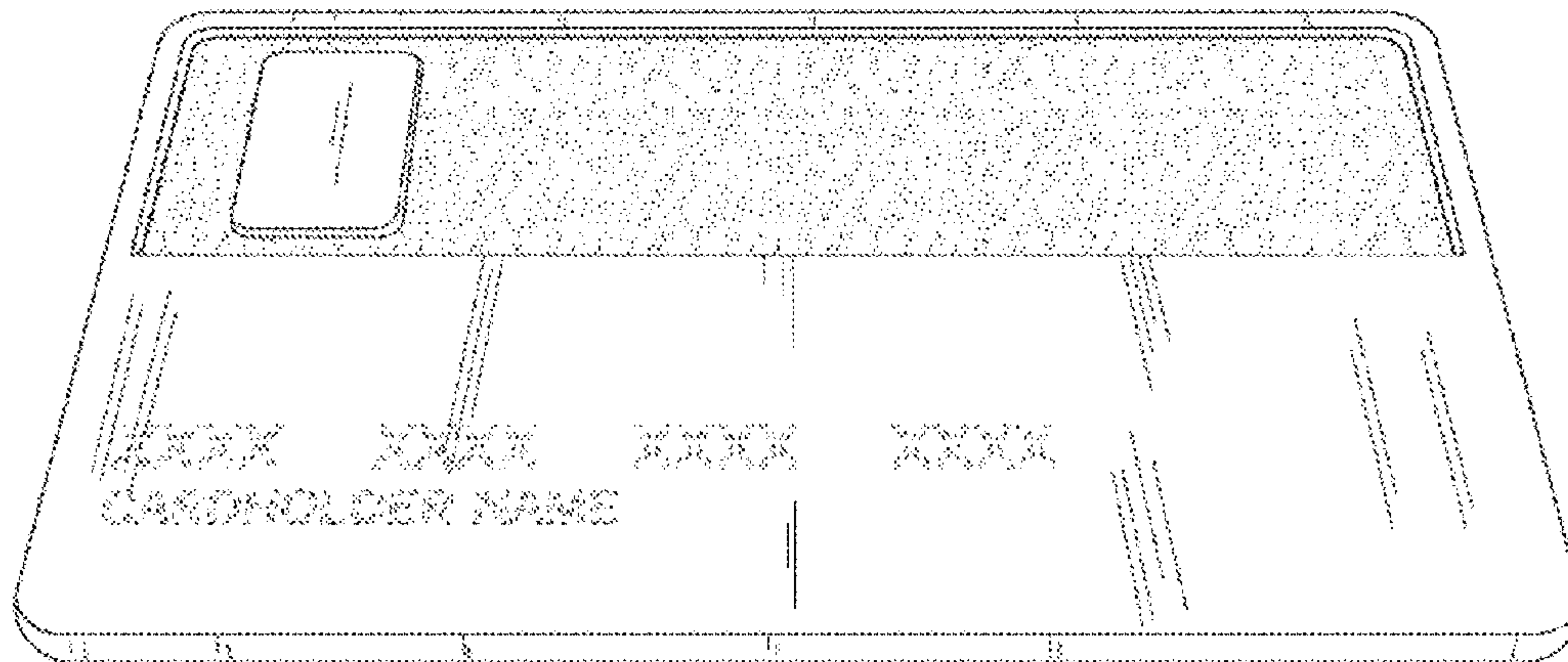

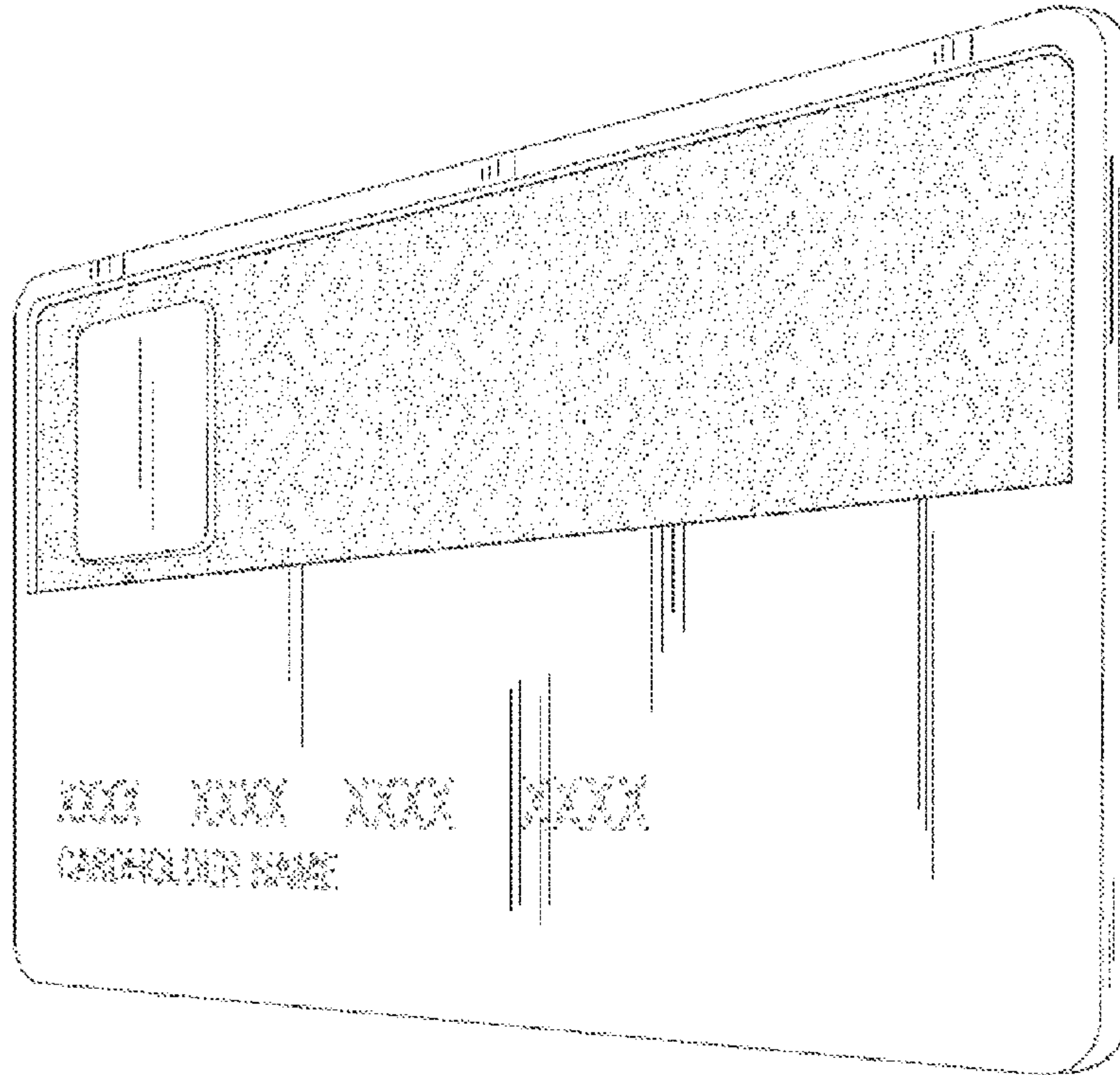

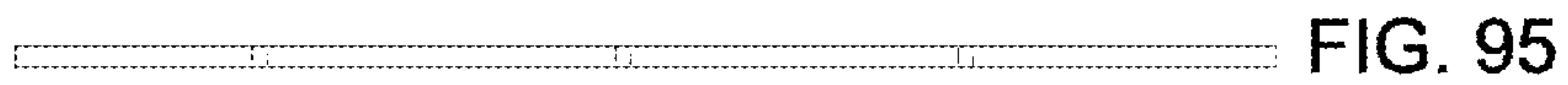

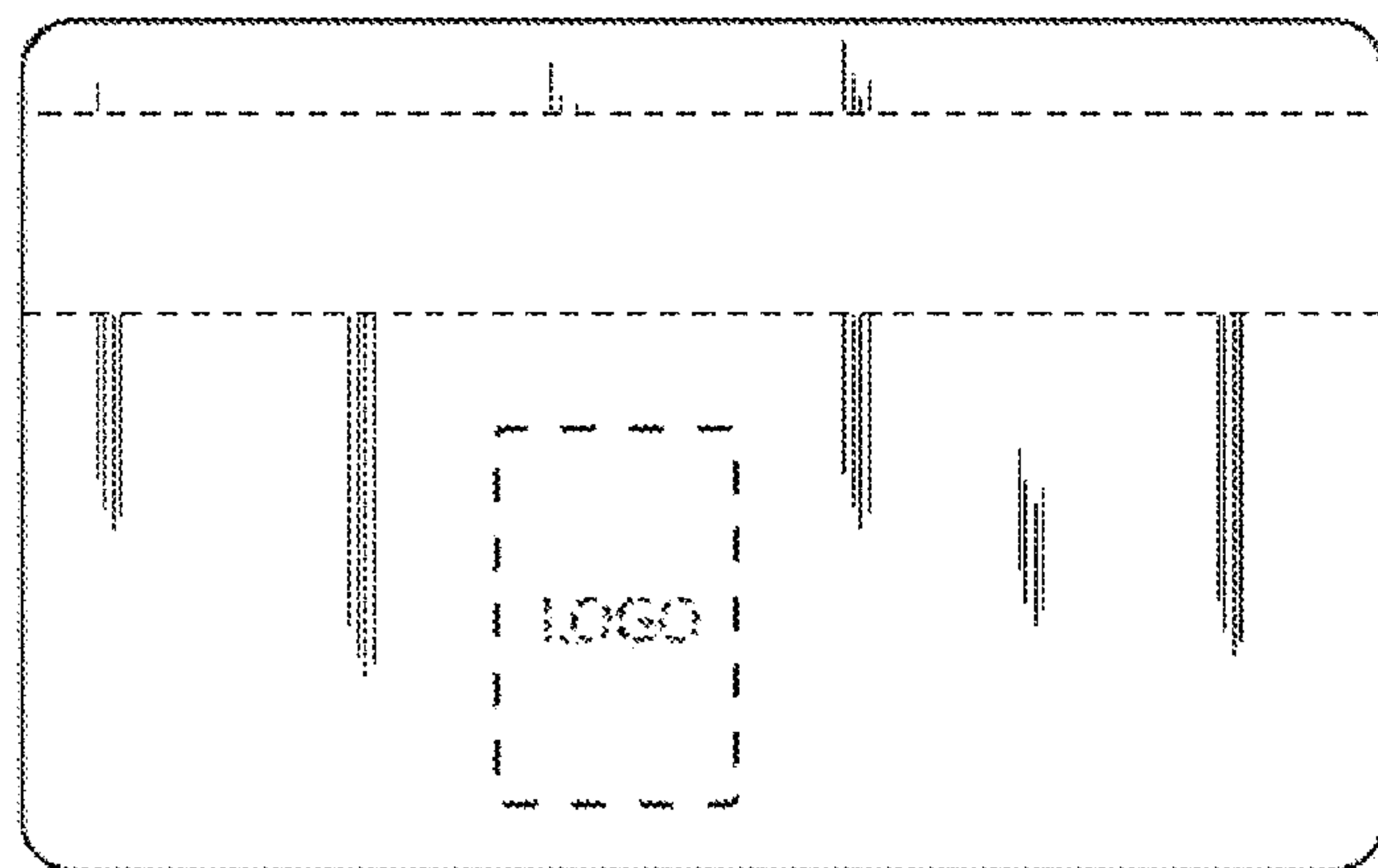
