The ornamental design for a fitting for an air treatment chemical dispenser, as shown and described.

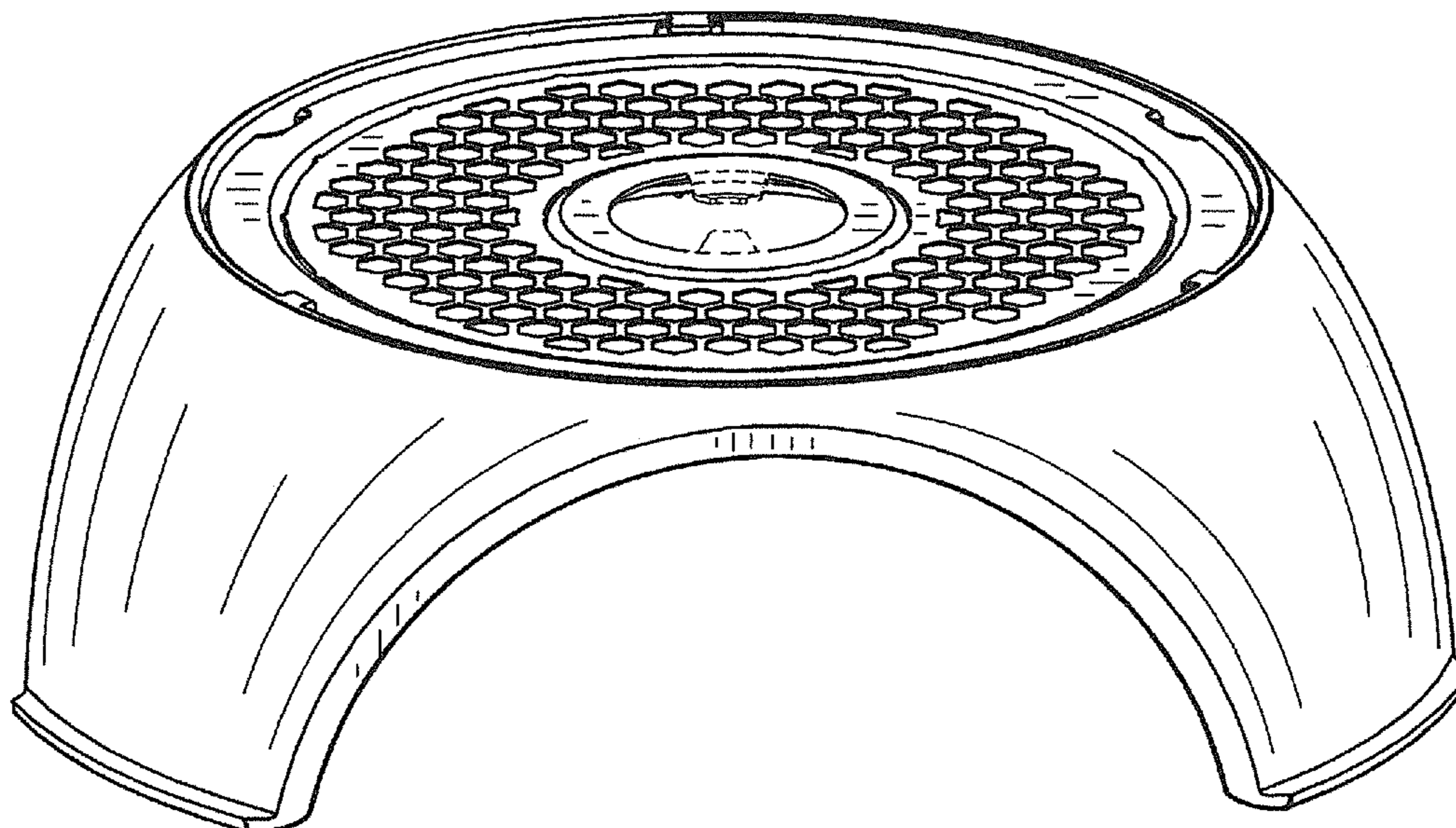
DESCRIPTION

FIG. 1 is a front perspective view of a preferred embodiment of our invention;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

The dotted line representations of the heat dispersal fins in the figures are for purposes of illustration only and form no part of the claimed design.

In a preferred embodiment the fitting is useful in connection with a dispenser that dispenses insect repellent in response to heat, such as that provided by a lit candle.

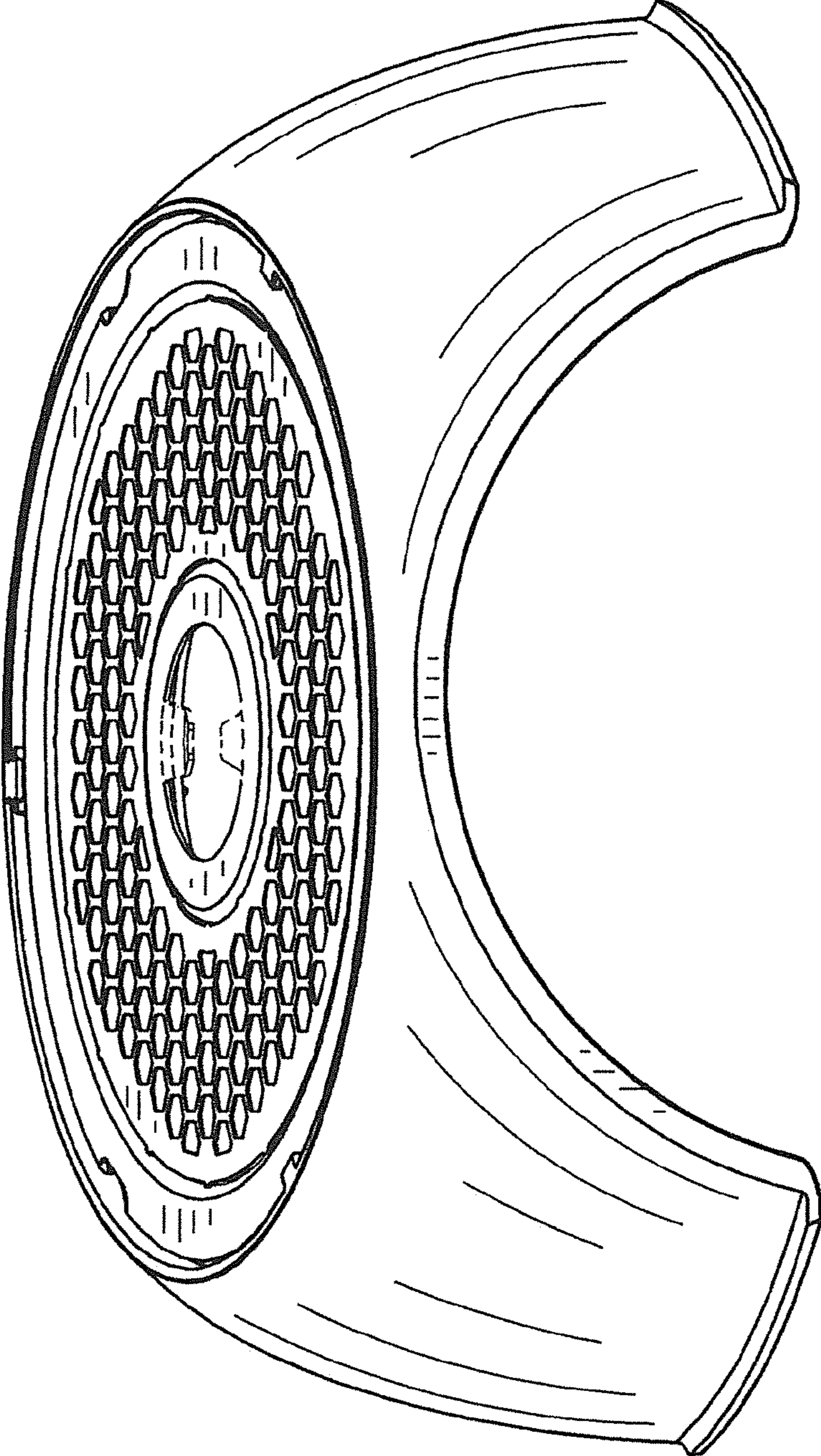

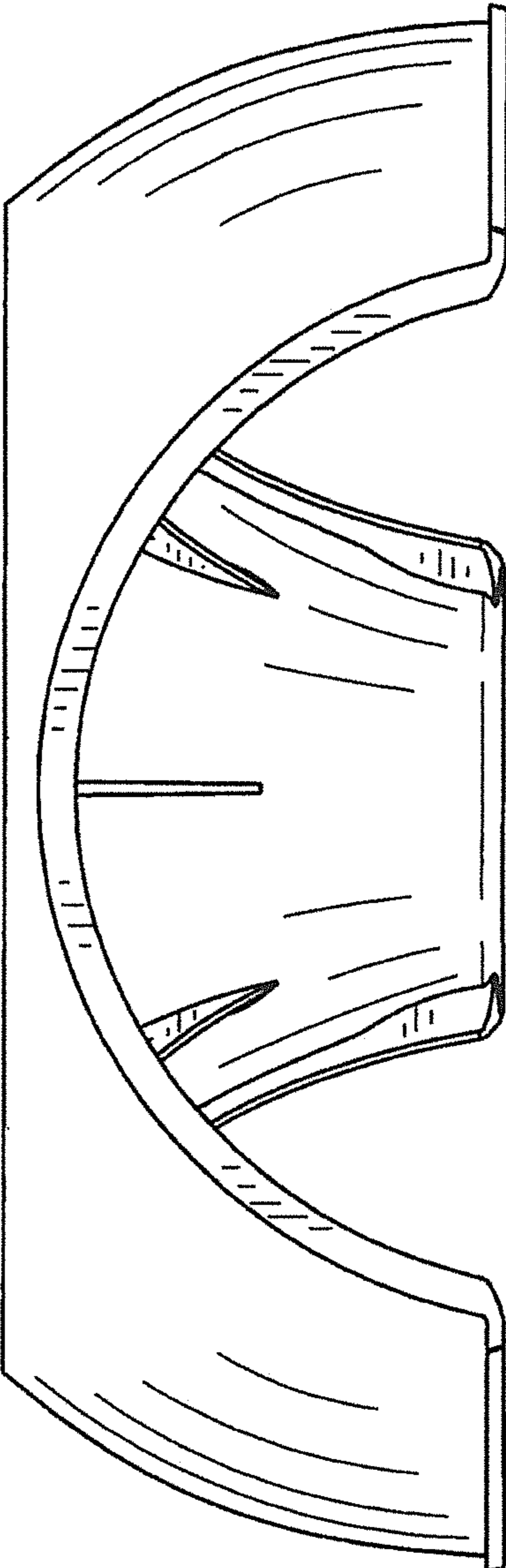

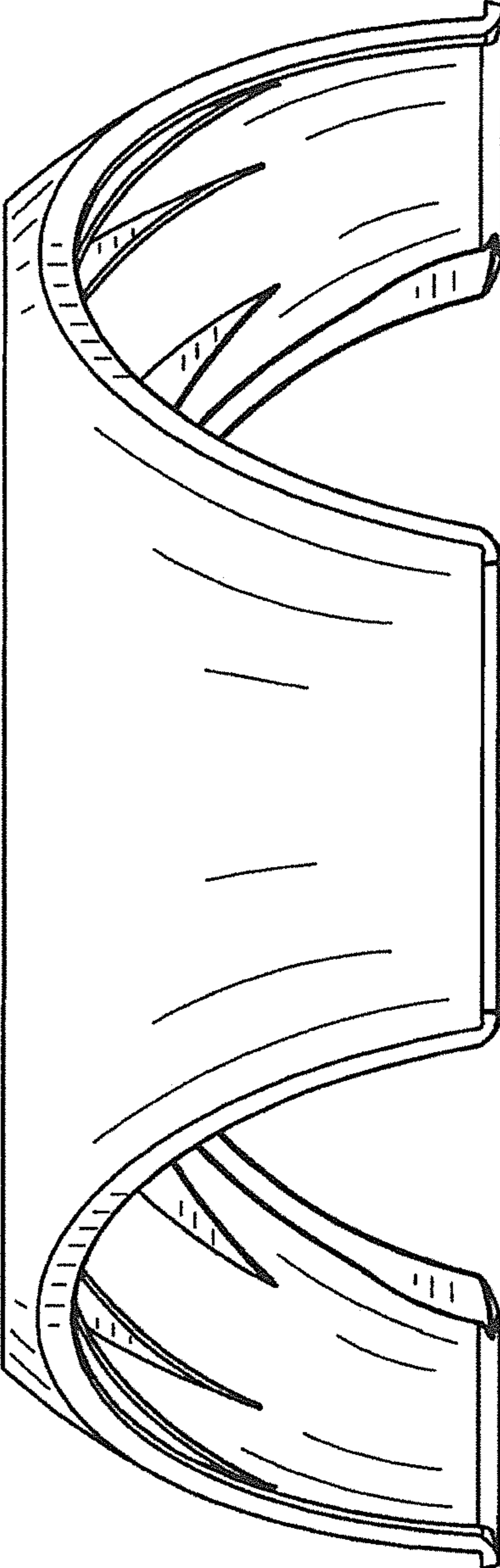

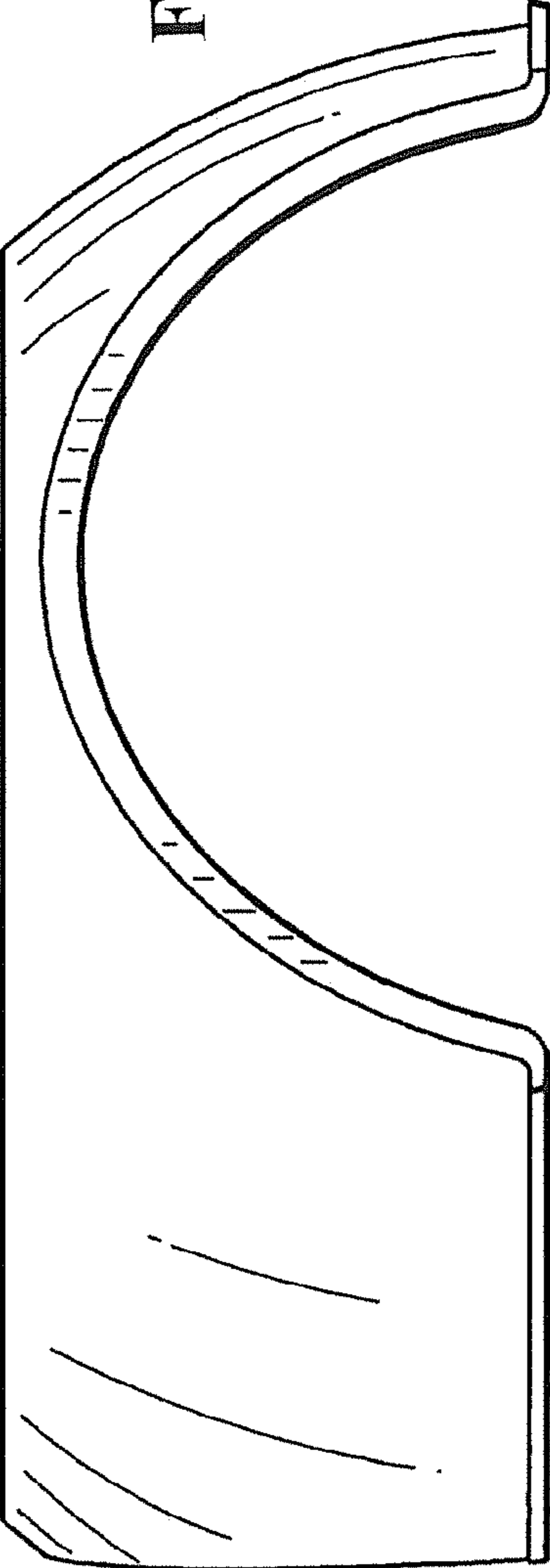
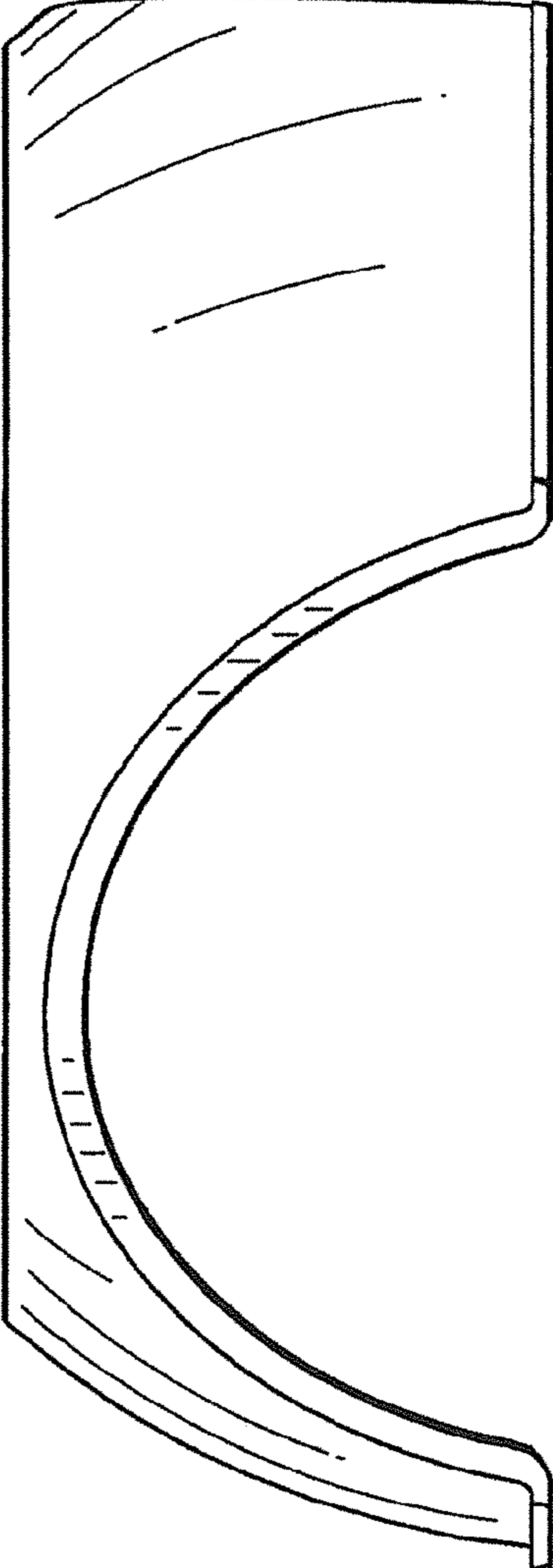

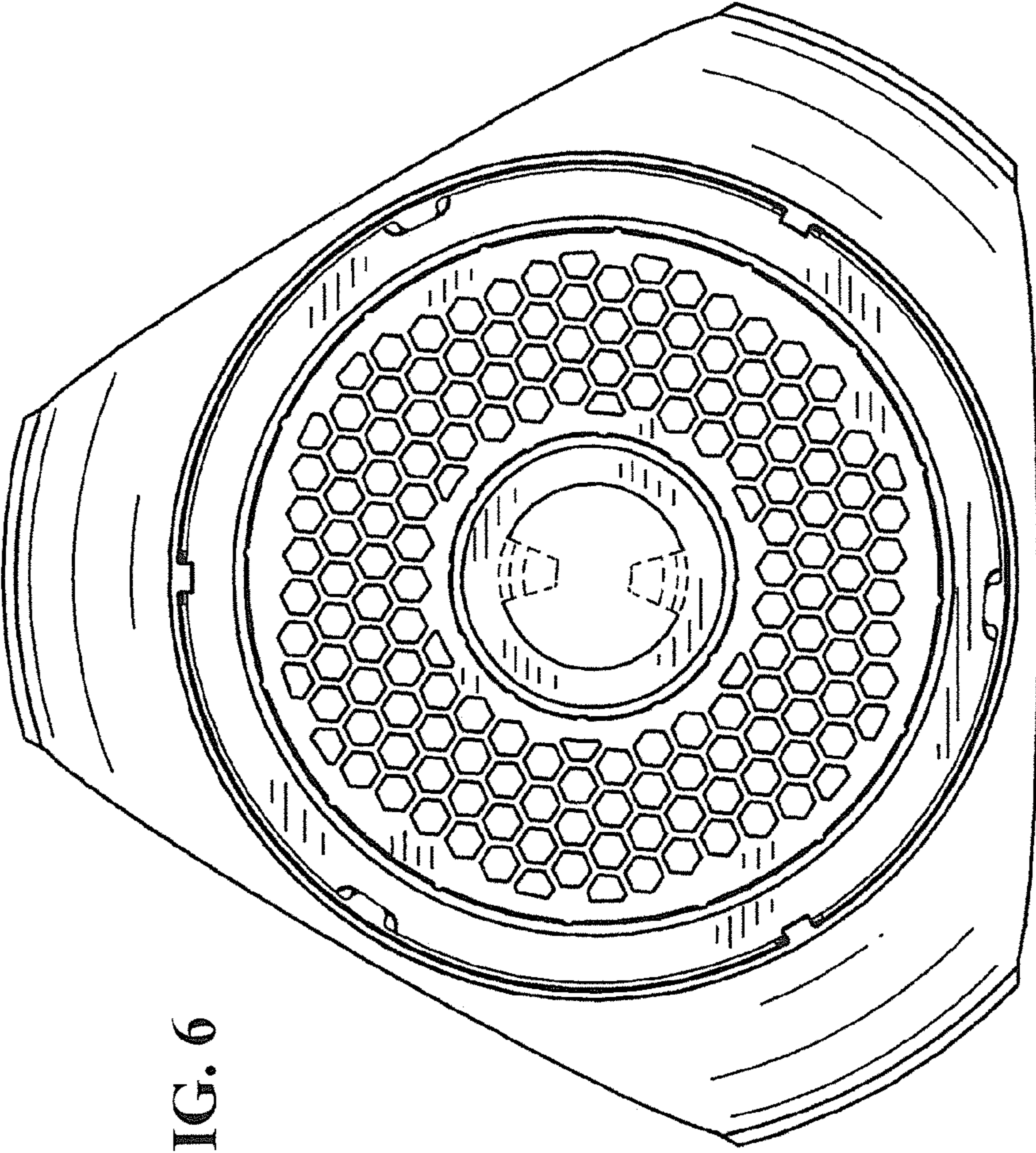

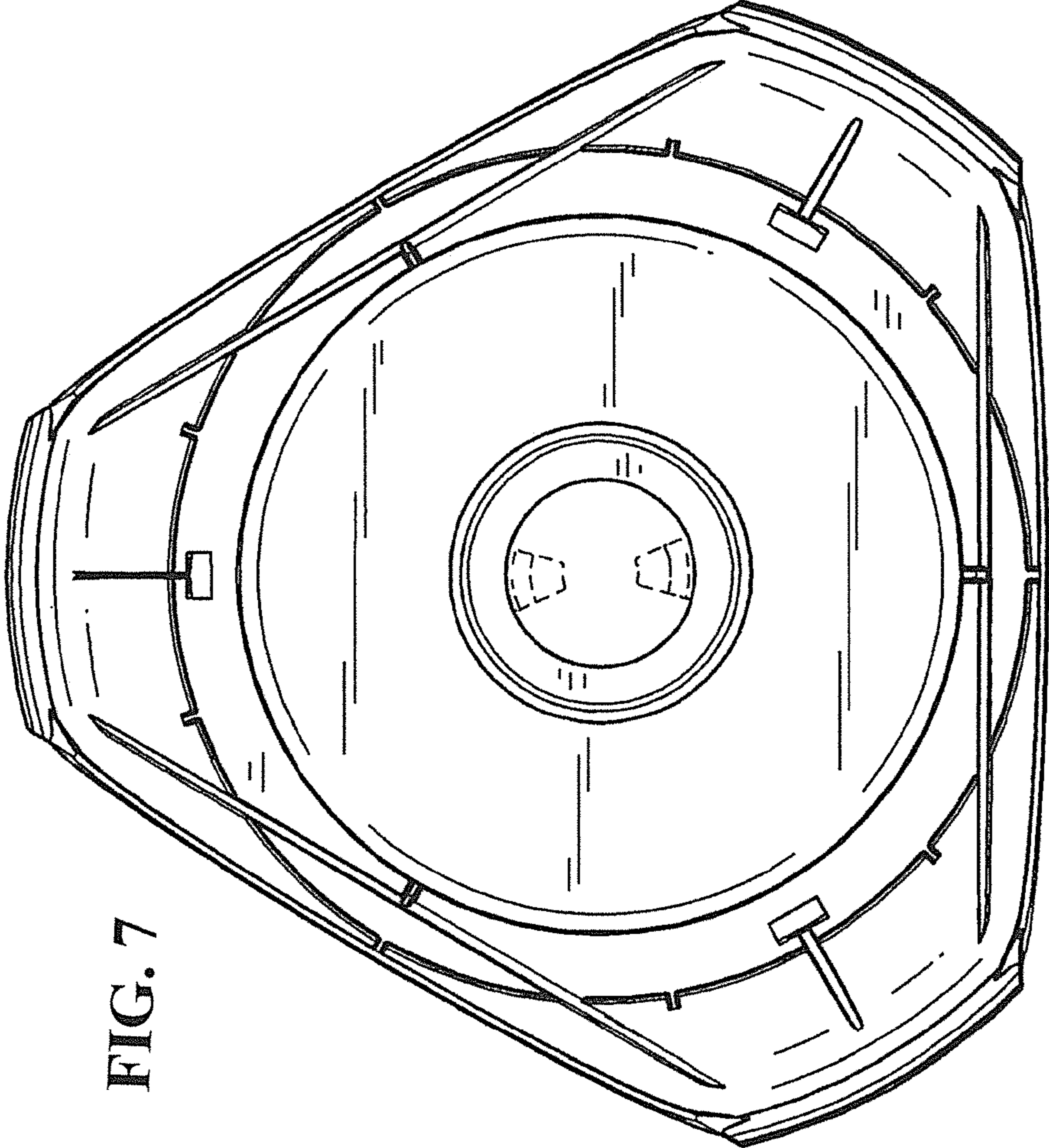
