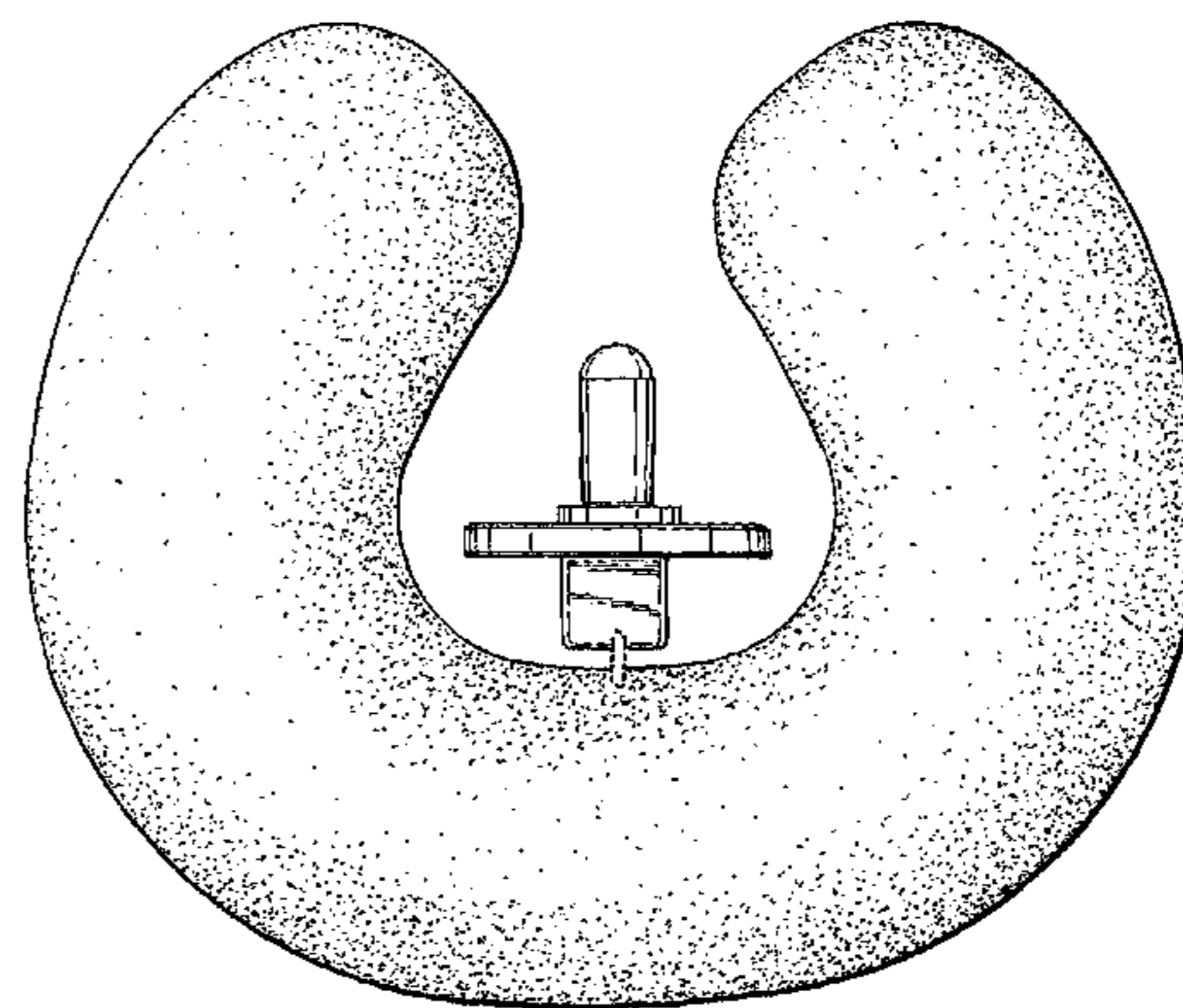
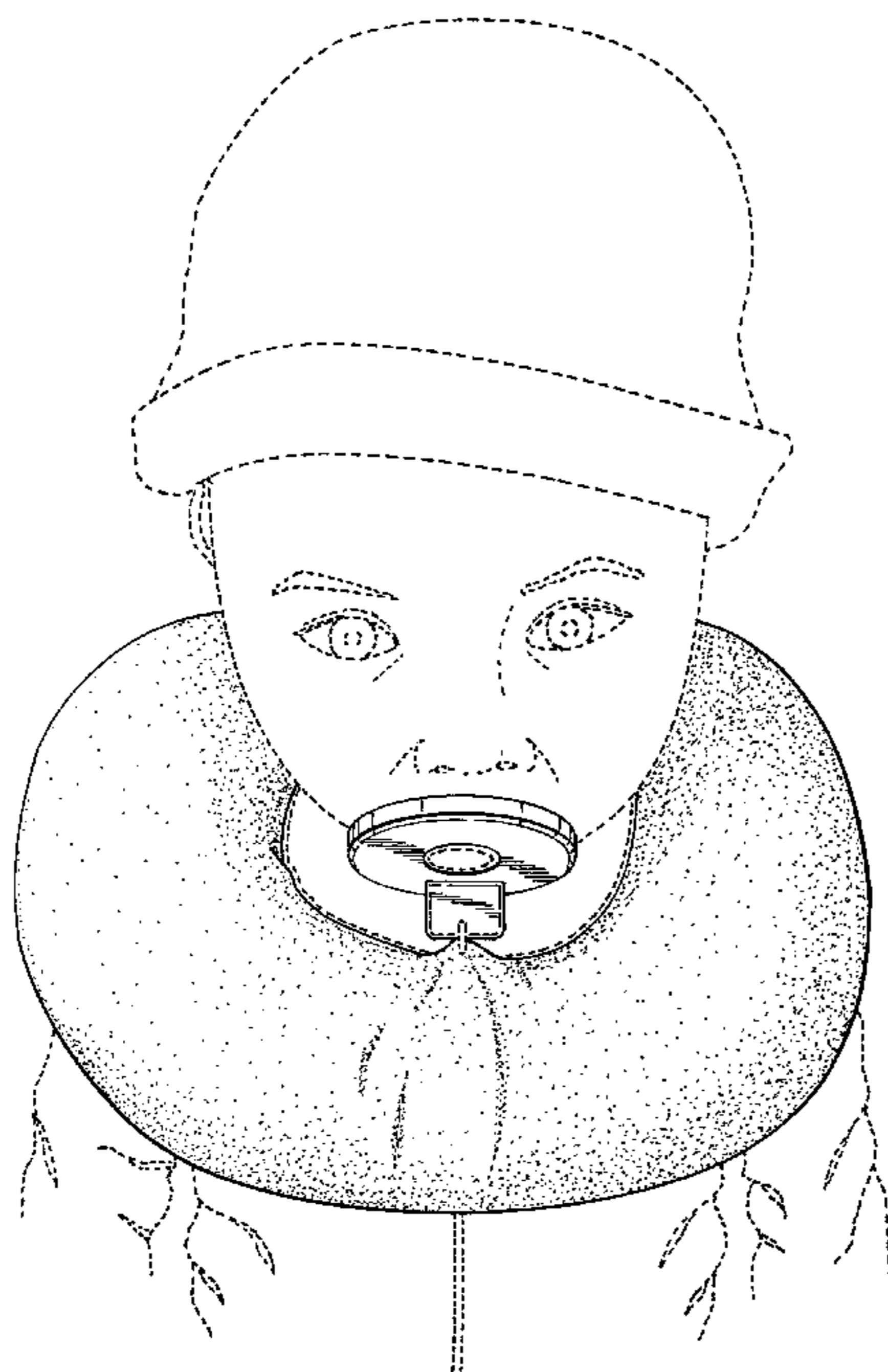
(57) **CLAIM**

The ornamental design for a pacifier pillow, as shown and described.

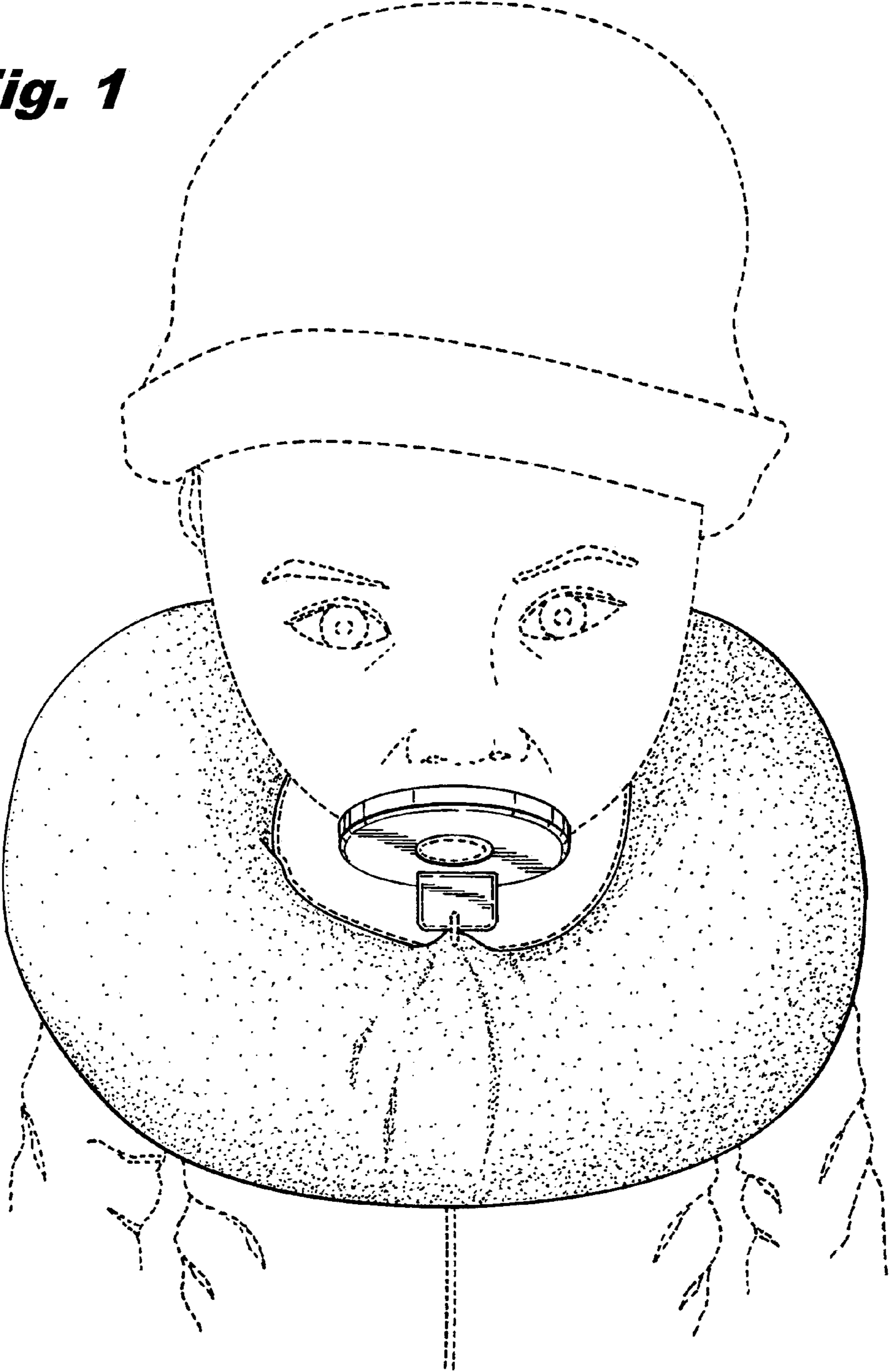
**DESCRIPTION**

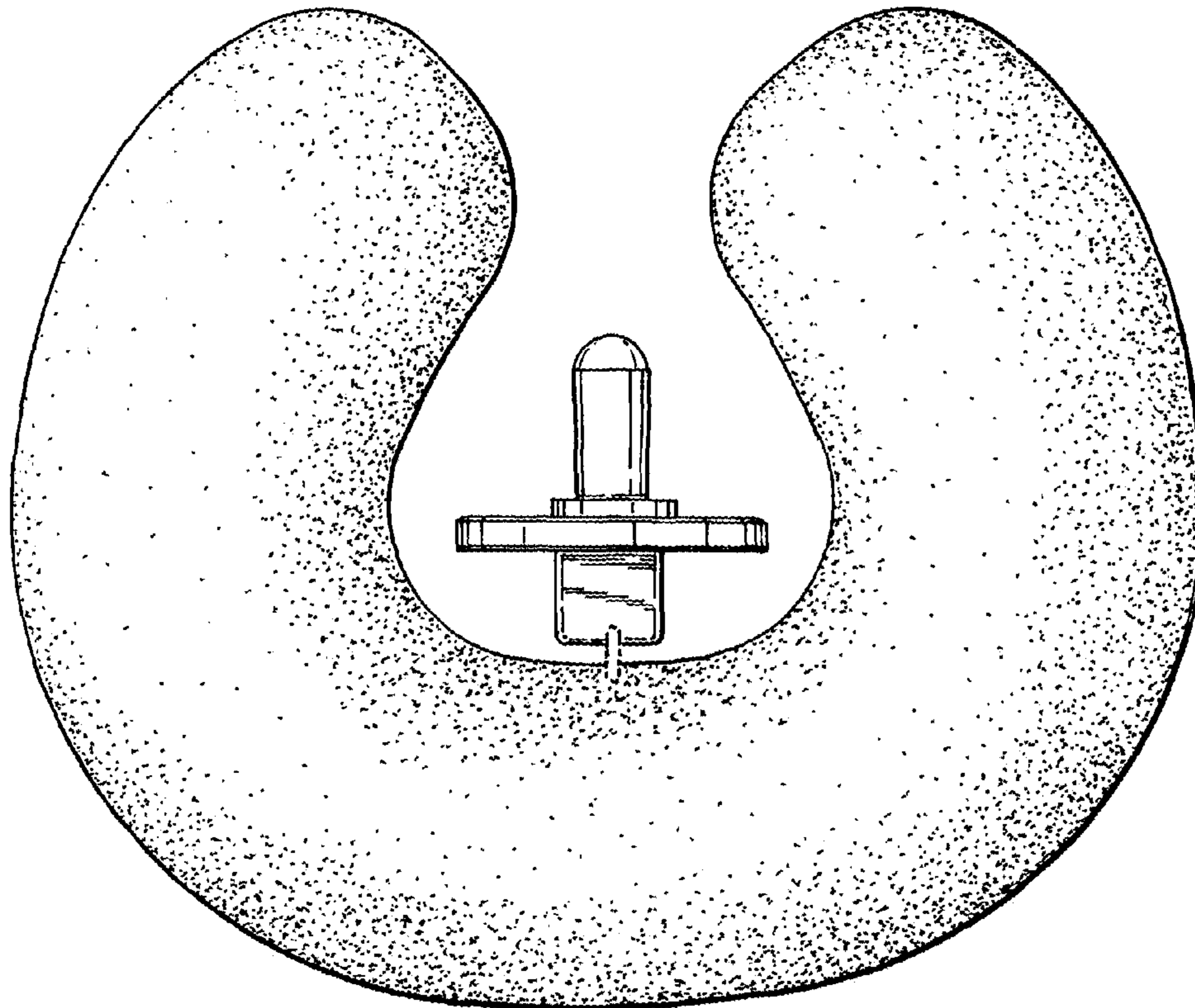
FIG. 1 is a top-front perspective view of a pacifier pillow, showing our new design;

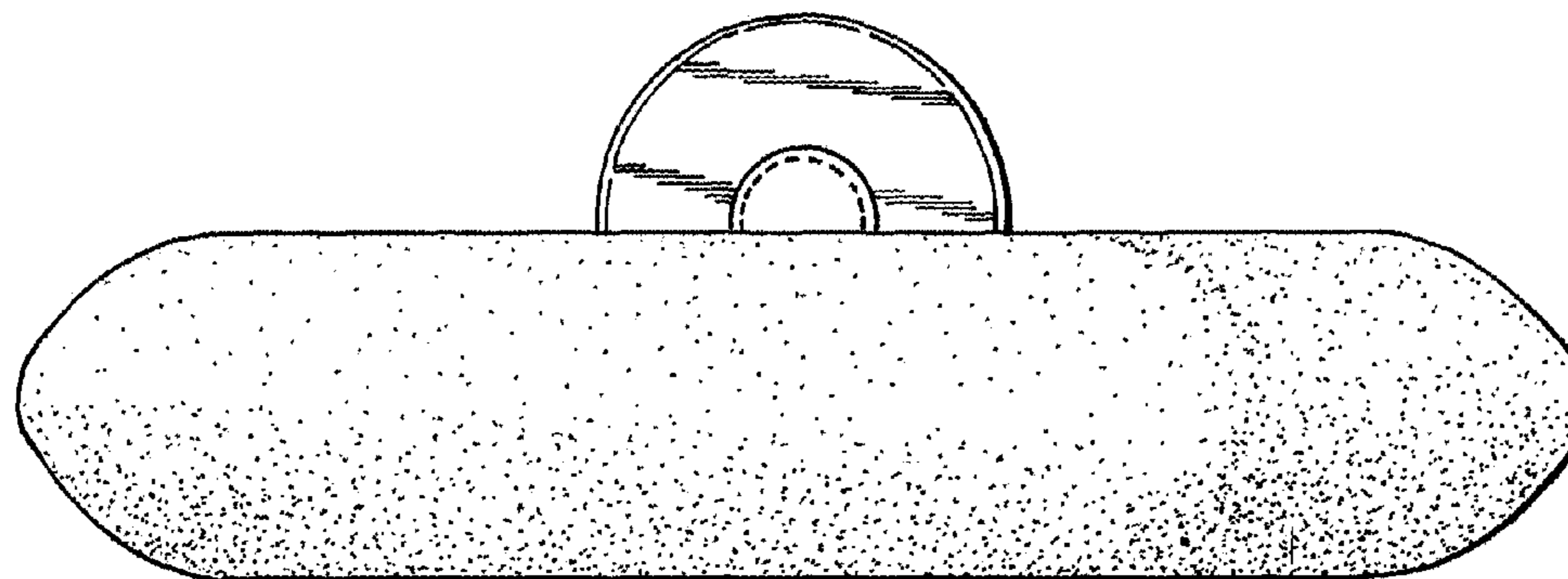

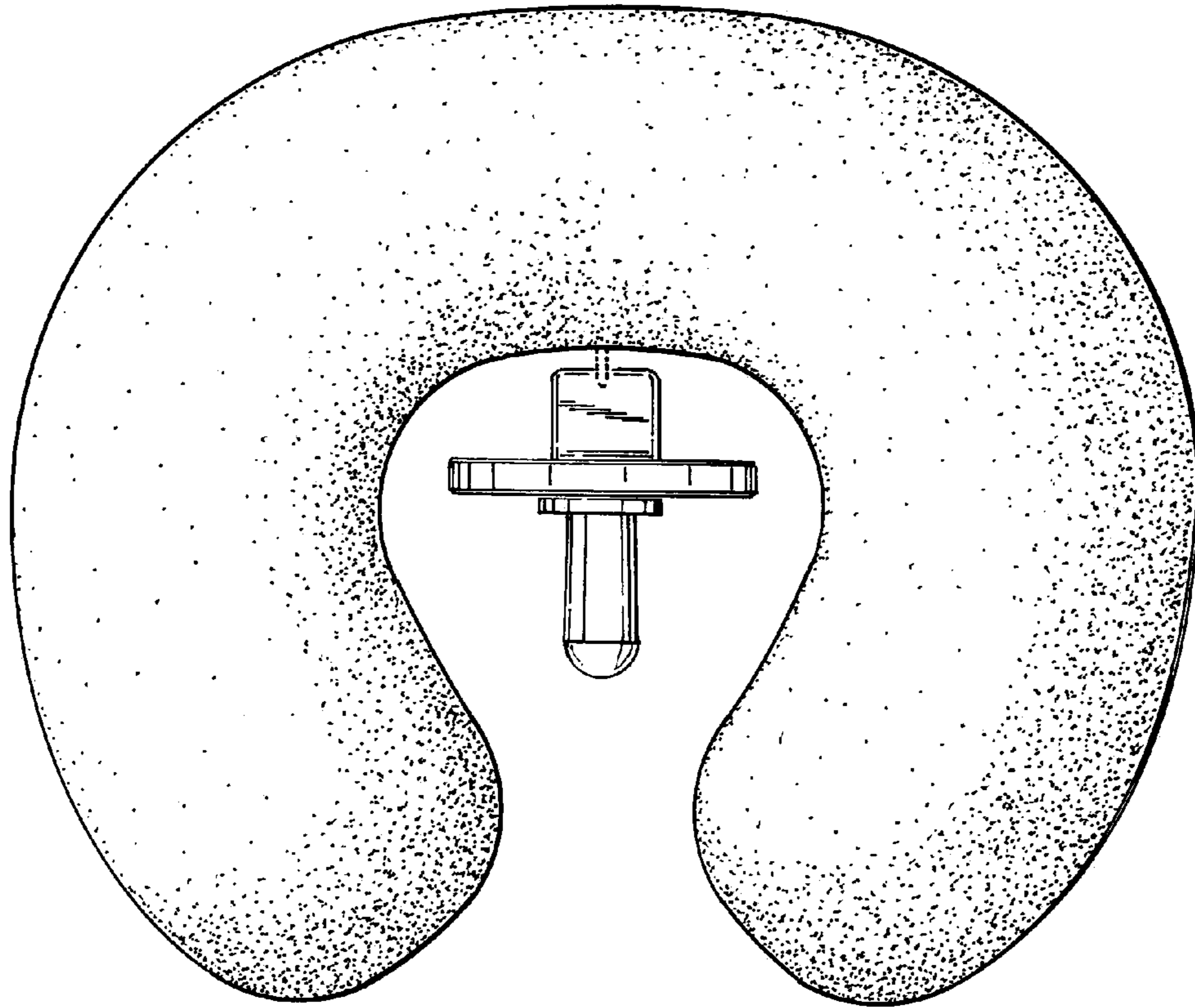

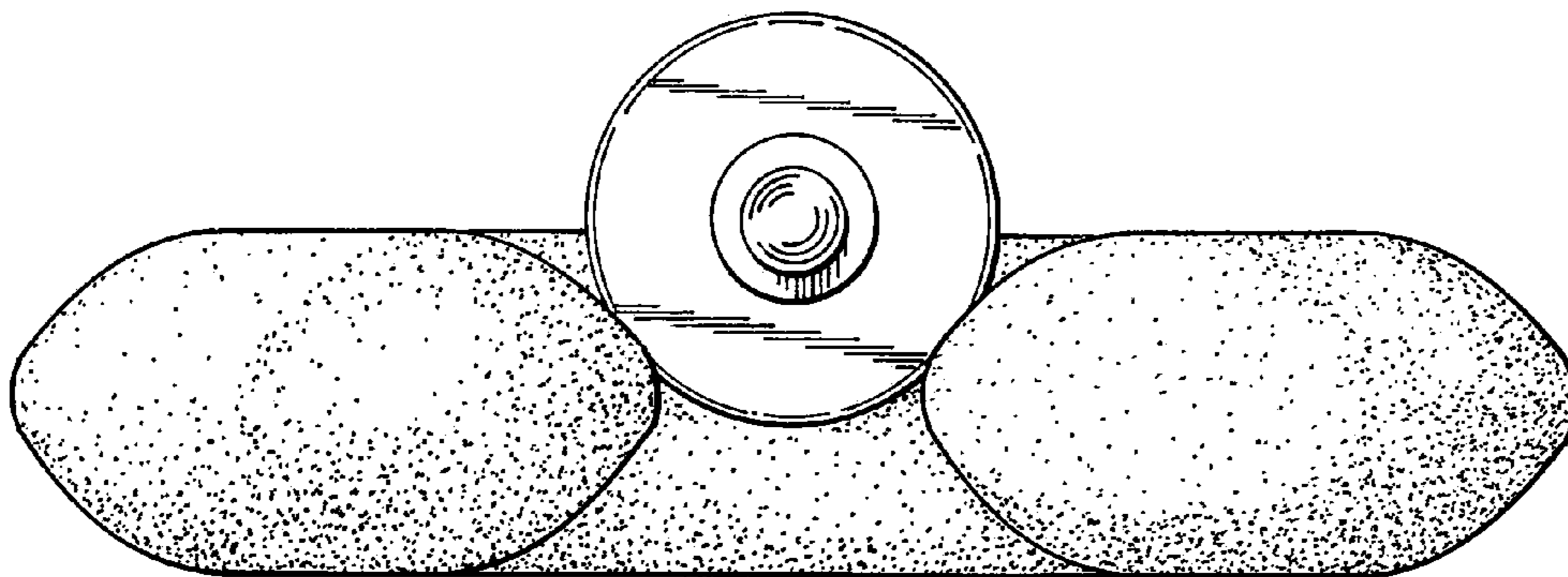

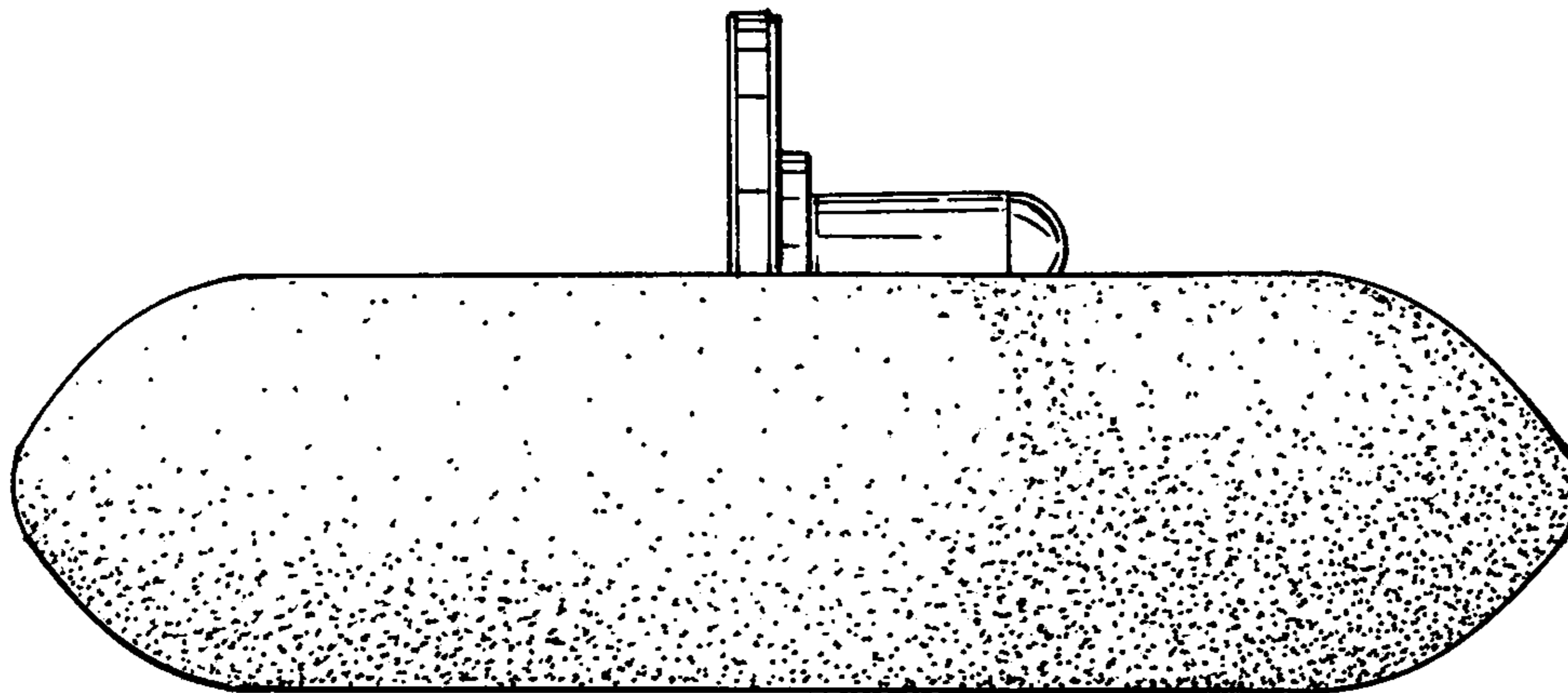




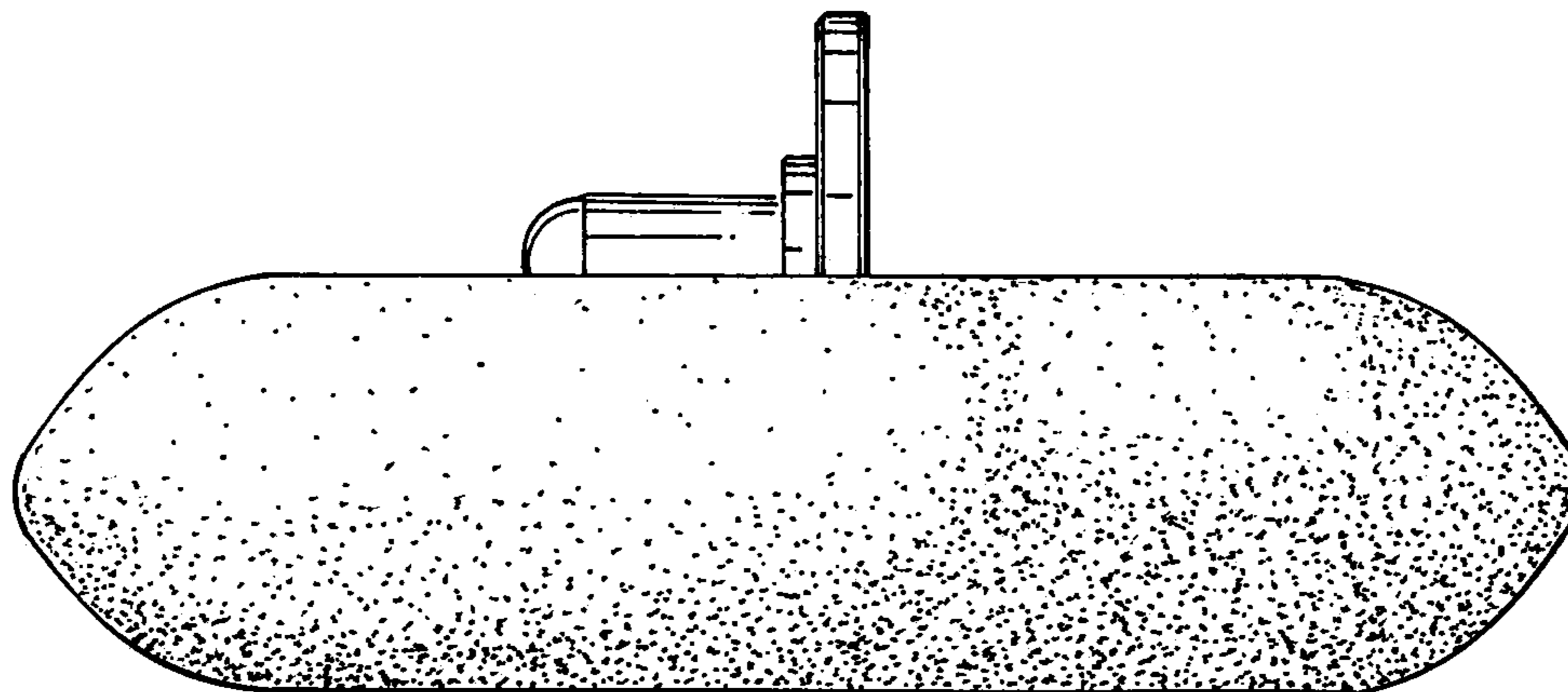
