(57) **CLAIM**

The ornamental design for a packaged food article, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the packaged food article according to a preferred embodiment of my new design.

FIG. 2 is a left side view of the packaged food article as in FIG. 1.

FIG. 3 is a right side view of the packaged food article as in FIGS. 1-2,

FIG. 4 is a top view of the packaged food article as in FIGS. 1-3.

FIG. 5 is a bottom view of the packaged food article as in FIGS. 1-4.

FIG. 6 is a bottom perspective view of the packaged food article as in FIGS. 1-5 with package dosed.

FIG. 7 is a top perspective view of the packaged food article as in FIGS. 1-6 with package partially open to expose the food article.

FIG. 8 is a top perspective view of an alternate embodiment of the packaged food article.

FIG. 9 is a left side view of the packaged food article as in FIG. 8.

FIG. 10 is a right side view of the packaged food article as in FIGS. 8-9,

FIG. 11 is a top view of the packaged food article as in FIGS. 8-10.

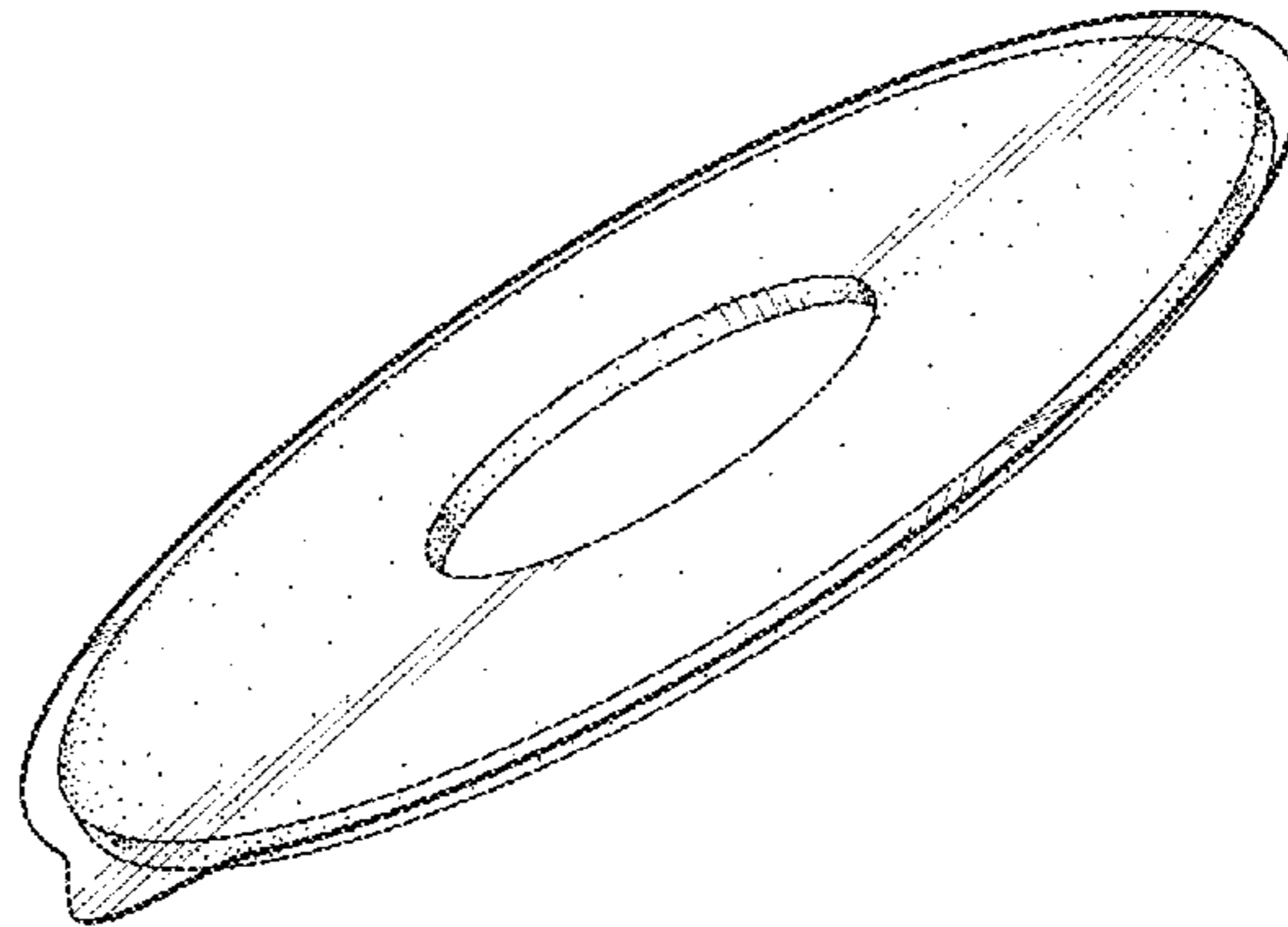
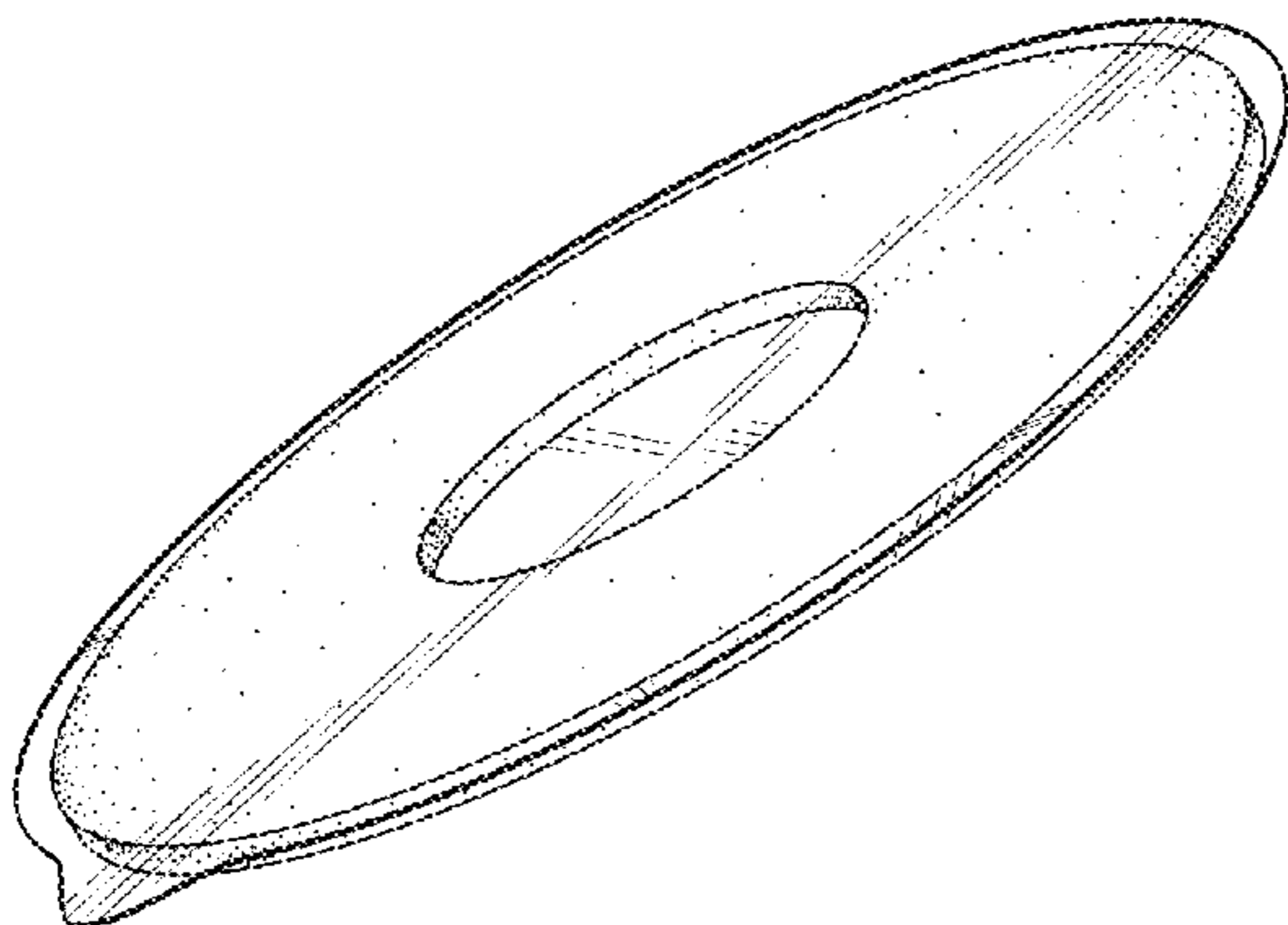
FIG. 12 is a bottom view of the packaged food article as in FIGS. 8-11.

FIG. 13 is a bottom perspective view of the packaged food article as in FIGS. 8-12 with package closed; and,

FIG. 14 is a top perspective view of the packaged food article as in FIGS. 8-13 with package partially open to expose the food article.

The design of the present invention and as shown in FIGS. 1-14 is a packaged food article having an ornamental annular appearance.

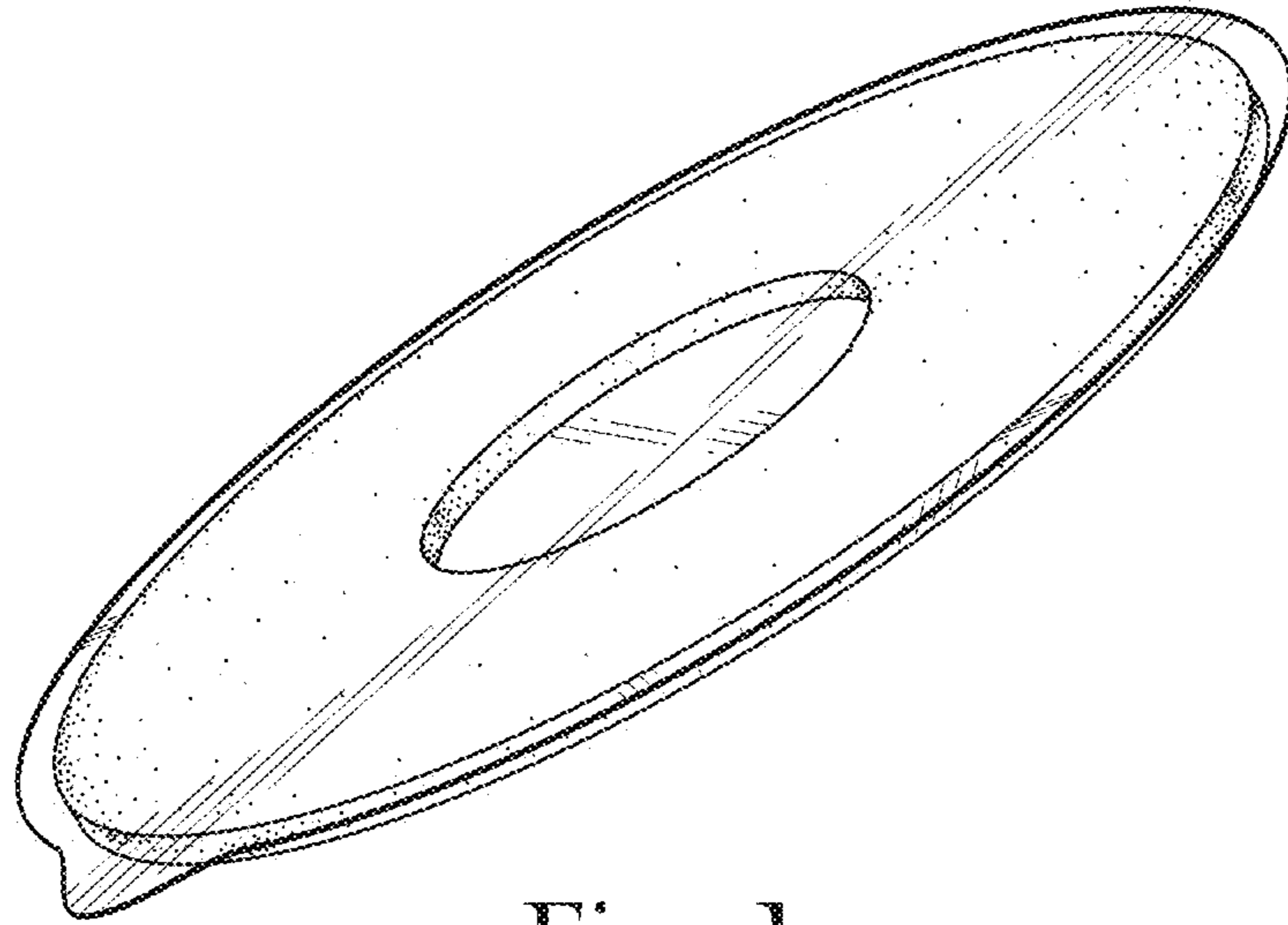

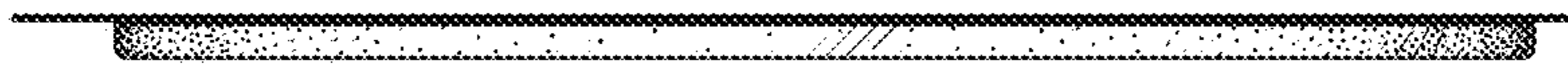

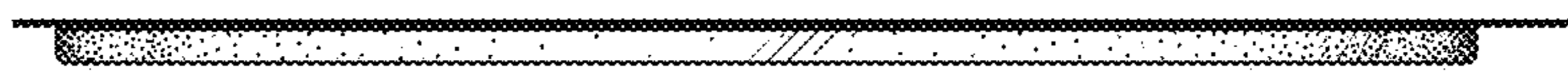

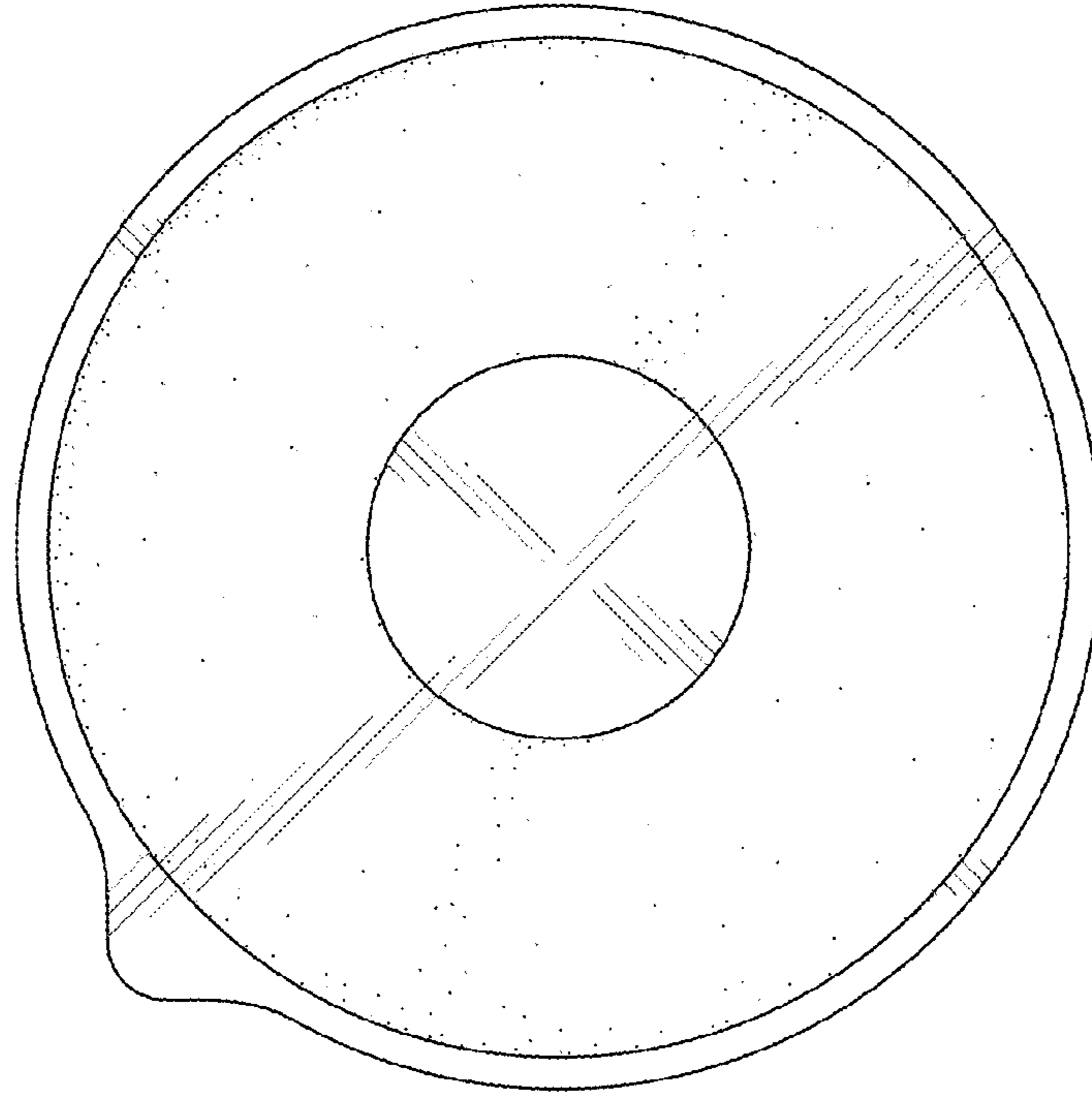

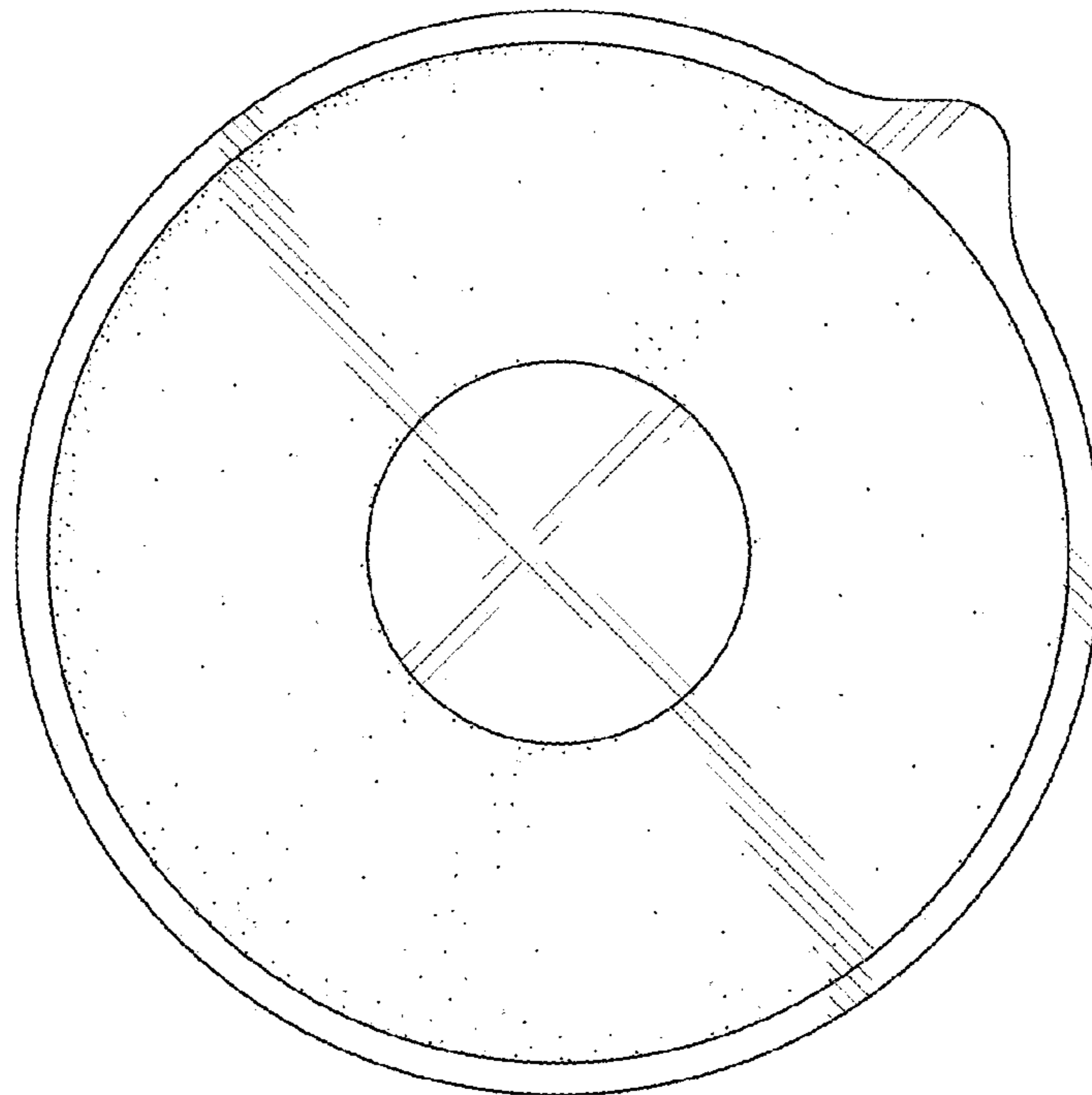

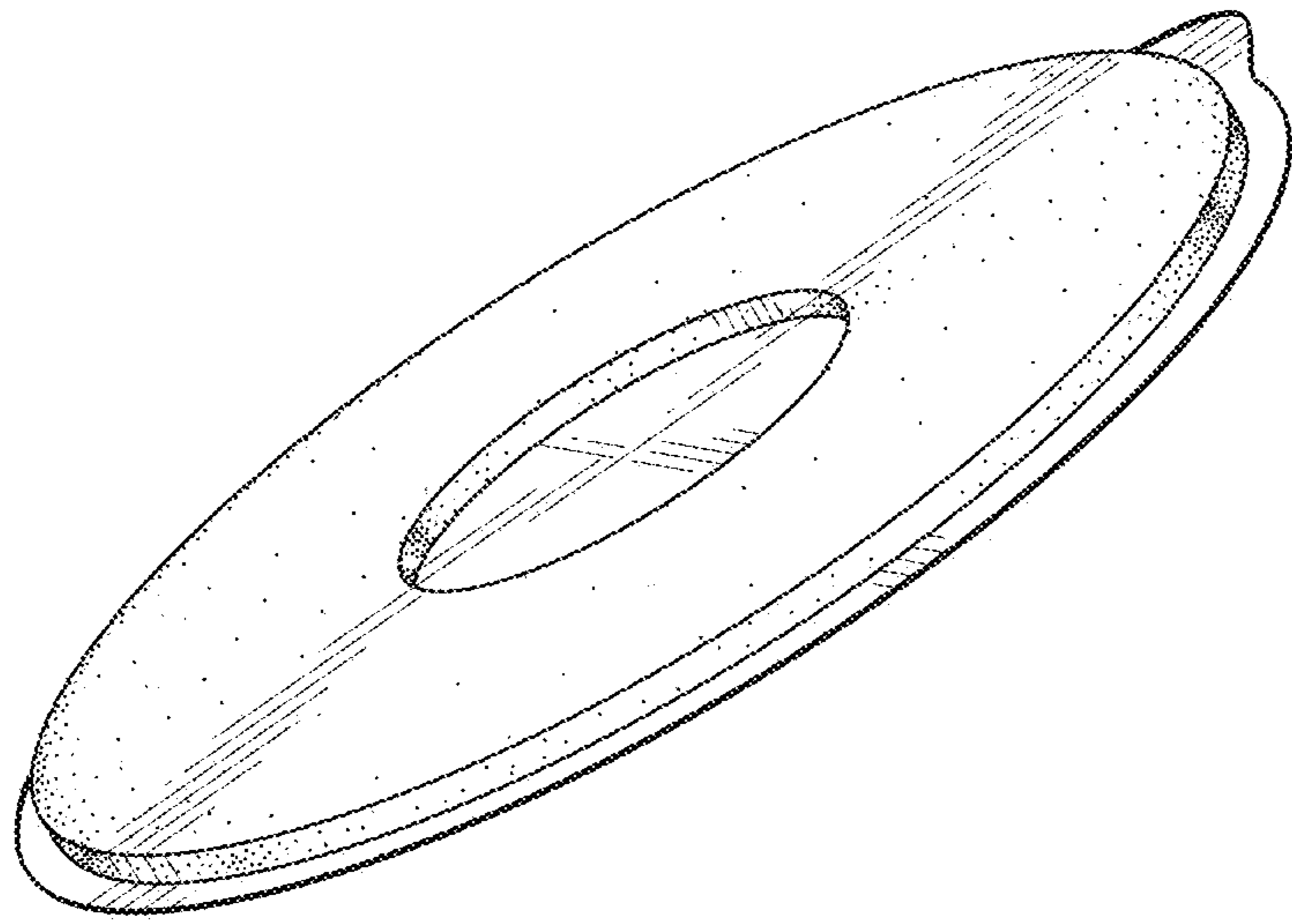

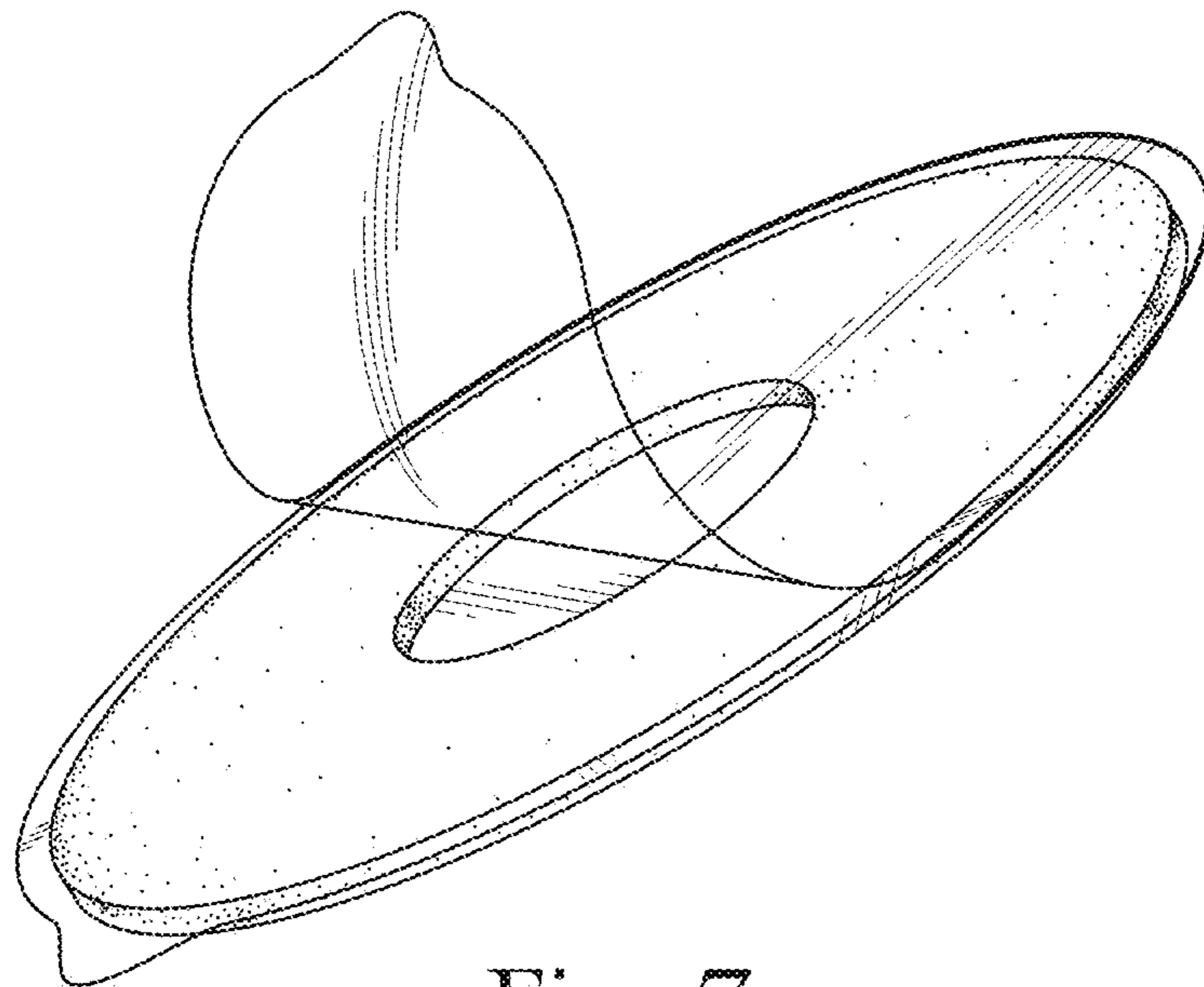

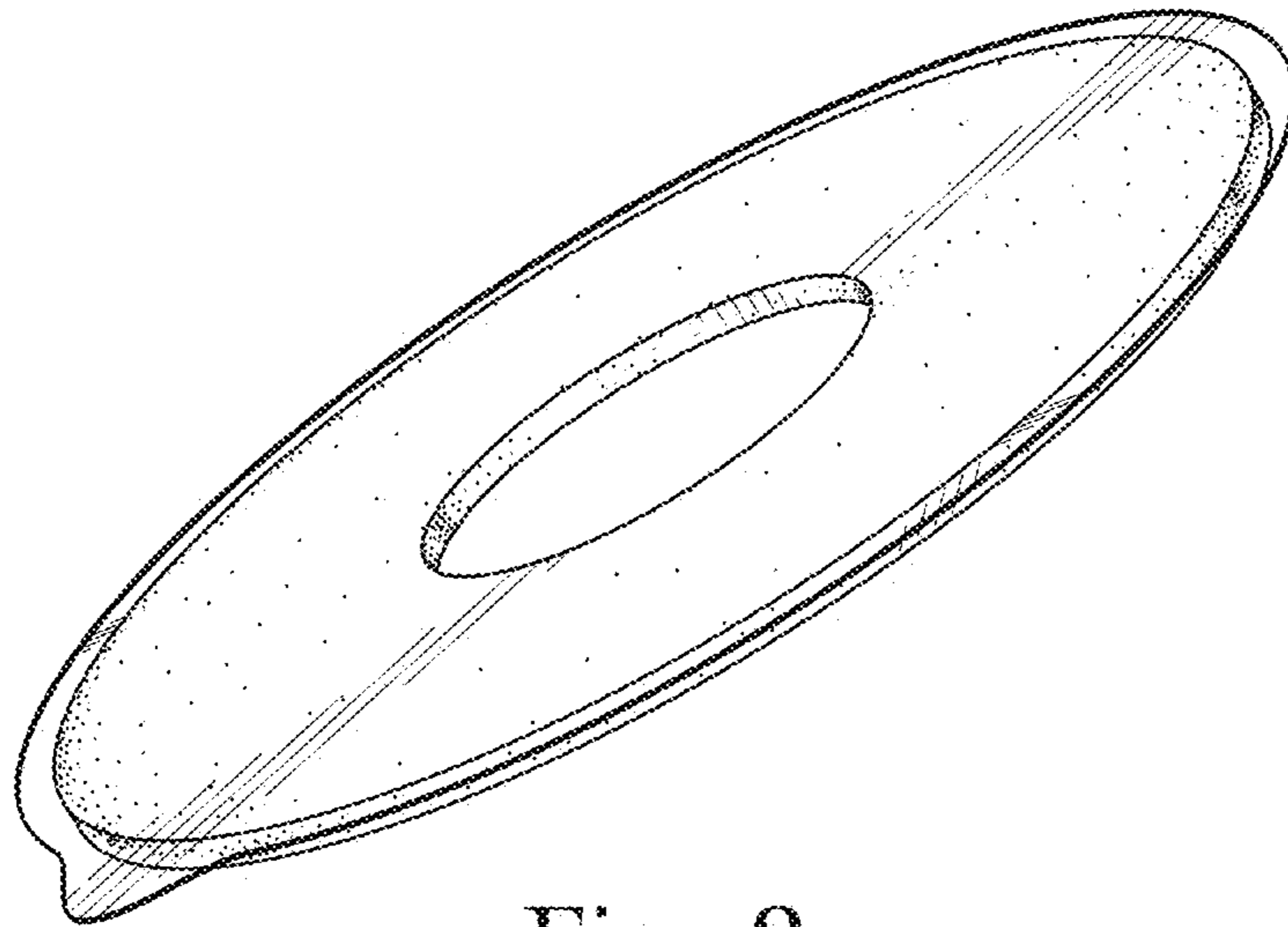

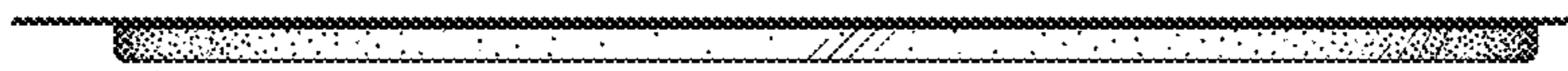

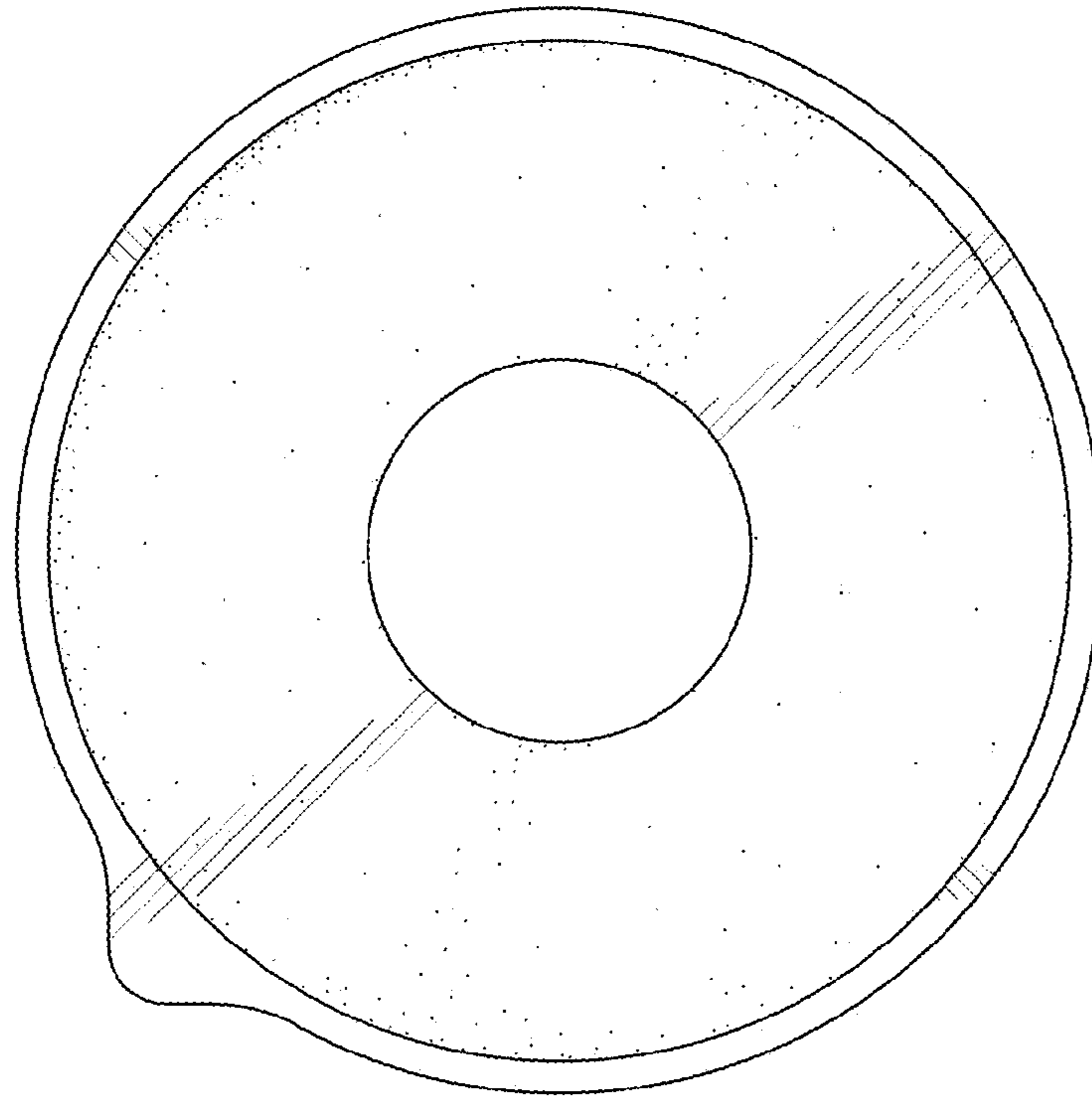

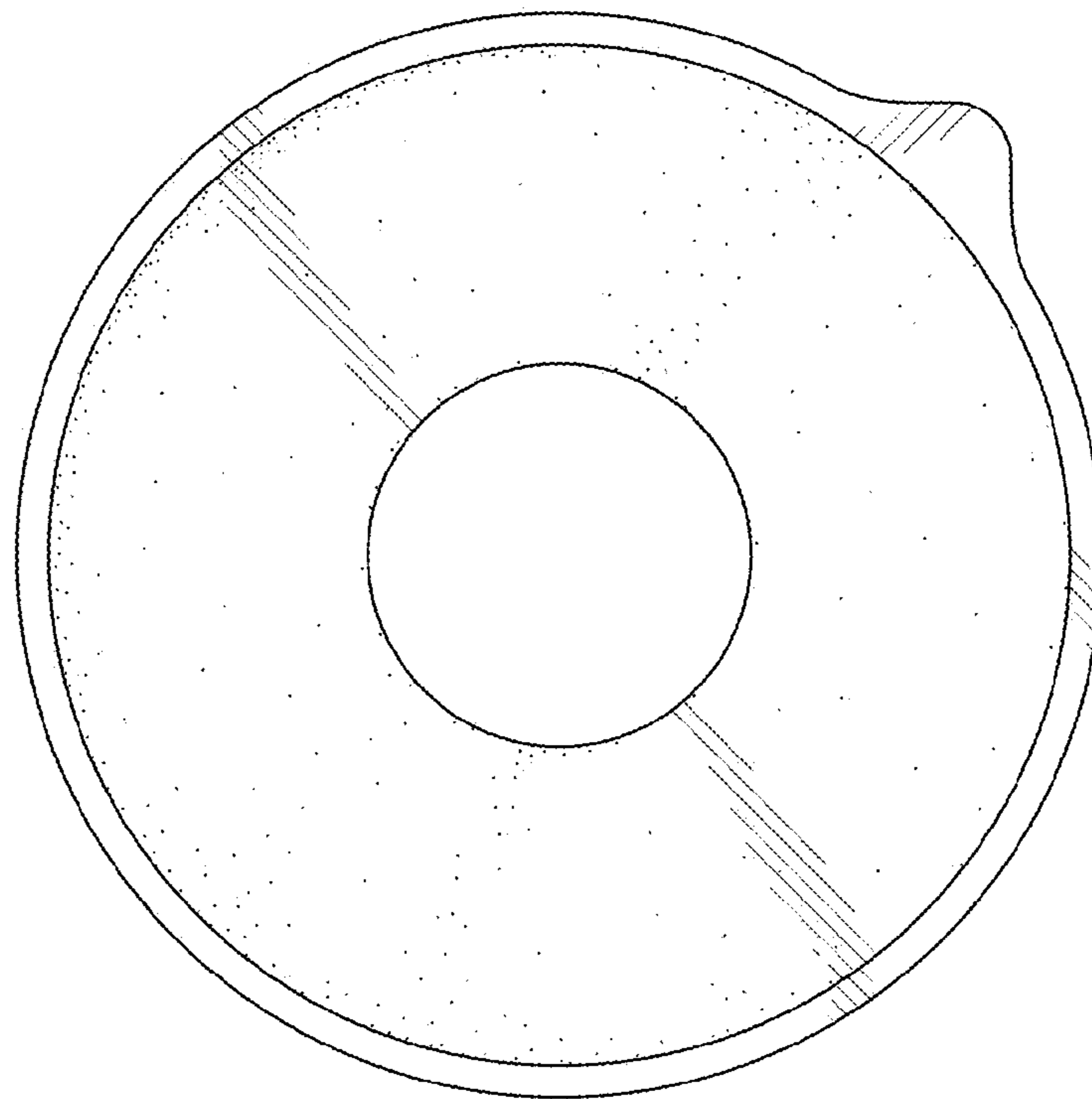

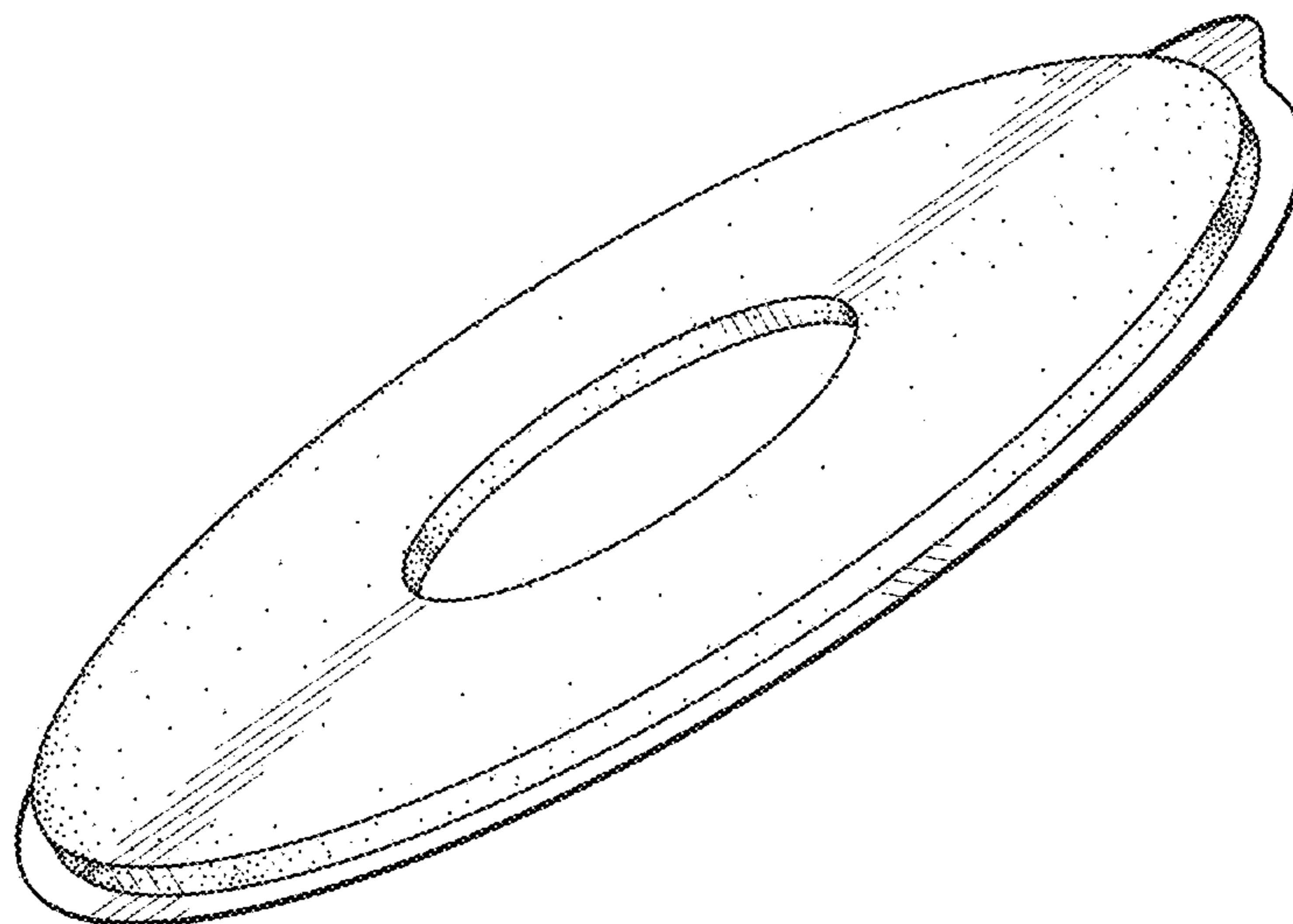

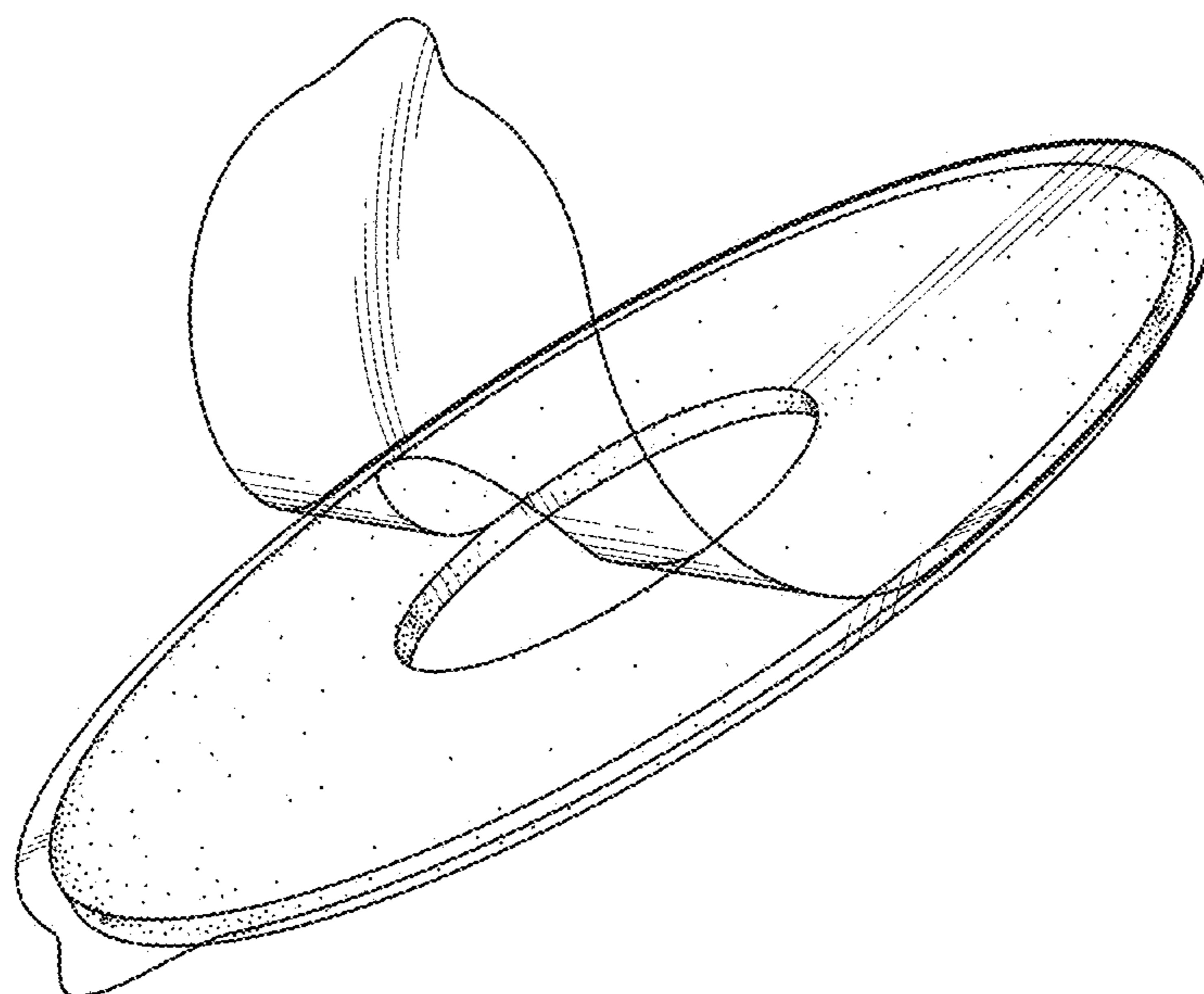
