(57) **CLAIM**

The ornamental design for a power toothbrush head, substantially as shown and described.

**DESCRIPTION**

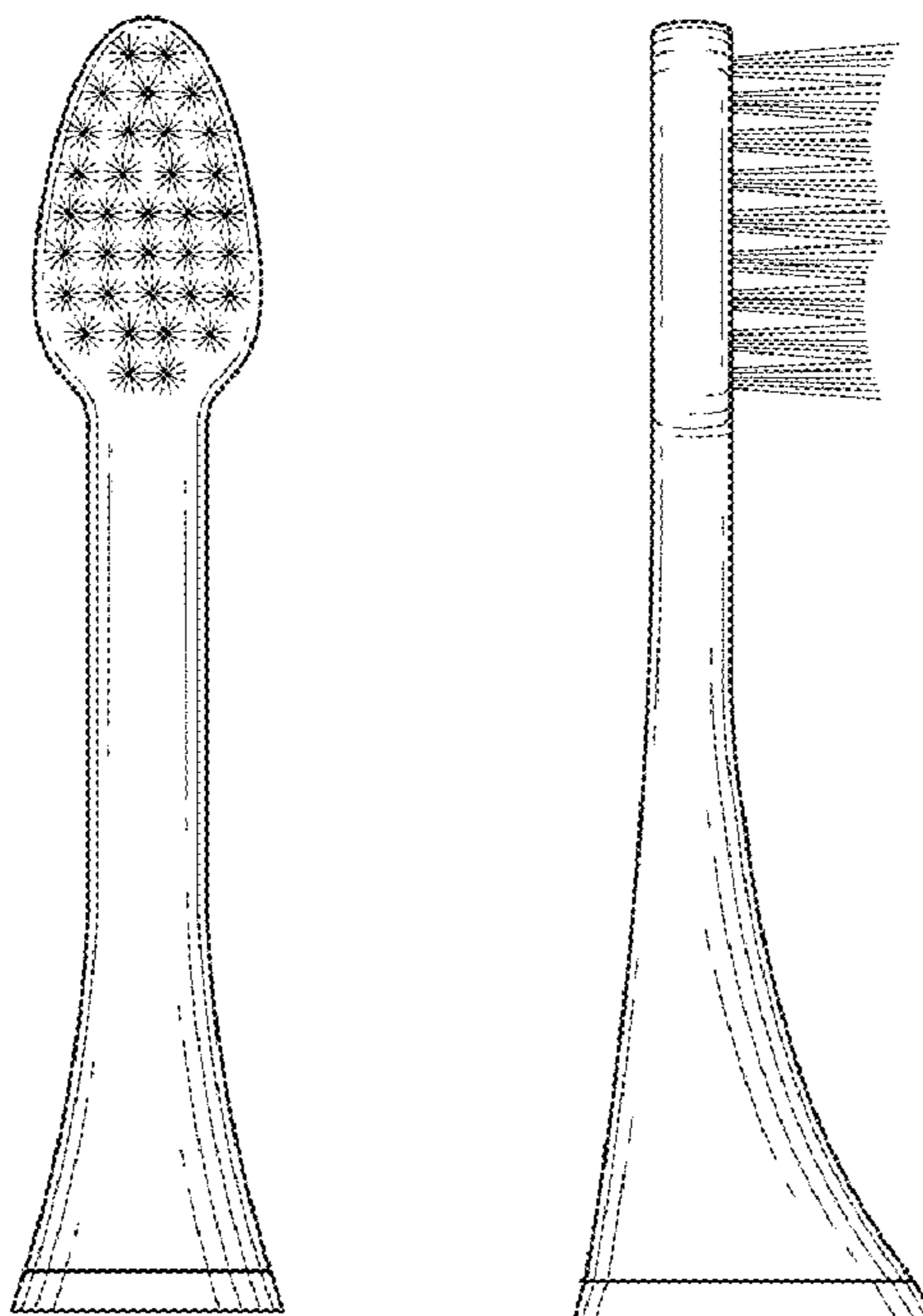

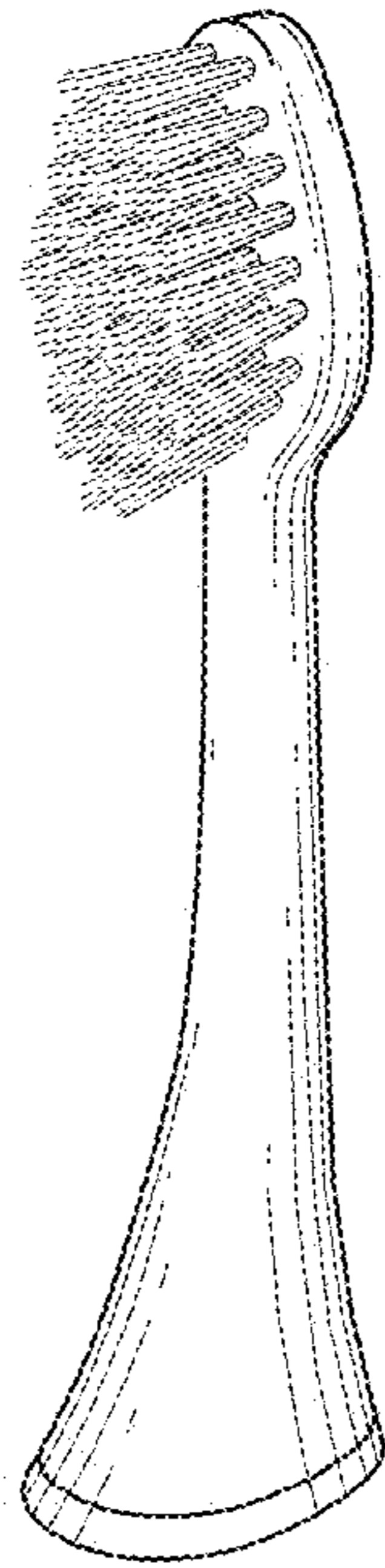

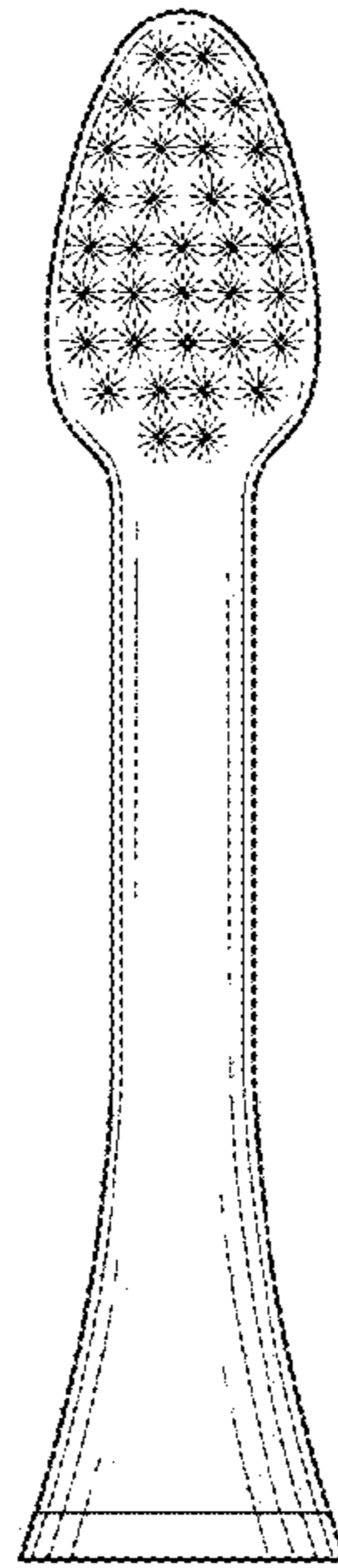

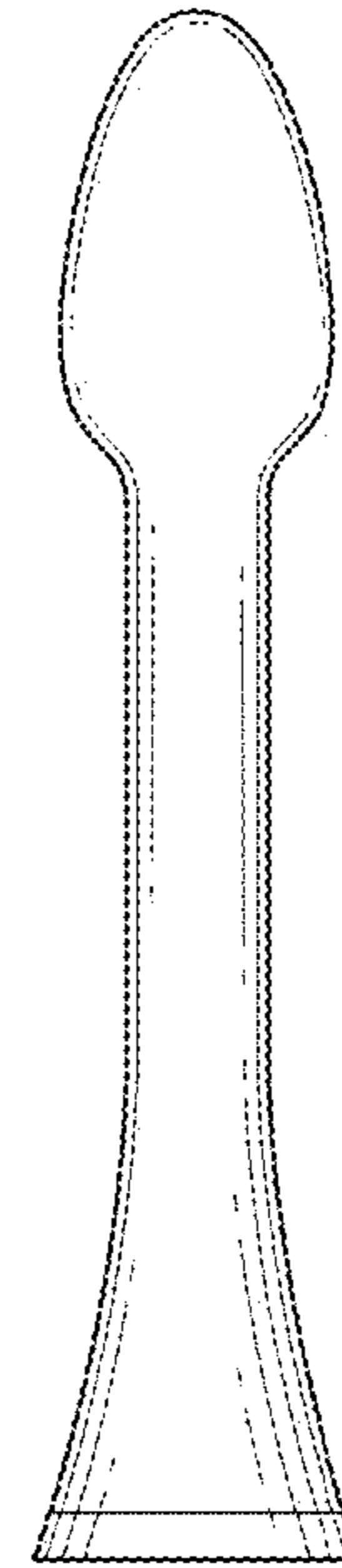

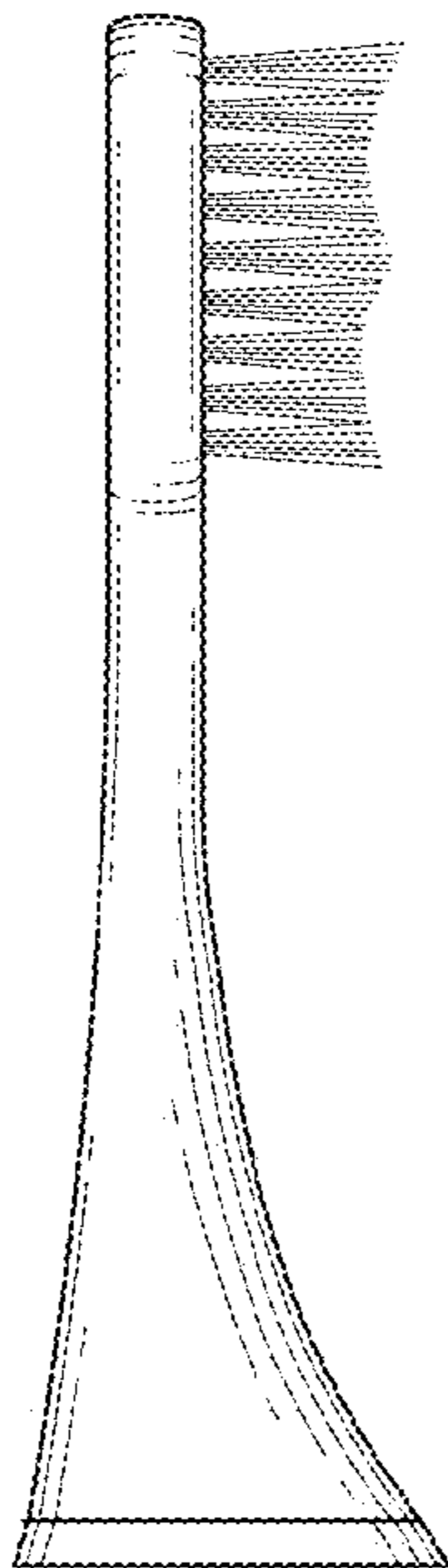

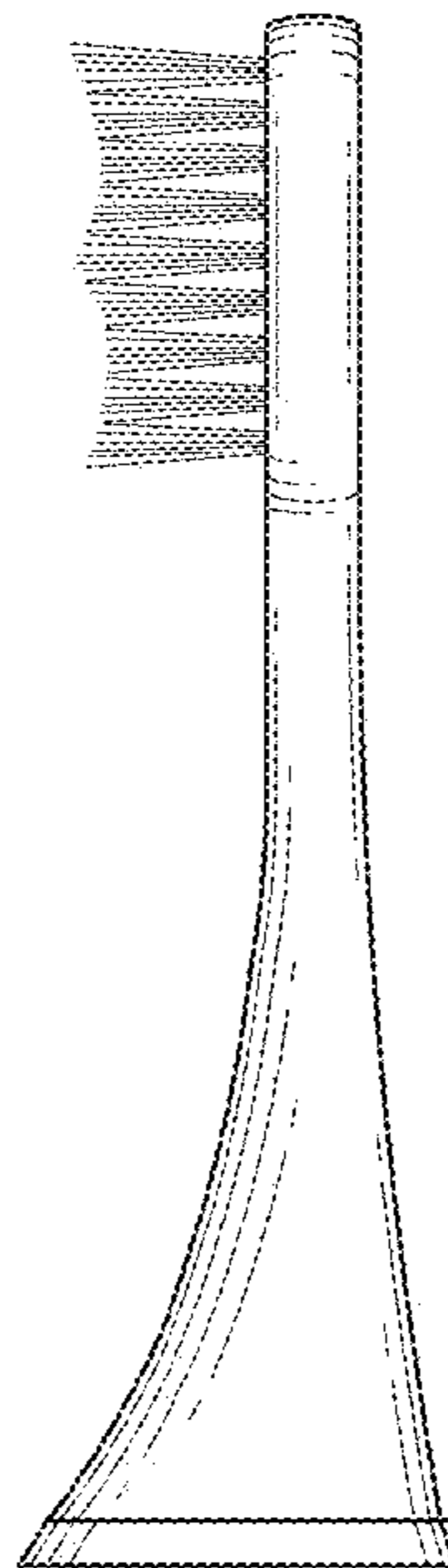
