**DESCRIPTION**

FIG. 1 is a perspective view of the baking dish showing the new design;

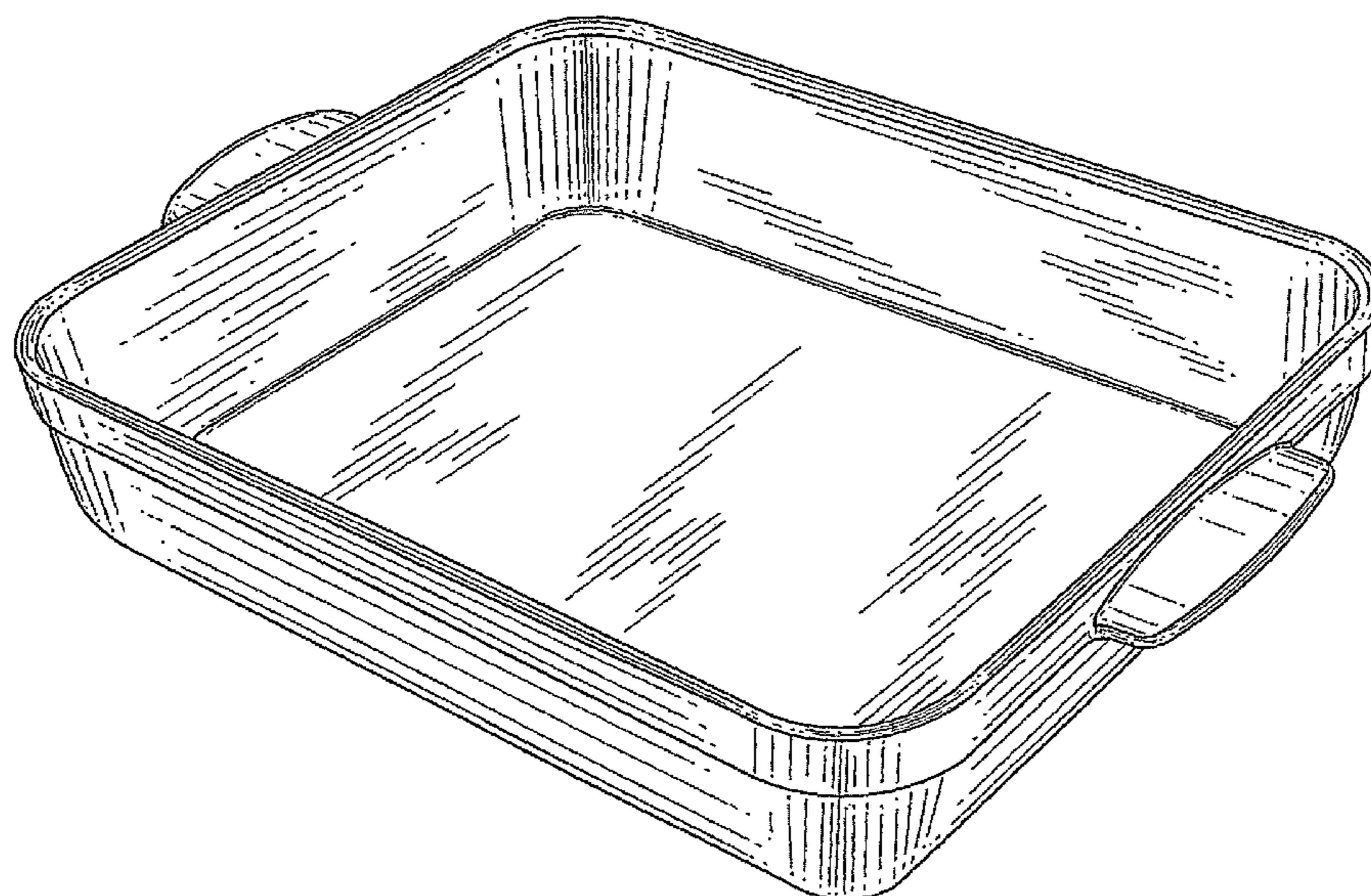
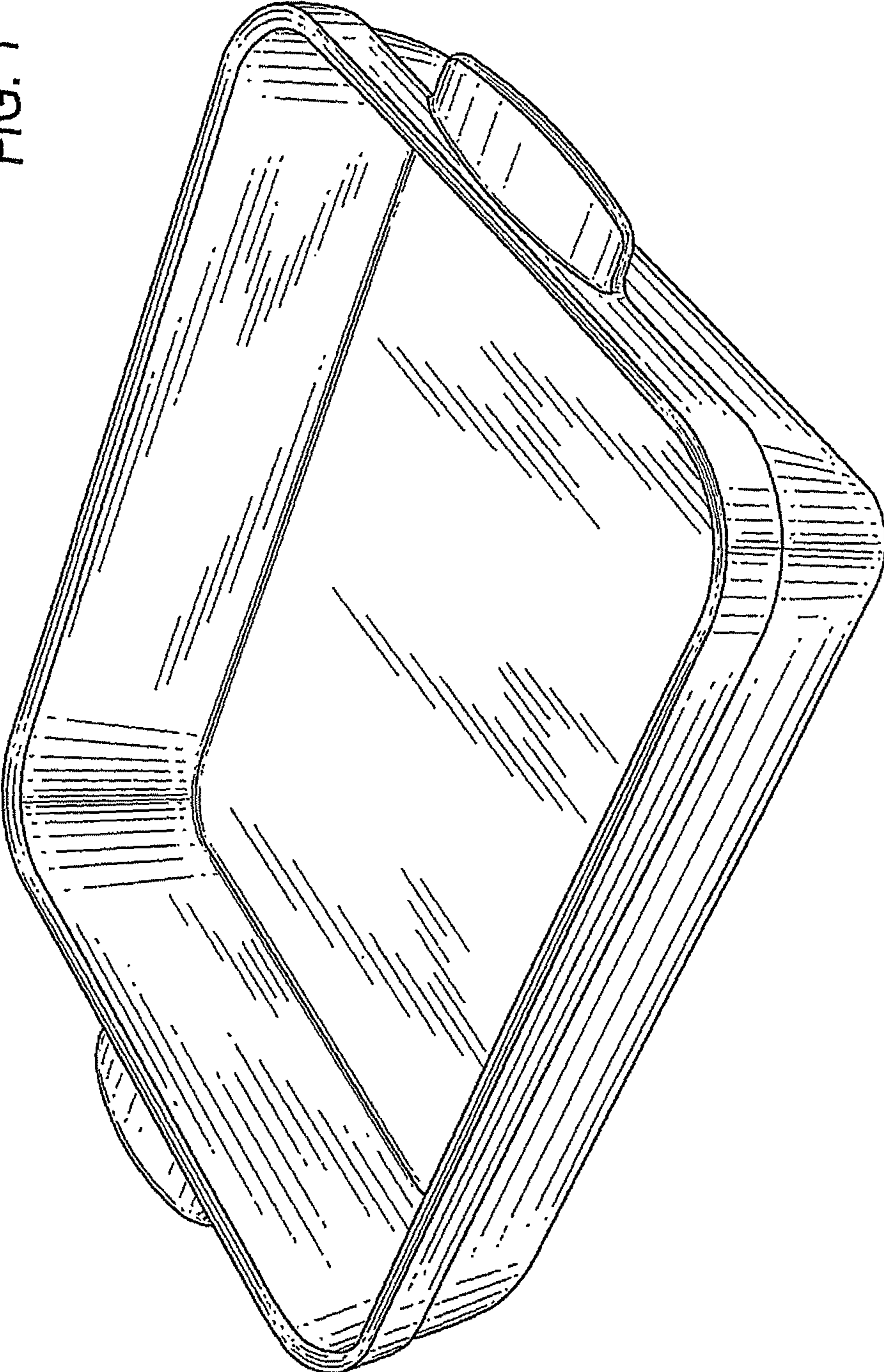

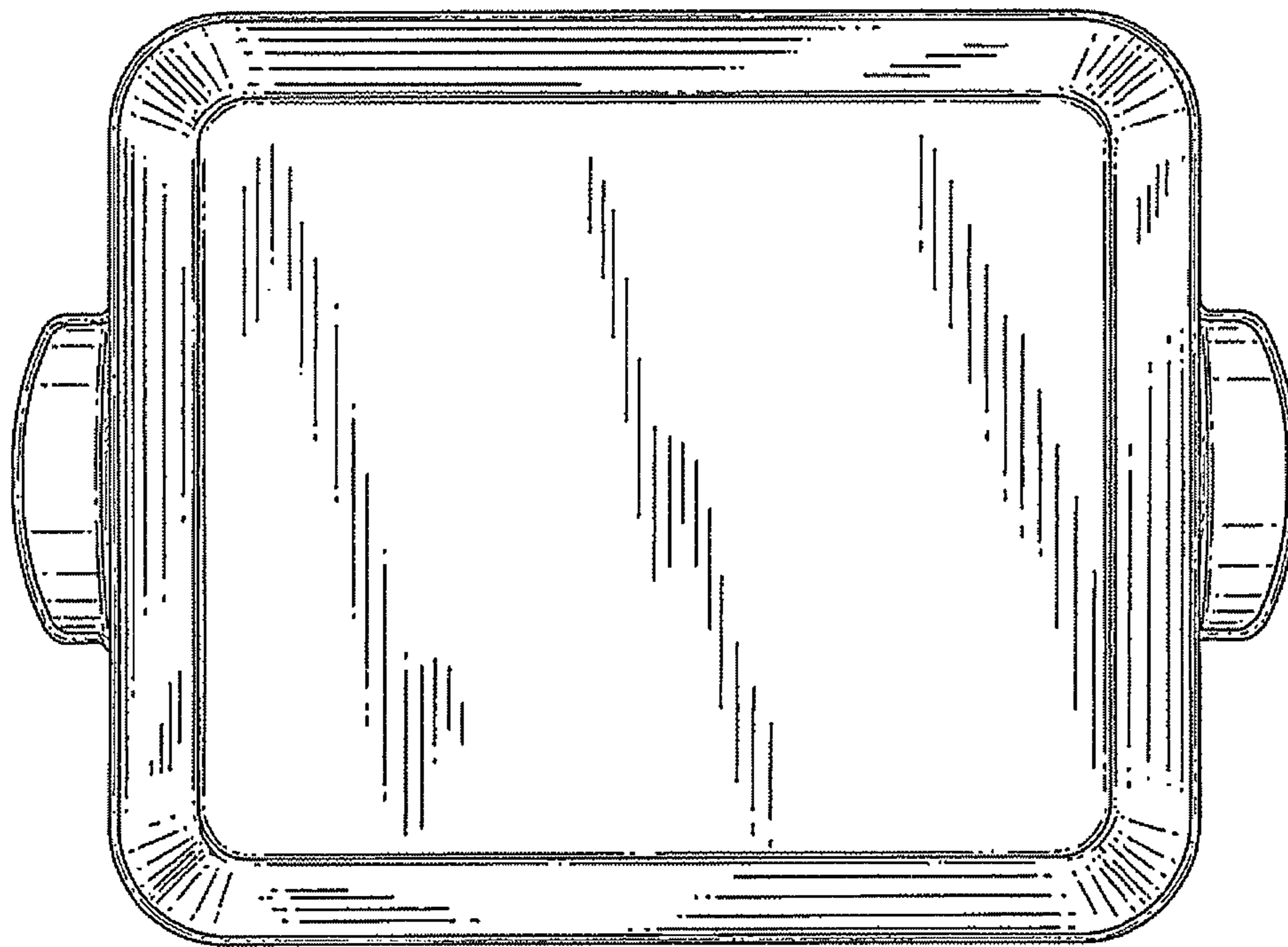

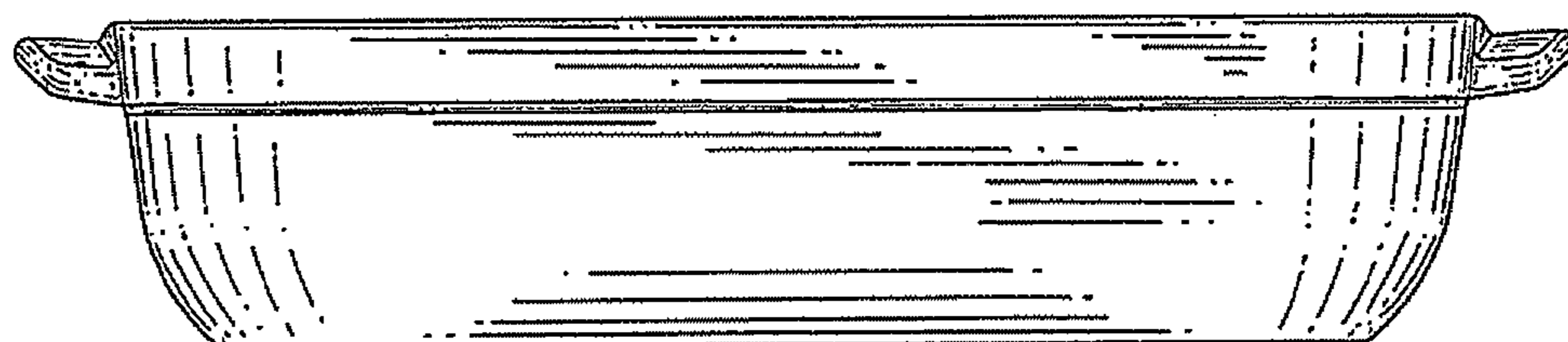

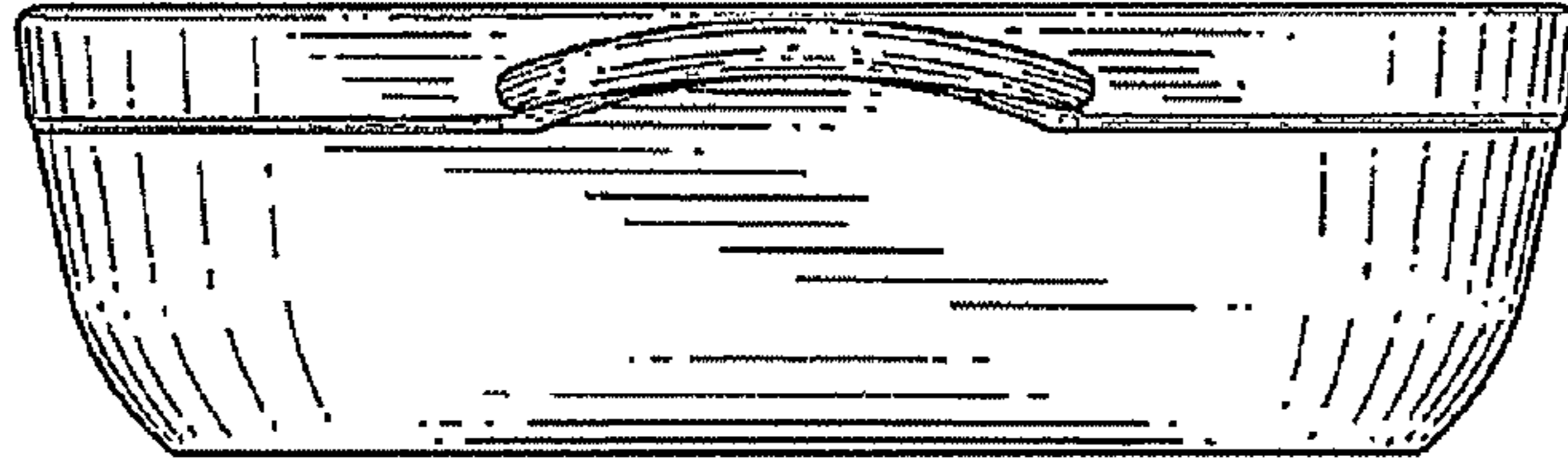

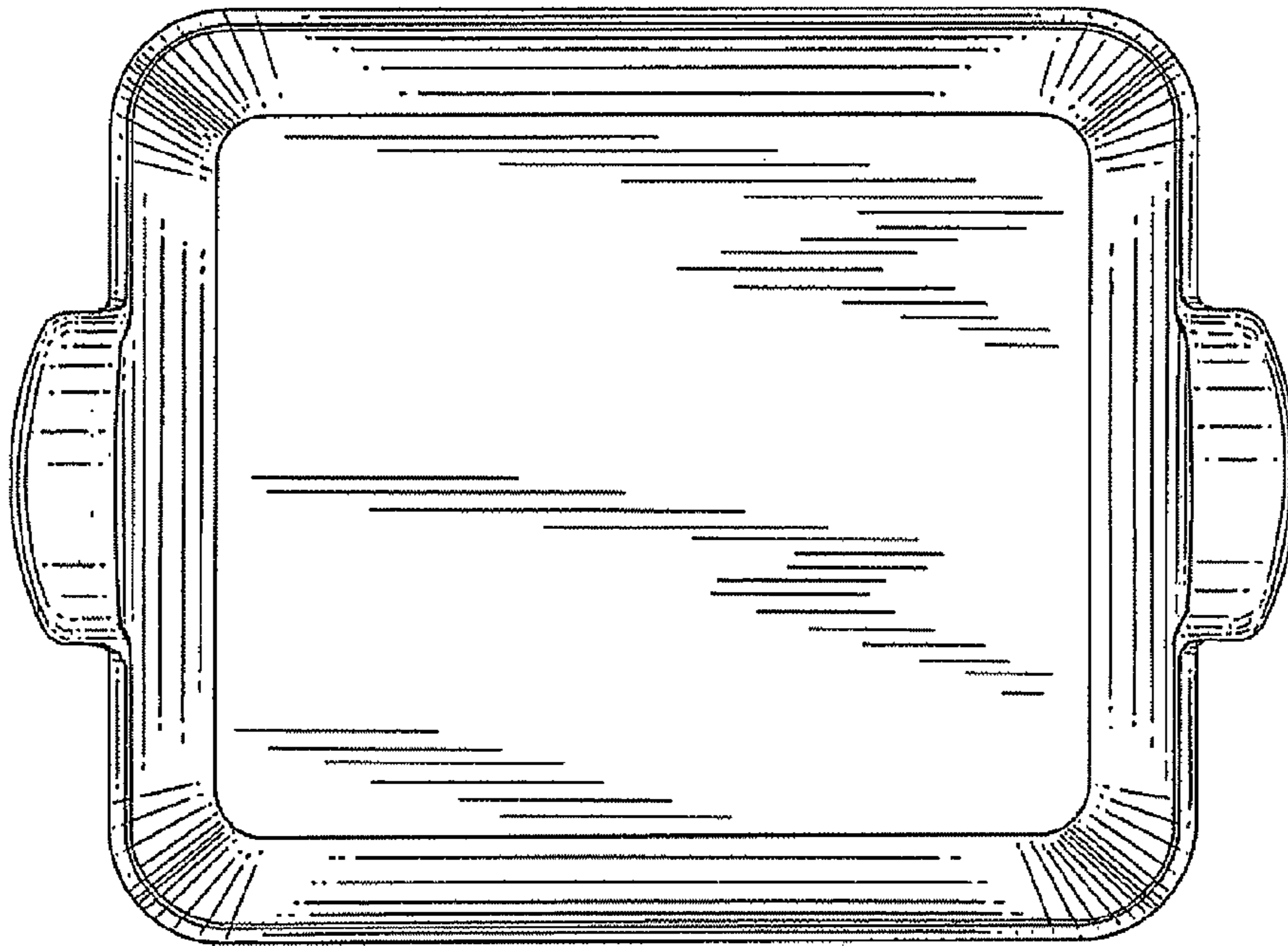
