**DESCRIPTION**

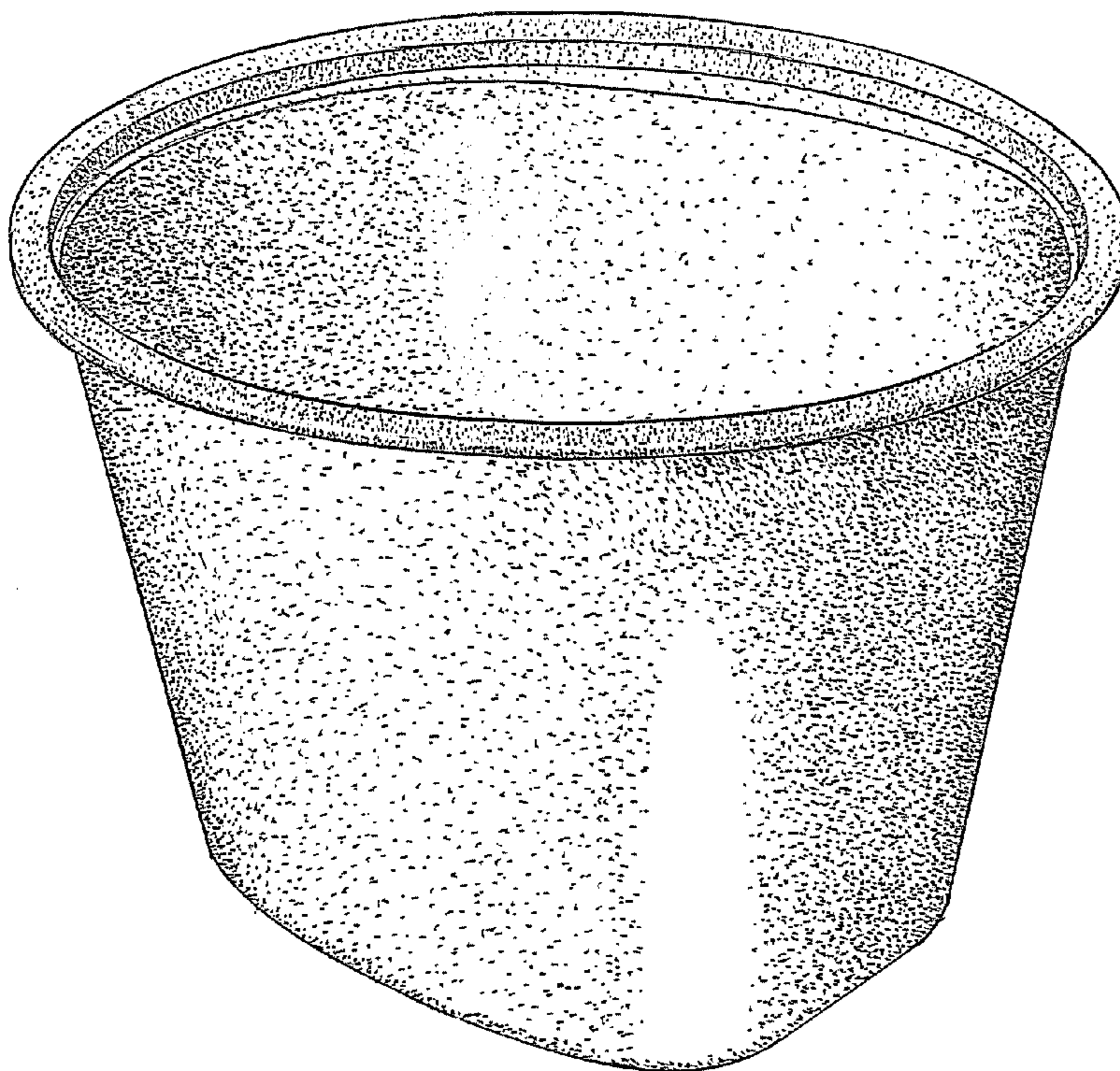

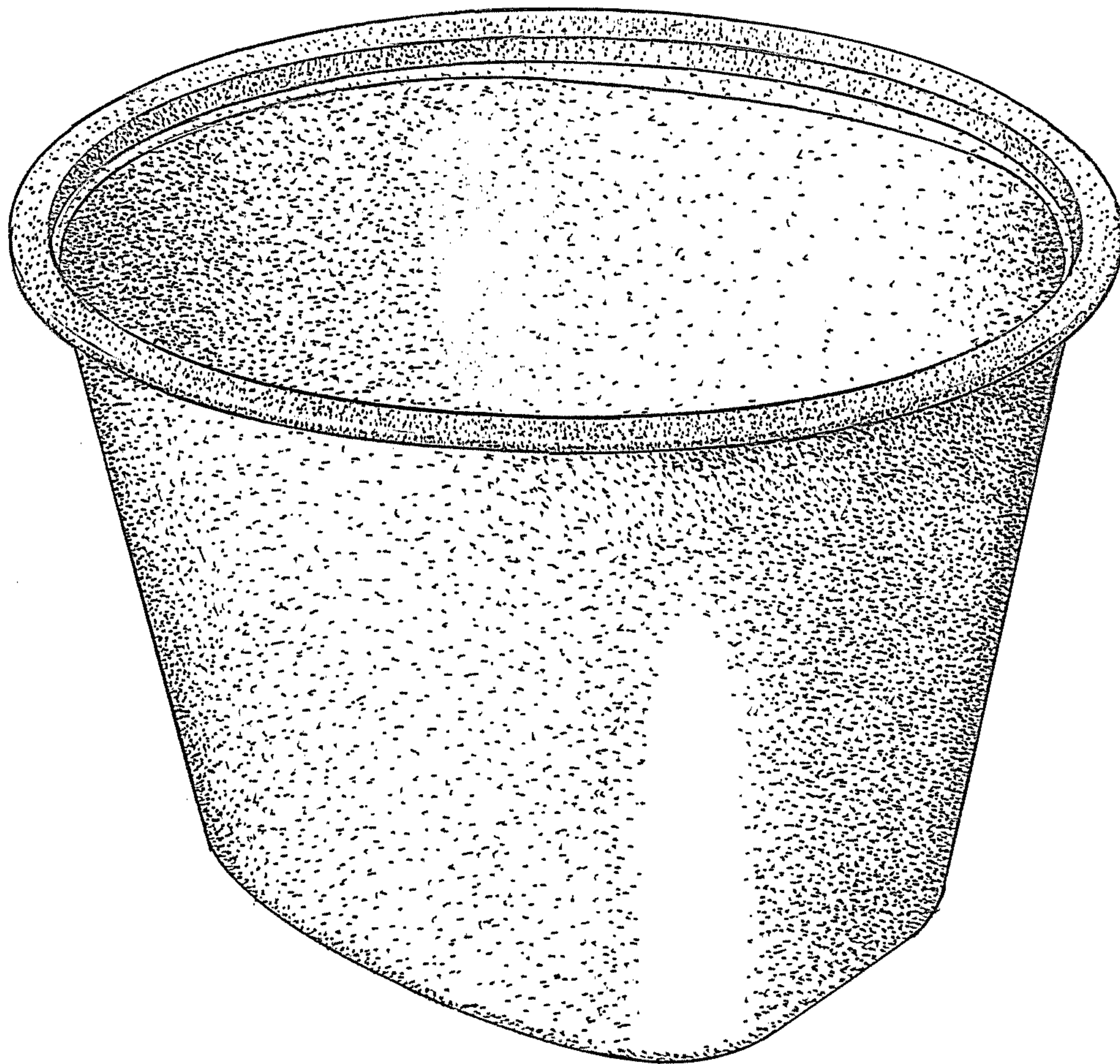

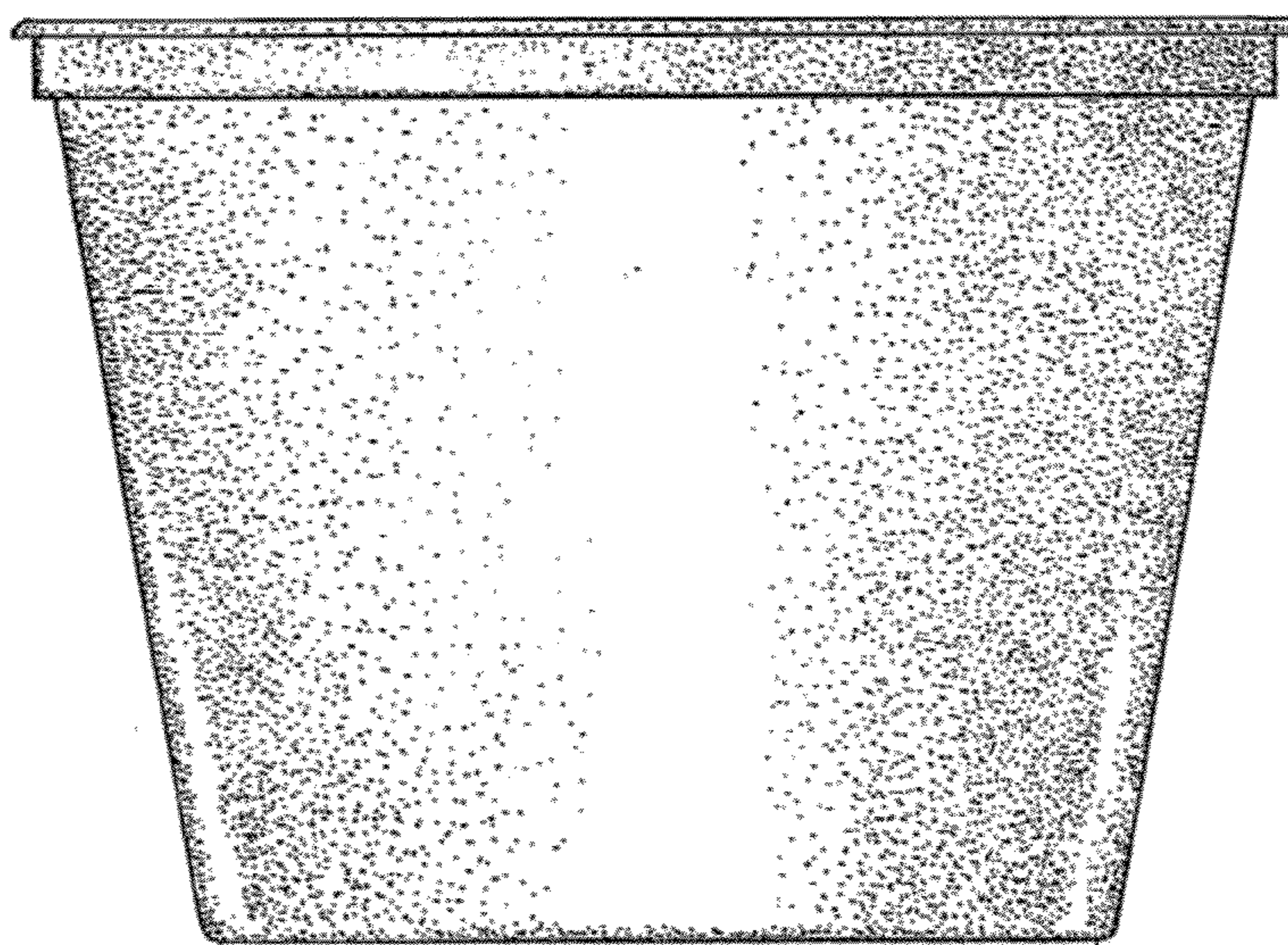

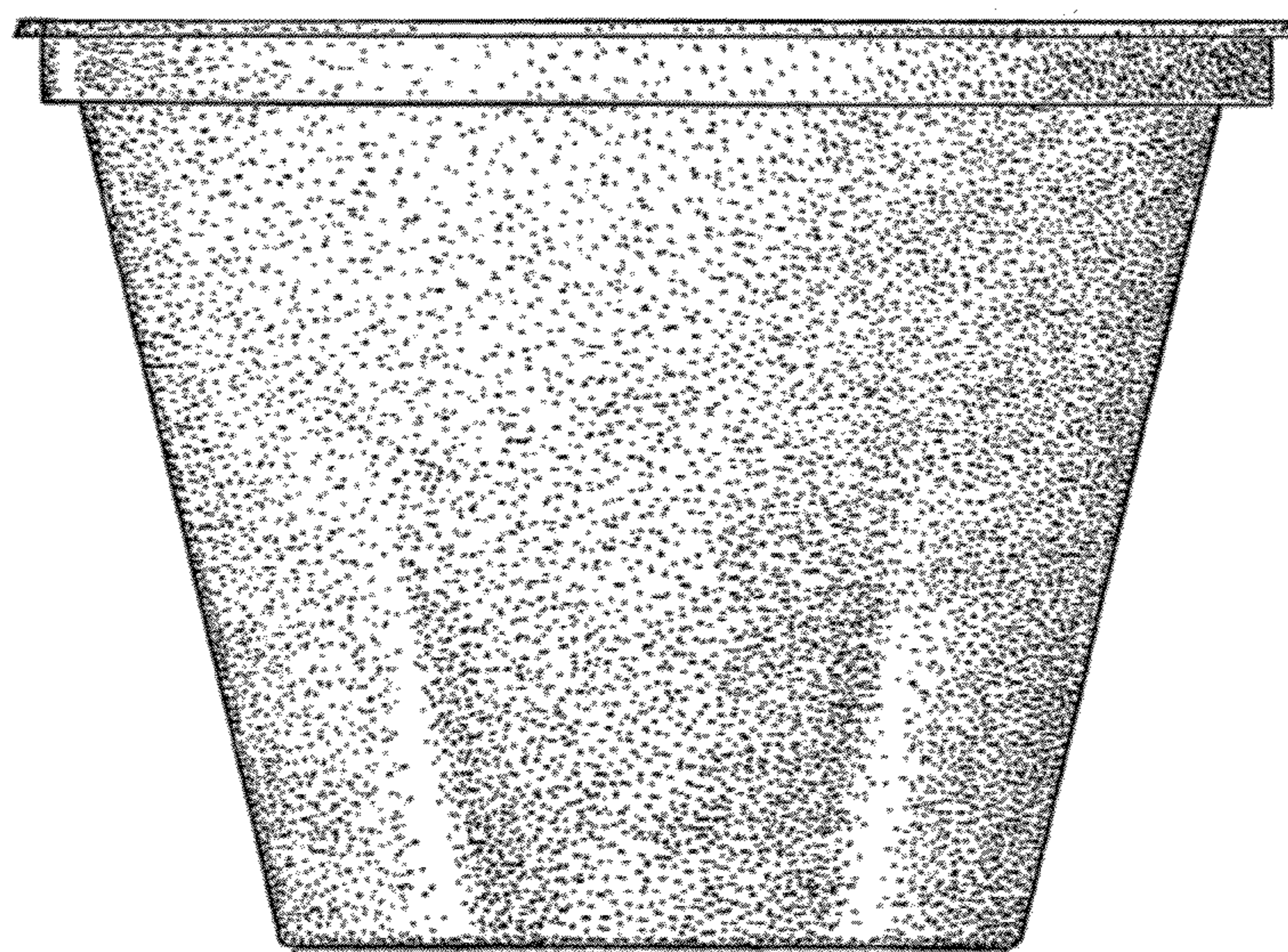

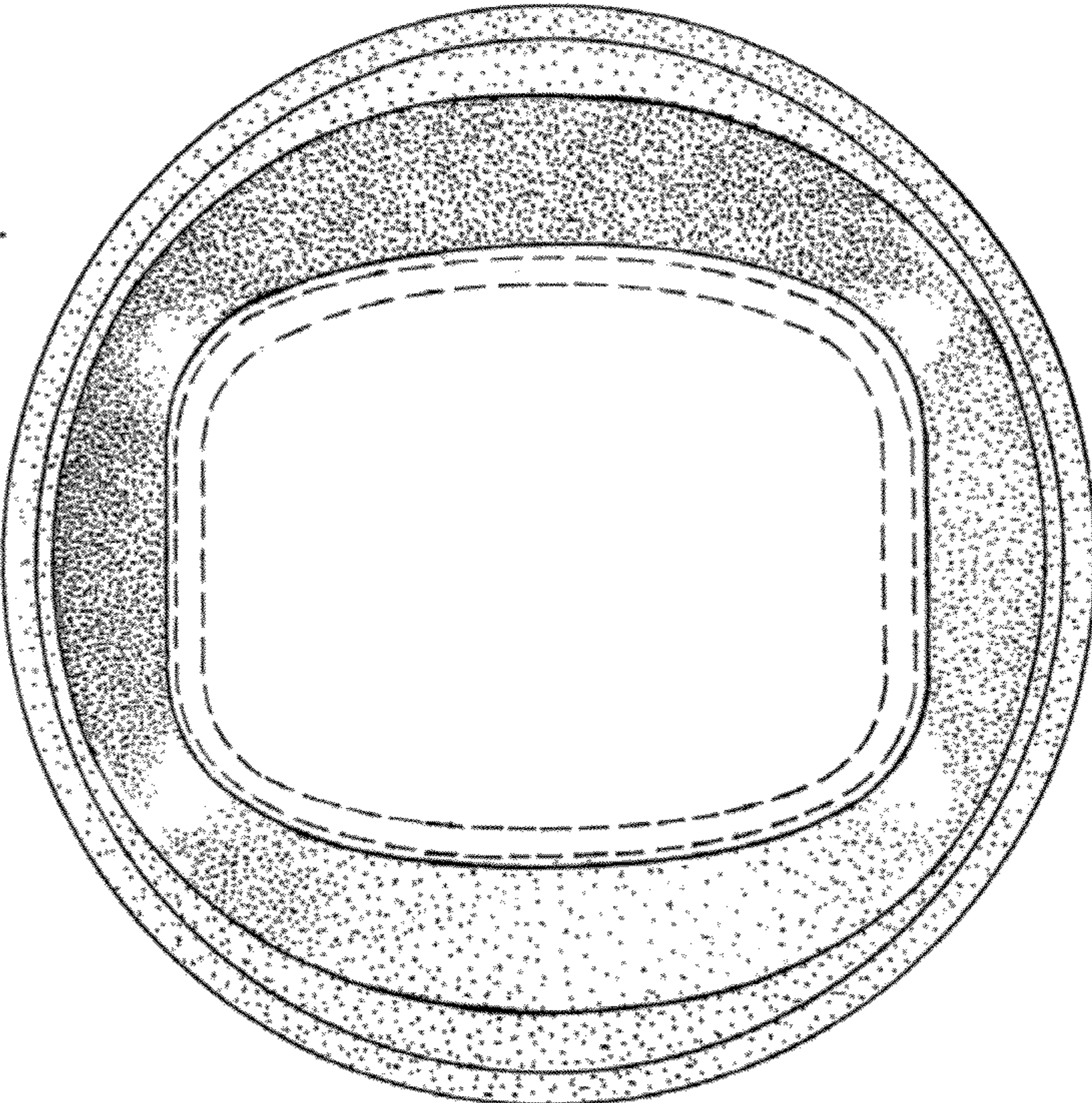

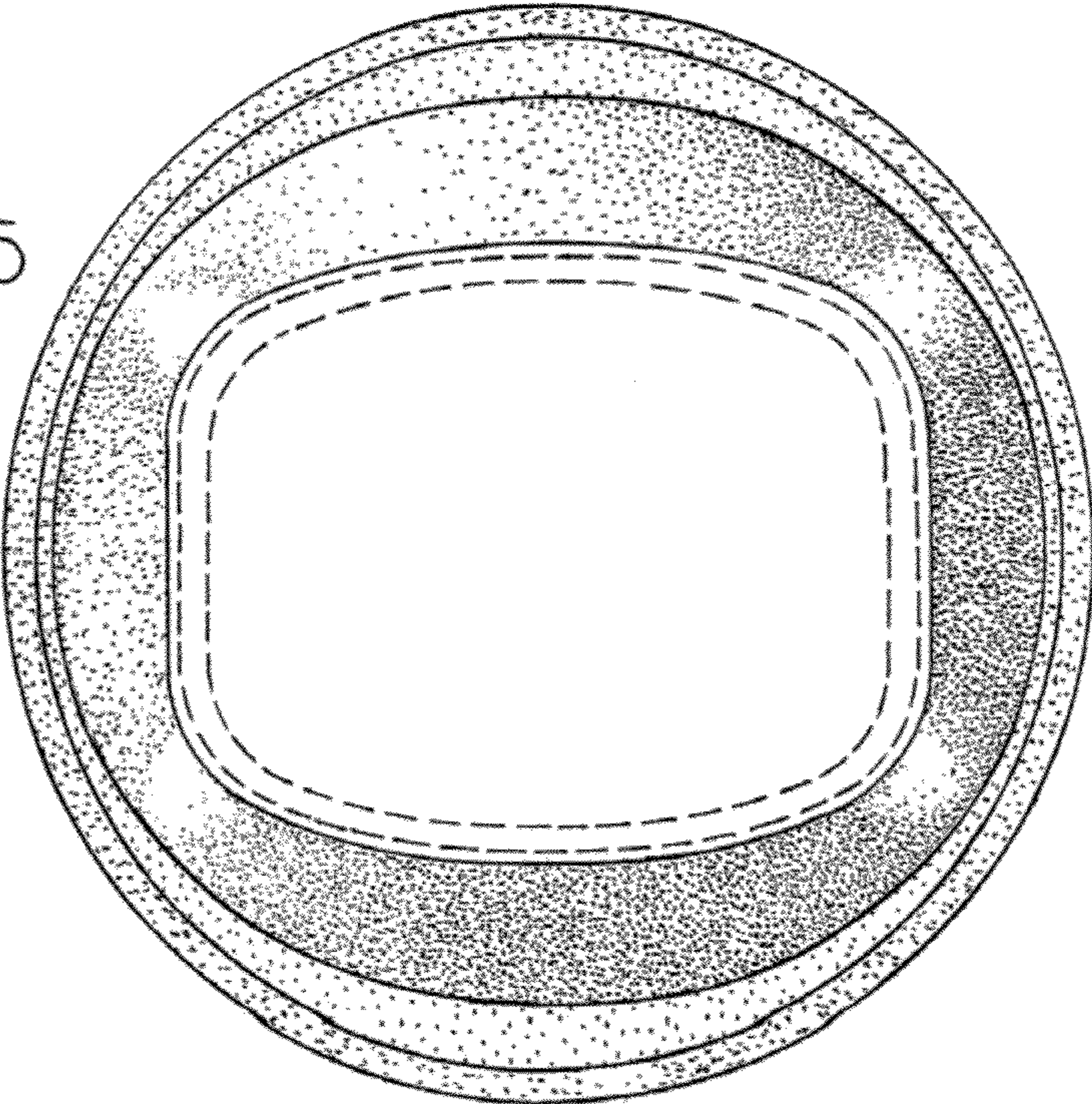

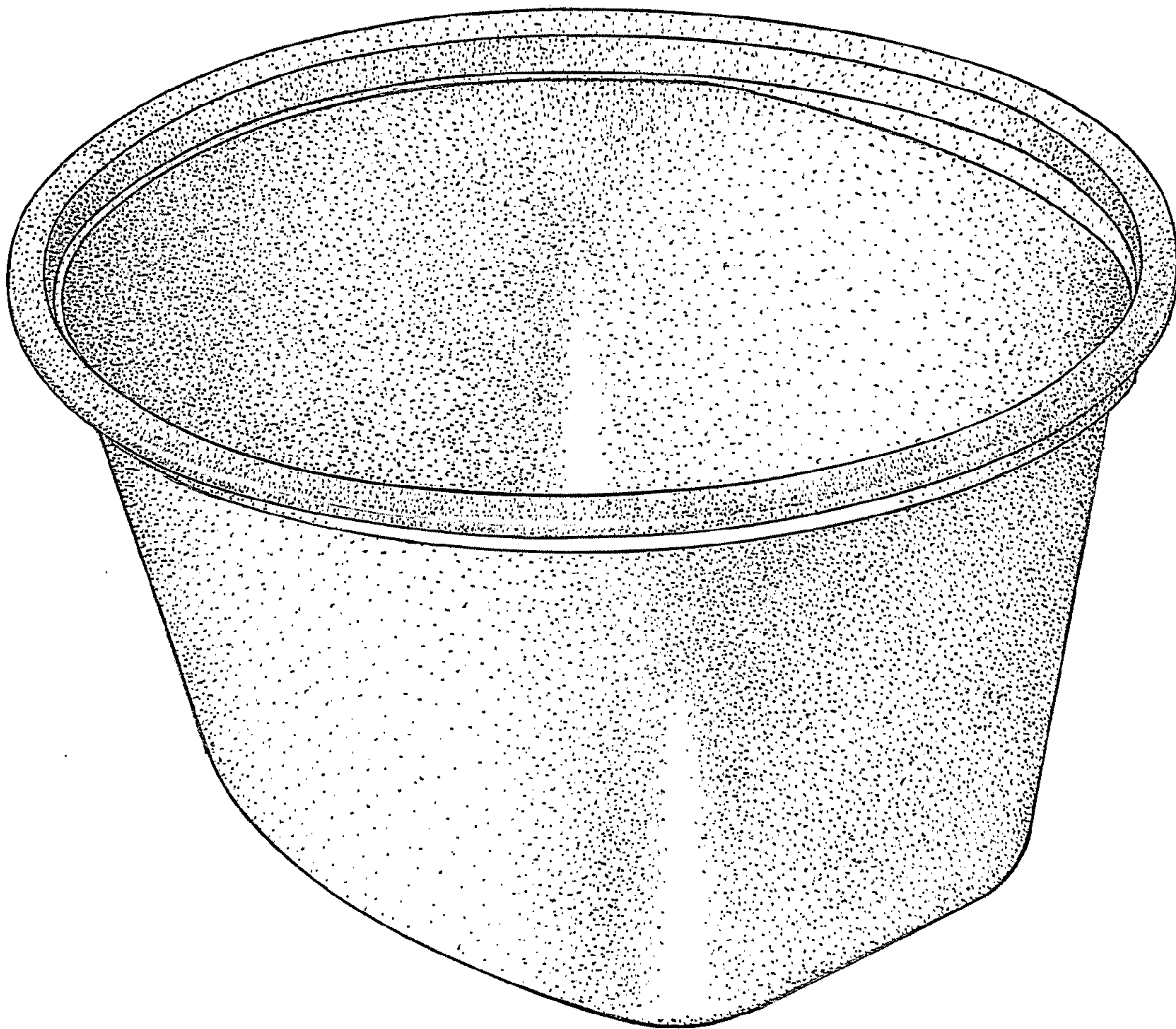

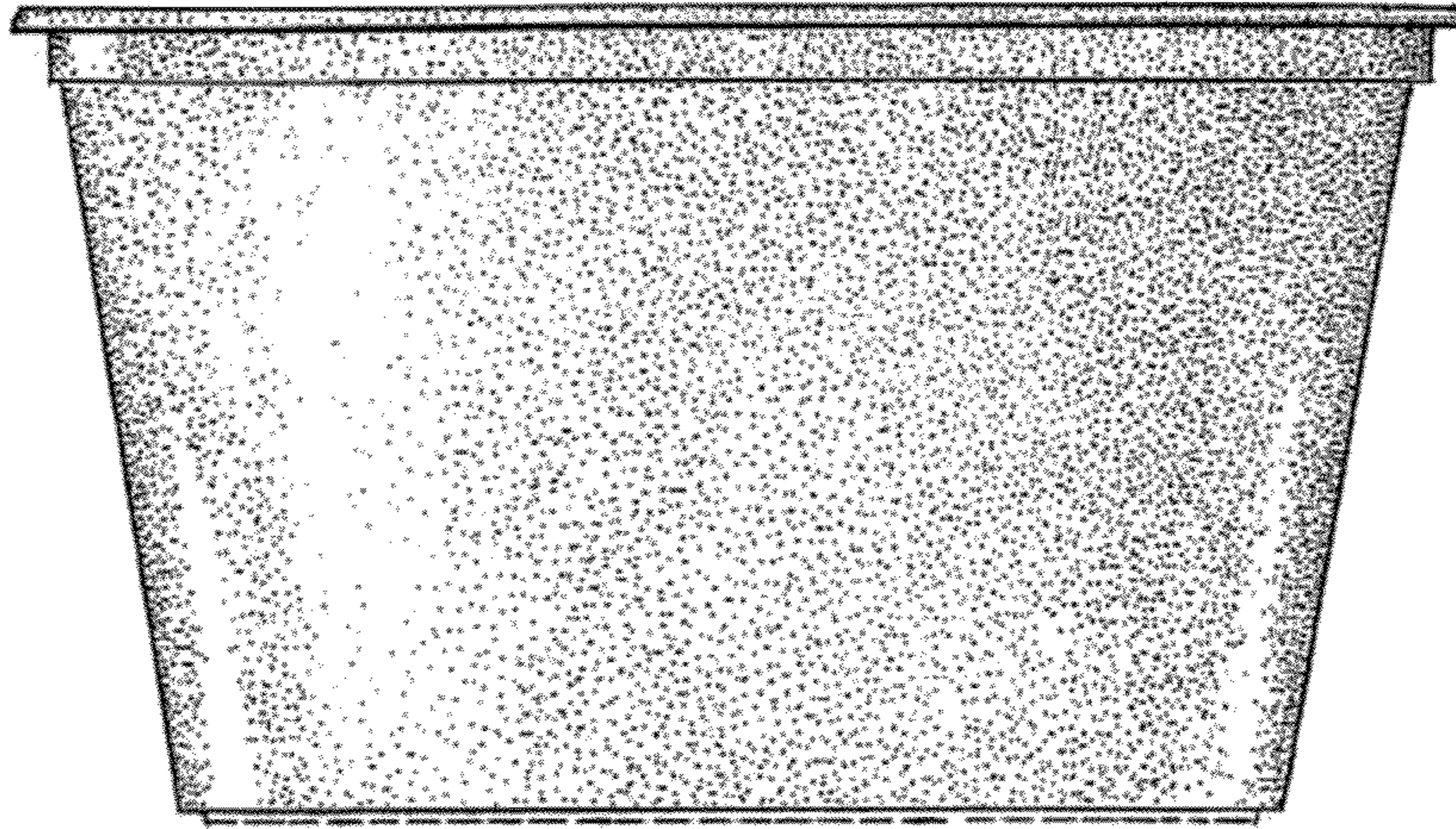

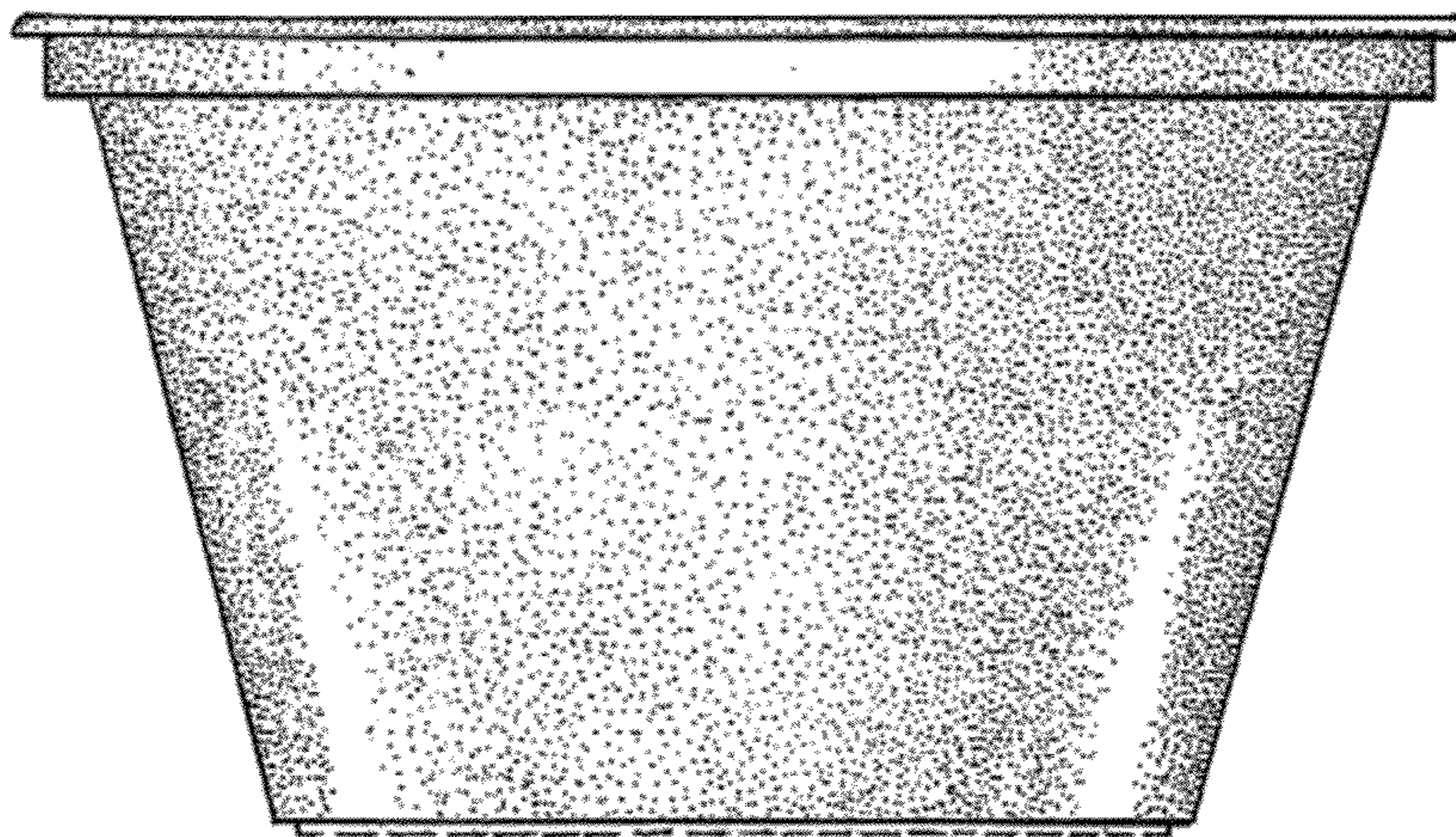

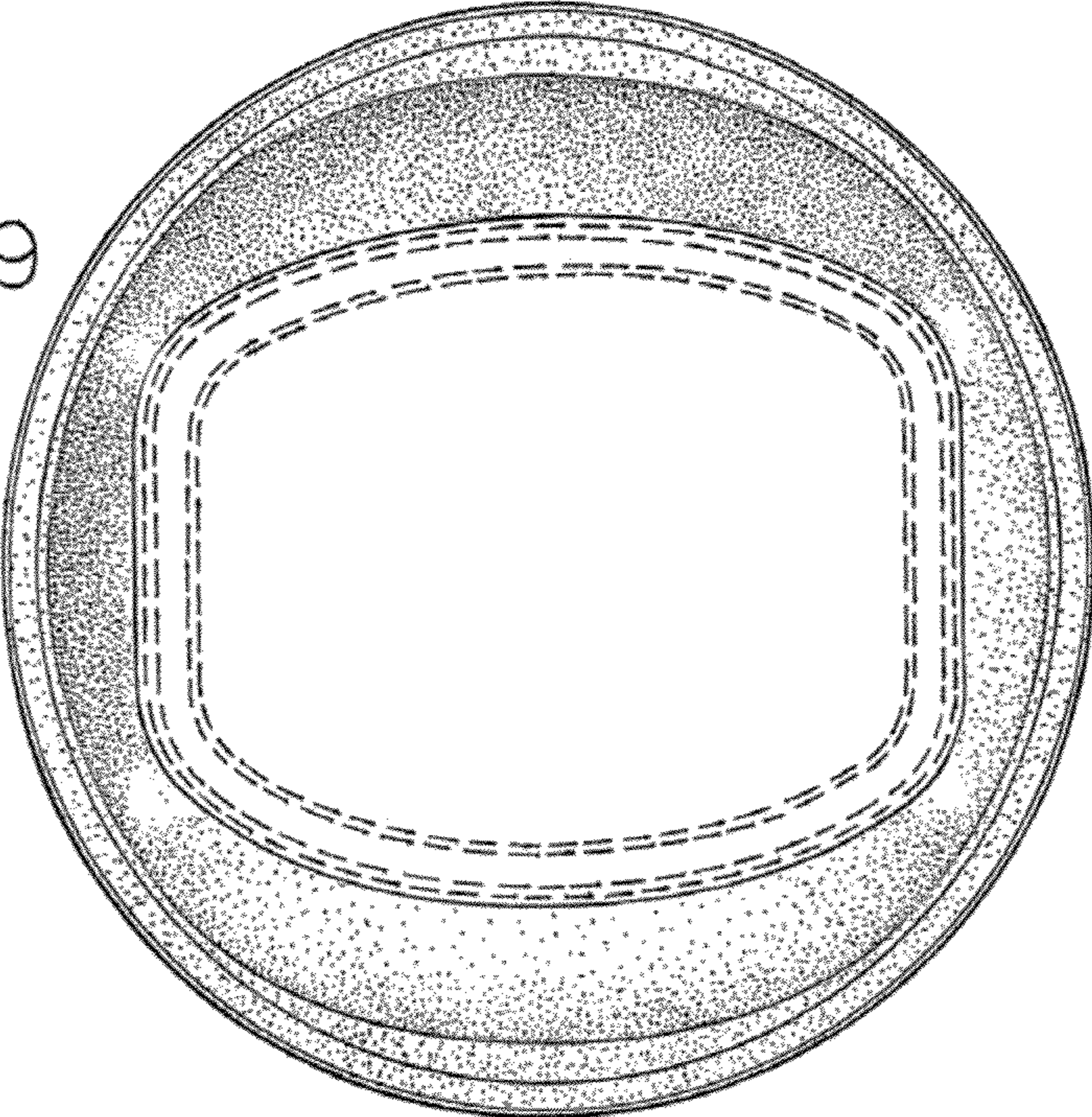
