FIG. 6 is a front perspective view of a sixth embodiment of jewelry with modified yin yang symbol showing my new design.

The jewelry with modified yin yang symbol is flat, with no raised or recessed features.

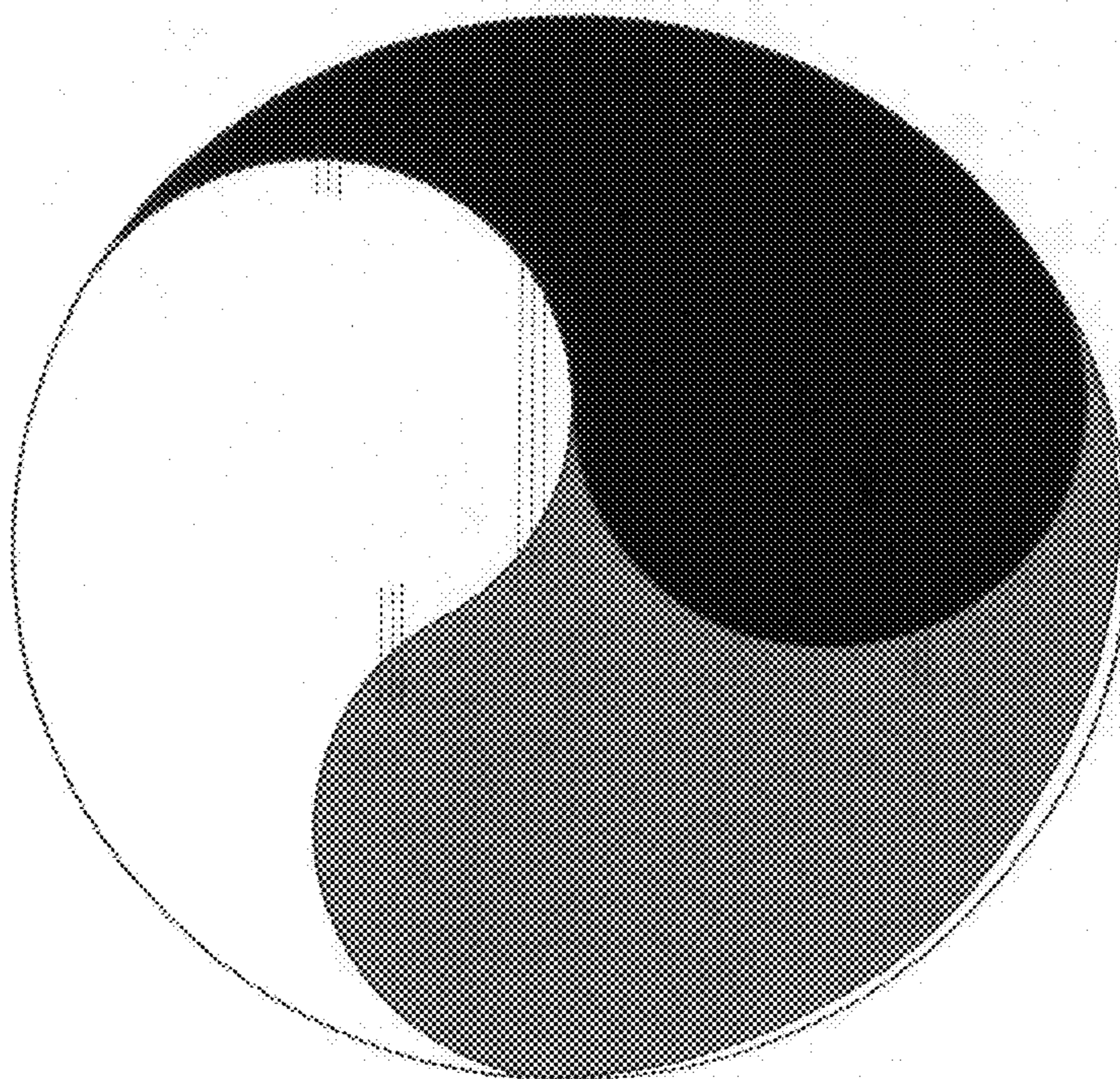
The characteristic feature of the design resides in the three shadings of black, white and gray.

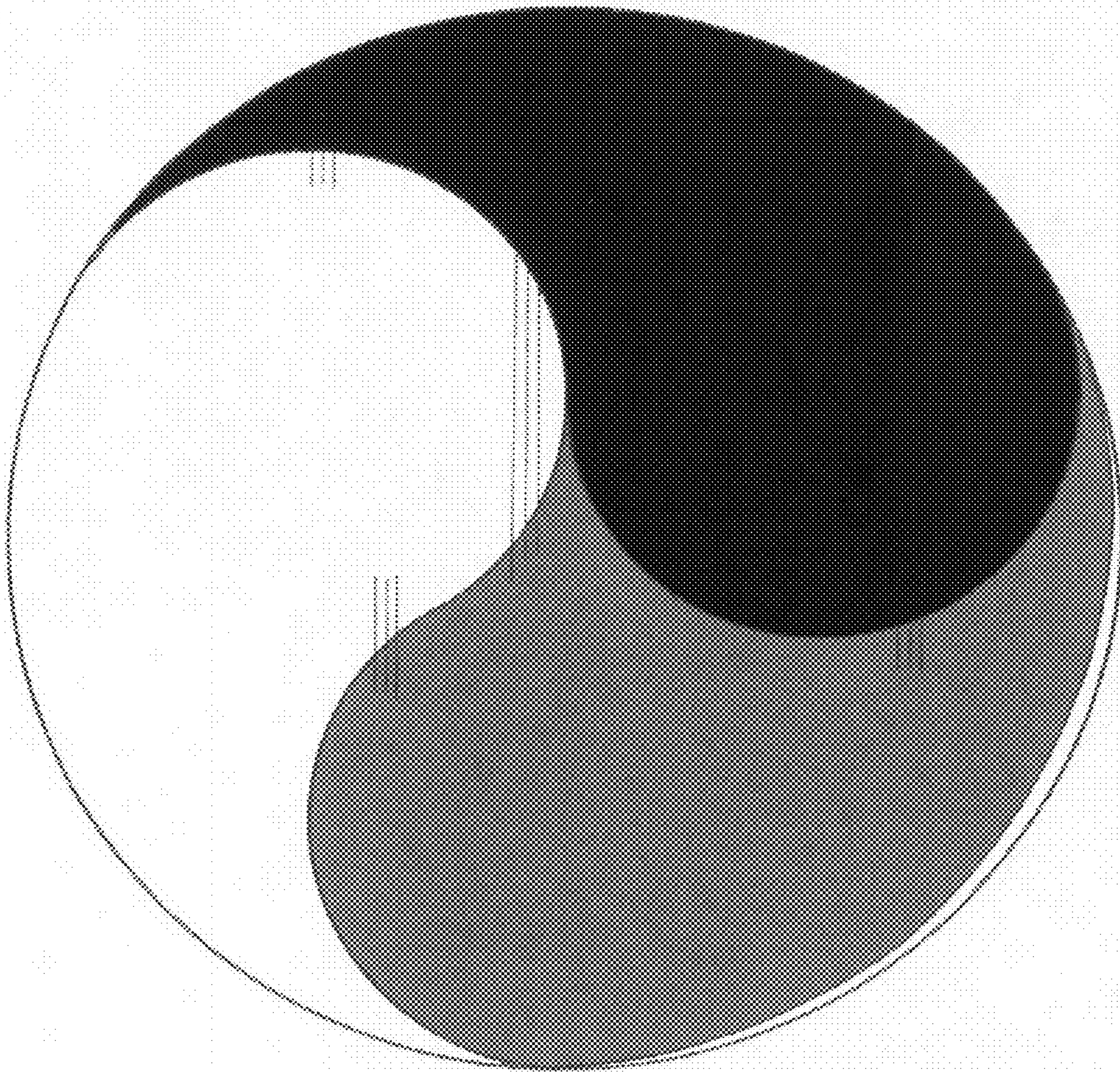

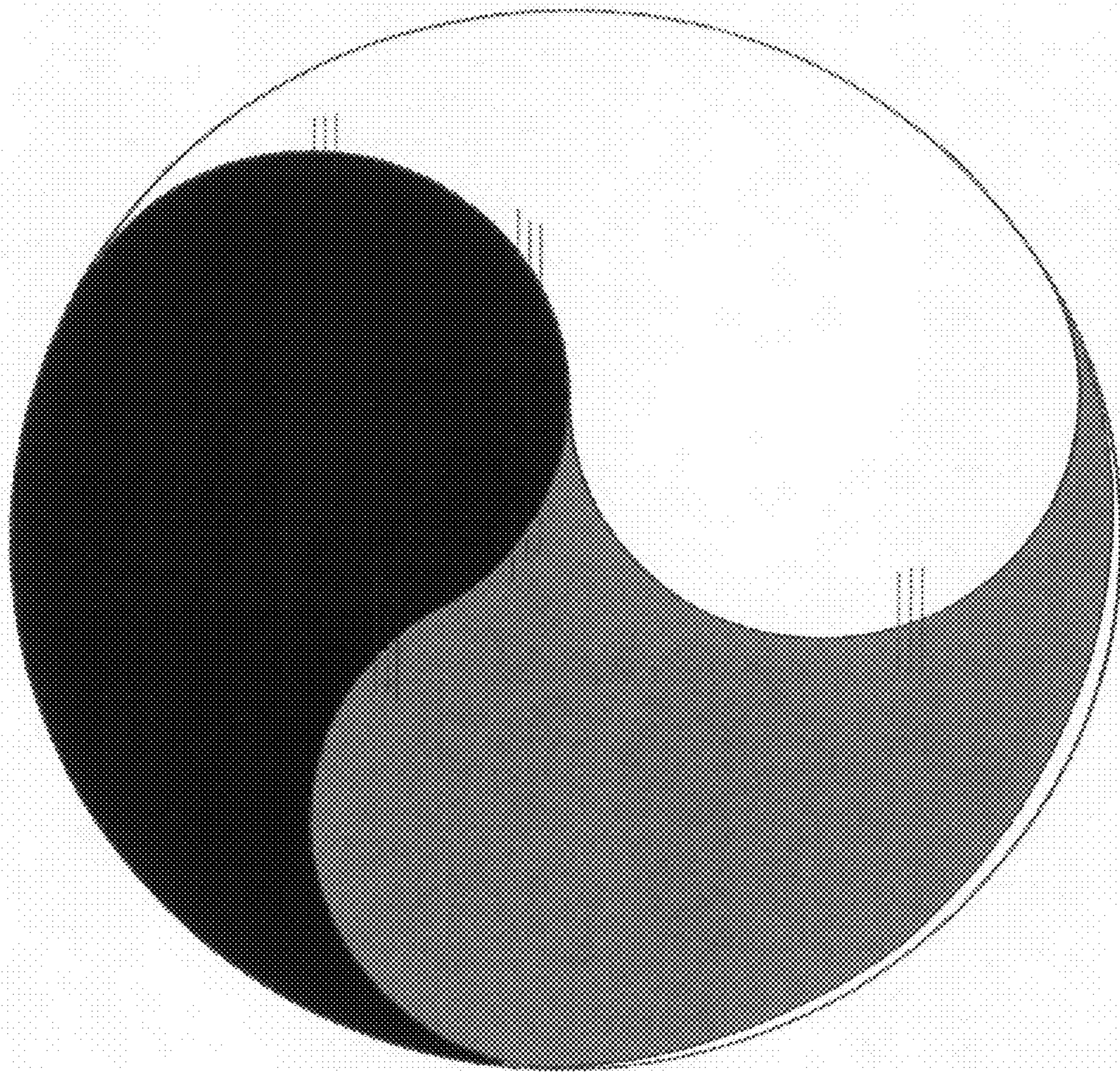

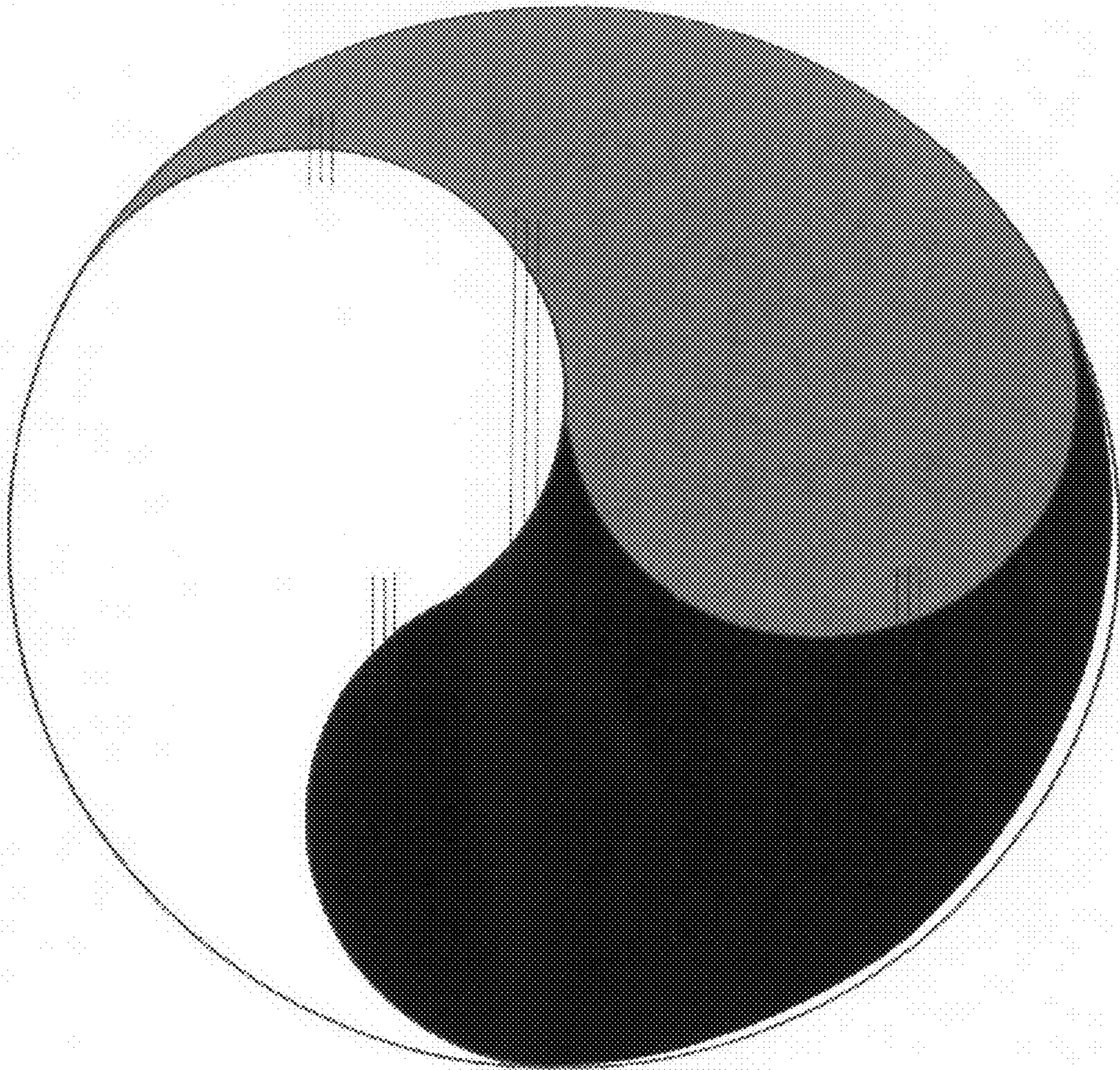

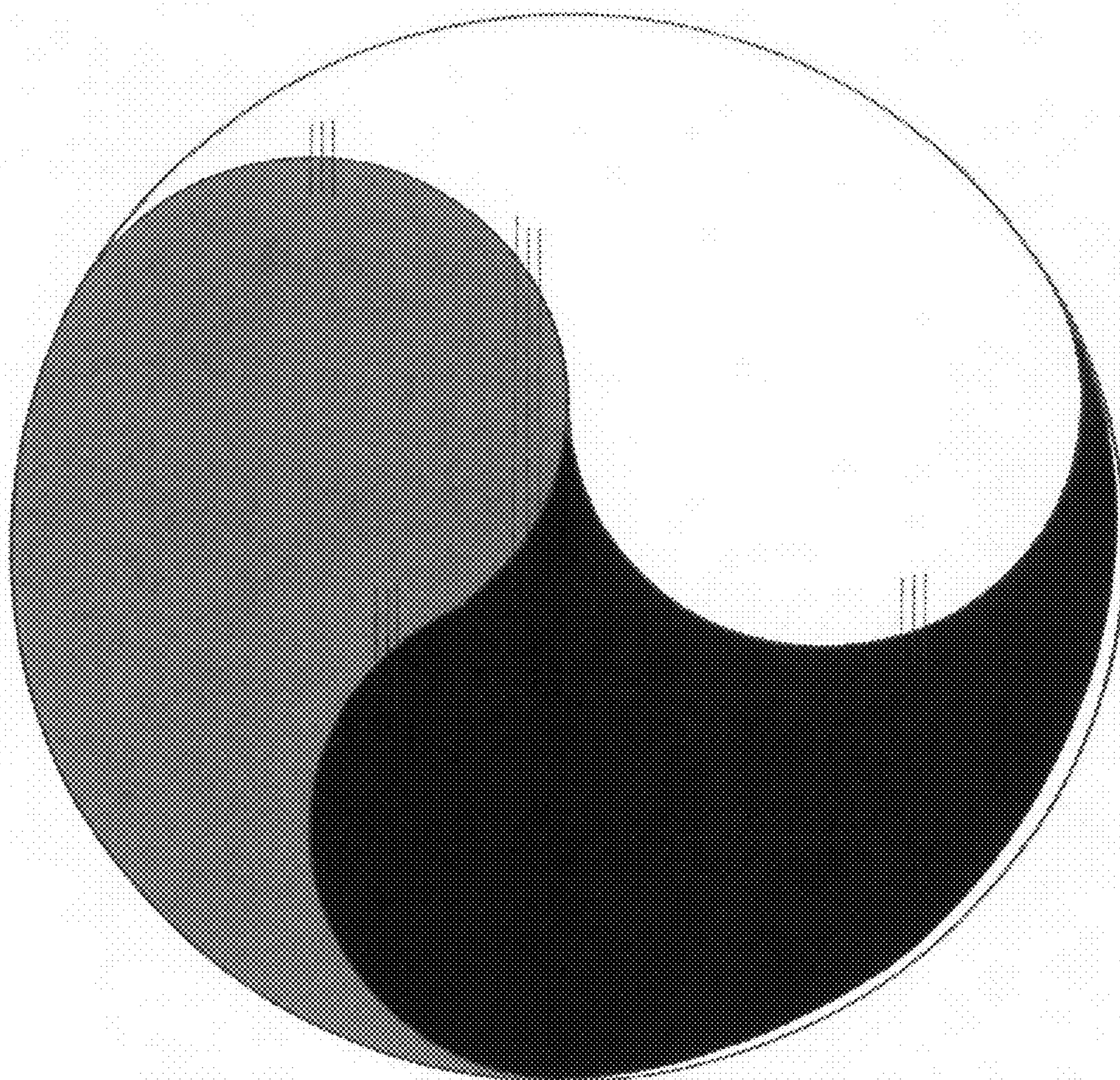

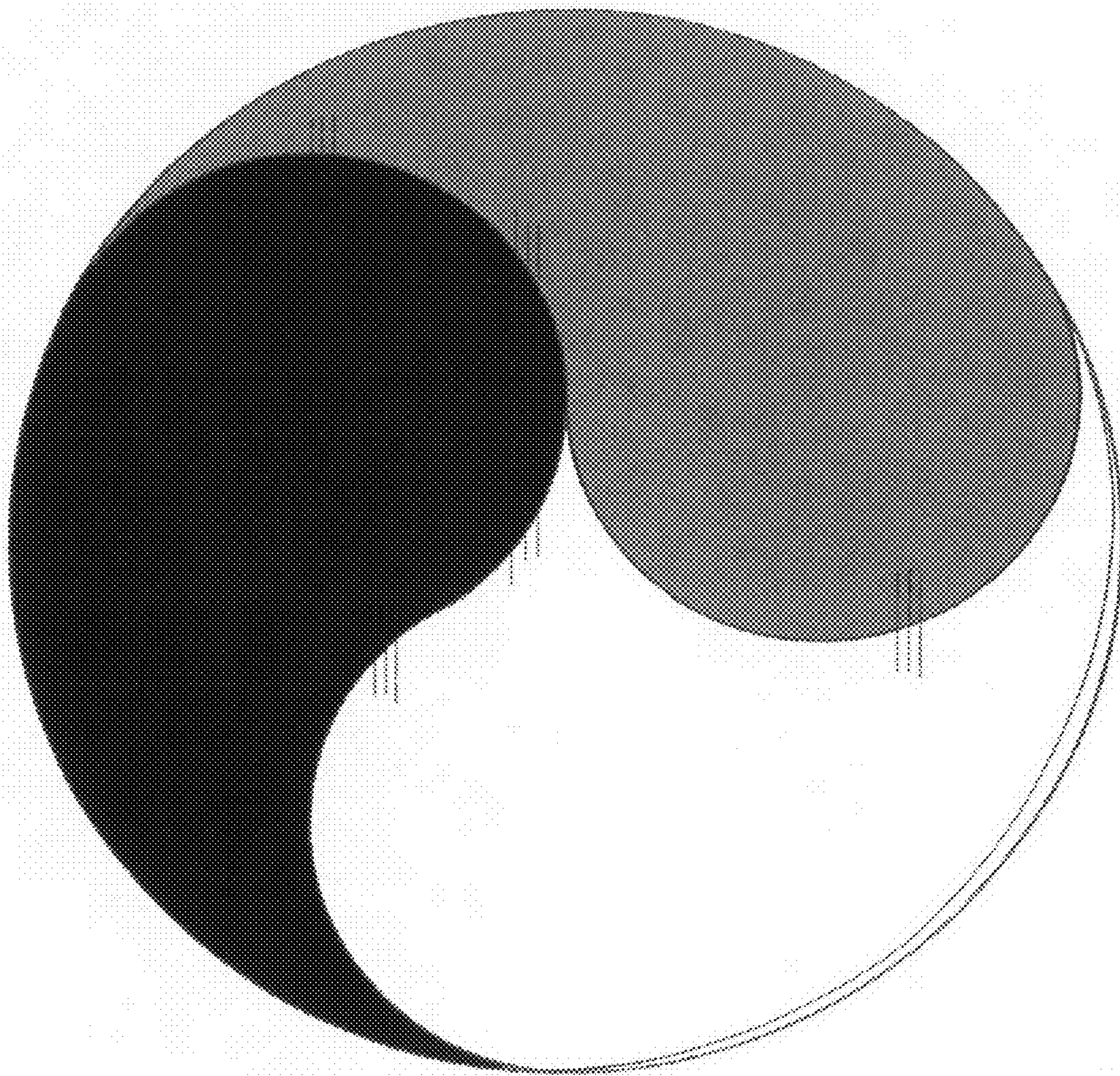

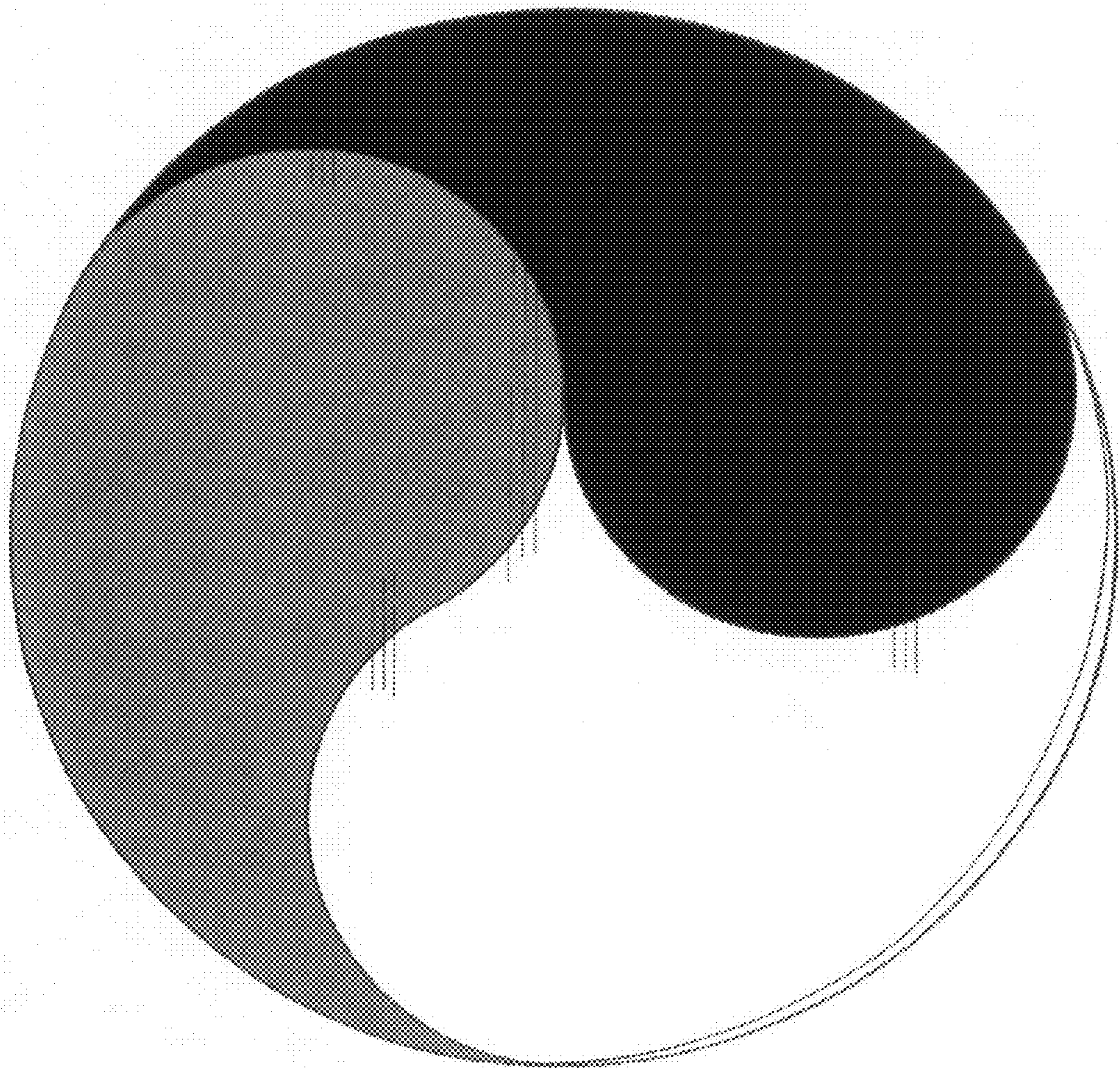
