(57) **CLAIM**

I hereby claim the design for the bicycle stand, as shown and described.

FIG. 1 is a front view of a bicycle stand showing my design, with both lids of the two compartments closed;
 FIG. 2 is isometric view thereof, with both lids of the two compartments closed;
 FIG. 3 is a right side view thereof, with both lids of the two compartments closed;
 FIG. 4 is a tom view thereof, with both lids of the two compartments closed;
 FIG. 5 is a bottom view thereof, with both lids of the two compartments closed;
 FIG. 6 is a left side view thereof, with both lids of the two compartments closed;
 FIG. 7 is a rear side view thereof, with both lids of the two compartments closed;
 FIG. 8 is a front view thereof, with one lid open showing the inside of the compartment;
 FIG. 9 is isometric view thereof, with one lid open showing the inside of the compartment;
 FIG. 10 is a right side view thereof, with one lid open showing the inside of the compartment;
 FIG. 11 is a tom view thereof, with one lid open showing the inside of the compartment;
 FIG. 12 is a bottom view thereof, with one lid open showing the inside of the compartment;
 FIG. 13 is a left side view thereof, with one lid open showing the inside of the compartment; and,
 FIG. 14 is a rear side view thereof, with one lid open showing the inside of the compartment.

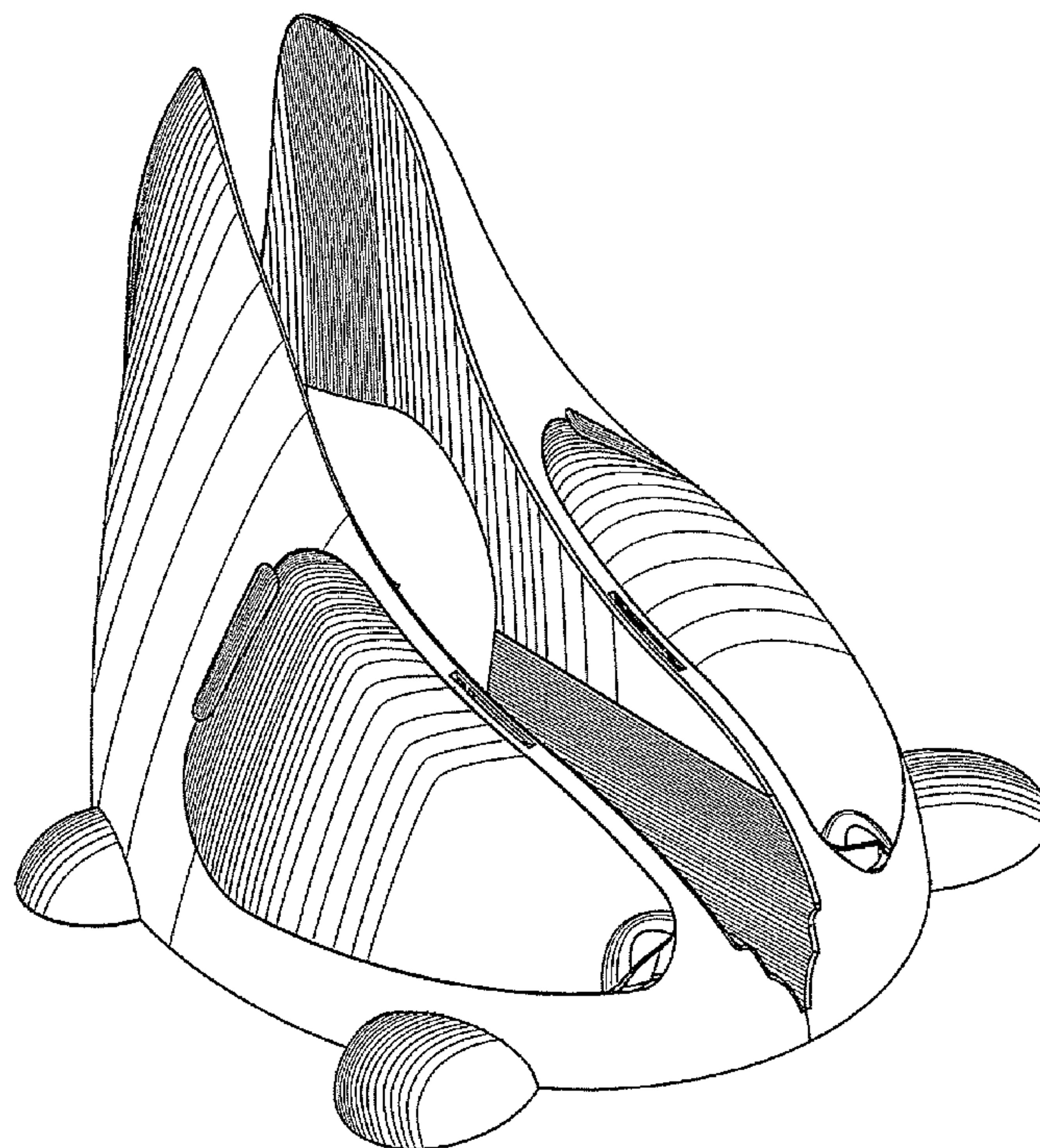

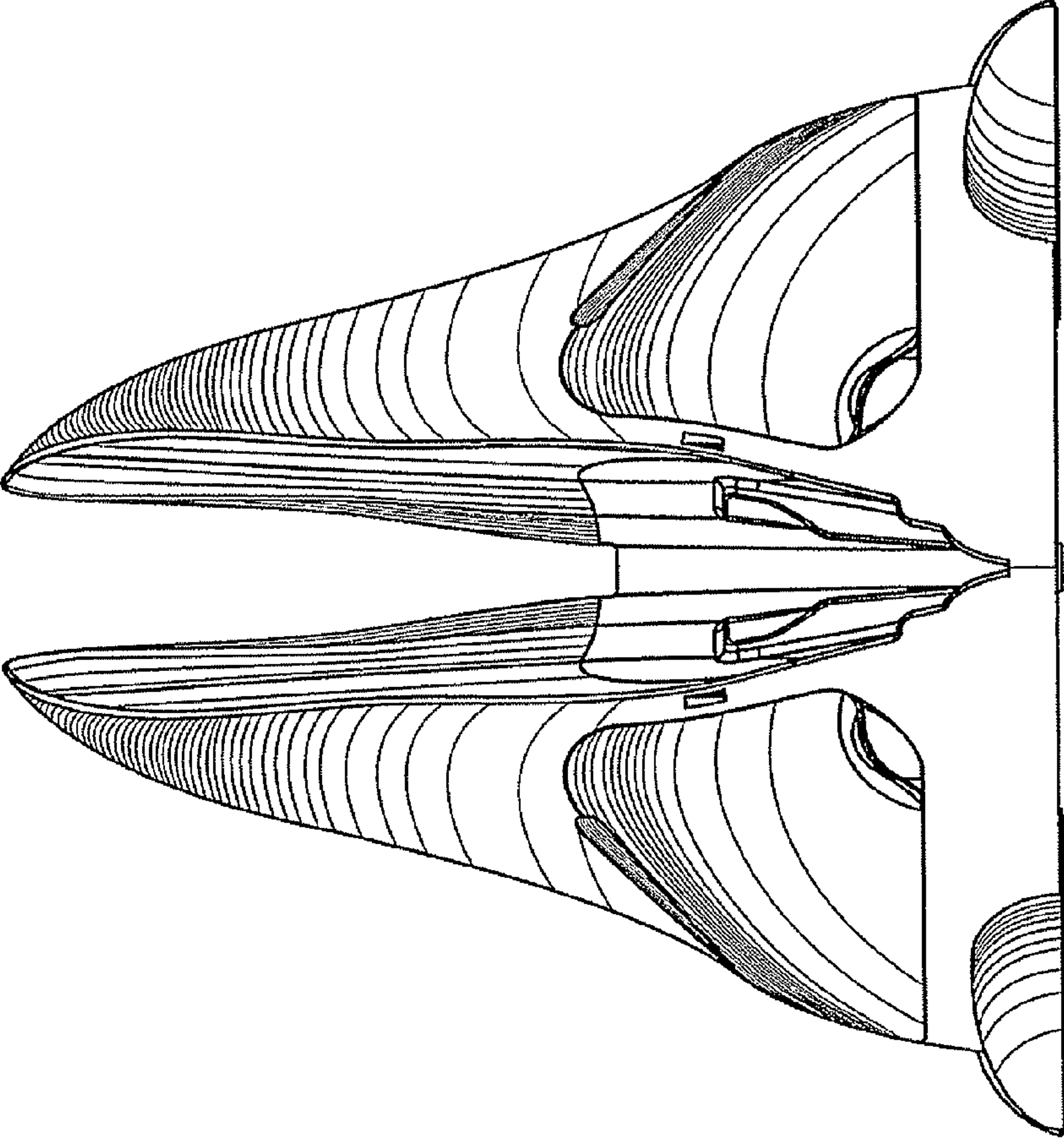

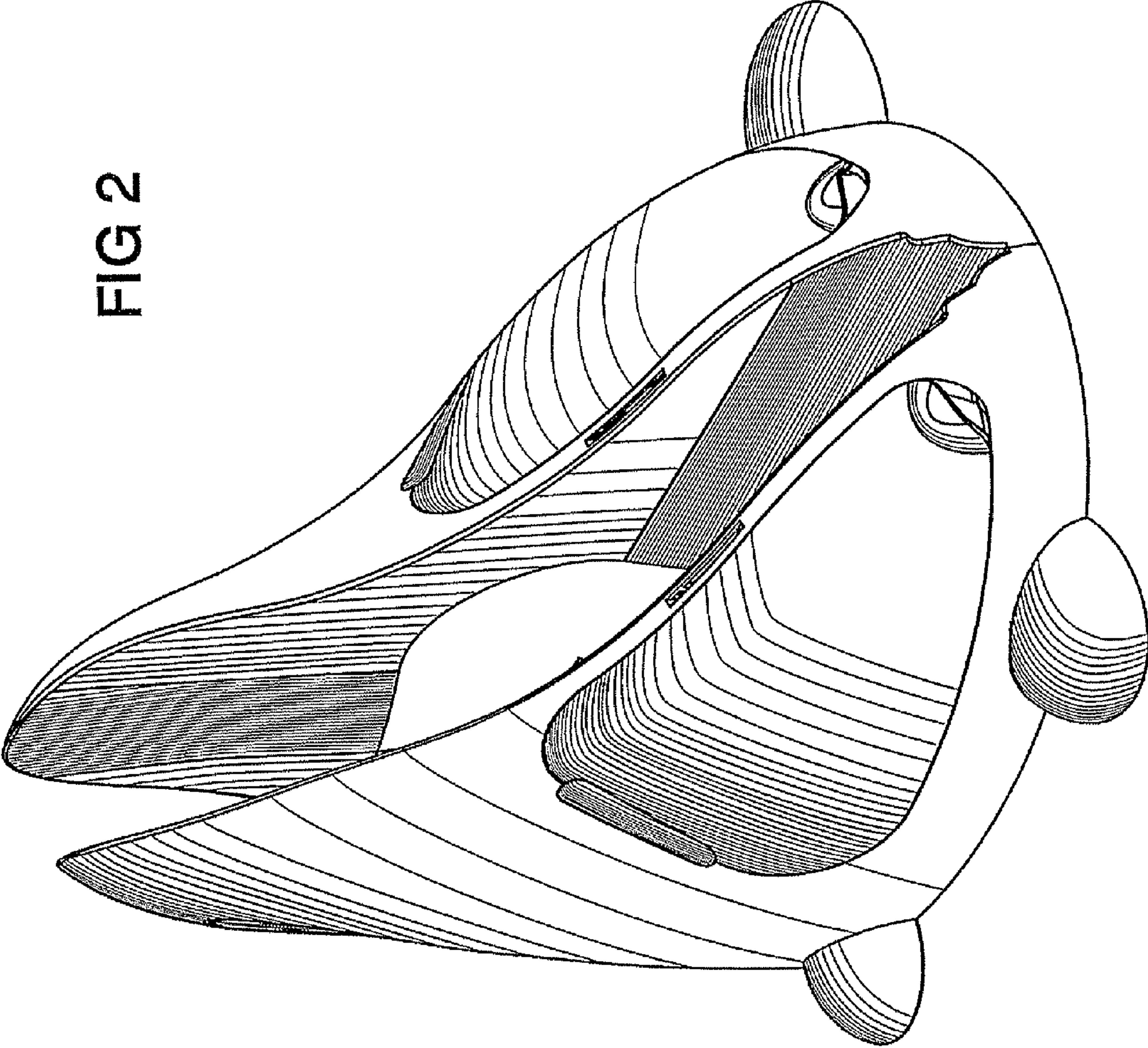

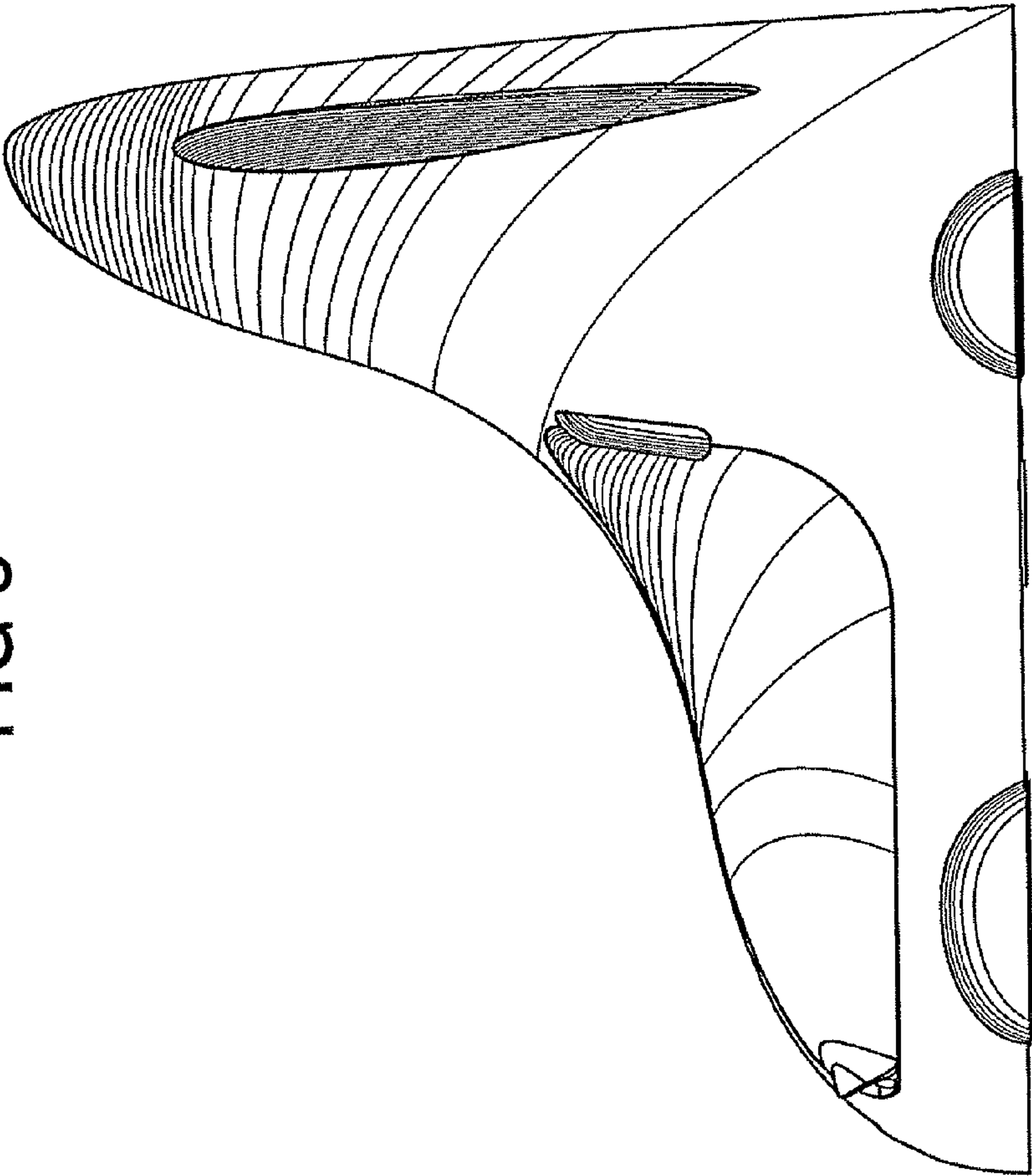

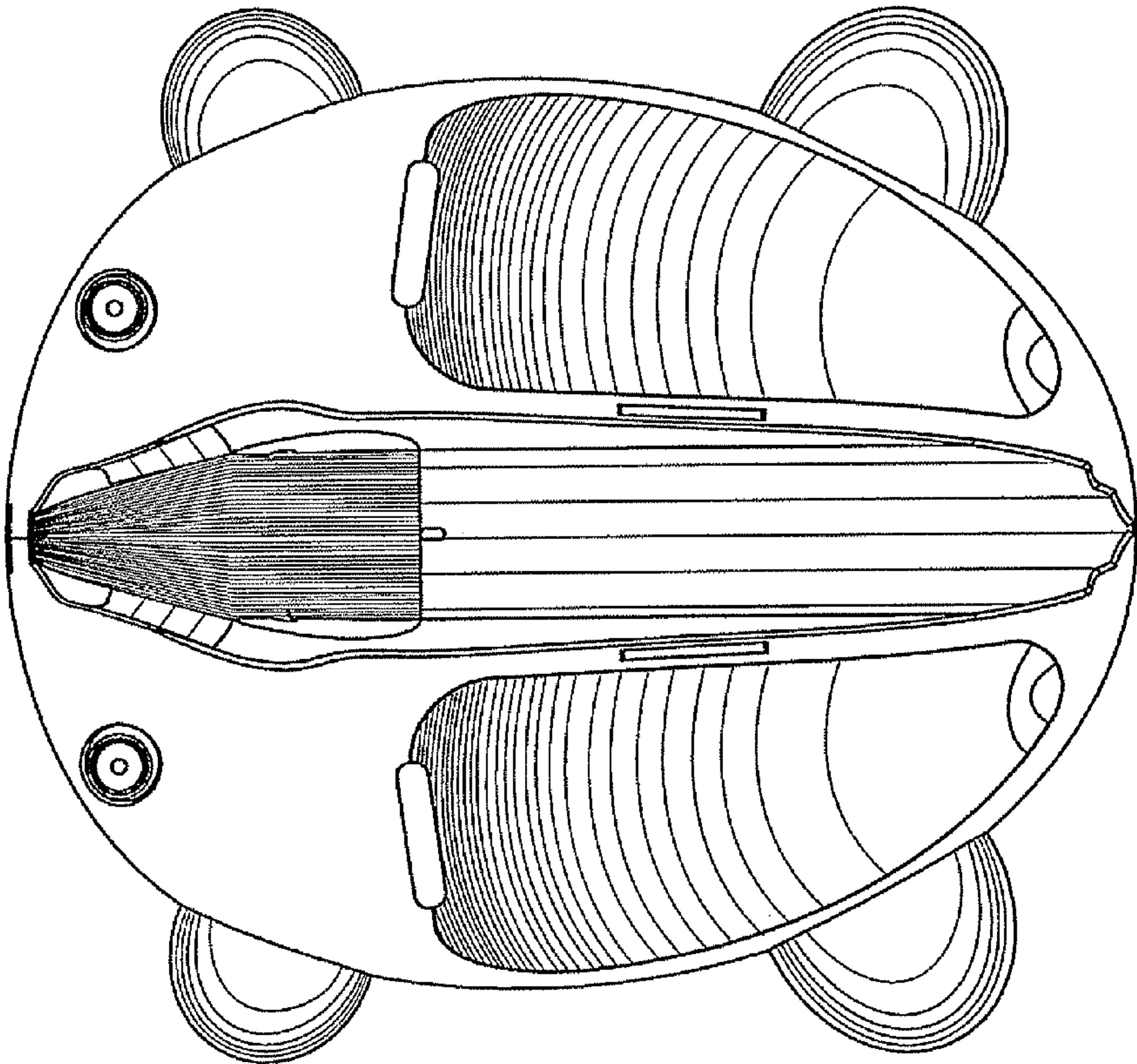

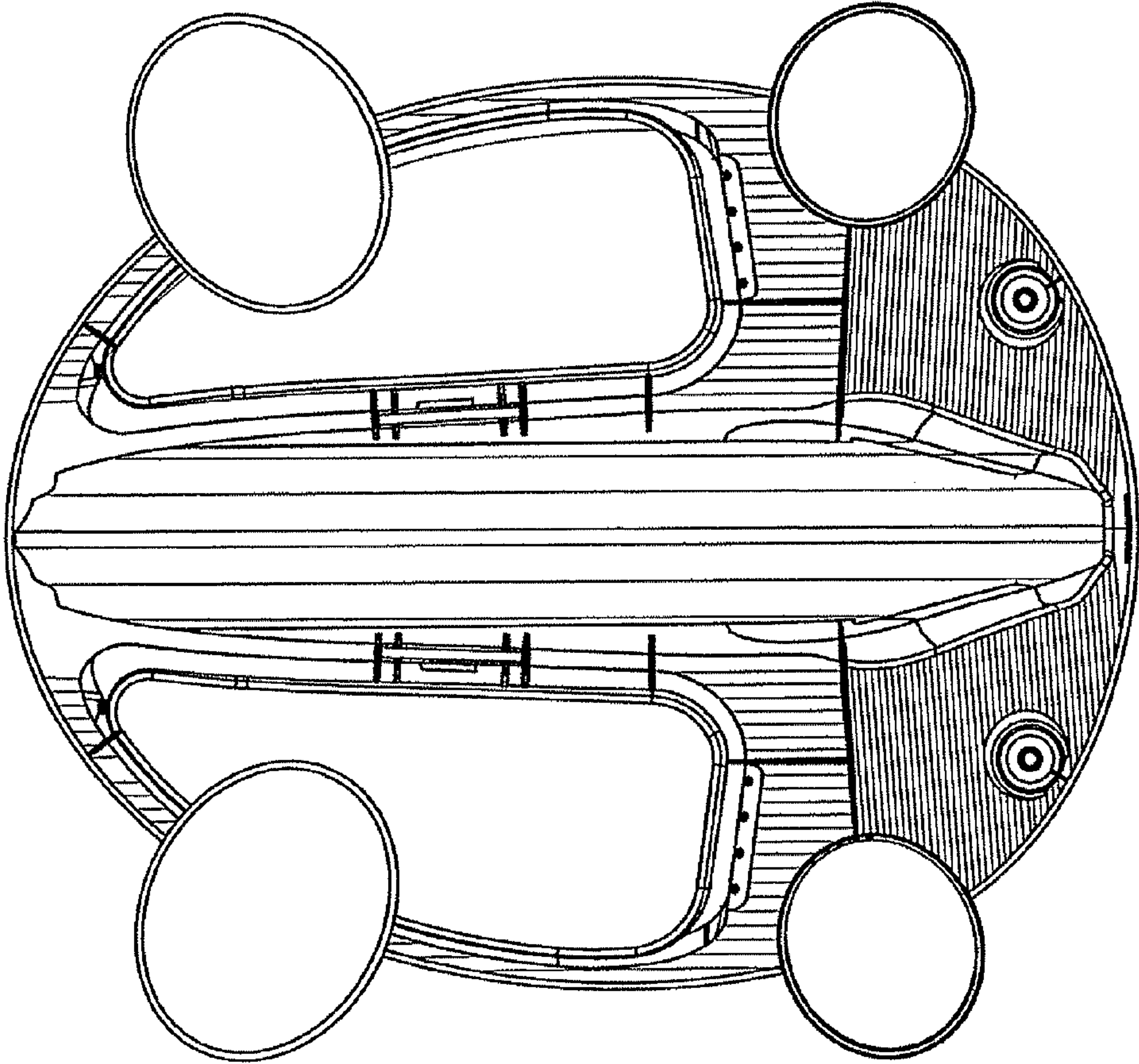

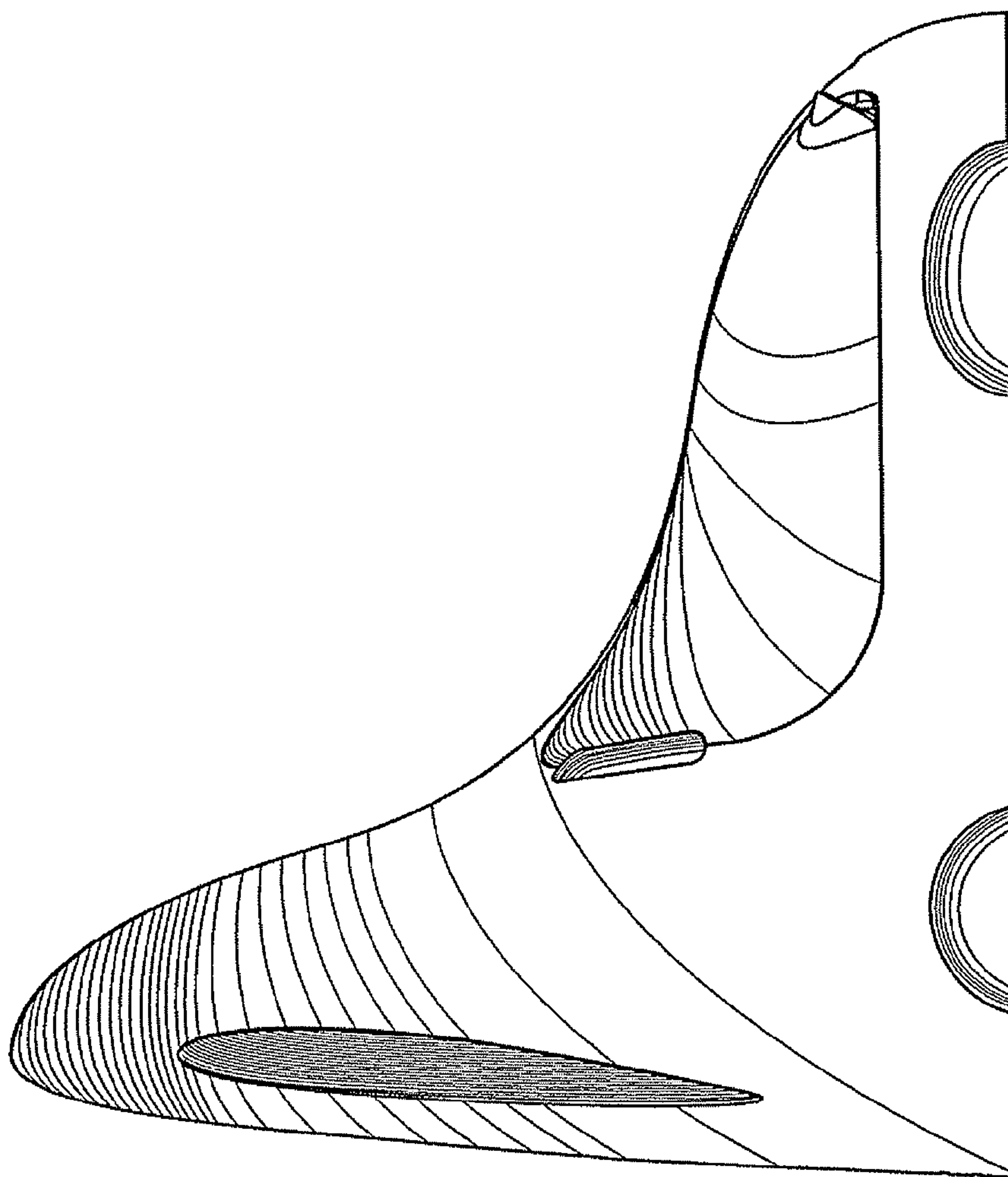

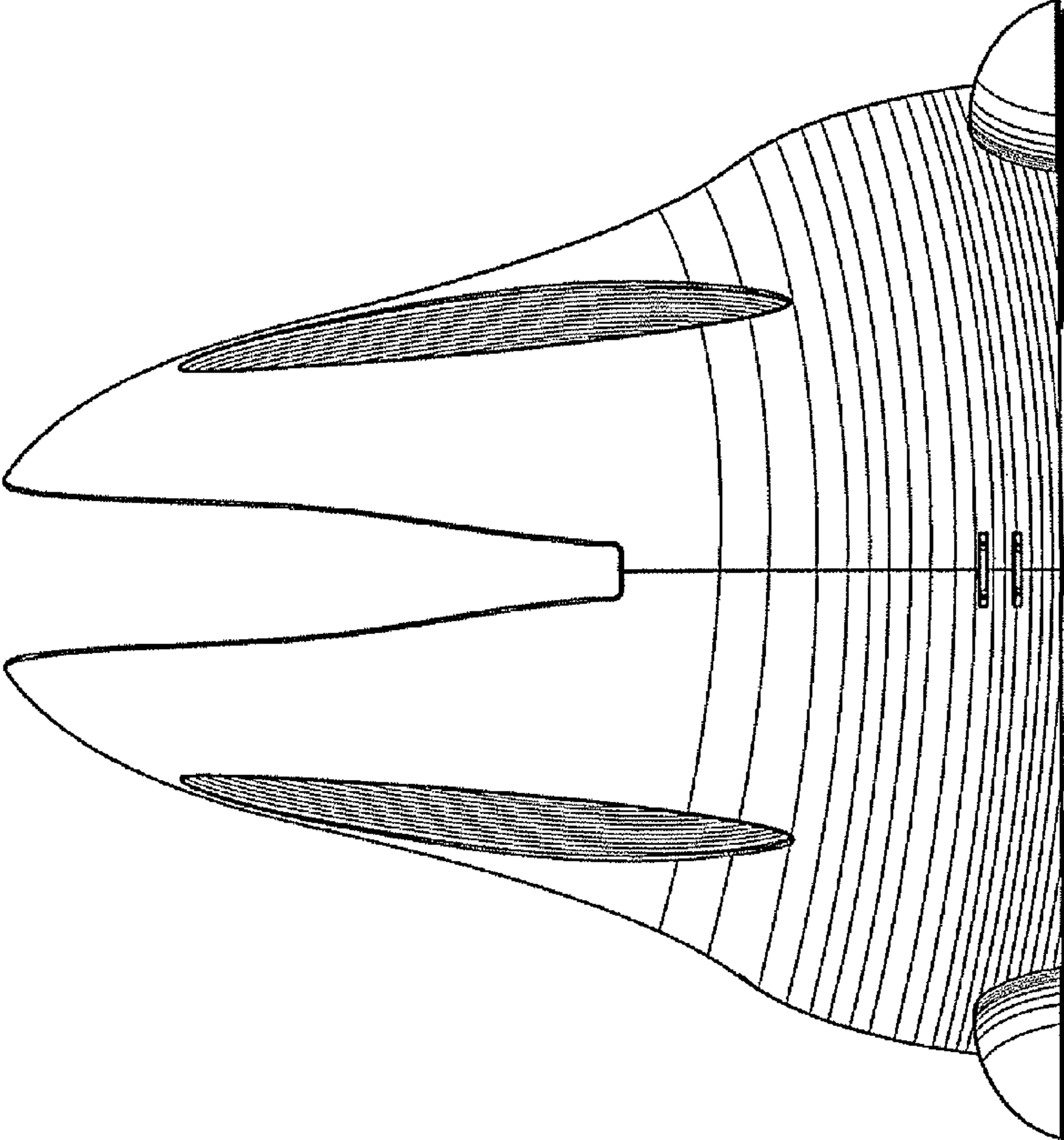

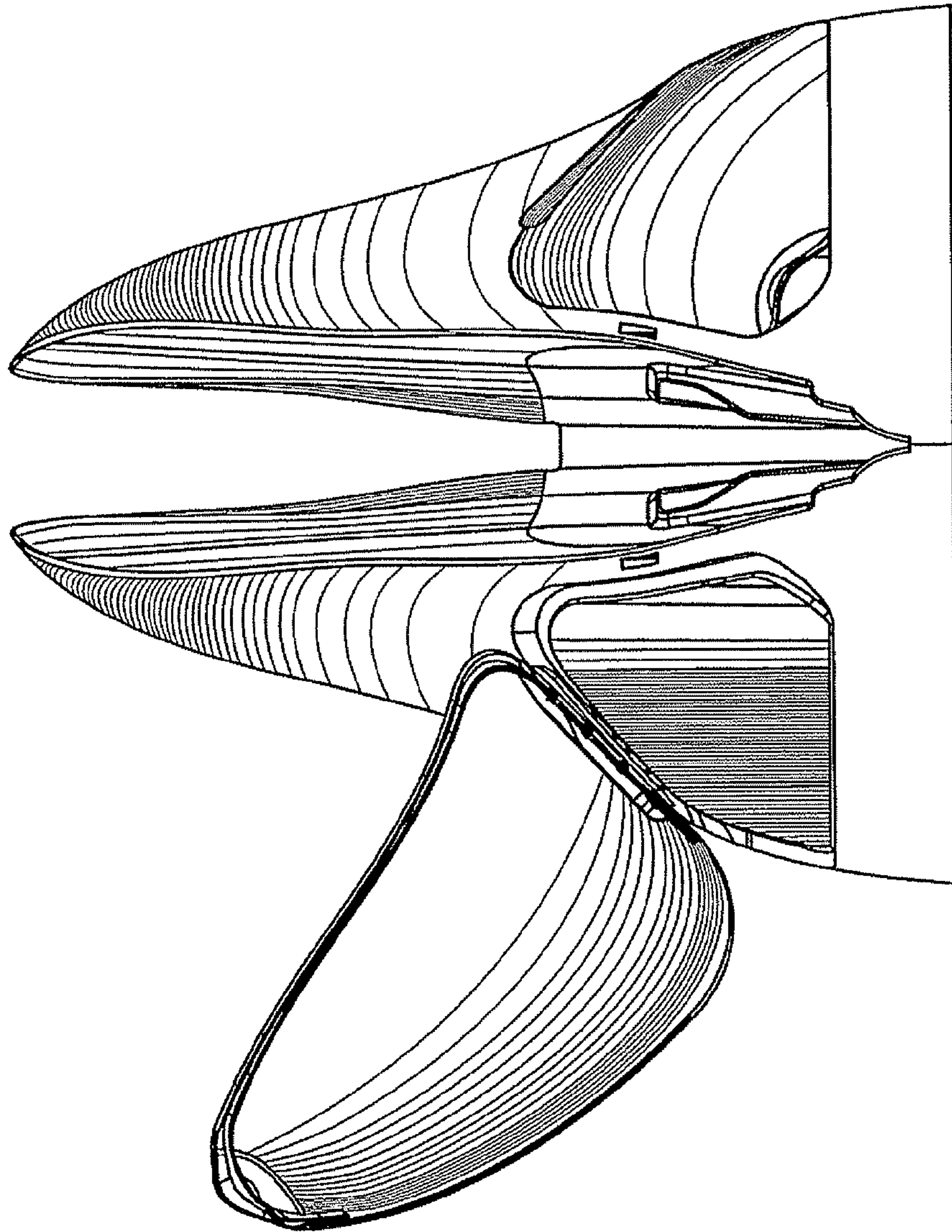

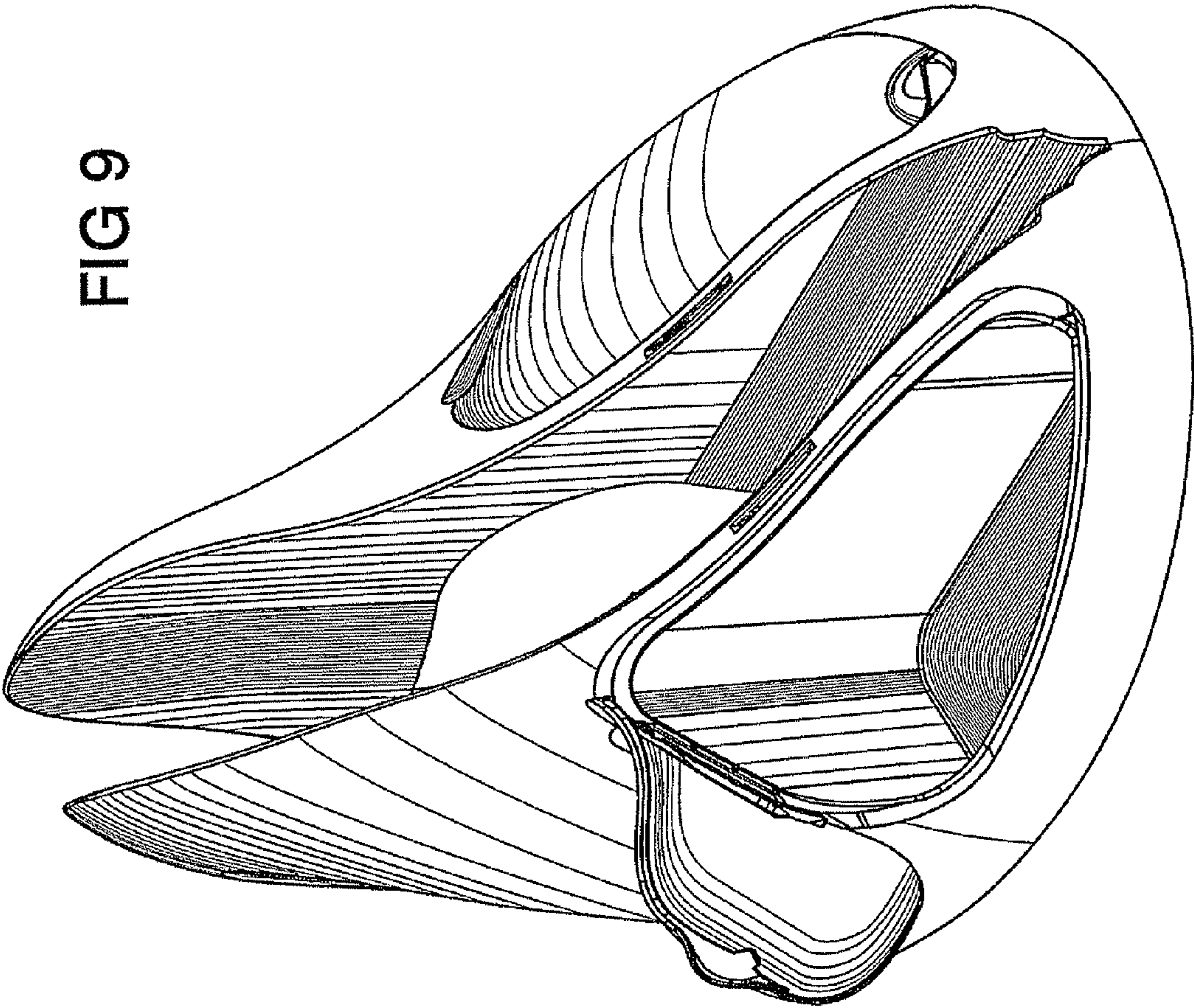

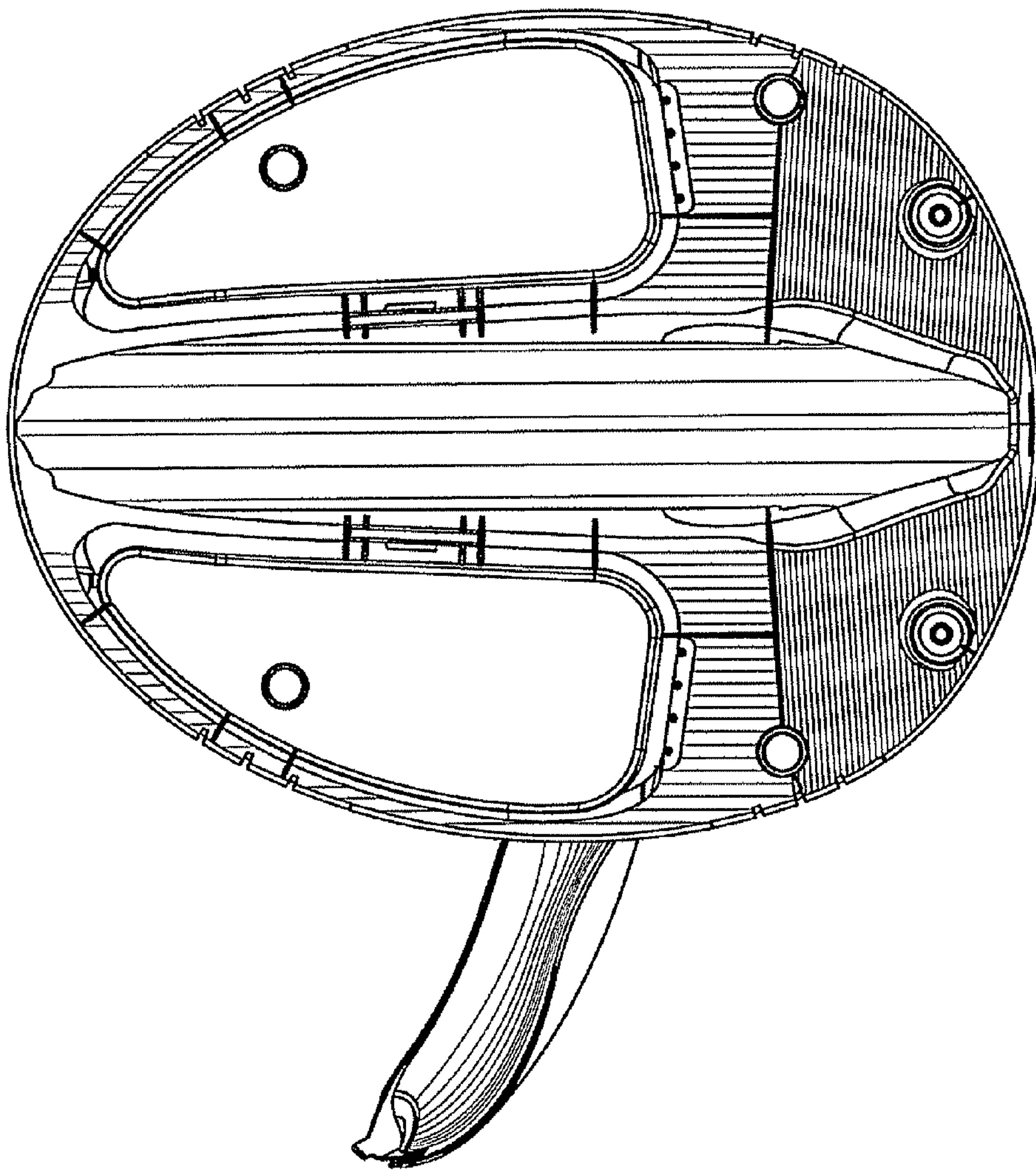

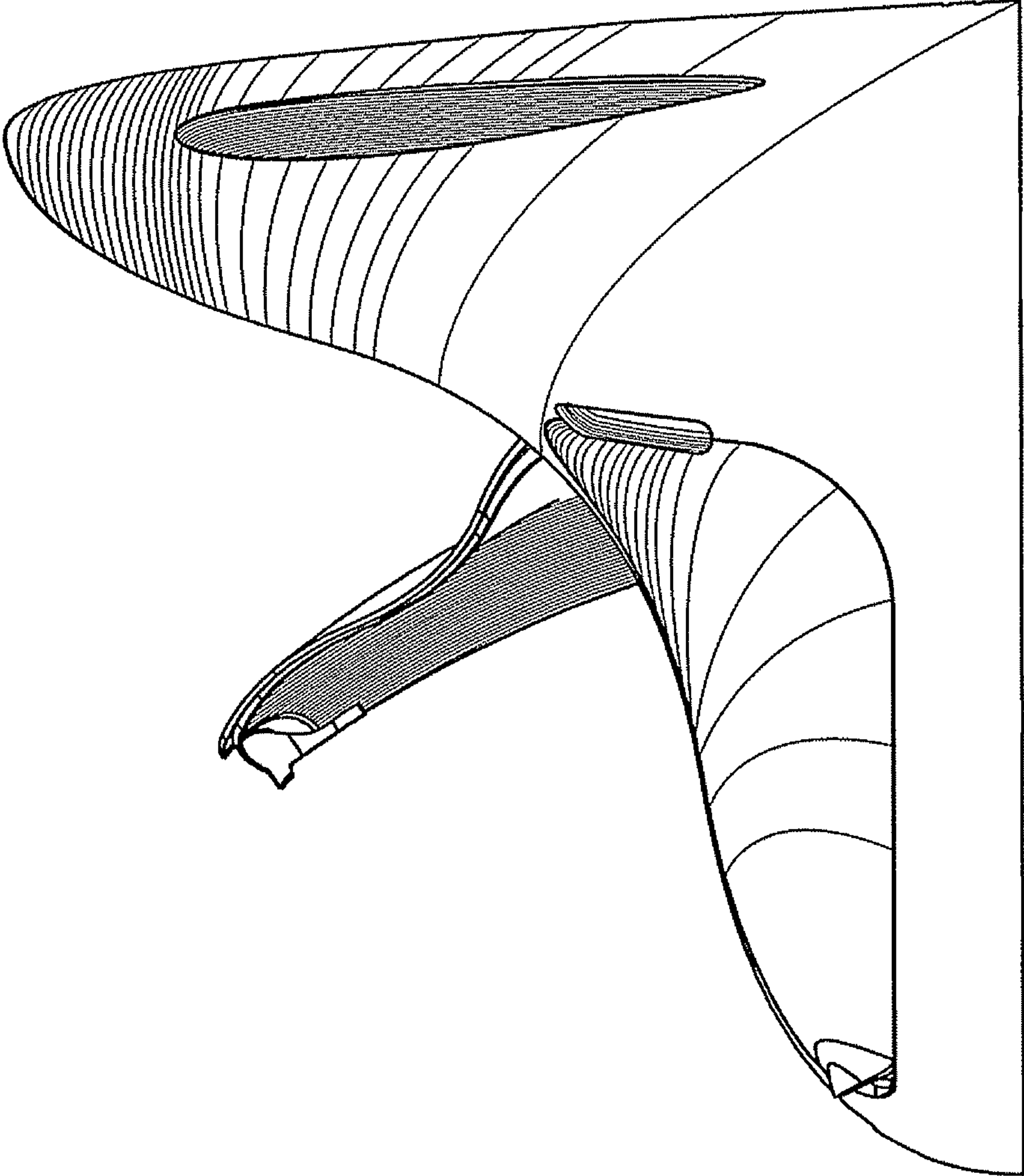

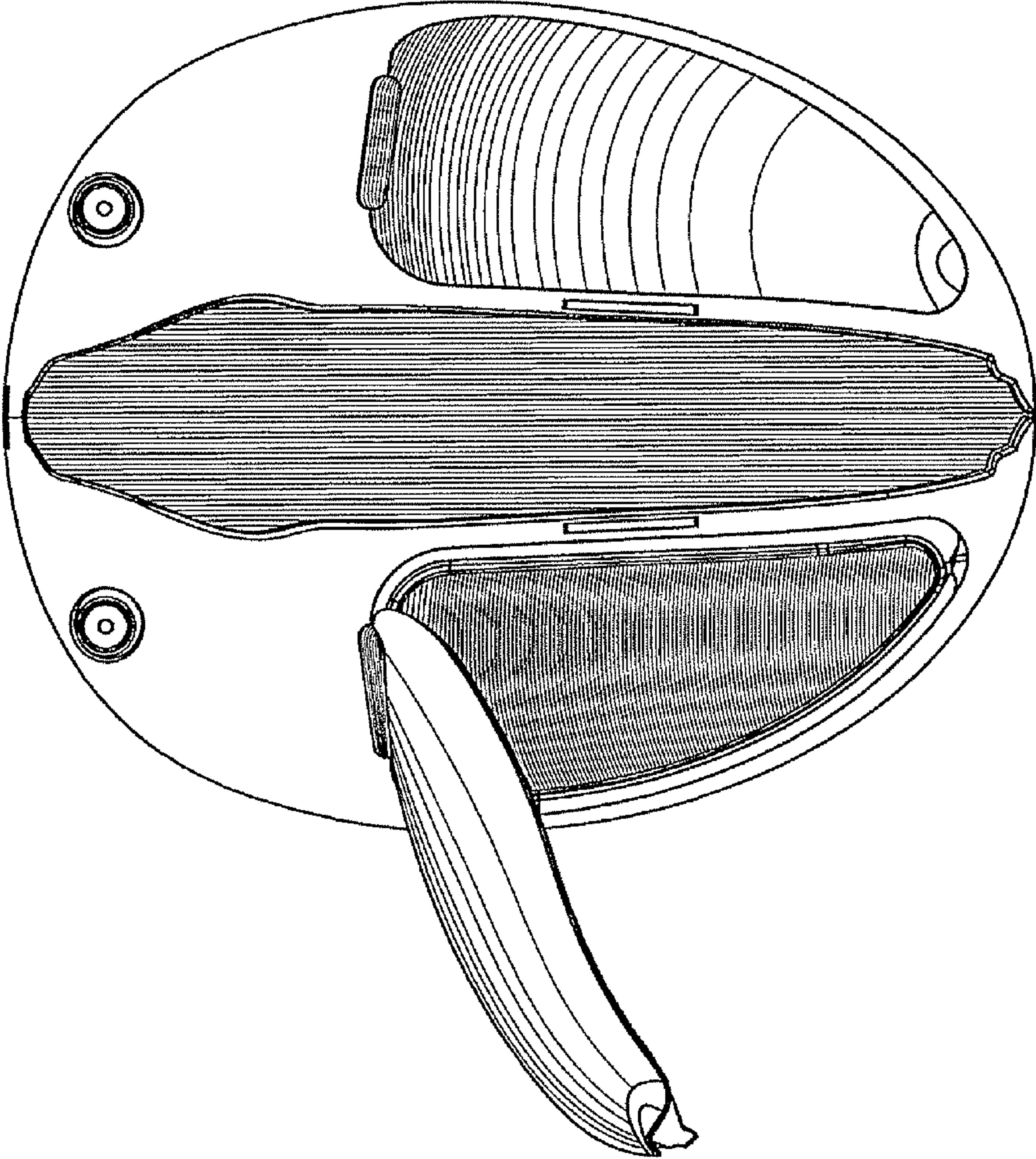

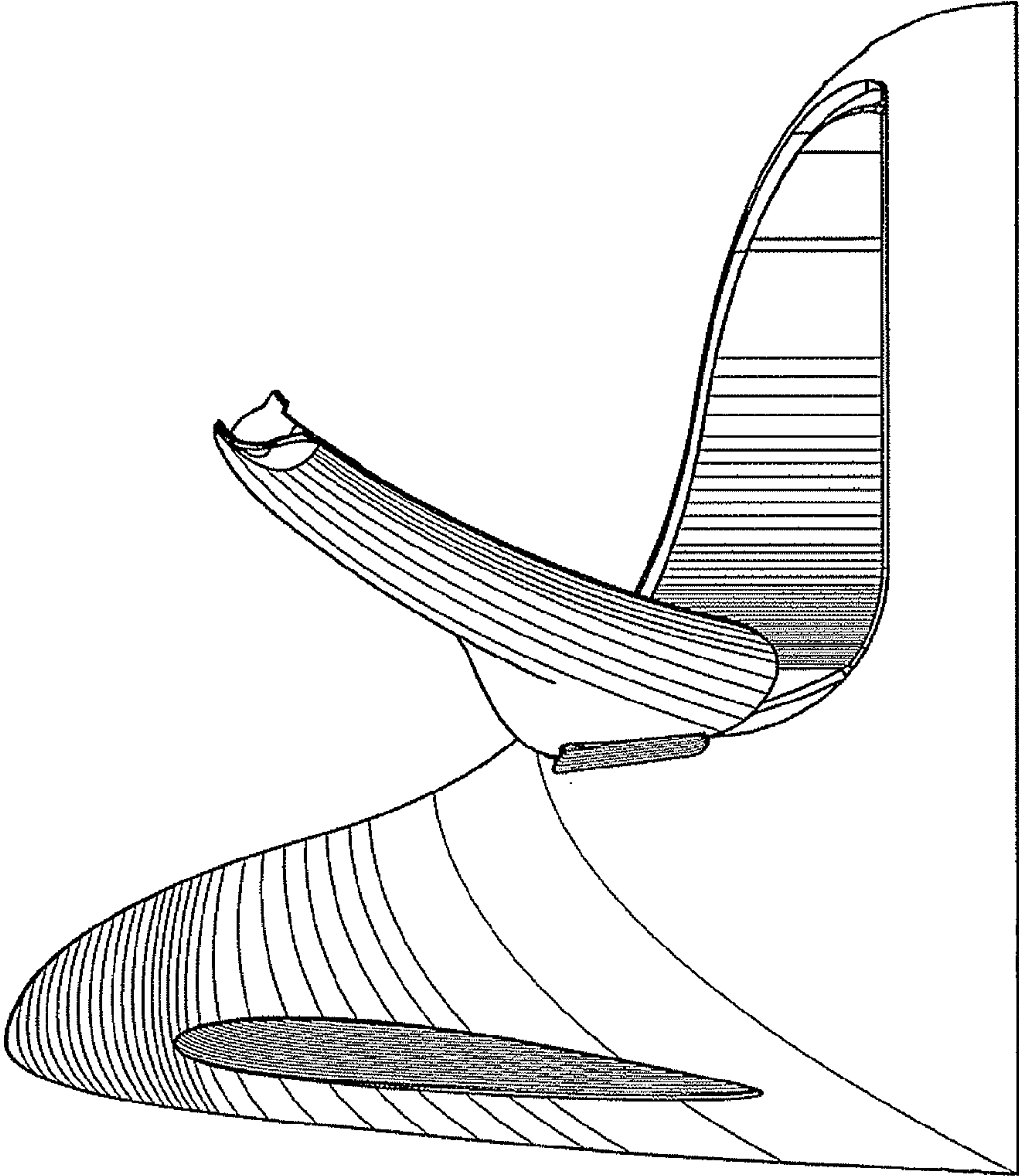
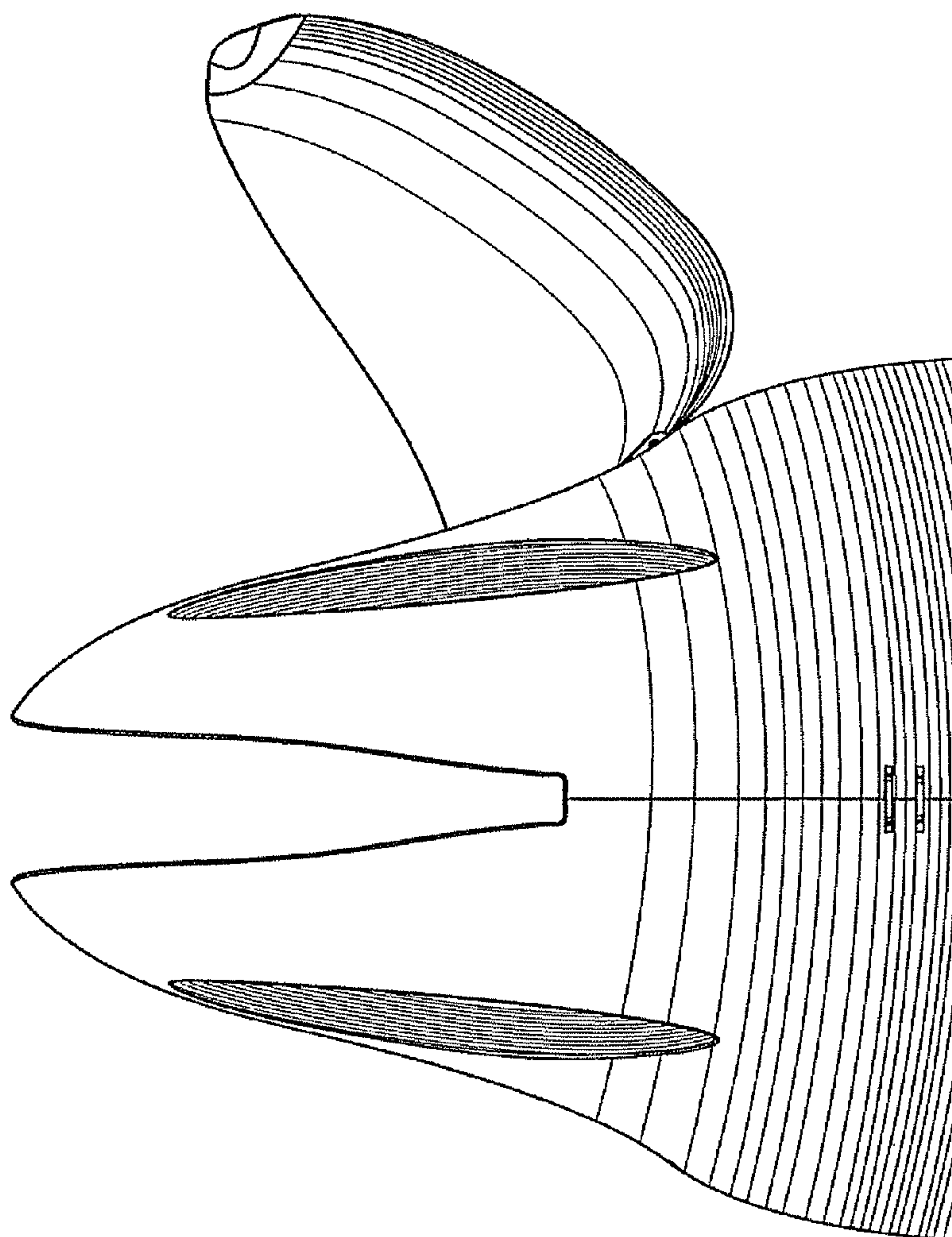
