DESCRIPTION

FIG. 1 is a perspective view of a wiper blade according to the present invention.

FIG. 4 is an enlarged left side view of the wiper blade of FIG. 1.

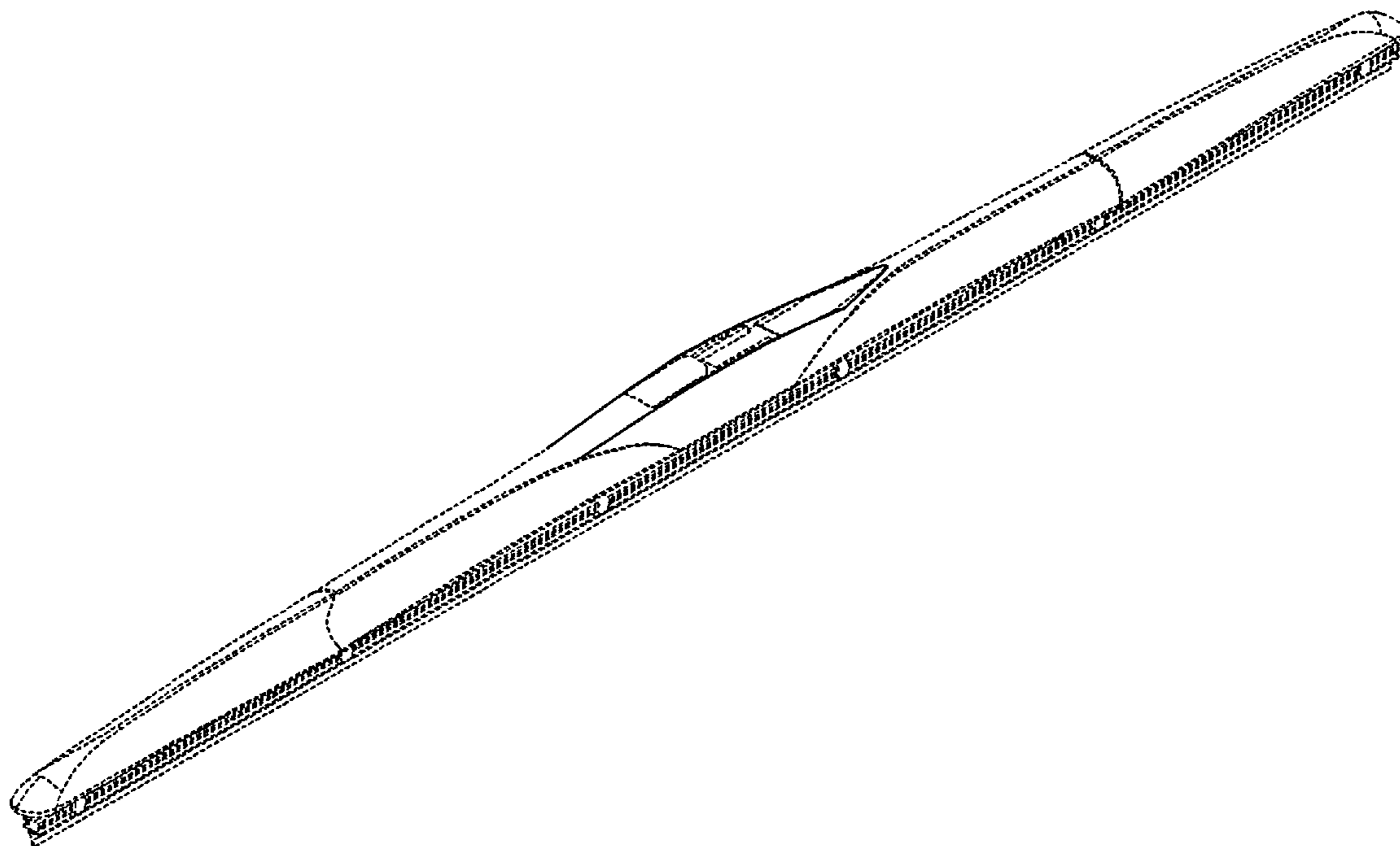
FIG. 5 is an enlarged right side view of the wiper blade of FIG. 1.

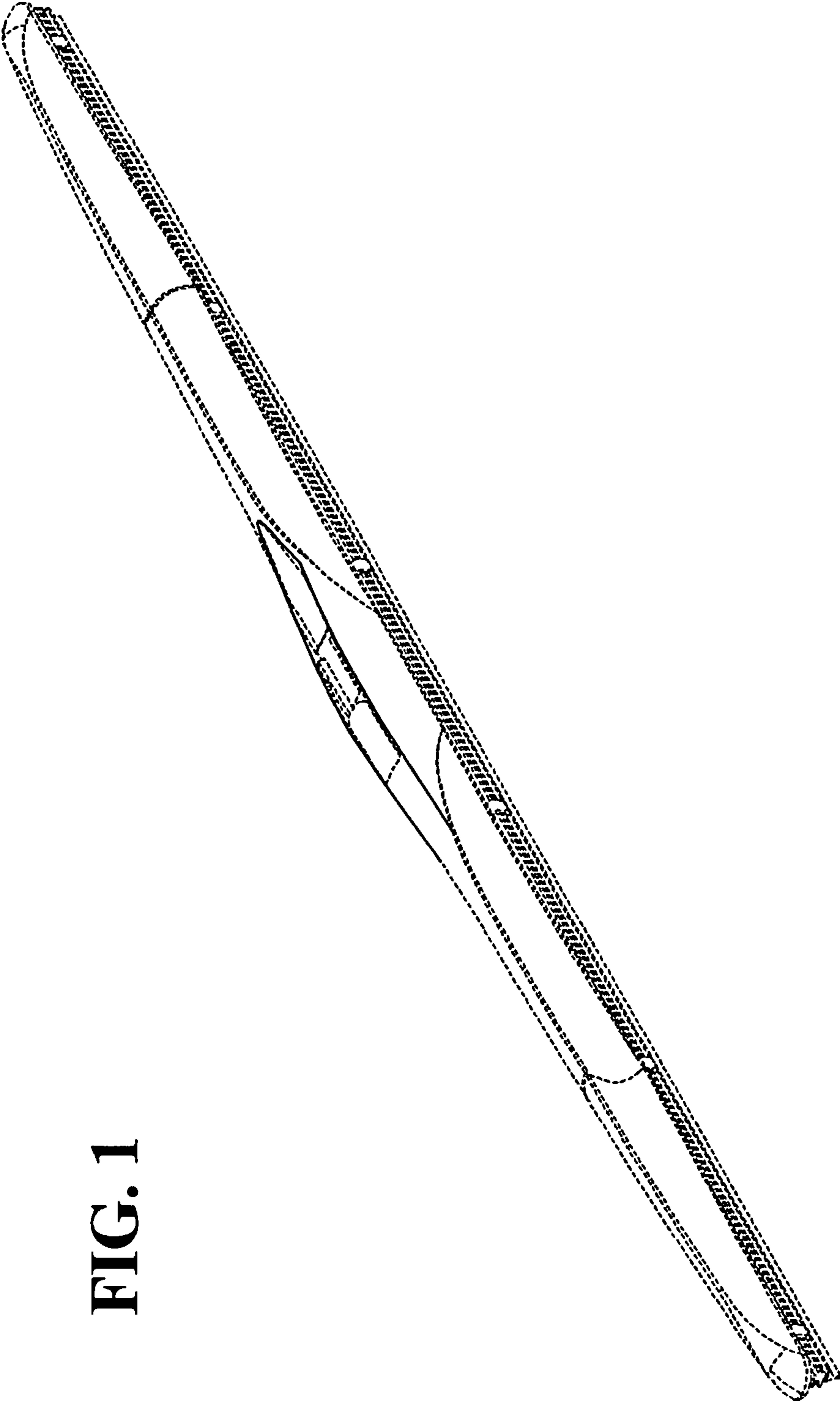

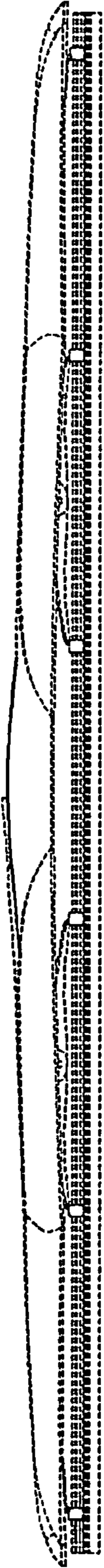

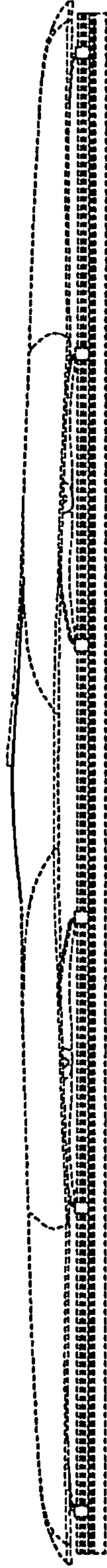

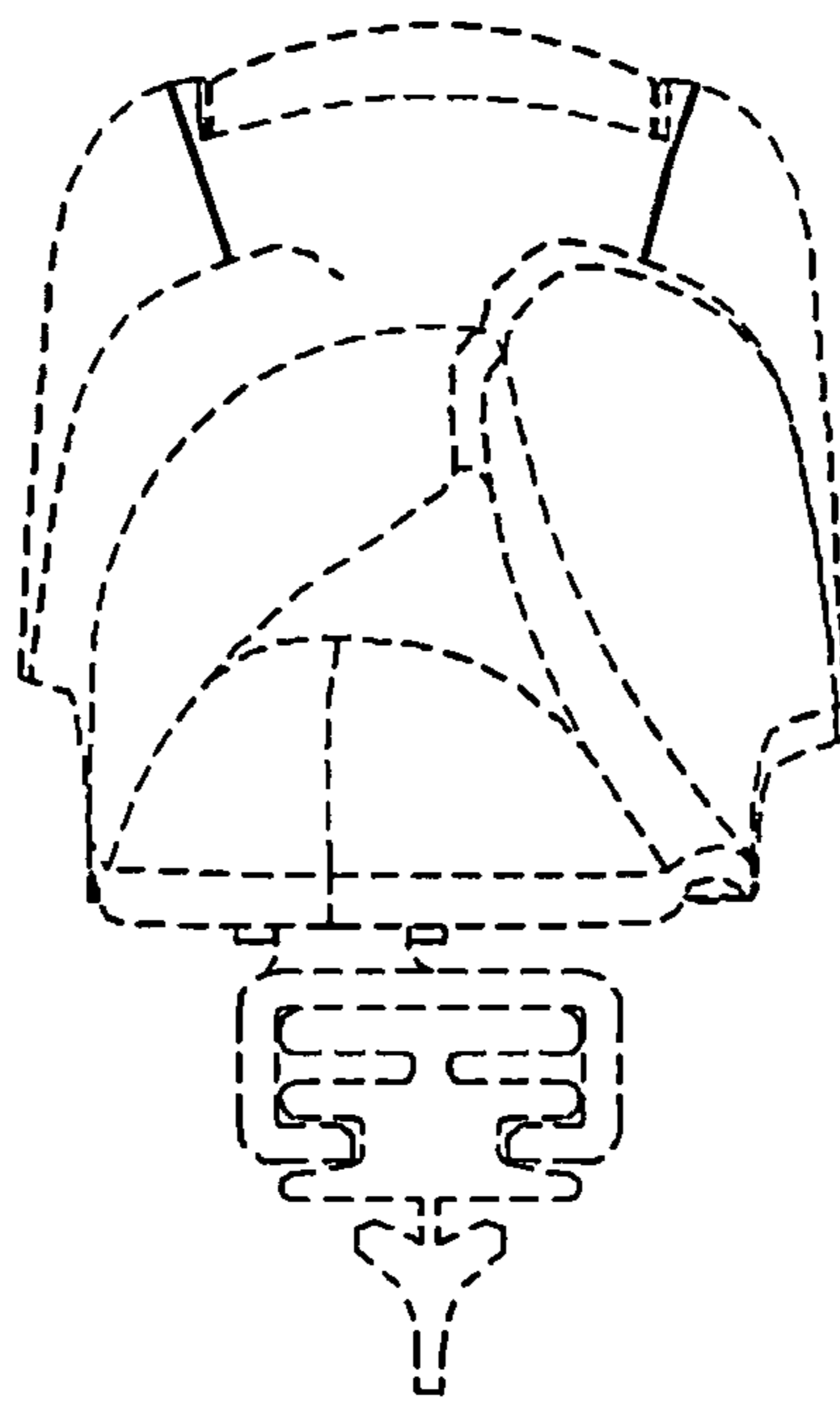

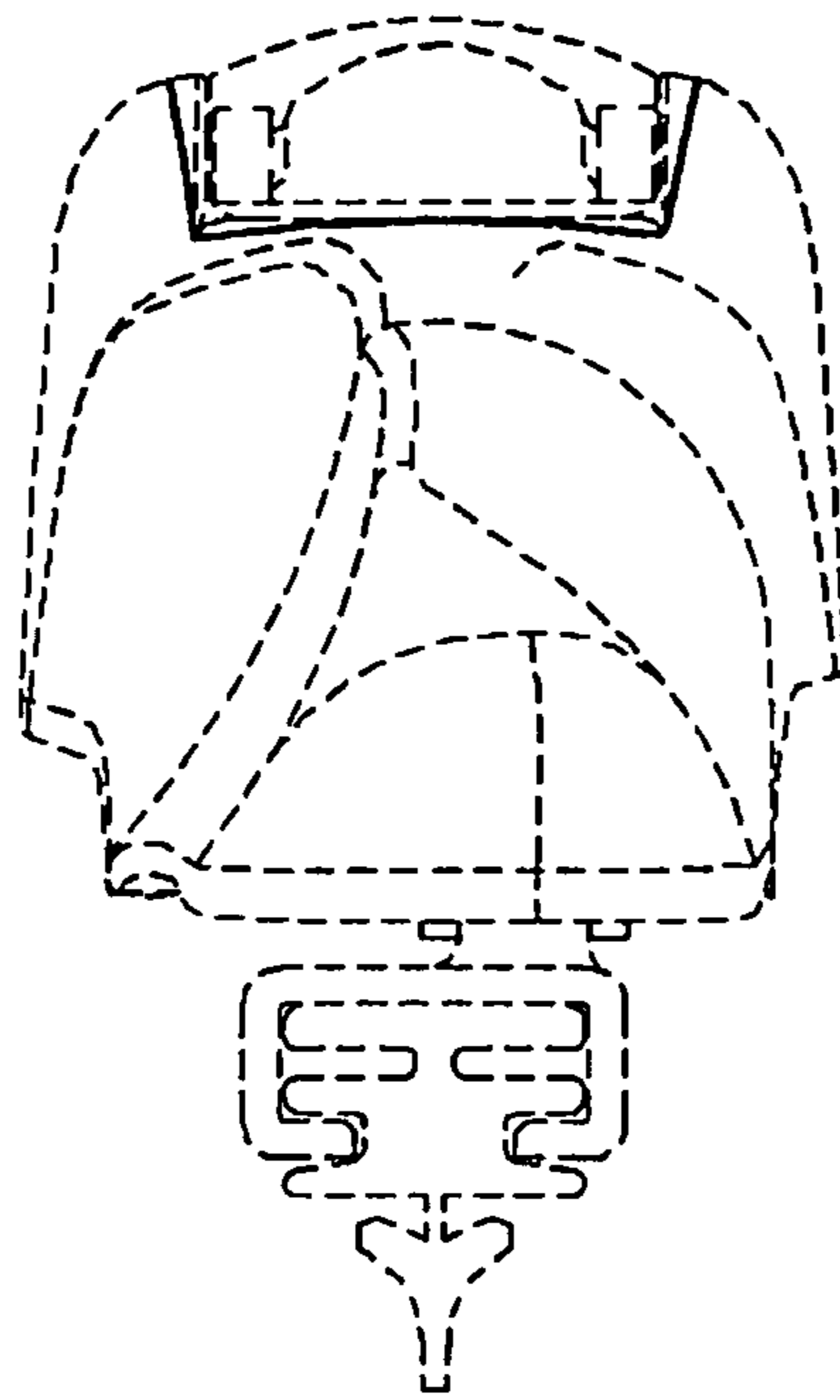
