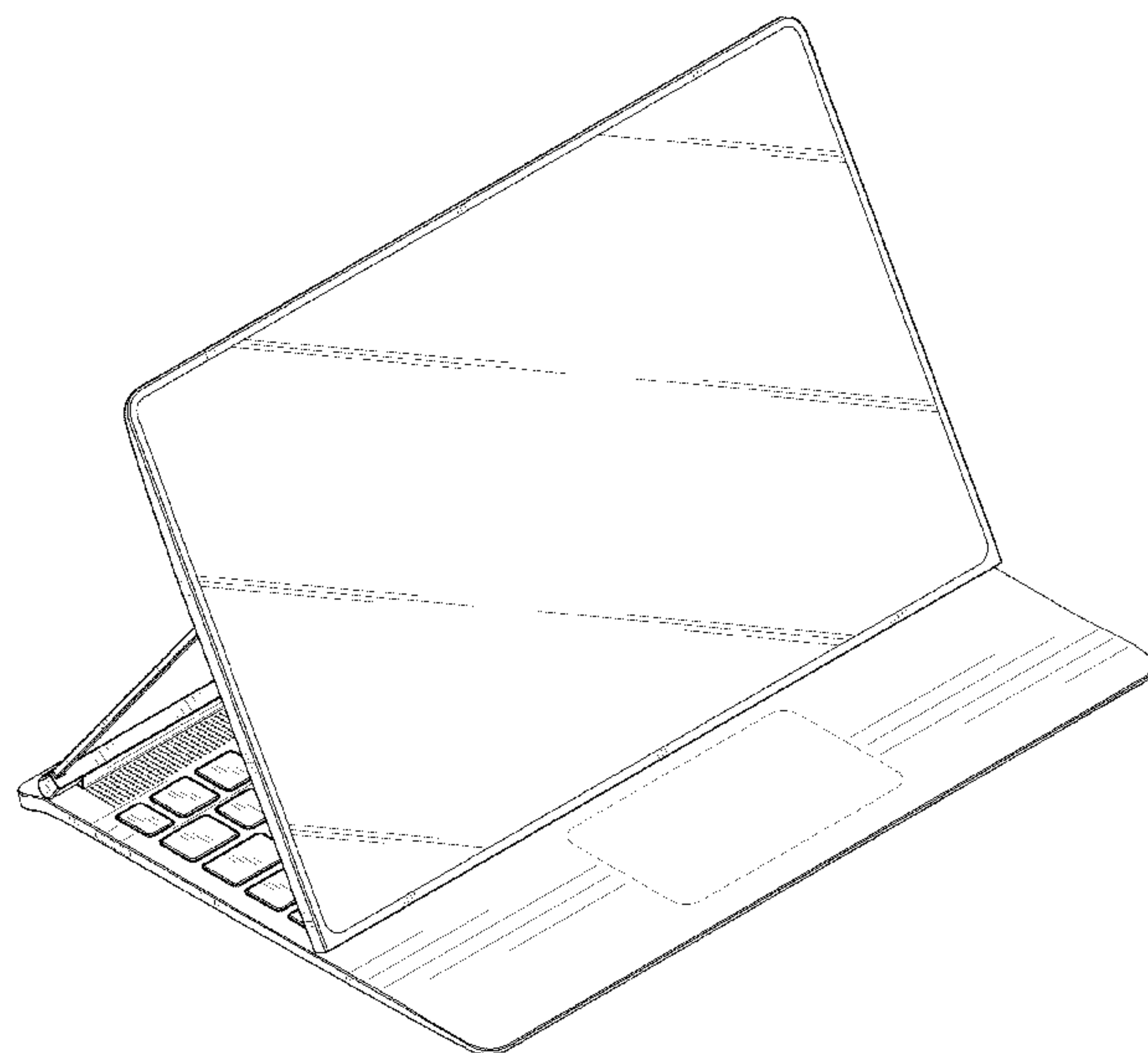
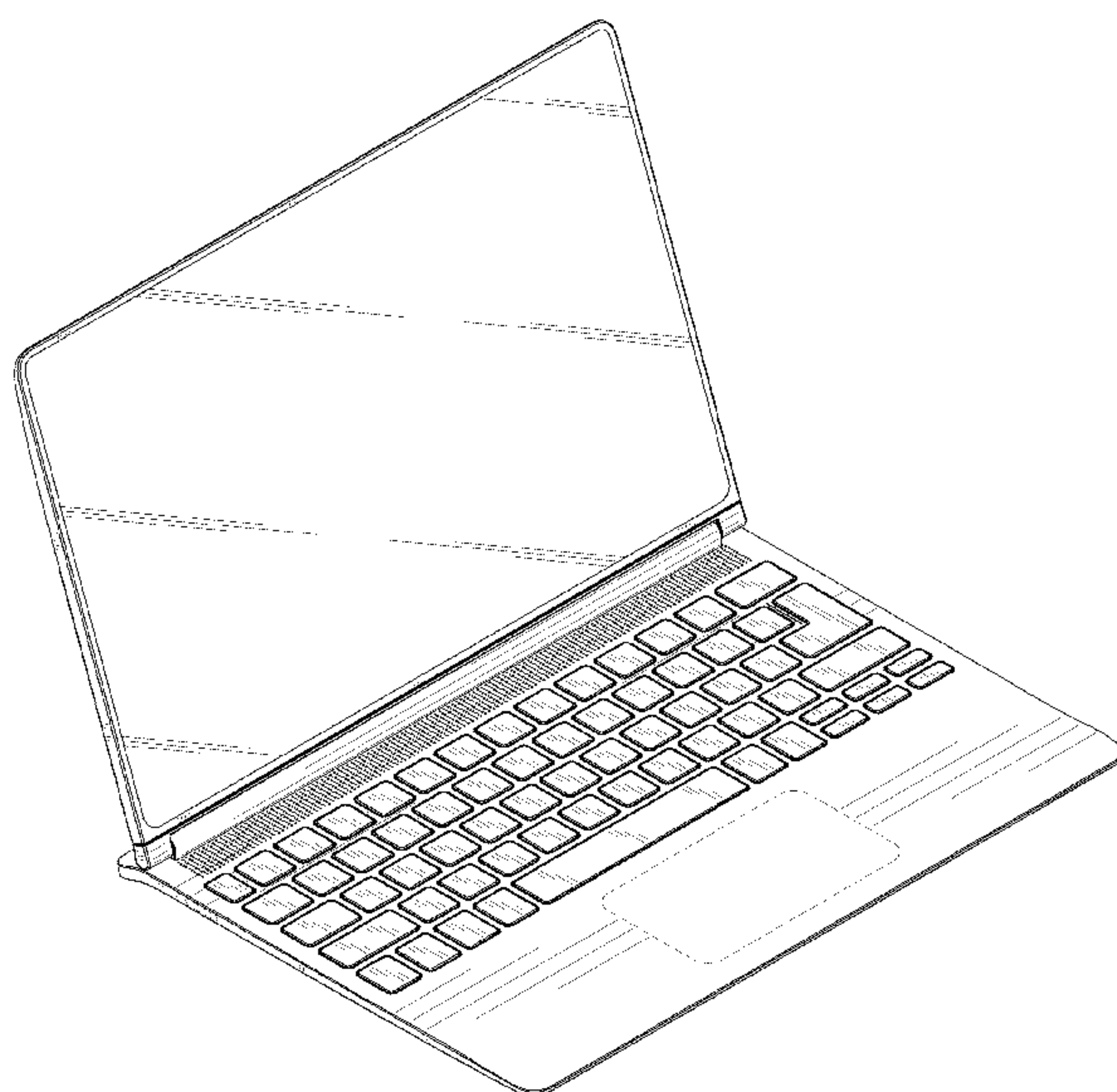
(57) **CLAIM**

The ornamental design for a combined tablet and personal computer, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a combined tablet and personal computer showing our new design in an open state; FIG. 2 is a rear perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a right side view thereof; FIG. 7 is a top view thereof; FIG. 8 is a bottom view thereof; FIG. 9 is a front perspective view thereof in closed state; FIG. 10 is a rear perspective view thereof in closed state; FIG. 11 is a front view thereof in closed state; FIG. 12 is a rear view thereof in closed state; FIG. 13 is a left side view thereof in closed state; FIG. 14 is a right side view thereof in closed state; FIG. 15 is a top view thereof in closed state; FIG. 16 is a bottom view thereof in closed state; and, FIG. 17 is a front perspective view thereof in touchable state. The broken line portions of the combined tablet and personal computer in FIGS. 1-2, FIGS. 5-7, FIGS. 9-10, FIGS. 13-14 and FIG. 17 represent unclaimed portions of the claimed design and form no part thereof.

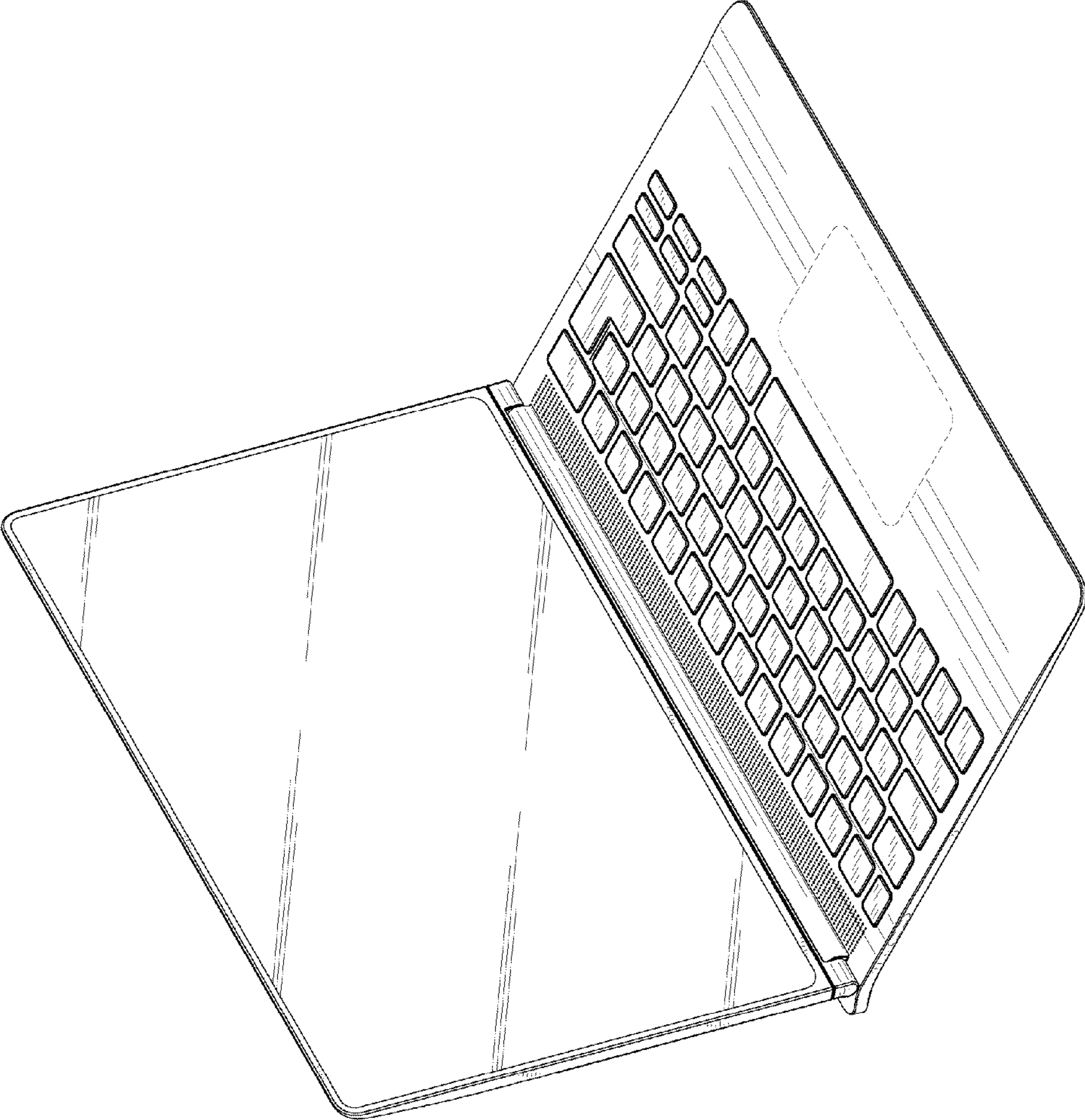

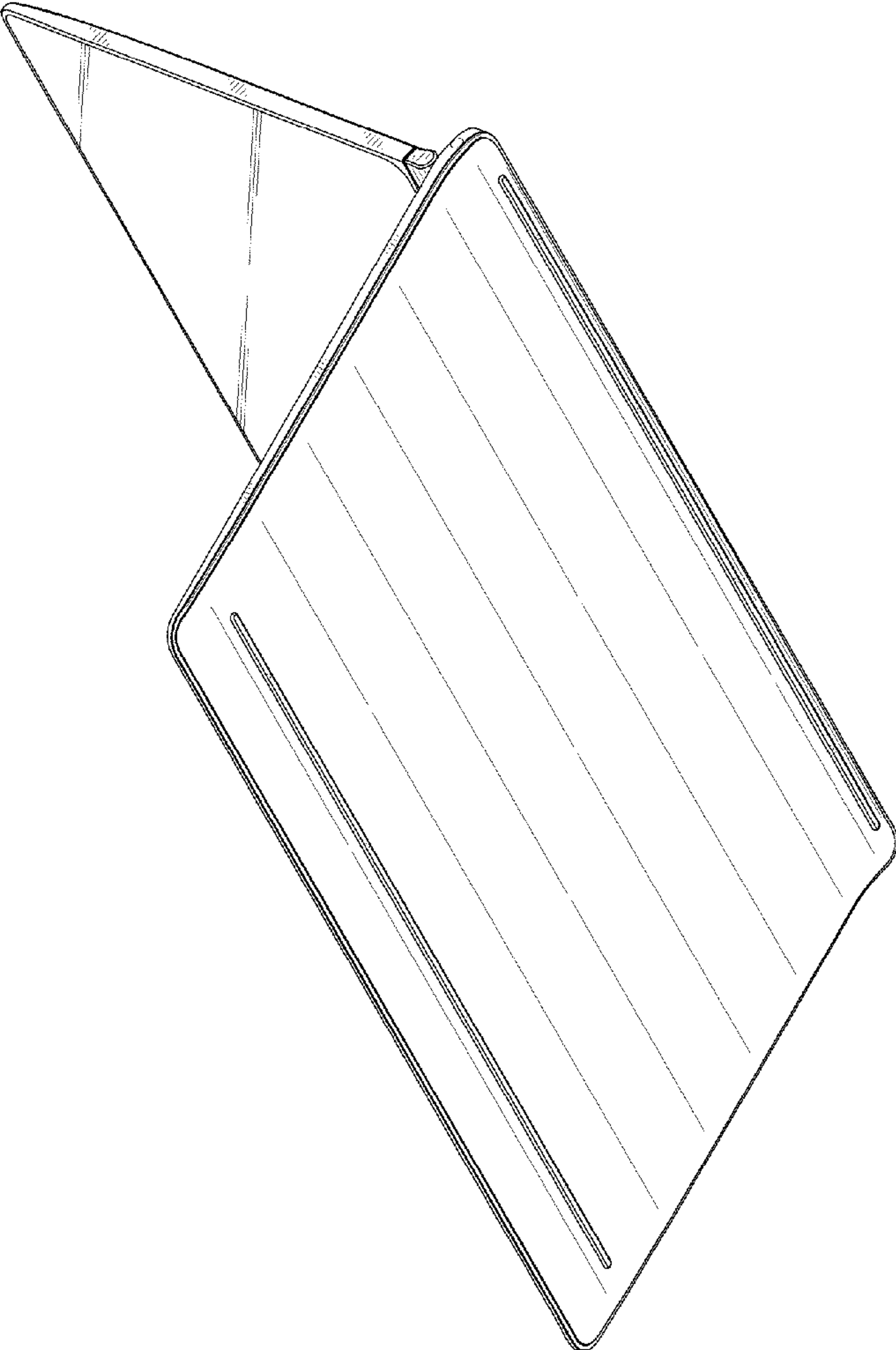

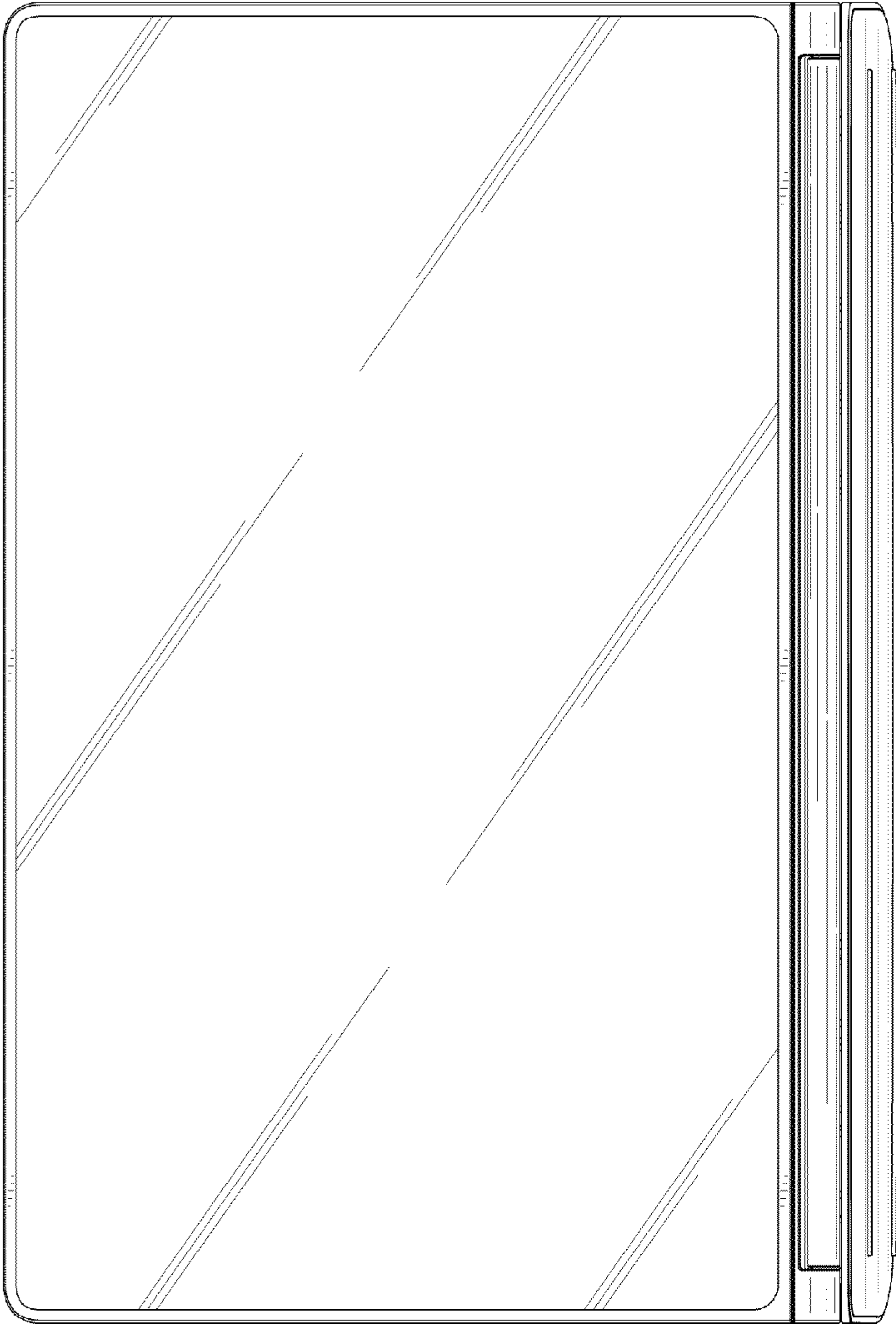

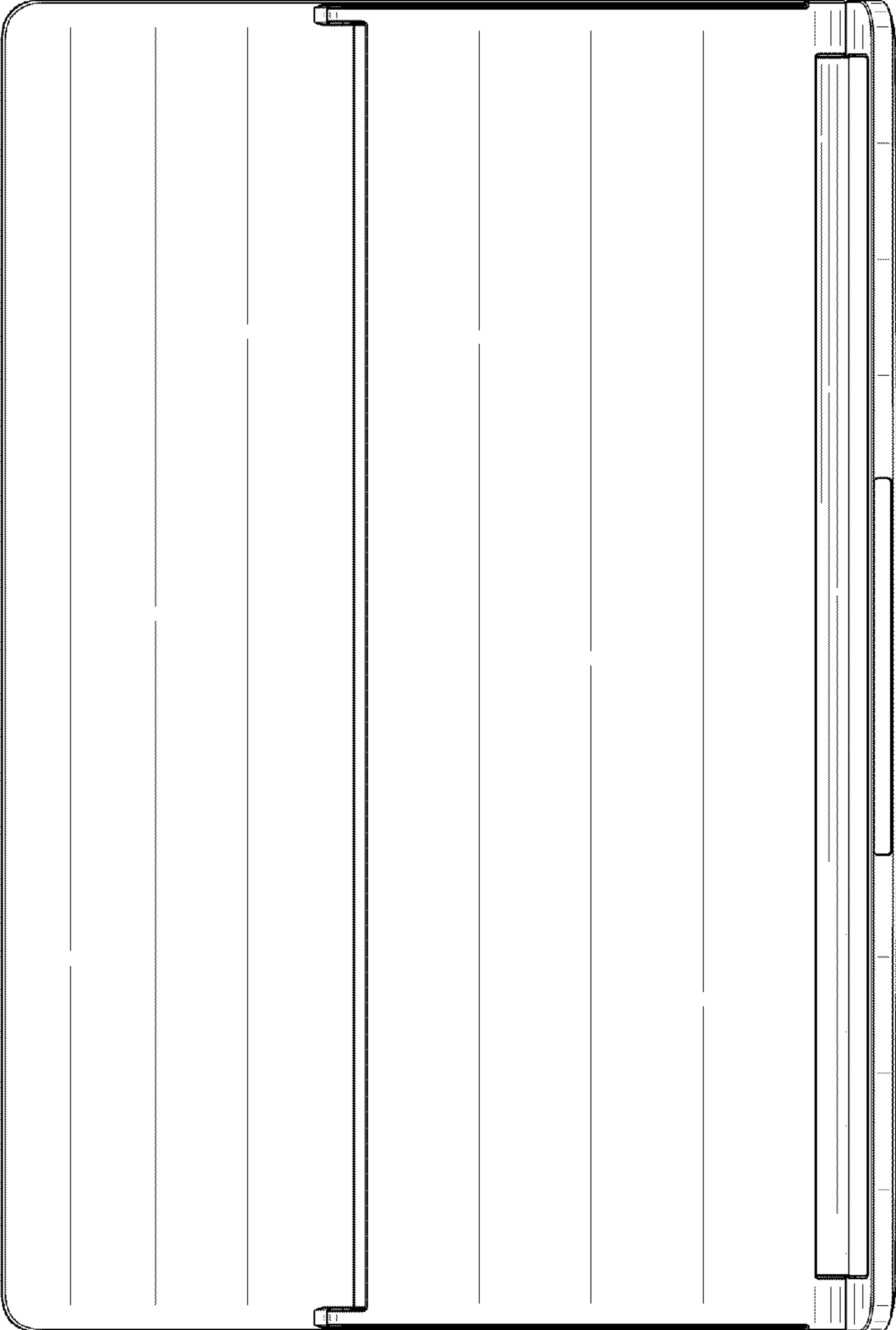

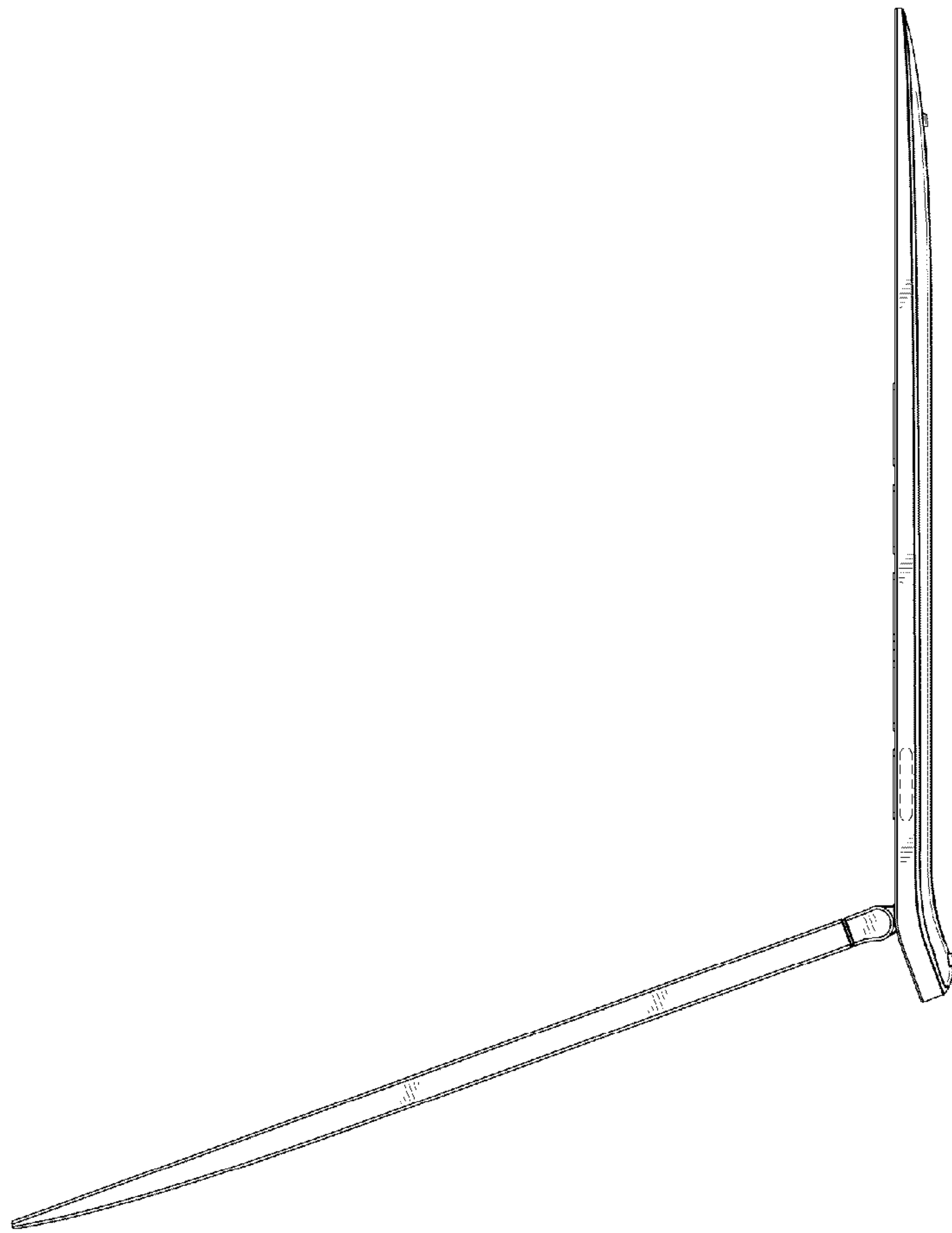

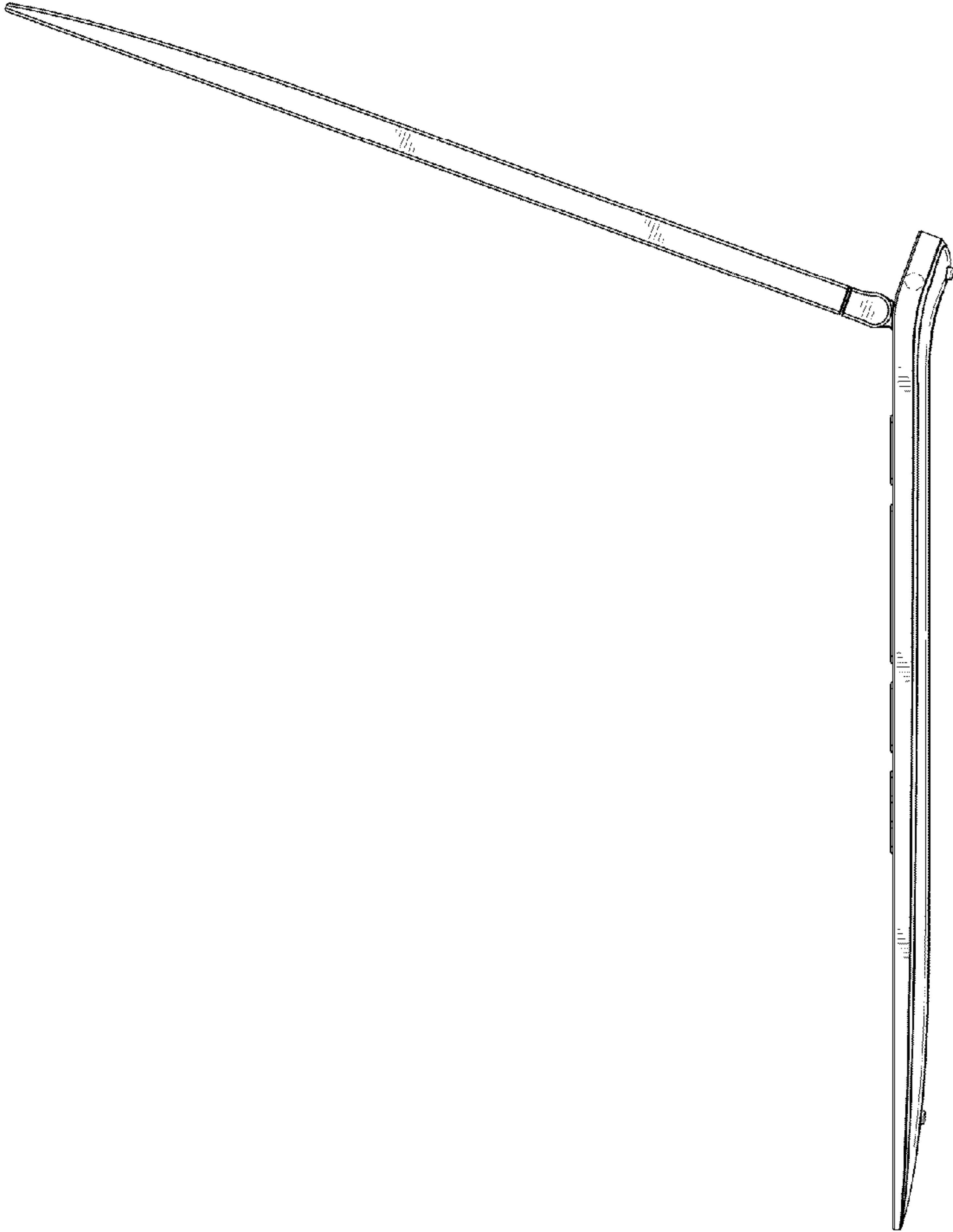

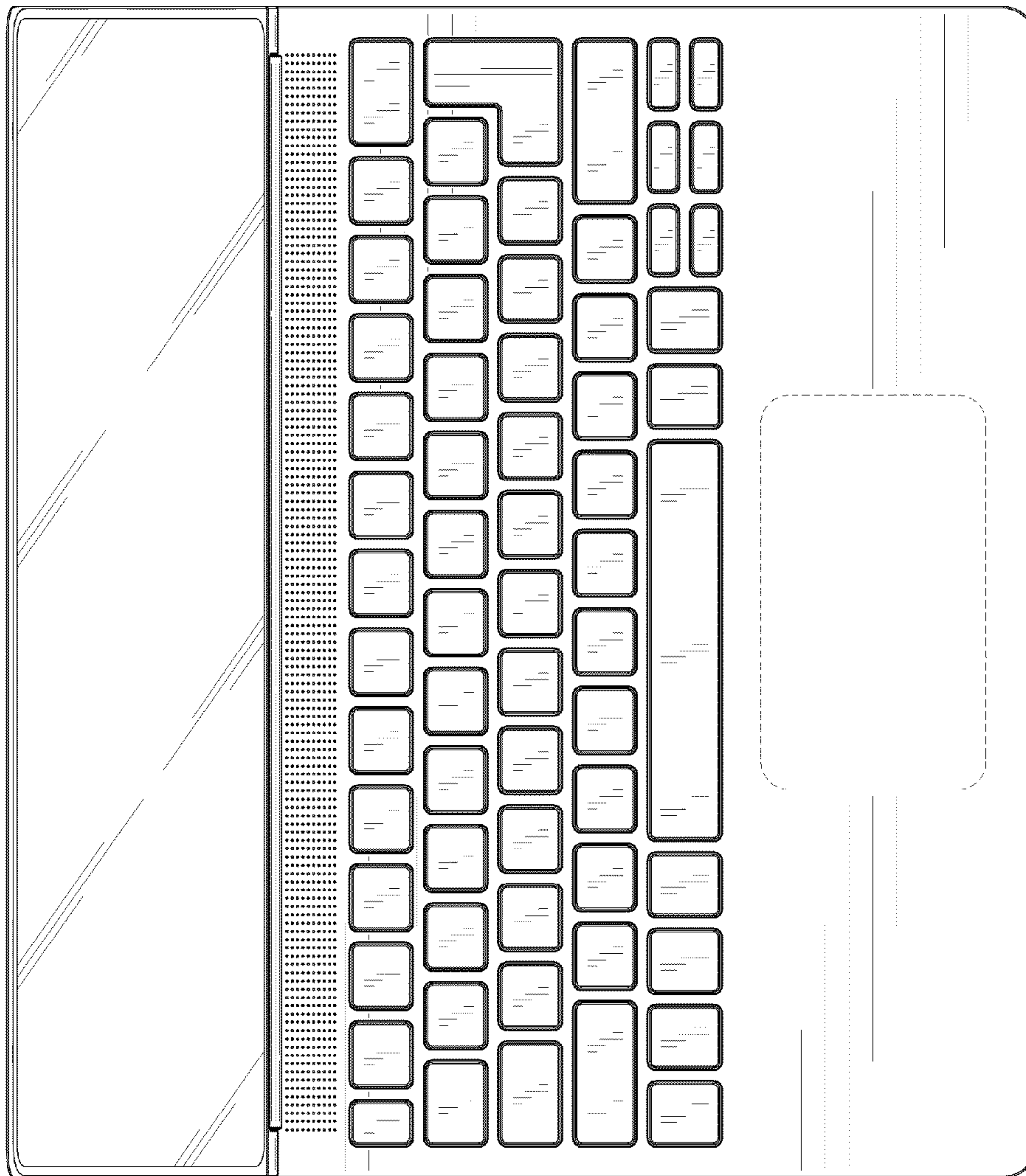

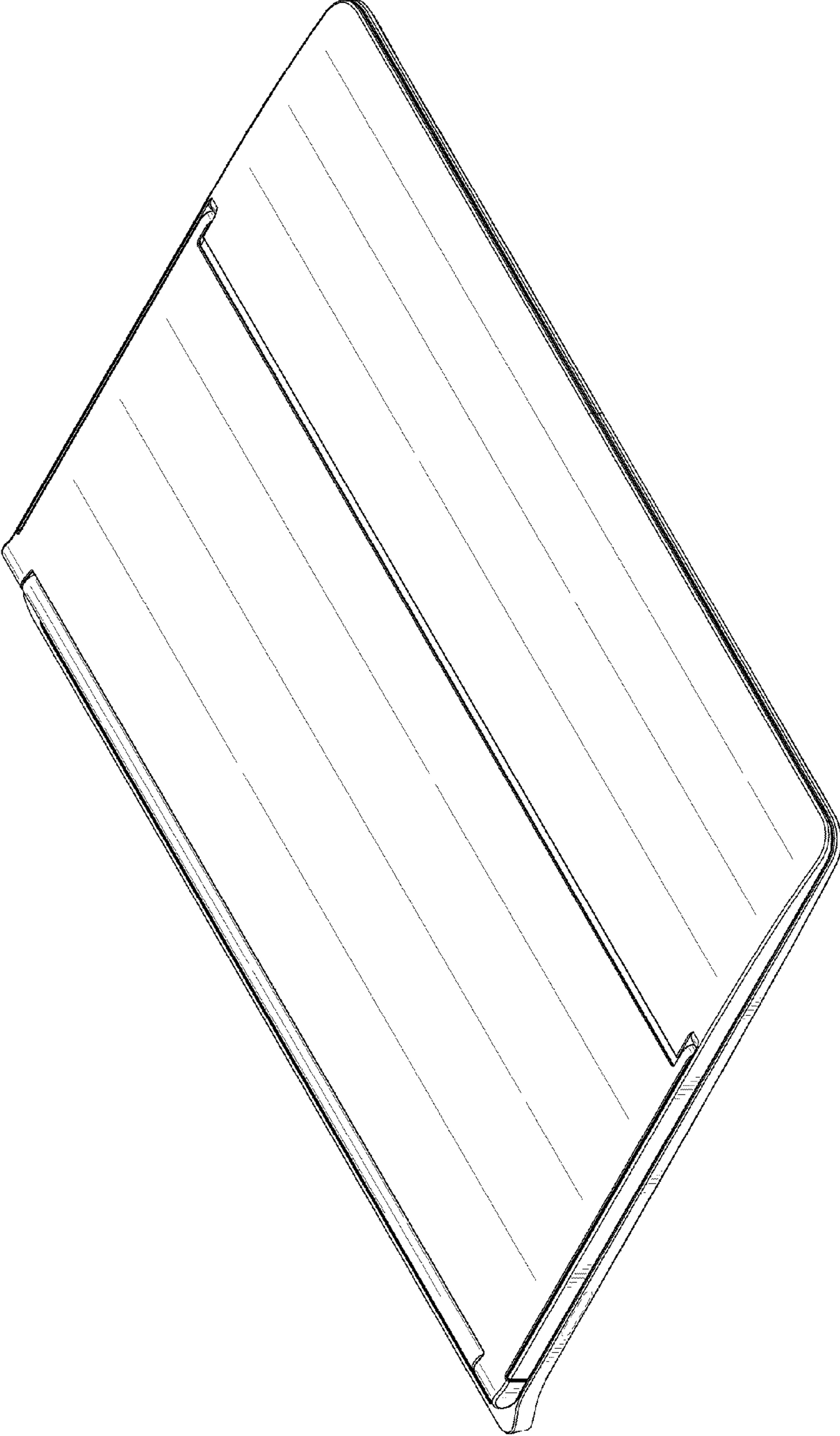

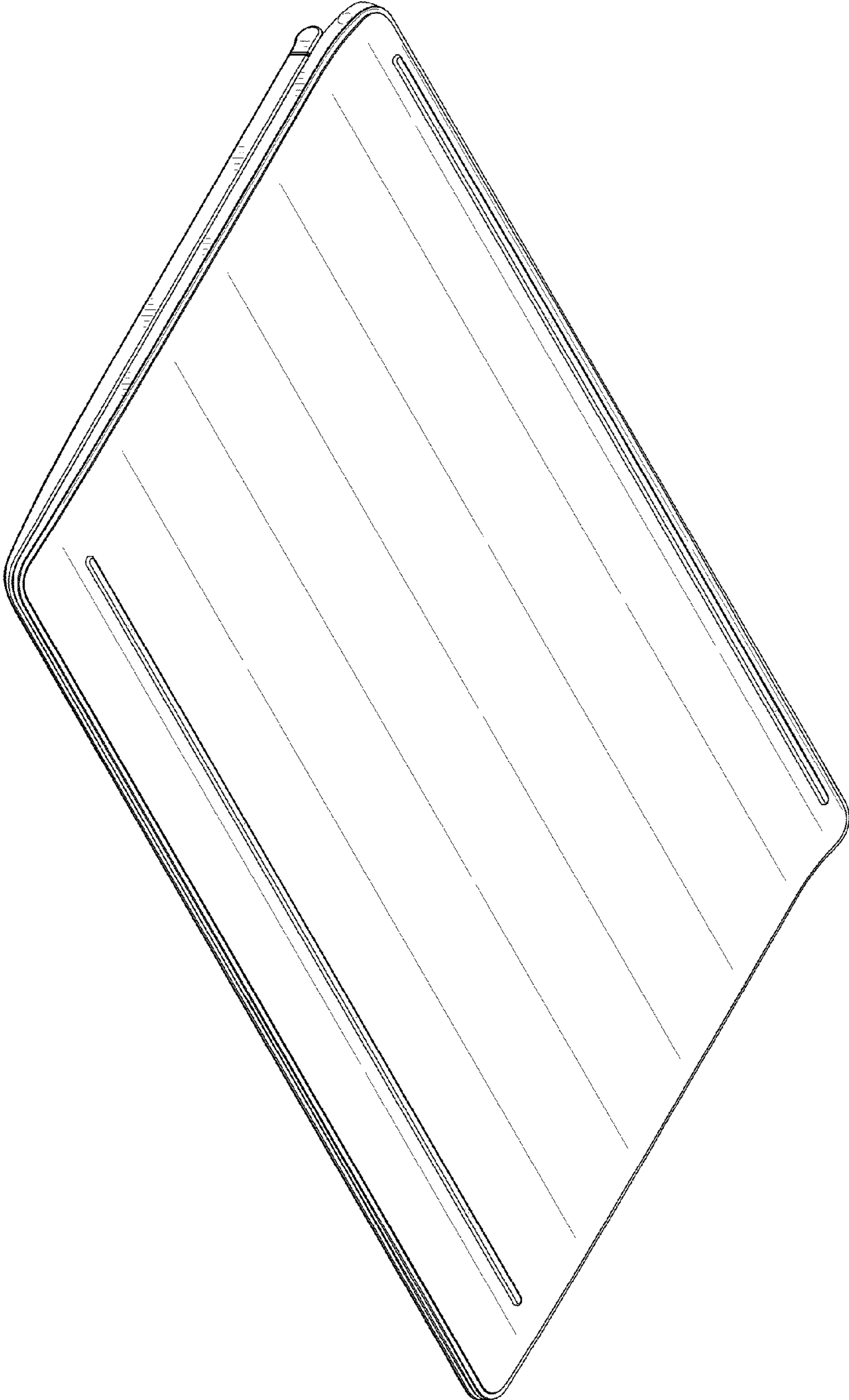

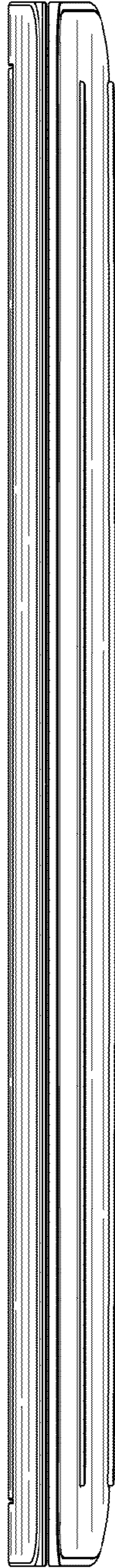

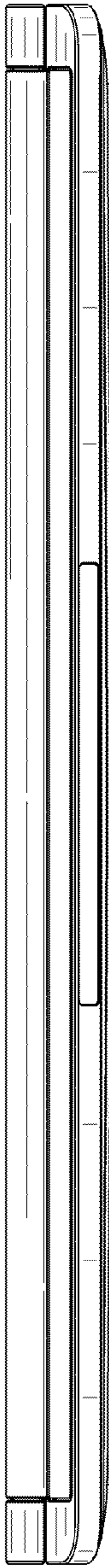

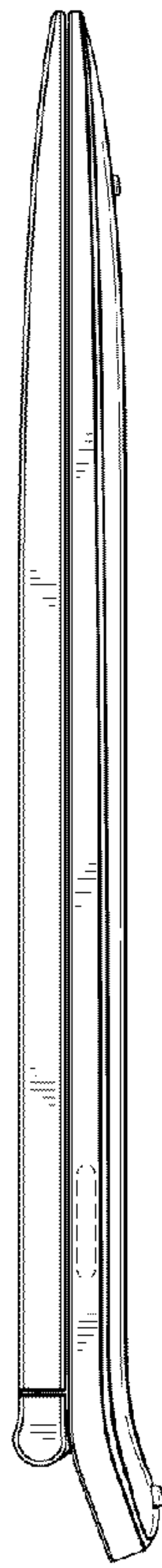

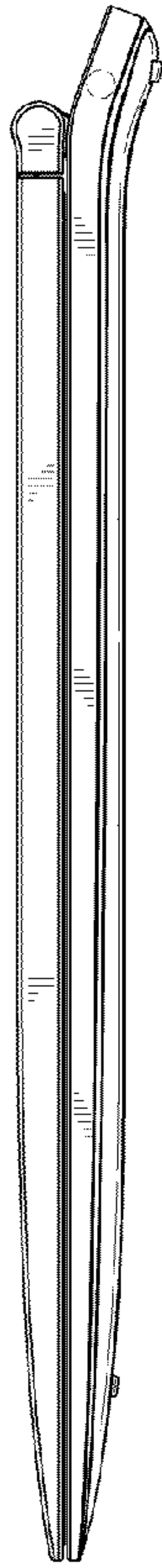

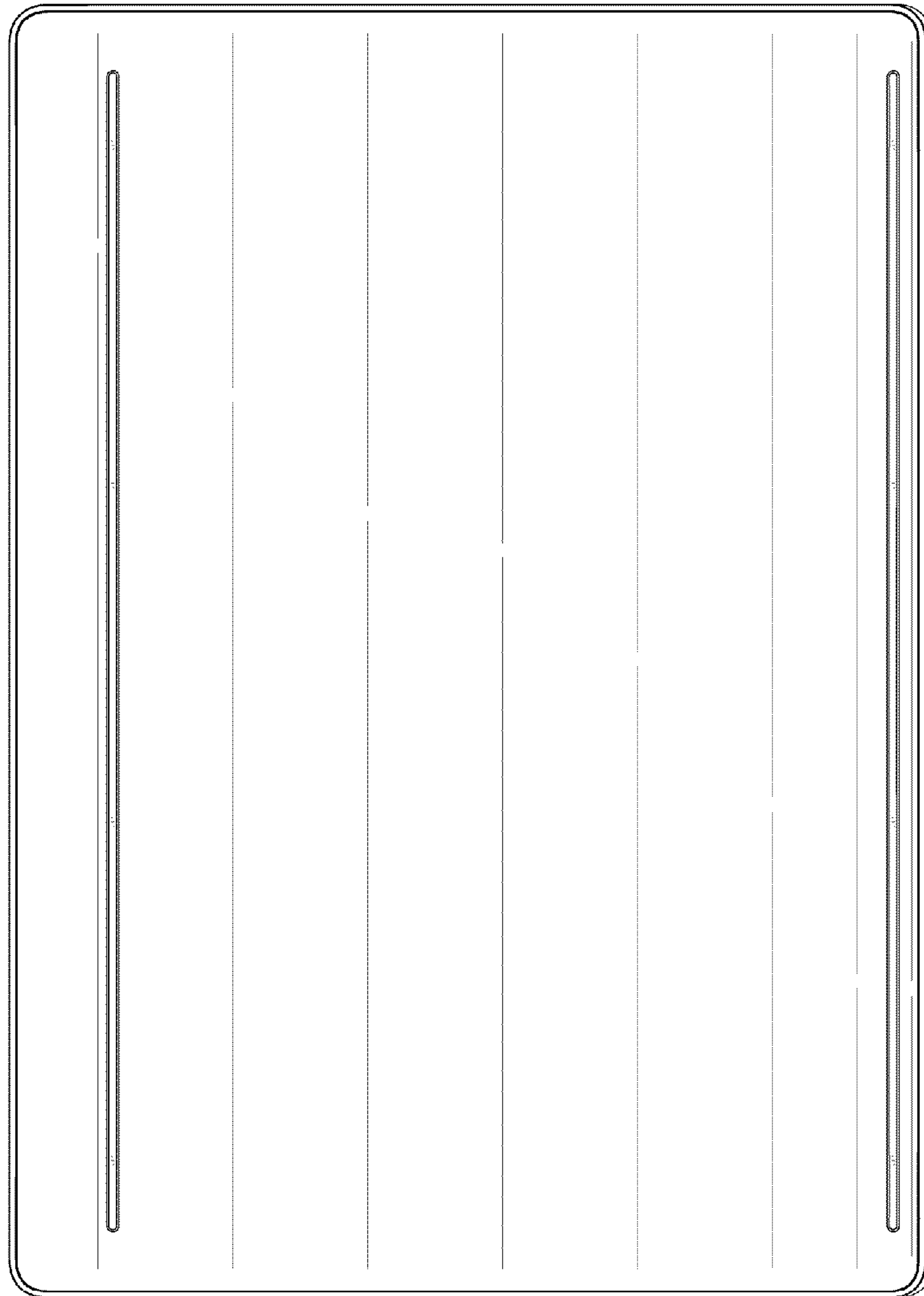

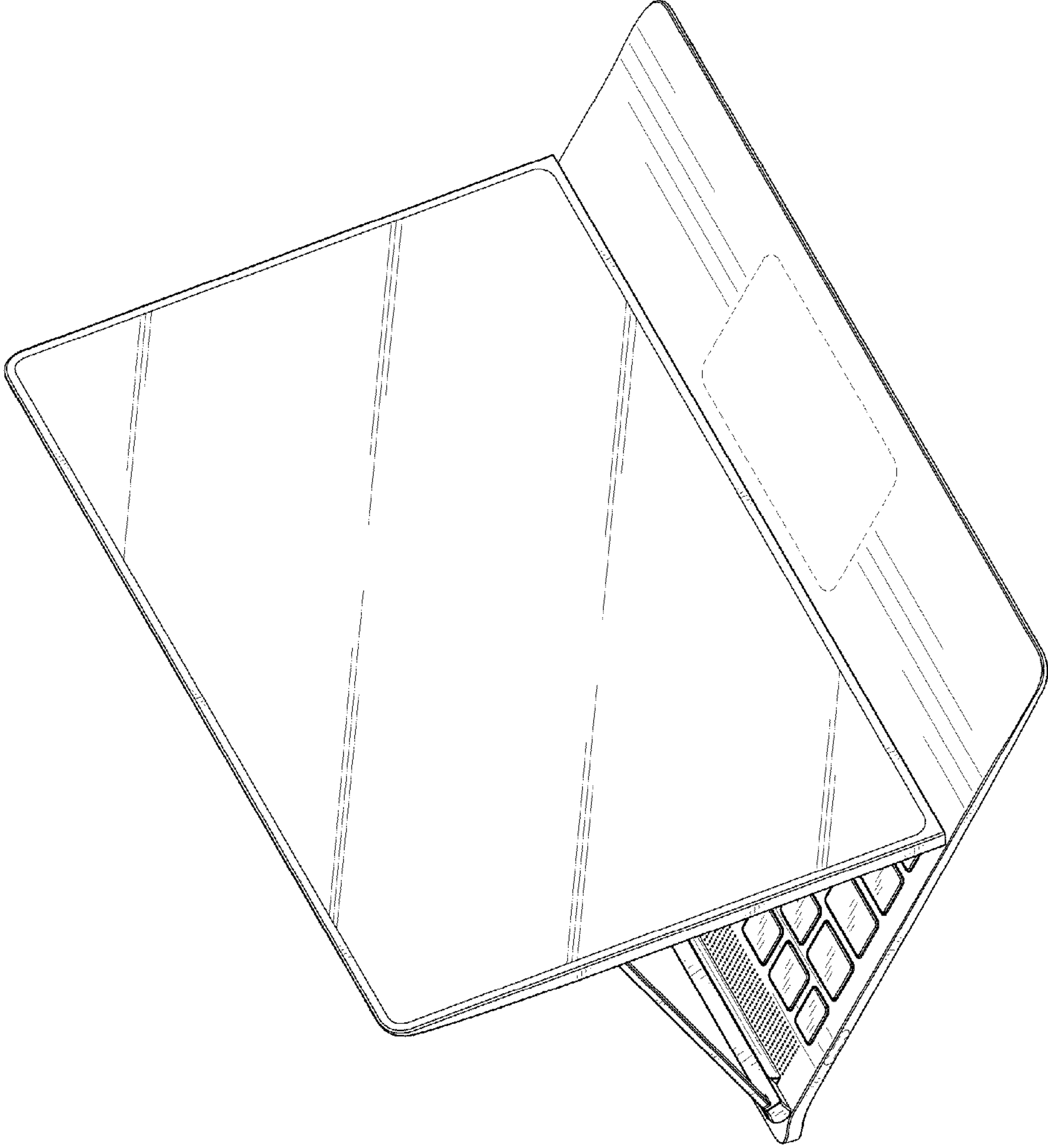
