The ornamental design for a computer display screen with graphical user interface, as shown and described.

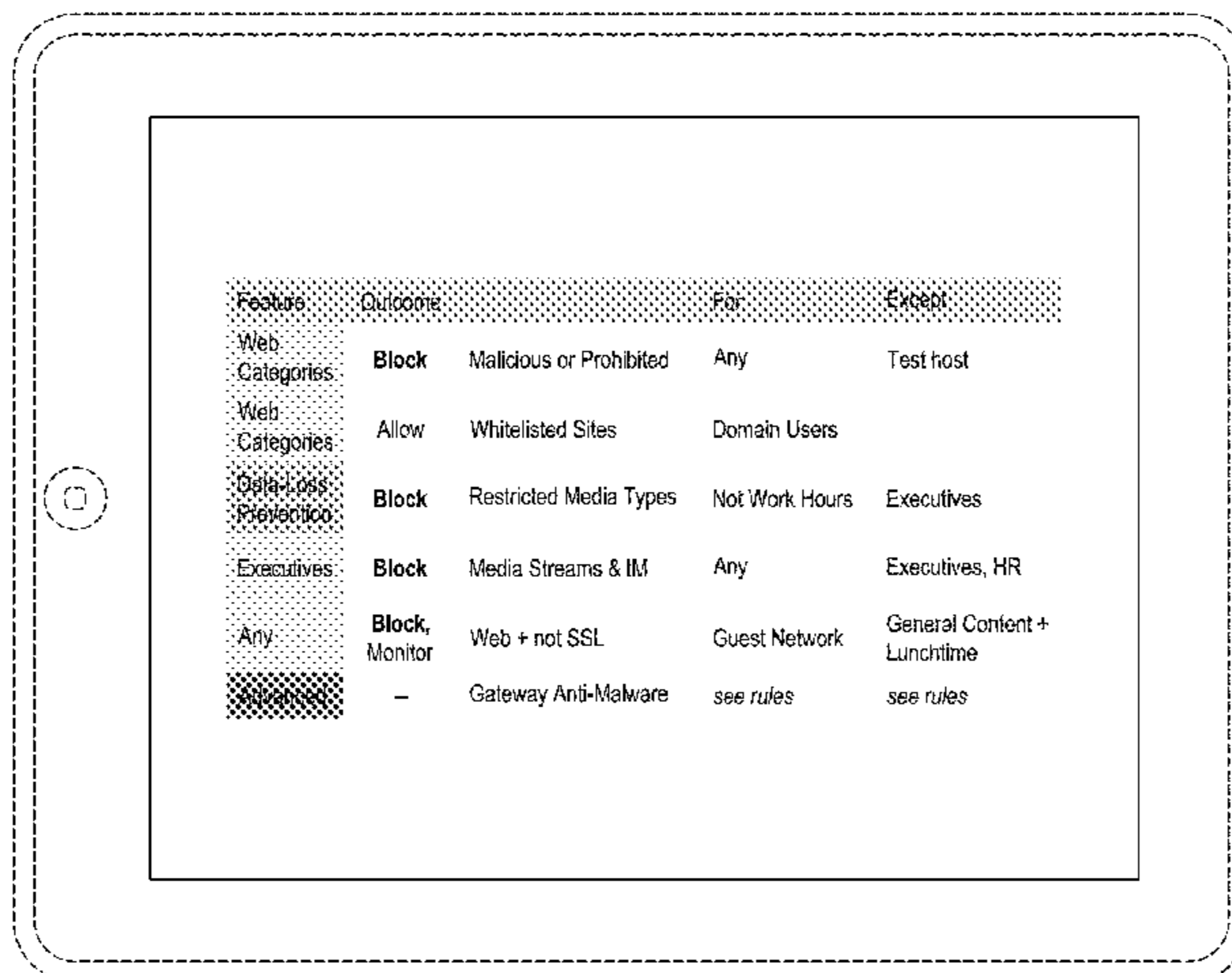
DESCRIPTION

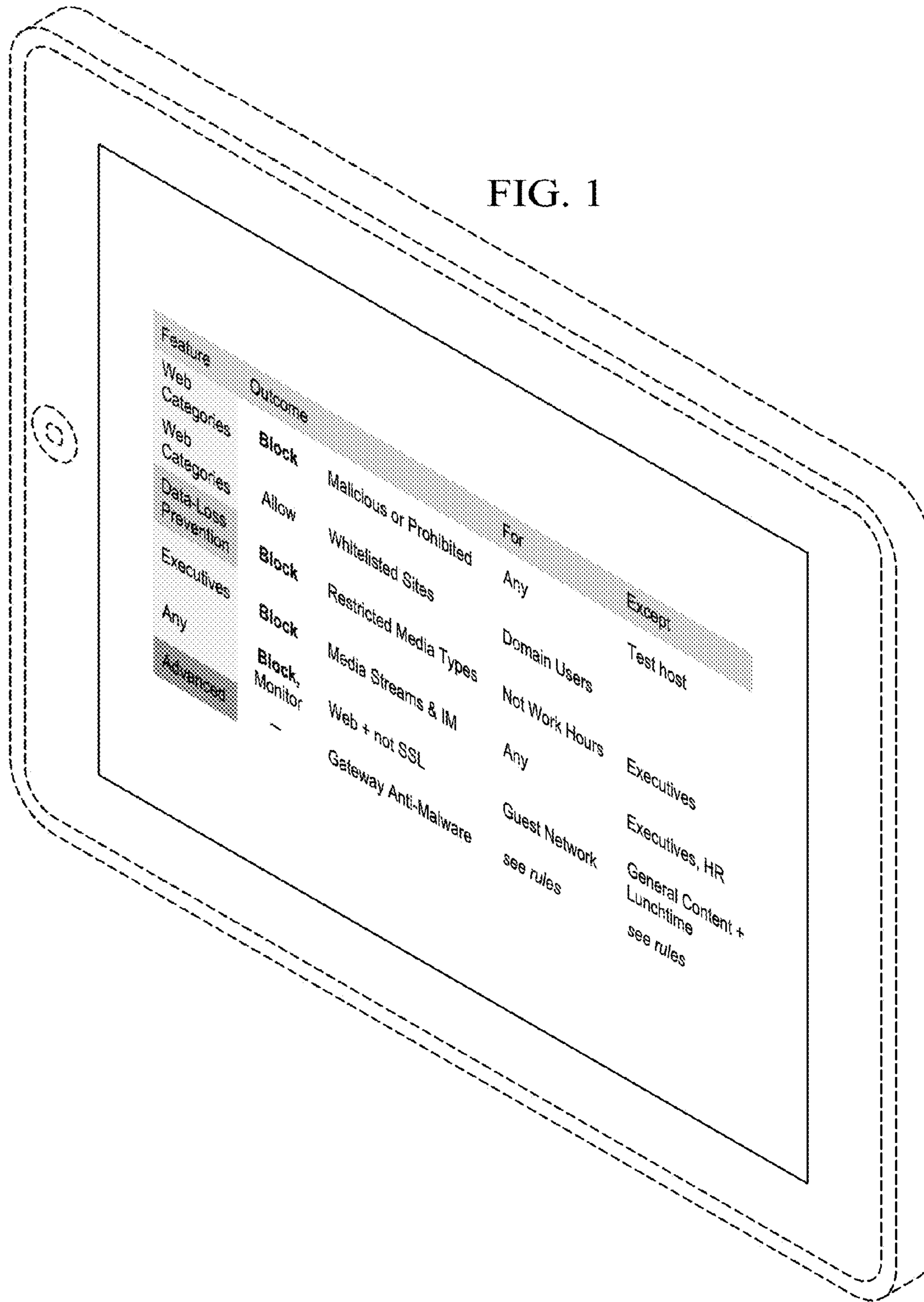

