(57) **CLAIM**
I claim the ornamental design for a file folder, as shown and described.

DESCRIPTION

FIG. 2 is a front elevational view thereof;

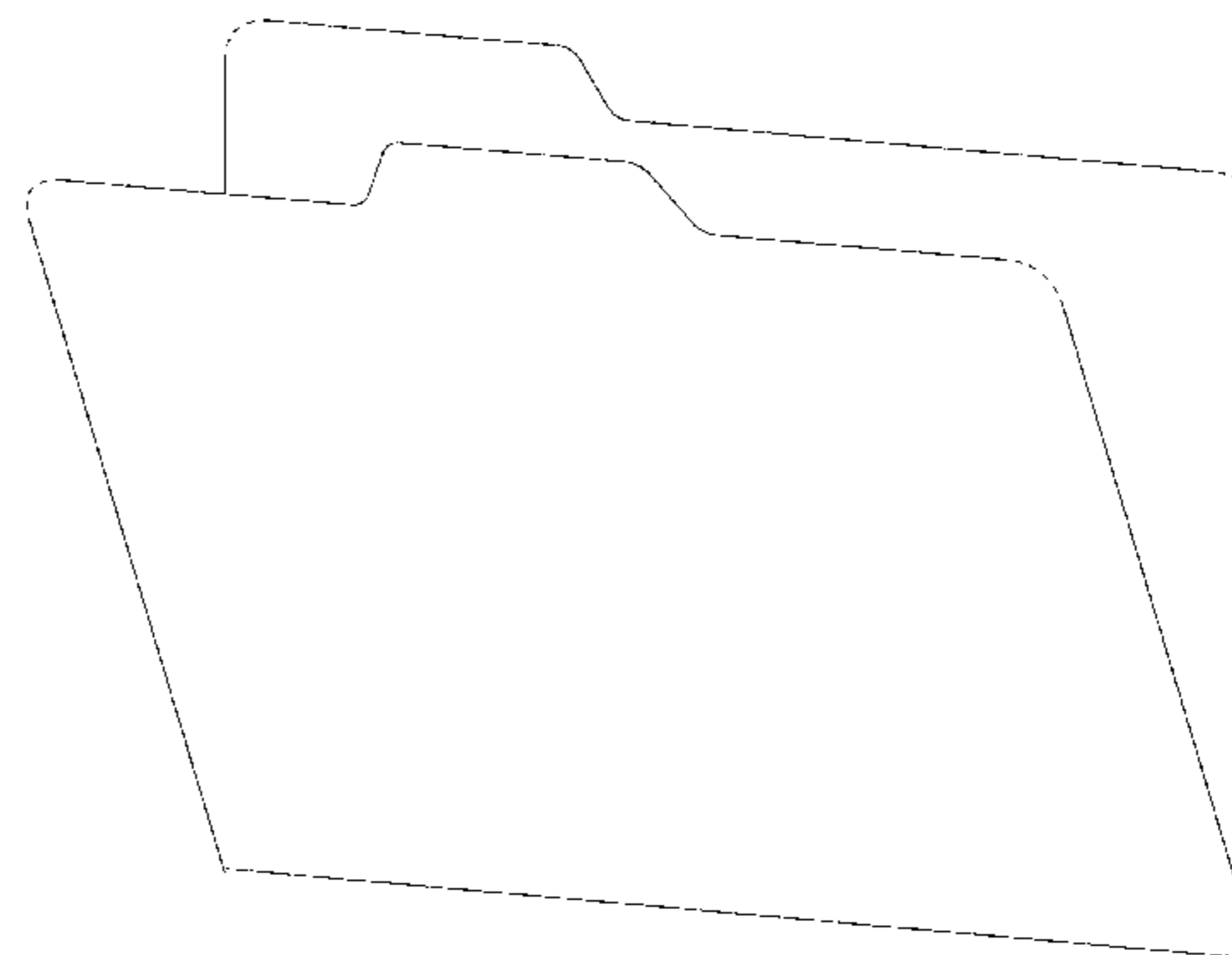
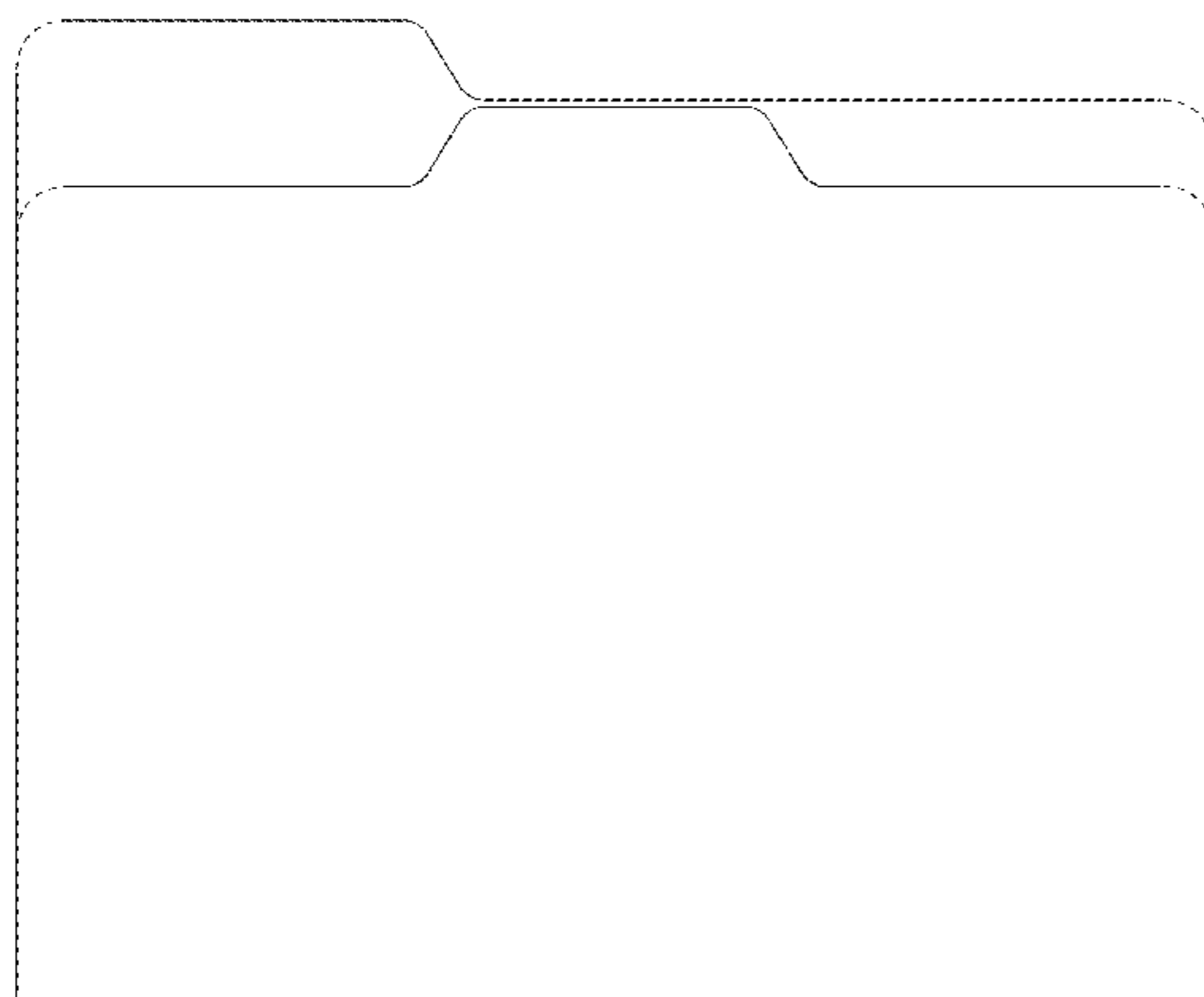


FIG. 3 is a rear elevational view thereof;

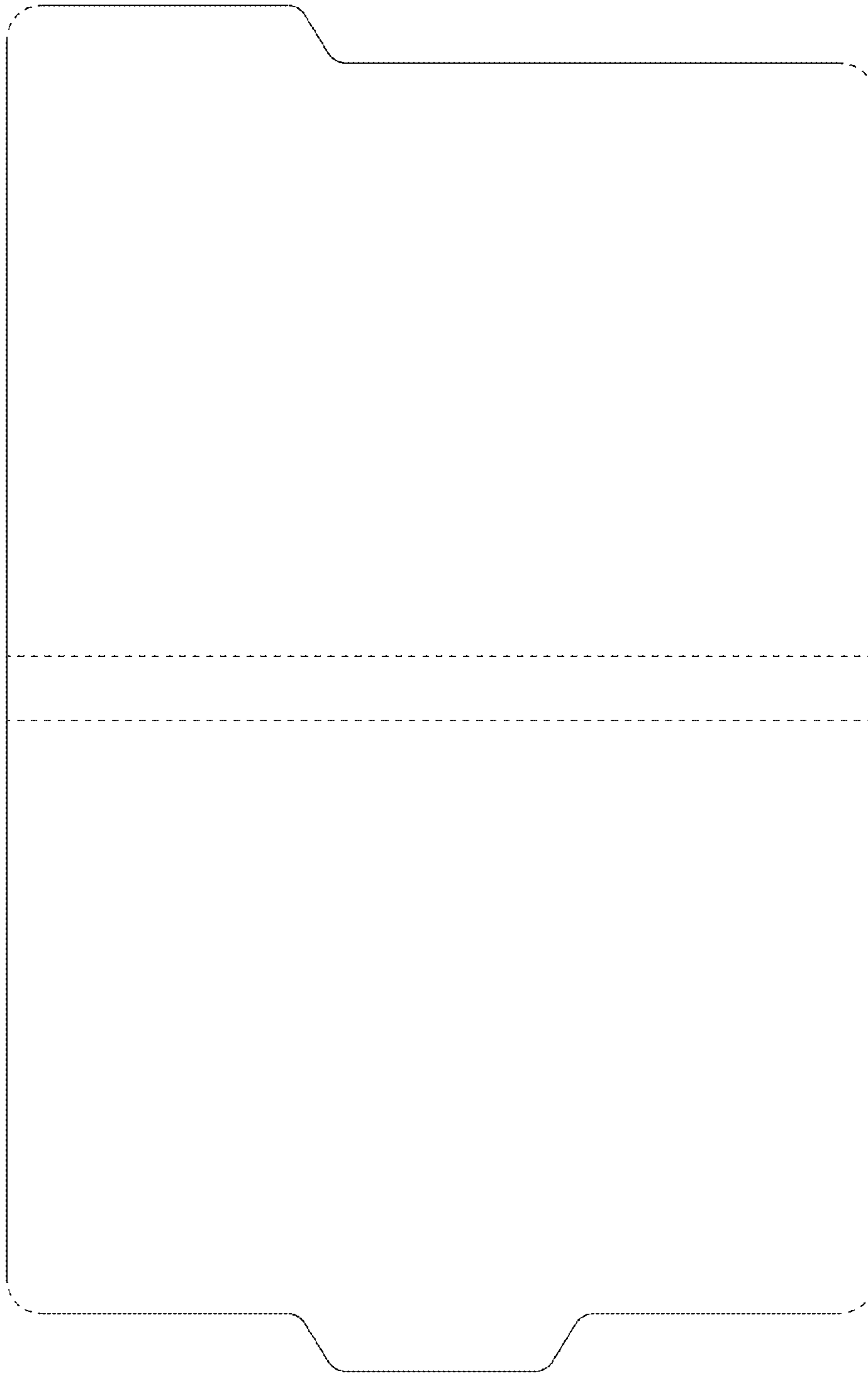

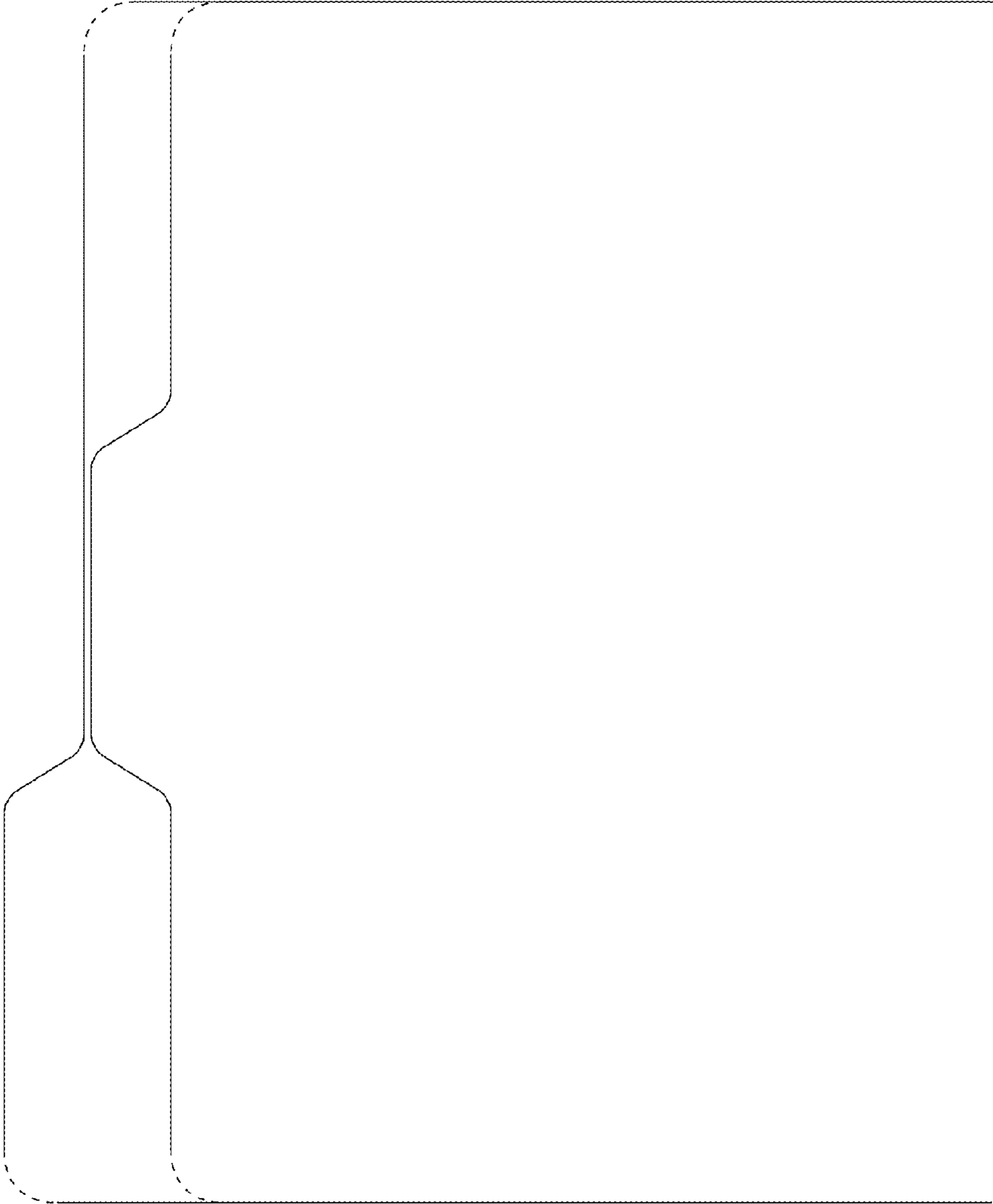

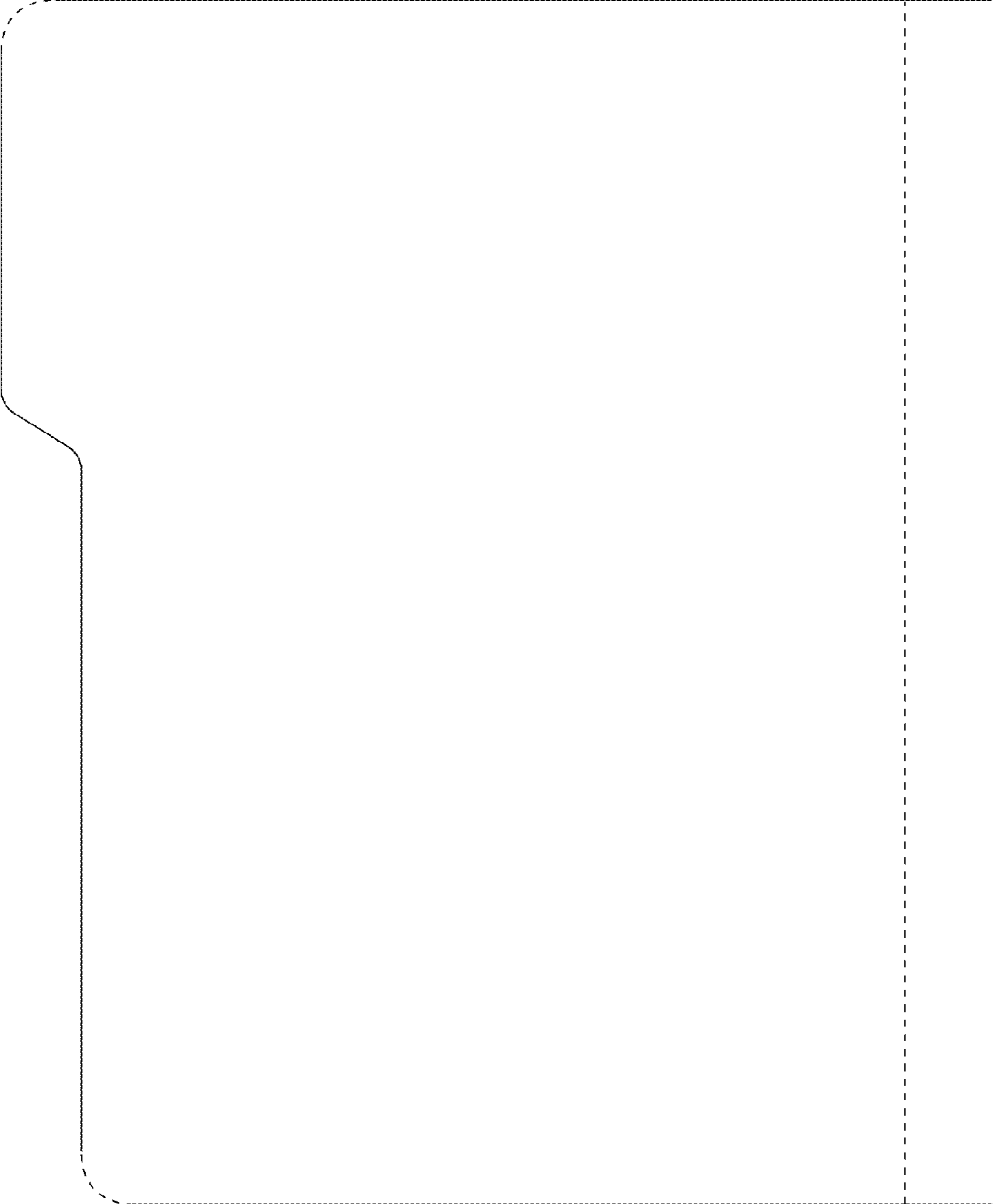

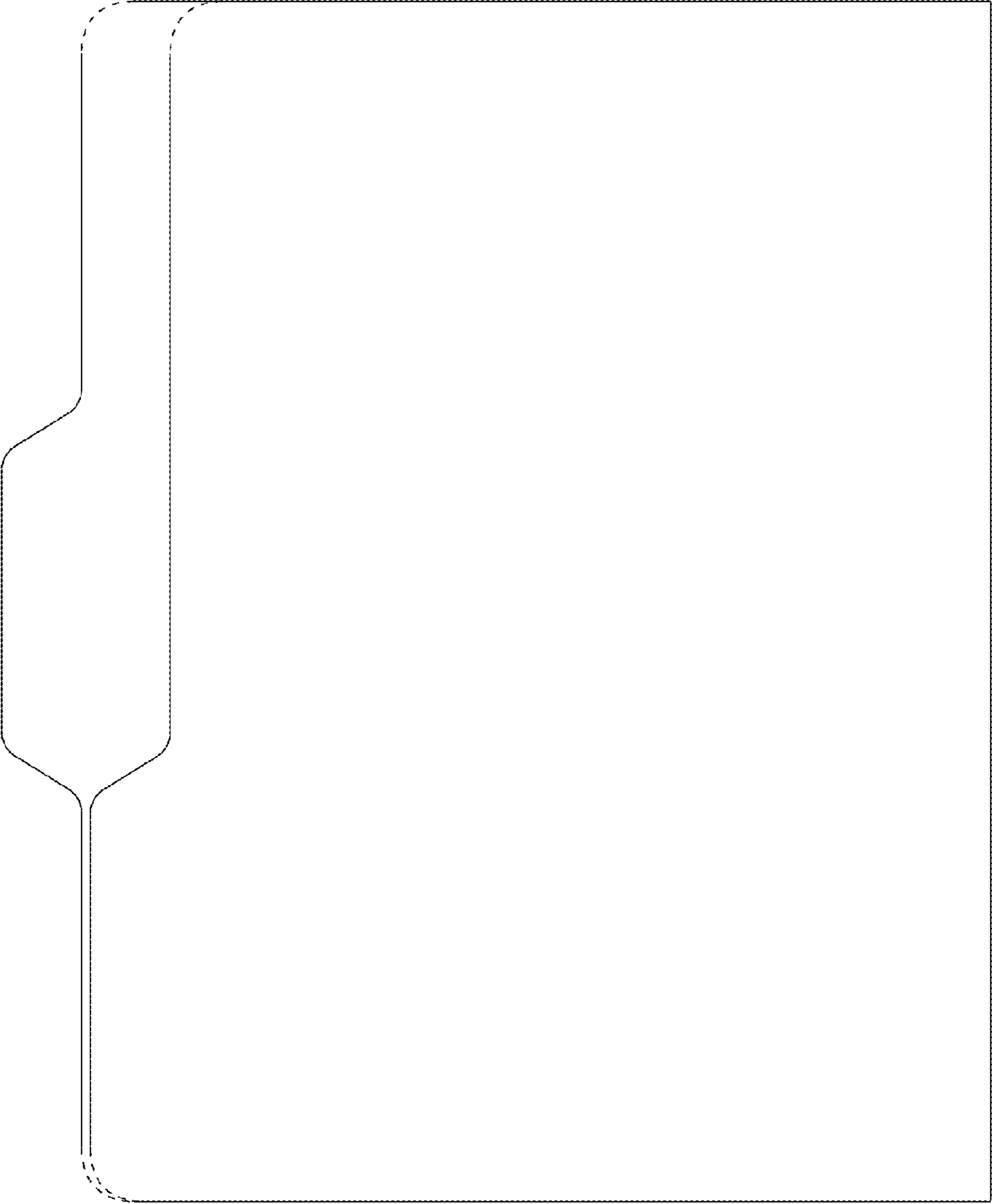

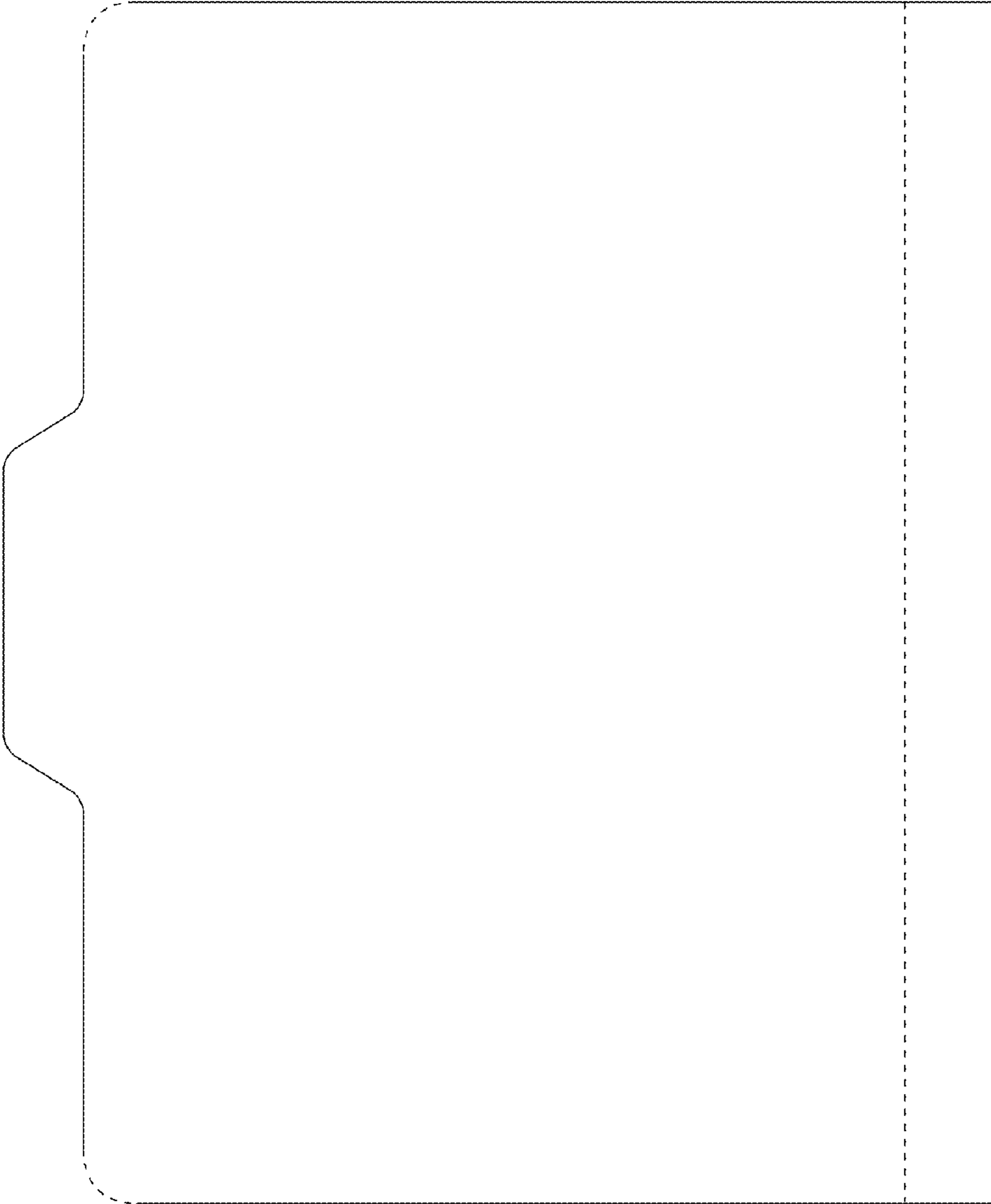

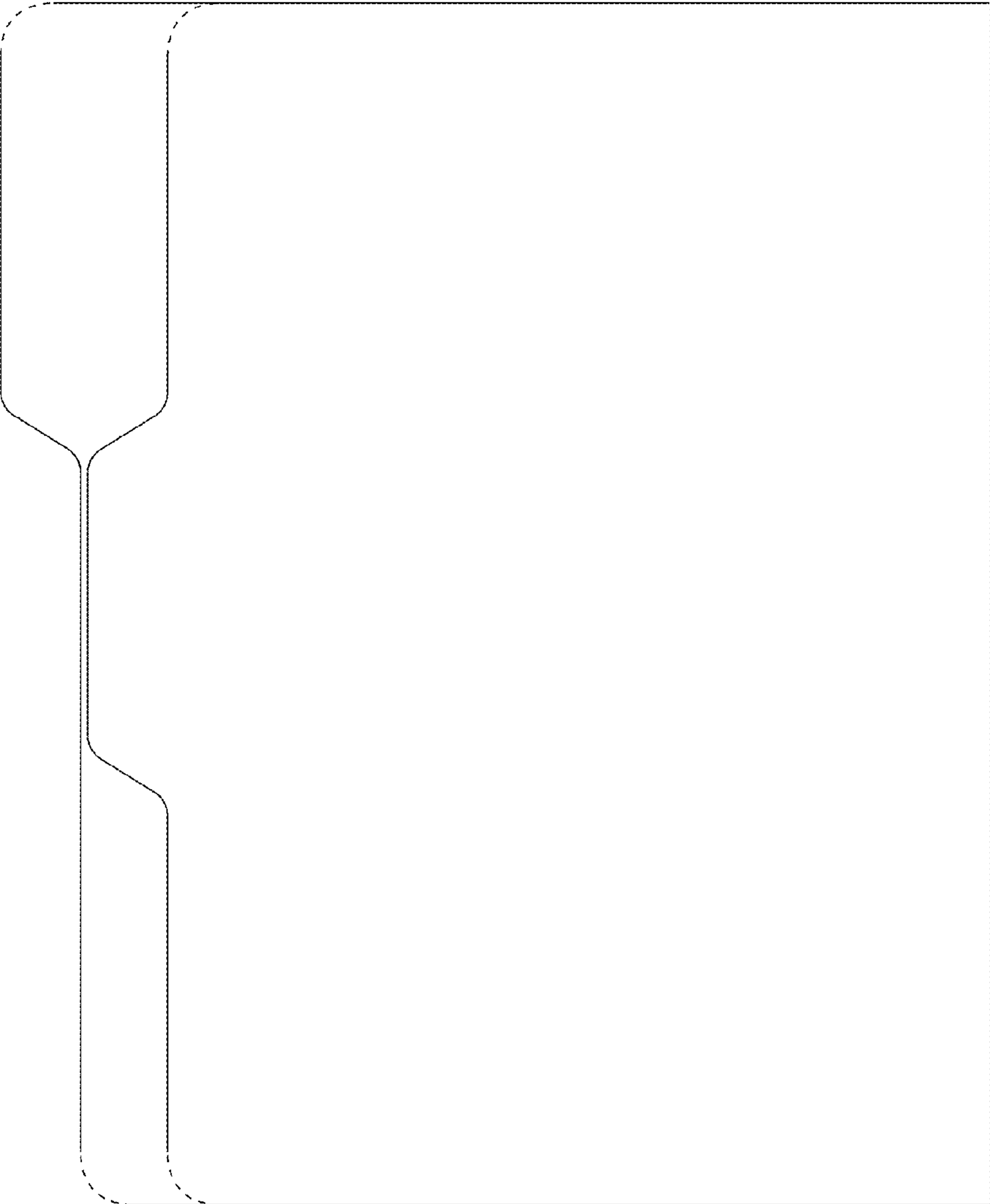

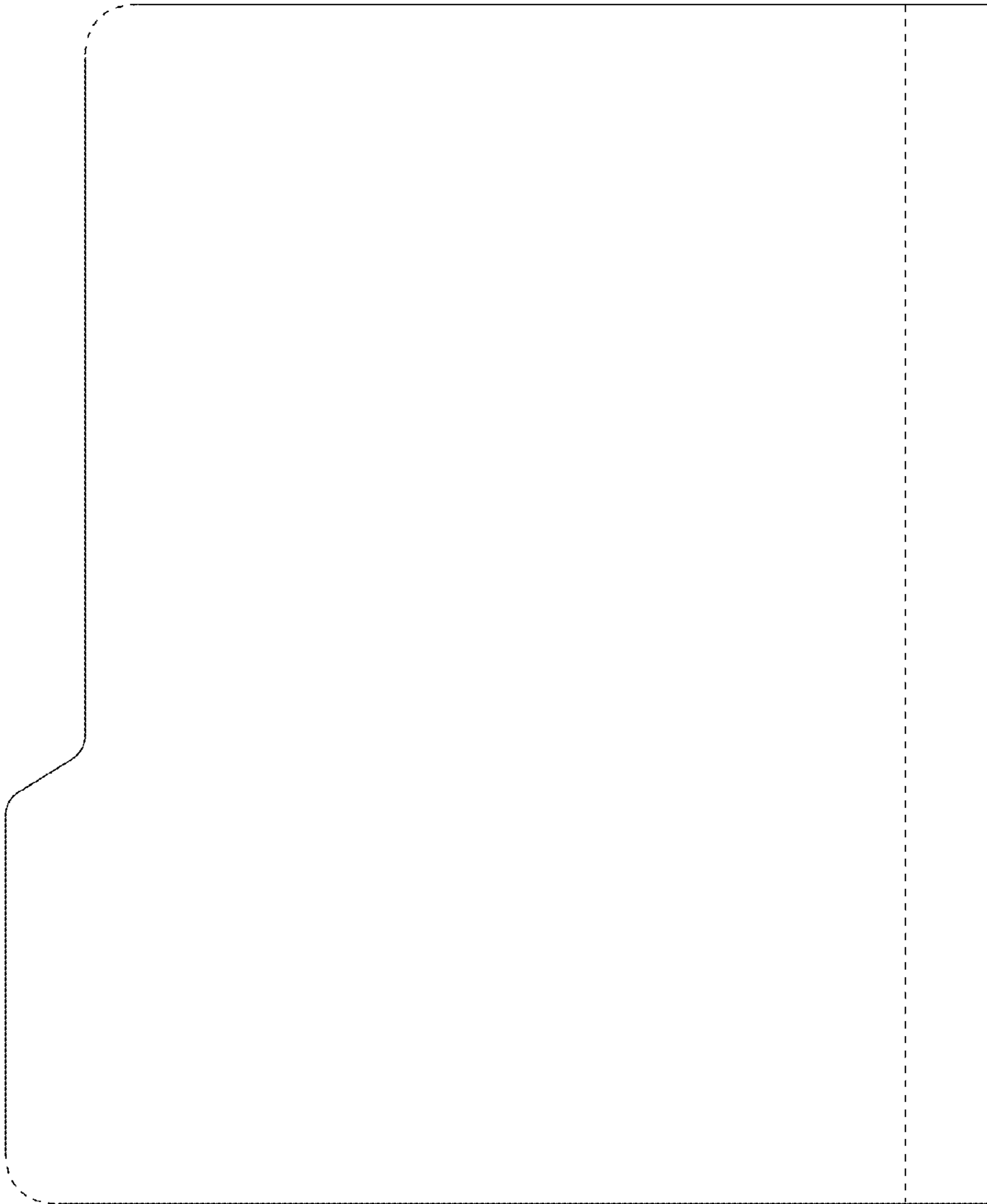

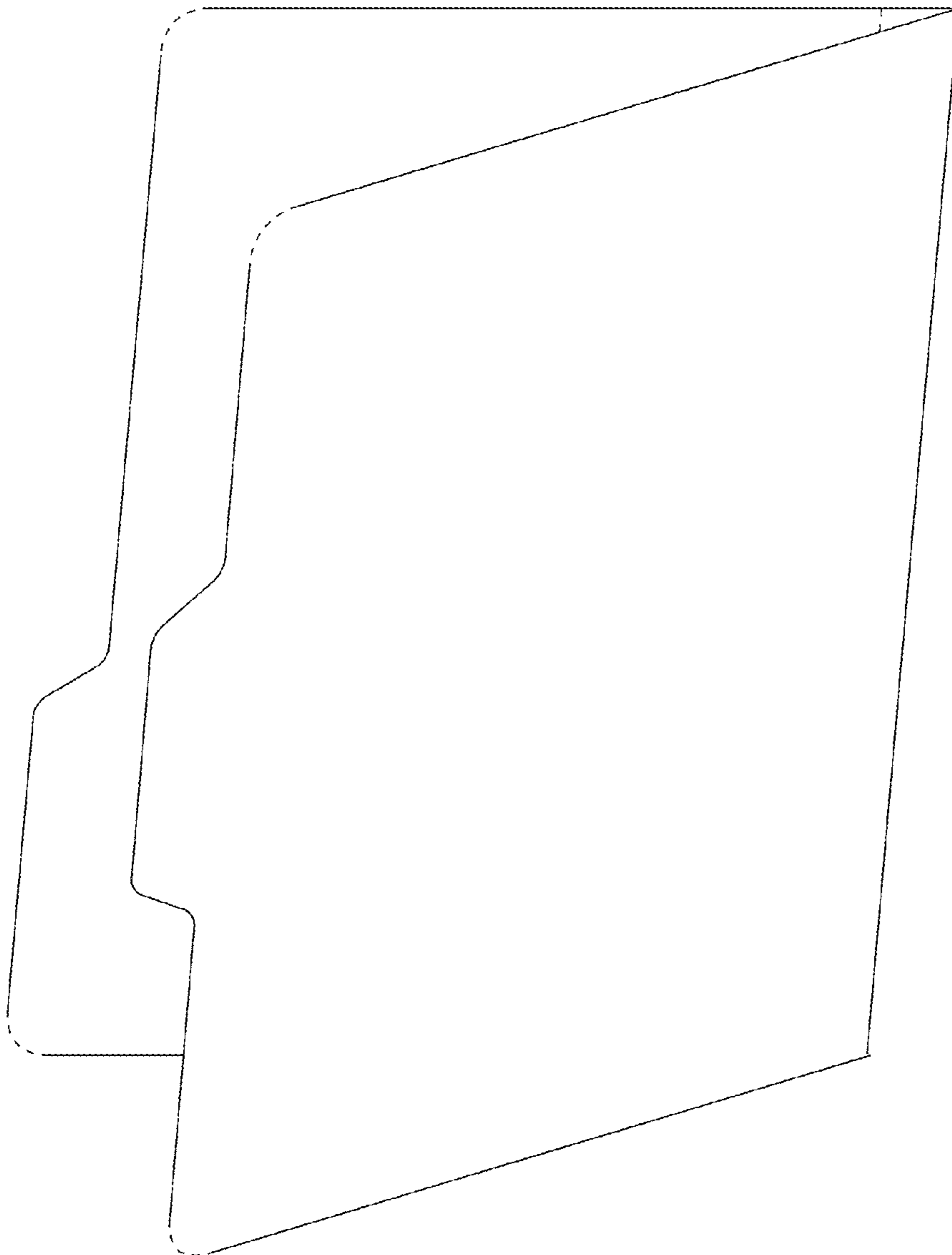

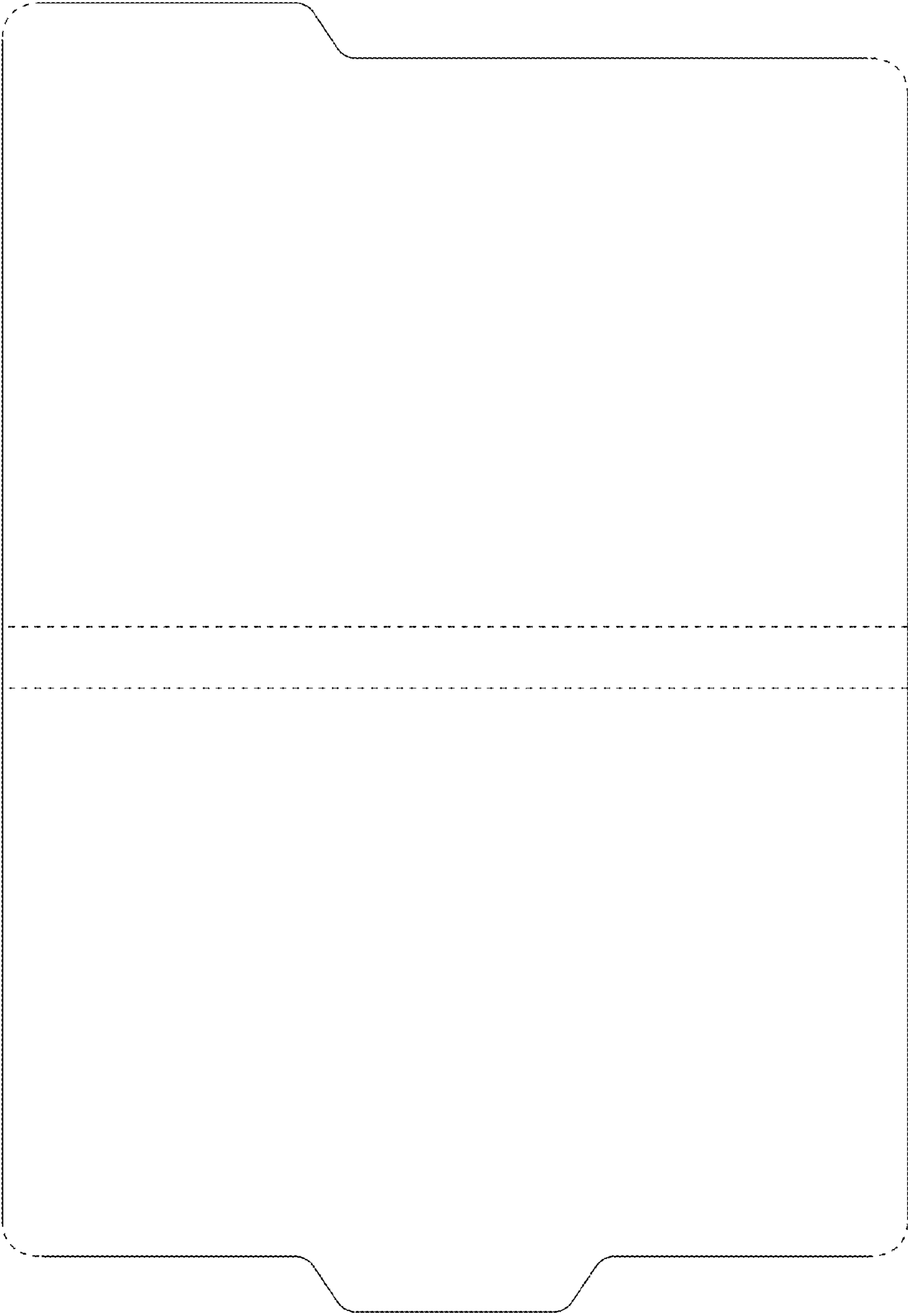

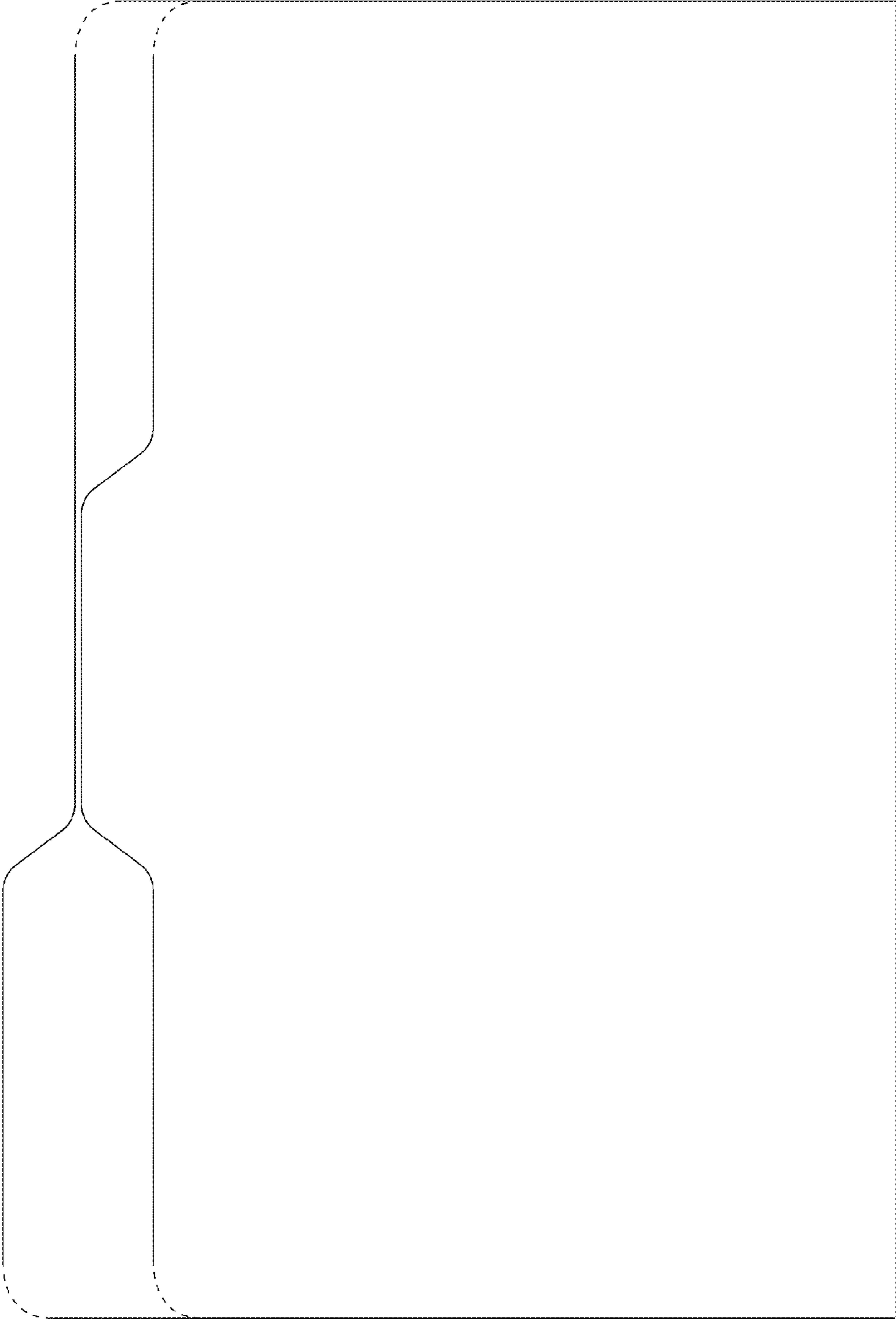

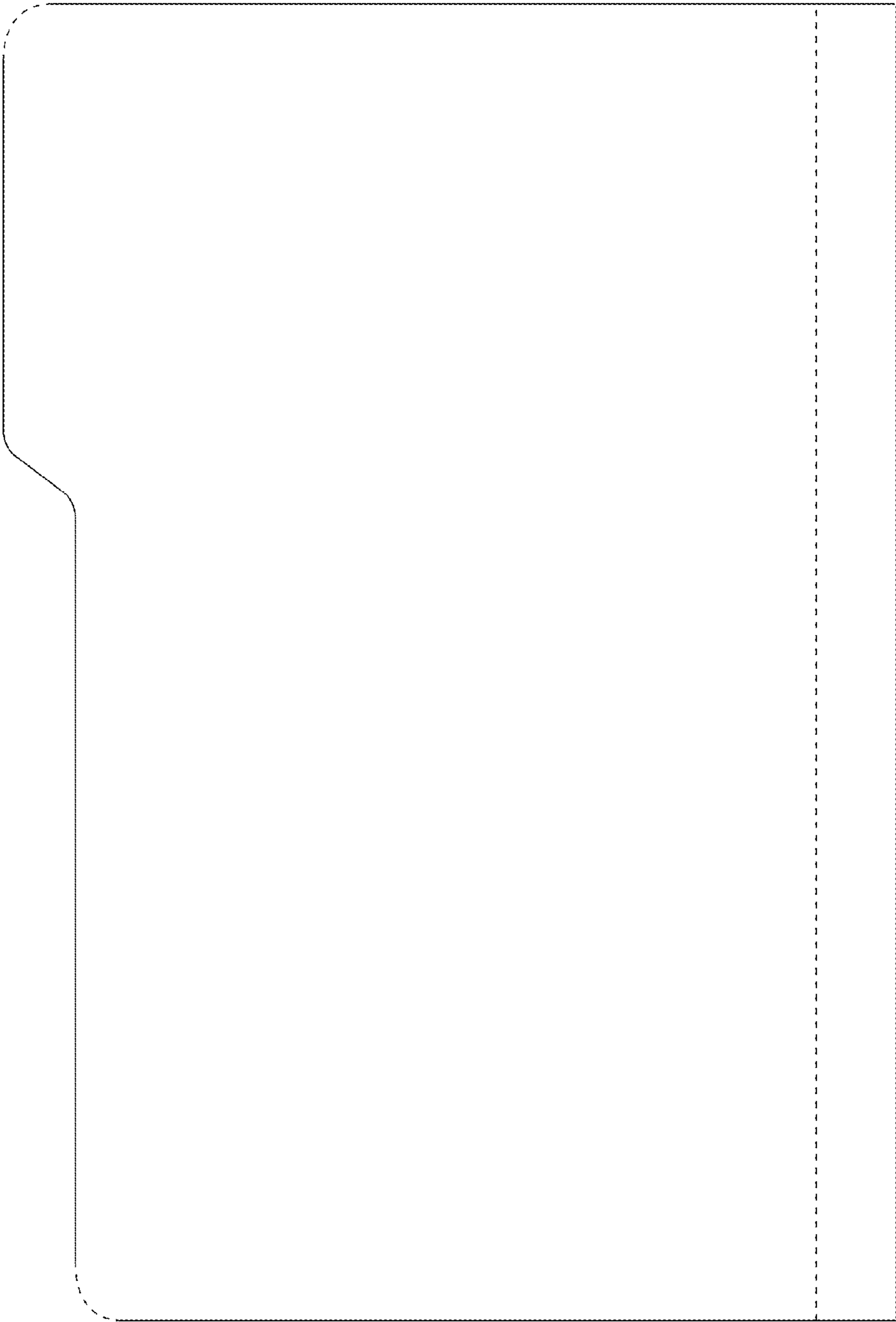

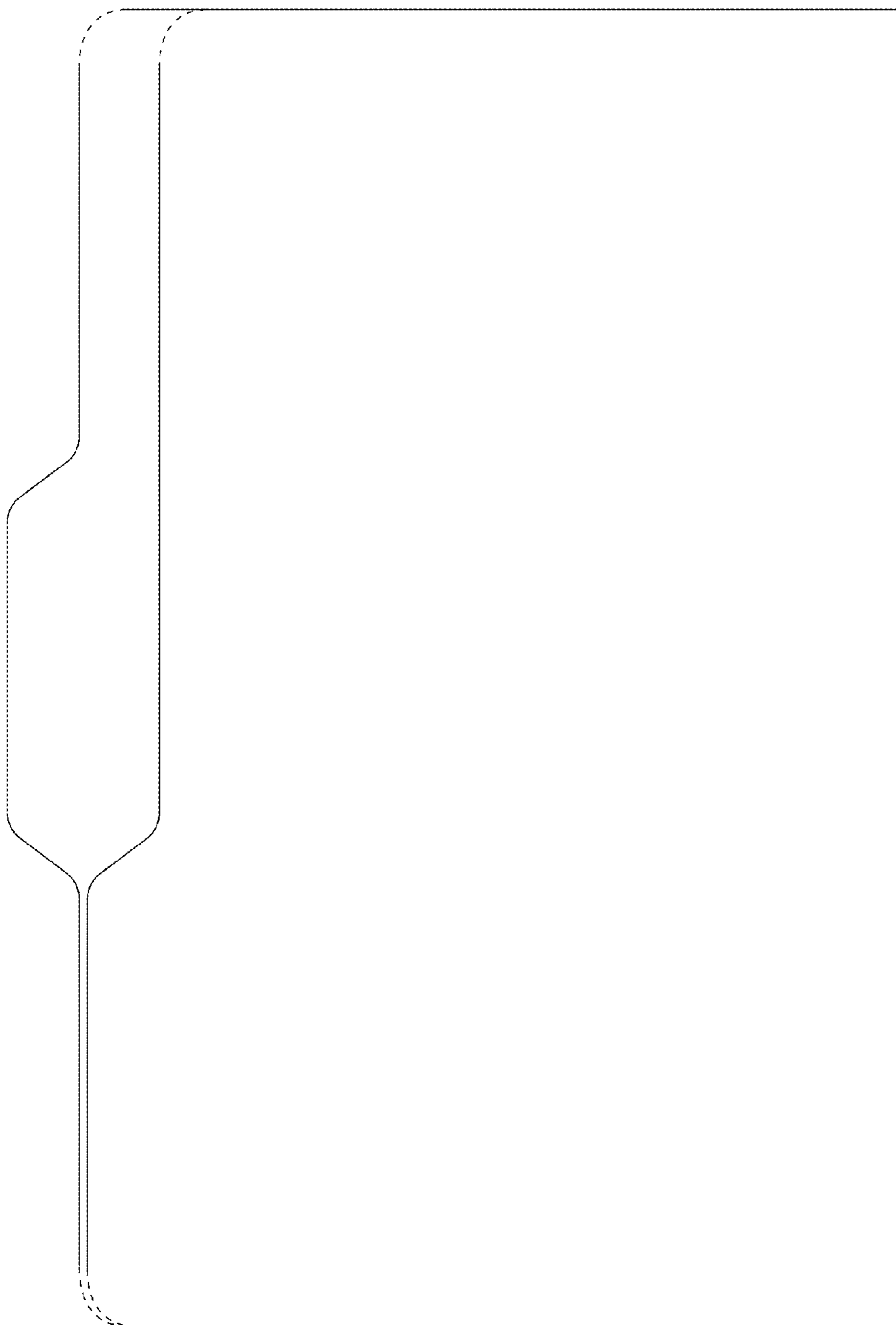

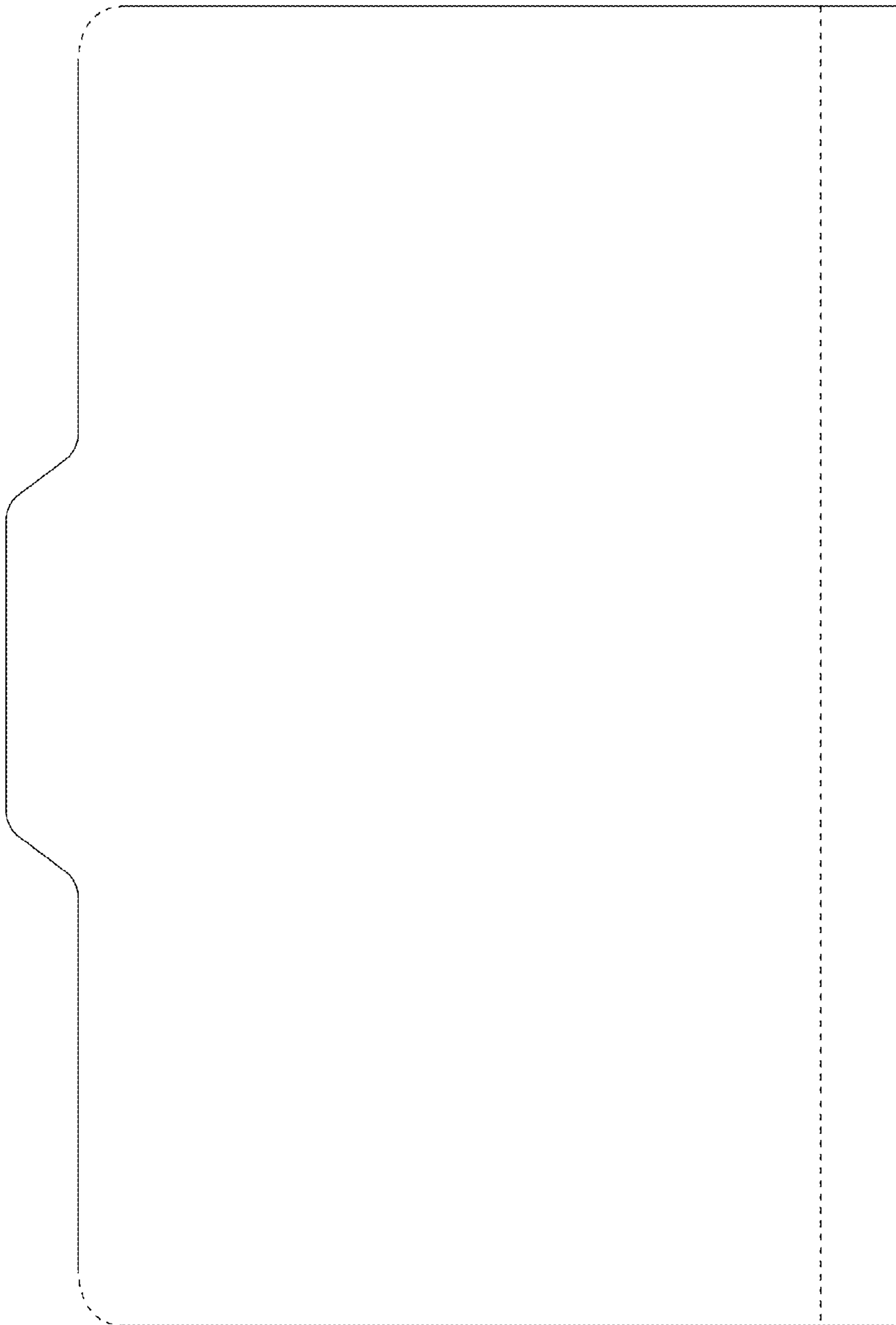

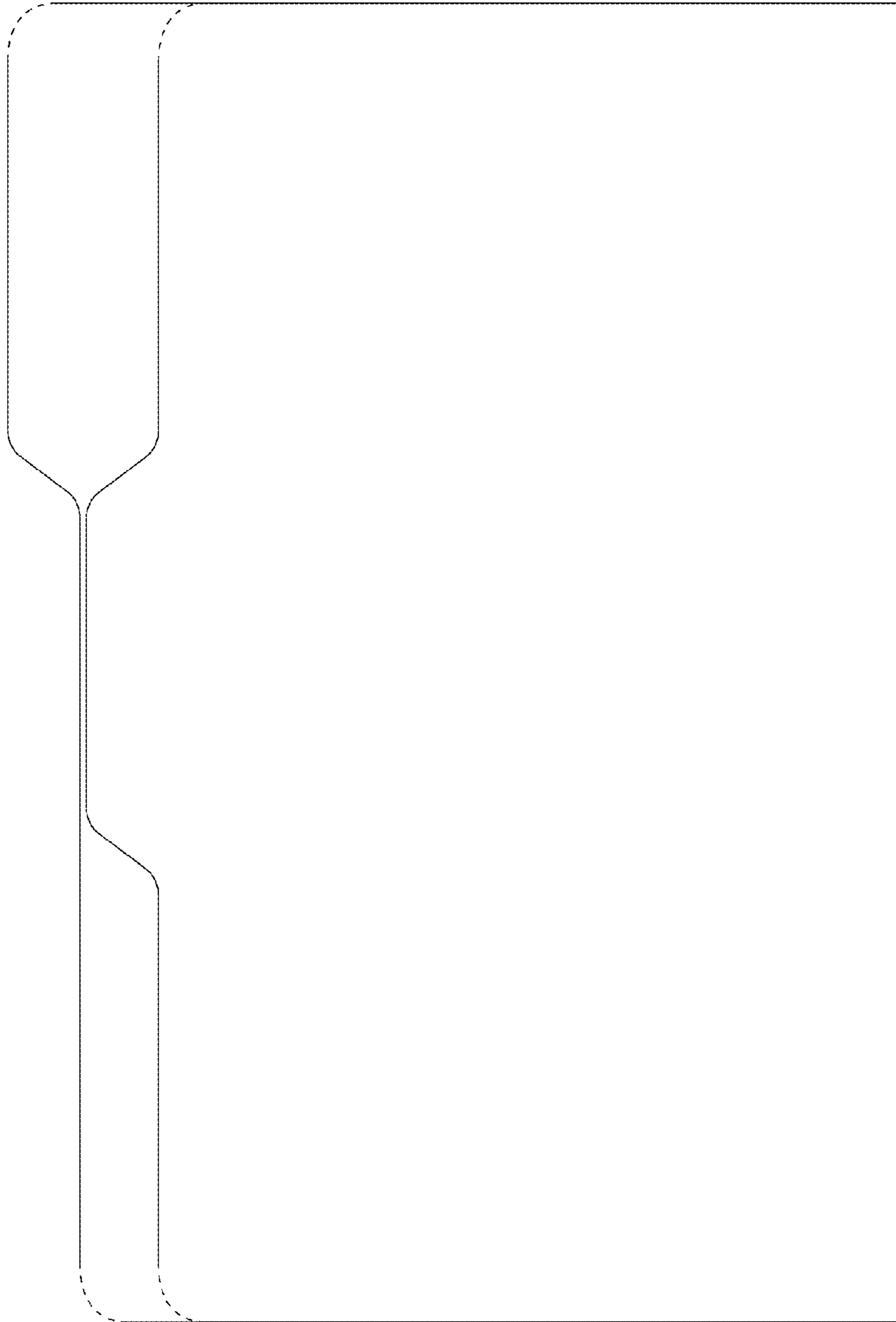

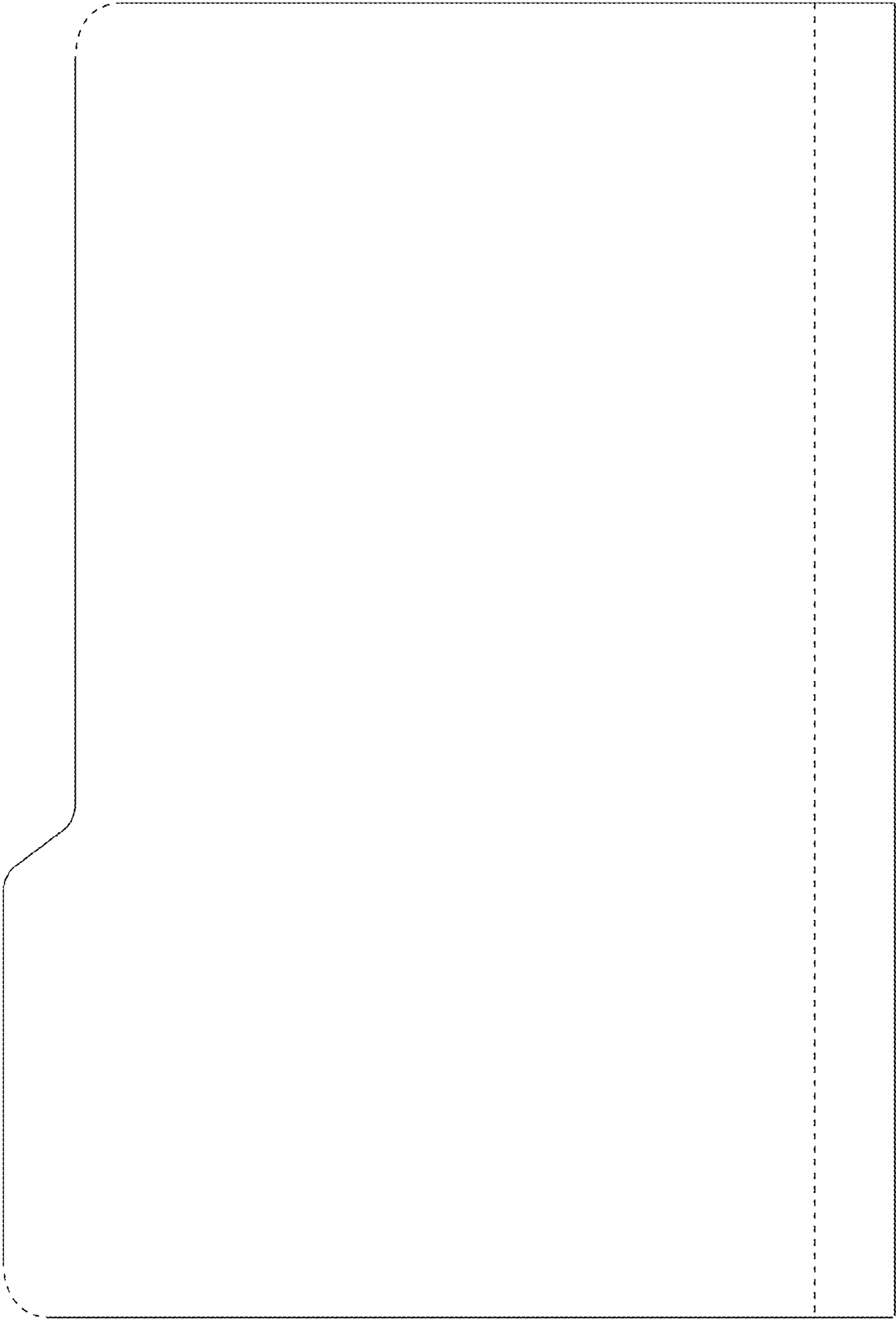

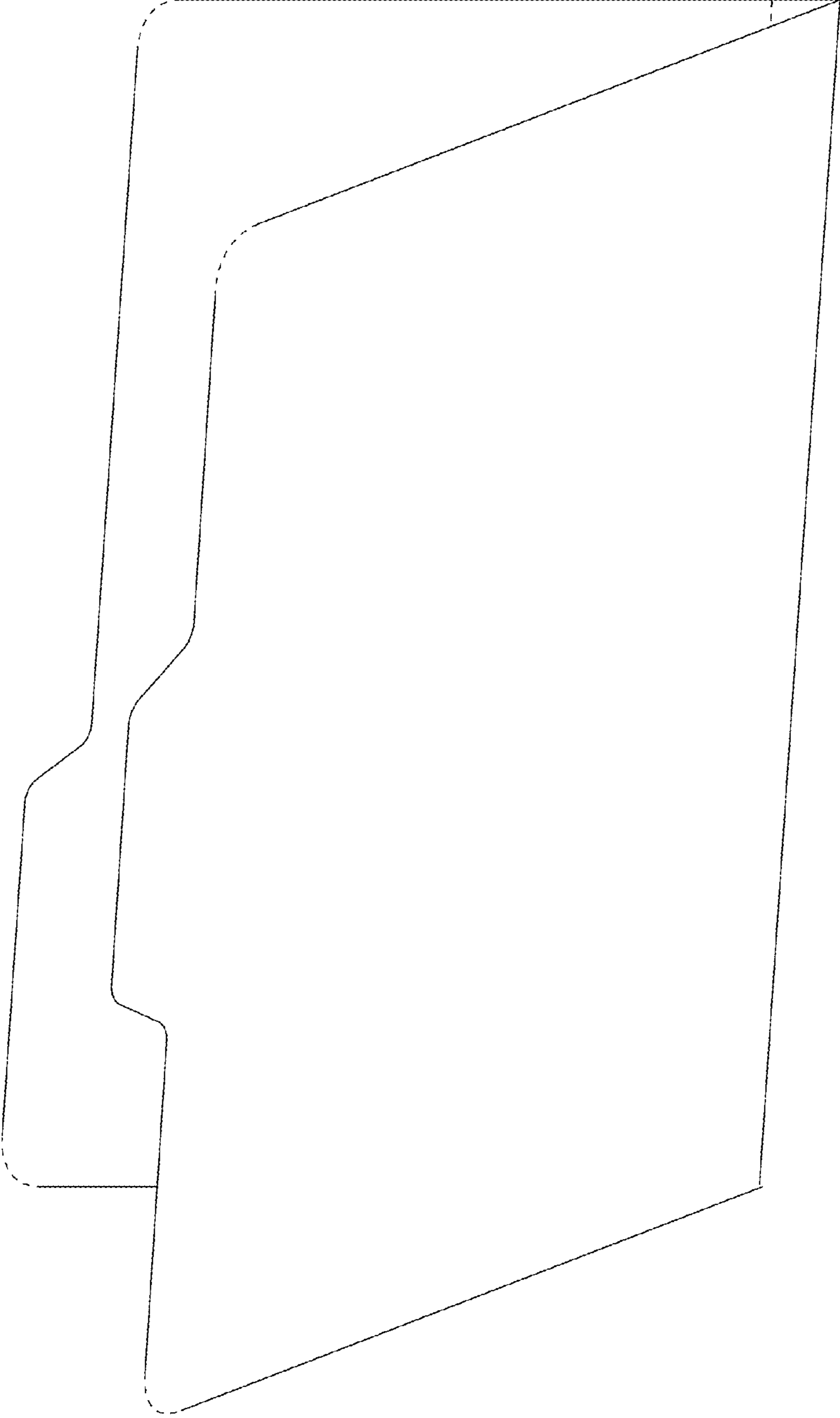

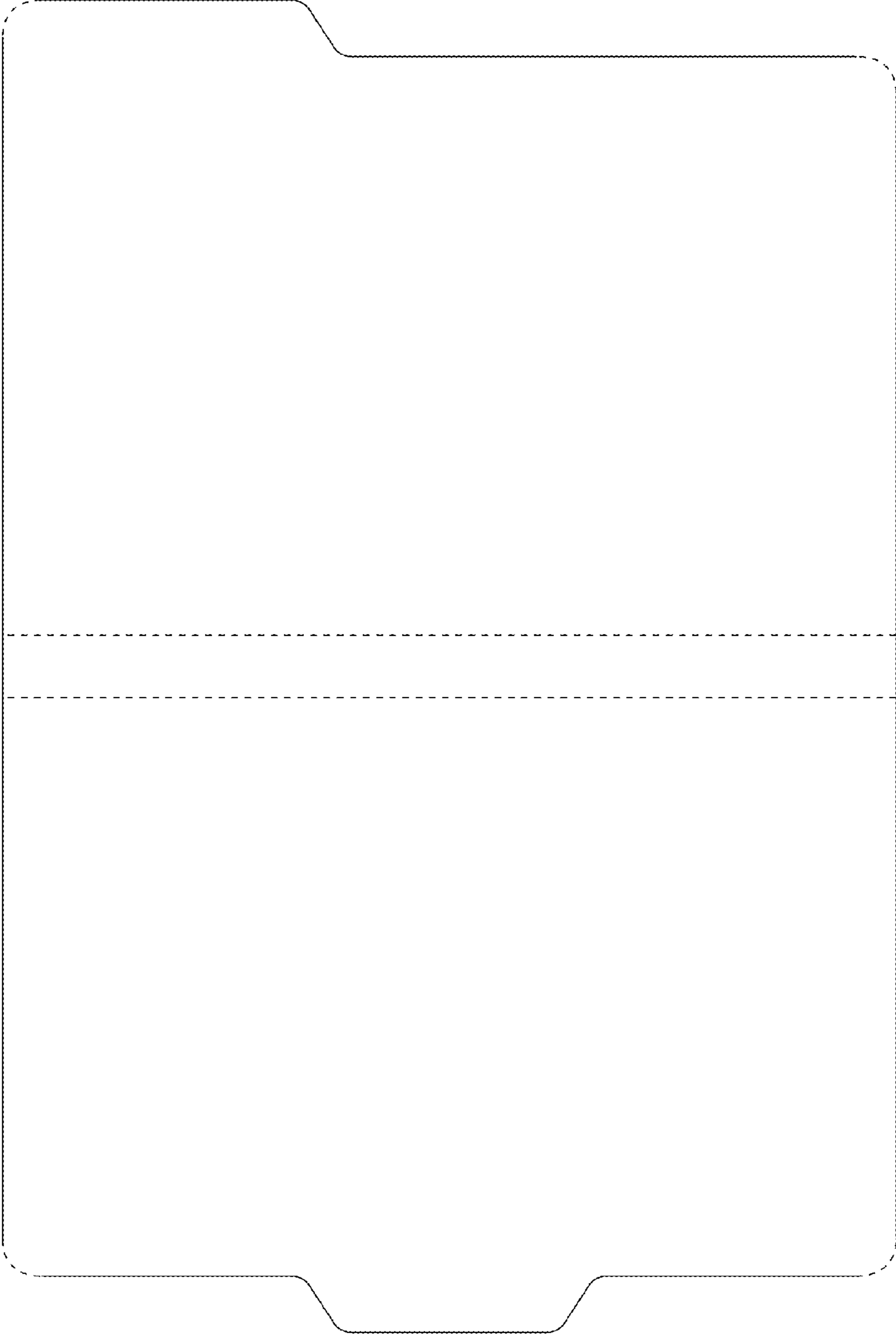

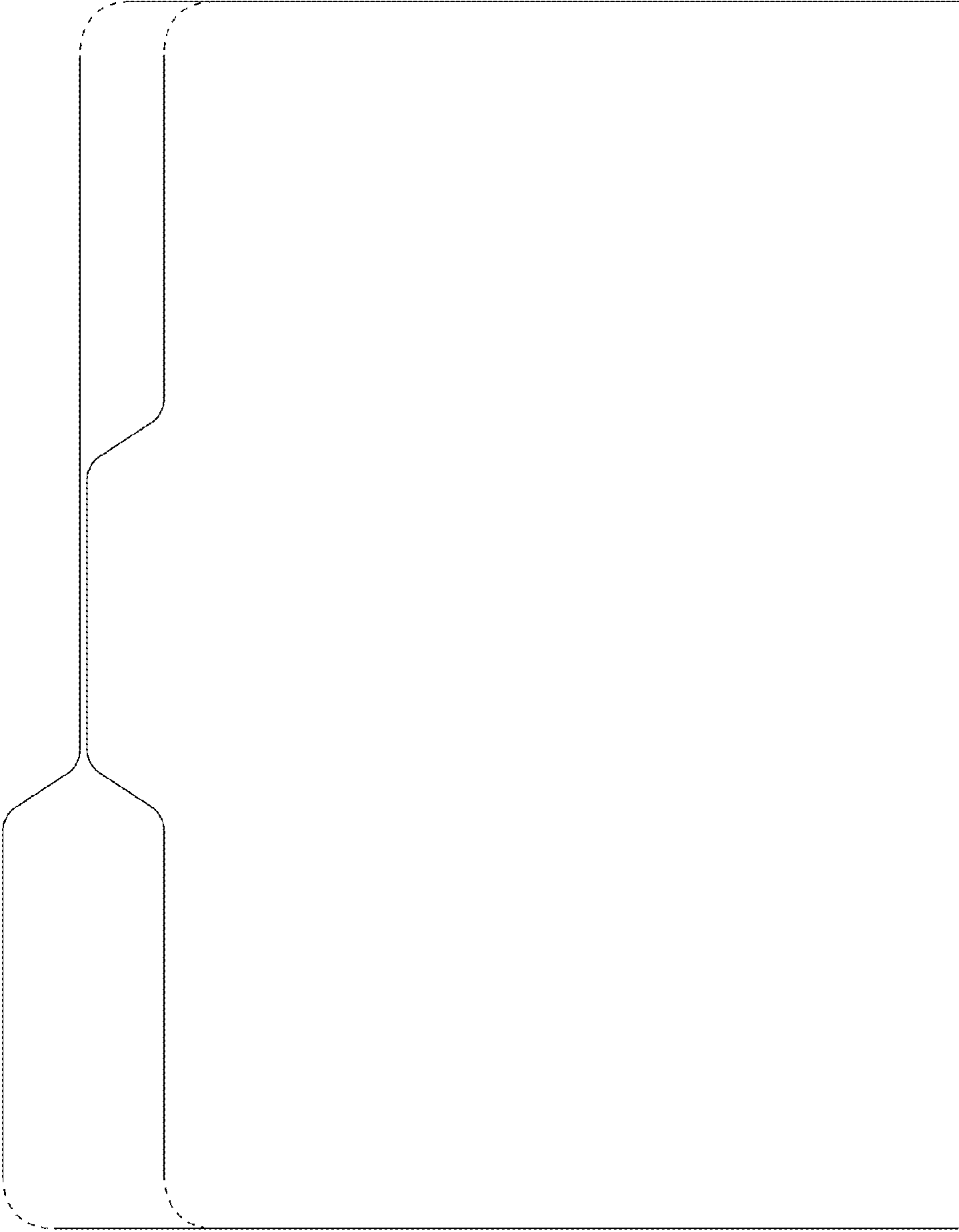

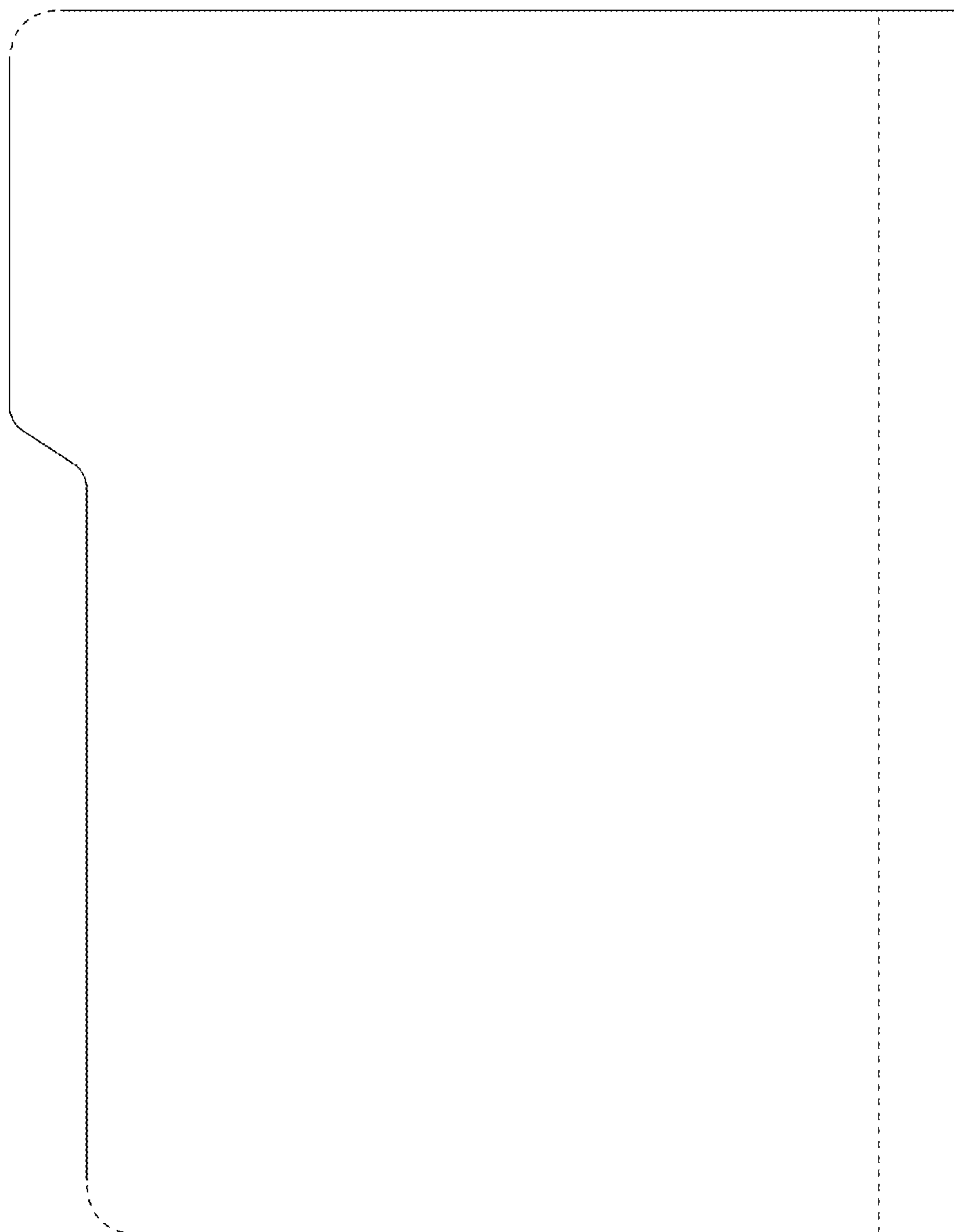

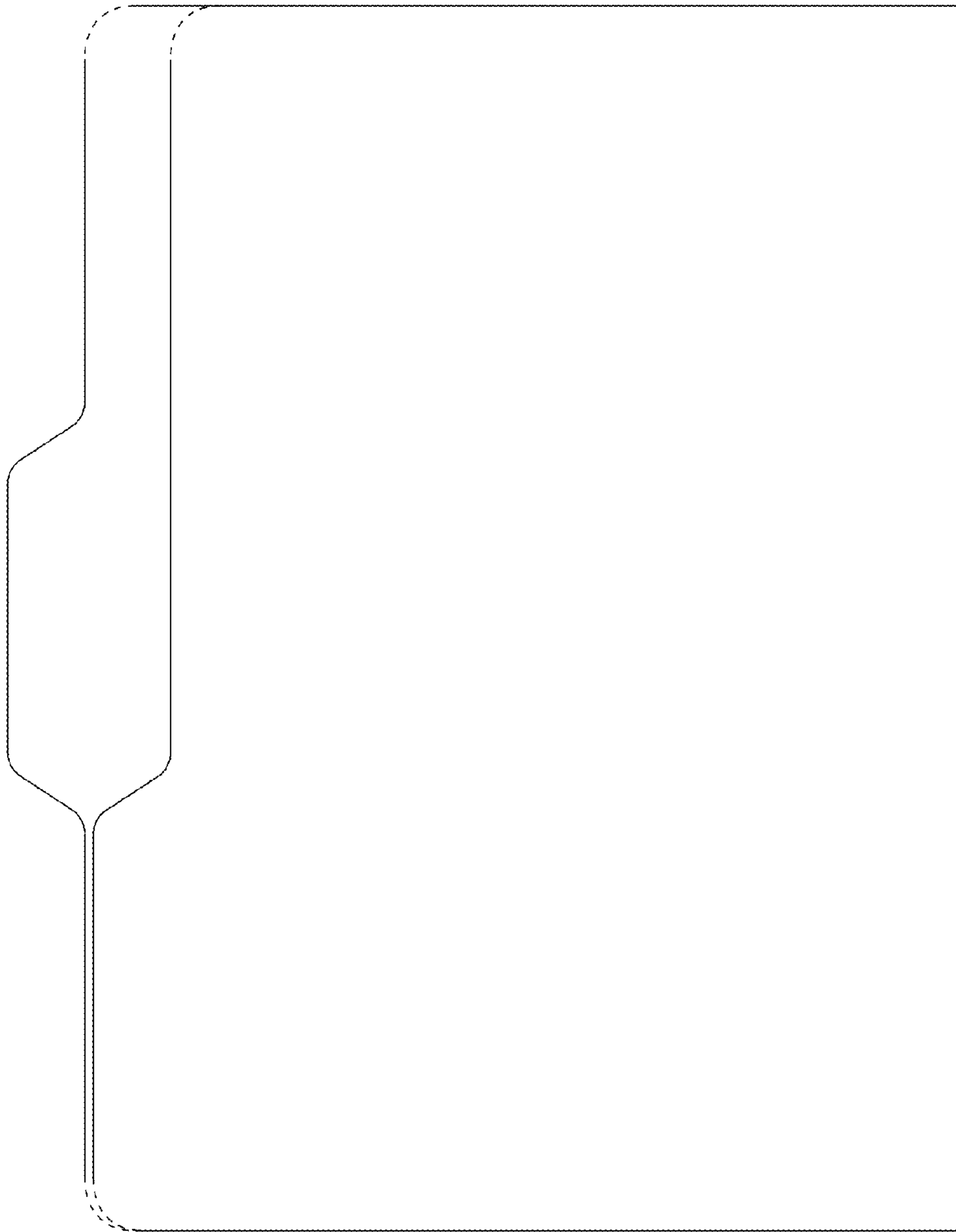

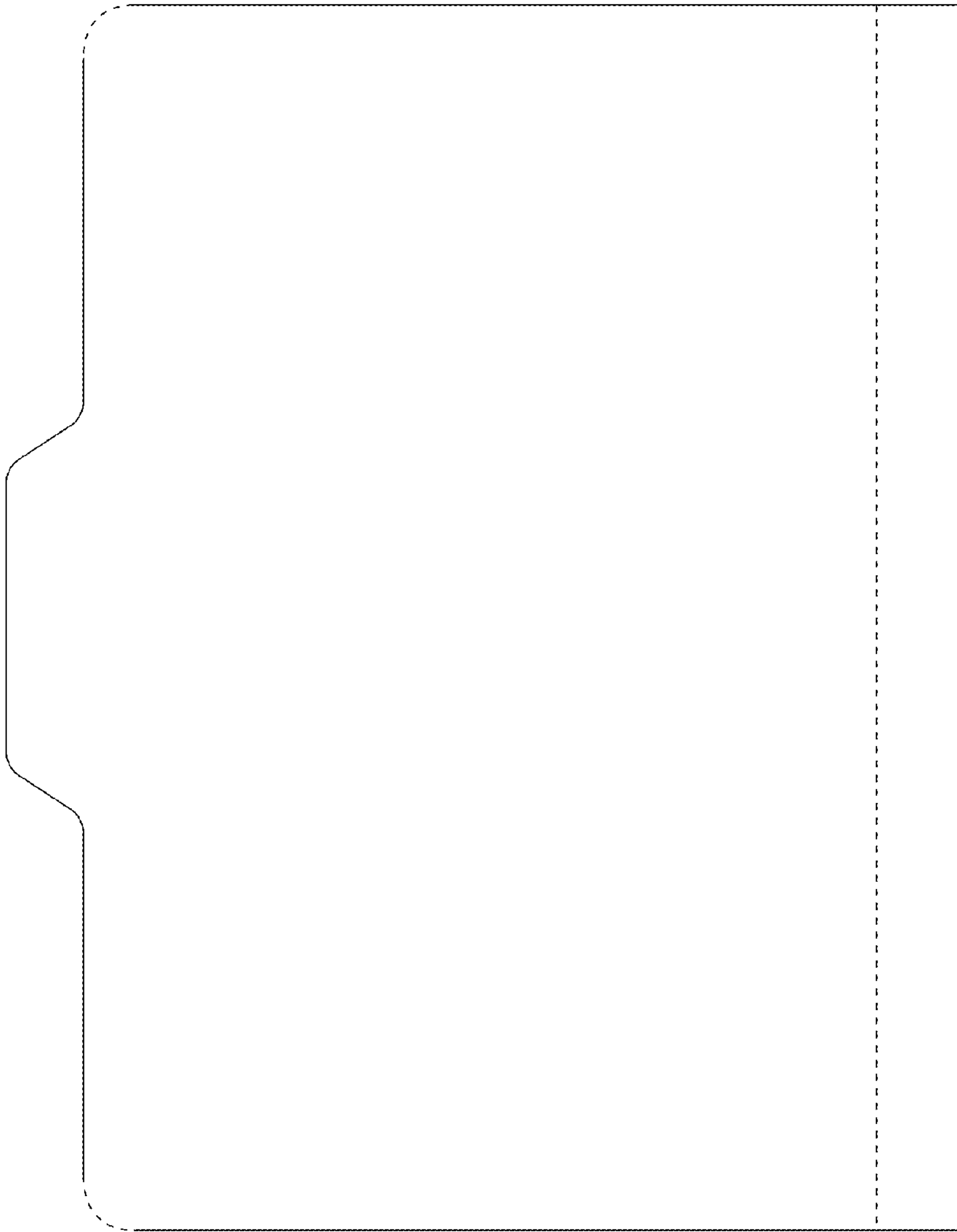

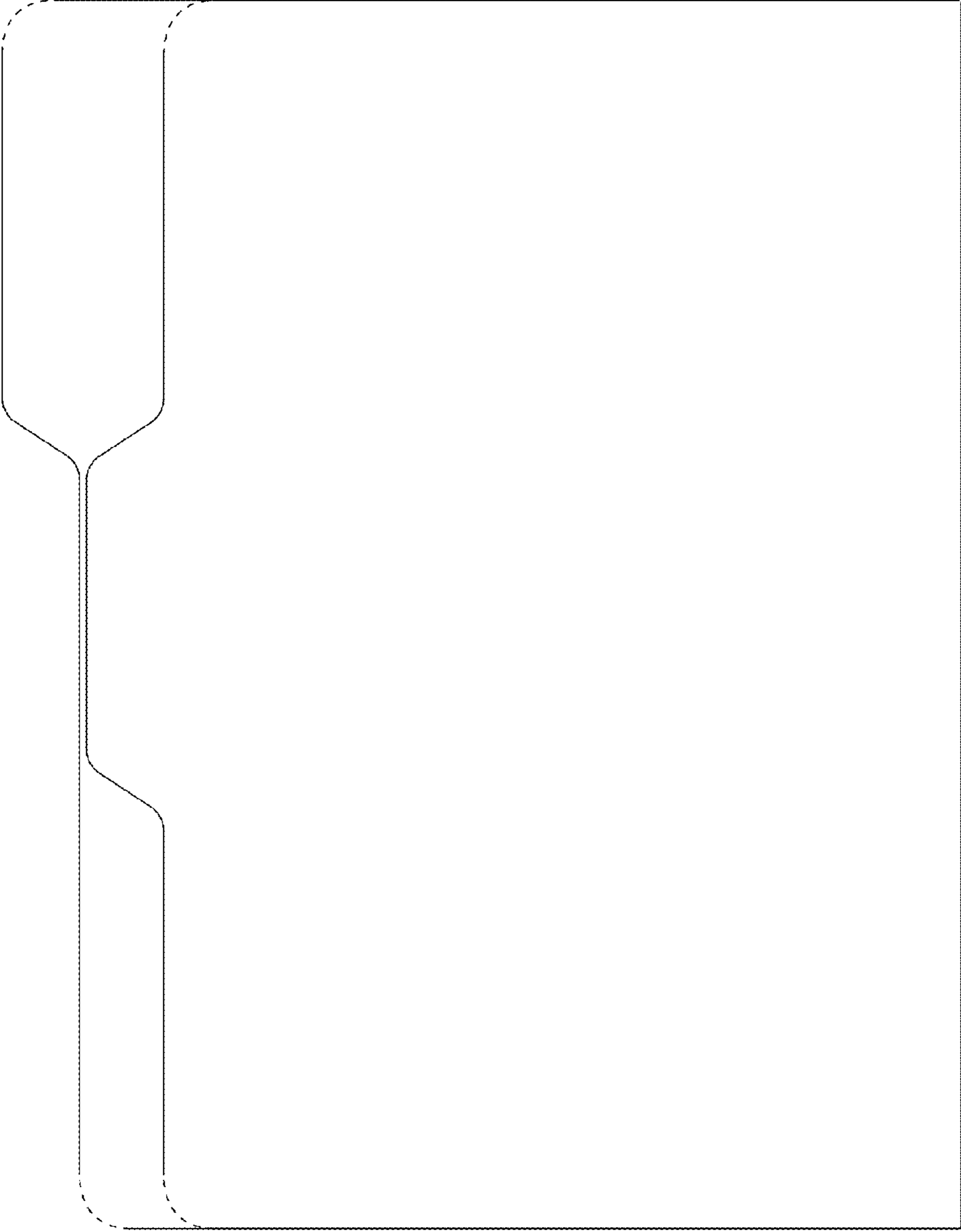

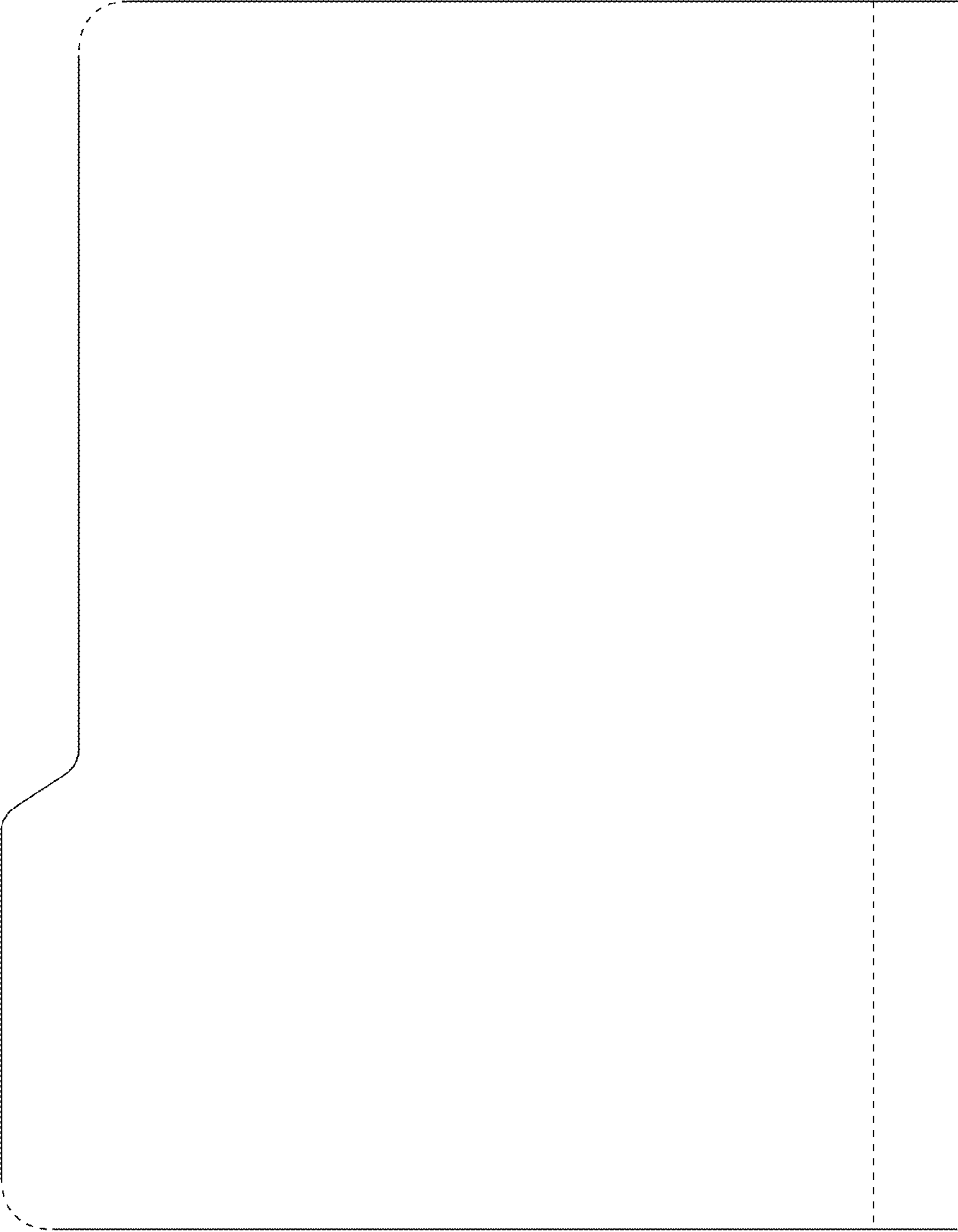

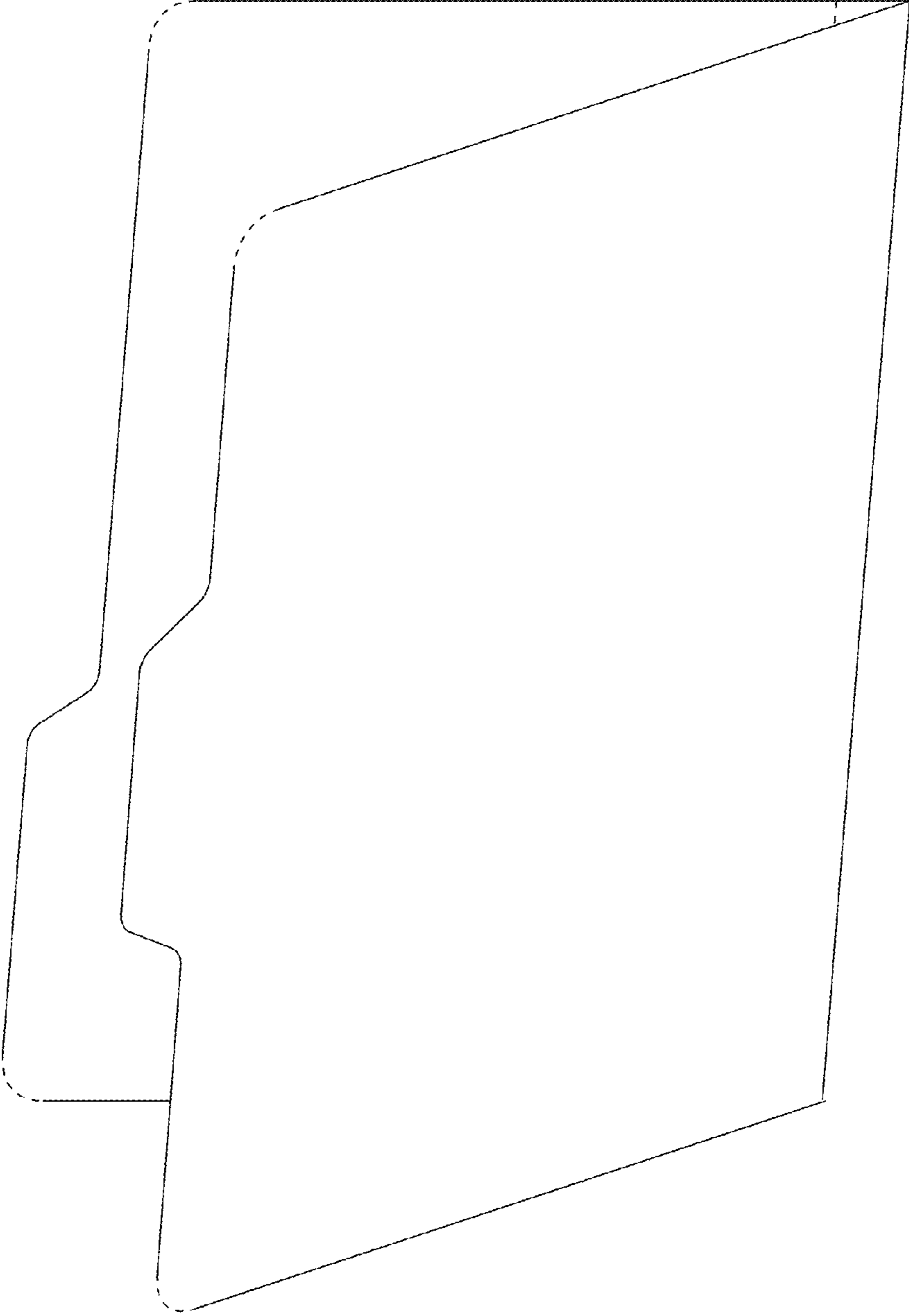

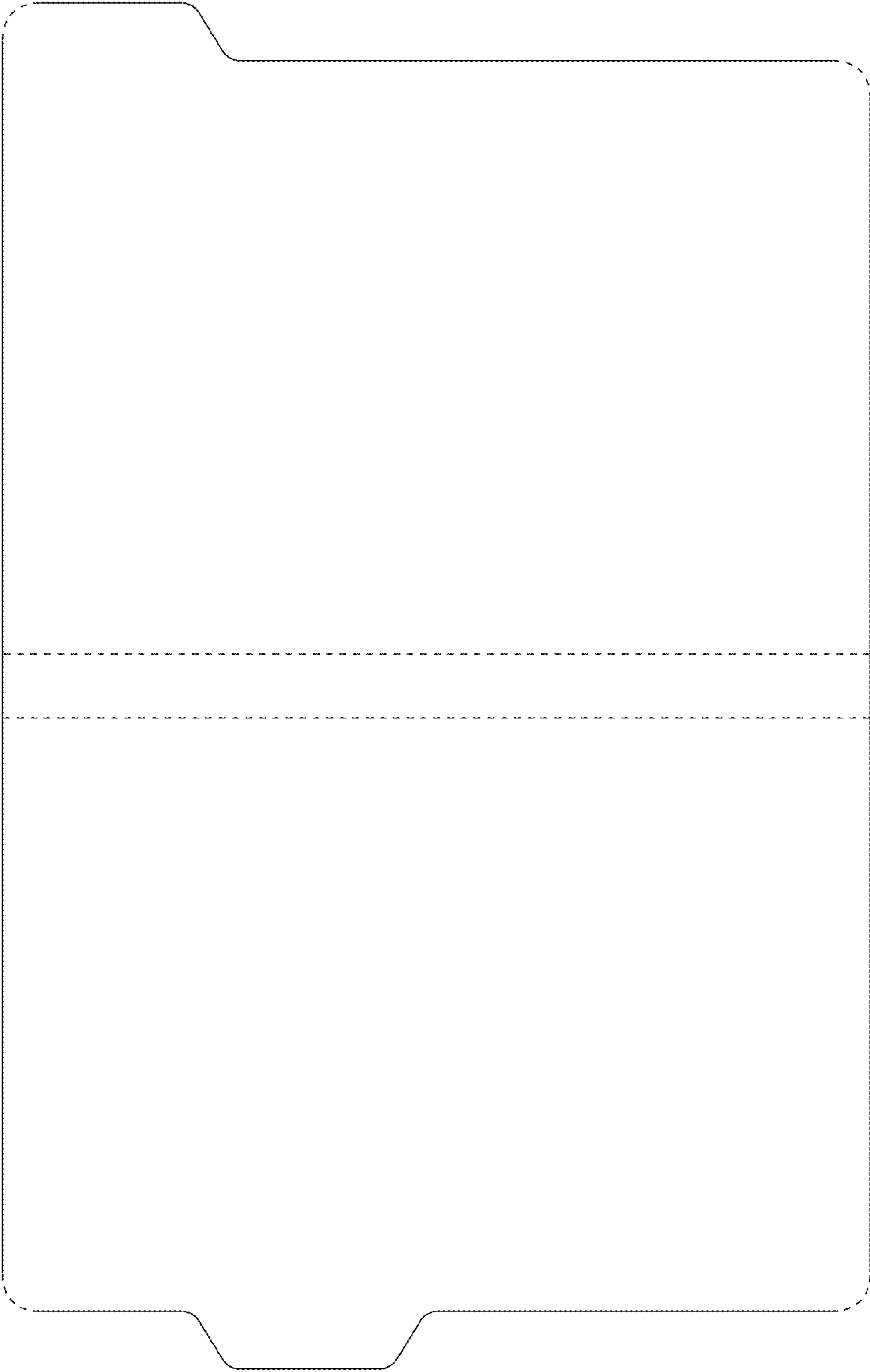

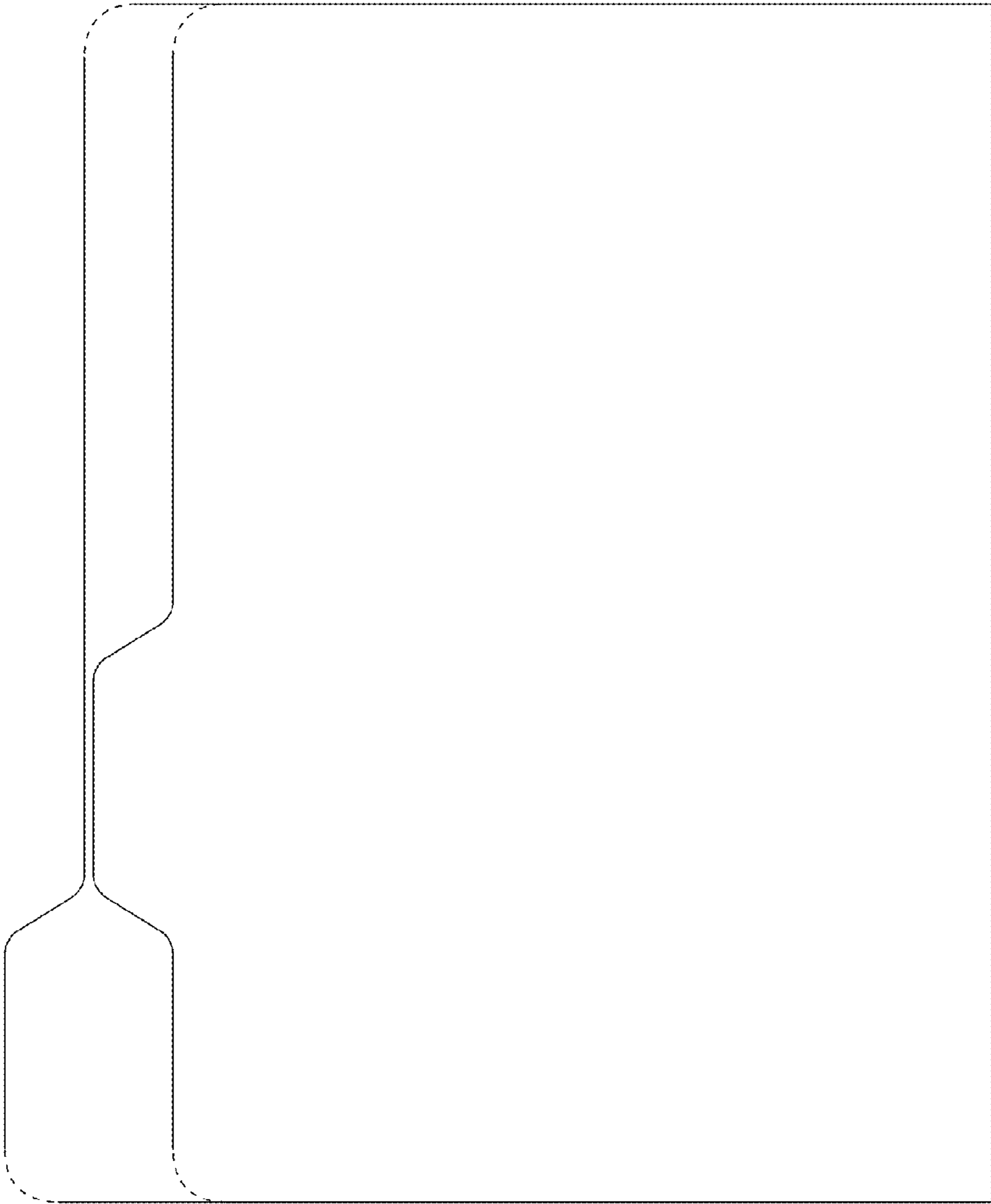

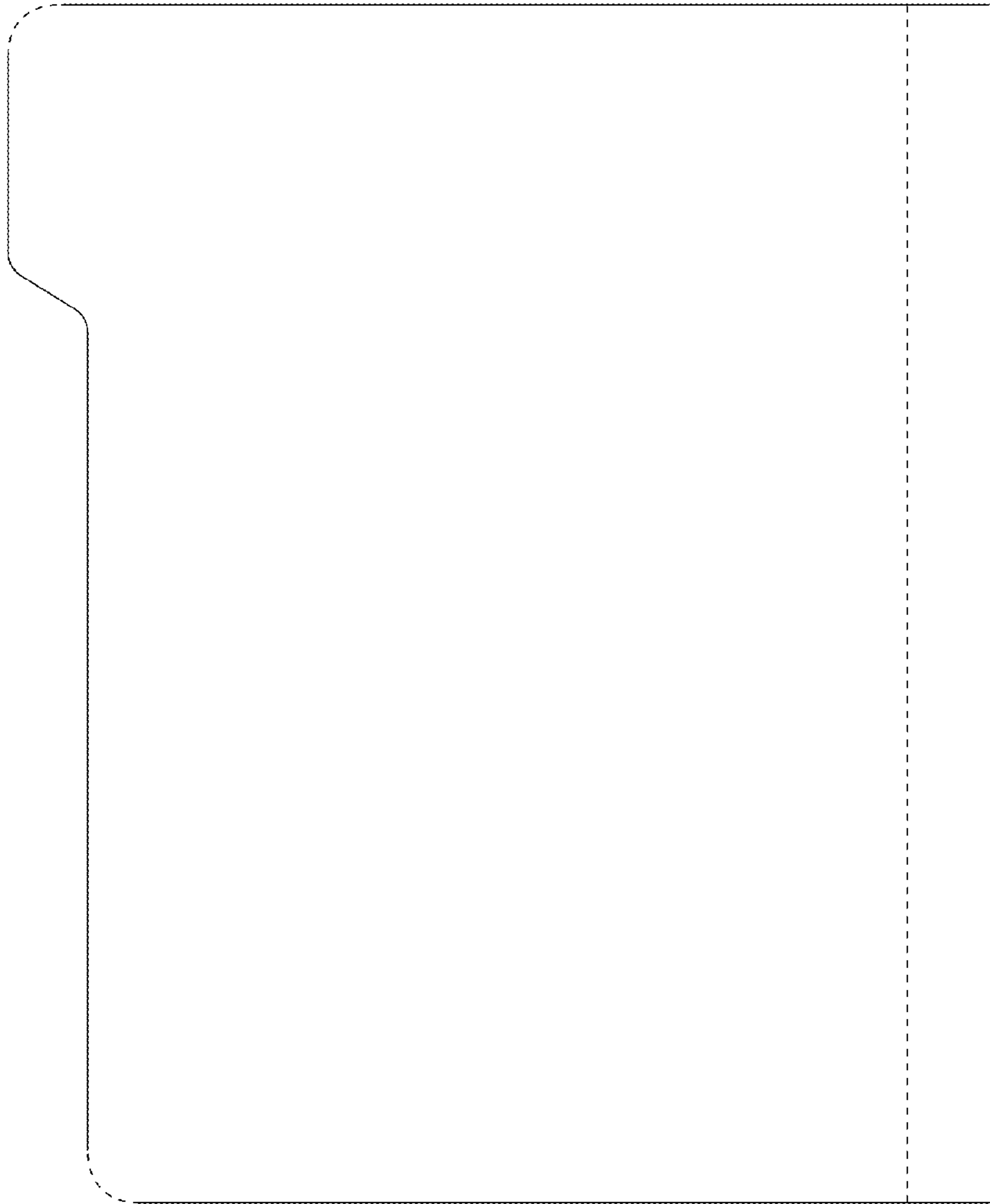

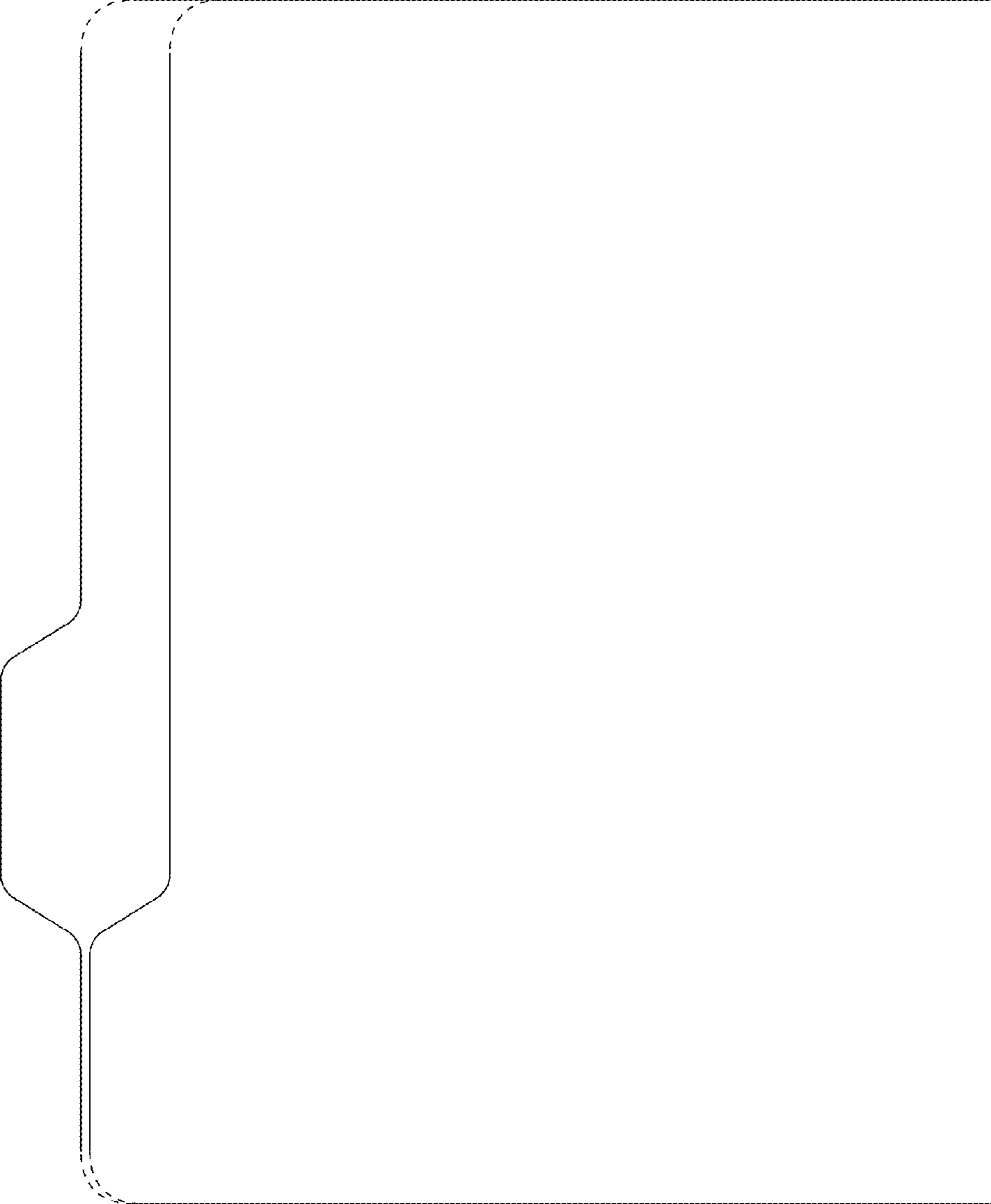

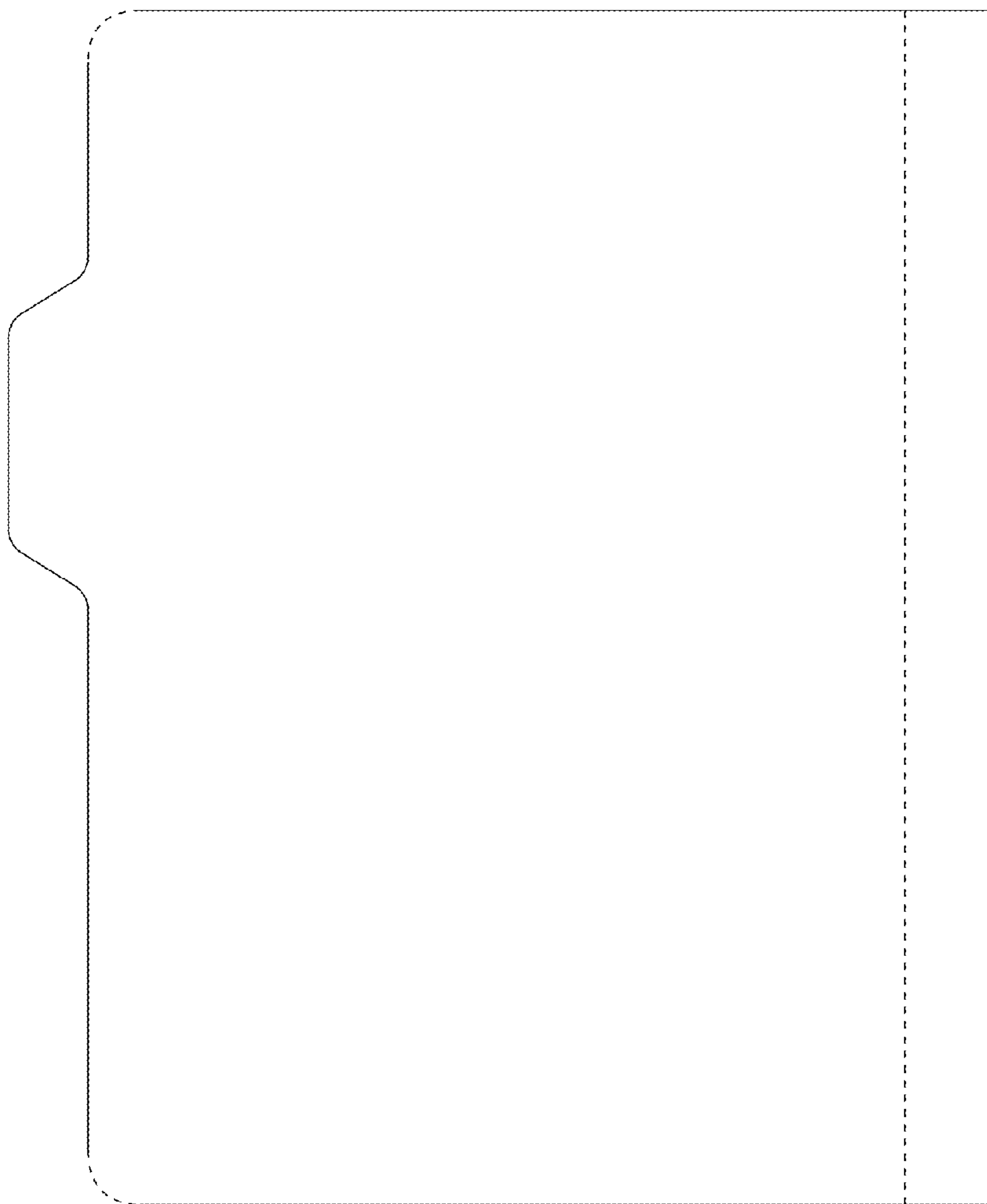

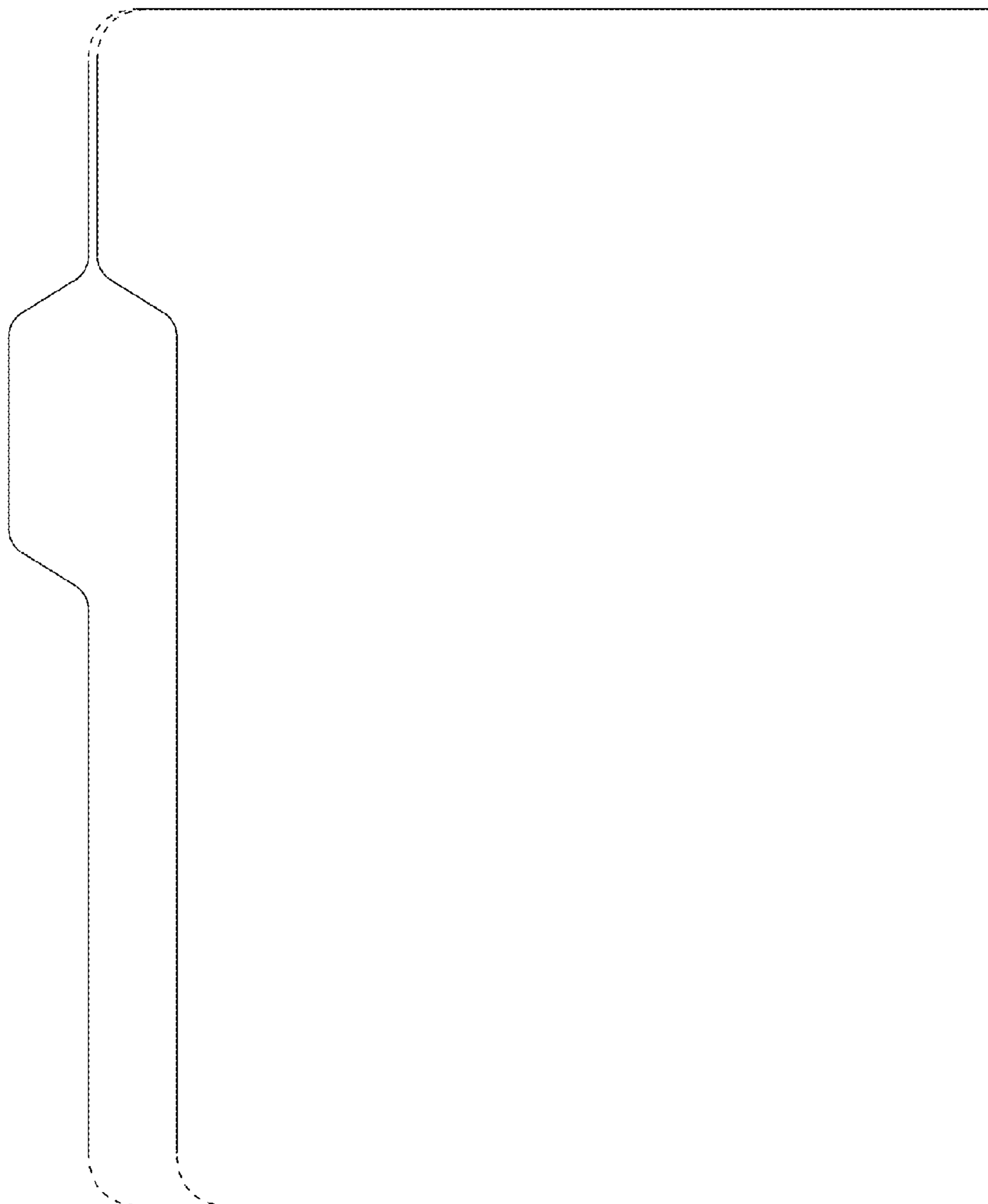

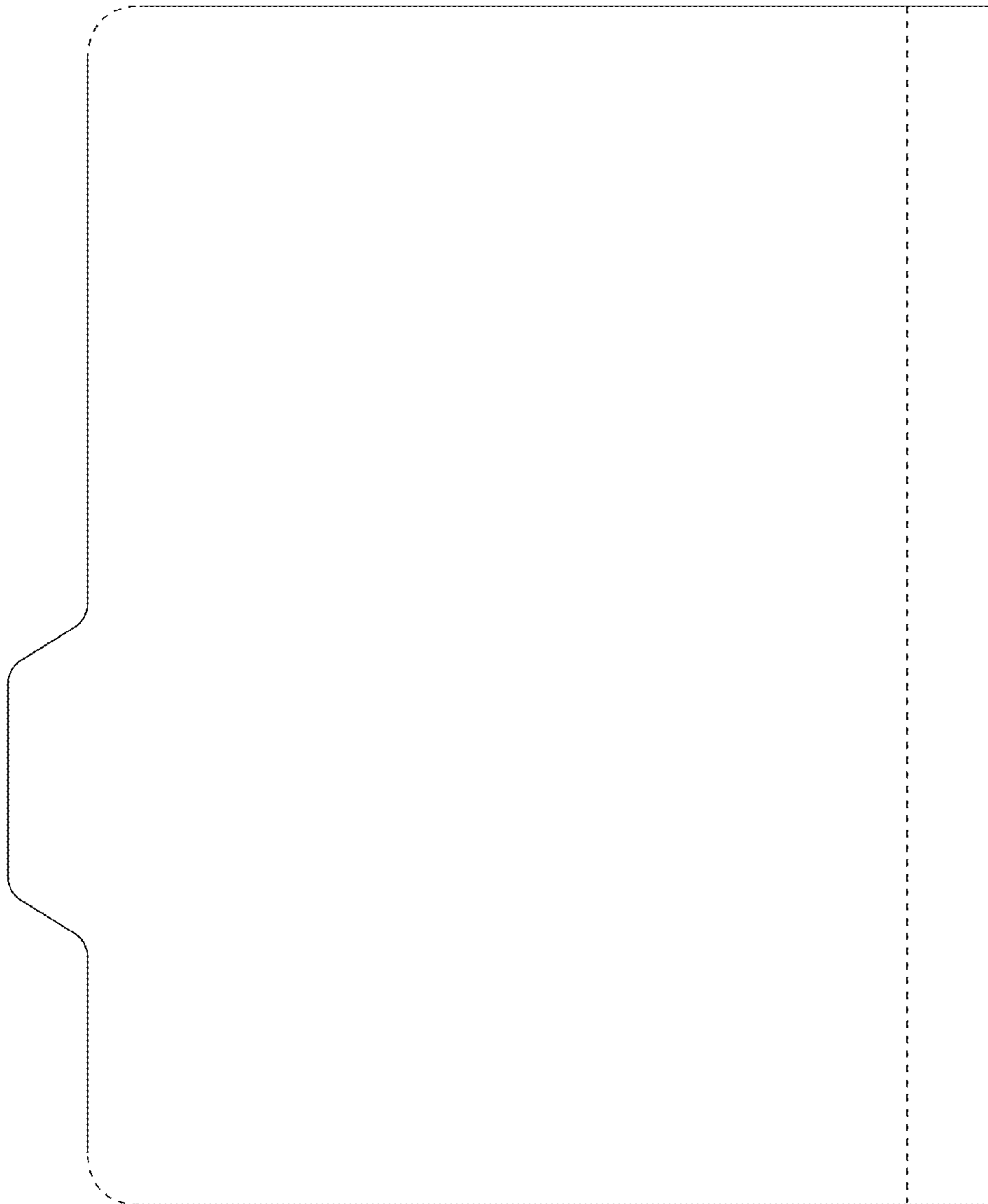

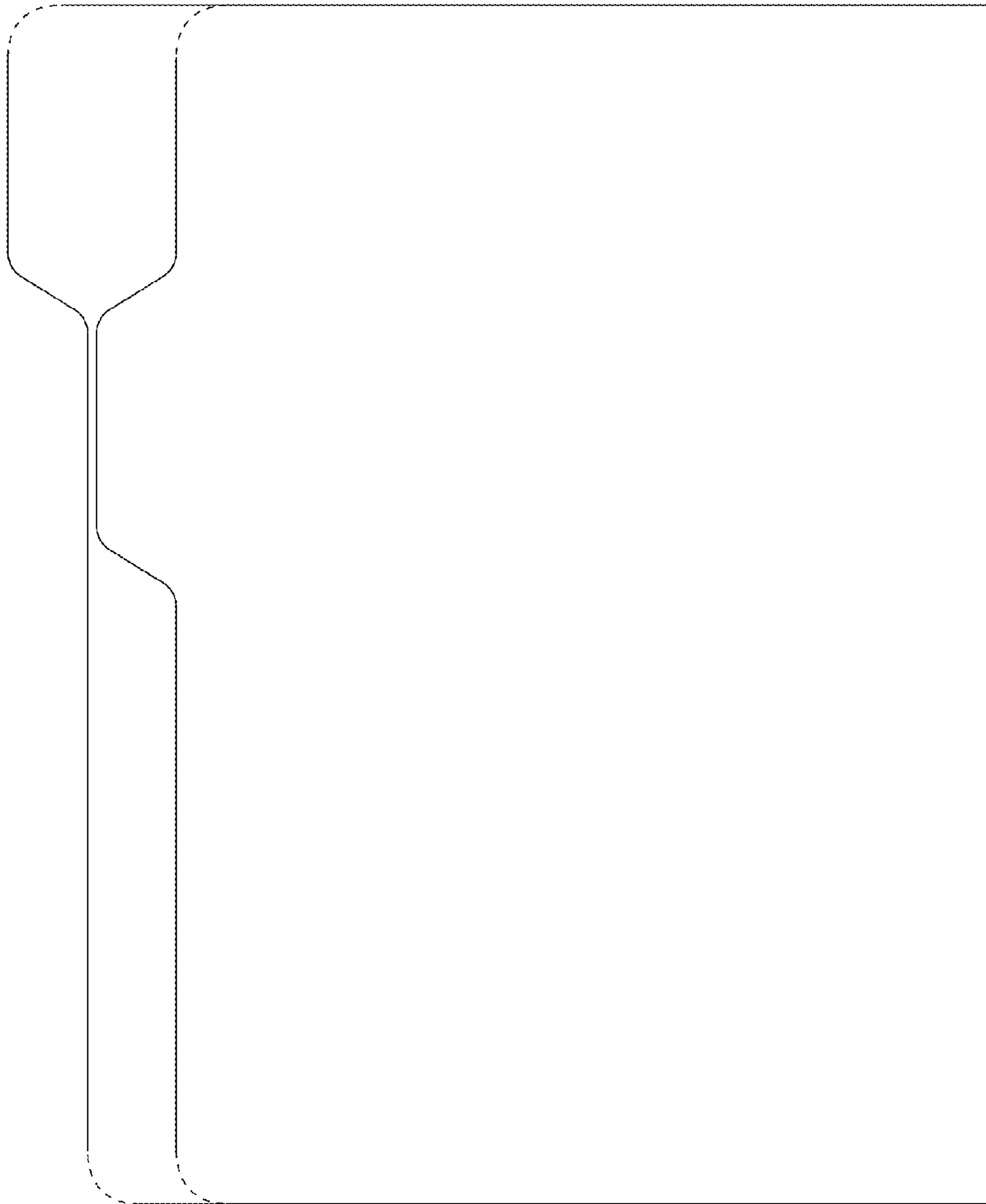

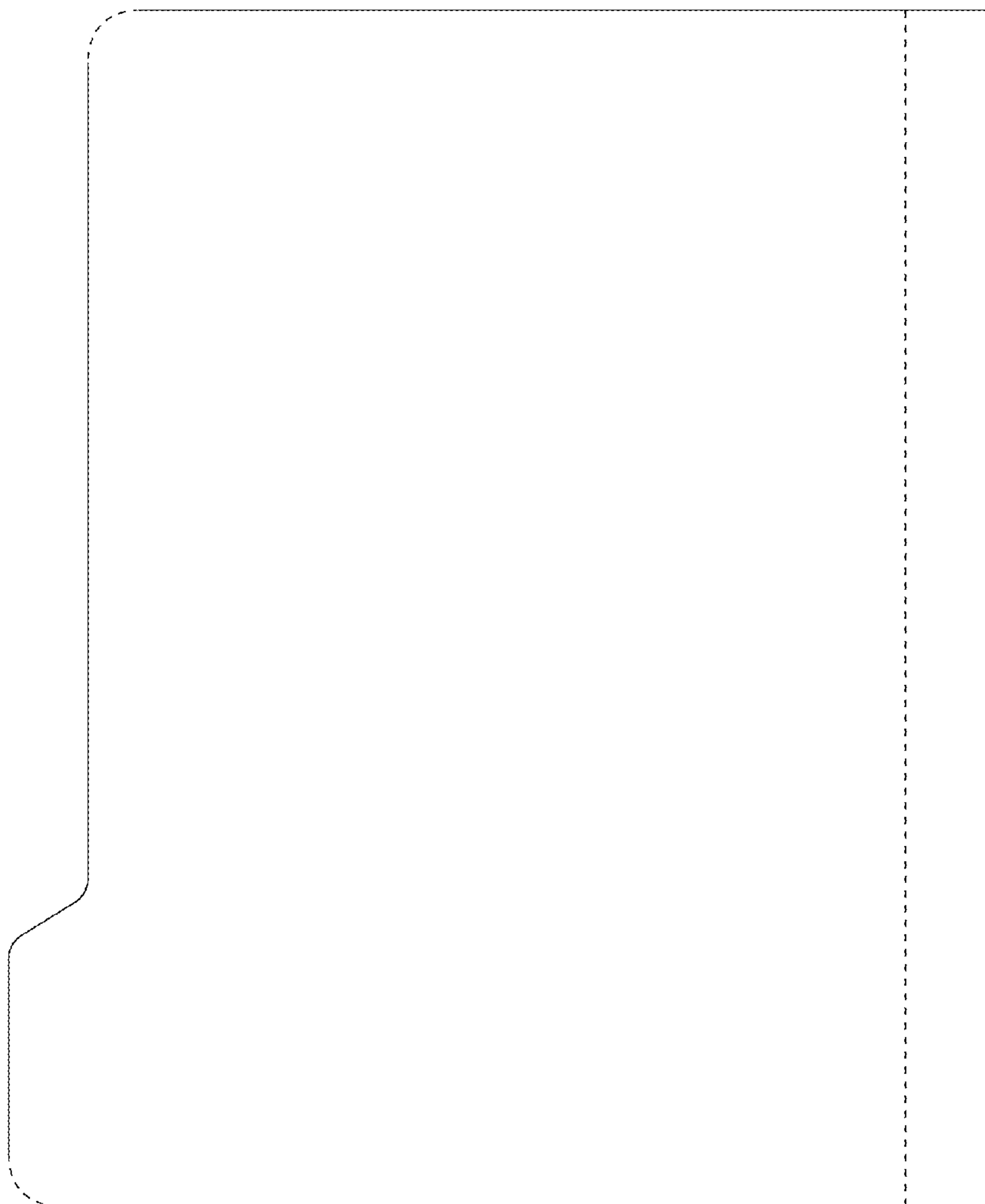

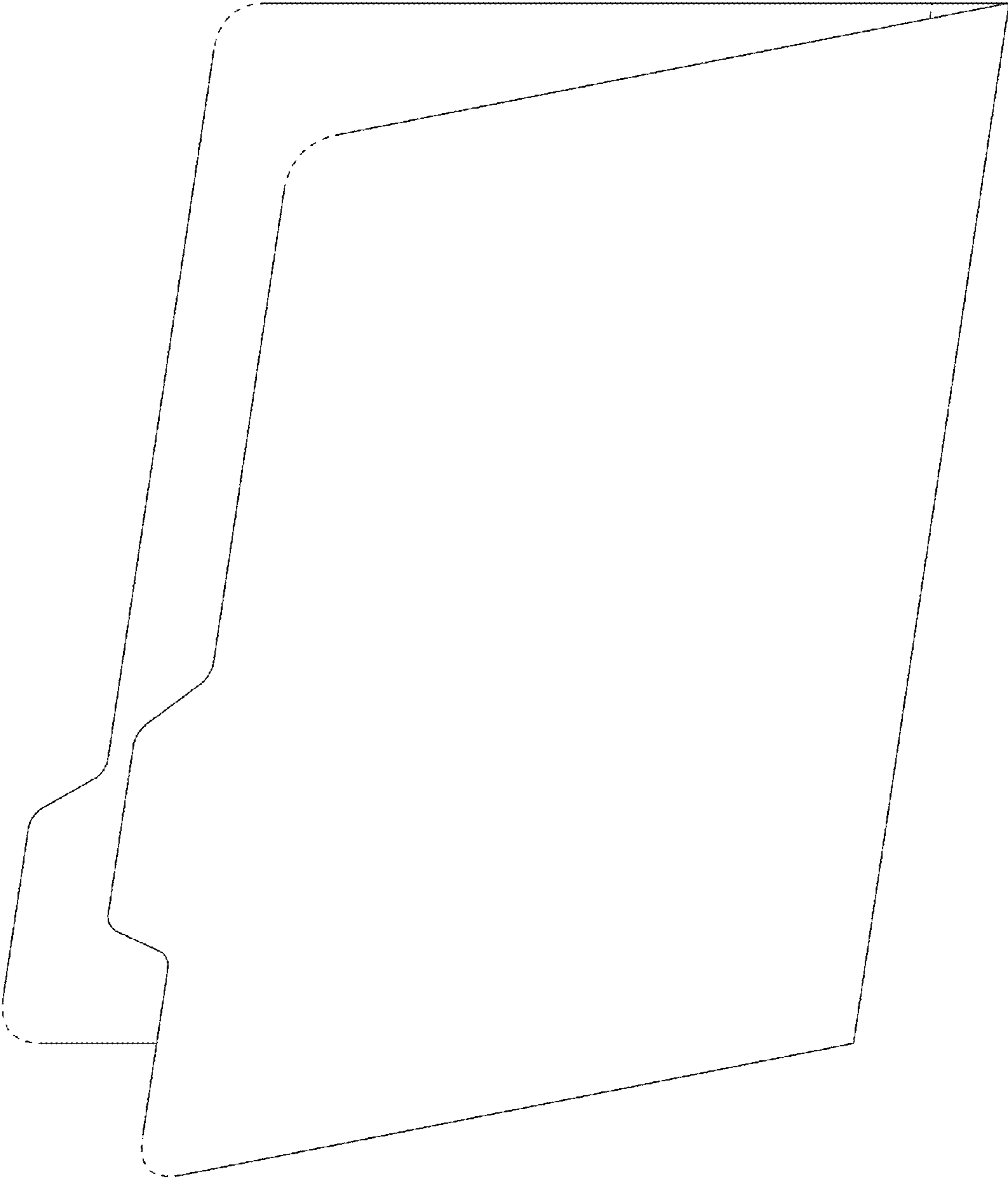

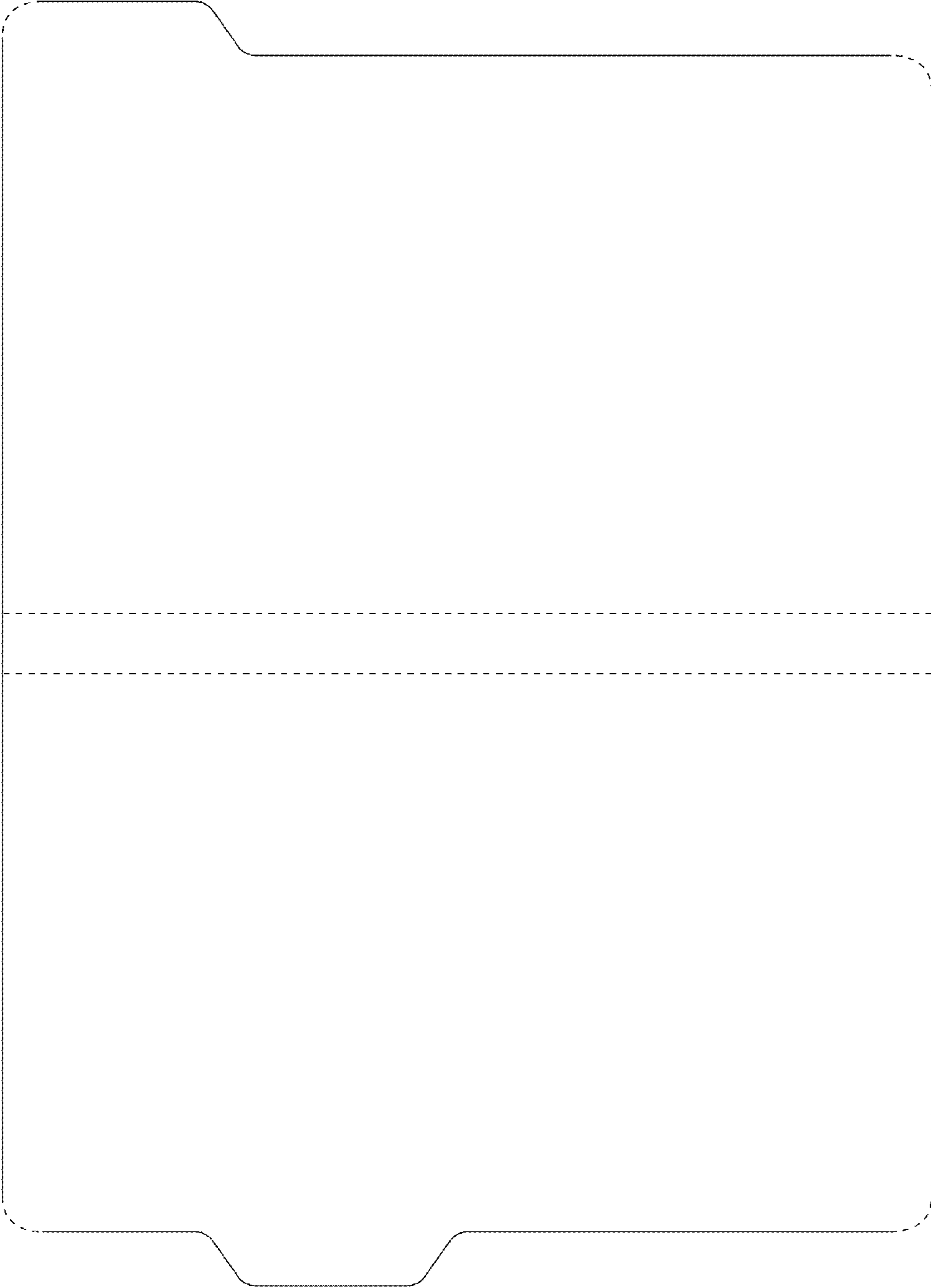

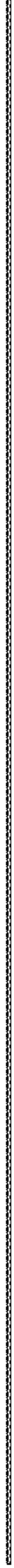

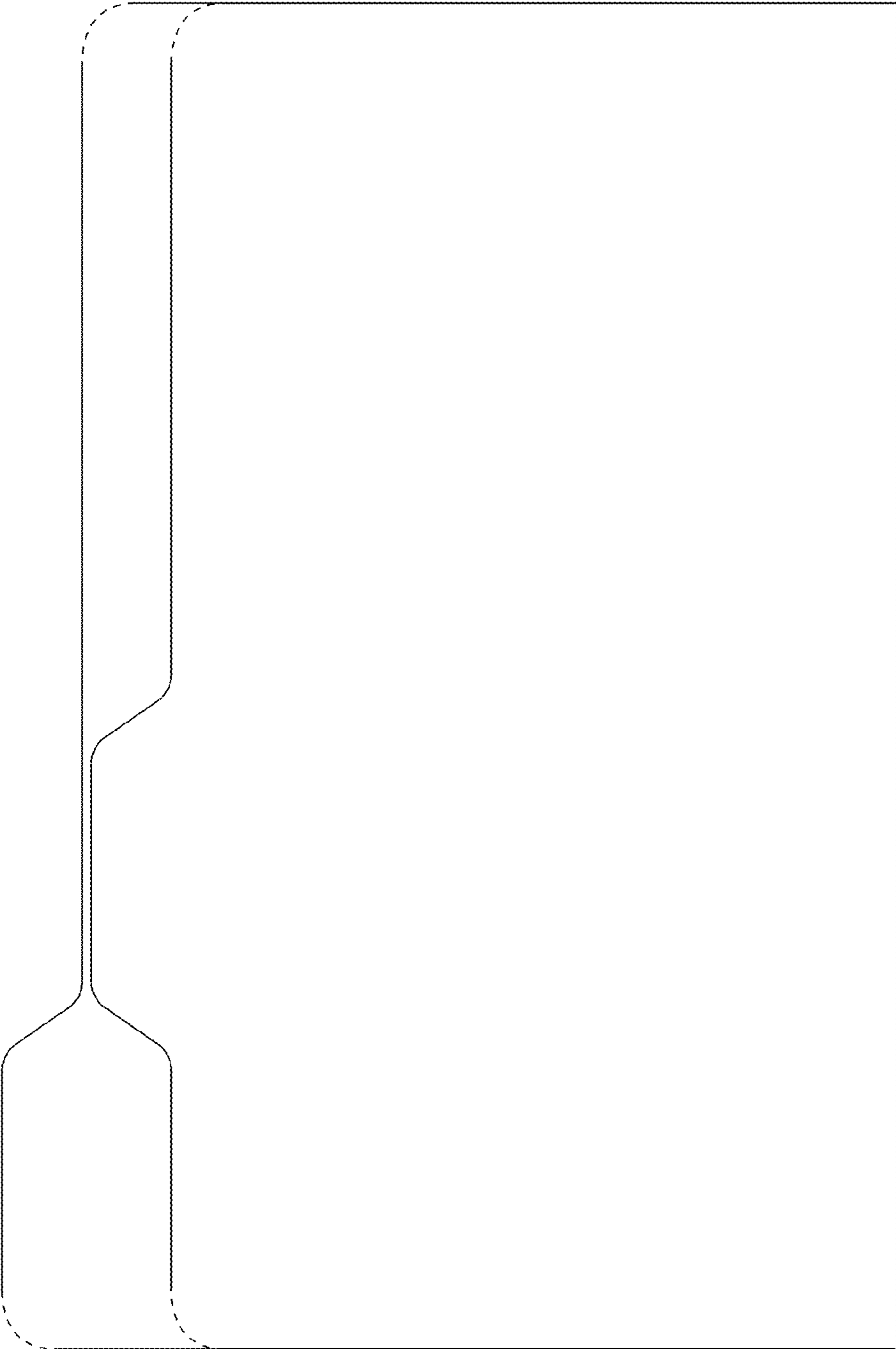

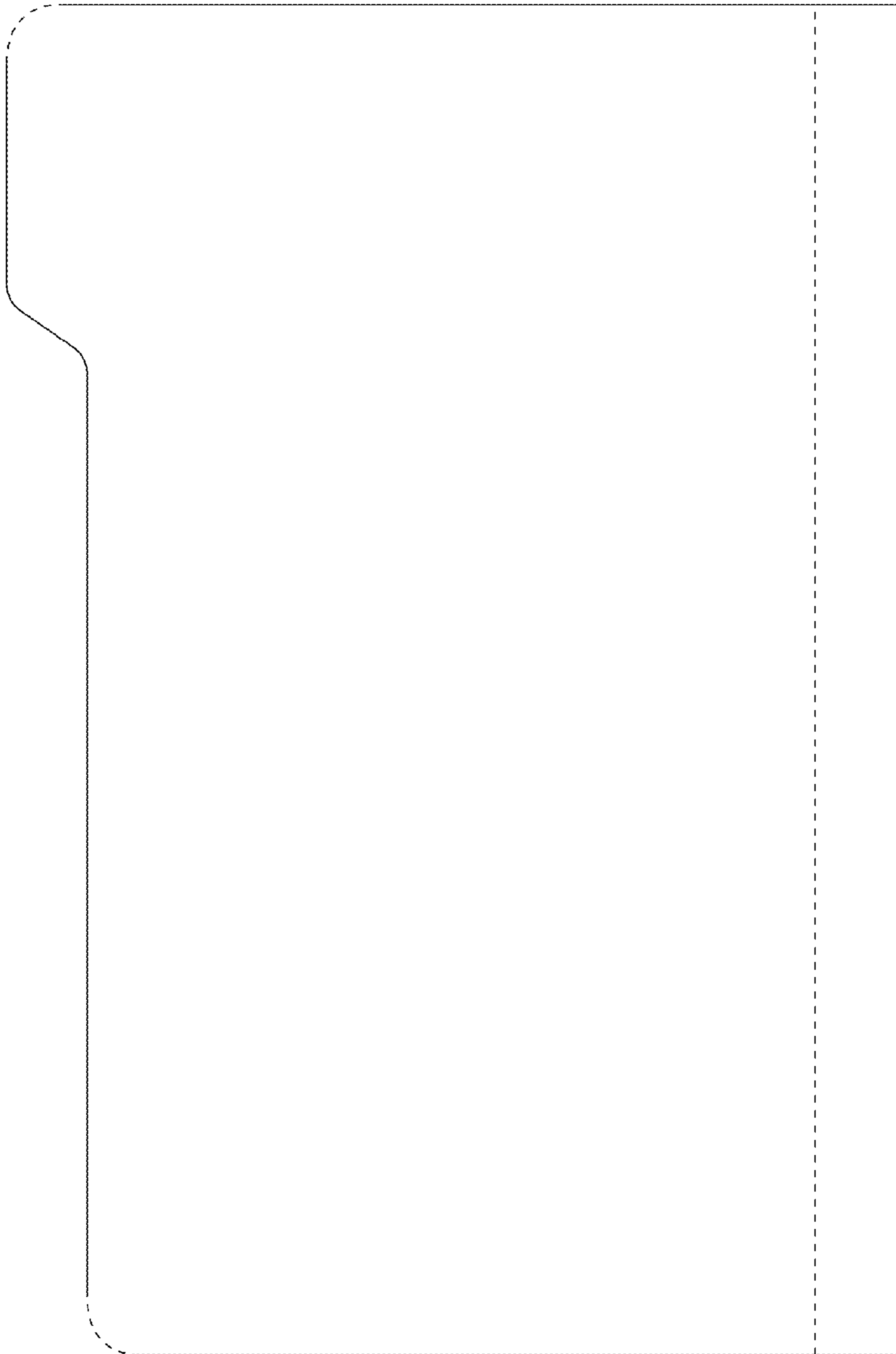

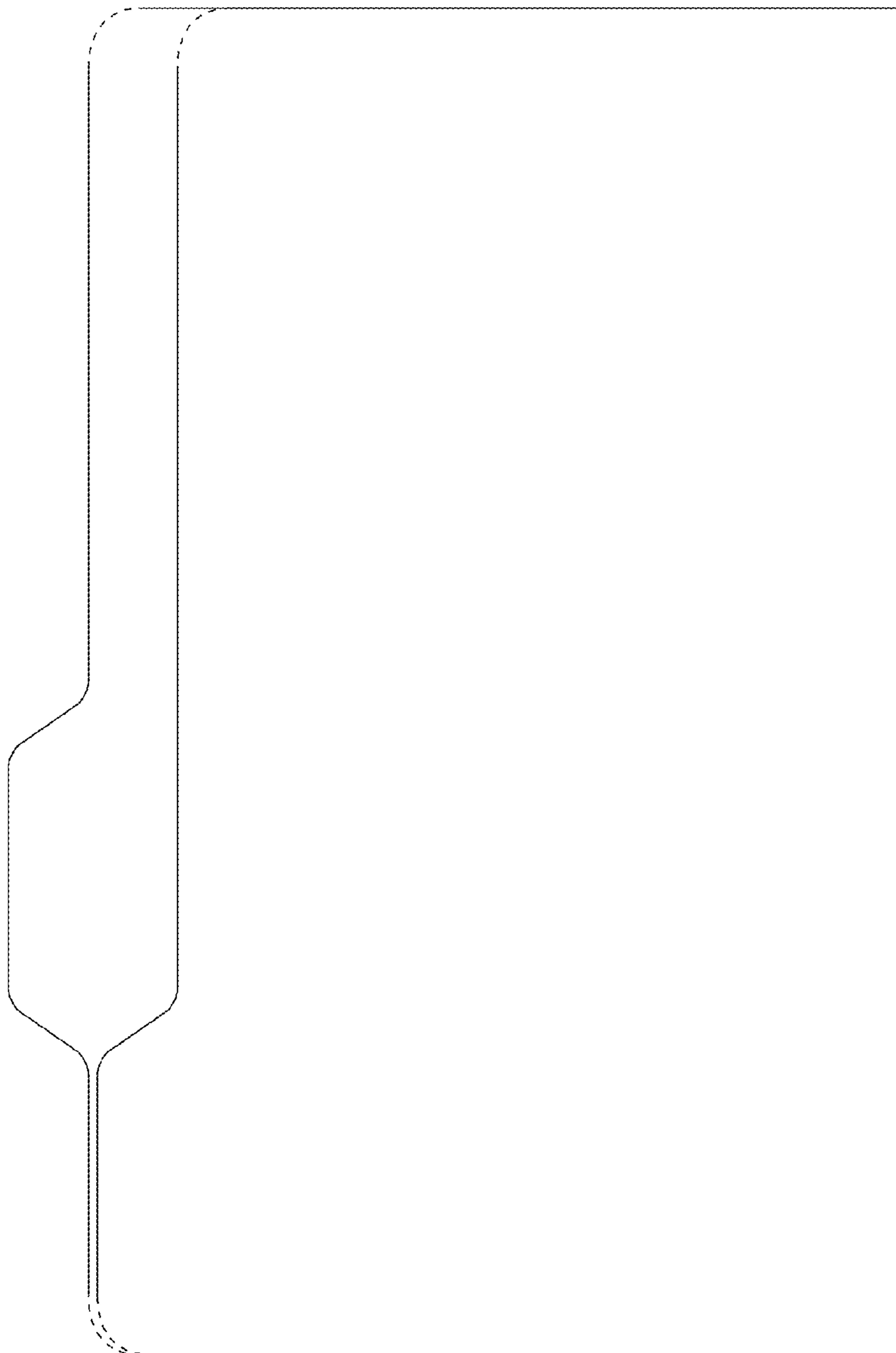

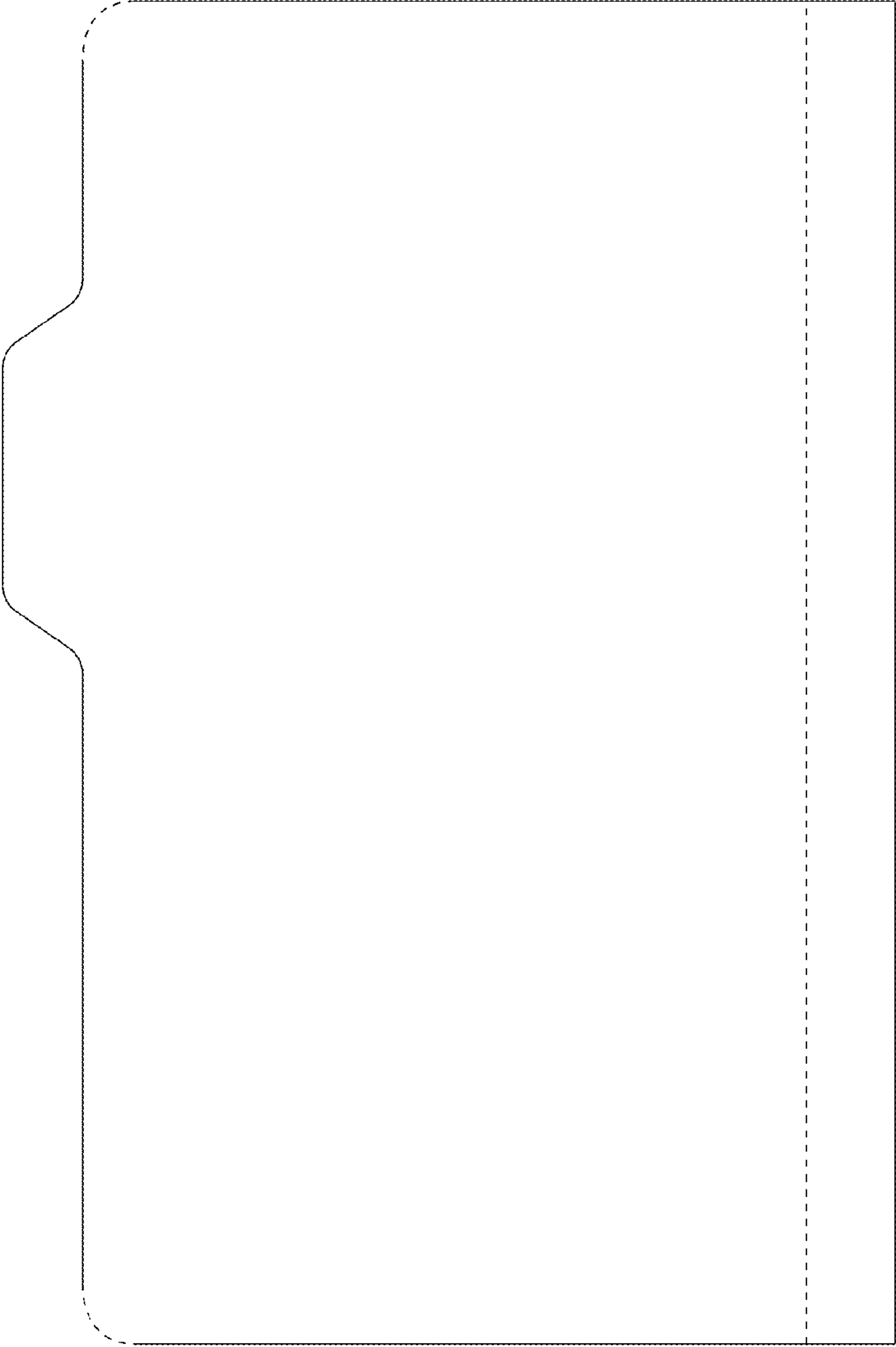

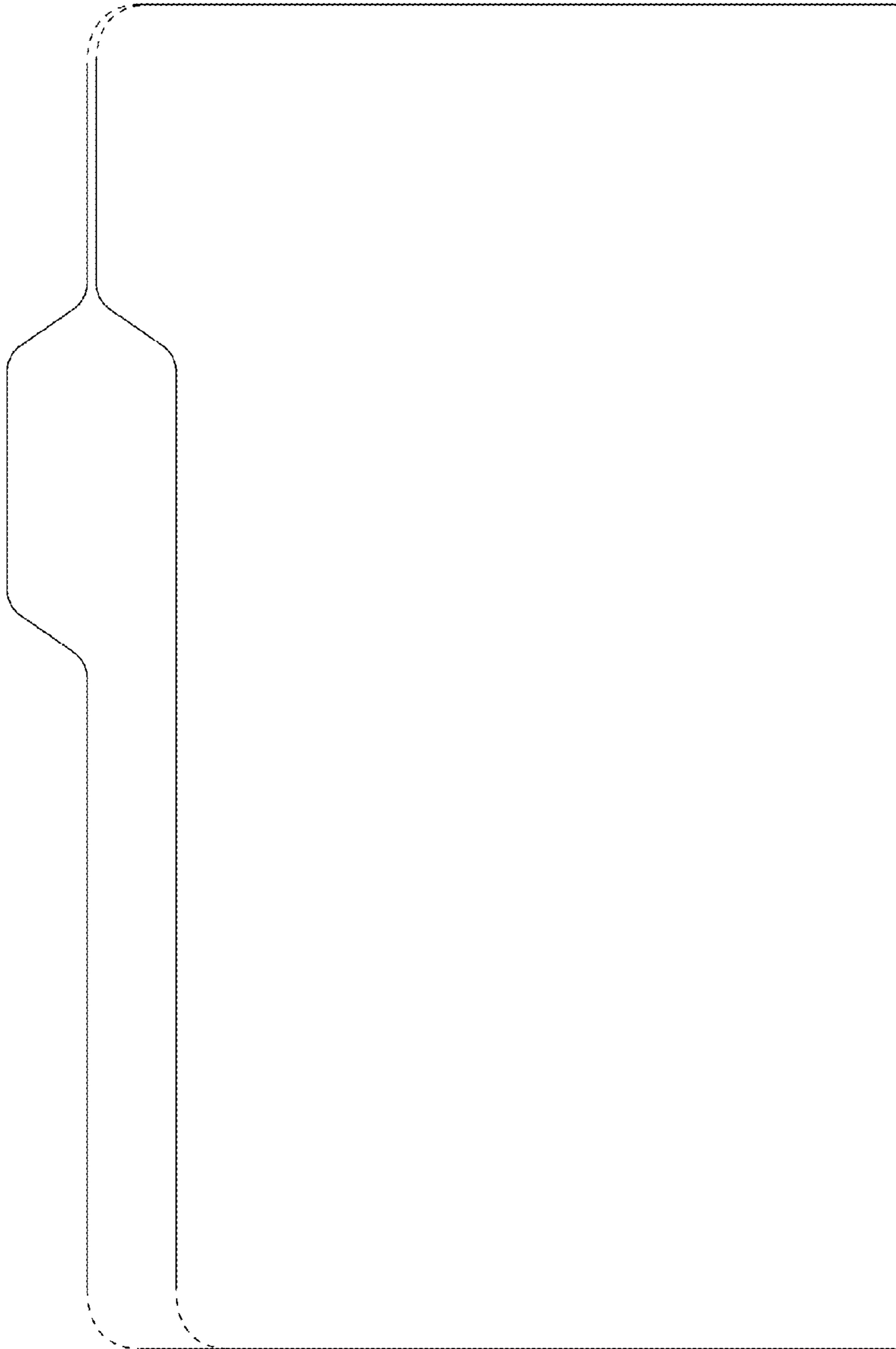

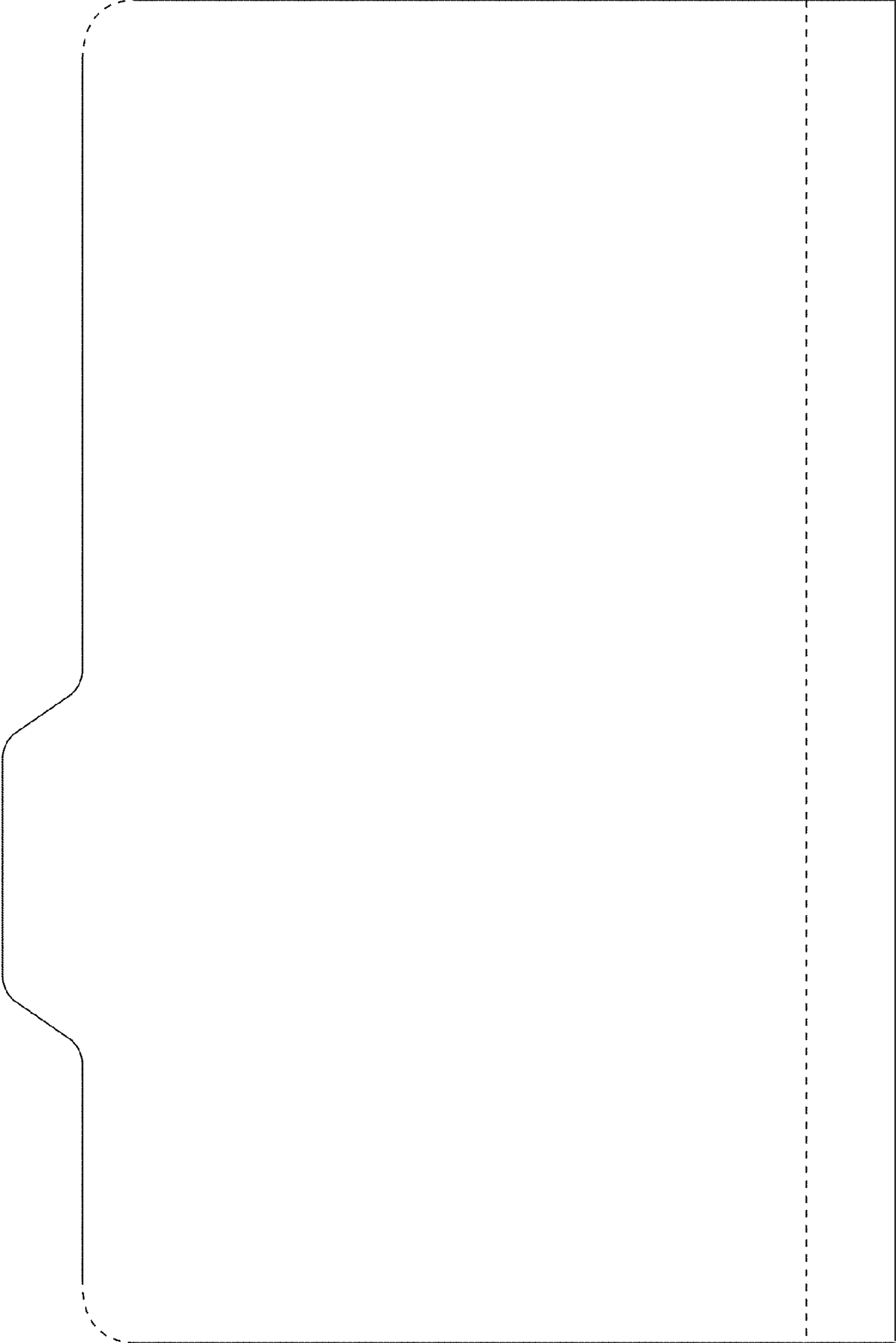

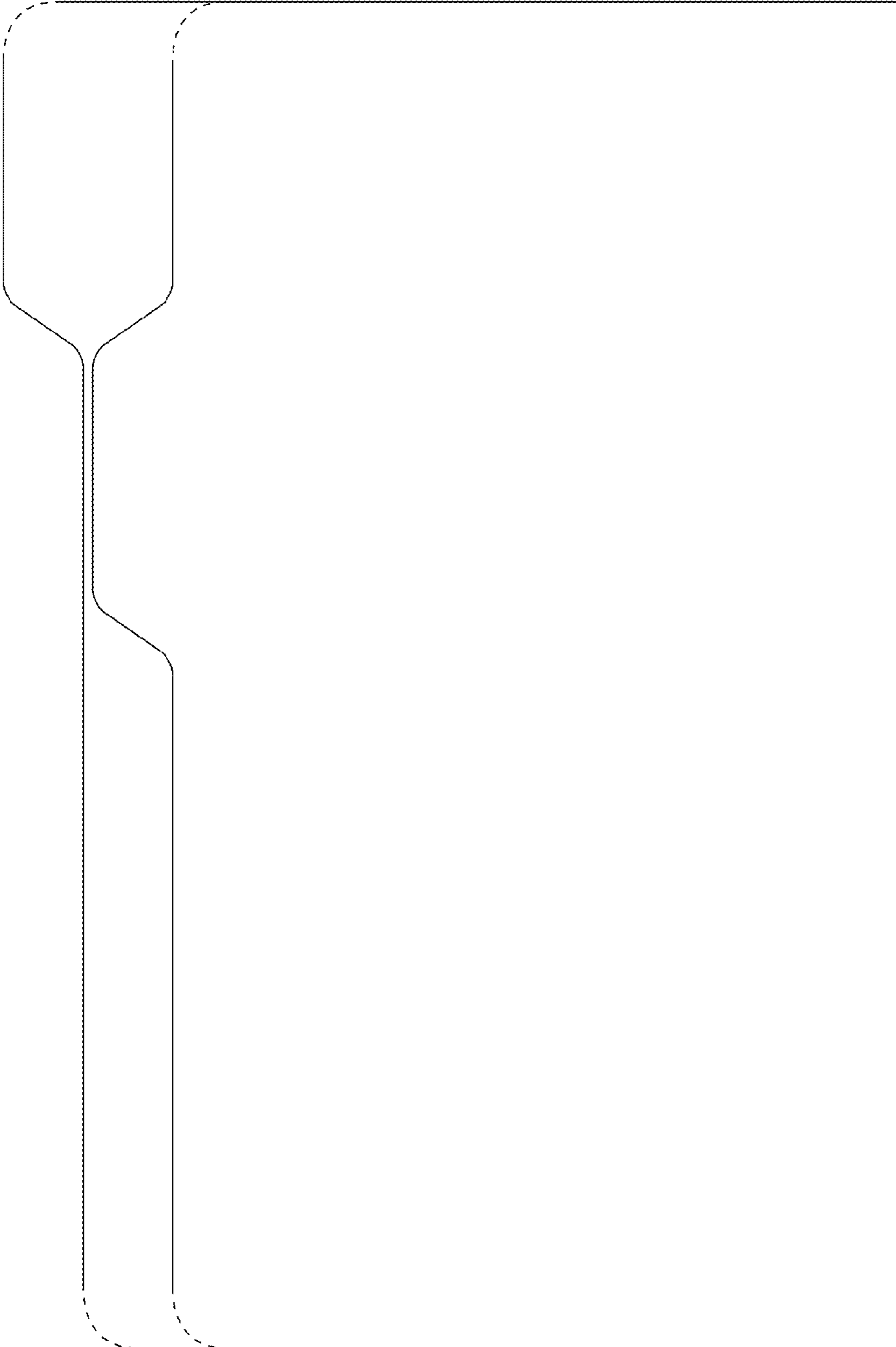

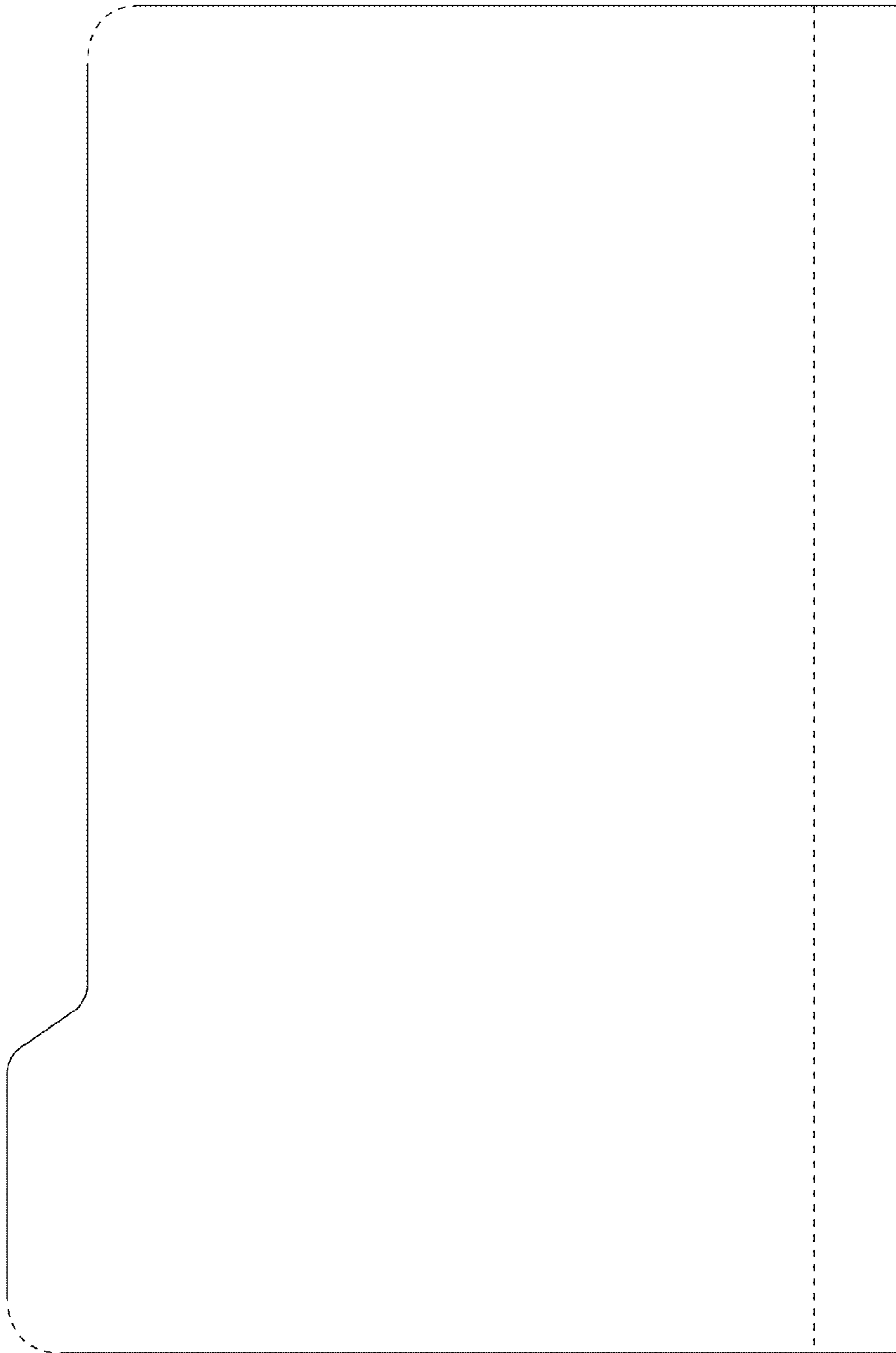

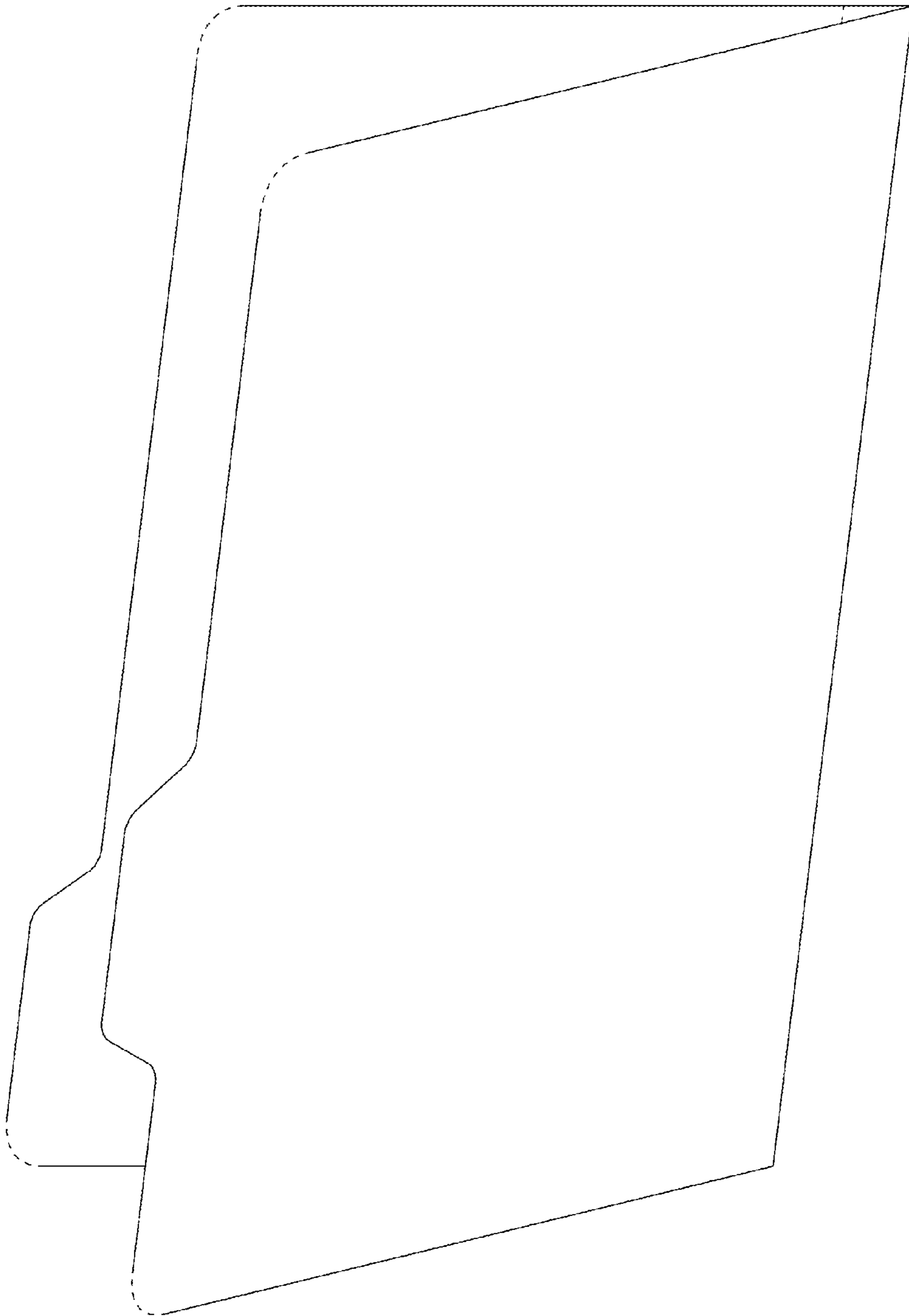

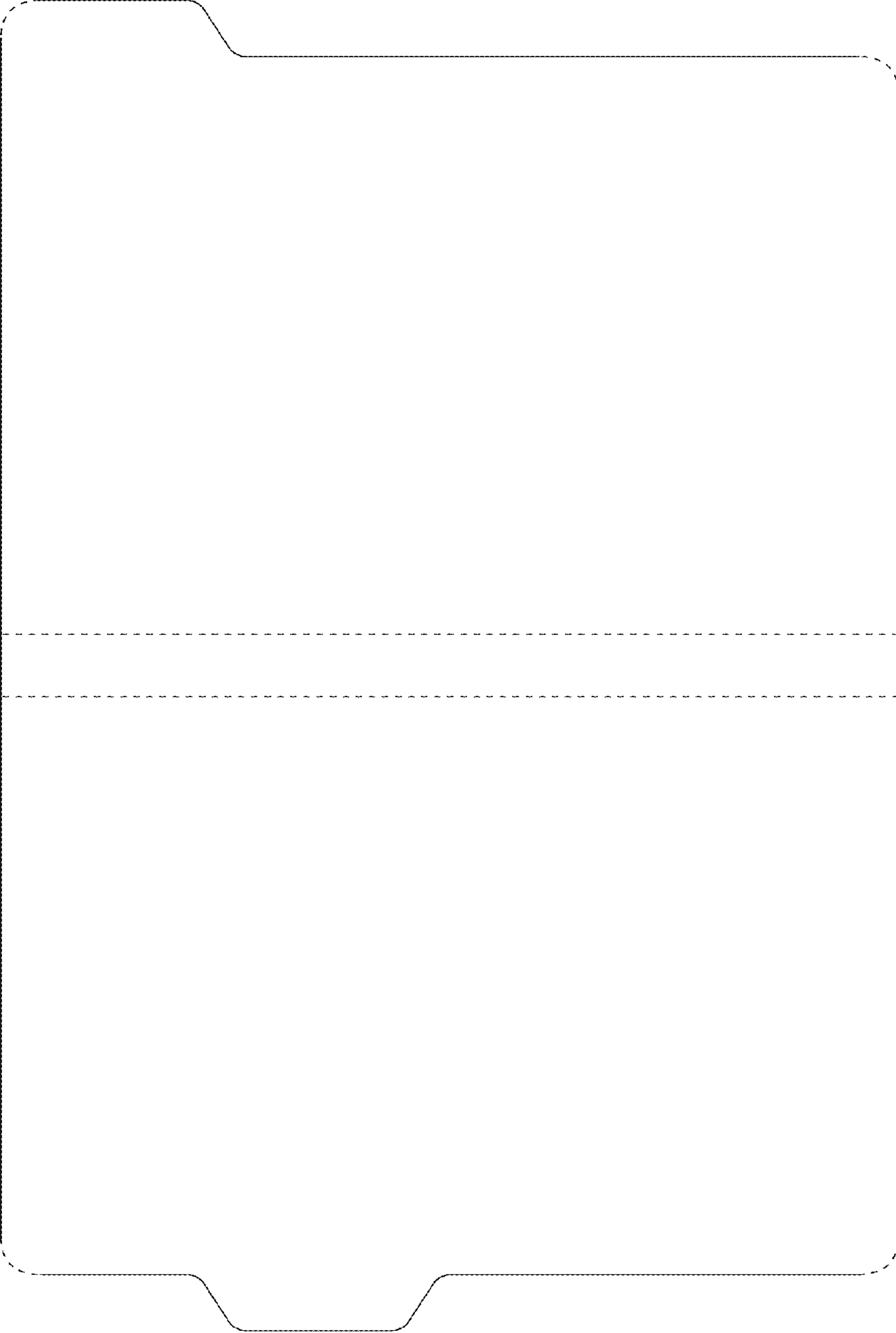

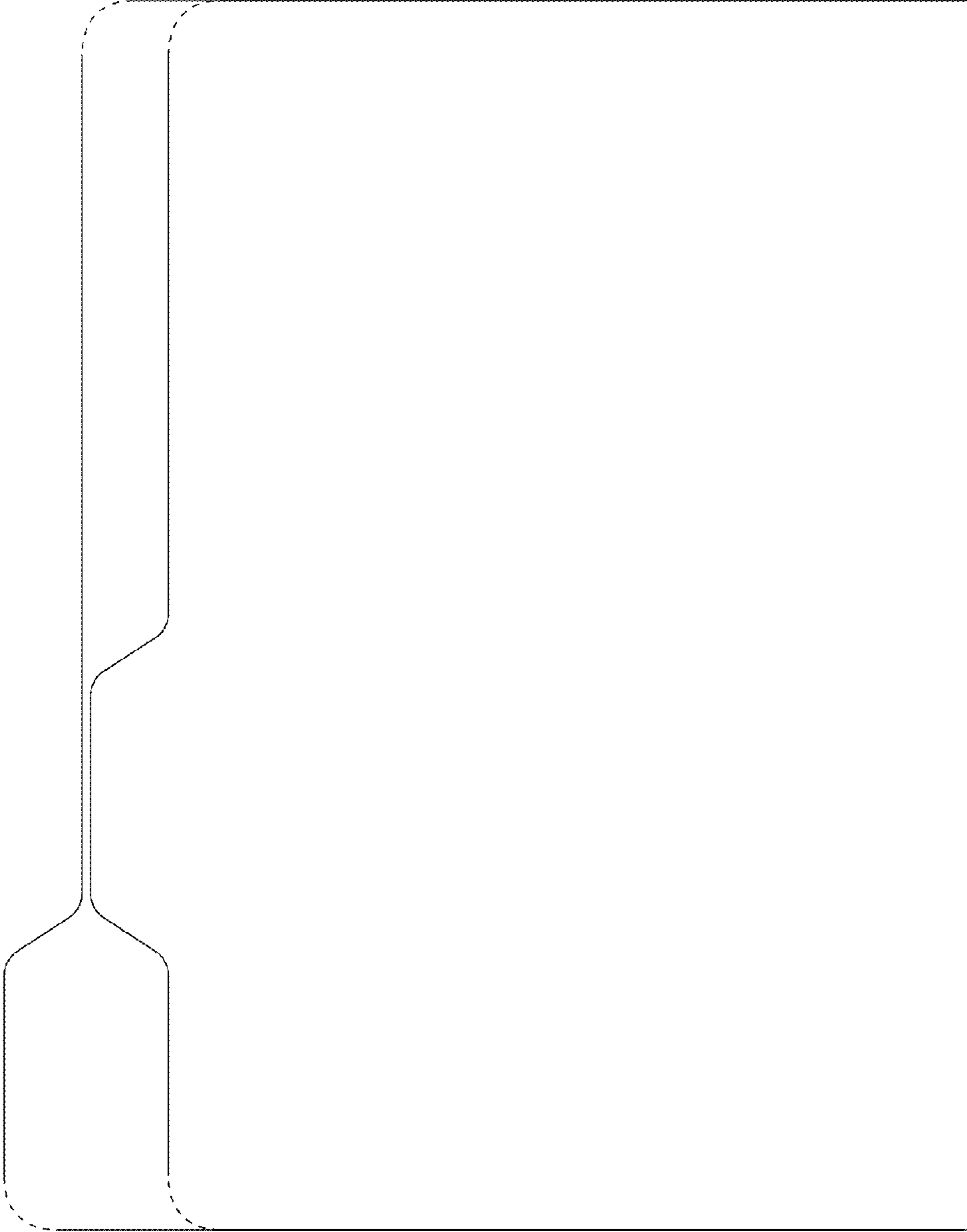

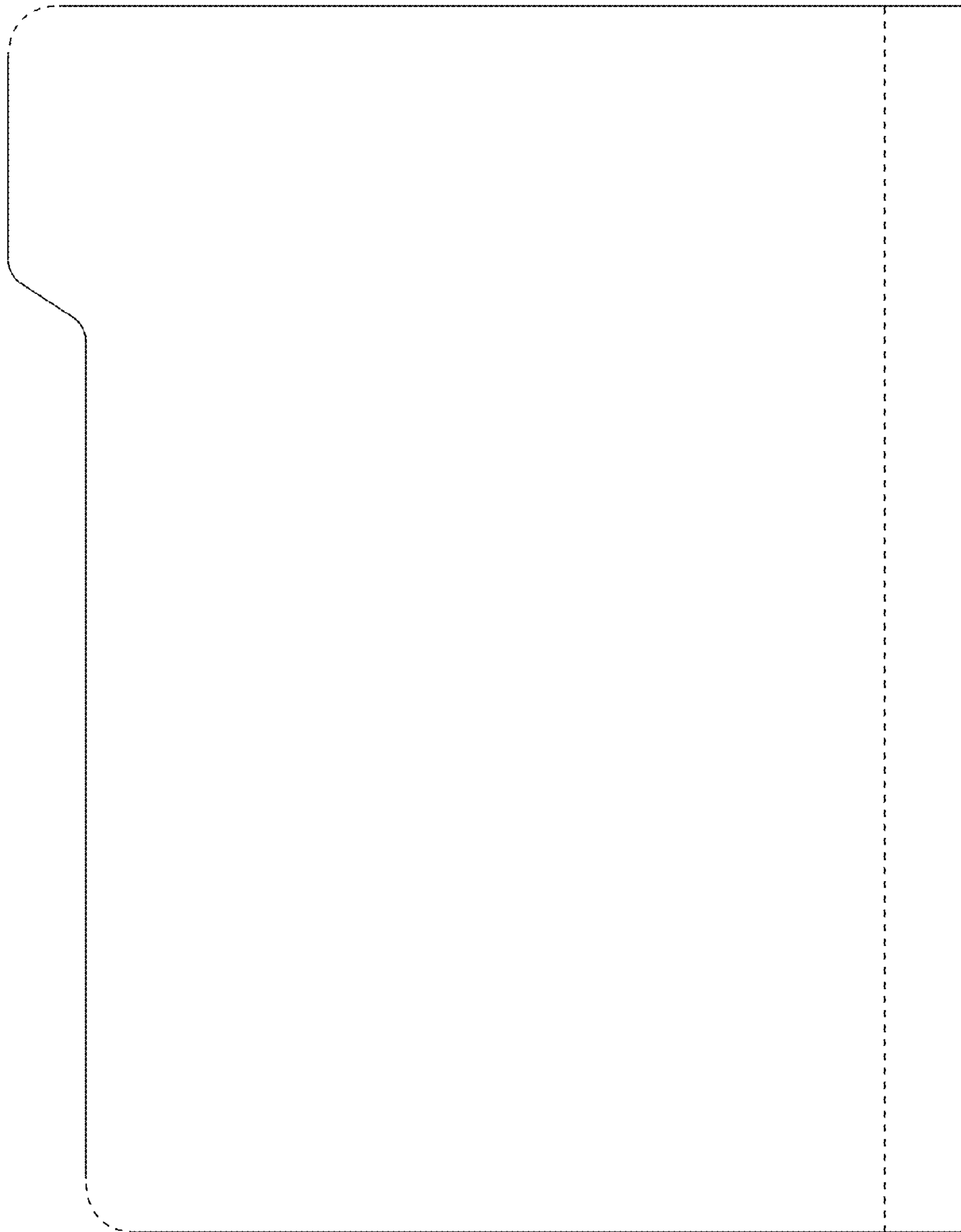

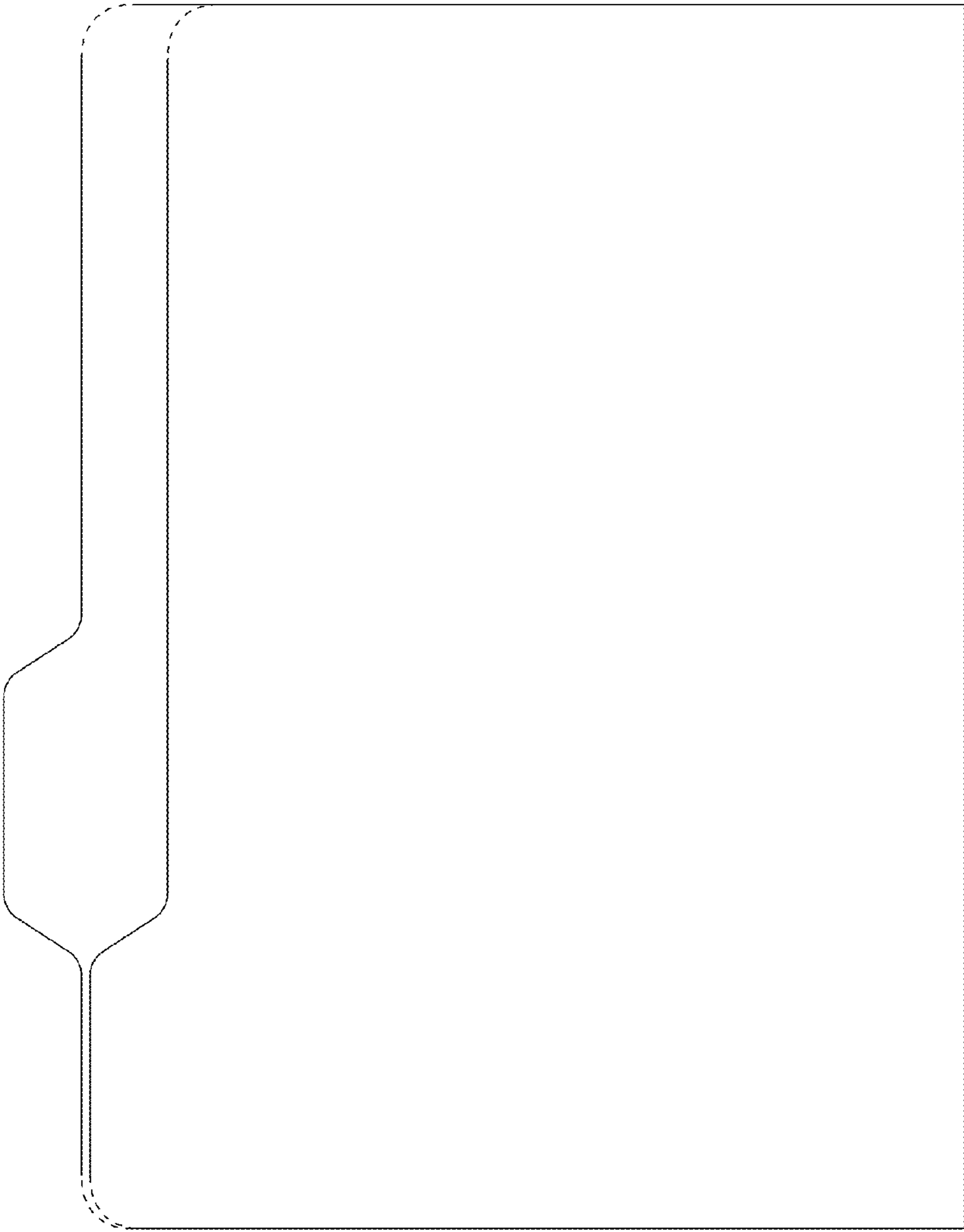

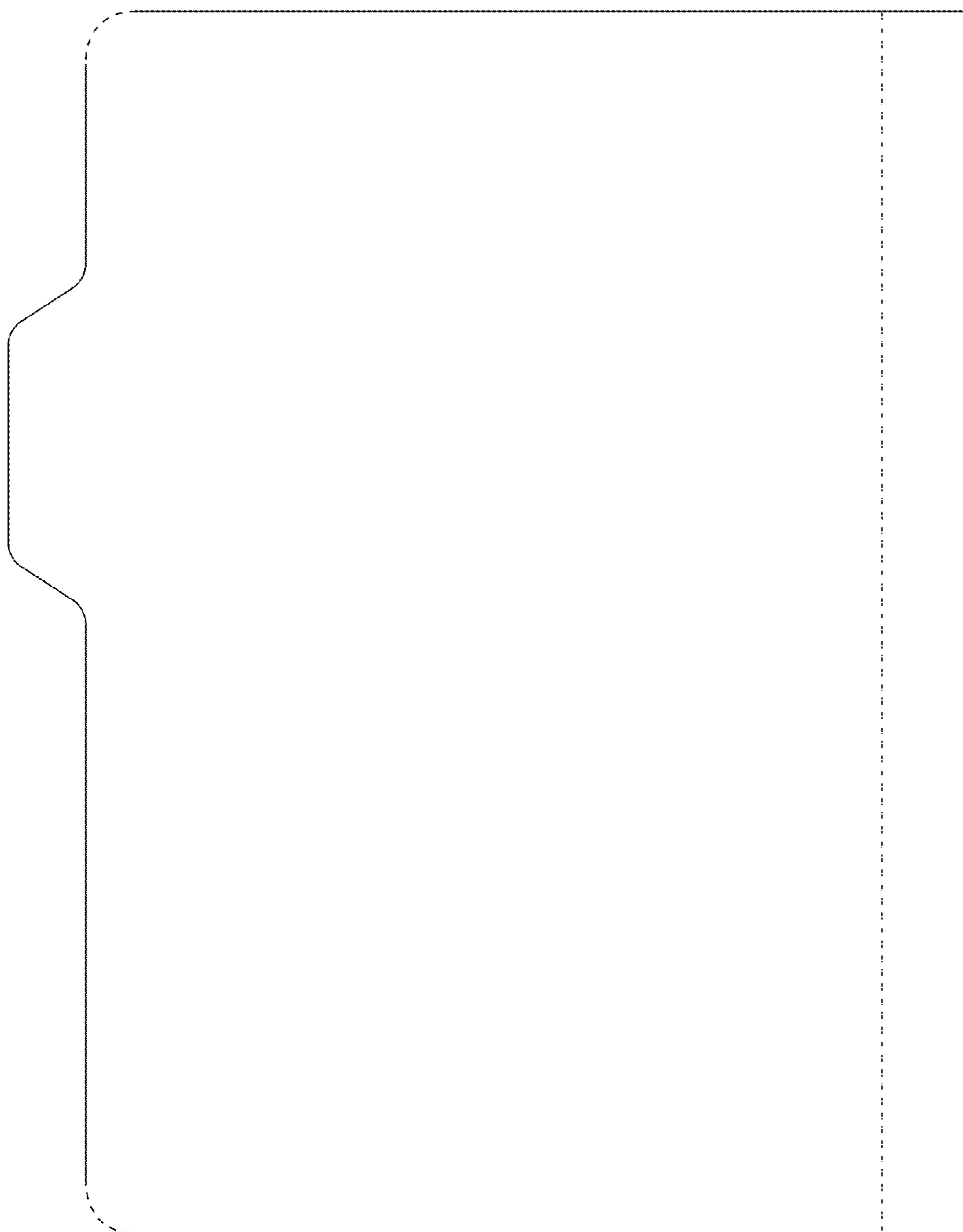

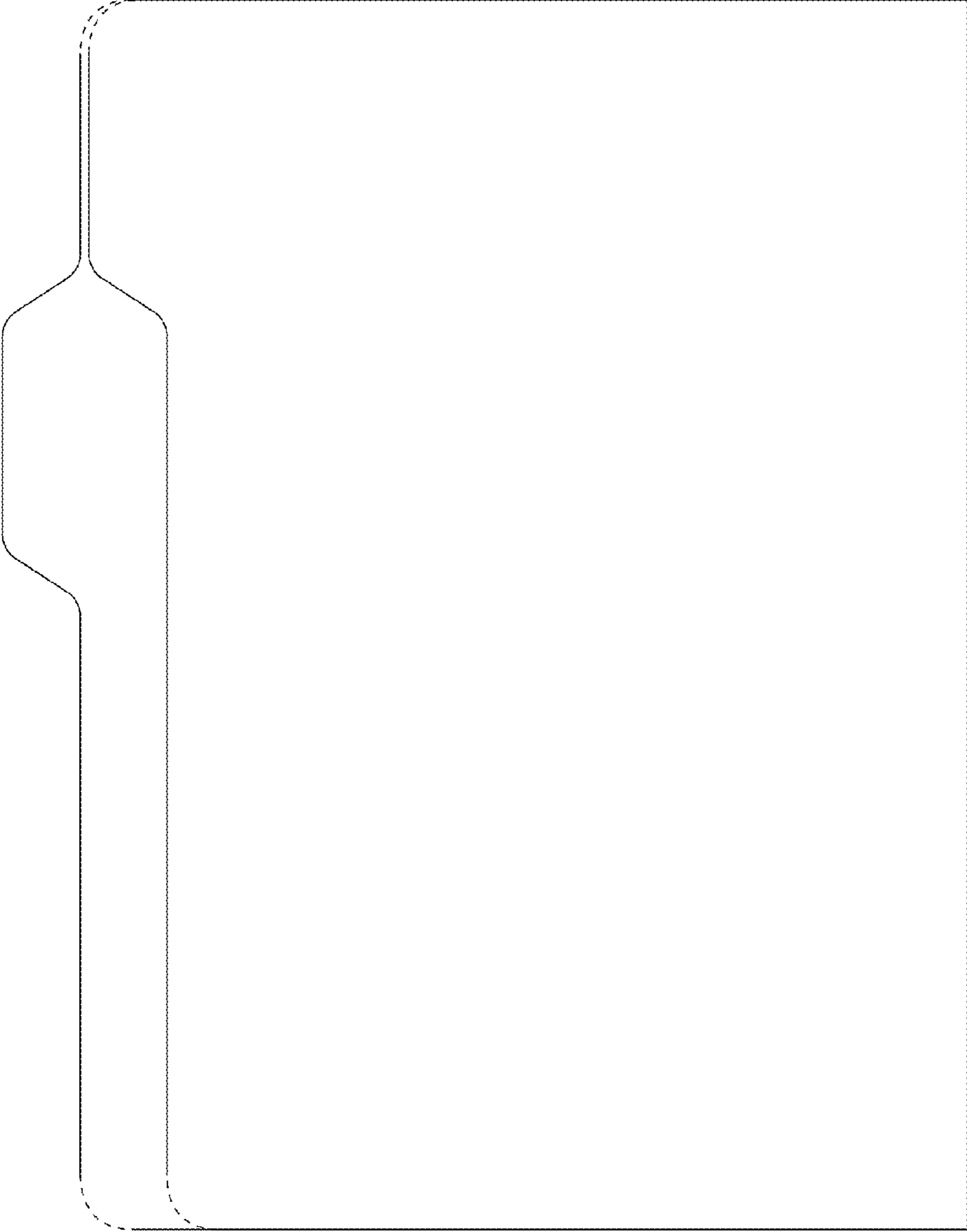

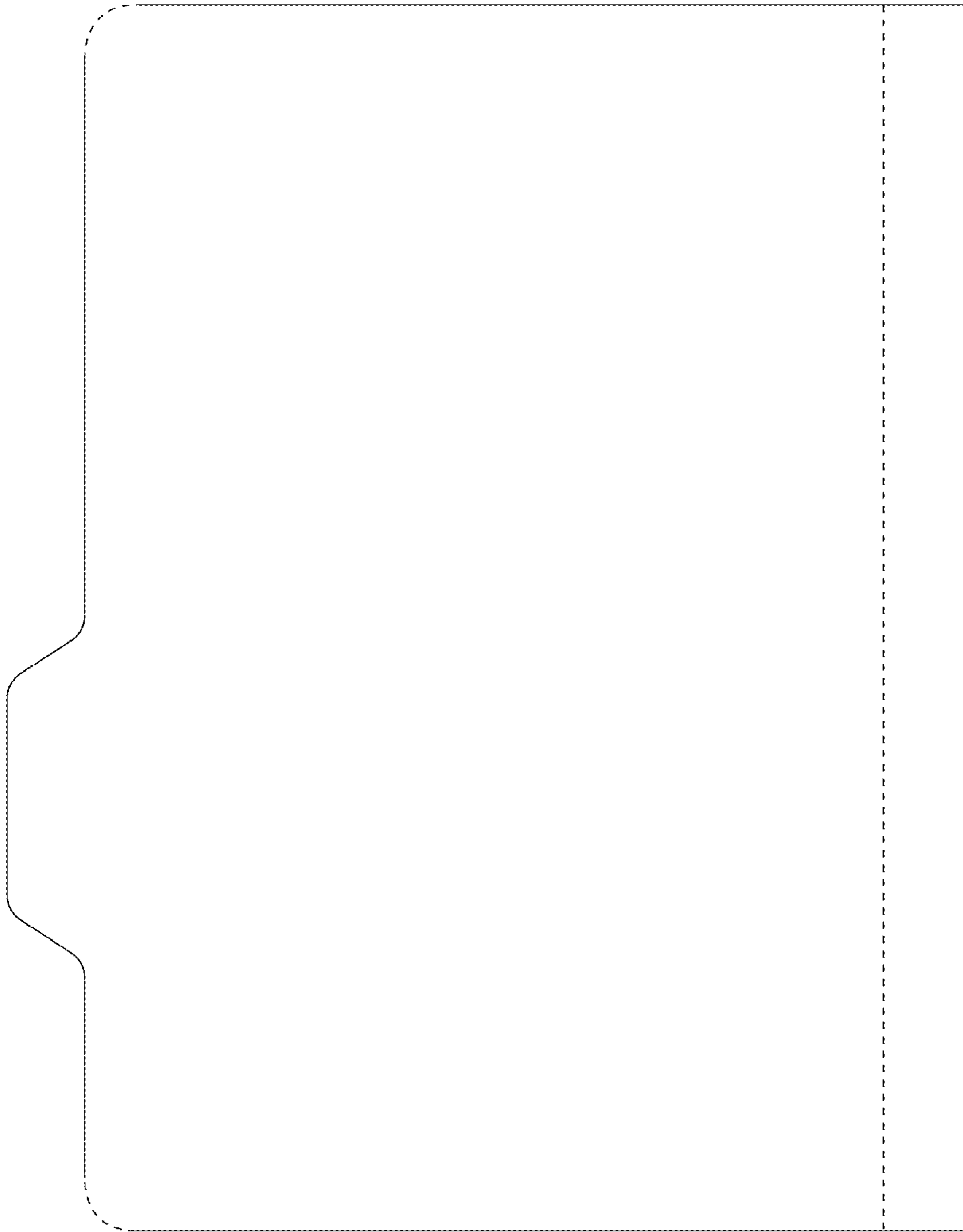

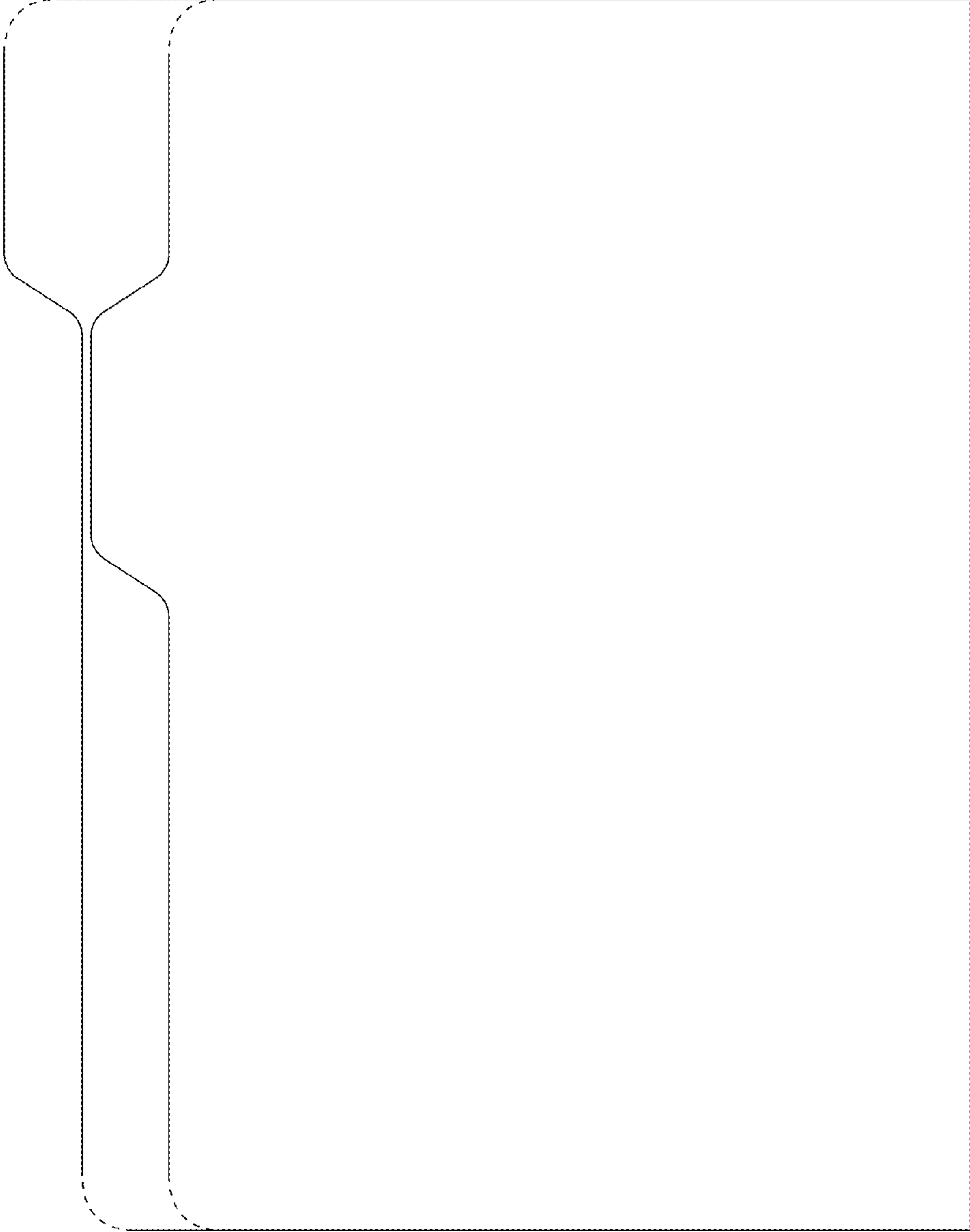

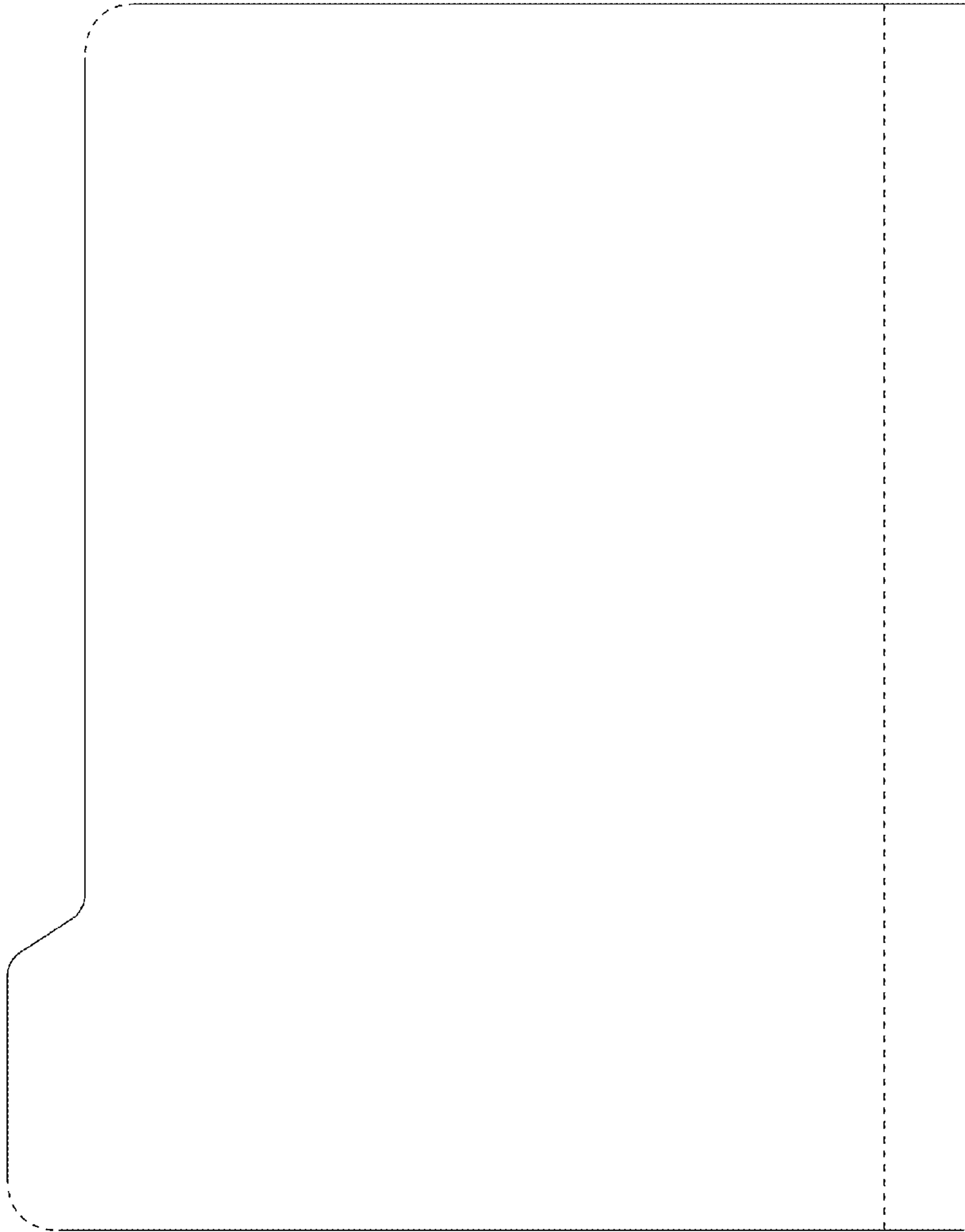

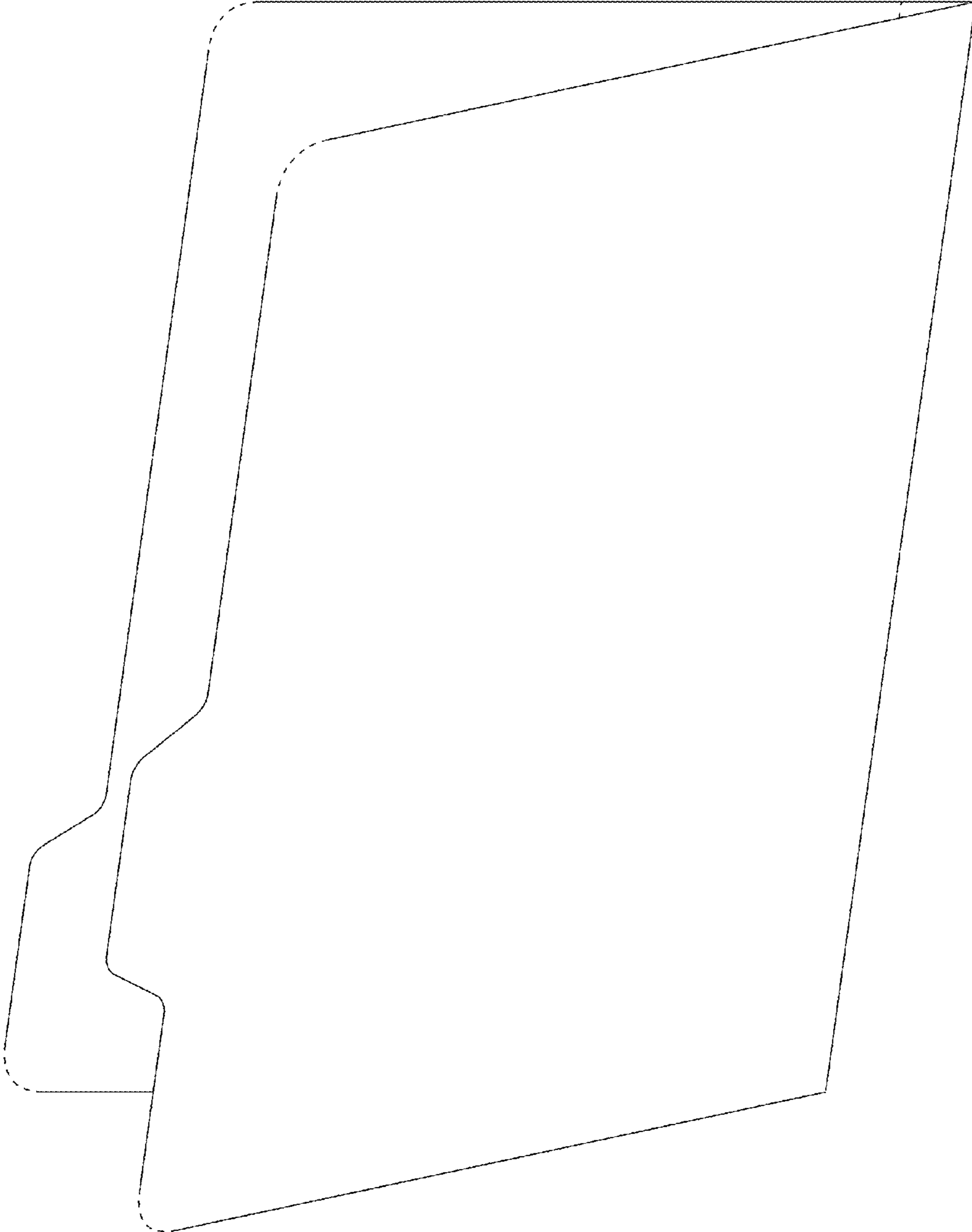
