FIG. 5 shows a bottom plan view thereof.

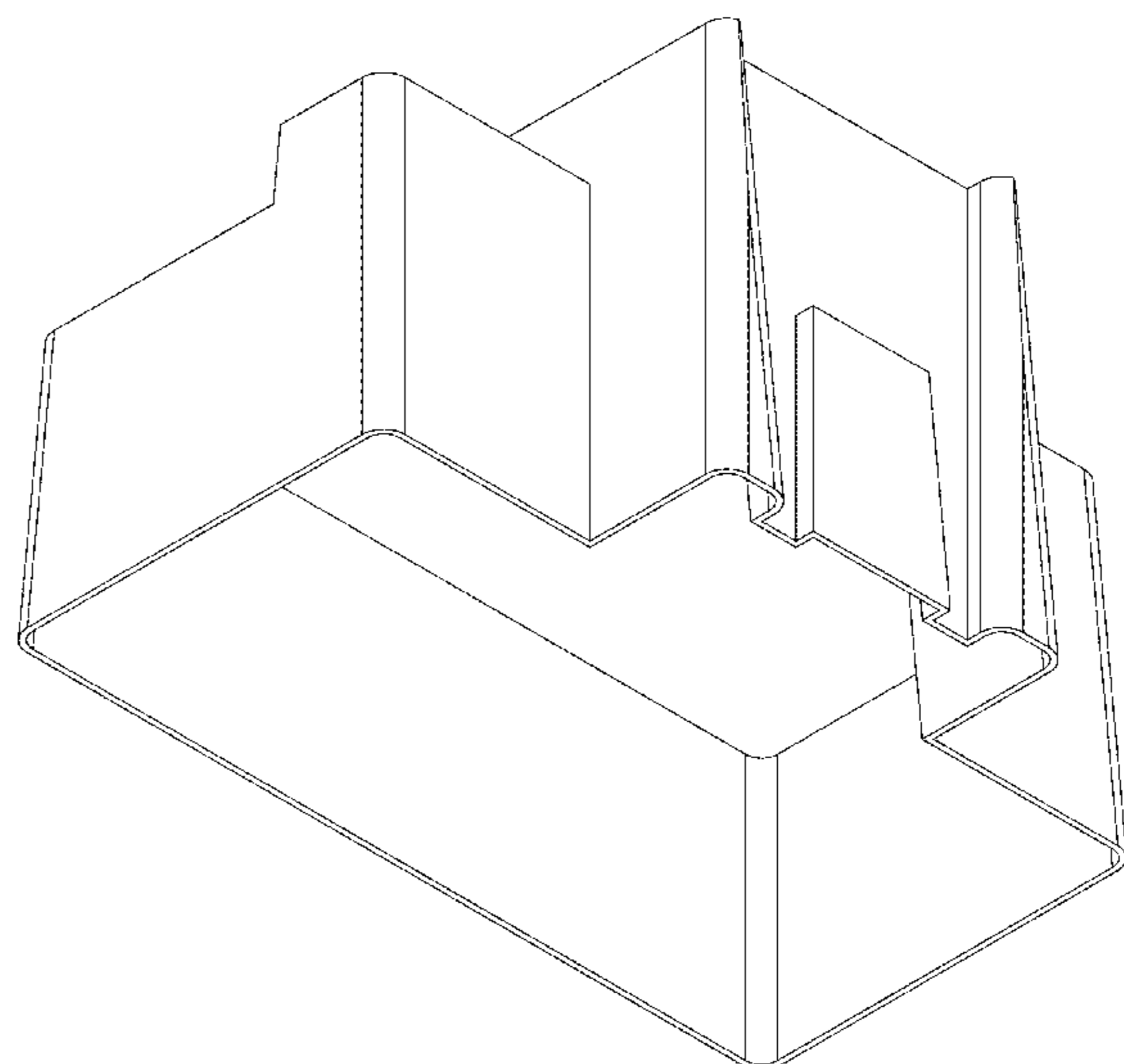
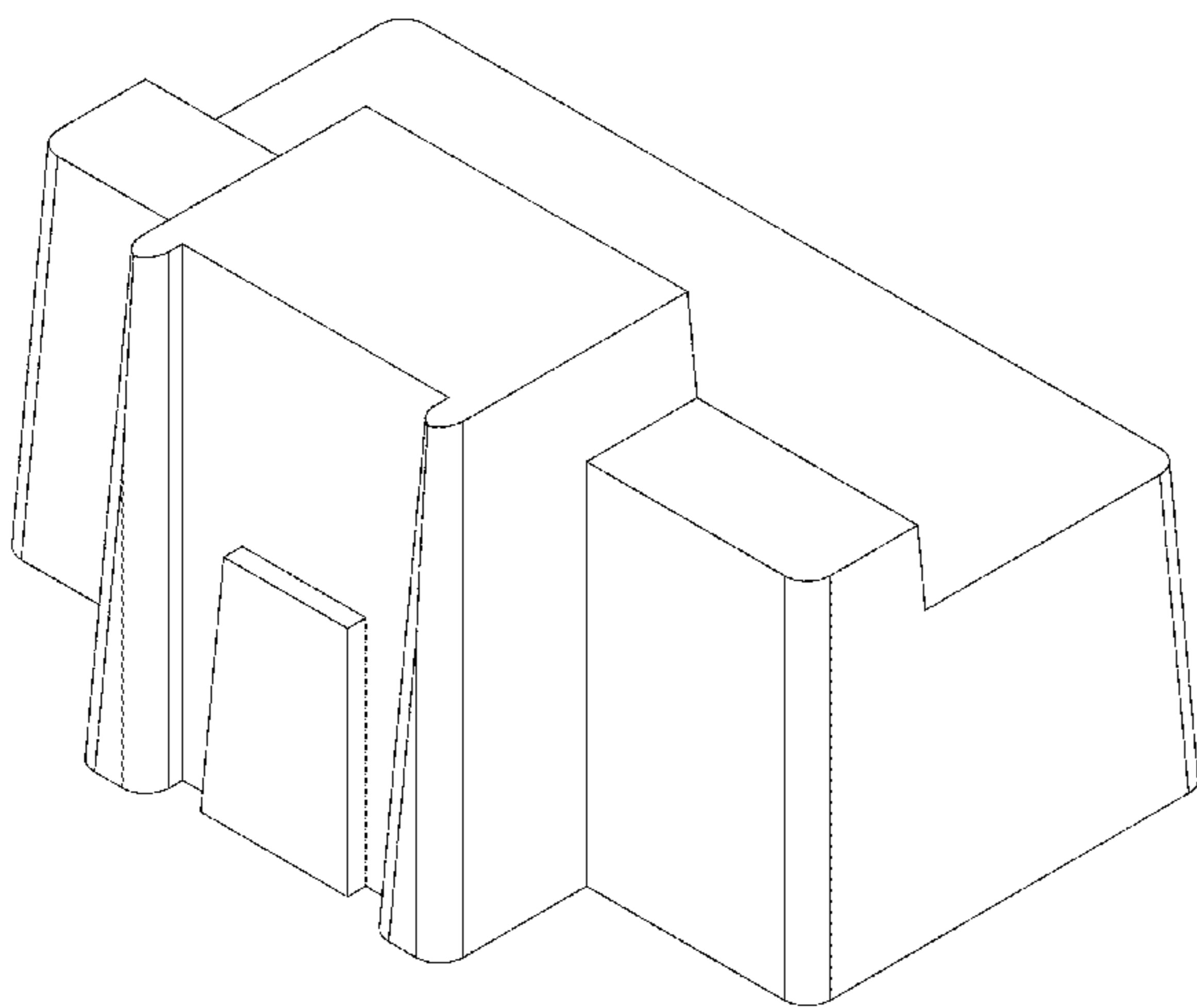
FIG. 6 shows a top, front and left perspective view thereof.

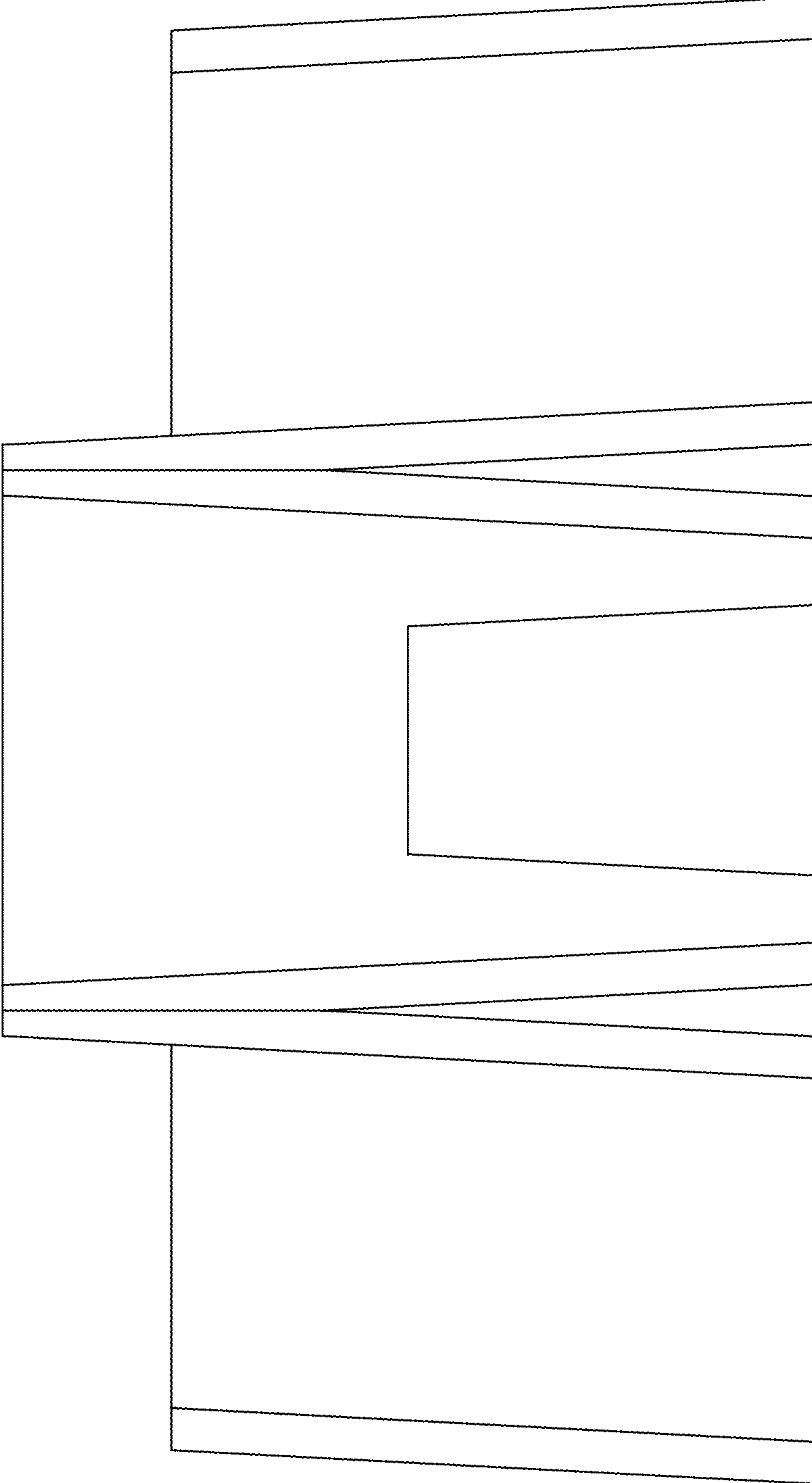

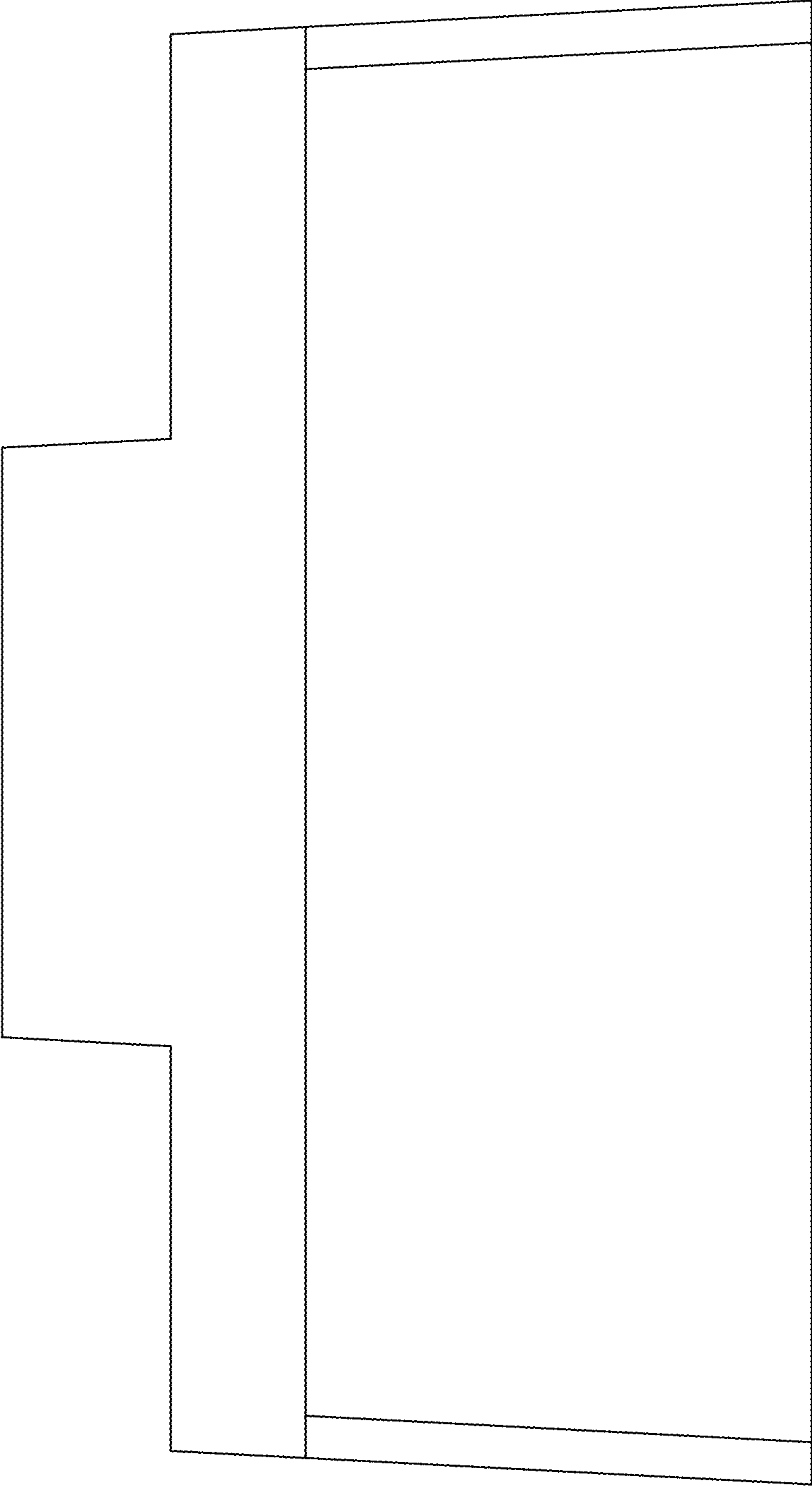

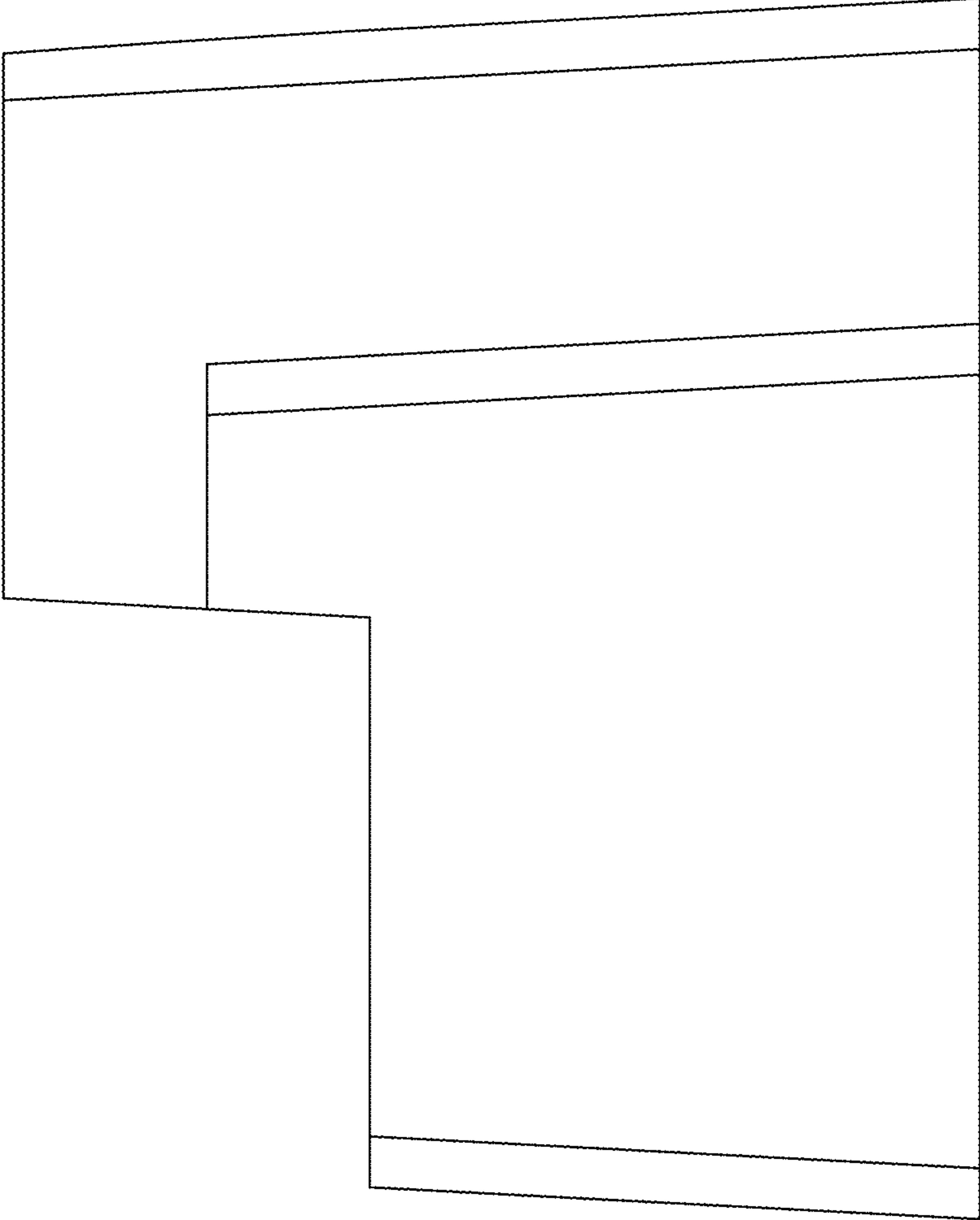

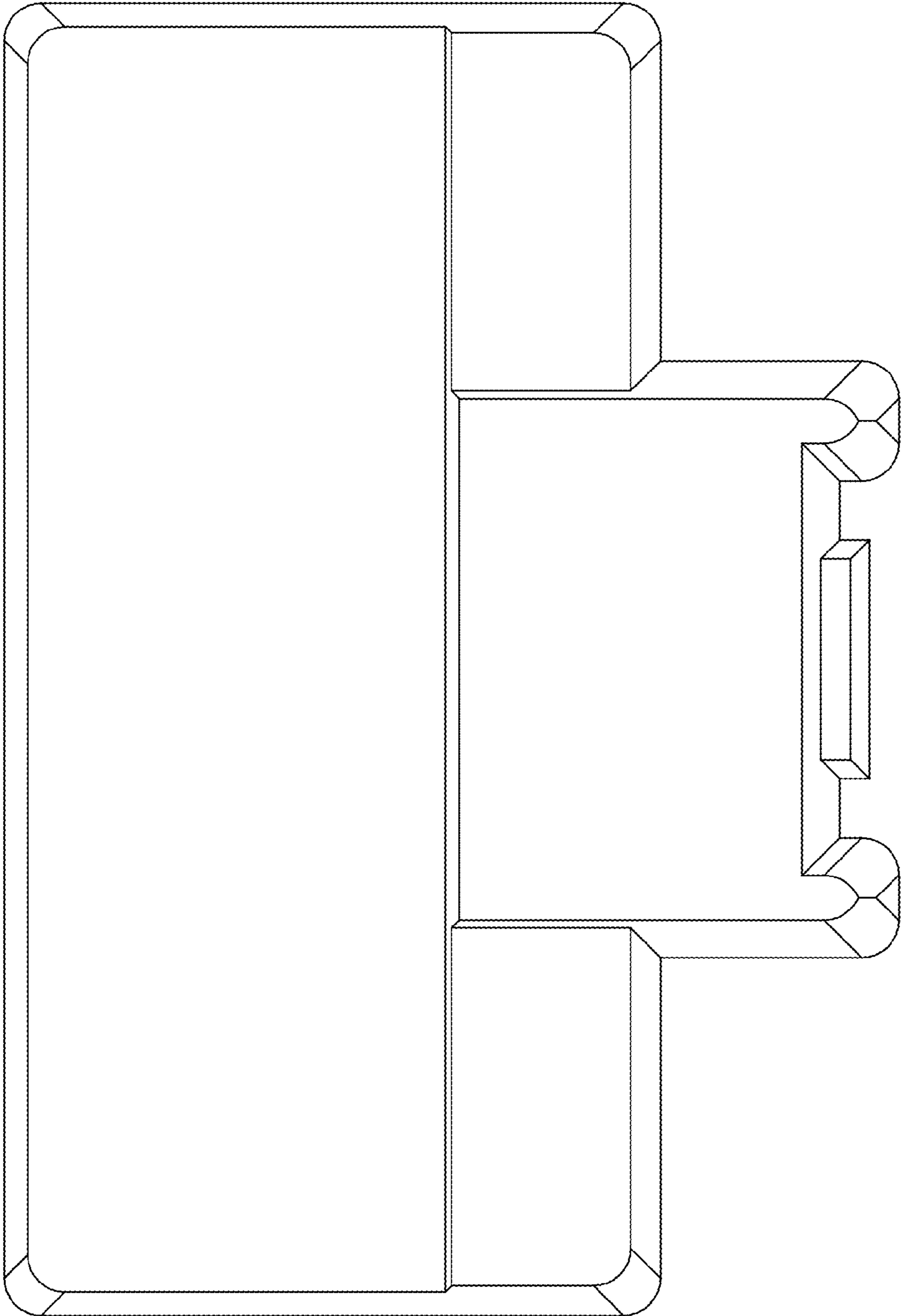

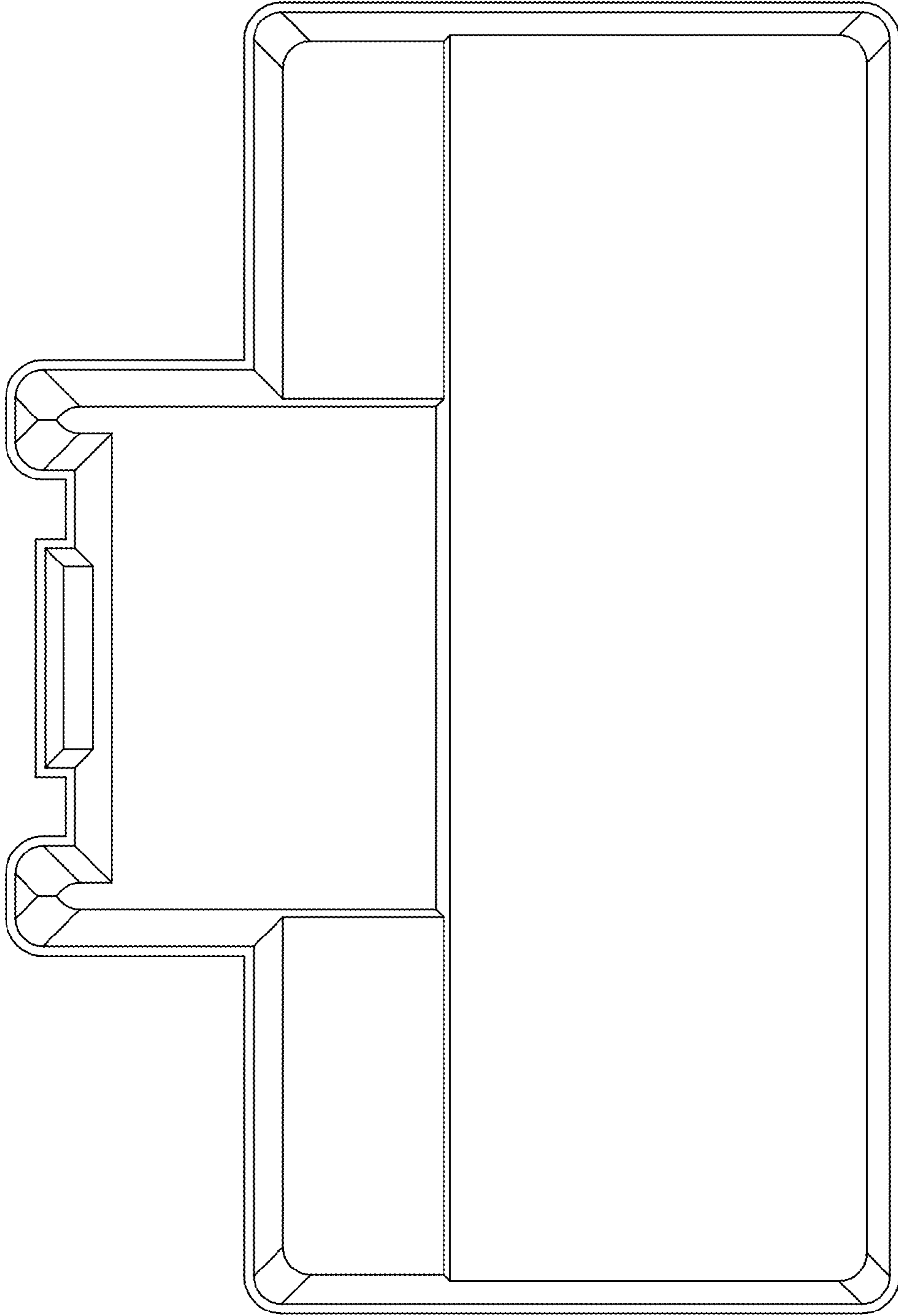

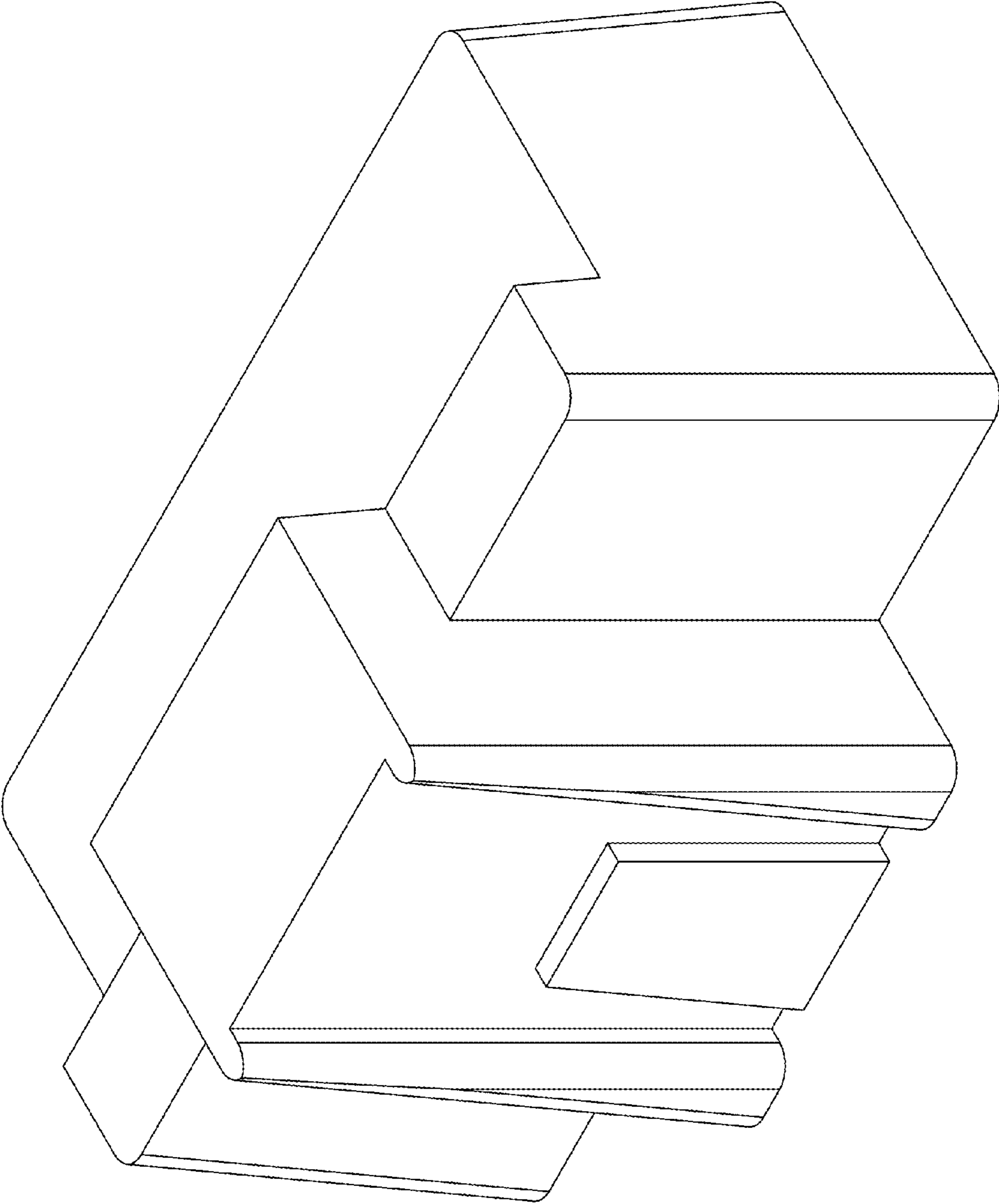

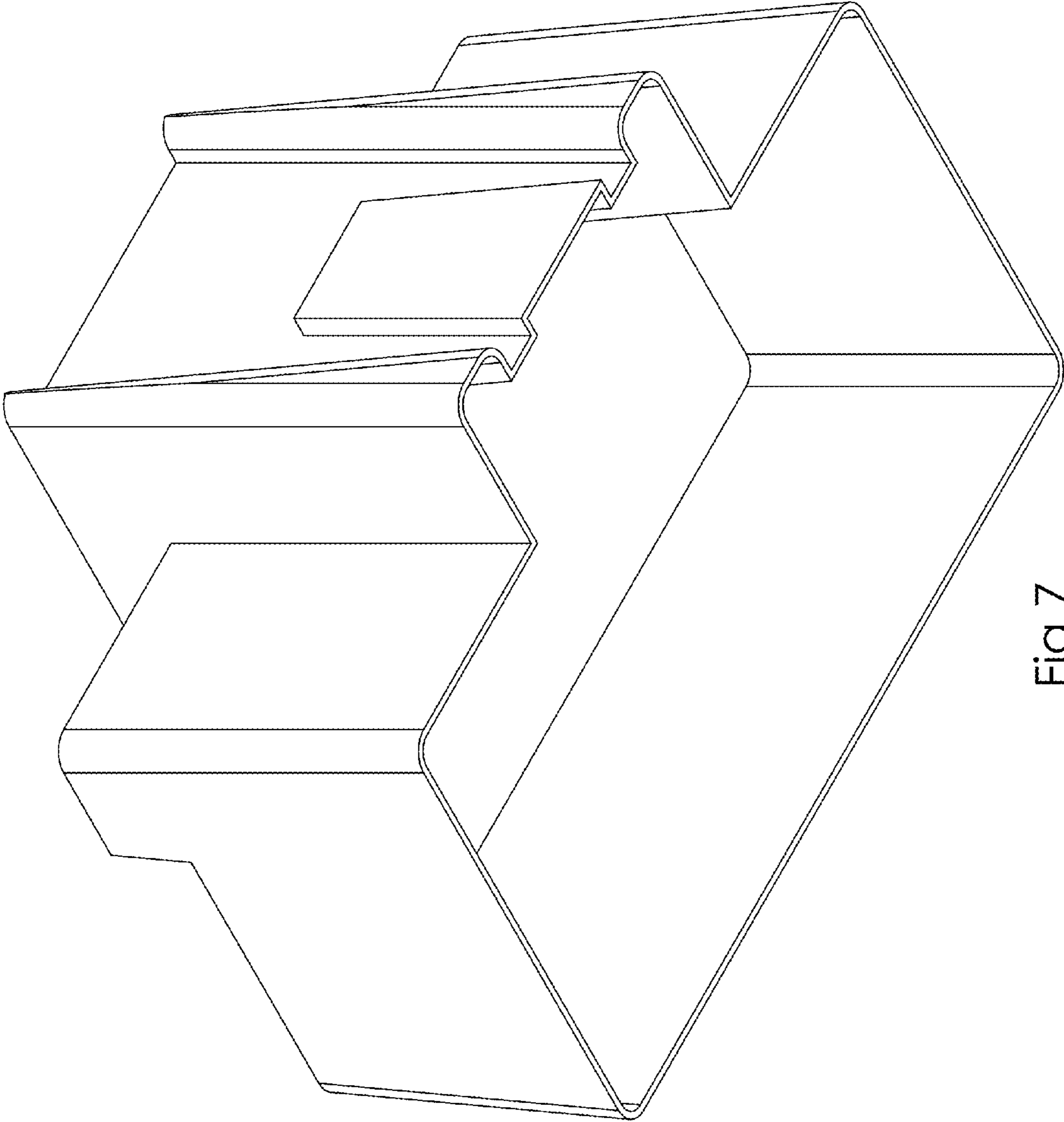

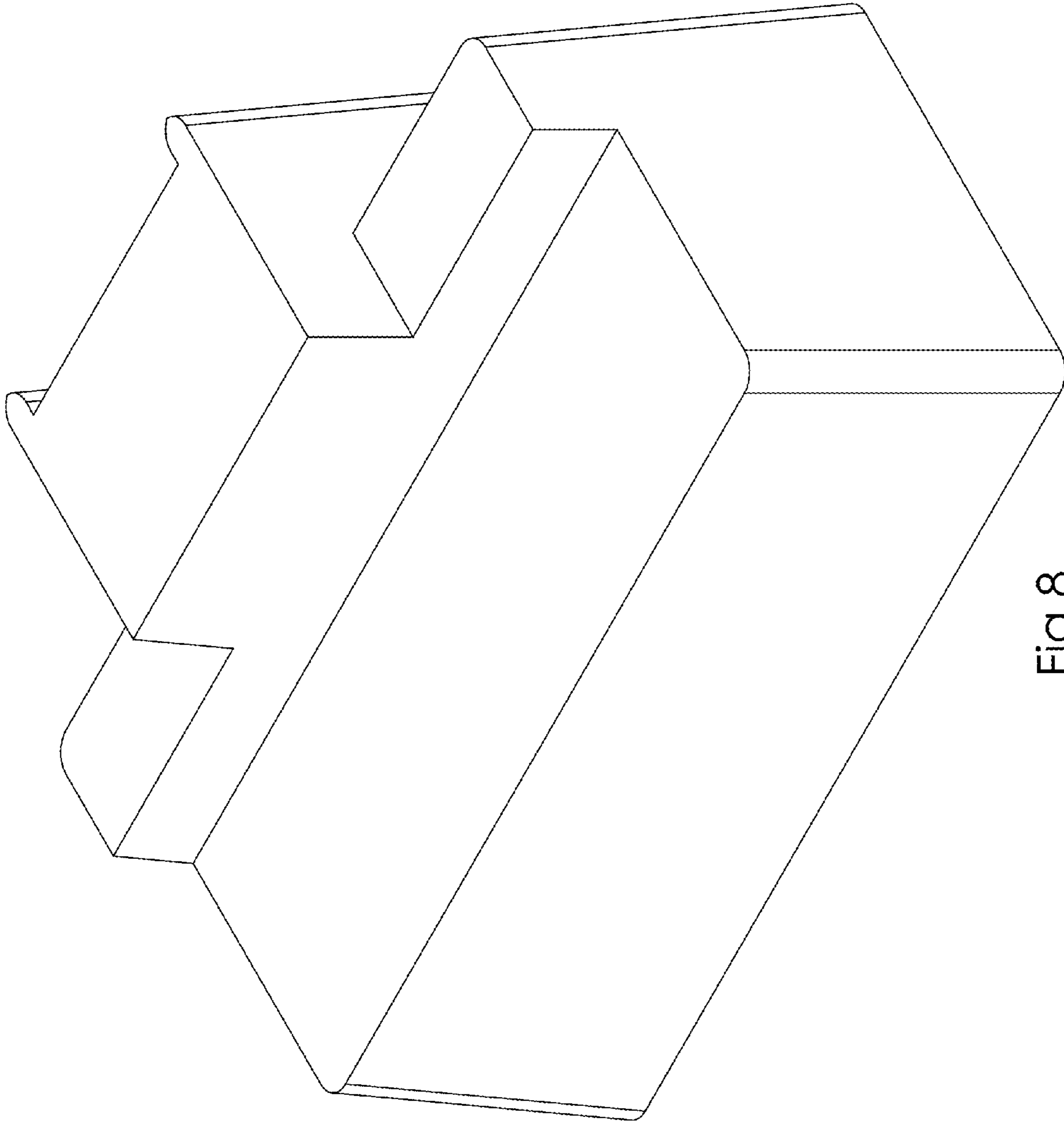

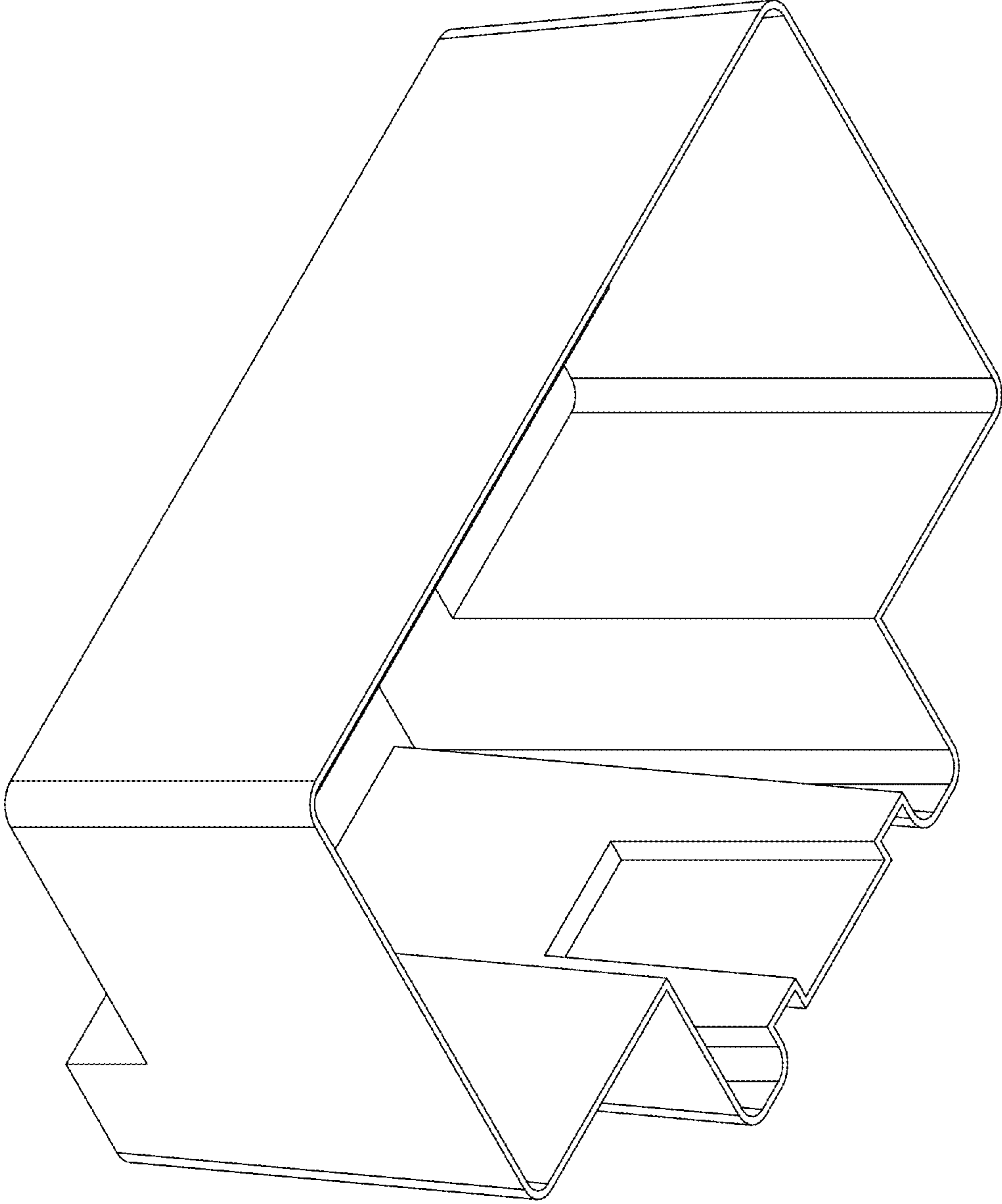
