(57) **CLAIM**

The ornamental design for a thick grip adapter for fitness apparatuses, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a thick grip adapter for fitness apparatuses of the present invention showing my new design; FIG. 2 is a left-side elevational view of FIG. 1, the right-side elevational view being a mirror image thereof; FIG. 3 is a top plan view of FIG. 1 thereof; and, FIG. 4 is a front elevational view of FIG. 1, the rear elevational view and the bottom plan view are identical.

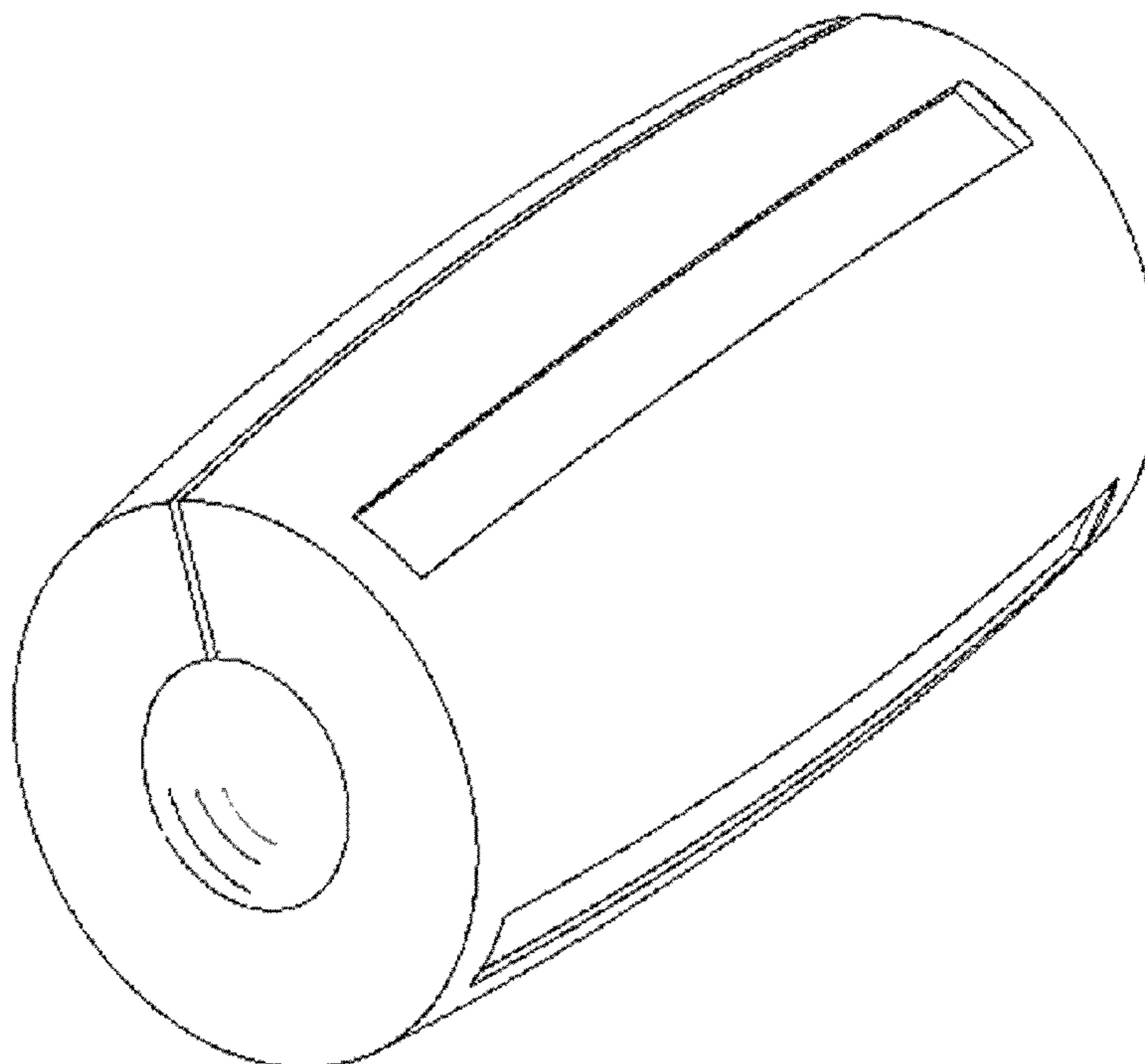
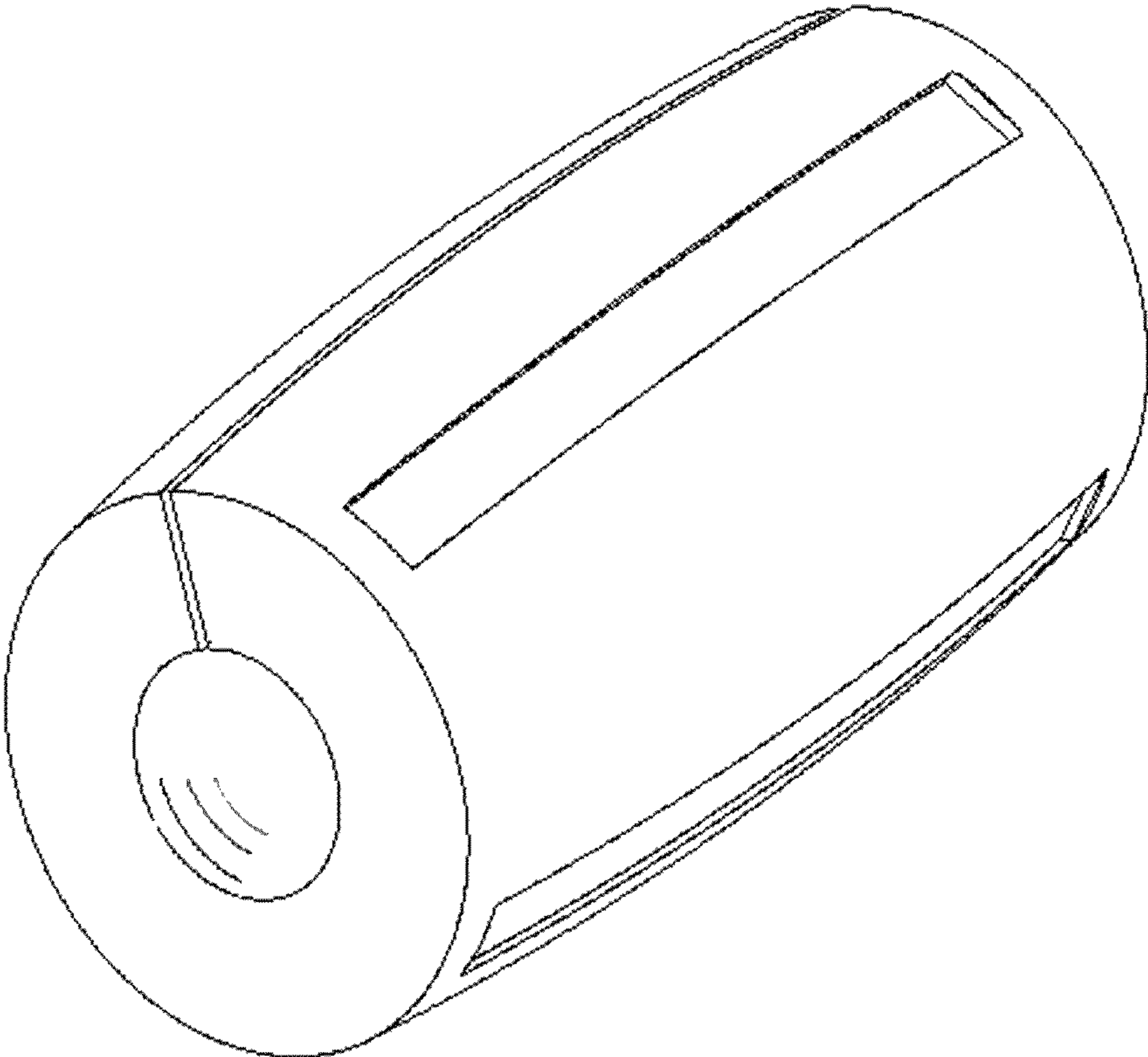
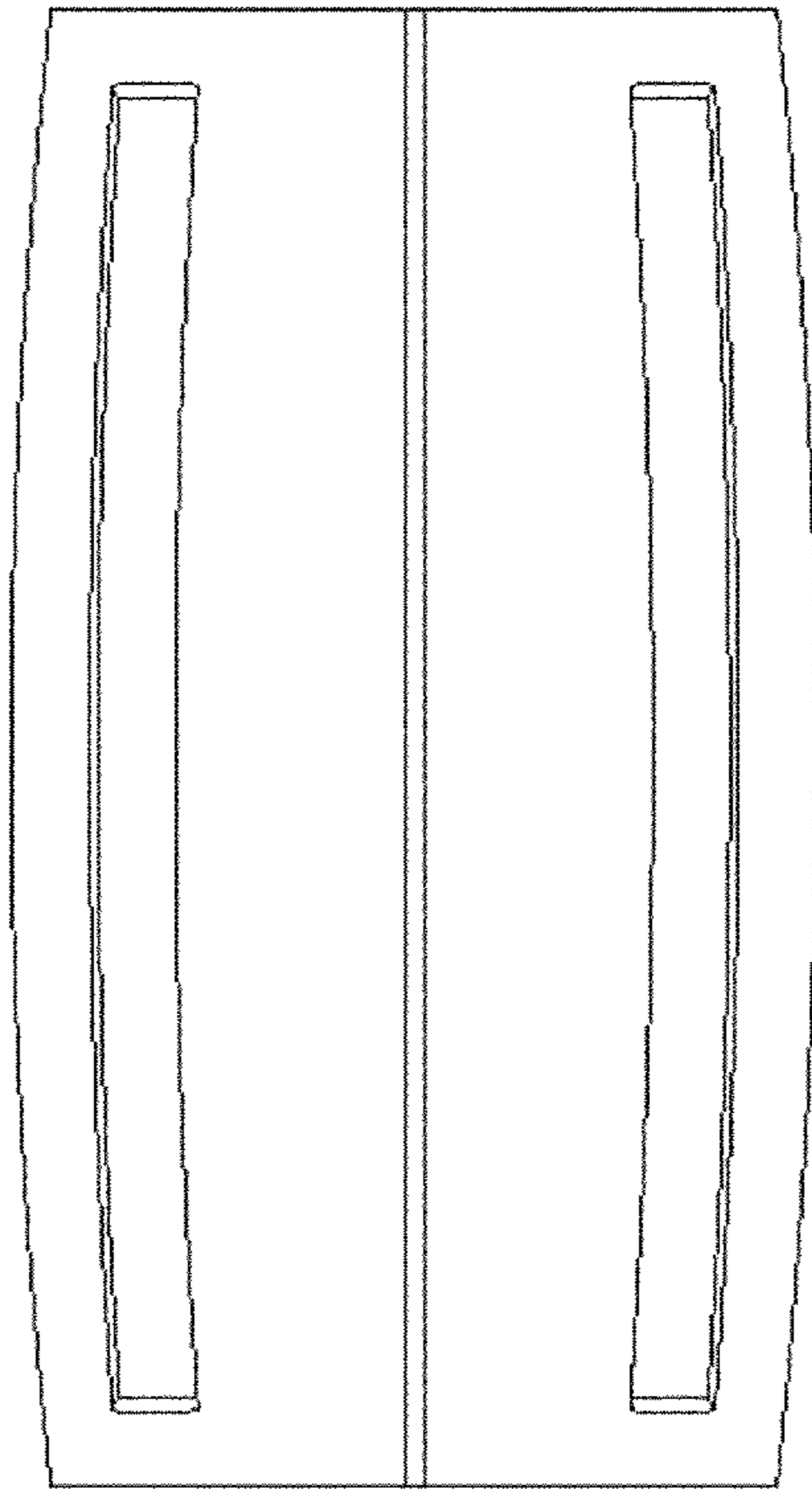


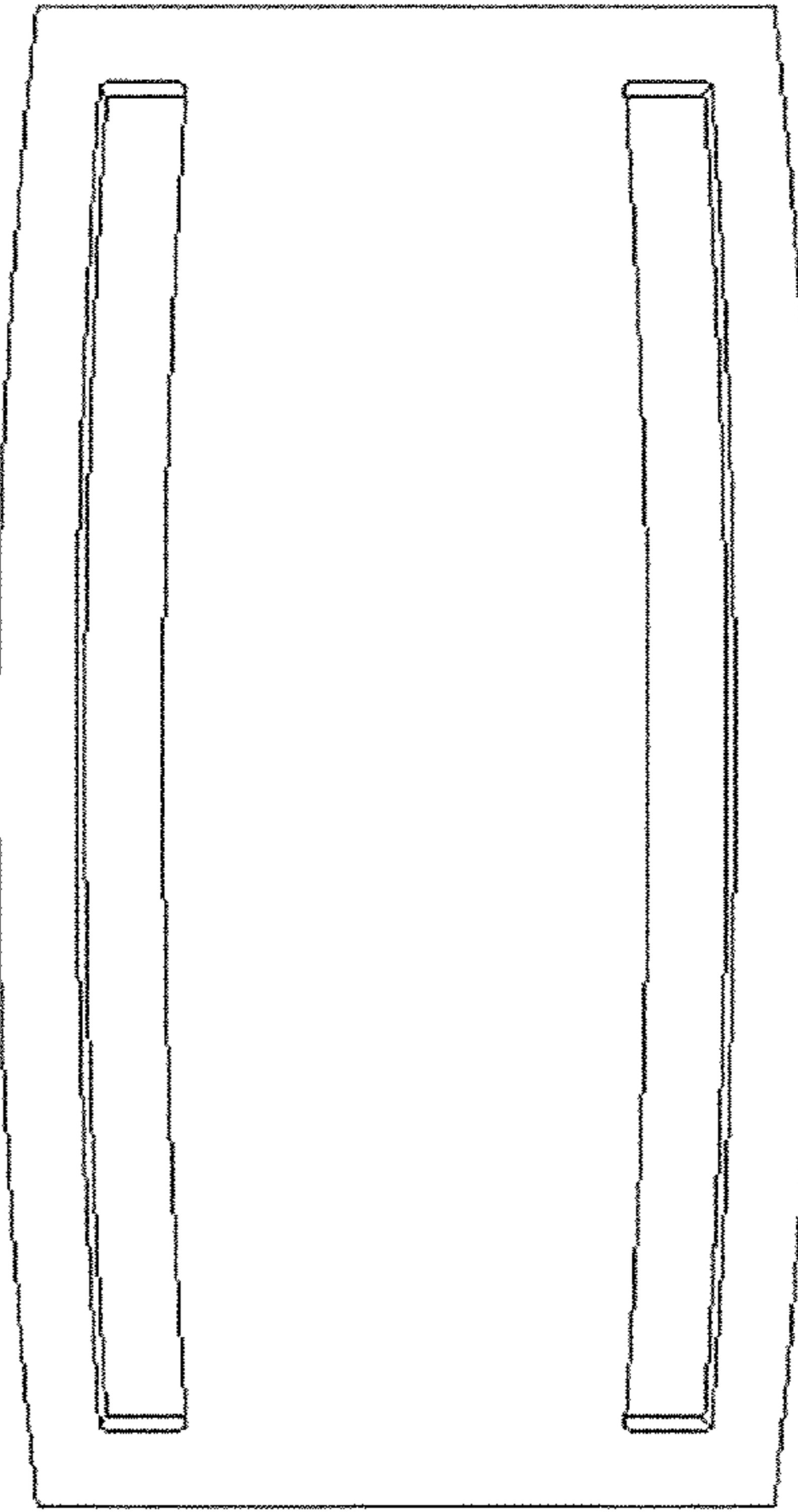
