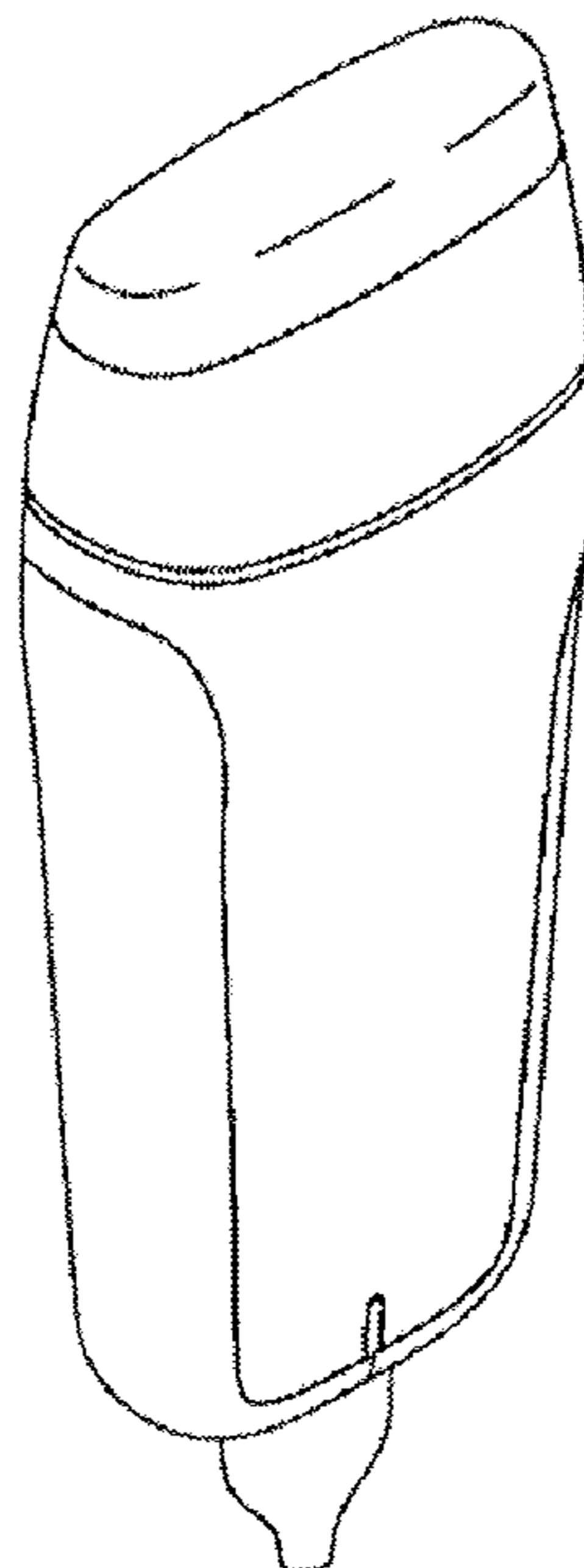
(57) **CLAIM**

I claim the ornamental design for a probe unit for medical scanning apparatus, as shown.

DESCRIPTION

FIG. 1 is a perspective view of the probe unit looking onto its front side, left side, and top side;
FIG. 2 is an elevational view of the rear side thereof;
FIG. 3 is an elevational view of the front side thereof;
FIG. 4 is a plan view of the top side thereof;
FIG. 5 is a plan view of the bottom side thereof;
FIG. 6 is an elevational view of the left side thereof; and,
FIG. 7 is an elevational view of the right side thereof.

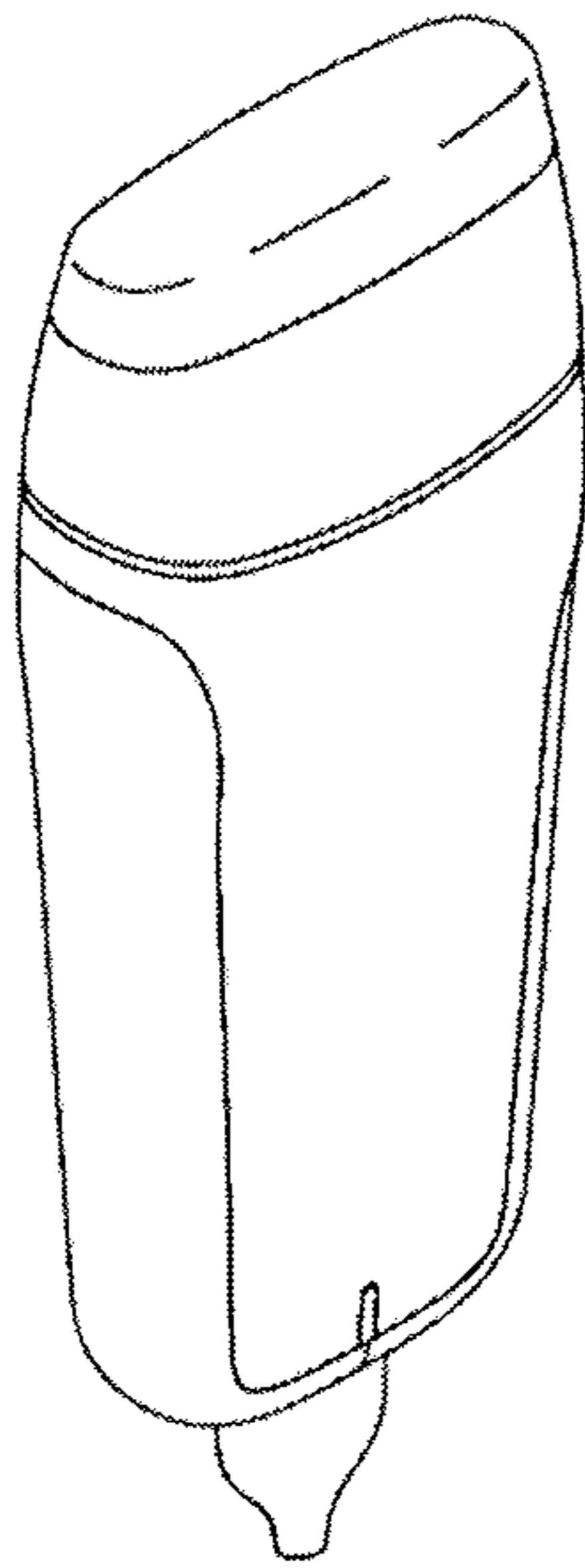

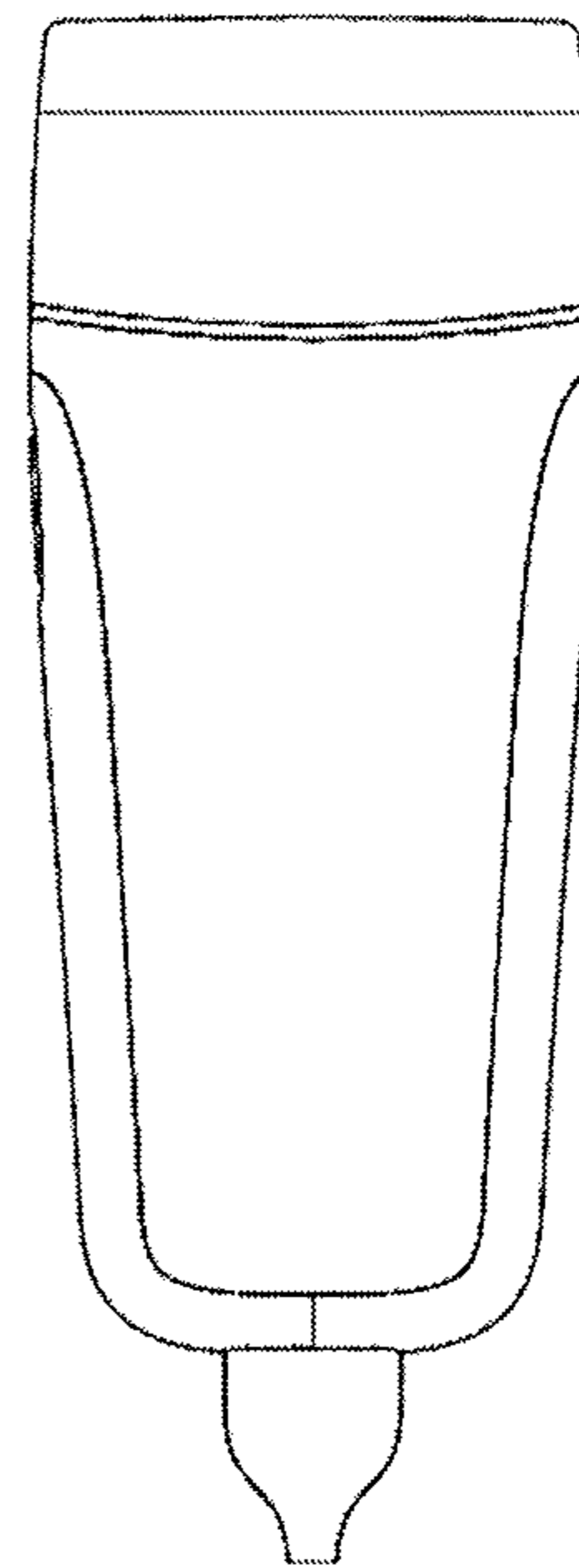

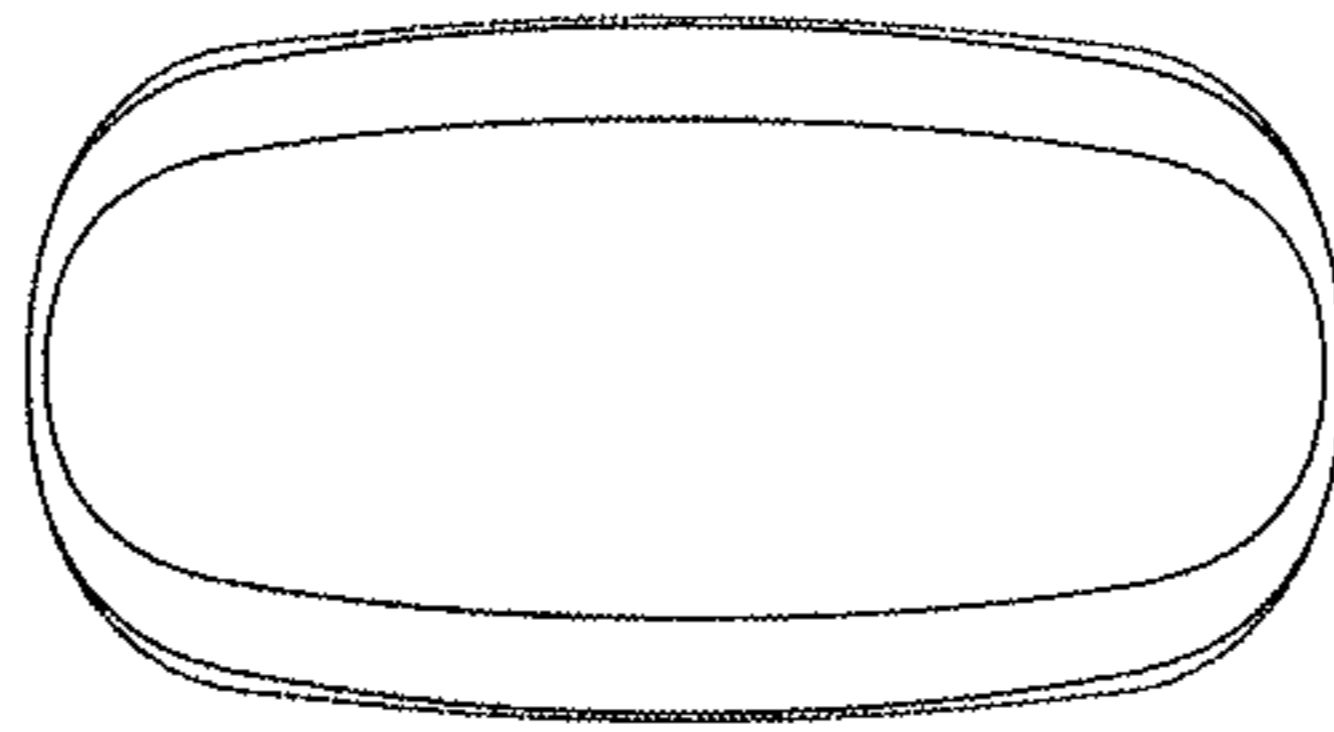

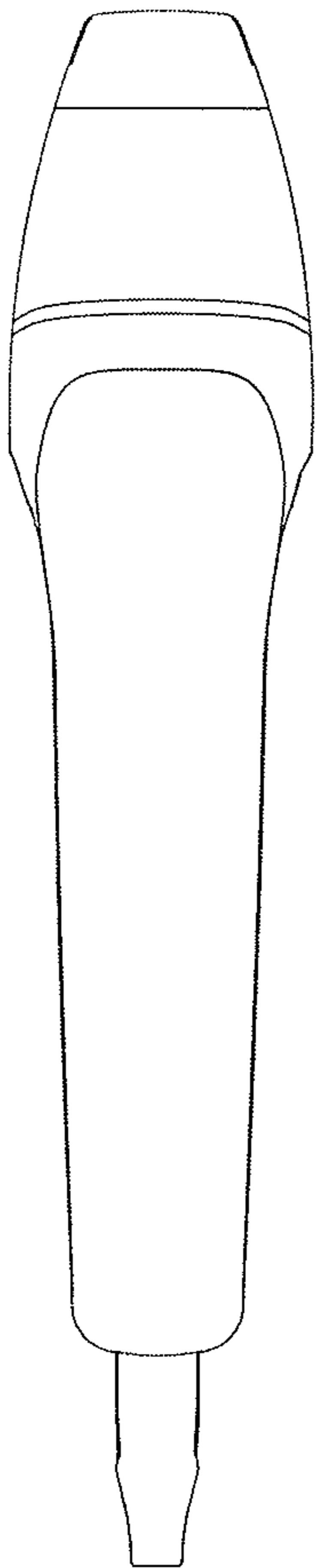

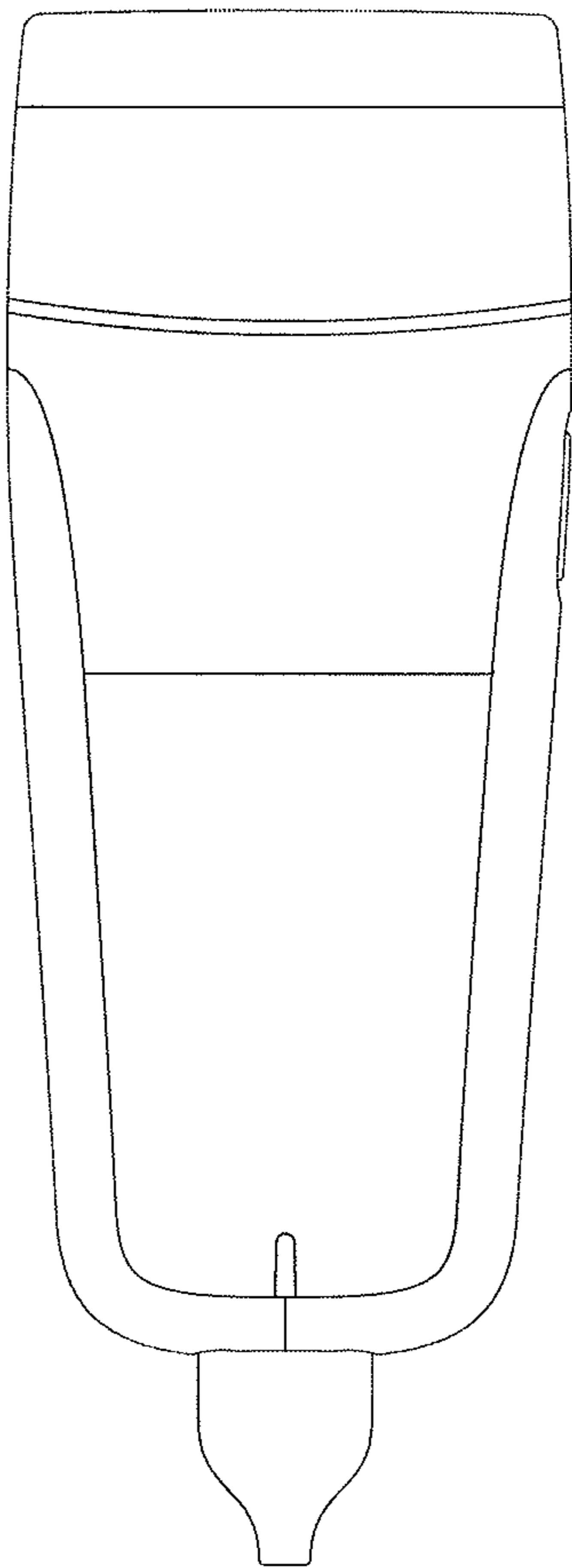

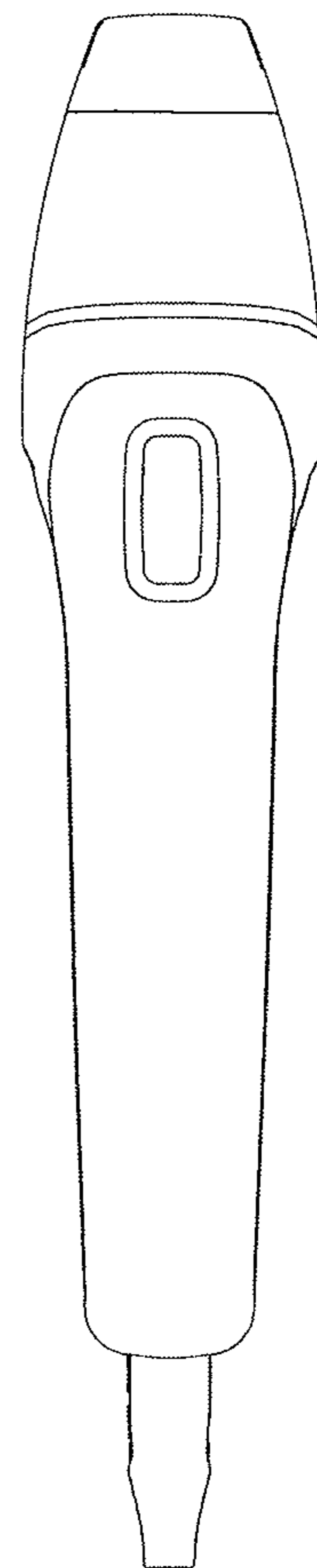
