(57) **CLAIM**

The ornamental design for a prefabricated house, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a prefabricated house; FIG. 2 is a front view of the prefabricated house of FIG. 1; FIG. 3 is a rear view of the prefabricated house of FIG. 1; FIG. 4 is a left-side view of the prefabricated house of FIG. 1; FIG. 5 is a right-side view of the prefabricated house of FIG. 1; FIG. 6 is a top plan view of the prefabricated house of FIG. 1; FIG. 7 is a bottom plan view of the prefabricated house of FIG. 1; FIG. 8 is a right perspective view of the prefabricated house of FIG. 1; FIG. 9 is a rear perspective view of the prefabricated house of FIG. 1; and, FIG. 10 is a front perspective view of the prefabricated house of FIG. 1 with the entrance in a closed position. Features shown in broken lines in FIGS. 2, 3, 4, 5, and 7, form no part of the claimed design.

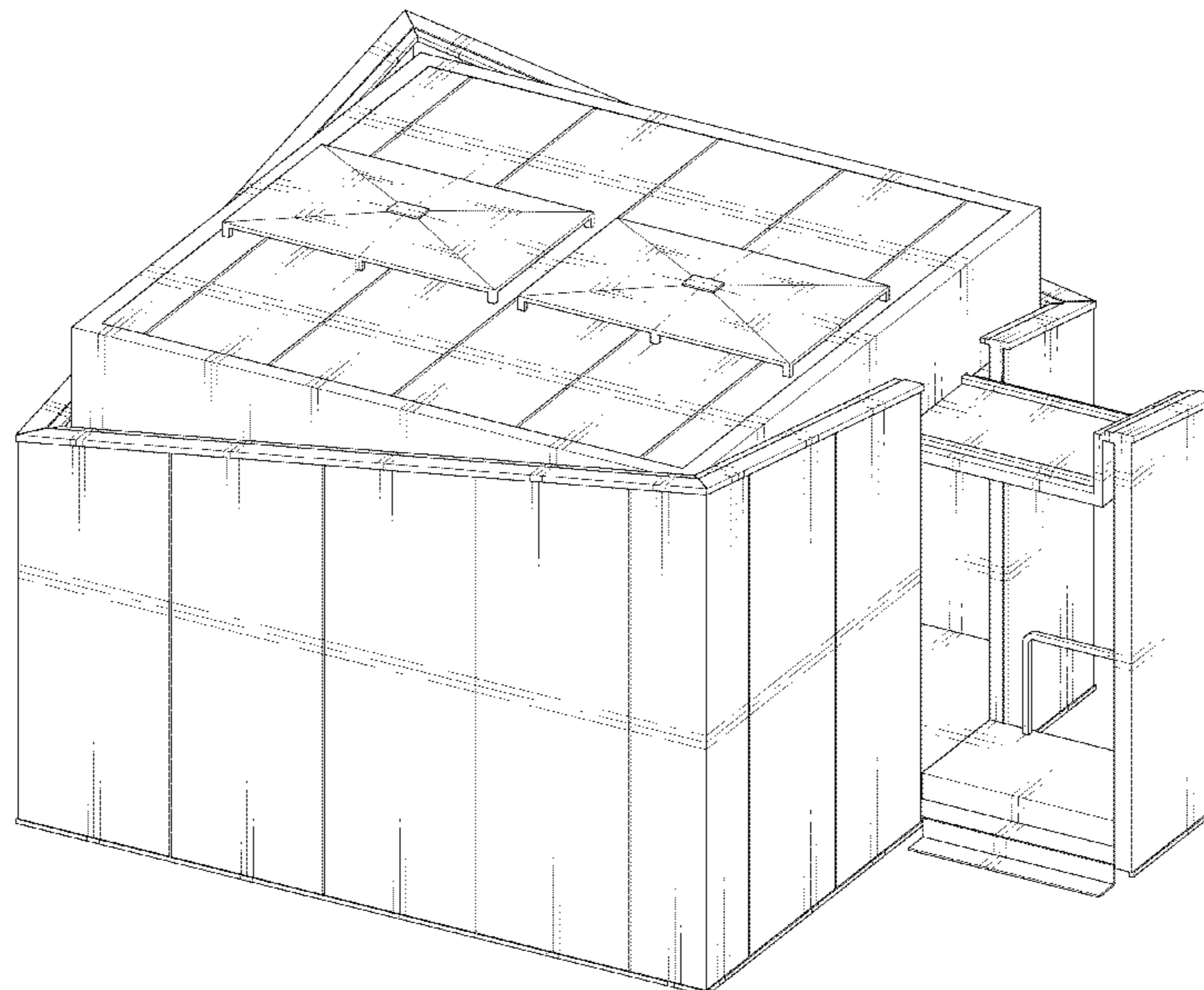

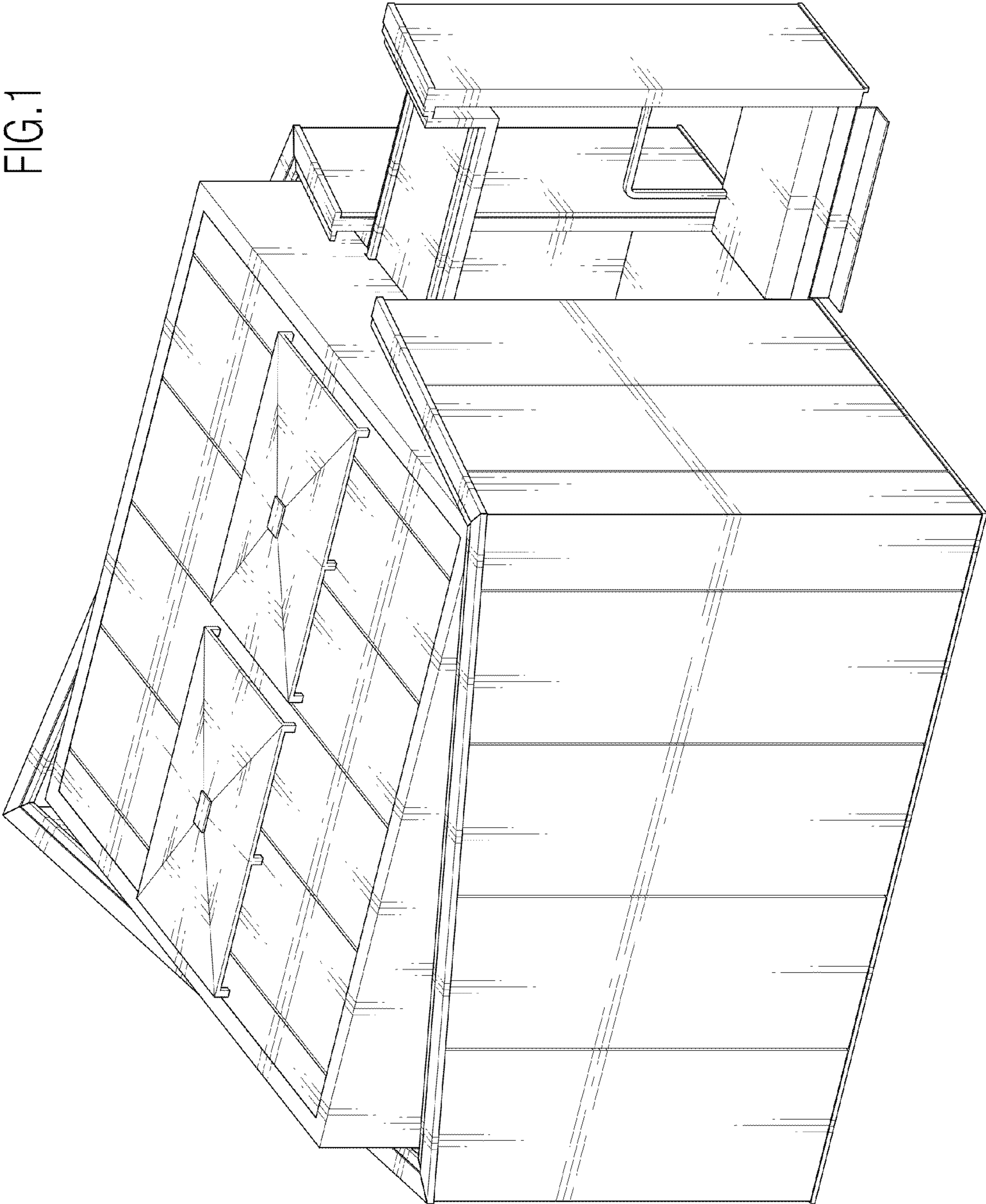

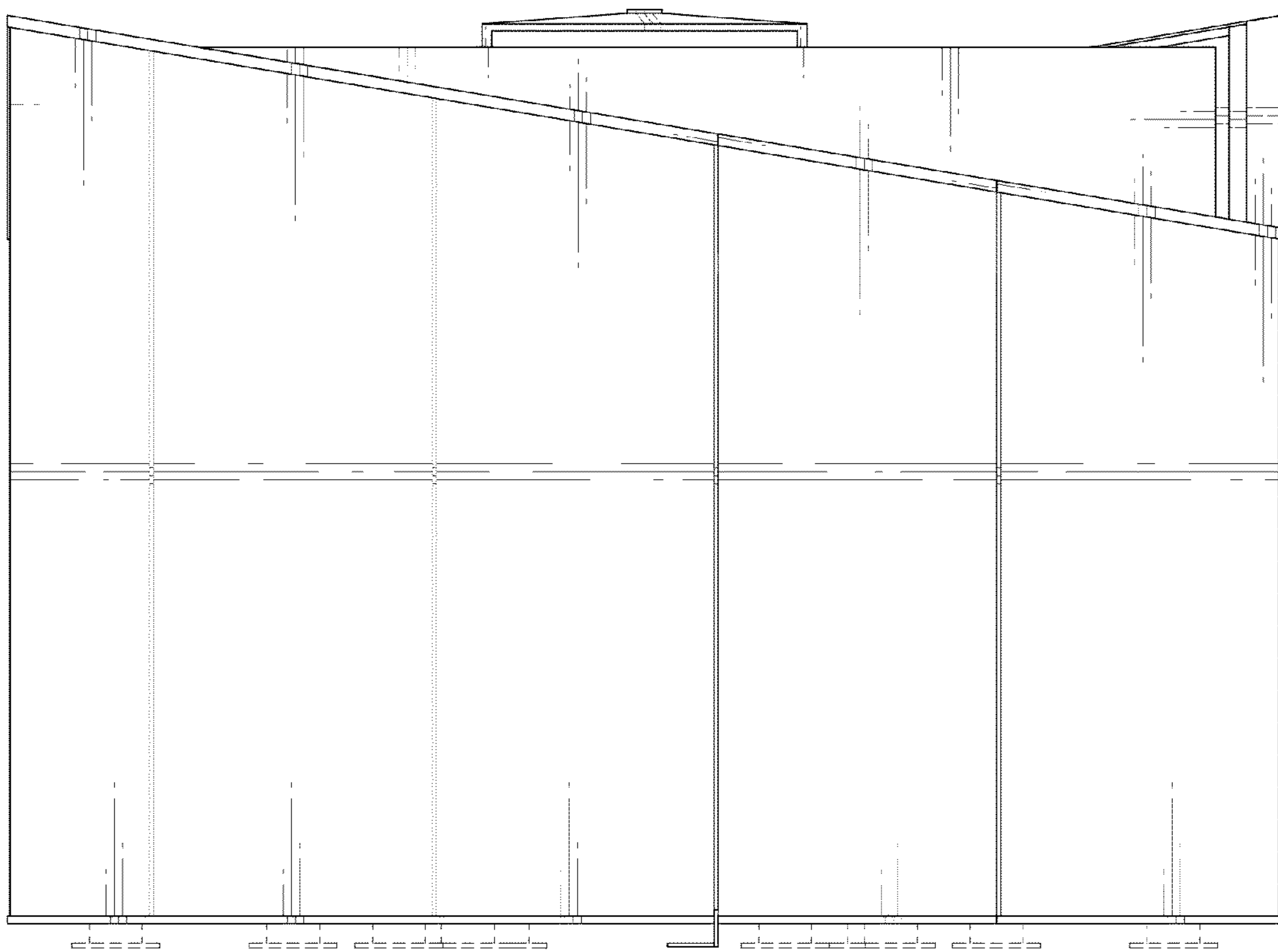

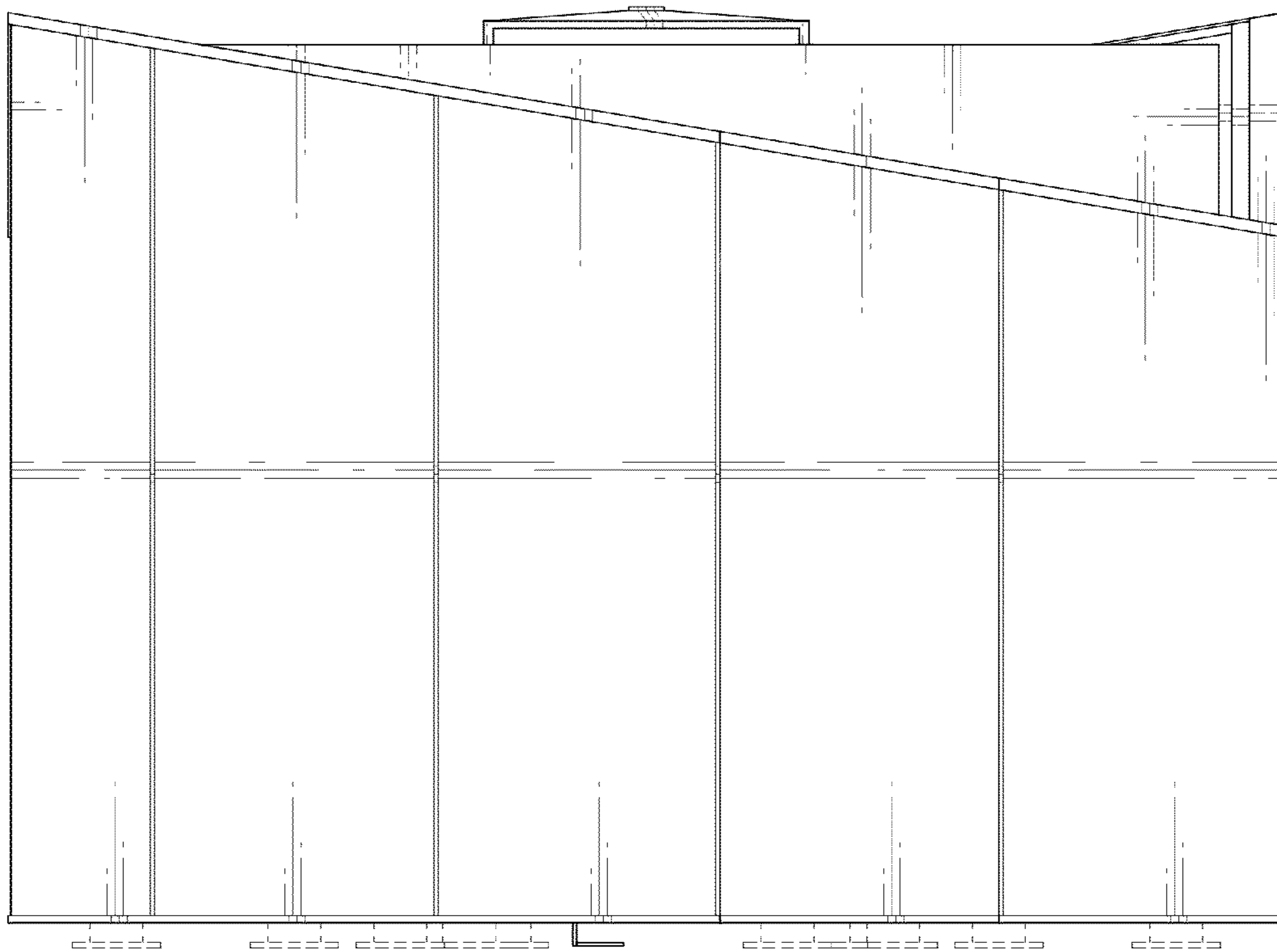

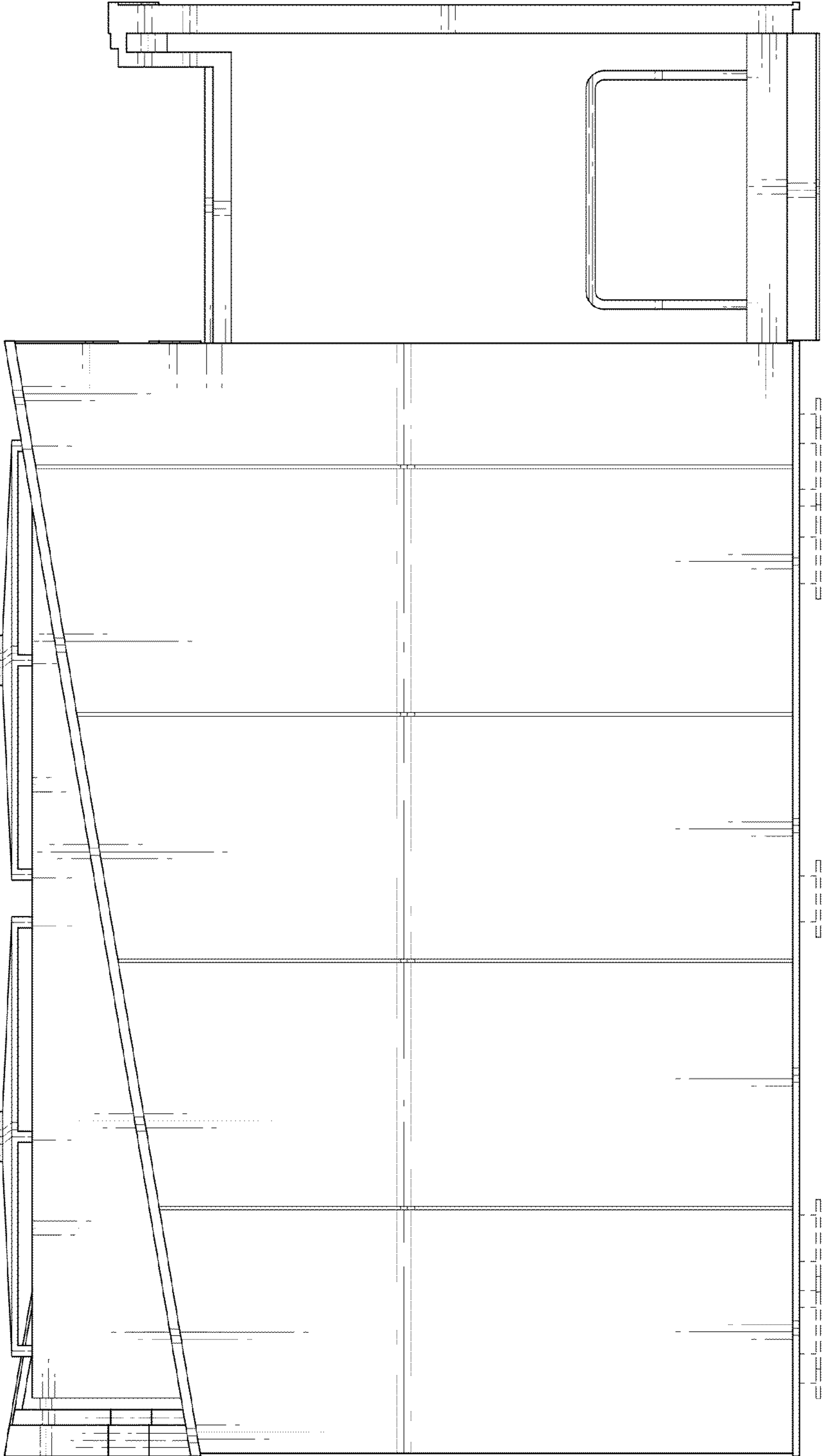

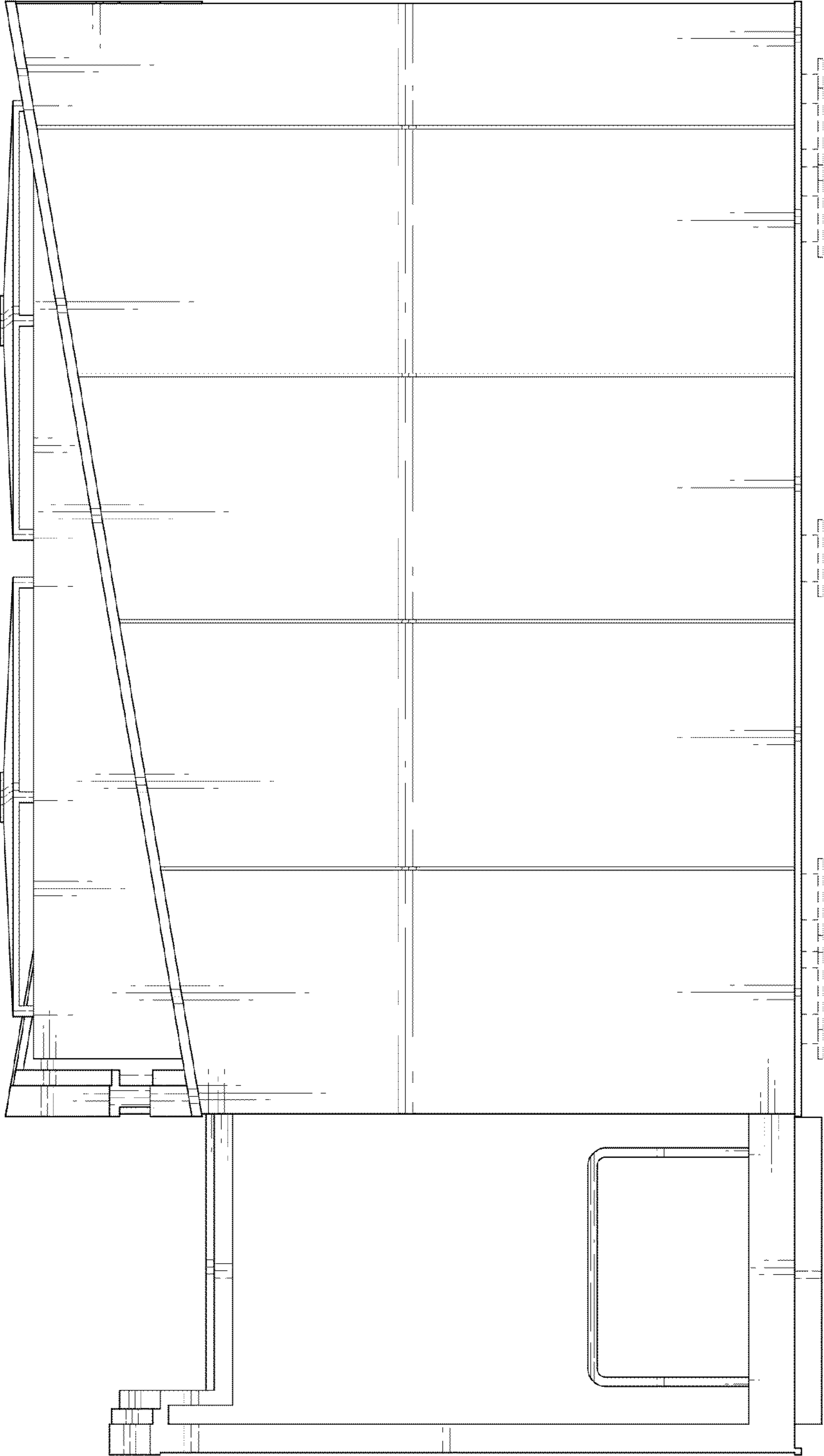

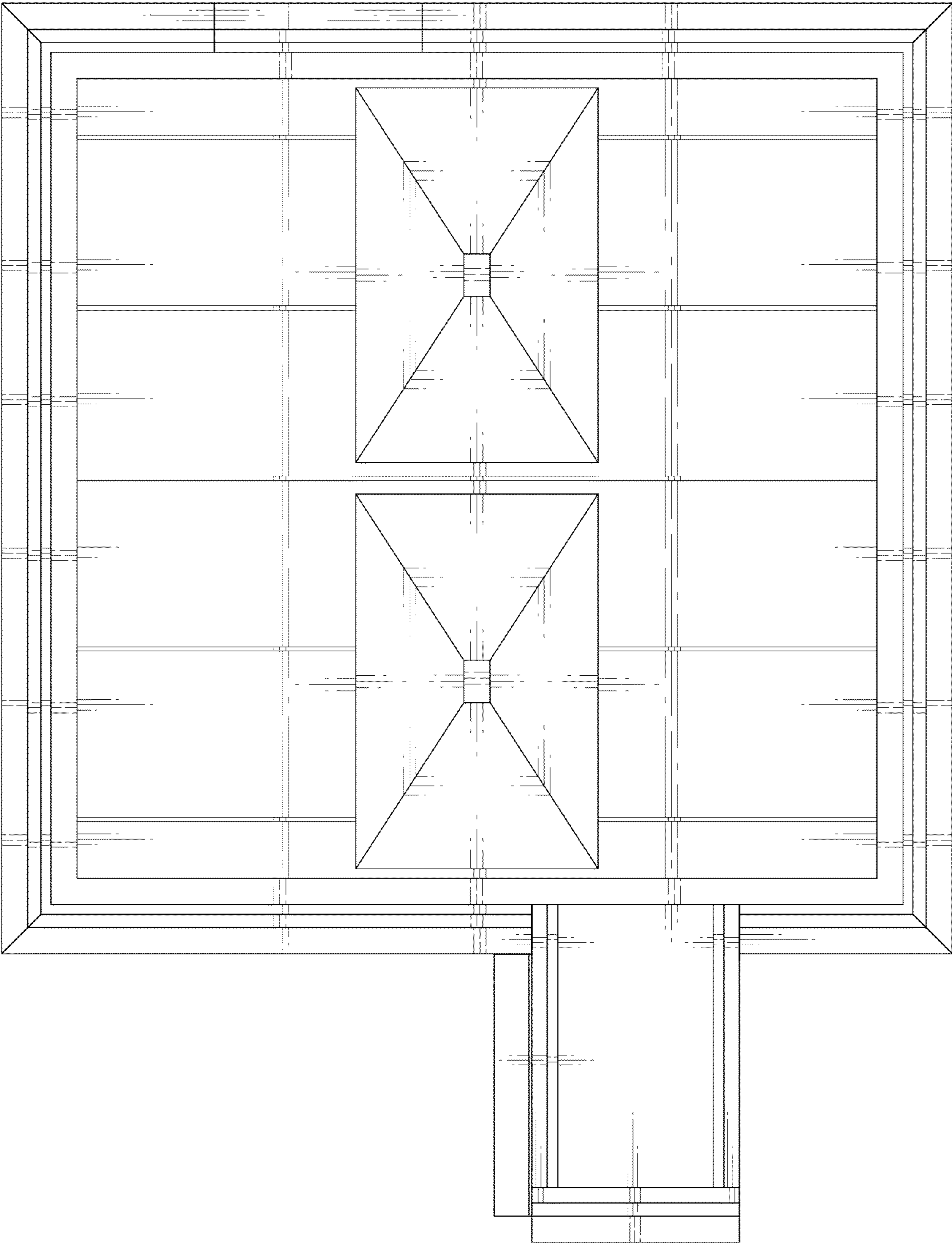

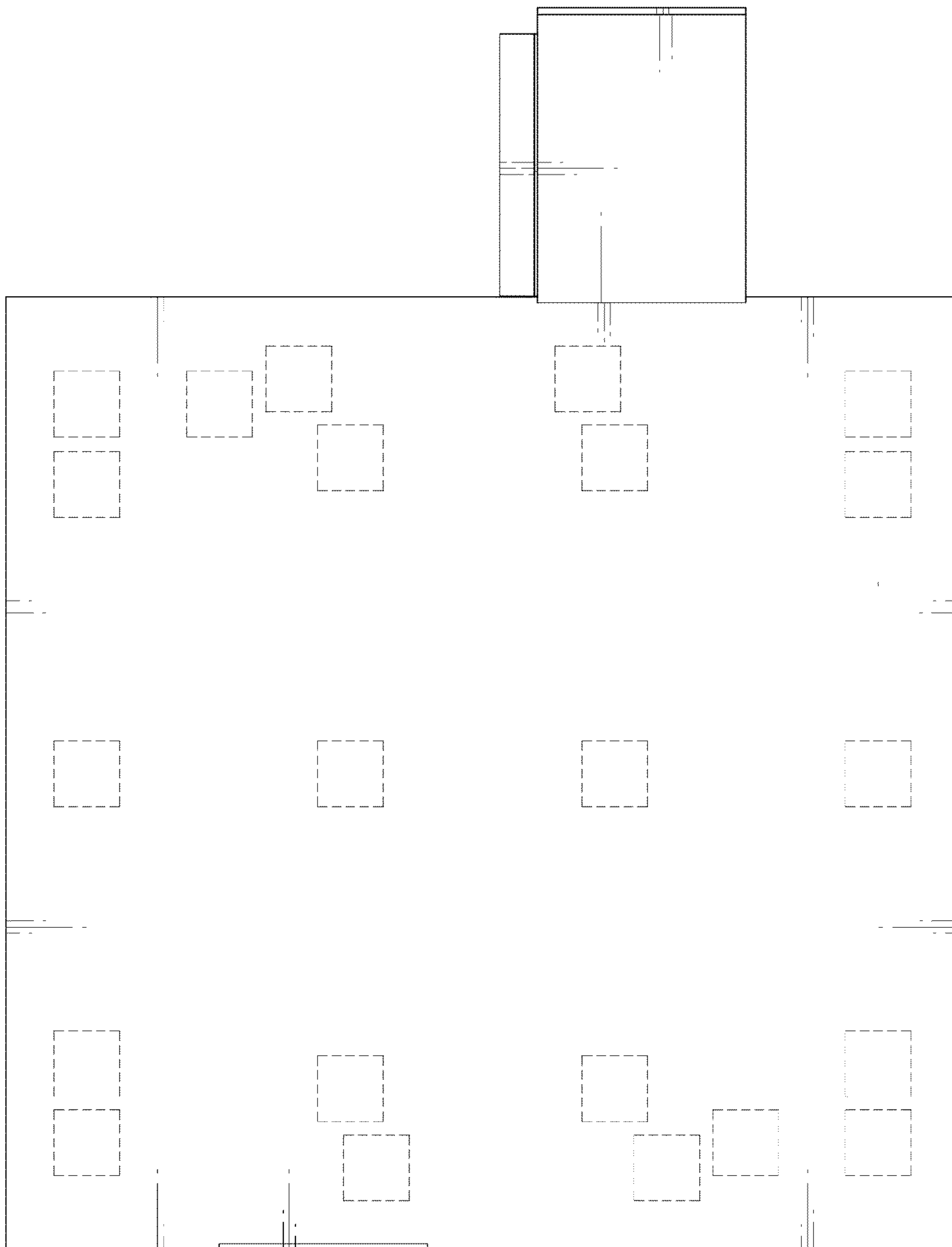

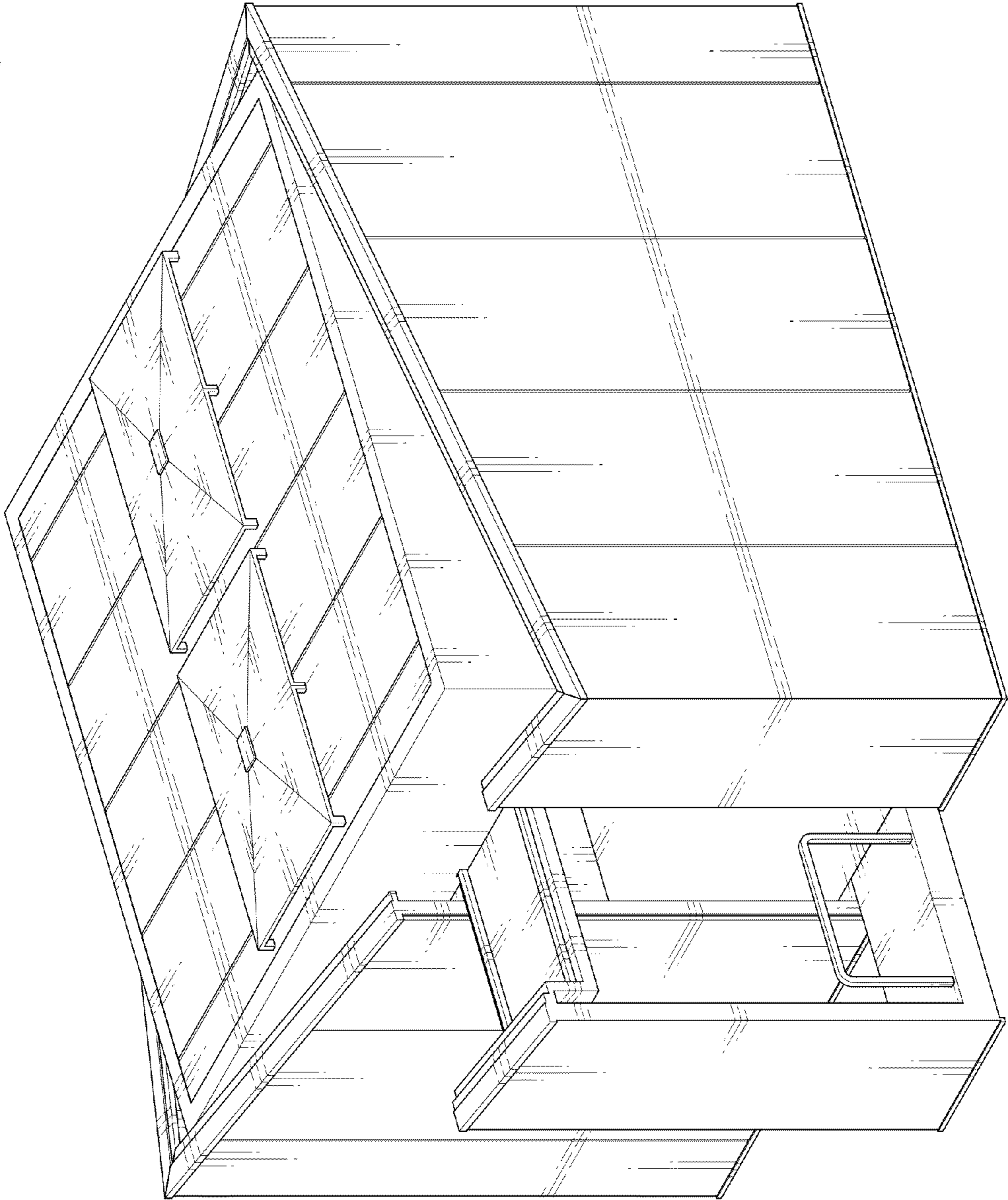

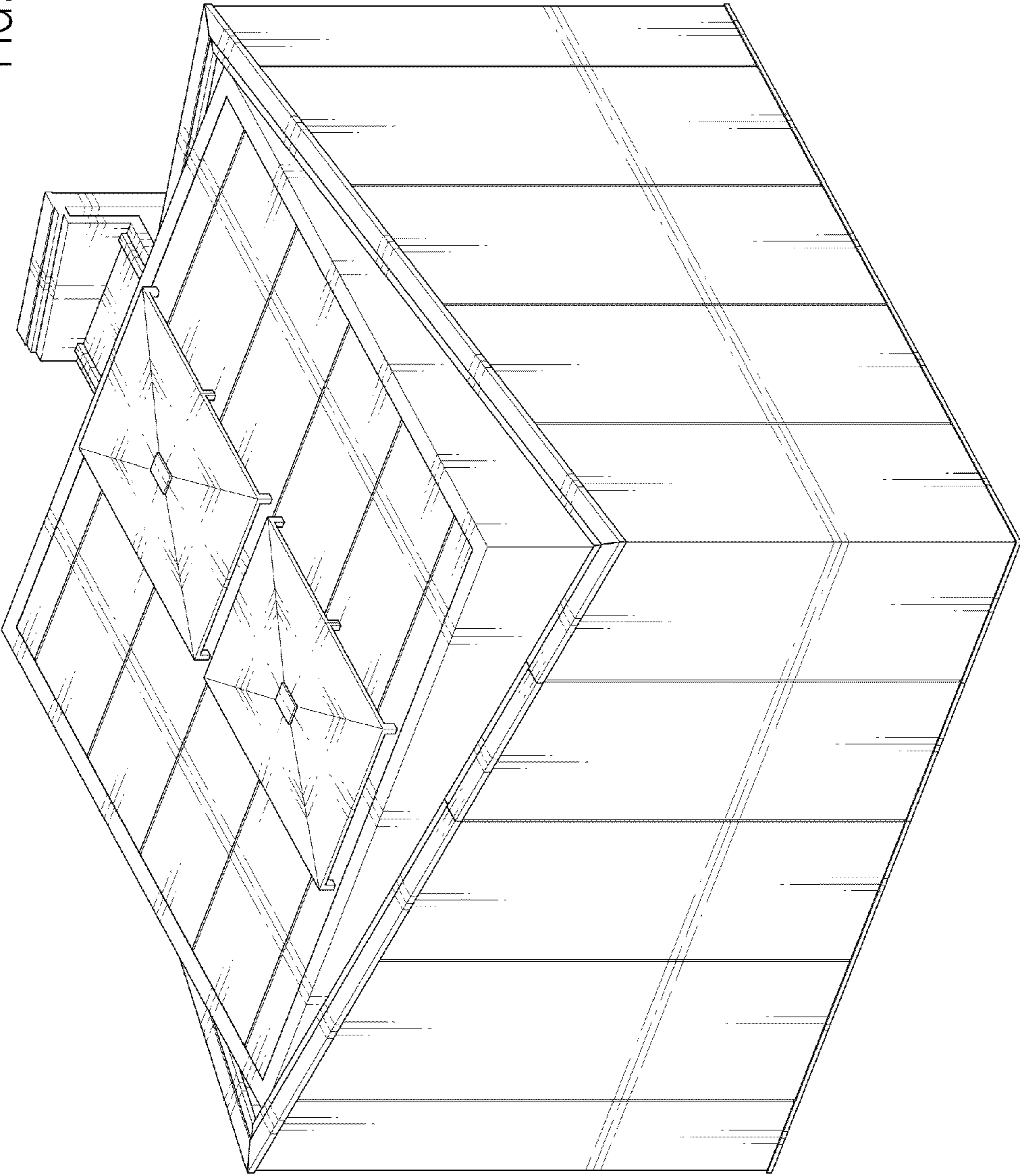
