(57) **CLAIM**

We claim the ornamental design for a dog leash attachment device, as shown and described.

DESCRIPTION

FIG. 1 shows a front elevation view of a dog leash attachment device of the present invention, where the back elevation view is identical thereto.

FIG. 2 shows a perspective view of a dog leash attachment device of FIG. 1.

FIG. 3 shows a bottom plan view of the dog leash attachment device of FIG. 1.

FIG. 4 shows a right elevation view of the dog leash attachment device of FIG. 1, where the left elevation view is identical thereto.

FIG. 5 shows a top plan view of the dog leash attachment device of FIG. 1.

FIG. 6 shows a front elevation view of another embodiment of a dog leash attachment device of the present invention, where the back elevation view is identical thereto.

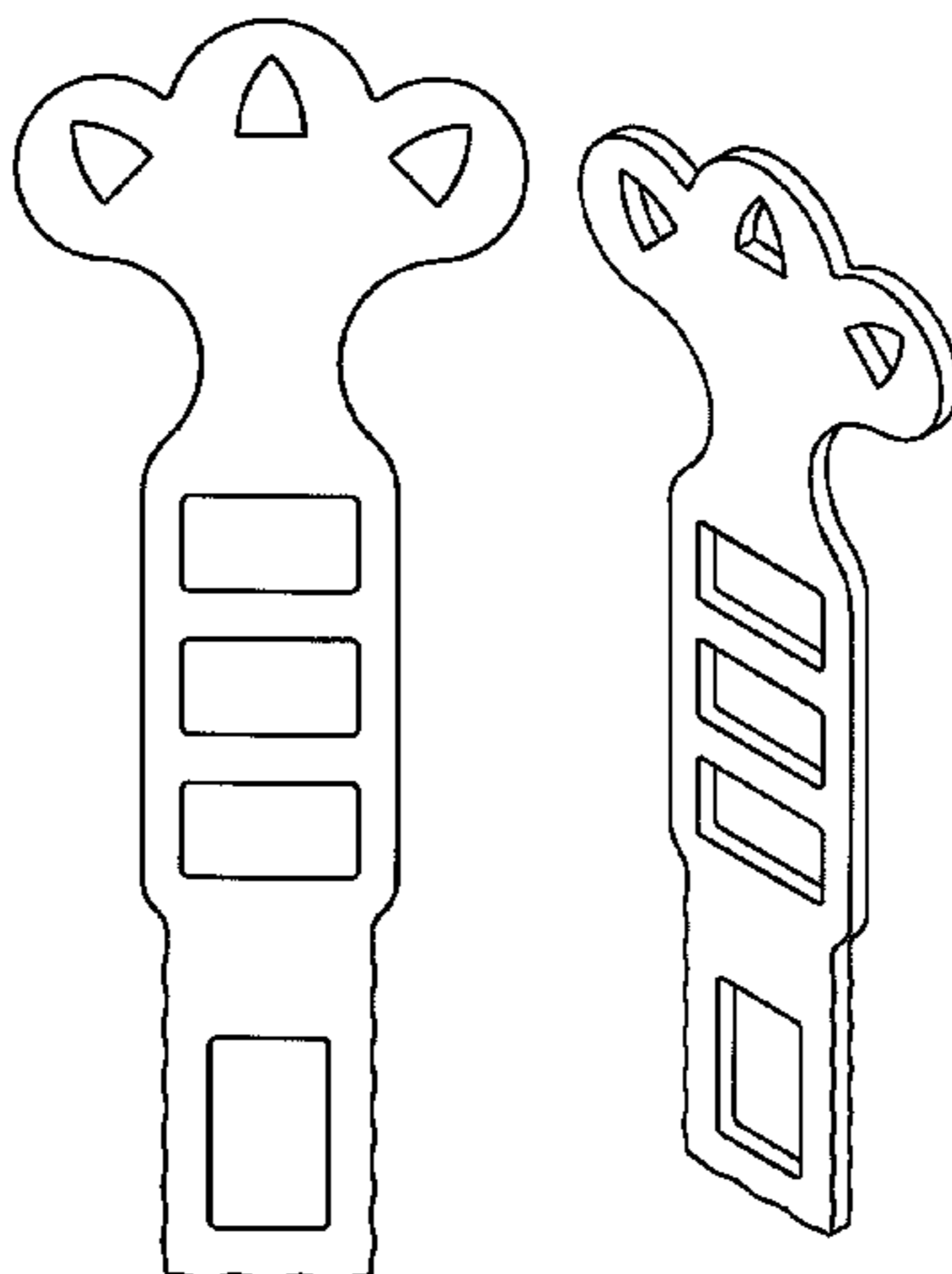
FIG. 7 shows a perspective view of a dog leash attachment device of FIG. 6.

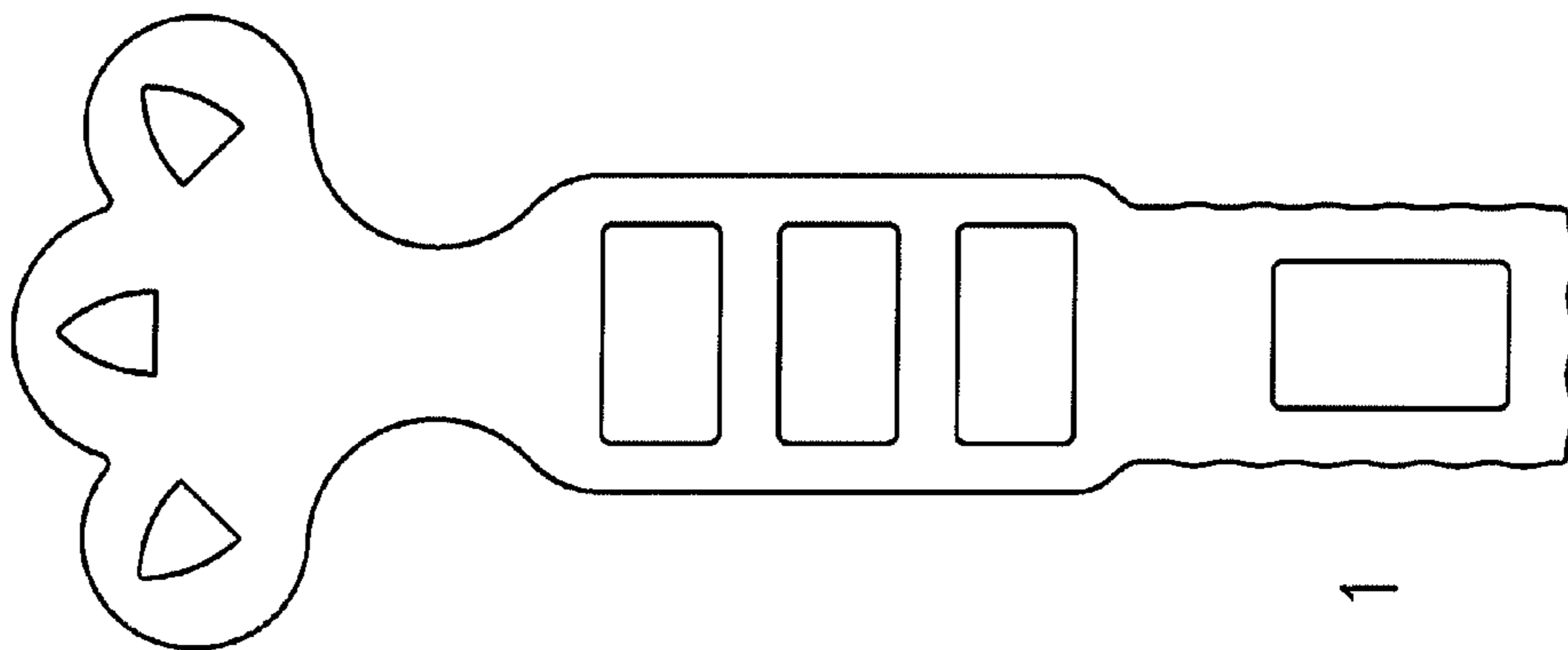

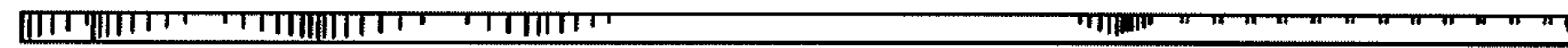

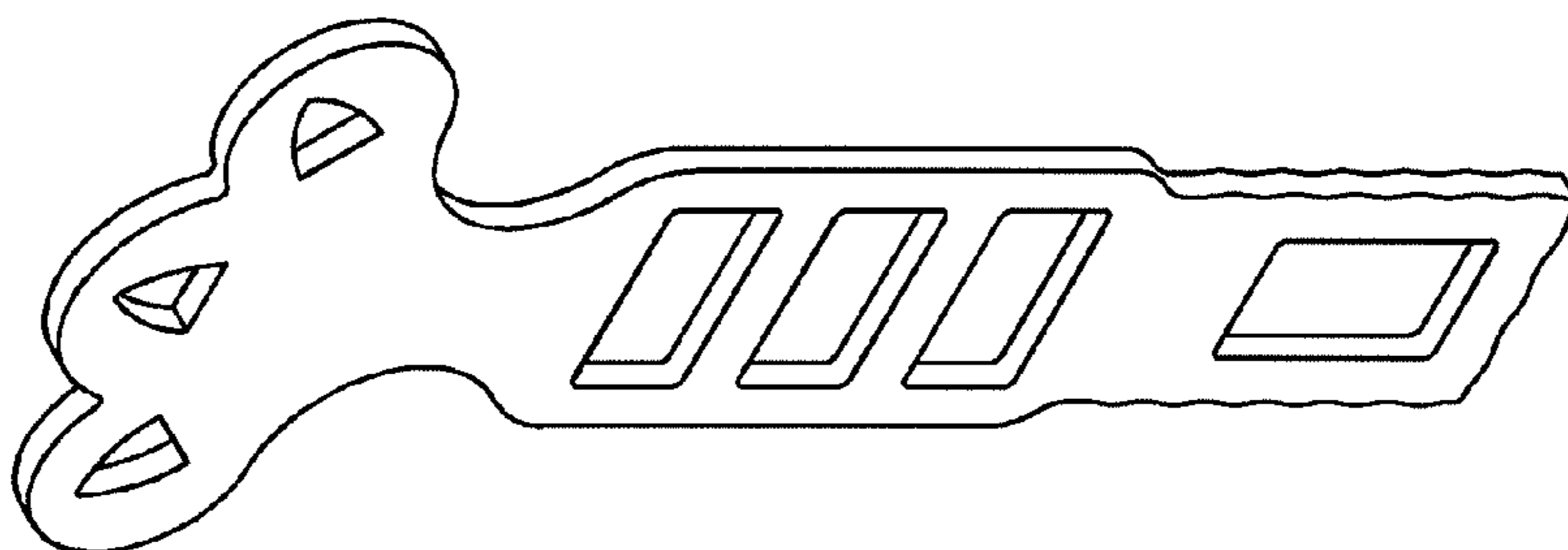

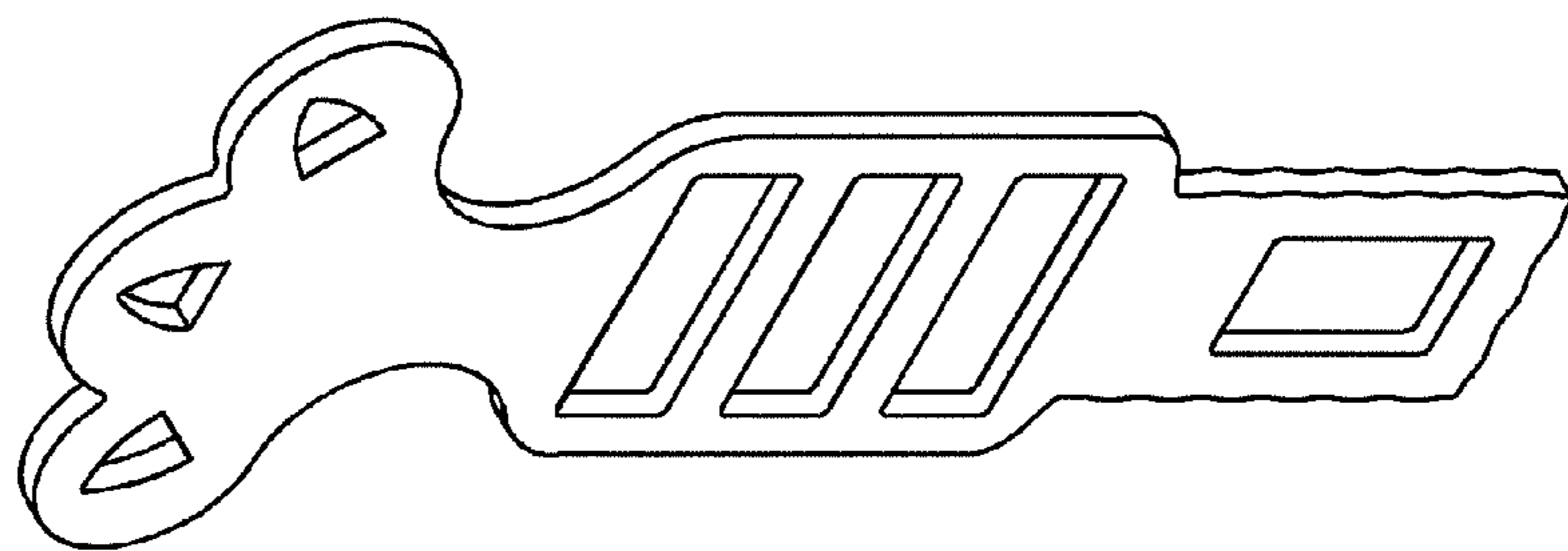
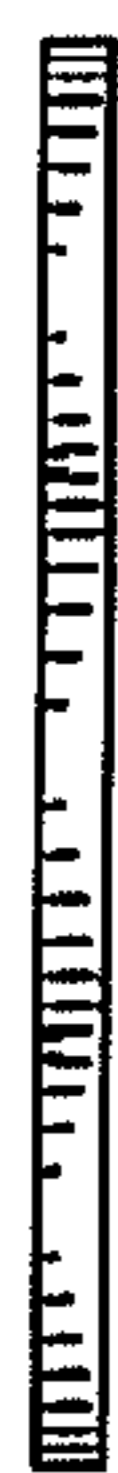

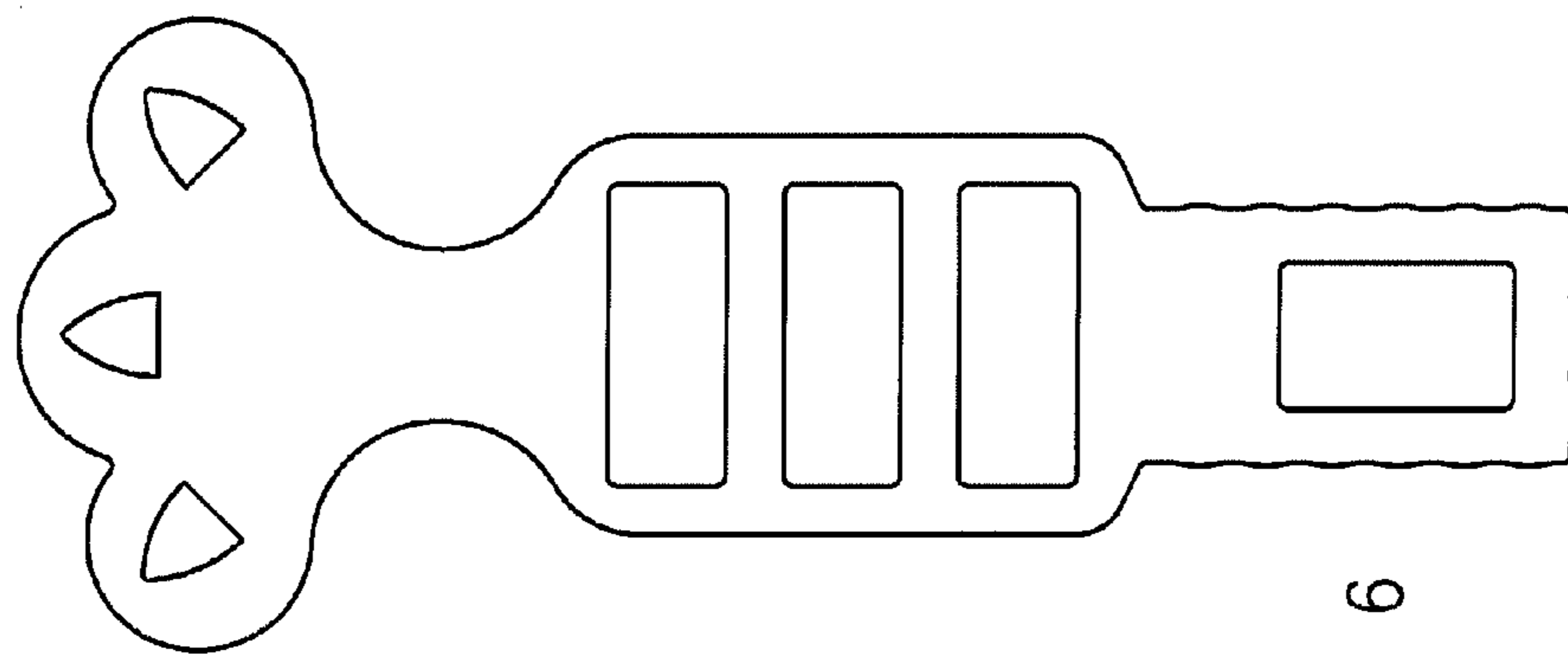

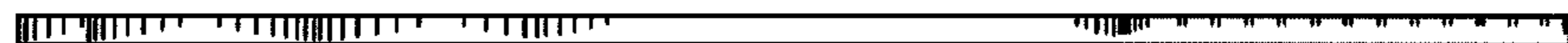
