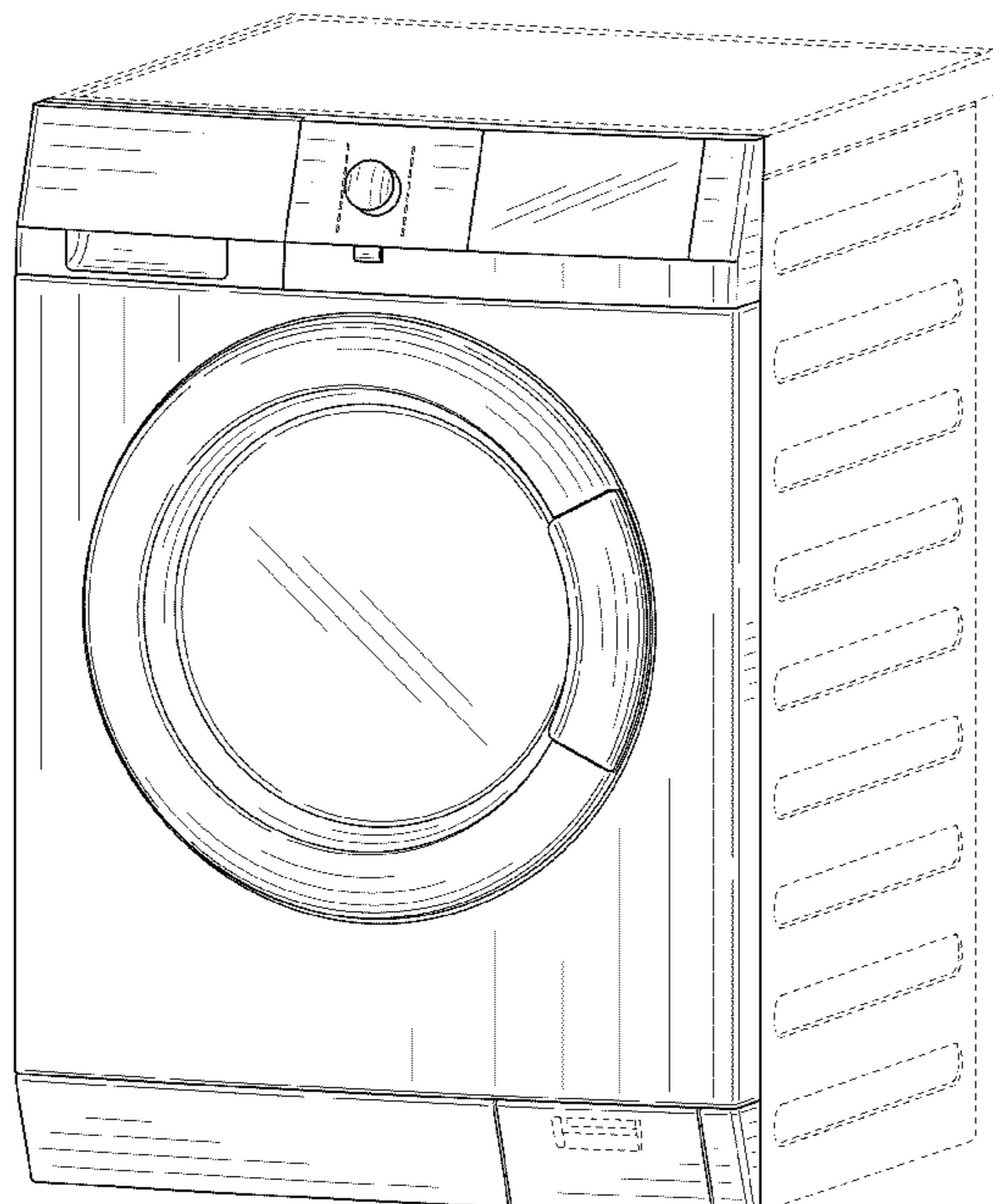
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a laundry appliance showing my/our new design;

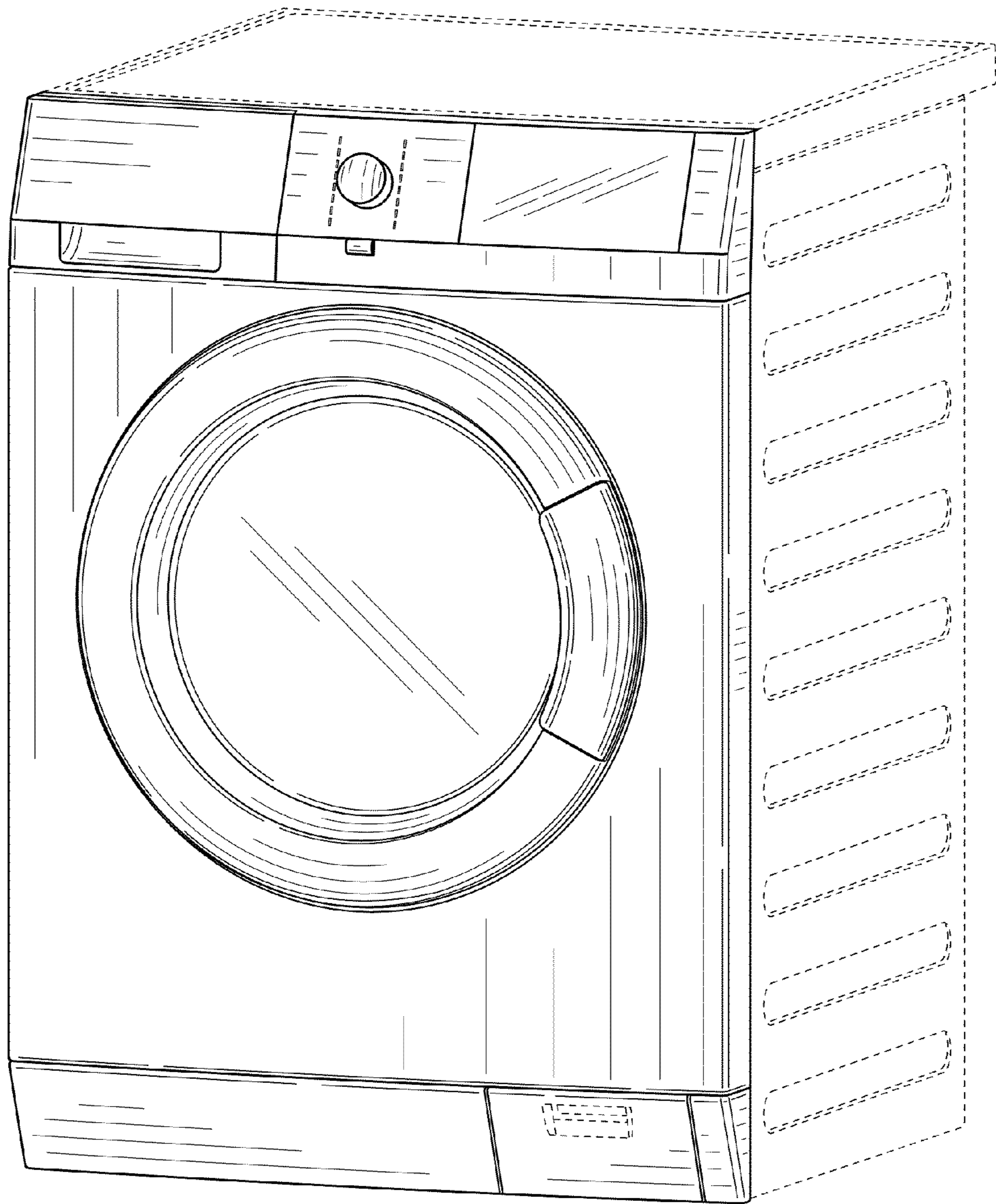

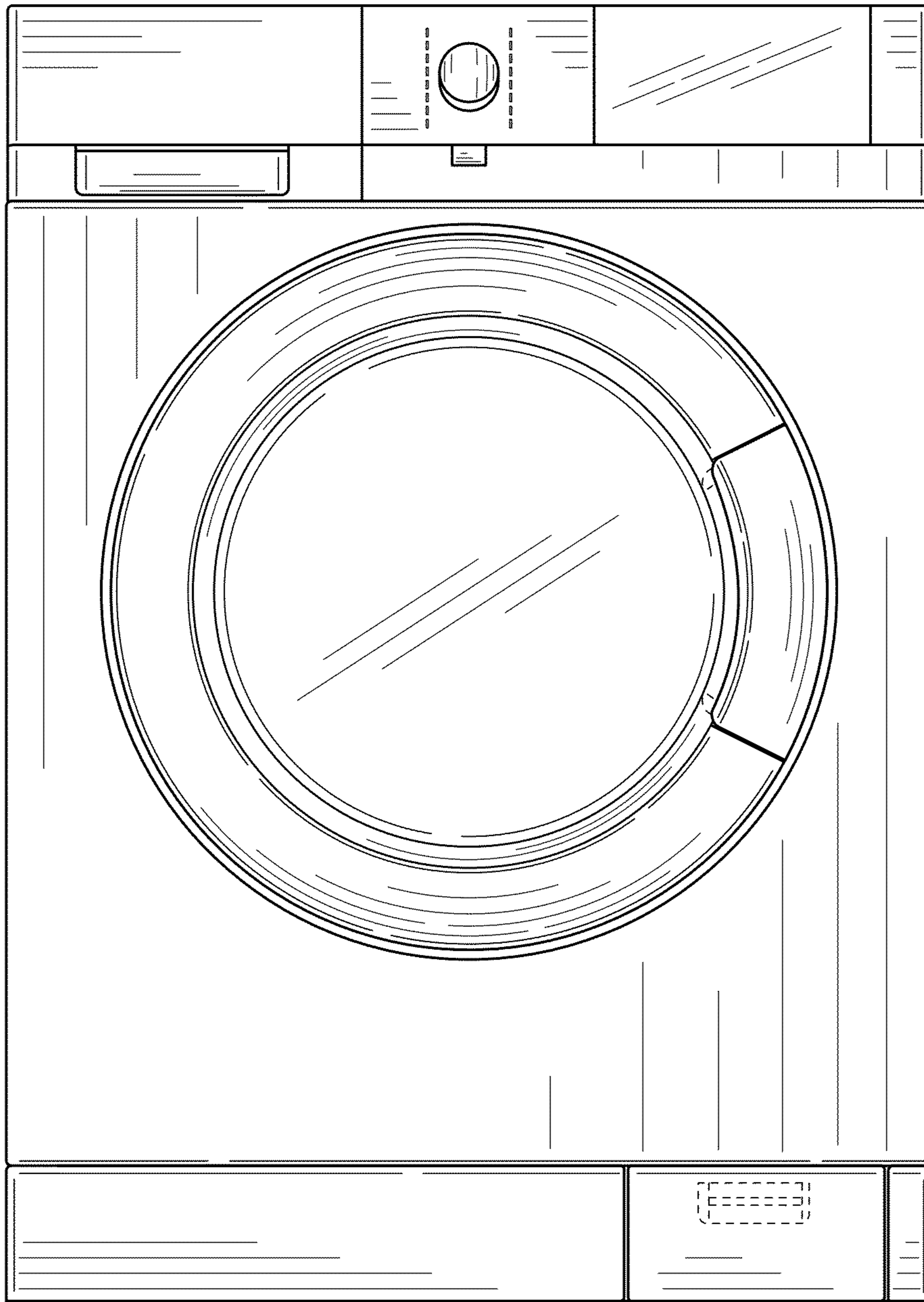

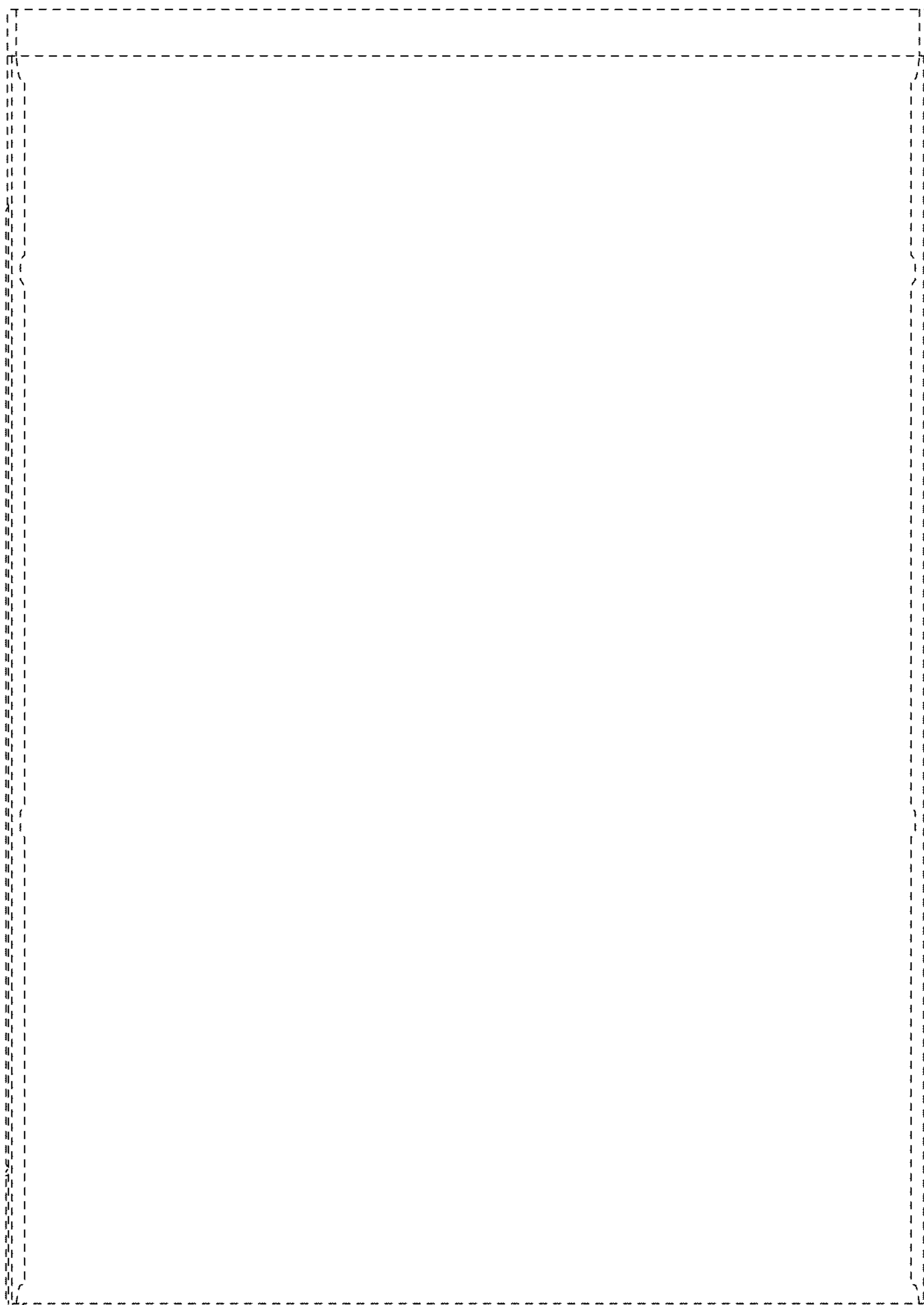

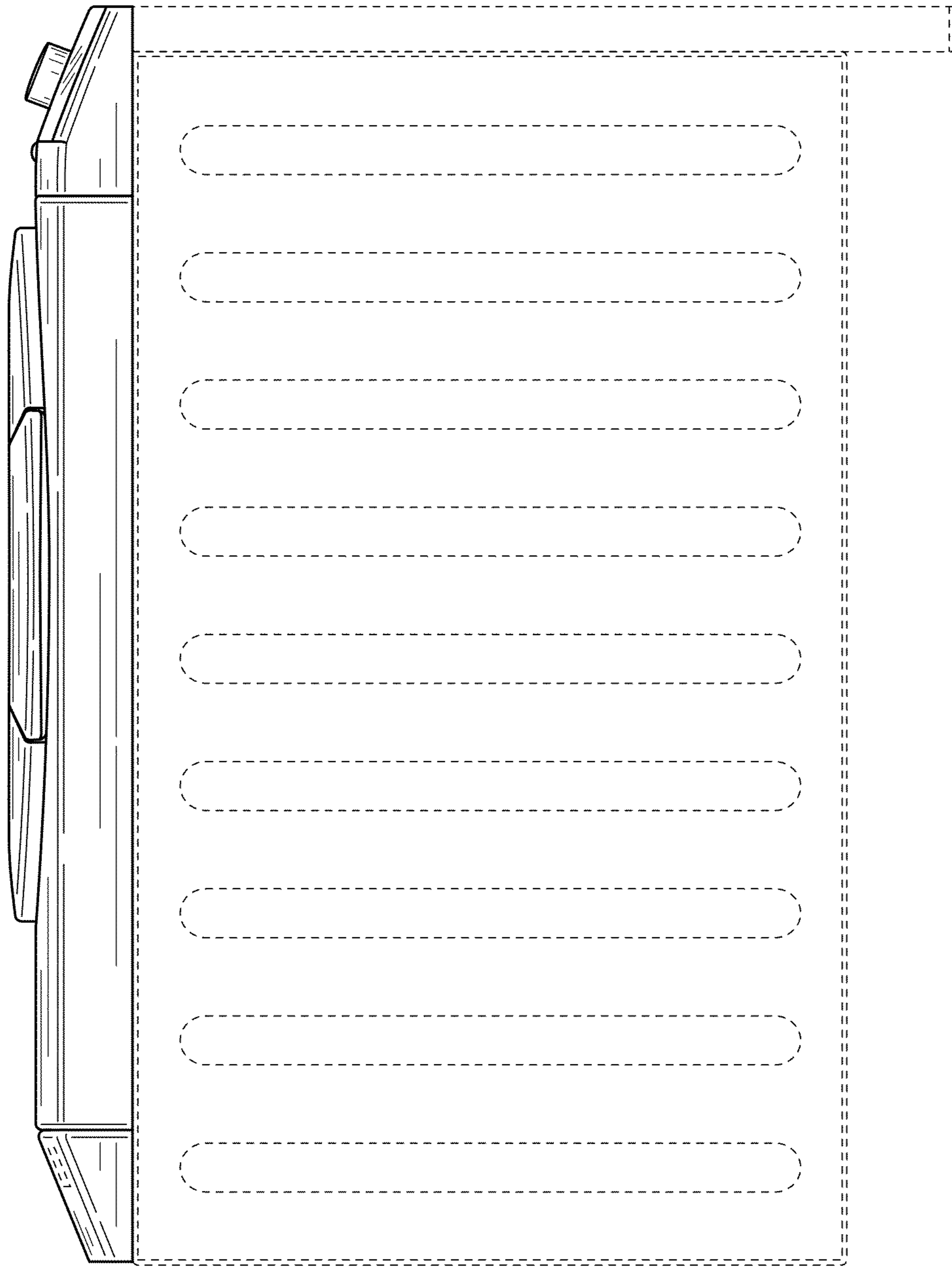

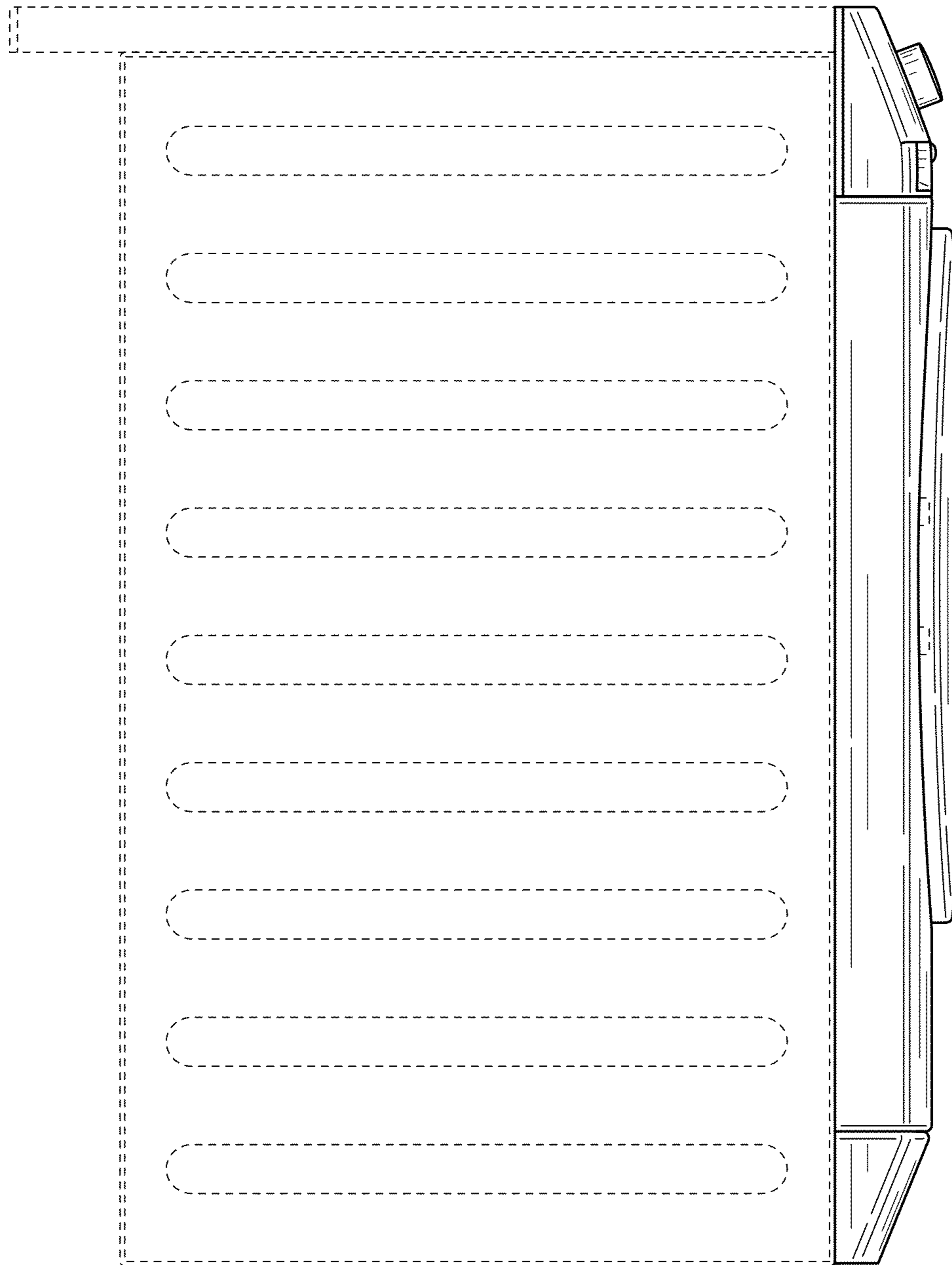

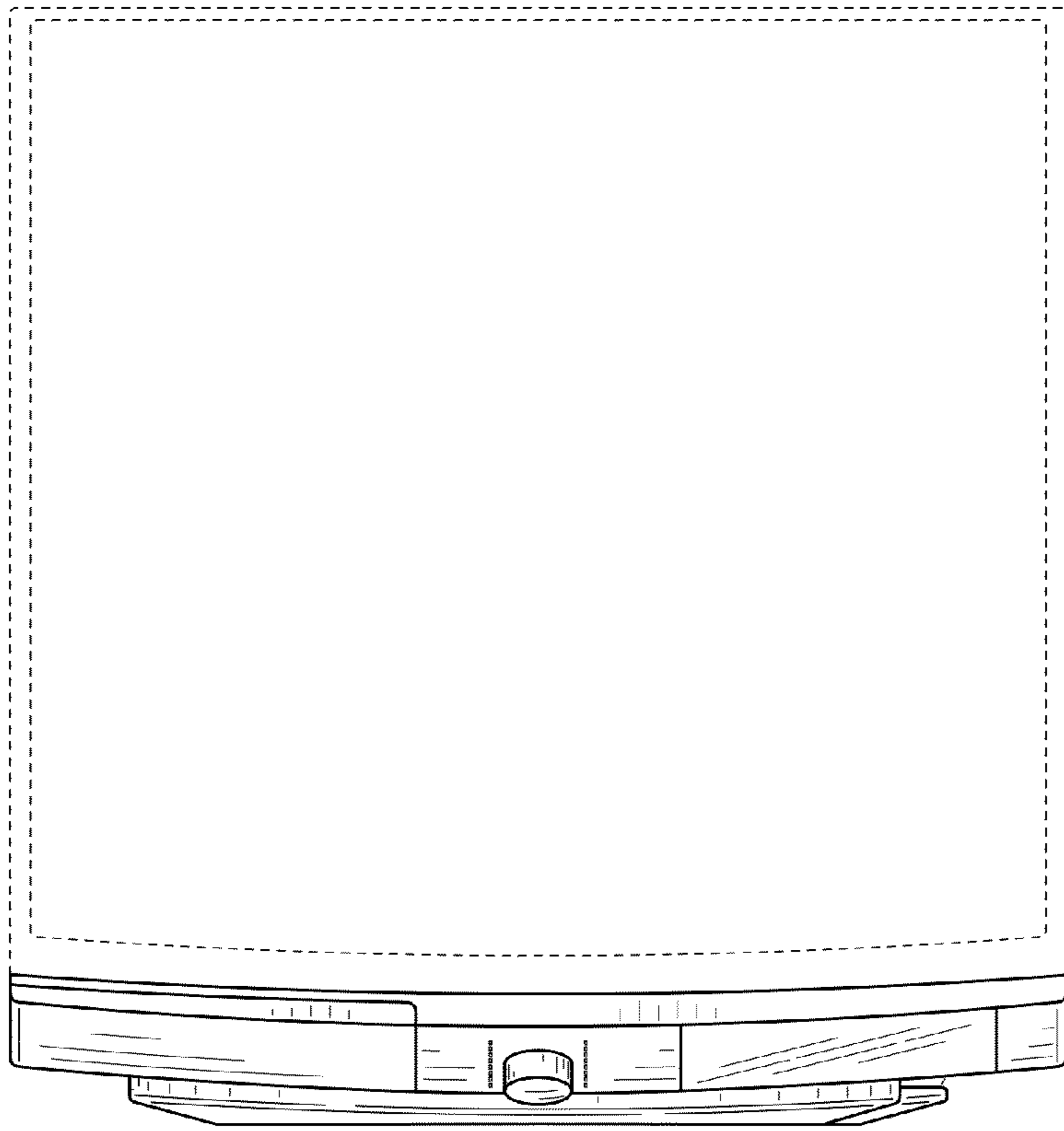

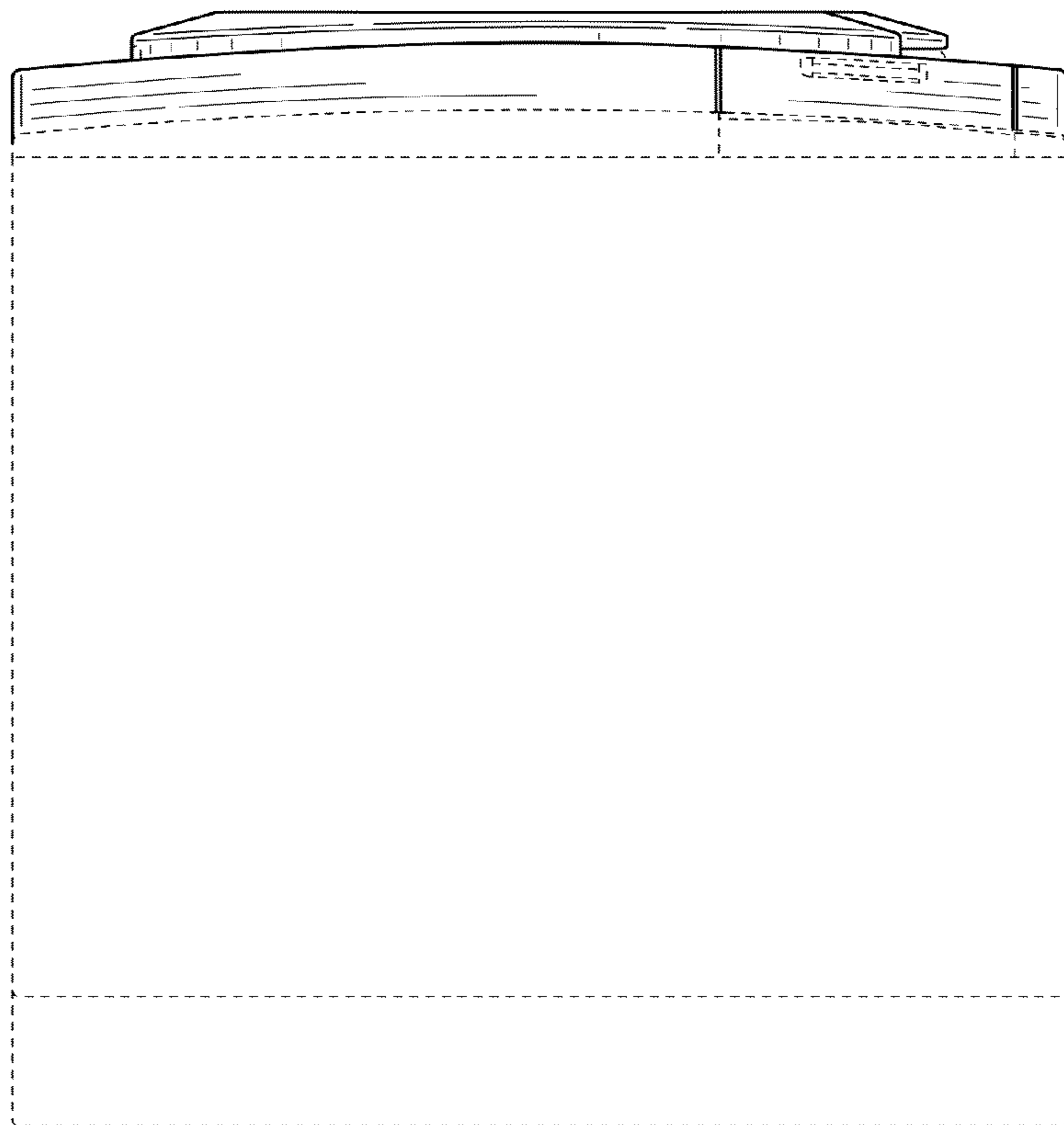
