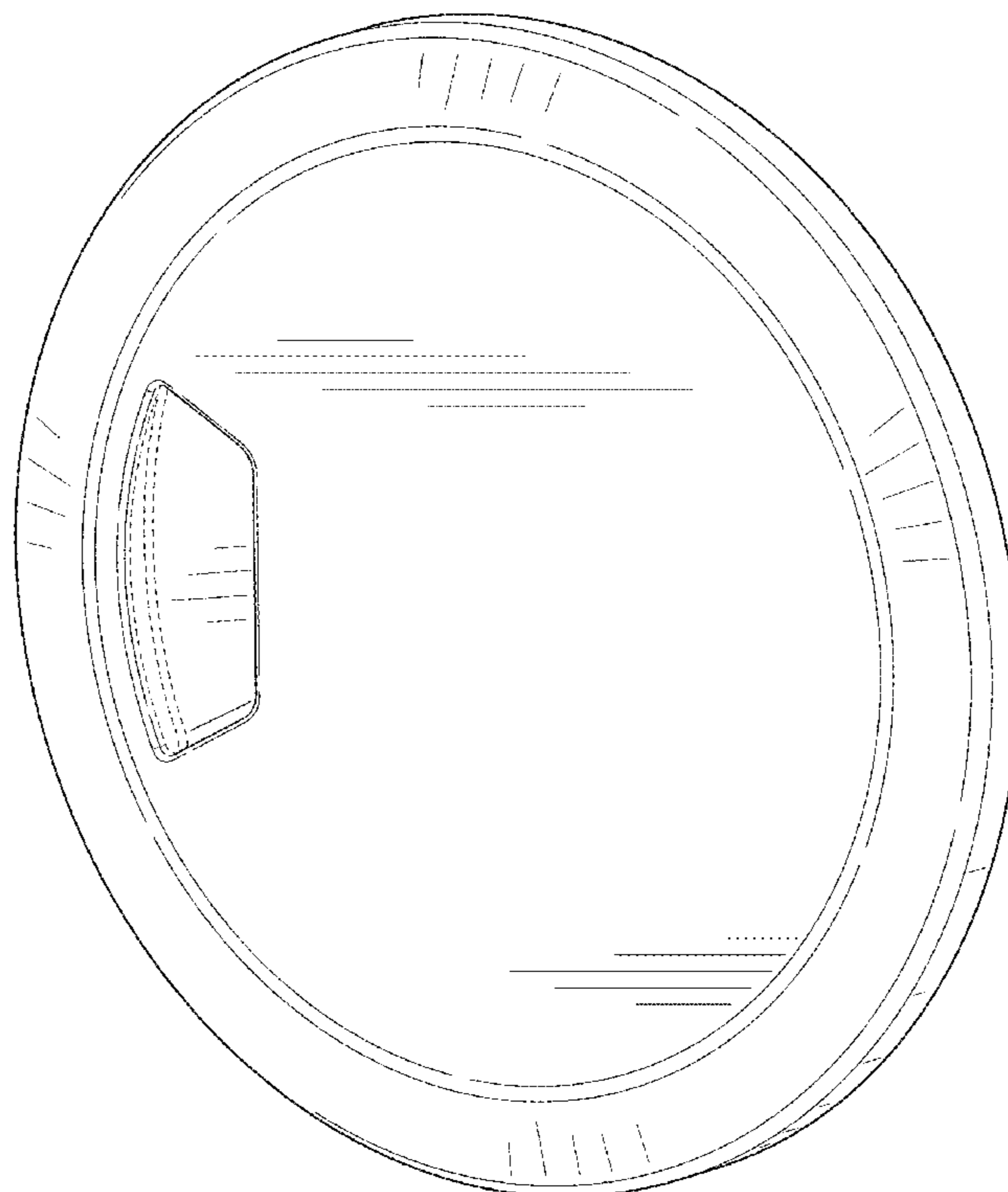

(57) **CLAIM**
The ornamental design for a door for a laundry appliance, as shown and described.

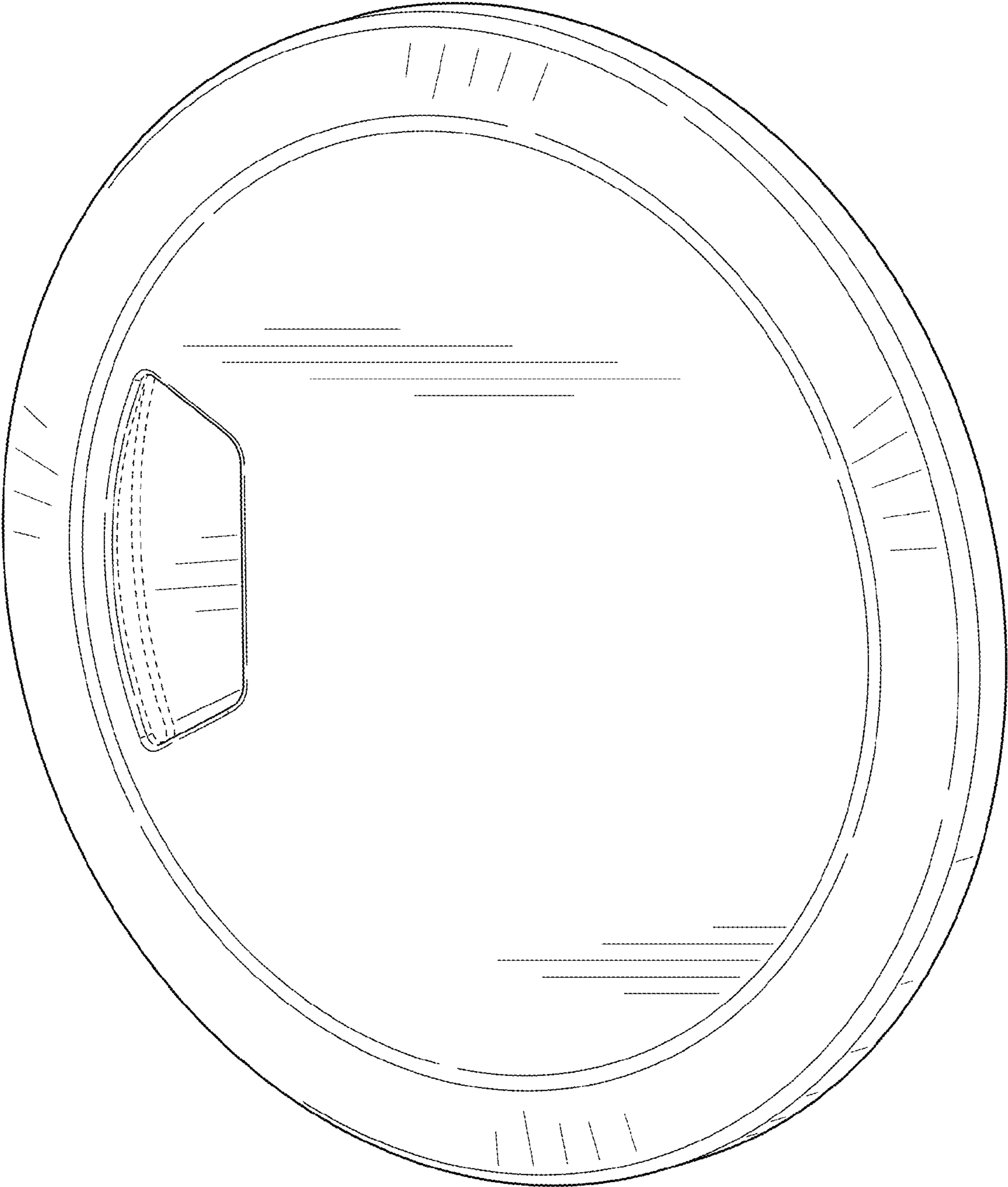

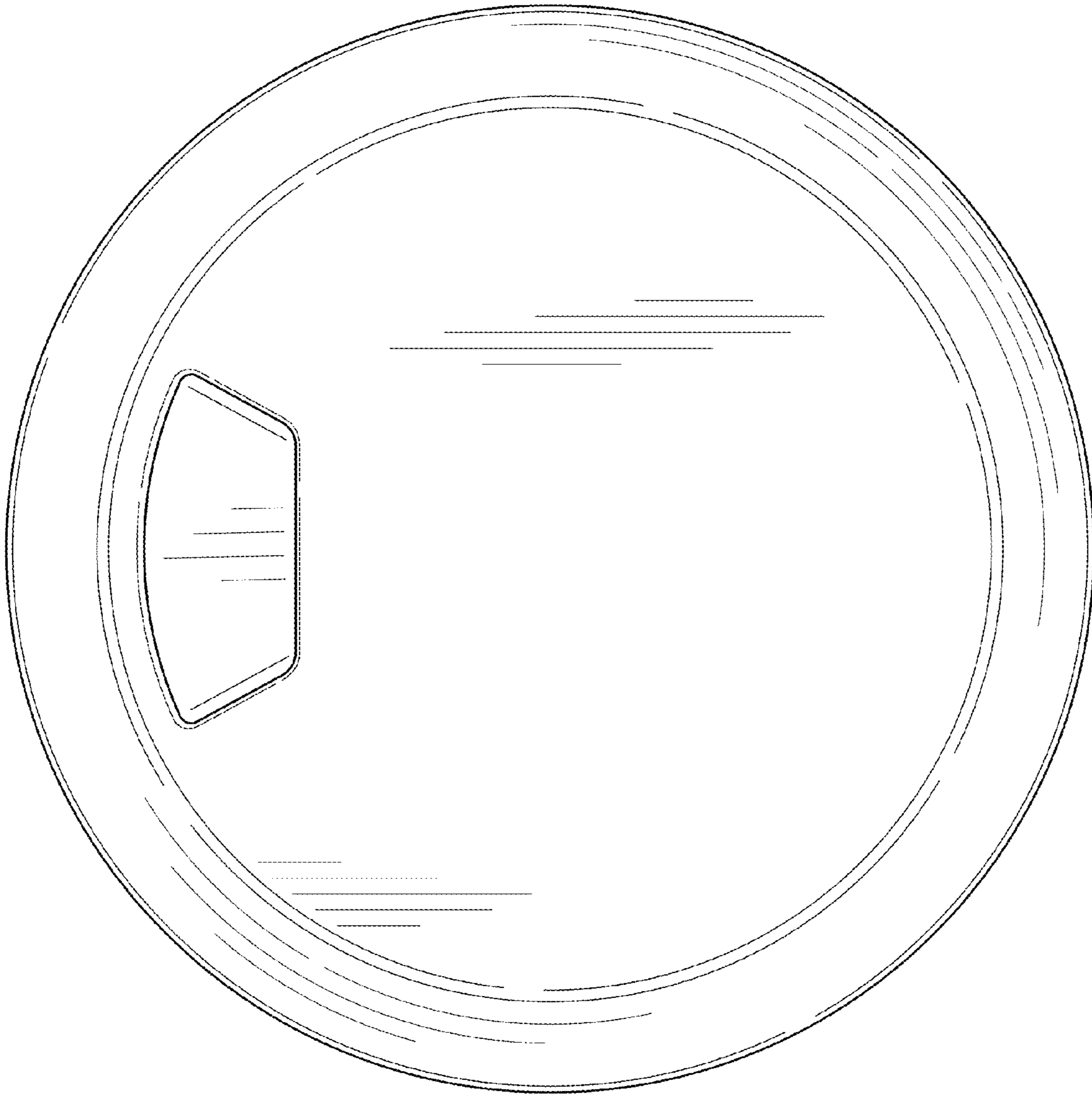

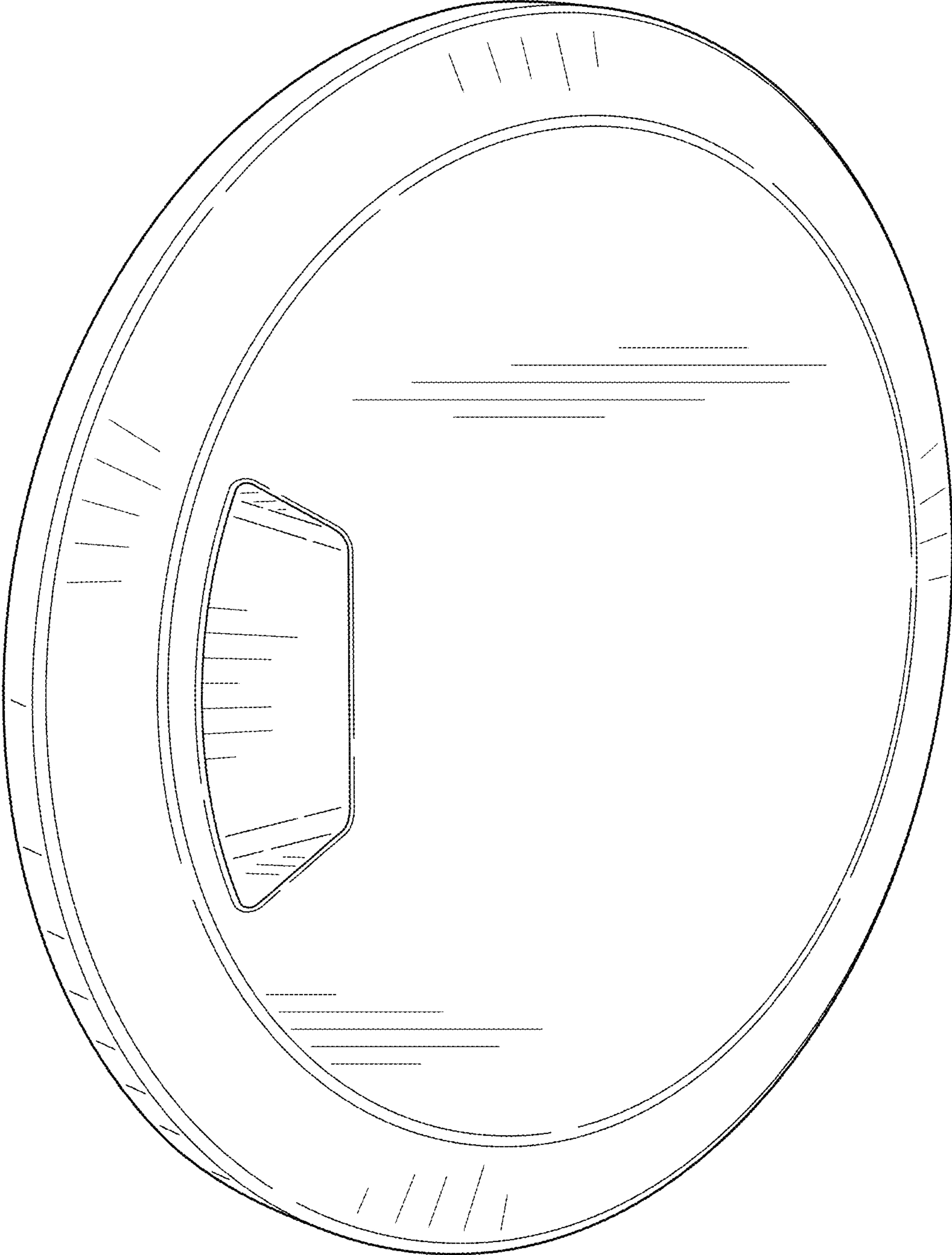
