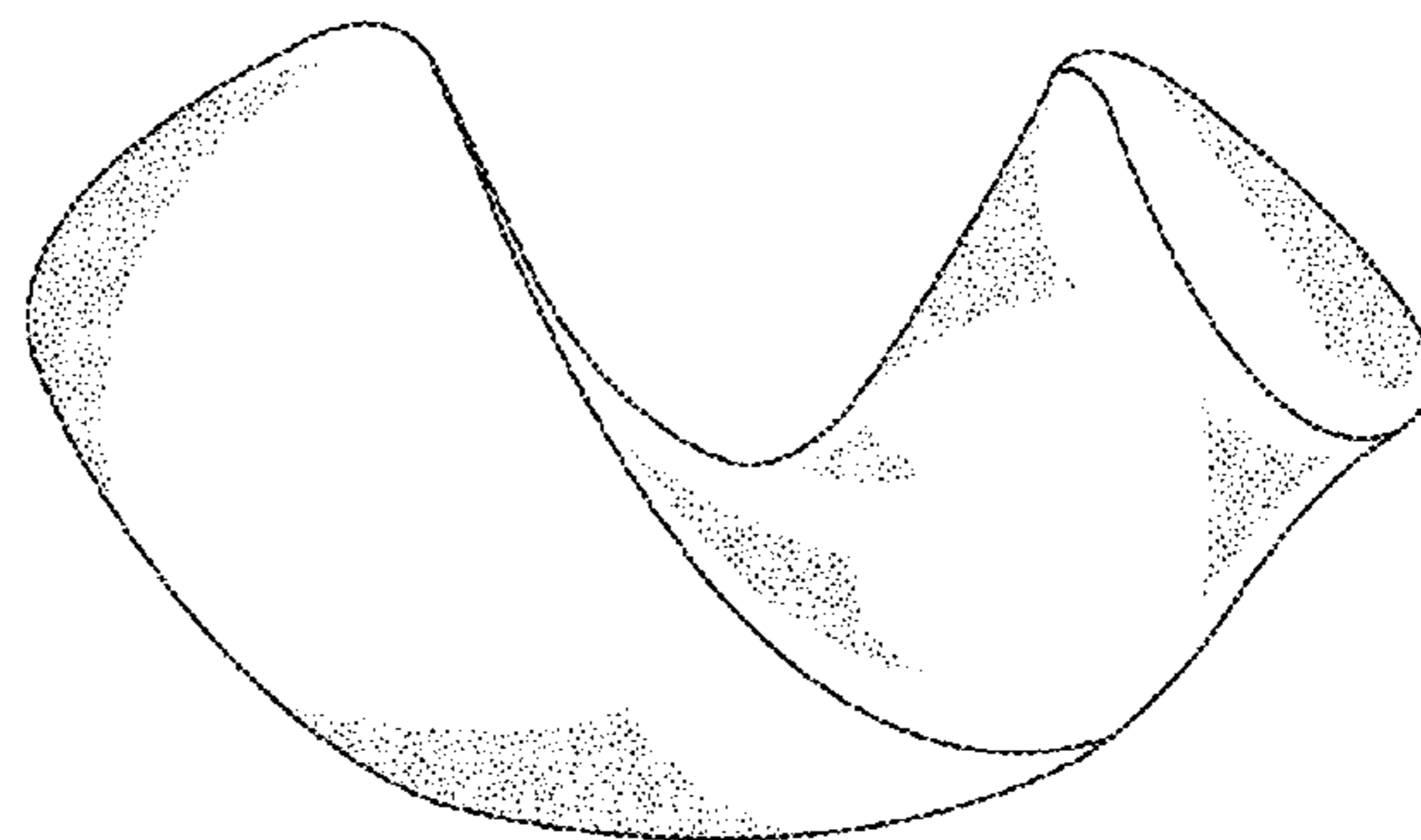
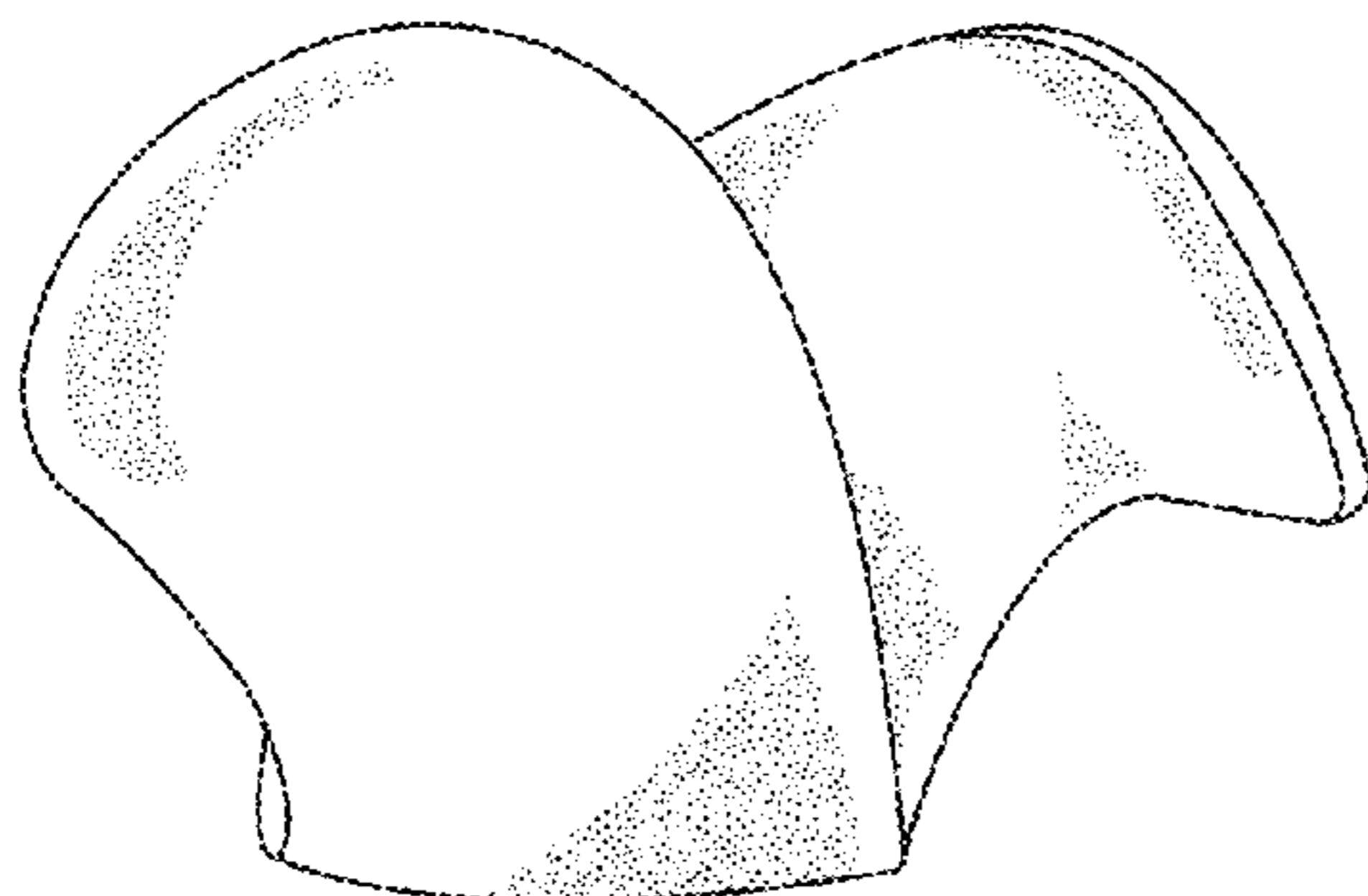
(57) **CLAIM**

The ornamental design for a spiral potato piece, as shown.

**DESCRIPTION**

FIG. 1 is a left end elevational view showing the spiral potato piece embodying the new design;  
 FIG. 2 is a right end elevational view thereof;  
 FIG. 3 is front plan view thereof;  
 FIG. 4 is a rear plan view thereof;  
 FIG. 5 is a top plan view thereof;  
 FIG. 6 is a bottom plan view thereof;  
 FIG. 7 is a left end elevational view showing a second embodiment of the spiral potato piece;  
 FIG. 8 is a right end elevational view of the alternative embodiment of FIG. 7;  
 FIG. 9 is a front plan view of the alternative embodiment of FIG. 7;  
 FIG. 10 is a rear plan view of the alternative embodiment of FIG. 7;  
 FIG. 11 is a top plan view of the alternative embodiment of FIG. 7; and,  
 FIG. 12 is a bottom plan view of the alternative embodiment of FIG. 7.

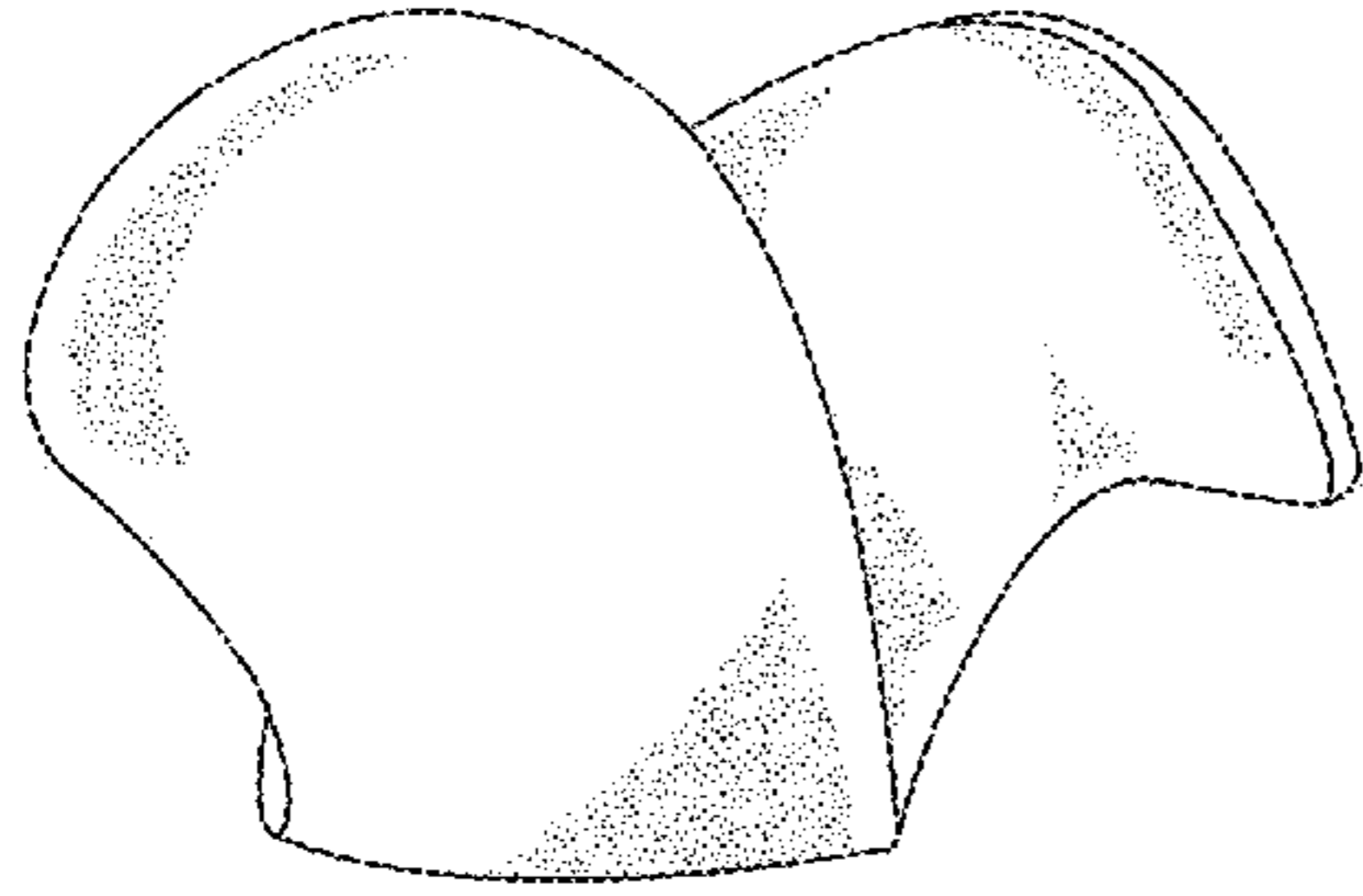

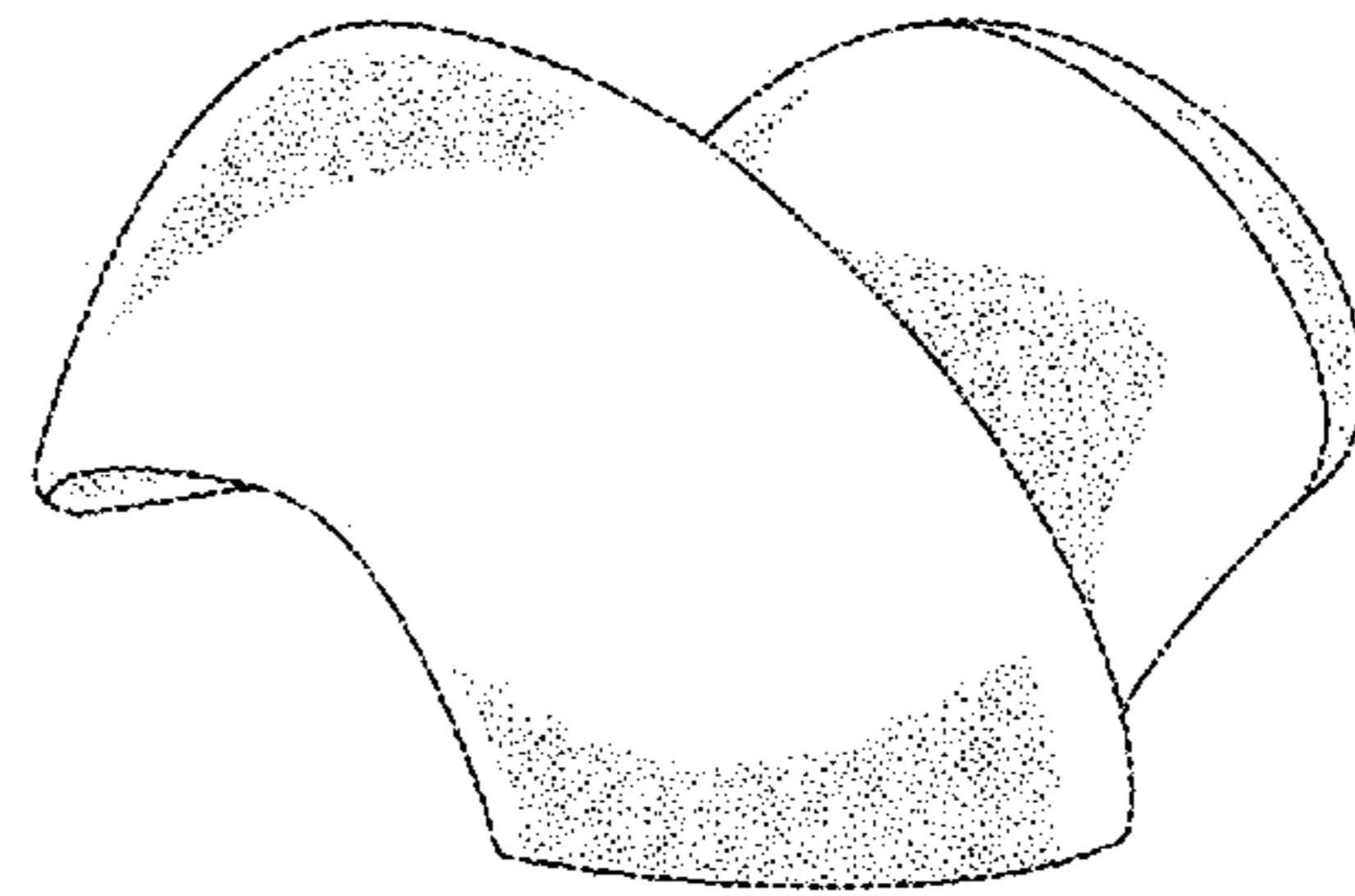

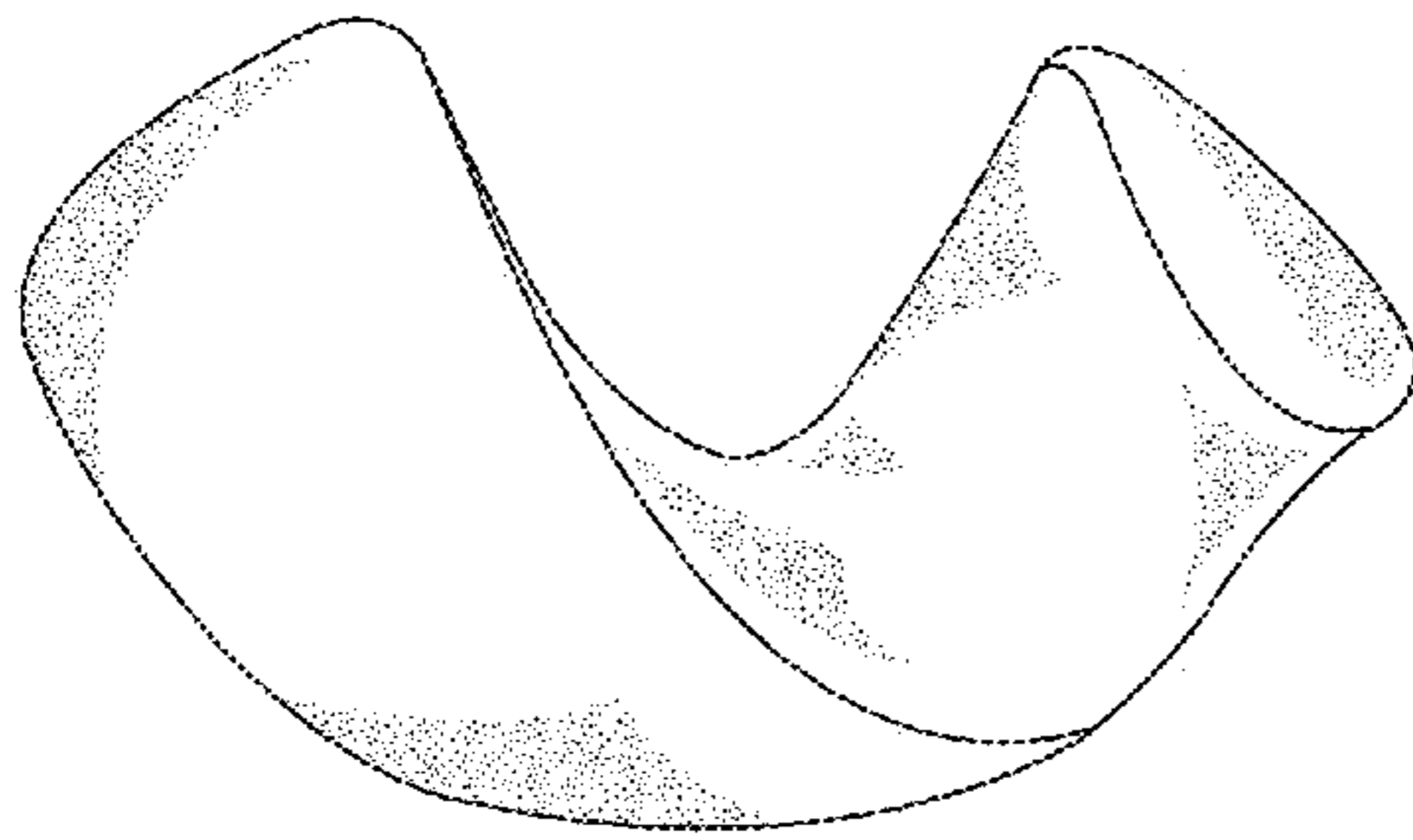

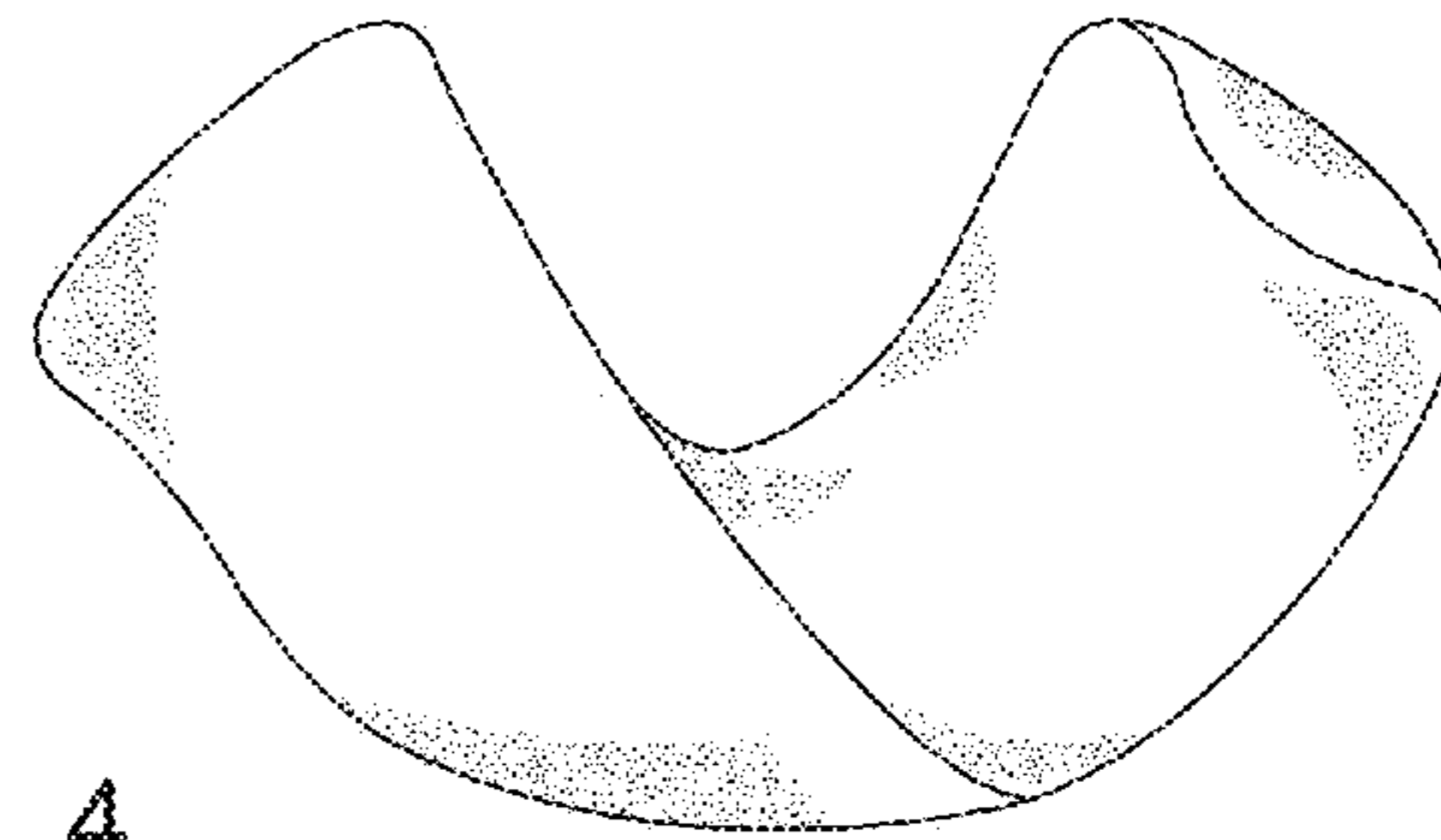

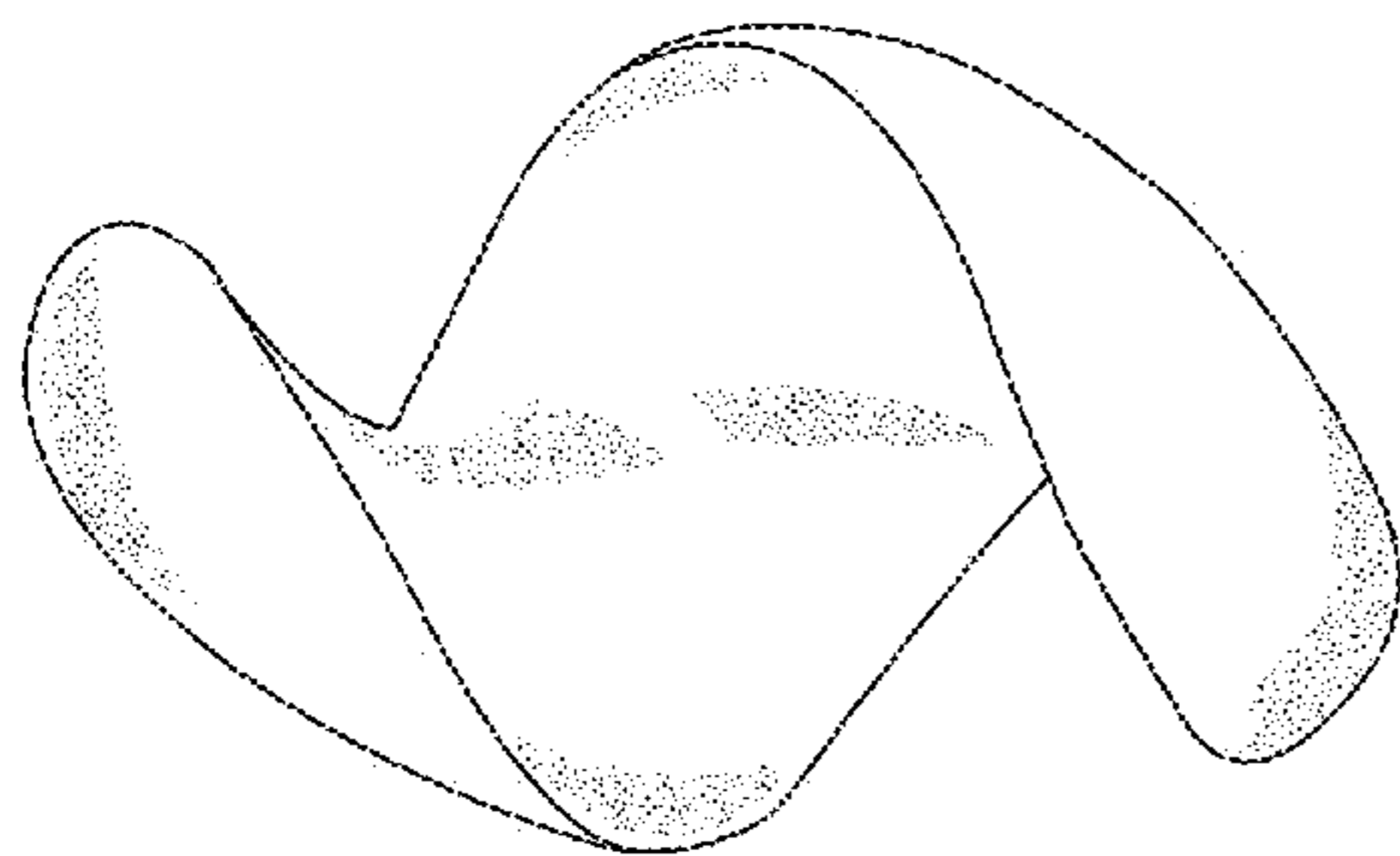

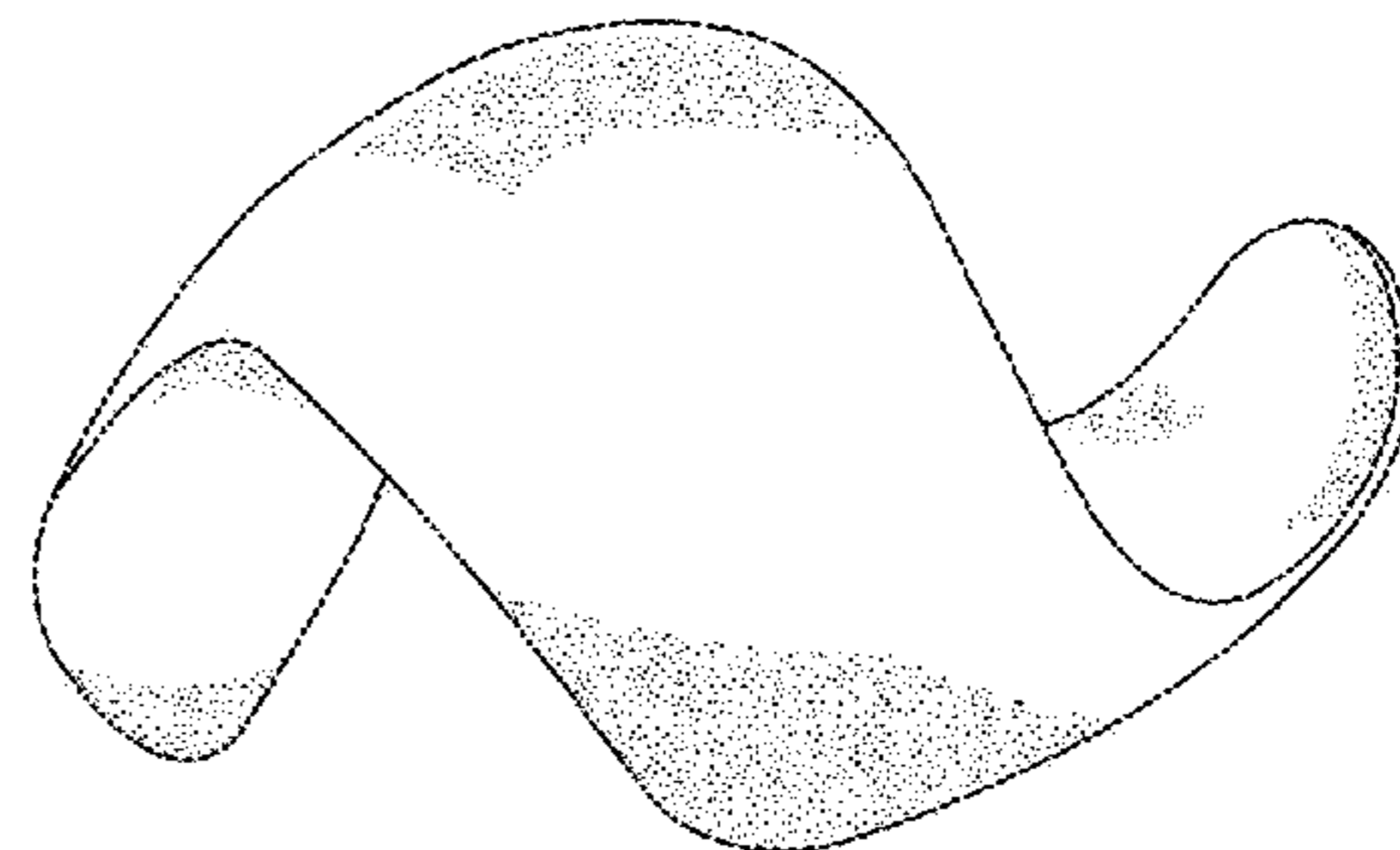

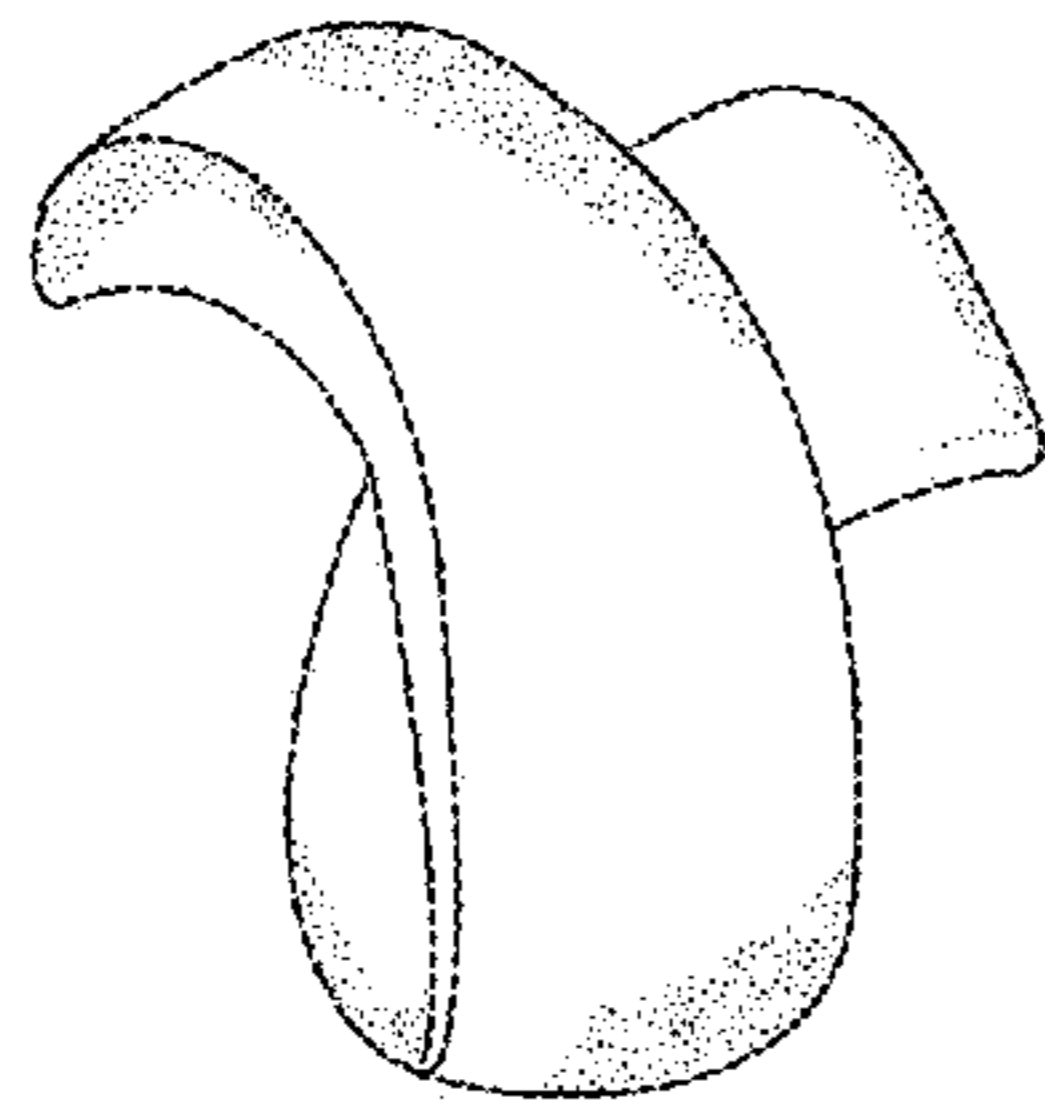

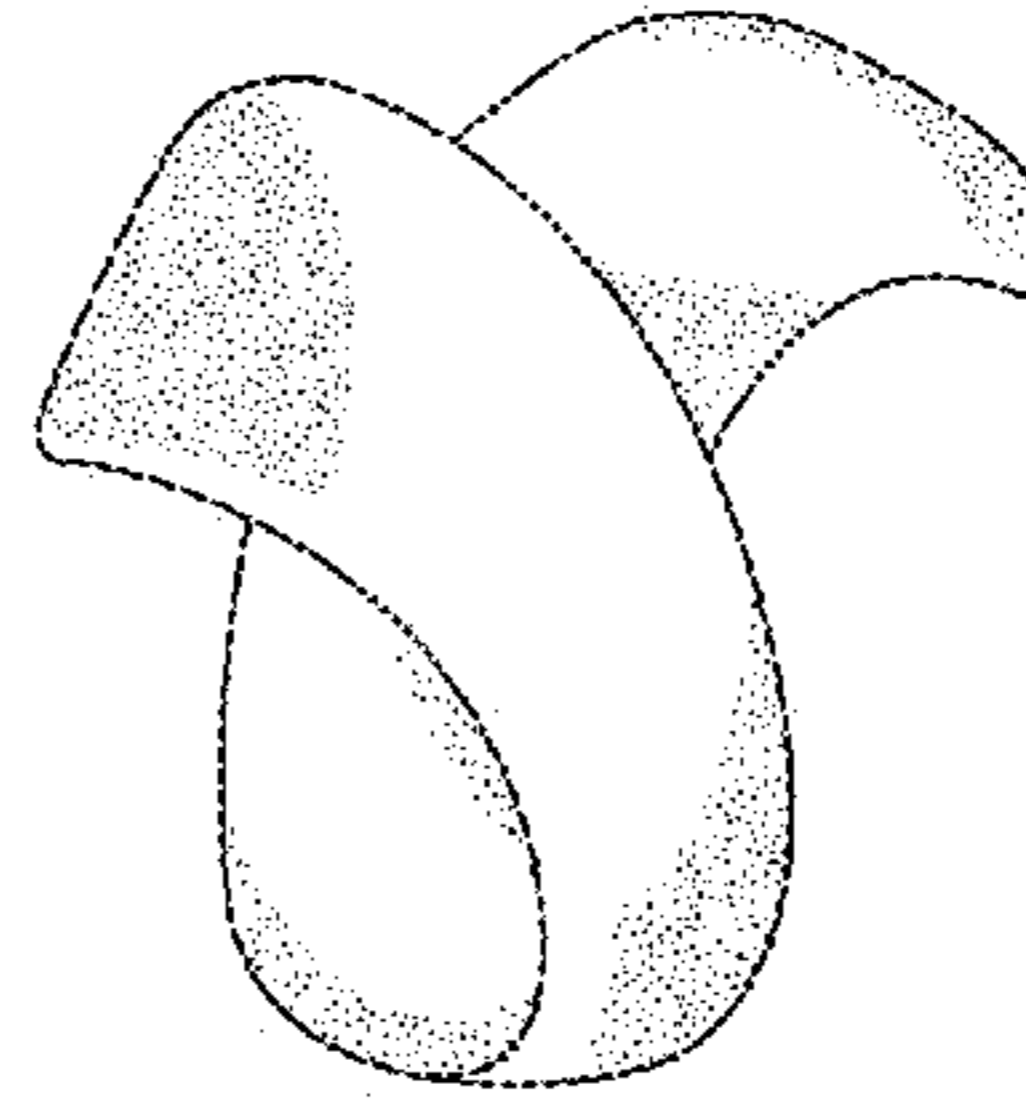

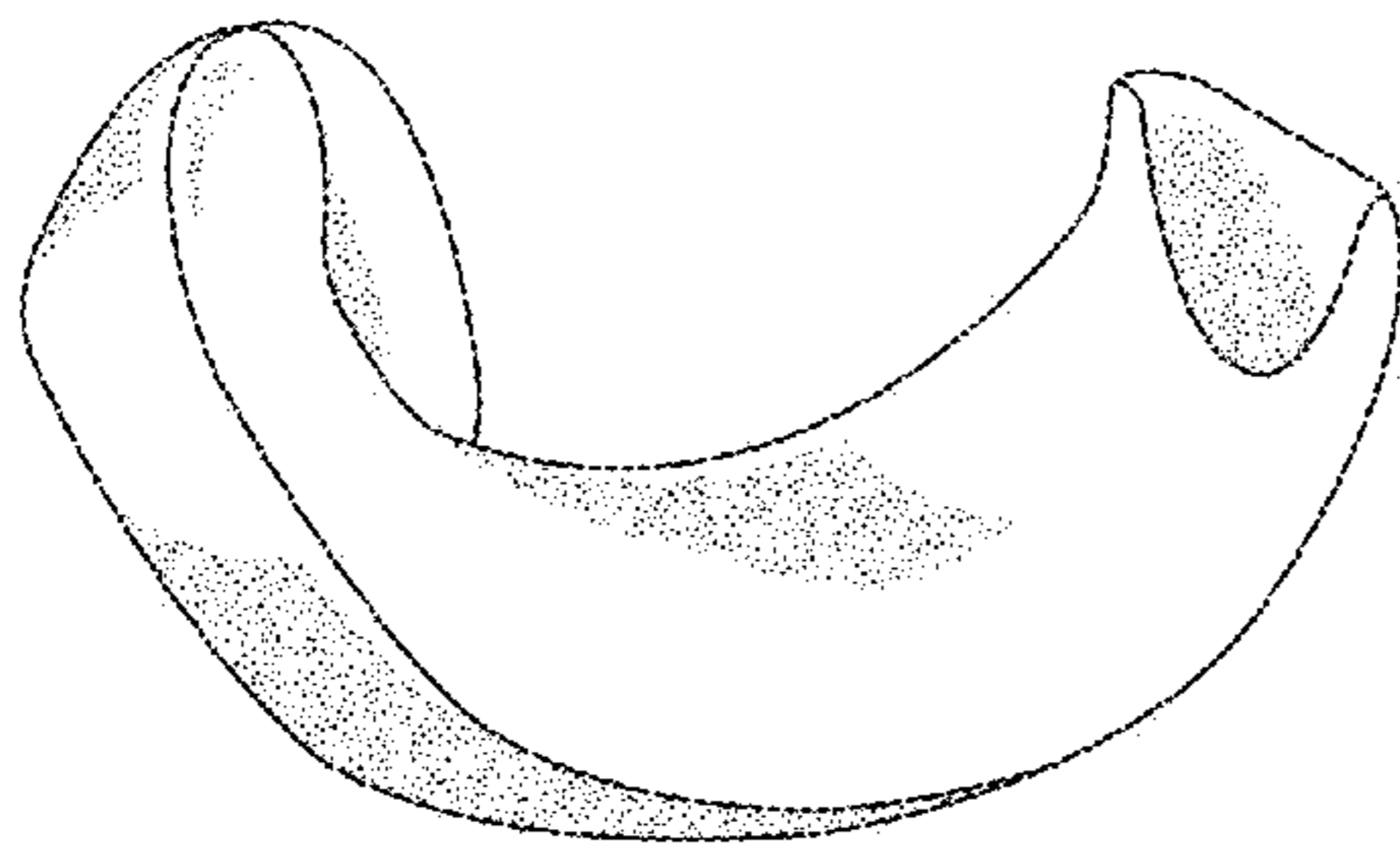

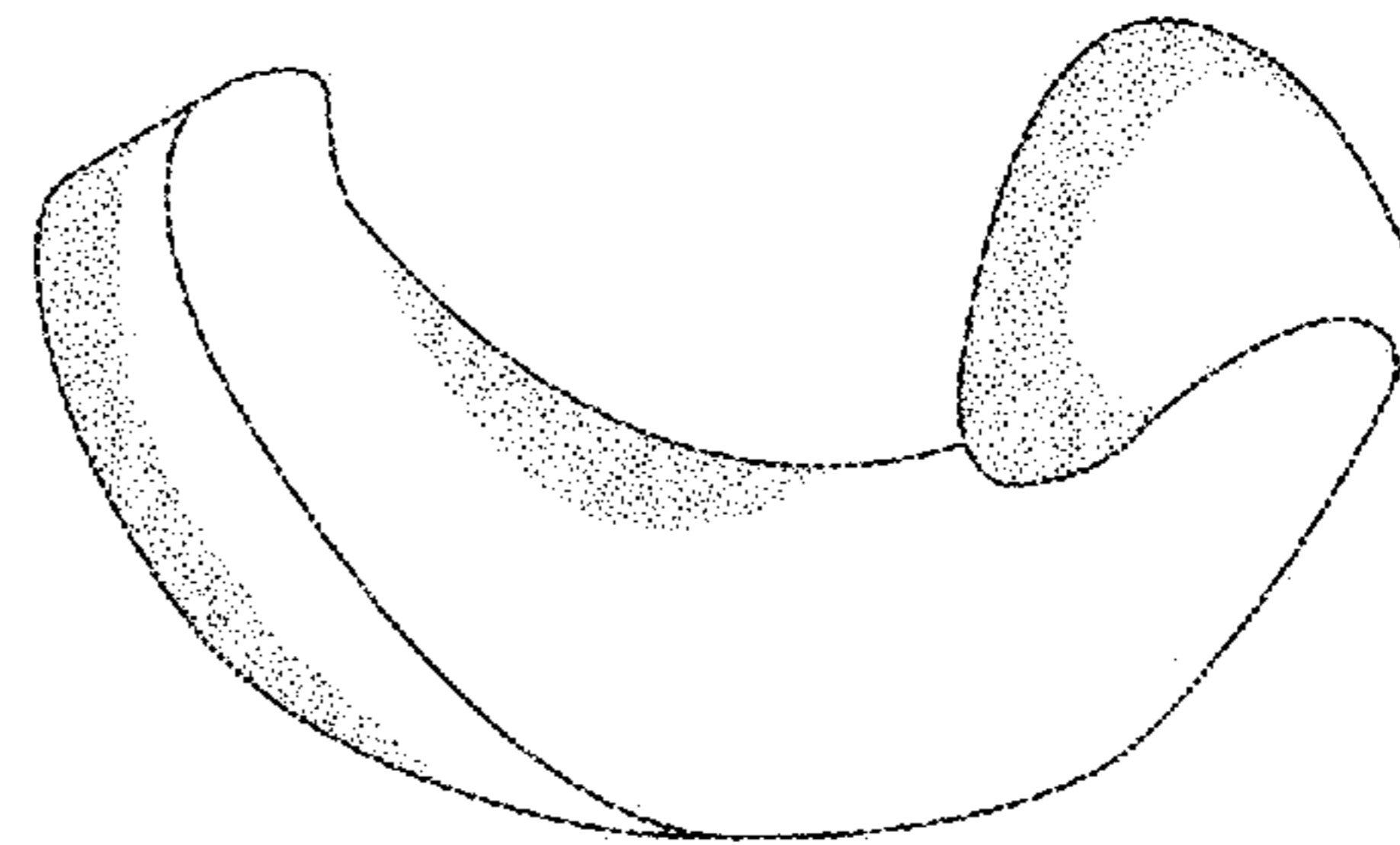

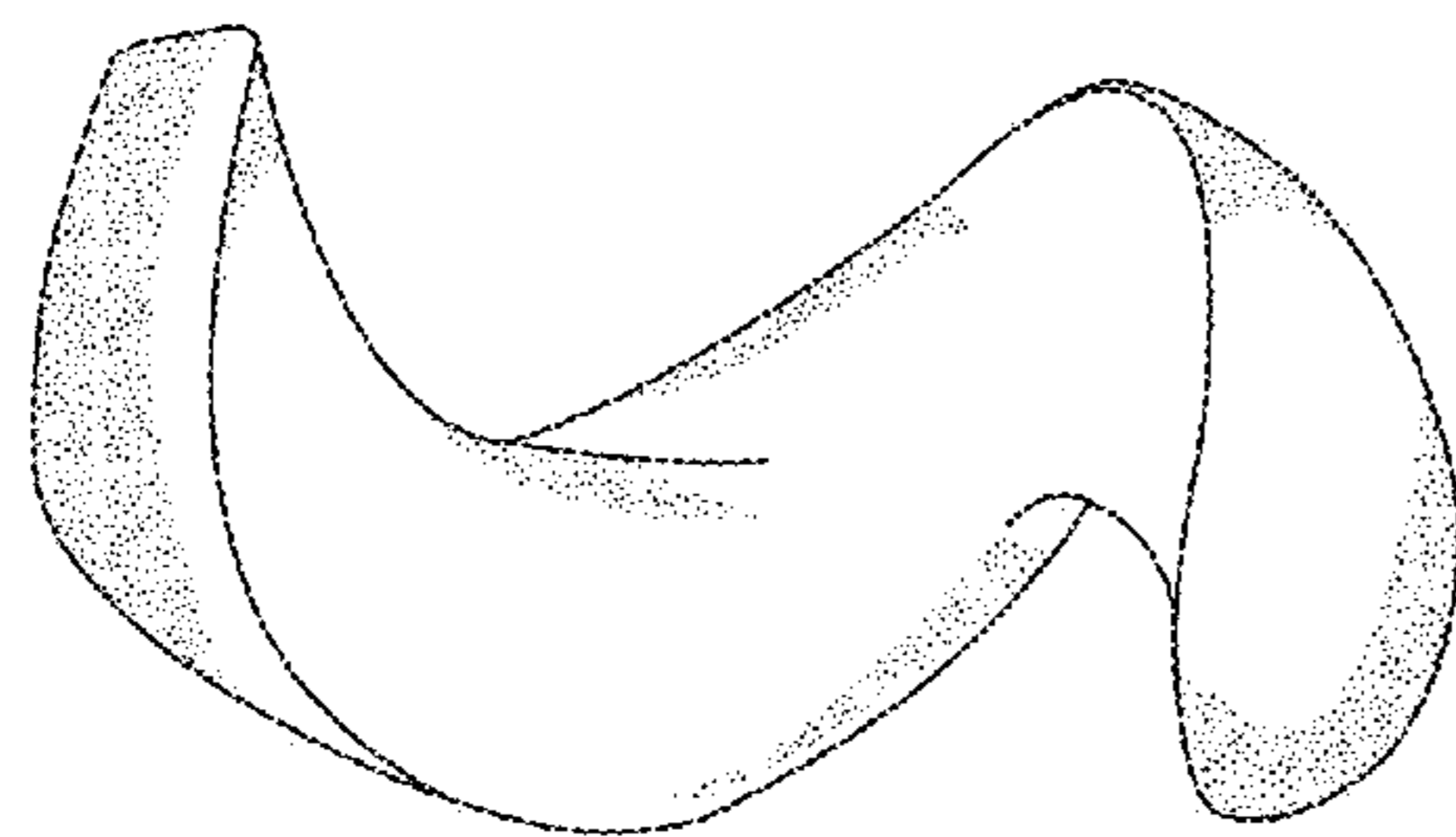

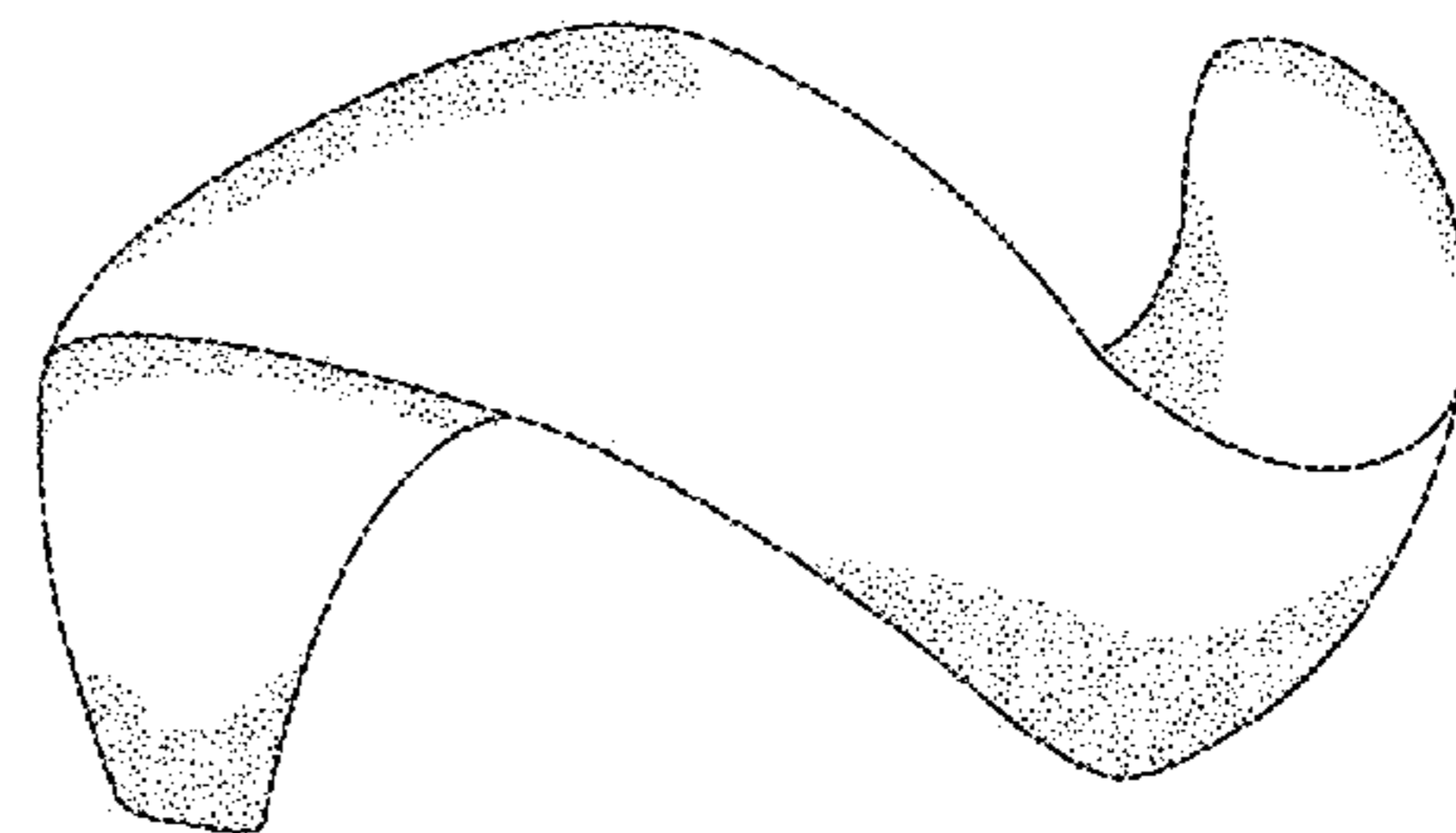
