FIG. 7 is a rear elevation view thereof.

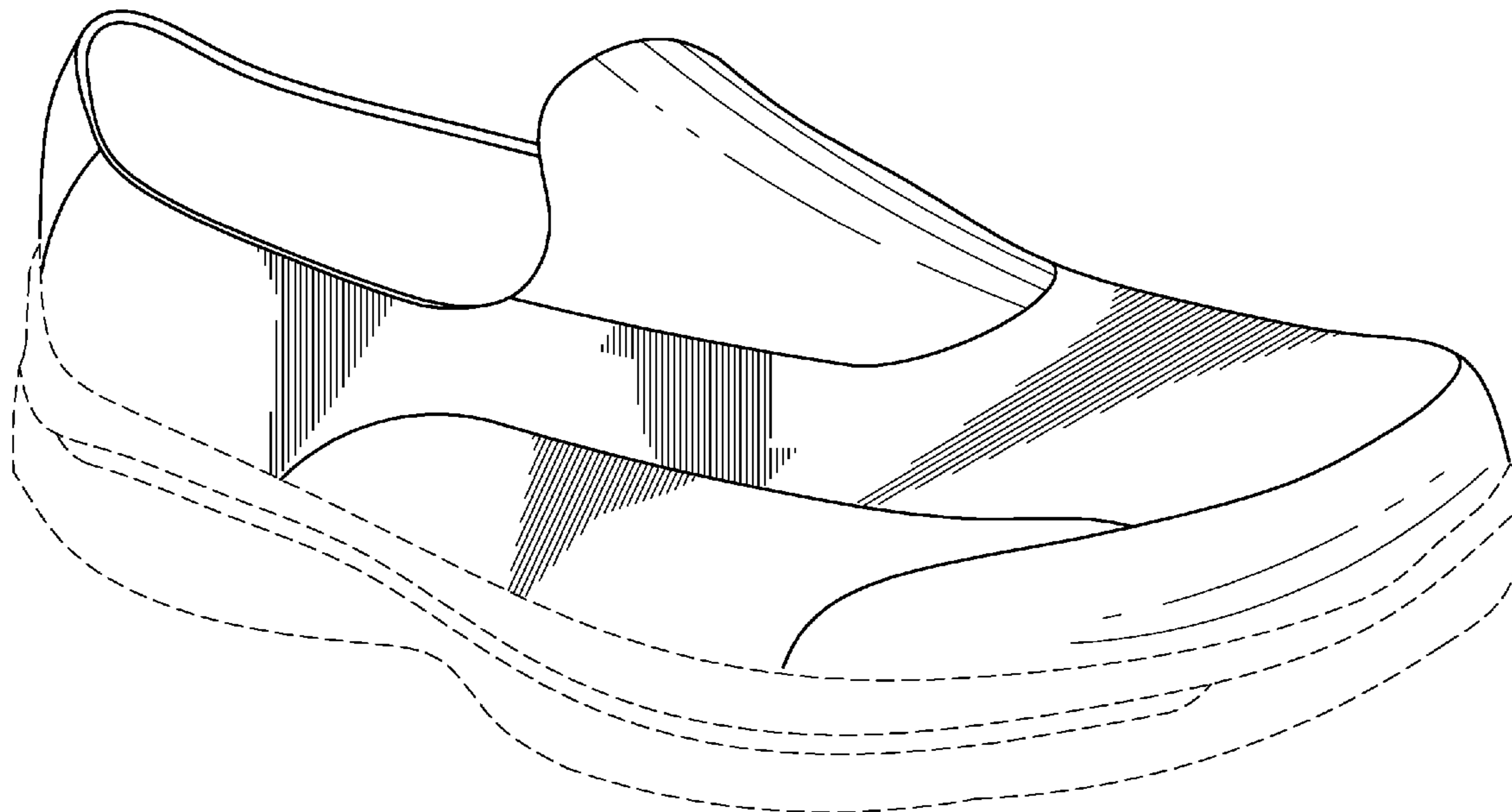
Broken lines showing the remainder of the shoe in the figures are for environment only and form no part of the claimed invention.

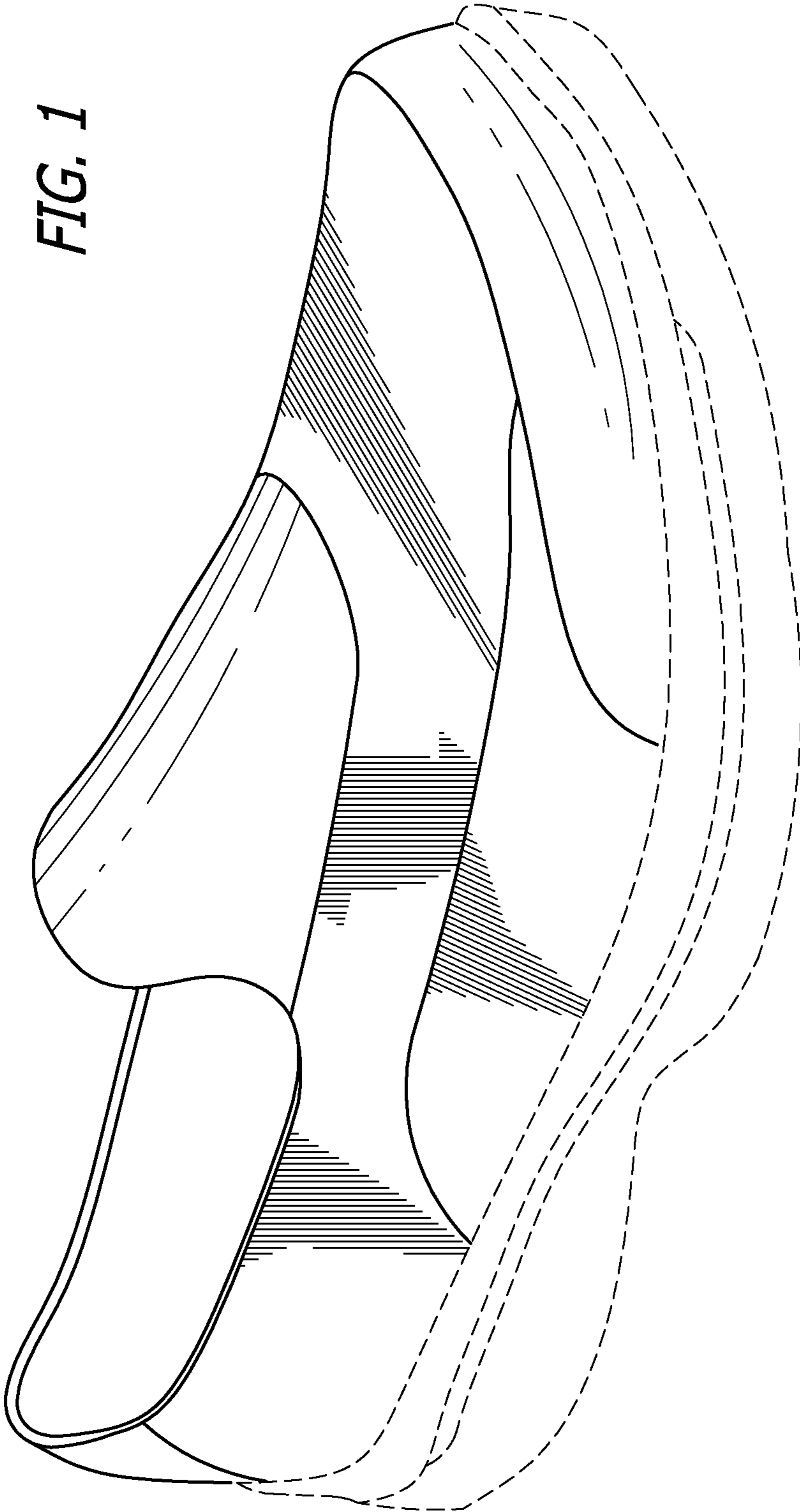

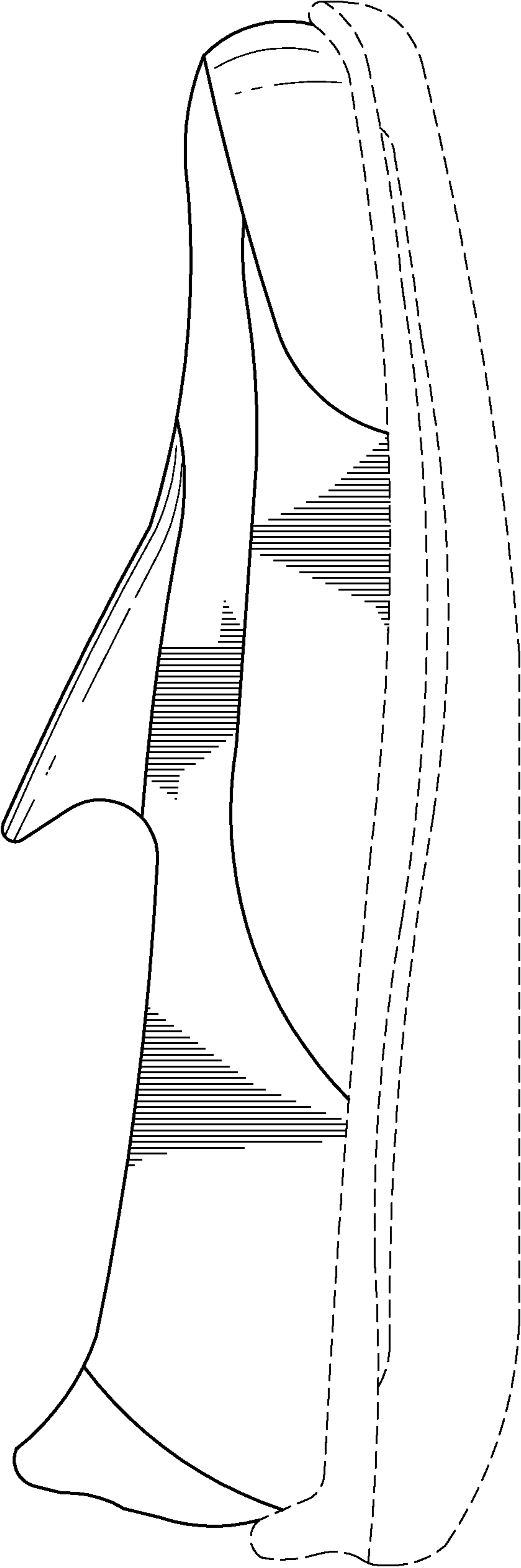
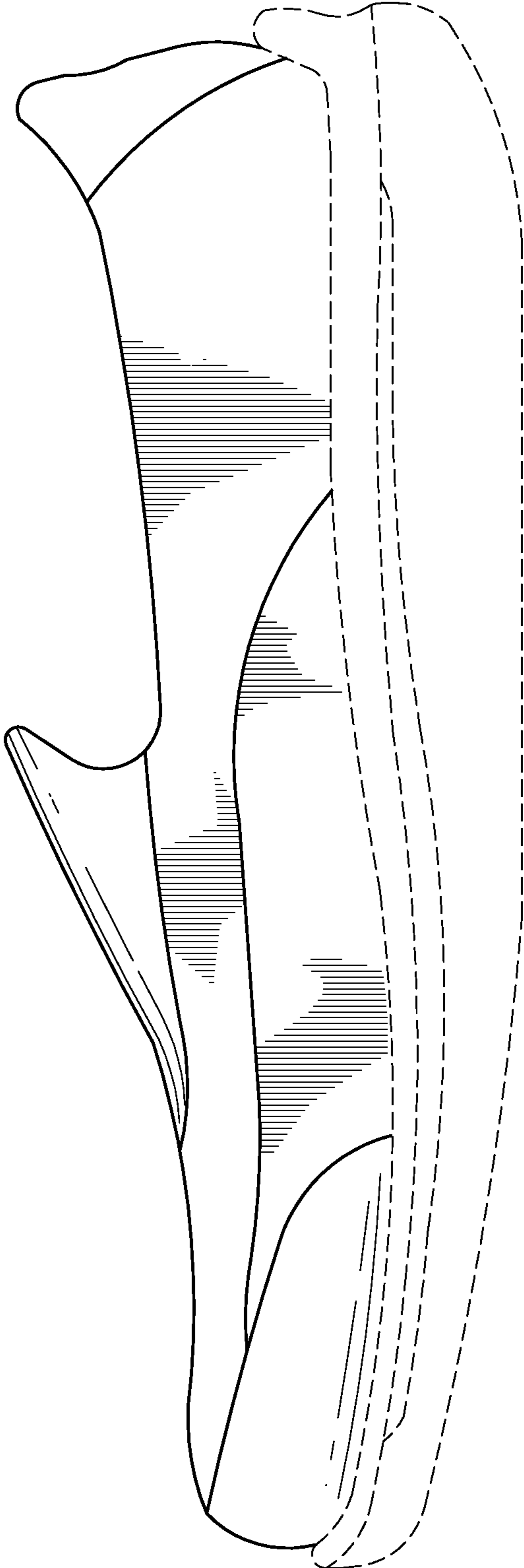

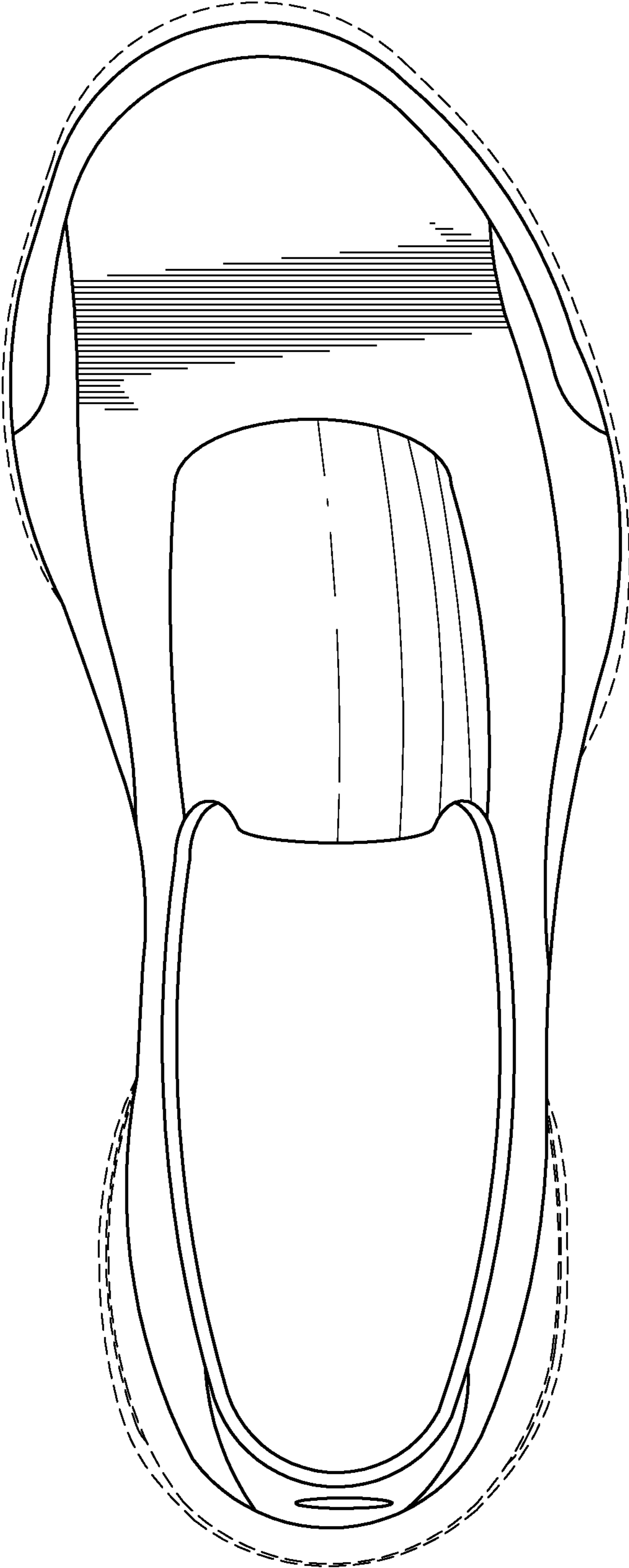
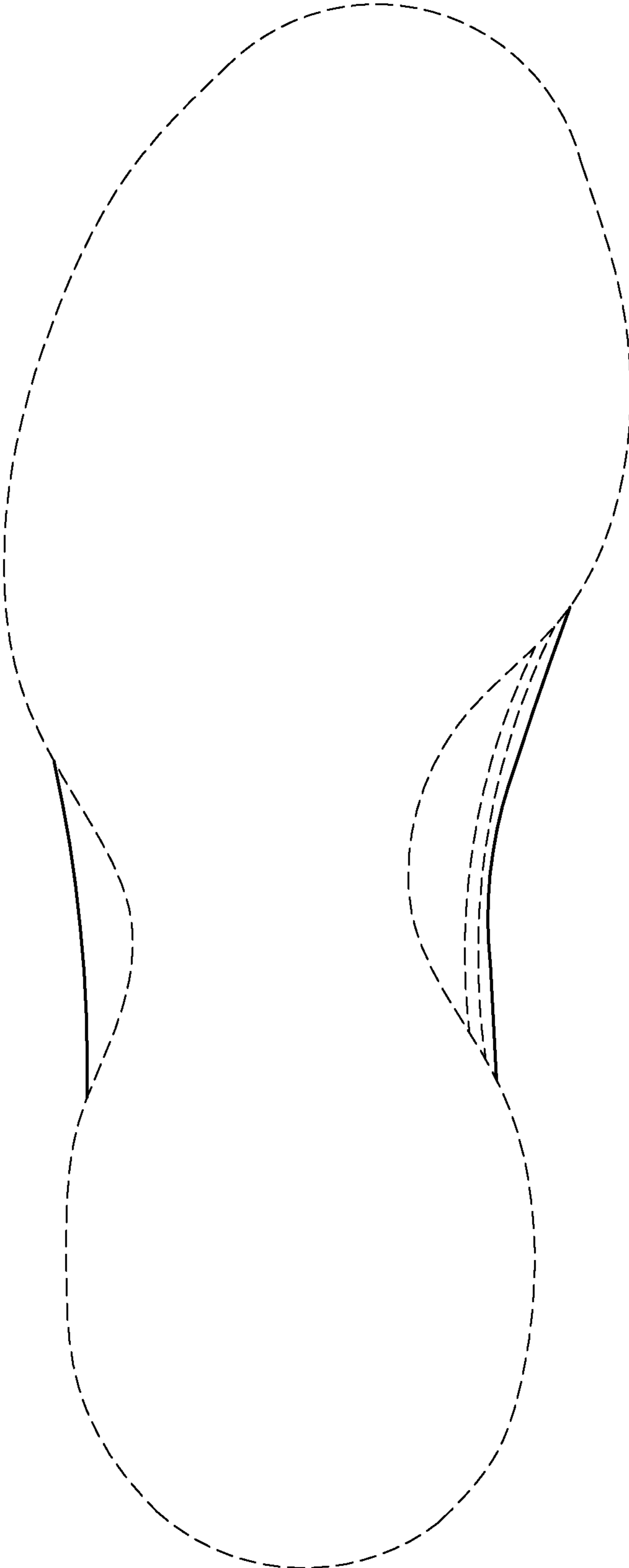

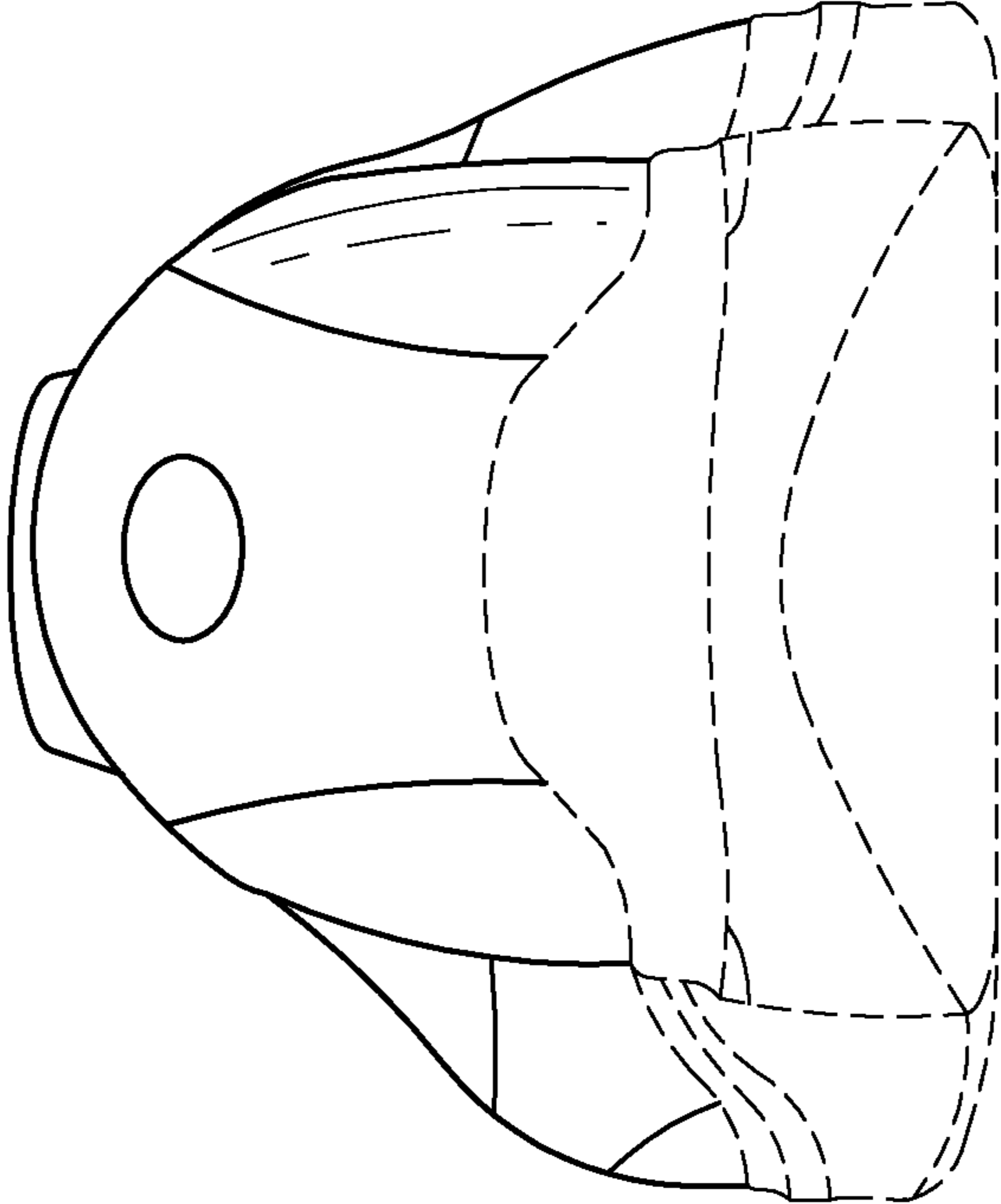
