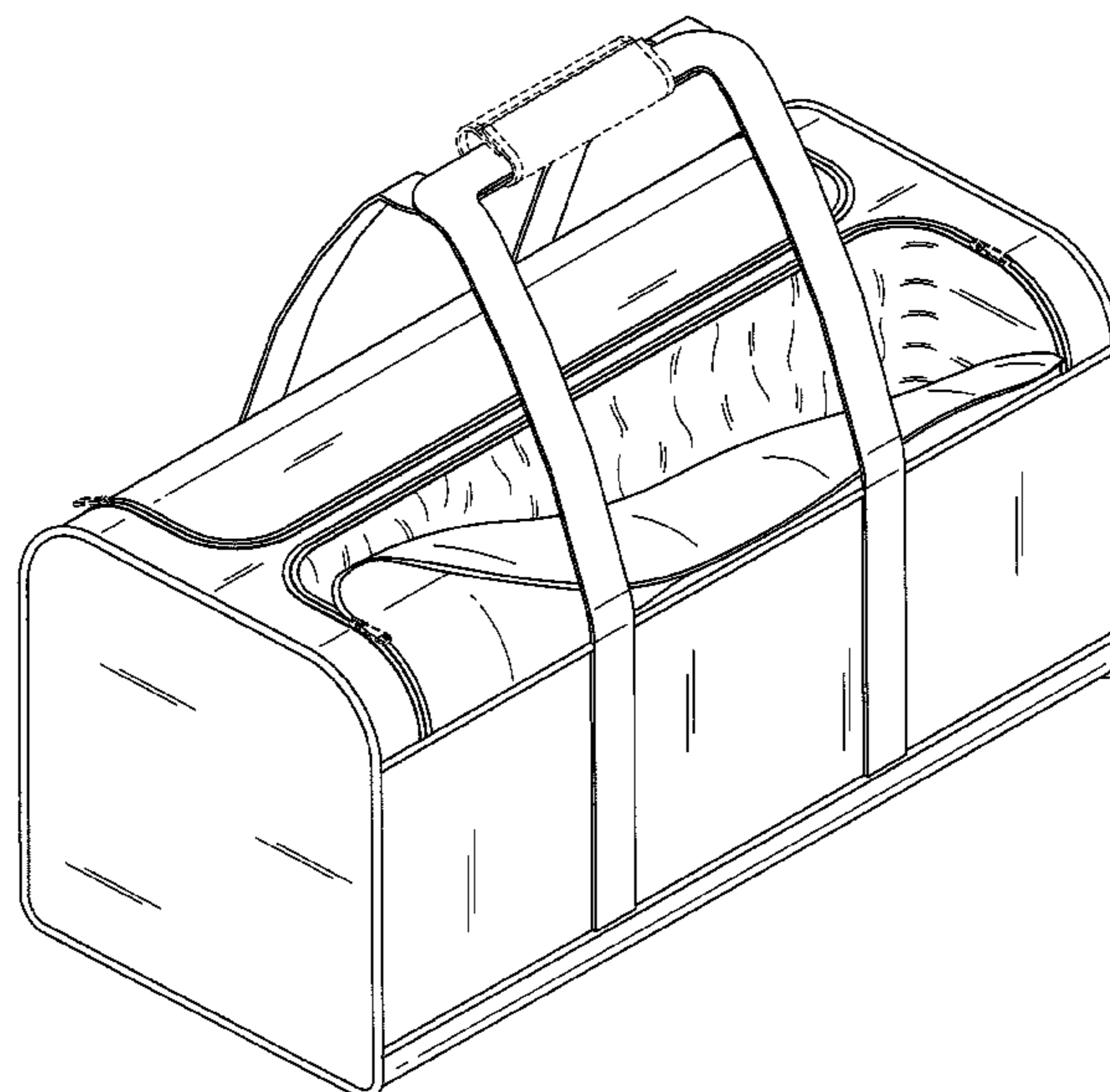
(57) **CLAIM**

The ornamental design for a duffle bag with rectangular pockets, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the duffle bag with rectangular pockets, showing my new design;  
FIG. 2 is a perspective view of the duffle bag with rectangular pockets showing one pocket in an open position;  
FIG. 3 is another perspective view of the duffle bag with rectangular pockets;  
FIG. 4 is a front elevational view thereof;  
FIG. 5 is a rear elevational view thereof;  
FIG. 6 is a left side view thereof;  
FIG. 7 is a right side view thereof;  
FIG. 8 is a top plan view thereof; and,  
FIG. 9 is a bottom plan view thereof.  
The broken lines showing the handle grip and zipper tag form no part of the claimed design.

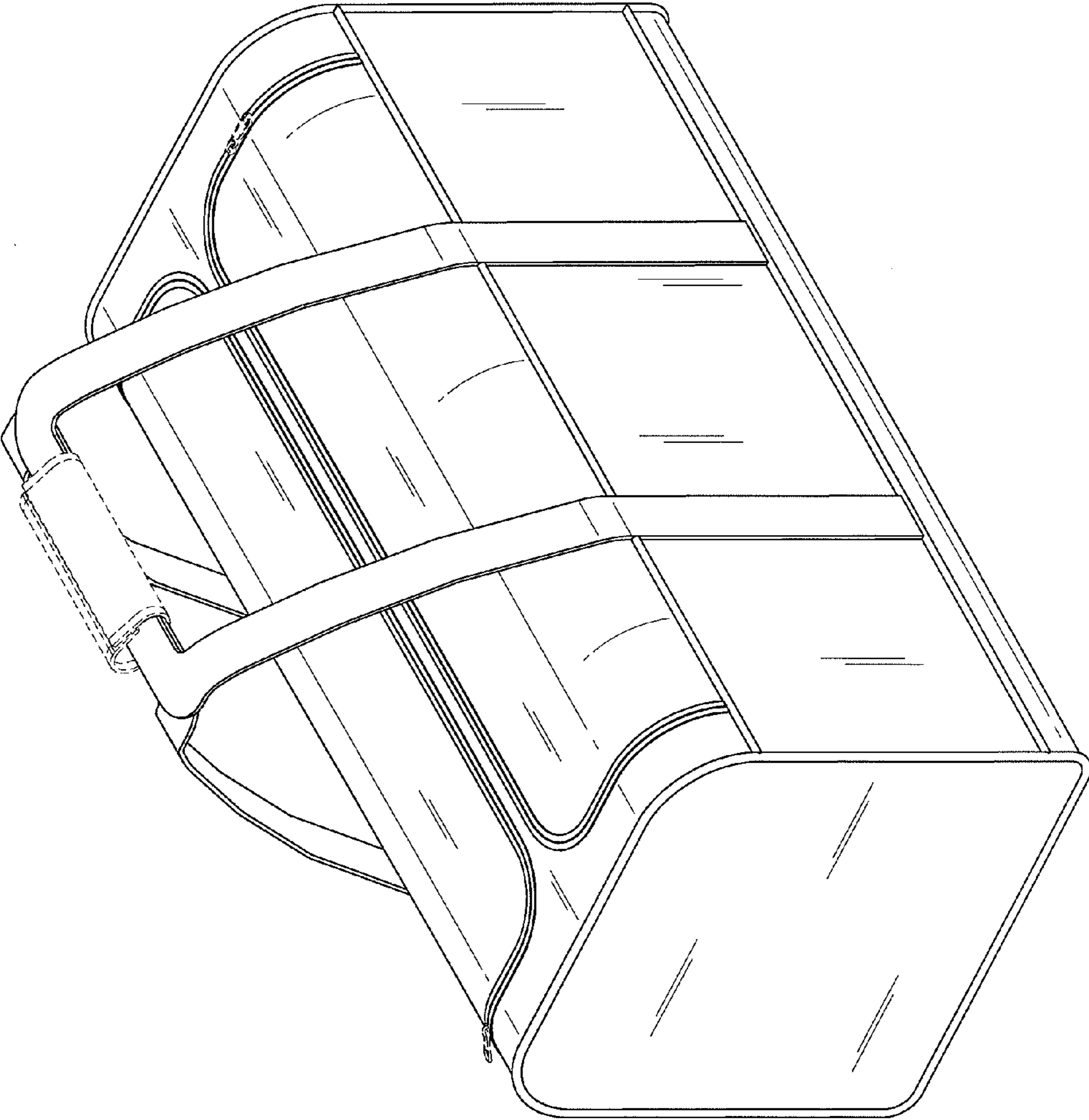

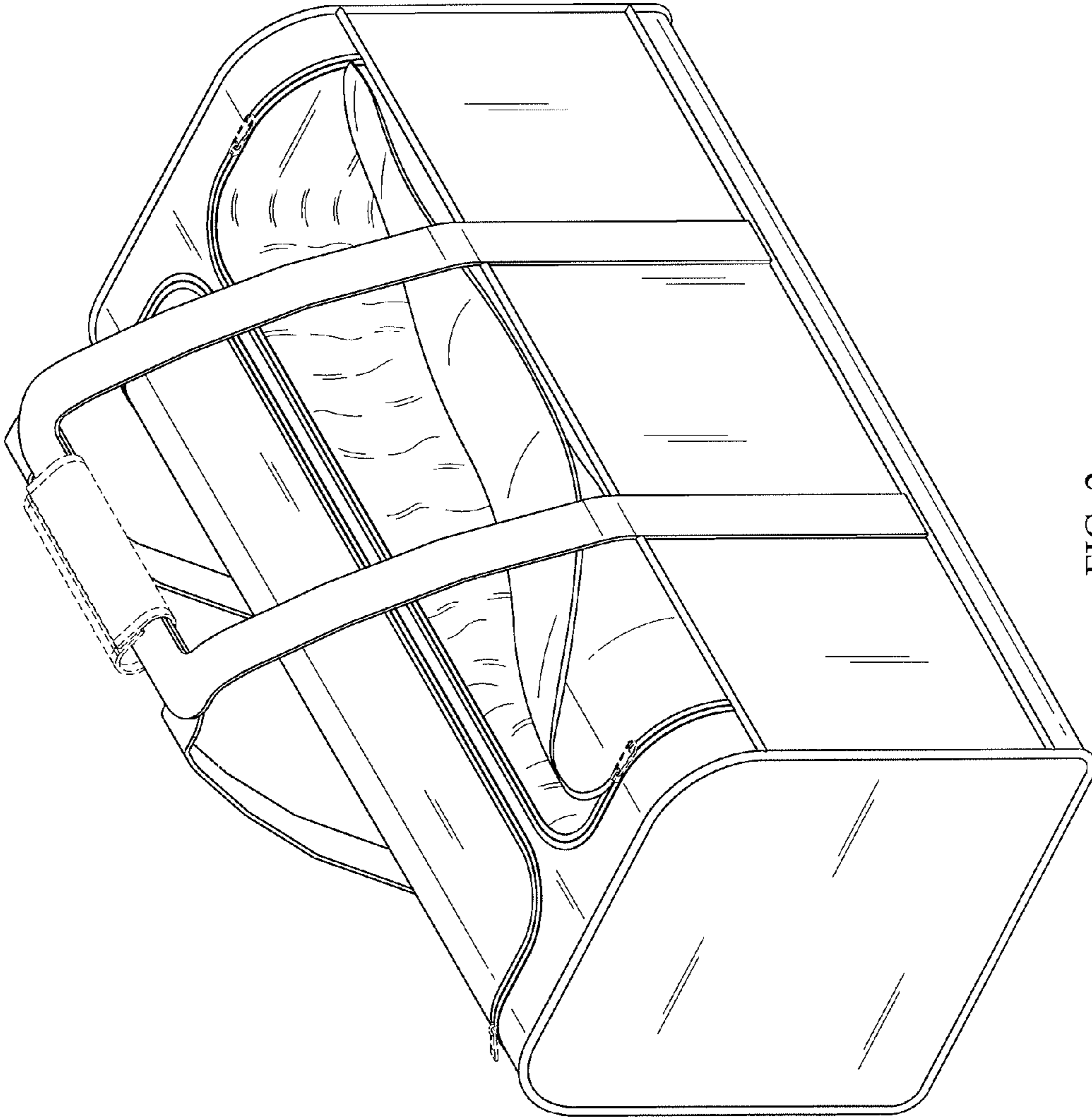

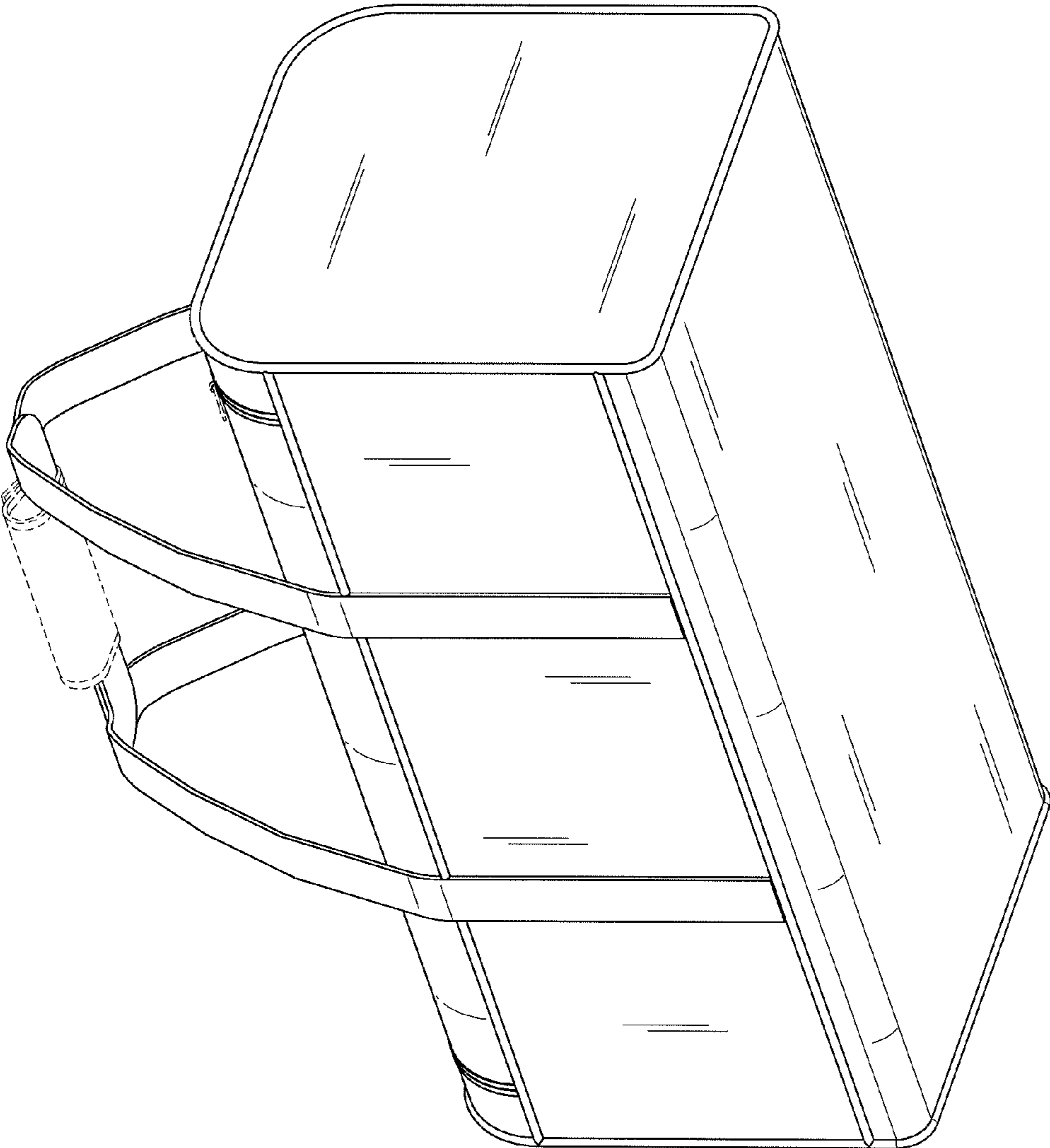

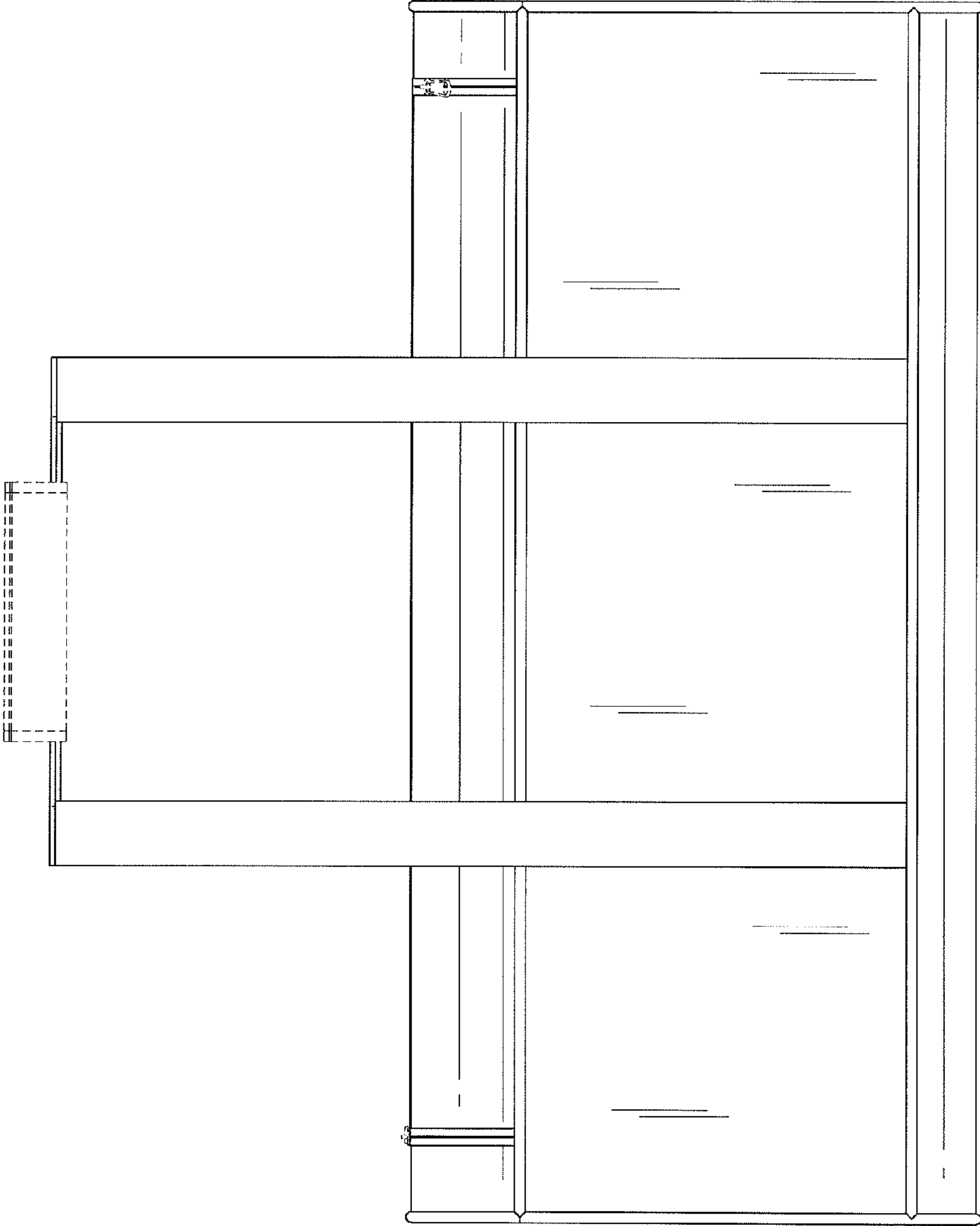

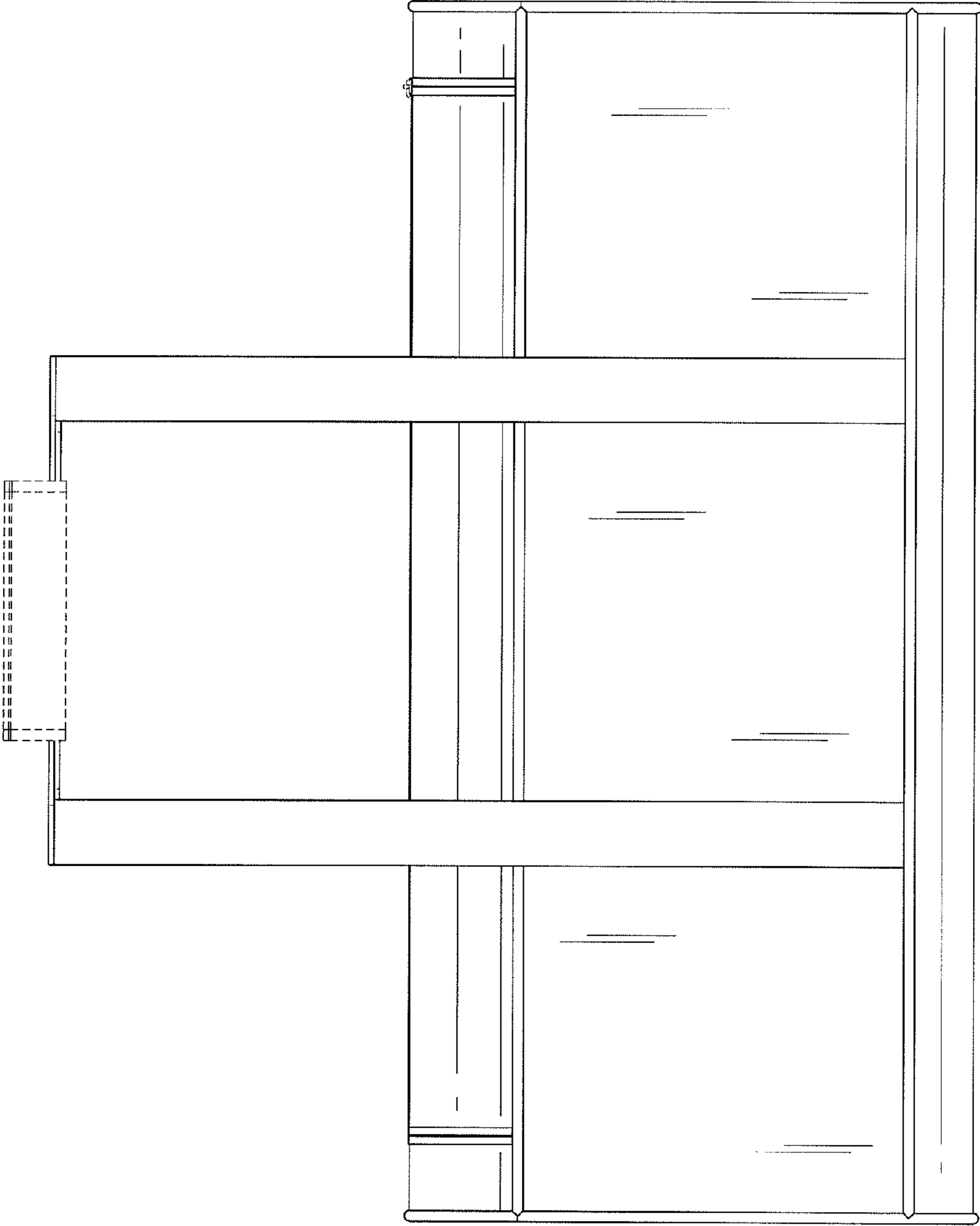

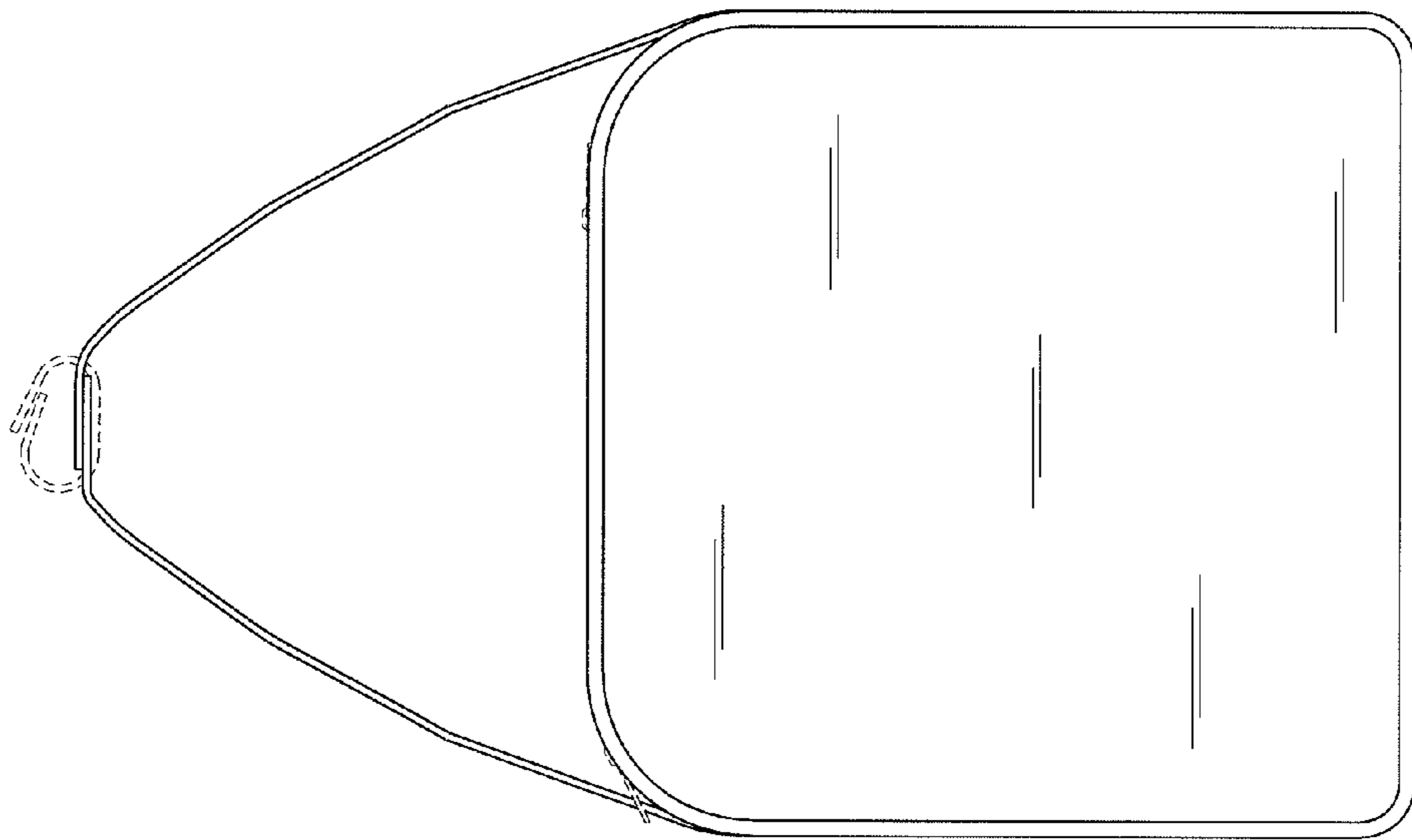

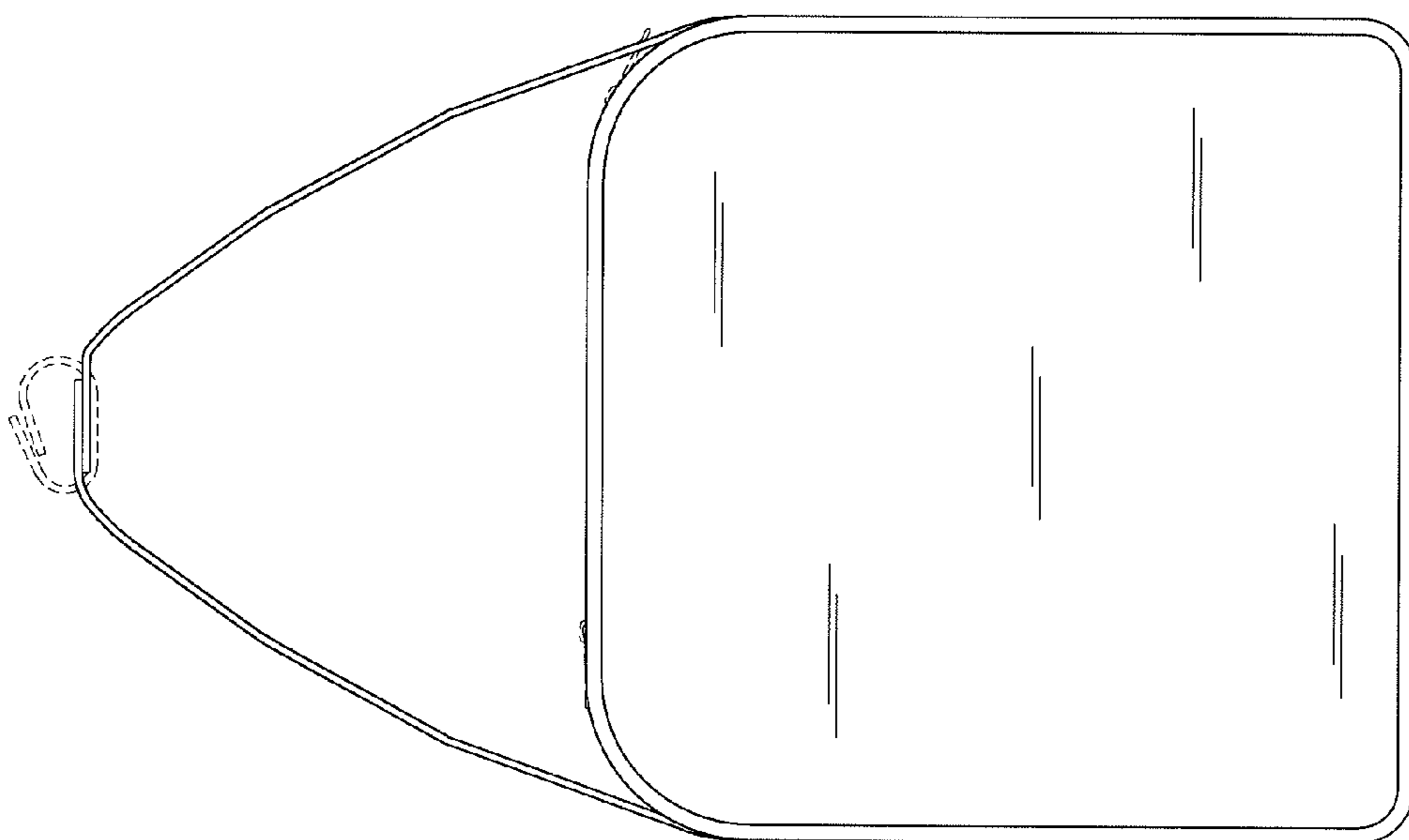

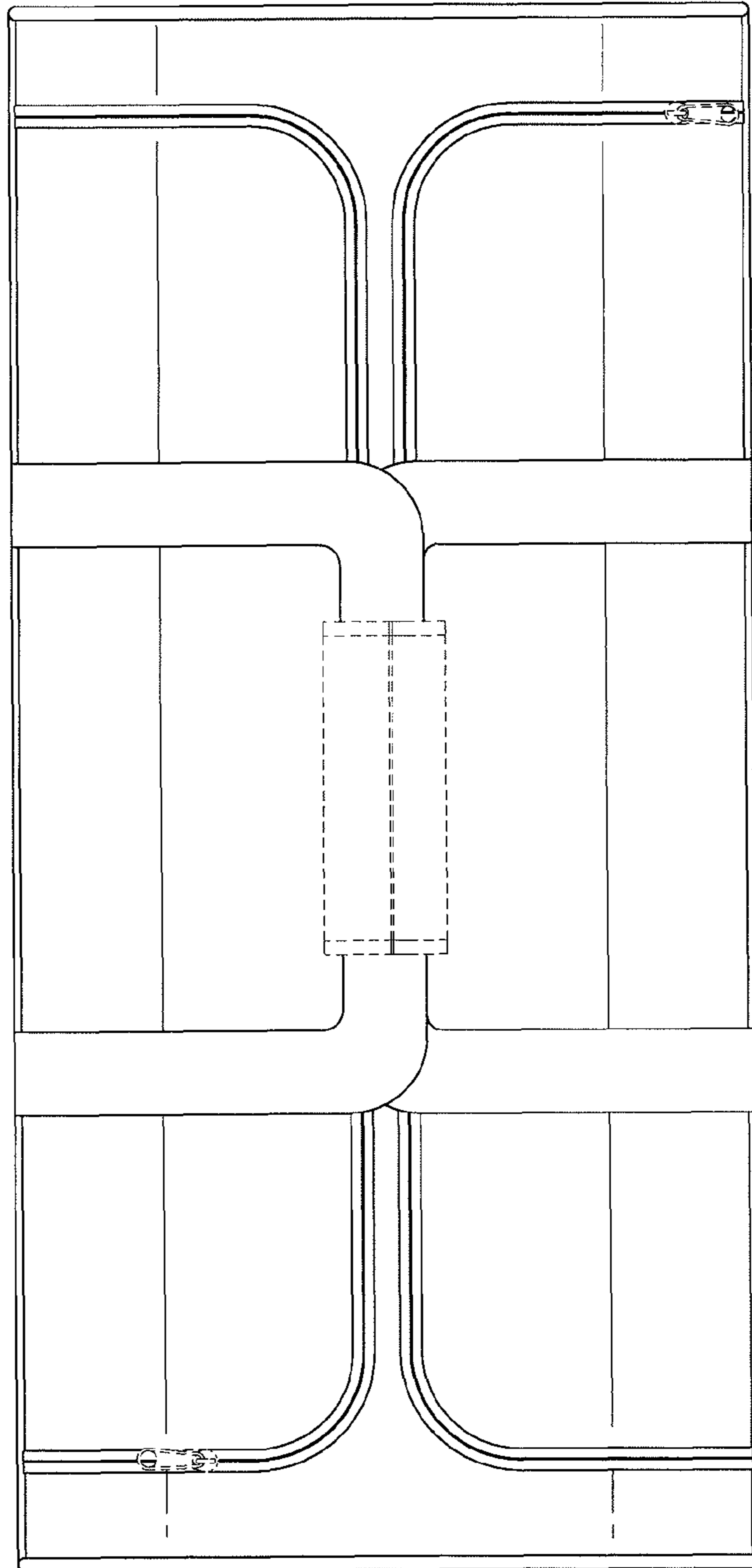

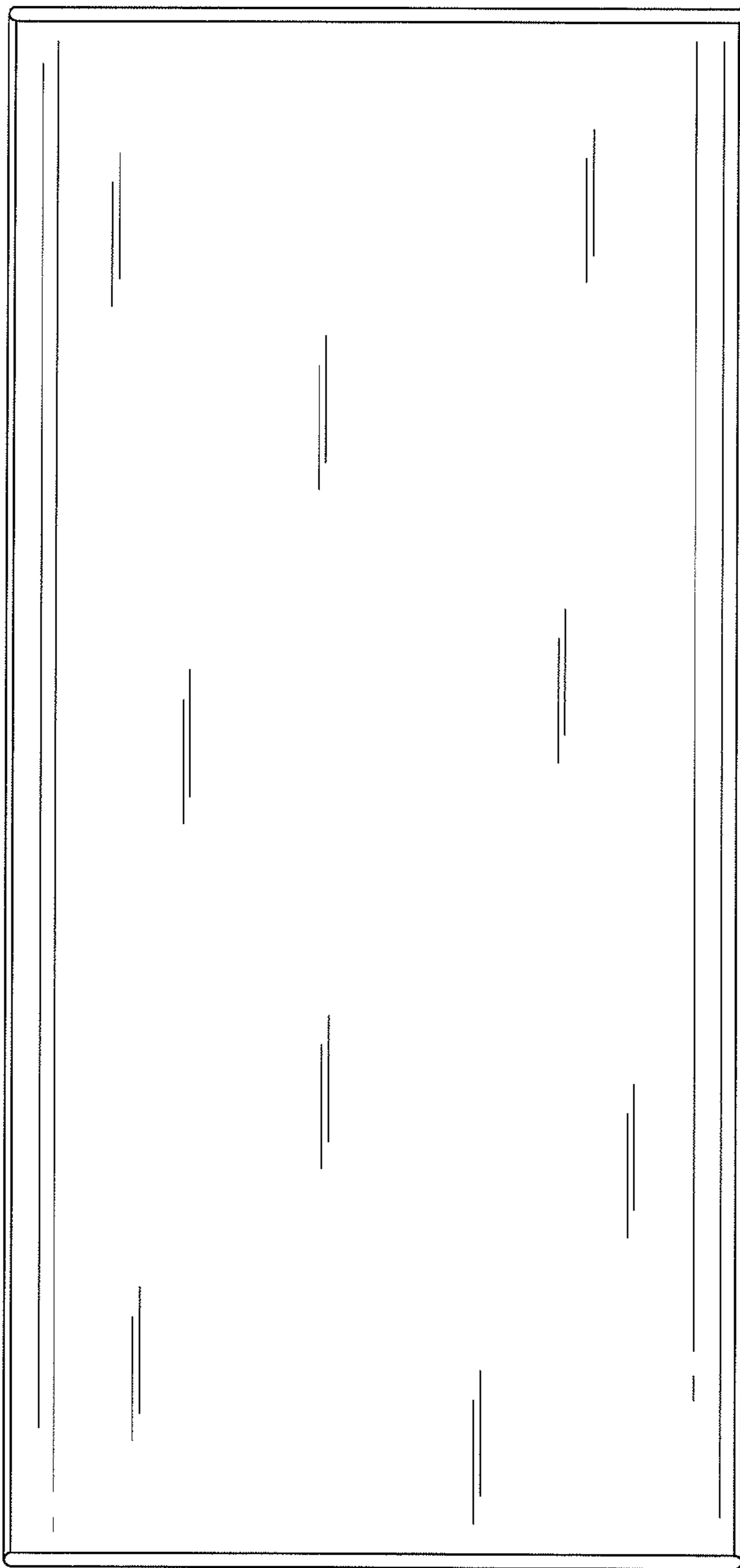
