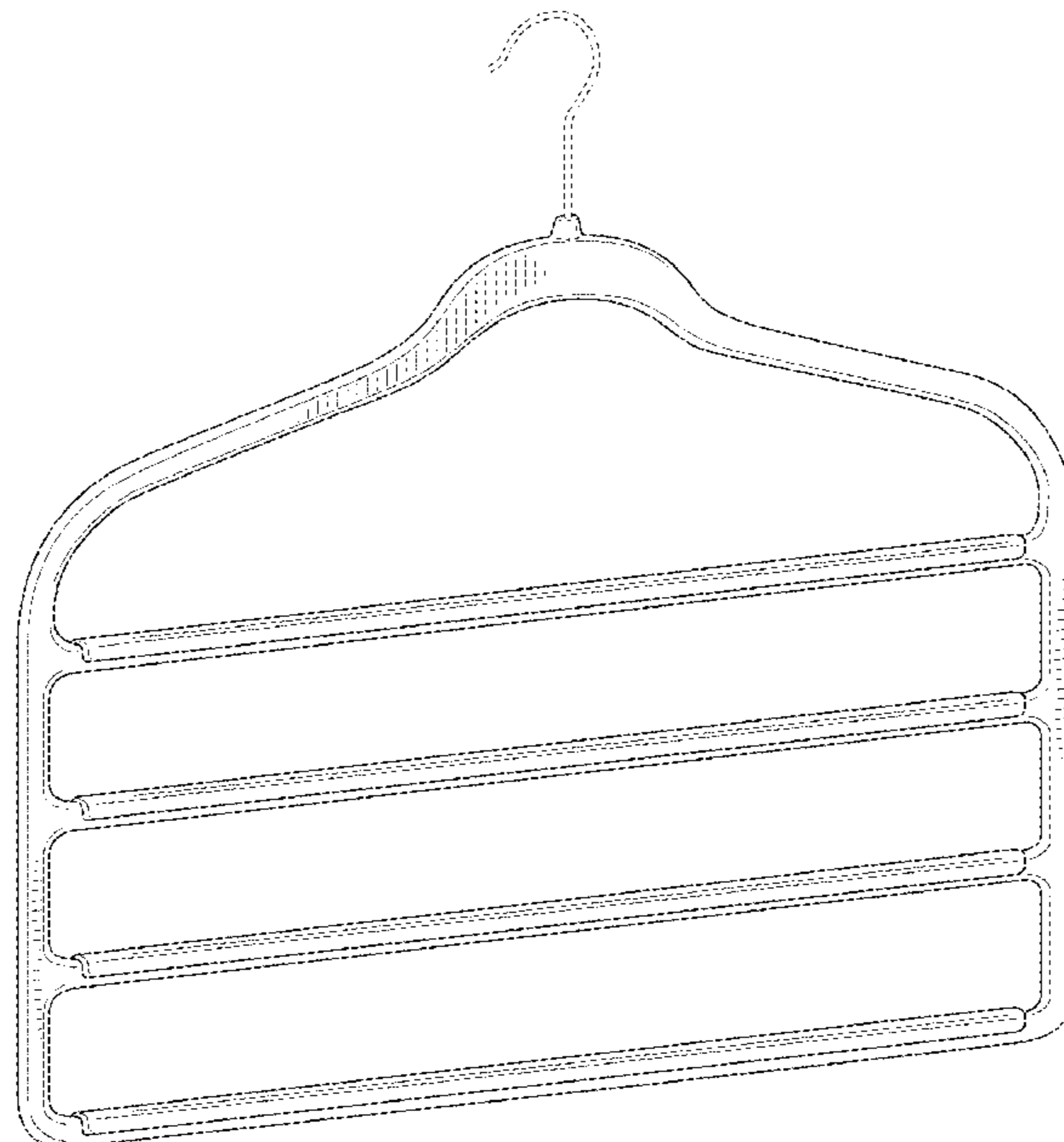
FIG. 1 is a perspective view of the present invention, a slim profile, non-slip, clothing hanger;

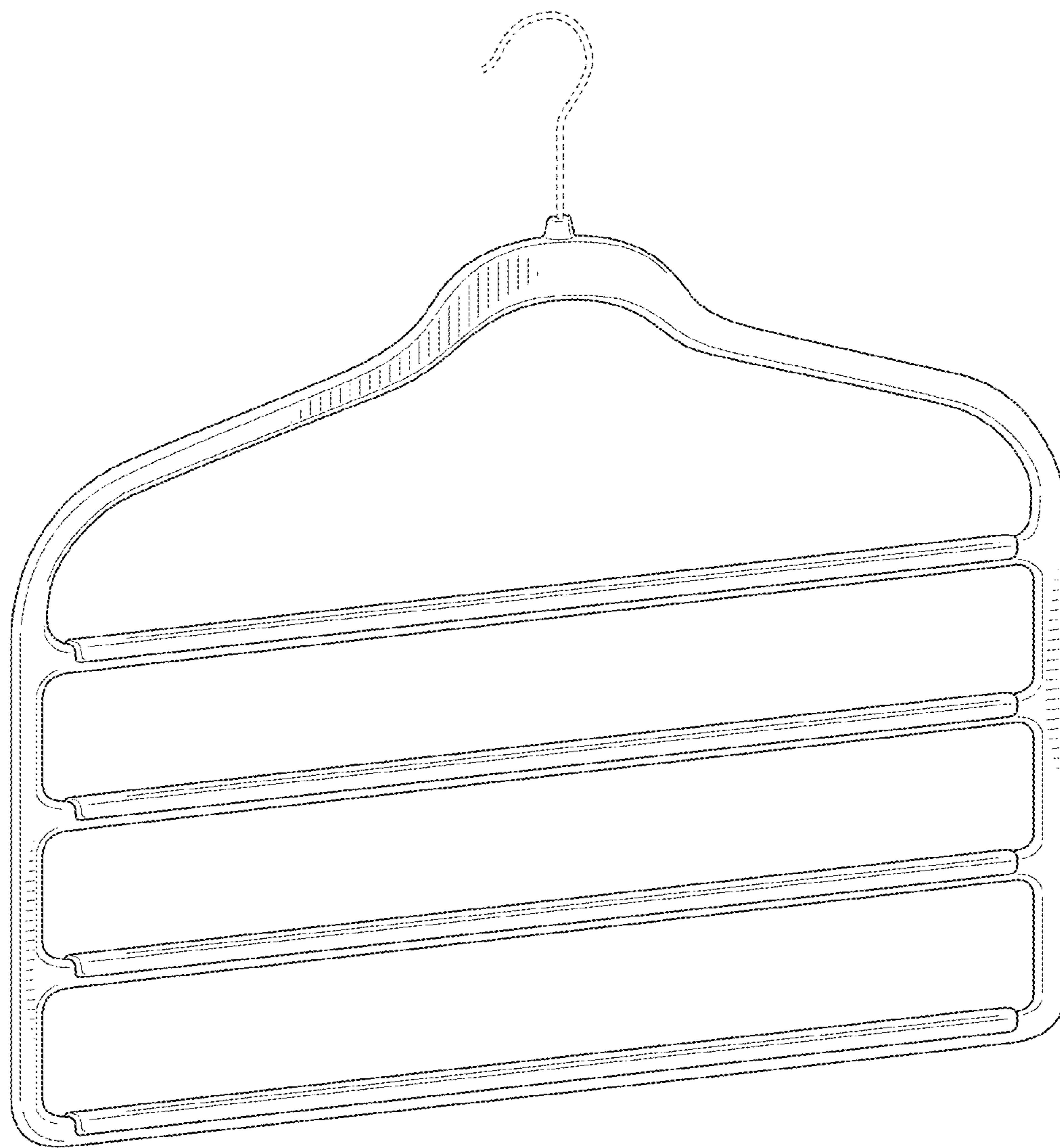

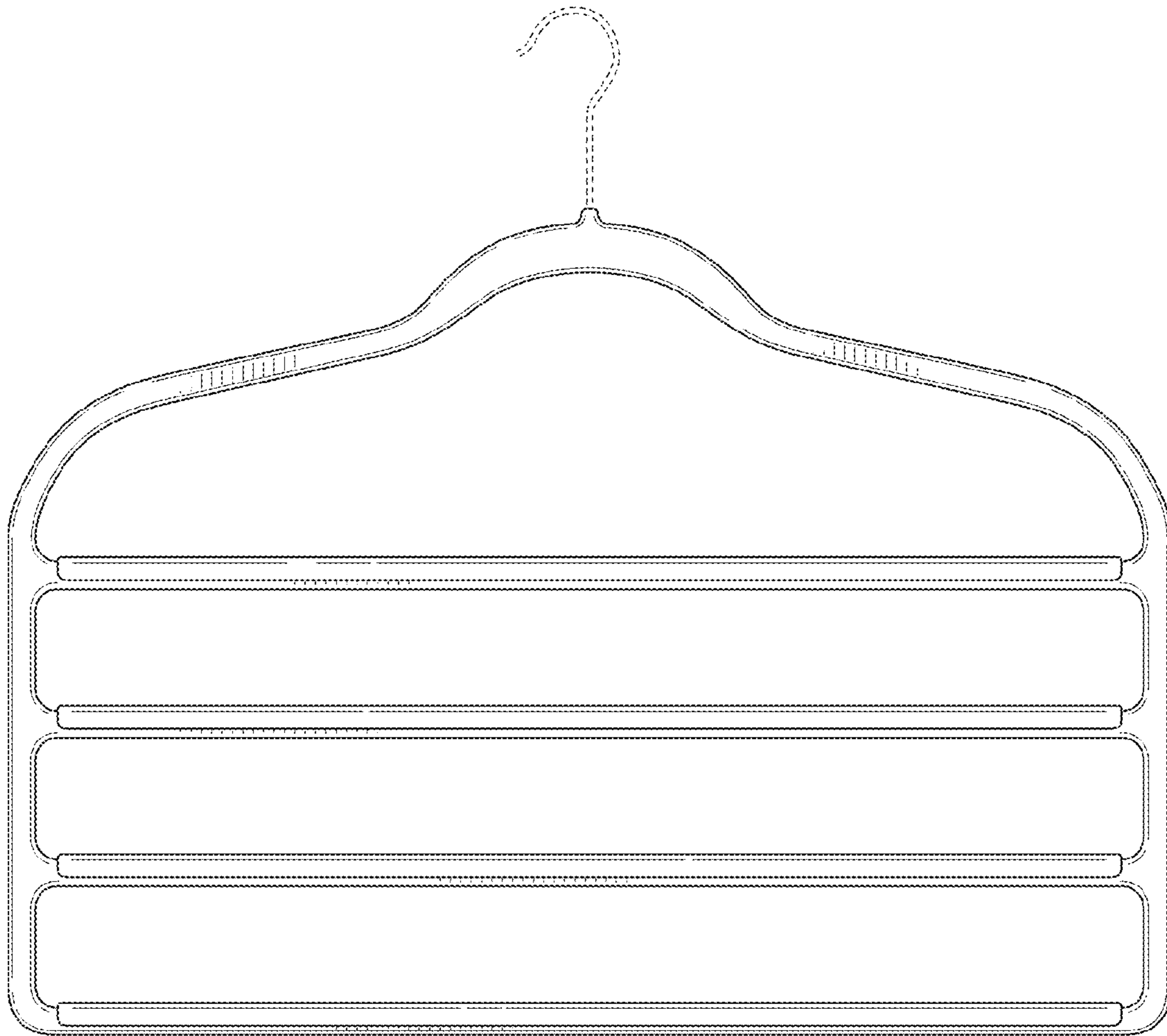

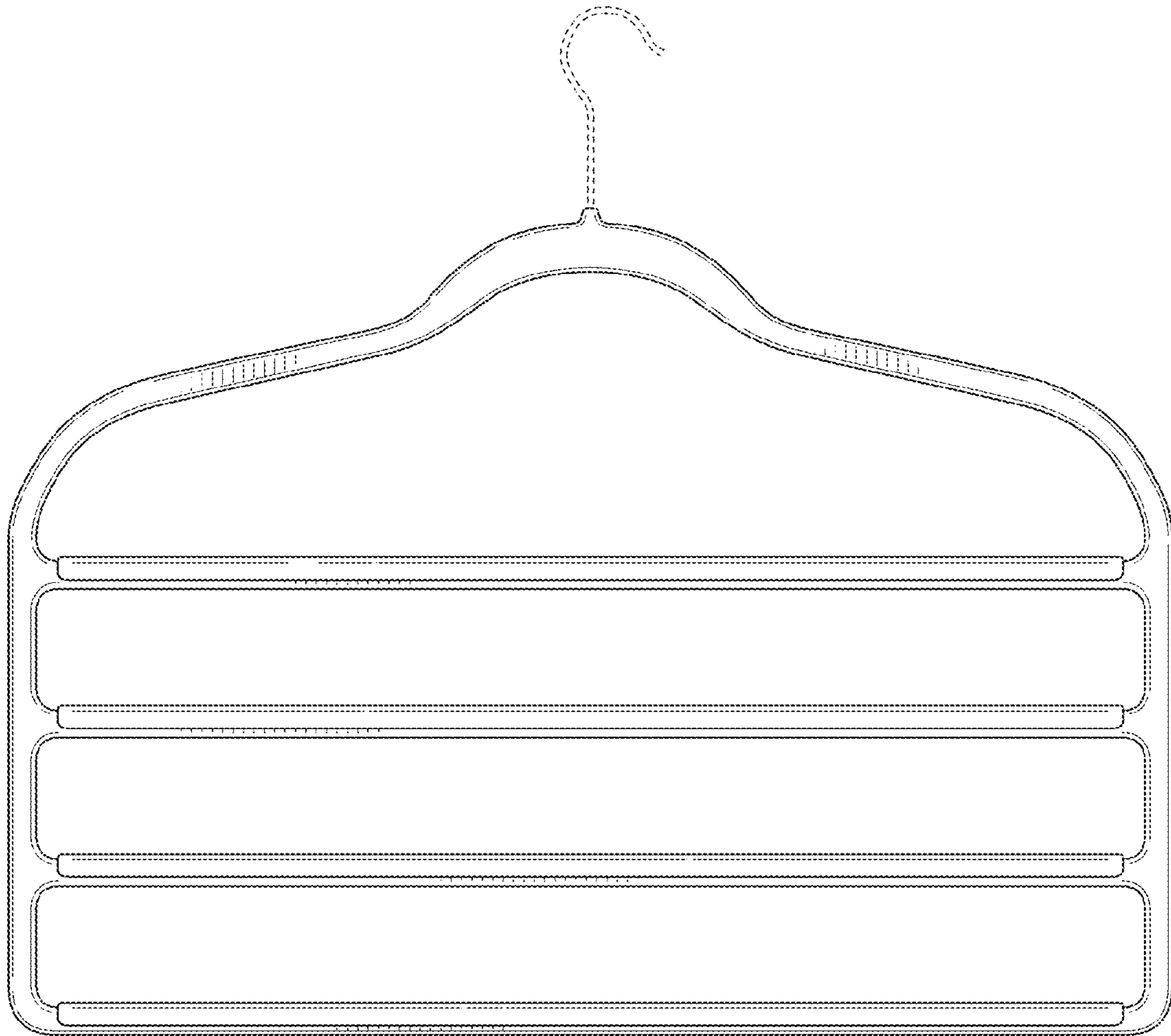

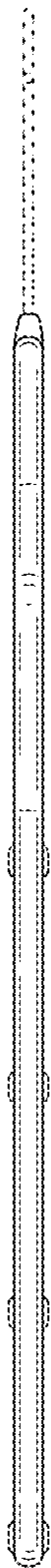

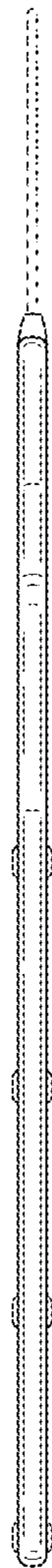

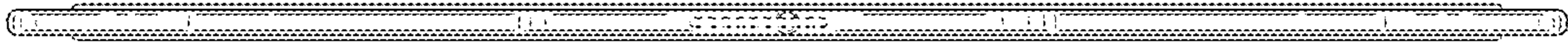

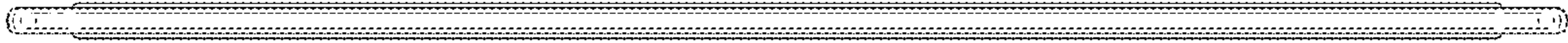
