(57) **CLAIM**

I claim the ornamental design for rice paper water bowl, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of my new design;

FIG. 2 is a back perspective view thereof;

FIG. 3 is a side view thereof;

FIG. 4 is the opposite side view thereof;

FIG. 5 is a top view thereof;

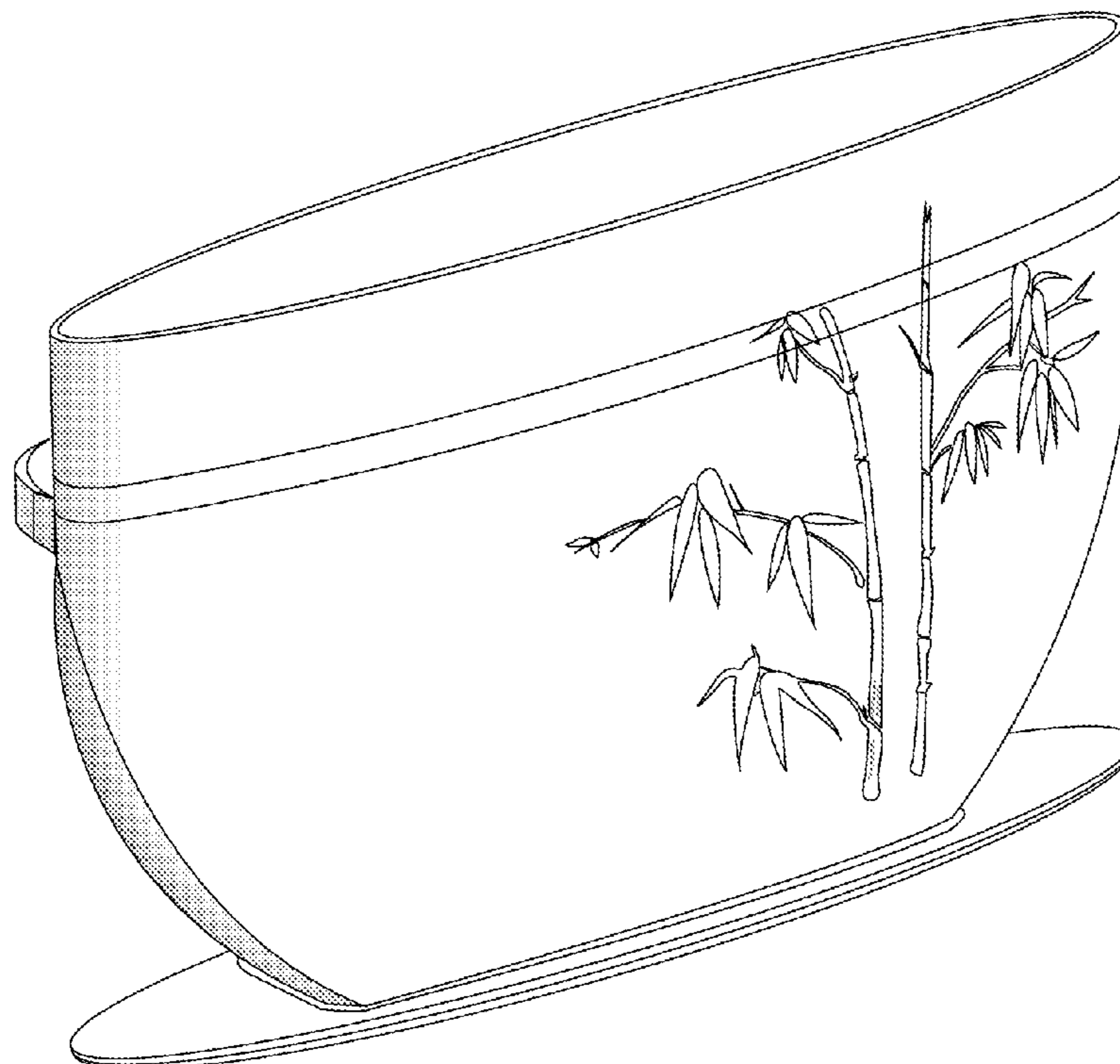
FIG. 6 is a bottom view thereof; and,

The novel features of my new design are the handle attached to the bowl, tapering shape of the bowl and oval shaped base on which the bowl rests.

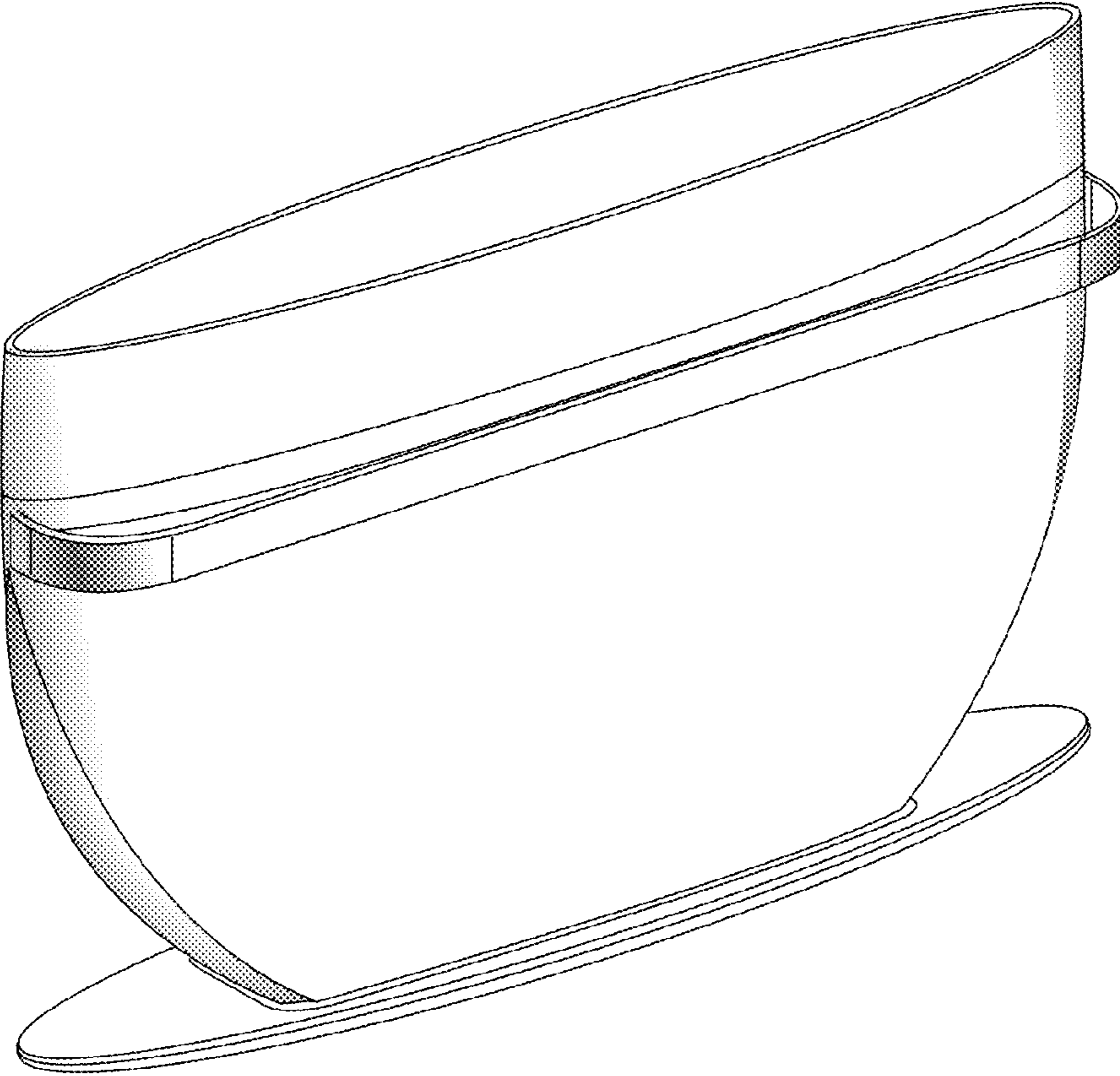

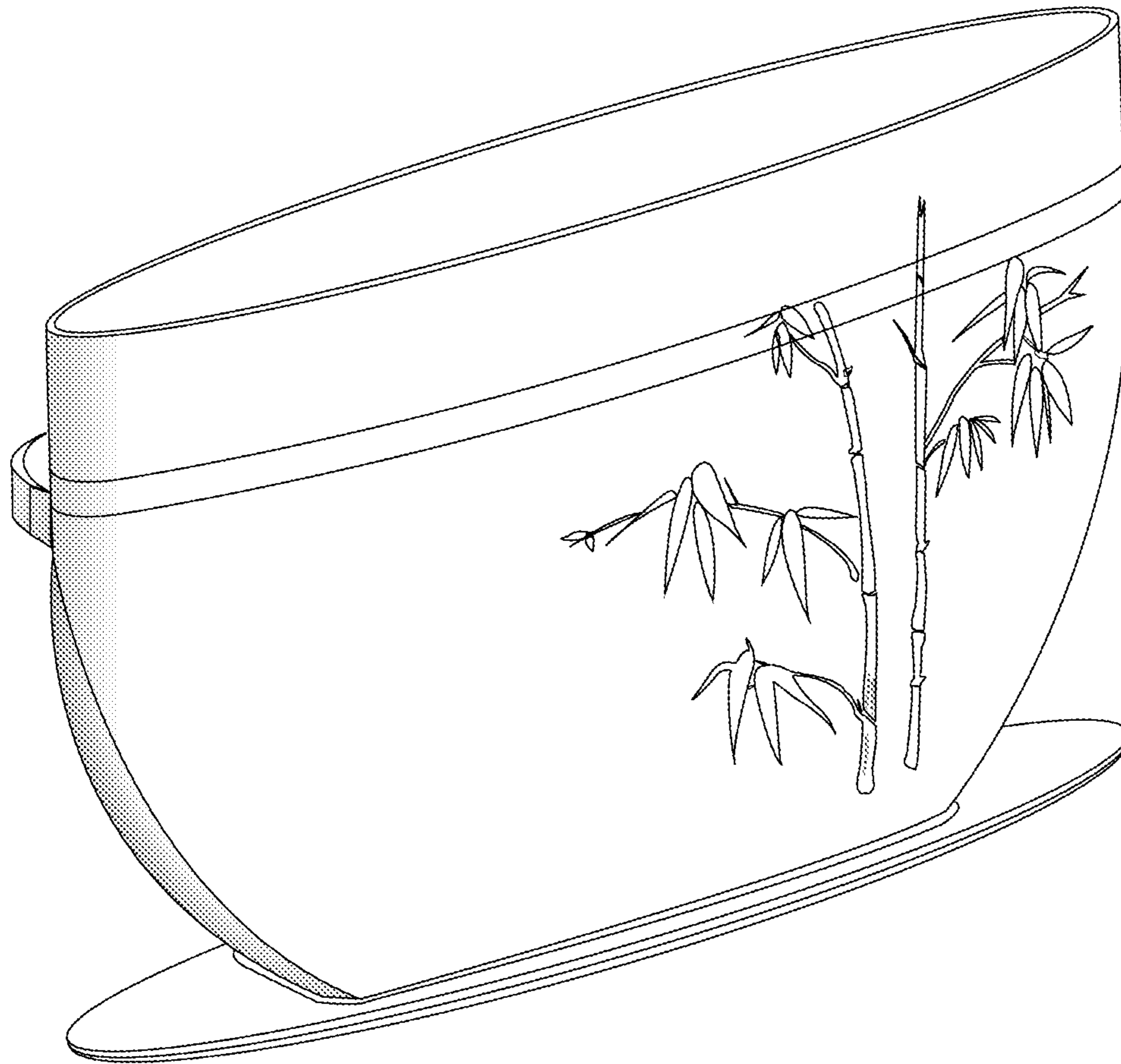

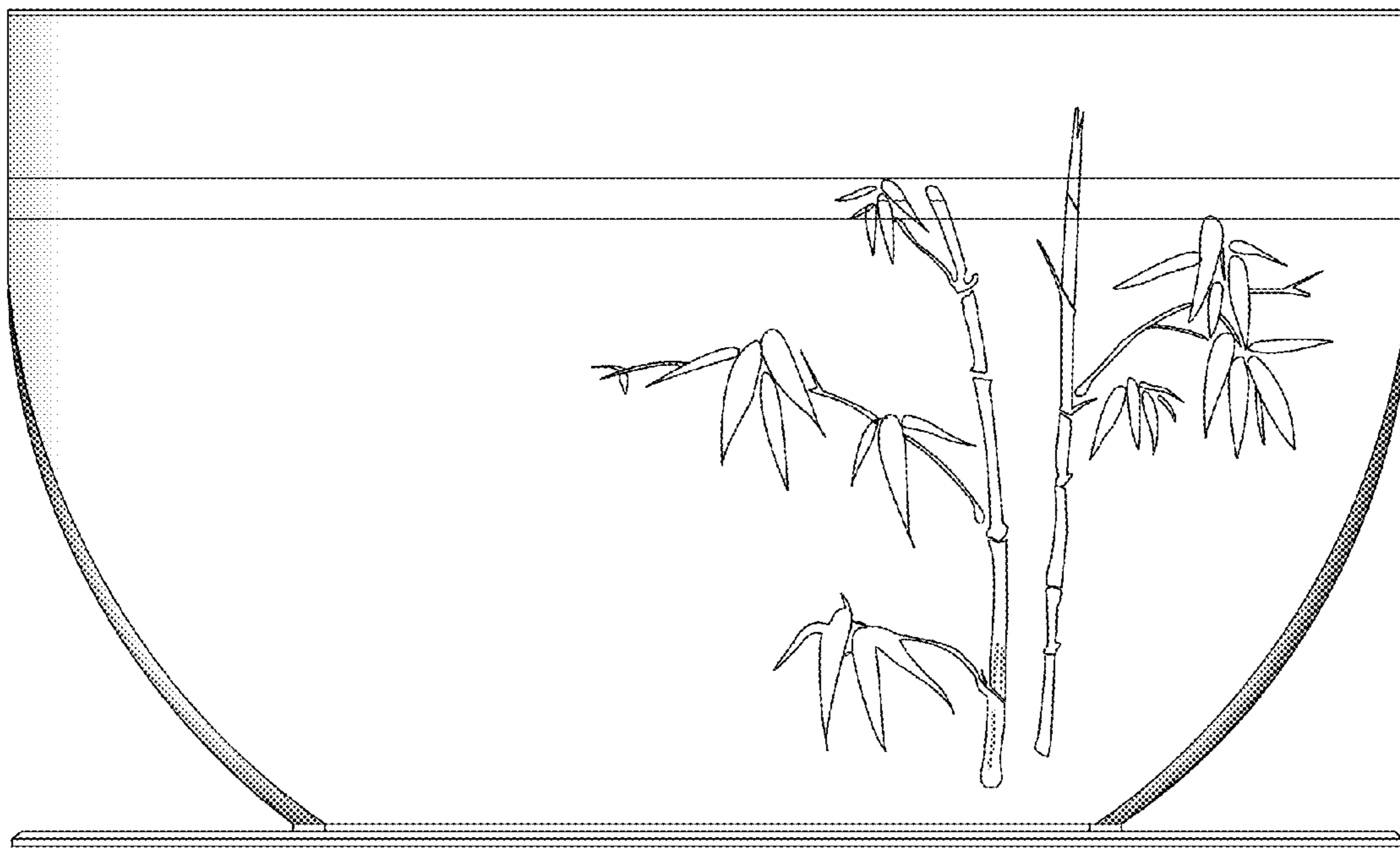

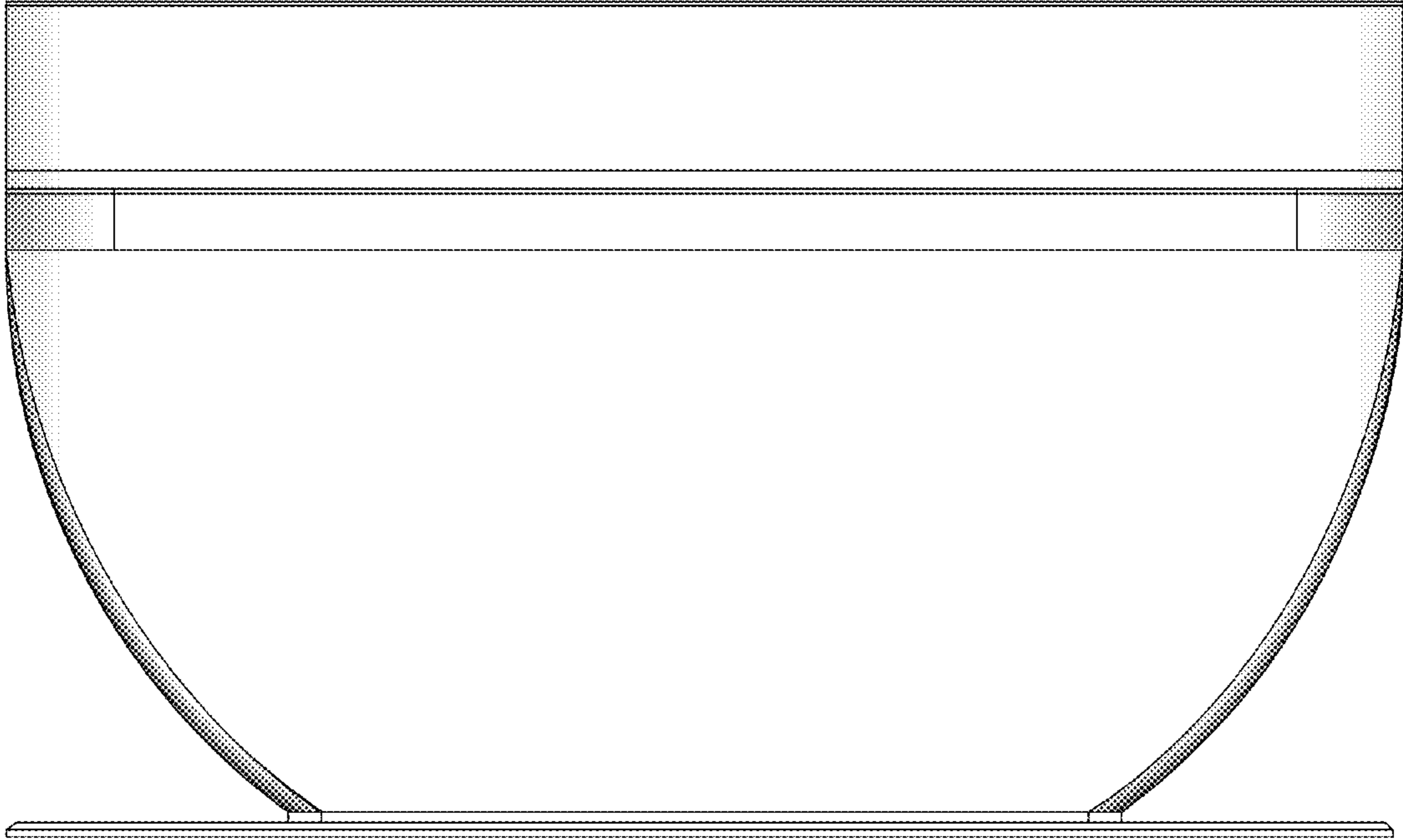

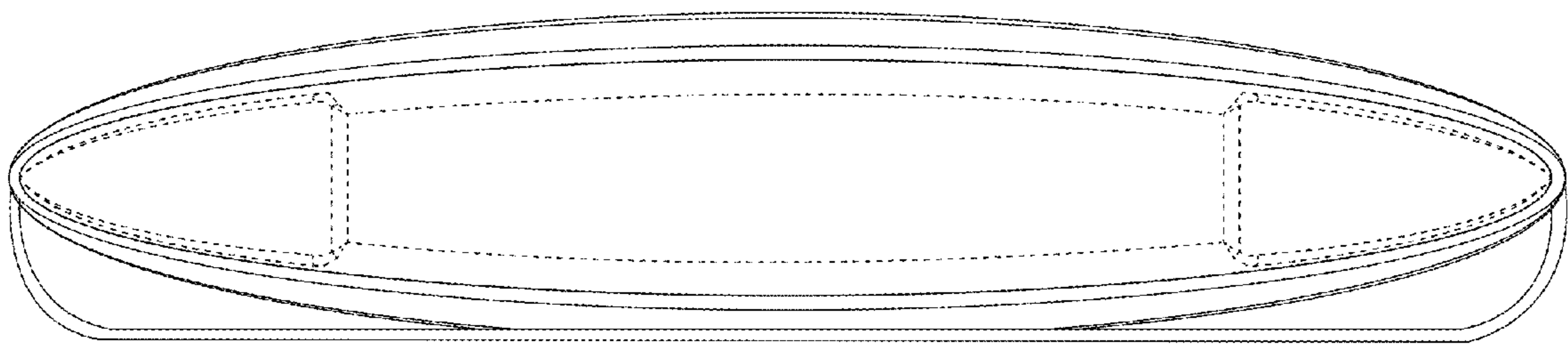
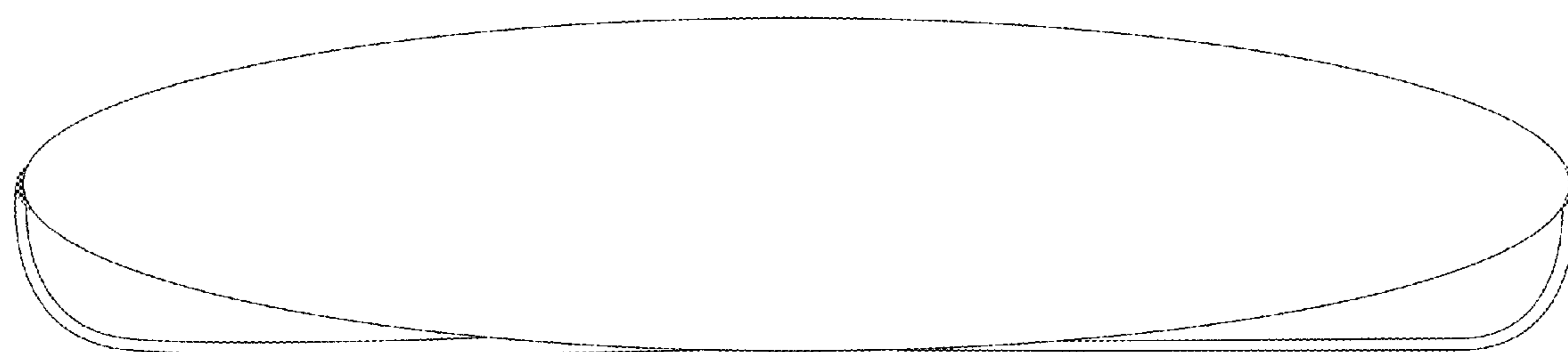

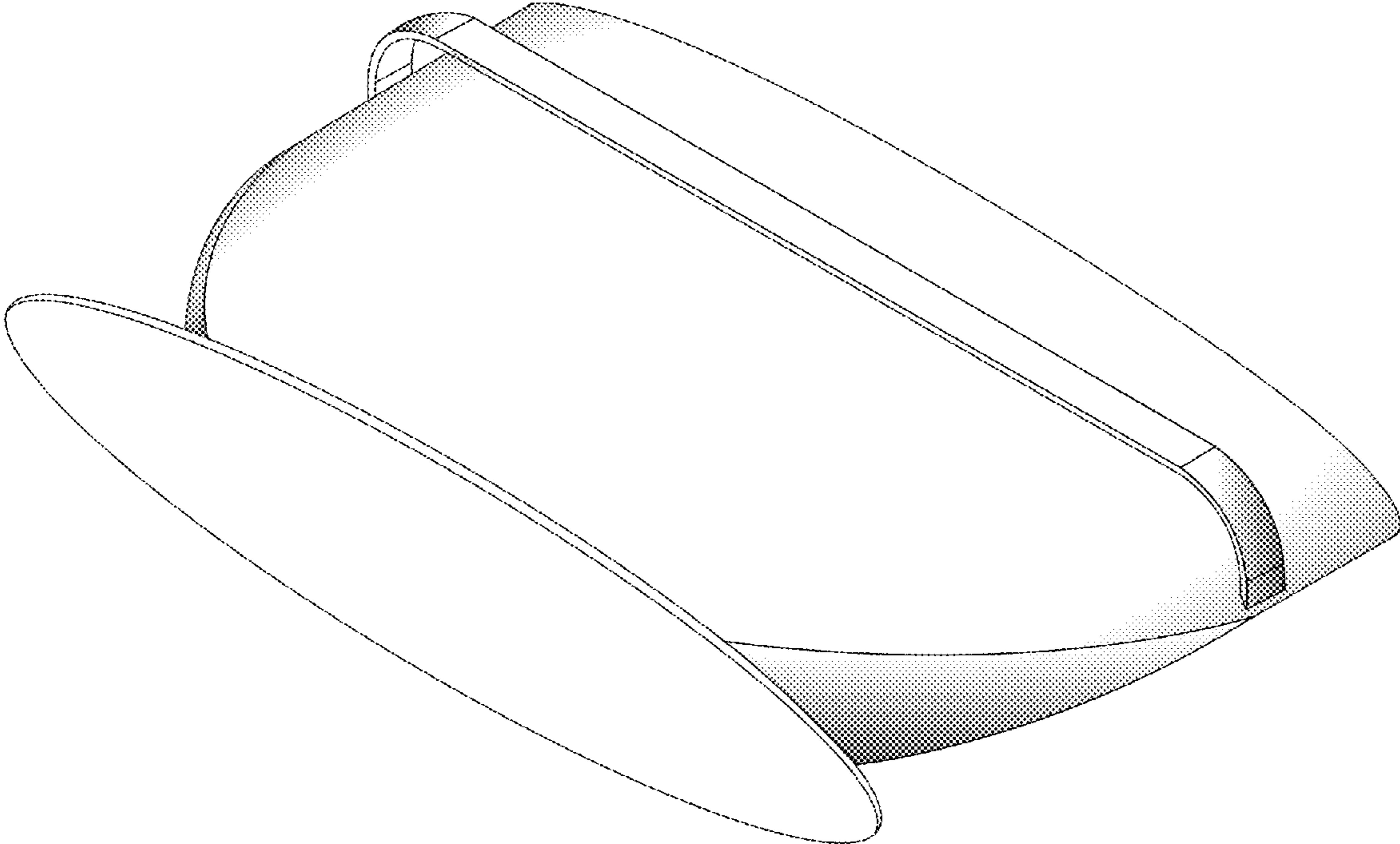
